Proposed Plans Announced For Skilled Nursing Facility

Within a few weeks, the city of Sierra Madre should know if an adult day care provider, Healthcare of Today, will buy the Skilled Nursing Center property. This announcement was made at Tuesday's council meeting by Loren Tino Rowyn, a consultant for the company. If the plans are successful the property would again be used as a health facility for senior

Mayor Kurt Zimmerman said he had asked Rowyn to address the council because of the importance of the project to Sierra Madre. The council was prohibited from discussing the issue as it was not part of their agenda and because Rowyn spoke during public comment said Zimmerman.

According to Rowyn, after an earlier conversation with councilmember Don Watts, that they also plan to incorporate a 24-hour Urgent Care Facility into the project. Rowyn said Watts suggested an urgent care component after being asked what he thought was the one thing the city could benefit from.

"Just to show you how I operate, all I did was make two phone calls," Rowyn said, "and within six hours before the close of that day I did call the manager of the city's office, Elaine, and told her we would definitely give the community an urgent care." Elaine Aguilar is the Sierra Madre City Manager. He continued, "Now I would assume that would be a good thing, but the funny thing was, within 24 hours I did receive calls from people thinking it suspicious that I could deliver something so quickly." Rowyn said the bottom line was that the developer wants to make money and that includes a project with something the community can use, "Urgent care is something we can make a part of this development, and I think it is something we can work", said Rowyn.

Mayor Pro Tem Maryann MacGillivray asked about other services they plan to extend to the community. "We did talk about opportunities for some of the elders in the community to participate in -- some of the programs you may be setting up such as yoga exercises that you will extend those opportunities to the community."

"The facility now, if it is an elder care facility, can be broken down into three or four different categories, the first would be having elder care as daycare...," Rowyn responded. Other ideas includied basic physical therapy that would be open to the community. "As far as taking the facility as a whole, we are not going to encapsulate it, and say it is for only one type of person or one type of situation," he said, "and some of the things I can promise is that once we do open our doors, we will give Sierra Madre the opportunity of employment first before we try to bring people outside of the community."

The only foreseeable dilemma with the project

according to the consultant, could be putting in a pharmacy, but he assured the council that it would not

compete with Best Buy Drugs on Baldwin Ave.
"The first thing I did was, I went downtown, which was simple to find since there is only one pharmacy in town, and I spoke with the owner/manager. When asked if our plans presented a problem the answer was no after Rowyn explained who he was and what he intended to do including keeping the pharmacy "in house." At press time, the owner of Best Buy Drugs could not be reached for comment

In the beginning of his preseentation, Rowyn encouraged those with questions to "Google" his name. In doing so, it turns out he has an interesting background as the host of a television show. Rowyn writes, "The New Remodeling Show has a very revolutionary premise; whereby I (the host) will help show (teach and condition) the TV viewer how to find the right contractor (at the right price) for their project with the intent of them (the consumer) having a happy outcome to their remodel project whereby there will be a positive spin on the business exchange of money for services rendered."

Longtime Sierra Madre Resident Karl Teigler Passes Away

Karl Edward Teigler, longtime He was preceded in death by his Sierra Madre resident and volunteer, passed away Easter morning shortly after midnight. Karl had been suffering and in pain due to cancer, according to his wife Ruth.

Karl had just celebrated his 94th birthday on Thursday, April 9th. He and Ruth would have celebrated their 67th anniversary in June. "He was twenty-seven before I could catch him," said Ruth. They were married in Rochester, N.Y. on June

Karl was born on April 9, 1915, to Fredrick and Marie (nee Kumph) Teigler, Buffalo, N.Y. After graduating high school, he attended college. He worked for Picker Electric Co., selling, installing, and maintaining X-ray equipment. During the second World War, he worked with high-energy X-ray equipment in support of the Manhattan Project. After the war, and until he retired, Karl worked for the General Electric Co., residing in Tyler, Texas and then moving to Sierra Madrein 1963. After many years in Sierra Madre, Karl and Ruth, moved to Kokomo to be closer to their daughter.

In Sierra Madre, he was very active in the community. He served the city as assistant treasurer. He served on the National Committee on Aging. Karl worked on the Senior Master Plan and on the Youth Master Plan for the City of Sierra Madre.

He received awards from the County of Los Angeles on Older American's Recognition Day, May 11, 1994. He also received awards from the City of Sierra Madre for his work on the Senior and Youth Master Plans. Karl was raised a Lutheran. After he married Ruth, he joined the Episcopal Church. He was active in church affairs. He taught Sunday School and was involved

in establishing a new Episcopal





Sonja Yates, Director of the San Gabriel Valley Habitat chapter of For Humanity spoke Tuesday to the Sierra Madre Rotary. 



Celebrate Handbill Ordnance Put on Hold

Residents again threaten to sue. By Dean Lee

After a number of residents expressed concern Monday night that a recently passed severely ordinance limiting the distribution of handbills on residential property was unconstitutional the city council put the matter off asking the city attorney to tweak the language possibly exempting multifamily dwellings from the

The issue would be reheard April 27 City Attorney Michele Bagneris said.

Resident Marvin Schachter reminded the council that they had lost a lawsuit in 1998 after passing a similar law calling for an outright ban on all handbills, leaflets, fliers and other written material where owners have posted a "No Soliciting" sign.

"I cannot conceive of a reason why this council, people who I respect, would vote for an ordinance so obviously in violation, not only of the letter of the Constitution but of the spirit of the Constitution of the United States," Schachter said. "I urge the council to reject this first reading and withdraw this effort; I don't want to sue the city again."

He then reminded them that they currently have a budget problem saying they should not waste hundreds of thousands of dollars on a lawsuit as they had done before.

At issue Schachter said is the given ability for the managers or owners of apartments to prohibit the distribution of literature. He then gave a number of examples.

"A candidate that wants to run for the city council who cannot afford the heavy cost of mailing or

the cost of advertising could be prohibited from distributing literature in that building," he said. "if the tenants of a rental building wanted to organize, or if a tenant's organizer wanted to organize renters to defend their rights, the owner of that building could prohibit the distribution of literature in that building."

He said at lest 55 percent of all housing units in Pasadena are rental, most of them in multifamily building.

Schachter also said littering should not be used as an excuse for violating a person's fundamental Constitutional right something other speakers agreed with including Michelle White Affordable Housing Services. White is also the president of the local chapter of the ACLU.

"As a landlord I could preclude each one of my tenants from receiving information," she said. "All I have to do is put up 'No Handbills."

She also said the law would interfere with fair housing counselors who go around investigating housing claims.

"Typically if they are not home what they do is leave information so that they can be called back," she said about the counselors. She added that this would also hinder complaints such as housing discrimination.

'This would interfere with that ability of the fair housing groups that you're funding," she said. 'It would also interfere with the ability of Social Services and economic justice agencies, such as mine, that go around and try to organize its communities."

Resident Nancy Nelson said the law also violates people's right to work.

'The right to work includes the right to have business cards and fliers and brochures and trifolds and to hand them out," she said. "This is a fundamental pursuit of life liberty and the pursuit of happiness,"

The new ordinance would repeal the unenforceable existing handbill law. City staff said in October of 1999 U.S. District Judge William Keller issued a permanent injunction prohibiting the city from enforcing the existing law which regulated handbills Photo D. Lee MVNews

distribution by way of a refusal registry, "do not deliver" list.

Schachter said Keller ruled just minutes after hearing all the testimony.

Staff also said the law would reduce wind blown litter as well as cutting down on burglaries where an unoccupied home could be more vulnerable because handbills unclaimed.

As written, according to the staff report, the new ordinance would, prohibit the distribution of handbills on residential unless property handbills are properly secured so that they will not be blown about; Prohibit the distribution of handbills on residential property if there is placed in a conspicuous location near the entrance a legible sign of at least 16 square inches bearing the words "No Handbills" or a similar notice, subject to certain exceptions; Permit the handing of any handbill to a person who is willing to accept the handbill; and Establish a rebuttable presumption that the person whose message is on the unlawfullydistributed handbill has violated the ordinance.

Ruling Bars Officers **Names** from Being Released

The Los Angeles Civil Court ruled Thursday against the city of Pasadena's position that the release of officers' names in critical incidents should be left to the discretion of the department according to a statement issued by Pasadena Police Chief Bernard Melekian.

"I am disappointed with the Court's decision in the matter," Melekian said. "I believe that we have, in the spirit of transparency, made every effort to be open about the Barnes' and all other cases we investigate in releasing information as long as it did not jeopardize the safety or well being of the officers and their families."

Pursuant to the court's orders the names of the officers will not be released. In the meantime the department will consult with the city Attorney to see what the next steps are pending the hearing date the statement also reads.

Ginkgo Tree Blooming; Causing Complaints

Although numerous completes have come in to this newspaper, the city, and other newspapers in Pasadena, photographs along Colorado Blvd, taken before and after a number of Ficus trees were cut down, clearly, show that no new Ginkgo trees have been planted to replace them as alleged.

The city had placed moratorium on planting new trees after councilmember Sid Tyler asked that they look at replanting shade canopy and drought tolerant trees instead of the planed, Ginkgo's and palms.

Monday Tyler asked when the soonest trees could be planted to which staff replied, three to four months. He then asked them to confirm that it

would not before next fall. Staff said the optimum time to plant would be September due to irrigation.

It was also said that if bids for the work came back under \$75, 000 they would not have to come back to city council although that process is still far off. City Manager

Michael Beck also said they did want to go out to bid until the council lifted the tree planting ban.

Councilmember Victor Gordo had asked the council to reconsider its position on waiting saying that Ginkgo trees do in fact meet the Untied Nations Urban Accords. This came after outcry during pubic comment that the city was not following it own green action plan.

He also said after researching the Ginkgo he

found them fascinating. "It is, I'm told, the oldest living tree specimen in the world."

He then asked if they were going to outlaw all slow growing trees, using the Oak tree as an example. Gordo also said that the Ginkgo is known to live 3,000 years.

He also asked that they plant immediately the 36 Ginkgos planed along Colorado Blvd that now many this week, have claimed had already happened.

The city's Assistant Public Information Officer Linda Centell said Thursday that no new Ginkgos had been planted as reported. She said the 52 existing trees along Colorado Blvd between Lake Ave and Los Robles Ave had been lying dormant and were now being noticed because

they are blooming. After over two hours

the council ended the discussion Monday night with no action and a motion by Gordo still pending. The council could not agree to exempt Old Pasadena, South Lake Avenue and the Playhouse Business Districts and allow tree planting to move forward according to approved tree planting plans for each of the three

business districts.

Environmentally Speaking, Did You Know?

Senator Gaylord Nelson and Earth Day

On April 22, 1970, the first Earth Day was held; something its founder, Senator Gaylord Nelson, had been working toward for seven years. Nelson announced in September of 1969 that in the spring of 1970 there would be a nationwide grassroots demonstration on behalf of the environment and invited everyone to participate. The wire services carried the story from coast to coast. The response was electric. Twenty million people demonstrated their support. Since that date—some important environmental highlights:

*1970, the Environmental Protection Agency (EPA) was created by President Richard Nixon with a $mission\ to\ protect\ the\ environment\ and\ public\ health.\ In\ the\ same\ year\ Congress\ amends\ the\ Clean$ Air Act to set national air quality, auto emission, and anti-pollution standards.

*1972- EPA bans DDT, a cancer-causing pesticide, and requires extensive review of all pesticides. In 1996, the bald eagle was removed from the endangered species list, reflecting its recovery since this

*1972-Congress passes the Clean Water Act, limiting raw sewage and other pollutants flowing into rivers, lakes and streams.

In 1972, only 36% of the nation's assessed stream miles were safe for uses such as fishing and swimming: today, about 60% are safe for such uses.

*1974- Congress passes the Safe Drinking Water Act, allowing EPA to regulate quality of public drinking water.

*1990-EPA's Toxic Release Inventory tells the public which pollutants are being released from specific facilities in their communities.

The number of chemicals listed nearly doubled, from 328 in 1990 to 644 in 1999.

* 1993-EPA reports secondhand smoke contaminates indoor air, posing serious health risks to non-

Today, more than 80% of Americans protect their children from secondhand smoke exposure at home. *1996- Public drinking water suppliers are required to inform customers about chemicals and microbes in their water, and funding is made available to upgrade water treatment plants. Today, the vast majority of American households has safe drinking water, and receives annual reports

on the quality of their drinking water. Unfortunately, space prohibits listing the vast amount of accomplishments and improvements to our environment. Please take the time to check them for yourselves at: www.epa.gov/earthday/

Gaylord Nelson was awarded the highest honor given to civilians in the United States—The Presidential Medal of Freedom. It was presented by President Bill Clinton, on September 29, 1995.

Spotlight on Madre Volunteers

Jay Whiteraft -Supernova Volunteer

Jay Whitcraft could be called "the man for all seasons." His giving in some form fills every day of his life and shines upon the world much like a very bright star.

The 26-year resident came to live in Sierra Madre with his three-decades-long partner, Joy Phillips, after taking a bus tour, led by Phyllis Chapman, covering Sierra Madre historical sights. They decided to move here, and have been enthusiastic residents since.

"On the bus tour I saw the Richardson House and Lizzie's Trail Inn, and I decided I wanted to work there." He is now curator of Lizzie's and an active board member of the Sierra Madre Historical and Preservation Society.

Eight years ago he became a trustee at the Sierra Madre Library and began teaching computers there with Maury Whittaker. In four years they have taught over 800 students. Jay's dream as chairman of the Board of Trustees is to have a coffee cart in the library garden where people will discuss ideas gleaned from the books they've read. He calls it "a lifelong learning quest." He also works the used book sales every two months.

Overnineyears ago Jay was one of the community leaders to investigate starting a community foundation, and they formed Sierra Madre Community Foundation under the umbrella of the California Community Foundation. Jay was the second chairman, following Eph Konigsberg's

He and Joy have a donor-directed fund within the California Community Foundation and via that vehicle have donated money toward the planting of trees in honor of Jim Heasley and Charlie Corp, have given to the Fire Fund and Katrina, and they bought a bench for the library garden. They spearheaded refurbishment of the cannon in Memorial Park, have given to the Mt. Wilson Trail Fund and toward the Historical Society Centennial book. Jay has run silent movie



fundraisers for the public with proceeds going toward the book publication.

"Based on my experience with the cannon refurbishment, it is not possible to complete such endeavors without volunteers. It tells me how important volunteers are in the City of Sierra Madre."

Jay and Joy work at the L.A. Arboretum herb garden every week, and he teaches sailing in Marina del Rey at the California Yacht Club. He is a member of the U.S. Lighthouse Society, and has volunteered his time helping various City and State canadidates toward their quests for office He's a member of the Coordinating Council, whose members represent all Sierra Madre groups to coordinate the timing of all Sierra Madre events.

Jay was born and raised in Wynnewood, Pa., and graduated with a Bachelor of Mechanial Engineering from the University of Pennsylvania. He served in the Army Air Corps during World War II and came to California 40 years ago to work for IBM.

Jay concluded simply, "My life revolves around Joy and volunteerism."

Arcadia Police Blotter



Facing Facts by Howard W. Ways

Okay, I'll admit it. I'm one of those who, as described by columnist Gregory J. Wellborn, will "shamelessly" use recent acts of gun violence to argue for "stricter gun control laws and assault weapons bans". Since Mr. Wellborn frames his argument in terms of "facts", "evidence" and "statistics", I'll attempt to do the same.

Mr. Wellborn asserts that "As the number of gun permits increased, the number of violent crimes decreased". Yes, crime rates dropped in states with permissive concealed weapons laws. According to a 1999 study based on FBI statistics, between 1992 and 1998 violent crime rates in those states dropped by an average of 15%. But during the same period, violent crime dropped by 25% in the nation as a whole - and by 30% in states with stricter permit laws on the books.

Mr. Wellborn points out that countries, such as Germany, with gun control laws much stricter than ours are not immune from multiple-victim shootings. That's true - but it might help to look at the bigger picture. According to the United Nations Office on Drugs and Crime, between 1998 and 2000 the U.S. ranked #8 per capita in a survey of 32 nations on murder by firearms, between Costa Rica and Uruguay, with .028 per 1,000 people (South Africa fared the worst at #1). Germany came in at #21, with .005 per 1,000. (The United Kingdom was best at #32, with .001 per 1,000).

In discussing guns and children, Mr. Wellborn states, 'The statistics show that the death rate from guns is considerably smaller than the death rates from drowning, bicycles or fires." According to the Centers for Disease Control, in 2005 firearms were the second-leading

cause of death among those in the U.S. between the ages of 1 and 19, after motor vehicle accidents. In that year, 1,972 children and teenagers were murdered with guns, 822 committed suicide with guns, and 173 died in unintentional shootings (as Mr. Wellborn says, "accidents will happen").

There's the argument that only "law-abiding" citizens would be issued permits to carry guns. According to a 2002 study from the Violence Policy Center, between 1996 and 2000 concealed handgun license holders in Texas had an arrest rate for weapon-related offenses 81% higher than that of the general Texas population age 21 and older - including arrests for assault or aggravated assault with a deadly weapon, unlawfully carrying a weapon, deadly conduct/discharge of firearm, etc.

In August 2008, The Atlanta Journal-Constitution quoted a spokesman from the Georgia Bureau of Investigation as stating, "A blind person can get a permit in Georgia, since all you have to do is pass a background check. And that person can be arrested the very next week for a felony, convicted of that felony the next month and still have that permit for the next five vears."

Finally, I'll submit that anyone who demands the right to stockpile assault weapons, fears that liberals are out to seize all guns, and feels the need to pack heat for protection when venturing out to the local mall - these people shouldn't be allowed on the street without adult supervision, let alone issued a permit to carry a concealed weapon. I may not have statistics to back this up, but I'll stand by it, just the same.

Looting Social Security



It would be a real loss to all Americans—now and in the future—if Social Security, the retirement and disability program conceived as part of the New Deal during the Great Depression, should come to its demise during the current

ity summit" to examine the long-term costs of entitlements, including Social Security. That forum set the trap for a "bipartisan compromise" that may become difficult for Obama to resist, given the burgeoning deficit. If he ignores the forum, he will be denounced as an old-fashioned free-spending liberal.

Proponents of looting Social Security are urging both parties to hold hands and take the leap together, authorizing big benefits cuts in a circuitous way that allows them to dodge the public's blame.

Opponents argue that Social Security is actually running a huge surplus \$2 trillion and that the only "crisis" is that the government has raided this surplus to pay for general funds and is now threatening to renege on this.

Government money is government money, right. WRONG! If the government hadn't "raided" Social Security to pay for all that spending, it would've had to borrow it, putting increased debt on all those same people. The problem is not that we have a Social Security crisis -- it's that we have a general government spending and borrowing crisis.

Everyone thinks Social Security is just another major expense of the government like defense, and so asking everyone to take a cut is not so unreasonable.

But asking seniors, who have paid into Social Security for decades expecting full benefits when they retire, to take a cut is just plain unacceptable. It is just as unacceptable to pass the increased cost of Social Security on to future generations, who can't stick up for

No, the solution is neither cutting benefits nor raising employee contributions.

Rather, the Obama Administration should take the bold step of finally putting a permanent lock on the Social Security fund and prevent it from being used as a source of money for other government spending. Social Security should be reserved for retirement and disability. PERIOD!

cule was obvious, but it took a keen ob-Gregory J. Wellborn server of urban slang to spot the disgusting sexual innuendos used by CNN, MSNBC

and other media outlets who applied the sexually derogatory term, "teabagging" (see urbandictionary.com) to all those who organized, supported or attended one of the tax protest rallies. Moving beyond this low point in American mainstream journalism, let's consider the validity of the complaint voiced by so many who feel we are overtaxed.

President Obama requested, and Congress delivered, a 2009 budget, 2010 budget proposal and long-term projections beyond that which call for deficit spending of \$7 trillion over the next 10 years. The administration promises that this will only be charged against the wealthiest Americans - the top 1% earning more than \$250K per year - but many people in this country suspect that is a lie. They believe that increasing taxes on the wealthy alone won't close the gap and that middle-class tax hikes are inevitable. That's why they are protesting, and so it's relevant for us to ask whether these people are patriots or pinheads.

So what does \$7 trillion really represent? It's always difficult to deal with numbers that large, because they cease to have any meaning to most ordinary Americans. Perhaps the following facts will help. According to the Internal Revenue Service, the top 1% of Americans collectively earned \$3.1 trillion. To balance the budget on their backs we're going to have to tax them more than twice what they earn in an average year. Suppose that we expand this to the top 10%. These Americans collectively earned \$6.7 trillion, so we would have to tax them slightly more than 100% of what they earn in an average year. Neither scenario is likely to occur, because these people will simply stop producing income at these levels if we really try to take that much away from them.

This means the administration will have to move further down the income ladder to finance its spending plans. If it goes down to the top 25% of Americans – those who collectively earned \$9.7 trillion then at least we will be trying to tax away less than 100% of their average annual income. The problem here is that any family earning over \$64,700 falls into this top 25%. I don't know about you, but this seems like a fairly middle class existence to me.

At first glance, it sure seems as though the tax protesters have the upper hand in this argument. To confirm or deny that preliminary conclusion, let's consider the "fairness" issue. We've all been conditioned to believe that higher income earners should pay a larger share of the total tax obligation in this country. Granting the validity of that assertion for the moment, we still need to define "fair". Consider the following:

The top 1% of Americans produce 22% of the wealth in this country, but they pay 40% of the total tax burden.

The top 10% of Americans produce 47% of the wealth in this country, but they pay 72% of the total tax burden.

And that top 25% of Americans (remember the middle class families earning \$64,700) produce 68% of the wealth in this country, but they have to pay 89% of the total tax burden.

By way of a quick comparison, the bottom 50% of Americans pay only 3% of the total tax burden.

I don't think any reasonable American - Republican or Democrat - can say that these numbers represent a fair allocation of responsibility. You will probably note that in the course of this article I've changed the word "earn" to the word "produce". That's been purposeful because what's often missed in the whole debate is the fact that people who earn money have to produce something first. More often than not, the middle class family earning \$64,700 has had to work very hard to produce a product or deliver a service to their employer or their customers in order to earn that money. This isn't just money they somehow take away from others; this is money they earn from hard work. These are the last people that we should punish, but that's exactly what the new budget and tax mandates will

There is no way to escape the fact that taxes on the middle class will have to increase substantially if the Obama administration's spending policies are actually implemented. But that is not the worst of it. What has been left totally unaddressed in this debate are the unfunded liabilities of Social Security and Medicare. The most realistic conservative estimate I've seen indicates that the Social Security liability which has not yet been collected in taxes (that's what unfunded means) is \$100 trillion. That's 6.5 times the size of our entire economy. The Medicare liability which has not yet been collected in taxes is \$52 trillion, a measly 3.5 times the size of our economy.

What the tax protesters know is that 2009 should be the year of spending and tax restraint, not pork barrel spending. What Congress and our President are doing is simply unconscionable and, as John McCain phrased it, represents inter-generational theft. The levels of spending are not sustainable, and the levels of taxation required to pay for it all cannot realistically be collected. There just aren't enough Americans who will work hard enough at the necessary tax levels to produce sufficient tax receipts.

So, in a perfect world where the press was really objective and took just a moment to check its facts before demonstrating its collective ignorance and arrogance, we would hear tax protestors described as patriots, not pinheads, and the degrading sexual innuendo would be left in the junior high locker room where it belonged.

The World Around Us

April: Jazz Appreciation Month by Pat Birdsall

While in the waiting room of my pet's veterinarian, I overheard an exchange between a man who appeared to be in his eighties and a woman in her early forties. The woman had a handsome Golden Retriever that she called Bix. The man asked her to repeat the name and then proceeded to tell her about the great jazz virtuoso of the twenties, Bix Beiderbecke. The woman said that Mr. Beiderbecke was related to her grandmother somehow, and indeed the dog was named for him. The man went for a stroll down memory lane and, judging from the smile on his face, was enjoying the trip as they discussed the career of the late cornet player. It piqued my interest enough to find out

more about the man who is still revered today. Bix Beiderbecke

Leon Bix Beiderbecke entered this world on March 10, 1903, in Davenport, Iowa. His father operated a successful fuel and lumber company. His mother was a gifted pianist. Bix had a few piano lessons and learned to play at an early age, but he was self-taught on cornet and developed an unorthodox technique by playing along with recordings. His musical ear was so amazing that he didn't learn to read music. He became immersed in jazz, and his family disapproved. In addition, his academic performance in high school was inadequate, so they sent him to school at the Lake Forest Academy in 1921. The opportunity for Bix to play and hear jazz in nearby Chicago caused frequent truancy and eventually his expulsion. He spent several months working for his father in Davenport, but turned to a career in music where he felt at home.

Based in Chicago, Beiderbecke became known through his playing and recordings with the Wolverines in 1924. He then played with Frankie Trumbauer's band in St. Louis. In 1926, Bix joined the Jean Goldkette dance band. Radio broadcasts brought Beiderbecke nationwide acclaim. In 1927, he joined the Paul Whiteman orchestra. His polished sound



and precise rhythms fit beautifully with the symphonic sound of Whiteman's orchestra. Beiderbecke's originality made him one of the first white jazz musicians to be admired by black performers. Louis Armstrong recognized in him a kindred spirit.

From 1929-1931, Beiderbecke's health deteriorated. The excessive consumption of bootleg gin and little nourishment ravaged his young body. In 1931, Bix had a cold that lasted throughout the summer and he was extremely weak. He died in the evening-- August 6, 1931, at the age of 29.

Although his career spanned only a sixyear period at the time of his death almost 80 years ago, and he was largely unknown to the general public, his luminous playing has left an indelible mark in the world of jazz.



We may need to shake our piggy banks to put some change in our pockets and purses before heading out to shop in the near future. After Tuesday's passage of the "California Bag Tax" by the State Assembly's Natural Resource Commission, forests and oceans may begin to breathe a sigh of relief now that shoppers will be faced with the prospect of paying 15 cents for every carryout bag used to pack purchases at the checkout counter, plastic or paper. For now, consider the threat of this surcharge as a voluntary reduction measure similar to one enacted by the LA County Board of Supervisors in January of

AB 2058 would impose the 15 cents tax if future recycling goals (to be determined) are not met by grocery store chains and large drug stores over the next three years. This state law is prompted by the proliferation of plastic bags in our environment. We could probably blanket the entire state with a tarp constructed of plastic from the 14 billion bags used in stores across California to pack our purchased items. Fewer paper bags would translate into more trees left standing in our ecosystem to manufacture oxygen and help filter the air to make it both possible and healthier for all of us to breathe.

Some of us are grateful that the more restrictive AB 2829 didn't pass. That would have added a price tag of 25 cents per plastic bag to shopping outings starting July 1st. Some of us, along with environmentalists, are disappointed that the legislation and actions aren't more restrictive and immediate. Whether for or against, the data reflects our wastefulness as a society and our collective resistance to anything that impedes on our attachment to convenience of our disposable with paper or plastic.

If we could trust our Legislature to use these proceeds to fund litter prevention and reduction efforts as proposed, it would be easier to accept a bag tax. But given the history in Sacramento, it is very likely these tax funds will be redistributed elsewhere once the revenue flow is well-established.

The hype about the new state tax is tempered by the fact that nothing of significance is slated to happen for several years. At least our County ordinance has the appearance of more serious intentions, with July 2010 as the stated timeline for imposing a ban on the use of plastic bags if a 30% reduction is not met, with the ultimate goal of a 65% reduction by

Consumer use of plastic bags is approaching the half century mark. Saran Wrap was introduced by Dow Chemical in 1953. Plastic bags sold on a cardboard roll were on stores shelves by 1957, with the Baggies brand taking top billing. When Union Carbide manufactured the first disposable green garbage bags for home use in 1960, their usage became as American as apple pie. The supermarket industry began to offer us the option of "paper or plastic" in 1977.

The list of contemporary disposable plastics has expanded to include millions of products, include water bottles, diapers and other items used by some segment of the population. But plastic is the type of carryout bag used by the majority of shoppers in the U.S. With the new bag tax lying in wait, I feel motivated than ever to purchase a few reusable shopping bags to do my part on behalf of the forests, oceans and landfills. My only dilemma is deciding whether to pay

On Line "GhOst RATs" and the "GhOstnet" with P.J. Carpenter

Here's Something To Think About:

Representatives of the Tibetan Government-in-Exile recently asked the Information Warfare Monitor group to investigate suspected incidents of Cyber-Espionage committed against their organization. The results of that investigation were truly eye-opening and the results shed a considerable amount of light on just how good the 'bad' guys have gotten. Well-organized, Wellfunded and Government-Sponsored (allegedly), this latest breach utilized tools and techniques that proved to be hard to defend against, even though they've been known about for years.

Users began thinking something was amiss when their computers started acting strangely. Further investigation showed that their machines had been compromised by a Trojan program called "Gh0st RAT". A Gh0stnet is a collection of machines compromised with the Gh0st RAT Trojan. It is believed that the initial infections came about through e-mail attachments. After the first machines were captured the infection spread within the organization. In a nutshell, this Trojan gave the attackers full control over the compromised machine and allowed them to search for other targets to infect. Machines

that had been taken over were literal fountains of information in the hands of their controllers. Files and programs were mined for contact information, passwords, sensitive documents, distribution lists, etc. This information was in turn used to compromise even more machines.

Researchers suspect that the attack may have been politically motivated because of the choice of the target and the lack of any real collateral or financial damage. The aim appeared to be disruption of the organization of social activities on behalf of the Tibetan Government-in-Exile.

The attackers gained entry into the network and organization through basic social engineering techniques. Social Engineering attacks rely on getting the intended victim to take an action based

trust. In this case the recipients of the infected emails were persuaded to download e-mail attachments because they appeared to come from a trusted source. Once inside the perimeter the attackers were able to convince even more users to take the bait because it appeared to come from known sources and had relevance to the business routinely conducted by the organization.

Caring for your Companion Proper Pet Nutrition

"When I was a kid, we fed our dog scraps and he never went to the vet except for shots!" Well, when my grandfather was a kid, bloodletting was still considered advanced medical treatment.

Times have changed, in human and veterinary medicine. In fact the tide seems to be turning in the favor of our four legged friends. Where previously they were used for research to help humans, the treatments once only afforded us are now available to dogs and cats. Newer and safer medications, MRI, CT scans, radiation oncology, total hip replacement, cruciate ligament repair, kidney transplantation, dialysis, open heart surgery, even brain surgery are now helping our furry companions live longer healthier lives.

There's even one aspect of health care where we exceed human care, Nutrition. Through specially formulated, consistent diets, we can not only keep pets healthier, but even treat diseases. Arthritis, kidney failure, urinary tract disorders, diabetes, chronic ear infections, even a brain disorder similar to Alzheimer's can be helped with special diets. Yes, there are still animals that you can throw any food at and it will live a long, relatively uncomplicated life. My neighbors had a car like that too... never changed the oil, just kept adding to it. Those pets, and cars are the far exceptions though. Every day, veterinarians see loved pets who through ignorance, finance, or marketing are not getting proper nutrition. Generally speaking, if you feed your pet high quality foods, you'll have fewer medical problems throughout its life.

Supplements don't make up for poor nutrition. Yes, supplements can be very beneficial when they are targeted at a specific need. They can

they are not. As an example, I'm a great fan of Glucosamine and chondroitin for osteoarthritis of certain joints. Many well meaning people put their companions on various forms of these chemicals because they see stiffness, lameness, or difficulty rising. Too many times, in doing so without a diagnosis, they're not only not helping, but prolonging the problem and depriving their pet of appropriate treatment. Take for example stiffness or limping in the rear legs. While there are a myriad of conditions that can cause this, the most common are arthritis of the spine, hips, and stifles [knees]. Spinal arthritis responds to little but antinflammatory and pain relief. Hip arthritis, in its early stages, generally does well with glucosamine and chondroitin supplementation. Stifle issues are usually secondary to injury of the cruciate ligament, and is a mechanical instability. While we use supplements to help in the recovery process, this condition requires surgical repair. Furthermore, all supplements are not created equal. You generally, though not always, "get what you pay for". The number of milligrams may be the same from bottle to bottle, but the bioavailability, that is the amount the body can actually absorb and utilize can vary from 98% [best product] to as low as 20%.

Supplements may also be harmful. Used in excess, vitamins like A [liver issues] and C [urinary bladder stones] can be harmful.

"HOW THE EARTH GOT ITS WATER" is the title of a public lecture by George W. Preston, Director Emeritus, Carnegie Observatories, on

Sunday, April 26, 2:30 p.m. at the Altadena Library. Water is the most precious compound on the surface of the Earth. How and when it got here are matters of vigorous current debate. Dr. Preston, who has spent more than a quartercentury studying the chemical evolution of stars in our Milky Way galaxy, will describe the issues surrounding our planet's water, and offer a few opinions about its origin.

This lecture is free of charge, and all are welcome. There will be light refreshments beginning at 2:00 p.m. The Altadena Public Library is located at 600 E. Mariposa Street in Altadena, two stop signs west of Lake Avenue at the corner of Mariposa and Santa Rosa Avenue ("Christmas Tree Lane"). The talk is sponsored by the Mount Wilson Observatory Association (MWOA), a group of volunteers assisting the Observatory in public outreach. WATER SEEMS TO BE QUITE ABUNDANT throughout the Universe, but finding it in a liquid state is another matter. Since water becomes ice below 32 degrees F and steam vapor above 212 degrees F, the temperature range for finding it in a liquid state is quite limited, and no planet other than Earth has yet been discovered where such conditions exist.

Ice, however, does exist in great abundance in comets, as well as in the moons of the outer planets-Jupiter, Saturn, Uranus, Neptune, and


A comet is a Small Solar System Body that orbits the Sun and, when close enough to the Sun, exhibits a visible coma (atmosphere) or a tail—both primarily from the effects of solar heating upon the comet's nucleus. Comet nuclei are themselves loose collections of ice, dust, and small rocky particles, measuring a few miles or tens of miles across.

As of November 2008, there were a reported 3,572 known comets, but this probably represents only a tiny fraction of the total potential comet population—the reservoir of comet-like bodies in the outer solar system may number one trillion.

Did all of Earth's water come from impacts by comets, some billions of years ago, back in the earliest years of the Solar System? My guess is that most of it, at least, did—but we surely will have a better idea after next week's lecture. As a lifelong weather-watcher and

former lakeside dweller, ice skater, and skier, I feel a certain kinship with water, vaporous cloud, snow, and ice—whether as near at hand as the raindrops on my head and the sea-fog drifting in, or as far away as Halley's Comet and Jupiter's icy moon Europa. I propose a toast to Earth's lovely water in all its forms—to ponds and lakes and oceans, to towering clouds full of rain, to snow-peaks and glaciers and ice-rinks. And may we find such wonders in far-off worlds as well.

"A million icy comets move between these worlds, Ancient beyond measure, back to the first snow;



Europa's great ice-floes groan, crack and shine and

workout goals when – four or five days a week -- we do a bit of stretching, then hop on the exercise bike or treadmill, or go walking.

Is something missing something here? Absolutely, say the experts. We're missing one of the key components that make our exercise sessions complete. We're not getting strength training.

The best exercise program includes four different components, according to the National Institute on Aging (NIA): endurance (such as walking or cycling) to strengthen the heart and circulatory system and improve overall fitness; stretching to promote flexibility and keep limber, and to prevent injury during the endurance phase; balance to help maintain stability and prevent falls; and strength training to build muscle tissue and reduce age-related muscle loss.

We're not talking about training to enter body building contests! We're just talking about how strength training can improve your daily functioning. Sarcopenia, the technical term for muscle loss, can be noticed as early as the 40s and may result in a loss of muscle strength of approximately one percent per year. If nothing is done to counteract this decline, one potentially may lose as much as 20-30 percent of muscle strength by the 60s and 70s. So it's small wonder that many seniors complain of difficulty opening jars, lifting items, or even getting up out of chairs. We all know this when we get down on the floor and then do this awkward multistep routine just to get up.

Strength training works muscles against some type of resistance; this makes the muscles contract with greater force. Over time, the result is stronger muscles and in some cases, increased size. Many benefits come from this: improvement in muscle function and

Some of us are satisfied that we've met our flexibility, increased bone density, reduction in symptoms associated with diabetes, heart disease and other chronic conditions, lowered body fat, and increased self-confidence in looking more fit. Strength training increases muscle strength and balance. It also decreases pain and improves flexibility.

So what does strength training entail? You should work all major muscle groups--the upper arm and back of the arm, shoulders and upper back, chest muscles and middle back, abdominal muscles, thighs, hamstrings and

Just as important as doing the exercises is carrying them out properly and safely by stretching before the weight-lifting, starting slow, and repeating them two to three times per week, on nonconsecutive days. It's especially important to consult your physician before beginning an exercise program if you have previously been inactive. Slight fatigue and soreness is normal after strength training but pain and exhaustion is not.

The equipment you use need not be expensive – you can purchase elastic bands, rubber tubing, or weights. Try using soup cans as weights. You may wish to join a fitness club or YMCA. The local "Y" usually has programs of this type for seniors for minimal cost. Also, check with your city Parks and Recreation Dept. for free programs.

So, get your information, and get it in gear! No excuses. It's your life, live it.


(for your crock pot) Ingredients:

With Some Polish and aALittle Love This Pasadena Diamond **Could Shine Again!**

ck in 1907, Thomas and Nina Stocks, Ohio natives, built their Arts and Crafts style dream home in northwest Pasadena. Mr. Stocks helped establish Pasadena's National Bank of Commerce in addition to his clothing business. Thomas Stocks gained notoriety in 1911 as the neighborhood hero, saving an adjoining Los Robles neighbor's home from fire.

The property remained in the Stock family for 102 years, passed on to relatives over the decades. Alas, the final Stock family member has moved away from the family homestead. The listing

agent can literally claim it's on the market for the first time in a century!

Though the actual architect is unknown, well-respected contractor, Christian Hansen, who also built homes for the renowned Greene brothers. He constructed the main home in a transitional style blending Craftsman and Colonial Revival styles, with a "rubble" stone (which we now call Arroyo stone) foundation and perimeter wall, arched dormers, gables and a distinctive stone porch. That original two story home is one of three residential structures totaling 4549 square feet of living space on the 0.55 acre land parcel.

If you compare black and white photos right after completion to today's images 102 years later, beautiful overarching trees have formed a shaded canopy over this neighborhood since the main home was built. You'll find children at play. You'll find many homes lovingly restored. Some, like this one, await that inspired buyer who wants to restore and update a unique home with real character, some land around it... and even some rental income if they desire.

In 1915 a two bedroom home, apparently intended as a rental property was constructed on the southwest corner of the large parcel, facing Elizabeth Street. Today, it still affords that possibility, with little impact on the lifestyle and privacy of the main home.

In 1925, a large building we might today call a pool house or guest house was constructed. The called it merely "the hall." Others called the nearly 1000+ square foot structure "the ballroom" referring to the Stocks' love of dancing and dance parties. It includes a full bath, kitchenette hookup and certainly room to create a full kitchen, a music or sitting room and finally the huge ballroom. My mind races with possible uses in today's lifestyles... A magnificent home office, a guest house, a pool house... even a workout space for "Dancing with the Stars!"

In the last ten years of Thomas Stocks' life, he became blind, and it's said he constructed high, above grade rims around both the swimming pool and the koi pond (both currently drained) to prevent his accidental immersion.

Much of the wood used in the homes is redwood, providing it with an amazingly good "bill of health" from the termite man. Especially for a 102 year old main home!

Though Pasadena's Cultural Heritage Commission notified the owners in 1985 that it might qualify for local landmark status and listing on the National Register of Historic Places, it



appears no action was taken in this regard. In addition, the home is apparently not currently in the Mills Act, a tax reduction status which encourages the maintenance of historic homes. This status could be a plus or a minus, depending on what the future owner has in mind for the parcel.

The Stocks property, at the corner of N. Los Robles and Elizabeth in Pasadena, is offered at \$1,100,000. It stands ready for a buyer with a passion for character homes and a little imagination, to repolish this diamond to its original shine.


