1 Carter/Stonehouse Settlement/Tolling **Approved With Conditions**

Council Authorizes Execution of Agreement By Susan Henderson

In an effort to end the ongoing battle between the residents and officials of Sierra Madre and the Developers of the One Carter/ Stonehouse projects, the Sierra Madre City Council unanimously approved a motion to, "...authorize the City Manager and Mayor, subject to the City Attorney's approval as to form, to execute a settlement and tolling agreement in the form presented at the meeting with the following changes and additional terms:

1. The exceptions [to the city's existing codes for grading within Slope Category 4 on Lots 4,5,and 6 shall be removed;

2. The exceptions to the height limits for Lots 4,5,6,18 and 19 shall be removed;

3. The property owner shall meet with neighbors immediately adjacent to Stonehouse and One Carter prior to submission of the CS Settlement Proposal Plan for processing by the city; and

4. The land included in Lot 3 on One Carter shall be permanently restricted and dedicated as Open Space."

The Agreement will stop the clock ticking on the numerous lawsuits that have been filed by both the current and previous owners and work towards a complete settlement of the litigation.

The vote came after years of discussions with the developers of the property and residents. And, although the authorization passed unanimously, not everyone is happy about it.

Resident Tracy Thomas, who sides on Lilliano Drive which borders the Stonehouse Project, spoke on behalf of her neighbors. She says that the community wants to see the strict application of the Hillside Management Zone, which resident Angelyn Moore earlier in the evening said, "reflects the values of the community."

The proposed agreement allows for some exceptions to the HMZ and Moore would like to see only those exceptions that are not 'offensive' to the community allowed.

The Hillside Management Zone is at the heart of all the litigation on both the One Carter and Stonehouse developments. The claims against the city range from challenging the HMZ standing on the One Carter Property to whether or not the passage of the HMZ was done in accordance to state law.

Residents near Stonehouse have asked that the HMZ govern all home sizes and heights and are built on lots no less than 25,000 square feet. They want the construction period limited to 7 years, with lots to remain in the current condition until owners are ready to develop. They also want strict management of the tree screening and watering and Lot 18 allocated for Open Space, similar to the request on Lot 3 at One Carter.

Since the original owners of the properties, Dorn Platz, defaulted on their loans, the properties were taken over by Capital Source Funding (CSF). CSF was represented at the council meeting by Susan Hori, an attorney with the high powered law firm of Manatt, Phelps & Phillips, LLP, and Brian Salsner, Director of the project. Both Salsner and Hori stated that Capital Source had been working with city staff to try and address some of the city's concerns.

Horipointed out to the council that they have made several changes to the original settlement plan including decreasing the number of units on Stonehouse from 35 to 20. Said Hori, "Our desire is to arrive at a point to finalize the Settlement Agreement."

Salsner told the council that Dorn Platz was in no way affiliated with Capital Source. "We had issues with Dorn Platz. We were appointed conservators, not partners. We have our own litigation with them." He went on to ask the council and residents to, "Judge us by our actions."

However, whether or not residents will ever the developer of the projects is doubtful.




DUARTE HISTORICAL SOCIETY SPONSORS BIRD WALK







Jean Guyot: 104 Years Young

When I was given the in here is an antique, assignment to interview Jean including me". Guyot, a 104 year old resident of Villa Gardens Retirement community in Pasadena, the first thing that came to my mind was an interview that I had seen recently on television about a woman that had just turned 100 and the difficulty the interviewer had in getting his centurion to speak at all. For that unlucky reporter it was 'no deal', she was not talking. So this image being fresh in my mind, I had no idea what to expect.

It was 9:00 AM when I arrived at Villa Gardens. As I walked into the lobby I felt more as if I was walking into the lobby of a five star hotel. I anxiously waited for the administrator, Silvia to introduce me to Jean. On the way up in the elevator I asked Silvia if Jean was an assisted living resident. Silva looked at me and in a very "matter of fact tone" told me " Jean is a resident here and she does not need assistance".

This aroused my curiosity because my Mom was a centenarian and while I, myself am not a "spring chicken" and every now and then I could use a little assistance of some kind

When we reached Jean's unlocked and Silvia and I walked in. My first reaction was that of amazement. There, organizing her gift wrapping, was Jean - a tall fit woman, without a hair out of place and dressed to the 'nines' in a blue and white silk blouse, a tailored blue skirt and black (not too high) heel pumps.

Silvia introduced me and we went into Jean's meticulous, well-appointed front room to talk. When I mentioned how well dressed Jean was, Silvia immediately said "and she did not dress up for you, she dresses like this every day".

While Jean did use a walker because of a recent hip surgery, I felt as if the walker was merely a precautionary measure and she was using the walker to please those around her. To say that Jean's presence was amazing is an understatement.

Her apartment at Villa Gardens was beautifully furnished with lovely antiques and mementos of a well-lived life. When I asked her about the antiques, she said without missing a beat, "I guess you could say that everything

Jean was born in Los Ángeles in her family home located in the middle of downtown LA on October 17th, 1905. There were no automobiles then and Jean remembers the preferred mode of transportation at the time was the "Red Car" an electric streetcar that was the most efficient method of mass transportation. Jean suggests that now it probably would not work as well because there are far more people than in the early days of Los Angeles.

Her memory is extraordinary. She remembers her father's first car. She was six years old and his car was a Regal, though she doubted that they made them

A University of Southern California graduate in 1927, and she fondly remembered that her father, a football fan, insisted that she go to USC because they had a great football team. Jean's father, a prominent Los Angeles football and according to Jean, it - Joe Ditullio was my first wanted to play football but was cello teacher! not big enough.

After graduating, she went to New York and studied Library Science at Columbia University. Jean has always loved to read, and has been a veracious reader her entire life.

I asked her if her late husband of over 50 years also loved to read and she remarked, would call him a book worm".

When I asked her what she would attribute her long and healthy life to, she told me that she was very fortunate in her life. She considers her life ordinary, but she always had a place to live and food to eat, and she felt very lucky.

I also asked her about the "stress factor" in her life and she told me that she really never remembers feeling stressed or being stressed, and considers herself a homebody. The Guyots were disappointed that they did not have children, and were able to adopt because both her husband and she were too old (at 40) to qualify for adoption.



As fascinating as the interview was, there was one amazing piece of information that astonished me and proves that this is truly a small world.


As we were winding up the interview, Jean asked me, Well, you have asked me lots of questions, what about you?" I told her that I had gone to Cal Berkeley majored in music performance and played the cello. I could not believe

> She went on, "It was such a pleasure living next door to a steady diet of classical music". She then told me that for a short while a band moved into the house on the other side of her by the name of Chicago. "They did not stay long because they were renting". She remarked that being between the two musical groups, the Ditullio's and the band *Chicago* gave her an experience in music appreciation she would never forget.

MTA Approves Seeking Gold Line **Extension Federal Funding**



A motion Thrusday Supervisors Mark Ridley-Thomas, Michael Antonovich and Duarte Mayor John Fasana to make the Gold Line and Crenshaw Line the top MTA priorities for new federal, state and local funding was strengthened by the demands of a bipartisan coalition of 15 congressional representatives in Southern California.

"The attempt to jumpstart the unfunded subway extensions over the longawaited Gold Line and Crenshaw Line was derailed by a unanimous vote of the MTA Board," Antonovich said.

This team effort helped bring a regional package for federal funding to ensure equity for all parts of the County. For the first time ever, MTA will commit to fund and operate the Gold Line to Claremont . Also, MTA will commit to fund needed grade separations and improvements to the Crenshaw Line to LAX.

In addition, the Antonovich/ Thomas/Fasana motion also provides for an evaluation of the allocation of funding for the Interstate 5 improvements from I-605 to I-710 and from SR-14 to the Kern County Line to improve major goods movement corridors in Los Angeles County.

He then pulled Barnes out of the vehicle still holding the gun. According to the report Barnes then fell to the ground with both his hands concealed under his body. Fearing Barnes still had possession of the handgun officers opened fire. Barnes was shot 11 times, including seven in the back.

The report also states Barnes was a known gang member and on active parole at the time. He was convicted of multiple prior felonies including, assault with a firearm, assault by means likely to commit great bodily injury and felon in possession of a firearm.

During an interview, the driver of the car told investigators that Barnes told her not to stop for police and attempted to grab the gearshift while telling her to drive away.

Lawsuit to Remove Surveillance Systems From **Metrolink Trains Criticized**

The Brotherhood of Locomotive Engineers and Trainmen (BLET) took legal action this week in both State and Federal Court to try and remove recently installed video surveillance systems from Metrolink trains.

Metrolink Director, Supervisor Michael Antonovich criticized the actions.

"The union's lawsuit to derail Metrolink's efforts to prevent future tragedies is stupid and irresponsible," Antonovich. "After months of investigations and studies to enhance safety, Metrolink spent over one million dollars installing cameras to prevent deadly mistakes and protect our passengers, the public and

According to the BLET website, "The Federal lawsuit charges the installation of video cameras inside locomotive cabs violates the Railway Labor Act. The cameras were installed in violation of the railroad's collective bargaining agreement with the BLET."

It also states, "That the installation of cameras violates federal wire tap laws as well as the Federal Rail Safety Act of 1970."

JPL iPhone Developer Speaks as Part of Tech Week

Who knew that every JPL employee is given an iPhone as part of a deal made by AT&T and the contracted government laboratory? Apparently not many attending this year's Los Angeles County Tech Week in Altadena as Mobile Application Engineer Joe Estes casually mentioned it as part of a panel discussion Thursday to a few surprised

participants.

Estes even said that AT&T went so far as to put a cell tower on 177 acre campus although not everything was bliss for those in love with the sleek device.

After another speaker from JPL Kevin Klenk spoke about problems with cell service in the buildings, Estes explained how an app he wrote helped with the situation.

"We find in the newer buildings were we put in a nice glazing on the windows for energy efficiency, it very effectively blocks the wireless signals," Klenk said.

Estes later explained how one of the iPhone apps he wrote, called the "Conference Room Locater," helps with this problem. Most of the wireless access points are located in or near the conference rooms he explained.

"This lets you see where

you are in relationship to an open conference room he said. "And if one is in use the app will tell you where the next open one is." The app can also obviously be used to just find a conference he later said.

Estes also wrote a similar app showing route information and schedules for the local bus system on the campus. He is also working on a collaborative JPL tour guide app he said they hope to soon make public. "You can scroll through and we have actual facts and information, a photo tour and audio tour." Both spoke as part of the

Info2Go panel discussion. According to ganizers, "L.A. organizers, Tech Week events are designed to inform those with an interest in technology about the state of the technology landscape in Los Angeles County."

It's Gary. Are you seeking someone who's involved in the newly approved Emergency Radio Station in Sierra Madre? Yes? Call Gary.

And then there's his role as an inventor of PAL (Personal Alarm Locator) that identifies a firefighter in trouble.

That's Gary. Gary Hood, the ultimate in volunteers.

Gary was an L.A. City Firefighter from 1971

(NAPSI)-If you're Pollyannish, the than they already are--an average of bigger savers than their parents were at the same age.

Then again, some may feel pressured to save out of concern their families might not otherwise be able to afford to put them through college.

With even the wealthiest families' net worth having taken a beating in the recession, a new Opinion Research Corporation survey found that having to help parents finance their college educations was the biggest reason why so many teens--87 percent--said they banked "some portion" of whatever money they receive each month versus just 56 percent of adults who recalled being young savers. Tuition costs specifically weighed on the minds of 62 percent of those teens questioned.

Just to show you how much times have changed, back when those adults surveyed--Gen Xers, Gen Yers and the youngest of the baby boomers--were teenagers, most of them saved up to buy clothes and accessories.

"Today's teens have grown up with an understanding that paying for college is a challenge for most American families," says Diane Young, director for retirement and goal planning at TD Ameritrade. "And since they see higher education as essential to their future success, it's not surprising that they're taking the initiative to start saving now."

They'll have to stash away a lot of tax on earnings

Right now, tuition and room-andboard expenses at public universities average \$14,333 per year for in-state students and \$25,200 for those out of state, according to College Board data. And by the time today's Gen Zer is freshman age, the only safer bet than private university costs being higher

good news is that today's teens are \$34,132 annually-may be that the world will be even more globally competitive.

> One sign that teens are serious about helping foot those bills is that 41 percent of those surveyed had heard of 529 college savings plans. (The "529" refers to a section of the IRS tax code. Immediately, that should be a tip-off that the federal and most state governments have loaded the plans' three different tax-advantaged versions with what SmartMoney.com calls "plenty of perks to make [them] an exceptionally attractive tool" for funding a child's education.)

> Young says the trick is sorting through "the pros and cons" of each, as well as the lesser-known (but also perky) Coverdell education savings accounts, to determine which is right for you. While it's recommended that you consult with a tax adviser regarding your personal tax situation, TD Ameritrade's own Web site can walk you through the process, starting with access to a "College Planner" tool that helps families estimate how much they'll need to save by answering a series of questions. From there, you can choose among:

- Prepaid 529s, which let you lock in public colleges' current tuition by prepaying all or part of the bill through the purchase of "tuition units" or "contracts" issued by the schools. However, only 18 states now offer this option, and most restrict participation to residents.
- Independent 529 plans, which are basically prepaid plans for private universities. Should your son or daughter wind up not attending one of these schools, the money is returned-plus or minus an annualized 2 percent, depending on the performance of the trust holding the money.
- Coverdell accounts, which limit annual contributions to \$2,000, but-unlike 529s--also permit spending on certain qualified kindergarten through 12th-grade expenses.

As for all that teen angst, one way to ease it is through what Young calls a "parent match" that commits adults to contributing a certain amount for every dollar your child saves.

Be warned: Unlike at companies, kids can't be fired to get out of it.

Strong Rhetoric but No New **Promises to LGBT Community**

President Obama continues to exhibit a lack of urgency about the nature and magnitude of many of the challenges facing his administration.

Our economy is in shambles; our national debt is skyrocketing; millions of Americans are unemployed; we are still at war in Iraq and Afghanistan; Guantanamo is still open; and there is still no health care reform.

Add to this list one more pressing challenge: Lesbian Gay Bisexual Transgender (LGBT) citizens are still being discriminated against and are still not being allowed to integrate into mainstream American society.

On October 10, before a welcoming crowd at the Human Rights Campaign's (HRC) annual dinner in Washington, Obama delivered an eloquent speech strong on rhetoric but that did not make any new promises or commitments to the LGBT community.

Obama rattled off other LGBT priorities, including the Employment Non-Discrimination Act, for which he said his administration is "pushing hard," and a domestic partnership bill. And he promised (again) to end the military "Don't Ask, Don't Tell" (DADT) policy.

Obama also promised to defend any of his employees from attacks based on their sexual orientation, a likely reference to Safe Schools Chief Kevin Jennings, who has been under attack from anti-gay right-wing and religious groups. He also trumpeted recent House passage of a federal hate crimes bill and promised to sign it once it reaches his desk.

did he mention the anti-same-sex marriage ballot on your pledge to the LGBT community!" measures popping up in several states, most notably, Maine and Washington State, where the

religious right is organized to overturn recent marriage equality laws.

The President did, however, discuss his commitment to gay and lesbian families, using as an example his invitation to allow them to roll Easter Eggs at the White House.

According to comments posted on the internet by LGBT's after the HRC gala, many are angry and disappointed with the President's speech.

"Obama gave a great and stirring speech—full of sound and fury, but specifying nothing—a spineless insult to the LGBT community."

"Nothing but more words piled higher and deeper. No action; not even concrete promises or timelines for action. Total BS; ridiculous; I'm furious that lots of gay people will probably be satisfied with the crumbs that Obama offered. My wallet has long been closed to the HRC. After Saturday, it's slammed shut for Obama and the Democrats. Screw them."

"All flash and no substance; words and promises are easy. Mr. President it's time to prove yourself and deliver. You have the power to end discharges under DADT immediately. You know there are actions you can take that would ensure equality for LGBT citizens and yet you don't. I have no doubt that you believe in gay equality, but part of your job is to act boldly and decisively. You were elected on a platform of change. Justice delayed is justice denied."



"two sips". She awoke from unconsciousness some time later, bleeding, bruised, with lacerations and other injuries that would require reconstructive surgery. She said up to seven coworkers participated in the assault.

Jones was initially treated by a U.S. Army doctor, who collected evidence for a "rape kit". The kit was turned over to KBR, and then somehow disappeared. (It re-appeared two years later, but missing photos and notes.) She was then held in a locked storage container under armed guard by KBR for more than 24 hours with no food, water or medical care. Two options were given her; either "stay and get over it" or return home, and don't expect a job waiting when she gets there. With a cell phone borrowed from a sympathetic guard she called home. Her Dad phoned their congressman, Rep. Ted Poe (R - TX), who contacted the State Department, and Jones was eventually released by agents from the U.S. Embassy in Baghdad.

The assailants of Jamie Leigh Jones were protected under CPA Order 17, which barred prosecution under Iraqi law. In June 2007, Jones and three other women filed suits against KBR in federal courts in Texas, Florida and Oklahoma. She went public with her frustration that after nearly two years neither the U.S. Justice Department nor any other federal agency was investigating the case, stating, "There needs to be a voice out there that really pushes for change. I'd like to be that voice."

Halliburton's response was that it had spun off KBR so was not liable. The Bush Administration stonewalled Rep. Poe's dogged pursuit of the case. KBR was more direct: Read the fine print in your employment contract. Your only recourse is arbitration - with arbitrators hired by us, behind closed doors, no public record, no

Committee in December 2007, as did others who made clear hers was not an isolated case. The Department of Justice refused to send a representative to explain what, if any, actions were being taken in pursuing the matter - an absence Chairman John Conyers (D - MI) called 'an absolute disgrace'

In May of last year, a federal judge ruled that Jones could indeed bring her case to trial; although her employment contract required arbitration for workplace disputes, the court found her bedroom did not to qualify as a "workplace". Just last month, the 5th Circuit Court of Appeals affirmed the lower court's decision.

At a senate hearing earlier this month, Sen. Al Franken (D - MN) reminded a representative of KBR who asserted Jamie Leigh Jones had already "had her day in court" that Jones had spent almost four years battling KBR for merely the right to be heard. The day before, Sen. Franken saw passage in the senate of his amendment that would ban government funds from going to contractors "sexual assault, battery and discrimination cases" to court. The amendment easily passed with unanimous Democratic support and that of a number of Republicans (including all female

Looking with Bob Eklund Behind the 2012 Doomsday Craze: What You Need To Know







Recipe of the Week: **Downeast Maine Pumpkin Bread**

1 (15 ounce) can pumpkin puree

1 cup vegetable oil

Ingredients:

2/3 cup water

3 cups white sugar 3 1/2 cups all-purpose flour 2 teaspoons baking soda 1 1/2 teaspoons salt

1 teaspoon ground cinnamon 1 teaspoon ground nutmeg

1/2 teaspoon ground cloves 1/4 teaspoon ground ginger

Directions:

Preheat oven to 350 degrees F (175 degrees C). Grease and flour three 7x3 inch loaf pans.

In a large bowl, mix together pumpkin puree, eggs, oil, water and sugar until well blended. In a separate bowl, whisk together the flour, baking soda, salt, cinnamon, nutmeg, cloves and ginger. Stir the dry ingredients into the pumpkin mixture until just blended. Pour into the prepared pans.

Bake for about 50 minutes in the preheated oven. Loaves are done when toothpick inserted in center comes out clean.
