

SMHPS Presents Placques For Famous Landmarks

The Sierra Madre Historical Preservation Society, at their monthly meeting last week, presented 18 bronze placques to owners of historic homes in the city as part of the SMHPS Landmark Plaque Project.

There is a cost associated with each of the placques. Residents participating in the project were asked for funds to supplement what the Society donated. At other times in the city's history, such items were funded by the city via the Cultural Heritage Commission, which has since been disbanded.



approved advisory measure that specified the voters' preference that the increased UUT revenues be used for Public Safety Services. The Committee deferred issuing its final report until the City's audit report is completed. The next meeting is scheduled for January, the 28th at 6:30 pm. in the City Hall Council Chambers.

<u>Canyon Zone Committee</u> – Advisory to the Planning Commission and City Council

The Canyon Zone Committee is developing new zoning standards that would pertain to the Canyon area, thereby replacing the current R-1 zoning standards that currently apply. A construction moratorium is currently in place while the new zoning standards are being developed, due to concerns that development in the Canyon might not be complementary with the unique residential character and rustic setting of the Canyon. Issues such as building massing, lot coverage, building floor area, height, setbacks, and parking are being addressed. The Canyon Zone Committee is currently working on drafting the proposed new standards, and meets every 3rd Tuesday of the month, at 7:00 pm in the City Hall Council Chambers. In addition, a Community Input meeting is planned for January 2009.

<u>General Plan Update Committee</u> – Advisory to the Planning Commission and City Council

This Committee's role is to update the City's 1996 General Plan. The General Plan is a longrange planning document. It provides the City with a framework for action and the direction in which to focus that action. The General Plan is a visionary document and a road map for the next 10 to 20 years; it sets the policy agenda for land-use development, transportation, energy conservation, parks, public services, and shapes future budget decisions and allocation of City services. As possible tasks, the Committee will be asked to develop an overall vision for the future of Sierra Madre, priorities for development within the community, and other land use goals, policies, and objectives. The first meeting will be held on November 17, at 5:30 p.m. The regular meeting date will be determined in the near future, but is anticipated to occur on the first Tuesday of each month, at 6:30 pm in the City Hall Council Chambers.

In addition to the committee above, the City has a number of standing Commissions that are also busy tackling important community projects.

Planning Commission - Advisory to the City

This Commission is responsible for reviewing project applications regarding land use and zoning matters, i.e., variances, development plans, conditional use permits, historically significant homes and landmarks, and associated environmental documents such as environmental impact reports (EIRs), for their compliance with local zoning code and the City's General Plan. The Commission recently revised and updated the commercial zone, identifying the allowable uses and permit requirements for the downtown area. The Commission is currently updating the R-1 (single-family residential) zone, identifying current development standards that have been proven to be problematic or unclear, and amending such standards with the goals of improving the quality of life for Sierra Madre residents. The Planning Commission regularly meets every 1st and 3rd Thursdays of the month at 7:00 p.m. in the City Hall Council Chambers.

<u>Senior Community Commission</u> – Advisory to

need for services and amenities that will enrich the quality of life, provide information and education, and support the emotional and physical needs of seniors in Sierra Madre. The Commission has accomplished some of the <u>Library Board of Trustees</u> - Advisory to the City goals in the 2007 Senior Master Plan through new exercise programs, organizing monthly excursions, hosting special luncheons and collaborating with local organizations for their Lunch & Learn series. The Senior Community Commission regularly meets on the 1st Thursday of every month at 3 pm in the City Hall Council

<u>Tree Advisory Commission</u> – Advisory to the City Council

The Tree Advisory Commission conducts a monthly review of the City of Sierra Madre's Urban Forest and construction projects that may affect Sierra Madre's protected tree species. The Commission has also embarked on developing tree care educational materials for distribution throughout the community, and identifying street tree planting palettes for various Sierra Madre neighborhoods. A Commission subcommittee will soon be formed to evaluate and recommend amendments to the City's Tree Ordinance. The Tree Advisory Commission regularly meets the third Wednesday of the month at 7:00 pm in the City Hall Council

<u>Community Arts Commission</u> – *Advisory to the* City Council

The Commission is charged with approving any public art through the Arts in Public Places Program. The Commission is currently focused on forming a "Friend of the Arts" group. The Commission regularly meets the second Wednesday of the month at 6:30 p.m.

<u>Art Review Board</u> – *Advisory to the Community* Arts Commission

The Art Review Board is responsible for reviewing artwork and making recommendations to the Community Arts Commission regarding the artwork to be included in public art displays in City Hall. The current exhibit, Flowers, is by local artists Igor de Kansky, Carolyn Gravatte, Myra Epstein, and Jane Sameth Fishman. This

exhibition will run through November 13th. The next exhibit will be selected for January 2010. The exhibit is accessible for viewing during City Hall's regular business hours.

Friends of the Arts

The Friends of the Arts group is being created to promote the community's interest in, awareness of, and appreciation for the arts; to provide support and encouragement to artists living in the community; and to increase the community's participation in the arts. The Friends of the Arts group will host events such as the Open Studio Tour in June and the Jazz and Poetry appreciation events in April. The Arts Commission will be meeting to develop bylaws for this new group on November 19 at 7:00 p.m. in the Hart Park House.

<u>Community Services Commission</u> – *Advisory to*

the City Council

The Community Services Commission is responsible for overseeing the City's recreation and community services programs. The Commission oversees the general use of park facilities and matters relating to the community's recreational and service needs. The Commission recently re-established a transportation ad-hoc committee, is working on water conservation awareness programs, approved a new Middle School Co-ed Intramural Sports Program, and approved concept plans for renovations of the Sierra Madre Room and Hart Park House. The Commission regularly meets the third Monday of the month at 6:00 p.m. in the City Hall Council Chambers.

<u>Transportation Ad-hoc Committee</u> – Advisory to the Community Services Commission

The Transportation Ad-hoc Committee was recently reinstated by the Community Services Commission through a request by the Senior Community Commission. The Committee will review the City provided transit services, with an emphasis on the senior community. At its November 16, 2009 meeting, the Community Services Commission will define the scope of this committee and approve the process for appointment to the committee. The regular meeting date and time have not yet been determined.

SMTV3 / Cable Programming Committee -Advisory to the Community Services Commission This Committee meets once a month to work with staff and the Community Media of the Foothills to provide informational, educational and enlightening programs to the City's Community Television Station. This year, the Committee was able to ramp up its efforts and was able to present rebroadcasts of the City's famed 4th of July Parade, Little League Championship and Closing Day Ceremonies, an overview of the City's weekly Farmer's Market, and the Arts Commission's Open Studio Tour. Plans are in the works to cover some of this year's holiday celebrations including an expanded documentary-style presentation on Sierra Madre's annual self-built Rose Parade Float entry. Meetings are held on the first Wednesday of the month at 7:30 am at the Community Recreation Center.

Mount Wilson Trail Race Committee - Advisory to the Community Services Commission

This Committee of close to 30 volunteers organizes one of the City's most popular annual events. Each year 325 runners race approximately 8.6 miles to Orchard Camp and back to Kersting Court. Other related race-day events include the Pasta Feed, Kids Race, Art This Commission assists in identifying the Show, and Beer Garden. This year's race will take place on May 29, 2009. The Committee will begin their month meetings on November 17 at 7:00 pm in the Hart Park House.

The Library Board of Trustees is responsible for adopting policies that guide the delivery of quality public library services to the community. The collection development (the selection and de-selection of library materials) policy was recently approved by the Board of Trustees on September 23, 2009. Trustees participate in planning and implementing library programs and services on behalf of the community by monitoring the Library Strategic Plan. Beginning in January 2010, Trustees will work with library staff to develop new goals and objectives related to the service responses adopted in the Sierra Madre Public Library Strategic Plan. The Trustees regularly meet the 4th Wednesday of the month at 7:00 p.m. in the City Hall Conference Room.

Friends of the Library

The Friends of the Sierra Madre Library provides essential extra funding to supplement any allocated tax support for the Sierra Madre Public Library. The money raised by the Friends each year through membership dues, Best Used Book Sales, Wine and Cuisine Tasting and Art Fair is used for relevant resources, technologies and programs. The garden in front of the Library is enjoyed by the community today because of the Friends' efforts and donations in 2007. Friends Partners, is a new fundraising effort for donors who are willing to commit to an annual gift of \$100 or more. Friends Partners and the Mary Tumilty Endowment Fund make special unfunded projects possible. The Friends of the Library have an annual meeting June of each year.

REMEMBRANCE - James K. Knowles

James K. Knowles, emeritus William R. Kenan professor and professor of applied mechanics at Caltech, died Nov. 1. He was born April 14, 1931, in Cleveland, OH, to Allyan Emma Gray and Newton Talbot Knowles.

He was noted for exceptional teaching and research in continuum and structural mechanics and applied mathematics at MIT, where he received his bachelor and doctorate degrees, and at Caltech, where he was on the faculty from 1958 to 1996 and named honorary alumnus.

He also was known for his leadership and commitment to excellence in science, students, and the greater campus community. In addition to serving as acting chairman of the Division of Engineering and Applied Science, he was a member of the board of the Organization of Women at Caltech and the Kent Clark Stock Company, a group that performed musicals honoring Caltech luminaries.

Honors and awards include an honorary doctor of science degree from the National University of Ireland, the Eringen Medal from the society of Engineering Science and the Koiter Medal from the American Society of Mechanical Engineers. He also was president and fellow of the American Academy of Mechanics and a fellow of the American Association for the Advancement of Science and American Society of Mechanical

Other professional memberships include Society for Industrial and Applied Mathematics, Society of Engineering Science and Society of Sigma Xi. He also was a member of the editorial boards of the Journal of Applied Mechanics, Journal of Elasticity, SIAM Journal on Applied Mathematics, International Journal for Mathematical Education in Science and Technology.

In addition to 100s of professional articles, he



was the author of two scientific books, one with Rohan Abeyaratne. He was the principal invited lecturer at scores of conferences and symposia around the world. Caltech sponsored such a symposium in honor of his 60th birthday.

Caltech also is establishing a James Knowles Lecture in Solid Mechanics for an annual daylong symposium featuring a nationally known scientist with additional lectures by graduate students in the same field.

He is survived by his wife, Jacqueline "Jackie", and three sons – John, Jeffrey, and James – and five grandchildren – Joshua, Christopher, Jeffrey, Jack and Hallie.

A commemoration will be held Saturday, Nov. 14, 10:30 a.m., Sierra Madre Pioneer Cemetery. A Caltech memorial service will be held in January. Special guest speaker, W.W.II Navy veteran Lyle Umenhoffer will recall his personal experience as one of the few survivors of the U.S.S. Indianapolis, one of the most tragic incidents of W.W.II. The San Gabriel resident was a Seaman First Class serving on the U.S.S. Indianapolis in the Philippines Sea on July 30, 1945 when a Japanese submarine torpedoed the ship. The vessel sank in 12 minutes taking down 300 of the 1200 men aboard. Although pregnant women are also a high priority group, the Pasadena Public Health Department has not received any doses of preservative-free adult H1N1 vaccine for use with pregnant women due to delays in spread from person to person through manufacturing of the vaccine.



Annandale Wilderness Area Dedicated

Everyone was optimistic and upbeat during a long anticipated dedication ceremony last week for the Annandale Canyon wilderness area. The canyon near the end of Glen Oaks Canyon is one of the last remaining open space areas in Pasadena to be preserved.

The list of speakers included, Mayor Bill Bogaard, Pasadena Councilmember Steve Madison, and Assembly member Anthony Portantino among others.

"We were able to acquire 20 acres of beautiful open space in Pasadena," Madison said. "And we are dedicating it as open space through the efforts of the Santa Monica Conservancy." Madison also thanked all the neighbors who he said all rolled up their sleeves and "Just went out and did it."

He also said they voted to establish an assessment district to acquire the property. Funds also came from the Santa Monica Conservancy and the city Bogaard said.

He called the area a great natural resource for the future. Portantino went over a history of the funding saying it was the first project to get funding through proposition 84 in the region. The 2006 proposition was a \$5.4 billion bond to improve drinking water, provide flood control, and conserve open

"This [Annandale Canyon] really is a case study of how to take an idea and move it across the threshold with state, local, county and personal funds and effort," Portantino said.

City staff also boasted new hiking trails were being planned making it more accessible for hikers. The area was bought in 2001 as a proposed housing development. With the cooperation of the developer and a group of dedicated individuals from city of Pasadena Linda Vista/Annandale Association, Santa Monica Conservancy, and county of Los Angeles, funds were identified to acquire the property from the developer.

Spotlight on Madre Volunteers Sierra The Caldwells 2 'Pea's' in a Pod

How many couples started romantic relationship donating blood, lying side by side on separate cots at a Red Cross Blood Bank?

That's where Gordon and Mary Lou Caldwell had their first date in Sierra Madre.

Then we went to Pepe's restaurant for dinner," Mary Lou remembered. And after that beginning, they were married one year later on Nov. 7, 22 years ago.

Gordon had been a Red Cross disaster volunteer since 1958. After their marriage, Mary Lou and Gordon made the blood bank scene together, organizing blood drives in Sierra Madre three

times a year for 14 years, collecting over 2,000 units of blood during that time. One of Gordon's jobs was to call -- personally -- at least 300 prospective donors and convince them of the need for blood. If he'd ask them, they'd show up. Besides donating blood, Mary Lou took care of the details of the

Mary Lou had been a Red Cross volunteer since 1988, and has been on the Red Cross Board for both the Pasadena and larger San Gabriel Valley chapter. She joined the Civic Club at the urging of several members, including Dorothy Jerneycic, and served two years as treasurer. She is currently the Commander of Unit #22 and California State Chaplain of the Disabled American Veterans Auxiliary. She has been a docent at the Wistaria Festival "for too many years to count," and, also, Creative Arts Garden Tour.

Gordon joined the Sierra Madre Volunteer Fire Department in 1958, the same year he moved to Sierra Madre. He is the only one still in town who drove old "Snort," the engine with no brakes. He is still a member of the Volunteer Firefighters Association. As owner of Gem Plumbing, he sponsored a Little League team for years and worked on developing Heasley Field. He helped raise money for the second EMT van, and installed the floodlights in Memorial Park (Mike Sizer ran the electrical system). For years, Gordon was on call day and night (mostly night) to provide the propane, which he donated to the Rose Float. He towed the Sierra Madre Float to its starting position in Pasadena three years in a row and had to replace the transmission of his truck as a result.

Gordon has been a member of Kiwanis Club for many years, an officer in both the Veterans of Foreign Wars and Disabled American Veterans. He served as chairman of the Wistaria Festival and was Grand Marshal of the Fourth of July Parade that

The Caldwells work together on many projects. Sometimes I pick up the donuts at 5 a.m. for the Kiwanis Club to sell at Huck Finn Day, while Gordon is always willing to supply the truck and muscle for Livic Club events, we work as a complementary pair," Mary explained. Mary Lou attended Presentation High School in

San Francisco as a fifth generation Californian. She graduated from the University of California Medical Center of Pharmacy with a Doctor of Pharmacy degree. She first worked in San Jose before moving to Southern California.

She was a pharmacist at Good Samaritan

Hospital when she bought the little house next to the Caldwells in July, 1984. Gordon's first wife (also Mary), passed away the following February after a bout with a very aggressive cancer. That house next door was severely damaged in the Whittier earthquake and condemned just one month before their wedding. (She and Gordon have since built a new home on the same site.) When the house was completed, they started their travels in the U.S. and Europe on a part-time basis. Since their retirement, they manage to be on the road three to eight months

Gordon was born in Louisburg, Missouri, and spent his early years on a farm where his dad farmed and served as a carpenter. As the youngest of eight children, Gordon was only 4 years old when his mother died. He now has three living siblings, one 96, one 94, and one 90.

Listening to Gordon remember his early years is like reading a history book. On the farm they had a bull who thought he was a pet, even drawing them in a wagon to haul water to the cattle. Gordon also remembers milking cows, working the farm in every exhausting way. He described his future Navy boot camp as a "vacation," -- you didn't have to get up at 4 a.m.

He attended a rural one-room school and then graduated from Louisburg High Scool. He was drafted into the Navy and served on the carrier, USS Saratoga, during WWII.

After service, Gordon heard that Shell Oil Co. was hiring in California. This is where he met Hal Jordan, his partner in Gem Plumbing for 38 years. They were both hired by Shell Oil on the same day and their friendship started with Hal buying Gordon a hamburger.

Years later, Hal trained to be a plumber and called Gordon to say, "I've just bought a plumbing business in Sierra Madre, California. Let's go into business together." That was in 1958. Gordon, with his first wife and four children, took a big chance and moved to Sierra Madre, where he became known as "Mr. Gem Plumbing." Gordon and Hal sold the business after 38 years, in 1995, and Hal now lives in Greensboro, N.C.

Gordon spoke for himself and Mary Lou when he said, "We have some of the greatest people in the world living here. I would never leave Sierra Madre... I try to make the most of every day.'

Mary Lou: "We volunteer because we both have education, training and talents that we need to share. We love people and enjoy helping."

They truly are "Two 'Peas' in a pod."

being a referendum on the Obama Administration. (Had Democrats won all major races, then I would've done so.) I noticed an interesting trend, though; one having to do Party versus that tea bagger, Fox News, talk radio, Going-Rogue-you-betcha variety.

Robert McDonnell, Republican winner of Virginia's gubernatorial race, emphasized the more "moderate" aspects of his record as a state legislator, such as working to include child care in welfare reform, rather than repeating views expressed twenty years earlier that "working women and feminists" were "detrimental" to the family. He had described as "illogical" a Supreme Court ruling legalizing contraception use by unmarried partners and, according to the Washington Post, said homosexuality "raised questions" about one's fitness to serve as a judge. But, as he explained during the campaign, "my views have changed as I have gotten older." Colleagues warned that he risked losing the support of the faithful by running from his record, but running towards moderation proved

Republican prosecutor Chris Christie defeated incumbent Jon Corzine for the governorship of New Jersey. Christie was best known for his perfect record in prosecuting public corruption cases - going after both Democratic and Republican officeholders alike. He's spoken out in support of alternative energy development, same-sex civil unions and strict enforcement of gun laws. As for Democrat Jon Corzine, despite an impressive record of accomplishment in both the U.S. Senate and as governor, perhaps this wasn't the best time to be running with "former CEO of Goldman Sachs" on the resume.

In both those races, the winning margins were provided by voters describing themselves as "independents". There was also significantly less turnout among the young and minority voters who helped Obama win those two states a year ago. According to polls, where Obama was popular before, such as in Virginia, he remains popular. And unpopular governors, such as Corzine in New Jersey, remain unpopular no matter how much the voters like Obama.

Ballot measures included Maine voters rejecting their legislature's approval of gay marriage. According to exit polls, it appears a major concern was that public grade school curricula would henceforth include arithmetic, spelling, social studies and the "teaching" of "homosexual marriage". Also, it appears it'll be legal to possess, light up and pass around the doobie in the ski town of Breckinridge, Colorado. For political junkies, though, the biggest show was in the 23rd Congressional District in upstate New York, where Republicans have held the seat since the Civil War.

The last Republican to do so was John McHugh, whom President Obama chose to serve as Secretary of the Army. For the special election to fill the seat, Democrats selected Bill Owens, former Air Force captain and business law attorney. The Republicans chose 10-year State Staying up late watching Assemblywoman Dede Scozzafava. She'd been a reliable opponent of gun control, against capelections, none with and-trade, and supported the Bush tax cuts. She significant local impact, also supported gay marriage, was pro-choice on abortion, and supported unions in their efforts to improve the lives of middle-income workers. That proved too much for the Conservatives, who decided to send a message to those daring to deviate from party doctrine, and run a candidate of their own.

Accountant and financial planner Doug Hoffman was selected for his sterling credentials; with the "traditional" wing of the Republican anti-tax, anti-abortion choice, anti-regulation, anti-gay, anti-health care reform, anti-union and very pro-guns. As a sign of his dedication to the cause, Hoffman agreed to move to the district he'd be running in. Newt Gingrich, who endorsed Scozzafava out of deference to local Republican leaders, acknowledged that Hoffman's "rise is a result of Glenn Beck, Rush Limbaugh, Sean Hannity, Fox News ... Gov. [Sarah] Palin and ... former House Majority Leader Dick Armey". Armey, of course, worked for the lobbying firm responsible for inventing the "grass roots" teabagger movement, as well as trying to turn congressional town hall meetings into shouting matches. This was to be the opportunity to show that their movement could not only be grab media coverage but also seats in Congress.

The problem, however, was described in the Watertown Daily Times when it editorialized that Hoffman "showed no grasp of the breadand-butter issues pertinent to district residents". The editorial mentioned such local issues as a proposed "rooftop highway" to Plattsburgh, which Hoffman said hed be open to studying, though the idea "has been around for years". He had "no idea" about environmental concerns raised in connection with widening the St. Lawrence Seaway, and its effect on navigation and the Great Lakes. "A flustered and ill-at-ease Mr. Hoffman objected to the heated questioning, saying he should have been provided a list of questions he might be asked. He was, if he had taken the time to read the Thursday morning Times editorial raising the very same questions. Dick Armey, whom the Times said accompanied Hoffman, dismissed such issues as being merely parochial". The Times concluded its editorial, however, by stating, "it is just such parochial issues that we expect our representative to understand and be knowledgeable about". Over 95% of Hoffman's funding came from outside the district, but, unfortunately for the candidate, so did his supporters - and they couldn't vote. Republican Scozzafava pulled out of the race and endorsed Democrat Owens, who prevailed in the

So after watching the results come in, I learned that we live in a country where voters can like a Democratic president but support a Republican governor; can legalize pot but not gay marriage; and most importantly will prefer moderation and knowledge of local issues over media-friendly extremism. As I see it, it may be confusing and not very exciting, but also somewhat reassuring.



You order much like a to go restaurant, wait in line and they give you a number, the guy behind the counter was as friendly as they make them, I hemmed and hawed over what to order. Are you starting to feel like I did, that he may just help me with a flat tire on the side of the road someday?

We decided on the Ribs, some Pizza and the guaranteed BBQ Beef sandwich. Now before I get into my thoughts and grades, to be called BBQ you must actually have a BBQ, if you notice Tony Romas or Chili's doesn't call their ribs BBQ, they just call them ribs. Okay, just a little background, you seat yourself and I don't mind that, we surveyed the patio, but even with the warmers it was too cold for my tender daughter. So we decided to sit inside. The pizza and sandwich rolled out with military efficiency, of course you do get your own drinks and utensils. We started on the pepperoni pizza at (\$10.99); it was ok, on the edible side. Daughter Lauren gave me half of her sandwich a la carte at (\$6.99). That was okay as well, ditto.. Edible. Okay, last chance the ½ rib slab for (12.99), our server said, "That they were so good, that I'll order extra just to take them home for tomorrow." I must say, they are well trained on the art of upsell at Stonefire. Again... they were okay, if pressed, I would say there were

The restaurant is clean, attractive and what I can see, a well-run machine. I was impressed for only being open a few weeks. Stonefire is a friendly family restaurant, lots of items to choose from on the menu, reasonably priced. It will probably make many top 5 lists as far as family friendly restaurants. Now if you are looking for the best pizza, or the best ribs, or the best Beef Sandwich, it isn't here. But, for a family experience and something to please everyone, check it out.



Monster star 13.1 billion light-years away lived near the beginning of the Universe, and died in the most violent explosion known to exist

Two international teams of astronomers have observed a gamma-ray burst (GRB) from the most distant object ever discovered—a star that died when the Universe was only 630 million years old, or less than 5 percent of its

Dubbed GRB 090423, the record-breaker is also the brightest and most violent explosion known to exist. The explosion, reported last week in the science journal Nature, is thought to have accompanied the catastrophic death of a very massive star, when the star collapsed to form a black hole.

'This observation allows us to begin exploring the last "blank space" on our map of the Universe," said Professor Nial Tanvir of the University of Leicester, UK, who led one of the teams.

Beyond the mere breaking of a record, the age of the newly detected object opens a window into a cosmological era that has not previously been accessible to observation. The cosmic "Dark Ages" are thought to have ended about 800-900 million years after the Big Bang, when light from stars and galaxies re-ionized the previously neutral gas pervading the Universe. Identity Theft And Your Social Security Number

Identity theft is one of the fastest growing crimes in America. A dishonest person who has your Social Security number can use it to get other personal information about you; use your number and your good credit to apply for more credit in your name. Then, they use the credit cards and do not pay the bills. You may not find out that someone is using your number until you are turned down for credit or you begin to get calls from unknown creditors demanding payment for items you never bought.

Identity thieves get your personal information by:

Stealing wallets, purses and your mail (bank and credit card statements, preapproved credit offers, new checks and tax information); Stealing personal mation you provide to an unsecured site on the Internet, from business or personnel records at work and personal information in your home;

Rummaging through your trash, the trash of businesses and public trash dumps for personal data;

Posing by phone or E-mail as someone who legitimately needs information about you, such as employers or landlords; or

Buying personal information from "inside" sources. For example, an identity thief may pay a store employee for information about you that appears on an application for goods, services or credit.

Be careful with your Social Security card and number

Show your card to your employer when you start a job so your records are correct. Provide your Social Security number to your financial institution(s) for tax reporting purposes. Keep your card and any other document that shows your Social Security number on it in a safe place. DO NOT routinely carry your card or other documents that display your number.

Recipe of the Week: Carmel Apple Pie

Ingredients

1 recipe pastry for a 9 inch double crust deep dish pie

1/2 cup packed brown sugar

1/4 cup butter, melted

1/3 cup all-purpose flour 5 cups thinly sliced apples 2/3 cup white sugar

3 tablespoons all-purpose flour 2 teaspoons ground cinnamon

1 teaspoon lemon juice 20 caramels, halved

2 tablespoons milk

Directions

Preheat oven to 375 degrees F (190 degrees C).

To Make Taffy: In a small bowl combine brown sugar, melted butter or margarine, and 1/3 cup flour. Mix well and set aside.

To Make Apple Filling: Place apples in a large bowl. Add white sugar, 3 tablespoons flour, cinnamon, and lemon juice. Toss until all ingredients are mixed well and apples are thoroughly coated. Spoon half of apple filling into pastry-lined deep-dish pan. Top with half of caramels and half of taffy mixture. Repeat process with remaining apple filling, caramels and taffy mixture. Place top pastry over filling and seal well (this is very important--if edges are not sealed, caramel will leak out all over). Cut steam vents and brush top crust with milk or light cream.

Cover pie with foil and place on a baking sheet. Bake in preheated oven for 25 minutes. Remove foil from pie and bake for another 20 to 25 minutes, until crust is golden. Serve warm

Landscape Architecture Professor's Home Studio

John Tillman Lyle, 1934-1998, left a legacy of his life's passion for architecture in his hometown, Sierra Madre and at Cal Poly Pomona, where he was a revered professor of environmental and landscape architecture until his 1997 retirement.

The university's sixteen acre campus of its John T. Lyle School of Regenerative Studies sports a large bank of solar panels, a very visible announcement

of its purpose. The panels are merely the tip of the iceberg in a multi-disciplinary approach to "advancing the principles of environmentally sustainable living through education, research demonstration and community outreach... including low-energy architecture, energy production technology, water treatment... and sustainable community development," according to their website, http://www.csupomona.edu/~crs/.

During his 36 year professorial tenure, Lyle wrote two books on his topic, worked on a Del Mar wetlands restoration and a 1600 acre, Bolsa Chica development-restoration project near Huntington Beach. In between classwork, he also advised the Brazilians on protecting their coastal forests, the Italians on preserving their wetlands and lectured in Japan at the esteemed Kyushi Institute of Design.

At home in Sierra Madre, Lyle designed a studio and guest house in 1984, adjacent to their 1949 Harwell Hamilton Harris-designed home featured in last week's column. According to Harriett Lyle, her husband envisioned a dual purpose, separate space that utilized passive solar energy efficiency and breeze cooling, while complementing and relating well to Harris' main house design.

The result was a dramatic space in its own right that doesn't

overpower or pre-empt the main house. This was accomplished by situating the building downhill from the main house. Conversely, the studio's windows do not look directly up at the main house, so the larger building doesn't overshadow the smaller one.

The studio's downhill site creates a very different perspective from the main house's panoramic LA valley and San Gabriel mountain views. Down below, Lyle has indeed captured his beloved mountain views to the north, but also created a very different, on-grade woodland garden view to the south, enveloped by the sprawling and twisted branches of a majestic and rare Engelmann oak.

His low water usage garden design, featuring rosemary, rockrose, drought resistant arctotheca as a hillside groundcover plus a stone pond with water lilies to minimize evaporation, won a national design award from the American Society of Landscape Architects in 1986.

The passive solar heating system utilizes double stacked windows to collect the sunlight, then stores that heat in a layer of gravel inside the perimeter of the glass. The trapped heat then rises naturally up to the second floor through a slatted area.

The building is designed to be "breeze cooled" through strategic window placement, completing its passive heating and cooling circuit. A rhombus shaped window actually opens to vent out the hot summer air at the top of the tightly-wound spiral staircase and serves as a round frame for second story

An east-facing triangular window mimics the shape of the limbs of a Chinese elm outside the window, creating the feeling of living in a tree house. On the exterior, horizontal and vertical slats tie loosely to Harris' lines and shade function on the main house.

The first floor studio remains intact as John left it before his passing, as if he had just left for a brief walk or a dinner break. One can still feel his spirit there, with drawings still at his worktable and a task light trained at the ready.






