
## SIERRA MADRE MUD REMOVAL: AFTER THE STORM

After surviving the Santa Anita Fire in 2008, the City of Sierra Madre has been fortunate thus far to have withstood subsequent rain storms without personal injury or major property damage. However, with the thousands of cubic yards of mud and debris already coming down the hillsides, and thousands of cubic yards still expected in future storms, one of the main challenges for City staff is the "clean-up" after the storm.

The following is a review of the post-storm assistance provided by the City of Sierra Madre:

- o City streets will be cleared as quickly as possible when it is safe to do so. Public Works crews are not allowed to put themselves or the safety of others in jeopardy to clear a street
- o Neither hand crews nor medium to heavy machinery or vehicles are effective during heavy rains. Shoveling or scooping muddy water is an inefficient use of the City's resources.
- The clearing of streets will be prioritized by considering access for public safety vehicles and number of affected trapped residents.
- o Mud and debris deposited on private property is the responsibility of the property owner. City staff cannot enter private property to remove mud and debris after the storm. o Private property owners are allowed to deposit mud and debris from their property onto the public street, within seven days following the storm, for collection by City crews. (For the most recent, January 18th to 22nd storm; by Friday, February 5, 2010.)
- o Please contact the Sierra Madre Public Works Department at (626) 355-7135 with as much advance information as possible including the location and timing of when the mud and debris will be placed on the street.
- o Under no circumstances can mud or debris be deposited in the streets in such a way as to create a hazard to vehicular or pedestrian traffic.
- o Please be advised that street-sweepers are not designed to eliminate dust or compacted mud remaining after a major storm.

It may take time and patience to return the street to pre-storm condition. The City of Sierra Madre thanks its residents for their understanding and all their efforts to assist with the post-storm clean up.

An unidentified man was taken to the hospital in Pasadena with moderate injuries Friday after his car stuck a Gold Line train leaving him trapped until firefighters could get him out.

Pasadena Police say the accident was reported shortly after 4 p.m. near Raymond Ave. and Glenarm Street.

Pasadena Fire Department Public Information Officer Lisa Derderian said when the PFD arrived firefighters found a silver compact Mitsubishi on its side with a 40-year-old man trapped inside. Rescuers had to cut power to the train for his and their safety. It took about 20 minutes to get free him





regularly to discuss local happenings, and in the video they were, fittingly, having coffee and reminiscing about their old friend. Newcomer to the club Jesse Campo said "I think Sierra Madre is gonna miss him a lot. He was a real good man." Gordon Caldwell noted that "He always had a great big smile, you couldn't miss that smile." Paul Duncan spoke of meeting Dr. Neiby after an accident which had fractured five of his ribs, and drew laughs when remembering the time he went to visit Paul in the hospital and, hearing that he couldn't visit unless he was a relative, informed the staff that Paul, who was about the same age if not younger, was his grandfather. Gary Hood discussed the Neibys contributions to the town's CERT program and their latest cause, the Sierra Madre AM radio station for emergencies. George Maurer recalled that Neiby "...fought a gallant battle to keep Orange Grove the way it is today. He was very passionate with every project he undertook, he followed it to completion." Maurer also recalled one of his last conversations with the doctor, in which he was told "It's important that you not rest on your laurels..." Joe Pergola, echoing Maurer's comments stated that "One of the things I've learned from Paul is - you start a job, you finish a job," adding that the honor being given to Louise and Paul is "most deserved." Bud Switzer reminisced about Neiby's contributions to Pioneer Days and the Veterans Photo Wall, and an obviously emotional Jay Whitcraft talked about working with Dr. Neiby on the Library Board of Trustees, the Oral History Project, and the town archives. He added that "I loved him a lot, it's very hard to talk about, he was a very good guy...He was always there for me...and Joy (Phillips, Whitcraft's partner for many years) all during the time I was taking care of her... very supportive and a very determined man."

Following the video, guest speakers Pat Birdsall (who met the Neibys through Kiwanis), and author Michelle Zack spoke. Birdsall drew some laughs when she recounted a story in which a staff member at a hospital asked how it worked having a doctor and a nurse in the same household, to which retired Nurse Practitioner Louise responded that it worked much the same as in the hospital, with the doctor giving the orders, and the nurse carrying them out. Zack, whose book "Southern California



Story: Seeking the Better Life in Sierra Madre" was recently published by the Sierra Madre Historical Preservation Society and was a pet project of the Neibys, lauded the Neibys for their focus and drive in making the book a reality.

Then the couple received proclamations/certificates from the Chamber, the City of Sierra Madre, the L.A. ### PUSD BOARD VOTES TO PLACE PARCEL TAX ON MAY 4 BALLOT

Measure Would Protect Schools, Libraries, Arts & Music In Pasadena, Sierra Madre and Altadena

Pasadena, CA – Facing the most severe reduction in funding from the State of California in its history, the Pasadena students to succeed in college and careers; ballot. Because of an 18 percent overall cut lessen the impact of state budget cuts. in funding to public schools in California, PUSD faces up to \$23 million in cuts to its schools and programs.

"When Sacramento fails to fund our schools by more than \$20 million, we must take steps to ensure that every student continues to have access to a great education," said Board President Tom Selinske. "The successes and milestones we've seen in our schools deserve stable, local funding so that we can attract and retain qualified teachers, protect college preparatory programs, keep libraries open and continue offering arts and music."

The Quality Public Education Preservation Act of 2010 would levy a \$120 tax per residential and commercial parcel each year for five years, with exemptions for low-income seniors, and raise an estimated \$7.1 million annually beginning in the 2010-2011 year. All funds would benefit PUSD schools and students. The parcel tax requires approval by two-thirds of Altadena, Pasadena and Sierra Madre voters.

> parcel tax was one of the recommendations of PUSD's 2008-2009 Budget Advisory Committee, which helped set the District's funding priorities as the budget situation in Sacramento became increasingly uncertain.

"More of our schools have scored above 800 points on the Academic Performance Index than ever before, and our focus must remain on preserving those gains," said Superintendent Edwin Diaz. "A parcel tax would lessen the impact of severe budget cuts from Sacramento."

Voters in the neighboring school districts of La Cañada, San Marino and South Pasadena have recently approved parcel taxes to protect local educational programs.

## Marathon Will Not Include Wheelchair Class

Wheelchair Racers Angered With Marathon Decision

With less than a month to the Pasadena Marathon, world class champion wheelchair racer Martian Vogel said Wednesday that the exclusion of a wheelchair class does not surprise him. And, although it may not be this year, he has vowed to fight until they let him race. "You could push to have a class for baby strollers, a class for bicycles; they have a woman's class, men's class, they have age groups all the way up to 100 but no wheelchair class? Vogel said. "What if they said woman can't compete, would that be ok? This is my home town and I can't even race here?"

Vogel is a seven time world champion racer winning multiple international wheelchair marathons as well as representing the U.S. during two different Olympics. He is currently ranked 5th in the world in all wheelchair sports.

Money and time, he said, was the reason given by race officials for the omission of the class. "I offered my services to them, I told them I would do it, free," he said. "Organize it, put it together for them, invite the athletes, sponsors, and handle it." Vogel stated that he could easily have a pack of 100 racers from all over the world sign up.

## Filming Closes Colorado Street Bridge Access



#### **Filming Closes** Colorado Street Bridge Access

The Colorado Street Bridge was again set to close both Saturday and Sunday for the filming of a commercial by Duo Films, and with another shoot scheduled Feb, 24, this would shut the bridge down four times, within a 60 day period, an unusually high number for the location according the city's calendar.

This has prompt concerns about access for cyclists and people walking in the wake of the city's recent decision to cut local ARTS bus 70 services across the bridge. The route, which ran east on Colorado Blvd to Avenue 64, ended Dec, 14.

Rain earlier this month pushed off the first filming on the bridge of the year for a new Jack in the Box commercial by Radical Media. The bridge was closed, unscheduled all day Jan, 14, the city's film office confirmed but refused any further comment. The bridge had been scheduled to be used by Radical Media the day before form 5 a.m. to 10

Other inquiries about filming were also directed to the city's website filmpasadena.com in which all the links on a A number of legendary movies prominent filming calendar littered with other broken links. ironically, including ones on the complaints page. No answer was given as to why?

City staff in the film office did said they have been instructed, in general, not to speak with reporters.

The website also gives no information about street closers or specific filming times. Rescheduling is also not mentioned on the site.

The website does say that, "The city requires that film companies provide a written notice on their company stationery to all property owners/tenants within 300 feet of the filming location on each side of the street."

It makes no mention of notice for filming in parks, or other public areas such as city owned public parking lots or open space areas. It also says nothing about filming at historic landmarks or alternative routes for pedestrians during any closures.

A request for an update to a 2001 payroll audit by the Motion Picture Association of America, posted on the site, boasting "\$333 million dollars in production payroll is paid to Pasadeneans employed in film production each year," also went unanswered.

The site states that Pasadena allows filming, as a benefit to the local economy, funding community services such as police and fire. It also says that filming in non-residentially zoned areas is limited to 15 days per quarter, 60 days.

#### Airborne Radar to Study Quake Faults In Haiti

In response to the disaster in Haiti on Jan. 12, NASA has added a series of science overflights of earthquake faults in Haiti and the Dominican Republic on the island of Hispaniola to a previously scheduled three-week airborne radar campaign to Central America.

NASA's Uninhabited Aerial Vehicle Synthetic Aperture Radar, or UAVSAR, left NASA's Dryden Flight Research Center in Edwards, California Monday aboard a modified NASA Gulfstream III aircraft.

During its trek to Central through mid-February, the repeat-pass L-band wavelength radar, developed by JPL, will study the structure of tropical deformation and volcano processes; and examine Mayan archeology sites. After the the Haitian earthquake, NASA managers added additional science objectives that will allow UAVSAR's unique observational capabilities to study geologic processes in Hispaniola following the earthquake. UAVSAR's ability to provide rapid access to regions of interest, short repeat flight intervals, high resolution and its variable viewing geometry make it a powerful tool for studying ongoing Earth processes.

"UAVSAR will allow us to image deformations of Earth's surface and other changes associated with post-Haiti earthquake geologic processes, such as aftershocks, earthquakes that might be triggered by the main earthquake farther down the fault line, and the potential for landslides," said JPL's Paul Lundgren, the principal investigator for the Hispaniola "Because overflights. UAVSAR uses a technique called interferometric synthetic aperture radar, or InSAR, that sends pulses of microwave energy from the aircraft to the ground to detect and measure very subtle deformations in Earth's surface, such as those caused by earthquakes, volcanoes, landslides glacier movements.

Flight plans call for multiple observations of the Hispaniola faults this week and in early to mid-February. After processing, NASA will make the UAVSAR imagery available to the public through the JPL UAVSAR website and the Alaska Satellite Facility Distributed Active Archive Center.

#### Surf and Turf in Encino!!!

Can you imagine being at the table the first time that these two

wonderful pairing of this edible king and queen is truly genius. As kingly as this dish may appear, it is actually one of those dishes that can easily be done at home. I have cooked countless steaks in my backyard and boiled many memorable lobsters. But for this article, we are going on a road trip. I had a meeting this week and needed to pick a restaurant that was at a halfway point. Encino was the center of the universe for this trip. I was destined for Delmonico's Steak and Lobster House, where they pride themselves on their exceptional Steak and Lobster. I wore my good tie for this wedding.

Delmonico's is a staple in Encino; you may remember they opened and closed very quickly at The Paseo mall in Pasadena a while ago. They were unable to develop a loyal customer base at that location, but I fondly remembered a business lunch at the Encino location many years ago. With umbrella in hand and rain in the clouds, I was off to Encino.

Surprisingly, I was on time. For some reason I felt compelled to ask the valet, "How is the food?" His reply? A thumbs up and a gleeful smile. The restaurant was half-full at best. Hmm..... Delmonico's not crowded? Well, I guess the tough economic times and a rainy night had left an impact on this evening's crowd. The restaurant has a bar in front with open seating and closed booths running along each side. My choice was the booth. My initial sense was that this was going to be a great meal. The hostess greeted us, and the next person to meet us was a man dressed more in the armament of a manager than a waiter; no matter, we were not attending a fashion show.

Steak and Lobster! When I asked, "How are the crab cakes?", he responded with an enthusitic, "Great, and they would go great with our famous garlic bread." The classic up-sell, very well done and I went for it. were married? The Crabcakes are two medium cakes surrounded by what I could only guess were onion rings (\$12.95). I'll give them a passing grade, but the trip was not worth these items. The Garlic Bread includes four large slices of sourdough bread with garlic shallots sprinkled on the surface, nice touch; usually when it looks good, it tastes good. That held true to form. Okay, appetizer was not so hot, but I'm here for Steak and Lobster, Surf and Turf (\$40.95). The restaurant strongly boasts of the Lobster, even calling itself a Lobster House. The plate I ordered included vegetables, and a choice of a potato. The lobster comes detached from the shell, which is helpful, and the last delectable item is a 6 oz filet. The meal is plenty large enough for this hungry reviewer. The steak is topped with a sauce that I cannot identify, something between a BBQ sauce and a béarnaise. My suggestion, order the filet dry with the sauce on the side. **Anytime** you are ordering an expensive piece of meat there shouldn't be a need for a pool of sauce or

I tried a few bites of this and thought I should have gone fish. All and all, it was a decent experience with mediocre food. If the tribe's-worth of sons (daughters don't count). If the wife was unable to produce, the husband turned to an available concubine. Patriarchs seldom slowed down until reaching the age of 130-or-so; if the wife couldn't keep up, she'd be traded in for a younger model so the begetting could continue uninterrupted.

Throughout the millennia, traditions were strengthened in which wives were regarded as property; expected to tend to the farm and the kids while being unable to make contracts, buy property, participate in community affairs or pursue an individual life outside that of her husband's. Some of those long-standing traditions have only recently been broken, such as by the acceptance of two-career marriages (and of those choosing not to have children), treating domestic violence as a crime and the recognition of interracial marriage. None of this happened without warnings of the destruction of the institution of marriage itself.

Barely forty years ago, my own marriage would not have been permitted in many parts of the country. Arguments used then were similar to those heard today; marrying between races deviated from accepted norms, violated religious doctrine and devalued "traditional" marriage. But most of all - What about the children? (Our son is doing quite well, thank you.) If Greg had been writing back then, he could have suggested we consider why the Founding Fathers chose not to guarantee a right to interracial marriage in the Constitution.

That Greg's definition of the "ideal" marriage may differ from mine is okay; it's a personal matter, after all. That his church might frown on marriages others would lovingly accept is called religious freedom. That he can so easily pass judgment on forms of marriage different from his own might raise questions of a different sort, but he's entitled to his opinion. Where he and others cross the line, though, is in their insistence that not only is their concept of marriage superior, but that others must be and family. 

## Why Gays And Misunderstand Marriage

This week a new battle has begun in an old war. It's not the Afghanistan war or the Iraq war I'm referring to, it's the culture war here in the U.S., and the current battle is being waged before a California court over the issue of gay marriage. California voters overwhelmingly passed proposition 8 which simply sought to affirm thousands of years of tradition and moral teaching that marriage is limited to the union of one man and one woman, but advocates of gay marriage are hoping the court will overturn this, just as a Massachusetts court did not too long ago. If love is the only criteria, then of course we should allow gays to marry, but we should also allow any combination of people to

Allowing love solely to define the appropriateness of marriage actually weakens marriage. For several millennia, marriage has been more important than simply an expression of the love between two people. Marriage between one man and one woman has been, and should continue to be, society's ideal for raising a family and for fully maturing as a person.


Traditional marriage is better for children. A mother and a father each give something different to a child. There's simply no way for either to be an equal substitute for the other. Numerous studies have confirmed what common sense tells us all is true: that children are healthier and better able to maintain intimate relationships when they have had a mother and a father in a stable marriage.

Traditional marriage is also better for men and women because each compliments the other, making them whole, in a way that a relationship with the same sex cannot. Now gay activists point to the high heterosexual divorce rates and the growing number of children raised by single parents as evidence that traditional marriage isn't all that ideal in our society. This is twisted logic at its worst. Are we supposed to abandon a goal simply because some fall short? I thought it was self evident that there would be failings in the pursuit of any goal. In fact, I would argue that the higher, the better, the more lofty the goal, the higher will be the failure rate. Failure has nothing to do with worthiness.

The lesson I take away from today's marriage statistics is that society isn't doing enough to support traditional marriages. Rather than throw in the towel by allowing marriage to mean anything at all, we should reinforce it, emphasize its importance to our youth and make divorces more difficult to obtain than today's "quickie" divorces. Perhaps couples should be made to think a tad longer about an action that will disrupt their children's lives well beyond childhood.

Allowing traditional marriage to further deteriorate will have far reaching consequences that few in the media have chosen to bring to our attention. Clearly Europe is "ahead" of us in this matter. They are much further along on a deteriorating course. Statistics out of Scandinavia, as chronicled by noted scholar Stanley Kurtz, indicate that increases in gay marriage have ultimately translated into the separation of child rearing from marriage - any marriage. Gay marriage in Scandinavia has led to a devaluation of all marriages to the point where the vast majority of children are now birthed and raised by unmarried individuals.

Overturning proposition 8 by a small coterie of judges runs the risk of further tearing the social fabric of our society and further polarizing Americans. As a matter of principle, a small number of judges has no right to overturn centuries of understanding and moral teaching. #### **ORDINANCE NO. 1304**

#### AN ORDINANCE OF THE CITY OF SIERRA MADRE,

CALIFORNIA PROHIBITING THE EXERCISE OF EMINENT DOMAIN FOR PRIVATE PURPOSES THE CITY COUNCIL OF THE CITY OF SIERRA MADRE, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS: SECTION 1: Title 3, Chapter 3.06 of the Codified Ordinances of the City of Sierra Madre is hereby added as follows:

The City may not facilitate, fund or consent to the use of City property or resources in connection with, the exercise by any other agency of the power of eminent domain to acquire property from any private Owner thereof, without such owner's consent, when the purpose of the acquisition is to convey the property so acquired to a private party.

SECTION 2: Severability. If any section, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining sections, sentences, clauses, phrases, or portions of this Ordinance shall nonetheless remain in full force and effect. The City Council of the City of Sierra Madre hereby declares that they would have adopted each section, sentence, clause, phrase, or portion of this Ordinance, irrespective of the fact that any one or more sections, sentences, clauses phrases or portions of this Charter he declared invalid or the property of the fact that any one or more sections, sentences, clauses, phrases, or portions of this Chapter be declared invalid or unenforceable and, to that end, the provisions of this Ordinance are

SECTION 3: Effective Date. This Ordinance shall take effect thirty days after its passage and adoption pursuant to California Government Code section 36937.

SECTION 4. Certification. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published according to law.

## All That Money Can Buy



by the Immortal Óne? You must know who I mean? That person who need never die. As defined in Ambrose Bierce's

Devil's Dictionary as "an ingenious device for obtaining individual profit without individual responsibility". Yes, this "ingenious device" was given the rights of personhood by Chief Justice John Marshall in the famous 1819 case of Dartmouth College v. Woodward. After listening tearfully to the arguments of the great orator Daniel Webster, Justice Marshall wrote an opinion extending the same rights to a limited corporation as belong to a natural person.

A half century later, after the passage of the fourteenth amendment the fifth and fourteenth amendment now combined to extend due process to all individuals, and since an incorporated business had become a single person under the law it now enjoyed all the legal protections afforded any individual by the spirit of the Constitution. Yes, the corporation has been given rights without responsibility

Is it hopeless? Are we now finally defeated fictitious person that is the corporation cannot be imprisoned for any legal violation. Similarly, no individual person can be held responsible for obligations and liabilities of the corporation. Furthermore, the corporation can go on forever as it is not subject to inevitable mortality that unfortunately is waiting for the rest of us.

> Daniel Webster, the great advocate who prevailed before the Supreme Court and brought Justice Marshall to tears, is one of the most famous statesmen of the nineteenth century. He is immortalized in the short story by Stephen Vincent Benet entitled 'The Devil and Daniel Webster'. In this story Webster has to risk his own soul as he confronts the devil. The story was made into a 1941 fantasy film ironically entitled All That Money Can Buy. Remarkable, considering the applicability of the Dartmouth College case to the January 23, 2010 decision Citizens United v Federal Election Commission which has held that because corporations have the same rights as non-fictitious persons, the free speech of corporations cannot be limited. The decision by that great protector of human

rights, Chief Justice John Roberts, has held that the restrictions upon the right of Corporations to contribute funds to political campaigns violate the Constitutional rights of the fictitious person and therefore are illegal.

Yes, the ninety page dissent by Justice Stephens points out that it is absolutely absurd and a grave error to treat corporate speech (and political participation is a kind of speech) as being the same as the speech of an actual human being. # Looking **Latest News From Mars**

After six years of unprecedented exploration Spirit no longer will be a mobile robot. NASA has designated the once-roving scientific explorer the past several months to free it from a sand trap have been unsuccessful.

The venerable robot's primary task in the next few weeks will be to position itself to combat the severe Martian winter. If Spirit survives, it will continue conducting significant new science from its final location.

Ten months ago, as Spirit was driving south beside the western edge of a low plateau called Home Plate, its wheels broke through a crusty surface and churned into soft sand hidden underneath.

The Martian winter at Spirit's location will begin in May. Solar energy is declining and expected to become insufficient to power further driving by mid-February. The rover team plans to use those remaining potential drives for improving the rover's tilt. Spirit currently tilts slightly toward the south. The winter Sun stays in the northern sky, so decreasing the southward tilt would boost the amount of sunshine on the rover's solar panels.

We need to lift the rear of the rover, or the left side of the rover, or both," said Ashley Stroupe, a rover driver at JPL. "Lifting the rear wheels out of their ruts by driving backward and slightly uphill will help. If necessary, we can try to lower the front right of the rover by attempting to drop the right-front wheel into a rut or dig it into a hole."

At its current angle, Spirit probably would of the Red Planet, the Mars Exploration Rover not have enough power to keep communicating with Earth through the Martian winter. Even a few degrees of improvement in tilt might make a stationary science platform, after efforts during enough difference to enable communication every few days.

#### Recipe of the Week:

Chilean Potato Pie (Pastel de Papas)

#### Ingredients

- 5 cups potatoes, peeled and cubed
- 2 tablespoons butter
- 2 eggs, beaten
- 1/2 cup vegetable oil 1 clove garlic, minced 1 onion, diced
- 2 tomatoes, diced 1 tablespoon tomato paste
- 1 pound ground beef
- 2 tablespoons shredded panquehue cheese 1/2 teaspoon chopped fresh parsley
- salt and black pepper to taste 1 pinch cayenne pepper (optional)

#### Directions:

Preheat an oven to 350 degrees F (175 degrees C). Grease a 2-quart baking dish.

Place the potatoes into a large pot and cover with salted water. Bring to a boil; reduce heat to medium-low, cover, and simmer until tender, about 20 minutes. Drain and allow to steam dry for a minute or two. Mash the hot potatoes with butter and salt. Let cool until just warm;

stir in the beaten egg until smooth. Meanwhile, heat the oil in a large skillet over medium heat. Stir in the garlic and onion; cook and stir until the onion has softened and turned translucent, about 5 minutes. Stir in the tomatoes and tomato paste; continue cooking until the tomatoes soften and begin to lose their shape. Add the ground beef and cook until browned, about 10 minutes. Stir in the panquehue cheese and parsley; season to taste with salt, black pepper, and cayenne pepper.

Spread half of the mashed potato mixture into the prepared baking dish. Cover with the ground beef mixture, then spread the remaining mashed potatoes over the beef to completely cover.

Bake in the preheated oven until the potatoes are hot and the top is lightly browned, about 40 minutes.

Ravi Johar, founder of Southland Stone first decided to get into the stone business during a 1976 trip to Italy. He and his wife Gita, of Pasadena, have been building that business for over the last three decades. Johar first started his stone business in Dubai, then emigrated to the States after a visit to family enticed him here to Los Angeles.

Southland Stone, located in North Hollywood since 1999, now imports


3000 different SKU-numbered stones from thirty six countries. Container after container of slab and tile arrive by sea to our port here... granite marble limestone, travertine, slate, sandstone, basalt and porphyry. Porphyry???

I thought I was pretty literate in stone vernacular, but that one was new to my vocabulary. Porphyry is a "reddish purple rock containing large distinct feldspar crystals embedded in a finegrained groundmass," according to Encarta.

A rainbow of colors saturates my senses as Gita Johar takes me on a tour of their acres of display. Carefully stacked slabs of granite, marble, travertine and more exotic stones carry beautiful names like Absolute Black, Crystal Gold, Dakota Mahogany, French Vanilla, Golden Fantasy, Himalayan Blue and event Morning Glory sandstone, to fit any building's color palette, both inside and outside on walls, floors, baths, kitchens, patios, walkways and more. I have been to stone yards all over the Bay Area and LA and I have never seen a place like Southland.

These enormous slices of stone, slabs polished on one side, stand like oversized decks of multicolored playing cards in vertical holding pens tracked by origin and lot numbers. Most decorators, architects and homeowners come out to pick a particular slab or two or ten, reserving it for pickup at the right moment during construction. Small vehicles with cranes tip back the selections for the buyer to view the color and "movement" of "veins" within the slab.




