### Sierra Madrean George L. Throop **Passes Away**

PASADENA, CALIF. (April 13, 2010) – Honorary Tournament of Roses Director George Lynford Throop, Jr., age 86, died on Sunday, April 11, 2010 from complications of pneumonia. George joined the Association in 1960 and was named an honorary director in 1988 after 28 years of valuable service. The Tournament of Roses was special not only to Throop but to his entire family; he was the proud father of current Tournament of Roses President, Jeffrey L. Throop. "Dad loved his time with the Tournament. He knew how to get any task done and have fun doing it," said Jeff Throop about his father. "Those who served with Dad all have stories that will be lasting memories."

George Throop, Jr. took over the George L. Throop Building Materials Company in Pasadena and operated the organization for more than 50 years. It began as a feed and fuel company in 1921 delivering coal and building materials with a horse and wagon. Today, the business is one of the oldest companies in Pasadena and is currently operated by George's two sons, George Throop, III and Jeffrey L. Throop.

George Throop, Jr. was a Pasadena native, born in 1923 at the Huntington Hospital. He attended various Pasadena schools and the University of Southern California in Los Angeles. He served three years in the United States Army as a military policeman during World War II before joining his father at the George L. Throop Company in 1947. In 1948, he married his wife, Nancy Hentges.

Active in Sierra Madre civic affairs for many years, he was a past recipient of Sierra Madre's Older American of the Year. In addition, he is the inspiration for the development of the city's Wine and Jazz Walk chaired annually by Angel Throop. Proceeds from the event have raised over \$200,000 for the City

Survivors include his beloved wife Nancy, three children, George, Jeff, and daughter Ann, three grandchildren, and three great grandchildren.

Voters Elect Mosca, Moran & Walsh To Lead City Council With "Civility"







#### Mosca Takes the Gold

At a victory Party Tuesday night, re-elected council member Joe Mosca thanked everyone for their support, especially his family which he said, withstood a lot in order to stand by him. Mosca easily won over three contenders vowing to remove him from office. He received 1704 votes —the most of any candidate.

Council member, John Buchanan told a room packed full of Mosca's supporters that they are now looking at "the next Mayor of Sierra Madre." The party was held at long time

Mosca supporter Bob Burnett's home.



Mosca explained that, as compared his with campaign, he took a different approach although he also got the highest number of votes at that time as well.

"Instead of telling [residents] them what I was going to do, I asked what they wanted to see change in the city," he said. By far the two issues on people's minds were

fixing road conditions and the abandoned skilled nursing center he said.

Mosca said he wanted to see the property become either an office/retail center with a nice courtyard or again become a nursing center. Last year, a portion of the property was proposed as a possible temporary location for the Community Heath Alliance of Pasadena. Mosca

said he could never see 🖡 that happen adding that the property was too far in disrepair. He said it would be a safety issue for anyone to try and occupy any part of the building.

Buchanan said Mosca would, most likely, become Mayor at their next council meeting April 27. He said the meeting was a reorganization, in which, outgoing council members Kurt Zimmerman and Don Watts will be honored for their services.

Along with Mosca, Council Members-Elect Nancy Walsh and Josh Moran will also be sworn in.

### Certified Results Due Monday

On Tuesday, voters in Sierra Madre made it clear that it was time to change the way City Hall operates. In what, by Sierra Madre standards, could be considered a 'landslide', Incumbent Joe Mosca, and newcomers Josh Moran and Nancy Walsh, beat out Incumbent Don Watts and challengers Pat Alcorn and John Crawford. The seventh candidate, Bill Tice, who stated he ran not to win, but to be heard, finished his fourth run for city council in last place.

Voter turnout was higher this year than in 2006, the last three seat council race. For this election, 27% of the registered voters cast their ballots compared to 23% of registered voters in 2006. That number pales in comparison, however, to, according to City Clerk Nancy Shollenberger, a 49% turnout for Measure V.

There was no way to predict what the outcome of the election would be, however, earlier in the evening, both camps seemed optimistic. As the returns were counted, however, it was clear that the slate endorsed by outgoing Mayor Mary Ann MacGillivray was loosing.

On April 20th, the current council will hold a Strategic Planning Retreat at the Recreation Center to review its progress on the plan adopted earlier in the year. It is not clear whether or not Councilmembers-Elect Moran and Walsh have been invited to participate. The event is open to the public.

Around town, residents are optimistic that we can get back to working on the city's problems, a sentiment shared by the newly elected. Says Nancy Walsh, "I'm very excited about getting down to doing the business of the city."

The official council reorganization will take place on Tuesday, April 27th in the council chambers, where it is expected that Joe Mosca will finally have the opportunity to serve as Mayor. The normal rotation for ascension to Mayor was bypassed in 2008 and 2009 to allow Kurt Zimmerman and MacGillivray, respectively to become Mayor. Zimmerman did not run for re-election.



#### **Vulcan Holds Duarte** Wilderness Day Family **Event Hostage To Advance Mining Expansion Plan**

DUARTE, CA, April 15, 2010 - In a calculated and premeditated move, Vulcan Materials Company has decided at the 11th hour to slam its gates shut and prevent access through its property to Fish Canyon Falls for the Annual Duarte Wilderness Day affecting over 300 pre-paid participants. The Wilderness Day event at Encanto Park in Duarte will go on as scheduled and feature alternative hiking opportunities in addition to the traditional BBQ and park activities. However, due to the sudden change in the program, the City of Duarte will waive its

no-refund policy for this event.
"Vulcan Materials Company has been looking to cancel this event for weeks," said Duarte Mayor Margaret Finlay. "This unbelievable action interrupts a wholesome

to Fish Canyon Falls."

Vulcan's action stems from its unwillingness to negotiate in good faith with the City of Duarte over an indemnification agreement that was sprung on the City at the close of business Monday. Vulcan has never required an indemnification agreement, nor have any of its predecessors in all the past years of the annual event.

"Duarte never refused to sign a reasonable indemnification agreement for the Wilderness Day event," cited City Manager George. Adding, "It was Vulcan that refused to even discuss with the City of Duarte reasonable revisions to the agreement."

The City of Duarte rightfully refused to sign the indemnification agreement presented by Vulcan because it included language that could have been used by Vulcan to potentially prevent the City from suing on the company's proposed mining expansion project. It also would have required the City of Duarte to indemnify Vulcan even if through Vulcan's own negligence anyone, including one of its own employees, was injured during the event.

Assistant City Manager James Makshanoff, and Azusa Police Chief Robert Garcia, on Thursday April 8, 2010 at Azusa City Hall to discuss the Wilderness Day event, and none of them said anything about the need for an indemnification agreement. The meeting, originally called to address Vulcan's concern over how to address any situation that may arise, concluded with all parties in full agreement over the discussed plan.

Vulcan proposes to blow off the entire top of the mountain. Then they deny access to the falls because they fear our families will vandalize their property. Vulcan's real fear is people seeing up close what they have done and will continue to do to our mountains," commented Councilmember John Fasana. The 21st Annual Wilderness Day will feature a series of alternative hikes led by City Recreation leaders, park activities, including a 24-foot climbing wall, and hands-on nature experiences. The Duarte Historical Museum located in Encanto Park will also be open for visitation from 10 a.m. to 3 p.m. Admission is free. Due to the late change in events, the City of Duarte will waive its tradition of hiking the falls, and reinforces City of Duarte officials met with Vulcan no refund policy. 

# SAN GABRIEL VALLEY DOCTOR CONVICTED

Doctor with Duarte 'Pain Clinic' was Nation's Largest

Buver of Hydrocodone

A physician who operated a clinic in Duarte and dispensed massive quantities of powerful and addictive painkillers, such as oxycodone and hydrocodone, directly out of his office without examining 'patients" who simply paid him cash for pills was sentenced this afternoon to 48 months in federal prison.

Dr. Daniel J. Healy, 53, who until he was arrested in early 2009 resided in Arcadia, was sentenced this afternoon by United States District Judge Manuel Real. In addition to the four-year prison term, Judge Real ordered Healy to pay a \$150,000 criminal fine. Following his release from prison, Healy will be on supervised release for 10 years, and he is required to perform 500 hours of community service during each of those years.

According to court documents, from January 2005 until his arrest on February 10, 2009, Healy ordered, dispensed and prescribed huge amounts of prescription painkillers to patients he typically did not examine. No single doctor in the nation purchased more hydrocodone tablets than Healy did in 2008. Taking into account the cost of the hydrocodone that Healy bought from the pharmaceutical company and the amount he sold to his customers, prosecutors argued that Healy realized profits of \$688,840 just on the sale of hydrocodone

In briefs filed in relation to today's sentencing, prosecutors described Healy as "nothing more than a drug dealer in a lab coat, who operated a cash-and-carry narcotics store." Healy was more of a "dealer" than a doctor, and a dealer who made "a huge amount of money," according to papers filed by prosecutors.

was in this for the money, I don't think there's any question about that."

Healy attracted the attention of federal authorities when an informant reported that Healy was dispensing controlled substances in exchange for cash payments, according to court documents. The informant reported that "patients" could obtain any amount of nearly any kind of painkillers they wanted from Healy, and then use the pills themselves or sell them for profit. In many instances, Healy accepted cash payments for manufacturer bottles of narcotics containing as many as 500 pills. According to DEA informants, Healy either did not examine or made only cursory examinations of "patients" who directly received drugs or obtained prescriptions. A criminal complaint filed last year said that Healy was known to inquire whether his "patients" wanted a "party size" or a "family size" bottle of narcotics.

Special Agents with the Drug Enforcement Administration found that in 2008 Healy ordered more than 1 million hydrocodone tablets - more than any other individual practitioner in the nation, which includes doctors who worked at large pain management clinics. In contrast, the average pharmacy in the United States ordered 111,226 pills that year, meaning that Healy himself ordered nearly 10 times more hydrocodone in 2008 than the average American pharmacy. In the City of Duarte, Healy ordered nearly three times more hydrocodone during 2008 than the CVS, Wal-Mart, Target and City of Hope Hospital pharmacies combined. Based on Healy's ordering history the DEA estimates that Healy made \$688,840 in 2008.

A newly discovered asteroid, 2010 GA6, safely flew by Earth Thursday afternoon. At time of closest approach 2010 GA6 was about 359,000 kilometers (223,000 miles) away from Earth - about 9/10ths the distance to the moon. The asteroid, approximately 22 meters (71 feet) wide, was discovered by the Catalina Sky Survey, Tucson, Az.

"Fly by of near-Earth objects within the moon's orbit occur every few weeks," said Don Yeomans of NASA's Near-Earth Object Office at the Jet Propulsion Laboratory.

NASA detects and tracks asteroids and comets passing close to Earth using both ground and spacebased telescopes. The Near-Earth Object Observations Program, commonly called "Spaceguard," discovers these objects, characterizes a subset of them and plots their orbits to determine if any could be potentially hazardous to our planet.

JPL manages the Near-Earth Object Program Office for NASA's Science Mission Directorate in Washington. JPL is a division of the California Institute of Technology Pasadena. Cornell University, Ithaca, N.Y., the Arecibo operates Observatory under cooperative agreement with the National Science Foundation in Arlington,



The National Academy Foundation (NAF) works to sustain a national network of career academies to support the development of America's youth toward personal and professional success in high school, in higher education, and throughout their careers.

"I am so proud of our team's accomplishments and look forward to expanding and enhancing the achievements of our academies," said Muir High School Principal Sheryl Orange.

PUSD has adopted college and career pathways as a reform initiative to make high schools more rigorous and relevant for its students. Strengthening the academies at John Muir High School began as part of its overall reinvention three years ago, after PUSD reconstituted the school to accelerate academic achievement.

Now, all students are placed in one of four academies that integrate themes like Engineering and Environmental Science into the school's regular college preparatory curriculum. Teams of teachers, counselors and administrators in each academy work daily with students to identify, explore and build skills in academic subject areas where students have a particular interest and aptitude.

Funded by the James Irvine Foundation, the grant was secured through the Pasadena Educational Foundation, a nonprofit organization whose mission is to support educational programs, students and teachers of the Pasadena Unified School District, which serves Pasadena, Altadena and Sierra Madre.

#### **HOWARD** Hays As I See It

Ever hear of Pierre Omidyar? Didn't think so. He's a Frenchborn computer programmer with family roots in Iran, who

had a consulting company in San Jose called Echo Bay Technology Group. He developed a web-based program for unloading used stuff - the first such item unloaded being a broken laser pointer. Seeking to register a domain name some fifteen years ago, he learned "Echo Bay" had already been taken, so he shortened it to "eBay". Omidyar is now a billionaire and no, I don't begrudge him that. Here's an entrepreneur who took an emerging technology and developed a business model to facilitate things people like to do - buying, selling, bidding, collecting, cleaning out the attic and coming home to find something really neat left on the doorstep. Economist Adam Smith likened creating wealth to taking a tree branch, which has no value, and carving it into an ax handle, which does. Mr. Omidyar took his niche of the internet and carved it into a worldwide marketplace.

There's a difference between creating wealth and simply making money. Omidyar's business created thousands of jobs and pumped billions of dollars back into the economy. Others seem adept not at creating wealth, but in transferring it from the larger economy into their own pockets. The collapse of 2008 resulted from drawing hundreds of billions from pension funds and the pockets of present and future retirees, from assets of smaller banks intended for consumer and small business loans, and transferring that wealth to Wall Street players. Collateralized securities, "exotic" derivatives and credit default swaps facilitating this transfer lacked the intrinsic value of an ax handle, but were ultimately guaranteed by taxpayers. Funds available to entrepreneurs dried up and seniors anticipating a comfortable retirement hired on as Wal-Mart greeters, while some on Wall Street became ungodly rich.

Nowadays, the name most associated with eBay is not founder Pierre Omidyar but rather former CEO and current gubernatorial candidate Meg Whitman. There was confusion when presidential candidate Sen. John McCain (R-AZ) claimed Whitman had "founded" eBay when he mentioned her as a possible Treasury Secretary. There was also confusion over what Whitman's role there had been: creating wealth for the company or simply making money for herself. It was this confusion that brought her to the attention of Republican lawmakers, and not in a favorable

Eight years ago, then-Chair of the House Financial Services Committee Rep. Michael Oxley (R-OH) issued a report singling out Meg Whitman as a beneficiary of "spinning", a method of laundering kickbacks by Wall Street firms during the dot-com boom. Investment houses would offer shares of forthcoming IPOs to insiders at a price below what investors would normally have to pay, with the recipients able to sell the shares days

later and pocket millions in profit.

Meg Whitman was one such recipient when she chose Goldman Sachs to handle eBay's own IPO and the later acquisition of PayPal. Her reward was to go spinning with Goldman, pocketing some \$1.78 million in profits, along with a seat on the Goldman Sachs board. Whitman claimed this was related to her business as a private client, rather than as eBay CEO. Others didn't see it that way, and she became the target of an eBay stockholders' suit accusing her of making corporate decisions based not on the best interests of the company, but for her own personal benefit. A Delaware judge refused motions to dismiss the case, and Whitman settled in 2005. David Shapiro, Professor at City University of New York specializing in financial fraud, commented: She had no understanding of the appearance of impropriety ... She didn't acknowledge in hindsight that it didn't look good. What will become of all the conflicts of interest that come before her as governor?"

Related to the question of creating wealth vs. making money is the matter of taxation addressed in "Building a New California", a recent "policy agenda" released by the Whitman campaign. She says we can't afford a simple across-the-board tax cut for everybody, and she's probably right. What she proposes instead is eliminating the capital gains tax, pointing out that California is "one of a few" states that taxes capital gains the same as "traditional" income. (By "a few", she means just California - and forty other states.)

Those who derive the bulk of their income by working for it, who are affected most by the current downturn and would be most likely to spend a tax cut and put it back into the economy - they'd be out of luck. The windfall Whitman proposes would come to those accustomed to sheltering fortunes in Dubai and the Cayman Islands; hedge fund managers who profit by betting on businesses to fail; investors in private equity firms who take over companies, close factories, lay off workers and part-out the remains as if it were an old car. The windfall would come to those like our wannabe governor, Meg Whitman.

Fairly or not, half of California's tax revenue comes from less than 150,000 of its wealthiest citizens. According to the California Budget Project, those in Meg Whitman's tax bracket derive more than 60% of their income from capital gains. Taken together, this means Meg Whitman's proposal would surely drag California's credit rating below "junk" status, but add millions to her own individual net worth - currently estimated at \$1.2 billion.

As I see it, we don't need leaders with the biggest investment portfolios, but rather those with the biggest ideas - like Pierre Omidyar, who wrote in 2008 endorsing Barack Obama for president, "... we are fundamentally good and strong and proud, and we can overcome our challenges by working together, across all sorts of lines, be they partisan, racial, cultural, religious . . . That's the America I want to live in." If not, we'd might as well just put the office of Governor up for sale to the highest bidder - on eBay.

### The Tax Man Commeth, Will He Ever Leave?

Thursday was tax day, and millions of Americans wealth and employment. rushed to complete their annual returns and get that all-important April 15th postmark. This year, at least, there can be some consolation taken in the fact that things could be worse. We could suffer under the tax burden inflicted on most Europeans. Then again, if the current administration has its way, we may soon surpass the European burden.

Let's start, though with a brief understanding of just what we face in the United States. I'm going to use as an example, some of the personal observations shared by Mike Donahue, a young entrepreneur, whose Thursday's article in the Wall Street Journal chronicles painfully detail the tax burden already faced by those in our country who have labored hard to build something for their families and, in the process, have employed many others in their communities. Mr. Donahue speaks of the 20 years he has taken to build his business, of the 70 hour long weeks, of the sacrifices to family and personal pleasure necessitated by keeping his business open during several of the recessions he's had to face along the way. He comments movingly of the work ethic inculcated in him by delivering newspapers, splitting firewood, shoveling snow, and making sandwiches, which he's done over the years since his 14th birthday, all in an effort to afford college, learn the skills necessary to succeed and ultimately to run a small thriving business.

Yes, by his own admission, he drives a nice car although it was bought used – and lives in a nice neighborhood, but it has taken him 20 years of effort and sacrifice, doing without the security of a steady salary and benefits paid by someone else, in order to get his business to the point where he now employs others and pays their steady salaries. His is the quintessential rags-to-riches American success story. I don't know if he is black, white, brown or tattooed with multiple colors. I do know that he didn't grow up in an economically privileged home. He worked, scraped by and borrowed heavily to get through college and sustain his dream. As he describes himself – and thus by extension millions of other entrepreneurs across this great land – he is a high earner, but he's

Now for the bad news! What do we do to these icons of success, these employers of the vast majority of our workers, these producers of wealth that benefit our entire community? To put it indelicately, we tax the hell out of them. Mr. Donahue, and others like him, pay 32% of their earnings to the IRS, 10% to the state of California, another 15% in payroll taxes, 1.2% to his county in property taxes and 8.75% in sales tax on every nonfood related purchase he makes. Conservatively estimated, he's paying 65% of what he earns to one government agency or the other.

What I haven't even bothered to calculate are the taxes he'll have to pay on any gains he might make on the investments he's made with the money that was already taxed. What I mean by this is that if he takes some portion of the 45% that remains for him and his family and invests it wisely, then whatever profit is made from that will again be taxed 15% by Uncle Sam and 10% by his cousin in California in the form of capital gains taxes.

Since he has labored under this system for a fair number of years already, I suppose you could make the argument that he's a big boy, knew what he was getting into when he decided to be an entrepreneur and hire other people. But now, he's told that the "rich" don't pay their fair share and that they need to cough up more. Mr. Donahue and countless other entrepreneurs like him generate by the sweat of their brow, willingness to risk and countless hours of work 20% of the wealth created in this country, and then they are asked to pay 40% of the country's total tax burden.

I don't care which measure you use, but I have to admit that I am amazed every time I hear one of their stories that they continue to labor under these conditions. It's just not fair to take 65% of a person's earnings and then possibly take another 25% if he invests wisely. It's just not fair to expect these people to create as much of our national wealth as they do and then pay more than double that amount back in taxes. At some point, I would quit working, as would you, dear reader, and as will they, the entrepreneurs, at some point.

We are dangerously close to, if we have not already passed, the level of taxation at which the most productive members of our society will decide to move on. Make no mistake about it. People of wealth have choices about what to do with their money and with their creative, productive energies. They can (a) stay in our state/ country and continue to grow their businesses which means hiring more people, or (b) decide to move offshore or just stop being productive. How many businesses have shut down or scaled back their operations because of oppressive taxes?

Mr. Donahue even comments in his article that his patience and pocketbook are at the breaking point. The saddest thing of all is that most of our elected leaders don't have a clue about this. Gone are the days when the majority of our politicians were citizen politicians, people who spent as much or more time living under the laws they created as they did in elected office writing those laws. Those people at least knew what it was like to make a payroll, build a business, contribute to the wellbeing of their community. Most of our politicians today are career, or professional, politicians who have never worked non-government job, let alone actually created

A recent interview of Henry Waxman, illustrated this point poignantly. When the chairman of the Commerce Committee was asked how much taxation is enough, how much is too much to ask people to pay, his response was "I haven't really given that much thought". I wish that was a mis-quote. I wish there was a context to the comment which excused the willful ignorance and arrogance of one of the most powerful leaders in Congress to the reality facing our most productive citizens. But there isn't. Those who seek to "spread the wealth" rarely have any idea of, nor experience in, what it takes to actually create wealth. The wealth of our country doesn't just grow on trees. It doesn't exist to simply be picked up from the ground by one person or the other. This is the great misunderstanding which characterizes so much of liberal thought. The left believes that wealth simply exists and thus should be shared in some reasonable and "equitable" fashion as they define it. The reality is that wealth has to be created. That means that entrepreneurs, risk takers, have to invest something, tempting failure and financial loss, to actually create wealth. Whether it is investing the money to drill miles into the earth in the hopes of finding oil, or it is investing that money in the creation of a new, never-before-seen software program which they hope will improve productivity and thus prompt consumers to buy their new product, wealth must

True equity lies in allowing the people who create wealth to enjoy the fruits of their inspiration, labor and risk taking. There is no virtue in forcefully taking money from Peter to pay Paul. That is theft disguised as virtue. Fortunately, most Americans understand this at a visceral level. America was founded on, and thrived under, social mobility derived from freedom of opportunity. We don't care where a man was born, the color of his skin, the names of his ancestors or the accent of his speech. We care whether he's productive, takes responsibility for himself and his family and contributes to his community. Poll after poll shows that the vast majority of Americans believe nobody should be forced to pay more than 20% of their income in taxes. That's the common man's definition of equity. Yes, we believe in taxes to support the legitimate functions of government. Yes, we believe in contributing to various charities and our communities to help those who are truly less fortunate, or just experiencing tough times. But no, we don't believe that the government should force us to pay a huge percentage of our income to support those who refuse to help themselves or for wasteful earmarks which serve only to endear the politician to one or an other

When we hear that our state legislatures have run up deficits, that our federal government has run up huge deficits and that our federal government is continuing to add to this sea of red ink, we instinctively and rationally know that we will be asked to shoulder even more taxes in the future. The 25 tax increases already signed into law by President Obama total \$670 billion over the next 10 years, put a burden on this country that cannot be supported, and contain 14 tax increases which directly contradict candidate Obama's solemn pledge not to raise taxes on those earning less than \$250,000. The farce has become a lie, which has become an insult. The only question is how much damage will be done.

Americans are over-taxed as they are and the taxes being assessed are anything but fair or equitable. They penalize those who would labor and sacrifice to employ others and thus contribute to a rising standard of living that has heretofore been the envy of the world. Tone deaf doesn't begin to describe the hubris existent in our elected leaders. We are lectured about the need to pay more, to suffer more and to bear more. The tax man has come, as he always does this time of year, but this time there is serious talk of adding yet another layer in the form of a value added tax, a national sales tax to be paid on top of all other state, county and local sales taxes. It is no mystery that we're all beginning to ask ourselves if the tax man is ever going to leave. If Obama has his way, there will be no such thing as tax freedom day, no theoretical date after which we are all working for ourselves, rather than for the government. If Obama has his way, the tax man will become a permanent guest at the table, and we will be the slaves to his gluttony.

## Mountain Views News ANTI-AGING MEDICINE: Fact or Fiction?

Advertisements for pills, potions and lotions that claim to slow, stop or reverse the signs of aging are everywhere. Searching for the fountain of youth has become a national past time. "Ah, for the simplicity of Dr. Watson's Snake-Oil Cure-All."

Anti-aging products flood the market to meet consumer demands. The phenomenon feeds off a number of factors: a cultural obsession with youth; legitimate advances in genetics and clinical medicine; and, entrepreneurs peddling to the desire of consumers to stay forever young. The underlying message has been, "Growing old is undesirable and to be avoided." This contradicts the very essence of the human life cycle.

Many organizations have stepped forward to dispute claims made by the anti-aging medicine industry. They warn Americans that many of these products do not work, and some may cause harm. Anti-aging products have proliferated in recent years due to the Internet and deregulation by legislation. Vitamins, minerals, and herbal remedies as dietary supplements, are outside the monitoring of the Food and Drug Administration. These products are not subjected to the testing and close scrutiny necessary to determine their safety or effectiveness. Many claims are based on partial truths and what seems to make logical sense.

Most consumers believe that if it is "natural" it cannot be harmful and it is not a "real" drug. Natural substances can be harmful and their chemical reactions in the body as powerful as man-made formulas. Older adults are at greater risk because their systems are more sensitive to chemical compounds – they take longer to metabolize and more time to eliminate from the system. Additionally, seniors are more likely to be on prescription drugs that can negatively interact with these substances. For example, the popular supplements ginkgo biloba and St. John's wort magnify the effects of blood thinning drugs such as warfarin and coumadin.

Furthermore, some herbals are contraindicated for certain medical conditions. For example, people with hypoglycemia should not take ginseng and those with Parkinson's disease can worsen their condition by ingesting Kava Kava.

So, how do we know what to take and what to avoid? The U.S. Special Senate Committee on Aging hearing offered the following tips to avoid fraudulent "anti-aging" products:

- If it sounds too good to be true, it probably is. (Where have I heard this before?) Ask questions about the product. Find out exactly what it should do for you and what 2) it shouldn't.
- Research a product before buying it. Check reputable websites for info.
- 4) Watch out for so-called "Secret Formulas" or "Breakthroughs of the Century."
- Be wary of products that purport to cure a wide variety of illnesses that don't appear 5)

Testimonials and/or celebrity endorsements are often misleading and sometimes are simply fabricated by the product's manufacturer.

Be very careful of products that are marketed as having no side effects.

Always consult your doctor before taking any dietary or nutritional supplement, especially prior to surgery.

Trust your instincts and common sense. Drink lots of water, eat your fruit and veggies, exercise with moderation, and . . . laugh a lot! All of these can help create a long healthy life. 

### One Of A Kind: Featuring unique homes & gardens and the people who create them Story and Photos By Chris Bertrand Garden Spreads Goodwill to Generations of Schoolchildren

than the functional classrooms, a lunch area, a playground,

all about functionality. Yet... hidden now to outsiders is a treasured "Garden of Goodwill" built seven decades ago, in a different era.

A plaque created in 1995 reads, "This garden was created in 1931 by grateful parents of Japanese-American students. It was destroyed by vandals during WW II as the caretakers were taken away to internment camps. It lay buried for 50 years. In 1995, it was rediscovered and restored by the efforts of the sixth grade class of 1995 and Lew Watanabe (A true ambassador of goodwill) in hopes of healing the wounds of war. PEACE ON EARTH, GOODWILL TO ALL.

A "Goodwill Garden" in the Japanese garden tradition, was constructed in 1931, not in the middle of the city of Sierra Madre, not at a park, but in the heart of an elementary school. Sierra Madre Elementary School treasures the history



and tradition handed down through generations of children and adults who had a part in its initial creation by Japanese immigrants a century ago; the students and townsfolk who unearthed and rebuilt it in the early 1990's, as well as the dedicated 5th graders, school staff, neighbors and garden lovers who maintain it today.

Lew Watanabe, the garden designer, mentioned on the plaque, took me to this hidden treasure this week. The 1931 iteration of this Japanese garden and koi pond celebrated the opening of Sierra Madre's new school at Highland and Auburn. Contrary to other neighboring communities, Japanese immigrants here were assimilated and welcomed into the community. Decades later in the 1990's, an LA Times article water. Library research led the students to find articles about the garden, and even some of the students in a 1931 photo of the original dedication ceremony, Helen Obazawa, Yoneko Hashimoto, Tommy Honda and Dr. George Shimizu. Though built as a gesture of goodwill, anti Japanese sentiment during World war II and the garden's ensuing vandalization probably led to it being covered over with dirt and eventually mostly forgotten. Fed by the fervor of their discoveries, the students were determined to get the garden restored. They were referred to Lew Watanabe, who agreed to donate his well-known garden design talents and leadership toward the restoration. He was delighted that young children were interested, excited and cared about such a project. Two old photos from different angles provided the basis for the rebuilding work.

> Fundraisers began in earnest and \$15,000 was raised from bake sales, car washes, and sales of handmade garden angels and origami cranes, with funds eventually coming in from all across the United States. Watanabe tapped his vendors, and San Gabriel Nursery donated a concrete lantern, other suppliers including Norman's Nursery donated most of the plants and materials. As word got around,0 a concrete lantern from a Japanese garden on a Lima Avenue estate was donated by a couple who had purchased it earlier for their condo's back yard. Watanabe worked with "cement master" and local resident now deceased, Gerald Twedell to recreate the bridge and outlines of the pond, the central lantern and other elements. The young sago palm in the original picture was now a multi-trunk beauty. A volunteer or randomly planted conifer was kept, and enhanced when Watanabe exposed a massive root giving the hillside rise a horizontal anchor element in the waterfall area.

Some enhancements were incorporated. Watanabe created a sound box behind the waterfall to amplify the splash volume of the Japanese garden once located on the grounds landscaping on the walkways next to the



Although less than ideal, sellers are seeing the sellers have the right to accept another offer more "contingency" contracts, wherein the buyers make their offer contingent upon being able to sell their own home first to complete the purchase. If the buyers aren't successful, their Offer To Purchase becomes null and void, potentially leaving the sellers at Square One.

A compromise has developed, called a "kickout clause," which is wording included in the contract that allows the sellers to continue marketing their home, even while under contract. If the sellers receive another offer, the buyers are granted a "kick-out" period - usually 72 hours - to respond by removing their selffirst contingency or by securing financing and completing the purchase.


Unfortunately, the chances are that most buyers who must sell first likely won't qualify for another loan on the new property. If the buyers fail on both counts - selling and financing - then

While this might seem to put the buyers at a disadvantage, the sellers must have some sort of protection against an offer that could tie up their listing indefinitely and perhaps never be consummated.






