

Court Rules - Cities To Turn Over RDA Funds by S. Henderson

Despite efforts by the California Aguilar, the release of those funds "will money". Redevelopment Association to stop the implementation of AB26, which requires local governments to turn over Redevelopment Agency funds by May 10th, Judge Lloyd Connelly denied their petition. 

in its decision-making process through the use of citizen commissions. Currently, there are six citizen commissions established by the Council to advise and assist in dealing with specific problems (presently the Planning Commission has the responsibilities of the Cultural Heritage Commission). These advisory bodies are able to study a variety of issues and problems in detail. After gathering all pertinent information, hearing arguments, and weighing values, they recommend to the Council what they consider the best action to take. In certain situations, commissions are empowered to make specific decisions, subject to appeal to the Council. Public notice on all commissions are prepared in compliance of the Maddy Act.

Should you wish to apply to be a commissioner, applications may be obtained at City Hall or the City website at www. cityofsierramadre.com should you wish to apply (see attached application) Applications will be accepted until all positions are filled; however the first review will take place June 1, 2010.

COMMUNITY ARTS COMMISSION

The mission of the Community Arts Commission is to promote the community's interest in, awareness of, and appreciation for the arts; to provide support and encouragement to artists living in the community; and to increase the community's participation

PLANNING COMMISSION

The responsibilities of the Planning Commission fall into two broad categories: consideration of current land-use (i.e. applications for General Plan amendments, zone changes, specific plans, conditional use permits, tract maps, variances, and appeals of staff land-use decisions); and advising the City Council on City initiated amendments to the City's General Plan. SENIOR COMMUNITY COMMISSION

The Senior Community Commission is responsible for defining the needs, locating and publicizing available resources, and coordinating and initiating services and opportunities for the senior population of Sierra Madre.

TREE ADVISORY COMMISSION

The Tree Commission is an advisory body to the Director of Public Works, City Manager, Planning Commission, and City Council. Residents and businesses will have the opportunity to safely dispose of electronic waste conveniently and free of charge at the city's Electronic Waste Collection Event on Saturday, May 29, from 9 a.m. to 3 p.m. in Parking Lot I of Brookside Park, south of the Rose Bowl, 1001 N. Rose Bowl Dr.

E-waste qualified for this special collection, provided by Pasadena Department of Public Works, includes computers, keyboards, printers, monitors, laptops, docking stations, scanners, shredders, fax machines, mice, telephones, televisions, flat screens, VCRs, DVD players, PDAs, cassette players, tape drives, stereos and household batteries. Many of the products have parts that will be recycled.

By law, e-waste cannot be disposed of in landfills because its hazardous parts can cause environmental damage.


Sierra Madre Dolphins Swim Team



PUSD Superintendent Begins Plan B Roll Out After Measure CC Defeat



Edwin Diaz, head of the Pasadena Unified School District, is not one to give up after loosing a fight. Despite the fact that the Measure CC campaign failed to convince two thirds of the voters that a parcel tax was needed to sustain the school district, Diaz continues the uphill battle for the salvation of public schools in Pasadena, Altadena and Sierra Madre.

The District was required to issue layoff notices to hundreds of employees, including teachers, last week. As a result, the resources available to students such as school libraries will close. Class sizes will increase and support services, such as security, academic assistance and para-educational services will cease. With no assistance from the parcel tax, nor the State or Federal government in sight, the threat of a \$23 million deficit has become a stark reality.

However, Diaz is a man with a plan. Recognizing that more that half the voting population voted *in favor* of the tax assessment, and that he has partners such as the Pasadena Educational Foundation, he recently sent a letter to the community outlining his plan for the future:

Dear PUSD Community Members,

Once again, I would like to express my appreciation to all of the volunteers, supporters and donors to the Measure CC campaign. Over the last several months, I've been moved and inspired by the level of sacrifice, support and passion demonstrated by those who gave their all to advocate for our students

Although the number of votes fell short of the two-thirds required for passage, a majority of community members voted to tax themselves to protect the quality of public education.

I hope to build upon that commitment by strengthening and broadening the coalition we've established.

Moving forward, I am optimistic that we can move beyond the year-to-year battle for limited state resources and develop a stable source of local funding

to meet the educational needs of all PUSD students. As we make the difficult cuts that are necessary to balance this year's budget, I remain committed to accelerating improvements in academic achievement and identifying resources to minimize the impact of budget cuts in our classrooms.

You may be aware that our community partners are working to sustain the positive momentum of the Measure CC campaign, and to provide assistance during these difficult times. There are several things you can do immediately to help support their efforts:

In place of the parcel tax, donate \$120 or more to the Building on CC fund, which will raise money for librarians, arts and music. The Pasadena Educational Foundation, a 501c3 nonprofit organization, will manage the fundraising effort on behalf of PUSD, and

- Visit a PUSD campus to learn more about our instructional programs, and encourage others to tour our schools.
- Contact schools in your neighborhood to find out how you can volunteer to help fill the gap with your time, expertise or resources. Support efforts by local and state organizations to lower the threshold for local parcel taxes to 55 percent.
- I appreciate your active support of PUSD students as you continue to volunteer, donate and advocate for our schools. Thank you for your partnership and friendship.

Diaz's plea to the community to save the area's public schools will need a rapid response from the public. He is hopeful that the PUSD's efforts to deliver a quality education to our children not become a thing of the past. Schiff Calls for Solutions to Process Remaining Sexual Assault **Evidence Kits** Washington, DC - With

Angeles struggling to eliminate a backlog in the processing of more than 7,000 rape kits evidence collected from the crime scene and victim's body after a rape report - Rep. Adam Schiff (D-CA) and members of Congress from the Los Angeles area sent a letter to Attorney General Eric Holder and Federal Bureau of Investigation (FBI) Director Robert Mueller asking that they work with the City of Los Angeles develop immediate solutions to expeditiously process remaining sexual assault evidence kits. In the City of Los Angeles alone, 1,700 kits were awaiting a technical review on March 1, and that number is only

growing.

"The thousands of independence kits" sexual assault evidence kits currently awaiting technical review could be uploaded into the national database much more quickly in a reformed technical review process," Rep. Schiff said. We believe that Los Angeles can serve as a pilot to demonstrate the feasibility of alternatives, taking dangerous people off the street, speeding justice for victims of assault, saving scarce resources, improving DNA technologies."

From The Desk of Fire Marshal Rich Snyder SURVIVING A WILDFIRE VEGETATION MANAGEMENT

Year after year, Sierra Madre is faced with the potential for disaster. As we get closer to brush fire season with its high temperatures and low humidity the once green vegetation that surrounds our City starts to turn brown as the moisture is pulled from it by the Santa Ana winds that blow in off the deserts. The thick, volatile chaparral that blankets our hillsides are like bombs waiting for their fuses to be lit. We have all heard the term "firestorm" used to describe the incredible temperatures and tremendous winds that are generated in a raging chaparral fire. Hardly any house can withstand direct exposure to such a storm. Wildland fires usually pass by fast and furiously. Typically, they're controllable only when the wind dies out or they run out of fuel. If you reduce the amount of combustible brush around your house, you have taken the first step to preventing disaster.

The success over the 2008 Santa Anita fire was no accident. The Fire Department put up a good fight; however, we could not have done it without the help of the homeowners who gave us a "fighting chance" by maintaining proper brush clearance around their homes.

Each year, The Sierra Madre Fire Department works with the residents in the foothills to help provide that "fighting chance" that is desperately needed to prevent a disastrous fire. This is done through an aggressive brush management program and by educating the residents on what to do before, during and after a brush fire.

Here is a list of the brush clearance requirements that you can use to protect your home:

- ☐ Maintain the first 30 feet around any structure free of native brush and hazardous vegetation.
- ☐ Aggressively thin and trim the vegetation 30 to 100 feet around any structure. ☐ Remove dead branches from trees and keep all braches 6 feet off the ground.
- ☐ Clear vegetation 10 feet from roadways.
- ☐ Remove tree limbs that are within 10 feet of a chimney outlet.
- ☐ Maintain 5 feet of vertical clearance between your roof and overhanging vegetation.
- ☐ Keep all roof surfaces clear of dead leaves and twigs.
- ☐ Post your street number on your house so it is visible from the street.

Rep. Schiff to Testify Before the Senate Appropriations Subcommittee on Interior

Will Call for Forest Service to Consider Repeal of Prohibition on Night Time **Flights**

Washington, DC - Earlier this week, Rep. Adam Schiff (D-CA) announced that he will testify before the Senate Appropriations Subcommittee on Interior, Environment and Related Agencies, and will call for a reconsideration and possible repeal of Forest Service policies prohibiting night time flights. The hearing will take place at 9:30 a.m. on Wednesday, May 26, 2010, in Room SD-124, Senate Dirksen Office Bldg.

"The Forest Service stopped flying fire fighting helicopters at night after a tragic collision in the 1970s," Rep. Schiff said. "I hope this hearing will shed light on the need to reexamine this long-standing policy, which has been overtaken by new capabilities. As advances are made in aviation technology, we need to ensure that the Forest Service's policies keep pace, so we can guarantee Southern Californians the safest, most effective response whenever a fire breaks

In March, Rep. Schiff proposed that the House Appropriations Committee include a provision in its 2011 funding bill directing the Forest Service to conduct a formal study on whether to acquire night-flying capability, as pioneered by the Los Angeles County Fire Department. Rep. Schiff called for the study to be completed within 90 days of the funding bill's enactment.

In December, he asked for a Congressional inquiry into the night-flying prohibition, as well as the Forest Service's response to the Station fire that broke out in August, killing two fire fighters and devastating 250 square miles of the Angeles National Forest.

"I want to thank and applaud Senator Feinstein for holding this important hearing to examine the Forest Service's fire policy," Rep. Schiff said. She has brought extraordinary leadership and focus to fire safety issues for years.'

Rep. Schiff also plans to convene a panel of Los Angeles-area Members of Congress to hear testimony from experts and local fire officials. The panel will discuss issues that have been raised about decision-making during the early hours of the Station Fire.

ST. RITA EXCELS AT CYO TRACK CHAMPIONSHIPS

Track season for St. Rita School in Sierra Madre closed with a bang at the Catholic Youth Organization (CYO) Archdiocesan Championships for the Los Angeles region. Thirty-one Raiders in grades 4-8 survived the Regionals and Prelims

to make the Finals. Only the top eight athletes from approximately 75 schools earned the trip to Serra High School in Gardena for each event in the four divisions. The Raiders walked away with first, second, third and fourth

place finishes as the majority of the athletes put up their best marks of the season. The B Girls were led by sixth grader Sarah Troescher's 30 points including all-time CYO records in the 200m, 400m and the long jump. Fifth grader Natalie O'Brien's

victories in the 800m and 1200m accounted for another 20 points in the team's record total of 92 points. In all, 11 different Raiders scored to earn the 60th CYO Track title in the schools history. It also kept the streak of 23 straight years of at least one championship

The B Boys finished fourth, just 2 points out of third. Fifth grader Sean Espinosa's 1200m victory and sixth grader Tyler Rix's second in the shot put led the team.

The Varsity Girls grabbed a second place trophy on the back of incredible performances by eighth grader Michelle Basham. After taking first in school record time in the 1600, Michelle came from third to first in the final 50m of the 800 to complete the difficult double victory. She then anchored the 4X400 team to a fourth

place finish to complete the night. The Varsity Boys amassed four school records in the most difficult competition of the evening as they fought to a third place finish. The 4X100 team of Landry Assinesi, Conor Williams, Grant Gonzalez and Stephen Krause shaved over a second from the school record to begin the night before Alex Cargal obliterated the school's 400m record. William Hurtado followed that with



what was without a doubt, the most exciting race in St. Rita history.

Grant Gonzalez took the first circuit with baton in the final event of the evening as St. Rita battled a powerful St. Benedict 4X400m team. He passed to William Hurtado as the eight team race developed into a threeteam battle. Holy Family slowly dropped off as Hurtado chased the St. Benedict team. Stephen Krause grabbed the baton about 20 meters behind the Bruins but quickly chewed up the distance with a blistering leg. He gave the baton to Alex Cargal right on the Bruin's heels. Cargal refused to give any ground as the runners hit the home stretch. Each of Cargal's strides cut inches off the lead as the entire crowd stood up with only a few meters to go, Alex pushed past the leader and cut to the inside lane, blocking the competition and insuring the dramatic victory. The time sheets showed that each Raider runner had turned in the best leg of their career and the effort took eight seconds off the school record and six seconds off the CYO record.

That race epitomized the entire season for the tracksters as they showed the grit and determination that led them to overall point

a record in the 800m. This set the stage for victories in every meet this year, extending their unbeaten streak to 22 years. The meet also showed the competition that the Raiders will be tough to deal with for years to come, as so many fourth through sixth graders scored points in these finals.



Tips on Tipping

If you have been following Table for Two here at the Mountain Views News, you know that we like to sprinkle in helpful dining out tips as well as reviews. Just this week, a reader named Sylvia, had some thoughts on my tipping story.


I read a recent column of yours called "Table for Two". You mentioned tipping concerns in the column. "Tips, grapes, or gripes...

I have noticed that some restaurants print a list of suggested tip amounts on the receipt for various % tips. The problem is that some restaurants calculate these tip suggestions based on the total bill and not the total cost of the meal/drinks. Which means they are trying to get customers to pay a tip on the tax too! I have lived in and visited many US states (and 2 countries in Europe) but have never seen this until moving to Southern California. Everywhere else in the US, the tip is based on the cost of the meal, not the tax! I've also noticed that some people don't know that the tip is supposed to be calculated solely on the cost of the meal and drinks, not including the tax.

Finally, some people calculate the tip based on doubling the tax. In this area, that would be giving a very large tip since the tax is 9.75% in most places in this region. Giving a large tip is fine if it is what you had *planned* to do. But after telling some of my friends the amount of the accepted/expected tip versus what they were actually tipping, they were quite surprised. Many people don't have extra money in these financial times.'

Dear Sylvia,

I know that millions of customers appreciate your concerns, and are indeed confused by all of the different ways they are told and instructed to tip. It sometimes seems like we are doing our taxes all over again, and this conflicts with that. A pain! The reason we TIP is to insure prompt service. That is how it began in concept, but now we tip on quality of service as well, if the person addressed our needs and was helpful. I shared your note with a few restaurant managers and servers, and this very unscientific sampling, surprisingly, widely varied in responses. A few managers felt that you don't have to tip if you don't want to. I had to scratch my head on that one, sort of if you are in the mood type of spirit. As they say in the Army, it is the privates that do all the fighting, or in this case the serving. The servers that I surveyed on the other hand, strongly thought, if one can't afford to tip, stay home. Now that may be a little extreme. I guess if I'm forced to render an opinion I would say, if you are going all the way and dining out at a fancy steakhouse be prepared to tip! If you are just going to El Pollo Loco, no need to tip. I do admit that even at Starbuck's, when I wasn't happy I used to tip,

Looking Arc to Arcturus

OF THE 2,000 OR SO STARS that are visible to the unaided eye (or would be, in a dark sky far from city lights), only a relative few are known by name. The brightest ones have names given to them many centuries ago, mostly by Greek, Babylonian, Roman, or Arab starwatchers names full of history and lore, like Arcturus (Greek for "bear-guard"), Betelgeuse (Babylonian for "armpit"), Capella (Latin for "little she-goat"), and Deneb (Arabic for "tail").

Probably no one star has a more celebrated history than Arcturus, and the name is even mentioned in the Bible, in the book of Job. Arcturus is the fourth-brightest star in the entire sky (after Sirius, Canopus, and Alpha Centauri), and is easily visible in our city sky. This golden-orange star can be seen high in the east in the early evening, the brightest object to be seen in that area. The best way to find it is to look for the curving handle of the Big Dipper, now high in the northeastern sky, and then "arc to Arcturus"—extend the dipper's curve southward until you come to a bright star, which will be Arcturus.

To help in pinning down the locations of stars, the ancients created constellations, and they placed Arcturus in the constellation of Boötes, the Herdsman. Boötes is just south of Big Dipper is a part)—and Arcturus' name is derived from the ancient Greek arktos, bear, and rus, guard. One can imagine this bright star protecting the Herdsman's lambs from the ravages of the Great Bear of the north.

Later, more accurate measurements showed the star's distance to be actually a little less—36 light-years, or about 200 trillion miles—but the point was well made, and the event became an enduring footnote in the history of

The violin music of Nicole DeWeese was other-worldly, uplifting, and inviting as I approached the local outdoor memorial service. The music was beautiful, and sent my spirit soaring. HOWARD Hays As I See It

First, the news. Former New York Governor George Pataki brought his movement to overturn "Obamacare" to Orange County last week. He was joined

at a rally in Fountain Valley by Orange County Republican Chair Scott Baugh and Assemblyman Van Tran. According to the Orange County Register, 30 people showed up. (No, I didn't leave off any zeros.)

And now the election returns. A number of interesting races took place around the country, and some of us (since the Lakers were idle) were actually paying attention. If there's a trend, it's that two sides are becoming more clearly defined, and one side is clearly winning. It's not a matter of Democrat vs. Republican, or liberal vs. conservative. Rather, it's a contest between those perceived as being members of the Washington establishment, and those who aren't. To the extent partisanship plays a role, those who stay true to their party's ideals, whether Democrat or Republican, are winning over those whose allegiance is to the lobbyists and party honchos who call the shots.

Sen. Arlen Specter (D, R, whatever - PA) is best remembered for his grilling of Anita Hill during the 1991 confirmation hearings for Supreme Court Justice Clarence Thomas - employing the strategy that the best defense against charges of sexual harassment is to smear the accuser. He wasn't as eager to defend his support of President Obama's stimulus package among Republican voters (which could've been done with two words; "it worked"), so he switched parties. There was no equivocation in his opponent, Rep. Joe Sestak - retired Navy Vice Admiral - who boasts a strong environmental record, supports reinstatement of the federal assault weapons ban and has been a consistent supporter of healthcare reform. He described his support for accessible healthcare for all Americans as "payback" for the quality care he and his family received during his long career in the Navy. Regardless of the issues, and despite endorsements from Obama and Pennsylvania Gov. Ed Rendell, it was Specter's using party affiliation as a political tool that sunk his candidacy.

In Kentucky, a Senate candidate supports medical marijuana, opposed the invasion of Iraq and troop surge in Afghanistan, blames U.S. involvement overseas for 9/11, and argues the Patriot Act infringes on individual rights. That's Rand Paul, Tea Party winner of the Republican primary. Paul also supports congressional term limits and slashing everything and everywhere in the federal government - with the exception of Medicare payments, because that might "hurt doctors". (Dr. Rand Paul is an ophthalmologist.) But it appears his victory was not so much a referendum on issues as it was on the fact his opponent, Kentucky Secretary of State Trey Grayson, was the anointed candidate of the Republican establishment. Kentucky's junior Senator Jim Bunning was coaxed into retirement by senior Senator and Republican leader, Mitch

McConnell. He gave the nod to Grayson, and brought in the support of Republican bigwigs like Dick Cheney, Rudy Giuliani and the U.S. Chamber of Commerce. It was this perception of pre-ordained succession that riled Republican primary voters. It's also made Democrats optimistic they'll be able to take the seat in November with their candidate, state Attorney General Jack Conway. (Both Conway and his opponent in the Democratic primary garnered more votes than Rand Paul.)

Arkansas Sen. Blanche Lincoln won her Democratic primary, but didn't. She got more votes than Lt. Gov. Bill Halter, but not the majority needed to avoid a runoff. This was a race focused not on party affiliation, but on principals. Sen. Lincoln could not run from her record, despite the support of President Obama and noted Arkansan Bill Clinton, as well as a strategically-timed push for derivatives regulation in the current financial reform bill - withdrawn as soon as its "standing up to big banks" campaign purpose had been fulfilled. Arkansans remember how she stood up for corporate cotton growers when threatening to filibuster a proposed \$250,000 cap on farm subsidies, how she stood up for health insurance conglomerates when threatening to filibuster any "public option", and how she stood up for employers against workers' rights in opposing the Employee Free Choice Act.

Sen. Lincoln complained about "liberal interest groups" from outside the state becoming involved in the election, but in the end it was Arkansas voters who made the choice. They apparently agreed with Bill Halter's message that agriculture subsidies should go to help family farms, not corporate agribusiness; that educational loans should go directly to students and not channeled through banks so they can grab a hefty profit percentage, as in the current system supported by Sen. Lincoln; and a healthcare policy focused on the health of the people, not the health of HMOs and insurance companies from whom, according to Halter, Sen. Lincoln has received some \$800,000 in support.

Jane Hamsher, co-founder of Accountability Now, a PAC dedicated to the proposition that Democrats should act like Democrats, put it this way: "It's not so much an anti-incumbent sentiment as it is anti-Senate. People are tired of their arrogance, their sense of personal privilege, the way they completely dismiss the House and demand they swallow whatever Joe Lieberman wants . . . People aren't stupid. They understand what's happening. Yesterday the House of Lords got a giant kick in the teeth from a public hungry for accountability. Contrary to the wisdom of the punditocracy, the country isn't moving to the right. It's the corporatists who are going down."

The results of this election will provide an interesting backdrop for the few weeks leading up to the next round of primaries in June. Voters won't be beholden to the wishes of leaders in either party, and will demand the same of the representatives they send to Washington. In the meantime, should anyone wish to meet up-close a former New York governor or county Republican chairman, there might be another rally scheduled somewhere - and I'm sure there won't be any troublesome crowds to deal with.

GREG Welborn The Voter's Message

The two key elections held this week sent an undisputable message to our political leaders, even because these two guys aren't as those same political leaders are disputing that the same. any conclusions can be drawn. As we all know by now, the Republican candidate for Pennsylvania's congressional seat lost, as did the GOP handpicked Kentucky Senate primary candidate. In their places, the voters said that Democrat Mark Critz could take the congressional seat and that Tea Party candidate Rand Paul would represent the GOP in the November Senate race. That may look like a confusing state of affairs, but the message that ALL the winning candidates delivered to Washington D.C., and the current administration in particular, was remarkably consistent: get out of our lives, get out of our pocket books and get out of our doctor's office.

Looking at the Kentucky Senate primary first, Rand Paul handily defeated the candidate put forward by the Republican establishment. Exit polls showed that the voters listened carefully to a polished politician who said all the right things about reducing spending, taxes and the size of government, but who really relied more on his primo resume as a Republican insider who deserved the seat. Instead, Kentucky voters listened and elevated a political neophyte - an ophthalmologist - who had simply had enough of all that spending, taxing and meddling and got involved. His message was essentially the same, but much more believable. Think what you will about a first term Senator's ability to really do anything in D.C. (especially if he's held no previous political office), but you have to admit that he believed what he was saying and will go down fighting. Rand Paul is as close as you get to being a Libertarian while still being a Republican, he's a dedicated Tea party activist and will no doubt carry this message to Washington.

If ever there was a race where an establishment Republican should have won without much of a fight and thus signaled that the traditional method of raising up political leaders was alive and well, this was that race. The retiring Republican Senator, Jim Bunning, had served well and represented a conservative state admirably along those lines. The GOP establishment tried to put forward their candidate, Trey Grayson, who is the state's Secretary of State, which should have been an easy win for him. But a funny thing happened on the way. Some of the GOP stalwarts - these are the smart ones who "get it" - didn't support Trey Grayson. The retiring GOP senator himself, the State Senate President and a former campaign manager for former President Bush all said no. They threw their support behind the youthful, idealistic and inexperienced Rand Paul. They realized that the voters were tired of politics as usual, tired of out-of-control spending, and wanted someone who had a take-no-prisoners style. Yes, the GOP was handed a defeat, but it was the GOP that had gone along with President Bush's excessive spending, the same GOP that didn't stand strongly enough against the whole TARP disaster and bank bailout. That GOP is just a paler complexion of the Democratic Party. To the politicians of either party who don't get it, the message was clear - your services will no longer be needed, and don't let the door hit your you-know-what on the way out.

This is the same message that voters in Pennsylvania delivered when they elected a Democrat to fill John Murtha's congressional seat. This may be the toughest part of the lesson for career politicians. D.C. politicians may understand what happened in Kentucky, but if they view Pennsylvania's results as a counterargument, then they are in trouble and deserve to be so. The Republicans in Pennsylvania tried to run on a platform of "just say no to Nancy Pelosi and President Obama". They tried to nationalize this election and leave it at that. They got some traction from the fact that the Democrat, Mr. Mark Critz, was an aide to the "über-liberal attempts to paint Mr. Critz to be the same as

The Republican candidate said

he was against the healthcare bill, against cap and trade and against runaway spending. Unfortunately, the Democrat said he was against those things, too. Despite being Murtha's aide, the Democrat said he wouldn't have voted for them. He also said that he was pro-life and pro-gun. He also, like the Kentucky ophthalmologist who won, came across as credible and honest in his campaign promises. The proof will be in the pudding, as they say, but the voters clearly said the have had enough of high spending, high taxation and heavy-handed interventions in the economy. The Republican candidate lacked much of that credibility because

he has supported raising taxes in the past.

In addition to the commonality of the central themes in these three candidates, we find additional support in the fact that President Obama's endorsement in two other elections that same day spelled disaster for the candidates he supported. You'd think after campaigning in Virginia (and losing), campaigning in New Jersey (and losing) and campaigning in Massachusetts (and losing), that Democrats would be reluctant to ask President Obama to come out and express how fond he is of them. Somehow, Senator Arlen Specter and Senator Blanche Lincoln, both Democrats, didn't understand that they could decline drinking the Cool-Aid. Instead, they had the President make several appearances for them in each of their states, and they suffered for their foolishness. Specter is out and Lincoln was forced into a run-off.

So here's the short version of the message that our political leaders should understand. When an inexperienced Tea Party activist can defeat an establishment Republican in a conservative state, when the only winning Democrat is pro-life, progun, pro-fiscal restraint, and when the President's appearances for the other Democratic candidates all but kills their political future, you better figure out that Americans are sick and tired of excessive spending, excessive taxation and excessive interference in their lives.

can't tell you which party will win more seats in the House and the Senate in the November elections, and I won't even try. In fact, I'm not sure I care. I can tell you what message is going to win - and win big - in November. We've had enough. We want you to stop spending our children's and grandchildren's inheritances. 

Defending the CAHSEE

Your kids study hard in classes and earn passing grades. They stay on task during the school day, dutifully complete their homework, stay out of trouble, and attend school as often as their health permits. The one remaining hurdle they have to graduate is a test that assesses their ability to show mastery of several 9th and 10th grade state standards in English and mathematics. This last hurtle is the California High School Exit Exam (CAHSEE).

Lawsuits against the CAHSEE have been popping up since its inception. They usually center on its fairness, especially for students with special needs. I've seen quite a few reports about the latest lawsuit and a thought has been running through my head.

If real problems with the test exist, why did people wait until the last minute to bring these issues up and to bring them into court? Is it because their kids are finally up against the fence and have to face the fact that they've squandered their 12 years of free public education? We've known about this test as a graduation requirement for the class of 2006 since 2004, and the legislation for the test passed in 1999. But wait; now there's an exemption to the CAHSEE.

Beginning in the 200910 school year, **Education Code Section** 60852.3 provides an exemption from meeting the CAHSEE requirement as a condition of receiving a diploma of graduation for students with disabilities (any type of disability, for any duration) who have an Individualized Education Plan (IEP) or a Section 504 (educational access) Plan. The IEP or Section 504 plans must state that the student is scheduled to receive a high school diploma, and has satisfied, or will satisfy, all state and local requirements for high school graduation, on or after July 1, 2009.

EC Section 60852.3 also provides that students with an IEP or a Section 504 Plan, who have completed all graduation requirements except passing the CAHSEE, and may have received a Certificate of Completion in 2008 or 2009, are eligible for an exemption in order to receive a diploma. The exemption also applies to students in the class of 2010 who will have completed all graduation requirements, except passing the CAHSEE.

The Individuals with Disabilities Education Act (IDEA) of 1975, the Educational for All Handicapped Children Act (1975), and Section 504 of the Rehabilitation Act (1973) are essentially civil rights laws intended to guarantee access to public schools and remove obstacles for children with disabilities. Their objective is to level the playing field with instruction tailored to each student's special needs.

The CAHSEE exemption is not necessary because Special Education and Section 504 students are already allowed certain accommodations and modifications when taking the CAHSEE, not available to other students, like using calculators and dictionaries. As a result, a large proportion of special needs students pass the CAHSEE, despite their disabilities. (Note: students granted a high school diploma under EC 60852.3 are not eligible for further special education and related services at a K-12 public school.)

The CAHSEE is the best thing to happen to the public education system in a long time, but is not flawless. It is a gigantic step in the right direction, though. Now, if we could use the CAHSEE to replace silly, meaningless exams, like the battery of tests that fall under the STAR/CST designation that rate schools not students, and encourage colleges to consider CAHSEE scores when weeding through applicants, we'd have a test that students would really care about doing well on.

Shame on parents who sue the state for requiring a test that demands proficiency with standards that should have been mastered two (2) years prior to graduation. Shame on lawyers who accept these suits and build cases against a test that will, at least, begin to set a bar for those who want a high school diploma to mean something.

If high school diplomas are to be worth anything at all, students must be held accountable by demonstrating a basic mastery of direction.



Today's Subject: Headaches Part 3: Anxiety Health Tips From Dr. John Talevich

The mental/emotional aspect of head pain has to do with how we respond to the circumstances within our lives. Anger, resentment and helplessness lead to increased levels of stress hormones, triggering various chemical reactions. These reactions promote changes in the diameter of the blood vessels of the head, giving rise to pain patterns.

While it is sometimes possible to change a situation which is stressful, a good percentage of the time such may not be possible. Traffic, noisy neighbors, smog, the evening news, hostile co-workers are a few examples of what we may simply need to adjust to.

So, how can we reduce the stress around us? In the simplest terms, we can influence outer stress by modifying inner stress. In Dr. Herbert Benson, M.D.'s seminal work, The Relaxation Response, the author outlines a simple method for turning off the body's alarm system. This is done in two ways: First, the repetition of a word, sound, phrase, prayer or muscular activity which is positive and calming. Second, passively disregarding everyday thoughts that inevitably come to mind and returning to the chosen repetition.

Another way to describe this is to sit quietly for fifteen to twenty minutes and breathe slowly. Begin by repeating a word or phrase that has special meaning to you such as "peace," "I let go," "I breathe in, I breath out," or a small prayer if you are so inclined. While doing this practice, your mind will wander ~ simply bring your focus back to your phrase, gently and without any judgment.

This proactive practice reduces blood pressure and other components of stress, offering peace of mind and reduced ill effects. With consistent practice, stress can be managed and a healthy outlook

Facts About Driving and Aging

Facts about driving and aging Everyone ages differently, so some people can continue to drive into their seventies, eighties, and even beyond while others cannot or should not. However, the statistics on older adults and driving can be sobering.

Older adults and accidents

Statistics show that the elderly are more likely than other drivers to receive traffic citations for failing to yield, turning improperly, and running red lights and stop signs—all indications of decreased driving ability. It is a fact that older adults are at higher risk for road accidents than other age groups. Older drivers are more likely to get into multiple-vehicle accidents than younger people do, and the accidents are more dangerous for them than for younger drivers. A person 65 or older who is involved in a car accident is more likely to be seriously hurt, more likely to require hospitalization, and more likely to die than younger people involved in the same crash. Truth is, fatal crash rates rise sharply after a driver has reached the age of 70.

Environmental factors

There are environmental factors as well. These affect people of all ages and include signs and road markings that are difficult to see or read, complex and confusing intersections, older vehicles that lack automatic safety features, and newer dashboard instrument panels with multiple displays. Such factors are often amplified in those seniors who experience a decline in their ability to drive, and become very risky. For all of these reasons, you want to stay alert to your own driving experiences and be willing to admit and discuss any difficulties and concerns with a relative or someone else you trust.

Lessening aging risk factors that affect safe driving

It is easy to overlook problems that develop slowly over time because we typically accommodate our daily activities to what we can comfortably do. Consequently, issues like vision or hearing loss, decreasing physical activity, growing forgetfulness, or the impact of prescription and over-the-counter drugs are hardly noticed. Any one or a combination of these conditions can make driving hazardous.

Decrease risks by taking control of your

The most important and positive action you can take is to decrease the driving risks associated with aging. Do not wait until problems become serious. Tending to your health and well-being on a regular basis can help in your efforts to stay independent and mobile. The most common risk factors related to safe driving are listed below along with suggested steps you can take:

Visual decline

Get eyes checked every year and make sure that corrective lenses are current. Keep the windshield, mirrors, and headlights clean, and turn brightness up on the instrument panel on your dashboard.

Hearing loss

Have hearing checked annually. If hearing aids are prescribed, make sure they are worn while driving

Limited mobility and increased reaction time An occupational therapist or a certified driving rehabilitation specialist can prescribe equipment to make it easier to steer the car and to operate the foot pedals. Medications


Talk with a doctor about the effects of medications you are taking on driving



Amazing Maturity Just Two Years After Opening

San Marino mayor and Huntington docent, Dennis Kneier, invited me to join him on a tutorial for docents, guided by guest speaker, Daxin Liu of Fragrant Hill Design in the Bay Area. It's amazing what two years of plant growth has done for this 3.5 acre, first phase of the

Kneier commented, "The plants and architecture fit together perfectly, and the garden gets better and more interesting with each passing season. It's simply amazing how the garden has matured and blossomed in just two years time. The quietness and serenity of the garden takes one to another world. I love it."

Born in Beijing, our guide and guest speaker, Daxin Liu, came to Stanford in Palo Alto in 1990 for a Ph.D. in Applied Physics, working afterward in high tech. Drawn in a completely different direction some years later; Liu decided to study Horticulture and became a landscape designer in 2005.

He commented, "I think my love of plants and gardening started when I was grudgingly helping my grandfather tend his small rose garden in his traditional Beijing courtyard as a young teenager.

In our walk through the first phase of a planned twelve acre Chinese Garden, Liu called attention to design elements and specific plants incorporated into the lake, pavilions, bridges, tea shop and teahouse set into the wooded backdrop of the 207 Liu Fan Yuan, Garden of Flowing Fragrance, California's first public acres that encompass the Huntington site. Water, symbolizing Chinese Garden. If you haven't visited since the opening, now is the change, and rock, symbolizing the permanent or eternal elements, are critical to the classical Chinese Garden.

> Originally the estate of business magnate Henry E. Huntington, this private nonprofit institution includes a library of rare book and manuscript collections with exhibition space, permanent and changing art collections in three buildings including the 1911 Huntington Beaux-Arts mansion plus 120 acres of botanical gardens. Open to the public since 1928, the addition of the Chinese Garden, with hundreds of native Chinese plants, expands what was already one of the most celebrated botanical plant collections in the country, especially since so many of our most beloved landscape plants originated in China.

After a worldwide fundraising effort beginning in 2001, two Chinese firms were commissioned by the Huntington, The Suzhou Institute of Landscape Architectural Design and Suzhou Garden Development Company, Ltd. Delightfully, my guest at the tour, Joan Milazzo, was headed to Suzhou a

couple of days after our visit, and will bring back memories and photos of the gardens there to share with our readers The authentic Chinese structures were

designed and constructed in China to comply with California seismic codes and disabled access, a challenge in itself. Almost all of the materials were shipped from China, with the major exception of the hidden, structural steel that stabilizes the traditional structures and the concrete.

In 2006, when the time came for installation, eleven stone artisans traveled from Suzhou to install the hand-carved bridges and to carefully place the stones and boulders around the waters' edge, a revered art within Asian garden design in itself. The next year, fifty artisans arrived for six months of meticulous work in wood carving, installing Chinese style roofs plus courtyard and walkway pavers.

Several "scholar rocks" traditionally

incorporated into traditional Chinese gardens were also shipped to the Huntington. Sculpted by nature, the large limestone boulders have holes, wrinkles furrows and shapes "carved" into them, creating prized focal points for reflection in a traditional garden.


Classical Chinese gardens are highly linked to artistic, literary and academic pursuits and figurative or literal symbolism is often incorporated, beautifully paralleling the garden's presence at the Huntington institution. Chinese garden purposely melds its architecture and design with scholarly pursuit and the surrounding landscape, and flowery poetic names are usually given to gardens.


