#### We Remember & Give Thanks

They are the faceless figures that secure freedom. They are sons, daughters and parents, but to most Americas they remain nameless strangers. The history books have managed to chronicle a few of these heroes. Conversely, we know volumes on Washington, on Grant and that of Eisenhower. And if those men are rightly thought upon as the brains of war, than it must be true that farther down in the ranks resides the heart of America. As a nation, we demand much from our soldiers, for in their toil

we find safety and in their sacrifice we obtain victory.

On a rainy day in November of nineteen hundred and sixty-three, a group of people gathered upon a strip of land in Gettysburg to mark a battle. The Civil War had not concluded when these people gathered, but the magnitude of what occurred on this now quiet land demanded a voice. The renowned speechmaker, Edward Everett, had been deemed as the best equipped for a dedication of this importance, and when Everett was initially informed of the decision, he told the committee that he would need more time to prepare a proper speech, so the ceremony was postponed. The committee then decided to send an invitation to Abraham Lincoln a little over two weeks before the event. He was told that he was to have a "small part in the ceremonies."

Everett went on to give a marvelous speech that day, but would famously say in a note to Lincoln, "I should be glad, if I could flatter myself that I came as near to the central idea of the occasion, in two hours, as you did in two minutes."

For Lincoln, the emotion of that day at Gettysburg rose upon the mighty and inescapable witness of the Civil War. It was the soldiers that inspired and compelled the speech that Lincoln would deliver that afternoon. Lincoln's life was seeded with the words of the Bible and that of Shakespeare. And it is fitting that in a single poetic manifestation of precise cadence and embodiment of language, Lincoln would usher forth both the head and the heart of a people. The Gettysburg Address requires no backdrop for us to understand it; it needs no buildup of a great battle to be haunting in its theme. It is self-evident. A reverent prayer and venerated acknowledgement of all the actions that inspired America's greatest testament to the laws of freedom. The dead are eulogized, but we, the living, are implicated too. For as we look over the graves of those that have perished, we must know that their dreams were not wholly realized because of their sacrafice. And just as certain they have given to us a measure stronger than steel, they have delivered their "Sacred Promise."

If we are to endure as a nation of people we must determine that our eyes and our actions inhabit the example that is their sponsor. The light of Freedom burns brightly upon the holy alter, and it remains incumbent on us to justly recall the judgments of those thoughtful people that boldly risked and forfeited their lives for that common cause.

May the knowledge of their sacrifice always reside upon our prayers and our hearts.

#### THE GETTYSBURG ADDRESS

Four score and seven years ago our fathers brought forth on this continent a new nation, conceived in liberty and dedicated to the proposition that all men are created equal. Now we are engaged in a great civil war, testing whether that nation or any nation so conceived and so dedicated can long endure. We are met on a great battlefield of that war. We have come to dedicate a portion of that field as a final resting-place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this. But in a larger sense, we cannot dedicate, we cannot consecrate, we cannot hallow this ground. The brave men, living and dead who struggled here have consecrated it far above our poor power to add or detract. The world will little note nor long remember what we say here, but it can never forget what they did here. It is for us the living rather to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us-that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion-that we here highly resolve that these dead shall not have died in vain, that this nation under God shall have a new birth of freedom, and that government of the people, by the people, for the people shall not perish from the earth.

# **Alverno and Neighbors Reach Agreement**

#### School To Be Granted Temporary Use Permit Allowing Private Rental **Events To Continue**

Alverno High School, the All Girls High School on Michillinda in Sierra Madre, has come to an agreement with neighbors and was granted a much needed Temporary Use Permit that will help generate funds to sustain the school.

Since 2007, there has been an organized effort to have the school modify the way it operates so that neighbors would not have to have their tranquility disrupted. A group formerly known as the "Village Neighbors" initially wanted to prevent the school for its' supplemental income activities. However, after two years of negotiations, both sides finally came to an agreement and a TUP will be issued.

Alverno, which is on the grounds of the historic Villa Del Sol d'Oro, according to the Head Of School, Ann Gillick, depends on the income derived from private rentals to "provide scholarships and maintain the grounds". If a comprimise had not been reached and the city had refused to issue the use permit, the result would have been a major financial setback.

Not all residents took issue with the way Alverno operated. During the three council meetings that were held, there were as many neighbors in support of the school as there were those against the school. For the most part, supporters stated that not only was the school a responsible neighbor, but that the school had existed long before most of the members of the Village Neighbors moved to Sierra Madre. Said one ressident, "The

school was here when they bought their homes."

However, other neighbors complained of noise and disturbances. Police records of calls regarding problems at Alverno did not support those allegations.

Nevertheless, both sides agreed to change the way things are done. Alverno has agreed to new limits on events and the quantity of events they will hold during a month. They also agreed to install air conditioning in the Villa so that more events could be held inside and would not disturb anyone in any way.


As soon as the parties agreed, Village Neighbors began removing the protest signs that had appeared on lawns for month, and for now, the neighbors and school are in harmony.

# Ron Polidan Speaks to MWOA May 30 On "Future Space Telescopes"

The Mount Wilson Observatory Association's monthly public lecture, on Sunday, May 30, at the Altadena Library will feature Ron Polidan, Director of Civil Space Advanced Systems at Northrop Grumman, speaking on "Future Space Telescopes."

NASA is about to begin a new era of space telescopes with the launch of the James Webb Space Telescope in 2014. This telescope, currently under construction at Northrop Grumman Aerospace Systems in Redondo Beach, will be discussed in detail both as the scientific and technological marvel it is and as the pathfinder for a family of even larger telescopes of the future. In addition, other telescopes and related systems will be discussed in the context of the science they will perform and the technology that will be needed to enable them.

Dr. Polidan currently manages Northrop Grumman's Environmental Systems and Space Science and Exploration Business Areas. This includes Civil Space strategic planning, technology investment strategy, and the development of advanced mission architectures and concepts for NASA and NOAA science business. He received a Ph.D. (in astrophysics) from UCLA and has worked for over 30 years with NASA science missions of a wide range of sizes and disciplines. He is the recipient of a number of NASA awards including the NASA Medal for Exceptional Service.

#### About Dr. Patzert:

Often called the "Prophet of California climate," Dr. Bill Patzert is a scientist at the California Institute of Technology's NASA Jet Propulsion Laboratory (JPL) in Pasadena, Calif.

His research is focused on the application of NASA satellite data to improving our understanding of our planet's climate and important environmental problems ranging from developing El Niño, La Niña and longer-term climate forecasts to monitoring the health of coral reefs. The author of many scientific and popular

He had the ability to light up a room and that's exactly what he did every time I saw him. His memorable contributions to the Dodgers in 2004 and throughout baseball will always be remembered. Our deepest condolences and prayers go out to his family during this extremely difficult

According to McCourt, Lima had rejoined the team within the past month as member of the Dodger Alumni Association and was preparing to open a youth baseball academy this summer in Los Angeles to help teach the game he loved to youngsters. He was committed to making appearances in the community on behalf of the team, including an upcoming musical performance at a Viva Los Dodgers event this summer.

City Councilmember Steve Madison raised concerns Monday night over a pair of 16th century wood panels, once owned by a Nazi leader, on display at the Norton Simon Museum saying that they may in fact belong to a Connecticut family who is again asking for the paintings back. Madison asked the city's involvement?

Marei von Saher, of Greenwich, Conn., had unsuccessfully sued the museum for the paintings, depicting Adam and Eve, in 2007. Recently, Attorney General Jerry Brown filed a "friend-of-the-court" brief May 19 asking the U.S. Supreme Court to consider an appeal. The paintings were appraised last year at \$24 million.

"I was surprised to learn that there was even an allegation the Norton Simon was even in possession of such a piece," Madison said suggesting city attorney Michele Bagneris to look into the matter. "The city owns that property and leases it to the Norton Simon... I'd like to think that someone who's operating a museum on city property might be less swayed by technicalities."

#### **Police Officer Unintentionally Discharges Weapon in Car**

According to an issued statement Monday, Pasadena police officer accidentally shoot out the front windshield of a patrol car while initiating a felony traffic stop in the 1100 block of North Raymond Avenue. Another officer in car was taken to a local hospital complaining of hearing loss.

Police said the two officers were responding to a domestic violence call approximately 8:45 a.m. The names of the officers were not given.

"I will release a full statement when all the facts are known," said Interim Police Chief Christopher Vicino.





I am fully aware that times are tough and when you are going to spend your hard earned dough, you want to feel that you got your money's worth. I thought about changing the name of the article to, "My Money Says ... ". What do you think? But I digress.

Beckham Grill has been around since 1977. Originally named after owner Bob Beckham, it was known as Beckham Place. There are new owners, but the management remains the same. The restaurant by today's standards is "Old School." It's not a dark restaurant, but is cozy and faintly lit. # Phoenix Mars Lander Does Not Phone Home

the spacecraft were unsuccessful. A new image transmitted by NASA's Mars Reconnaissance Orbiter (MRO), looking down on Phoenix from orbital height, shows signs of severe ice damage to the lander's solar panels.

"The Phoenix spacecraft succeeded in its investigations and exceeded its planned lifetime," said Fuk Li, manager of the Mars Exploration Program at NASA's Jet Propulsion Laboratory in Pasadena, Calif. "Although its work is finished, analysis of information from Phoenix's science activities will continue for some time to come."

Last week, NASA's Mars Odyssey orbiter flew over the Phoenix landing site 61 times during a final attempt to communicate with the lander. No transmission from the lander was detected. Phoenix also did not communicate during 150 flights in three earlier listening campaigns this year.

Earth-based research continues on discoveries Phoenix made during summer conditions at the far-northern site where it landed May 25, 2008. The solar-powered the lander are consistent with predictions of

operations after repeated attempts to contact and kept working until sunlight waned two months later.

> Phoenix was not designed to survive the dark, cold, icy winter. However, the slim possibility that Phoenix had survived could not be eliminated without listening for the lander after abundant sunshine returned.

The MRO image of Phoenix taken this month by the High Resolution Imaging Science Experiment, or HiRISE, camera on board the spacecraft suggests the lander no longer casts shadows the way it did during its working lifetime.

"'Before' and 'after' images are dramatically different," said Michael Mellon of the University of Colorado in Boulder, a science team member for both Phoenix and HiRISE. 'The lander looks smaller, and only a portion of the difference can be explained by accumulation of dust on the lander, which makes its surfaces less distinguishable from surrounding ground."


NASA's Phoenix Mars Lander has ended lander completed its three-month mission how Phoenix could be damaged by harsh winter conditions. It was anticipated that the weight of a carbon-dioxide ice buildup could bend or break the lander's solar panels. mission's biggest surprise was the discovery of perchlorate, an oxidizing chemical on Earth that is food for some microbes and potentially toxic for others.

Who's to blame? I want to point fingers. I want to "play the blame game". President Obama, usually criticized for doing too much, is now being accused of not doing enough in addressing the BP oil spill. One critic suggested a link between campaign donations and "taking

so doggone long to get in there, to dive in there, and grasp the complexity and the potential tragedy that we are seeing here in the Gulf of Mexico." That was from Sarah Palin, whose ticket in the 2008 election received \$2.4 million from oil and gas, vs.

There's been a reference to another Louisiana tragedy in calling this "Obama's Katrina". But in 2005 we had an administration ignoring days and weeks of warnings (as it similarly ignored warnings of an impending terror attack four years earlier). No doubt there were inadequate preparations, but here's what happened after the initial April 20 blast on the offshore rig: The next day, April 21, President Obama held a briefing on the event with Homeland Security Secretary Janet Napolitano, Interior Secretary Ken Salazar, Coast Guard Commandant Adm. Thad Allen, EPA Deputy Administrator Bob Perciasepe and FEMA Administrator Bob Fugate. Deputy Interior Secretary David Hayes was dispatched to the site to "assist with coordination and response". The Coast Guard had four units at the scene fighting fires and engaging in search and rescue, with additional units on the way.

By April 23, the Coast Guard and the Interior Department had "technical teams in place overseeing" efforts by the "responsible parties" (BP and Transocean) to "secure the well". At that time it looked like the situation was under control, but the Coast Guard said they were working with BP to "prepare

for a worst-case scenario". On April 25, a "unified command team" of federal, state and industry personnel was in place. A plan was approved to activate a "blowout preventer", and BP invested heavily in buying off had another rig on the way to drill a relief well.

By April 26, 1,000 personnel, 10 offshore vessels and 7 skimming boats were involved in the clean-up. Air crews from safety equipment and inspection the U.S. Fish and Wildlife Service and teams from the National Oceanic and Atmospheric Administration conducted their own surveillance, and their findings led Coast Guard Rear Adm. Mary Landry to declare on April 28 that the spill was at least five times worse than what BP had led everybody to

On April 29, Homeland Security Secretary Napolitano declared the spill to be of "national significance", allowing the draw-down of resources from across the country. EPA Administrator Lisa Jackson described onshore teams already in place in advance of landfall, as well as continuing flights monitoring the situation from the air. Two Air Force planes were sent to Mississippi to prepare for a chemical drop. On April 30, the Wall Street Journal reported the U.S. Navy had sent 12 miles of inflatable booms, seven skimming systems and 50 contractors to the Gulf, and made available facilities in Mississippi and Florida to the effort, as part of what it described as President Obama's "robust response" to the crisis. All this occurred within 10 days of the initial blast.

Who's to blame? Louisiana Governor Bobby Jindal acknowledged that "BP is the responsible party, but we need the federal government to make sure they are held accountable and that they are indeed responsible. Commandant Thad Allen of the Coast Guard explained, "To push BP out of the way (as suggested by Interior Secretary Salazar), it would raise the question, to replace them with what? There's the reality that, despite the resources of the federal government, fighting a major oil gusher fifty miles offshore and over 5,000 feet beneath the surface requires a rather specialized set of skills and equipment. Regardless of blame, it appears BP is in charge of taking care of the situation, and the federal government is in charge of making sure they do.

Who's going to pay for it? BP has committed to covering all "legitimate" costs, but it's unclear how long it might take in court to define the term "legitimate" (there's been twenty years of litigation in the Exxon Valdez case). Sen. Robert Menendez (D-NJ) has introduced legislation to remove the relatively insignificant \$75 million cap on damage liability, but has been stopped by Republicans who want to treat oil companies the same as Wall Street investment houses; fully entitled to profits, but able to turn losses over to taxpayers. Sen. James Inhofe (R-OK) advances the argument that removing the cap would have a discouraging effect on small businesses (like those Mom-and-Pop entrepreneurs who can't decide whether to open a corner deli or an offshore drilling platform).

Who's to blame? There's BP, who invested heavily in buying off politicians and federal agencies in order to avoid investing in safety equipment and inspection teams. There's the federal government, which allowed itself during the last administration to become a wholly-owned subsidiary of Big Oil.

And, there's us - specifically the "us" of thirty years ago. At that time we had a president calling for "the most massive peacetime commitment of funds and resources in our nation's history to develop America's own alternative sources of fuel" and achieving "the crucial goal of 20 percent of our energy coming from solar power by the year 2000". We had a governor calling for conservation and taxpayer subsidies going to wind and solar energy rather than to Big Oil. An early act of the incoming Reagan Administration was to remove the solar panels Jimmy Carter had installed on the roof of the White House; Jerry Brown was derided as "Moonbeam".

I don't know what crisis will be occurring some thirty years from now, but I'll bet some columnist will be writing about warnings given back in 2010 - about global warming, for example - that were ignored. And we won't have to ask who's to blame for ignoring them.

This week's article is going to be shorter than most, and so I offer apologies to the editor who has to now figure out how to use the space I would have otherwise taken. My rational for brevity is simply to direct the most attention possible away from me, my opinion, or anything else that might distract, and to place the attention where it more rightly belongs: on those who have given the last full measure of their devotion in support of the values and blessings we hold most dear as Americans.

This week's article is dedicated to those who have served, and most especially to those who have died, in defense of this great country.

I have been able to travel a great deal in my life and in so doing developed a habit which has only been reemphasized in the years since 9-11. Wherever I am, in whatever airport I am transversing, restaurant I'm eating or hotel I'm staying, I make a point of approaching anyone who wears the uniform of one of our services in order to thank them for their selflessness and to ask how things are going for them. In all the years I have done this - both before 9-11 and after - I have never experienced a bad attitude or heard a complaint. Given the number of soldiers, sailors, airmen and Marines I've met, that's an amazing occurrence. And it's not accidental.

If you've ever really looked into a soldier's face, you've seen the same thing I have. Now sometimes that face belongs to a kid, too young to bear the burden we ask, sometimes it belongs to a wizened middle ager who's born more of that burden than we should ever ask, but always it belongs to someone who radiates a determination to do what's right, to do what's needed at the moment, to do what his or her country asks in order to bless the rest of us who call ourselves Americans. That face, that certain look which they all bear, speaks of pride in how that responsibility has been shouldered over the years of their own time in uniform, but also pride in the long line of those who have gone before. Band of brothers is more than a movie title; it's more than a description of the bond shared by members of the same unit. It's a description of the loyalty to one another that they all share across the years, decades and centuries - a description of the mutual respect they have for one another and the acknowledgement that they all are responsible for what we enjoy today.

Some of them are more responsible for these blessings than others. They are the ones who didn't come back to these shores after doing their duty. They are the ones who have indeed given the last full ounce of their devotion. Their comrades in uniform owe them much, but we owe them more.

I want to close this week by paraphrasing a poem. I don't know it's author – so I hereby thankfully give attribution to an unkown - and with acknowledgement that it originally applied to all who wore a uniform, I hereby dedicate it on this Memorial Day specifically to those who did not come home.

It is the one who has fallen, not the reporter, who has given us freedom of the press, although many a journalist can't wait to fault the soldier for his honest mistakes.

It is the one who has fallen, not the pundit, who has given us freedom of speech, although many an orator has mocked the idea of duty, honor and country.

It is the one who has fallen, not the campus organizer, who has given us freedom to assemble, although many a student has sought to expel the uniform from the commons.

It is the one who has fallen, not the lawyer, who has given us the right to a fair trial, although many a jurist has sought to hamstring the military and destroy its warrior culture.

It is the one who has fallen, not the politician, who has given us the right to vote, although many who hold public office have sought to use the military as props or weapons for their own political expediency.

It is the one who has fallen, not the rest of us, who knows the price of what we have. May we honor them publicly today and in our hearts always.

#### More Jobs, Not More Lawsuits By Senator Bob Huff



More than 12 percent of California's workforce is now unemployed. In Los Angeles County, more than 600,000 former workers are without jobs. Public tax revenues have plummeted, critical services have been slashed, family incomes have stagnated and the business climate is depressed. While we struggle to find a comprehensive solution to these economic woes, one obvious, critical remedy is consistently ignored: frivolous lawsuits. California's burdensome and biased litigation climate discourages new start-up businesses, slows the growth of our existing small companies and threatens millions of jobs at the very moment we need them the most.

California has one of the worst litigation climates in the nation. Pointless, wasteful and unnecessary civil lawsuits cost Californians billions of dollars every year. Frivolous lawsuits

erase thousands of jobs in our state. In an economy as depressed as this one, we simply cannot afford to waste critical resources or slow our workforce. Right now, we need more jobs and fewer lawsuits. More than four class action lawsuits are filed every single day in California. Last year more than 1.6 million class action, tort, personal injury, damages and contract lawsuits were filed in

California - making us the most litigious state in the nation. Not only do we file the most actions, but our courts are among the most biased. A recent survey by the U.S. Chamber of Commerce ranked our state 46th in the nation for legal fairness - placing California among the five most biased court systems in the country.

The legal costs of these cases, both in financial terms and job losses, are immense. The negative legal

climate affects all businesses, but small businesses are at the greatest risk. Most small businesses operate on small profit margins; in an economic downturn like ours, a single lawsuit can be the difference between a job-creating business and more people looking for work. The National Federation of Independent Businesses in California recently found that 98 percent of responding small business owners believe lawsuits hurt our economy, one third have been sued in

the last five years, and six-of-ten have been threatened by lawsuits during the same period. Of equal

concern are the job losses from larger companies that relocate from litigious California to other

states with more balanced legal systems. We can't know the full financial cost or number of jobs lost to frivolous lawsuits. What is certain, though, is that these personal and economic losses are a very serious burden in the best of times – however, in this recession, unnecessary lawsuits threaten any chance we have of recovery. It is way past time our Legislature acted to balance our courts, limit unnecessary

lawsuits and give our businesses a chance to restore this state's wealth. As a state senator, I know firsthand how difficult it can be to pass common sense legislation to support our businesses. I introduced a bill, Senate Bill 1017, which will protect retailers from product liability lawsuits when the retailer has no responsibility for the product. Current law

now holds retailers liable for anything they sell, even when the seller has no knowledge of or control over the defective product. SB 1017 represents just one element of desperately needed broad civil justice reform. We need to remedy a number of costly, valueless and destructive aspects of our legal system before we will see real improvement in our economic situation. A survey of Southern California voters by the non-profit group California Citizen's Against Lawsuit Abuse found voters overwhelmingly recognize unwarranted lawsuits negatively affect job growth and our economy. The same voters overwhelmingly support candidates that promote genuine legal reform. All the elements necessary for real progress on legal reform are in place: economic pressure, public support, a recognized problem and clear solutions. All we need now

#### **HAIL** Hamilton My Turn Why We Celebrate **Memorial Day**

Once in a while I'm moved to tears. On April 17 I went with a couple of old friends to get together with a bunch of other folks, most of them combat veterans, in a small Burbank park to commemorate a Marine who had been awarded the Medal of Honor.

It was a beautiful day to be in the park, and an even better day

The focus of attention was a young Burbank man named Larry L. Maxam who died 42 years ago in a far away place this nation has tried hard to forget.

The 20-year-old Burbank Marine never got the due he deserved from his hometown, on this day he finally did. Pacific Park in Burbank was renamed the Larry L. Maxam Memorial Park.

There were hundreds who came to the ceremony that lasted

about two hours to hear numerous dignitaries speak. There were also a dozen Marines present, who had fought alongside Larry when he died. The last of his old squad. The audience solemnly watched as a lone bugler played Taps and

Larry's family was presented with an American flag. Afterward a contingent of Marine riflemen fired a 21-gun solute. There wasn't a dry eye in sight. The dedication included new a park sign and a bronze plaque containing Larry's full Medal of Honor citation. It was a moving

ceremony for a war hero who died saving his fellow Marines. I'm sure Larry would have been pleased with the crowd who came to honor him. Born in Glendale, Larry attended Burbank schools before

enlisting in the Marine Corps in 1965. He arrived in Vietnam two years later and served as a rifleman, radioman and squad leader with Company D, 1st Battalion 4th Marines, 3rd Marine Division.

On 2 February 1968, four months after being promoted to corporal, while participating in Operation Kentucky, Larry's squad was sent to Cam Lo District Headquarters, Quang Tri Province, Republic of South Vietnam. TET, the massive North Vietnamese offensive, had begun three days earlier.

Larry's squad was guarding the perimeter of the compound when his position came under heavy artillery and gun fire. A large breach was created in the perimeter. Wounded by fragments of exploding grenades, Larry ran to an abandoned machine gun and fired on advancing forces.

"As the enemy directed maximum firepower against the determined Marine, Cpl. Maxam's position received a direct hit from a rocket-propelled grenade, knocking him backwards and inflicting severe fragmentation wounds to his face and right eye,"

according to the citation that accompanied the medal.
"Maxam returned to his feet and kept firing. He was hit again with small-arms fire... [but] gallantly continued to deliver intense machine gun fire, causing the enemy to retreat to cover. In a desperate attempt to silence his weapon, the North

inflicting two additional wounds. "Too weak to reload his machine gun, Cpl. Maxam fell to a prone position and valiantly continued to deliver effective fire

Vietnamese threw hand grenades and rifle fire against him,

"After 1 1/2 hours, during which he was hit repeatedly by fragments from exploding grenades and concentrated small-arms fire, he succumbed to his wounds, having successfully defended nearly half of the perimeter single-handedly."

Larry did what was right; he sized up the situation and, with extraordinary valor, did what he had to do to protect his fellow Marines. His actions are a remarkable testament of courage under

On 20 April 1970, Larry was posthumously awarded the Medal of Honor by President Richard Nixon for his "conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty." Larry was buried in the National Memorial Cemetery of the Pacific, Oahu, Hawaii. The Marine Corps Motto "Semper Fidelis" means "Always

faithful." More common is the abbreviated verbal version, "Semper Fi," used by Marines to voice loyalty and commitment to their comrades in arms. As they say, "Once a Marine always a Marine."

This Memorial Day take a moment to reflect on Larry L. Maxam and all the other American servicemen who have sacrificed their lives in our defense.

This is why we celebrate Memorial Day. Semper Fi.



## YOUR HEALTH MATTERS

Today's Subject: More On Stress Management Health Tips From Dr. John Talevich

"I am an old man and have seen a great many troubles, but most of them never happened."

While there are many things that stress us which are outside our control, we see in Mark Twain's quote that a good number of stresses come from our own projections. So, if it's an inside job, what can be done about it? How can we practice custody of our thoughts and feelings? How can we calm down?

Brain wave studies have produced a working model of how body chemistry is affected by our thoughts and how this chemistry, in turn, affects our thinking. One of the primary pathways is called the HPA axis; it excites a series of responses that light up the fight/flight pattern. When this pattern becomes chronically active a professor becomes chronically active, a preference for stress is established. One more easily becomes anxious, depressed, confused, angry or moody. Fortunately, this response pattern can be trained to move along other

neuropathways, establishing balance and equanimity.

Here are a few simple practices that raise the threshold for stress response patterning:

- Take a walk. Not a horse race, a stroll of a half hour, twice a day. Smell the flowers! Breathe. A simple breathing practice of inwardly saying "I am breathing in, I am breathing out" is very effective. If you need some help with this, set a timer and breathe in and out calmly for
- Stay in the present moment. By keeping our minds aware of "the now," we eliminate the constant provocation that our monkey-minds demand. We relax.
- Water. Bent out of shape? Sit down with a glass of water, breathe, calm the mind and return to the present moment.



#### **Walking Tips For Seniors**

Walking may be the best fitness activity for many seniors givern the relatively low physical risks and the enormous long-term health benefits. These 'Walking Tips for Seniors' are designed to reduce the risk of often preventable foot and ankle injuries and ailments that could lead to inactivity, and prohibit many seniors from realizing the tremendous benefits of walking.

The Foot Health Foundation of America (the Foundation) -- the education arm of the American Podiatric Medical Association (APMA) -- has issued guidelines for seniors in response to the recent release of two major long-term studies confirming the beneficial effects of regular walking on a person's overall health and well-being.

One study revealed that regular exercise walking lowered the risk of death from

cancer and cardiovascular disease and -in general -- prolonged life. Increasing the walking distance from just one to two miles produced even greater results. The second study found that taking brisk half-hour walks just six times a month appeared to cut the risk of death by 44 percent, and even occasional exercisers were 30 percent less likely to die than sedentary folks.

"Now -- more than ever -- we are urging Americans to get up and go. These tips should serve as a great starting point, from choosing a proper walking sneaker to knowing where and when to walk," commented Dr. Marc Lenet, DPM, president of APMA. "To ensure a successful and safe walking program, seniors should also consult their primary care and/or podiatric physician - especially if they have a family history of heart disease, poor circulation or diabetes, or if they have any pre-existing foot conditions.'

Benefits of Walking
In addition to the long-term benefit of prolonging life, the Foundation points out that seniors can experience many short-term benefits from walking.

-- Controls weight, blood sugar and cholesterol levels. A brisk walk can burn up to 100 calories per mile or 300 calories per hour. Walking is the perfect complement to a sensible diet to lose weight and keep it off;

-- Improves cardiovascular fitness and circulation. Walking gets the heart beating faster to transport oxygen-rich blood from the lungs to the muscles; and increases the size and improves the efficiency of tiny vessels that supply blood for cellular respiration;

-- Facilitates medical rehabilitation and recovery from many ailments, including

Generates a sense of well-being, and can relieve depression, anxiety and stress by naturally producing endorphins, the body's natural tranquilizer;


#### Getting started

The Foundation recommends setting appropriate and realistic goals, pacing oneself, choosing an appropriate and "like-able" activity, and paying attention to what the body, including the feet, reveals. Drinking fluids on hot days or during very strenuous activities to avoid heat stroke and heat exhaustion is vitally important.

#### Recipe of the Week:

#### Really Good Potato Salad

#### **INGREDIENTS:**

6 eggs 10 red potatoes 1 cup mayonnaise 1/2 cup ranch dressing

1/3 cup dill pickle relish 2 tablespoons prepared yellow mustard

1 1/2 teaspoons salt

1/4 teaspoon ground black pepper

1/8 teaspoon paprika

2 stalks chopped celery 1 onion, chopped

1/4 cup pepperoncini (optional) 1/4 cup sliced black olives (optional)

#### **DIRECTIONS:**

Place the eggs into a saucepan in a single layer and fill with water to cover the eggs by 1 inch. Cover the saucepan and bring the water to a boil over high heat. Remove from the heat and let the eggs stand in the hot water for 15 minutes. Pour out the hot water; cool the eggs under cold running water in the sink. Peel and chop the cooled eggs.

Place the potatoes into a large pot and cover with water. Bring to a boil over high heat, then reduce heat to mediumlow, cover, and simmer until tender, 15 to 20 minutes.

Drain and refrigerate until cold. Peel and cube once cold. Stir together the mayonnaise, ranch dressing, relish, mustard, salt, pepper, paprika, and celery seed in a mixing bowl. Add the eggs, potatoes, onion, pepperoncini, and olives; stir until evenly mixed.

Cover and refrigerate at least 2 hours before serving.

One Of A Kind: Featuring unique homes & gardens and the people who create them Story and Photos By Chris Bertrand **Progress At The Pinney House** 

'Welcome to the Money Pit!" chuckled Pinney House owner and chief restorer, plumber, painter and carpenter, Greg Asbury last week to two civic groups, The Sierra Madre Chamber of Commerce and the local Rotary Club.

Invited by Asbury and his wife to hold their meetings at their 10,000 square foot historic home in the midst of restoration and renovation, both groups enjoyed a tour of the family's progress on restoration since they purchased the property in 2003.

Constructed in 1887 for retired civil war surgeon, Dr. Elbert Pinney, the Asburys have been delighted by contact and visits

from descendants of the original owner, and now have copies of family and historical home photos for their archives. They've learned that early civic meetings took place at the home, in lieu of a town hall.

When I last visited the Pinney House for a 2007 article, Asbury calmly chatted with me while workers were busily lowering decades of plaster and lathe room dividers right behind us. saw a warren of rooms, 1960's era kitchens, 6'x10' windowless "hotel" rooms from a century old design and dust, dust, dust.

Back in the 1800's, a modestly priced hotel room at a place like the Sierra Madre Hotel sometimes meant a "room with only room for a bed" to fall into after a day of hiking in the San Gabriel Mountains, or later a room to "dry out" in a Betty Ford-style Center in the Jimmy Durante era. Even later, those windowless rooms became part of nine apartments within the Pinney House. (Ône was occupied by new city

council member, Josh Moran, in his tender years.)

Greg Asbury recounts their home restoration

Today those windowless hotel rooms are gone, and work is well under way for six new bedrooms and baths befitting this Sierra Madre treasure. The Asburys reflected that it was financially possible to do some much renovation only because they shouldered most of the work themselves. Hence, they've drawn heavily on Greg's experience rehabbing old homes, begun way

Asbury fascinated the groups with anecdotes and near horror stories of remodeling. Asbury discovered an old style of house framing called ballooning was used for the construction of part of the home. Common until modern building codes required firestops and shear walls stiffening the structure, the good news is that "the balloon framing allows air to flow from under the house that is naturally temperate and moderate both hot and cold days. It actually provides flexibility to the structure" evidenced by the home's survival though several other Sierra Madre structures fell in the 1990 earthquake, including several homes on Grove behind them, and the monastery on Sunnyside.

In one harrowing incident, work on an outer wall uncovered that only one 2"x6" beam fully supported the turret room, or oriel, on the third floor. Wide eyed, Asbury hustled up to the turret, currently occupied by a crowd of nine at a meeting his wife was holding. He didn't rest until the turret was emptied and the framing reinforced.

In completing the turret, Asbury ruefully recalls, "I will never forget climbing up to the top of the roof to plant the spire on the turret as the wind whipped me around." Oh, the joys and adventures of

Another time, an unsent love letter by a senator contemporary of Abraham Lincoln was uncovered when baseboards were removed in one of the bedrooms. Written in the flowery Victorian language of the era, it was penned at another hotel stop for the senator, Pasadena's Hotel Green. Alas it was never sent and somehow slipped behind the baseboard a century ago.


In 2006, when I first started traversing Lima Street in Sierra Madre on daily treks through town, my eye was drawn to the tired but still majestic "Lady on Lima"... the Pinney House. Its faded color was one we'll call "formerly white." After years of work, including a period with scaffolding around the structure, the house now sports an intricate Victorian color palette that fits beautifully in the 21st

If I'd been painting, I'm not sure I could have kept all of it straight with all the curlicues and spindles in multi colors, but the finished effect is stunning, with olive and tan and maroon. I'm truly afraid to ask the number of gallons required.

Designed by San Francisco then Los Angeles based brothers, Samuel and Joseph H. Cather Newsom, this


huge Queen Anne Victorian structure was intended as a country inn, and as such, not meant to be elaborate. The Asburys are slowly purchasing accoutrements Victorian, their sometimes searching out of state for pieces. In Arizona recently, they found an elaborate walnut fireplace facing manufactured by the Newsoms. Now it's the beautiful focal point of the main parlor.

More "over the top" examples of the "Gruesome Newsom" brothers' work is available at the Carson Mansion in Eureka, CA, reputed to be one of the most photographed and ornate Victorians. A much closer example is the fully restored San Dimas Hotel about 15 miles east of Sierra Madre, completed in March, 2009.






In 1915, inspired by the poem "In Flanders Fields," Moina Michael replied with her own poem: We cherish too, the Poppy red That grows on fields where valor led, It seems to signal to the skies That blood of heroes never dies.

She then conceived of an idea to wear red poppies on Memorial day in honor of those who died serving the nation during war. She was the first to wear one, and sold poppies to her friends and coworkers with the money going to benefit servicemen in need. Later a Madam Guerin from France was visiting the United States and learned of this new custom started by Ms.Michael and when she returned to France, made artificial red poppies to raise money for war orphaned children and widowed women. This tradition spread to other countries. In 1921, the Franco-American Children's League sold poppies nationally to benefit war orphans of France and Belgium. The League disbanded a year later and Madam Guerin approached the VFW for help. Shortly before Memorial Day in 1922 the VFW became the first veterans' organization to nationally sell poppies. Two years later their "Buddy" Poppy program was selling artificial poppies made by disabled veterans.


