Winners! 44th Annual Mt. Wilson Trail Race

The 44th Annual Mt. Wilson Trail race took place last Saturday as the town came out to cheer for almost 300 runners that decided to tackle the 8.6 mile course that reaches elevations of more than 2,100 feet. Runners of all ages took on the trail that has been run since the 1800's. According the the race's official website, "The Mt. Wilson Trail has been noted since 1840 as a packing and hiking trail which rises from Sierra Madre to the summit of Mt. Wilson eight miles away.

The Mt. Wilson Trail Race is sanctioned by the Athletic Congress and is considered to be one of the toughest of the "uphill" runs in the circuit. Due to the steep, narrow features of the trail, the race is limited to a maximum of 300 runners. The limit is established by the volunteer Sierra Madre Search and Rescue (continued on page 2) Madre finished the race in made in second place.

On Tuesday, residents of the 59th Assembly District will go to the polls to select the person they wish to represent them in the November general election. However, because of the district lines that have been drawn many people, especially those in Sierra Madre, have no idea who the candidates are. Overshadowed by the gubernatorial primary race and the ballot measures, there is a clear lack of visibility of the candidates in this area.

In addition, the current configuration of the district, which covers parts of Los Angeles and San Bernardino counties, creates an isolation that, according to one local resident, "makes our town the step child of the district."

The district includes 16% of Arcadia, Bradbury, Claremont, Duarte, Glendora, La Crescentá-Montrose - 93%, La Verne, Monrovia - 61%, San Dimas - 87%, Sierra Madre, Apple Valley, Crestline, Hesperia, Highland - 36%, Lake Arrowhead, Mentone, Redlands - .09% and San Bernardino - 17%

There are 6 Republican candidates, 2 Libertarians and 1 each Democratic and American Independent. Therefore, the primary election will determine which Republican - Bye, Calaycay, Donnelly, Hnter, Lancaster or Riley will run against the Libertarian choice (Fernandes or Tyler) and Darcel Woods, Democrat and Robert Gosney, AI.

Although there have been few signs displayed in Sierra Madre or the portion of Arcadia that is in the

Chris Lancaster, La Verne, www.lancaster2010. com, served three terms on the Covina City Anthony Riley, Hesperia, (www.rileyforassembly. com). is a member of the School Board and labels

himself as a "conservative Reagan Republican". Dan Fernandes, La Verne, www.danfernandes.

com, is currently Chair for the East San Gabriel Valley region of the Libertarian Party. He will face Libertarian Anthony "Tony" Tyler, Apple Valley for the nomination.



Team which regularly monitors the trail and provides emergency support on race day. Unique features of the Mt. Wilson Trail Race include its historical value to the community and a competitive course layout for runners. Innovative features involve the use of volunteers and support groups, specifically in the preservation of the Mt. Wilson Trail.

Mt. Wilson Trail History

The first trail to Mt. Wilson was made by the Gabrielino Indians and was used by them when they carried timber from the mountains for use in the construction of the San Gabriel Mission in 1771. The original "Mt. Wilson Trail" was built in 1864 by Benjamin I. Wilson, known as "Don Benito." In 1889, Harvard College established the first observatory on Mt. Wilson. The

Pacific Electric "Red Cars" e s t a b l i s h e d their route to Madre Sierra 1906 until Literally thousands people rode the cars to Sierra Madre to hike the Mt. Wilson Trail.

Largely through the efforts of a few dedicated and ambitious Sierra Madre residents, the Sierra Madre Historical Wilderness Area was established by declaration of the City Council on January 24, 1967 dedicated and January 27, 1968. On October 12, 1993, the Sierra Madre City Council included the Mt. Wilson Trail on the Sierra Madre Register of Historic Čultural Landmarks.

On Saturday of Memorial Day weekend, nearly 300 people completed one of the most arduous athletic events around: the 2010 Mt. Wilson Trail Race.

This sporting event, which dates to 1908 and thus is the second oldest race in California, requires participants to run from downtown Sierra Madre to Orchard Camp, halfway up Mt. Wilson and back again, a length of 8.6 miles and a vertical gain of 2,100 feet. The trail is a single track most of the way up and there are drops of 200 to 300 feet.

This annual event brought many organizations together to bring to the community "a celebration of the trail." Sierra Madre Civic Club provided registration and finish line volunteers. Sierra Madre Police Department saw to a safe course all the way up to the trailhead from Kersting Court. Sierra Madre Volunteer Firefighters patched up those participants who suffered cuts and bruises from falls. And Sierra Madre Search & Rescue had 25 members up on the trail to see to the runners' safety. The City of Sierra Madre's Community Services Department, in conjunction with the Mt. Wilson Trail Race Committee, saw to all the logistics.

The MWTR Committee congratulates men's winner Kevin Chaves, who completed the challenging course in a fantastic time of 58:30 and women's winner Sharon Pevsner, who in finishing with a time of 1:19, captured yet another MWTR title. (Prior to the adults finishing the race, some 150 kids from 3 to 12 ran the MWTR's Kids' Race, a one mile fun run up Baldwin Avenue and back.)

The Mt. Wilson Trail Race embodies the unique importance of maintaining community, reminding us of our rich history and keeping fit. I hope Mountain Views readers will join us for the race next year – Saturday, May 28, 2011.

What unites a local Buddhist priest, a Catholic ministry and women from all spiritual backgrounds for a day in Sierra Madre? "A thirst for peace and patience in our everyday lives," say Karen Maezen Miller, a Zen Buddhist priest, Sierra Madre resident and the host of a one-day retreat called the Mother's Plunge at Mater Dolorosa Passionist Retreat Center, 700 N. Registration for the day, including lunch, is \$75. The program intentionally ends at 3:30 p.m. so attendees can bring renewed focus to their priorities at home.

CRITICAL MISSING ADULT



Michael Timothy HIGDON, 48 years old 6'-01"/215 lbs, brown hair/hazel eyes

Michael Higdon was last seen at his Arcadia residence in the late evening hours on Wednesday, June 2, 2010. Mr. Higdon left the residence in a relative's car and did not return home. He was reported missing on Thursday, June 3, 2010, and was possibly seen in the Huntington Beach area early that morning. Mr. Higdon suffers from physical and mental disabilities and is in need of medication. Investigators do not suspect foul play.



Red Light Crackdown

"Run a Red Light and you will be cited," police warned



The Pasadena Police Department will conduct a Red Light Enforcement Program Monday —enforcement detail will be deployed throughout the city from 6:00 am - 2:00 pm., officers said.

The department is committed to reducing the number of traffic collisions resulting from drivers who run red lights. "The ultimate goal is to enforce and educate the driving public, while reducing serious injuries and fatal collisions at the same time," said Interim Chief of Police Christopher Vicino. "The ticket is expensive, but a life saved by safer driving habits is invaluable."

Vicino further explained, "a red light" means the driver must completely stop their vehicle at the marked limit line. If there is no limit line, the vehicle must be stopped at the nearest crosswalk line or the nearest side of the intersection. For right turns at red signals, you must first make a complete stop and then you may turn once the intersection is clear of pedestrians and oncoming traffic. However, if the intersection is posted with a "No Right Turn on Red" sign, you must wait for a green signal before any turning movement.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Administration.

CALIFORNIA ASSEMBLY OKS BAN Sierra Madre Police Blotter ON PLASTIC BAGS

Coalition of enviro, business and government groups back AB 1998

SANTA MONICA, CA (Wednesday, June 2, 2010) – California state legislators voted today to bar the distribution of single-use plastic shopping bags at grocery stores, convenience stores and pharmacies statewide, buoyed by consensus support by a broad coalition of environmental, local government, union and business groups.

In a 41-27 vote, the California Assembly approved AB 1998, a bill authored by Assemblymember Julia Brownley (D- Santa Monica) that seeks to end the environmental and fiscal waste created by Californians' use of 19 billion single-use plastic shopping bags each year.

Heal the Bay, which sponsored AB 1988, has led the legislative fight to enact a bag ban for more than five years as part of its ongoing efforts to tackle plastic pollution.

AB 1998 also has the crucial backing of the California Grocers Assn., the California Retailers Assn. and the United Food and Commercial Workers Union (UFCW), whose members have called for a uniform and environmentally sound single-use bag policy statewide.

California municipalities spend nearly \$25 million each year just to collect and dispose of plastic bag waste. Less than 5% of plastic grocery bags are recycled each year statewide, so the remainder clogs precious landfill, litters public spaces and harms animal life when the bags infiltrate waterways.

Retailers will still be able to distribute paper bags, so long as they contain at least 40% postconsumer content. Shoppers who forget their reusable bags have the option of purchasing a paper bag at checkout. Heavy-duty reusable bags are convenient, environmentally friendly alternatives that have been embraced by millions around the world.

The bill now goes to the state Senate, which is expected to vote on the bill later this summer. "Today marks a critical milestone in the ongoing battle to rid our oceans and watersheds of harmful, wasteful plastics," said Mark Gold, president of Heal the Bay. "We congratulate the Assembly for not only helping to save the marine environment, but also for saving taxpayer dollars."

Dozens of progressive local governments statewide are poised to curb the use of plastic bags. The cities of San Francisco, Palo Alto and Malibu have already enacted bans. "After years of hard work, it's gratifying to see such a broad range of stakeholders come together on a common-sense solution," said Leslie Tamminen, organizer of the Clean Seas Coalition, which has helped lead the legislative charge in ending the scourge of plastic pollution statewide.

The two most common questions that I get are, "What is your favorite restaurant" and "Do you ever write a terrible review of a restaurant?" My response to the first question is, "For what type of cuisine: Steak, Lobster, Drinks or a View?" For the second question, I believe if the experience is that lamentable, I need to find something else to write about. Honesty

is very important and while bad reviews often capture the distinction of "sensationalism," thus catering to our more primitive instincts, mostly I find them unpleasant and often vicious. I have noticed that one person's critical comments on the Internet often carry a lot of weight. It used to be that a newspaper article, television show, radio broadcast or word of mouth was the most frequently sought source for recommendations. With the ever increasing expansion of the Internet behind an individual voice, we have truly evolved into, "All the world's a critic." Fortunately, some of us still know the comfort of the newspaper resting on the doorstep in the morning.

So, with that being said, and Father's Day fast approaching, let's revisit a restaurant that serves one of my favorite dishes.

The first few times I went to Houston's I was on the fence. I had some good memories of it being the Velvet Turtle many years ago. It is still a little dark inside, and bring your credit card because you will need it here!! Let me say that I think the entrees are on the expensive side, but I do find the wine

I have dined at Houston's at least ten times in the past year and I have to say that the overall experience has blossomed for me, as it has become one of my favorite restaurants to enjoy an evening. Why, you

ask? I find that the food is exceptional and the service is stellar. You are warmly greeted and seated, brought your water, drinks and food, usually by a different server in each instance. Each handoff leaves you with a friendly, warm and considerate person as you move through your meal. This part is amazing because Houston's is a chain restaurant. They train them well here - my hat is off.

Let's talk about the food and prices. Let's start with The FAMOUS French Dip (\$18) which is usually the dish that I order while at Houston's - a Roast beef on a French roll is definately a must try. The Barbeque Ribs (\$27) are oven baked and come with fries and coleslaw; rib fans will not be disappointed with this meal. Is it sushi that you crave? There are many great choices on the menu and they tell me that many customers rave about it. But, come on now, why go to a steak place for Sushi? Or is this a steakhouse? Sushi prices have a range range (\$12 to \$16). I suggest the Seared Tuna Roll (\$16) if you must have seafood. For my next visit I look forward to the Lump Crab Cakes (\$18); when done right you can never go wrong with crab cakes. Desserts feature a Five Nut Brownie and an Apple Walnut Cobbler (\$8) - both very sweet and tasty!! In surveying the wine list I was impressed with



both the Schramsberg and the Tantara Chardonnay (\$9) per glass.

Astronomy From An Airplane? A New Way of Looking Up

Can you imagine a telescope the size of Mount Wilson Observatory's 100-inch, doing astronomy from a Boeing 747 jetliner?

It happened on May 26, when the Stratospheric Observatory for Infrared Astronomy (SOFIA), a joint program by NASA and the German Aerospace Center, made its first in-flight night observations.

With this flight, SOFIA begins a 20-year journey that will enable a wide variety of astronomical science observations not possible from other Earth and spaceborne observatories," said Jon Morse, Astrophysics Division director in the Science Mission Directorate at NASA Headquarters in Washington. "It clearly sets expectations that SOFIA will provide us with "Great Observatory"-class astronomical science."

The highly modified SOFIA Boeing 747SP jetliner fitted with a 100-inch diameter reflecting telescope took off from its home base at the Aircraft Operations Facility in Palmdale, Calif., of NASA's Dryden Flight Research Center. The in-flight personnel consisted of an international crew from NASA, the Universities

Space Research Association in Columbia, Md., Cornell University, and the German SOFIA Institute (DSI) in Stuttgart. During the sixhour flight, at altitudes up to 35,000 feet, the crew of 10 scientists, astronomers, engineers, and technicians gathered telescope performance data at consoles in the aircraft's main cabin.

who put it through its paces during the flight.

"The crowning accomplishment of the night came when scientists on board SOFIA recorded images of Jupiter," said USRA SOFIA senior science advisor Eric Becklin. "The composite image from SOFIA shows heat, trapped since the formation of the planet, pouring out of Jupiter's interior through holes in its clouds?


The highly sensitive Faint Object infraRed CAmera for the SOFIA Telescope (FORCAST) used for these initial observations was operated in flight by its builders, a team led by Cornell's Terry Herter. FORCAST captures in minutes images that would require many hour-long exposures by ground-based observatories blocked from a clear infrared view by water vapor in the Earth's atmosphere. SOFIA's operational altitude, which is above more than 99 percent of that water vapor, allows it to receive 80 percent or more of the infrared light accessible to space observatories.

their identity is often left behind from some other source. If one has ever attended a school that posts an alumni page or has a friend of a friend with a Facebook page and a digital camera, chances are high

that one is "in there" somewhere, and those are just the chances of being placed on the web incidentally or just by being included in someone else's digital photo. Although this type of inclusion happens most often without our awareness of the act it still counts as an internet presence and an internet user savvy enough just might be able to pull these disparate pieces together and draw their own conclusion as to who the "person" they've located really is.

More often than not the pieces of information that could be used to establish our identities on the web are placed there by us. The now commonplace web media known as social networking has given internet users the world over ample resources to tell the world exactly who they are and what their interests entail. Large and efficient search engines trawl these websites and other internet resources in order to keep track of the huge amount of information to be found there and catalog it for ease of use and access by any interested parties. The reasons that people would want to establish a presence on the internet vary from the personal to the professional but the common element that ties them together is the desire to define ones self as the person in question sees fit to do so.

This new form of self-expression continues to push the boundaries of social interaction and continues to make waves in the legal arena. Just a few months ago we saw the resolution of two court cases that had similar implications centered on the issue of Protected Speech but radically different outcomes. The first case was about a Florida teen who created a Facebook dedicated to making public her feelings of scorn for a public school teacher.

The site featured a picture of the teacher and it invited visitors to share and also make public their feelings about the teacher. The court decided that the post was protected speech under the First Amendment and the lawsuit has been allowed to proceed through the courts. The second case involved a Pennsylvania teen who created a mock MySpace profile that insinuated that her teacher was a sex addict and a pedophile. In this case, the court ruled that the fake MySpace page was not protected under Free Speech protections and ruled against the student. The Supreme Court of the United States has yet to take on the issue of online speech such as the type described in the two aforementioned cases but beyond the pressing legal issues even larger social issues that need to be considered are found. In both cases material posted by a party other than the subject has now become part of the permanent collection of information that the web presents to users when information about the original person concerned is searched. The creators of the fake web pages have in a sense taken part in defining their subjects above and beyond any objections that the subjects themselves about held about the opinions presented about them.

Figures in the Public arena (celebrities, politicians, athletes, etc.) are subjected to this type of treatment all the time and in many cases their public personas are for the most part considered public property. Both officially and unofficially this treatment is part of the package that public figures sign on for when they participate in the public sphere. Private citizens on the other hand, most often see things radically different and are often slightly more sensitive when it comes to what is said and posted about them online and in other media. Since the internet has a persistent memory that doesn't forget, there are several interesting questions that future courts may find themselves having to consider in relation to web postings such as how much right does someone have to define another person's web identity through postings that may be considered opinion or just outright false.

How can injured parties be made whole once something is posted and later proven to be less than honest if the offending statements can't be permanently scrubbed clean from the web. Hmmm...just something to think about....



During the confirmation of Justice Sonia Sotomayor, the term "empathy" got a bad rap -as if relating to cases through her personal background was

somehow a bad thing. Others argued it's essential to see the law from the perspective of the everyday lives of ordinary people, rather than only as it's discussed in courtrooms and lecture halls.

Empathetic considerations are too seldom a part of foreign policy. The Bush Administration told us we'd be greeted as "liberators" upon invading Iraq. It would've been helpful to employ a little empathy and imagine oneself in the other person's shoes: subject to the rule of a brutal dictator, but finding it hard to be appreciative as a superpower assumes it's doing me a favor by pulverizing my capital city and killing thousands of countrymen in a display of "shock and awe". I wonder how much empathy Israeli policymakers have employed in dealing with Gaza. Apparently not much, as actions seem intended to thwart middle-of-the-night operation. resolution and prolong conflict.

We hear how Gaza was defined when Arabs to how the action would be perceived by other

rejected the 1947 United Nations partition and came under Egyptian control. We know how I have a hard time relationship with Turkey, the population was swelled by refugees from Jordan - another country not eager to harbor Palestinians. We're reminded that Gazans continued to suffer tradition and riches when Yasser Arafat's Palestinian Authority took over following the 1994 Oslo Accords, and commerce became synonymous with corruption.

I imagine the reaction of a typical Gazan to this history would be, "So what?" The resident might become particularly incensed by that line attributed to Golda Meir about if only Arabs would "love their children as much as they hate us" - as if presuming to judge whether another shows sufficient love for their children. (The reaction might be similar to that of a Vietnamese hearing Gen. William Westmoreland's rationalization that life is somehow cheaper among the people of Southeast Asia.) As a typical Gazan, I'd have no memory of the 1967 Israeli invasion and very little of life under Arafat. My concern would be life as it is today, and how to bring myself and my family out of a desperate situation.

If I were a Gazan voting in the 2006 elections, I might associate Fatah with the failures of Arafat. Hamas, however, builds schools and clinics and promises change. A Gazan might also resent the hypocrisy of Americans, Europeans and Arab countries extolling the virtues of elections, yet refusing to accept the outcome when Hamas receives a plurality of votes. I'd wonder why these countries would accept Hezbollah as part of a coalition government in Lebanon, but not Hamas as part of a government in Gaza. Fatah might then become the enemy when it refuses to accept a coalition and fights to maintain control.

Any doubts as to the real enemy, though,

determined included the deliberate targeting of civilians - though a Gazan wouldn't have to be reminded of that. There'd be no eagerness to negotiate with a party attempting to pound an already suffering people into submission. With Israeli control maintained over airspace and waters and the movement of goods and people in and out, a Gazan would likely agree with the U.N. that although Israeli troops have withdrawn, Gaza remains occupied territory.

It might have been helpful for Israelis to employ a bit of empathy in assessing how the economic blockade of Gaza, and its attack on the flotilla attempting to break the embargo, would be perceived and ultimately affect its goals. It might have considered the cost to its credibility when arguing that to lessen the threat from Hamas it was necessary to ban the import of crayons, musical instruments, light bulbs, chocolate, shampoo and blankets - let alone cars, refrigerators and computers. As retired US Army Lt. Col. Robert Mackey pointed out in a recent column, it also doesn't help Israel's credibility when it has a detailed, multi-page report ready to hand out within a couple hours of a chaotic,

nations? Considerable damage was done to the allies in the region. Turkish Prime Minister Recep those in a land of great Erdogan referred to the raid as a "bloody massacre" which was an attack "on international law, the conscience of humanity and world peace". NATO, of which Turkey is a member, has called for an

investigation. Another important ally, Egypt, has temporarily opened up Gaza's southern border for the transport of goods and people.

Reaction has been strong from within Israel. Former Israeli Defense Forces officer Mickey Bergman writes that he directs his "outrage" towards leaders that would send soldiers "on a mission that defies logic". While it would've been possible for a Navy commando to "dismantle and immobilize" the ships' engines, he accuses Israeli leaders of having "demonstrated that the life of a soldier is no longer as sacred as it had always

Columnist Bradley Burston of Haaretz puts it more broadly; "We are no longer defending Israel. We are now defending the siege of Gaza." He points out that while Israeli leaders want "the world to focus on Iran and the threat it poses to the people of Israel . . . the world is now focused on Israel and the threat it poses to the people of Gaza." Israel: Verdict First, Trial Later

With apologies to Lewis Carroll's Queen, watching the world's great leaders has left me feeling as though I have traveled down the rabbit Iran from getting the bomb hole into wonderland. The speed with which the UN and other august world bodies came together to exert the immense leverage to denounce Israel's actions against the supposed it has over North Korea to control the situation "peace flotilla" is simply unprecedented in modern times, or in any historical period for that matter. good to talk to one another. Really, I think we are all now Strangers in a Strange Land, increasingly isolated and wrongly searching for connection through social networking and superficial contacts. To be a good man, I believe one must CARE and this can be done in isolation. Life is With People is the title of some book describing village Jewish Life, which I now cannot find. I will not give up looking. Staying in contact with our families, however difficult (and it is always difficult) often gives meaning to our confused lives. We are all part of an old tradition creating new meaning with every breath. Atheist that I am, I still believe there is a path to follow. Hard-wired within us is not only a universal capacity for language but also, believe it or not, a universal capacity for love. It's out there and in us and our continuous struggle to find it is part of the process. What a Good Man does is to keep believing and keep looking and through it all trying to be kind. Alas, I think there must be more to this than just reading a lot.

My TurnBoycott Arizona? What's up with

Clueless of what Arizona's new illegal immigration law actually says, much less means, the State of California, as well as a number of cities, school districts and other entities are threatening to boycott the Grand Canyon State and warning Hispanics not to go to there.

In Sacramento, leaders are calling for Gov. Arnold Schwarzenegger to do everything legally possible to sever California's economic ties with Arizona until the law is repealed.

Senate President pro Tempore Darrell Steinberg requested that no new contracts be negotiated and that the state study the legality of breaking existing contracts.

I think we have a moral obligation to deliver an unequivocal message to lawmakers in Arizona that California does not condone its conduct," Steinberg wrote in a letter to the governor. 'The Arizona law is as unconscionable as it is unconstitutional, and the state of California should not be using taxpayer dollars to support such a policy."

Here's a question for all those grandstanding, sanctimonious public officials threatening to cancel Arizona contracts, and issuing travel advisories.

What state's penal code does the following section come from? "(b) With respect to any such person who is arrested, and suspected of being present in the United States in violation of federal immigration laws, every law enforcement agency shall do the following:

(1) Attempt to verify the legal status of such person as a citizen of the United States, an alien lawfully admitted as a permanent resident, an alien lawfully admitted for a temporary period of time or as an alien who is present in the United States in violation of immigration laws. The verification process may include, but shall not be limited to, questioning the person regarding his or her date and place of birth, and entry into the United States, and demanding documentation to indicate his or her legal status."

That would be... California!

Oops.

The only real difference between Arizona and California on the "show me you papers" front is that in Arizona they no longer call I.C.E. and get the bureaucratic brush off; they will enforce the law

Which means none of the reasons given by California liberals for opposing the Arizona law are honest. What they are really mad about is that in Arizona, immigration laws will be enforced, and that in California -- and in the rest of the country for that matter--they are not.

What these open border advocates really want is "comprehensive immigration reform"--i.e., amnesty and a path to citizenship for illegal aliens.

Here is the rest California Penal Code Section 843 pertaining to local enforcement of federal immigration laws:

'(2) Notify the person of his or her apparent status as an alien who is present in the United States in violation of federal immigration laws and inform him or her that, apart from any criminal justice proceedings, he or she must either obtain legal status or leave the United States.

(3) Notify the Attorney General of California and the United States Immigration and Naturalization Service of the apparent illegal status and provide any additional information that may be requested by any other public entity.

(c) Any legislative, administrative, or other action by a city, county, or other legally authorized local governmental entity with jurisdictional boundaries, or by a law enforcement agency, to prevent or limit the cooperation required by subdivision (a) is expressly prohibited."

And, there is even a California Attorney General opinion upholding the penal code. California AG Opinion 01-213 (11/16/2001) says:

'While California's Penal Code Section 843b's mandate that local officers inquire into immigration status has been enjoined, officers can still voluntarily make the inquiry. A local law enforcement officer during detention of Spanish speaking person for otherwise valid purposes may question the person as to immigration status, but may not question status solely because the individual speaks a non-English language."

In supporting the boycott L.A. Mayor Antonio Villaraigosa called the Arizona Law "unpatriotic and unconstitutional." The mayor is clearly suffering from a bad case of foot-in-mouth

Often called the most beautiful actress in Hollywood, Ms. Lamarr was born in either 1913 or 1914, depending on whom you believe.

No, I'm not here to discuss the beautiful actresses of the last century (though that's not a bad idea.) I'm here to talk about what Ms. Lamarr did in her free time. In 1941, she co-invented

a secret communications system that helped combat the Nazis in World War II. Her "spread spectrum" technology manipulated radio frequencies at irregular intervals between transmission and reception that created an unbreakable code that prevented the bad guys from intercepting our secret messages. What's truly extraordinary is this technology that Lamarr invented helped form the technical backbone that makes cellular phones, fax machines and other wireless operations possible. Can we say WOW?

Not that Ms. Lamarr was alone in the women inventor club. In 1903, Mary Anderson invented the windshield wiper. Whatta you think of that? In 1956, Bette Nesmith Graham invented liquid paper. 

Problem: Exposure to dust mites and mold aggravates asthma and results in increased health costs each year.

- Ensure proper ventilation in the attic and bathroom to prevent excessive moisture that can promote mold growth.
- Wash sheets and blankets in hot water weekly and use mattress and pillow covers to reduce asthma triggers and attacks.
- Vent the clothes dryer outside the home to prevent mold and mildew.
- Vacuum carpets to remove allergens that trigger asthma attacks and allergic reactions. Problem: Falls are the leading cause of home injury deaths. The cost of fall injuries for people 65 and older exceeds \$19 billion annually. Solutions:
- Remove any items that can be tripped over (such as papers, books, clothes and shoes) from stairs and places where you walk.
- Good lighting can make a difference. Keep everything well lit.
- Install grab bars bathrooms.

Problem: For children, suffocation, firearms, drowning and poisoning are the leading causes of deaths at home.

Solutions:


- Install and maintain smoke and carbon monoxide alarms.
- Make sure that cribs, playpens and play equipment are safe and always keep a crib free of soft objects or loose bedding.
- If you have a swimming pool, install four-sided isolation fencing around the pool with a self-closing, self-latching gate.
- In homes with young children, control or eliminate lead-based paint hazards and lock up products used for cleaning, car maintenance, gardening, and pest control.

In small bowl combine mayonnaise, onion, catsup, milk and sweet pickle and blend with whisk. Set aside. In large serving bowl combine salmon, salad greens, tomatoes and hard cooked eggs. Drizzle with reserved salad dressing and toss gently. Serves 4

Basil Cheese Breadsticks

INGREDIENTS:

- Small round loaf sourdough bread, unsliced
- 3-4 tablespoons butter 1/8 cup Minced onion
- 1 clove garlic, minced
- 1-2 Tbsp. fresh basil leaves, chopped
- 1/2 teaspoon dried basil leaves

1/4 cup freshly grated Parmesan cheese

DIRECTIONS:

Slice bread into 1-1/2 inch slices, cutting to bottom of loaf but not through it. Turn bread one quarter turn, then slice bread again into 1-1/2 inch slices, cutting to but not through bottom of loaf, forming breadsticks that are attached to the bottom crust. (The loaf should look like the popular onion flower appetizer.) Carefully place loaf on a sheet of heavy-duty foil.

Melt butter in small saucepan, and stir in onion and garlic. Cook for 4 minutes, stirring frequently. Remove from heat and stir in fresh basil and dried basil. Drizzle the butter mixture evenly between breadsticks and over top of loaf, then sprinkle with cheese.

Wrap securely with double-fold seal. Place bread on grill 6 inches from medium coals. Heat 15-25 minutes or until cheese is melted and bread is hot, turning and moving loaf frequently to prevent burning.

To bake in the oven, place wrapped loaf in a preheated 400 degrees F oven for 20 minutes. Then unwrap the loaf and bake for another 10-20 minutes until cheese is melted and bread begins to brown. To serve, pull apart breadsticks. Makes 24 breadsticks

If you can't find an unsliced loaf of bread, use a sliced loaf. Cut bread into 2" wide strips, cutting to but not through bottom. Keep loaf shape while you're cutting. Proceed with recipe as directed.

Homes & Property One Of A Kind: Featuring unique homes & gardens and the people who create them Story and Photos By Chris Bertrand The School Garden: Learning responsibility, stewardship and the joy of growing food

This is almost a fairy tale story; one where fact is sweeter than fairy tale. Once upon a time, a Sierra Madre family walked by a home under remodel on their way to and from school every day. Over the months, they got to know the nice couple working on the home, exchanging pleasantries

When the remodel was complete, to the family's surprise and delight, the couple offered their large, unused side yard to the family's school for a student garden. When the topic of garden beds came up, the owner built planter boxes, consulted with Armstrong's in Monrovia for advice, then

quietly had premium quality planting medium, the "chocolate cake of topsoils," delivered for the children's use. Plans for pathways and additional fencing evolved. A parent with a construction company pitched in with the plumbing for irrigation. Others contributed plants cash and labor.

Such is the stuff of small towns like Sierra Madre. The stuff that builds and binds a community, children to elders, strangers to neighbors, students to stewardship of the land around them.

Principal, Joanne Harabedian was blown away by how the garden project unfolded. "It was a dream come true after discussing garden boxes and options for years. Sharing their yard with us (for a school garden) was a generous gift but that was just the start of their hospitality with the planter boxes and soil and... and ... and. They blew me away with their down to earth hospitality, generosity and humility. It took me back to when I was a kid and neighbors shared without expecting anything in return. If love

makes a garden grow, we will have a forest in no time! Volunteering is an incredible thing. It builds a special bond between special people who share their talents and learn something new every time they come together."

Today, the garden is alive with children actively engaged in growing food... learning how food grows and develops, the challenges of growing from seed, breaking the surface tension of soil so the water doesn't run off without nourishing the plant, the quick growth of weeds and the joy of a ripe homegrown strawberry.

Gina Cloer and Robin Nardoni have taken on the shepherding of these young gardeners at St. Rita School in Sierra Madre on a new path, an untested journey in this new, gifted garden. They have patiently guided enthusiastic hands and trowels into newly formed furrows of beans.

They have taught young arms to haul extra water to corn that's waist high to a third grader at the end of May. They've put rakes and fingertips to the test of keeping the weeds from





stealing nutrients from their precious eggplants, tomatoes, strawberries, corn, beans and more. Cloer commented, "This is brand new territory since the project just began. Our initial plan is to have the children enjoy the produce in simple ways. For example, we have cilantro that is ready now. I will be making a fresh cilantro lime dressing and have the children dip some lettuce in it and give it a try."

Nardoni reflected, "To have been on the receiving end of such generosity is amazing. I hope one day when my kids are grown I can be riend a neighbor family and offer such an experience as they have for me and my family."

Julie Cambonga, third grade teacher at the school has proudly observed the life lessons her students are absorbing from the new garden. "The list is long, and they're concepts not easily taught in the traditional classroom setting especially to third graders... cooperation, ownership, pride in your work, global awareness and care for the land."

Big lessons from dirt, water and seedlings!
