Council To Discuss Street Resurfacing **Project**

A subject that has been on the minds of residents of Sierra Madre for a while will be on the agenda. The repaving of streets.

Construction bids were sent out for Phase 1 of the project for the FY 2009-2010, came in at less than 50% of the estimated cost, so the council directed staff to research ways utilize the unused funds for additional repaving projects.

The funds available are from numerous sources including Measure R, Proposition 1B, Metropolitan Transit Authority/LA County Department of Public Works Swaps and Prop C money. The budget for street projects, according to staff reports, for the fiscal year 2009-2010 which ends on June 30th was \$816,732. As of the June 22nd, only \$364,450 has been spent.

Staff is recommending that the remaining funds be used for the Phase 2 projects. Proposed Phase 2 streets are:

West Alegria - Baldwin to Auburn Monterey Place - Cul de Sac to Monterey Lane

Monterey Lane- Cul de Sac to Sierra Madre Blvd.

Sierra Meadow - Cul de Sac to Wistaria

Sierra Meadow - Wistaria Way to Carter East Bonita - Mountain Trail to Cul de

East Bonita - Cul de Sac to Baldwin

Grove Street - Highland to Grandview.

Other items on Tuesday's agenda include the proposed Proposition 218 Process and Proposed Water Rate Increase, appointments to the Green Advisory Committee, and a public hearing on the fees for Public Facilities Rate Adjustments.

The council meets at 6:30 June 22, 2010.



Azusa Votes to Reconsider Vulcan Mining Expansion Project; Meeting Set for June 21

Vulcan Materials Company will have second chance to convince the Azusa City Council to approve a modification of its conditional use permit and revised reclamation plan. On a motion by councilman Uriel Macias, seconded by councilman Keith Hanks, the Azusa City Council on Monday night voted 5-0 to reconsider their May 17 denial of the plan. The council also voted on a motion by Macias, seconded by Hanks, to table the Rules of Parliamentary since the May 17 vote to address his concerns. Procedure, an action Azusa City Attorney, Sonia Councilman Macias outlined his concerns Carvalho counseled as necessary for the body to allow reconsideration of the matter.

The actions were a surprise to the community since the Vulcan matter was not on the posted June 7 agenda. It was added as an urgency item during the reports and announcements section of Azusa's agenda after Councilman Macias began an inquiry concerning possible scenarios for dealing with the Vulcan matter. Councilman Macias was in the majority on May 17 when the council voted 3-2 to deny Vulcan's plan.

While some council members expresses surprise that the item arose in the midst of the hearing without any prior notice, others including the Azusa City Attorney indicated that inquiries concerning the available parliamentary procedures were made in the week preceding the meeting. Using that time, the City Attorney performed advanced research so that she would be prepared to respond to Councilman Macias' inquiries.

Prioritizing Public Safety



California has been overspending for years, and now the State finds itself staring down the barrel of a \$20 billion dollar budget deficit. The Governor's May budget proposal, as expected, contains deep cuts to several social services programs. It also avoids an increase in the personal income tax and state sales tax, which is definitely a positive step given Californians are already severely over-taxed. The budget is not enacted in a vacuum though, so the Legislature must weigh the impact budgetary decisions have on vital operations, especially when it comes to public safety.

Unfortunately, a major part of Governor Schwarzenegger's projected Department of Corrections and Rehabilitation savings comes from

shifting the State's burden onto the backs of local governments. Under the Governor's proposal, non-violent, non-serious and non-sexually deviant felons will be sent to county jails, thus saving the State over \$292 million. Additionally, it calls for transferring Department of Juvenile Justice (DJJ) parolees to county probation departments, also placing a heavy weight on local governments and their already bowing budgets.

Local jails are perpetually overcrowded and already have court-imposed population caps. What the Governor is proposing in his May revision of the State's budget will force local governments to release inmates early in order to make room for the incoming felons. This action clearly threatens the safety of our residents. To make matters worse, only half of inmates participate in any sort of job-training or rehabilitative programs while incarcerated. This leaves them ill-prepared for reentry into society. It is irresponsible and inequitable to transfer costs to local governments without sufficient reimbursement and consideration of the public safety impact. Although these proposals reduce up-front State costs, it will be devastating to California's local governments and to the health and safety of California's citizens.

Conversely, there are promising elements in the Governor's budget plan that use taxpayer dollars efficiently while preserving public safety. Recognizing our decreasing juvenile offender population, for instance, the Legislature has approved the conversion of the former DJJ Heman G. Stark facility in Chino into an adult prison. This will use an existing under-filled and expensive juvenile detention center to properly house adult inmates, removing them from our overcrowded State prisons. The Governor's plan also aims to increase the number of lower-cost, out-of-state prison beds we contract prisoners out to. These ideas demonstrate creative cost-saving measures to ensure that public safety is defended, prisoners fulfill their sentences and local governments are not over-burdened.

At the foundation of any viable budget solution, lie elements of job creation and private economic growth. Ensuring public safety is vital to give people the confidence to do what it takes to recover from exceptionally difficult times. The first step in reducing obstructions to private sector job creation is to ensure people are safe and the law is enforced accurately.

The chief's salary would be \$23,508 more annually, including salary-related benefits according to city staff.

Beck made the announcement hiring Sanchez Tuesday as Chief. The terms of his contract, including salary, were not made public at the time. City staff said he had not yet signed a contract.

NASA Prototype Tsunami **Prediction System Demonstrated**

NASA-led research warnings that can save lives time elements of a prototype the lives of coastal residents." that quickly and accurately assesses large earthquakes and estimates the size of resulting tsunamis the agency said Monday.

After the magnitude 8.8 Chilean earthquake on Feb. 27, a team led by Y. Tony Song of NASA's Jet Propulsion Laboratory in Pasadena, Calif., used real-time data from the agency's Global Differential GPS (GDGPS) network to successfully predict the size of the resulting tsunami. The network, managed by JPL, combines global and regional real-time data from hundreds of GPS sites and estimates their positions every second. It can detect ground motions as small as a few centimeters.

successful demonstrates that coastal GPS systems can effectively be used to predict the size of tsunamis," said Song. "This could allow responsible agencies to issue better

> Song's team concluded that the Chilean earthquake, the fifth largest ever recorded by instruments, would generate a moderate, or local, tsunami unlikely to cause significant destruction in the Pacific. The tsunami's effect was relatively small outside of Chile.

Song's GPS-based prediction was later confirmed using sea surface height measurements from the joint NASA/French Space Agency Jason-1 and Jason-2 altimetry satellites. This work was partially carried out by researchers at The Ohio State University, Columbus.

"The value of coordinated real-time observations from precision GPS, satellite altimetry and advanced Earth models has been demonstrated," said John LaBrecque, manager of the Solid Earth and Natural Hazards program in the Earth Science Division of NASA's Science Mission Directorate in Washington.



Thomas Wolfe, in 1940, said, "You can never go home again." That line has become a popular expression. Several years ago I was singing the praises of Masa Restaurant in Central Pasadena. Then things changed, and I went back

only on and off - mostly off. I can't tell you the number of times that I've zipped past this very local restaurant as I travel on the way to my next Odyssey to experience another restaurant about which everyone is buzzing. Often I wonder about that so-near restaurant I just passed on my own corner – it's been a while, but I'm on my way elsewhere.

I often have to remind myself: Slow down, Peter. I am off to a restaurant here, an engagement there, frantically trying to keep appointments as they race toward me on the calendar. It is a fleeting thought while I race to make the next meeting. Every once in awhile though, I jump off that appointment book and slam on the brakes and stop at just a place. When my Pal, Roberto, who first introduced me to Masa called me last Friday to inform me that Fuji was back. Is that Master Sushi Chef Fuji Wara who has returned to his familiar and successful role at the *Masa* Restaurant? My experience with his former creations are ones that I still remember with fondness. Yes, it is – and I'm like, "Hold on - I am hitting the brakes". Here Masa is, right down the corner from my house, and I pass by it more times than I shave each day. I told Robert, "I'll meet you there."

Masa Restaurant is a Japanese Fusion/Sushi Bar. When I walked in, it was like nothing had changed. There was Fuji, smiling at me and asking me if I want the Spicy Tuna handroll – how amazing he still remembers that's what I always got!!! I threw him a curve ball, though, and ordered the two premium rolls, which were phenomenal. The Fantasy Roll (\$11.95) crab meat, wrapped inside, then topped with albacore, fried garlic and green onion. Robert, who is as good at sharing as he is in finding restaurants, ordered the 9 months later, (\$11.95) breaded white tiger shrimp with spicy tuna and avocado topped with peppered seared salmon, lemon and housemade pesto. Friends this is good eats!!

At Masa you experience the skill of a Samurai warrior as the restaurant is in the very able hands of Master Sushi Chef Fuji Wara. You may remember him from Komoshi in years past. Fuji might be a little older these days but he has not lost his comedic spirit and still retains the highest mastery of his art!!! First timers to experienced Sushi lovers will enjoy Masa Restaurant. I am told that Fuji goes down to the Fish Market at least four times a week to pick his prey, so there is no need to worry about



U.S. High School Students Help Recover Spacecraft

For millions of American high-school supporting the mission. students, early June means long hours studying for final exams. But for three lucky astronomy class meant traveling halfway around the world-from Massachusetts to the Australian Outback—to work side-byscientists.



The remains of the spacecraft will now will be transported to Japan for analysis and the opening of the sample collection chamber.

'JAXA's Hayabusa mission has opened up a whole new world to us and now we have many more questions than answers, which makes this a very exciting time to be in planetary science," said Paul Abell, a research scientist at the Tucson, Arizona-based Planetary Science Instutite, who was part of the recovery operation and a member of the team that investigated the asteroid's composition.

The name LimeWire has long been synonymous with getting online music and videos free of charge. LimeWire is basically a software package that uses various P2P (peer-topeer) protocols to access shared files on computer networks. Limewire's network of choice is the gnutella network, but users of the software don't have to know such details in order to get started. All that's required is to obtain the LimeWire client, install it on an internet-connected computer, create a user account and log in. The software takes care of all the rest, including finding the music or video requested in title searches. Unlike iTunes, Napster and other licensed online music services, the networks used by LimeWire don't really seem to care if the content trading on their networks was legally purchased or owned by the sharing party and it often seems as if no real attempt to stop users from illegally sharing files on their networks is being made at this time. The company that creates and distributes the software, LimeWire LLC, has been the target of several lawsuits by various entertainment industry groups, including the RIAA (Recording Industry Association of America) and the NMPA (National Music Publishers Association), both suing for "pervasive online copyright infringement" with the latest complainant, the NMPA, asking for equitable damages and relief said to amount to billions of dollars in lost revenue and sales.

Besides being a magnet for lawsuits because of its copyright-infringing activities, LimeWire and other P2P software products have earned themselves a somewhat sullied reputation as being vectors for the dissemination of malware and other security vulnerabilities. There have also been several well-publicized cases of end users having their machines hacked into and their identities stolen due to security vulnerabilities with the Limewire client software and the changes it makes to the users system once installed.

Coupled with the more than 30,000 lawsuits filed by the RIAA against individual P2P network users trading in illegal music and software, one would think that the allure of getting something for nothing would've worn off long ago. Despite the risk of infection, security breaches and lawsuits, P2P networks continue to thrive because of several factors - including high-speed internet connections and the relatively low risk of being directly prosecuted for participation in illegal file-sharing. For some users, "Something for Nothing" is still the best deal going. Just remember, however, that "Something for Nothing" is never really free – and you may not like the consequences ...

and blames those darned environmentalists. He could've taken it further; happening in the Gulf of Mexico, it must have something to do with illegal immigrants. Had "big government" not imposed regulations on BP, they could've adopted safeguards guided by the free market. Reports of cleanup crews becoming ill from exposure shows the failure of "Obamacare".

Maybe I missed it, but I don't recall any suggestion that if big oil were allowed to set up shop in our arctic wildlife refuge, they'd forgo drilling in our outer continental shelf. I do recall, decades ago, promises that once they started drilling on the Alaska North Slope, we'd be relieved of high gas prices and threats of OPEC embargos. They drilled, got the oil - then sold it to Japan and we went back to high gas prices and threats of OPEC embargos.

The problem's not a shortage of pristine lands available for exploitation. On the campaign trail two years ago, then-Senator Barack Obama, in response to Sen. John McCain's call for more offshore drilling, pointed out there were already 68 million acres of federal land under lease on which the oil companies were just sitting - about three-quarters of all leases held (President Bush wanted to add another 1.5 million acres in the Arctic National Wildlife Refuge), are kept as assets on their books and as a comeon for potential investors. Sen. Obama supported use-it-or-lose-it legislation that would require companies to either explore and drill on leased lands or pay a fine if they didn't (funds going for alternative energy development). There's a disconnect between "drill, baby, drill" proponents and reality; turning over more millions of acres doesn't mean more drilling; big oil often determines the commodity is more valuable left in the make references to protecting walruses ground when bringing it up would threaten to lower the market price.

There's deep-water drilling because we've been subsidizing it. Oil companies have found it cheaper to drill overseas, but saw "energy independence" as an effective pitch for tax breaks. The companies knew it wouldn't be achieved, that we'd be importing two-thirds of our oil through the next decade under most optimistic projections, but it worked - in 1995 the Deep Water Royalty Relief Act eliminated the 12% royalty levied on oil extracted in federal waters. The levy was supposed to be reinstated once oil hit \$40 a barrel, but President Bush made sure it stayed gone when he signed his 2005 energy bill - and threw in an extra \$2.6 billion in tax breaks for good measure.

It's hard to turn this into a partisan debate - from either side. Following the disastrous 1969 Santa Barbara oil spill, the Environmental Protection Agency was created under President Richard Nixon and his domestic policy advisor, John Ehrlichman. The aforementioned Deep Water Royalty Relief Act was passed under

President Clinton, and Bush's 2005 energy bill was supported by Senator Obama. There's something more ominous at work; the protection of the interests of no particular party, and of no particular country, but of trans-national corporations whose profits for the gulf oil spill, Greg set from offshore drilling lie in offshore tax the record straight last week havens - and whose allegiance lies only to themselves.

> Nor is there any allegiance to their workers. As reported in The Guardian, survivors of the initial blast and fire on the rig were detained for up to forty hours, unable to contact their families, until they'd signed documents absolving Deepwater Horizon / BP of liability. There's no allegiance to the right of gulf residents, or the rest of us, to know what's going on. Small-town police and fire authorities have routed media access requests to BP personnel. BP has forbidden clean-up crews from talking to the press and allowing pictures (especially of dead animals). Private security contractors hired by BP have blocked access to public beaches and taken power from local sheriffs. There have been reports of confiscating cell phones and cameras, and prohibiting scientific monitoring equipment. Permissions for flyovers have been revoked once it was learned reporters would be among the passengers. A particularly chilling episode was captured on video and shown on CBS Evening News; a news crew member demanded to know from a Coast Guard official why they were being denied access to a public area. The official replied, "These are BP's rules. These are not our rules." (Coast Guard Commandant Thad Allen denied such incidents were occurring even as reporters relayed their first-hand experiences.)

> Rep. Ed Markey (D-MA), Chairman of the House Select Committee on Energy Independence, compiled damning evidence of oil companies' lack of allegiance to our nation's laws requiring adequate safety measures be taken and adhered to. He shows that the laughable "Oil Spill Response Plans" for Gulf drilling submitted by Shell, Exxon, Chevron, Conoco/Phillips and BP are "virtually identical". All, for instance ("which have not called the Gulf of Mexico home for 3 million years"). He points out oil companies pulled in \$289 billion in profits over the past three years, while spending only \$39 billion on exploring for new oil and gas "Yet the average investment in research and development for safety, accident prevention, and spill response was a paltry \$20 million per year, less than one-tenth of one percent of their profits." In preparing for hearings, House Energy Committee Chair Henry Waxman (D-CA) cited a BP engineer's description of Deepwater Horizon as a "nightmare well" a few days before the blast, and describes BP's "carelessness and complacency" in making "decisions that increased the risk of a blowout to save the company time or expense".

What possible definition could he have in mind that doesn't insult every Democratic primary voter in South Carolina and, by very logical extension, every voter of every party in every state who has or will vote for an outsider in a noble attempt to shake up D.C. and express their rage at the fiscal malfeasance that passes now for serious debate and policy in our nation's capital?

Hundreds of thousands of Democratic voters took part in the South Carolina primary, and 86% of them voted for a Senate candidate. That's an awful lot of people to dis. It may well be possible that a Republican did in fact pay Mr. Greene's filing fee. But it could also have been a hyper liberal activist, like an ACORN representative or a George Soros apparatchik. 

HAIL Hamilton My Turn **Dust Devils Whirl Around Arizona Law**

I'm sorry to keep harping about Arizona's new immigration law, but the

mirage of false and misleading information that continues to be spun by critics of SB 1070 is like one of those Dust Devils that whirl across the desert.

President Obama said the Arizona law, which goes into effect July 29 and makes it a crime under state law to be in the U.S. illegally, is a "misdirected expression of frustration over our broken immigration system." He has also said that he thought "the Arizona law has the potential of being applied in a discriminatory fashion." Apparently the president either hasn't read the law or doesn't understand it.

Attorney General Eric Holder, following the President's lead,

sternly warned the nation that "we could potentially get on a slippery slope where people will be picked because of how they look as opposed to what they have done." He has also warned that the law "has the possibility of leading to racial profiling."

However, when pressed about his comments in a recent House

Homeland Security Committee hearing, Holder admitted that he hadn't actually read the law--a stunning admission by our nation's top law enforcement official!

Another SB 1070 opponent, Homeland Security Secretary and former Arizona governor Janet Napolitano, said, that she hasn't read the law either. Under questioning by Sen. John McCain, R-Ariz., last month in a Senate Homeland Security Committee hearing she said, "I have not reviewed it in detail." But when McCain pressed her to provide information about "what specific aspect of the law" would hurt law enforcement, Napolitano was unable to provide any.

If they had read and understood the law, the President and administration officials would have seen that S.B. 1070 expressly prohibits racial profiling.

In four different sections, the law reiterates that a law-enforcement official "may not consider race, color, or national origin" in making any stops or determining an alien's immigration status. With this language, S.B. 1070 goes to extraordinary lengths to protect against racial profiling. In addition, all the normal Fourth and Fourteenth Amendment protections against racial profiling will continue to

Critics have declared that the law will require aliens to carry documentation that they weren't otherwise required to possess. President Obama claimed, "Now, suddenly, if you don't have your papers... you're going to be harassed."

federal immigration laws. Since 1940, it has been a federal crime for aliens not to keep certain registration documents on their person or not to register with the federal government. The Arizona law merely makes violating these federal statutes (8 USC Sections 1304(a) and 1306(e)) a state crime as well.

Critics have also claimed that the law requires police officers to stop people in order to question them about their immigration status. Here too, President Obama misrepresented the law. Offering the example of a Hispanic family going to an ice-cream parlor, Obama said "a police officer might walk up to the father and start interrogating him about his immigration documents."

Section 2 of S.B. 1070, however, stipulates that in order for its provisions to apply, a law-enforcement officer must first make a lawful stop, detention, or arrest . . . in the enforcement of any other law or ordinance of a county, city or town or this state."

The original wording made reference to "lawful contact"; this was revised to "lawful stop, detention, or arrest" to make clear that officers could not stop someone simply on suspicion of illegal immigration status and ask for papers. So in President Obama's example, S.B. 1070 might come into play if the person came running out of the ice-cream shop with a gun in one hand and a bagful of money in the other. But an officer could not demand identification without the initial lawbreaking that justified the stop.

The law operates in straightforward fashion. If a police officer,

during a detention to investigate another offense--say, a traffic violation--develops reasonable suspicion that the subject is an illegal alien, then the officer must take specific steps to verify or dispel that reasonable suspicion. And contrary to the claims of critics, "reasonable suspicion" is a well-defined concept. Over the past four decades, the courts have issued more than 800 opinions defining those two words in the context of immigration violations.

Like a Dust Devil whirling across the desert, the mirage of misinformation being spun by critics of SB 1070 only underscores the apparent abandonment by the federal government of Arizona residents to the siege of Mexican drug lords, human traffickers, and squatters.

Digestive disturbances ranging from GERD to the common "sour stomach" cost consumers millions of dollars and hours of discomfort every year. While we may be hoping for a cure, answers can be as simple as a few changes in diet. In the next three weeks, we will discuss various conditions and approaches which are lowtech and effective.

Starting at the Beginning

Let's face it, we want to be able to eat anything we choose without gaining weight or suffering from indigestion. Truth is, this may be unrealistic. If the body is expressing discomfort, it is often a result of something we are doing. Sure, we may find a medication that reduces symptoms for a while, but frequently they will return with a vengeance. At some point, we've got to get back to basics in

order to rest and repair the digestive system. Here are a few powerful, yet simple, tools:

Keep it simple. For some, complex meals tax the digestive system's ability to produce the enzymes necessary to cleanly break down the food. Simple food combining rules can help. Avoid combining proteins with starches (ie. meat and potatoes, milk and cereal, bread and peanut butter) at the same meal. Instead, eat protein with green vegetables or fresh fruit at one meal, and starches with salad or steamed green vegetables at another. This simple step helps many to increase their digestive efficiency.

Simplify your food choices. Fresh produce, whole grains, raw nuts and seeds, simply prepared animal proteins can all promote health. Refined and processed foods, especially sugars, sodas, and artificial preservatives and colors, contribute to numerous health disasters.

Drink any liquids a half hour before, or one and a half hours after, a meal. This allows the digestive juices to be more concentrated and helps reduce fermentation/putrefaction from incompletely digested foods.

If emotionally upset or very fatigued, wait to eat until later or eat a small amount of simple, fresh food rather than a larger meal.

Finally, "close the kitchen" three or four hours before bedtime. Eating too close to a night's rest promotes discomfort and a sense of restlessness throughout the night for many. In the next two weeks, we will discuss support and diagnostics for digestive health.



Recipes of the Week:

Spicy Crab Cakes with Lemon Aioli Sauce

Spicy Crab Cakes:

INGREDIENTS:

- 2 tablespoons butter 1 shallot, chopped fine
- 1 clove garlic, minced
- 1/4 cup finely chopped red pepper Kosher salt and freshly ground black
- 1/2 cup mayonnaise 1/2 cup Dijon mustard 1/2 teaspoon lemon zest

- 1 teaspoon crab boil seasoning
 1 tablespoon chopped fresh parsley leaves
 1 cup plain panko bread crumbs
 1 large egg
- Hot sauce, to taste
- 1 pound lump crabmeat, picked over to remove cartilage and shell fragments 1/2 cup peanut oil

DIRECTIONS:

Heat a medium size pan over medium heat. Add the butter. Once melted add the shallot, 1 clove of garlic and red pepper. Lightly saute until tender, about 3 minutes. Season with salt and pepper.

Remove from heat and allow to cool.

In a medium bowl, mix together mayonnaise, Dijon mustard, lemon zest, crab boil seasoning, fresh parsley, 1/2 cup of the panko and egg. Mix in cooked vegetables, hot sauce, and salt and pepper,

Add crabmeat and stir well.

Form crab cakes using about 2 tablespoons of crab mixture for each cake.. Flatten until they're about 3/4 inches high. Dip the cakes into the remaining panko.

Add oil to a large skillet over high heat. Add crab cakes and saute, flipping once, until golden brown and crisp, about 5 to 6 minutes per side. Serve with Lemon Aioli.

Lemon Aioli Sauce

INGREDIENTS:

- 1/2 cup mayonnaise
- 1 clove garlic, minced
- 1 tablespoon chopped chives
- 3 tablespoons lemon juice
- 1/2 teaspoon lemon zest Kosher salt and freshly ground black
- pepper

DIRECTIONS:

In a medium bowl, mix all the ingredients together.

One Of A Kind: Featuring unique homes & gardens and the people who create them Story and Photos By Chris Bertrand Cal Poly's Center For Regenerative Studies: Learning and Living Sustainability in Pomona

Perhaps if Cal Poly Pomona's Center for Regenerative Studies were to open today, it would be named instead with the current buzz phrase, "Sustainable Living." Decades ahead of its time, the CRS was the 1970's brainchild of Sierra Madre's own John Lyle, a landscape architecture professor in the College of Environmental Design there. Many years of idea evolution and fundraising

Chris Bertrand followed, and CRS broke ground in 1992, then took on its first student in 1994. Though Lyle passed away in 1998, his work had a far-reaching effect on the university,

and the center now bears his name. Cal Poly Pomona president, J. Michael Ortiz, commented on the Lyle Center, "John Lyle had a tremendous influence on the underlying philosophy of all of the programs in the College of Environmental Design. Graduates of the College have had a profound impact on the manner in which they approach their discipline with a very specific focus on sustainability. He was way ahead of his time, but his work continues to influence our efforts to be good stewards of the environment and create a carbon neutral campus."



The Lyle Center is part of the College of Environmental Design, one of only three design schools in California that combine departments of architecture, landscape architecture, and urban and regional planning. The center offers a master degree program and an undergraduate minor, centered at sixteen hilltop acres overlooking the Pomona campus.

Dr. Kyle D. Brown, now director of the center, said the exciting Lyle Center concept actually drew him to Cal Poly, where their mission is "To advance ... environmentally sustainable living through education, research, demonstration and community outreach. The term "regenerative" describes processes that restore, renew or revitalize their own sources of energy and materials, creating sustainable systems that integrate the needs of society with the

This Cal State "learn by doing" university program translates

those lofty words into actions with students and faculty studying, practicing, building, testing and even living onsite, focusing on "low energy architecture, energy production technology, water treatment, organic agriculture, ecological restoration and sustainable community development," per their website.

Cal Poly architecture professor, Norberto Nardi and Lyle's wife, Harriett, accompanied me on my tour of the center in May. Turns out Nardi, whom I wrote about in April, and Professor Lyle had adjacent offices for years, and worked together in a couple of

professional commissions quite connected at that time with concepts of sustainability. The tour was an opportunity for Nardi to meet his old friend's wife and reminisce a bit.

Of the CRS and John Lyle, Professor Nardi reflects," I always have been amazed how well John understood the concept of sustainability as the result of the appropriate dialog between the human race, common sense and nature. His intuition regarding control and respect to the environment was beyond that of today's excessive use of gadgets and oversophisticated technologies."

My tour showed me low tech to cutting edge sustainable living solutions. Simple things can make a big difference in utility costs as well as comfort. By using passive solar design, the winter sun can have the maximum warming effect during the season it's needed most, by using vine trellises and carefully placing deciduous vegetation that's leafless in the

When summer comes, deciduous vegetation shields buildings from sun, keeping them cool. In the same design, high clerestory windows allow a convection effect, where hot air is drawn up and out during the summer. Dr. Brown indicated that just these two factors keep the buildings comfortable until the outside temperature rises to

More involved concepts included water cooling from ponds extending under CRS buildings, straw bales used for inexpensive insulation; vehicle fuel derived from used cooking oil and roof

shingles incorporating solar energy production.

On the topic of solar production, CRS has long proudly used a variety of solar arrays on the site. Dr. Brown was pleased to share that a new tracking concentrated solar array has just been donated, and all look forward to the next generation of study with this new

Very simple housing prototypes for the impoverished were constructed onsite, with a concrete and newspaper mixture plus wood gleaned from pallets, a readily available commodity. Options for major lifestyle improvements to these simple structures at very minimal cost are demonstrated here. For instance, an old, retired water heater was painted black and placed uphill from the dwelling. Gravity could force the water down a pipe, delivering warm water for bathing. Another idea, costing only \$1 each, were clear glass plates from IKEA used as windows.

Yet another idea for homes without electricity was repurposing an old car radio with a battery pack for access to news and music. Cal Poly partners with a non-profit group to build and improve homes in Baja Mexico based on these technologies. Again, learning by doing. The need for this type of housing in places of extreme need like post-earthquake Haiti has recently been all over the media.

CRS takes their ideas for sustainable living on the road for regular demonstrations throughout LA and beyond. Dr. Brown adds that they are always looking for new business partners to further research and experiments in real life living. 


