### **Water Woes**

#### Sierra Madre's pristine Water System is the source of great pride and great concern

There are few small towns that have just about everything. A clean, safe environment, their own fire and police departments, good schools, talented, dedicated city staff, a war chest of community volunteers and.....water.

Yes, Sierra Madre even has its' own supply of water and doesn't have to rely on surrounding purveyors of water to sustain the city. In1882, The Sierra Madre Water Company was formed, 25 years before the town was incorporated.

Sierra Madre's water supply is primarily derived from four wells Sierra Madre's pumping station

drawing from the East Raymond Basin aquifer (85%) and two natural spring tunnels located on either side of the county flood control dam in Little Santa Anita Canyon. These wells are the source of great pride, and once again, great controversy.

The local supply is managed by the Water

Division of the Department of Public works and has the responsibility for maintaining water quality, and pumping, treating, and distributing water to residents and businesses in town. The water is collected in a reservoir at the City's maintenance facility and then pumped to other reservoirs around town. The water is then distributed through a network of pipelines in our streets.

Current revenues from water users are not sufficient to continue operating the city's aging water system properly. This is primarily due to the fact that there has been no rate increase since July 2006 to keep up with the escalating costs of, for example, electricity which runs the pumps.

There is also not sufficient revenue to replace aging parts or to match available federal funds of \$10 million dollars to do major capital improvements. For instance, the Mira Monte Reservoir was recently rebuilt utilizing the matching grant program with the federal government. Funds for matching grants come from the Water Revenue Reserves. Those reserves are now below acceptable levels and leave the city vulnerable in the event of a disaster or emergency.

Recently, the city council was advised of the

need for a rate increase for water users and began the process of increasing the water rates. Those plans have inspired a campaign against the fee hike. As the result of a state proposition, "Prop 218"), certain utility fee increases can be blocked through a process that allows citizens to protest the action. Opponents of Sierra Madre's proposed rate increase have surfaced and are asking residents to sign documents in "protest" of the rate hike. If they are successful and ascertain support of more than half of the rate payers in

Sierra Madre, the city will not be allowed to raise water rates. As of this writing, however, no other viable alternative to increasing water revenues has been found and without increased revenue, the maintaining and integrity of the city's water resources properly will be in jeopardy.

Over the years, there have been many legal battles over water rights but this developing modern day 'feud' is not over who has access to the water but over the costs associated with maintaining the water system and who should pay for them. In a city that has total control of its water resources, there are those who appear to be opposed to

The city's current water delivery system, which dates back to the early 1900's requires constant maintenance and improvements. As recently as this week, as if a warning to the city that the system's need for maintenance is immediate, an aging water main broke in the canyons. It appeared that the main (shown below) had not been replaced since the 1930's.

On July 13th, the city council will hold a public hearing in accordance with the conditions of Prop 218. Protests must be submitted to the council by that date.

#### New Water Tanker Makes Parade Debut

After fighting fires for over 35 years, the fire department has finally decided, this year, to retire their water tanker, replacing it with a brand one that will make its first public appearance in the Fourth of July day parade. Fire Marshal Richard Snyder said maintaining the old truck just got to be too much.

'Usually we go out on mutual aid assignments, to bushfires, and last year it got called out five or six times but we didn't take it," he said. "We didn't take it because we didn't think it was mechanically sound."

Snyder said they drove the new tender down from Sacramento three

Along with the new water truck, the department also bought a new ambulance and one new fire engine. Snyder said they plan to take two older engines out of service, replacing them with just one. The new ambulance, he added, will also be in the parade on

The cost of the truck was part of a large citywide capital spending program, he said ,which also included new public works vehicles. Snyder did not specify the price of individual vehicles, but said the city gets reimbursed on many assignments, "It will eventually pay for itself." Finance Director Karen Schnaider, he said, oversaw the vehicle's leasing.

He added that the new truck is similar to the old one in technical specifications. Both hold 2,800 gallons of water and both can be used for applying Phos-Chek. The new truck

has a stainless steel tank he said. Phos- California. Chek is a non toxic fire retardant used to fight wildfires.

water tanker that is a mobile Phos-Chek mixer," he said, explaining that they made sure the new one was as well. "That is one of a kind."

Although, not yet in city service, the tuck has been at work the last week applying Phos-Chek along the San Gabriel Mountain foothills cities.

Snyder, along with Pasadena Fire, spent all day Wednesday spraying Phos-Chek around the Rose Bowl in anticipation of this year's Americafest, the largest fireworks show in Southern

"We have 8,000 pounds [of Our water tanker was the only Phos-Chek] that we are spying as a preventive measure for the Four of July activities," said Pasadena Fire Information Officer Lisa Derderian. "Not only are there thousands of people that attend the show at the bowl, but thousands that surround the Rose Bowl area as spectators."

Snyder said they used the truck for the first time last weekend applying Phos-Chek at Chantry Flats. He also said the fire retardant is good until it





Back in April, Brady viewed a moving video of a volunteer group of medical professionals performing cleft palate surgeries on needy children around the world, literally enabling some of them to smile for the very first time at a service club meeting. Days later, when he couldn't get these children out of his mind, he was driven to raise funds for more surgeries...and a new event started evolving.

Brady immediately began gathering community, civic, school, service organization and volunteer support for this and another needed project, much closer to home, an expanded fine arts program offerings at the Sierra Madre Youth Activity Center. Also known as the YAC, the center also serves adjacent communities like Arcadia, Monrovia and Pasadena. "It's so important for our children to expand their academic and sports experiences with fine arts. So many studies reinforce that work in the arts spells increased success and focus for students,"

says Brady. Funds raised will be equally split between the two causes.



"Architecture and DNA" is a series of photographs that examines the influence of a father's work as an architect on his daughter's work as an artist.

Inspired by models of buildings and gardens that Cybele's dad designed when she was a child, Cybele started constructing her own buildings out of foam core – emphasizing the kind of spaces that fit her personal life. Unlike her dad's works that were designed to be used in the real world, her structures were created as spaces of potential – architecture for her own personal/artistic narratives.

The garden and studio of the home Cybele grew up in were designed by her dad and, of all his work, had the most immediate impact on her. For this series of photographs she projected images of their garden and studio onto her own structures, creating a 3rd space – one that exposes the complexity of influence and departure from a parent. Cybele holds an MFA from Hunter College in New York, where she received the Tony Smith Award in her final year. She has recently shown at Krowswork Gallery in Oakland and Artists Television Access Window Gallery in San francisco. Cybele will be an artist in residence at the Bemis Center in Omaha this fall as well an affiliate artist at the Headlands Center for the Arts in 2011.

Cybele's father (the silent partner in this project) was founder of Cal Poly Pomona's Lyle Center for Regenerative Studies. Her mother, Harriett Lyle, is a prominent Sierra Madre civic leader.

# Safety Urged During 4th of July Activities

Pasadena Fire Department Pasadena Police Department remind residents and visitors that the best way to celebrate the Fourth of July holiday with family and friends is by attending a professional fireworks show.

The sale and possession of all fireworks is illegal in Pasadena as well as most of Los Angeles County. Violators are subject to confiscation and impound of vehicles, up to one year in jail and fines up to \$50,000. Due to high fire hazards

associated with record-low rainfall the past few years, Pasadena police and fire personnel will staff checkpoints to seize all illegal fireworks and arrest offenders. Parking enforcement officers will ensure that vehicles illegally parked in hillside areas on July 4 are impounded.

Pasadena's police and fire chiefs stress that the aim is to prevent accidents and injuries.

"Even sparklers, which most people consider safe, can reach temperatures of 1,000 degrees Fahrenheit, burn people seriously and cause fires," said Pasadena Fire Chief Dennis J. Downs. "Adults wouldn't ordinarily allow children to get near anything that hot but for some reason they think it's acceptable to put sparklers in the hands of small children on the Fourth of

July." Statistics show that nearly 10,000 fireworks-related injuries are treated in U.S. hospital emergency rooms annually. The highest injury rates are for children aged 5 to 9 and 10 to 14. In 2007, more than nine out of 10 (92 percent) emergency patients with fireworks-related injuries were injured by fireworks that federal regulations permit consumers to use. Fireworks are the riskiest consumer product.

#### Exhibit to Celebrate the 90th Anniversary of Woman's Suffrage

LOS ANGELES – Heritage Square Museum's latest exhibit Their Rights and Nothing Less: A Celebration of Women's Suffrage will open on June 19th and runs through September 26th. Complete with original, rarely-seen ephemera from the early years of the suffrage movement, a special section of the exhibit will be dedicated entirely to the efforts of women in Los Angeles who led the fight for equality 9 years before its ratification at the National level.

This year marks the 90th anniversary of the passage of the 19th Amendment to the Constitution giving women the right for women to vote. More accurately, the language does not reference women in the affirmative; what it does is not deny the right to vote based upon

gender.
The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex. Congress shall have power to enforce this article by appropriate legislation.

The 19th Amendment was proposed on June 4. 1919. Ratification was completed on August 18, 1920 by Tennessee, by a one-vote margin. It was certified on August 26, 1920. Of course, the fight for women's rights began much, much earlier. In 1792, A Vindication of the Rights of Woman: With Strictures on Political and Moral Subjects was published by Mary Wollstonecraft, which responded to an issue even more basic and immediate than voting rights—the right—indeed the necessity for women to receive an education. Although almost inconceivable to think of now, this was considered a radical position which provoked a dramatic, although not necessarily negative, response. Starting with this simple idea, women have been fighting for equal rights ever since.

Curated by Mitzi March Mogul, Their Rights and Nothing Less takes a critical look at the incredible effort it took to gain that right and includes original artifacts from the early years of the struggle. In addition, the exhibit continues after the vote was won to look at critical issues fought and won by the women's rights movement after. Including ephemera and artifacts from a never-before-seen private collection, the exhibit is a must for every woman...and man. The exhibit is made possible thanks to sponsors Planned Parenthood of Pasadena, 9 to 5-the National Association of Working Women, Bob Taylor Properties and the Glendale Printing Center.

Ćelebrating 41 years preserving and interpreting the history of Southern California, Heritage Square is a living history museum

whose eight historic structures to tell the story of the development of Los Angeles like no place else. #### An excerpt - the Story of Olive Percival

On July 19th, Heritage Square Museum will debut Their Rights and Nothing Less: Commemorating the 90th Anniversary of Women's Suffrage. The exhibt highlights several examples of women, (some you may have heard of and some who you have not) who led the fight for women's rights.


Olive Percival is one such story.

Like so many others, Olive Percival, her mother, and sister were lured to Southern California by the temperate climate, as well as the opportunities it presented. She was born in a log cabin; her father died when she was only ten years old.

Although Olive lived on a relatively modest salary (which never exceeded \$150 a month), she managed to buy land in the Arroyo Seco, where she built a home called "Down-hyl Claim." Down-hyl Claim was the setting for frequent gatherings by local and visit celebrity authors, artists, actors, society leaders, professionals and intellectuals and her diaries, which date from 1889 to 1943 are a chronicle of this life and read like a Who's Who of important residents of Los Angeles.

Olive began her writing career in 1896 and is probably best known for her 1911 "Children's Garden Book." She eventually became a regular contributor to the Los Angeles Times, writing on subjects ranging from women's suffrage to gardening. In 1910, following the bombing of the Los Angeles Times building by anarchists, she wrote an article entitled "Would Woman's Vote Suppress Anarchy?" in which she made the persuasive case that for America to be truly democratic, liberty must be granted to all.

As for equal suffrage, I have never in my life heard one sane argument against it. I think the only argument that men who are opposed to the measure have ever advanced...is that they do not want women to lose their delicacy and charm by rough contact with matters political. This is not sentiment, but sentimentality. There is no sense or intelligence





# Looking

Voyager 2 Completes 12,000 Days of Continuous Operations

#### New "Cosmic Café" Opens on Mt. Wilson

MountainViews-News Saturday, July 3, 2010

On June 28, 2010, Voyager 2 completed 12,000 days of continuous operations since its launch on August 20, 1977. For nearly 33 years, the venerable spacecraft has been returning unprecedented data about the giant outer planets, the properties of the solar wind between and beyond the planets and the interaction of the solar wind with interstellar winds. Having traveled more than 13 billion miles on its winding path through the planets toward interstellar space, the spacecraft is now nearly 9 billion miles from the sun. Traveling at the speed of light, a signal from the ground takes about 12.8 hours to reach the spacecraft.

Voyager 1 will reach this milestone on July 13 after having traveled more than 13 billion miles. Voyager 1 is currently more than 10 billion miles from the Sun.

Visitors to the world-famous Mount Wilson Observatory can once again enjoy a memorable lunch among the telescope domes and Ponderosa pines up in the clear air overlooking the Los Angeles Basin. The Mount Wilson Institute last week announced the opening of the Cosmic our 'Second Century Campaign', in which we hope to build Café, where they can purchase fresh-made sandwiches, hot dogs, soft drinks, snacks and souvenirs. Not since 1992 has food been available for purchase at the Observatory to enhance the visitor experience, or to refresh hikers as they reach the mountain's summit.

The Cosmic Café is located in the open-air pavilion overlooking the large parking lot just inside the gate to what



has been known since the 19702 as Skyline Park. The pavilion serves as the entry point to the Observatory grounds.

"We're delighted to reopen this food venue to the public after all these years," said Dr. Hal McAlister, the Observatory director. "The income from the Cosmic Café will support a wonderful new visitor center that will entice Southern Californians to rediscover this world-class science heritage site in their back yards."

The Angeles Crest Highway remains closed due to MtnViewsNews.com. washouts following the Station Fire, but the Observatory is still readily accessible via L.A. County roads from Sunland. "The drive to Mt. Wilson is a bit longer than we are all used

to," said McAlister, "but the roads are in great shape, and you can witness the recovery progress of the forest following the massive destruction of the Station Fire."

While the Observatory is open daily to public visitation from 10 a.m. to 4 p.m. during April through November, the Cosmic Café will be open initially only on Saturdays and Sundays from 10 a.m. until 4 p.m. The Café will also be open on Monday, July 5, for the upcoming Fourth of July weekend.

To reach Mt. Wilson, take Oro Vista Ave. in Sunland to the Lower Big Tujunga Canyon Road, and proceed 11.9 miles to the wellmarked intersection with Angeles Forest Highway. Turn left on Angeles Forest Highway and proceed 4.6

miles to another well-marked intersection with Upper Big Tujunga Canyon Road. Turn right on Upper Big Tujunga Canyon Road and drive 9 miles to Angeles Crest Highway. Turn right and proceed 4.2 miles west to Red Box junction. Turn left at Red Box and take the 4.5-mile road up to Mount Wilson.

PRC bills itself as a non-profit with the dual mission of consumer education and consumer advocacy. Among PRC's stated goals is to raise consumers awareness of how technology affects personal privacy and to empower consumers to take action to control their own personal information by providing practical tips on privacy protection. In addition to responding to specific privacy-related complaints from consumers and interceding on their behalf, PRC routinely advocates for consumers' privacy rights in local, state and federal public policy proceedings. Services provided by PRC include a hotline for consumers to report privacy abuses and request information on how to better protect their privacy, fact sheets on privacy issues in English and Spanish and a host of other privacy-related material including transcripts of PRC legislative and regulatory testimony. The Home Page for the PRC website features a sidebar for browsing such privacy topics as Privacy Basics, Background Checks & Workplace, Banking and Finance, Credit and Credit Reports, Debt Collection, Education, Harassment and Stalking, Identity Theft & Data, Insurance, Junk Mail/Faxes/Email, Medical Privacy, Online Privacy and Technology, Privacy When You Shop, Public Records & Info Brokers, Social Security Numbers, Telephone Privacy and more. These topics are presented in a clear and concise manner and provide a wealth of relevant knowledge about privacy issues that every consumer should know.

Established in 1992 by Beth Givens, the Privacy Rights Clearinghouse bases its philosophy of consumer privacy on a bit of testimony embedded on its "About Us" page:

"The real danger is the gradual erosion of individual liberties through the automation, integration and interconnection of many small, separate record-keeping systems, each of which alone may seem innocuous, even benevolent, and wholly justifiable." --- U.S Privacy Protection Study Commission,

The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

Dear Jai: Do I have to attach or include a cover letter when I submit my resume? Yes. You should always include a cover letter or e-letter when submitting your resume. The cover letter is very important and is your first introduction to an

employer. Your cover letter should be very short and concise since employers will take only about 10 seconds to read it. However, you should spend enough time to write a dynamic cover letter that will support your resume. The cover letter should be written in 2 or 3 paragraphs. Each cover letter should be customized to target a specific position or company. The following questions should be answered in writing your cover letter.

First paragraph: How did you find out about the position? Why are you interested in the position? Why do you feel you fit the qualifications for this position?


Second Paragraph: What would you bring to the company to increase their clients or success? What is your most successful accomplishment/s that you feel would bring them added value to hiring you. Explain why you are transitioning (changing

Third Paragraph: This is considered the "sales closer". Restate your interest in the position. Lastly write that you will contact them to follow-up or that they can contact you for further information and/or to make arrangements for an interview. Remember to address your letter to the appropriate person or department and include your contact information.

#### Don't be discouraged. Be committed.

If there is nothing more American than a Hot Dog, why am I writing about Pastrami? Read on, my loyal readers. My late Pappy always told me, "Son, never debate sex, politics or religion." I am adding one additional item to his list, a Sandwich/Dip. You probably


couldn't go more than a couple blocks in most cities without coming across an American Sandwich Shop. The sandwich may be the most versatile food item ever created. I eat them for lunch, dinner and, sometimes, even for breakfast. We are lucky, for in the San Gabriel area we have a number of All-Stars sandwich shops to choose from. There is Tops on Walnut, Connel's Grinders on E. Washington, and The Hat, which has several locations. The Hat has been around since 1951, and I am glad to say, it is a family-run business. They are actively involved in the community, and a fully demonstrated fact when Ron "Corky" Conzonire held the position of President of the Tournament of Roses, from 2008-2009.

The Pastrami Sandwich or "Dip," as the menu proffers, is the Hat's signature dish. Sure, they have burgers, hot dogs and salads, but the menu item that keeps them coming back is the "Pastrami Dip." It is a World Famous plunge of sandwich into 'au jus. I am planning on a trip to South America next month and I am going to ask everyone I meet, about LA-based World Famous Dishes. I'm just kidding... a little. But, I do develop a chuckle in that selfanointed phrase. The World Famous Pastrami Sandwich is reasonably priced (\$6.99). The meat is thinly sliced and piled generously high. The bread is light and fluffy (maybe a little


too light and fluffy in my opinion). Next visit I will try it on regular sandwich bread. My sources inform me that The Hat goes through 14 tons of Pastrami per week. By my calculations, that is a lot of sandwiches. My dining companion "Mike" had the Hot Dog (\$1.99) and a huge portion of fries (\$3.09). He is on a diet it appears. The prices are right at The Hat, everything is under (\$10). If you haven't checked it out, you will love the Dip. For the location near you, they have a slick web site www.thehat.com.

The Club House at The Santa Anita Race Track serves a corned beef sandwich (\$7.95) that should be renowned as a Southern California Legend. The tasty sandwich is reason enough to go to the track, although, I often spend considerably more money on some turtles that enter through the starting gate before enjoying their leisurely stroll around the track while they view the mountains. I can give you an inside tip, this corned beef sandwich is a guaranteed winner every day.

#### A True July 4th Tradition

#### Old-Fashioned Homemade Ice Cream

- 6 eggs
- 2 cups sugar
- 1/4 teaspoon salt
- 1 tablespoon vanilla extract
- 13-ounce can evaporated milk (1-1/2 cups plus 2 tablespoons)
- 1 gallon whole milk
- chipped ice
- rock salt

In a large mixing bowl, beat eggs. Add sugar gradually, stirring constantly. Add salt, vanilla and canned milk. Add about a pint of the fresh milk and mix.

Pour mixture into ice cream freezer can. Add enough of the remainder of the milk to fill can to the middle of the top board of dasher. (If the freezer can has a "fill" line on it, fill no higher than that line.)



Assemble the ice cream freezer. Add alternating layers of chipped ice and rock salt to barrel around freezer can. Crank freezer until ice cream begins to freeze (cranking will become harder as ice cream freezes), adding more ice and salt, as needed. When handle becomes difficult-to-impossible to turn, remove turning mechanism, and carefully remove top from freezer can; remove dasher. Replace top. Cover can with more ice and salt. Cover ice with an old towel, allowing ice cream to "cure" for at least 1 hour. If yours is an electric freezer, follow manufacturer's directions, but the curing step is essential.

Makes about 5 quarts of ice cream

#### **HOWARD** Hays As I See It

Befitting Fourth-of-July, here U.S. Constitution:

What are the last four words of the *President's Oath of Office?* 

If you thought "so help me God", then you get a "wrong" buzzer. The oath concludes with, "... preserve, protect and defend the Constitution of the United States". Originally written as a statement ("I do solemnly swear."), at first it was administered as a question ("Do you, state your name, solemnly swear . . .?"). Chester A. Arthur in 1881 answered, "I do, so help me God". The phrase stuck.

Nothing says she couldn't. One was qualified to vote if, under state law one was qualified to vote for the state legislature. States back then pretty much limited voting to over-21 white male property owners, though.

For those seeking the "original intent" of our Founding Fathers, there's the fact that U.S. Senators were selected by state legislatures. There's also this: "Representatives and direct Taxes shall be apportioned . . . according to their respective Numbers, which shall be determined by adding to the whole Number of free Persons, including those bound to Service for a Term of Years, and excluding Indians not taxed, three fifths of all other Persons.

For that "three fifths" category, our Constitution adds: "No Person held to Service or Labour in one State, under the Laws thereof, escaping into another, shall . . . be discharged from such Service or Labour, but shall be delivered up on Claim of the Party to whom such Service or Labour may be due." This is in the main body of the document; all that other stuff about freedom of speech, due process, right to bear arms, etc. was added later as an afterthought.

There's also the matter of precedent and "settled law". For this, our Supreme Court is the last word, and a look at past decisions can provide an illuminating perspective. There's Barron v. Baltimore (1833), where the Court decreed the Bill of Rights applied only to federal laws, with states free to trample those "rights" however they wished. In Dred Scott v. Sandford (1857), slave Scott argued for his freedom on the grounds he'd been taken for extended periods to free states. In writing for the majority declaring Scott had no standing, Chief Justice Roger Taney noted that blacks would never become U.S. citizens, as they are "beings of an inferior order".

Plessy v. Ferguson (1896) established that segregation was permissible as long as the facilities were "separate but equal". In the early twentieth century, the Court sought to protect what it called "liberty of contract" by striking down state and federal laws protecting workers hours laws and guarantees of the right to join unions. A few years later, the Court struck down programs in FDR's New Deal.

In Bush v. Gore (2000), the Court took it are a couple questions on the upon itself, rather than leaving it to the State of Florida, to decide a presidential election. Garcetti v. Ceballos (2005) permitted retaliation against government whistleblowers and limited free speech rights of public employees. Gonzalez v. Carhart (2007) allowed Congress to ban an abortion procedure even when a doctor deems it necessary to protect the patient's health. Citizens United v. FEC (2010) granted "personhood" and free speech rights to corporations, allowing unlimited corporate donations to political campaigns.

> We can be grateful many of these decisions have been overturned, and others may be in the future. I doubt it was the "original intent" of our Founding Fathers that the Supreme Court be allowed to select a president, or that a corporation be allowed to buy an election. Sometimes the discussion gets bizarre. Twenty years ago, at his confirmation hearing, would-be-justice Robert Bork questioned the constitutionality of paper money. Last year on 60 MINUTES, Justice Antonin Scalia pointed out that torture is not necessarily "cruel and unusual punishment", because if the purpose is to extract information, it's not "punishment".

> Then there's the view of the late Justice Thurgood Marshall, who saw the Constitution as "a living document", and said of the Founding Fathers, "the government they devised was defective from the start, requiring several amendments, a civil war, and major social transformations to attain the system of constitutional government and its respect for the freedoms and individual rights we hold as fundamental today." Marshall began his law practice taking on cases for the NAACP, breaking down the "settled law" of Plessy v. Ferguson and fighting discrimination in housing, voting rights and education (one of his first targets was the University of Maryland, to which he himself had been denied admittance). Arguing several cases before the Supreme Court, he's best known today for his victory in Brown v. Board of Education (1954), which did away with the "separate but equal" doctrine in our public

> "It's a judicial philosophy that concerns me", says Sen. John Cornyn (R-TX). It "does not comport with the proper role of a judge" in the opinion of Sen. Charles Grassley (R-IA). Sen. Jeff Sessions (R-AL) reveals that Justice Marshall was in fact "a well-known activist". Sen. Dick Durbin (D-Ill), has a different outlook: "Some may dismiss Justice Marshall's pioneering work on civil rights as an example of empathy, that somehow, as a black man who had been a victim of discrimination, his feelings became part of his passionate life's work -- and I say, thank God".

Thurgood Marshall's son was in the audience this past week during the confirmation hearing of his father's former law clerk. It's not, as Chief Justice John Roberts put it, simply a matter of an "umpire calling balls and strikes", but of the through minimum wage and maximum working ongoing work "to form a more perfect Union, establish Justice . . . " and building on the legacy of her mentor as Elena Kagan will hopefully do as Associate Justice of the U.S. Supreme Court.

Their success or failure depends on the will of the United States – on whether we have the collective

Such is the situation in which we find ourselves in Afghanistan, a task and war made all the more important because of the commitment our enemy there has made to send terror to our shores and because of their potential to magnify that terror to unprecedented levels should they ever obtain nuclear capabilities. It is into this situation that our current president must throw himself wholeheartedly if he is ever to live up to the most basic of the promises he made at his inauguration: to defend the constitution and these United States against all enemies, foreign or domestic. With the sacking of General McChrystal and the appointment of General Petraeus as successor, we stand at a tipping point.

This war has now dragged on longer than the Vietnam war, and a democracy's appetite for military campaigns is always limited. Unfortunately, we don't have the option of just declaring victory and bringing the guys (and gals) home. We have to actually win. Unlike the Vietnamese, our enemies in the Middle East will follow us across the seas. Just because we say the war is over doesn't mean they have to believe it or abide by it.

To be honest, I don't know whether General McChrystal should have been fired or not. I do know that President Obama has the right to do it and the obligation to do it if he feels it necessary to the mission and his oath of office. That's a call that history will have to judge. But what's very clear is that he also has an obligation to replace McChrystal neral who will press this war to successful resolution.

President Obama's West Point speech in December put on full display his deep ambivalence about the Afghan war. While granting his general most of the troops he requested, President Obama then undermined that general's - and all future generals' – mission by announcing that we would begin our withdrawal in July 2011. will to use our military power to protect the freedom of others.

This is a strategic blunder of monumental proportions. It demoralized the troops while granting the enemy the first glimpse of success a la Vietnam fatigue syndrome. America, it would seem, can't go the distance, just as Osama Bin Laden predicted so many years ago. Knowledge that America just might leave Afghans to the tender mercies of the Taliban at some future specific date certainly encourages them to think a second time before helping out the American effort.

> So as General Petraeus is confirmed by the Senate and as we celebrate our independence from tyranny, let us hope that our president can draw the proper lessons from our nation's history and position in the world and from the demands placed upon him by circumstances. First, President Obama must take charge of this war and own it. He can't do that if he continues to insinuate that Bush caused the problem. Even if he did, it is Obama's to lose or win, and the consequences one way or the other will be rendered unto all of us. Second, President Obama must speak publicly about Afghanistan in a serious manner which he hasn't done since December of last year. Americans need to know from their leader what history and morality call us to do; they need to know how imperative success is in this endeavor; and they need to know what the results of failure will be.



America is celebrating birthday. another Another year of progess, another year wiser. another year wiser. Really? You can't prove it by the Supreme Court's latest decision on guns. #### **SELF DEFENSE**



it's the Fourth of July and fire-crackers are so much fun. No, in these modern times we know fire-crackers are dangerous and most cities have laws prohibiting individual usage. What I'm

talking about now is the United States Supreme Court decision, announced today, that held that the good old second amendment to the Constitutional guarantee of an individual right to bear arms applies to state and local gun control

Yep, it's just like Dodge City and Tombstone, Arizona and the rest of the Old West, where every good citizen strapped a six-gun onto his or her belt for self-protection. Justice Samuel A. Alito, Jr., writing for the majority, explained that the right to self-defense protected by the Second Amendment was fundamental to the American conception of ordered liberty and must be applied to limit not only federal power but also that of local and state governments.

Right; of course we all know that nothing protects you like a good gun. This is, of course, total nonsense. To begin with the Second Amendment, as designed by the Constitutional framers, was most probably intended to protect the ability of militiamen to keep muskets available for military use when this nation was in its infancy. Contrary to the desires of Justices like Anton Scalia, it is probably impossible to discern the actual intentions of delegates to the Constitutional Convention held a couple of hundred years ago. Judge John Paul Stevens, in his final dissent before retiring, writes sensibly that the proper manner of determining whether a particular law should be upheld is to look at the probable consequences of the law. He asserts that the motivations of Constitutional framers, whether discoverable or not, have only a limited bearing on the questions that confront society today. Other dissenters point out that history does not provide clear answers but that there is evidence that firearms cause 60,000 deaths and injuries in the United States each year These dissenters do their best to determine what is best for our nation's communities and take positions in accord with these beliefs.

In order to evaluate a potential judge, it is absolutely crucial to understand that judge's values. This will probably

As we go through another charade while aspiring Justice Kagan is being questioned by Congress, it is clear that our rights as Americans are being violated. The recent confirmation hearings of Chief Justice Roberts and Justice Alioto have shown the standard practice of every potential judge to hide, or at least do their best to obscure basic beliefs and opinions.

You know Justice Alioto is correct in his assertion that Americans have a basic and fundamental right to self defense. What self defense means in these modern times is something other than the unrestricted right to carry firearms. We also need to be able to protect ourselves from the abuses of money and power. I believe that today every responsible scientist agrees that the very survival of people on this planet is threatened by global warming or climate change. #### The Signers of the **Declaration of** Independence

Have you ever wondered who the signers of the Declaration of Independence were and what happened to them? Well, here's a thumbnail sketch someone sent me of the men who pledged "our lives, our fortunes and our sacred honor" for liberty so many years ago.

'Fifty-six men from each of the original 13 colonies signed the Declaration of Independence on July 4, 1776. Nine of the signers were immigrants, two were brothers and two were cousins. One was an orphan. The average age of a signer was 45. Benjamin Franklin was the oldest delegate at 70. The youngest was Thomas Lynch Jr. of South Carolina at 27. Thomas Jefferson was 33.

"Eighteen of the signers were merchants or businessmen, 14 were farmers, and four were doctors. Twenty-two were lawyers - although William Hooper of North Carolina was "disbarred" when he spoke out against the king - and nine were judges. Stephen Hopkins had been governor of Rhode Island. Forty-two signers had served in their colonial legislatures.

"John Witherspoon of New Jersey was the only active clergyman to attend. (Indeed, he wore his pontificals to the sessions.) Almost all were Protestants. Charles Carroll of Maryland was the lone Roman Catholic.

Seven of the signers were educated at Harvard, four at Yale, four at William & Mary, and three at Princeton. Witherspoon was the president of Princeton, and George Wythe was a professor at William & Mary. His students included Declaration scribe Thomas Jefferson.

Seventeen signers fought in the American Revolution. Thomas Nelson was a colonel in the Second Virginia Regiment and then commanded Virginia military forces at the Battle of Yorktown. William Whipple served with the New Hampshire militia and was a commanding officer in the decisive Saratoga campaign. Oliver Wolcott led the Connecticut regiments sent for the defense of New York and commanded a brigade of militia that took part in the defeat of General Burgoyne. Caesar Rodney was a major general in the Delaware militia; John Hancock held the same rank in the Massachusetts militia.

"The British captured five signers during the war. Edward Rutledge, Thomas Heyward, and Arthur Middleton were captured at the Battle of Charleston in 1780. George Walton was wounded and captured at the Battle of Savannah. Richard Stockton of New Jersey never recovered from his incarceration at the hands of British Loyalists. He died in

"Thomas McKean of Delaware wrote John Adams that he was "hunted like a fox by the enemy - compelled to remove my family five times in a few months." Abraham Clark of New Jersey had two of his sons captured by the British during the war.

"Eleven signers had their homes and property destroyed. Francis Lewis's New York home was razed and his wife taken prisoner. John Hart's farm and mills were destroyed when the British invaded New Jersey, and he died while fleeing capture. Carter Braxton and Nelson, both of Virginia, lent large sums of their personal fortunes to support the war effort but were never repaid.

"Fifteen of the signers participated in their states' constitutional conventions, and six - Roger Sherman, Robert Morris, Franklin, George Clymer, James Wilson, and George Reed - signed the U.S. Constitution.

"After the Revolution, 13 signers went on to become governors. Eighteen served in their state legislatures. Sixteen became state and federal judges. Seven became members of the U.S. House of Representatives. Six became U.S. senators. James Wilson and Samuel Chase became Supreme Court justices. Jefferson, Adams, and Elbridge Gerry each became vice president. Adams and Jefferson later became president.

Five signers played major roles in the establishment of colleges and universities: Franklin and the University of Pennsylvania; Jefferson and the University of Virginia; Benjamin Rush and Dickinson College; Lewis Morris and New York University; and George Walton and the University of Georgia.

"Adams, Jefferson, and Carroll were the longest surviving signers. Adams and Jefferson both died on July 4, 1826, the 50th anniversary of the Declaration of Independence. Carroll was the last signer to die in 1832 at the age of 95."

So, take a few minutes while enjoying your 4th of July holiday and give thanks to these patriots who so long ago dedicated themselves to the proposition:

We hold these truths to be selfevident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.



Today's Subject: Helicobacter Pylori & Stomach Health Health Tips From Dr. John Talevich

In the last two articles, we have discussed some basic considerations regarding digestive health. These are 1) simple foods, properly combined, to reduce gastric distress and 2) elimination of foods which may be inflammatory in individual cases. Also considered were some time-tested herbal and supplemental supports for improved digestion. This third installment is concerned with the stomach bacterium, helicobacter pylori.

Helicobacter pylori has become a hot topic in recent years due to research done by two Australian doctors, Barry Marshall, M.D. and Robin Warren, M.D. Prior to their discovery that ulcers are caused by this organism, it was commonly believed that anxiety and emotional stress were the

primary causes. Most researchers felt that bacteria could not live in the acid environment of the stomach.

For those suffering from long-standing gastric distress, it can be a relief to know what might be causing the problem. Once diagnosed, helicobacter can be eliminated by a visit to a medical specialist familiar with the issue. #### **Home Safety Surprises And Suggestions**

Consider using a can opener instead of a kitchen knife the next time you open those frustrating anti-theft plastic clamshell packages. And did you know that a sharp knife is safer than a dull knife? A dull blade leads to slips.

AARP has compiled a list of 30 home safety facts and tips that shine a light on the simple things that can help make homes safer and more user friendly.

Did you know that:

- 86,000 people fall each year because of their pets?
- Power-mower injuries cause 80,000 hospital visits each year?
- Poison ivy is getting more potent and harder to identify?
- More people are injured using hand tools than power tools?

Many of these injuries can be prevented with simple fixes that take just moments but rarely make it to our to-do lists.


Consider these small tasks:

- Moving the grill 10 feet from the house or shrubs can help protect you from a larger fire if the grill tips or the fire flares.
- Feeding the cat before making dinner can stop it from milling around the kitchen when you're cooking. A baby gate can keep the dog out of the kitchen altogether.
- Most mower injuries are caused by stones or other things kicked out by mower blades moving at high speed. Clearing the yard of debris before mowing can help.

#### Recipe of the Week: 4th of July BBQ'd Cornish Hens

3 cloves Garlic crushed 1 tb Seasoned salt 1c Fresh lemon juice 12 tsp Italian Salad dressing 1/2 c Chopped onions 1 Pepper 1 ts Crushed thyme 4 Rock Cornich Hens, giblets removed

#### **DIRECTIONS:**

**INGREDIENTS:** 

Blend garlic, seasoned salt, oil, lemon juice, dressing, onions, pepper, and thyme. Marinate the birds overnight in the refrigerator.

Cut the birds lengthwise.

Cook on outside grill, bone side down 10 minutes, flesh side down 5 minutes, alternating 10 minutes and 5 minutes in this manner for about an hour and basting with marinade frequently (at least every 5 minutes) while barbequing.

Serves 8.

If you can't get outside to barbecue, just use the oven method: Preheat oven to 400 degrees.

Place skin side up in a shallow pan, baste with marinade, cover with foil and roast for 30 minutes.

Remove foil and brush with marinade again. Roast again uncovered for 20-30 minutes (brush with marinade again after about 10 minutes).

Test for doneness: drumsticks should be soft and juices should not be tinged with pink when you pierce the thickest part of the thigh with a fork.




