The Bell That Won't Stop Ringing

Sierra Madre's City Manager's Salary Raises Few Eyebrows; City Clerk's Compensation Sounds Alarm

The recent discovery of the exorbitant salaries of officials in the city of Bell, has caught the attention of taxpayers throughout the country. In California, the state has demanded that all cities, regardless of their classification (Charter, General Law), post elected officials and city staff salaries online. Even in the city of Sierra Madre, information on the salaries of the town's elected officials and city staff are

now under scrutiny.
This week, the City of Sierra Madre put the "Elected Officials and Executive Staff Salary Information on its web site at www.cityofsierramadre.com. (See *chart below)*

While the Bell City Manager received a salary of nearly \$800,000 annually, Elaine Aguilar, who joined city staff in August, 2007, is paid, by comparison, a mere \$150,000 per year. That figure includes the city's payroll burden for her position. Compared to other cities in the area and when considering the population slightly over 11,000 residents and the fact that the median income in Sierra Madre of \$88,008, Aguilar's salary is commensurate with the responsibilities of the job. In Signal Hill, a city of the same size that has a median income substantially less - \$66,283, the city manager makes \$240,372 per year. In San Marino, a town of comparable size (13,000+), and a median income of \$158,000 a year, the city manager makes almost \$200,000 per year.

The Sierra Madre City Manager's salary was not the concern for those who had viewed the salaries on the Sierra Madre web site. What seemed to concern some residents was that all elected officials except one receive a stipend of \$3,000 per year. The exception is the Sierra Madre City Clerk, Nancy Shollenberger, who receives annual compensation of \$10,800 plus \$7,500 for General Municipal Elections. Other city clerks in Monrovia and Arcadia, are paid the same as council members. In Monrovia, a city that has a population almost 4 times the size of Sierra Madre, the City Clerk makes \$4,800.00 a year. In Arcadia, whose population is over 50,000, the city clerk is paid the same as the council members, \$6,000.00 per

Shollenberger, who has held the office for over 25 years, has been criticized for her participation in the water rate fee hike protest as she was also the elected official responsible for the integrity of the protest letter tally. She has also been criticized for displaying campaign signs on her home and other property she owns during elections, something many residents feel is a conflict of interest.

The City Clerk is elected to a fouryear term. Among the responsibilities of this office are recording the meeting minutes of the City Council, Financing Authority and Community Redevelopment Agency; advertising legal notices, codifying newly adopted municipal codes, administering oaths, ensuring that city staff and elected and appointed officials comply with State Conflict of Interest and Campaign Reporting Laws, providing notary services, and managing municipal

For several years, Shollenberger operated from her home after being refused an increase in salary of \$350 per month. During that time, city staff was responsible for taking minutes of council meetings. However, in February 2008, she returned to an office in City Hall and resumed taking minutes after the council agreed to pay her the designated elected officials stipend of \$250 per month, plus an additional \$650 per month for minute preparation.

At that time, then Mayor Enid Joffe cast the deciding vote to increase Shollenberger's compensation and end the stalemate. Council members Zimmerman and Buchanan also voted in favor of the increase. Councilman Don Watts abstained and Councilman Mosca opposed the increase in compensation taking the position of previous councils that the position should be limited to the compensation mandated for elected officials.

Although the increase was less than Shollenberger had requested, (\$1,000 per month increase), she accepted the \$650 figure. Former Councilman Zimmerman then committed to waive his \$250 a month stipend and give it to Shollenberger. It is not known whether or not Zimmerman made good on his pledge, however, upon approval by the council, Shollenberger resumed her duties as City Clerk.

Two months later, Shollenberger ran for re-election winning by a margin of less than 15 votes.

Construction Begins On New School

Residents Concerned About Noise And Dust

The Pasadena Unified School District, with funds generated from the passage of Measure TT, has begun the demolition of the old school and construction of a new Sierra Madre School Upper Campus. Initially, the district's Master Plan called for numerous renovations to be made to the existing buildings, however, after realizing that it would be more cost effective and less expensive to build a new school, the renovation project was abandoned.

The current Upper Campus is located on approximately eight acres of land. It had 3 buildings and breezeways totaling approximately 40,410 square feet.

According to the district, "Implementation of the Project will demolish all existing structures on-site and will develop a grouping of


two-story, small-scale buildings, totaling approximately 72,114 New transquare feet. The total increase in Auburn.

footage compared to the original facilities is approximately 31,704 square feet. The main increase in square footage is within the proposed support facilities, consistent with a modern middle school. Included

within the new facility will be a gymnasium that will available for joint use with the City of Sierra Madre."

While the new school is being constructed, a number of portable buildings, trailers, are being placed on the lower campus site. When school opens in September all Sierra Madre School students will attend classes at the main school on Highland Avenue (Lower Campus).





Sixty Year Resident of Sierra Madre, Frank Saumur Passes

Francis E. "Frank" Saumur, resident of Sierra Madre since 1950, died at his home on July 26, 2010 at the age of 88. Frank was born the 5th of 6 children to Philip Francis Saumur and Euphemia Hamel Saumur in Grand Forks, North Dakota. He grew up on the family's 640 acre farm and moved to Southern California along with a brother, sister, and their families in 1940 to work in the aircraft industry. He served in the Army Air Corps during World War II and married Marcella Hoover, daughter of Alfred Hoover and Eva Schlueter Hoover, in February 1944. In 1950 Frank and Marcella built their home in Sierra Madre and shortly thereafter started their plumbing company, Sierra Plumbing and Heating (later Saumur Associates, Inc.) Frank was an active member of St. Rita Catholic Church and a strong supporter of Mater Dolorosa Passionist Retreat Center. Frank leaves behind Marcella, his wife of 66 years, daughters Joan Saumur of Walnut Creek, CA, Kathleen Saumur Roach of West Linn, OR, and Carol Saumur of Sierra



Madre, brothers Joe and Paul Saumur, as well as grandsons, great granddaughters and numerous nieces and nephews. Funeral Mass was held on July 31, 2010 at St. Rita Catholic Church in Sierra Madre. Phyllis Battle is synonymous with jazz mastery among her peers. Her signature, scripted performances include historical facts delicately intertwined with jazz vocals and music, and her latest work, "Satin Dolls," is a tribute to jazz divas, Sarah Vaugh, Dinah Washington, Carmen McRae and Nina Simone. Phyllis will bring them to life with renditions of some of their most familiar songs, with costume changes and nuances to capture their personalities. Two performances are scheduled to take place at the Sierra Madre Playhouse on consecutive Sunday afternoons (August 22 & 29).

As a child, Phyllis Battle would frequent the Apollo Theatre on 125^{th} Street in Harlem, and amidst the razzle and dazzle of the talent onstage, she was always most intrigued by the jazz singers. When she was a teenager, her cousins entered her in Amateur Night at the Apollo where she placed as a finalist.

Phyllis moved to Los Angeles to pursue a career as a professional singer and worked as a secretary to make ends meet. Soon, she found herself touring as a background singer for Frank and Nancy Sinatra, Rita Coolidge, Donna Summers and others. She

later joined the 5th Dimension, touring and recording for sixteen years.

Throughout her adventurous career providing a vocal backdrop for many prominent entertainers, Phyllis also enjoyed an impressive career as a solo artist, which has been her focus in recent years. Phyllis's CD, Night Flight, was produced by jazz greats, pianist Cedar Walton and the late drummer, Billy Higgins.

Phyllis was the artistic director for the critically-acclaimed Instrumental Women Project's Annual "Lady Jazz" Series at the Ford Amphitheatre during its first four years. Her special brand of scripted concerts was key in garnering a "Best Live Jazz Performance of The Year" distinction by the L.A. Times, followed by five annual consecutive "Best Bets" designations as the recommended weekend jazz venue. In 2006, she sang for an entourage of international dignitaries attending the celebration of the 60th anniversary reign of the King of Thailand. Within days after returning to the U.S., she was the opening act for Pancho Sanchez.



"As we move into the application period for this position, I want to provide an opportunity for the community at large to provide input into the process," said Beck. "I value the community's opinion."


The new planning director will have an opportunity to present a fresh assessment of the department's business practices, systems and customer orientation that support the community's vision for land use.





Spacecraft Camera Yields Most Accurate Mars Map Ever



THEMIS 100 meter global daytime mosaic

A camera aboard NASA's Mars Odyssey spacecraft has helped develop the most accurate global Martian map ever. Researchers and the public can access the map via several websites and explore and survey the entire surface of the Red Planet.

The map was constructed using nearly 21,000 images from the Thermal Emission Imaging System, or THEMIS, a multi-band infrared camera on Odyssey. Researchers at Arizona State University's Mars Space Flight Facility in Tempe, in collaboration with JPL, have been compiling the map since these observations began eight

The pictures have been smoothed, matched, blended and cartographically controlled to make a giant mosaic. Users can pan around images and

"We've tied the images to the cartographic control grid provided by the U.S. Geological Survey, which also modeled the THEMIS camera's optics," said Philip Christensen, director of the Mars Space Flight "This approach lets us Facility. remove all instrument distortion, so features on the ground are correctly located to within a few pixels and provide the best global map of Mars to date."

Working with images from the new map, the public can contribute to Mars exploration by aligning the images to within a pixel's accuracy at NASA's "Be a Martian" website, which was developed in cooperation with Microsoft Corp. "The Mars Odyssey THEMIS team has assembled a spectacular product that will be the base map for Mars researchers for many years to come, said Jeffrey Plaut, Odyssey project scientist at JPL. "The map lays the framework for global studies of properties such as the mineral composition and physical nature of the surface materials."

Pediatric Food Allergies on the Rise in US

Pediatric food allergies are on the rise in the United States, and it may be due to our Westernized lifestyle.

These days, it seems that most kids have allergies to eggs, wheat, milk or nuts. In fact, between 1997 and 2007, pediatric food allergies increased by 18 percent, according to a study published in the journal Pediatrics. In 2007, approximately 3 million U.S. children reported a food or digestive

In a Journal of Allergy and Clinical Immunology study, researchers found that between 2001 and 2006, visits to the emergency room for allergic reactions at Children's Hospital Boston more than doubled. Moreover, the severity of reactions increased sharply, resulting in more children experiencing anaphylaxis.

Dr. Susan Rudders, the author of the Children's Hospital study, suspects her findings at the local ER reflect a national trend, according to CNN. Though Rudders studied only 1,255 children, her theory is supported by the experience of other physicians across the country. Doctors at the Children's Hospital of Los Angeles and the Children's Hospital of Philadelphia have seen a rise in the severity and number of cases coming into their emergency rooms.

Dr. James M. Rubin, chief of the Division of Allergy and Immunology at Beth Israel Medical Center in New York City, has also perceived a rise in pediatric food allergy cases, though he cautions that it may be due to "better detection on part of parents, pediatricians and primary care physicians."

While nobody is certain as to why there seems to be a food allergy epidemic, theories abound.

Some doctors and scientists wonder if children should be exposed to allergens like nuts and shellfish earlier than age two or three -- the age many doctors recommend -so that they can avoid developing allergies. In a 2008 study in the Journal of Allergy and Clinical Immunology, researchers found that Jewish Israeli children were far less likely to develop peanut allergies than were Jewish children in the U.K. -- a difference that was linked to with the fact that while 69 percent of Israeli children ate peanuts by the age of nine months, only 10 percent of the British children had.

"In terms of diet, there's a lot of controversy: Should you avoid certain things when you're pregnant? Should you avoid things when breastfeeding or not?" says Rubin.

Another fledgling theory is that a Western diet makes children susceptible to allergies and illnesses. A recent study out of the University of Florence in Italy shows that meat and junk food may make kids prone to allergies. Researchers compared the fiber-rich diets of 14 children from a rural African village in Burkina Faso to the diets of 15 children from Florence. The African kids ate mostly grains, beans, nuts and vegetables that had been farmed or raised near their homes, while the Italian kids ate far more meat, fat and sugar. The scientists found that the African children had flourishing "good" bacteria in their guts --cutting down their risks for obesity, easing their ability to digest food, protecting them from occurring? The answer is no."

against bugs and limiting inflammation. They also had an abundance of fatty acids, which guard against inflammation, asthma, allergic eczema and other allergic reactions. But it's not just American and European

diets that could be the culprits. There's also the popular "hygiene hypothesis," which posits that growing up in a sparklingclean environment doesn't allow a child's immune system to properly develop. Modern medicine and sanitation have eliminated many infectious diseases but have also limited a child's exposure to immune system-building bacteria, which may ultimately protect a child against allergies, obesity, asthma, inflammatory bowel disease and autoimmune diseases.

The substance in the immune system that's associated with allergies was put in people to defend them against parasites," says Rubin. "There are no parasites in more civilized environments, so it seems that [the substance] may react to pollen or food." Multiple studies in European rural areas have shown that the children raised on farms have a decreased prevalence of hay fever and allergic rhinoconjunctivitis, implying that growing up in a nonsterile environment can help ward off some

Ultimately, Rubin believes little can be definitively done to prevent children from developing allergies. Allergies, he notes, are hereditary -- when one allergic person marries another, their odds of having allergic children rise 90 percent. "If they're destined to develop allergies, they will develop allergies," he says. "Can you prevent

Nature is the Best Kind of Nurture: So Grab Your Kids and Head Outside

NWF Whole Child Report Examines the Health Impacts of an Indoor Childhood and Benefits of Time Outside

Some say it takes a village to raise a child. The National Wildlife Federation contends it takes a backyard, a playground, a park. Washington, DC (Vocus) August 5, 2010

For American parents who want their kids to be fit, focused and feeling good, the first step is out the front or back door. National Wildlife Federation (NWF) has issued a health report, Whole Child: Developing Mind, Body and Spirit through Outdoor Play, which reveals how our kids are on techno overload and it's seriously affecting their physical and mental health.

Reviewed by an independent panel of medical experts, the report begins with a day in the life of the average kid in 2010, immersed in technology. It suggests that Americans wake up to the reality that children today spend only four to seven minutes outside each day in unstructured outdoor play. While their parents spent free time in activities like a neighborhood game of tag, building forts, or climbing trees, the modern child's day includes far more screen time than green time.

"As this report reveals, nature may indeed

rising rates of childhood diabetes, vitamin deficiencies, asthma, and vision problems, all of which can be reduced with adequate outdoor time. The Mind:

While not considered a cure, exposure to natural settings may be widely effective in reducing ADHD symptoms in kids, according to researchers. Sadly, children with ADHD may get even less outdoor time than their peers, as children with attention problems are more often held in for recess due to misbehavior in the classroom. Regular outdoor time can be a scholastic boon to children with attention problems, but research reveals connecting all kids with nature can help them excel academically. According to a March 2010 survey by NWF of nearly 2,000 educators, 78 percent feel students who spend regular time in unstructured outdoor play are better able to concentrate and are more creative and better problem solvers. Their test scores are better too.

The Spirit:

An increasing number of experts are recognizing the role of playing outside in enhancing kids' mental health by helping to better connect them to self, to others and to the natural world. Children who spend

much of their time indoors watching television or playing video games can become isolated and withdrawn, even if they think they are connecting on-line. Nature helps kids feel less stress and interact in positive ways. One study shows kids are more caring when they're around nature.

Understand Doctors Connection between Health and Outdoor Time

The medical profession is starting to take note.
"I would rather write a

prescription for safe, outdoor play for my pediatric patients than see them five years later with depression, anxiety and obesity," says Wendy Kohatsu, MD, with Santa Rosa Family Medicine and assistant clinical professor at the University of California in San Francisco.

Child Whole includes recommendations caregivers, healthcare

providers, local, state and national leaders, and educators so that, together, they can begin changing American children's indoor habits. Recommendations include asking parents to model "un-plugging" from technology and taking the Be Out There pledge to go outside with their children and advising pediatricians to write prescriptions for regular outdoor time for kids. questions relating to job searching techniques, networking skills, resume Res writing and interviewing. The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

Q: I have been applying for jobs for the past 2 years. I now have a gap in my work history. It's obvious on my resume that I have been unemployed for 2 years. I don't want my resume to look like I have not been doing

anything. What should I do? Jane P.

Employers have been more understanding during the past few years regarding unemployment gaps, given the current state of the economy and unemployment. I would suggest that you include in the Work History section of your resume any significant length of time spent doing volunteer activities, self-employment, care-giving, traveling, or any training that would be relevant to the position you are seeking. This section should be similar to the rest of your resume. Include the organizations name, your responsibilities and list of your accomplishments.

Q: I've e-mailed hundreds of resumes and cover letters over the past month and have not received one response from any employer. My background is sales and marketing. What should I do? Baffled

Some employers are waiting to see if you are pro-active and aggressive in pursuing a position with their company. This is especially true if you are seeking a position in sales and marketing. First step is to develop a follow-up action plan and timeline. Allow 5-7 days between communications. Send an e-mail to the employer stating that you are following up regarding the resume you sent and let them know that you are still interested in the position, offer that you are available for any questions or interview at their convenience. Then make a telephone call and try not to leave a voice message. If you have to leave a voice message be prepared to express yourself professionally. Next, mail a hard copy of your resume and letter to the employer. Possibly make another follow-up telephone call. Your communications should always be positive and not overly aggressive in tone or manner. Finally, decide when to stop contacting employers who are not responding. There is a fine line between becoming annoying and aggressive. Continue applying, reaching out and sending your resume to other employers until you find that position.

Q: I am invited to lunch by the company recruiter and the hiring manager for a second interview. Does this mean they want to hire me? Charles

Dear Charles

Employers usually conduct lunch interviews to assess your social and communications skills in a public setting. Treat lunch interviews as a continuation of the employer's screening and interviewing process. Do not relax. Dress professionally and brush-up on your table manners. Do not drink alcohol or order expensive food. Be prepared to ask and respond to questions. Within 24 hours after lunch send a thank you note or letter to the recruiter and hiring manager.

here, they are never returned. From time to time, I will sprinkle in the subject of comfort food or Americana. No one knows for certain which - mad genius or Betsy Ross - created the French fries, but Americans have certainly embraced the yellow strips of sunshine as our own. Just like the sun, I have cut back over the years, because I know that the better the fries the more likely the oil used is fattening. Last week I went to an Angel Game and, as a gesture of my thankfulness, I invited my host to have a beer after the game. He suggested the Gastropub in Monrovia. I have been to The London Pub a few times and I liked the upbeat servers, clean surroundings and (\$9) glass of "J"

Going here reminded me of the question. Why can't everyone, or at least more restaurants, offer the other vegetable, French fries? It has got to be the common and unglamorous label that the fry has been given. I think it goes something like this: the restaurant owner spends hundreds of thousands of dollars on their kitchens and furniture, while the ubiquitous fries is so conventional, so everyday, that they simply can't envision that plain item on the menu after all the toil and expenditure they have invested to give their restaurant presence and swagger. This is not to pick on the Monrovia pub alone, but I was hoping for better fries. You would be amazed at the number of places that don't have fries, or dare I say, Un-American plates of French fries. So, what is the best type of potato to use with a fresh French fry? I went to Vons and asked the produce guy that very question. He said most use a Russet Potato, so I bought one, for less than a buck and I am sure the restaurants pay less. That night I cleared the kitchen and began my experiments. I was getting them up to an acceptable level but something, just something, was absent from these fries. I called my friend Robin Salzer from Robin's and he said.

How's that for an epic OHHH No!!!! Russet is what they cut and freeze; battle? Stickem up while the best potatoes are the Kennebec Potato. All the I salt you. Certainly, restaurants that know their salt in the potato wars use when you take prisoners the Kennebec!!! In' Out uses them, as does Island's. The secret is that they have less starch and water, which gives them more flavor when frying. Have you ever had Belgium fries? They are great but they will set the pocket book back, in fact (\$8) in my most recent order. They are Kennebec fries as well, but twice cooked.

Let's Try Something New:

PURSLANE (Portulaca oleracea)

A versatile, tasty plant found world-wide by Christopher Nyerges

Every Wednesday at the Sierra Madre Farmers Market, Gaytan Farms is there selling produce. Often, they have the unique plant called purslane. Henry Thoreau was fond of eating purslane, and consumed it frequently during his Walden Pond experiment. He wrote: "I learned that a man may use as simple a diet as the animals, and yet retain health and strength. I have made a satisfactory dinner off a dish of purslane which I gathered and boiled. Yet men have come to such a pass that they frequently starve, not from want

of necessities, but for want of luxuries. Purslane is probably one of the most versatile and well-liked weeds commonly available. The plant can be eaten raw, lightly cooked, pickled, fried, in soup and stews, and the seeds can be ground into flour. Though not available at the produce section of supermarkets, it

often appears at farmers markets. In salads, use all the plant but the root. Wash it carefully to remove any dirt and sand adhering to this low-growing plant. Chop the leaves and stems for the salad. The leaves are mild tasting and slightly slimy. The thick, succulent stems are juicy and "crunchy." A salad of only purslane, with seasoning and chopped onions, is very acceptable fare. The stems are great to quench your thirst when hiking along a dusty trail.

As spinach, the plant should be lightly cooked in a small amount of water, seasoned, and eaten. Gently fried, either alone or with onions, eggs, etc., it's a

The chopped stem and leaves also mix well in soup, stews, and egg omelettes.

Purslane is not only good and versatile, it's good for you! Dried purslane has been found to be about 30 percent albuminoids (protein) and 35 percent carbohydrates. 100 grams of purslane contains 2500 I.U. of vitamin A when cooked; .10 mg. of riboflavin and .06 cooked; 103 mg. of calcium raw and 86 cooked; 25 mg. of vitamin C raw and 12 mg. cooked; 21 calories; and small amounts of phosphorus, niacin,

In 1986, purslane was identified as being the richest leafy-plant source of omega-3 fatty acids, a substance that helps reduce the body's cholesterol levels and reduces the risk of heart attack. This discovery was made by Norman Salem, Jr., a lipid biochemist (with the National Institute on Alcohol Abuse and Alcoholism in Bethesda, Maryland).

Interestingly, rather than suggest people begin including purslane in their diets, Salem and his collaborator, Artemis P. Simopoulos (of the American Association for World Health in Washington, D.C.) studied range-fed chickens at a Greek farm which fed on wild purslane. The yolk from one large-sized egg from purslane-fed chickens contained about 300

mg. of omega-3 fatty acids (17.87 mg. per gram), the

same amount contained in a standard fish oil capsule, and 10 times more than what is found in a typical supermarket egg (1.74 mg. per gram). Salem and Simopoulos' findings about the eggs was published in the November 16, 1989 New

England Journal of Medicine. RECOGNIZING

PURSLANE Purslane is a low-growing herb, fleshy whose outstretched, sprawling, prostrate stems are from three to twelve inches long. The stems are tinted red, roundshaped, and very succulent.

The leaves are succulent and paddle-shaped. The tiny little flowers are yellow.

Introduced from Tropical America, purslane was in the United States before colonial times. Purslane is believed to have originated from India, from which it gradually spread throughout the world. Here in Southern California, purslane is not one of the early spring weeds. Rather, we find it sprouting up in the early summer, and it seems to prefer rose beds, fields, and even hard-packed soils.

If you're still not sure what purslane looks like, go to any nursery. Where the herbicides are sold, there is usually a chart with photos of all the "noxious weeds" that must be eradicated, with the names of those herbicides which will kill them. Invariably, the wonderful purslane is found on such charts. Why? Because it sometimes grows in rose beds. As Walter Kelly's Pogo reminds us: "We have met the enemy, and

RECIPES: Verdolago con Queso

This is a simple recipe. Collect one quart of tender purslane, including the stems. Once washed, gently boil for about two minutes. Drain the water, and chop the purslane into smaller pieces. Return the purslane to a skillet, and shred a half cup of Monterey jack cheese over the greens. Warm on a low flame until the cheese is melted. Serves two. Succulent Sunshine

Clean one quart of purslane stems and leaves. Cut into one-inch pieces and place in clean jars with lids. Add three sliced garlic cloves and 10 peppercorns. Pour one quart of raw apple cider vinegar over the purslane. You can also use old pickle juice, or jalapeno pepper juice). Keep this in the refrigerator at least two weeks before using.
Serve as a side dish with omelettes, sandwiches, and

The Shepherd Sings at Noon

This sandwich recipe was sent to me from Greg Kirshner of Fullerton, Calif. It's very simple. Using toasted or untoasted rye bread, add a few slices of good ham. Instead of pickles, add a small handful of fresh ourslane stems to the sandwich. Add a mustard and

Other - Chopped purslane can be mixed into your egg omelettes, added to lettuce salads, and used as the main salad ingredient.

The Stealthing of Sierra Madre

seconds, the shadow passed and we could see one of our country's magnificent flying machines. The sight was quite moving but the thought that it was upon us before we even knew it, was unnerving. Not a sound and bam...there it was. Well, in recent weeks we have learned that Sierra Madre experienced something quite similar. We were suddenly covered by a dark cloud that we didn't see coming and by the time we recognized it, many were shocked and disappointed. It was like the plot of a B rated movie. The town had been 'stealthed'.

The very organized 'protest' movement that collected signatures in an attempt to defeat the proposed water rate fee hike was nothing more than political campaign that few people recognized. Many of those who were recruited to submit their 'protest' were not aware of anything more than the misinformation' that they were given. They were not aware that the 'organizers' of this 'protest' were actually a group of residents with a craving for dissent regardless of the issue. Involved and/or supporting this organized effort was every single candidate (except Bill Tice), that lost the recent election and their 'slate mailing buddy' who sits on the current city council. And, based upon the pronouncements of our City Clerk, it even included her, an involvement that many call inappropriate and perhaps illegal because of her responsibility to tally the protest documents.

Yet, on the other side of the coin, those who did not object to the fee increase, were not aware that there was a campaign against it going on. Yes, the stealthing of Sierra Madre was done very efficiently, designed not to draw attention to it. (Stealthing.... new word, not from Sarah Palin but from me. Stealthing as in flying under the radar like a stealth

Using the tried and tested dirty tactics method of instilling fear by suggesting that people would be paying unconscionable rates for water, signatures were collected very often, unscrupulously. Example: When one rate payer (business) signed a protest based upon a dispute with the city that has been unresolved for years, they noted an objection not to the increase but to the unresolved issue on the form. Within minutes, the signature gatherer could be heard soliciting support for the protest by invoking the name of the previous signer without disclosing the real reasons for gaining that

signature. The business owner was quite upset. Now, I do not make this up. I spent a considerable amount of time reviewing the 'protests'. So, when I saw the preprinted letters soliciting protests that were distributed (one from Former Councilman Don Watts - the only letter that had a name on it, the others were unsigned. It was also the only letter that had the correct amount of the proposed

Several years ago as I was increase.), I was shocked. One letter that was mailed to residents actually said, in bold letters, "If this rate hike goes through, in five years your bill will be 140% of what it is now", implying that the rate was going to increase by 140%, which is simply not

true. You do the math: If your current bill is: \$50.00 - A 140% increase will make it (in 5 years) \$120.00

The Truth: If your current bill is: the most your bill could increase is 37% (in the highest category) thus making your maximum bill in 5 years \$68.50.

There is a big difference in thinking that your bill is going to jump to \$120.00 compared to it possibly jumping to \$68.50. Big Difference. Big Lies.

What was even more egregious is that these letters were sent selectively to residents and property owners that the 'organizers' obviously thought they could fool, and they went to extraordinary lengths to gather signatures from owners who don't even live in town. So while many thought they were participating in a local, door to door protest effort, it was much more than that.

You also had, and this is where it really gets strange, the 'organizers' of the protest, an otherwise an anti-development crowd, using the help of the most controversial developers in town -the owners of 1 Carter. Yes it is true, when those who organized the protest bragged about the signatures they had collected against the rate hike, they were proud to have the support of the owner of 1 Carter, which signed 30 protests, giving them more power than any other rate payer or land owner in town. I guess we won't have any more protests about the size, shape or burden that 1 Carter will put on the city from them since they are now best buddies.

Fortunately, when the final tally was done, the stealth campaign didn't fly. This time. However, if we aren't careful, at the very next opportunity, there will be another such disingenuous, dishonest and deceptive attempt to gain the public's support.

I know that the intent of many people who signed the protest was not rooted in the 'sore loser' syndrome or the 'I must protest everything' syndrome. Many were just led by people they trusted but really didn't know. And perhaps that is the problem.

In Sierra Madre, which sometimes has a reputation that it does not deserve due to the shenanigans (their favorite word) of those who have an insatiable appetite for chaos, we have to all take more personal responsibility for learning what is really going on in town. We have to actually open our mail, read it and question anything that the author refuses to put their name on. Dissent is a valuable tool in making sure all sides of an issue are heard, but as residents, we have to recognize what the real issues are and draw our conclusions based upon fact.

There is one good thing that came out of the stealthing of the city. City officials recognized that it is an absolute necessity to improve the communications between the public and City Hall. The other good thing, I hope, is that we now know to watch out for that dark shadow when it flies over

Last week I wrote about against one another. Less than three percent of the wealthiest Americans (I chose that number because

it represents those who'd benefit from the \$680 billion extension of the Bush tax cuts) feel they can fend off intruders at their banquet if we're kept fighting amongst ourselves for the crumbs allowed to fall from the table.

As Barack Obama put it at the 2004 Democratic Convention; "It's not the Red States, it's not the Blue States, it's the United States of America." On a more somber occasion, 26th District Democratic congressional candidate Russ Warner noted in a Memorial Day address that regardless of the backgrounds and ethnicities of the fallen, crosses marking their graves are all the same white color, and they all fought for the same red, white and blue.

The senate bill contained input from both sides of the aisle, and was endorsed by the U.S. Chamber of Commerce. It eliminated the capital gains tax on small business investment and created a lending fund to be administered through community banks. Leadership agreed to the consideration of at least three Republican amendments. Here's something everybody could come together and agree on,

Maybe not. Republicans refused to allow passage if they couldn't debate amendments dealing with nuclear funding, Bush's millionaires' tax cuts and brown hordes encroaching our southern border. efforts to keep us divided controversial. You'd think this would be a real come-together moment, but some Republicans decided instead to turn their backs and let the rescue workers suffer -

including our own Rep. David Dreier. I wanted to know the reason, so I put in a call to the congressman's office. I was told not to doubt Rep. Dreier's commitment to our 9/11 heroes, because he supported the original aid bill - just not this subsequent version. Did I miss something? When did this original bill come out? Unfortunately for them, that system isn't working like it used to. Leaders, like the new Prime Minister of England, are now having to tell their people to expect decades of austerity to pay for what has been put in place. There simply aren't enough tax revenues collected to pay for what voters. The result is sluggish growth, declining living standards and now social unrest.

The other model is the one being offered by many of the emerging economies of the world. Workers are being allowed greater flexibility in where they can work, are being allowed greater latitude in negotiating for their rate of pay, and now finally being allowed greater freedom in where they can spend their wages. Workers get to spend and enjoy the fruits of their labor.

America is at a fork in the road. Historically, we have believed in the freedom model. But our current president has made no bones about his desire to fundamentally transform America. The healthcare bill was just an opening salvo in this effort. We can debate the financial implications of the bill later, but if it is fully implemented, at its heart it shifts control over healthcare decisions from the patient Financial reform bill was the second The government has now usurped the power to decide which company presidents can be fired, abrogated and who will get a student

But the most potentially reaching battle is

the overall budget battle. The current administration has not just presided over, it has actively caused, the largest deficit we have ever seen with even more red ink planned. This isn't just an issue of financial prudence. These deficits are being caused to an ever-increasing number of constituencies. Every one of these promises tends to be embraced by its recipient once it goes into affect,

If we elect leaders who maintain or lower taxes, we will be taking back control over our lives. In Thomas Jefferson's immortal words, this is about the pursuit of happiness. Who is going to decide what we can pursue - us or them? Choose well America.

For many of us, our inner workings are much like a runaway train. Agitation, worry, anger, isolation, fatigue and anxiety are the principal actors on our inner stage, a veritable improv. Here is one to utilize this week: When you first get into your car, the initial response might be to turn on the radio. Instead, take a few breaths, be aware of yourself and enjoy the quiet. Gently resist the urge to reach for the radio as you go about your business, instead breathing and being awake to what your are doing, feeling and thinking.

Garlic Shrimp Linguini **INGREDIENTS:**

- 1 pound uncooked linguine
- 1 tablespoon butter 3 tablespoons white wine
- 2 teaspoons grated Parmesan cheese
- 3 cloves garlic, minced
- 1 teaspoon chopped fresh parsley salt and pepper to taste
- 1 pound medium shrimp, peeled and deveined

DIRECTIONS:

Bring a large pot of lightly salted water to a boil. Add pasta and cook for 8 to 10 minutes or until al dente; drain.

In a medium saucepan, melt butter over medium low heat; add wine, cheese, garlic, parsley and salt and pepper to taste. Simmer over low heat for 3 to 5 minutes, stirring frequently.

Increase heat to medium high and add shrimp to skillet; cook for about 3 to 4 minutes or until shrimp begins to turn pink. Do not overcook.

Divide pasta into portions and spoon sauce on top; garnish with Parmesan cheese and fresh parsley, if desired.

And finally, don't focus on the asking price alone. Location in a declining neighborhood or extreme maintenance and repair issues will eclipse any perceived value in a low price. Great homes are out there at bargain prices, but let an agent guide you through potential pitfalls.




