## Sierra Madre Individual **Preparedness Project Enters Final** Phase and Your **Participation is** Needed!



Research has shown that even in the wake of 9/11 and recent natural disasters, there has been little increase in the number of citizens who have a "preparedness plan" in place to cope with a crisis or major state of emergency.

Donna Cayson, a former Sierra Madre Police Department Sergeant and graduate of the Naval Postgraduate School, is working with FEMA's National Preparedness Directorate in Washington D.C. Donna has developed a pilot project, Sierra Madre Individual Preparedness Project, to assess, encourage and increase individual and family preparedness through an all-inclusive, collaborative, community-based approach and Sierra Madre has been selected as the beta site. If successful, the "template" created in Sierra Madre will be available for use in communities nationwide.

Phase 1 of this project was a pre-survey to determine the current state of preparedness among the residents of Sierra Madre and of those who work in the city. A total of 647 residents participated in the anonymous pre-survey, thank

Phase 2 of the project consisted of preparedness education and training by all stakeholder groups from May through August along with hosting the Sierra Madre Family Preparedness Festival on September 11th in Memorial Park.

To measure the project's success, phase 3 of the project is currently underway and consists of a post-survey of Sierra Madre residents in order to determine the effectiveness of the all-inclusive, collaborative, community-based approach to increasing individual and family preparedness.

The success of this project will, in part, depend on how many people agree to participate in the post-survey. We ask that you do so by taking a minute to complete this anonymous survey. ## The BUCK Turns 50!

On Tuesday, October 19th, the Sierra Madre Chamber of Commerce will perform the ceremonial ribbon cutting associated with new businesses, but in this case, the event will be celebrating longevity. The Buccaneer Lounge will be celebrating fifty years in business. The Buc, as it is known locally, originally opened in the 1940's as Club 60, taking its name from the address of the establishment at the time.

The owner at that time, Roger Miller, changed the name to The Buccaneer Lounge in 1960, and moved it to its current location at 70 W. Sierra Madre Blvd. in 1984. For twenty years now, the Fraser family has owned the business. Brian, who was also a volunteer firefighter in town, passed away in 1998 and the bar is now run by his wife, Gerri. Well known artist Frank Bowers, whose murals can be found at several locations in Southern California, created the 30 foot long mural that depicts pirate scenes and provides the backdrop behind the bar at the Buccaneer. Several other Bowers pirate paintings adorn the walls at the Buc. Legend has it that Bowers, who also painted sets for *Gone With the Wind*, did this work to pay off his bar tabs.

The Buccaneer, with it's "Cheerslike" atmosphere, is a favorite watering hole for locals and non-locals alike.

The ribbon-cutting and mixer are scheduled for 5:30 to 7pm on the 19th. Admission is \$7 for Chamber members and \$15 for non-members which will include a complimentary buffet, as well as your choice of two draft beers, two glasses of wine, or two well drinks.





JOE GRIPPI - 1925-2010

Joe Grippi, 85, passed away peacefully at his home in Sierra Madre on October 7, surrounded by his loving family.

Born on July 10, 1925, to Cosma and Joseph Grippi at the family home North Mountain Trail, Joe lived most of his life in Sierra Madre. He was the first child to be baptized in St. Rita's RCC on North Baldwin Avenue.



After graduating from John Muir High School in 1942, Joe enlisted in the U.S. Navy, serving on a destroyer in the South Pacific, and training gunners at the Navy center in Dahlgren, VA. After an honorable discharge in 1946, he returned to Sierra Madre to raise a family.

Joe worked for the U.S. Post Office before establishing a career as a local independent distributor of the LA Times. He was deeply committed to his hometown throughout his life, serving for nine years as chairman of the City's Parks and Recreation Commission, and playing an integral role in the development of the Recreation Center at Sierra Vista Park, Dapper Field, and a Bailey Canyon Wilderness Park protected area. Joe was also a longtime member of the Sierra Madre Kiwanis Club, serving as president in 1964.

Many will remember Joe as a lifelong baseball player and ardent fan. His love of the game led him to serve as a youth baseball coach throughout the 1960s and 70s.

After retiring from the LA times, Joe enjoyed reading, gardening, cooking, traveling, concert-going, and attending UCLA football and Dodger baseball games.

Joe was preceded in death by sisters Margie and Annie, and brothers Joseph and John. He is survived by his wife of 32 years, Barbara; daughters Linda Grippi, Margie Lorusso, Beth Brady, and son Vince Grippi; seven grandchildren; and brother David Groth.

A High Mass Funeral was held on October 13 at the Church of the Ascension in Sierra Madre, followed by internment at Sierra Madre Pioneer Cemetery. Memorial donations may be made to the Church of the Ascension, 25 E. Laurel Ave., Sierra Madre, CA, 91024, in care of the Very Reverend Michael Bamberger, to honor Rev. Bamberger's longtime service to the residents of Sierra Madre.



## Metrolink to Integrate Positive **Train Control System**



By Dean Lee

Metrolink's Board of Directors authorized, Oct. 1, a \$120 million contract to Parsons Transportation Group integrating a Positive Train Control, PTC, system throughout Metrolink's 512 miles of tracks.

The announcement comes less than a month after the second anniversary of a Metrolink crash September 2008, in Chatsworth, that killed 25 people and injured 135 more.

According to Metro, they are the nation's first rail operator to get approval from the Federal Railroad Administration on a PTC implementation plan.

The train control technology monitors and controls a train's movements remotely avoiding train-to-train collisions. It can also monitor unauthorized train movement into a workzone, movement of a train through a switch left in the wrong position and trains exceeding authorized speeds according to Metro.

A week after the Chatsworth tragedy, the Los Angeles County Metropolitan Transportation Authority developed a comprehensive County Commuter/Freight Rail Master County Plan that, among other things, looked at implementing PTC.

The system consists of onboard computers, display screens, GPS tracking and radios on 57 cab cars and 52 locomotives as well as a stop enforcement system at 476 LED wayside signals.

Six-county specialized communication systems will link the wayside signals, trains and the centralized dispatch office replacing the current


## General Plan Hearing Oct. 26

(Oct. 12, 2010)— Construction to replace Santa Anita's synthetic main track with a natural dirt surface began on Monday and it is anticipated work on the project will continue into early December. Horses are projected to return to training over the one mile oval on Dec. 6, roughly three weeks in advance of Santa Anita's traditional winter/spring



Another bit of prescience came 150 years earlier, when President Lincoln wrote in 1864, corporations have been enthroned and an era of corruption in high places will follow . . . until all wealth is aggregated in a few hands and the Republic is destroyed."

The Court itself dealt with the issue on numerous occasions, notably in 2000 when, under Chief Justice William Rehnquist, it ruled the State of Michigan's restrictions on corporate political donations "... are justified by a compelling state interest: preventing corruption or the appearance of corruption in the political arena by reducing the threat that huge corporate treasuries, which are amassed with the aid of favorable state laws and have little or no correlation to the public's support for the corporation's political ideas, will be used to influence unfairly election outcomes."

Five years later, Rehnquist was replaced by one of his former law clerks, who promised during his confirmation hearings to abstain from "judicial activism" and instead act like "an umpire calling balls and strikes".

Chief Justice John Roberts broke that promise with the Citizens United case. Rather than ruling on the narrow issue of banning the airing of an anti - Hillary Clinton "documentary" within thirty days of an election, he took the opportunity to overturn a hundred years of precedent protecting the integrity of our elections by equating corporations with "persons" and money with "speech".

There was consolation that Congress would be able to plug some loopholes, such as ensuring no matter how much money is poured into a campaign, at least We the People should be entitled to know where the money's coming from. "Independent expenditure" committees (the preferred vehicle for corporate largesse) would become as transparent as Political Action Committees under the DISCLOSE Act. Not surprisingly, Senate Republicans made sure that Act would never come up for a vote.

The U.S. Chamber of Commerce couldn't be to block the efforts of those who are. happier, as suspicions of illegal foreign funding of U.S. elections, courtesy of the Chamber, won't go away. At first they tried to divert attention to the relatively small amounts gathered in their "AmCham" affiliates overseas, but now we know of the huge sums solicited and going directly into the very 501(c)(6) entity used to fund the \$75-80 million in attack ads this campaign cycle (about twice what was spent two years ago).

How do they keep foreign and domestic money separate? "We are not obligated to discuss our internal procedures." How do we know foreign money isn't going into attack ads? Karl Rove's groups, according to limited disclosed records, show contributions from individuals and corporate interests able to write checks for a few hundred thousand to over a million dollars.

> It's not surprising that the ads being financed aren't extolling the backgrounds, records of accomplishment, or ideas of the preferred candidates. Nor will you find any promoting notions of "compromise" or a more cooperative, productive environment in Washington. Rather, it's the demonizing of opponents with false charges - secure in the knowledge the authors and funders of those ads will never be held

## Looking Chosts of the Future: First Giant Structures of the Universe

Astronomers using the South Pole Telescope report that they have discovered the most massive galaxy cluster yet seen, at a distance of 7 billion light-years. The cluster (designated SPT-CL J0546-5345) weighs in at around 800 trillion Suns, and holds

hundreds of galaxies.

This galaxy cluster wins the heavyweight title. It's among the most massive clusters ever found at this distance," said Mark Brodwin, a Smithsonian astronomer at the Harvard-Smithsonian Center for Astrophysics. Brodwin is first author on the paper announcing the discovery, which appeared in the Astrophysical


Located in the southern constellation Pictor (the Painter), the cluster has a redshift of z=1.07. (Redshift measures how light from a distant object has been stretched by the universe's expansion.) This puts it at a distance of about 7 billion light-years—meaning that we see it as it appeared 7 billion years ago, when the universe was half as old as now and our solar system didn't exist yet.

Even at that young age, the cluster was almost as massive as the nearby Coma cluster. Since then, it should have grown about four times larger. If we could see it as it appears today, it would be one

of the most massive galaxy clusters in the universe.

"This cluster is full of 'old' galaxies, meaning that it had to come together very early in the universe's history—within the first two billion years," stated Brodwin.

Galaxy clusters like this can be used to study how dark matter and dark energy influenced the growth of cosmic structures. Long ago, the universe was smaller and more compact, so gravity had a greater influence. As the universe expanded at an accelerating rate due to dark energy, it grew more diffuse. Dark energy now



dominates over the pull of gravity and chokes off the formation of new galaxy clusters.

Brodwin and his colleagues spotted their quarry in the first 200 square degrees of data collected from the new South Pole Telescope. The SPT is currently completing its pioneering millimeter-wave

survey of a huge swath of sky covering 2,500 square degrees.

In their search for giant galaxy clusters, the team uses the Sunyaev-Zel'dovich effect—a small distortion of the cosmic microwave background (a pervasive all-sky glow left over from the Big Bang). Such distortions are created as background radiation passes through a large galaxy cluster.

Surveying for this effect has significant advantages over other search techniques. It works just as well for very distant clusters as for nearby clusters, which allows astronomers to find very rare, distant, massive clusters. Further, it provides accurate measurements of the masses of these clusters, which are crucial to unraveling the nature

Once this distant cluster was found, the team studied it with the Infrared Array Camera on the Spitzer Space Telescope to pinpoint galaxies within the cluster. Detailed observations of the galaxies' speeds with the Magellan telescopes in Chile proved that the galaxy cluster was a heavyweight.

As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

## Functional vs Chronological Resume

Q: A friend said that I should write a functional resume instead of a chronological resume because I have over 15 year's professional accounting experience. I am currently seeking a Senior Accountant position with an accounting firm. Which style of resume should I use? Malik

Dear Malik:

If you have extensive years of experience with one company and in the same professional field then the functional resume is most likely the right format for you to use. A functional resume is an acceptable format to use if you have: gaps in your work history, over 10 years experience with one company or are changing careers or industry. A functional resume is not easy to write and I have seen numerous versions. This type of resume could also throw up a "red flag" for some employers who feel that functional resumes are written to hide job seekers inadequacies. A well-written functional resume should highlight only those transferable skills and accomplishments that relate to the new position that you are currently seeking. This is an excellent resume format to highlight your areas of specialization in accounting. The resume layout should include the following: A dynamic summary statement at the top of your resume that will capture the employer's attention. Next, headings for each area of specialization (i.e. finance, auditing, customer service). Each heading should highlight your quantitative and qualitative accomplishments. Then chronologically list your work history. Only list the company name, location and dates of employment. Include a heading for skills that relate to your area of specialty. Add your educational history and other related headings.

Recruiters and hiring managers receive thousands of resumes daily and take approximately 10 seconds to review each resume. The functional resume usually requires an employer to spend more than 10 seconds to review. Most employers will not take that time. You as a job seeker want to ensure that your resume is always reviewed for consideration. Therefore, I strongly suggest that you consider writing a chronological formatted resume. This type of resume is currently preferred by employers and recruiters and can easily be reviewed by them within 10 seconds. This format is great if: you are looking for employment in the same field, you have professionally advanced, your skills and work experiences are consistent. The chronological resume can easily be converted by you to an electronic resume and uploaded into employer databases. Finally, only you can decide which resume format best represents you, your accomplishments and skills.


## KATIE Tse .....This and That The Eye Of The Beholder







### Ingredients:

- 1 bottle Prosecco
- 1 1/2 cups fresh blood orange juice
- 1 tablespoon super-fine granulated sugar 2 tablespoons orange liqueur
- (recommended: Grand Marnier)

#### Directions:

Chill bottle of Prosecco. Combine fresh blood orange juice with sugar and orange liqueur in a large measuring cup and stir to combine. Cover and refrigerate until chilled. To serve, pour into the bottom of Champagne glasses and slowly top-off with ice-cold Prosecco.

### 2. Pumpkin Waffles w/Trail Mix Topping Ingredients:

### For the Waffles:

1 small sugar pie pumpkin (2 to 3 pounds)

- 2 1/4 cups all-purpose flour
- 1 teaspoon baking powder
- 1/2 teaspoon baking soda 1 teaspoon salt
- 2 teaspoons pumpkin-pie spice 1/2 cup packed light brown sugar
- 2 large eggs, separated 1/4 cup plain Greek yogurt
- 1 cup whole milk 4 tablespoons unsalted butter, melted

## For the Topping:

1/4 cup slivered almonds

1/4 cup raw sunflower seeds 1 1/2 tablespoons pure maple syrup

Coarse salt

1/4 cup dried cherries or cranberries Whipped cream, for serving (optional)

Prep the pumpkin: Preheat the oven to 350 degrees F. Remove the stem and cut the pumpkin into quarters with a serrated knife. Scrape the seeds and pulp into a strainer;

Roast the pumpkin: Put the wedges on a baking sheet and cover tightly with foil; bake until the flesh is tender, about 1 hour, 30 minutes. Remove the foil and let cool.

Puree and strain: Scoop the pumpkin flesh into a food processor and puree until smooth. Transfer to a sieve set over a bowl to drain the excess liquid, about 1 hour.

## Ingredients:

- 1 3/4 pounds ground pork (not lean)
- 1 small onion, grated and squeezed dry 4 cloves garlic, finely grated 2 tablespoons minced fresh sage

- 1 tablespoon paprika
- 1/2 teaspoon ground allspice 1/2 teaspoon ground coriander

### 2 tablespoons extra-virgin olive oil Directions:

Mix the pork, onion, garlic, sage, thyme, syrup, paprika, allspice, coriander, cayenne, 2 1/2 teaspoons salt and 1/2 teaspoon black pepper with your hands. Form into 18 patties, 2 inches wide and 1/2 inch thick; put on a foil-lined baking sheet, cover and chill overnight.

The next day, preheat the oven to 350 degrees F. Heat 1 tablespoon olive oil in a skillet over medium-high heat. Cook half of the patties, turning once, until golden, about 5 minutes. Transfer to a baking sheet. Wipe out the skillet. Repeat with the remaining 1 tablespoon oil and patties, then transfer the patties to the oven to finish cooking, 5 to 10 minutes.

## PASADENA'S RONALD McDONALD HOUSE

Chris is taking a few week's vacation. Please enjoy a few of her favorites while she's away.

With ten bedrooms, seven and a half bathrooms, and two stocked pantries, families with critically ill children spend an average of two weeks in the caring confines of these two homes. While the foundation charges \$15 a night for those who can pay, (no one is turned away for inability to pay), it costs about \$144 a night to house these families who travel have from for flying states and countries. who travel here from far flung states and countries, as well as within California.

Grand, covered porches which provided cool, shaded seating for the original residents, now provide respite to these families in crisis with newly completed cedar Adirondack furniture built by an ambitious Eagle Scout. An enormous living room in one of the homes creates a welcoming semblance of home with several comfortable seating areas.

The elegant dining room seats over 20 now, albeit Ronald Mc Donald on one of the porches. in a more utilitarian setting. Laundry facilities in both homes are a blessing to parents who have little

energy to feed themselves, much less search out a laundromat at odd hours. These days, internet and computer access is very important, allowing parents to keep in touch with loved ones as well as for some to telecommute while remaining close to their children.

some burgers on the grill, peels back a bit of the enormous burden of what these families are undertaking here.

Refuge is truly the word that defines these spaces. Here they can day. Or donate as little as \$50 to be recognized as the house sponsor clean up and rest up near their child's hospital. But they can also of the day.

Two beautiful Craftsman homes at 763 share experiences with other families in similar circumstances, one most of us pray never to face ourselves. Surprisingly though, only 8% of the budget comes from that source.

Little bits of normalcy, like grilling donated or prepared and delivered yourself for 6:00 dinner nightly. They have projects organized for volunteer groups to finish in just a

The spacious living room gives families a place to unwind a bit and interact with others facing the same challenges.

It used to be too common a story: you're excited about signing the paperwork, shaking hands, and grabbing the keys to your new home. But the day before closing, the lender advises that your closing fees are several hundred dollars more than their Good Faith Estimate listed. Suddenly, your excitement turns to pressure to just pay it and close the deal.

Now those days are over, thanks to the Mortgage Disclosure Improvement Act (MDIA). What was once the Truth In Lending Act has been rewritten with new rules to help consumers understand the loan costs and alert borrowers to changes in fees well in advance

Now the lender must provide their Good Faith Estimate within three days of receiving the borrowers' application, and closing cannot occur until the buyer has seven days to review the disclosure. If the final APR (annual percentage rate) differs more than 0.125% from the original quote, a new disclosure must be provided, granting the borrower the right of rescission.

This relieves the pressure that buyers once felt to agree to pay higher fees and rates at the very last minute. As always, borrowers can review the final documents one day before closing, providing an excellent opportunity for you to review all the figures with your real estate agent and to ask any lingering questions before you make it

## On The Course With Bobby Eldridge

### PUSHING YOUR IRONS TO THE RIGHT



I am going to be straight with you, pushing your iron shots to the right is a pretty tough mistake to fix. Allow me to explain myself. The golf ball sits on the ground and with the technology that has come along in the past 20 years, the superintendents can mow the fairways closer than the putting greens I grew up on.

What does that have to do with missing irons shots to the right? For those of you that struggle with this mistake, the golf club swings too much from the inside to the outside in the downswing. When the golf club swings in that direction the club BOTTOMS out behind the golf ball. The direction the club is swinging in the downswing is to the right of the green.

Oh, there is one more challenge. When the golf club swings too much from inside to outside, the bottom of the arc reaches the ground behind the golf ball and then it begins to swing back up. You never really find the bottom of the ball. You will either top it or hit it real thin. Y es, you add insult to injury. Not only does it go right but it goes short-right.

Of course there are a number of ways to correct it, but I am going to give you something to work on and I know it will help. After you aim correctly (not left) I want you to look at the bunker or edge of the LEFT side of the green. Not the middle of the green, not the pin but the left of the green.

Now you are aiming at the center of the green but you are LOOKING a little bit left of the green. I want you to make sure you swing to the left side of the green in the downswing. Not a lot of thought just think left. This is huge: DON'T HOOK IT LEFT, but simply swing and turn through to the


