The owner of Sierra Mader's very own Cheers, The Buccaneer Lounge, had a packed house as it celebrated its' 50th anniversary Tuesday night. Fondly known as 'The Buc', the bar has become an institution in the city, drawing patrons from every legal age, educational, political and economic spectrum on a nightly basis. In fact, the 50th Anniversary Celebration, which began shortly before the special council meeting on water rates, drew a larger crowd.

Current owner Gerri Fraser and her family have owned the business for twenty years. Gerri's husband Brian, who was also a SM Volunteer Firefighter, passed away in 1998 and she, with the help and support of her daughters Jennifer Higdon and Robyn Tapert keep the doors open.



Special Water Rate Hearing Held Supporters and Opponents of Proprosed Rate Hike Speak Up

In keeping with the Mayor's promise to better educate residents on the elements of the proposed water rate increase, a special council meeting/ public hearing was held on October 19th.

Residents on both sides of the issue were in attendance, however the council chambers were not filled to capacity, as generally is the case with truly controversial matters in Sierra Madre.

Although opponents of the proposed hike of approximately \$8 per month failed to gather sufficient signatures to block the increase via Prop 218, Mayor Mosca and the council agreed to

postpone any action until residents were given the opportunity to review the proposed hike. Since that time, city staff have availed themselves to the community through a series of informational presentations and water tours. Nevertheless, those opposed, such as former Mayor Kurt Zimmerman, the city's obligation for a number continue to challenge the process and the increase.

During Tuesday's meeting, City Attorney Sandra Levin addressed accusations that the Prop 218 process had not been conducted properly. The Proposition, passed 1996, gives citizens the opportunity to vote down, among other things, rate increases for water.

questioned is the city's current maintenance of the system. water bond indebtedness. A part of the proposed increase will keep the city from defaulting on its bond obligations and help the city maintain the required reserves which were a condition of the bonds when they were granted.

The bonds in question have been of years. In 1998, a Water Revenue Refunding Bond was issued for \$4.5 million dollars. In 2003, \$12.6 million in parity bonds were issued. Those bonds, along with a loan from the San Gabriel Valley Municipal Water District of \$1.5 million dollars, have allowed the city to meet matching fund requirements for state and federal One aspect of the proposed rate grants that paid for projects such

Several residents who support the council's proposed actions also spoke, encouraging personal responsibility for conserving water resources as a way to ease the 'pinch' should a rate increase be implemented. At least one such speaker, however, was subjected to interruptions from the back of the room by opponents.
The council directed staff to consider

a different distribution of the increased costs over a period of time in an effort to meet the needs of the city's water system and soften the blow to ratepayers. A report is due back to the council at the next meeting.







initiatives, redistricting, term limits, and state budgets. She has appeared as an election-law authority on NBC, ABC and the Fox News Network as well as on NPR, KNX and KFPK.



City Council Takes Stance on **Propositions**

By Dean Lee

Councilmember Terry Tornek said he thought it was counter intuitive that the city's water and power department would take a stance opposing proposition 23, suspending implementation of air pollution control law (AB 32) requiring major sources of emissions to report and reduce greenhouse gas emissions.

Tornek made the comment earlier this month before the council voted unanimously opposing Proposition 23. He said he fully supported the city's position although found the department's stance odd. "If you didn't have to deal

with AB 32, you would in fact have a much easier life," he said. "The PWP would be liberated from some of the difficult goals that you were confronted with in terms of buying cleaner power and a variety of other targets that we have established."

Tornek said he found the state initiative "fraud with hypocrisy." He further said that because the proposition uses a goal of 5.5 percent unemployment before reimplementation of AB 32, it

suspends it indefinitely. Gureharan Bawa, Pasadena Water and Power Assistant General Manager, said Pasadena has one of the Manager, highest carbon footprints in the state. He explained that his department is now committed to reducing that carbon footprint.

"It would seem that a path that we have under your [the council] direction, committed to pursue, this regulation would take away the regulatory requirement," Bawa said. "It would also discourage a lot of new technologies, it would discourage new businesses which are bringing a lot of capital into the state and potentially new jobs.

The council also voted unanimously in favor of Proposition 22 which prohibits the state from taking funds used for transportation or local government projects and services.

"The state has continued to identify means of taking local revenues and shifting them for the state's proposes, Assistant City Manager Steve Mermell said. "Proposition 22 would close a number of these loopholes and prohibit the state from taking, borrowing or redirecting any local taxpayer revenues that are dedicated to public safety, transportation, emergency response and vital local government services."

Arcadia Fire Department Earns 2009 Life Safety Achievement Award

The Arcadia Fire Department has been presented with a Life Safety Achievement Award for the year of 2009 by the Residential Fire Safety Institute (RFSI) in partnership with the Grinnell Mutual Reinsurance Company. The award was announced by Alan Shuman, President of the National Association of State Fire Marshals (NAFSM), RFSI's parent organization.

For 19 years, the Life Safety Achievement Award has recognized local fire prevention efforts that have contributed to reducing the number of lives lost in residential fires. The Arcadia Fire Department qualified for this award in year 2009 because it recorded zero fire deaths in structures or a reduction by at least 10% during the year. In addition, the department was able to demonstrate the existence of an active and effective fire prevention program and a clear commitment to reducing the number of fires in the homes in their community.

Although residential fires in the U.S. account for only 20 percent of all fires, they result in 80 percent of all fire deaths. The RFSI is committed to reducing that number.

"Experience tells us that fire prevention activity and public education can significantly reduce life and property loss from residential fires", the Residential Fire Safety Institute said. "Prevention and education are very cost effective compared to the traditional approach of relying on fire suppression. The Life Safety Achievement Award recognizes fire departments for their fire prevention efforts and encourages them to continually improve those efforts."

The RFSI is a public interest group whose mission is to reduce residential fire deaths and injuries. The RFSI advocates the use of residential fire sprinklers, smoke alarms, carbon monoxide detectors and teaching people fire-safe behavior. The RFSI assists fire departments with implementing residential sprinkler/smoke alarm programs on a local basis. The RFSI's partners include the United States Fire Administration, the National Association of State Fire Marshals and private industry/ associations with an interest in and commitment to residential fire safety.

The Bridge To Arcadia - Design of 210 Freeway Structure Near Completion



The design of the so-called Iconic Freeway Structure (IFS) bridge of the Gold Line Foothill Extension Construction Authority over the eastbound 210 Freeway heading into Arcadia is nearly complete, with only final engineering tweaks to artist Andrew Leicester's design before work begins on the bridge featuring woven baskets pictured above.

Following the August release of the Phase 2A (Pasadena to Azusa) Request for Proposals for Design-Build-Finance services (to construction the track, stations, a 25-acre Maintenance and Operations Facility, crossings, bridges, utilities and more), the three short listed teams are hard at work preparing proposals. Proposals for the \$450+ million project are due in late January, and an award is anticipated for April.

This schedule keeps us on track for a late 2014 project completion.

IFS design-build team Skanska USA/AECOM is spending the next several months finalizing designs for the 584-foot bridge over the eastbound lanes of the I-210 freeway. They are currently working with the California Department of Transportation (CALTRANS) to get the necessary permits to conduct some additional geologic testing at the IFS site location, which will help finalize the design.

Between now and April, when major construction is scheduled to begin on the bridge, AECOM (the designers) will work to turn the artist's concept into an engineering reality.

Meanwhile, the Phase 2B environmental

process is getting started. The consulting team, led by Parsons Brinckerhoff, is initiating work with the cities along the Phase 2B corridor, and will begin the public involvement process early in 2011. The Construction Authority will be preparing an Environmental Impact Report/Study (per CEQA/NEPA guidelines) for this 12.5-mile extension – evaluating the environmental impacts of the project and identifying ways to mitigate those impacts when feasible.

And finally, Construction Authority staff has been working around the clock to update the decade-old Authority website. Look for a revamped www.foothillextension.org website.

America's \$42 Billion Annual Boondoggle What

government buy if it had an extra \$42 billion spend every year? What might our government do if it suddenly had that much money dropped onto its lap

each and every year? For one thing, it might pay for the entire \$7 billion increase in the Children's Health Insurance Reauthorization Act President Barack Obama signed, expanding the health care program to an additional 4 million children and pregnant women, including for the first time legal immigrants without a waiting period -- and there would still be \$35 billion left over.

Or perhaps hire 880,000 new schoolteachers at the average U.S. teacher salary of \$47,602 per year.

Or give every one of our current teachers a 30 percent raise (at a cost of \$15 billion, according to the American Federation of Teachers) and use what's left to take a \$27 billion whack out of the federal deficit.

Or use all \$42 billion for a massive tax cut that would put an extra \$140 in the pockets of every person in the country - \$560 for a family of four.

The mind reels at the ways such a massive sum of money could be put to

Why \$42 billion? Because that's what our current marijuana laws cost American taxpayers each year. According to a new study by researcher Jon Gettman, marijuana prohibition costs taxpavers \$10.7 billion in law enforcement, and \$31.1 billion in lost tax revenues. And that may be an underestimate, at least on the law enforcement side, since Gettman made his calculations before the FBI released its latest arrest statistics in late September. The new FBI stats show an all-time record 858,408 marijuana arrests in 2009, 10,545 more than in 2008; while the total arrests for trafficking and sale was 99,815.

That's like arresting every man, woman and child in Long Beach, Pasadena, and Glendale on marijuana charges ... every year. Arrests for marijuana possession alone -- not sales or trafficking, just possession -- totaled 758,593. By comparison, there were 581,765 arrests last year for all violent crimes combined. Basing his calculations mainly on

U.S. government statistics, Gettman

concludes that marijuana in the U.S. is a \$113 billion dollar business. That's a huge chunk of economic activity that is unregulated and untaxed because it's almost entirely off the books.

Of course, the cost of our marijuana laws goes far beyond lost tax revenues and money spent on law enforcement. By consigning a very popular product -- one that's been used by about 100 million Americans, according to government surveys -- to the criminal underground, we've effectively cut legitimate businesspeople out of the market and handed a monopoly to criminals and gangs.

Strangely, government officials love to warn us that some unsavory characters profit off of marijuana sales, while ignoring the obvious: Our prohibitionist laws handed them the marijuana business in the first place, effectively giving black market marijuana dealers a multi-billion dollar free ride. Prohibition doesn't lessen marijuana use; it subsidizes the illegal cultivation, distribution and sale of marijuana.

All this might make some sense if marijuana were so terribly dangerous that it needed to be banned at all costs, but science long ago came to precisely the opposite conclusion. Compared to alcohol, for example, marijuana is astonishingly safe. For one thing, marijuana is much less addictive than alcohol, with just nine percent of users becoming dependent, as opposed to 15 percent for booze. And marijuana is much less toxic. Heavy drinking is welldocumented to damage the brain and liver, and to increase the risk of many types of cancer.

Marijuana, on the other hand, has never caused a medically documented overdose death. Scientists are still debating whether even heavy marijuana use causes any permanent harm at all. Marijuana has also been found to have numerous medicinal uses for such diseases as cancer, AIDS, and Alzheimer's. And then there's violence. Again, the scientific findings are overwhelming: Booze incites aggression

and violence; marijuana doesn't. Legalization of the marijuana in California is a step in the right direction. Let's be the first state to reject this annual \$42 billion boondoggle.

Looking NASA's Hubble Telescope's Latest Discovery

Hubble Telescope Captures First Images of Aftermath from Possible Asteroid Collision

NASA's Hubble Space Telescope has captured the first snapshots of a suspected collision of two asteroids in space. The images show a bizarre X-shaped object trailing a cometlike trail of material.

In January 2010, astronomers began using Hubble to track the object for five months. They thought they had witnessed a fresh asteroid collision, but were surprised to learn the collision occurred in early 2009.

"We expected the debris field to expand dramatically, like shrapnel flying from a hand grenade," said astronomer David Jewitt of the University of California in Los Angeles, who is a leader of the Hubble observations. "But what happened was quite the opposite. We found that the object is expanding very, very slowly."

The peculiar object, dubbed P/2010 A2, was found cruising around the asteroid belt, which is a reservoir of millions of rocky bodies between the orbits of Mars and Jupiter. It is estimated that modest-sized asteroids smash into each other about once a year. When the objects collide, they inject dust into interplanetary space. But until now, astronomers have had to rely on models to make predictions about the frequency of these collisions and the amount of dust produced.

Catching colliding asteroids is difficult because large impacts are rare while small ones, such as the one that produced P/2010 A2, are exceedingly faint. The two asteroids that make up P/2010 A2 were unknown before the collision because they were too faint to be noticed. The collision itself was unobservable because of the asteroids' position in


relation to the Sun.

"These observations are important because we need to know where the dust in the solar system comes from, and how much of it comes from colliding asteroids as opposed to 'outgassing' comets," Jewitt said. "We also can apply this knowledge to the dusty debris disks around other stars, because these are thought to be produced by collisions between unseen bodies in the disks. Knowing how the dust was produced will yield clues about those invisible bodies."

The Hubble images, taken from January to May 2010 with the telescope's Wide Field Camera 3, reveal a point-like object about 400 feet wide, with a long, flowing dust tail behind a never-before-seen X pattern. Particle sizes in the tail are estimated to vary from about 1/25th of an inch to an inch in diameter.

The 400-foot-wide object in the Hubble image is the remnant of a slightly larger precursor body. Astronomers think a smaller rock, perhaps 10- to 15 feet wide, slammed into the larger one. The pair probably collided at high speed, about 11,000 mph, which smashed and vaporized the small asteroid and stripped material from the larger one. Jewitt estimates that the violent encounter happened in February or March 2009 and was as powerful as the detonation of a small atomic bomb.

Sunlight radiation then swept the debris behind the remnant asteroid, forming a comet-like tail. The tail contains enough dust to make a ball 65 feet wide, most of it blown out of the bigger body by the impact-caused explosion. The science

Ask jai.....

Ask jai is a weekly column that will strive to honestly answer your job search questions relating to job searching techniques, networking skills, resume writing and interviewing. The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

Q: I have been out of work for almost 5 years taking care of my family and raising two children. I want to return to the workforce. I have a finance degree and over 10 years work experience as a financial analyst. My husband is employed by a large corporation and they always have jobs listed on their website that I am interested in pursuing. I have asked my husband to talk to the Personnel Department about me and give them my resume. Which he has done. It has been over six months with no result. My husband has a good work history and has been with the corporation for 15 years. We are getting frustrated. What should we do to get me into their system to be considered for employment? Marika

Dear Marika,

First, find out what husband's employer's policy is regarding hiring spouses and family members. Next, there is no "we" when "you" are looking for employment. You are placing a lot of stress on your husband to assist you in finding employment, especially with his employer. You need to take on full responsibility for finding employment, and that should be with any employer that is looking for someone like you with your skills and experience. Start by letting your family, friends and former coworkers know that you are seeking employment. I am assuming that you are seeking employment in finance and as an analyst. A cover letter will be your key document when applying for any position.

Your cover letter should explain why you are transitioning from family life back into the workforce. Be sure to include a referral name, the position you are seeking, why you are returning the workforce, why you feel you qualify for the position and some out standing accomplishment statements. Do not focus your cover letter on your family or family activities. You want to communicate to the employer that you will be completely focused on their needs and that your skills and experience will add value to their organization. I would also suggest that you write a chronological resume, include an objective heading and what you have been doing for the past 5 years. Any volunteer work, school activities and some hobbies all count as work experience and are appropriate to include on your resume into order to bring it up to date.

However, if you are set on finding employment at your husband's company you should find out if they have an employee referral program. Then ask your mutual friends who are employed there if they would refer you for positions at his company. I strongly suggest that you try to bypass the Personnel Department and go directly to the person who is making the decision to hire. Ask your husband to find out the name of that person and, instead of him contacting and giving them your resume, you do it. Call or e-mail them directly, start with who referred you and if you feel it would be appropriate mention your husband's name. Continue looking for employment with other companies until you are employed.

Although the trend of Tech Industry executives seeking to make the switch from private sector success to elected public office can hardly be considered a new development in the world of politics, this years' election cycle saw more than its usual share of superstar tech-CEOs attempting to use their considerable wealth and influence to make just that switch. To watch multi-millionaires (and sometimes billionaires) pour hundreds of millions of dollars of their personal wealth into their political campaigns often leaves one wondering what these candidates really have in common with the typical Main Street voter. To be totally honest, many a so-called "justlike-you" politician often lives an existence far beyond the grasp of the average American but the hi-tech variety of politician, especially in the FaceBook age, are truly a breed unto themselves. While the skills that have led them to conquer the tech world and push the limits of technology and business far beyond anything ever thought possible are rarely found though highly sought after in the business world, the usual skillsets, temperaments and empathy usually found in responsive, effective public officials is, in many cases, lacking. The drive to perform in business in a manner that increases shareholder value to the exclusion of all other factors could be, and often has been, proven to be disastrous towards something as nebulous as the public good.

In fact, many functions and goals of Local, State and Federal governance are not undertaken with the goal of profit in mind, but in order to provide goods and services needed by the public. One could easily see how success in one sphere might not directly translate into success in the other. "Empathy" is the word that got President Obama into trouble when he said it was a necessary quality for a Supreme Court justice. He was right, though, and empathy is a very desirable trait in a public leader. Over the years we've been exposed to many charismatic and personable hi-tech business leaders and while their achievements have been noteworthy and they have been personally likeable, "empathetic towards the situation of the average worker" is not a phrase that is often used to describe them, and rightly so. They haven't gotten to the positions in life that they currently occupy because they "feel our pain." They've gotten there because of their ability to run a business and to make a profit. Those are - in and of themselves - awesome things to know how to do, but the positions that these people are running for are not businesses and these offices require different measures of success than simply increasing shareholder value.

So please, hi-tech leaders, stay in Silicon Valley. We need you there. If you feel a burning desire "to give something back," emulate Bill Gates, whose charitable work is altogether admirable and appropriate for a man of his wealth and talent. But please, stay off the ballot.

in charge here. It looks like we're quite outnumbered! Fact is, we have a mutually beneficial relationship with our bacteria and, in some cases, are quite dependent on them. For example, some of the B-complex vitamins are synthesized by bacteria. Now it looks like there may be more to this arrangement than we had thought: the kinds of bacteria living in our digestive tracts may actually influence

Thenewscienceofneurophsychoimmunology studies how the movement of peptides, hormones and neurotransmitters give us our experience of thought, emotions and consciousness. Now, we can add to this electro-chemical dance another factor: the metabolic byproducts of certain bacteria may influence behavior in the same way that the organs and systems of our bodies do.

Fatal Feline Attraction

Joanne Webster of Imperial College in London discovered that mice and rats infected with Toxoplasma began to "wander around and draw attention to themselves" in an apparent attempt to attract the attention of cats. It seemed the bacteria "had hijacked" the rodents and were securing their future home in the digestive lining of the cat's intestines. The cat would then pass the bacteria out through the feces and perpetuate the cycle when the bacteria were ingested by rodents. Clever!

What Does That Have to Do with Me?

Briefly, other studies on human populations have indicated that Toxoplasma's presence may contribute to conditions as far reaching as accidentproneness, neurotoxism, schizophrenia, and attention-deficit disorders. Some researchers are going so far as to suggest that whole cultures are altered by bugs. This makes the old adage,"He's got a bug up his ****" almost

prophetic.

In a nutshell: Bugs act like cells by manufacturing chemicals that are the same as, or similar to, the innate regulators of body function found in normal cells. These chemicals can change our consciousness.

We can inoculate the intestinal tract with organisms which we regard as beneficial, thereby reducing the influence and population of less desirable bacteria. We do this through diet and supplementation (ie. high quality nondairy probiotics found in health food stores).

I hope you enjoy this sharing and remember: the next time someone sneezes on you, don't take it personally. It's the bugs

PUMPKIN BREAD PUDDING WITH TOFFEE SAUCE

Ingredients:

- 2 cups half-and-half or light cream
- 1 15-ounce can pumpkin
- 1 cup packed brown sugar
- 2 teaspoons vanilla
- 1-1/2 teaspoons pumpkin pie spice
- 1-1/2 teaspoons ground cinnamon 9 ounces French bread, torn into bite-size pieces (10 cups)
- 1/2 cup golden raisins 1/2 cup granulated sugar
- 1/2 cup evaporated milk
- 2 tablespoons butter
- 2 tablespoons light-colored corn syrup 1/2 cup chocolate-covered toffee pieces

Directions:

- 1. Lightly grease a 2-quart shallow baking dish; set aside. In a very large bowl, combine half-and-half, pumpkin, brown sugar, eggs, vanilla, pumpkin pie spice, and cinnamon. Add bread pieces; stir to moisten evenly. Stir in raisins. Transfer mixture to the prepared baking dish. Cover and chill for 1 to 4 hours.
- 2. Meanwhile, for sauce: In a small saucepan, combine granulated sugar, evaporated milk, butter, and corn syrup. Bring to boiling; reduce heat. Boil gently, uncovered, for 1 minute. Cool to room temperature. Transfer to a serving bowl. Stir in toffee pieces.
- 3. Preheat oven to 350 degrees F. Bake bread pudding, uncovered, about 35 minutes or until a knife inserted in the center comes out clean. Cool on a wire rack for 30 minutes. Serve warm bread pudding with sauce. Makes 8 servings.





GOLF GRIP - Check Your Knuckles

In order to hit the golf ball further and more consistent, after you grip the club-check your knuckles EVERY TIME. I have a question for you that you have to answer in two seconds. Is gripping the golf club an art or a science? Think about it for 10 seconds if you want to. Do you know why I am giving you 10 seconds to think about it? Ten seconds is longer than you take to think about gripping the club when

your on the golf course.

When most amateur golfers struggle with their golf game it can be traced right back to the grip the golf club. What I have heard for the past 35 years is "I am really struggling with my swing"-DON'T TOUCH MY GRIP. "I keep coming over the top"-DON'T TOUCH MY GRIP. "I can't stop hooking the ball"-DON'T TOUCH MY GRIP.


Here is the problem. Changing your grip can be a nightmare. I don't care if you have played for six months or 30 years, for you to make a grip change, it can be a long and painful process. I started playing golf when I was 2 years old, by the time I was 13 I was bigger and stronger and I had a very strong grip. I hooked the ball way too much. My mom told me it was time to weaken it, It was the longest year of my life.


I am going to let you in on two little secrets that nobody talks about. If you slice the golf or if you hit weak fades to the right, changing your grip will be the most exciting and rewarding thing you will do for your golf game. You will fall in love with me in five minutes. (OK, maybe a little overboard-can you tell I am excited)? On the other hand. If you hook the ball you will want to wrap that driver around my neck for about three months AND then you will also fall in love with me.


That is secret number one. Now for secret number two. Whether you are a slicer or hooker of the golf ball, changing your grip can be very uncomfortable. I have a saying that I have used with my students for 20 years. As soon as they change their grip and make solid contact they always say to me "it doesn't feel good". And I always say to them "you have a choice, you can either hit it poorly and feel good or hit it great and feel poorly".

Let me tell you why the knuckles are so important. Let's talk about slicing first. After you grip the golf club and address the golf ball, when you look down at your left hand, you probable don't see any knuckles. of the left hand. You see the top of the left thumb. The problem is the clubface will not close in time for you to hit a draw. This next part is really important. Before you start your backswing, simple turn BOTH hands to the right the same amount. Do it in baby steps. Turn the hands on the club so you can see one knuckle, and hit some balls from this position. If you get rid of your slice then stop. You have hit gold, that is the correct grip for you. This is a very powerful change, that is why you will love it.

On to the golfers that hook the ball. After you grip the club and address the golf ball you will look down and see three or four knuckles of the left hand. The clubhead will close way to fast in the downswing from with this grip. You have to move BOTH of your hands to the left the same amount. Do it in baby steps, one knuckle at a time. The reason this is more painful than the grip change above is because you are going from a stronger position to a weaker position. You will not feel the love for some time. I know you can do this, I did.







In closing after you grip the club-check your knuckles EVERY TIME and you will begin to see the ball start flying straighter and further.
