Dickens Village to Kick Off the Holiday Shopping Season in Sierra Madre

The Sierra Madre Chamber of Commerce will host Sierra Madre's annual Dickens Village festivities to kick off the holiday season this Saturday, Nov. 27th from 3pm to 8pm in the downtown village shopping district. The City tree will be officially lit in Kersting Court shortly before 6pm, and Santa will arrive right after that at 6pm. There will be carolers downtown, (including the Sierra Madre Playhouse Carolers, warming up for the evening's performance of "A Christmas Carol" at 8pm, immediately after Dickens Village), horse and carriage rides from 3:30 to 7:30pm, and snow sledding from 3 to 8pm. The sloped drive-thru driveway at the Bank of the West on Sierra Madre is transformed to a winter wonderland of "snow," and youngsters of all ages can ride sleds down the slope to the their heart's content. Local non-profit and other organizations will have booths in the street selling holiday fare, some homemade, at the Chamber's second biggest single day event of the year, behind only the Wistaria Festival.

Downtown stores will stay open late and offer their holiday best to shoppers taking advantage of the first ever Small Business Saturday, a follow-up to Black Friday, the traditional shopping kickoff when shoppers fill department stores and malls the day after Thanksgiving. Small Business Saturday is a day to support the local businesses that create jobs, boost the economy and preserve neighborhoods around the country. Small Business Saturday is a national movement to drive shoppers to local merchants across the U.S.



camp, a migrant farm labor camp in California during the Great Depression. When John Steinbeck used this setting in this Grapes of Wrath, where the Joad family arrived scared, bone tired, dirty, hungry and broke in the southern San Joaquin Valley, he gave it the fictitious name of Weed Patch. During the making of a movie from the book, the scenes in the migrant camp were filed there. After the movie came out, it has been known as Weed Patch ever since.

You'll remember the "Okies" poured into California penniless, escaping the Dust Bowl, willing to work anywhere for any wage. As a result of the movie making this place famous, three of the original buildings were saved. There is still a work camp here, though with newer buildings and more amenities.

Every year, now, by this camp in the small community of Lamont south of Bakersfield, a Dust Bowl Festival takes place on the third Saturday in October. As this festival there is lots of music; there is food, such as biscuits and gravy with sausage and chili over corn bread; there are many displays of rusty, old-timey kitchen utensils, work equipment and tools. There are also

got them to Weed Patch, his dad became a "professional alcoholic". In the morning he would poke his son in the ribs and say, "Buck, put the coffee on!" As the father swigged his coffee he would swear off alcohol, but later in the day would go back to the bottle.

This kid, now an elderly man took us into the still standing Community Hall, containing a very large room with a stage. The walls inside and out were so weathered, that no paint remained. 

entertainment evenings. The man in charge asked the kid 'Buck' to help him. He, the man, would try to pull off Buck's pants, but the kid was told to fasten his belt well so they really wouldn't come off. Earl said he had to cinch up his belt very tightly as he was skinny. The two crawled about on the stage, the man chasing 'Buck' and the boy narrowly escaping, bringing guffaws from the audience. (His pants did not come off.). Then the

man ran after him with his mouth wide open, grabbed **Buck's** belt in his teeth, picked him up off the floor and with his teeth still grasping Buck's belt, ran about the stage swinging the boy in the aid the howls of amusement from the onlookers!

Earl also related that when Grapes of Wrath was filed there, the camp manager took part in a small scene and received \$10,000 for doing SO.





Parking Fines Increase Citywide

Before approving upping parking ticket fines across the city \$3 Councilmember Terry Tornek suggested earlier this month that the council look at alternative ways of dealing with the parking problem, including, issuing more warnings and cracking down on repeat offenders. The new fines take effect next week.

All of the city's parking restrictions will go up as part of a stat mandate. An expired meter ticket will go from \$42.50 to \$45.50 staff said.

"It's difficult, for me at least, to defend a \$45, \$50 fee for an expired meter," Tornek said.

He brought up an idea of increasing the fees for repeat offenders after reading about it in an op-ed article in the Los Angeles Time. He asked city staff to look into the idea.

"The whole parking fee structure doesn't make any sense," Tornek said quoting Donald Shoup from the Times. "What we should be doing is discerning between repeat offenders and first time offenders. It's really the repeat offenders that should be getting whacked."

He said in certain cities first time offenders get only a warning. He also said this eviate some of the complaints about unfair overnight parking tickets.
Fred Dock, director of

transportation, said the city currently does not have the capability to track parking offenders.

'We would have to have access to a database that would tell us in real time if a license plate has previously received a citation." Staff said upgrading the system would cost upwards of \$100,000.

This is the second year in a row that state has mandated a parking increase, last year all fines went up \$4.50.



County Bans Medical Marijuana

The County Board of Supervisors unanimously approved Tuesday an ordinance to ban Medical Marijuana Dispensaries in all unincorporated county

Supervisor Michael Antonovich had introduced a motion in July of this year directing staff to prepare an ordinance amending the County's Zoning Code to prohibit Medical Marijuana Dispensaries. The Regional Planning Commission, after considering a draft ordinance and conducting public hearing, recommended approval of the ban to the Board of Supervisors.

"Attracting crime and other nuisances, these facilities have a negative impact on the communities where they've operated -- leading more than 100 cities and 9 counties in California to pass similar ordinances," said Supervisor Antonovich. 'Since many municipalities in Los Ángeles County currently have either a ban or moratorium, adjacent unincorporated communities would become the obvious location of choice for dispensary operators -- creating an undue burden for residents in these areas."

After a second reading before the Board next week, the ordinance will take effect 30 days later.

U.S. funds Arcadia street upgrades: City staff took advantage of federal transportation funding to cover 80% of the \$1.7 million it cost to widen and add turn lanes at three major intersections on Santa Anita Avenue — Duarte Road, then Foothill Boulevard, and now Live Oak Avenue.

Mall biz growing; mall expanding?: Westfield Santa Anita business was up 6% in October, with traffic up 8%. The mall recently filed a non-specific application with the city to convert the former and vacant Robinsons-May building to be used for a large-scale retail store and several small retailers that would flow out into the food court area.

No housing slump here: While new home construction has stalled in many cities, in one recent month Arcadia had 61 new homes being built, including 52 tear-downs/rebuilds and 9 brand new homes.

Rusnak talking again: With the city in escrow on key properties on Morlan Avenue near the Rusnak Mercedes car lot on Huntington Drive west of Santa Anita, talks have resumed with Rusnak about buying those properties from the City to expand his dealership.

Caruso/Stronach talking again smaller Shops at Santa Anita?: Officials report a new deal may be finalized by December between Rick Caruso and Santa Anita Park owner Frank Stronach about a new partnership between the two titans on a slightly scaled-down Shops at Santa Anita project.

Joint-Use Gym: The new joint-use (City/School District) gymnasium being built at Dana Middle School will be opened in January with a City staff person assigned to manage it. The City will have use of it evenings and weekends, with the school accessing it weekdays.

Library traffic/use in the fast

Did you know that the Arcadia Public Library had nearly 600,000 visitors in the past year and loaned out the collection of nearly 200,000 books and other items such as DVDs and audio books more than 725,000 times? That's way more than ten times the number of residents in Arcadia. About 168,000 visited the ever-expanding web

Also exceeding the population was the number of questions asked of librarians: nearly 64,000. Maybe that's because there are nearly as many current library cards for the Arcadia library the number of people living in town: more than 53,000. That's a much higher percentage than the 62% nationally, which is also impressive.

That means the library staff can always use help, which they got last year from 238 volunteers who put in more than 15,700 hours, 32 of those volunteers tutoring residents how to use one of the library's 60 computers — 802 questions and 7,435 computer sessions in October alone!

Proving that public libraries remain a vital part of American life, there are 16,604 of them in the U.S., more than the number of McDonald's restaurants.







to provide morale and recreation services to uniformed military personnel. This request led six civilian agencies -- the Salvation Army, Young Men's Christian Association, Young Women's Christian Association, National Catholic Community Services, National Travelers Aid Association and the National Jewish Welfare Board -- to unite in support of the troops. The United Service Organizations, or USO, was incorporated in New York February 4, 1941.

USO centers and clubs opened around the world in order to be a "Home Away from Home" for GIs. The USO was a place to go for dances and social events, for movies and music, for a quiet place to talk or write a letter home, or for a free cup of coffee and a doughnut. The USO also brought Hollywood celebrities and volunteer entertainers to perform for the troops.

At its high point in 1944, the USO had more than 3,000 clubs, and curtains were rising on USO shows 700 times a day. From 1941 to 1947, the USO presented more than 400,000 performances. Entertainers such as Bing Crosby, Ann Sheridan, James Cagney, Jimmy Stewart, Fred Astaire, the Andrews Sisters, Joe E. Brown, Glenn Miller, Martha Raye and, of course, Bob Hope were just a few of the "Soldiers in Greasepaint" who volunteered their time and talents to tour with the USO.

In 1950, when the United States entered the Korean War, the USO once again brought its vital services and entertainment tours, including Marilyn Monroe, to the troops. This effort continued after the war ended, and the USO expanded to serve the more than one million troops who remained stationed overseas. During the 1960s, as tensions escalated in Vietnam, the USO began to open centers in combat zones. The 23 centers in Vietnam and Thailand served as many as a million service members a month, and the USO presented more than 5,000 performances during the Vietnam War.



The flag and accompanying certificate are "rather rare honors," said Mr. Dorn. "I really enjoyed hearing what happened to the idea;


... I doubt that many of our legislators would have taken the time to tell me the tale."

conception we're in a space of neverending movement, as mother's blood pressure changes whether she's sleeping or "up and moving around." When awake, other vibrations / pressures vary as she walks, bends, stretches, drive or rides in vehicles: we experience 24/7 movement, within which we freely move and stretch in this marvelous liquid environment whenever we wish.

The birthing shock of pressure, light ages? Why can't we adults have swings and air, hands touching us and suddenly being constricted by clothes and blankets enough for our posteriors, so we too and winding up alone on a non-moving can sit and swing gently and talk with a surface separates us from the warm and surrounding pulsations during our nine months' gestation.

Even in primitive cultures, parents find ways to provide gentle, ongoing movement for babies - often just being carried on back, or by older children. In yesterday's world, we tucked babies in cradles, keeping our adult hands free for seated tasks, while a foot pressed/ released (i.e., rocked) the cradle with rhythmic movement that soothed and comforted We'd have to take out 3 trees."

parents "get on with life's duties." And drive for hours during the night while the baby in back sleeps only as long as movement continues – and wakes up screaming at every stop?

Movement is life – the absence of

movement stresses our bodies in so many ways that we literally cannot count them. And so we are encouraged to exercise walk, jog, run, play one of many kinds of ball, bicycle, climb, gymnastics, yoga, swim ... keep moving, keep active, keep toned, keep strong, keep going.

Which brings me to swings. Who among us does not have a fond childhood memory of some kind of outdoor swing - a rope with a couple large knots or pumps through her body with its subtle a tire tied to a tree? A swing set in the back yard, or at the nearby playground? Parents often take their kids to a park, plop the kids in the "baby swings" and (maybe) talk with other adults.

Wait! What happened to the adult-sized swings in Memorial and Turtle Parks? Where we find swings, how come they're only for babies? Aren't our parks for all with seats large enough and comfy friend, or pump strongly to get up a good movement for a few moments until we let 'the cat die down" again?

Occasional visits to the Public Works office at City Hall over the last 10 years elicited: "Oh, swings are too dangerous. Toomuch liability. We can't have swings for adults." The current General Plan Parks and Recreation Committee says – "Oh, there's not enough clearance room for adult-sized swings in Memorial Park.

motorized swings to soothe babies while adult swings in our town's several area space areas near us!

parks. A city council member on Sunday how many of the youngest babies' parents I pointed out that there are 4 "older children" swings to the YAC's rear on the east side. So I tried one out. Obviously they are swings for really tall kids - 6' tall, or taller. At 5'5" I had to struggle to get up on tip-toe to get even one hip on the seat (although I eventually managed). And yes, there was certainly enough space around them so I wouldn't hit anyone on either forward or backward swing, and yes, it was quiet, and I had a good swing. However, while we're looking at updating our city's 5-Year General Plan - let's get "larger children / adult" swings back in Memorial Park, plus more elsewhere – the open space south of the library? Goldberg Park? Bailey Canyon? Turtle Park? Beside the Post Office? Every adult I've talked to, while understanding safety concerns, recognizes this hole in Sierra Madre's outdoors life – and the corresponding hole in their hearts because there's no swings for them. Some residents stopped taking their children, because there was "nothing for us". A good swing is one of life's special moments. Just because we're "adults" doesn't mean we don't like feeling young from time to time.

With only 5 minutes (or even just 90 seconds) of swinging (which rhythmically pressure-exercises every cell just like it did when we were still inside mommy) we reexperience what it was like to be young and free, to revel in the delight of soaring toward the sky - back and forth, back and forth, back and forth until the desire to fly is soothed, we slow down, and - once more at peace with life - we move on.

For the Swingers Amongst Us – let City Council, our Parks and Recreation folks, and our Public Works department know how much we want our "older child / baby. Today's parents quickly acquire Horse-feathers! We certainly can have adult" swings back again in the open

My two kids are born on the same date, November 28th, just two days before the date of Mark Twain's birth it seemed appropriate to buy this huge 737 page Autobiography of Mark Twain and realize that it's only Volume 1. Right now I'm rereading Huckleberry Finn and I'm beginning to understand something new about what freedom means...


Throughout the book wrestles with questions of right and wrong. He is accompanied on much of his journey by the escaped slave Jim whom at first Huck regards as a being much less worthy than a White Man; but Huck soon learns the error of his thinking and the error of his whole culture. Huck undergoes a kind of reverse initiation out of civilization and learns to measures Jim's worth according to his own instinctive sense of justice and brotherhood, rather than the beliefs of society. Still Huck is unable to completely ignore what has been drilled into him and worries that he will

be forever condemned to hell if he continues to aid Jim. Huck's willingness to risk Hell is a decision of great moral magnitude. Planet from Another Galaxy Discovered

An exoplanet orbiting a star that entered our Milky Way from another galaxy has been detected by a European team of astronomers using a 2.2-meter (87-inch) telescope at the La Silla Observatory in Chile. The Jupiter-like planet is quite unusual, as it is orbiting a star nearing the end of its life and could be about to be engulfed by it—giving tantalizing clues about the fate of our own planetary system in the distant

Over the last 15 years, astronomers have detected nearly 500 planets orbiting stars in our cosmic neighborhood, but none from outside our Milky Way has been confirmed. Now, however, a planet with a minimum mass of 1.25 times that of Jupiter has been discovered orbiting a star of extragalactic origin, even though the star now finds itself within our own galaxy. It is part of the so-called Helmi stream—a group of stars that originally belonged to a dwarf galaxy that was devoured by our galaxy, the Milky Way, in an act of galactic cannibalism about six to nine billion years ago. The discovery was announced Nov. 18 in Science Express.

"This discovery is very exciting," says Rainer Klement of the Max-Planck-Institut fur Astronomie (MPIA), who was responsible for the selection of the target stars for this study. "For the first time, astronomers have detected a planetary system in a stellar stream of extragalactic origin. Because of the great distances involved, there are no confirmed detections of planets in other galaxies. But this cosmic merger has brought an extragalactic planet within our reach."

The star is known as HIP 13044, and it lies about 2,000 lightyears from Earth in the southern constellation of Fornax (the Furnace). The astronomers detected the planet, called HIP 13044 b, by looking for the tiny telltale wobbles of the star caused by the gravitational tug of an orbiting companion.


Adding to its claim to fame, HIP 13044 b is also one of the few exoplanets known to have survived the period when its host star expanded massively after exhausting the hydrogen fuel supply in its core—the "red giant" phase of stellar evolution. The star has now contracted again and is burning helium in its core.

"This discovery is part of a study where we are systematically searching for exoplanets that orbit stars nearing the end of their lives," says Johny Setiawan, also from MPIA, who led the research. "This discovery is particularly intriguing when we consider the distant future of our own planetary system, as the Sun is also expected to become a red giant in about five billion

HIP 13044 b is near to its host star. At the closest point in its elliptical orbit, it is less than one stellar diameter from the surface of the star (or 0.055 times the Sun-Earth distance). It completes an orbit in only 16.2 days.

The star poses interesting questions about how giant planets form, as it appears to contain very few elements heavier than hydrogen and helium—fewer than any other star known to host planets. "It is a puzzle for the widely accepted model of planet formation to explain how such a star, which contains hardly any heavy elements at all, could have formed a planet," Setiawan

Upgrade your browser. Upgrade your Internet browser to the most recent version available. Review the browser's security settings. Apply the highest level of security available that still gives you the functionality you

Ignore pop-up messages. Set your browser to block pop-up messages. If you do receive one, click on the "X" at the top right corner of the title bar to close the pop-up message. NEVER click on a pop-up! If you are interested in what the pop-up is promoting, go to the website on your own, not through the link in the pop-up. Legitimate companies do not use pop-ups.

Secure your transactions. Look for the "lock" icon on the browser's status bar and be sure "https" appears in the website's address bar before making an online purchase. The "s" stands for "secure" and indicates that the webpage is encrypted. Some browsers can be set to warn the user if they are submitting information that is not encrypted.

Use strong passwords. Create strong passwords for online accounts. Use at least eight characters, with numbers, special characters, and upper and lower case letters. Don't use the same passwords for online shopping websites that you use for logging onto your home or work computer. Never share your login and/ or password.

Do not e-mail sensitive data. Never e-mail credit card or other financial/sensitive information. E-mail is like sending a postcard and other people have the potential

Review privacy policies. Review the privacy policy for the website/merchant you are visiting. Know what information the merchant is collecting about you, how it will be used, and if it will be shared or sold to others.

Make payments securely. Pay by credit card rather than debit card. Credit/charge card transactions are protected by the Fair Credit Billing Act. Cardholders are typically only liable for the first \$50 in unauthorized charges. If online criminals obtain your debit card information they have the potential to empty your bank account.

Use temporary account authorizations. Some credit card companies offer virtual or temporary credit card numbers. This service gives you a temporary account number for online transactions. These numbers are issued for a short period of time and cannot be used after that period. This is the safest method of shopping

Select merchants carefully. Limit your online shopping to merchants you know and trust. Confirm the online seller's physical address and phone number in case you have questions or problems. If you have questions about a merchant check with the Better Business Bureau or the Federal Trade Commission.

Keep a record. Keep a record of your online transactions, including the product description and price, the online receipt, and copies of every e-mail you send or receive from the seller. Review your credit card and bank statements for unauthorized charges.


Have you suffered a concussion, maybe fractured rib or two? I, for one, am in a perfect Zen state of wholeness in body and spirit because I did not







Recipe of the Week: **TURKEY RICE BAKE**

INGREDIENTS:

6 slices bacon 1 medium onion, chopped

1/4 cup sliced onion 2 cups cooked rice

1 package (10 ounces) frozen chopped spinach or

broccoli, cooked and drained 2 tablespoons chopped pimiento

DIRECTIONS:

Toss bread crumbs with butter and sprinkle around edge of casserole. Bake in a preheated 350° oven for 30 to 35 minutes, until hot and browned around the edge. Serves 6.

Common Runners' Injury: Stress Fractures Of The Foot; Repetitive Impact On Feet Can Increase Risk Of Damage

(N A P S) — S t r e s s fractures of the foot are becoming more common in runners, especially first-time marathoners, according to the American College of Foot and Ankle Surgeons.



The growing popularity

of marathons among beginning runners has contributed to the increase in repetitive stress injuries, including stress fractures of the foot, seen by foot and ankle surgeons. Often, first-time marathoners enter a race with little or improper long-distance training. The lack of experience coupled with the repetitive impact placed on the feet during the run can produce enough stress to cause hairline breaks in the bones of the foot.

"Runners who increase their mileage too quickly or change to a more intense phase of training may be more susceptible to a stress fracture due to the increased force placed on the bones," said Alan MacGill, DPM, AACFAS, a foot and ankle surgeon from Boynton Beach, Florida. "A general rule of thumb for runners is to increase the mileage by no more than 10 percent each week. Runners who are training also need to have adequate rest time in between runs to help decrease the risk of injury."

Runners at all levels of experience are also at higher risk for stress fractures if they wear improper shoes while running or training, suffer from flatfoot or other foot deformities, or have

osteoporosis. Signs of a stress fracture can include pain, swelling, redness

and possibly bruising of the area. "Stress fractures can occur anywhere in the foot and can eventually lead to a complete break of the bone if left untreated," Dr. MacGill explained. "Early diagnosis and treatment are important to ensure proper healing."

If a break is suspected, Denver foot and ankle surgeon John McGarry, DPM, FACFAS, advises runners to immediately follow the RICE protocol: Rest, Ice, Compression and Elevation. If pain and swelling last longer than a few days, a visit to a foot and ankle surgeon for an X-ray and diagnosis is in order.

In most cases, treatment includes rest and immobilization with casting of the foot. Surgery may be required in certain instances to repair and stabilize a stress fracture that has progressed to a full fracture.

Runners can take action to prevent repetitive stress injuries in their feet by wearing supportive athletic shoes and slowly building up their activity levels according to their abilities. "If a runner suffers from abnormal mechanics in the foot, such as overpronation or hypermobility, custom orthotics can also be helpful to prevent these injuries," Dr. McGarry said.

When I walked up to the 13th tee, I remember it as thou it was yesterday, I decided that I was going to do something about my golf game. The first thing I needed to do was start practicing and the second thing was to CATCH UP with the game. It was passing me by. The game was changing (getting longer) and I was stuck in neutral.

The next moring I ordered a Momentus Heavy Hittable Driver off of the internet with overnight delievery. I could hardly pick it up. I took it to the range, swung it five times and almost feel over. That is when I decided that I needed to come up with a routine so I could take advantage of my new club.

I decided that I was going to swing the club 25 times, three days a week whether I was at the golf course or not. In the backyard I went every Monday, Wednesday and Friday. Once I started using it at the practice facility I then came up with another way to use it. During practice sessions I swung it three times for every six balls I hit. I like to hit three draws, three fades, three straight shots and then three swings with the heavy driver.

On days that I play, I have another routine that I have used for years. I hit three shots with every club in my bag. Now my routine includes swinging the heavy driver one time every time I change clubs.

OK, I know you are dying to hear the results. The only reason I am not going to tell you how much further I am hitting the ball is that everybody is different. The one thing I will tell you is that I am back. I have caught up with the sport and... well ok, I am at least 20 yards further off of the tee and 1.5 clubs longer with my irons. BUT, I have been VERY committed to this process. I have not missed a day in two years.

VERY IMPORTANT REMINDERS:

- #1. Warm up before you pick up a heavy driver and start swinging it
- #2. Even thou it says it is a HITTABLE club, make 200 practice swings with it before you start hitting balls. You have to get use to it first.
- #3. This is NOT an overnight fix for short tee shots. Stay committed to see results.
- #4. I added 15 yards in the first three months, I kept going so I can keep what I have!!!
- #5. Harvey Mackay (USE YOUR HEAD TO GET YOUR FOOT IN THE DOOR) is a genius at dishing out great business advice. I took advantage of his lesson to me.


