CREDIT CARD SCANDAL GROWS



Police Chief Urges EVG Victims to Report Fraud

Sierra Madre Police Chief Marilyn Diaz is urging victims of the EVG gas station fraud to report the crime to the Police Department. The fraudulent charges arising from credit and debit cards used at the EVG station are showing up both as EVG charges and charges to other retail establishments, both in California and out of state. Anyone who has used a credit or debit card at EVG in the past 12 months should report any fraudulent charges to Sierra Madre police.

Some victims have dealt only with their banks to reconcile the fraudulent charges, and opted not to report the crime to police. It is critically important to report as many fraud cases as possible. The greater number of victims, and the higher the loss, increases the chances of a successful prosecution if the suspects are identified and arrested.

As of Saturday, January 8, 2011, over 360 victims have been identified, and the loss exceeds \$100,000. Victims can report fraud at the Sierra Madre police station at their convenience, 24 hours a day, 7 days a week. The police will process reports promptly. For more information call (626) 355-1414.

There are six financial institutions involved: Chase, Wells Fargo, Bank of America, Bank of the West, American Express and Citibank.

Most accounts were only hit once, however, there were several accounts that were hit between two and nine times.

The largest individual loss was \$3,700. Of the victims, 78% of them are Sierra Madre residents.

Several of the financial institutions automatically canceled the credit cards and issued new ones as soon as they became aware of the situation. One resident reported a friend joked, "He thought you'd

Chief Diaz and the entire police department have been busy interviewing victims and searching for the suspects. At the press conference, Diaz said there were now three suspects, one of whom is Evgeny Yakimenko, a Russian who purchased the station a year ago. Diaz also noted that the investigation did include the Valero station but said that the owners of the Valero station were cooperating with the department.

Last week, Diaz made a presentation to the Sierra Madre Kiwanis Club and to the Senior Community briefing them on the status of the investigation. She reviewed many of the ways in which thieves steal your identity and what one can do to protect themselves.



house on Sunday, January 30, 2011 at 7 p.m.


Appearing on the same bill will be musical guests, which include some of the finest singer-songwriters from Southern California, as well as musical friends from Europe.

EVG Gas Station Fraud, Use Another's Personal Identification to Obtain Credit/Etc, 50 S. Baldwin Ave EVG Gas station. Between Monday, December 27th and Thursday, January 6th over 300 cases of credit and debit card identity theft were reported. Victims used their cards to buy gas between July and December 27 2010. Over the Christmas weekend the suspects illegally accessed the victims' accounts for cash and retail sales, exceeding \$82,000. The loss is expected to increase daily as additional victims report more fraud. The EVG gas station closed after Christmas weekend, and detectives are seeking the owner and his associates for questioning. The Secret Service is also working with SMPD on the investigation. 8:40 PM- Battery, 10 blk. N. Baldwin Ave. Two parties began engaged in an argument which led to a fight in front of Bean Town. Police File Charges Against Murder Suspect



Police announced Tuesday that they had made a break in a nine month old murder case charging local area resident Terry Adkisson, 23, with the murder of Abraham Rodriguez.

Rodriguez was killed March 7, 2010, near the intersection of Fair Oaks Avenue and Tremont Street. The charges against Adkisson are the result of an investigation by the department's Homicide Unit, lead by Detective police said. Curry Detective's efforts resulted in witnesses identifying Adkisson as the assailant, and as such Adkisson admitted to his involvement in the homicide. victim's family has been apprised of the arrest and they were extremely pleased with the commitment of the Pasadena Police Department to Abraham's killer.

In addition to murder charges, the Angeles County District Attorney's office filed gang enhancements and felon in possession of a firearm. His bail is set at \$2,035,000.

Immediate Action Needed to Save Sycamore Oak Woodland in Arcadia!

for destruction. LA County Public Works Department has approvals and permits to destroy this woodland habitat to create a disposal site for sediment removed from behind Santa Anita Dam. On the recommendation of Supervisor Antonovich, on December 7th the Board of Supervisors authorized a 30-day moratorium on tree removals, which was originally scheduled to begin on December 13th. This moratorium will expire

Please immediately voice your opposition to this oak woodland destruction by communicating your concerns to Supervisor Antonovich and your local newspaper/radio/television station. Removal of the sycamore/oak woodland to create a sediment disposal site is a short-term solution to a long-term problem. Sedimentation will continue to occur indefinitely until foothill dams are removed, an unlikely occurrence. However, other locations exist to place sediment that does not involve removal of trees.

The sycamore/oak woodland provides water storage, pollution filtration and carbon sequestration benefits to the community. Woodlands provide ecosystem services including (but not limited to) intercepting rainfall and storing it underground; filtering particulates and other pollutants; and sequestering carbon dioxide from the atmosphere. (One large tree can store 10,000 lbs of carbon dioxide) Residents of the local community lose these benefits if woodland loss at this com.

This 11-acre sycamore oak woodland is slated location is mitigated off-site. In addition, it would take many years for nearby mitigation plantings to create similar benefits to those which this mature woodland provides.

> This is an intact, functional and dynamic ecosystem. The ecological functions of groundwate storage, shade, habitat, nutrient cycling, carbon sequestration and wind/noise/dust abatement are occurring in this self-sustaining and regenerating woodland, which is not severely degraded as the project Environmental Impact Report suggests.

> The area has potential to become a recreation corridor for activities such as hiking and mountain biking. Although a public hiking trail through this area from Arcadia to the Angeles National Forest is shown on some maps, the area is currently fenced off from public use.

> There is a need for coordination between the County's Departments of Public Works and Regional Planning. The Regional Planning Department is currently working with the Los Angeles County Oak Woodland Habitat Conservation Strategic Alliance, a group of tree and biological professionals, to develop oak woodland preservation and enhancement policies to meet the requirements of the California Oak Woodlands Conservation Act (SB 1334). The Department of Public Works should join in this effort.





Eat Well! Take A Ride To Montrose

The question poised to your local restaurant reviewer this week was, "What was your greatest discovery of 2010?" Easy Answer.

Divina Cucina - Ristorante Italiano. How it had managed to slip past my knife and fork for all these years is a true mystery, since Divina Cucina has been around for 19 years.

The restaurant itself is quaint, with a bar, a main dining room and an attached patio. I sat on the enclosed patio and found it comfortable and acoustically perfect. You can have a nice conversation without the bother of shouting or the need to whisper so that no one hears you. As I tilted to look above my table I noticed the rich wood beams spanning the room which brought to mind a chalet in

The restaurant is owned and operated by the husband and wife team of Horacio and Alicia Lavanchy. My server, Luis, followed Horacio from his own restaurant to Montrose and has been serving with him for all of the 19 years. He was lightning quick, and his service reminded me of the professionalism that is lacking in too many restaurants.

I was fortunate enough to be able to try an array of dishes. I soon discovered that all the breads are made right in Divina's kitchen. Horacio explained to me that there is a big difference between bread that was made a day before and bread that is made an hour before. I agree with him - the difference is measurable. It certainly was evident in the Bruschetta Con Pomodori (\$6.95). Sticking with appetizers, I enjoyed the Carpaccio di Manzo (\$10.95), with a mustard caper sauce that made this dish a must on my next return. Soup of the day was a delightful Mushroom Soup and I sampled the Squash Soup as well. I have long since said that, if the soup is good, it usually leads to a great dining experience. I don't know of anything they could have done to improve these two liquid delights.

Continuing with the house-made theme, I moved on to the pastas, which are all made from scratch at Divina Cucina. The pastas offer so many layers of intriguing flavors that it was self-evident that their preparation was under the watchful care of this restaurant. "The Special" of the night was the four-cheese Gnocchi. I also tasted the Ravioli di Zucca, filled with butternut squash mousse in Alfredo sauce. Exceptional, but the lobster filled Ravioli di Aragosta was even better! Both are in the (\$16) range. Other entrées that pepper the menu: Veal, Chicken, Beef and a Fresh Salmon, the one menu item that Alicia said is her favorite. I thought the Pollo alla Gorgonzola (\$19) smelled wondrous when it arrived at the table, as it cast its rich aromas in bouquets. In a word, Perfection. The sprinkling of olive oil, shallots and Gorgonzola cheese made you want to sing as you dined on this dish. For beef lovers, I highly recommend the Filetta con Porcini. A thin fillet of beef grilled in porcini mushroom sauce. Yes, there are pizzas here, and no, I didn't have the room to sample one, but the owner, Horacio, guarantees that they are great as well. I trust this man! This restaurant cares about your dining experience! I cannot remember the last time I could say this, but every dish I dined upon ranged in the well-above-average to exceptional. This is one my best finds in the past year. The restaurant is a great combination of thoughtful owners and tantalizing dishes. Divina Cucina, means Divine Kitchen, and the food here, is indeed, Heavenly.





The City of Sierra Madre gives notice, pursuant to State of California law, that the City Council will conduct a public hearing to consider a text amendment to the City's Zoning Code (Title 17), and corresponding Zone Change and General Plan Amendment for the proposed Residential Canyon (RC) Zone. The difficulties inherent in applying citywide R-1 Zoning standards to the Canyon area of Sierra Madre prompts the need to adopt zoning standards that allow reasonable development of properties located therein while preserving the unique character and natural environment of this area, as well as preserving the overall quality of life for its residents. The purpose of the new Ordinance is to 1) facilitate residential canyon preservation through single-family development standards; 2) maintain the environmental equilibrium unique to the residential canyon consistent with the aesthetic of its rustic and historic character; and 3) establish dwelling size, lot coverage, building massing, and floor area ratios specific to the Canyon area. Adoption of the Ordinance includes amendments to the City's Zoning Map, Land Use Map and Title 17 (Zoning Code) of the Sierra Madre Municipal Code. At the September 16, 2010 meeting, the Planning Commission recommended approval of the proposed Canyon Zone Ordinance to the City Council.

lican leadership will be pursuing something Democrats have yearned for: hearings and Congressional investigations into the Executive Branch.

Since Democrats took control of Congress, there's been clamoring for thorough and transparent investigations into the Bush Administration's dismissing warnings prior to 9/11, "fixing the facts" to lie us into the Iraq War, sanctioning torture and "renditions" to "black-site prisons", etc. There was disappointment when President Obama said we should "look forward, not backwards", confounding those who saw public accounting not as settling scores, but as deterring others who'd consider such malfeasance in the future.

Republicans harbor no such reticence. Their target is one whom House Oversight and Government Reform Committee Chairman Rep. Darrell Issa (R-CA) referred to on comedian Rush Limbaugh's show as "one of the most corrupt presidents in modern times", Barack Obama. (Later on CNN, Issa said he was referring rather to a "corrupt administration". Then, he explained what he really meant to say was handling so much money, much of it appropriated of "Huh?") under President Bush, can't help but have a "corrupt-

Top priorities for Congress were to be jobs and the economy, but Rep. Issa's committee is set to tackle more urgent matters, such as overreach by the FDA under the food safety bill signed by President Obama. Rep. Jack Kingston (R-GA), Chair of the appropriations subcommittee covering the FDA, referred to "nanny-state politicians" and assured that "the system we have is $\bar{d}oing$ a darn good job."

HHS Sec. Kathleen Sebelius might testify at Rep. Issa's hearing that, as she's stated before, "Today, one out of six Americans gets sick from food-borne illness each year with 128,000 people ending up in the hospital and 3,000 people dying every year." Republicans would argue that doesn't justify the bill's cost of \$1.4 billion over five years. Democrats could counter by comparing that to the \$152 billion annual cost to the U.S. economy of food-borne illnesses (according to a Georgetown University study) - but Republicans have never been good at math.

Another concern to be addressed by Rep. Issa's committee is the hurt feelings of multi-millionaires on Wall Street, who've had to endure accusations they share culpability in the 2008 economic meltdown. Fannie Mae and Freddie Mac are the new designated culprits. If they're at fault, though, it's for coming late to the party; Fannie and Freddie being prohibited from dealing in sub-prime mortgages while Wall-Streeters were already making fortunes off them - along with their collateralized securities, derivatives and credit-default swaps.

The task of Rep. Issa's committee is to place blame for the Great Recession on those grifters who snookered naive loan officers at Chase, B of A and Wells Fargo into granting bad loans. Blame a meddlesome government and shiftless poor folks, not victimized Wall Street innocents.

Other committees are planning their own hearings. Homeland Security Chair Rep. Peter King (R-

The new (pre-owned) Repub- NY) wants to delve into the "radicalization" of Muslims in the U.S. He might attempt to debunk reports that recent terrorist plots have been thwarted by authorities who'd been tipped off by - Muslims. Rep. Lamar Smith (R-TX) wants his Judiciary Committee to hold hearings on whether Attorney General Eric Holder has sufficiently addressed threats to election integrity posed by members of the New Black Panthers. ("Both of them", quipped Keith Olbermann).

Barely into his seat again as Chair of the House Rules Committee, Rep. David Dreier (R-CA) has already embarrassed himself and his constituents here in the 26th District. Try as he might, he was unable to make sense to Greta Van Susteren in an interview on Fox News. When asked about Republican pledges to hold hearings on proposed legislation, then scheduling a vote to repeal the Affordable Care Act with no hearings at all, Dreier replied there would indeed be hearings on the matter - after the vote had been taken. This didn't get him anywhere, so he then explained there would be no hearings because the legislation itself was one sentence long. The impact of repealing the ACA might be monumental, but the language itself was short, so therefore no hearings. (Van Susteren evinced a clear expression

Republican handlers are aware of the concern over jobs, and that President Obama, at fifty-percent approval, is still polling significantly higher than Congress. "Obamacare", therefore, won't do anymore as the label for the Affordable Care Act; it's now "The Job-Killing Healthcare Act". Rep. Dreier had some trouble following the script in his interview with Van Susteren; at one point simply referring to "The Healthcare Act", then stammering to retroactively add the "Job-Killing" part.

In this new hearings-crazy House, why no hearings on repeal of the Affordable Care Act? Probably, because then they'd have to specify what they're willing to repeal. Referring to parts of the act that are already in effect, or will be this year, do they want to return to having young adults kicked off their parents' plan at 23, rather than 26? Let insurance companies deny coverage to sick kids upon discovery of a "pre-existing condition"? Let insurance companies cancel coverage if you get sick? Allow lifetime caps on coverage? Revoke tax credits to small businesses providing coverage for employees? Force seniors to again pay full price for prescriptions falling in the "doughnut hole" of Medicare coverage? Let insurance companies spend as much of your premium dollar as they want on marketing and executive bonuses, and as little as they want on actual healthcare?

Already, Rep. Darrell Issa has sent over 150 letters to businesses, trade associations and think tanks requesting lists of regulations they'd like to see eliminated - regulations established in the interests of We the People, but which might affect the profits of those who purchase House members.

We're told such actions relate to jobs, but the end result is more jobs moved overseas, continued high unemployment at home, and more tax breaks encouraging off-shoring defended by Rep. David

I wish there'd be a Congressional hearing on that.

America, Down **But Never Done**

As we turn a new year, we find ourselves confronted with many problems that collectively have caused some to claim that the American era is finished. Wars, terrorism, recession and debt have given rise to a crisis of confidence. But I write today with unshakeable conviction that the American era is just beginning. This is not a wish, it is a certitude, and to prove that, we have only to look at our history and character.

We can start at the very beginning if you wish. Our country was birthed in total opposition to the prevailing wisdom which held that the young, untrained, ill-skilled farmers and yokels of these distant colonies would never be able to hold off, let alone defeat, the British Redcoats, believed by many to be the greatest army ever fielded in combat up to that time. Our country also faced a grave test less than one hundred years into its young history in which brother fought against brother in a civil war that was all but sure to end the experiment in self government and devotion to the rights of all men. But America prevailed as it has always done.

Coming into modern times, there has been no shortage of pronouncements that the American era is ending. In the 1930s, the Great Depression was supposed to mark the end of our economic system. The rise of Nazi Germany and then Stalinist Russia both promised the triumph of a better engineered man, devoted to the common good rather than the selfishness of the individual. In the 1950s, Americans were caricatured as unthinking, unimaginative company-men. The 1960s saw a counterculture movement which again postulated the end of traditional American culture. The 1970s witnessed recession and inflation of such magnitude that many believed we truly had reached the terminus of our age of plenty. In the 1980s, we were told that the Japanese model of state-directed economic policy, with its emphasis on the collective at the expense of individual dreams and aspirations, was the only model which could guarantee economic dominance. In the early 2000s, it was Europe's turn to be our superior. Given our tech-bubble collapse and the rise of the kinder, gentler European Union, we were relegated once again to hasbeen status. And finally, today, we are told that China will inevitably dominate us and the rest of

The common thread across all the years, decades and centuries has always been the absolute conviction in the irrelevance of the American model and the pronouncement of its imminent defeat. But that hasn't happened; it isn't happening now; nor will it happen anytime in the foreseeable future. The common thread is a lie postulated by those who stand opposed to the American ideal of self government and individual freedom, both of which necessarily undergird and sustain the economic success and international influence we have enjoyed and will con-

After all was said and done, America was born and survived its civil war to see its founding principles finally extended to all Americans. The massive economic dislocations of the depression, oil shortages, stagflation and tech-bubble collapses pushed us back a bit into unfamiliar, defensive, self-doubting postures, but they didn't last for long. So, too, the false prophesies of a superior man engineered and controlled by strong fascist or communist elites collapsed on to the ash heap of history – ironically, the place where we were supposed to land. The most highly touted of the Asian models, Japan Inc., has flirted with national bankruptcy for more than a decade, and Chinese successes of the last several years mask growing social and political problems which are more likely to rip the country apart than to propel it into a world leadership role.

America is not dead, nor is it terminally wounded. Our future today is brighter than it has ever been, despite the current economic statistics. We've overcome 10% unemployment before; we've overcome the ravages of inflation; we've risen out of the public



malaise and self-doubt which has periodically gripped our national psyche. The reason we have overcome all previous setbacks and challenges, as we will overcome our current challenge, is found in our national character. The true strength of a nation can't be measured by the sum-totalling of its economic parts. Those are but a result of true strength. The two are inseparable and thankfully they exist together in our country today, as they have since the beginning.

We are a people who can do great things. We are free-thinkers, tinkerers and perpetually restless, always seeking to build a better mousetrap and reap the rewards there from. We are fortunately also a free people where such innate human curiosity and desires are allowed a free rein. Spiritually, philosophically and politically we seek to improve what already is and to create what is not yet.

In contrast to our national character, stands the rest of the world. Europe still clings to the privilege of birth and cannot assimilate those foreign to its shores. The Muslims cannot provide tolerance to the different religious factions within Islam, let alone to its other religious minorities. Dreier Introduces Four Key Bills on Opening Day of 112th Congress



WASHINGTON, DC -Congressman David Dreier (R-San Dimas, CA) today introduced several bills aimed at helping our economy recover, cutting federal spending, securing our borders and protecting our natural resources.

"My top priority is to get our economy going again," Dreier said. "Helping families keep more of their hard-earned money and providing businesses with additional resources to invest in their operations

Dreier re-introduced the Fair and Simple Tax Act, a comprehensive tax reform plan to simplify the code and reduce the burden on taxpayers. The bill creates an optional one-page tax form with three simple rates of 10, 15 and 30 percent. The bill also preserves major deductions, including mortgage interest, charitable, state and local taxes, the child tax

will help create jobs and get our economy back on

credit and the personal exemption. Dreier also re-introduced his bill to enhance oversight of government programs and eliminate waste, fraud and abuse in federal spending. The Biennial Budgeting and Appropriations Act, establishes a two-year budget cycle to streamline the budget process and improve the fiscal management of government programs.

'It is critical to our economic recovery that we rein in the size and scope of government," Dreier said. "Reforming the federal budget process will allow Congress to better scrutinize federal spending, helping us to cut wasteful and duplicative programs."

In addition, Dreier is demonstrating his longstanding commitment to stopping illegal immigration by introducing the Illegal Immigration Enforcement and Social Security Protection Act, to crack down on the hiring of illegal immigrants.

"The roots of our broken immigration and employer verification system can be traced to three underlying factors: too many unreliable documents, including the Social Security card; a faulty employment verification system; and lax enforcement," Dreier said. "Improving the security of the work authorization verification program will help to stop the hiring of illegal immigrants."

The legislation creates an easy-to-use electronic verification system based on a secure, tamper-proof Social Security card, which employers can use to electronically verify the work authorization status of prospective employees. The bill also raises penalties for employers who hire illegal immigrants and increases personnel to enforce compliance with the

Finally, Dreier is introducing bipartisan legislation to protect and enhance recreational opportunities on our federal lands in the San Gabriel Valley. The Angeles and San Bernardino National Forests Protection Act adds to existing wilderness areas in both the Angeles and the San Bernardino National Forests and directs the Forest Service to address the backlog of maintenance, focusing on the recreation areas impacted by the Station Fire. In addition, this legislation includes language expanding forest fire prevention activities.


"As two of the most visited national forests in our nation, it is vital that we preserve recreational opportunities in the Angeles and San Bernardino National Forests for future generations," Dreier said. "In addition, we must continue to ensure that the men and women who work to prevent and contain wildfires have the ability to do their job safely and effectively." In drafting this legislation, Dreier worked with dozens of individuals, organizations and local officials who are focused on protecting this area, including property owners, as well as the Los Angeles and San Bernardino County Fire Departments.


Yesterday as I drove home from work I heard on the radio that Philosophy Courses had become very popular in a certain New York Community College. In a separate article in the New York Times an article appeared identifying itself as a forum for contemporary philosophers. Both the item on the

radio and the newspaper column emphasized the importance of taking time out and reflecting upon what it is that we are actually doing with our lives. Coincidentally, I happen now to be reading a book entitled HOW TO LIVE –OR--- A LIFE OF MON-TAIGNE-- IN ONE QUESTION AND TWENTY ATTEMPTS AT AN ANSWER.

For those few of you who were not previously acquainted with Montaigne he is described on the book jacket as a Renaissance writer who is perhaps the first recognizably modern individual. He wrote free-roaming explorations of his thought and experience that were unlike anything written before. He called them "essays" meaning attempts or tries. The method used by Montaigne was to write down everything that he thought of as he addressed himself to any subject. He did not seem to be concerned with impressing anyone else but instead was obsessed with just trying to understand what influenced him to do as he did. His writings were a best-seller four hundred years ago and the book I am describing is a best-seller today. As described on the book cover the writings of Montaigne have for over four hundred years drawn readers to him as they search for companionship, wisdom, and entertainment-and in search of themselves. Readers for centuries have found in these writing an inexhaustible source of answers to the haunting question, "How to live?"

The popularity fo the Montaigne book, together with the radio message and the New York Times article have shown me that I am on the right track. In my approximately 165 articles entitled Stuart Tolchin On Life I, unknowingly of course, have addressed myself to the same philosophical concerns that interested Montaigne and which now seem to be important to contemporary readers and students. One of my favorite chapters in the Montaigne book is entitled Read a lot, forget most of what you read, and be slowwitted. Really, this could and should be my rallying cry. I read continually, forget most of what I read and have a lifetime of spectacular non-achievement to testify to my slow-wittedness.

Why to everything, of course. In addition to paying attention reflect upon what you perceive rather than absorbing what others tell you. Montaigne lived through horrid times of religious, dogmatic wars in which death was always preferable to compromise. Somehow these times do not seem so very far away.

The New York Times Article explains that Philosophy, among other things is that living activity of critical reflection in a specific context, by which human beings strive to analyze the world in which they find themselves, and to question what passes for common sense or public opinion. This is the very process utilized by Montaigne and it is described in the New York Times article as THE EDUCATION OF GROWN UPS. This process must form part of the life of a culture. It must engage the public and influence how a culture converses with itself, understands itself, talks to other cultures and seeks to understand them. The article emphasizes that without a willingness to seriously reflect upon our own actions we cannot really engage in dialogues intended to influence one another. Without this willingness to look at ourselves from different perspectives the best we can do is simply to exchange opinions in kinds of parallel monologues that carry no influence other than to already believing members of the choir to whom we

preach. Yes, I think my articles are on the right track and at long last they have obtained some physical recognition. Hung upon the walls of my favorite breakfast place, Andy's Coffee Shop on Colorado two blocks west of Hill are a couple of my articles next to my favorite table. Check out the good food at Andy's and meet the owner Yesenia and the server Lorena, both delightful folk. While at Andy's notice the other contemporary figure and customer to whom a portion of the wall is dedicated. This contemporary hero is Steve O, one of the stars of Jackass. As I understand it the Jackass programs and films (I have not seen them) are completely within the spirit of Montaigne as they question the rules of society and the boundaries of good taste and endeavor to entertain at the same time. I really don't know, but like everything else, you'll have to chick it out for yourself.

Mission Impossible --Obama's "Lame Duck" Congress

After the November elections, members of Congress returned to Capitol Hill for their "lame duck" session with one huge piece of

unfinished business - the Fiscal Year 2011 budget. And while they failed to complete work on the budget - the government is currently running on a "continuing resolution" that funds federal agencies through March 4, 2011 - the lame duck session of the 111 Congress did pass legislation on a number of serious issues in the last weeks in Washington.

The most significant piece of legislation was the agreement between the Obama administration and the Republican leadership to extend the Bush era tax cuts. Congress opted to extend the tax cuts for all taxpayers by another two years. The package also extended unemployment benefits by thirteen months, and cut the Social Security payroll tax by 2 percent, from 6.2 percent to 4.2 percent through 2011. It is estimated this legislation will add almost \$1 trillion to the national debt over the next two years.

A lot happened in the area of national security. The Senate ratified the new START nuclear weapons reduction treaty by a vote of 71 to 26. Both the House and Senate voted to repeal the Pentagon's "Don't Ask, Don't Tell," policy which barred gays from serving openly in the military. Congress also enacted the Fiscal Year 2011 Defense Authorization Act, which, at roughly \$725 billion, including \$158 billion for the wars in Iraq and Afghanistan, is the highest Pentagon spending bill since World War II.

Congress did not, however, pass the controversial DREAM Act, which would have created a way to legalize young undocumented immigrants who arrived in the United States before the age of 16, lived here continuously for at least five years, and who either go to college or enlist in the U.S. military. The legislation passed in the House but was blocked in the Senate.

Congress also reauthorized the "America COMPETES Act" which is intended to maintain U.S. global economic and scientific leadership by supporting basic research, improving science, technology, engineering, and math (STEM) education and fostering innovation, especially in the area of new energy technologies.

Congress also approved the Government Performance and Results Modernization Act of 2010. This legislation forces federal agencies to prioritize programs and report quarterly on progress in reducing redundant programs and increasing efficiency as a way to save money.

Congress also adopted the FDA Food Safety Modernization Act - the first major overhaul of U.S. food safety laws since the 1930's. It gives the Food and Drug Administration new authority to recall tainted food. Under current law, the FDA can only recommend a recall and it is up to the food companies to voluntarily recall suspect foods. The Act also gives new protections to whistleblowers who report fraud-related food manufacturing

And finally, Congress passed the James Zadroga 9/11 Health and Compensation Act, which would provide \$4.2 billion in compensation and long-term health-care benefits for first responders who became ill from working at Ground Zero in the wake of the September 11 attacks. Originally the bill would have provided \$7.4 billion over 10 years, but this was scaled back to \$6.2 billion, and then to \$4.2 billion over concerns about the legislation's costs and how to pay for it. The legislation is named for James Zadroga, a police detective who died from respiratory disease it was believed he contracted at Ground Zero.

Closeups of Saturn's Moon Rhea Show Unprecedented Detail

Newly released by NASA, images of Saturn's second largest tures cutting across the surface of the moon, somemoon Rhea obtained by the Cassini spacecraft show dramatic times at right angles to each other. A false-color views of fractures cutting through craters on the moon's surface, revealing a history of tectonic rumbling.

During a flyby In March 2010, the Cassini craft made its closest approach to Rhea's surface so far, swooping within 62 miles. An even closer flyby is planned on January 11, 2011, when Cassini will take images just 47 miles above the icy, cratered surface. "These will be by far the best images we've ever had of Rhea's surface—details down to just a few meters will become recognizable," said Thomas Roatsch, a Cassini imaging team scientist based at the German Aerospace Center In-

stitute of Planetary Research in Berlin.


Images from the March 2010 flyby show bright, "wispy" fractures resembling some that were first spotted on another part of Rhea by the two Voyager spacecraft in 1980 and 1981. At that time, scientists thought the wispy markings on the trailing hemispheres—the sides of moons that face backward in their orbit around a planet—of Rhea and the neighboring moon Dione were possible cryovolcanic deposits, or the residue of icy material erupting. The low resolution of Voyager images prevented a closer inspection of these regions at that time. Since July 2004, Cassini's imaging cameras have captured pictures of the trailing hemispheres of both satellites several times at much higher resolution. The images have shown that the wispy markings are actually exposures of bright ice along the steep walls of long scarps, or lines of cliffs, indicating that tectonic activity rather than cryovolcanism produced the

view of the entire disk of the moon's Saturn-facing side reveals a slightly bluer area, likely related to different surface compositions or to different sizes and fine-scale textures of the grains making up the moon's icy soil.

"These recent, high-resolution Cassini images help us put Saturn's moon in the context of the moons' geological family tree," said Paul Helfenstein, Cassini imaging team associate, based at Cornell University, Ithaca, N.Y. "Since NASA's Voyager mission visited Saturn, scientists have thought of Rhea and Dione as close cousins, with some differences in size and density. The new images show us they're more like fraternal twins, where the resemblance is more than skin deep. This probably comes from their nearness to each other in orbit."

The new images have also helped to enhance maps of Rhea, including the first cartographic atlas of features on the moon complete with names approved by the International Astronomical Union. Thanks to a recent mission extension, Cassini will continue to chart the terrain of this and other Saturnian moons with ever-improving resolution, especially for terrain at high northern latitudes, until

The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

Q: I spend between 10 and 20 hours a week applying on-line and sending out resumes to about 20 employers with no results! What am I doing wrong? Unemployed and desperate

Dear Unemployed and desperate,

There could be numerous and various reasons. So, I am going to answer your question based on the information that you have given me. "It's a job looking for a job"! It's time you find out what you would like to do. Employment should be enjoyment. Start by identifying what you really enjoy. This could be an activity, volunteer work, a hobby or something that you enjoy doing with your free time. Look for a company or industry that is this area. Re-write your resume and focus on your skills, experience and education that will target your new interest and objective. Devote time and a lot of energy in your new job search. You will be surprise how many companies you will find and the type of positions that will be open to you. 40 hours a week, 52 weeks a year for the next 30-40 years doing something you hate does not make either a happy person or sense. Finding out what you like to do will result in finding the right company, the right job and being happily employed.

Q: I am being told that I dress inappropriate for job interviews. I have my own personal and unique style of dressing and refuse to change it. Stylish.

I would suggest that you research the company culture before applying for employment or accepting interviews. This can be achieved by searching the company on the internet, reading trade magazines, talking with employees, sitting outside the company and observing employees entering and exiting the building or asking the person who contacted you for the interview. You can not change a company's culture. Find employment with a company that matches with your style of dressing. They do exist.


Molly's Miracle

I will never forget the day I first met "Molly". She had just been adopted by my dear friend and neighbor Frederick, who fell in love with her the very moment he saw her. I had asked Fred to call me when she arrived, so I could meet her and be the first to welcome her to the neighborhood. Somehow, I already knew that Molly was going to play a very important part in Frederick's life, but I had no idea that she would have such a positive impact on mine.

If you have never visited an SPCA facility, I highly recommend it, even if you are not ready to adopt a pet. Although it can be an emotional and somewhat sad experience, if you are an animal lover one thing is for sure, it will prompt you to do whatever you can to play a part in saving homeless animals in your community. Frederick's visit to the San Gabriel Valley Humane Society last year proved to be a life changing experience for him. It had been a few months since he had said good-bye to his beloved four-legged friend of many years, "Chelsea" who died of bone cancer, and Fred was finally ready to adopt a new companion. After a walk down the isle between the fenced kennels housing numerous adult dogs waiting to be claimed, he asked the caretaker if there were any puppies available for adoption. He was taken to the puppy department, where he stepped through the doorway and immediately locked eyes with a browneyed babe who looked up at him as if to say, "we were made for each other"! Frederick didn't even bother to walk over and take a closer look at her before he told the lady at the desk, "I definitely want that one". He later confided in me that he felt as though Chelsea was there, telling him to take that little girl home; "She is the one for you". Chelsea had played such a big part in Frederick's life over the past several years, and that would be a tough act to follow for sure, but his instincts told him he had made the right choice.

This was not great news, but with the proper treatment, we knew Molly would recover and grow strong and healthy. Unfortunately, Molly did not respond to treatment as expected, and soon it became clear that there was something radically wrong with her. She was re-evaluated and re-diagnosed with a much more serious dis-



ease...Molly had distemper. Canine distemper is a contagious, very serious viral disease with technically no known cure. The disease affects dogs, and certain species of wildlife such as raccoons, wolves, foxes, skunks and ferrets. Young, unvaccinated puppies and non-immunized older dogs tend to be more susceptible to the disease. Molly had been vaccinated by the SPCA after being rescued, but unfortunately it was too late. She had already been infected with the disease before she received the vaccination.

This news broke Frederick's heart. After the trauma of loosing Chelsea earlier that year, he was just not ready to let go of his new-found friend. When I got the news about Molly's real diagnosis, it was all I could do to hold back the tears. I have always been a praying person, believing that God listens and answers our prayers, however it had been quite some time since I had prayed to God, and I was way over-due for a good long talk with Him. I guess sometimes it takes a traumatic experience to drive us to our knees. I did get on my tnees that day and I prayed that God would grant a miracle for Molly. I thanked Him for people like Frederick who are willing to care for the animals he created. I asked God to let Molly live, mostly for Frederick's sake, because he clearly needed her

Things got worse before they got better. There were moments when it seemed Molly would die, then she would get stronger and show signs of recovery. This went on for several weeks, but with continued medical attention and consistent tender loving care, Molly did indeed recover. She now lives a full, very happy healthy life and she brings smiles to the faces of all of the neighbors who greet her during our daily walks together. I don't know what I would do without seeing that open, honest little face with those perky ears peering up at me each morning before our walks. I elieve that God did indeed grant Molly a miracle, not the least part of which is manifested in the joy that little girl brings to Frederick and to me, as well as so many others who know and love her! Thank God for "small" miracles!

The (Fabulous) House and Views That Come with Sierra Madre's Famous Wistaria Vine

Tucked up against the foothills of Sierra Madre is the historic Wistaria vine (Wistaria is the historic spelling of choice used by the city) that made Sierra Madre "famous." Noted in the Guinness Book of World Records as

the world's largest vine, the plant rambles through a property recently listed by Judy and Amy Skiff of Dickson Podley.

We've done yearly articles on the vine and the associated mid-March festival in town with all the details, (http://mtnviewsnews.com/old/mvnews/v04/MVNews_2010_03_13. pdf on p. 18).

On and off for almost a century, two adjacent properties on Hermosa have been open for public viewing one day a year. The current owners have been delighted to share this "Sierra Madre Treasure" with the public since their purchase of the property in 2006.

The first question people inevitable ask is about hosting the viewing in March every year. "It's really been no trouble at all to host the vine viewing," reflects the owner. "The city and the local Chamber have it all well organized."

"They pay insurance during the period visitors will be onsite, so our liability is covered. Then it's only a very brief time during the year and we get to enjoy it for months in between! There isn't any requirement that we open our property on that one day in March. We've considered it a privilege. A new owner can choose to open it or not, BUT we've loved doing

What Wistaria Festival visitors never see is the stunning 3520 square foot (measured), four bedroom, three bath home that sits atop a sloping site affording twenty to thirty mile views toward downtown LA. "We get fabulous sunsets all year long and get to enjoy the vine from above. When in bloom it's like

a rolling sea of purple for a month or two," say the owners. Inside, the film production designer owners remodeled just about everything over the past five years, using their creativity, design and artistic backgrounds to create a soothing Sierra Madre sanctuary. New Cost-Saving Flood Insurance Option From FEMA

(NAPSI)-There may be good news for residents and business owners in locations recently designated as high-risk flood areas. Starting in 2011, the Federal Emergency Management Agency's (FEMA's) low-cost insurance policy may be available to help them save on flood protection.

Making New Insurance Requirements More Affordable

Flood risks are dynamic and change over time due to a variety of factors, including changes in the natural landscape, the impacts of land use and development, and the condition of flood control structures such as

multi-year effort has been underway to update the nation's flood maps to reflect these changes. The new maps are providing more accurate information about where flooding is most likely to occur.

As a result, many property owners are finding that their risk has changed and they may now be required to purchase flood insurance. Fortunately, FEMA understands the financial burden this may place on some property owners and is expanding eligibility for its popular lower-cost flood insurance

A New Insurance Option Beginning January 1, 2011, a new insurance rating option from FEMA's National Flood Insurance Program (NFIP) will allow many property owners who previously didn't qualify, to take advantage of the low-cost insurance for two years before they are required

to pay standard rates.

The program will make Preferred Risk Policies (PRPs), which start at just \$129 a year, available for properties that have been newly mapped into high-risk areas due to a flood map revision on or after October 1, 2008.

"Floods are the nation's most costly and frequent natural disaster and those who are now in the highest risk areas really must have flood insurance protection. But we recognize the challenge of additional expenses in the current economy. This new option provides time for residents to adjust to the higher risk level-and continue their flood coverage at a more affordable rate," said Edward L. Connor, Acting Federal Insurance and Mitigation Administrator.

While extended eligibility for the PRP does not become effective until the start of the new year, policyholders who believe they Since mandated by Congress in 2003, a may qualify should contact their insurance agent for further details.

> After two years at the reduced PRP rates, policies will increase to standard rates. However, there are other options to reduce cost, including a grandfathering provision, use of elevation ratings and higher deductible



PERFECTIONISM

We all know what this means. It is that parallel road that runs beside us, representing where we want to go ,and someday become. (If we can only get it right.)
As we are all too easily reminded, we are not "there" just yet. So, on we struggle. What to do? Try harder? Be even more demanding than usual? Surely, there must be a solution.

Self-Talk

At the heart of the change game lies the desire within us to be fully alive. Perhaps the biggest misconception we entertain is that we are our habits. When we say, "I am fat" or "I am lazy," there is no distinction made between what we do and who we are. This leaves very little room for improvement, due to the critical nature of internal dialogue. In time, discouragement sets in which can lead to becoming even more self-punishing in our behavior.

Compassion

Kristen Neff, of the University of Texas, Austin, is one of the world's leading researchers on the topic of self-compassion. Her research indicates that, contrary to the belief we need a high degree of self-criticism to effect change, long-term change is more likely with selfcompassion. In a 2007 set of studies published in "The Journal of Personality and Social Psychology," Neff found that those who tested high on the self-compassion scale were less upset by their failures and less likely to obsess about them. Those who were harder on themselves were less resilient after setbacks and were prone to anxiety and depression. Essentially, this suggests that being compassionate about our shortcomings and failures allows us to become more resilient, healthier people. In that respect, our failures offer us opportunities to grow.

Discipline

Usually, when we think of discipline, we visualize a tough love approach. But, what happens when the inevitable failure occurs? Instead of pushing harder, we might use this as an opportunity to acknowledge our accomplishments to date, remind ourselves that we are whole, and, with compassion intact, continue on.

Recipe of the Week: **Red Wine Beef Stew With** Potatoes & Green Beans

INGREDIENTS:

- 2 pounds beef chuck for stew, cut into 1-inch cubes
- Kosher salt and freshly ground black pepper 3 tablespoons butter
- 4 medium carrots, peeled, halved and cut into
- 1-inch chunks
- 3 small onions, diced
- 2 tablespoons all-purpose flour 2 (14 1/2-ounce) cans reduced-sodium beef or chicken broth
- 2 cups dry red wine
- 1 cup canned crushed tomatoes
- 3 sprigs fresh rosemary
- 2 medium russet or Yukon gold potatoes, peeled and cut into 1-inch chunks
- 2 handfuls green beans, ends trimmed

DIRECTIONS:

Season the beef cubes lightly with salt and pepper. Heat 2 tablespoons of the butter in a heavy 6-quart pot over medium heat. As soon as the butter starts to turn brown, add half the beef and raise the heat to high. At first, the beef will give off some liquid, but once that evaporates, the beef will start to brown. Cook, turning the beef cubes on all sides until the pieces are as evenly browned as possible, about 5 or 6 minutes after the water has boiled off. If the pan starts to get too brown at any point, just turn down the heat a little. Scoop the beef into a bowl and brown the rest of the beef the same way using the remaining butter.

Scoop out the second batch of beef, then add the carrots and onions and raise the heat to medium-high. Cook until the onion starts to turn translucent, about 5 minutes. Stir in the flour until it has been worked into the veggies and you can't see it any more. Pour in the chicken broth, wine, and crushed tomatoes, and toss in the rosemary. Slide the beef back into the pot

and bring the liquid to a boil.

Turn down the heat so the liquid is just breaking a gentle simmer. Partially cover the pot and cook 50 minutes. Stir the stew several times while simmering so it cooks evenly and nothing sticks to the bottom.

Stir the potatoes into the stew, cover the pot completely, and cook until the potatoes and beef are tender, stirring occasionally, about another 45 minutes. Add the beans and cook for another 5 minutes until the green beans turn bright green and are cooked through but still have a nice snap to them.




