When activists scaled the Oak and Sycamore trees in Arcadia's Wilderness Park on Wednesday, they hoped their presence would stop the county from destroying over 11 acres of trees. Famed environmentalist John Quigley, 50, along with Travis Jochimsen, 28; Julia Posin, 23 and Andrea Bowers, 45 were arrested late in the day.

The LA County Sheriff's Department from the beginning treated the protest, including those on the ground, as if it were a major incident.

Seniors Get The Green Light

Redevelopment Agency Agrees To Provide Funds For The Hart Park House Renovation Project

At long last, the Hart Park House - Senior Center Renovation Project is fully funded.

Dubbed the Cinderella Project years ago by for Senior Community Commissioner Pat Birdsall, the project was started in 2004. Over the years the senior community has been able to earmark \$227,000 however, the total cost of the renovations is approximately \$467,000. Efforts to obtain grant funds have not been successful and the project had been at a standstill until Tues-

day evening. On Tuesday, at the Community Redevelopment Agency Meeting, the Agency, which consists of the five elected council members, agreed unanimously to use funds from the CRA reserve account to make up the \$240,000 funding gap.

Before the decision was reached, members of the senior community spoke to the city council during the public comment period.

The speakers, which included former commissioners Pat Birdsall,

Ken Anhalt, and current commission Vice Chair Alice Hultsman, urged the council to take the appropriate steps so that the project could be completed.

When the council meeting adjourned and the CRA began, City Manager Elaine Aguilar reviewed the current project list and the balances in the CRA accounts. She noted that there was approximately \$176,000 in unallocated funds available and approximately \$2 million dollars in the CRA Reserve Account.

Because the center is located in the city's CRA district, CRA member Nancy Walsh recommended that the funds for the Hart Park House project be taken from either of the two funds or both. She told the agency members that the Seniors had not only been waiting since 2004, but also had completed the Senior Master Plan in 2007 and raised \$30,000 in seed money so the city could solicit grants.

After a brief discussion it was the consensus of the group that the \$240,000 be taken from the CRA

Water Rate Hike **Approved**

After months of community hearings, a contentious Prop 218 exercise and an extensive community outreach/education program that the city embarked upon after the Prop 218 protest failed, the Sierra Madre City Council, in a 4 to 1 vote, raised the water rates for residents of Sierra Madre. Councilmember Mary Ann MacGillivray was the only dissenting vote.

At stake was the city's ability to pay the existing bond obligations on time. Those obligations, entered into years before this council was seated, were created in the 1990's and for politial reasons, rates were not raised as recommended to keep up with the increasing costs.

The amount of the increase, which has been inflated by opponents, will be less than the initial \$8 per month per rate payer. A chart of the new fees and the Ordinance in its entirety can be found on page 10 of this edition.



house on Sunday, January 30, 2011 at 7 p.m.


Appearing on the same bill will be musical guests, which include some of the finest singer-songwriters from Southern California, as well as musical friends from Europe.

"On Gold Mountain"—Sierra Madre's 2011 "One Book One City" Selection

Activities Planned Throughout February

The Sierra Madre Public Library is pleased to announce "On Gold Mountain: The One-Hundred Year Odyssey of My Chinese-American Family," by Lisa See, as the City's 2011 One Book One City selection. With a full schedule of events throughout February celebrating Chinese culture, highlighted by a program and book signing with Ms. See, the Library invites everyone to read this highly acclaimed multi-generational family saga that traces the emigration and establishment in California of one of the most esteemed Chinese families in America.

Lisa See is perhaps best known for her novel, "Snow Flower and the Secret Fan," for which she traveled to a remote area of China to research the "secret writing" that was invented and used by Chinese women for more than a thousand years. Hailed as "imaginative" and "achingly beautiful," the novel became a New York Times Best Seller, with foreign-language rights sold to 38 countries. A movie based on the novel is scheduled to be released

Ms. See's other novels include "Peony in Love" and "Shanghai Girls," absorbing bestsellers with unique stories based on the lives of Chinese women in the 17th and mid-20th centuries, respectively. The idea for a mystery novel, "Flower Net," which was nominated for an Edgar Award, was developed as she was doing research for "On Gold Mountain.'

Ms. See was born in Paris and raised in Los Angeles. Although she lived with her mother, she was able to spend countless hours with her father's family in Chinatown. "On Gold Mountain" was her first book, undertaken when she was approached by her aged "aunties" to document their family history. The book traces the journey of Lisa's great-grandfather, Fong See, who overcame unrelenting obstacles to become the 100-year-old godfather of Los Angeles's Chinatown and the patriarch of a sprawling family. The breadth of the book extends beyond a personal family saga, however, providing an in-depth historical perspective of the Sino-American diaspora, and of a culture in transition, often hidden from Western eyes. One Book One City hopes to inspire members of the community to engage in reading the same book at the same time. In addition to giving people an opportunity to read a notable book, the Library is organizing a number of events to explore the book and its cultural perspective in depth. Copies of "On Gold Mountain" are available for checkout at the Library and for purchase at Sierra Madre Books.

The One Book One City kickoff, which will include activities celebrating Chinese New Year, is set for Saturday, February 5, 2:00-4:00 p.m. at the Library. City to look at Ten-Day Ban on All **Outdoor Watering**

Total Shutdown planned of MWD Treatment Plant *March 18 to 27.*

The city's department of water and power is set to go before City Council later this month to urge a total prohibition on all outdoor watering from March 18 to 27 during a temporary shutdown of a major regional water treatment plant.

According to city Officials, "The Metropolitan Water District of Southern California (MWD), which supplies about 60 percent of Pasadena's water, is planning a seismic upgrade of its Weymouth Treatment Plant in LaVerne and will stop all water deliveries from the plant to Pasadena and neighboring cities to perform the retrofit.

For those 10 days, Pasadena must rely solely on groundwater and reserves. We'll need to eliminate all outdoor watering to cut citywide water use by 40 percent.

In prepare of the shutdown officials asking are residents, well in advance, to share this information with your gardener, family, neighbors and co-workers. Notification about the final plan approved by the city council will be mailed in February to every household they said.

Officals say "during a typical March, PWP customers use almost 250 million gallons over a 10-day period. During the shutdown, we'll have only 150 million gallons."

They also said PWP would temporarily ease enforcement of the current water shortage rules from March 11 to 17 only. Residents may water on any day that week and as much as they see fit to prepare landscaping for the shutdown.



Grand Opening Dana gym

Fourteen months after ground was officially broken on construction of what was then called the Joint-Use Gymnasium Project, a grand opening ceremony was held Tuesday afternoon for what is now called the Dana Gym on the northeast corner of the property at Dana Middle School, 1401 S. First Ave.

Officials from the City of Arcadia, Arcadia Unified School District, police and fire departments, Chamber of Commerce, students, and many others filled the bleachers to capacity in the 8,700 square-foot building that represents the first and only gymnasium operated by the school or the city other than those at the high

With the City and school district contributing an equal share, Dana Middle School and the school district will get priority use of the facility during school hours (weekdays from 7 a.m. - 5 p.m.), while the City's Recreation and Community Services under director Sara Somogyi will oversee scheduling of activities on weeknights (5 p.m. – 10 p.m.), weekends, and summertime.

Sign-ups began last month for an adult men's winter basketball league set to start Jan. 23.

The City is also offering winter classes for adults 50 years of age and older in yoga, strength training, line dancing, tai chi, zumba gold and aerobics. Registration is open now for classes at the new gym and the Community Center, 365 Campus Drive, by calling Arcadia Senior Services at 574.5130 or signing in at www.ci.arcadia.

The gymnasium features telescopic bleachers, a full-size basketball court, two cross courts, a home/visitor electronic scoreboard, office space, restrooms and an outdoor asphalt basketball court on the west side of the building.

While it was Mayor John Wuo and School Board president Cung T. Nguyen who were the point people at the time of the groundbreaking, it was current school board president Lori Phillipi and Mayor Peter Amundson who officiated on Tuesday. Both praised the cooperation of the two entities, with Mayor Amundson noting that the building was not only only opening on schedule but came in significantly under the initial \$3 million budget.

The initial plan was for the City and School District to each contribute 25% to create a combined matching of 50% from the state, which agreed to approve a grant of up to \$1.5 million for the gym. But construction bids came in under budget at about \$2.8 mil., potentially allowing a lower contribution of about \$650,000 each from the City and Arcadia Unified School District, the latter acting as the primary agency for the project.

CITY OF HOPE REACHES HISTORIC TREATMENT MILE-STONE WITH 10,000TH BONE MARROW TRANSPLANT

Bone marrow or stem cell transplantation—collectively known as hematopoietic cell transplantation (HCT)—is a complex, often lifesaving procedure in which stem cells are used to help cure patients of their cancer. His physician told him he should prepare himself for inevitable death. But his cousin, a physician in Los Angeles, knew that City of Hope was launching a bone marrow transplant program. The young student went to City of Hope to undergo a bone marrow transplant, and he has remained in remission for 35 years.

Each year, he and thousands of other survivors, their families and hospital staff attend City of Hope's Bone Marrow Transplant Reunion, a rite of spring held on the Duarte, Calif. campus.

City of Hope currently performs nearly 500 bone marrow transplant procedures each year. During transplant, patients typically undergo high doses of chemotherapy and/ or radiation that helps eradicate the cancer cells but also destroy their bone marrow and immune systems. Patients then receive stem cells from one of several sources which then rebuild their blood and immune systems. Different sources of stem cells can be utilized depending on the disease and the availability of stem cell donors. Autologous transplants isolate and use the patient's own healthy stem cells. Related donor allogeneic transplants use donor stem cells from a compatible relative or sibling, while unrelated donor allogeneic transplants use cells from altruistic volunteers who registered themselves as potential bone marrow do-nors. Umbilical cord blood stem cells also can be used. City of Hope recently was recognized by the National Marrow Donor bone marrow transplant in 1976 on a young to achieve above average survival rates in transplant patient.

"All of our research and treatment efforts reflect our commitment to patients and their families-recognizing each of them as a dignified human being with a story to tell and a life to live," said Forman. "They also are our partners in developing new therapies for those who will come to us tomorrow for care. There are a significant number of people who are alive today because they were and are a part of something we did at City of Hope that was both bold and new." City of Hope laboratory and clinical scientists continue to make transplants safer and more effective, and help extend the length and quality of patients' lives. New transplant procedures are improving cure rates, extending the procedure to older patients and expanding the use of transplants to diseases beyond leukemia, lymphoma and multiple myeloma.

City of Hope virologists were among the first to develop an investigational vaccine to prevent cytomegalovirus, a potentially deadly infection to HCT patients. City of Hope researchers also are developing genetically modified T cells that can specifically recognize cancer cells and help improve the cure rate of transplant. They also created a technique combining HIV-fighting gene therapy with HCT to cure patients of AIDSrelated lymphoma while blocking the virus causing AIDS. City of Hope scientists also are investigating using radioimmunotherapy instead of total body radiation in which engineered immune molecules deliver targeted radiation directly to cancer cells in the


Snow Predicted in Duarte on Jan 22 Good Sledding Ahead for Kids at Duarte Park

Just this past week I visited an old friend, Derek's Bistro. It's hidden in a small shopping strip on the corner of Marengo and Glenarm and you have probably driven by hundreds of times. Derek's Bistro is named after the former owner and now is in the hands of a former patron, Mr. Tony Auer, I had the opportunity to discuss past and present Derek's and enjoy Chefs Paul Ragan's menu. Paul was a personal Chef for years and was trained at the French Institute of New York City.

Tony explained to me that Derek had been hinting for years that he might retire and that he was looking for the perfect person to take over, that special person that has knowledge of not only wine but food and the importance of customer service. 





TOPDOG/UNDERDOG

A Review - by Despina Tsiknas-Arzouman

"Topdog/Underdog" a Pulitzer Prize winning play (2002) returns to the Fremont Centre Theatre on Saturday, January 29th, 2011. I saw this play last August, 2010, and because it was such a hit, it is returning for another run. The play was written by Suzan-Lori Parks who wove together some brilliant dialogue between two African-American brothers (named Lincoln and Booth - their dad's idea of a joke) depicting the epitome of diametric internal confusions between the eternal polarities between basic human (natural) needs and what is real moral identity. While such confusion is a challenge every person is e'er faced with, at the heart of this confusion also lies the outrageous abandonment by their parents -- leaving these two young boys to fend for themselves while still juveniles at the respective ages of 16 and 11 years of age. The playing-out of their predicament is situated and further exacerbated by their shared living space: a rented room in tenement -- no running water, with a shared toilet, outside and down the hall. So, the staging is simple - with no evidence of any "creature comforts" most of us Americans are used to. The brothers continually struggling for some semblance of clarity (through their sheer unguided survival). For two decades, the brothers' banter vacillates between brotherly love, sibling rivalry, and absolute estrangement from with their outright impersonal hostility (obviously fed by the unacknowledged deep-rooted fears of not knowing or ever learning how to think, learn, love, or live rightly).



At the heart this play is an irony (and metaphor) which comes from their names: Booth and Lincoln. The younger brother (Booth) wants to become a master of the con game of three card monte (which game is about duping the mark, or 'sucker,' through misdirection), something the older brother (Lincoln) had already mastered, but in an effort pursue legitimate employment, abandoned the con game years before. The irony is that their own parents (mistakenly) brought two children into the world and the only thing they "gave" to them the ultimate form misdirection; i.e. the misdirection between the psychologic principles of "down" and "up" (i.e. nature vs. morality, respectively). One comes to see that "down-and-up," "dark-and-light," "wrong-and-right," "black-and-white," "fear-and-love," are qualities of mind and the eternal (and internal) battle we each are faced with every day.

ORDINANCE NO. 1312

AN ORDINANCE OF THE CITY OF SIERRA MADRE. CALIFORNIA AMENDING SECTION 13.04.060 OF THE SIERRA MADRE MUNICIPAL CODE REGARDING WATER RATES AND ADOPTING A WATER RATE SCHEDULE

WHEREAS, the City provides water service pursuant to Chapter 13.04 of the Sierra Madre Municipal Code,

WHEREAS, by prior action, the City Council proposed to increase the rates charged for water service;
WHEREAS, notice of the proposed rate increase, and of a hearing thereon, was mailed pursuant to Article XIIID, Section 6 of the California Constitution;
WHEREAS, a full and fair public hearing was held on July 13, 2010, at which all interested persons were permitted to present oral and written testimony with respect to the proposed

WHEREAS, a full and fair public hearing was field with all 12, 2015, an increased rates;
WHEREAS, following the public input portion of the public hearing, written protests against the proposed increased rates were tabulated in accordance with the procedures previously adopted by the City Council;
WHEREAS, a majority protest against the proposed increased rates does not exist; and
WHEREAS, in response to public input, the City Council desires to adopt rates that are lower than previously proposed, none of which exceed the proposed rates;
THE CITY COUNCIL OF THE CITY OF SIERRA MADRE, CALIFORNIA DOES HEREBY ORDAIN AND RESOLVE AS FOLLOWS:
Section 1. Section 13 04 060 is hereby amended to read as follows:

<u>Section 1</u>. Section 13.04.060 is hereby amended to read as follows: "13.04.060 Water Rates

The City Council shall adopt a schedule of water rates pursuant to Article XIIID, Section 6 of the California Constitution.

The City Council shall adopt a schedule of water rates pursuant to Article XIIID, Section 6 of the California Constitution."

Section 2. The rate schedule set forth in Exhibit "A" to this Ordinance is hereby approved as the schedule of water rates for the City.

Section 3. The City Council may annually consider the rates set forth in Exhibit A and may, by Ordinance, reduce or delay the effectiveness of any scheduled rate.

Section 4. The City Council directs that the Water Users Tax imposed by Section 3.36.090 shall be collected at the rate of 9%, beginning with the effective date of the water rates increase. The Council may, by ordinance, resolution, or order, rescind this direction effective as of any date subsequent to the adoption of that ordinance, resolution, or order. Such rescission shall not be interpreted as an increase of the rate of the Water Users Tax for purposes of Articles XIIIA or XIIIC of the California Constitution. Notwithstanding any other provision of this Ordinance, the Council would not have adopted any portion of this Section if any other portion of this Section were invalid or unenforceable and the provisions of this Section are not intended to be severable from each other. provisions of this Section are not intended to be severable from each other.

Section 5. The City Council finds as follows:

A. The purpose of the City's water rates is to fund costs associated with providing water service to water customers in the City.

B. Revenues derived from the water rates will not be used for any other purpose and will not exceed the funds required to provide water service.

C. The amount of the rates, and of the Water Connection Fee (Bi-Monthly Meter Charge), imposed upon any customer does not exceed the proportional cost of the service attributable to the customer.

Section 6. If any section, subsection, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this Ordinance. To the extent the provisions of the Sierra Madre Municipal Code as amended by this Ordinance are substantially the same as the provisions of that Code as they read immediately prior to the adoption of this Ordinance, then those provisions shall be construed as continuations of the earlier provisions and not as new enactments.

Section 7. This Ordinance shall take effect thirty days after its passage and adoption pursuant to California Government Code section 36937. The rates established by this ordinance for Fiscal Year 2010-11 shall be effective July 1, 2011. Rates for each subsequent fiscal year shall automatically take effect on July 1 of that fiscal year.

Section 6. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published according to law.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SIERRA MADRE ADOPTING BY REFERENCE, PURSUANT TO GOVERNMENT CODE SECTION 50022.2, THE 2010 CALIFORNIA CODE OF REGULATIONS, TITLE 24 - THE 2010 CALIFORNIA BUILDING STANDARDS CODE WITH CERTAIN EXCEPTIONS, MODIFICATIONS AND ADDITIONS AND AMENDING THE SIERRA MADRE MUNICIPAL CODE

As I See It

Hearing of something like the shootings in Tucson, my first reaction is to tune in a news channel. When I did, though, all I heard were protests of "Don't blame us! "It's not our fault!" I was reminded of a kid who runs

home from school to advise, "If you get a call from the principal's office, I had nothin' to do with it!"

They were trying to distance themselves from remarks by Pima County Sheriff Clarence Dupnik, mentioned in Susan's column last week, who said "(T)he anger, the hatred, the bigotry that goes on in this country is getting to be outrageous", adding that "people who are unbalanced are especially suscep-

Megyn Kelly would have none of it as she interviewed Sheriff Dupnik on Fox News. The words "Democrat" and "Republican" hadn't been spoken until Kelly noted that "... you ran for office as a Democrat" before asking, "... why are you putting a political spin on this?" Sheriff Dupnik responded by recalling a time when "politicians from different parties could sit down, forget about their ideology, and work on the country's problems." Kelly then pressed about whether it was appropriate for him to "stir the pot" with such partisan remarks.

Tea Party Nation leader Justin Phillips described Sheriff Dupnik as a "leftist sheriff" and the shooter as a "leftist lunatic". The Heritage Foundation pointed their finger at other peoples' words in warning that those who "point their fingers at other peoples' words" will "only further coarsen our civil discourse."

Bill Clinton, speaking on the anniversary of the Oklahoma City bombing, observed that words enter a "vast echo chamber" and "fall on the serious and the delirious, alike; they fall on the connected and the unhinged, alike."

Negative ads and incendiary rhetoric are decried, but are employed because they work. Republican strategists long ago decided to turn Franklin Roosevelt's "the only thing we have to fear is fear itself" on its head, telling voters to be afraid - to be very afraid.

In 2000, Al Gore failed to carry his home state of Tennessee because voters were told to be afraid he would take away their guns. In 2004, Sen. John Kerry (D-MA) lost because voters were told to be afraid this decorated combat veteran would decimate the military. In 2008, we were told to be afraid of a candidate who was "palling around with terrorists".

In the healthcare debate we were told to be afraid of "death panels" that would "pull the plug on Grandma" (Sen. Charles Grassley, R-IA). Rep. Michelle Bachmann (R-MN) called on supporters to show up "armed and dangerous". Nevada Republican senate candidate Sharron Angle referred to "2nd Amendment Remedies". Arizona Republican Governor Jan Brewer reported (falsely) "our law enforcement agencies have found bodies in the desert . . . that have been beheaded", while her state's Sen. John McCain warned (falsely) Phoenix had become the "number two kidnapping capital of the world".

The problem is not so much the incendiary rhetoric, but that those who encourage it want to make it easy for nutcases to get guns.

Aside from the speculation, we know the shooter was armed with a Glock 19; a semi-automatic with high-capacity magazine. The 30-round clip was illegal from 1994 to 2004, when the Republican Congress allowed the national assault weapons ban (prohibiting magazines larger than 10 rounds) to expire.

Last year Gov. Brewer signed legislation allowing Arizonans to carry concealed weapons without a permit. It was perfectly legal for the gunman to approach the congresswoman at a public event with his fully-loaded Glock; he only broke the law once he pulled the trigger. We know he'd previously been rejected for enlistment in the Army and had been repeatedly kicked out of school because of mental health issues.

According to state figures, Arizona has over 120,000 records of individuals with "disqualifying mental illnesses" that should go in the national background-check database for gun purchases, but has to date submitted less than 5,000 for inclusion.

Our Rep. David Dreier expressed "hope this tragedy will play a role in diminishing some of the strident statements we have heard". Rep. Drier is working to repeal the Affordable Care Act, not concerned about halting expansion of mental health resources to help prevent similar tragedies. In 1993 he opposed the Brady" bill, not concerned about criminals arming themselves with no background checks required. He opposed the 1994 assault weapons ban, not concerned with Texas and Arizona becoming armories for Mexican drug cartels, or the consequences of easing the purchase of 30-round magazines. But he is concerned about "harsh words".

A ban on 30-round magazines may not have averted the tragedy; a single bullet, a knife or a baseball bat can be deadly. But there wouldn't have been those other victims; the federal judge, the grandparents, the young congressional staffer - and Christina

Truth And Deficits

Lots of ink has already been spilled discuss- much spending) the governing the awful tragedy in Tucson, and most of it has been the worst sort of journalism, attempting to blame the right, the Tea Party, talk radio, gun ownership, or Sarah Palin for what happened without a shred of evidence in support. What makes it even more sickening to watch and hear is the blatant hypocrisy on display. On August 3, 2010, when a black man purposely killed 8 whites and himself credited liberal rhetoric about racist America as his motivation, the press told us to ignore those associations. When Major Hassan yelled "Allah akhubar" before he started his killing rampage at Fort Hood, the press again told us to not rush to judgment and associate a lone act with the Muslim faith. But when a clearly deranged loner shoots a Democratic congresswoman and kills several others, the press announces within 24 hours that this was what Tea Party, talk radio and Sarah Palin caused. Pathetic, manipulative and evil don't even begin to describe the mainstream press, but that is not the point of my article today.

The point of my article, which the press coverage of the Tucson tragedy illustrates, is that truth doesn't always win the day, and that is especially true in politics. What matters in politics is how well you present your case to the voting public, and in this liberals enjoy a key tactical advantage: the support of a liberal dominated mainstream press. I bring this up and am devoting the column to it because the upcoming debate over the size, scope and cost of the federal government will be filled with liberal attempts to prtray conservatives as insensitive and irresponsible for trying to scale back spending.

In essence liberals will try to do what they did when the 1994 Republican Congress stood firm against President Clinton and allowed the government to shut down for awhile as a natural consequence of massive deficit spending. be California law is being PORAC supports AB 144." given a second chance. Assemblymember Anthony "open carry" of unloaded handguns in California. The

prior bill made it through the legislature last year, but failed to get to the Governor's desk when the legislative session adjourned at midnight without completing its business.

"We have laws to license weapons in California and this bill will improve them. It keeps guns out of public places by individuals who are not properly and legally licensed to carry weapons," explained Assemblymember Portantino. "Certainly, most folks would not want people walking down the grocery isle or sitting in a public park displaying weapons. There's a proper place for firearms and having a proliferation of them strapped to hips is something that belongs in a Western movie, not Main Street, California."

Because of the miscue at the end of the 2010 session, AB 1934 by former Assemblymember Lori Saldaña did not make it to the Governor's desk. This oversight means that Californians may walk into a grocery store carrying an unloaded weapon on one hip and the bullets on the other. After seeing a rise in these types of needless public displays, law enforcement officials sought the ban on this open display of firearms. Portantino took up the cause and has worked with law enforcement to reintroduce the "open carry" ban.

San Mateo Police Chief Susan Manheimer, President of the California Police Chiefs Association explains why her group is endorsing Portantino's AB 144. "The California Police Chiefs Association is strongly in support of Assembly Member Portantino's open-carry bill. The open display of firearms in crowded public places creates very real public safety issues - both for the public and for police officers. This is a good-sense public safety bill and we are committed to securing its passage."

Portantino's bill, AB 144, which was introduced Thursday, makes it illegal to carry an unloaded handgun in any public place or street. Law enforcement personnel are exempt as are hunters and others carrying unloaded weapons under specified licensed circumstances.

"PORAC members are committed to keeping our communities safe, and this practice wastes a huge amount of law enforcement officers' time. These people work in groups and they are trained on how to confront peace officers. It is scary for our neighborhoods and businesses," said Lt. Ron Cottingham, President of the Peace Officers Research Association of California, PORAC. "It is

California is one of many states that allow socalled "open carry" which gives gun owners the Portantino (D-La Cañada right to display weapons, though in California Flintridge) has introduced those guns must be unloaded. Carrying loaded legislation to outlaw the firearms in public is already against the law in California. The dispute came to a head last year when gun enthusiasts began showing up in coffee shops and public beaches with unloaded guns strapped to their hips.

"Average Californians understand police officers displaying loaded weapons, they understand hunters, and they even understand those folks who are legally licensed to a carry a weapon. What they don't want is a proliferation of public displays of weapons for no purpose. It's imperative that the public safety of our families and our neighbors' families is protected. It only takes a few seconds to load and fire. This bill is a sensible public safety protection that will make such an occurrence less likely in our neighborhoods," concluded Portantino.

the death of my father freed me to take all kinds of risks that I would not have taken had he still been around. I dreaded the idea of failing and having to face his dis-

appointment, I guess. It was not anger or criticism I feared, just disappointment. It was so important to my father that I be someone of whom he could be proud, whatever that meant. I think my father's sense of himself was highly influenced by the disapproval of his own father. When my father and the rest of the family finally reached America and met up with my grandfather it was very difficult for all of them. As I understand it, my grandfather and grandmother were an arranged marriage, as was customary in those times. My knowledge of the period sort of starts and stops with the movie Fiddler on the Roo,f and psychological compatibility does not seem like one of the areas ever considered by the Matchmaker. For whatever reason, my father's father left the family when my father was just an infant and he was raised fatherless at a time when this was a very uncommon situation.

I can only imagine what my father thought of this situation and believe he, and the rest of the family, was filled with emotion as they reconnected with my grandfather. Unfortunately, it just didn't work out. During his time in America, my grandfather had learned English and had become Americanized. He was embarrassed by the 'Greenhorns" who spoke no English and had no "culture". He demanded that my father and his brothers learn to play musical instruments when they wanted to learn to ride bicycles. My grandfather and grandmother had almost nothing in common other than the ability to make children. My grandfather was physically abusive and the family soon separated. When I came along I know my grandfather was not allowed in the house even though my grandmother lived with us. I can recall his climbing up a fire escape and trying to talk to my sister and me but even being prevented from doing that. I know that, like me and my father, my grandfather had diabetes. I know he died falling out of a streetcar and I know that my father would not go to the funeral, although his older brothers

So why am I telling you this story? What possible relevance does it have to your life or even to mine. I think my family's legacy to me is this in this New Year.

Looking back on it now, I think need to connect and this need is reflected in the 165 previous articles that I have written and you (the imaginary you) have read. I have little need to convince you to do anything, but I do want my feelings and opinions known. After my father's death I believe I am more willing to take risks as I will not have to face disapproval if I fail. The crucial factor is that I want to live a life that would make my father and my grandfather proud even though I know they would disagree with many of the life-decisions that I have made. I live my life often talking to ghosts, ghosts of people I did not know in the first place. I believe that I am not alone in this process. I believe that many of you are also strongly influenced in the way you live your life by your own experience in growing up. Most of the time it is difficult to articulate to ourselves why we do what we do; but we all have consistent personalities and these personalities do not occur at random. We live our lives trying to do something and that something is not just to be entertained, or to be well-groomed, or to be comfortable in summer heat.

Writing this particular article has helped me to understand why I keep writing. . Your reading of the article, imaginary person that you may well be, has helped me to feel a connection. You may not like the article or find it very interesting. It's okay, but occasionally I meet people who know me only from these articles and when they remember something of my writing I am gratified beyond all reason.

NASA Telescope Catches Thunderstorms Hurling Antimatter into Space

Scientists using NASA's Fermi Gamma-ray Space Telescope have from Fermi. In addition, lightning-generated radio signals detected detected beams of antimatter produced above thunderstorms on Earth, a phenomenon never seen before.

Scientists think the antimatter particles were formed in a terrestrial gamma-ray flash (TGF), a brief burst produced inside thunderstorms and shown to be associated with lightning. It is estimated that about 500 TGFs occur daily worldwide, but most go

"These signals are the first direct evidence that thunderstorms make antimatter particle beams," said Michael Briggs, a member of Fermi's Gamma-ray Burst Monitor (GBM) team at the University of Alabama in Huntsville. He presented the findings Jan. 10 at the American Astronomical Society meeting in Seattle.

Fermi is designed to monitor gamma rays, the highest-energy form of light. When antimatter striking Fermi collides with a particle of normal matter, both particles immediately are annihilated and transformed into gamma rays. The GBM has detected gamma rays with energies of 511,000 electron volts, a signal indicating an electron has met its antimatter counterpart, a positron.

Although Fermi's GBM telescope is designed to observe highenergy events in the universe, it is also providing valuable insights into this strange earthly phenomenon. The telescope constantly monitors the entire celestial sky above and the Earth below-and 130 TGFs have been identified since its launch in 2008.

The spacecraft was located immediately above a thunderstorm for most of the observed events, but in four cases, storms were far


by a global monitoring network indicated that the only lightning at the time was hundreds or more miles away. During one TGF, which occurred on Dec. 14, 2009, Fermi was located over Egypt. But the active storm was in Zambia, some 2,800 miles to the south. The distant storm was below Fermi's horizon, so any gamma rays it produced could not have been detected.

"Even though Fermi couldn't see the storm, the spacecraft nevertheless was magnetically connected to it," said Joseph Dwyer at the Florida Institute of Technology in Melbourne, Fla. "The TGF produced high-speed electrons and positrons, which then rode up Earth's magnetic field to strike the spacecraft."

The beam continued past Fermi, reached a location, known as a mirror point, where its motion was reversed, and then hit the spacecraft a second time just 23 milliseconds later. Each time, positrons in the beam collided with electrons in the spacecraft. The particles annihilated each other, emitting gamma rays detected by Fermi's

Scientists long have suspected that TGFs arise from the strong electric fields near the tops of thunderstorms. Under the right conditions, they say, the field becomes strong enough that it drives an upward avalanche of electrons. Reaching speeds nearly as fast as light, the high-energy electrons give off gamma rays when they're deflected by air molecules. Normally, these gamma rays are detected as a TGF.

NASA's Fermi Gamma-ray Space Telescope is an astrophysics



and particle physics partnership. It is managed by NASA's Goddard Space Flight Center in Greenbelt, Maryland. It was developed in collaboration with the U.S. Department of Energy, with important contributions from academic institutions and partners in France, Germany, Italy, Japan, Sweden and the United States.

The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

I am in my 60's and after being self-employed for the last 20 years, I find that I must go back to work for someone else. But, when I look online, my education and experience are outdated. How do I write a resume that will showcase my strong points, excellent people skills, crisis management and creativity? Sixtyish

Dear Sixtyish:

Key questions for you to answer right now are: Why do I want to work? Is it for need or added income? I am bored? Want to give back to society what I have learned? Do I want to do something different or change careers? Once you have answered any of these questions you can move onto the next step.

First, I would say you already have a lot of value that you can bring to the table for any company or organization. You are obviously a successful business owner to have survived for over 20 years. So you will want to showcase those skills and accomplishments as strong points in your resume.

You should use a functional resume format instead of a chronological formatted resume. The functional resume is the best resume format for: career changers, people with over 15 years work experience with one company or in the same field. There are at least three sections in the body of a functional resume: Summary, Accomplishments and Experience, Skills, Education. The Summary section should state your key qualifications and achievements. You should categorize the skills section with headings (i.e, Customer Service, Strategic Marketing and Sales Planning, Finance and Budgets, etc.). List your accomplishment statements under each Skill heading. Try to list those accomplishments that you are most proud which have happened within the last five years. Accomplishment statements can include: business development, written and verbal communications skills, management, motivational and organizational skills, creative thinking and problem solving skills. Be sure to add quantitative and qualitative terms to your accomplishment statements. List community, volunteer, associations and membership activities, classes or conferences that relate to the position you are pursuing. Also include sections for computer, software and language skills. I would "fudge" the dates and probably use the following 2000 – present in the Accomplishment and Experience section. Do not list dates in the Education section. Include a focused and intriguing cover letter with your resume. The cover letter should state why you are submitting your resume, the position you are seeking, and the reason you no longer want to be self-employed. Emphasize that you will bring your entrepreneurial spirit and success- driven value to their organization.

My dear Auntie Evelyn turned 97 years old this past November, and believe me when I say that you would never know it if I hadn't told you. She is remarkably healthy for her age, she has a "steel-trap" mind that is as sharp as a tack and she still lives on her own! Evelyn Swallow-Leake was born in 1913 in Worcester, Massachusetts. In one of my recent conversations with Aunt Evelyn, she recounted a very vivid memory of the many times she accompanied her Uncle Carl Woods (my great uncle) on a horse-drawn carriage, during his lumber deliveries from one area of town to another. Evelyn, who was about 12 years old at the time, would wait by the road side after school had let out, knowing that was when Uncle Carl was expected to pass by with two horses towing a load. She would ride along with him during the latter part of the day, until it was time to take the horses back to the barn.

Even as a young child, Aunt Evelyn was an avid animal lover who was fortunate enough to have had pets of her own. If you haven't already, perhaps now would be a good time to mark February 19, 2011 on your calendar. It's estimated that 98 percent of these addresses (4.2 billion unique addresses) have already been assigned for public and private use. No one is expecting the Internet to come crashing down on that day in particular but it will make things a little more interesting for those in the business of assigning IP addresses.

Typically, IP addresses are assigned by ISP's and other telecom providers for the purpose of granting access to the telecommunications network known as the Internet. The IP addressing scheme single device at the same time. is what allows devices connected to the Internet to find and communicate with each other and it does this by ensuring that society. Under IPv6, there are a total of 2¹²⁸ (about 3.4×10³⁸) addresses or 340,282, 366,920,938,463,463,374,607,431,768,211 ,456 individual addresses (pronounced -Three hundred and forty undecillion, two hundred and eighty-two decillion, three hundred and sixty-six nonillion, nine hundred and twenty octillion, nine hundred and thirty-eight septillion, four hundred and sixty-three sextillion, four hundred and sixty-three quintillion, three hundred and seventy-four quadrillion, six hundred and seven trillion, four hundred and thirtyone billion, seven hundred and sixty-eight million, two hundred and eleven thousand, four hundred and fifty-six).

Back in 1962, one of the largest homes on the west coast was razed; the lot graded out and left to accumulate weeds for four decades. In the interim, the homesite was acquired by CalTrans for a section of freeway never built. Left in limbo for forty plus years, Pasadena

City Council member Steve Madison asked for "development ideas" from the public, early in the last decade.

New Arlington Drive residents in 2002, Betty and Charles

Mc Kenney, fondly known as Kicker, volunteered that year to be part of the committee to decide the future of the land. "We knew what we DIDN'T want right away," said Betty. "No new buildings. The garden idea evolved."

And so did the Mc Kenneys' involvement. "When we're not out here in the garden, we're back at the condo figuring out how to fund and expand it," chuckled Charles. "It takes \$40-50,000 every year, just to maintain, prune and irrigate the site. We solicit donations and support from organizations and individuals... We even sell marmalade made at E. Waldo Ward from our orange orchard here. Every little bit helps. Our next batch will be ready sometime in March. Check our website for details."

Today, Arlington Garden, located at Pasadena Avenue and Arlington Drive, is a tranquil 3 acre jewel with over 800 Mediterranean and drought tolerant plants. The gently sloping plot, a demonstration site for low water usage landscape, sits amidst the urban environment of Huntington Hospital, the bustling retail of Old Pasadena and the hundreds of "Millionaires' Row" condos along Orange Grove and its tributary streets. The city now holds a lease on the garden land from the

Mayita Dinos, deemed Best Xeriscaper (drought tolerant landscaping) in Los Angeles Magazine's Best of LA, designed the master plan of Arlington Garden into 25 outdoor "rooms", such as the Butterfly Garden, Citrus Grove, the Arroyo, the Succulent Garden, the Amphitheater, the Mediterranean allee of olives and cypress, the Vernal Pool, the bocce ball court, the Oak Grove with complementary underplantings of dry summer tolerant narcissus, gooseberries, golden currant, wildflowers, huechera (coral bells), hummingbird sage and

The garden has its bits of quirkiness that imbue a bit of light hearted humor into the garden. "A friend decided we needed a "fairy door" and one appeared at the bottom of one of our trees at Christmas this year," said Betty. Near the newly installed fairy door is a mysterious water feature, inviting mystified query as to its source.

"AG is being built 'room by room' as funding becomes available," Dinos commented, "The Arlington Garden has



been championed by the City of Pasadena from the beginning. In particular, I think we can count Mayor Bill Bogaard and Councilman Steve Madison among the many fans of the AG; if it weren't for their stalwart support, it wouldn't be here. They really 'get' what this garden means to the community of people, birds, insects, and native plants of Pasadena!"

"Betty and Kicker McKenney, along with many friends, have created a unique and wonderful new park in southwest Pasadena," reflected Mayor Bill Bogaard. "I hope it gains more and more support and continues as a great resource for the community."

Other yearly memorials have been installed in Tokyo and Sao Paolo. Afterward, the 90,000 wishes were sent to an island off Reykjavik, Iceland, per Ono's request."



Ruminations

In the process of working with one of my patients earlier this week, the subject gravitated to concerns she had about "turning off her mind." "Mary" stated that it was normal for her to be worried about one thing or the other most of the time. When I asked her if there was a time during the day when she did not worry, she replied that she no doubt worried even while sleeping! Apparently, the subject matter wasn't an issue: she was an equal opportunity worrier.

From a clinical point of view, we know that unmanaged stress leads to the development of physical problems. Since Mary presented with severe neck pain, along with the usual treatment modalities, we talked about taming that monkey mind we all know so well.

In the Health and Wellness section of last Sunday's "Los Angeles Times", there was

an article on mindfulness therapy. It mentions a research article published in The Journal of Consulting and Clinical Psychology which combined findings from thirty-nine previous studies involving 1,140 patients. Mindfulness therapy was found to be effective for alleviating anxiety in patients recovering from cancer and other serious illnesses; the greatest degree of improvement, however, was demonstrated in those patients suffering from mood disorders, including anxiety.

What exactly is mindfulness therapy? In a nutshell, it is the practice (practice, practice, practice) of bringing the mind back to the present moment. This is done a number of ways, including breath work, movements, and various mental exercises that dismantle the habits associated with worry. As an example, the article in the Times shares an insight by a patient who does this simple practice when negative thoughts occur: "There's a thought, and feelings are not facts." To realize that our feelings need not be our source of truth could go a long way in reorganizing our stress habits.

Another practice that works well in this busy world is to ask ourselves, "Where are my feet?" Inevitably, if we take a few breaths, we find that initially we were nowhere near those feet but, after a moment of mindfulness, we find them just where they ought to be.

Recipe of the Week:

Corned Beef and Cabbage Tarts

INGREDIENTS:

- * 2 crust pastry recipe
- * 2 Tbsp. olive oil
- * 1 red onion, chopped
- * 1/2 large head red cabbage, chopped
- * 3 cloves garlic, minced
- * 3 Tbsp. balsamic vinegar
- * 1 tsp. sugar * 1/2 cup water
- * 1/2 cup cooked cubed corned beef or ham
- * 1 cup cubed Gruyere or Swiss cheese
- * 1/4 cup grated Parmesan cheese

DIRECTIONS:

Prepare pie crust and divide dough into four pieces. Roll out each between waxed paper into 7" rounds. Fit each into a 4" tart ring, or simply put the crusts on two cookie sheets. Set aside.

Preheat oven to 425 degrees. Saute onion in olive oil in a large skillet until soft. Then add cabbage, vinegar, sugar, and 1/2 cup water. Cover pan and simmer for 10 minutes, until cabbage is soft, stirring frequently. Then uncover pan and cook for 5-8 minutes longer on medium high heat, stirring frequently, until liquid is absorbed.

Divide half of the cabbage mixture evenly among the pastry circles. If you aren't using the tart rings, just mound the mixture in the center of the circles of pastry. Divide the corned beef evenly onto the cabbage mixture. Sprinkle with Gruyere cheese cubes and grated Parmesan cheese, and top with remaining cabbage mixture. Fold crust edges over the top of the cabbage mixture, pleating to form a ruffled edge. Bake tarts at 425 degrees for 20-30 minutes. Remove tart rings and serve. Serves 4
