DICK SALE, LONGTIME SIERRA MADRE SEARCH AND **RESCUE TEAM MEMBER PASSES**

Alfred R. 'Dick" Sale of Eagle Rock, long time mountain rescue volunteer, died February 14 at Huntington Memorial Hospital. He was 80. Dick, a renowned wilderness searchand-rescue authority, electronics hobbyist and HAM radio operator, was easily recognized by his full beard, belt and red suspenders, bolo tie and his Stetson hat.

His motto was: "Mountains and wilderness don't care, you take care, be safe".

He was born on September 15, 1930 in Altadena and spent his boyhood at Switzer's Camp in the San Gabriel Mountains, where his mother was the camp cook. He worked at Rockwell as a photographer specializing in high speed photography and worked with the NASA space program in the 1960s and '70s. He married his first wife Barbara in 1950, and together they raised three sons. After her death in 1973, he carried on

Always civic minded, Dick served on the Civil Defense Commission and the Traffic Commission for Temple City, and won election to Barbara's seat on the Temple City School Board after she died.

Sale enjoyed teaching children and adults about wilderness safety. From 1962 to 1971 he served as Scout Master of Boy Scout Troop 157 in Temple City. He became an accomplished mountaineer and volunteer group leader for the Sierra Club Angeles Chapter's Basic Mountaineering Training Course (BMTC) from 1971 to 1976. He then joined California's first mountain rescue team, Sierra Madre Search and Rescue (SMSR). He enjoyed a long and storied affiliation with the American mountain rescue community and was active as an SMSR operations leader, working with the sheriff's department, organizing wilderness searches and rescues both locally and internationally until his passing. From 2003 onward he made regular trips to Taiwan as the lead instructor for that nation's mountain rescue teams, which formed under his guidance, and whose members consider him the father of the Taiwan Mountain Rescue Association.

He is survived by his beloved wife of 28 years, Melody Peterson of Eagle Rock, and his two surviving sons, Terry Sale of Denver, and Jeffrey Sale of Orange County, and six grandchildren. His is pre-deceased by his second son Donald. Memorial services will be announced, to be held in the local mountains in the spring.



WISTARIA FESTIVAL SHUTTLE TICKETS NOW AVAILABLE ONLINE

The Sierra Madre Chamber of Commerce reminds you that shuttle tickets to ride up to view the Wistaria Vine at its annual Wistaria Festival are now available online. The 2011 Wistaria Festival will take place on March 20th, 2011.

The Wistaria Festival features tours of the world's largest blossoming plant, certified as such by the Guinness Book of World Records. Each year, the property owners upon whose land the vine sits, the Solts and the Dorrances, open their property to allow thousands to view the vine. Dozens of Sierra Madre residents volunteer to act as docents at the property, telling the story of the vine, which was originally planted from a 1-gallon pot that was purchased for \$0.75 in 1894. At its peak, the vine covered more than an acre of ground, and in the early 20th century was so large that it even destroyed a home that was under it.

In addition to the tours of the vine, the two main downtown streets of Sierra Madre are closed to traffic so that 175 juried crafters and artists can set up booths to display and sell their arts/crafts. Downtown village shops are open, and more than a dozen musical acts perform at multiple outdoor venues. Memorial Park is transformed into a combination Kids/Food zone, as bouncy houses, slides, rock climbing and other kids attractions set up in the park alongside food vendors, both for profit and non-profit alike.

The shuttle to the vine from downtown avoids a long uphill walk from downtown to the neighborhood in which the vine sits. "Day of" tickets for the shuttle have been reduced from \$15 to \$12 this year, and pre-sale tickets are just \$10. This year, for the first time, seniors and kids (6 to 16) receive a discounted rate of \$7. Children under five ride for free. There is no charge to view the vine.



culture as a Caucasian-looking, mixed race child with red hair fascinated her listeners. She commented that in spending extensive time with her Chinese grandparents, she considered herself Chinese, as that's what surrounded her. Not the red-headed girl she saw in the mirror.

An interesting repartee developed between See and another author about the decision to write about family "secrets." The audience member shared that she felt some guilt in revealing family secrets. See, bluntly, said she felt the opposite. Nothing was secret, she replied, as the family decided to share their stories, though it took years and years to unravel them fully. And sometimes, sharing those stories lead to lightening the emotional carried for a lifetime.

When See's Aunt Sissee finally allowed her to start documenting family stories and history, the floodgates finally opened. Before that, the Chinese traveled a difficult road, often technically living outside the law, as the main character in On Gold Mountain, did. From his "contract" marriage to Leticie, a Caucasian, because interracial Chinese marriages were not allowed to their initial business of making crotchless underwear or "Fancy underwear" for "Fancy ladies"... er...

Sudden Closure of Post Office Raises Concerns By Dean Lee postal service chose not to go

The United States Postal Service went ahead Monday with plans to close the only Post Office east of Lake Ave and north of the 210 freeway, serving an area with more than 65,000 residents according to city staff.

The Post Office at 1355 North Mentor Avenue, became the center of an hour long debate during the council's last regular meeting Feb 7, with postal officials, residents and Congressman Adam Schiff's office all taking sides. At issue was a lack of any notification

about the closing.

Councilmember Margaret McAustin said they needed to send a very strong letter to Schiff's office in support of the location something the council agreed to along with also sending a copy to The United States Postal Service.

"To keep us informed as he [Schiff] receives information back from the postal service about the community process that apparently was not followed," she said. "And if there will yet be an opportunity for full public input."

Councilmember Chris Holden asked that the letter request halting the closer something that did not happen. There was no answer Friday after making a call to the location. An employee at the Fair Oaks office said the station had in fact closed Monday.

United States Postal Service Consumer Affairs Manager Consumer Affairs Manager Teresa Lamb Simpson said Alicia Delgadillo said at the Schiff had asked postal Feb 7 meeting they were not closing any post office, calling the process a "relocation" to the existing 1100 North Fair Oaks Postal Service building.





Last spring, CPR performed by three bystanders saved Little League parent Jill Hisey, who suddenly collapsed during a game at Hugo Reid Park. Two Little League moms and a scorekeeper - Sue Selinske, Mary Lesh and Matthew Breda – immediately stepped forward to do CPR until paramedics arrived less than five minutes later.

"I was so fortunate," Hisev said. "I am cadia American Little League. "We are

coaches and league officials to take the CPR training class. Their grant will pay the training cost for up to 75 people for each league.



EDISON REPLACING TRANSMISSION TOWERS IN DUARTE

Southern California Edison has begun work removing electrical conductors in Duarte on the westerly towers within the Edison property/easement between Tocino Dr. and Greenbank Ave. and within Hacienda Park and the Rancho Duarte Golf Course. The work is being done in preparation of replacing tower structures in conjunction with Edison's Tehachapi Renewable Transmission Project (TRTP) to construct new and upgraded transmission lines and substations between eastern Kern County and San Bernardino County.

On Sunday, Feb. 27, work is scheduled between 6 a.m. and 10:30 a.m. at Huntington Dr. at Encanto Parkway for conductor removal. For safety reasons, the affected portion of Huntington Dr. will be closed briefly during that time period.

Edison's Tehachapi Renewable Transmission Project, once completed in 2015, will deliver electricity from wind energy generators in Kern County south through Los Angeles County and east to San Bernardino County to help meet California's renewable energy goals.

DUARTE PERFORMING ARTS CENTER TO HOST PASADENA NAACP'S ACADEMIC, CULTURAL, TECHNOLOGICAL AND SCIENTIFIC OLYMPICS COMPETITION

For the first time the Pasadena branch of the NAACP will participate in a local competition of the NAACP's Academic Cultural, Technological and Scientific Olympics (ACT-SO) for African-American youth, and Duarte will play a major role in the youth initiative project.

ACT-SO, founded in 1978 by renowned author and journalist Vernon Jarrett, is an enrichment program designed to recruit, stimulate, improve and encourage high academic and cultural achievement among African-American high school students. There are 25 categories of competition in the sciences, humanities, performing and visual arts.

The local competition will take place at the Duarte Performing Arts Center on April 16. More than 50 students from throughout the San Gabriel Valley are expected to compete in categories including biology, math, original essay, poetry, entrepreneurship, computer science, chemistry, physics, oratory, dance, dramatics, musical instrumental classic/contemporary, vocal, photography, painting and drawing. High school students of African descent, who are citizens of the United States, enrolled in grades 9-12 and are amateurs in the categories of competition are invited to participate. Youth who achieve a gold medal in their category will proceed to compete in the Nationals to be held in July during the 102nd NAACP Convention.

Duarte Teen Center Director, Marilyn Mays, who once served as president and executive administrator of the NAACP in Eugene, Oregon where she oversaw the ACT-SO program for eight years, has been named to chair the Pasadena NAACP's ACT-SO competition. The ACT-SO program is intended to be a learning experience. The focus is on enrichment and mentorship. 


if it has anything to do with the fashion industry, she has seen it all and has probably done most of it. Her talents as a producer and

GENE STEVENSON, Seat 4

His credentials show experience as a community leader for various events and organizations. It is this leadership ability that he hopes to bring to the board. In his interview, he discusses that through opportunities one can reach their potential, how the teachings in Louisiana prepared him for the real world, and how the use of technology can transform an organization.

MVN: A student is experiencing a life changing decision. He is considering whether to drop out of school or to stay in school. What would you say to him to keep him in the PUSD system?

Stevenson: I would say to him what people have said to me. We believe in you. We know you can do it. And we want you to get an education. That's what I would say to him. And then I would try to connect him with some

people involved in the school system, whether it would be directly with the district itself or organizations such as NYPD at Muir, a mentoring program for young male students. The idea is to connect them with men in the community who would serve as role models and connect with their parents so that the parents can stay involved with the child, and expose them to opportunity for supporting like tutoring, and opportunities for exposure to services that person might not be aware of or even had the opportunity tho broaden their horizons. With that understanding, it would attract their interest in them wanting to stay in school

We were very poor. You hang around with a lot of kids whose circumstances are a little better than your own. And so you want the things that they have or their families have. But, at those times you can't always see your way clear. It was only when I came to California and had a chance to attend LACC at \$6.50 that my eyes opened up to other opportunities. I couldn't see my way clear in high school. So, I've always appreciated that opportunity. In the South, we were sort of lead to believe that we were not as good as others. Even though there were several high schools, we were not allowed to go to them. My parents were very hard on us in teaching us to deal with the society out there which was not for us And to have confidence in our selves. And the teachers were hard on us in teaching us the basics. We have strong educational program. We all had to take three years of vocational classes so that when we came out if we didn't go to college, we have three shots of being able to go to land a job after we left high school.

MVN: How would you build confidence in the schools?

Stevenson: One thing we need to do is have more representation on the board for both African-Americans and Latinos. We also need to have more representation for Altadena, so I'd like to help influence the board in setting policy and setting direction, and be able to monitor that policy, and allow the administration to do its job and the superintendent to do his job, and assist the board to be more cohesive. Right now, the board is kind of fractured to a large extent I'd like to influence the board to becoming more focused as to what its job is to be, and not allow the public to focus on how fractured it is because that will help to build public confidence in the board and public confidence in the district. So that would help as far as bringing more people back in line in belief that the district can provide quality education. The other thing is getting more male mentors involved in providing assistance to young males. We have several agencies working over here and there. Let's bring them together into some type of coalition agreement, so that there can be a uniform discussion of issues of working together as a coalition to develop solutions, yet maintaining their own identity.

This school district is surrounded by a big private system and parochial schools here, so it has a lot of competition. And for it to survive, it's going to have to focus on how do we make this district a district of choice for parents. We're going to have to look at technology to expand the district capacity. Maybe we need virtual classrooms as an option, or consider how do we really take advantage of the resources that Pasadena has (JPL, Huntington Library) that no other City has in such a concentrated area.

MVN: What factors contribute to the Board being fractured?

Stevenson: Part of it are the times that we are living in. These are very difficult times. Everyone has their own point of view as to what's the best way of handling it. I think that's a part of the issue and the stress of the times that they create. It's also the constituents that each board member believes they have to respond to. But, we only have one constituent and that's the total. When you focus on the total, you're taking care of the individual constituents.

MVN: When you start a business, you have enough capital to fund that business. You define the market that you want to be dominant in and you don't concentrate on just the individual units sold. But schools aren't able to do so. Is that why funding for schools has been a problem?

Stevenson: The school districts are always going to be faced with the problem of debt. That's just genuine to how school districts operate throughout the country. They operate on the margin. Under the margin, what are the ways that would help us be more solvent than we generally are. One way is through virtual classrooms. Through the use of technology, the kids today are probably fully advanced than the people who are teaching them.

MVN: What has been your most difficult challenge?

Stevenson: One of them has been walking into the 8th largest health care agency in the United States and being asked by the director of that agency to reorganize this agency. The Miami Dade Public Health is successfully operating today with a model that I put in place for them.

MVN: What did you think of that experience?

Stevenson: It was the most gratifying because I could see what it was before. I was down there two years ago. And I see what it is now. And, I say to myself, I had a hand in making that happen.





"Gauntlet Hair's" exiguous collections of tracks are adventurous, wild, and energetic - all of which bears a similarity to the likes of Animal Collective. In this case, it's not nearly as sporadic or tumultuous as Animal Collective, but a sound refined and innovative. It'll have one stopping in their tracks once they hear these infectious tunes. A highly anticipated debut album set for later this year is leaving me voracious for what ostensible surprises are in store.

Young The Giant - Arguably the most mainstream pop-rock band on this eclectic list, "Young The Giant's" lighthearted debut LP shouldn't keep the underground indie lovers wandering too far away. There is just an inherently likeable feel to the self-titled album that came out in late 2010. An album that caters to the mainstream masses and under-the-radar listeners, these Newport Beach idealist dudes have the potential to be ferocious in the year ahead. 

This is best selling author Vince Flynn's eleventh Mitch Rapp thriller, but it's



Ronald Reagan campaigned in 1980 describing the \$60 billion budget deficit under President Jimmy Carter as

"criminal". He then more than tripled that deficit barely halfway into his first term. By the time Reagan left, the United States had devolved from being the world's biggest creditor nation to its biggest debtor.

The national debt, \$930 billion when Reagan took office, had never reached a trillion in our history. That mark was surpassed and more than doubled, reaching \$2.6 trillion, by the end of Reagan's second term.

Unemployment stayed below 8% under President Carter. Within two years of Reagan's election, it was over 10%. Before Reagan, a decent blue-collar income with union benefits was enough to own a home and raise a family. After Reagan, Americans struggled to do it on two incomes, while those enjoying union protections fell from over a fifth of the workforce to less than 7% today.

There's that eternal chicken-or-the-egg question; Republicans argue cutting the deficit is a necessary prerequisite for a strong economy, while Democrats maintain that once investments are made to encourage economic growth, the deficit will take care of itself.

The Democrats' argument is bolstered by the fact history has shown it to be true. The Republicans' argument is harmed by the fact there's no evidence to support it, and that their adherence to it seems to change with whatever talking points they're handed on a given day. There's also the question of whether they truly believe it themselves.

David Stockman, Reagan's Budget Director, later acknowledged they really didn't buy into the "Laffer Curve", that graph showing revenue lost through tax cuts eventually returning and increasing as a result of a stronger economy. They intentionally grew the deficit, he explained, in order to starve the social programs remaining as a legacy of Lyndon Johnson's "Great Society".

Deficit fears became a big deal for Republicans as they warned against President Bill Clinton's budget for 1994, which cut taxes for low-income Americans and small businesses, but raised them on the wealthiest 1.2% - thus denying it any Republican support. Deficits continued to be a concern as investments were made in education, environmental protection and children's health. Republicans sought to change the subject, though, as Clinton left office with a \$200 billion surplus, paying down the national debt, with the highest end-of-presidency approval since WWII.

Cheney's statement above was recalled by Paul O'Neil, Treasury Secretary under George W. Bush, as he described a meeting that took place near the end of Bush's second year in office. The first round of tax cuts enacted under Bush had already turned the surplus left by Clinton into a \$158 billion deficit, exacerbated by a "war on terror" and ongoing fighting in Afghanistan. Preparations were being made for the invasion and occupation of Iraq. It was in this context that O'Neil questioned the wisdom of pushing for yet

> V.P. Cheney responded with the aforementioned dismissal of deficit concerns and then, in apparent reference to those sharing his tax bracket, added, We won the (2002) midterms. This is our due.

> Last year, with 15 million Americans out of work, Republicans campaigned on job creation. Now that it's apparent there were never programs behind the slogans, the focus has turned again to the deficit.

Attention is on the proposed budget for 2012, but soon we'll return to the reality that we don't have a budget for 2011 - and will continue to fund the government through a series of continuing resolutions, perhaps all the way to the 2012 elections. In the meantime, Republicans will continue pontificating on \$100 billion in cuts which have nothing to do with job creation, but everything to do with appeasing the corporate interests that bought them their seats.

(They could take care of more than that \$100 billion right away by simply returning to the bookkeeping system employed under Bush, where costs for the wars in Iraq and Afghanistan were kept off the books as "emergency appropriations".)

If there were true concerns about the deficit, there wouldn't have been the insistence on going \$40 billion deeper in debt for a year's extended tax breaks for the richest 2%; there wouldn't be the resistance to President Obama's wanting to cut \$36.5 billion in taxpayer subsidies to oil and gas companies over the next ten years; there'd be support for House bills seeking to apply a .25% transaction tax on Wall Street trades, estimated to bring in \$50 billion to \$150 billion a year; there'd be support for saving additional billions by reforming agricultural subsidies, where threequarters of the funds go to the richest 10% of

There'd be allowing Medicare to negotiate for lower drug prices, which Rep. Peter Welch (D-VT) estimates would save \$156 billion over ten

Instead, Republicans seek to knock out taxpayer support for Big Bird and Elmo on Sesame Street.

When the targets are funding for green jobs, science education, global warming initiatives, pollution enforcement, national parks, fisheries and waterways preservation and energy efficiency, their concern is not the deficit.

When a major goal is defunding Wall Street reforms enacted to prevent a recurrence of the 2008 meltdown, their concern is not the

When cuts to education of \$10 billion (a quarter the cost of the tax break for the richest 2%) are proposed that would take 26,000 jobs from elementary and secondary schools, affect 324,000 special needs students and slash Pell Grants for 1.5 million low income students, their concern is not the future of our country.

Such proposals show a deficit in understanding of history, economics and the interests of the people they're supposed to be serving. As I see it, that's the deficit that matters.

Egypt's Future Is Today GREG Welborn

As protesters took to the streets in Egypt, the odds overwhelmingly favored bloodshed and chaos. The reality, at least as of this writing, is almost a miracle. We don't know yet Egypt's future, but we do know that those who are ignorant of history are doomed to repeat it. At this particular point in time, it is largely the U.S. which will demonstrate whether the lessons of history give Egypt its 1979 or its 1989 moment. As some of you remember, 1979 was the year when Iran's dictator fell, only to be replaced by the mad Mullahs who now subject the country and its people to more misery than the Shah ever imposed. 1989, on the spectrum's other end, is the year when the dictators of Eastern Europe fell, the Berlin wall came down, and freedom and democracy came to people who had know neither for a generation. Both historical moments owe their outcome largely to the actions taken by the U.S., and Egypt today equally depends on what we do in the days, weeks, months to come.


1979 represents one of the saddest moments

in American foreign policy. As a dictator was toppled, the U.S. remained mute on the subject of whom we preferred to rule the country. We pretended that there was moral and geopolitical equivalency between the fledgling democrats who had barely survived under the Shah's oppression and the repressive theocrats who had become strong and well organized in exile. Lending no support to those who truly would have brought peace and dignity to the country, we allowed the Ayatollah's to take control. The error of that decision lives with us to this day.

1989 represents a shining moment in American foreign policy – the capstone in a 44 year history of successful U.S. policies designed to thwart and eventually topple communist tyrannies. This history is important to understand. After WWII, Western Europe was free from Nazis but in ruin and unstable. It faced external and internal threats from communists. Russia quickly gobbled up Eastern Europe, attempted to capture several other countries and fielded an army of covert agents, sympathizers and committed members throughout Western Europe. The communist parties in France and Italy were bigger than their democratic rivals, well organized and ruthless in their pursuits. There, as in Egypt, the smart money would have said that the communists would win.

The U.S. adopted the Truman Doctrine, declaring our goal of protecting democracy and freedom in the west and around the world. We countered external threats militarily and internal threats by supporting and funding democratic parties wherever possible. It was not a steady trajectory to victory by any measure, but most presidents from

the first Bush supported the doctrine and our commitment remained - weaker at times and then stronger, but always present. We never gave up on our belief that the residents of Western Europe desired and were capable of representative democracy. Ultimately,



freedom won, the wall fell, and Republicans and Democrats could take pride in what we helped bring to pass.

The same opportunity presents itself in the Middle East and most specifically at this time in Egypt. There are fledgling secular democratic parties; there are people who desire freedom and look to the U.S. for guidance, encouragement, and sometimes sustenance. These forces, which are our natural allies, face threats both external and internal. Iran has taken on the role of the old Soviet Union, seeking to dominate the region, impose its own radical and totalitarian control, and fielding an army of covert agents, sympathizers and committed members. Hezbollah and Hamas are nothing without the support from Iran.

Unfortunately, the current administration seems incapable of its own Trumanesque moment. So fearful appearing imperialistic, it can't be humanitarian and take concrete actions to support freedom movements in Egypt or elsewhere in the Middle East. What we desperately need is a Freedom Doctrine, ideally comprised of the following succinct elements:

1. Concrete support for democratic reforms and movements in the Middle East.

2. Specific efforts to help nurture the rule of law, a free press, independent political parties, and a professional military.

3. Overt and covert assistance to those political parties which truly reflect a commitment to

These aren't complicated, and they don't need to be. As Jose Maria Aznar, former Prime Minister of Spain, wrote, "the duty of democrats should be to do whatever is necessary for freedom to prevail". Egypt's future is being written today. If we have learned from history, the Middle East and the rest of the world will be a much better



Also held numerous public forums on Proposition 13, the revolutionary Howard Jarvis measure limiting property taxes. In the 1980s, began promoting equitable campaign financing and supported a bond measure to finance a city police and jail building as well as a measure to retain the city council/city manager system in Pasadena.

In the 1990s, advocated for community access stations as part of the cable TV franchise and focused on women's rights, children and families and instant runoff voting, a system to avoid runoff elections and that upholds the principle of one person, one vote. (It has since been instituted in cities around the country.) In the first decade of the 21st cen-

tury monitored a task force on good government in Pasadena that resulted in a charter amendment revising the Taxpayer Protection Act, supported the Monterey Park Environmental Commission; monitored affordable housing in the 10 League communities, and joined the state League in advocating for a redistricting commission. Redistricting remains a topic of interest.

NASA Releases Images of Man-Made Crater on Comet

NASA's Stardust spacecraft returned new images of a comet showing a scar resulting from the 2005 Deep Impact mission. The images also showed the


comet has a fragile and weak nucleus.

The spacecraft made its closest approach to Comet Tempel 1 on Monday, Feb. 14, at 8:40 p.m. PST at a distance of approximately 111 miles. Stardust took 72 high-resolution images of the comet. It also accumulated 468 kilobytes of data about the dust in its coma, the cloud that is a comet's atmosphere. The craft is on its second mission of exploration called Stardust-NExT, having completed its prime mission collecting cometary particles and returning them to Earth in 2006.

The Stardust-NExT mission met its goals which included observing surface features that changed in areas previously seen during the 2005 Deep Impact mission; imaging new terrain; and viewing the crater generated when the 2005 mission propelled an impactor at the comet.

This mission is 100 percent successful," said Joe Veverka, Stardust-NExT principal investigator of Cornell University, Ithaca, N.Y. "We saw a lot of new things that we didn't expect, and we'll be working hard to figure out what Tempel 1 is trying

working hard to figure out what Tempel 1 is trying to tell us."

Several of the images provide tantalizing clues to the result of the Deep Impact mission's collision with Tempel 1.

We see a crater with a small mound in the center, and it appears that some of the ejecta went up and came right back down," said Pete Schultz of Brown University, Providence, R.I. "This tells us this cometary nucleus is fragile and weak based on how subdued the crater is we see today." Engineering telemetry downlinked after closest approach indicates the spacecraft flew through waves of disintegrating cometary particles including a dozen impacts that penetrated more than one layer of its protective shielding.

"The data indicate Stardust went through something similar to a B-17 bomber flying through flak in World War II," said Don Brownlee, Stardust-NExT co-investigator from the University of Washington in Seattle. "Instead of having a little stream of uniform particles coming out, they apparently came out in chunks and

While the Valentine's Day night encounter of Tempel 1 is complete, the spacecraft will continue to look at its latest cometary obsession from afar.

'This spacecraft has logged over 3.5 billion miles since launch, and while its last close encounter is complete, its mission of discovery is not," said Tim Larson, Stardust-NExT project manager at JPL. "We'll continue imaging the comet as long as the science team can gain useful information, and then Stardust will get its well-deserved

Stardust-NExT is a low-cost mission that is expanding the investigation of Comet Tempel 1 initiated by the Deep Impact spacecraft. The mission is managed by JPL for NASA's Science Mission Directorate in Washington. Lockheed Martin Space Systems in Denver built the spacecraft and manages day-to-day mission operations.







Recipe of the Week: APPLE SKILLET PANCAKES

INGREDIENTS:

3 eggs

1/2 cup (125 mL) milk

1/2 cup (125 mL) all purpose flour 1 tbsp. (15 mL) granulated sugar

1 tsp. (5 mL) vanilla

2 tbsp. (30 mL) butter

3 medium apples, peeled, cored and sliced

1/4 cup (50 mL) brown sugar powdered sugar for dusting maple syrup, if desired

DIRECTIONS:

Preheat the oven to 500 degrees F In the container of a blender or food processor, combine the eggs, milk, flour, granulated sugar and vanilla. Blend until smooth, scraping down the sides of the container to make sure everything is evenly blended. Set aside. Melt the butter over medium-high heat in a 10-inch (25-cm) nonstick skillet that can go into the oven. When the butter is foamy, add the sliced apples and the brown sugar. Cook, stirring occasionally, for about 10 minutes or

brown. Remove from heat. Pour the mixture from the blender over the apples in the pan and place the pan into the preheated oven. Immediately reduce the oven temperature to 425 degrees F (220 degrees C). Bake for 16 to 18 minutes, or until the batter is browned and slightly puffed. Remove from oven and dust with powdered sugar. Cut into wedges and serve with maple syrup, if desired.

Santa Anita wins back fall racing By Scott Hettrick, Arcadia's Best

Fall horse racing will return to Santa Anita Park this year. At the February 17th meeting of the California Horse Racing Board, Santa Anita Park won unanimously on both counts it had applied for, the return of racing to the historic park after a 1-year absence due to safety concerns regarding a state-mandated synthetic turf that has since been replaced with real dirt, and complete control of those fall dates during which the track had been leased to the non-profit Oak Tree Racing every year since 1969.

The return of racing comes at a great time for the City of Arcadia since the meet usually generates more than \$200,000 during the period, including about \$185,000 for the City's cut of bets placed, and the rest from additional sales taxes from increased spending at local

Breeders' Cup was run during Oak Tree Racing at Santa Anita two consecutive years in 2008-09 for the first and only time in the history of the Breeders' Cup.

Last year's decision by the CHRB forced Oak Tree to move to Hollywood Park for one season and Southern California lost a return of Breeders' Cup. Hollywood Park has been clinging to dwindling race crowds and purses each year as the owners await a rebound in the housing market to convert the property into a residential development.

Oak Tree Racing has been one of the top contributors to local charities, donating more than \$400,000 each year, according to Oak Tree executive director Sherwood Chillingworth. But much of that was cut back last year when it was forced to leave Santa Anita, and all of it is

By a 6-0 vote before about 100 people at Santa Anita, the board opted to transfer the dates, Sept. 28 to Nov. 6, back to Santa Anita instead of returning to Hollywood Park for 2011, according to BloodhorseRacing.com.

But hold your horses before getting too excited; chairman Keith Brackpool emphasized that the decision only applies this year for now, and Santa Anita must do a little legal jockeying to comply with state rules governing the number of race dates that can be run. Rather than Santa Anita's Los Angeles Turf Club managing the fall dates, the fall meet will be operated by the Pacific Racing Association, which just happens to be a subsidiary of Santa Anita parent company MI Developments.

And Santa Anita must finalize a financial payment to Oak Tree as compensation for some dates and events to which it holds rights. Chillingworth told Arcadias Best.com this afternoon that even though Oak Tree will no longer be managing the event, it will still be associated with it and remain headquartered at Santa Anita for now. In a nutshell, the relationship between Santa Anita and Oak Tree has been reversed, he said. Instead of Oak Tree running the event and paying Santa Anita a fee and a percentage of earnings, which usually came to between \$4 mil. – \$5 mil., Pacific Racing will run the event and Oak Tree will get paid a fee. Given the circumstances, Chillingworth said he is satisfied with what Oak Tree came away

Meanwhile, CHRB plans to create a new permanent state racing dates calendar for all of 2012. Frank Stronach of MI Developments has been lobbying for year-round horse racing, running only 3 or 4 days each week instead of divvying up the year so that only one track has exclusive horse racing within its competitive region for several months each year.

"This is great news for Santa Anita and for the California horse racing industry," Santa Anita President George Haines said in a statement. "This means so much to so many people. From all of our employees and the people who work within the industry, to our fans and to the entire business community here in the San Gabriel Valley, this means jobs, revenue and the opportunity to remain viable and to grow our business into the future."

"Obviously, this is very welcome news, on several fronts," said Arcadia City Manager Don Penman. "Not just from the standpoint of providing fans with the opportunity to visit what we believe is the most beautiful racing facility in the world, but having live racing back here in the fall is a great opportunity for our hotels, restaurants and other businesses in this very tough economy."

GOLF SWING ADVICE: USE YOUR WRISTS FOR MORE POWER

I am going to give you some great golf swing advice. If you want to hit the golf ball further, you are going to have to use your wrists. Before you run out to the practice facility, I have to tell you exactly "how" to use your wrist to benefit your golf swing.

Let's start at the address position. When you grip the golf club your wrist are unhinged. As you start the club back the toe begins to roll open and so do your wrists. When you reach the 9:00 o'clock position the back of the left hand should be parallel to your target line.

This is where you have to pay close attention to your wrists. From this position to the top of the backswing the wrists have to start (folding, breaking or unhinging) call it what you want, they have to have some play in them. By the time you reach the top of the backswing the shaft has to be parallel to the ground.

I know some of you struggle with arthritis, stiffness or the inability to turn like you use to. When you reach the top of the backswing and your shaft is pointing to the sky, you are

going to loose a lot of yardage. The key here is to make sure you soften up the wrists and let them fold. Do not keep them in the same position as they were in at address. You are going to need as much sling in the downswing as you can muster up.



The best tip I can give you so you know for sure that you are folding your wrists at the top of the backswing is called the thumb pad drill. When you address the golf ball your left thumb is on the top of the golf club. When you reach the 9:00 o'clock position your left thumb is still on top of the golf club. As you continue to turn your right shoulder out of the way and swing the club to the top of the backswing, your thumb pad is now UNDER the golf club. In other words your left thumb pad is supporting the club at the top of the backswing. That is how you can tell if you used your wrist.

I know this golf swing advice will help you hit longer shots the next time you tee it up.


