## MOSCA DELIVERS 1<sup>ST</sup> ANNUAL CITYWIDE STATE OF THE CITY ADDRESS "Working Together the Sierra Madre Way"

On Monday evening, Sierra Madre Mayor Joe Mosca walked up to the podium in the newly remodeled Sierra Madre Room full of anxiety. His anxiety wasn't over the contents of the speech he was about to deliver, rather it was due to the fact that he "had a tough act to follow", referring to the performance by 3rd Graders from Sierra Madre Elementary School. The group, accompanied by Principal Gayle Bluemel on the piano, opened the event with several inspiring songs from their 'Showcase on the Pillars of Good Character'. They literally 'rocked' the house and the showcase theme coincided with the Mayor's topic for the evening on working together.

of the City address in Sierra Madre. In the past, Mayors have generally delivered the address at the invitation of The Chamber of Commerce, The Women's Club, and Sierra Madre's Kiwanis and Rotary clubs. For this event, the invitation was extended to every resident in Sierra Madre and held in the evening in order to accommodate working members of the community. It was well attended with a standing room only crowd at times.

Representatives of every civic organization were present as well as the entire city council and all city department heads. Highlights of the State of The City:

"The good news is that our current General Fund budget is "balanced", and we have ended the past couple of years with a surplus. This surplus has been added to our General Fund reserves, which is now approaching an amount equal to more than

50% of the annual General Fund This was the first citywide State expenditures, which is not all that common for our community."

> Mosca noted that one reason Sierra Madre was able to sustain a healthy financial position because of proactive measures taken including the voter approved Utility Users Tax that helps sustain our Police, Fire and Paramedics.

> He also noted that the city does not rely on sales taxes as other cities due and therefore the impact of a down economy is less. "We are more dependent upon property taxes, which is a much more of a stable revenue stream." He noted that our town "has always been fiscally prudent in our investments, revenue forecasts, and our expenditures."

While speaking of finances, he also

General Fund, our Water Fund was not balanced and our projections indicated that in a few short years all of our reserves would be spent. The increase that was ultimately approved was the first increase approved in the past five years.

As some of you may know, the Water Department is a city owned utility with a wholly separate fund. This utility must bring in enough revenue to cover its obligations and to ensure an appropriate level of investment in the system, so that it continues to deliver quality water in a reliable manner."

Discussion of the Water Fund in particular was timely as a claim has been filed against the city by Blogger John Crawford who threatens to sue the city over the water rate increase. Crawford, according to the Pasadena Star News, is being represented by Former Mayor Kurt Zimmerman.

#### **Accomplishments**

The Mayor went on the outline the many accomplishments that have been achieved in the last year or two. They included (partial listing):

The Sierra Madre Community Room Renovation through the use of Federal and County grants; \$800,000 in Street Improvements; Acquiring a new fire engine, a new fire department water tender, a new ambulance, a new backhoe for Public Works, along with a new Vactor Truck for maintaining the City's sewer system;

Updating the city's computer software system;

Launching the Emergency/ travelers radio station, AM1630 and completion of the Housing

He also mentioned updating the General Plan and the work being done on the new Canyon Zone Ordinance.

Mosca ended his speech with a quote from the President of the National Civic League describing cities, such as Sierra Madre, that have received the high recognition of being named an All-America City, "These communities serve as models for the rest of the country... they are tackling challenges that seem insurmountable and are producing positive and tangible results with ingenuity collaboration."

## Parents Angry Over Children Not Receiving Awards

When Sierra Madre resident Tom Brady came up with the idea of hosting a citywide event to benefit not only the Sierra Madre Youth Center, but also the Rotaplast Foundation and young Artists and Fessy. young Artists and Essayists in local schools, the idea was well received. As stated on the website, "A Taste of Sierra Madre" is a community celebration of fine arts, culinary arts, drama and live music hosted on Kersting Court, Saturday, September 11th. This inaugural event raises awareness and equal funding for the Sierra Madre Youth Activity Center and the Rotaplast Foundation which serves kids & adults who require cleft palate surgery. We are devoted to the well-being and future of our children locally and humanitarian ser-

vice globally." Brady gathered support from all over town including local schools, churches, service orga-

nizations, the Police and Fire Departments and local media. The mission was noble and Brady was a master at motivating over a hundred volunteers that made the one day event a success. Or so it seemed.

Even when Brady appeared before the Sierra Madre City Council and presented a big check to the city for \$6,000 for the Youth Activity Center everything appeared to be just fine. An equal amount is alleged to have been sent to the Rotaplast Foundation. Everything still appeared to have been performed as committed. However, by late November, the fact that the 33 students who had been promised Savings Bonds for winning their category in the Arts and/or Essay competitions had not received them, started to surface. When questioned, Brady indicated that there had been a delay in acquiring the necessary information from the parents in order to process the bonds. Later, Brady made a public announcement that all bonds had been processed and they would shortly be in the hands of the award winners. That never happened.

In January, parents began speaking up. After receiving conflicting accounts from Brady, Contact was made with Chase Bank, who issued the forms on the day of the event. Chase confirmed that only 11 forms had been turned in to them by Brady and processed. Those bonds are the only ones that have been received by students. Brady acknowledged that the information from Chase was correct and the remaining bonds would be purchased right away. That was January. That never happened either.

Members of the committee who were questioned about the situation were

> all shocked to learn that the Bonds had not been issued. "The children who won the awards should have been paid before any other funds were disbursed," said one volunteer.

> No explanation has been given by Brady as to what happened. Several parents have denied that there was ever a problem getting the information on the Bond applications. One parent recalls going into Chase Bank on the day of the event to get her child's social security number so that the form could be processed that day.

> The response by Brady to inquiries led one organization that committed to buy 6 bonds for the 7th and 8th grade winners, to withhold the funds because when they asked Brady on several occasions to confirm the amount and send a letter requesting the funds or an invoice, he never responded.

> And to further exacerbate the problem according to one parent, Brady issued an individual personal check to her child. The committee specifically voted to have Savings Bonds distributed to the award winners in order to introduce the award winners to the value and saving and being thrifty. They were also told that the event had made net profit enough to meet all of its obligations and donate \$12,000 to the YAC and Rotaplast respectively. Despite repeated requests the details on what children have received has not be forthcoming.

> Breaking News: According to an email received from Brady just before press time, he said, "Disbursed over 14k to community half to Rotaplast half to Sierra Madre Community Services plus all student awards in the form of bonds and awards." That statement has not been confirmed.

#### WISTARIA FESTIVAL SHUTTLE TICKETS NOW AVAILABLE ONLINE

The Sierra Madre Chamber of Commerce reminds you that shuttle tickets to ride up to view the Wistaria Vine at its annual Wistaria Festival are now available online. The 2011 Wistaria Festival will take place on March 20th, 2011.

The Wistaria Festival features tours of the world's largest blossoming plant, certified as such by the Guinness Book of World Records. Each year, the property owners upon whose land the vine sits, the Solts and the Dorrances, open their property to allow thousands to view the vine. Dozens of Sierra Madre residents volunteer to act as docents at the property, telling the story of the vine, which was originally planted from a 1-gallon pot that was purchased for \$0.75 in 1894. At its peak, the vine covered more than an acre of ground, and in the early 20<sup>th</sup> century was so large that it even destroyed a home that was under it.

In addition to the tours of the vine, the two main downtown streets of Sierra Madre are closed to traffic so that 175 juried crafters and artists can set up booths to display and sell their arts/ crafts. Downtown village shops are open, and more than a dozen musical acts perform at multiple outdoor venues. Memorial Park is transformed into a combination Kids/Food zone, as bouncy houses, slides, rock climbing and other kids attractions set up in the park alongside food vendors, both for profit and non-profit

The shuttle to the vine from downtown avoids a long uphill walk from downtown to the neighborhood in which the vine sits. "Day of" tickets for the shuttle have been reduced from \$15 to \$12 this year, and pre-sale tickets are just \$10. This year, for the first time, seniors and kids (6 to 16) receive a discounted rate of \$7. Children under five ride for free. There is no charge to view





## SCHIFF TAPPED TO SERVE AS RANKING MEMBER ON HOUSE INTELLIGENCE SUBCOMMITTEE

Technical & Tactical Intelligence Subcommittee Oversees Space and Cyber Security

**Washington, D.C.** – As we near the 10-year anniversary of the September 11, 2001, terrorist attacks and are keeping a close eye on countries across the Arab world undergoing significant changes in their quest for democracy, the House Intelligence Committee continues to be engaged in work critical to our nation's security.

 $In January, Rep.\ Adam Schiff (D-CA) was tapped to continue$ serving on the House Permanent Select Committee on Intelligence, and today he was named Ranking Member of the Subcommittee on Technical and Tactical (T & T) Intelligence. T & T oversees the technical aspects of

intelligence gathering, including space-based assets, as well as cyber security. T & T also has primary oversight over the National Security Agency, the National Reconnaissance Office, the National Geospatial Agency and other military intelligence programs.

"I am grateful for the continuing opportunity to serve on the Intelligence Committee, and I will be honored to serve as Ranking Member of the Subcommittee on Technical and Tactical Intelligence," Rep. Schiff said. "In the face of national security challenges of both today and tomorrow, good intelligence is the best defense. My top priority as Ranking Member will be ensuring that our world-class scientists, researchers, engineers, who work to improve our technological capabilities, are appropriately staffed, operating within the law and with maximum effectiveness when it comes to space and cyber security."

Satellites play a critical role in our intelligence agencies, because their images can be used to track suspected terrorists around the world and stop future attacks. Satellites provide real-time data to our troops on the ground in Iraq and Afghanistan, and allow us to monitor important global developments.

Cyber networks don't just power our cell phones and iPads; they keep our electric grid running, secure the banking world, protect our water supply, and operate our classified military and intelligence systems.

Since coming to Congress, Rep. Schiff has advance defforts to ensure the safety of all Americans by working to improve our intelligence gathering, implementing the 9/11 Commission Recommendations, and working the safety of tto revamp the Foreign Intelligence Surveillance Act (FISA) to meet the challenges of the 21st Century.

In 2007, House Speaker Nancy Pelosi appointed Rep. Schiff to the new House Select Intelligence Oversight Panel. The following year, he was also appointed to the House Permanent Select Committee on Intelligence, which also drafts the laws that govern the intelligence agencies operations. That committee is also responsible for overseeing the 16 agencies that comprise the intelligence community, which include components of the Departments of Defense, Homeland Security, Justice, State and



## Police Seek Help, **Information** on Shooting **Near Rose** Bowl

Residents in the 1000 block of Armada Dr. called police early Monday morning after what they said sounded like gun shots. A little more than an hour later a body was found in Brookside park. Officers had checked the area but nothing was found. They said the echo from the shots could have thrown them off.

At approximately 5:22 a.m., an employee of the city parks department notified Pasadena Police that as he was arriving for work he saw a Black male lying in a dirt area of the Brookside Parking lot, approximately 100 yards south of Seco Street at Arroyo Blvd.

Officers arrived and discovered the body of a Black male in his thirties who had been shot. Paramedics were called and the man was pronounced dead at the scene.

The victim was later identified by the Coroner's office as Victor F. Cass, 56, of Duarte.

'Police detectives are diligently investigating the death of Mr. Cass. This type of incident is very tragic, but also very uncommon," said Police Chief Phillip Sanchez. "Hundreds of adults and youth enjoy the wonderful facilities around the Rose Bowl every day. They can be assured the area is safe and well patrolled."

It is unknown if the incident on Armada is related to the discovery of the deceased. Detectives are investigating both incidents.

The Pasadena Police Department is seeking the public's assistance in this investigation as the Rose Bowl vicinity is patronized for recreational activity. Someone may have heard the gun fire, or observed a vehicle or person(s) leaving the area in the early morning hours and not realized their observations were associated with a crime.

## Duarte Mayor and School Board President Deliver JointState of the City/State of the School District Talks

DUARTE, CA, March 3, 2011 – While there was no getting around pointing out the economic challenges that confront the City of Duarte and Duarte Unified School District, there was also much upbeat about the joint State of the City/State of the School District presentations delivered by Mayor Tzeitel Paras-Caracci and School Board President, Pam Kawasaki.

More than 100 civic and business leaders attended the Duarte Chamber of Commerce sponsored luncheon held at the newly opened 34,000 square foot Maryvale Family Resource and Early Education Center in Duarte.

Paras-Caracci and Kawasaki spoke of the reality of budget cuts and the shared dread of more to come as a result of the State's budget crisis. But despite the gloomy economic news, Mayor Paras-Caracci told the crowd, "This could be our finest hour."

One example, she said is the new Maryvale facility which brought 30 new jobs to the City, provides child and family counseling, a family resource center, community classes and health and nursing services to the community.

"This is part of our future, part of our legacy," she said. Other reasons for optimism sited by the Mayor.

The City is safer. Bucking the norm that when unemployment goes up so does the crime level, Part 1 crimes in Duarte were down 13% in 2010 in almost every category with the exception of auto and grand thefts, up nationwide. The City was awarded a \$191,000 California Gang Reduction, Intervention and Prevention Grant (Cal-GRIP) in late 2010 that it is putting to work to expand services to youth Kindergarten through 8th grade and their families.

With the Gold Line now assured to come to Duarte, the City is optimistic that the station with at least 125 parking spaces will be completed by late 2014, constructed by the Gold Line Construction Authority and operated by Metro. "Most of all we are excited about public and private partnerships. This will make our vision a reality. We will continue to stay positive and plan for an affordable housing and parking project to create synergy around the station. The only way we can complete this puzzle though is if the State stops taking our redevelopment pieces," said the Mayor.

The completion of the Youth and Family Master Plan is another example of a City that unites together, builds partnerships, shares resources and creates community, said the Mayor. The 10-month process by a volunteer committee of 27, comprised of a cross-section of the community, produced a plan of 66 action steps for enhancing services and programs for youth and families in Duarte. Now, a committee of 12, appointed by the City Council and chaired by Damon Colaluca, executive director of the Santa Family YMCA, will oversee the implementation of the plan.

Of major concern for the City is a projected \$500,000 budget deficit for fiscal year 2010-2011 that could increase to \$1.5 million if the Governor succeeds in his plan to strip cities of redevelopment funds.

"We are seriously looking at ways to reduce costs and increase efficiencies. In a commitment to being smart about our anticipated reductions of services and programs this is our reality check," said Mayor Paras-Caracci.

She said the City has faced a number of cuts in the past few years including a 16% reduction in staff, leaving a vacancy of 8 full time positions and a remaining full time staff of 43 for the City of 22,000 residents.

Public Safety office hours have been reduced from five and half days to four days a week. The City has also reduced hours in after-school park supervision.

"City Hall is still functioning but at some point there will be more to trim if we are to provide what we promised in our mission statement, 'exemplary public services in a caring and fiscally responsible manner," said the Mayor. School Board President, Kawasaki noted the continued widening between projected versus actual funding from

School Board President, Kawasaki noted the continued widening between projected versus actual funding from the State for students. In 2011-2012, the District projected \$6,464 ADA funding but received \$5,196. She warned that the District stands to have another \$1.3 million cut from its budget if the tax extension doesn't pass on the June State ballot.

"We also look at deferrals. Currently our revenue limit is roughly about \$20 million. We're looking at 33% deferrals right now. Those deferrals can go anywhere from six months to the next fiscal year but what the Governor is proposing right now is a 45% deferral rate. That's really high and hard for any school district to carry on the excellence that it wants to," said Kawasaki.

On the good news front for the District:

Measure E, a \$62 million bond that passed last year will create a technology endowment that will keep the District technology up to date for many years to come. The bond has strict guidelines and safety measures built in and an oversight committee that is required. Applications are available in the District Office and online for community members to serve on the seven member oversight committee.

Duarte Unified School District API scores "are off the charts," said Kawasaki. "This is what we are so proud of." Andres Duarte grew by 43 points to an API score of 804. Beardslee advanced 30 points to 774. Maxwell increased 18 points to 731. Royal Oaks was up 20 points to 870. Valley View improved by 14 points to 840. Northview Intermediate grew 58 points to 755, and Duarte High School increased 43 points to an API score of 750. The Duarte Unified School District achieved the most growth of any school district in the San Gabriel Valley, a total 38 point gain.

Royal Oaks has been invited to submit an application for the national Blue Ribbon award.

Valley View was awarded the Golden Bell as a California Distinguished School. Northview Debate team is in contention for state finals.

Duarte High School now has three academies in place. Ninth grade students are placed in a Freshman Academy that helps indoctrinate them into the high school life and ease the transition from middle to high school. Students from grades 10 through 12 have the option of either entering the Business of Arts, Media, and Entertainment Academy or the Health, Science and Engineering Academy.


In an early college partnership program with Citrus College, the first group of 39 students will be graduating from Duarte High School with one full year of college completed.

Mount Olive High School is going green. In the area of environmental sustainability through their Mount Olive Outdoor School Experience program (MOOSE), the school has garnered a number of grants including \$5,000 from Toshiba; \$3,000 from California American Water; two \$10,000 grants in product from Rain Bird and the Department of Public Works; and \$2,500 from the California Department of Education.

Mount Olive is also starting a partnership with JPL and Citrus College centering on green initiatives. Last year 98.5% of the seniors graduated from Duarte High School and 84% went on to secondary education.

For your information, here is the Law in Pasadena: On October 27, 2008, City Council unanimously approved a No-Smoking Policy in certain

outdoor places.

I am not the Smoking Police, Well, I am not!! But.... have you noticed more employees bra-

According to Section 8.78.07: Smoking prohibited in certain outdoor public places. A. It shall be unlawful to smoke in the following outdoor public places:

Outdoor areas of shopping malls; Unenclosed areas of bars and restaurants;

In service waiting lines or within 20 feet of such lines; Outdoor public gathering events/special events/parades/fairs.

B. Notwithstanding exemptions enumerated under California Labor Code Section 6404.5, the prohibitions in Section A above shall apply to the outdoor areas of a private smokers lounge and retailer or wholesale tobacco shops as defined under state law


and to significant tobacco retailers under the City's Zoning Code. Section 8.78.072 Reasonable smoking distance required – 20 feet. Smoking in unenclosed areas shall be prohibited within a reasonable distance (20 feet) from

any doorway, window, opening, or vent into an enclosed area in which smoking is prohibited, except while actively passing on to another destination.

The Ordinance took effect on November 30, 2008. Staff will also be implementing a proactive public education communications effort, coupled with clear and prominent signage to notify the public about the newly adopted policies. ## THE REAL REAGAN LEGACY: PART III What Conservatives Don't Want You To Know About Ronald Reagan

The roots of our current econom- for all Americans, since 1980, median ic crisis can be traced back to Ronald Reagan. He was the first president

to state unequivocally that "budget deficits don't matter" as long as economic growth is there to counter it. And it was his "trickle-down economics," as well as his penchant for "off the books budgeting" that G.W. Bush embraced years later to justify his huge tax cuts for the wealthy and funding the wars in Iraq and Afghanistan. Here are a few things conservatives don't want you to know about Ronald Reagan.

Reagan was a serial tax raiser. As governor of Cali-

fornia, Reagan signed into law the largest tax increase in the history of any state up till then. Meanwhile, state spending nearly doubled. As president, Reagan raised taxes 11 times in seven of his eight years in office, including four times in just two years. Characterizing Reagan as an anti-tax zealot is false; he was never afraid to

• Reagan nearly tripled the federal budget deficit. During the Reagan years, the debt increased to nearly \$3 trillion, roughly three times as much as the first 80 years of the century had done altogether. Despite the conservative myth that tax cuts somehow increase revenue, the government went deeper into debt and Reagan had to raise taxes just a year after he enacted his tax cut. He raised taxes on everything from gasoline to corporate income, but was never able to get the deficit under control.

• Unemployment soared after Reagan's 1981 tax cuts. Unemployment jumped to 10.8 percent after Reagan enacted his much-touted tax cut, and it took years for the rate to get back down to its previous level. Meanwhile, income inequality exploded. Despite the myth that Reagan presided over an era of unmatched economic boom

household income has risen only 30 percent, adjusted for inflation, while

average incomes at the top have tripled, in some cases quadrupled!

• Reagan grew the size of the federal government tremendously. Reagan promised to move boldly, decisively, and quickly to control the runaway growth of federal spending, but federal spending ballooned under Reagan. He bailed out Social Security in 1983 after attempting to privatize it, and set up a progressive taxation system to keep it funded into the future. He promised to cut government agencies like the Department of Energy and Education but ended up adding one of the largest - the Department of Veterans' Affairs, which today has a budget of nearly \$90 billion and close to 300,000 employees. He also hiked defense spending by over \$100 billion a year to a level not seen since the height of the Vietnam war.

• Reagan gave amnesty to 3 million undocumented immigrants. Reagan signed into law a bill that made any immigrant who had entered the country before 1982 eligible for amnesty. The bill was sold as a crackdown, but its tough sanctions on employers who hired undocumented immigrants were removed before final passage. The bill helped 3 million people and millions more family members gain American residency.

• 1983 Beirut, Lebanon barracks bombing by Hezballoh terrorist of two separate buildings housing United States and French members of the Multinational Peacekeeping Force - killing 299 American Marines and French servicemen. The blasts led to the withdrawal of the peacekeeping force from Lebanon, where they had been stationed since the withdrawal of the Palestine Liberation Organization following the 1982 Israeli invasion

of Lebanon.

• Reagan illegally funneled weapons to terrorist Iran. Reagan and other senior U.S. officials secretly sold arms to Iran, a known supporter of terrorism, which was subject to an arms embargo at the time, in exchange for American hostages. Funds from illegal arms sales and drug trafficking also went to fund anti-communist Contra death squads in Nicaragua - something Congress had already prohibited the administration from doing. When the deals went public, the Iran-Contra Affair, as it came to be known, was an enormous political scandal that forced several senior administration officials to

• Reagan helped create the Taliban and Osama Bin Laden. Reagan fought a proxy war with the Soviet Union by training, arming, equipping, and funding Islamist mujahideen fighters in Afghanistan. Reagan funneled billions of dollars, along with top-secret intelligence and sophisticated weaponry to these fighters through the Pakistani intelligence service (ISI). The Taliban and Osama Bin Laden - a prominent mujahideen commander - emerged from these mujahideen groups Reagan helped

## As I See It



In a week when former Gov. Mike Huckabee (R-AK) describes President Obama's "growing up in Kenya with a Kenyan father and grandfather", and Gov. Rick Perry (R-

TX) refers to Ciudad Juarez as "the most dangerous city in America", we hear calls from newly-Republican statehouses to de-fund education and de-value teachers (along with calls to dismiss global warming and doubt evolution).

In a month when workers occupy the palace demanding ruling oligarchs recognize their rights, we find the setting to be the Wisconsin capitol at Madison, with sympathizers sending words of encour-

agement (and pizza) from Egypt.
In a year when the approach of April 15th amplifies discussions on equitable sharing of the tax burden, we learn that if we paid any federal taxes at all, we paid more than ExxonMobil, General Electric, Bank of America and Citigroup - combined.

It's a strange world. Education is derided while national figures flaunt ignorance of presidential biography, basic geography and science. Emerging from an historic recession is seen as an opportune time to strip public employees of collective bargaining rights. Politicians work tirelessly protecting loopholes to shield profits of multi-billion dollar corporations, while shamelessly declaring it's the \$30-60 thousand-a-year nurses, teachers and firefighters who need to sacrifice.

There's a proposal to trim the federal budget by \$1.1 trillion over ten years, shrinking or eliminating over 200 federal programs, primarily with cuts in social heating subsidies for low-income families, college scholarships for promising students, support for the Environmental Protection Agency, etc. That's the proposal from President Obama.

It's a proposal Republicans would barely consider a starting point. To demonstrate their focus on the deficit, they first want to add to it (by some \$230 billion, according to the Congressional Budget Office) by repealing the Affordable Care Act. So we don't become too complacent about our old age, they want to turn Social Security over to the same yahoos who gambled away our 401(k)'s - allowing tensof-billions of dollars worth of working families' retirement plans to vanish while

collecting their own multi-million dollar bonuses.

For Medicare, their solution is to divert more billions into the hands of private insurance executives, rather than allowing those public funds to be spent on actual healthcare. The philosophy behind the "Medicare Part D" option enacted under Bush proved instrumental in creating the Medicare budget problems we face today - so, naturally, Republicans

want to expand on it. Republicans in the House push a budget for 2011 containing \$61 billion in cuts, gutting aid to states (which face a combined \$125 billion shortfall for 2012) and halting stimulus programs responsible for encouraging the recovery we've seen over the past several months, with the creation of 4 million jobs (so far). To ensure the deficit remains an issue in 2012, though, they've coupled those \$61 in cuts, which would've been pumped back into the economy, with \$70 billion in tax cuts for the wealthiest 2%, which will be pumped into off-shore tax shelters.

Whether federal, state or household, budgets consist of income in addition to expenditures. The question is how equitably that contribution responsibility is

distributed. I listed above four corporations which, as reported from 2009, paid no federal taxes. (In the case of Bank of America, our largest bank and 5th-largest corporation, we handed them a \$2.3 billion refund.) According to a congressional report release by the General Accounting Office in 2008, two-thirds of American companies (and 68% of foreign companies doing business here) paid no federal taxes from 1998 through 2005 - despite a combined \$2.5 trillion in revenue. A quarter of American companies with over \$250 million in assets, or \$50 million in sales, companies with a combined \$1.1 services and education; there are cuts in trillion in revenue, reported no taxable income for 2005.

One of those who requested the report, Sen. Byron Dorgan (D-ND), observed (with considerable understatement), "The tax system that allows this wholesale tax avoidance is an embarrassment and unfair to hardworking Americans who pay their fair share of taxes."

Last year, the U.S. Public Interest Research Group reported an IRS finding that \$5 trillion in assets are held by corporations and individuals in offshore tax shelters. Goldman Sachs, recipient of a \$10 billion taxpayer bailout, brought their standard 35% corporate tax rate down to an effective 1% rate by what they call (continued on page 14)

## **UNION RIGHTS AND PRIVILEGE**

The raucous debate in Wisconsin over how to play the pounion rights and privileges has certainly gotten ugly - with some lawmakers fleeing the state to avoid having to cast votes on the issue – but this is by no means just a local Wisconsin issue. What's being debated and tested there will soon be the hot topic in state capitals across the land. We need to understand what's really going on here so that an informed electorate can influence their representatives at all levels to fix a system which is literally destroying us.

As a conservative, I'll be the first to say that unions should have a right to exist. Workers should also have a right to join a union and allow the union to negotiate for them. But on the other hand, workers should have the right not to join a union if they choose and/or be free to leave the union if they believe that is in their best interest. In similar fashion, business owners should be free to oppose unions. As conservatives, we believe in individual freedom and trust that a free market will sort out what's best for everyone. Workers clearly want to get the highest wage they possibly can, and they have no moral responsibility to take into consideration the business owner's demands. The business owner clearly wants to pay the lowest wage possible, and they have no moral responsibility to take into consideration the workers' demands. Each party argues vigorously for their own interests, and the resulting negotiation will result in a mutually agreeable outcome. Workers will work for the wage they think they can get, and owners will pay the wage they think they can afford. So long as both sides are free to pursue their self interest and neither side is favored by the government, the system is fair for everyone.

Sadly, the system hasn't always been fair. In the early part of the previous century, businesses were successful in convincing and/or bribing politicians to pass laws that unfairly favored them. Thus union power rose as workers sought the strength of collective bargaining to even the odds. Over time, business owners have learned that it is in their best interest to treat workers well in order to get the most qualified workers. As a result, union representation rose to a high of about 40% of the workforce in the 1940s and then gradually fell to its current 7%

Union leaders have seen their power slip away as more workers chose not to join unions in response to the increasing generosity of business owners. Rather than accept a natural diminished role in the economy, union leaders have fought back by turning to the public sector – by unionizing public employees. One of the key differences here is that unions have an inherently unfair advantage against employers in the public sector. The unions represent the workers, they get to contribute vast sums of money to the politicians who then sit across the table from them in negotiations about how much of the taxpayers' money will be given to public workers. Absent from the negotiations are the actual voters or even someone who has an incentive to represent them

honestly and forcefully. The crux of today's problem in state capitals across the country is that nobody has stood against the unions with a vested interest in opposing their demands. Without at least an approximate equality of power in the negotiations, the voters have been sold down the river, and public workers now earn substantially more than their counterparts in private industry.

Consider these statistics. Public workers earn on average about 5% more in wages than their private industry counterparts. That doesn't seem too out of balance, but wages are not the only form of compensation. Ask anyone who has looked at their healthcare benefits and retirement benefits how important those items are, and you'll get an ear full. This is where public employees have been able to hit a home run. When we add in job security, health benefits and retirement benefits, public employees earn on average 30% more than their private industry counterparts.

This is simply an unsustainable situation. It was tolerable for awhile because health and retirement benefits were future benefits for which payment didn't have to be level. Along the way, unions learned made right away. (continued page 14)

# Ooking with Bob Eklund

PLANET FORMATION IN ACTION

Using the European Southern Observatory's Very Large Telescope (VLT) in Chile, an international team of astronomers has been able to study the short-lived disc of material around a young star that is in the early stages of making a planetary system. For the first time, a smaller companion could be detected that may be the cause of the large gap found in the disc. Future observations will determine whether this companion is a planet or a brown dwarf. (Brown dwarfs are relatively cool, star-like objects between planets and stars in size. They are not massive enough to fuse hydrogen in their cores, but are larger than giant planets such as Jupiter.)

Planets form from the discs of material around young stars, but the transition from dust disc to planetary system is rapid and few objects are caught during this phase. One such object is T Chamaeleontis (T Cha), a faint star in the small southern constellation of Chamaeleon that is comparable to the Sun, but very near the beginning of its life. T Cha lies about 350 light-

million years old. Up to now no forming planets have been found in these transitional discs, although planets in more mature discs have been seen before.

"Earlier studies had shown that T Cha was an excellent target for studying how planetary systems form," notes Johan Ólofsson (Max Planck Institute for Astronomy, Heidelberg, Germany), one of the lead authors of two papers in the journal Astronomy &

Astrophysics that describe the new work. "But this star is quite distant and the full power of the Very Large Telescope Interferometer (VLTI) was needed to resolve very fine details and see what is going on in the dust disc."

The astronomers first observed T Cha using the observatory's AMBER (Astronomical Multi-Beam years from the Earth and is only about seven combineR) instrument and the VLTI to combine



the light from all four of the 8.2-meter VLT Unit Telescopes and create a "virtual telescope" 130 meters across. They found that some of the disc material formed a narrow dusty ring only about 20 million kilometers from the star. Beyond this inner disc, they found a region devoid of dust with the outer part of the disc stretching out into regions beyond about 1.1 billion kilometers from

the star.

Nuria Huelamo (Centro de Astrobiologia, ESAC, Spain), the lead author of the second paper, takes up the story: "For us, the gap in the dust disc around T Cha was a smoking gun, and we asked ourselves: Could we be witnessing a companion digging a gap inside its protoplanetary disc?"

However, finding a faint companion so close to a bright star is a huge challenge and the team had to use an adaptive-optics instrument called NACO in a novel and powerful way, called "sparse aperture masking," to reach their goal. After careful analysis they found the clear signature of an object located within the gap in the dust disc, about one billion kilometers from the starslightly farther out than Jupiter is in our Solar System. This is the first detection of an object much smaller than a star within a gap in the planet-forming dust disc around a young star.

labeling. There are a couple of basic bits of information to look for on the product label that might help take some of the mystery out of the process.

First of all, it is important that the product was inspected and approved by the AAFCO (Association of American Feed Control Officials). This should appear somewhere on the packaging and it ensures that the quality and balance of ingredients that went into that product meet regulation standards. One of the most and more obvious factors in selecting the best food for your dog, is knowing exactly what went into it. Be sure to read the small printed list of ingredients on the package, and if the first item on the list is not some kind of meat, you might want to pass on that product. Perhaps the most misleading thing you will find on a dog food product is "human grade ingredients", leading the buyer to believe that they are feeding their dog the same quality of food that they themselves are eating. In reality what it means is that it contains "crude protein" or pieces and parts of animal product, which may be very different from what human food contains. There is a lot more involved and a lot more to know about pet food selection, but these label reading tips can be very helpful in making that decision.

If you prefer preparing home-made food for your dog, here are a few basic tips: Dogs require a high protein, low carbohydrate diet, therefore meat should be among the most prevalent ingredients in any recipe combination. Chicken, beef, turkey and lamb are excellent selections (raw if possible). Vegetables such as spinach, lettuce, carrots, celery and squash are great choices. I have heard that onions are not great for dogs, so you might want to avoid them in your recipe. Oats are excellent nutrition for both dogs and cats but rice, wheat and soy should be avoided. Grapes and raisins have been known to be toxic for dogs. Apples, bananas and avocados are among the best fruit selections for the canine digestive system. Nuts and coconut oil are healthy additions to a homemade dog food mix, as well as additives such as Royal Jelly crushed vitamins and minerals to enhance the nutritional value of the meal. Always consider the specific health and diet needs of your pet, taking into consideration body weight, age and other particular factors, and again be sure to consult your vet first!


## KATIE Tse .....This and That THE COLD WAR

My husband, on the other hand, holds the stoic belief that medicine is reserved for the dying. He is nearly over his cold, and it's a good thing! It was pitiful to watch him sneeze, cough, and generally be miserable. I offered him some innocuous drugs, but he would have none of it. "I'm just going to sleep for a while," he said. But it's hard to sleep when you have to hold your head at a funny angle to keep the

phlegm from shifting. While being sick isn't fun for anyone, we all know elementary school teachers have it worst of all! With friends and relatives in education, I always hear about the kids who seem oblivious to yellow ropes of snot dangling from their nostrils. I'd estimate that kids are havens for germs and infectious diseases until they're about 10. A friend of ours has two children, seven and four, and I swear someone in that family is always sick! People also concoct weird ideas of what causes colds. Changes in the weather and sleeping, or going outside, with wet hair can supposedly put you under. If two people in a family are sick, they methodically study the onsets and symptoms to determine whether the other person is responsible; because who wants to be sick and not have someone to blame? My husband kept apologizing to me for getting me sick, although my watertight analysis of our illnesses suggested that I must've picked it up at work. Well, it doesn't matter anymore, I'm just glad I can breath through my nose again!



## YOUR HEALTH MATTERS Today's Subject: THE BURNING STOMACH

Up until roughly thirty years ago, if you had a peptic ulcer, it was thought that your lifestyle needed some management. Too much worry and spicy foods were considered to be the prime suspects. Perhaps a good glass of milk would be recommended to "coat" the stomach."

It is now recognized that a particular bacteria setting up camp in the lining of the stomach is a common cause. When Helicobacter Pylori is eliminated through the use of antibiotic therapy, the symptoms often clear up quickly. In some cases, the eradication of the troublesome bug may require repeat doses or another type of

Another leading cause of peptic ulcer is the use of various anti-inflammatory medicines, both prescription and over the counter (or OTC). Long term use of medications such as Celebrex, Advil, Motrin, Aleve and aspirin (even low dose) raise the possibility of ulceration. This gradual irritation of the

stomach lining can promote the development of lesions which expose delicate underlying tissues to stomach acids. Often, because over the counter medications are perceived as being very safe, the consumer may not be aware that he is actually causing the problem.

As a chiropractor, I have seen a number of patients who have an underlying gastric problem that is causing discomfort in the mid-back. The pain is usually unrelenting. While this appears to be musculoskeletal in nature, it is, in fact, a viscerosomatic reflex being generated from a sensory overflow originating in the stomach (whew).

So, here's the Catch-22: You may be taking an anti-inflammatory medication (prescription or OTC) for chronic musculoskeletal pain, and the medication may be contributing to the very pain for which it is being taken! Remember, pain is expressing for a reason; if you have been taking pain meds for a prolonged period of time, get checked out ~ your life may depend on it.

## **ELECTRONIC PAYMENTS ARE A MUST**

For years, Social Security has stressed the convenience, security, and safety of getting benefit payments electronically. Soon, direct deposit (or Direct Express) will not only be the best way to receive Federal benefit payments — it will be the only way.

That's because the U.S. Department of the Treasury announced a new rule that will phase out paper checks for Federal benefit and non-tax payments by March 1, 2013.

Here is how the transition will work.

- Anyone applying for Social Security or Supplemental Security Income (SSI) benefits on or after May 1, 2011, will receive their payments electronically, while those already receiving paper checks will need to switch to electronic payments by March 1, 2013.
- Anyone already receiving their benefit payments electronically will continue to receive their payment as usual on their payment day.
- People receiving benefits have the option of direct deposit to a bank or credit union account (of their choice) or into a Direct Express Debit MasterCard card account (a Treasury-recommended prepaid card option). You can visit www.GoDirect.org to learn more.
- Social Security, SSI, Veterans Affairs, Railroad Retirement Board, Office of Personnel Management benefits, and other non-tax payments are included.

For most people getting monthly benefits, this won't really be a change; already 8 out of 10 beneficiaries receive payments electronically.

Why the push for electronic payments instead of paper checks received in the mail?

It's safer: no risk of checks being lost or stolen;

## **NEW ORLEANS-STYLE CHICKEN**

#### **INGREDIENTS:**

- 1-1/4 pounds boneless skinless chicken breasts, cubed
- 3 teaspoons canola oil, divided
- 2 medium carrots, chopped
- 1 large onion, chopped
- 1 medium green pepper, chopped 1 medium sweet red pepper, chopped
- 2 portobello mushrooms (3 ounces each), chopped
- 3 garlic cloves, minced
- 2-3/4 cups hot water
- 1 can (15 ounces) black beans, rinsed and
- 1 package (8 ounces) red beans and rice mix
- 1 can (14-1/2 ounces) Hunt's® Original Diced Tomatoes, drained
- 1/3 cup shredded Asiago cheese

#### **DIRECTIONS:**

In a large nonstick skillet, brown chicken in 1 teaspoon oil over medium-high heat until no longer pink; remove and set aside. 
