# SIERRA MADRE VOLUNTEER FIRE **DEPARTMENT RESTRUCTURES**

—Altadena-



The Sierra Madre City Council voted Tuesday night to approve a re-structuring of the Sierra Madre Fire Department that would eliminate the Paramedics Coordinator position and the Fire Marshal position, and add three paid Captain positions. The current Paramedic Coordinator and Fire Marshal would remain as Captains, and their duties would be incorporated into the duties of the new Captains position.

Reason for Restructuring
The restructuring was described by Chief Steve Heydorff in the Staff report as "The next step in the continuous improvement of the Sierra Madre Fire Department." According to in which it started or allowing it to spread to other parts of Heydorff, the intent of the restructuring is to "improve response times, enhance supervision and bring the departally arrive on the scene two minutes earlier than the engine ment closer to the goal of automatic aid."

According to Heydorff, staffing a fire engine requires one captain, one engineer (driver and pump operator) and two firefighters. The least expensive schedule for 24/7 on-site staffing requires three captains, three engineers and six firefighters. Currently, the firefighter positions are adequately filled by volunteers, with the availability of captains and engineers varying daily. Heydorff stated that the proposal he was presenting seeks to ensure the constant staffing of the fire engine by a qualified captain.

Currently, the "firefighter" portion of the staffing has 2 to 4 volunteer firefighters in the station 24/7. Over time, this has evolved from these positions mostly filled by local residents to the current status, in which most of the firefighters are recent academy graduates who are not residents of the City, who volunteer to complete an apprenticeship that will result in state firefighter certification.

The captains staffing is, however, a "combination" model, which consists of paid and volunteer participants filling the role of captain. Weekdays, the captain role is taken by the fire marshal and the paramedic coordinator. However, weeknights and weekends, the captain role is filled by volunteers who respond from home to the fire station. This slows down response times, because the engine can not leave the station until the captain arrives. According to Heydorff, the possibility that the volunteer may not receive the call or may be unable to respond is the main reason that Sierra Madre is not included in the 12-city Unified Response automatic aid agreement. Under Unified Response, when 11 of the 12 participating cities experience a structure fire, additional resources are automatically dispatched from neighboring cities at the same time that the engine from the city in which the structure is located is dispatched. In Sierra Madre, part of the time, our engine must wait for the captain to arrive at

the structure, then verbally request mutual aid from other agencies. Sierra Madre's inability to guarantee immediate dispatch by having an on-site captain has prevented its inclusion in the reciprocity agreement.

Chief Heydorff also stated that analysis of recent data indicates that response times could be cut by two minutes if captains were in place at the station full time. According to the Chief, in the initial stage of a fire, it doubles in size every two minutes, so cutting the response time by two minutes could mean the difference between confining the fire to the room when the captains are not at the station, they are unable to begin advance life support until the engines arrive on the scene because they are busy with basic life support issues. That two minutes could prove critical to some patients, particularly those in need of resuscitation due to cardiac arrest. Chief Heydorff also stated that the addition of round the clock captain staffing at the station would improve supervision, training, teamwork, maintenance, and performance. Cost of Adding Full-time Captain Position

Cost to add a full-time paid captain to the department (two of the three captain positions are already funded as fire marshal and paramedic coordinator) is estimated at approximately \$130,000/yr. Salary would be somewhere between \$66,357 and \$84,690 a year, with the balance up to \$130,000 made up by benefits and retirement. CalPERS designates the position as "public safety personnel" which means a higher percentage of employer and employee retirement costs compared to non-public safety personnel. A survey of salaries for captains at fire departments of five local communities (Arcadia, Monrovia, Pasadena, San Marino and South Pasadena) showed that on average captains are paid \$80,637 to \$101,400, with South Pasadena the lowest at \$74,340 to







## Sierra Madre's Mater Dolorosa & Its Meditation Gardens Open to the Public on Good Friday,

April 22 Photos and story by Chris Bertrand

The magnificent grounds of Sierra Madre's Mater Dolorosa Catholic Retreat Center will be open to the public at two times on Good Friday, April 22. From 9 a.m. to 12 p.m. the gardens and grounds will be available for private reflection and prayer. At noon the gates will be closed. Later, at 4:30 until dusk, Passionist clergy, staff, board members, and volunteers will direct public devotions and prayer of the Stations of the Cross, according to Fr. Patrick J. Brennan, C.P., Retreat Director, and Elizabeth Velarde, Administrator.

Over the years, this once a year, public event has grown to draw up to 2,500 visitors of all ages to this, one of the largest privately held parcels of Fr. Pat Brennan, at Mater Dolorosa property in the community. Many say that just driving through the Mater Dolorosa gates, one can feel that the space here is sacred ground and the perfect place for quiet reflection. The gates at

the northern end of Sunnyside Avenue open wide to reveal a long avenue of overarching trees flanked by extensive open meadows.

When I visited again this year, the meadows glowed with an almost iridescent shade of spring green, benefiting from the much needed rains of the past months. Slowly one ascends to the collection of buildings tucked up against the mountain. It really becomes a journey each time I have entered these gates. I cannot but be taken aback by this place, causing me to pause, if only a moment, to take it all in, even when it's for a secular event.

Set in the beautiful foothills of the San Gabriel Mountains, the many acres of Mater Dolorosa definitely give one a feeling of stepping away from every day life. Located adjacent to Bailey Canyon Park and trails, the vistas, the mountains, the natural vegetation and the extensive cultivated gardens are breathtaking, causing one to revel in the beauty that abounds here.

The outdoor Stations of the Cross were constructed over 50 years ago by a former Sierra Madre mayor, Bill Schiltz, whose son was a member of the Passionist religious order here. The Catholic tradition calls out fourteen different points in this journey to Christ's crucifixion, naming it the "Stations of the Cross". These stations are set into the densely treed hillside, and one travels approximately the same distance walked by Jesus on the road to Calvary.

Several other garden areas will also be open to the public that day. The recently completed gardens surrounding a statue of St. Paul of the Cross, founder of the Passionist religious order are located at the northwest corner of the property. Here, a shaded perch allows one to sit, reflect and view nearly the entire LA basin far below. The succulent gardens include many varieties of plants with low water requirements, yet lots of texture and color.

The garden of Mary's Seven Sorrows is the only area separately gated from the abundant wildlife that shares Mater Dolorosa with its human occupants. Inside the beautiful wrought iron gates, the trumpet vine is brilliant with its huge yellow bugle-like flowers, and four of the nine water features peacefully gurgle. A magnificent, life size bronze statue of Christ and his mother is not to be missed. A wistaria pergola encircles the garden, and the heat followed by rain of the last weeks has quickly brought the purple flowering vines to eye-popping flower.

If you plan to visit Mater Dolorosa on Good Friday, April 22, Velarde calls attention to a few points. The terrain is moderately steep, so wear comfortable walking shoes. Bring a jacket against the evening chill, a flashlight, as there is minimal night lighting, and an umbrella. Plan to begin your visit in the chapel where a short history and reflection will be offered to each group of about 40.

### 'Open Carry' of Handguns Bill Passes Committee

A bill to repeal an "open carry" loophole in state law moved a step closer to approval Tuesday as the state Assembly Public Safety Committee voted in favor of Assemblymember Anthony Portantino's AB 144.

The bill would make it illegal to carry an unloaded handgun in any public place or street. Law enforcement personnel are exempt as are hunters and others carrying unloaded weapons under specified licensed circumstances Portantino said in a press release.

"This is a sensible gun ban that law enforcement asked me to carry to make our streets and communities safer," explained Portantino. "I think most Californians would agree that they don't want people walking around in parks or in coffee shops with a gun strapped to their hip. Whether it's loaded or not, it creates some very real public safety issues."

Despite being passed both houses in the legislature, similar legislation failed to reach the Governor's desk last year due to a large number of controversial bills on file at the end of session. This means that Californians may walk into a grocery store carrying an unloaded weapon on one hip and the bullets on the other. After seeing a rise in these types of needless public displays, law enforcement officials sought the ban on this open display of firearms. Portantino took up the cause and has worked with law enforcement to re-introduce the "open carry" ban. The measure is supported by the California Police Chiefs Association and PORAC rank and file police officers. Representatives from both groups testified at today's hearing.

The Los Angeles city council recently voted to support AB 144 and asked the L.A. City Attorney to look into writing a similar law banning open carry handguns in Los Angeles.

California is one of many states that allow so-called "open carry" which gives gun owners the right to display weapons, though in California those guns must be unloaded. Carrying loaded firearms in public is already against the law in California.

The suspect then surrendered without further incident. He was taken to a hospital and held for a 72-hour mental evaluation, pending criminal charges.




# I'M ALIVE!

Teacher rumored dead speaks out that life can go on after Cancer -- calls on Arcadia Elementary Schools to be involved with the American Cancer Society's Mini-Relay for Life – coming June 3


The other day, I was walking my  $4^{th}$  grade class to lunch when a student from another  $4^{th}$  grade class walked up to me and exclaimed, "Mrs. Conroy, my brother at Dana told me a rumor was going around there that you were dead!" After having my breath temporarily sucked out of me by the statement, I regrouped. "Tell your brother to set them straight at Dana Middle School, would you please?" I requested. "As you can see, I am far

A middle school rumor had declared me dead and that made me sad, as well as angry. After calming down, I realized that rumor had been created and spread by ignorance, fear, and a lack of awareness that life can go on after getting cancer. The incident was but another reason why I knew I did the right thing in getting involved with hosting the American Cancer Society's upcoming Mini-Relay for Life. I had to get the word out to young kids that just because you get cancer, it doesn't mean your life is over. Don't get me wrong. I am no Pollyanna. I saw both my mom and my sister die from cancer. However, in both cases, the cancer was not detected early. It is part of my mission as a teacher and two-year survivor of breast cancer, to show by example that life can go on after getting cancer. Early detection and treatment are key, of course, as well as a fighting attitude and healthy living habits. I also want to share that, believe or not, there are benefits gained from the horrendous experience. Those who survive take with them a unique appreciation for life, a second chance to make each moment count, not stress on the little things, and focus on soaking in the things that really have meaning – your kids and loved ones, and reaching out to others to make Jonie Tsuji proudly let's her students know...She's Alive! a difference.

### TIPPING 101

Our fearless leader Susan asked me for a little spring cleaning, a tour of my favorite subject. We all know them, the people that just can't bring themselves to leave a decent tip. What is the thinking behind tipping and what should be given, and when did it start in America? Tipping began to take hold in States in the late 19th Century after the Civil War. It was widely considered by many groups including the intellectuals of the day as an outright evil. Newspapers wrote vigorously against its vices. They reasoned that it established an aura of servitude, by offering a demeaning handout, or token. It implied a superiority of class and status that conferred on the lowly receiver of these offerings. There were groups such as bartenders that flatly refused tips as they considered it far below their status to receive these patronizing gifts. Now when someone says, "those were the good old days," you may know what they mean. It many ways the objections did make sense at this time in America. What about the places where you have to tip in advance. This does not insure good service, does it? Only at a place like a Starbuck's does this seem to make any sense. There are very few times that I have gone to a restaurant and actually tipped in advance.

When determining a tip at a restaurant, what are you to consider before settling your bill and factoring a tip? At the restaurant you are tipping on the speed, accuracy and usefulness of the servers, and not on the food. Is tipping at a fancy restaurant different than tipping at a coffee shop? Many people believe it is. I feel like I stepped in something when I hear that said. They are to be treated as the same.

Here are my guidelines for tipping but not necessarily the way I tip. I even give 10% for atrocious service. You on the other hand can wield far more influence than is availed to this restaurant critic.







### **IDLE LABOR**

A resurrection of '80s new wave in 2011? I'm down for another go around. Craft Spell's debut album, "Idle Labor", is an influential album from those who did it best - New Order, The Cure and Tears For Fears. "Idle Labor" is an introspective, faintly despondant, reverie record that showcases singer/songwriter Justin Paul Vallesteros' mesmerizing vocals, tenderness, and heartache. A dreamy,

idealistic, straight from the bedroom produced album for the kids with the dreamer's disease and those completely clinging onto a better, yet forgotten yesterday. I'm not advocating that Craft Spells are reinventing the wheel with their debut effort, but there is an innate catchiness and distinctiveness to their creative endeavor.

Everything you might expect from an '80s inspired record is found here. A recognizable atmosphere is set up with drum machines, synths, maudlin vocals, and dancing-alonein-my-bedroom sort of bass reverbs. There is an eclectic yet cluster of emerging bands these days with the same summery, dream-pop, lost-in-thought style. Even when one thinks this genre has become oversaturated, an album such as this gracefully arrives to reassure you a new component can be added into the mix. I can't even keep up with all the subgenres anymore, but "Idle Labor" falls

under glo-fi, chillwave, 80s new-romantic and bedroom-pop genres. At the end of Album: day though, it doesn't matter what category Artist: they're associated with. Simply put, this is a beautiful, sensitive, somber, yet ironically Label: inspiring work of art. I am enamored with Release Date: March 29, 2011 this type of music persuasion and Craft Spells have easily established themselves as a band with a promising future.

However, Craft Spells isn't headlining the revolution, but purely a significant player in the movement. Fans of indie darlings, *Wild Nothing* and *Beach Fossils* should find something commendable here to connect with. The party is short-lived though, as the album clocks in right under 37 minutes. I like to think of "Idle Labor" as a mixtape sort of album. You'll listen it to, embrace it for all it represents and then after awhile you'll put it to the side where it becomes lost in your drawers. Years later when you're enduring another transitional period in life, you'll come across this previously beloved mix. It'll seamlessly feel impeccably aged when you first pop into your CD player. A few moments later, you'll become hyponotized by the subtle beauty, nostalgic undertones, and perfect nuances for a second time around.


### Rawhide Down: The Near Assassination of Ronald Reagan by Del Quentin Wilber



The book reads like a literary thriller with cancer



as the protagonist. The book is about the people who have soldiered through demanding regimens in order to survive and to increase our understanding of this disease. Riveting, and surprising, it is an illuminating book that provides hope and clarity to those seeking to demystify cancer and a look into the future of treatments.

There have been expressions of dismay at home about how a company with an otherwise sterling reputation for decent wages, benefits and union protections could so easily exploit a desperate workforce overseas. A company spokeswoman explains that it's simply "related to the standard of living and general conditions in the different countries."

The company is IKEA, based in Sweden, and the place with cheap, exploitable labor is Danville, VA. While IKEA's profits, \$2.2 billion in 2009, have risen, hourly wages at the Danville plant have dropped from \$9.75 to \$8.00 an hour (compared to \$19.00 an hour in Sweden). Bill Street, a union organizer whose efforts were squelched by management despite a majority of workers having expressed interest, observed it's "ironic that IKEA looks on the U.S. and Danville the way that most people in the U.S. look at Mexico."

Barely a decade ago, we were looked upon as a nation of consumers, with cheaplabor factories overseas. Today, we've been supplanted as the world's largest economy by the European Union, China is becoming that nation of consumers, and we're the land of an \$8 an hour workforce. We also have a typically third-world distribution of wealth, with the top 1% controlling almost half of it.

Barely two years ago, we heard Republicans proclaim their "top three priorities" were "jobs, jobs, and jobs". When it became clear what they had in mind was the \$8 an hour variety, the focus then became the deficit.

Any pretense of concern over the deficit disappeared when the wealthiest were exempted from any responsibility to help alleviate it. Those of us in the bottom 99% were asked to sacrifice - not for the deficit - but to shift more wealth to the top.

A new focus of budget battles in Washington is the Democrats' insisting on a "clean" bill, while Republicans are holding out for an extensive list of "riders". A look at that list of riders shows the main concern of Republicans is not jobs, nor the deficit, but an agenda for which they are willing to shut down the government in order to see it enacted, an agenda which:

Targets Wall Street reform by defunding the new Bureau of Consumer Financial Protection as well as the "consumer products complaints all about.

Bans already-approved funding for watershed and wetlands preservation, flood control, and various environmental projects in California. Now, the tool is not perfect but as Craig Gurian from Remapping The Debate says, "At a time when both the President and his GOP adversaries are looking to lower income tax rates, it is helpful to get some historical perspective — a process that quickly reveals that federal income tax burdens are near post- World War II lows."

"There are a number of obvious limitations in using the tool. For example, the additions and subtractions to gross income (that yield adjusted gross income) change over time. The deductions that are available to yield taxable income from adjusted gross income also vary over time. The tool, however, only addresses taxable income, and thus doesn't account for those changes. Likewise, the difference between ordinary income and income from capital gains (the latter currently gets preferential treatment) is not accounted for. The tool only deals with income tax, not payroll tax (payroll tax as currently structured exacts a disproportionate burden on lower- and middle-income taxpayers)."

But even with all the variables that keep it from being a perfect instrument, the tool should definitely make you take another look at our current tax situation. Use the link above and try it for yourself.

Perhaps we need to consider the consequences in our demands for lower taxes, and the way the tax burden is allocated. What and for a couple that earned a million dollars are we doing to ourselves? Yes, this is definitely something we need to think about!

### **SURVIVING**



As I opened my car door this morning and walked out the driver's door into the street, I felt relieved that it was exactly nine o' clock and I could park for free. I was still aware of this pleasant feeling as I clutched my files and books in both hands and suddenly felt myself falling head first onto the concrete. I had no free hands to break my fall and I smashed face-

first onto the street. Cars whizzed past me just barely missing my prone body and I kind of remember thinking about Johnny Wooden and Chick Hearn and my mother, all older people who had fallen and injured themselves shortly before their death.

Death has been on my mind lately as my mom only recently passed away and now one of my oldest friends, a friend of about fifty-five years, is fighting what seems to be a losing battle against brain cancer. Really, I thought of all this as I lay face down on the street. My right knee hurt and my glasses had smashed into the street and now were some distance away from me. I felt the pain in my leg and wondered if my mother would be angry at me for ripping my pants. Of course I realized all at once that my mother would not be around to and I sort of laughed to myself. Crazy as this sounds, I think this is what I experienced as I noticed people running towards me from the bus bench and then all at once a car screeched to a stop and the driver leaped out and ran towards me. All these people seemed to be talking at me in different languages but together they helped me up and someone gathered my stuff and placed it all on top of the car.

I heard myself saying gracias and I'm okay and now I recall shaking people's hands. I stated walking towards the Court and my knee hurt but my pants weren't ripped and I actually glanced up toward the sky and kind of chuckled wondering if my mom noticed. As I went through the x-ray machines at the door to the Courthouse one of the Public Defenders said hello and asked what was wrong. I guess I still looked pretty weird. I told her I had fallen on to my face and kind of cracked my glasses. She said how lucky I was not to have broken my wrists as I fell and all at once my whole attitude changed. I was in the present and feeling fortunate. I looked at her and noticed she didn't look quite right and asked, "How are you?" As we waited for the elevator she told me that she was due to have back surgery on Friday and that her discs were to be fused and she was scared.

The elevator came and we went to our respective floors. I was left with a feeling of great compassion for her and for the people who had helped me after I had fallen. All of us seemingly disconnected people are joined somewhere deep in our unconscious and jointly we take care of one another. We live our stressful overburdened lives struggling through the mazes of our responsibilities and fears. Sometimes we're in the present, sometimes we're not, but usually most of us have the feeling that we are pretty well-camouflaged and that we appear sane to the outside world. Sure it's a mask and inside we all struggle with our bills, our relationships, our health, our powerlessness and our denials. STILL LIFE IS NOT SO BAD. Believe it or not, I think the thing that keeps many of us going is the realization that we are loved.

From Supervisor Michael Antonovich on Federal Reimbursements To Counties:

"Shortchanging county taxpayers for the jail costs of criminal illegal aliens illustrates the federal government's 'don't-give-a-damn' attitude when it comes to reimbursing local governments for illegal immigration," said Los Angeles County Mayor Michael D. Antonovich on the passage of Continuing Resolution H.R. 1473.

"The federal government's reimbursement is critical to the county -- but \$11.8 million PALES in comparison to the \$550 million in public safety costs provided by the county taxpayer for illegal immigration," he added. "Without full reimbursement, county budgets are stretched to the breaking point."

"In addition to the \$550 million for public safety, the Los Angeles County taxpayer is responsible for another \$500 million for healthcare and \$625 million in welfare benefits and food stamps for native-born children of illegal immigrants -- totaling over \$1.6 billion dollars a year, not including the hundreds of millions of dollars for education."

## Assemblyman Tim Donnelly and California Legislators Head to Texas for Governing Tips?!

### Portantino's Bill to Freeze Salaries of State's Highest Paid Workers Sacramento Shelved For the seventh time

Assemblymember Anthony Portantino's measure to freeze the pay of California's highest paid employees included. The potential savings would bas been put on hold in the Assembly, be in the tens of millions. While it is despite a looming state budget deficit of \$15 billion dollars.

AB 7 calls for a two-year freeze

on state employees who earn over \$150,000 per year. Today in Assembly Appropriations, Portantino (D-La Cañada Flintridge) introduced amendments to reduce the salary threshold to \$100,000 – meaning thousands more state employees would be subject to the salary and bonus freeze.

"It is unacceptable to be giving raises and bonuses when we are still struggling with a budget deficit in the bil-lions and one of the highest unemployment rates in the nation," stated Assemblymember Portantino. "Over the past three years, my bills on this issue have been held on "Suspense" in this committee because I was told they would not save money. Let's reduce the salary amount and see how much more we can save over the next 24 months. If President Obama can freeze the salaries of White House employees making \$100,000 or more, why can't we do the same here in California?

According to the State Controller, some 3, 300 state employees could be

be in the tens of millions. While it is not binding for the University of California, the measure urges the Regents to adopt the policy for UC employees. In 2009, virtually all of CalPERS

investment managers were awarded bonuses of more than \$10,000 each with several earning bonuses of more than \$100,000. The cash awards were distributed even as the fund lost \$59 billion.

Despite record losses in 2008, Cal-STRS gave an incentive award of \$208,677 to a chief investment officer who had a base pay of \$330,000

"If we are serious about saving money, then this legislation sends a clear message that California needs to prioritize its limited resources and reinin spending, testified Portantino. "It makes no sense for CalPERS money managers to get raises when cities and schools are looking at large cuts. It's unconscionable that this bill does not move to the floor for immediate action.

# **Curbing Bad Behavior:** Real Sports by Ron Carter



"Real Sports With Bryant Gumbel" is arguably one of the best sports show on television. Bryant and his colleagues usually produce some of today's most controversial, well executed and newsworthy issues in sports. The recent episode of "Real Sports" which centered around the question, "should college athletes be paid for playing sports?" though provocative was also a cautionary debate of what's wrong with the National Collegiate Athletic Association's

(NCAA) policy regarding compensating college athletes. The round-table discussion with guests Billy Packer, college basketball analyst; Rich Rodriguez, former football coach of University of Michigan; Jason Whitlock, sports journalist; Jeffrey Orleans, former commissioner of the Ivy League and Gumbel was spirited and informative, but it left a few questions unanswered.

Packer and Rodriguez were against paying college athletes while Gumbel, Whitlock and Orleans were in favor of paying the athletes. College athletes are fueling a multi-BILLION DOLLARS industry, college sports, which do not compensate them fairly for the billions of dollars and notoriety they bring to their schools. Most of the athletes recruited to play college sports are from poor and middle class families. Thus, the opportunity to play college sports and eventually have a professional sports career is alluring to the recruits. The question is, "are they prepared to take advantage of the opportunity," asked Jason Whitlock. I believe that most of them are not.

I also believe that the statement made by Bernard Goldberg, a regular journalist on "Real Sports" who was assigned to conduct the interviews for the episode, was the most poignant remark. He intimated that the NCAA has a great business model as a matter of fact it's the "only one" of its kind in America. The model is "you make billions of dollars, but you don't have to pay the employees anything." The colleges make hundreds of millions of dollars, the coaches make millions and the athletes, some of them, cannot even afford food and the opportunity to visit their families at the end of the football season.

Though the NCAA is a benevolent institution, it must do more financially for its college athletes. It's one of the only ways to eliminate some of the bad behavior (cheating and grafting) that is taking place in college sports. After all, college students studying other professions are allowed to make money while in college, why shouldn't college athletes have the same opportunities.

# LOOKIN with Bob Eklund Adventures of a Mount Wilson Telescope Operator

### PJ Sallave-Goldfinger tells what it's like to operate Mount Wilson Observatory's CHARA Array and the famous 100-inch Hooker Telescope.

A Research Technician for Mount Wilson Observatory's CHARA Array, PJ Sallave-Goldfinger gives an informative talk on the adventurous undertaking of running this coordinated array of six telescopes. This free lecture will be held on Saturday, April 23, at 2:30 p.m. in the Community Room of the Altadena Public Library. It is being presented as a public service by the Mount Wilson Observatory, and all are welcome.

Ms. Salave-Goldfinger, who describes herself as "an amateur astronomer at heart," has worked at Mount Wilson Observatory for over 10 years, operating both the 100-inch telescope and the CHARA Array. She presents a unique and enjoyable discussion about this mountain observatory and her interesting experiences

The CHARA Array is an optical astronomical interferometer operated at Mount Wilson by The Center for High Angular Resolution Astronomy (CHARA) of the Georgia State University. It is formed from six 1-meter (40-inch) telescopes arranged along three axes with a maximum separation length of 330 meters. The light beams travel through vacuum tubes and are combined optically, requiring a building 100 meters long with movable mirrors to keep the light in phase as the earth rotates. CHARA began scientific operation of the array in 2002.

Mount Wilson Observatory Now Open to the Public

As of the beginning of this month, the Mount Wilson Observatory/ Skyline Park area is open for public access daily between 10:00 a.m. and 4:00 p.m.

The "Cosmic Café," is also open (serving sandwiches) on weekends, and guided public walking tours of the Observatory are being given each Saturday and Sunday at 1:00 p.m. Tours begin at the pavilion in front of the Café (overlooking the large parking lot).

The Angeles Crest Highway has not yet re-opened from La Canada (pending completion of repairs), so you'll need to use the alternate route to Mt. Wilson, via Big Tujunga Canyon from Sunland. For directions and a map, see the Observatory website, www.mtwilson. edu. Allow about 1.5 hours from the Sunland Blvd. freeway offramp to the Observatory. Total distance, offramp to Observatory gate = 26.3 miles.

Enter the Observatory gate marked Skyline Park, and park in the lot below the Pavilion. To reach the Observatory, walk in on the access road (far left side of parking lot) about 1/4 mile to the Observatory area. The Museum is opposite the 150-foot solar tower.

NOTE: The U. S. Forest Service requires those parking within the Angeles National Forest to display a Forest Adventure Pass. A National Parks Senior Pass or Golden Age Passport is also acceptable. The Forest Adventure Pass can be obtained at the USFS Clear Creek Ranger Station or at Sports Chalet

# Ask jai.....

Ask jai is a weekly column that will strive to honestly answer your job search questions relating to job searching techniques, networking skills, resume writing and interviewing. The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering you questions, but I will be totally honest. My objective is to help you achieve your employment goal.

Is it important to include my computer skills on my resume? I am a computer professional and feel that employers should know that I am expert in my field? What other skills should I list on my resume? Kenny

Yes, it is very important for you to list your computer skills on your resume. Employers do not have the time to contact you and find out if you have specific skills. Employers use keywords and criteria when searching for candidates in resume databases. 99.9% of employers will use applicant screening software to identity candidates. Having the correct skill set keywords included in your resume is mandatory in order for an employer to find you. If you do not include skill sets on your resume, an employer might assume that you do not feel that the skills are important enough to performing the position or worse yet not important to you at all.

Not including skill sets on your resume or application could result in you being screened out of consideration for a position. I know candidates who were not hired because they did not include Microsoft Word and Excel on their resume. The employer just assumed they were just not computer savvy. As a high tech or computer professional you should definitely include your technical and professional skills. These include skills performed in a job, task, or class, acquired by reading, training, or education. Create a Computer Skills section with sub-headings on your resume. I suggest that you place this section at the beginning of your resume and include any operating systems, hardware, software and programming skills that you have experience using over the past 5 years. It would be to your advantage to list all your computer skills rather than lose a job opportunity, because you were too selective. Do not just list "Microsoft Office", list each individual software program (i.e., Microsoft Word, Excel, Power Point, etc.). Add any proprietary software programs that you learned at a former company. Listing proprietary software programs will reveal to the employer that you can adapt to any computer system. Include any foreign languages that you may speak or write in a Language Skills section.

I know job seekers who were interviewed and hired based solely on their foreign language skills. Technical Skills and Equipment Skills are great sections to add to your resume as long as they are relevant to the position you are seeking. Any special projects that you have participated in or managed can be included in an Occupational Skills section. The Work Experience and Education Section of your resume should support your skills sections. These two sections should explain how you acquired the knowledge, where you used the skills and your accomplishments.



### WHAT YOU CAN DO TO SPEED UP YOUR DISABILITY APPLICATION

If your disabling condition is we need? preventing you from continuing to work, you may want to apply for disability benefits through Social Security. In most cases, doing so involves a thorough process of determining your eligibility, medical condition, and ability to work. Because we look so carefully at so many cases — more than three million each year — it can take us three to five months to determine whether you are

Processing times on that initial claim can vary depending on several factors, but primarily

the nature of your disability; how quickly we obtain medical evidence from your doctor or other medical sources; and whether we need to send you for a medical examination in order to obtain evidence to support your claim.

There are things you can do to help speed up the process. The more information you provide up front, the less time it will take us to obtain the evidence we need — and the faster your claim can be processed.

Any medical records or documentation you have is helpful. We can make copies of the records you have and return your originals; The names, addresses, and

phone numbers for any doctors, medical facilities, treatment centers, or providers related to your disabling condition; The names, addresses, and

phone numbers for previous employers and the dates worked for each employer; Workers' compensation infor-

mation, including the settlement agreement, date of injury, claim number, and proof of other disability benefits awarded; Names and dates of birth of your minor children and your

Dates of marriages and divorces (if any);

Checking or savings account number, and the bank's 9-digit routing number, so we can deposit your payment electronically;

Name, address, and phone cation for disability benefits, number of a person we can contact if we are unable to get curity.gov/disability. in touch with you.

If this disability application is for a child, we need the name, What type of information do address, phone number of

the schools attended and any school records you can provide. We also ask you to sign release forms that give us permission to obtain the information needed from third parties to make a

decision on your claim. The best place to start is online at www.socialsecurity.gov/disability. Select "Disability Starter Kit" in the left column. There, you'll find more information and starter kits for both adults and children.

You can apply online for disability benefits (the easiest method), or you can make an appointment by phone or in Social Security office. The choice is yours.

(For Supplemental Security Income (SSI) disability benefits, you cannot apply online, but you still can complete the Disability Starter Kit to prepare for the interview and speed-up the processing time.)

## Recipe of the Week: Classic Carrot Cake

### **INGREDIENTS:**

2 cups shredded carrots 4 eggs

1 cup sugar 1 cup packed brown sugar

1 cup canola oil 2 cups all-purpose flour

2 teaspoons baking soda 2 teaspoons ground cinnamon

2 packages (8 ounces each) cream cheese, softened 1/4 cup butter, softened

2 teaspoons vanilla extract

1-1/2 cups confectioners' sugar 1/4 teaspoon salt

3/4 cup chopped walnuts

### **DIRECTIONS:**

Drain pineapple, reserving 2 tablespoons juice (discard remaining juice or save for another use). In a large bowl, beat the carrots, eggs, sugars, oil, pine-apple and reserved juice until In a large bowl, beat the carrots, eggs, sugars, oil, pineapple and reserved juice until well blended. In a small bowl, combine the flour, baking soda, cinnamon and salt; gradually beat into pineapple mixture until blended. Stir in walnuts. Transfer to a greased 13-in. x 9-in. baking dish. Bake at 350° for 35-40 minutes or until a toothpick inserted near the center comes out clean. Cool on a wire

For frosting, in a large bowl, beat cream cheese and butter until smooth. Beat in vanilla. Gradually beat in confectioners' sugar until smooth. Spread over cake. Yield: 12 servings.



The presentation from the street is breathtaking, with traditional, English style, red brick exterior, the distinctive hipped and gabled rooflines and chimneys. Inside, the grand reception hall has been installed with an iron chandelier, sconces and original artwork, then softened with furnishing vignettes by George Massar Design of LA.

The Great Room, quite stunning even in its "empty room" state before the showcase project, boasts a vaulted wood ceiling, leaded windows and a hand carved fireplace. David Dalton, also of LA, created custom designed furnishings with multiple seating areas for the massive room, in a dramatic décor palette in black and gold, accented by "Geranium Red, Carnation Pink and Dahlia Orange," according to the designer.




