SMPD CHIEF MARILYN DIAZ TO RETIRE

On Thursday, when news of Sierra Madre Police Chief Marilyn Diaz became public, many Sierra Madreans immediately began expressing their disappointment. "It's not that she doesn't have the right to retire, but she was doing so good", said one longtime

When Diaz became Chief of the SMPD in 2006, she also became the first female Police Chief in Los Angeles County and made national news. Prior to coming to Sierra Madre, she served for 32 years in the Pasadena Police Department.

Diaz, a Sierra Madre resident, recognized immediately that the SMPD had a unique mission as Sierra Madre is a city that "provides their own services catered to the needs of the community." She also recognized that there had been an accumulated degradation of service to residents and that changes need to be made. She quickly began

REMEMBERING THE SIERRA MADRE (SANTA ANITA) FIRE

Three years ago at about 3pm on Saturday, April 26th, 2008, a fire broke out in the mountains above Sierra Madre. The fire burned for several days, ultimately burning 584 acres at the time of its containment on May 1st. Two hundred thirty eight acres were in the Angeles National Forest, and three hundred forty six acres were within the corporate boundaries of Sierra Madre. Five minor injuries were reported, at one point more than 1,000 firefighters were assigned to the fire. Just after midnight Sunday morning, the City Council under the leadership of Mayor Kurt Zimmerman had an emergency meeting to declare the City to be in a state of emergency, freeing up resources from outside agencies to assist in fighting the fire.

Two Red Cross shelters were set up. Approximately 1000 people were evacuated from Oak Crest Drive across Carter Avenue to East Mira Monte Avenue, continuing down Mountain Trail Avenue, across Grandview Avenue to Santa Anita Avenue. A wedding party of 45 people and four pets were helicoptered out from Sturtevant Camp, it took five helicopter trips to move them all.



CITY TO HOST GENERAL PLAN UPDATE TOWN HALL FORUM MAY 7TH

The City of Sierra Madre and the General Plan Update Steering Committee (GPSC) is seeking input from the public at a Town Hall Forum to be held at the Sierra Madre Fire Station from 1 pm

to 4 pm on Saturday, May 7th. The Fire Station is located at 242 W. Sierra Madre Blvd., right next to Memorial Park, which will be the site of the annual Friends of the Library Art Fair that day (and all weekend). Make a day of it, start with the Firefighter's Pancake Breakfast at the Station in the morning, visit the Art Fair, and return in the afternoon to the Fire Station for the Forum!

This forum is a community wide brain storming session to help determine the vision to carry Sierra Madre into the next 20-30 years. 

ASSISTED LIVING DEVELOPER UNDER CONTRACT TO **PURCHASE FORMER SKILLED NURSING FACILITY, 225-45 W.** SIERRA MADRE BLVD.

With the weeds growing through the cracks in the pavement at the former skilled nursing facility across from City Hall, the site has become more of an eyesore each year that it stands empty and dilapidated. Fountain Square Development West LLC partner, Billy Shields, confirmed April 20th, that they have entered into a contract to purchase the site, but have not closed on a

"Three of us are involved, and I will be leading the development out here in the West," noted Shields. "We plan to build, then become owner operators of this residential community."

In March, Shields appeared before the City Council, not with a formal plan or formal application, but to open an exploratory dialogue with the community. The organization's idea is to develop a fully licensed, assisted living community housing about ninety, with a staff of approximately 25, including 24/7 nursing. A part of the facility would accommodate Alzheimer's or dementia residents.

Shields explained further, "We've made preliminary application to the city, which allows them to respond to some of the basic parameters we are proposing. We're anxious to get their comments and key questions answered, and to have the different departments look at the plans. Within a month of that meeting, we plan to meet requirements for the formal application."

Shields, a resident of Poway, played for the San Diego Chargers, the New York Jets and 1984 Super Bowl champion San Francisco 49ers, before moving to senior living community development at Virginia-based, Sunrise Senior Living, where he spent 17 years.

'I've enjoyed the senior living business, particularly when we open new communities... when we see the families and the residents move in a frail elderly resident. It's so much more rewarding than building apartments and commercial real estate," reflected Shields.

The Fountain Square team all came with experience from Sunrise, before creating their own senior development organization. Sierra Madre will be their third project, after

their first in suburban D.C., and a second in White Plains, New York.

Shields invites Sierra Madreans to view the website for their New York assisted living residence at www.TheKensingtonAL.com, with the sidebar note that each development is customized to the style of the community.

Shields and his partners welcome input on Fountain Square's development ideas from neighbors and the community at 858-748-0201. The group also plans forums, perhaps on the site grounds, as the process evolves.

Week-long Crime Spree Halted by Pasadena Police

Two men were taken into custody by police Monday after allegedly committing a series of robberies from Beverly Hills to Arcadia to Pasadena.

Juan Navarro, 24, and Gregorio Villalobos, 28, both from San Fernando Valley were arrested without incident police said.

Between 11:30 a.m. and 12:39 p.m. Monday, three armed robberies and one attempted robbery occurred in Pasadena. Police said the crimes were thought to be committed by Navarro and Villalobos armed with a handgun and driving a gray GMC Yukon.

Police said approximately five minutes after the last robbery, officers and the police helicopter searched the area and located the driving two suspects southbound in the 600 block of Lincoln Avenue. The vehicle was stopped and inside the Yukon was property taken from the victims, along with a loaded .45 caliber handgun.

Following the arrest, Pasadena Robbery Detectives Carlos Sainz and Carolyn Gordon researched similar robbery cases reported in Los Angeles County. Detectives identified Navarro and Villalobos as likely suspects who committed multiple armed robberies in the cities of Los Angeles, Beverly Hills, Glendale, and Burbank. The spree appears to have begun on April 19, 2011 and targeted male adults they said.

The Los Angeles District Attorney's office filed six counts of armed robbery; three counts of attempted robbery, and personal use of a firearm. The suspects were arraigned Wednesday and remain in-custody with

NASA Technology Looks Inside Japan's Nuclear Reactor

A new rover named PackBot, designed by JPL and created by IRobot, is being used to take radioactive readings in Japan's Fukushima nuclear reactors the agency announced Thursday.

The iRobot PackBot employs technologies used previously in the design of "Rocky-7," which served as a terrestrial test bed at JPL for the current twin Mars rovers, Spirit and Opportunity. PackBot's structural features are modeled after Rocky-7, including the lightweight, high-torque actuators that control the rover; and its strong, lightweight frame structure and sheet-metal chassis.





An enthusiastic group attended the dedica- Parents, students, teachtion of the Demonstration Garden at Sierra ers and administrators Madre School on Tuesday, April 26th. The front lawn of the school at 141 W. Highland was chosen because of its high visibility within the community, including the families of the 700 students in attendance at the school. Nearly a year in the making, the expansive grassy area has been transformed into a water-thrifty landscape, using mostly

California native plantings.
The project's theme, "Conserve, Preserve and Restore" is manifested in a new, water efficient irrigation system, redirected rainwater runoff from the huge roof, a smaller, water thrifty lawn area planted with low water usage grass that stays green more months of the year, decomposed granite pathways for walking and water runoff, designated space for a future "edible garden" and, of course, the installation of a varied and beautiful palette of California native vegetation.

The intention is that a "picture is worth a thousand words" by showing the school community and the public at large that a landscape using local native plants can be beautiful and colorful, beneficial to the ecosystem and extremely water thrifty.

Á \$75,000 grant from the San Gabriel Valley Municipal Water District (SGVMWD) started the ball rolling in 2010. Plans were drawn, and significant contributions came from The Theodore Payne Foundation, Pasadena Unified School District and the City of Sierra Madre. Skanska and Marina Landscape donated \$50,000 in decomposed granite for pedestrian walkways that double

from Sierra Madre School pitched in, too, including placing rocks and mulch. În addition to proclamations from state legislative leaders, representatives from all the groups involved spoke passion-ately about the benefits of the completed demonstration garden. Those who spoke even began to chuckle at the repetitive themes in their personal kudos: diverse groups working together for a common cause, finding creative ways to work with limited funds, and the delight at the project's success.

During a tour of the garden, it was explained that natives often take three years to get fully established. As part of incor-

porating the garden into the school's curriculum and to help the public understand, placards with the words "Sleep, Creep, Leap" have been installed throughout the

The first "sleep" year, not much is visible as the plant is busy developing a deep root system. For this reason, the natives were planted during the rainy season, in November, to ensure as much natural rainfall and as percolation paths for rainwater runoff. cool weather to give the plants a healthy

Once established, most natives require only about 1/7th the annual watering that non-natives require, a huge saving in dollars and water. It's hard to take tea-partiers by a YouTube video of attendees at an April 18 rally in Cline's "Crazy" in the background, they denounce our non-citizen president ("once you're a Muslim, I don't think

you can change"), declare Medicare and Social Security "unconstitutional", and condemn our invasion of "Lyboner" (Lebanon? Libya? Lipitor?). Preferred news source is Fox, early presidential favorite is Donald Trump. And for a punch-line, "we're spending too much money on education." 168,367 views so far - and counting.

Perhaps some on the right themselves didn't take these new activists seriously enough. Lobbyist-funded front groups mobilized crowds to disrupt town hall meetings more than a year ago, incensed by warnings of cuts to Medicare through "Obamacare". They turned out en masse to the polls last November to support Republican challengers promising to tackle unemployment and growing deficits.

Many, though, weren't interested in merely serving as surrogate warriors for the GOP. Many actually cared about jobs, red ink and the future of Medicare. They learned town hall meetings are effective venues in which to voice those concerns.

Beneficiaries of reduced upper-marginal tax rates, those pulling in twenty grand (\$20G) a month turned out to be less likely to attend town hall meetings than those who rely on Medicare. And, there was a mistaken assumption that those currently enrolled are only concerned about themselves. As a 64-year-old town hall participant told her congressman, Rep. Lou Barletta (R-PA), 'You seem to think that because I'm not affected, I won't care if my niece, my grandson, my child is affected. I do care." She continued, "You said nothing in the campaign about 'I'm going to change Medicare.' Now you voted for a plan that will destroy

Rep. Robert Dold (R-Ill) got a similar reception when trying to explain the budget authored by Rep. Paul Ryan (R-WI) to his constituents in Buffalo Grove. As reported in the local Daily Herald, "It began with audience members telling Dold they don't believe chopping 10 percentage points off the highest corporate tax rate will create jobs. A handful of people in the audience identified themselves as business owners and accountants who said their effective corporate income tax rate is already lower than the lowest rates proposed in the Ryan plan. They pointed to companies such as GE that pay almost no taxes despite billions in profits as

ATTACK OF THE OIL MEN

So what do you do if you're the most naïve guy in partial to the Angels and the the room, in a job that's way over your head, all your major policies to date have proven unpopular AND unsuccessful, and yet you still want to be President of the United States for another 4 years? Simple, you blame someone else. Ignore the facts, hide the truth and pick on the most unpopular guys in the room to deflect attention from the field and the lower away from you. In short, if you're Barack Obama, you dredge up the old myth that the oilmen are trying to ruin this country.

Last week, President Obama announced in his regular radio address that the attorney general had "launched a task force with just one job: rooting out cases of fraud or manipulation in the oil markets." This of course was the logical second step after his previous announcement that his administration was "taking various measures to deal with oil prices and was watching out for price-gouging". It is so ironic that a president who is jokingly compared to the utterly incompetent Jimmy Carter would so slavishly follow the same script that Jimmy did when oil prices skyrocketed during his term. All that has ever been proven is that the free market works pretty well to price oil and gasoline based on basic supply and demand - just like it does with every other product or service sold in the economy.

The price of oil is going up because the demand for it is going up and the potential future supply is going down. Demand going up is a good thing; it means that developing economies, like India and China, are finally beginning to grow and provide an opportunity for their people to attain middle class status. Future supply going down is a bad thing, and it's a direct result of this administration's failed energy/environmental policies. tickets to that game? This isn't rocket science! If supply is suddenly decreased, and the same number of people still want to buy seats, the price will increase. In fact, it will rise to the level where the number of people who want to buy seats equals the number of seats that are available. That's how markets work. Nothing magic, nothing sinister. The only problem is the city's action in taking away one half the seats.

Returning to the oil markets. This administration's policies have been driving drilling rigs out of the Gulf. Six deepwater rigs have already been taken out of the gulf, and many of them are heading down to Brazil where Brazilian oil companies are allowed to drill for oil. President Obama announced a six month moratorium on deepwater drilling. When he finally removed the moratorium, he slowed the pace at which new permits are issued to essentially maintain a quasi-ban without having to admit as much. One U.S. District judge has already challenged the administration on this. Last December, the President stopped a five year plan which would have opened up portions of the mid-Atlantic to offshore drilling. The affect was to lock up 7 billion barrels of oil and about 36 trillion cubit feet of natural gas.

The overall result has been lower domestic oil production. The Energy Information Administration forecasts that oil supplies from the Gulf will fall 13% this year and another 10% next year. Supplies go down, so prices go up.

No magic here - just simple economics and inordinately stupid policies. But we shouldn't be surprised. Candidate Obama told us that under his environmental policies energy rates would have to skyrocket to force us to conserve. If there is market manipulation here (and there is), it's being conducted by the guys in suits at 1600 Pennsylvania Ave. Just more of the transformational change we were promised.

A Rising Tide Lifts All Yachts

No matter how you in America the rich get most of the pie and

the rest get the leftovers. The numbers are shocking. Today the top 1 percent of Americans control 43 percent of the financial wealth (see the pie chart below) while the bottom 80 percent control only 7 percent of the wealth. Increasable, the wealthiest 400 Americans have the same combined wealth as the poorest half of Americans -over 150 million people.

In 2007, the year before the current recession, the share of the after-tax income going to the top 1 percent hit its highest level (17.1 percent) since 1979, while the share going to the middle one-fifth of Americans shrank to its lowest level (14.1 percent).

During this same period, after-tax incomes for the top 1 percent rose by 281 percent after adjusting for inflation -- an increase in income of \$973,100 per household -- compared to increases of 25 percent (\$11,200 per household) for the middle fifth of households and 16 percent (\$2,400 per household) for the bottom fifth.

Put another way, income for the top 20 percent has increased since 1980 while real income for the bottom 80 percent declined. In 1980 the top 1 percent received 8 percent of the total income, while today they receive 18 percent. During the same period the income for the bottom 20 percent decreased by 30 percent.

In 1980 the top 0.1 percent of Americans received 2 percent of total income. Today they get 8 percent. In 1980 the average CEO made 50 times more money than the average worker. Today the average CEO make almost 300 times more than the average worker!

America has become a lot richer, while most Americans have seen their incomes stay the same or decline in terms of purchasing power. As Warren Buffett, the second richest man in America famously said, "There's class warfare, all right, but it's my class, the rich class, that's making war, and we're winning."

Wealth and income inequity today in slice it, when it comes America is by far the worst in the industo income and wealth trialized world and has fallen in line with many Third World countries.

> Some people look at income inequality and shrug their shoulders. So what if this person gains and this person loses? What matters, they argue, is not how the pie is divided but the size of the pie. That argument is fundamentally wrong. An economy in which most citizens are doing worse year after year -- an economy like America's -- is not likely to do well over the long haul.

> The top 1 percent have the best houses, the best educations, the best doctors, and the best lifestyles, but there is one thing that money doesn't seem to have bought: an understanding that their fate is bound up with how the other 99 percent live.

> Since 1973 national Gross Domestic Product (GDP) has increased 46 percent in real terms, but the medium income has only increased by 15 percent. Where did the other 31 percent go? It went to the

> Supply-side economics is the cornerstone of Republican economic theory and has driven U.S. economic policy since the Ronald Reagan presidency. He popularized the controversial idea that greater the tax cuts for investors and entrepreneurs would provide incentives to save and invest and produce economic benefits that "trickle down" into the overall economy.

> In other words, if government economic policy focuses on making the rich richer, the benefits will "trickle down" to everyone else. As supply siders are found of saying, "a rising tide lifts all boats." Since Supplyside economics has come to dominate American economic policy, the rising tide has certainly lifted a lot of yachts, but at the same time it has left most of the row boats stuck in the mud.

> The past 30 years of Republican economics has proven that trickle down theory is just a convenient excuse to justify an economic policy favoring the rich, with benefits trickling up to make the very wealthy even wealthier. A rising tide is still critical to lifting all boats, but the implication is that helping to raise the lowest boats may actually help keep the tide rising.


OOKING NASA Orbiter Reveals Buried Dry Ice Deposit on Mars

NASA's Mars Reconnaissance Orbiter has discovered that the total amount of atmosphere on Mars changes dramatically as the tilt of the planet's axis varies. This process can affect the stability of liquid water, if it exists on the Martian surface, and can increase the frequency and severity of Martian dust storms.

Researchers using the orbiter's ground-penetrating radar identified a large buried deposit of frozen carbon dioxide, or dry ice, at the Red Planet's south pole. The scientists suspect that much of this carbon dioxide enters the planet's atmosphere and swells the atmosphere's mass when Mars' tilt increases. The findings were published last week in the journal Science.

The newly found deposit has a volume similar to that of Lake Superior—nearly 3,000 cubic miles. The deposit holds up to 80 percent as much carbon dioxide as does today's Martian atmosphere. Collapse pits caused by dry ice sublimation and other clues suggest that the deposit is in a dissipating phase, adding gas to the atmosphere each year. Mars' atmosphere is about 95 percent carbon dioxide, in contrast to Earth's much thicker atmosphere, which contains mainly nitrogen and oxygen and less than 0.04 percent carbon dioxide.

"We already knew there is a small perennial cap of carbon-dioxide ice on top of the water ice there, but this buried deposit has about 30 times more dry ice than previously estimated," said Roger Phillips



of Southwest Research Institute in Boulder, Colo. Phillips is deputy team leader for the Mars Reconnaissance Orbiter's Shallow Radar instrument and lead author of the report.

"We identified the deposit as dry ice by determining that the radar signature fitted the radio-wave transmission characteristics of frozen carbon dioxide far better than the characteristics of frozen water," said Roberto Seu of Sapienza University of Rome, team leader for the Shallow Radar and a co-author of the new report. Additional

evidence came from correlating the deposit to visible sublimation features typical of dry ice.

"When you include this buried deposit, Martian carbon dioxide right now is roughly half frozen and half in the atmosphere, but at other times it can be nearly all frozen or nearly all in the atmosphere," Phillips said.

An increase in atmospheric density would strengthen winds, lofting more dust and leading to more frequent and more intense dust storms. Another result is an expanded area on the planet's surface where liquid water could persist without boiling away. Modeling based on the known variations in the tilt of Mars' axis suggests that several-fold changes in the total mass of the planet's atmosphere can happen on time frames of 100,000 years or less.

The changes in atmospheric density caused by the carbon-dioxide increase also would amplify some effects of the changes caused by the tilt. Researchers plugged the mass of the buried carbon-dioxide deposit into climate models for the period when Mars' tilt and orbital properties would maximize the amount of summer sunshine hitting the south pole. They found that at such times, Mars' global average air pressure would be 75 percent greater than the current level.

THE PLIGHT OF PROHIBITIVE PET CARE COSTS

During a recent conversation with a friend, our dialogue eventually turned to a discussion about our pets, as it typically does. My friend and his wife have two darling dogs whom they love very much and treat like family. They spend lots of time with their dogs, and enjoy their company more than the average pet owner. PAWS/LA was founded in 1989 in response to the companion animal-related crises faced by residents of Los Angeles county who were financially and physically debilitated by HIV/AIDS. Their PACE Program (Preserving Animal Companionship for the Elderly) assists seniors by providing assistance with pet care. It has been documented through numerous scientific studies that the positive correlation between seniors and animals improves emotional outlook and health stability and PAWS/ LA wants to help. The Pet Fund is a non-profit association that offers financial assistance to owners of domestic animals who need veterinary care. Their purpose is to work towards a future where decisions about companion animal medical care, need not be made on the basis of cost. It seems like just about every week there's another breaking news story featuring a security breach that has resulting in the loss of personal user information to online thieves; this week was yet another of those weeks. The Sony Corporation reported a security breach that may affect upwards of 70 million users of the Sony PlayStation Network and could possibly go down as one of the largest customer data losses ever.

PSN allows users to interact in on-line games and also functions as an online store for the purchase of games and gaming-related merchandise and an outlet for exclusive content distribution online. The popular gaming network is one of the pioneers in the field of online gaming and services millions of users worldwide.

The details of this security breach haven't been fully released but this already appears to be a classic case of 'as-bad-as-it-gets'. Signs of trouble began to appear for users of the PSN on April 20th of this month, when Sony shut the network down to investigate evidence of an intrusion that was suspected of occurring somewhere between April 17th and April 19th of this month. Sony called the shutdown "Emergency Maintenance" at the time but later revealed that the service interruption was due an "External Intrusion". On April 26th of this month Sony finally announced that personal user datahad been compromised during the breach and that users' names, full addresses, birth dates, email addresses and passwords were all part of the data stolen. Sony has yet to confirm or deny if credit card information was also taken during the breach, but the strong possibility exists that it was. As a precaution, Sony has warned users that have ever used their credit card to make purchases from and through the network to monitor their accounts for signs of suspicious activity. Sony has also warned its users to be on the alert for scams that ask them to provide personal information such as credit card numbers, Social Security numbers or any other personally identifiable information. As of this writing the Sony PSN is still down and the company has yet to provide an estimate for a return to full service. Users of the PSN have already begun to post reports of fraudulent credit card activity on various forums around the internet. Eight (8) days offline and counting, with no return to service in sight, is literally forever in online time. It will be quite a feat in terms of PR, Marketing and technical know-how to bounce back from an episode of this magnitude.

This really is 'as-bad-as-it-gets'.





Most of us know about the benefits of probiotics, those friendly bacteria that inhabit the digestive tract. Did you know there are also digestive support agents that are equally important, known as "prebiotics"? These are soluble plant and fruit fibers that serve as food for the acidophilus and bifidus bacteria.

Why is this so important? In the simplest of terms, there is competition in the intestine between some 400 organisms. Most of these bacteria, viruses, and fungus (yes, fungus) have learned to live together for the benefit of all and for the host (us). As a matter of course, there are times when certain types become more dominant and may cause irritation directly or through the waste that they produce. LA WATER AUGMENTATION STUDY REVAMPS A NEIGHBORHOOD'S LANDSCAPE & STREETSCAPE TO REDIRECT, ABSORB AND FILTER RAIN AND IRRIGATION RUNOFF -



Recharging our groundwater supply by capturing and filtering stormwater and irrigation runoff

An entire block of Elmer Avenue in Sun Valley looks very different today, than it did two years ago, due to a test project for the Los Angeles Basic Water Augmentation Study (WAS).

WAS began over a decade ago, and is directed by the Los and Angeles and San Gabriel Rivers Watershed Council (LASGWRC). The organization works with local, state and federal entities, and received major funding for the study from the national Bureau of Reclamation, the Department of Water Resources and others

According to Brian Sheridan, Development and Marketing Manager of LASGWRC, "In the pursuit of a healthy watershed, our council has become the region's trusted hub for essential watershed research and collaboration to influence policy and informed care and practice.

An urban, single family home neighborhood in Sun Valley was chosen a few years ago, over other blocks for this test project, based on favorable interest and willingness to participate.

At the low point and confluence of the area's natural topographical drainage, the area has been plagued with flooding during heavy rains, poor original runoff management design, and most blocks in the neighborhood do not have curbs and gutters.

In resident's front yards, new swales were created to direct runoff to underground filtering basins under the street. New sidewalks and low water landscape was installed between the sidewalks, the new curbs and the street's new drainage system.

Another key feature of the test project was increased percolation into the aquifer, the natural occurring in the neighborhood. "holding tank" for Los Angeles Water located deep underground. Various paver projects replaced parts of walkways to homes, driveways and even parts of the front yards.

Thirteen of the homeowners adopted the option of using a rain barrel catchment system tied to part of their home's gutter system. When it rains, the barrel is automatically filled now, and includes a hose and spigot for hand watering using soft rainwater, especially appreciated by plants.

Homeowners were given a choice of several street trees for installation at their locations. When the landscape was complete, written and live training was provided, to teach residents how to care for their new landscape.

According to the WAS report, the study is now processing information gathered about the "water quality implications of infiltrating urban runoff, assess the effectiveness of various techniques in removing pollutants (like fertilizers), quantify how much stormwater can realistically be captured and infiltrated, and other factors, through monitoring stations.

So far they have determined that increasing stormwater reclamation should be a necessary component







in the recharge of the aquifer using devices and

practices that remove, reduce, or prevent stormwater runoff and the pollutants carried with it.

As is a measurable pattern with other neighborhood improvement projects, one improvement encourages another. An additional benefit of the project has been ancillary improvements and cleanup in the neighborhood.

Once a graveyard for junk cars, a wide alleyway, or paseo, across the street from the test project was intended as a walkway and drain during rain. Instead, it had become an eyesore and a danger to the neighborhood. Through the organization's work on the land and streetscape, the City of Los Angeles was able to clear the alleyway, and prevent cars from entering the area.

Due to the frequent flooding, a church parking lot at the far end of the alley had permanently altered

the parking space allocation due to the regular standing water.

The alley is now the focus of Phase 2 of the WAS, soon to begin. In the near future, the block long area will have a similar landscape, swale, hardscape, stormwater capture and filtration system. In addition to improving the attractiveness of the area with a park-like appearance, the project should significantly improve the flooding problem in the neighborhood.

To be renamed, the Elmer Paseo (meaning a leisurely walk), the project will continue the testing of a decentralized system to capture and filter rainwater to provide a re-fill of LA's underground water tank, our aquifer, and beautifying a tiny bit of LA, one block at a time.




DALAI LAMA TO SPEAK IN LA **AREA**




