THE 2011 Mt. Wilson Trail Race Much More Than Just A Race



In less than 13 days, hundreds of people will gather in Kersting Court to participate in the activities associated with the famous Mt. Wilson Trail Race. On Saturday, May 28th, some 300 runners will make the trek from Baldwin Avenue and Sierra Madre Blvd. to the end of the Mt. Wilson Trail and back down again. It is also expected that over 150 children will participate in the Kids Race up Baldwin on Saturday morning too. But, there is much more to the weekend than just the race!

Although for many, the fun started back in January when runners began training for the race, the night before race day gives those who are not venturing up the trail a chance to participate in the festivities.

On Friday, May 27th, the MWTR Committee will host the annual Pre-Race Pasta Feed. From 5:30-7:00 p.m., Cafe 322 will serve dinner, as the runners come to pick up their packets. A portion from each dinner served will be donated by Cafe 322 to Sierra


On race day, there is even more to do. The race will begin at 7:30 am. At 7:45, the Kids Mile Fun Run will start. Children run under the same banner as

HISTORY

The Mount Wilson Trail Race is the second oldest trail race in the country; first held in 1908 when runners raced to Mount Wilson, rested 1/2 hour, then raced back down. The race was held sporadically from the first year until the late 1940's and early 1950's,

when it was abandoned completely. In autumn of 1965 it was revived and has grown over the years to its present format. Organized by a volunteer committee and sponsored by the City of Sierra Madre, the current race is 8.6 miles in length. The exact course has changed by erosion, fires and earthquakes. For this reason no official record is recognized. Since the revival in the 1960s, today's course is considered the most difficult.

THE COURSE

The 8.6 mile race starts on pavement, uphill, to a dirt path no more than three feet wide. It features an elevation gain of over 2,100 feet; approximately 4.3 miles to the turnaround point at Orchard Camp. Most of the race takes place on the Mount Wilson Trail, where some sections have vertical drop-offs of several hundred feet. Boy and Cub Scout Troops provide water at two locations: the 2.3 mile marker (at First Water) and the turnaround point. Due to the steep, narrow features of the trail, the race is limited to a maximum of 300

Resident Files Lawsuit Over Water Rate Increase

On May 6, 2011, a lawsuit was filed in the Los Angeles Superior Court by Sierra Madre resident John Crawford against the City of Sierra Madre. The suit alleges that the city acted contrary to the law (Prop 218) in its implementation of the recent water rate increase.

The city maintains that it did in fact follow the provisions of Prop. 218, which requires public notification of rate increases such as water, and also allows citizens the opportunity to protest such

In 2010, an organized protest against the increase was orchestrated, however, it failed to yield the required majority needed to prohibit the city from moving forward.

After an extensive outreach to the community, the city proceeded with the increase which was the first such increase since 2006.

It is not known at this time what the cost of defending this lawsuit will be. Those costs, however, will come out of the city's water revenues.

Crawford is being represented by Former Sierra Madre Mayor Kurt Zimmerman.

I-210 BRIDGE/ICONIC FREEWAY STRUCTURE UPDATE



Crews conduct environmental sampling at the site of the future I-210 Bridge.

You may have noticed crews working at the future site of the I-210 Bridge, between Baldwin and Santa Anita Avenues on the eastbound I-210 Freeway. Following installation of a temporary sound wall and erosion control materials last month, crews were busy conducting environmental sampling.

In the coming weeks, crews will begin shoring (or grading) the slopes of the center and southern freeway medians, to create space for the large construction equipment to access the construction site. A temporary retaining wall will be built along the center median of the freeway to support the westbound I-210 traffic lanes, as part of that effort.

Work on the structure's foundations is planned to start in June. Drilling, rather than pile-driving, has been selected as the construction method for the foundation work. Although this method takes more time, it was selected because it reduces impacts on the local community.





A 27-year-old Tujunga man accused of fatally shooting a family member, then dumping the body on a Foothill freeway off-ramp, was charged with murder today, the District Attorney's Office announced.

Deputy District Attorney Lee Mitchell of the Pasadena Branch Office said Aram Sarukhanyan is expected to be arraigned - following his release from the hospital - in Department D of Pasadena Superior Court.

The defendant remains hospitalized for a selfinflicted gunshot wound, according to authorities.

Sarukhanyan is charged with one count each of murder and brandishing a firearm at a person in a motor vehicle. complaint includes an allegation that the defendant personally and intentionally discharged a handgun.

Sarukhanyan is accused of fatally shooting his cousin, Adrine Arzumanyan, 33, then pointing a handgun at a civilian who tried to stop him immediately after he dumped the victim's body near the La Crescenta Avenue off-ramp on the westbound Foothill freeway.

If convicted as charged, Sarukhanyan faces maximum prison term of more than 50 years to life.



LA SALLE STUDENTS RECEIVE PRESTIGIOUS GOLD KEY ART AWARDS

Pasadena, CA - La Salle High School students, Alec Shumate, Andrew Linaac, and Stephanie Delazeri are among the 94 students from Los Angeles County to receive the regional Gold Key Award in Scholastic's Alliance for Young Artists & Writers competition, the most prestigious recognition and scholarship program for teenage artists and writers in the United States.

RUTH'S CHRIS

Steak is one of my favorite dishes. My parents told me that when I was a boy, they would say the magic words, "We are having steak for dinner." My excitement level would explode. As if a long awaited birthday had finally arrived. Some things never change. I still love a great steak. Maybe I have been spoiled but an Argentinean Restaurant or the Brazilian Chascaria that gives you all you can eat and stuffs you like a human luggage container isn't my idea of enjoyment. I really believe you can't get a great steak for \$19.95. A great steak restaurant must have two essential ingredients, first and foremost, "The goods," a quality piece of meat, and secondly, the correct oven to prepare it in. Chef Gary Watanabe of The Ruth's Chris Steak House in Pasadena has both!!!

Founder Ruth Fertel was raised in Happy Jack, Louisiana, Fertel graduated from LSU with a degree in Chemistry, and in the 1960's Ruth saw an ad for a local steak house and took the job where she met Chris Matulich, the owner of Chris Steak House. Against advice, Ruth borrowed enough money to buy Chris out. The story has many more twists and turns, but as they say, "the rest is history."

Each of the Ruth's Chris has an identity of it's own, the Pasadena Restaurant has a per-


fect greeting area as you walk in. The hostess to your front the main dining room to your right and to the bar area is on your left. Now

I have dined at Ruth's Chris at least ten time since it opened five years ago and I am very comfortable pulling up a chair in the bar area. I am a people watcher and this is a great stop to watch people.

Steak makes up 90% of all sales in the restaurant; each steak is artfully prepared in an 1800-degree double broiler over. It is one of the reasons that you cannot get your steak at home to taste like theirs. The Beef is dry-aged in Chicago and shipped twice weekly to Pasadena. Here it is just like when I was just a boy, for eating at Ruth's Chris is a special day. The Petite Filet was incredible, I ordered it medium, rare as my first test. All the steaks come out on a sizzling plate with butter, and Chef Watanabe cooked my steak to perfection. I must confess that I rarely order a NY Steak, it isn't sexy enough, Chef agreed, that NY Strip Steak is under appreciated. I am now a convert. The New York Strip Steak was delicious; in fact it might have a new best friend in this reviewer. My guests devoured the Rib Eye Steak as if they hadn't eaten in weeks. Impossible, because before the steaks we also enjoyed some of the best Calamari that I have ever had, yes, the best. Too many restaurants try to

fool you with frozen rings, Yuk! If you have been reading my articles and following my radio show, Crab Cakes are one of my favorites, and they certainly pass the test here. A little hint, some of these items are available for sampling at a great price during happy hour. What would a Steak House be with out a legendary wine list. The list is headed with selections from the manager and boosts eight pages of wine. If you can't decide there are some thirty to forty wines by the glass. Desserts, are you kidding me, I am supposed to be on a diet. Leave your diet at home, the chef prepared cheesecake and a Creme Burlee that made me want to hang out at the bar and have a glass of wine here every night. Our server Karla, was a delight and she knew her steaks, great training!!

"Many of you have talked and I agree. We owe it to our children and grandchildren . . . At the end of those ten years, we will have paid available to retire. That is

more debt repaid more quickly than has ever been repaid by any nation at any time in history."

That promise President George W. Bush made to Congress and the American people in February, 2001 didn't seem unrealistic; coming off four straight years of budget surpluses under President Clinton, and ten uninterrupted years of economic growth.

The Heritage Foundation forecast that policies outlined by President Bush would create millions of jobs, a surge in personal income, and increased revenue lowering our national debt.

All it would take as a first step would be a \$1.35 trillion tax cut over ten years for the richest Americans.

Whoops.

shedding 750,000 jobs a month. Personal income did surge, but only for the top 10%; the fortunate among the remaining 90% remained stagnant while the rest lost ground. A greater percentage of our population, particularly children, fell into poverty than at any other period on record.

Budget surpluses left by Clinton became yearly deficits in the hundreds of billions. That national debt Bush promised to retire, and the Heritage Foundation forecast would be at least significantly trimmed under Republican policies, went from \$5.7 trillion to over \$10 trillion in eight years.

In today's battles, Republicans are calling for courage and sacrifice in bringing down the deficit. Back then, in control of both houses of Congress and the White House, they could deal with the problem as they saw fit, without having to compromise principles seeking accommodation with the other

Republicans confronted the deficit in two major ways: First, they kept the costs of wars in Iraq and Afghanistan off the books, as "emergency appropriations". This takes \$150 billion off your yearly deficit right there. (And, when a Democratic president takes over and puts those expenses back on the books in the interest of honest accounting, you can accuse him of adding billions to the deficit before he's hardly settled in.)

And, the more taxpayer-funded giveaways they can offer corporate and billionaire donors, the more generous campaign support they can expect

> Not every government initiative is expendable, though. That May 2003 \$980 billion hike in the debt ceiling, for instance, came on the heels of passing that year's \$350 billion installment on the Bush tax cuts; it was literally the next item on the Congressional agenda.

> Speaker Boehner flatly declares tax hikes are "off the table", but Republicans' definition of "tax hikes" is rather fluid. President Reagan took credit for tax cuts, but ending the deduction for consumer loan interest, and taxing social security payments and unemployment benefits for the first time, somehow weren't tax hikes.

> In Rep. Paul Ryan's (R-WI) budget plan, he doubles-down on Bush's tax cuts for the wealthiest, but says total tax revenue will remain unaffected. Since there's no explanation as to how that's to be done (we can only guess), he can assure there are no tax hikes in the plan.

Our Rep. David Dreier, though, won't consider removing the tax break encouraging Second, Republicans shouldered their corporations to ship jobs overseas, because that would be a tax hike. Speaker Boehner, in response to Sen. If I want to invest in highly aggressive stock mutual funds, I should be free to take that risk in the hope of earning a larger reward than my conservative neighbor. These are basic American principles, but they are under attack.

It's fashionable for liberals to talk about civil rights and political freedoms, but what they fail to understand is that if the government takes away my economic freedom, then the government has essentially taken away my political freedom and civil rights. If the government can deny me the education I wish to pursue, the job I want to perform or the business venture I want to launch, then I will inevitably be forced to censor the criticism I voice of that government. There can be no political freedom without economic freedom.

So what is the government trying to do that rises to the level of tyranny I've described? The National Labor Relations Board (NLRB), with the full approval and encouragement of President Obama, is trying to prevent Boeing from opening a manufacturing plant in South Carolina. The NLRB is trying to force Boeing to abandon the new plant it just built, which is intended to manufacture the new 787 Dreamliner, and build a new plant in Washington. It's no coincidence that South Carolina is a right-to-work state and Washington is a heavily unionized state. for a favored constituency. If successful, the precedence will be established justifying the federal government's right to decide any of the issues listed above: where any of us go to school, what jobs we take, what businesses we open and what investment we make.



As Boeing has made perfectly clear, and as is What would you say if the federal government amply supported by the facts, Boeing is simply seeking to exercise their right to decide how and where to spend their capital. If they aren't allowed to do that, then it won't take very long for the government to find various justifications to tell us how to spend our capital. You may think me extreme in this comparison, but this is not the first time the government has tried to exercise this power. The Clinton administration's illfated attempt to overhaul the healthcare industry (everyone remember Hilary-care) would have allowed the government to decide where each medical student went to medical school, what specialty they were allowed to pursue and where they would have to practice for the first several years after their schooling. Fast forward 20+ years, and the same naked power grab is being attempted.

> Supposing for a moment that I haven't convinced you of the philosophical reasons for resisting this latest foray into our private lives, consider the basic economic consequences of this for our nation. If the government wins the right to tell manufacturers where they can set up shop, how many new facilities do you think will be built here in the U.S., as opposed to being built in some other country? How many more jobs do you think will be shipped overseas? As is often the case, there are as many strong economic reasons as there are philosophical reasons to champion personal freedom. Those countries which allow the greatest amount of personal and economic freedom tend to have the fastest growing economies and have the lowest levels of unemployment in addition to offering the greatest amount of political freedom and civil rights.

So Bin Laden is dead, but that doesn't mean there aren't any threats to our freedoms and standard of living. This time we don't need to fly half way across the world to find an enemy. We just have to look to D.C. to find people who think they know best how we should spend our time and treasure.





Co-Authors AB 12 to Raise Fines Against "Johns"

Sacramento - Assemblymember Anthony Portantino (D-La Canada Flintridge) has added his support to AB 12, the Abolition of Child Commerce, Exploitation and Sexual Slavery Act. The bill, which passed the Assembly Public Safety Committee with unanimous support, would increase the fine against anyone convicted of engaging in prostitution with a minor under the age of 16.

"Current law is too lenient on these so-called 'johns' or customers," said Assemblymember Portantino. "These children often come from homes where they have been brutalized or abandoned and they turn to the streets to support themselves. We have to shield these children from the dangers of these sexual predators. As the father of two daughters, I am horrified and angered that current law

Sailing the Titan Seas: NASA Selects Mission to Saturn's Moon

Laboratory (APL) in Laurel, Md., is managing a project to explore the organic seas of Saturn's moon Titan, one of three proposals selected by NASA last week as candidates for the agency's next Discovery Program mission.

The Titan Mare Explorer, or TiME, would perform the first direct inspection of an ocean environment beyond Earth by landing in, and floating on, a large sea of methane (natural gas in a liquid state) on the cloudy, complex moon.


The TiME capsule would launch in 2016 and reach Titan in 2023, parachuting onto the moon's second-largest northern sea, the Ligea Mare. For 96 days the capsule would study the composition and behavior of the sea and its interaction with Titan's weather and climate. TiME would also seek evidence of the complex organic chemistry that may be active on Titan today, and that may be similar to processes that led to the development of life on the early Earth.

Titan is the largest moon of Saturn, the only natural satellite known to have a dense atmosphere,

he Johns Hopkins University Applied Physics and the only object other than Earth for which clear evidence of stable bodies of surface liquid has been found. Titan has a diameter roughly 50% larger than Earth's moon and is 80% more massive. It is the second-largest moon in the Solar System, after Jupiter's moon Ganymede, and it is larger by volume than the smallest planet, Mercury, although only half as massive.

> Titan was the first known moon of Saturn, discovered in 1655 by the Dutch astronomer Christiaan Huygens (and easily visible in small amateur telescopes as a bright dot close to the ringed planet).

Except for its lakes of liquid natural gas, Titan is primarily composed of water ice and rocky material. Much as with Venus prior to the Space Age, the dense, opaque atmosphere prevented understanding of Titan's surface until new information accumulated with the arrival of the Cassini-Huygens mission in 2004, including the discovery of liquid hydrocarbon lakes in the satellite's polar regions. These are the only large, stable bodies of surface liquid known



to exist anywhere other than on the Earth.

The climate on Titan—including wind and rain—creates surface features similar to those of Earth, such as sand dunes, rivers and lakes

(probably of liquid methane), and shoreline, and, like the climate on Earth, is dominated by seasonal weather patterns. With its liquids (both surface and subsurface) and robust nitrogen atmosphere, Titan is viewed as somewhat like the early Earth, although having a much lower temperature (methane is a liquid only at temperatures below minus 250 degrees Fahrenheit). Titan has thus been cited as a possible host for microbial extraterrestrial life or, at least, as a pre-biotic environment rich in complex organic chemistry. Researchers have suggested that a possible underground liquid ocean there might serve as a biotic environment. It has also been suggested that a form of life may exist on the surface, using liquid methane as a medium instead of water; and, indeed, anomalies in atmospheric composition have been reported which are consistent with the presence of such a life-form, but which could also be due to an exotic non-living chemistry.

The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers". As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering your questions but Little better the better the behavior achieves were tread. questions, but I will be totally honest. My objective is to help you achieve your employment goal

Q: I applied for a position over one month ago and was very excited to finally be contacted by the company recruiter for a telephone interview. The telephone interview lasted about 25 minutes. The recruiter informed me that he had several more interviews to conduct and that he would contact me as soon as possible regarding my status. He notified me one week ago that I pasted the interview and was being invited to take the next step, which was a written assessment. He said the written assessment would take about 90 minutes. The test was to analyze my writing and communications skills, critical and problem solving abilities, and my overall knowledge about the industry and profession. I agreed and completed the written assessment in their office. Yesterday, I was contacted by the recruiter and informed that I had passed the written assessment and that the next step would be a panel interview by staff and management. Is this the normal process that employers put candidates through before hiring someone? This process is very stressful and I am not sure it is worth it. What happened to 'submit your resume and application, interview and get hired?' Really Stressed

Dear Really Stressed,

Those days are long gone and will never return. Employers are receiving approximately 1,000 applicants for every position they announce. This abundance of job seekers is a blessing and a curse for employers. Overwhelming responses to their open positions make it very difficult for employers to search out the ideal candidate, screen, interview and hire. Therefore, they have added several components to their screening process. Some of these components are: Searching and reviewing resumes and applications, telephone and in-person interview, written assessment and personality test, aptitude test, panel interview conducted by staff and another by management, background checks, references, and some employers are asking candidates to spend a day, at no pay, with their organization. And let's not forget that salary plays an important part in the screening process. We are at the end of 2010 and the job market is not going to change that much for 2011. Next year will continue to be an employer's market. Which means that you, the job seeker, will have to do what ever it takes to be considered or hired for a position. I know a job seeker who has been interviewed 10 times by one employer over a three-month period. The job seeker was recently told by the employer that he is one of the final three candidates for consideration. It is very competitive in trying to find employment and a position that is the right match for you. Remember that the employer's process is to constantly screen-out applicants until they find who they believe is the best person for the position....and that usually is the last candidate standing. Is going through all these various screening processes worth it to you? I say yes, if you want the position. So, don't ever remove yourself from the screening process. Stay until the employer tells you that you are no longer being considered for the position. Which I hope doesn't happen.

What if nearly everything you usually keep on your computer was stored online? Your machine would be much speedier and perhaps needed a lot less because you could simply use another machine to access your data should you lose your laptop. This liberating premise is behind Google's upcoming Chrome OS, which will make notebook computers more like netbooks than most actual netbooks. The software powering Chrome OS, which is based on Google's Chrome browser, serves mainly as a tool for connecting your computer to the Web. Since much of what many people currently use is housed, the day when true cloud computing is the norm is getting closer and closer.

In Google's Chrome OS, users would have to login into a Google account (if you already have a Gmail account those credentials would suffice) leading to a homepage that would show the apps the user had previously purchased and "installed" from the Google Web Store (HYPERLINK "http://chrome.google.com" http://chrome.google. com). There appears to be a healthy market already for these apps and the introduction of the Chrome compatible computers will probably boost public demand for more in the near future. Many of these apps work independent of the Chrome OS but analysts expect that number to decrease in the future as Google promotes the widespread use of its new OS.

As to be expected some industry critics and analysts are not exactly gushing with high expectations for what this new mode of computing is attempting to do to business as usual. While fans of cloud computing will point to the speed, simplicity and security that appear to be built into Chrome OS, naysayers point out the fact that not everybody wants to be online all the time. For all of its speed and new-fangled slickness, Chrome OS is absolutely nothing without an active connection to the internet. When Chrome OS is not connected to the internet the entire concept of cloud computing is hobbled. And then there's the whole issue of just who the target market for this new OS is in reality. A large percentage of the market is comprised of the very young and the very geeky. These groups would probably have very little difficulty adjusting to a totally-plugged-in lifestyle and in many ways are already living and working as such now. These people would probably enjoy testing the bells and whistles of this new mode of computing. Then you have the "Will-This-Thing-Help-Me-Do-My-Job-Better" group. These people may or may not personally be interested in a new toy but if the new toy offers the real promise of being a better work platform than what they currently may be using, this group will not be shy about voting with their dollars and desktops for the new system. At this early stage of the game even the best release of the new OS will not be able to win over a significant share of this crowd for the simple fact that it won't be ready to do what so far the iPad and other platforms of great promise have been unable to do and that is replace the traditional workplace desktop.

What do Americans love more than reality TV, Pizza Hut, and Double Western Bacon Cheeseburgers? A good conspiracy theory! I've got great news for you; the film, "Forks Over Knives" has all these covered. In case you think you've wandered into the movie review section, that's a couple pages toward the front. And no. I do not have any financial connection with "Forks



Of course there's more money to be made in pills than peas, so it's unlikely your regular physician will prescribe produce in place of the latest Pfizer drug. Dr. Michael Greger, who's not in the film, but is a leading expert in nutrition, states that most medical doctors receive only a few hours of instruction in nutrition during their training. Just think, watching this film will not only enlighten you and possibly save your life or the life of a loved one, but you will also be a couple nutritional steps ahead of your physician! I recently had the opportunity to help facilitate a workshop at the Providence Regional Cancer Partnership in Everett, Washington. May daughter-in-law, Jessica, is an intern in the art therapy program at Antioch College in Seattle and is assigned to a group at the center. Jess was familiar with the various gatherings that we have created in our clinic in Sierra Madre and wondered if it would be possible to put together a life mask workshop for the cancer group. Sure 'nuff, I soon found myself standing in the center's conference room with twenty attentive faces turned toward me.

The Role of Art in Healing

Numerous clinical trials support the idea that creativity is a powerful factor in the maintenance of health. In the treatment of cancer, it has been used in a number of different ways to lift spirits by

bringing people together. The overall effect of community has physical as well as mental/ emotional healing value. In the process of creating something, the patient is transported to a state of awareness which is less focused on the difficult realities of his or her condition. Survival rates and the quality of life both improve.

The Human Factor

Initially, I was prepared for a room full of depressed people with very little to show up for. Instead, it was quite the opposite. If anything, it was hard to get them to stop wisecracking and listen to the intro. As they went around the room and updated each other on the latest news, there was a common thread of support, connection and empathy.

The life mask process can be a little messy, both physically and emotionally. A little vaseline along the hairline, eyebrows and eyelashes is most important, avoiding impromptu and inadvertent waxings. Covering the face and eyes, nose and mouth causes some people to become anxious (yes, we do leave nostril openings!) It calls for cooperation, a gentle hand, and a lot of trust.

At the end of the workshop, there was a table full of masks all depicting the unique features of their owners. At next week's gathering, they will be painted, beaded, spangled, decoupaged, sprinkled, emblazoned, engraved and who knows-knows-what by a bunch of folks that know well what we all much come to know in time. As I witnessed these people, Stephen Levin's book, <u>A Year to Live</u>, came to mind. The following is from this wonderful


