RECORD CROWDS ATTEND SIERRA MADRE JULY 4[™] FESTIVITIES

Just in case you need to be reminded of how wonderful this country is, one only has to come to Sierra Madre on July 4th. In Sierra Madre, from about two weeks before, you will see everyone unified in their efforts to prepare for America's Birthday. Patriotic decorations adorn homes all over town. Conversations everywhere are focusing on the very special way that Sierra

Madre celebrates Independence Day. This year held to the traditions of the past, however, the all volunteer Fourth of July Committee did something that no other committee has done. It had the largest crowds that anyone can remember. Yes, even the 'old timers' (residents over 50 years) said was the biggest one yet.

Protest Averted

Despite what appeared outwardly to be a perfectly orchestrated event, the committee had to react quickly the day before the parade in order to protect the best interests of the public. Originally, plans were made to have a trained elephant participate in the parade for the children. However, at the ninth hour, when it was learned that animal rights protestors might disrupt the parade, the live elephant was substituted with a giant inflatible dinosaur. The decison was made out of concern for public safety, as an el-

ephant might react to the kind of activity that protests sometime bring.

This is not the first time a live elephant was scheduled to appear in the parade. According to Former Mayor George Maurer, years ago an elephant in the parade was startled by a "youngster who ran into him with his go cart."

County Bans Vehicle 'For Sale' Signs

A new county ordinance, unanimously approved Tuesday by the Los Angeles County Board of Supervisors, not only prohibits parking cars with "for sale" signs on a number of streets in Altadena and East Pasadena but also allows police to impound vehicles displaying such signs.

The ordinance takes effect in

According to the county staff report, "the County of Los Angeles has experienced a proliferation of used vehicles being parked or left idle on public streets for the purpose of advertising or displaying such vehicles for sale, resulting in a negative impact on the County, its residents, and businesses."

Before impounding a vehicle, the ordinance, section 22651.9(a) of the CVC states that it must appear that the primary purpose of parking the vehicle is to advertise the private sale of the vehicle and that within the past 30 days; the vehicle is known to have been previously issued a notice of parking violation. The owner must also be warned that an additional parking violation may result in the impoundment of the vehicle even if moved to another street, as long as the signs or placards remain on the vehicle. A ticket must be issued at least 24 hours prior to impounding the vehicle.

A Department of Motor Vehicle's survey in August showed health and safety issues related to signs. The signs can cause passing motorists to slow down or stop to obtain information on the signage on the parked vehicles, causes motorists to "double park" next to such vehicles and get out of their cars to examine the vehicles thereby blocking traffic, and encourages jaywalking across streets for prospective buyers to inspect the vehicles the report said.

In Altadena, signs are prohibited on parts of Lake Ave. Lincoln Ave. Mariposa Street, Washington Blvd. and Altadena Drive, among others.

In Pasadena areas include, Huntington Drive between San Gabriel Blvd. and the City of Arcadia boundary, and Del Mar Blvd. between the City of Pasadena boundary and Rosemead Blvd.

Pasadena Water and Power brought a new water treatment plant online Wednesday, reviving a local groundwater source that had not been used since 2002.

The Monk Hill Treatment Plant at 2696 Windsor Ave. near the Jet Propulsion Laboratory is designed to treat up to 7,000 gallons of groundwater per minute, removing perchlorate and volatile organic compounds (VOCs) to meet all regulatory standards for safe drinking

Perchlorate is an oxidizer used in rocket propellants; VOCs were once used as industrial cleaning solvents. These chemicals leeched into the Monk Hill Sub-basin of the Raymond Basin aquifer subsequent to waste disposal practices at JPL decades ago.

The city of Pasadena worked closely with the National Aeronautics and Administration Space (NASA), owner of JPL, on design of the state-of-the-art treatment plant, site selection, public outreach and environmental and public health review processes. NASA funded funded construction and operating costs; the city of Pasadena leases and operates the plant.

Support for the project provided by Environmental also the U.S. Protection Agency, California Department of Toxic Substances Control, Los Angeles Regional Water Quality Control Board and California Department of Public Health (CDPH).

The CDPH led the public health review process, which consisted of evaluating the quality of the treated water, a public review, comment period and a public hearing, and issued a permit to serve water from the Monk Hill Treatment Plant on March 17th this year.

"On behalf of the city of Pasadena, I want to thank all the agencies that came together to realize this project," said Pasadena Water and Power General Manager "And I especially want to thank the many citizens who came to neighborhood meetings from the earliest days of this project, submitted comments and questions along the way and participated in the final public health review process. Your diligence is a testament to the vital importance of water to our community."

"NASA made a commitment to the city to clean up the chemicals in the groundwater from JPL, said NASA Groundwater Cleanup Manager Steve Slaten. "This new treatment plant achieves that result and we are pleased to have lived up to our commitment."

CITY OF HOPE RESEARCHERS DISCOVER METHOD TO REVERSE LATE-STAGE TYPE 1 **DIABETES**

DUARTE, Calif., June 27, 2011 — City of Hope scientists have demonstrated a new treatment approach for late-stage refractory type 1 diabetes that may shut down the body's autoimmune reaction, which destroys islet cells, and may boost natural regeneration of the insulin-producing cells. The two-pronged approach has potential to replace islet transplantation for patients with advanced disease. Miao Wang, M.D., Ph.D., post-doctoral research fellow in City of Hope's Department of Diabetes and Metabolic Diseases Research, presented findings from the study at the American Diabetes Association's 71st Scientific Sessions, running June 24 to 28 in San Diego.

An estimated 20 million people worldwide suffer from type 1 diabetes, an autoimmune disorder in which the immune system doesn't recognize islet cells, attacks them as foreign infections and ultimately destroys these insulin-producing cells in the pancreas. For patients whose condition has advanced to a refractory stage, islet cell transplantation is often the only option, though that procedure's effectiveness is temporary at best. However, a team of City of Hope researchers led by Defu Zeng. M.D., associate professor in the Department of Diabetes and Metabolic Diseases Research, has uncovered a new combination treatment that puts the brakes on the rejection process while simultaneously accelerating islet cell regrowth.

Patients with late-stage, refractory disease, do not have enough functional islet cells left to regenerate healthy cells; thus, the researchers combined the conditioning approach with compounds known to promote cell growth and regeneration, specifically gastrin and epidermal growth factor







Who says casted in their roles and significantly play well off lawyers can't one another. The courtroom drama is merely a backdrop for this wickedly funny dramedy. At its summer, both core, Franklin and Bash simply specialize in the ridiculous. And at the same token, it'd be ridiculous on your part not to tune in.

Suits plays the drama card a little more than F & more emotional depth. Plus, on occasion, you'll find razor-sharp humor. Mike Ross (Patrick J. Adams) is a lethargic but an extremely bright college dropout with a photogenic memory that has allowed him to pass the bar exam without attending law school. He has immeasurable potential, but has never truly utilized it in the finest way. Harvey Specter (Gabriel Macht), one of Manhattan's best lawyers and self-proclaimed #1 closer ter being completely impressed with him and his story. Problem is, Ross never went to Harvard (the firm only hires Harvard grads) and the two must keep it a secret. Honestly, the situations that arise in Suits feel to have more at stake than ones Franklin and Bash tell the story of two budding in Franklin & Bash. For the character, Mike Ross, he's a good guy, who is close to his ailing grandmother and he sincerely cares about the well being of others. Suits may appear to be less "fun" than the other guys, but they make up for it effortlessly with realistic scenarios, intelligent writing and avoid the same beat-for-beat story structure found in consecutive episodes of F & B. Even with only three episodes in the bag, I'm confident to say that these are a pair of "suits" you'd actually want to be friends with.

Look for Franklin and Bash on Wednesday convincing tactics in court. The first episode was nights at 9pm on TNT and Suits on Thursday nights at 10pm on USA.







by lauding the efforts of certain Republicans. It isn't debt ceiling, Republicans are demanding a balanced budget amendment (backed by all 47 Republican Senators), under which all eight

budgets of the Reagan Administration and all eight passed under Bush would've been deemed unconstitutional.

There's the demand that any closing of tax loopholes be matched by a corresponding drop in tax rates, despite taxes already being at their lowest level in fifty years. There's Sen. Jeff Sessions (R-AL) describing Majority Leader Harry Reid's call for millionaires to "make a more meaningful contribution to the deficit reduction effort" as "rather pathetic". (Sen. Reid's spokesman responded, "Apparently, nothing irritates Republicans more than the prospect that millionaires and billionaires might be asked to share in the burden of deficit reduction.")

In this context it was refreshing to read in Sam Stein's piece at Huffington Post of how Republican Congressman Stephen Fincher of Tennessee rose in support of a major port project on the Mississippi River. Thousands of jobs created in an area where more than a third live in poverty. A harbor, industrial park, road and railway improvements getting a \$13 million grant from the federal government, and \$7 million from the state.

"We just wanted to make sure that we could do everything possible to create jobs", said Rep. Fincher after the grant was approved by Transportation Secretary Ray LaHood.

Another freshman Republican, Rep. Bill Johnson of Ohio, co-signed a letter urging the Transportation Dept. to approve \$4.35 million for improvements in a runway at Youngstown-Warren Regional Airport.

Rep. Rick Crawford (R-AK) wrote to Agriculture Sec. Tom Vilsack requesting a grant supporting commercial development of biomass to "provide farmers an alternative energy crop source" and "create a significant number of new jobs for

Rep. Joe Walsh (R-IL) sought \$7.5 million in support from the Dept. of Agriculture for education and nutrition programs in Nicaragua through the American Nicaraguan Foundation and Fabretto Children's Foundation.

Freshmen Reps. Kristi Noem (R-SD), Scott Tipton (R-CO), Cory Gardner (R-CO) and Kevin Yoder (R-KS) co-signed a request to the Dept. of Agriculture requesting funds to combat a bark beetle epidemic in the Rocky Mountains.

In a recent NY Times column, David Brooks lauded Republicans for moving spending and deficit reduction to the top of the agenda, for their negotiating prowess in forcing Democrats to capitulate and agree to a 3-to-1 ratio of spending cuts to revenue increases; a "deal of the century", the "mother of all no-brainers" they'd be leaping on - "if only the Republican party were a normal

Brooks explains the Republican party has become "infected" by those who "do not accept the logic of compromise", "do not accept the legitimacy of scholars and intellectual authorities", and have "no sense of moral decency"; who "talk blandly of default and are willing to stain their nation's honor."

He concludes by warning that independent voters will blame any default on "Republican fanaticism" and a party "not fit to govern."

In last week's column I wrote of President Johnson's becoming aware of Richard Nixon's attempts to sabotage Vietnam peace talks, in order to boost Republican chances in the 1968 elections. When asked later why he didn't go public with the information, Johnson replied that if Nixon won the election, and this information became known, it would be difficult for Nixon to function as president - and that would be bad for

PORTANTINO'S RAPE KIT TESTING BILL APPROVED BY SENATE COMMITTEESACRAMENTO

Assemblymember Anthony Portantino's (D-La Cañada Flintridge) bill to help put more rapists behind bars passed another legislative hurdle today when it was approved by the Senate Public Safety Committee 7 to 0. AB 322 seeks to shed light on the problem of untested rape kit evidence from sexual assaults and help bring rapists to justice. "It's unconscionable that thousands of rape kits remain unopened and un-

tested across California," stated Assemblymember Portantino. "Rape kits hold vital evidence that is crucial to a criminal conviction, while the clock is ticking on the statute of limitation for these crimes. It's frustrating to know that a rapist could be walking free and a victim who suffered is further disrespected because a vital piece of evidence went untested." Under AB 322, law enforcement agencies will be required to report to the Department of Justice the number of rape kits they collect, the number that are the result of stranger-rape and the number of kits tested beginning when the law goes into effect. The bill will also establish a two-and-a-half-year pilot project to test all rape kits in California counties that make arrests in fewer than 12% of the forc- Monrovia, Mayflower Village, and the Los Angeles



scene. DNA evidence from the kits is used to compare samples from known felons in State and Federal databases. If you don't process the evidence you can't check it against the database. In 2009, law enforcement agencies reported 8,698 forcible rapes in California. But, arrests were made in less than 24% of the cases. By comparison, New York City, which has a policy of testing every rape kit, has an arrest rate around 70%.

This is the third time Assemblymember Portantino has introduced legislation aimed at getting law enforcement agencies to process rape kits in a timely manner. Despite strong bi-partisan support, former Governor Schwarzenegger twice vetoed earlier efforts. Assemblymember Portantino is hoping that this time with a new Governor and new language, the result will be different.

Maybe he didn't talk about it because he knows just how close we, and the rest of the world are, to being in the same boat. Or maybe he doesn't know. Either way, it would be helpful if all our representatives in Washington took a hard look at what's happening in Greece.

On Thursday, the Greek Parliament voted for an austerity measure that includes a five-year, \$40 billion plan to cut spending, raise taxes, reduce public employee wages and move the retirement age from 61 to 65. The plan also calls for privatization of some government services and selling \$71 billion in government assets.

Unfortunately, it may be too little too late. It's likely that Greece can't pay its bills, and all the bankers in Europe can't change that fact. What they can and are doing is holding off the inevitable until they can unload as much Greek debt as possible onto private investors and American mutual funds. They're also trying to delay a messy Greek default until they can prop up the other nations in Europe who face an imminent debt catastrophe: Ireland, Spain, Portugal and

What none of the bankers, politicians and journalists want to admit is that the rest of Europe -and for that matter, the United Sates -- may soon be facing our own catastrophe.


They have joined their American counterparts in the belief that if we just delay the problem long enough, it will disappear. They're afraid, and don't really know what to do so they do nothing. It's akin to the 4 year old who thinks if he puts the covers over his head, the monster won't know

There are really only three major differences between the debt crisis in Greece and the debt

First, their debt is much smaller than ours even on a per capita basis. Second, depending on what maneuvers President Obama and his Treasury Secretary can play to hold off default --we're still 8 to 24 months away from facing the problems Greece is experiencing now. And, finally, Greece had somewhere to turn when their debt crisis hit. We don't. By the time our debt crisis turns to catastrophe, the rest of the governments in the world who depend on debt to fund their operations will be in the same boat with Greece and us. ning in the red at a moderate interest rate. The U.S. is the biggest offender with a deficit this year of at least \$1.67 trillion. The rest of the world needs about \$8.5 trillion to fund its annual deficit spending. But there isn't the required \$10 billion readily available to fund that debt.

So the additional funds will have to be attracted from other markets and investments. Getting to that money will require governments to bid up the interest rate their willing to pay for access. Right now, Europe and the U.S. pay about 1.25%. Once we hit the Debt Wall, it's likely we'll be paying closer to double that or more. Greece is now offering its bonds at 26% and not finding many takers.

While a 3% or 4% interest rate on sovereign debt doesn't really sound all that threatening, the fact is that it will add \$600 billion to our deficit. That's when our own austerity plan will kick in.

The debate won't be whether we should fund college tuition, or health care, or defense. The debate will be whether we can pay for any of these services while the majority of our revenues go to servicing the federal debt. Today 42.8% of the federal money spent is money printed or borrowed and that is the U.S. deficit.

Businesses won't be able to survive huge interest rate hikes. Jobs will be lost as those businesses fail. Even more families will lose their homes as unemployment skyrockets. Retirement savings will be ruined as the markets fall off. And, of course, pleading a catastrophic fall off in revenues, liberals in Washington will move to tax and control everything in sight.

We have a very short time left before it will be too late to do much of anything at all. The deficit must be cut now. Our Representatives in Washington don't have to strain much to see the truth of that. They only need to watch the news coverage coming out of Greece.

Going, Going, Gone ---The Vanishing Landscape of America

Last week the writers here at the paper were asked to identify something they felt are vanish-

ing or gone from America. I thought the idea was so intriguing that I thought I'd devote this week's column to the subject. Here are six things I consider going or already gone.

Free Directory Assistance -- Remember when you could dial "411" and get free directory assistance from a real live operator? No more. One of the many changes that has taken place in the telephone industry in the last few decades is that while phone companies once generally provided their local customers with free directory assistance, in most cases telephone customers are now charged a fee (typically \$1.00 or more) for each directory assistance call. The phone companies say this is because of the burgeoning number of cell phone numbers. Despite the charges, U.S customers continue to use the 411 directory assistance service, placing some 6 billion such calls per year.

Phone Booths -- Many readers may not be old enough to remember how a phone booth even looked. They were a standup wood or metal-framed glass cubicle with a door for privacy. Some even had a stool you could sit on. Inside they were fairly spacious and had a good size level area you could put a pad to write on. Phone booths were conveniently placed where they were easy to use, most often on street corners, in gas stations, restaurants, libraries, train stations, or hotel lobbies. They were pleasant places to make a call. They were well-serviced, clean and always had a set of phone directories -- both white and yellow pages. Of course, almost no one used the phone books because directory assistance was free.

Handwritten Letters -- When's the last time you received a handwritten letter? This year it is estimated that, worldwide, 200 billion e-mails were sent each day. That's more than two million each second. Next year it is estimated that 5 billion Earthlings will own cell phones, and 80% of the world's population will have access to cell phone coverage. What's more nearly 750 billion text messages are now being sent a year, and the number

will no doubt increase exponentially in the future. So where amongst this gorge of gabble is there room for the elegant, polite handwritten letter?

Personal Checks -- Does anyone still pay for things with a check? According to an American Bankers Association report, 23% of bank consumers plan to decrease their use of checks over the next two years, while a net 14% plan to increase their use of PIN debit. Bill payment remains the last stronghold of paper-based payments -- for the time being. Checks continue to be the most commonly used bill payment method, but on a bill-bybill basis, they account for only 49% of consumers' recurring bill payments (down from 72% in 2001) as more people make their pay-

Paperboys -- When I was 12 years old I had my first "real" job delivering the Pasadena Star-News around Poppy Peak in the San Rafael area west of the Arroyo Seco. I remember coming home after school each day to wrap, band and deliver papers on my bicycle. The position of newspaper boy at that time occupied a prominent place in the U.S. because it was the first paying job available to young teenagers. Yet, today paperboys are almost nonexistent. This is mainly due to the disappearance of afternoon newspapers, whose delivery times worked better for school-aged kids than do morning papers which are delivered before 6 a.m.

Drive-in Movie Theaters -- Does anybody remember the Hastings Drive In? In the 60s, when I was a teenager, we euphonically called it the "Passion Pit." During the Drive-in theater peak in 1958, there were more than 4,000 drive-ins in the U.S., but by 2008 only 384 drive-ins were still operating. Even reopening the Hastings as an in-door theater with a massive 1,500-seat auditorium with a 60-foot-wide, 25-foot-tall screen and dual Norelco projectors, capable of showing both 35mm and 70mm couldn't save it from going the way of the milkman. It closed its doors for

Well, there you have it: The vanishing landscape of America. Where things are easily discarded and just as easily forgotten. I don't know about you, but there are some things I really miss and wish were still around.

Last week we celebrated the Fourth of July. My son is working, so he and his family will come by. I put up a few decorations in front of our house and began to think about our great country.

Why am I proud to be an American? My mom told me that her mother-in-law, my grandma would go back to San Quirico, Italy, for visits, but was thrilled to come home to the USA and wanted to kiss the ground! My grandma came over as a preteen. She met Grandpa, They married and raised five children. My grandpa and his brothers founded a statue business and were successful. My grandparents lived in a huge 3 story Victorian row house and had a bungalow at North Wildwood, N.J. They loved the USA!

My Dad stayed back in First Grade; he couldn't speak English. But he was so smart, he skipped 2nd and 3rd grades, and went to the University of Pennsylvania on a scholarship, He worked as a chemical engineer and had 14 patents! Only in America! Land of Opportunity!

My favorite story is Uncle Pete Carolfi. You must realize my dad's sister, Natalie, grew up saying, "I'll never marry an Italian". (She thought Grandma waited hand and foot on Grandpa. She did. But as Italian women know, "My husband is the boss, but I run the show.") Anyway, there was Pete Carolfi, an Italian Prisoner of War at Ft. Dix, NJ. They had "socials". (Probably dances) and Italian American young ladies would attend, such as my Aunt Natalie. Did she end up marrying an Italian? Contrary to her "I'll never marry an Italian" motto, she did! She followed Pete Carolfi to Italy, married him and they returned to the U.S.A. Peter left ALL his family behind, but became a successful sculptor. (secular statues) He and his sons were commissioned by the City of Philadelphia to do a statue of George Clymer, one of the Signers of the Declaration of Independence. The Statue is in front of Independence Hall. Pete's work can also be seen at Caesar's Palace, Atlantic City, and the Cherry Hill Mall, both in New Jersey! Only in America. Truly land of opportunity!

What about me? Why do I love this great land? I lived five years abroad as a military wife. Two years, 1978-1980 were in Taegu, Korea. We were lucky. My then-husband Richard had an importance job so we had housing on post, at Camp Walker. Some did not. One of my American student's family was robbed twice & moved into a small apartment for safety reasons. Let me explain.

First there was the "NO HOME CAN EVER BE WITHOUT A PERSON INSIDE." (This refers to people living on the econmy-not the Army Post. Once my Korean students were explaining, "Chusok", a holiday similar to Thanksgiving. All families meet at the eldest

son's house. Mira, my student was staying home. Only her parents and brothers were going to attend. She had to "Housesit.) Usually families in the city hired a young woman from the country. She was like a live-in maid ,housekeeper, babysitter. These country girls welcomed an opportunity to live in a nice home in the city and experience city life. Mira's family was kind and wanted the maid to spend her holiday in the country with her own family. So Mira remained at home while her parents and brothers went to the Uncle's House.

Besides someone having to PHSICALLY be in the house 24/7, all houses, rich or poor had 6 feet concrete walls around them. No pretty lawns! It reminded me of prison!

Then the curfew. Back in 1978-80, while we were there, the curfew was from midnight -6am, and NO ONE and I mean NO ONE went on the streets or you would be arrested. It was weird. Clubs closed at 11pm; movies ended 11pm. Everyone had to be home by midnight! My friend had a miscarriage. It was awful. The ambulance took her, but her husband couldn't go. There was no room in the ambulance, plus there was no way to get home.

The worst experiences were during the Pak (Their president) assassination. Other military wives were saying we could go on the economy and send our girls on a scout trip. One wife bragged, "MY husband is a Captain with the Military Police." My then-husband Richard said, "Absolutely not." He had a military vehicle at home. He had to drive to Kimpo Airport, and the Secretary of Defense gave him an important communication. Most of the time, I ad no idea of what he was dealing with.

With Pak's assassination came the threat of evacuation. We were terrified. Army wives had their documents and their children's papers, plus all our "doggy" tags. We had to be ready to leave quickly. Across the street were the Military Protestant Chaplain and wife. Their responsibility was a Military Police couple's baby. All military personnel remained behind no matter what. So this couple had made these arrangements for their baby daughter.

Then our beloved Pets! My neighbor and I

agonized over them They could not be taken home. What would we do with them? The last worst solution was the Army Vet would have to put them down. Thank God it never reached

For all of the above reasons, I am proud to be an American. It is a land of Opportunity! I have seen what my immigrant relatives accomplished. I am truly grateful to have a front lawn and for the whole family to take a trip together! God Bless America!

Hubble Makes One Millionth Science Observation

NASA's Hubble Space Telescope has crossed another milestone in its space odvssey of exploration and discovery. On Monday, July 4, the Earth-orbiting observatory logged its one millionth science observation during a search for water in an exoplanet's atmosphere 1,000 light-years away.

"For 21 years Hubble has been the premier space science observatory, astounding us with deeply beautiful imagery and enabling ground-breaking science across a wide spectrum of astronomical disciplines," said NASA Administrator Charles Bolden, who was the pilot aboard the space shuttle mission that carried Hubble to orbit. "The fact that Hubble met this milestone while studying a faraway planet is a remarkable reminder of its strength and legacy."


Although Hubble is best known for its stunning imagery of the cosmos, the millionth observation is a spectroscopic measurement, where light is divided into its component colors. These color patterns can reveal the chemical composition of cosmic sources.

Hubble's millionth exposure is of the planet HAT-P-7b, a gas giant planet larger than Jupiter or-

biting a star hotter than our Sun in the constellation of Cygnus the Swan. HAT-P-7b, also known as Kepler 2b, was studied by NASA's planet-hunting Kepler observatory after its initial discovery by ground-based observations. The Hubble telescope now is being used to analyze the chemical composition of the planet's atmosphere.

"We are looking for the spectral signature of water vapor. This is an extremely precise observation and it will take months of analysis before we have an answer," said Drake Deming of the University of Maryland and NASA's Goddard Space Flight Center in Greenbelt, Md. "Hubble demonstrated it is ideally suited for characterizing the atmospheres of exoplanets, and we are excited to see what this latest targeted world will reveal."

The James Webb Space Telescope, intended as the successor to the Hubble, is expected to be launched by 2018.

Hubble's odometer reading of 1,000,000 includes every observation of astronomical targets since its launch, plus observations used to calibrate its suite of instruments. Hubble made the millionth observation using its Wide Field Camera 3, a visible- and infrared-light imager that includes an on-board spectrometer. It was installed by astronauts during the Hubble Servicing Mission 4 in May 2009.

"The Hubble keeps amazing us with groundbreaking science," said Senator Barbara Mikulski, the chairwoman of the Senate Commerce, Justice, Science, and Related Agencies Appropriations Subcommittee, which funds NASA. "I championed the mission to repair and renew Hubble, not just to get one million science observations, but also to inspire millions of children across the planet to become our next generation of stargazers, scientists, astronauts and engineers."

Earlier this week the White House held a Town Hall in which the public was invited to participate via Twitter. 

HOW WORK CAN AFFECT YOUR MEDICARE DECISIONS

I'll be turning 65 this fall and I'm planning to work for a few more years. Do I have to sign up for Medicare if I am still working and receiving health insurance through my employer? Working Retiree

The rules for enrolling in Medicare can be confusing. But when you postpone retirement past age 65, as many people are doing these days, it becomes even more complicated. Here's what you should know.

Let's start with a quick review. Remember that traditional Medicare has two parts: Part A which pro-

vides hospital coverage and is free for most people. And Part B, which covers doctor's visits and other medical services and costs \$115.40 per month for new enrollees in 2011. If you're collecting a Social Security check, your Part B premium will be deducted automatically every month. If you are waiting to collect Social Security, however, your Part B premium will be billed to you quarterly.



Enrollment Rules

If you plan to continue working past the age of 65 and have insurance from your job, your first step is to ask your benefits manager or human resources department how your employer insurance works with Medicare. In most cases, you should at least take Medicare Part Á because it's free. But to decide whether to take Part B or not, will depend on the size of the company you work for.

If there are fewer than 20 employees in the company, Medicare will be your primary insurer and you should enroll in Medicare Part B during your initial enrollment period – a seven-month period that includes the three months before, the month of, and the three months after your 65th birthday. You can sign up online at socialsecurity.gov, or call 800-772-1213. If you miss the seven-month sign-up window, you'll have to wait until the next general enrollment period, which runs from Jan. 1 to March 31 with benefits beginning the following July 1. You'll also incur a 10 percent penalty for each year you wait beyond your initial enrollment period, which will be tacked on to your monthly Part B premium.

If, however, there are 20 or more employees in your company, your employer's group health plan will be your primary insurer. If this is the case, you don't need to enroll in Part B when you turn 65 if you're satisfied with the coverage you are getting through your job. But if you do decide to enroll in Medicare, it will supplement your employer insurance by paying secondary on all of your claims. In most cases, you should probably not drop employer coverage for Medicare. If you choose to take Medicare and drop your employer insurance, it may be very difficult for you to re-enroll in your employer plan should you decide to do so later.

In either case, you'll qualify for a special enrollment period, which will allow you to enroll in Medicare without penalty as long as you sign-up within eight months after you lose your group health coverage or you stop working, whichever comes first.

Drug Coverage

You also need to verify your prescription drug coverage. Call your benefits manager or insurance company to find out if your employer's prescription drug coverage is considered "creditable." (Creditable prescription drug coverage is one that is considered to be as good as or better than the Medicare prescription drug benefit.) If it is, you don't need to enroll in a Medicare Part D prescription drug plan. If it isn't, you should purchase a plan during your initial enrollment period or you'll incur a premium penalty (1 percent of the average national premium for every month you don't have coverage) if you enroll later.

Recipe of the Week:

CRAB STUFFED FLOUNDER

INGREDIENTS: 1 1/2 pounds flounder fillets

1 cup crabmeat - drained, flaked and cartilage removed

 $1\ {\rm tablespoon}$ finely chopped green bell pepper $1/4\ {\rm teaspoon}$ ground dry mustard

1/4 teaspoon Worcestershire sauce 1/4 teaspoon salt

ground white pepper, to taste 3 crushed saltine crackers

1 egg white

1 tablespoon mayonnaise 1/4 cup butter, melted

1 egg yolk 5 tablespoons mayonnaise

1/2 teaspoon paprika 1 tablespoon dried parsley

DIRECTIONS:

Preheat oven to 400 degrees F (200 degrees C). Rinse the fillets and pat dry with paper towels.

Combine crab meat, green pepper, mustard powder, Worcestershire sauce, salt, white pepper and the crushed saltines. Combine the egg white and 1 tablespoon mayonnaise. Stir this into the crab meat mixture.

Brush the flounder fillets with melted butter. Place in a lightly greased, shallow baking dish. Spoon the crab mixture over the fillets and drizzle with any remaining

Bake the fillets at 400 degrees for 15 minutes.

While the fish is baking, lightly beat the egg yolk in a small bowl. Stir in 5 tablespoons of mayonnaise. Remove fish from oven and spread this mixture over the stuffing; sprinkle with paprika and parsley.

Increase oven temperature to 450 degrees and bake until golden and bubbly, about 6 minutes.

"Airplane Bungalow" Incorporates Outdoor Entertaining into Preserved Traditional Surroundings



A young Sierra Madre couple, Steve and Dorothy Lewis, Civil and Electrical Engineers respectively, undertook a very visible Craftsman on South Baldwin in the town, seven years ago, about the time they married.

Part of its visibility has been its nearly iridescent mustard yéllow paint, scheduled soon for a more subdued, period appropriate, green color palate. Shaded by enormous ficus trees, this block of century old character

homes remains cool in the summers, lush with the shiny, deep green leaves of the massive trees.

The Baldwin home, built in 1915, was the second Craftsman bungalow for Dorothy, who loves the style, and felt confident after her tral air conditioning, many first successful Pasadena venture into old home living and rehabbing, near Pasadena Community College.

The Airplane Bungalow of the early 1900's is known for its homey, unpretentious architectural profile. Some say that looking at one of these bungalows from above invites visions of airplane wings in the spreading roofline, with a cockpit (dormer window) in the center.

The building style continued the design break with Victorian fussiness, focusing instead on terms like "simplify" and "organic" and bringing the enjoyment of the outdoors in. Bungalows of that era incorporating it into the

Steve designed and the two of them built an intricate, Craftsman style front fence of redwood, and then clad the automatic driveway gate to match. They integrated the fence into the existing stone pillars. The pillars, however, were carefully heightened by removing the vintage con-crete caps, adding Arroyo stone and recapping. The re-sult looks perfectly... old.

Without benefit of cenearly 20th century bungalows sported a generous sleeping porch, from which the family could sweat out the relatively few steamy LA summer nights hoping for a cooling breeze or the return of a marine layer from the coast. Previous owners had enclosed the sleeping porch,



home's living space, but proper insulation and central heat/air conditioning were severely lacking.

Plans are underway now to repair the century old, original barn and hayloft, which is now a garage with a small apartment above, serving as Steve's civil engineering office.

style, carriage doors have been crafted and installed.

Out back, they longed for a spa, and tough but beautiful surfaces that would tolerate their large dogs. The Lewises called in Sierra Madre resident, Mark Meahl, president of Garden View, Inc., to provide design inspiration and as general contractors. Meahl's company, run by the family, has several divisions, including a large plant nursery on the west perimeter of I-605, just south of the 210. The company is very proud of the 67 Awards received from the California Landscape Contractors Association over the years.

"Initially," Meahl reflected, "the Lewises wanted a big spa, maybe even a swim spa. I recommended against that option because every time you use the spa function, you have to heat a whole big area." Instead, Garden View built them a small saltwater pool with a raised spa beyond, so their spa use requires a much smaller amount of water to heat. They installed a pump to swim against, for "in place"


Garden View used a "mini-pebble" surface with a longer lasting and more durable surface than traditional plaster, without the blotch-

Garden View puts great effort into blending boulders, (not the artificial ones!) into the pool. "We can build with real stone for the same price in this size project. We put real, hand selected boulders into the water. We waterproof around them, and then put another boulder

on top of the pool wall that matches almost exactly to the one in the water, almost 'marrying' them to make it look like one big boulder. Many other contractors just plop one on top, and then it looks like it's going to fall into the pool!"

One of the challenges was to combine grass and dogs near the pool. They opted for an artificial grass, to give the feel and look of turf, but not subject to the stresses





of the saltwater pool and the four footed family members. The key to a natural look, according to the Lewis, was choosing a product which incorporated some brown "leaves" into the mix, mimicking the natucvcle of a live lawn.

In such a tight space, nearly every space does double duty. In back, part of the driveway doubles as a beautiful patio. The Lewises chose a four color paver system, tightly set in sand, for the front walk, driveway, garage entrance and patio. Meahl indicated the cost is a little more than colored concrete, but not much.

"It's a nice alternative to concrete, because the pavers don't crack," said Meahl. "If a problem arises underneath, it can be easily repaired." Pavers also allow rainwater to permeate the soil, reducing runoff.

The Lewises splurged for slab granite counters and split stone to face the built-in barbecue, and got a firsthand appreciation for the careful, labor intensive process, as they watched the assembly.

Every once in a while, the Lewises take some time to enjoy the fruits of their labors. The proof of the pudding was their 4th of July gathering, when guests commented on how much they got out of their relatively small yard.

for inviting hominess rather than as a heating source.

Almost no bungalow was complete without a wide front porch, and this home is no exception. All the Lewises took a rare moment to actually sit on their front porch to pose for my photo, though no grass grows under their feet, by any means, with two careers, two dogs, a baby and managing their rental properties.

In the last seven years, the two made an avocation of stripping or sanding decades of paint from the living room and staircase millwork down to its wood hued roots. Dorothy, the electrical engineer in the family, had the patchworked knob and tube wiring replaced, then delved deep into the electrical cobwebs to add recessed lighting to the living room.

Luckily, the kitchen, breakfast bar and casual dining areas had been tastefully updated by previous owners. The engineers brought the room closer to the period by retrofitting Craftsman reproduction fixtures into the kitchen area, and closer to today's lifestyle by bringing the laundry back into the house from the garage.
