Joan Milazzo, 56, was struck and killed Tuesday morning, August 30, in the Del Sur area of North County San Diego. Milazzo, her husband and sister were hiking in an area near their development.

According to a Press Release from the San Diego County Medical Examiner's office, "They were crossing Camino Del Sur Road when a vehicle traveling on the southbound lane at a high rate of speed lost control and skidded into the decedent as Santa Fe, CA 92067. Phone: she stepped onto the curb. 858 756-1911

The decedent was struck and fell to the ground. Bystanders called 911 and assisted with CPR. Medics transported the decedent to Scripps La Jolla Hospital with blunt force trauma and she was pronounced dead when resuscitative efforts were to no avail. San Diego Police Traffic Division is handling the accident investigation and charges are pending.

Milazzo and her husband had just moved there to join family only a few months prior, after retiring from a long career at AstraZeneca. Milazzo grew up in the San Gabriel Valley, and graduated from Alverno High School in Sierra Madre. She was previously a member of St. Rita Catholic Parish in Sierra Madre.

Portantino Calls for State Transparency



In his continuing efforts to provide sunshine and accountability government, Assembly Member Anthony Portantino Lastweekintroducedlegislation to force the Legislature to comply with the California Public Records Act (CPRA). Currently, Portantino said in a statement, the State Legislature is the only government agency in California that exempts itself from compliance with this important good government's standard. In 2004, voters passed Prop 59 to strengthen public access to information with 83%

of the voters in support. Under AB 1129, Portantino calls for elimination of the self-serving exemptions to transparency that the legislature follows. In place of the same transparency the legislature expects local governments to operate in, the Legislature established its own watered down version of the CPRA called LORA - the Legislative Open Records Act. This action created loopholes and exemptions which have allowed Assembly leaders to hide budget records and expenditures from public

review for years.
"Assembly leaders have hidden documents and expenditures from the public long enough. No more gimmicks, no more tricks and no more incomplete and misleading financial documents can be circulated or tolerated," commented financial Assembly Member Portantino.

The Los Angeles Times and the Sacramento Bee, as a result, joined forces in a lawsuit to compel the release of accurate and comprehensive financial information from the Assembly.

"A secret budget is by its very nature a corrupt budget, Portantino said. "I join with the Sacramento Bee which last week called for the Assembly to simply comply with CPRA.

AB 1129 repeals the LORA exemptions and brings the Legislature into complete compliance with the California Public Records Act. The Governor, other constitutional offices, and local governments

all comply with CPRA. Under the current system, the State Assembly spends \$146 million a year in tax money to operate its offices and committees with no accountability or sunshine.



Foothill Extension Progress:

Equipment is being mobilized this week for the upcoming foundation work on the I-210 Bridge. As you can see from the images below, a large drill rig and crane have been trucked in and are being assembled on the south side of the eastbound I-210 Freeway. This is the location of the first of three 110 foot deep, 11 foot in diameter foundations to be drilled over the next four weeks. The other two are located in the center median of the freeway.

Each foundation will take approximately six days to drill and cast. We anticipate drilling the first foundation next week, followed by the installation of the reinforcing steel cage, concrete placement and testing the following week. This schedule is dependent on receiving final approval from Caltrans this week. During these activities, partial and full eastbound lane closures are planned (full closures occur late at night to minimize traffic delays).





SIERRA MADRE SCHOOL BREAKS 900 Highest Academic Performance Index Ever For PUSD School!

Sierra Madre School became the district's first school to score above 900 on the Academic Performance Index (API), according to the 2011 Accountability Progress Reporting (APR) released this week by the California Department of Education. More than half of the remaining PUSD Schools scored 800 or better.

However, the results of the federal Adequate Yearly Progress (AYP), also released today, placed schools that scored above the 800 API benchmark into federal Program Improvement for failing to meet growth targets.

Together, the API and the AYP are the two main indicators of school performance and both systems are based upon the results from STAR and the California High School Exit Exam. California's definition of proficiency in English language arts and math is widely considered among the most rigorous in the country.

"I am pleased that schools demonstrated improvement, especially those that made substantial gains this year, and I am deeply committed to working with the schools with scores that dropped or remained low," said Superintendent Jon R. Gundry. "I have set an immediate course of action to examine the reasons for the inconsistencies in school performance and to make adjustments tailored to each school. Administrator and school teams began this work earlier this month and will continue throughout the year."

On the API, the score most commonly used as a measurement of academic performance, Sierra Madre scored 908 this year and became the first school in PUSD to score above 900. Ten other schools scored above the 800 benchmark on the API and two schools moved above 800 for the first time: Altadena Elementary scored 818 and Field Elementary scored 813. While 1,000 is the highest API score possible, the state sets its goal at 800 points. Schools with scores below 800 are assigned a growth target each year until they meet or surpass the state's

In terms of improvement, Altadena Elementary grew the most this year, jumping 63 points. Among secondary schools, John Muir High School improved the most, doubling its growth target to gain 19 points this year. Marshall Fundamental tripled its growth target for a 15-point gain and Washington Middle School gained 14 points. Nine PUSD schools met their API growth target this year. Overall, PUSD improved by 53 points over the last five

However, the number of schools whose scores dropped significantly were in

Already, school teams and administrators state API target of 800. have worked together with parents to closely examine data and determine the factors that lead to decreases in scores. The ongoing work is paired with an examination of the significant increases at other schools to determine which practices can be shared to propel improvement.

On the AYP, the federal school performance system established under the No Child Left Behind (NCLB) Act, nine PUSD schools met proficiency targets and in math and four met the English language arts target.

The AYP sets progressively higher performance targets each year with the goal of reaching 100 percent proficiency by 2013-2014. Schools must meet up to 42 objectives every year, including growth among subgroups of students, and can be labeled as failing AYP if they do not meet targets for two consecutive years. Once labeled, schools enter the federal Program Improvement, which mandates sanctions.

The federal growth target increased by 11 percent this year alone. In California, 913 schools were newly identified as "failing"

almost equal proportion to those that grew. this year, despite meeting or surpassing the

Three PUSD schools with API scores above 800 were placed on program improvement for the first time because of the federal AYP mandates.

Hamilton Elementary School, which scored 863 on the API this year, has consistently scored above 800 for the last several years, was named a National Blue Ribbon School in 2009, and scored a 10 of 10 when compared with similar schools in California, entered program improvement despite having more of its students test advanced or proficient than ever before. Hamilton was placed on program improvement because the school did not meet one its subgroup AYP goals for two consecutive years.

This week, State Superintendent of Public Instruction Tom Torlakson issued a letter to the federal Department of Education proposing that California be allowed to freeze the imposition of sanctions and mandatory identifications for the coming school year at last year's levels.







SHOWDOWN AT THE BEANTOWN CORRAL

OK, folks, it looks like an explanation is in order about my marijuana article from the August 27 issue. A few of you contacted me personally, and I got a few emails. But the big showdown came when I was cornered at Beantown with the Steve Girl Helen on the other side, giving me a piece of their minds.

They weren't challenging me about my facts, exactly, but mostly about the way I said it. They know me well, and they felt I would be misunderstood from the way the article was

I wrote that if you smoke marijuana, you're choosing to be an idiot. OK, that was a bit over the top, and it never helps to clarify issues by using anything that seems to be a personal attack. So I apologize for that one.

My column was inspired by my conversation with a mother who was exasperated by her two teens' use of marijuana, and their defiance in using it at the home. Thus, my opinion piece was liberally spiked with my random bursts of subjectivity, the likes of which brings few people to my point of view, and allows most readers to assume I am a frothing-at-the-mouth, ranting lunatic, or a judgmental fool.

So here are a few clarifications on what I wrote.

Regarding "medical marijuana," I did not intend to imply that the "medical use" is a joke and that there is no valid medical use. It's the phony claims for medical need that I perceive as a deception.

It seems there are probably more legitimate users of marijuana for medical uses than I believe. Granted, I am an advocate of using little or no medicines (legal or illegal), since the body is designed to heal itself. And though there may be other medical alternatives to marijuana, the fact that some people gain relief from their symptoms would justify its use.

So what percentage of folks who buy marijuana from the pharmacies are "legitimate users." This is not an easy figure to ascertain. I spoke to several

folks who run medical marijuana pharmacies, I received estimates in the range of "under 5%" to "around 20%" to "50%" of those who have a legitimate medical need. It is so easy to get the medical marijuana card that it is hard to quantify "legitimate." But after talking to several people, my sense is that the legitimate users are about 25% of the buyers. That estimate is a lot higher than my estimated one in a thousand (from last week's column). Still, even by the proponents' best estimates, that means there are a lot of users out there who simply want

However, my comment on why the larger legitimate pharmacies don't carry marijuana was incomplete. The simple answer is that the larger pharmacies are following federal

A followup to his Marijuana column of August law, not the state's voted legality of marijuana. 7 - by Christopher Nyerges law typically trumps local laws.

Is there more crime at the medical marijuana shops, as I inferred? Police records suggest that 7-11s get robbed more often than the medical marijuana shops, and criminals go where there's cash. The medical marijuana shops also deal the resident artist on one side, and Urban Nature in cash, so they're targets. It's about cash, not marijuana.

Due to the prevalence of alcohol in our society, and its legality, I would agree that legalizing marijuana would also decrease the criminal aspects of marijuana trade, and possibly reduce the power of the cartels which kill so many. But the flip-side is that some fear legality would encourage more "recreational" marijuana use.

Re: hemp. It's a great fibre with many good uses, and farmers should be allowed to grow it for fibre. But I wasn't talking about legitimate hemp-forfibre farmers or hemp-for-fibre promoters. What I dislike is that some marijuana smokers hide behind the many good uses of hemp, when in fact, what they really want to do is get high. (By the way, many people don't realize that both "hemp" and "marijuana" are just common names for the same plant, Cannabis sativa. The key difference is that marijuana has been cultivated to get an increased THC content).

With all this in mind, my point that I was trying to convey was that it is good and desirable to be clear-thinking, and to always be fully in charge of your mental and physical faculties. This basic principle is a good survival tactic in all situations.


I am content to leave the legal and medical issues to others. Free individuals should always choose to be free of anything that might curtail their full ability to function in all realms of "survival."

I see that my reactive state of mind when I wrote the original article didn't fully convey what I intended.

Please accept my apologies if I had inadvertently offended any of you. And thank you Steve and Helen for caring enough about me to encourage me to write this clarification.



That remark from the class-of-2010 tea-bagger

reminded me of the 1991 confirmation hearing of Justice Clarence Thomas, when he questioned whether a lifetime appointment to the nation's highest court was worth having to endure a "hightech lynching"; i.e., having to answer allegations of sexual harassment. I remember almost shouting at the T.V., "If it doesn't mean that much to you, then step aside for somebody else!"

Many would give anything for the privilege of serving their country in congress, even if it meant having to somehow scrape by on \$174,000 a year. I think of retirees in Tallahassee who never saw a salary half that much in their lifetimes, let alone the pension and healthcare benefits.

Last Spring, the Polk County Republican Party tried to squelch video postings on freshman Rep. Sean Duffy (R-WI), who dutifully supported Wisconsin Gov. Scott Walker's slashing salaries and benefits for those public employees not already fired. Responding to town hall questions about his own public salary, Rep. Duffy explained, "I still pay off my student loans. I still pay my mortgage. I drive a used minivan ... I struggle to meet my bills right now." He couldn't understand why anyone would begrudge him his \$174,000 plus benefits (more than three times the Polk County average).

Republicans faced embarrassing confrontations at previous town halls, but appear to have concluded the problem lies not in having to justify their salaries to those who pay it, but in town halls

About half of all members did away with town halls altogether. Among Republicans, many decided to limit attendance to those who'd pay for the privilege of being in the room with them. Price of admission varied; Rep. Chip Cravaack (R-MN) - \$10, Rep. Paul Ryan (R-WI) - \$15, Rep. Lou Barletta (R-PA) - \$30 (protesters and reporters not admitted), Rep. Ben Quayle (R-AZ) - \$35 (lunch

The Carver County, Minnesota, Republican Party abandoned all pretense and (briefly) posted an eBay-like site auctioning off opportunities to "get up close and personal" with lawmakers at a closed event (bidding starts at \$250).

Blogger Jed Lewison at Daily Kos offered this rationale: "It's hard to blame them. If you'd just spent the last seven months trying to end Medicare, causing the first debt downgrade in American history, and failing to pass a single piece of jobs legislation, would you want to face

Rep. Steve Chabot (R-OH) had previously required town hall attendees to sign in and submit questions in writing, with staffers selecting the ones to be passed on to the congressman. He took it up a notch, though, when last week a staffer directed Cincinnati police to confiscate the cell

An Ohio Tea Party activist wrote,

An Ohio Tea Party activist wrote, " public town hall event, in a public venue (high school gym), hosted by a public official and coordinated by public staffers, personal/private cameras and cell phones are now being forcefully removed to keep video footage from hitting YouTube." (Video hit YouTube anyway.)

Some later relented and opened up their town halls. Tea-bagger Rep. Cravaack watched his audience cheer a recent college grad after she confronted him on his remark that a problem with Pell Grants is they raise tuition costs for "normal people". Rep. Chris Gibson (R-NY) was slammed at a town hall in Millerton for having signed the no-tax pledge; "We are your constituents, not Grover Norquist!" Rep. Dan Lungren (R-CA) threatened to walk out of a forum outside Sacramento when a woman raised the same issue, reminding him the only "pledge" he need make is to the Constitution, and a man complained, "You use the debt ceiling as blackmail!"

As a means of combating such embarrassments, freshmen Reps. Dan Webster (R-FL) and Tim Griffin (R-AR) have taken to investigating those who ask the "wrong" questions at town halls, grabbing photos and personal information off Facebook, then distributing ominous information sheets on the troublemakers to the media. One of those sheets suggested the media question the military service of a 66-year-old Vietnam vet, who later commented to the Orlando Sentinel, "I think it's pretty weird. Someone asks a legitimate question, and all of a sudden somebody's got a dossier on you."

If there's such disdain for those paying their \$174,000 salaries, then who do freshmen teabaggers think they're working for?

Rep. Stephen Fincher (R-TN) took in \$87,700 from agribusiness over his first six months, then introduced legislation weakening oversight in rushing genetically-altered crops to market. The aforementioned Rep. Duffy raised 40% of his funds from insurance and financial services PACs, and is pushing to gut the new Consumer Financial Protection Bureau. Rep. David McKinley (R-WV) got \$176,000 from mining interests and is working to strip powers from the EPA, which earlier this year vetoed a mountaintop coal removal permit.







MONEY It Makes Us Crazy

I might as well write about money; everyone else After sweating out that weirdness about the debt ceiling the news last week involved the Angel's star pitcher, Jared Weaver. If you can believe it, the twenty-seven year-old pitcher voluntarily agreed to accept less money so that he could remain with the Angels. Of course he's still going to receive something

like \$85,000,000 over four years so it doesn't really seem like that much of a sacrifice. As Mr Weaver attempted to explain to incredulous reporters, "Really, how much money do I need?" The reporters couldn't believe it. It was as if this young pitcher was challenging the entire American way of life. For many Americans, money is the way we keep score. The more money we make, the more valuable we are. Valuable to whom, you might ask, and I guess the answer is that money is the quantification of our value to society no matter how we feel about ourselves.

I believe that I am in complete disagreement with this way of thinking. I can remember my father saying to people that my sister and I were his two million dollars. This always seemed to me to be a feeble excuse to the world that he was not making much money and was trying to pretend to some satisfaction that he did not really experience. To my own young mind, I was worth more than money and I still think that way. To my father, however, money probably meant something else. He was born in the Ukraine, came to America with no money and never went beyond one year of middle school. He lived through the Depression and started several businesses and struggled his whole life to earn a living. As I have written before, he continued working even after going blind and managed to support his family.

For my dad money was not just something that just had value as currency. It was something more, a recognition of commitment, of strength and responsibility and character. It seems to me that money no longer means any of these things. As far as I can tell, money is thrown around irresponsibly to athletes and celebrities who earn more than they know what to do with or have any need for. Our own wealth seems dependent upon everything beside our own efforts. Really, I think the possession of wealth should be significant because it presents great opportunities to be helpful to other people, and the opportunity to be helpful to others is a chance to experience one of the great joys of the world. Still, I do not dispute that it is easy to become confused.

As I think about it, I note that my attitudes, just like my father's, are influenced by past experiences in ways that are no longer appropriate. For example, I hate paying for parking. I remember when parking was free, or almost free, and I will park a mile away in order to avoid a parking fee. It's crazy I know and, on top of it all, I don't save any money. Four times I have had my car towed away by the police because time to park had expired or I had overlooked some sign which restricted the area. Each tow-away is a costly catastrophe, not only in money but in the inconvenience of not being able to locate the car. I hope you never have to go through the experience. I wish I could say I was sure that it won't happen to me again; but it probably will, as I still can't allow myself to pay sixteen dollars to park at the Courthouse.

Speaking of Court, I am an attorney on this Panel that receives hourly payments for Court appointed representation. In order to get paid I need only to fill out these forms, send them in, and eventually money arrives. Why then do I have such trouble filling out the forms and sending them in? I have noticed that other lawyers have the same problem. Why? Because the money makes us crazy. What money? The paltry amount we receive as testimony to our own meager worth? Or perhaps the realization that we are earning money from the pain of others? Who knows? Maybe, just like when my father valued me in terms of dollar worth, there is something invariably degrading about allowing oneself to be valued in terms of money?

As usual I don't know the answer. I must admit that, just like the Country, I have problems surrounding money and I wish those problems would go away. I would like to have more control of my own behavior. Maybe if some nice man would offer me eighty-five million dollars I could act more rationally;. probably not, though I would not refuse the opportunity. It would allow me to be so helpful to other people and still have enough left over to pay for parking.

NEWS FROM OUR GIANT PLANETS Jupiter-Bound Space Probe Captures Earth and Moon

Earth's natural satellite—our own Moon.

"This is a remarkable sight people get to see all too rarely," said Scott Bolton, Juno principal investigator from the Southwest Research Institute in San Antonio. "This view of our planet shows how Earth looks from the outside, illustrating a special perspective of our role and place in the universe. We see a humbling yet beautiful view of ourselves."

The image was taken by the spacecraft's camera, JunoCam, on Aug. 26 when the spacecraft was about 6 million miles away. The image was taken as part of the mission team's checkout of the Juno spacecraft. The team is conducting its initial detailed checks on the spacecraft's instruments and subsystems after its launch on Aug. 5.

Juno covered the distance from Earth to the Moon (about 250,000 miles) in less than one day's time. It will take the spacecraft another five years and 1 billion,740 million miles to complete the journey to Jupiter. The spacecraft will orbit Jupiter's poles 33 times, using its eight science instruments

On its way out to Jupiter, the biggest planet in to probe beneath the gas giant's obscuring cloud the Solar System, NASA's Juno spacecraft took cover to learn more about its origins, structure, time to capture an image of its home planet and atmosphere and magnetosphere, and look for a potential solid planetary core.

Cassini Closes in on Saturn's Tumbling Moon

Hyperion Meanwhile, much farther away and now


orbiting our Solar System's second-largest planet, NASA's Cassini spacecraft captured new views of Saturn's oddly shaped moon Hyperion during its encounter with this cratered body on Thursday, Aug. 25. Images were acquired as the spacecraft flew past that moon at a distance of about 15,500 miles, making this Cassini's second closest encounter with Hyperion.

Hyperion (meaning "the high one" and named for one of the twelve Titan gods of ancient Greece) is a small moon, just 168 miles in diameter. It has an irregular shape and surface appearance, and it rotates chaotically as it tumbles along in orbit. This odd rotation prevented scientists from predicting exactly what terrain the spacecraft's



cameras would image during this flyby.

However, this flyby's closeness has likely allowed Cassini's cameras to map new territory. At the very least, it will help scientists improve Cassini's next flyby of Hyperion will be on Sept. color measurements of this moon. It will also help them determine how its brightness changes as lighting and viewing conditions change, which can provide insight into the texture of the surface. The employment situation is getting better, however, it is still a challenge finding were the jobs are located and how to get pass the "gate-keepers. As an Executive Recruiter I was privy to working directly with Corporate Recruiters and understanding their process in selecting which candidates to interview and hire. I will candidly answer your questions, possibly bluntly answering your questions, but I will be totally honest. My objective is to help you achieve

I recently was laid-off after 7 years as an Office Manager with a financial company. The company just decided they had to cut staff by 75% in order to stay afloat. I started sending out my resume and applying for positions online within three months after being laid-off. I thought with my office, computer and management skills I would be able to find employment immediately. To my surprise, that is not the case. I have aggressively networked with former co-workers, family, friends, neighbors, and met new people at events, introduced myself to employers at job fairs. Nothing seems to be working. My mother suggested I start going from door-to-door knocking and asking employers if they have any openings. She said that is what she used to do in her day. I am not opposed to doing that if I have to. What is your opinion? Do you think that is a good idea or would it make me seem anxious? Are employers and businesses open to people going to their offices and asking if they have any openings? Norma Sue.

Dear Norma Sue,

I say yes. It's a great idea! However, the 21st century version is somewhat different. It's called "cold calling", or telemarketing yourself. Yes, you pick up the telephone and start to call employers! This actually works! Employers who are open to this type of solicitation are the small to mid-size companies which employ 50-1,000 employees. These employers do not advertise or post their positions because of the enormous cost. They rely on word of mouth, employee referrals or someone like you making a telephone call and asking if they might have any openings. This process is going to take some time and a lot of hard work on your part to make it happen. First: know what type of position you are going after. Second: build a target list of small to mid-size companies you feel might need someone with your skills and work experience. Third: prepare a script with talking points; why you are calling, who you would like to speak to (this could be a title only), ask if could you fax or e-mail your resumé to them either for a position now or for future consideration. Or, better yet try to make an appointment to meet and speak with someone. You are going to have to be a little aggressive to get pass the telephone "gate keepers". I suggest you ask whoever answers the phone for their assistance, treat them with respect and don't forget to thank them. You will find this treatment will usually get you to the right person. I have found a little bit of niceness goes a long way. However, also get ready for a lot of direct "in-your-face" rejection. It is going to happen. Don't take it personally. Keep on posting your resume on-line, e-mailing, mailing and now "cold calling". These efforts will eventually land you employment in a shorter period of time.

Pretentious, Powerful Plants of Prey

If you are like me, you probably specially modified as traps. think of plants as simply live, yet inanimate objects that help feed us, help keep our air clean and oxygenated, and add ornamental features to our environment that make the world around us far more beautiful than it would be without them. I am sure we all agree that these are all true facts mucilage. Snap traps (or steel traps) about plants, but some varieties of that of the Venus flytrap and waterwheel gorgeous green growing fauna we tend to take for granted, are way more active and animated than most. The plant traps, unique to bladderworts, are animals are the ones that fascinate me the most. Who isn't amazed by the beast-like behavior of the Venus fly-trap? I remember seeing "Rocky Horror Picture Show" for the first time as a kid, and thinking the screen-writer had invented the concept of a predatorlike plant, until I learned that they really do exist! The following narrative, written by contributors to the Botanical Society of America (www.botany. org) provides a very interesting and informative summary about the origin and development of several plants that it as fascinating as I do.

Carnivorous plants have the most bizarre adaptations to low-nutrient environments. These plants obtain some nutrients by trapping and digesting various invertebrates, and occasionally even small frogs and mammals. Because insects are one of the most common prey items for most carnivorous plants, they are sometimes called insectivorous plants. It is not surprising that the most common habitat for these plants is in bogs and fens, where nutrient concentrations are low but water and sunshine seasonally convergent evolution. In contrast, the Recently, I even find myself talking abundant. As many as thirteen species of carnivorous plants have been found in a single bog (Folkerts, 1982). Most

Traps work in a variety of ways. Pitfall traps of pitcher plants are leaves folded into deep, slippery pools filled with digestive enzymes. No single definitive list exists. Ibicella lutea, which has not been studied since 1916 (Juniper et al., 1989), is sometimes listed as carnivorous, and Catopsis berteroniana is sometimes described as borderline. The ability to digest prey and absorb the amino acids is considered the real clincher.

Carnivory is more widespread than just the plant and animal kingdoms. The fungi kingdom has flesh eaters also (Pramer, 1964). Living in the soil are over 200 species of fungi (identified zygomycetes, basidiomycetes, carnivorous plants, these fungi have the ability to trap prey and to absorb nutrients from the body of their prey. The traps of fungi come in two general types: constricting rings (active traps) and adhesive structures (passive traps). These trap types occur in separate fungi lineages (Ahren et al., 1998).

Exploring and learning more about the amazing world of carnivorous plant life somehow gave me a much wider perspective on how I view the greenery that surrounds me and makes this world such a gorgeous place to live. out loud to the trees and flowers as I pass by while walking through the neighborhood. Kathy & Bonito, Part 2


In case you missed last week's article, we left off "on a dark and lonely December night," when my mom's friend, Kathy, entrusted a lost pet parrot she found to our care.



Whether we want to admit it or not, there's a good reason why doctors' offices are called "practices." Each patient presents a whole new opportunity to learn something that we may not have know before.

When Robert came in with a frozen shoulder twenty-five years ago, he taught me something that changed the way I practiced forever. He had recently retired as an upholsterer and had awakened with a stiff, sore right shoulder. It had never acted up before, and he could not remember doing anything that would have set it off. When he arrived, the shoulder was almost completely immobilized.

As I began working on the area, Robert talked about his retirement and how glad he was to take time off after so many years of running his business. He admitted that there was some concern about what he would do with himself.

After a couple of visits, there was very little progress, so I began to work a little deeper and more firmly on the muscles and connective tissue surrounding the joint. On one occasion, Robert began to talk about how his family had been taken to Manzanar at the start of World War II. As we finished up, he said, "Boy, I haven't talked about that for a long time!" Was there a connection between his shoulder problem and the long ago traumatic event? I would find out the following week in a surprising way.

Robert had gone home with the Manzanar experience fresh on his mind and began talking about it with his brother. While talking about things long past, his brother, who was a couple of years older than Robert, asked him if he remembered the car accident. Robert had no recollection of any car accident.

When Robert was two, he and his brother were riding in an open car driven by their father. This was in the mid-1920's. Robert was on his mother's lap and somehow they hit a high curb, flinging the passenger door open and throwing Robert and his mother from the car. Robert landed on the parking strip and dislocated his shoulder. His mother's hair was caught in the spokes of the car, and she was carried a way down the street. Surprisingly, no one was killed or seriously injured. Robert's father refused to ever drive again.

Over the next few weeks of treatment, the shoulder began to move more freely and eventually returned to normal. What struck me most was how Robert became more alive. He seemed more at peace, more connected.

There's a simple statement that touches on this kind of experience: Your biology is your biography. Robert introduced me to this possibility first hand.

How to Detect and Prevent Telemarketing Scams

Dear Savvy Senior,

seniors from telemarketing scams? My 80-yearold mother has been swindled out of several hundred dollars over the past year and keeps getting calls from scam artists.

Dear Worried

Telemarketing fraud is a big problem in the United States, particularly among seniors who tend to be the most vulnerable and frequently targeted. Here's what you should know, along with some tips to help protect your mom.

Phone Fraud

According to FBI reports, there are around each year – most of whom are over the age of 60.

Telemarketing fraud happens when a con artist calls you up posing as a legitimate telemarketer and tries to cheat you out of your money by offering things like free prizes, vacation packages, sweepstakes or lottery winnings, discount medical or prescription drug plans, buying club memberships, credit and loan promises, investment and work-at-home opportunities and more. They also usually demand that you act right away and require some kind of up-front payment to participate or receive your winnings, which is always a red flag that the call is a scam.

Seniors also need to be careful of fake charity and fundraising phone scams, home improvement scams, fake checks (see fakechecks. org), grandparent scams, and invitations to free changing her phone number. Scam artists trade lunch seminars.

What You Can Do

The first thing you should do to help your mom steer clear of phone scams is to alert her to the Report It problem and how to recognize it. To help you with this, the Federal Trade Commission (FTC) offers a consumer education website at ftc.gov/ phonefraud that provides a rundown on some of the most common phone scams making the rounds these days and what to watch for. They also offer some helpful publications you can get for her like "Putting Telephone Scams on Hold" and "Who's Calling? Recognize & Report Phone Fraud" that you can order for free by calling Box 5443, Norman, OK 73070, or visit SavvySenior. 877-382-4357.

out her personal information like her credit card Can you recommend some tips to help protect number, checking or savings account numbers, Social Security number or mailing address to



telemarketers no matter what they promise or tell her. If she's getting calls from telemarketers requesting this information, she should simply hang up the phone because it's a scam.

If, however, your mom is having a hard time 14,000 illegal telemarketing operations that steal recognizing a scam or hanging up on pushy more than \$40 billion from unsuspecting citizens telemarketers, get her a caller ID and tell her not to pick up unless she recognizes the number of the caller. Or, ask her to let the calls go to voice mail. Telemarketers rarely leave messages.

> Also, make sure her phone number is registered with the National Do Not Call Registry which will significantly cut down the number of telemarketing calls she receives. You can register your mom's phone number for free at donotcall. gov, or by calling 888-382-1222 from the number you wish to register.

> Unfortunately, being on the registry will not stop calls from political organizations, charities, pollsters and companies that your mom has an existing business relationship with. And, it won't stop telemarketing scams either. If your mom is getting a lot of calls, discuss the possibility of and sell what they call "suckers lists" of prior victims, and the only way to get her off these lists may be to change her number.

It's also important that you or your mom report any suspicious telemarketing calls she gets to the FTC (see ftccomplaintassistant.gov or call 877-382-4357) and to her State Attorney General. Reporting it helps law enforcement officials track down these scam artists and stop them. You'll need to provide the telemarketer's phone number, as well as the date and time of the call.

- 2 bay leaves
- 3 large green bell pepper
- 1 1/2 teaspoons cornstarch
- 2 teaspoons soy sauce
- 1/4 cup cold water

DIRECTIONS:

Heat butter over medium high heat, brown meat, which has been cut into 1/4-inch wide strips. Brown the meat in 2 or 3 batches so that each batch just covers the bottom of the skillet without crowding. Remove meat and set aside. Reduce heat, saute onions for 5 minutes. Return meat to skillet, add remaining ingredients except peppers, cornstarch, soy sauce and water. Add peppers, which have been seeded and cut in 1/2-inch strips, simmer covered for 10 minutes. Blend cornstarch, soy sauce and water in small dish; stir into meat mixture. Cook until thick and clear, about 1 minute.

Pepper steaks serve 6.

Sierra Madre laid eyes on Dr. Roger Joe was as he, his family and staffers walked the yearly Independence Day parade this

Dr. Joe, a USC trained dentist, practiced the last sixteen years in the 301 W. Huntington Drive Building across from Methodist Hospital. Just six months ago, he closed escrow on the former Masonic Lodge building at 33 E. Sierra Madre Boulevard, with intentions to upgrade the meeting/ event space on the main level, and turn what was the Mason's meeting hall into his offices.

He started on the remodel immediately. "My family, staff and I have been greatly blessed to be welcomed into this beautiful, quaint foothill community. We are excited to continue serving people with a friendly, hometown atmosphere coupled with the most comprehensive level of dental care available."

Joe moved his dental practice and his staff of nine to the second floor of the Lodge building mid-August. After just a week to get mostly settled and functional, he proudly took me on a tour of the refurbished space. Prior to Joe's ownership, I had been inside the building several times to attend Kiwanis luncheon meetings on Tuesdays, but I had no idea what to expect upstairs.

After I hiked the beautiful and original, but rather steep, curving staircase somewhat reminiscent of the grand Alverno villa stairs, my first surprise is that the building has an elevator, one of the few in Sierra Madre.

The newly crafted office space left the high ceilings, intricate and ornate ceiling molding and original pendant lighting fixtures visible and intact, after having them refreshed. Stunning peaked doors, definitely appropriate for a castle, were also preserved and refinished.

At floor level, the walls rise only part way to the very high ceiling, leaving the office space very airy and filled with natural light. At the top of the second floor, Joe preserved a small balcony with intricate wrought iron railings.

Several of the six patient stations offer the mesmerizing distraction of unobstructed San Gabriel Mountain Views from each chair. At eye level, Joe has installed movable monitors, from which patients can view x-rays, educational materials or live video of problem areas or dental work in progress. Though Joe brought some equipment from the previous office, he pointed out that the office is truly state of the art.

A large central office area is open to both the generous waiting room and the patient rooms. The sterilization room functions with foot control pedals, not requiring touching hands to open and close the autoclave trays and other instrument processing doors. In one corner, a family area allows waiting children to do homework or watch a video. A small niche is set up for patients to update their contact and insurance information directly onto the computer.

On the main level, the sad state of disrepair and stained window coverings is long gone. The last to

be done is hanging draperies and refinishing the floors. The main meeting/event space currently holds regular meetings for Sierra Madre Kiwanis, Shriners, California Dance Co-op and Crosslife Church. Ballet barres surround the perimeter of the room, for use of the Le Petite Dance Studio on the afternoons.

Saturdays and Sundays are currently available to rent for events. Round tables and chairs are stored onsite, for approximately 125 seated attendees, plus a stage and piano are located at the

A system was installed to show presentations on the front screen, as well as a sound and speaker system, a new HVAC system, and new bathrooms on both levels. The kitchen offers a commercial stove, refrigeration space, plus generous staging for catered meals.

An important piece of Sierra Madre history has been carefully preserved, while a new business and beautiful event space adds to the milieu of opportunities in this small foothill town.




