SIERRA MADRE COUNCIL TO DISCUSS 2021-2029 HOUSING ELEMENT

On Tuesday, June 23, 2020, the Sierra Madre City | 3. Identify one to two sites for very high density | approval. Council will discuss the process to update Sierra Madre's state mandated Housing Element of the General Plan for the

2021-2029 period as required by State law.

The Housing Element establishes policies and programs to address existing and projected housing needs, including the City's fair share of the Regional Housing Needs Assessment (RHNA) allocation.

Just prior to the onslaught of COVID-19 challenges, On March 10,

Director Victor Gonzalez and Karen Warner, the City's housing element consultant provided an informational presentation to

the council which included an overview of the Housing Element process, RHNA/site requirements, and consequences of noncompliance.

RHNA Process and Status

Every eight years the California Department of Housing and Community Development (HCD) re-evaluates the status of the housing market throughout the State, and develops a new set of housing production goals for the State and its subregions. These allocated housing production targets are called the "Regional Housing Needs Assessment", or RHNA. Each regional government, which in our case is the Southern California

Association of Governments (SCAG), then allocates these regional housing targets to all its member cities and counties. The process for the 6th cycle RHNA is now underway, with 1.34 million new housing units assigned to the SCAG region, representing the largest allocation the region has ever received, resulting in much higher RHNA allocations for SCAG cities and

Following adoption of the final RHNA methodology and release of the draft RHNA plan by SCAG, jurisdictions will have a 45-day period in which to appeal their numbers.

Based on SCAG's Regional Council-approved RHNA methodology, as of March 3rd, SCAG had assigned Sierra Madre a 6th cycle RHNA allocation of 204 units. While still subject to refinement based on the RHNA appeals process, Sierra Madre's current allocation is distributed among the following income categories:

6th RHNA Cycle (2021 -2029) Units Allocated to Sierra Madre **Income Category Housing Units** Very Low Income Low Income 38 Moderate Income Above Moderate 53 Total 204

The City Council has the following policy choices for the selection of Opportunity Sites:

- 1. Designate a combination of Multi-Family Residential High Density opportunity sites R3-H (20 du/acre) and R3-H (30 du/acre) including Measure V properties (requiring a public vote); or
- 2. Increase densities on all current R-3 sites from 13 du/acre to R3-H 20 du/acre (excluding Measure V Boundary properties).

(i.e. 50+ units/acre).

On March 10, 2020, Staff solicited City Council input on potential opportunity sites with appropriate densities to meet the City's RHNA allocations. Recent changes in State Housing Element law under AB 879 and AB 1397 require substantial additional analysis

to justify sites as suitable and available for development within the planning period. For example:

1. Non-vacant sites, small sites (<0.5 acres), and large sites (>10 acres) are presumed to be inappropriate for development

of housing for lower income households unless the jurisdiction can provide evidence why the sites would be

appropriate, such as statements from developers or submitted plans.

2. Vacant sites included in the prior two housing elements to accommodate lower income households, or non-vacant sites included in the prior element, cannot be used in future housing elements unless: a) the site is zoned to the minimum lower income density thresholds; and b) zoning allows for development by-right if at least 20% of units are affordable to lower income households.

3. Unless a jurisdiction has established minimum densities, site capacity calculations must be adjusted downwards based on the following factors: a) land use controls and site improvements; b) realistic capacity of site; c) typical densities; and d) environmental and infrastructure constraints.

4. Sites identified in the Housing Element that had either lower income units or a lower income occupant within the past five years must replace that housing at the same or lower income level as a condition of

Birthdays seem to be happening just about every day lately and they are all significant. Of course, many of them are celebrations of the lives of people who have graduated from here to heaven.

Flag Day, June 14th, for instance, was my father-in-law's birthday. He would have been 127 He's been gone quite a long time, but my memories of him and my mother-in-law are so good that I wanted to share a little bit of them. He was a life-long member of the Gideon's and must have given out thousands of little New Testaments in his lifetime. During WW2 he was down at the train station as the young soldiers were taken out of Los Angeles to go to war, handing out New Testaments, shaking their hands, encouraging them, and praying for them. They lived, Jay and Leila Davis, all their lives together in the home that Leila's father bought on Van Ness Avenue in Los Angeles when she and her family first moved here from Idaho when she was 14. She became a school teacher, specializing in adult education, and he worked for the County all his life. He took a walk daily in his neighborhood and was one of the people who left his world a little better than he found it, picking up trash along the way every day. I expect that the line of people who came to know Jesus as their Lord and Savior, because Jay Davis gave them the Good News, stretched for miles when he arrived in heaven to receive his crown and "well done, good and faithful servant." They loved me and all our family. I had never met people like them before, and have been grateful all my life for the day John took me to meet them and they ran out the door to meet and welcome me.

On this date (June 16) in 1933 My best friend and Walking Sierra Madre buddy, John Davis joyfully arrived on the planet!

John and I were married fifty years and his birthdays became more and more interesting as time went on because he made it very clear he didn't want any more stuff. He let me refresh his wardrobe as soon as he realized I could buy all his clothes for him and he'd never have to go in another department store again. But as far as the children were concerned, what he wanted was for them to arrange something for them to do together. Go someplace, do something. He went to air shows with Leah, helped son, John, remodel a house, went on an outing to an aircraft carrier with Patti and grandson, Blake. We flew to Texas to celebrate birthdays with Crissy and Chris, had innumerable dinners, lunches, breakfasts to celebrate and all my memories of his birthdays involve lots of laughter, flocks of family, good times and good food.

We went on a hot air balloon ride to celebrate his 40th birthday, had a belly dancer and the party of the century at our house on Alegria for his 50th. Yep, friends and neighbors, epic

I suspect his birthday in heaven today is the best one yet. Interestingly, when I opened Sarah Young's devotional book, "Jesus Calling" today, the reading was really about him and his character, ending with his life verse, Micah 6:8: "He has shown you, O man, what is good. And what does the Lord require of you? To act justly and to have mercy and to walk humbly with your God." That was pretty much how John lived. Happy birthday my one and only love! The picture today, is one of us at the July 4th parade a few years ago.

Another birthday I have to mention is my friend Margie Simon, my son-in-law, Dave's mom. On July 2^{nd} she will be 100 years old. She still maintains her own home, takes care of herself and, until Covid 19, volunteered every Monday at Cedars hospital. She is to be congratulated! 100 years old! Can you believe it!

One last thing, the cake John liked most for his birthday was apple cake so I'll pass it along to you guys.

EASY APPLE CAKE

2 cups Granny Smith apples, peeled, cored, cut in good sized chunks

1 cup sugar - Place apples in a bowl and add sugar. Let stand 30 min. (That part is really important!)

Add:

1/4 cup oil

1 egg beaten

1 tsp vanilla Blend well.

Combine:

1 cup unsifted flour 1 generous tsp. cinnamon

1 tsp. soda 1/4 tsp. salt

Stir into apple mixture.

Add 1/2 cup or so chopped pecans or walnuts. Spoon into well-greased 8" square pan. Bake at 350, 45 to 50 minutes till cake tester inserted in middle comes out clean.

Cut into squares and dust with powdered sugar. Best served warm, and it doubles and triples beautifully.



Pasadena Summer Day Camp Returns

The City of Pasadena Parks, Recreation and Community Services Department will offer summer day camp for Pasadena residents and Pasadena Unified School District students at seven parks throughout the city from Monday, July 6, through Friday, August 7.

Camp will be offered Monday through Friday at Robinson Park, Victory Park, and Villa-Parke centers from 8 a.m. until 5 p.m. for children ages 5 to 12. Half-day camps will be offered at Central, McDonald, and Washington Parks from noon until 5 p.m., and at La Pintoresca Park from 8 a.m. until 1 p.m. for children ages 7 to 12. The La Pintoresca Teen Education Center will offer teen-specific programming Monday through Friday from noon until 5 p.m. for children ages

Salvation Army **Donátion Center Burns**

Pasadena fire investigators were looking into possible arson after a Salvation Army Donation Center went up in frames Wednesday sending massive flames and smoke into the air seen for miles. Thousands of pounds of donated goods were burned.

According to Battalion Chief Bill Cuskey firefighters responded to the donation center 56 W.

Brookside Raises Golf Course Fees

The Pasadena city council approved Monday increasing fees at Brookside Golf Course citing a need to offset loses after the course closed March 19 due to COVID-19. According to city staff and the Rose Bowl Operating Company standard golf fees will be flexible and could go up to \$50 and increase as high as \$90, including golf carts, for tournaments and

Officials said this is the first time fees have increased since

"Under this model green fee rates will have the flexibility to go up or down based on direct competition without delay." City staff said. For example, if our competition raises their green fee by \$1, we can act lickly (through the RBOC Golf Committee) and decide in real time if such an increase makes sense for Brookside."

According to Darryl Dunn RBOC General Manager, "The initial goal is to achieve approximately a 3 percent increase to the green fees. This will bring us closer to market prices and help to offset Brookside's estimated 1.5 percent annual expense increase for water use, labor, etc. It should be noted that the initial rate increase will not be a uniform increase across all rate categories. Instead each rate will be evaluated, now and in the future, as it compares with the rates of the competition in the market and changed accordingly. This is especially true for protecting the youth conducted development at Brookside through the Southern California Golf Association and most notably being home of The First Tee of Pasadena."

The council also approved a \$1 Capital fee to each green fee. The new fees could bring in an additional \$135,000 for improvements on the golf complex and clubhouse. 

ARCADIA/MONROVIA-DUARTE ARCADIA AWARDS GRANTS TO SMALL **BUSINESSES IMPACTED BY COVID-19**

June 17, 2020 - The City of Arcadia recently held a lottery to award grants to 49 small businesses impacted by the COV-ID-19 pandemic. The COVID-19 Small Business Grant Program, under the new Arcadia Works! Program, is dispersing \$245,000 in Community Development Block Grant (CDBG) funds. Grants of \$5,000 each, primarily provided under the federally funded CARES Act to assist with COVID-19 relief, are being directly awarded to small businesses in Arcadia.

Hundreds of businesses applied for the grant program and the need is deep throughout the community. Recipients included the full range of business types, from small retailers, to restaurants, to spas and salons, to offices that have been in Arcadia for decades. Mayor Roger Chandler participated in the lottery with Development Services Department staff. 'The City received an overwhelming response to the CO-VID-19 Small Business Grant Program," said Mayor Chandler. "It is important that we do everything we can to support small businesses during these challenging times."

The response from the Arcadia community has been overwhelming and several grant recipients have shared their feedback. "I am looking forward to sharing the great news with our employees," said Mariza Gatdula from Arcadia Dentistry, who will be using the grant towards helping retain

"We have been a small women-owned business for over 20 years in Arcadia," said Cheryl Marino of Cake Sisters. "It is so nice to see the support the City has given small businesses during this pandemic. This grant will help alleviate some of the stress caused by the mandatory closures," she added.

"We are appreciative of the local business community's interest in the grant program, and we sincerely hope this funding is helpful in keeping these businesses active and vibrant", said Jason Kruckeberg, Assistant City Manager/Development Services Director. "The COVID-19 Small Business Grants represent a concerted effort by the City of Arcadia to provide direct relief to as many local businesses as possible and is just one of the steps the City is taking to support our small business community." In addition to the grants, the City is providing other local resources and initiatives, including business license renewal payment extensions, extension of development deadlines, business assistance ombudsman services, allowances for additional outdoor seating areas for dining, and a partnership with the Arcadia Chamber of Commerce for business outreach and marketing.

The City is hopeful that more CDBG funding will become available to be used for additional grants in the near future, and is exploring other funding opportunities as well. "We plan to keep all applications on file should future funding become available," said Mr. Kruckeberg. "I believe that this direct financial assistance is the best way to help. Unfortunately, there is no quick fix to the economic impacts of CO-VID-19 but we are here to support our business community in any way we can," he added.

SOUTH PASADENA RELEASES STATEMENT REGARDING FINANCIAL OVERSIGHT

The South Pasadena City Council responded to community input regarding the status of its financial controls at last night's public meeting. Mayor Robert Joe explained that the City Council was recently made aware of community concerns about the City's financial processes based on public comments by a former City employee. "This City Council firmly believes the community has every right to know about our financial condition, the oversight processes we now have in place, and how we are managing our resources during this very challenging period," he said. The City Council and staff continue to prepare the City budget, which must be adopted by the end of June. The Council pledged to not take action to adopt the 2020-21 fiscal year budget until the City Finance Commission fully reviews all changes made since its last review.

Related to the criticism from the former finance department staff member, Mayor Joe said, "I want to assure the community that we take these concerns seriously. Over the past few years, we have made significant changes in our procedures so that our financial record-keeping and forecasting is far more rigorous than in the past. We recognize the critical importance of having the community trust us to manage our public resources wisely, and we have taken significant steps to earn that trust."

Mayor Pro Tem Diana Mahmud, who served as the City Council's liaison to the Finance Commission during the relevant period of the City's review of the Finance Department, made the following statement:

"About three years ago, we learned of some accounting errors and deficiencies that had gone undetected for several years during previous Finance Director's and City Manager's tenures. We took immediate action to correct these issues, including conducting a forensic audit to find out exactly what happened and how it could be prevented in the future. We want to be very clear: the audit confirmed that no city funds are missing. The audit did highlight the need for process improvements and we have made them in our operations, including a reorganization of our Finance Department; stronger internal controls; and contracting out for services such as payroll and business licensing."

"We are continually examining our limited resources and have the proper tools in place to weather financial downturns the Council considers its adoption at feedback, and share comments. You expect monitoring the budget, and preparing the

City Manager Stephanie DeWolfe, who was hired by the City three years ago to bring a higher level of oversight of financial operations, spent time during the Council meeting to provide an update to the City Council and community:

"I would like to provide the Council and the community with a brief history of our financial procedures and operations, outline become even more responsible stewards of public resources, and address the points made in a recent communication from a former City staff member.

"Let's begin by noting that the community has every right to expect full disclosure and transparency regarding our financial operations, reserves, and other aspects of city management. I understand the frustration among some members of our community and welcome any opportunity to discuss our finances in detail.

"First, some background on how we got to where we are today. In late 2017, we discovered a pattern of inappropriate accounting practices and internal control deficiencies dating back several years, spanning several previous Finance Directors, which, among other things, inflated the size of the unrestricted General Fund. This same accounting issue shows up in the City's 2017/2018 Comprehensive Annual Financial Report. Staff brought the concerns to the City Council, which quickly directed staff to begin the process of investigating and determining the full extent of the problem. We immediately put into place proper protocols to correct these practices while we began detailed work to reconcile all funds. We found that the amount of funds in various categories were over- and under-stated, resulting in the unrestricted General Fund to appear larger than it really is. Very importantly though, and as the mayor (vice mayor) pointed out: we found there are no missing funds in any City account. The location where various funds were inaccurately placed was not disclosed or discussed in

"Also, since the budget was presented to the Finance Commission on May 26, there were changes made to the draft budget posted on the City website as a result of updated nongeneral fund revenue estimates provided by Los Angeles County and changes in department budgets in response to evolving Safer at Home rules. Those changes will be presented to the Finance Commission next week along with a discussion of the enhanced fiscal controls now in place. It is important to note that department budgets and revenue estimates will continue to evolve as the County permits more services and businesses to reopen. We must recognize that we are still in a very fluid environment regarding estimates and predictions. Because of this, we anticipate presenting a budget update to Council at least quarterly, and potentially more often if circumstances demand. 

ARCADIA WOMAN ARRESTED ON COMPLAINT ALLEGING SHE SWINDLED INVESTORS OF COACHELLA HOTEL COMPLEX OUT OF MORE THAN \$20 MILLION

LOS ANGELES - A San Gabriel Valley woman was arrested this morning on a criminal complaint alleging she fraudulently solicited \$21.6 million in funds for a condominium and hotel complex in the Coachella Valley, then spent a significant portion of her victims' money on her own lavish living expenses, including luxury cars, travel, and designer clothing.

Ruixue "Serena" Shi, 36, of Arcadia, was taken into custody by special agents of the FBI. She has been charged with one count of wire fraud and is expected to make her initial appearance this afternoon in United States District

According to an affidavit filed with the complaint filed Wednesday and unsealed today, between November 2015 and July 2018, Shi solicited investments for the Hyde Resorts and Residences Coachella Valley. Hyde Resorts was to be a 207-unit luxury condominium and hotel complex that was supposed to have a total of 95,000 square feet of on-site conference facilities, a pool, spa, fitness center and other amenities.

Shi was the president and owner of Global House Buyer (GHB), a China-based real estate development company, and also was CEO of the Beverly Hills-based company Hyde Morgan Development, LLC, the affidavit states. The Hyde complex was to be developed by GHB while Hyde Morgan solicited investments.

Shi contacted prospective investors in the Hyde complex – who mostly were based in China – through sales presentations she gave at hotels, radio advertisements, and through the solicitation of investments over forums on We-Chat, a Chinese messaging, social media, and mobile payment application, according to the affidavit.

Among the false representations Shi allegedly made to her victims to induce them to invest was that the Hyde development was scheduled to begin construction in 2017. Investors were told they would be purchasing condos ranging in price from \$400,000 to \$700,000, according to the affidavit. Investors were required to pay 40 percent of the total purchase price upfront as a down payment, but Shi promised that GHB would help them finance the remaining balance with loans from U.S.-based banks when the project was completed.

Chinese investors in the Hyde project were falsely told that their investments with Shi would enable them to obtain visas through the EB-5 Immigrant Investor Program, the affidavit states. EB-5 is a federal program that allows foreign investors to secure a U.S. visa by investing a large sum of money to finance a business in the United States that employs American workers. One victim told law enforcement that Shi told her that Shi would procure a long-term visa for her through the EB-5 Program if she invested \$500,000 in the Hyde project, the affidavit states.

Shi also allegedly told investors that GHB had purchased a 47-acre lot of land in Coachella Valley where the Hyde development was to be built. In reality, Shi purchased only 20 acres of that property, the affidavit states. Shi also falsely told investors that GHB had obtained the required city development approvals for the Hyde development, which included the re-zoning of the land she purportedly had purchased, when no such approvals had been given.

When some victim-investors began demanding refunds after hearing GHB no longer was in operation in the United States, Shi allegedly offered them partial refunds if they signed a contract purporting to prevent them from disclosing they had received the refund. She also allegedly sent investors phony photographs purporting to be of construction that was underway. In truth, GHB never began construction on the Hyde development and never purchased the entire plot of land where the development was to be built, the affidavit states.

Bank records allegedly show that Shi transferred the victims' funds to her personal accounts and then misappropriated a significant portion of victims' money for her own expenses. For example, she allegedly used \$2.2 million of investor money to pay a company that provided luxury travel and concierge services, nearly \$295,000 to purchase two Mercedes-Benz automobiles, and hundreds of thousands of dollars to buy clothes, restaurant meals, and hotel stays in Beverly Hills, France, Thailand and China.

A complaint contains allegations that a defendant has committed a crime. Every defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt.

If convicted, Shi would face a statutory maximum sentence of 20 years in federal prison.

The FBI investigated this matter. This case is being prosecuted by Assistant United States Attorney Alexander C.K. Wyman of the Major Frauds Section.

LOS ANGELES COUNTY **COVID-19 UPDATE**

LOS ANGELES - The Los Angeles Coun- | as possible for employees, customers and ty Department of Public Health (Public Health) has confirmed 36 new deaths and 1,051 new cases of 2019 Novel Coronavirus (COVID-19). Twenty-six people who died were over the age of 65 years old, seven people who died were between the ages of 41 and 65 years old, and one person who died was between the ages of 18 and 40 years old. Thirty-one people had underlying health conditions including 25 people over the age of 65 years old and six people between the ages of 41 to 65 years old. One death was reported by the City of Long Beach and one death was reported by the City of Pasadena.

To date, Public Health has identified 78,227 positive cases of COVID-19 across all areas of LA County, and a total of 3,027 deaths. Ninety-four percent of people who died had underlying health conditions. Of those who died, information about race and ethnicity is available for 2,807 people (99 percent of the cases reported by Public Health); 42% of deaths occurred among Latino/Latinx residents, 29% among White residents, 17% among Asian residents, 11% among African American residents, less than 1% among Native Hawaiian/Pacific Islander residents and 1% among residents identifying with other races. Upon further investigation, 13 cases reported earlier were not LA County residents. There are 1,429 people who are currently hospitalized, 29% of these people are in the ICU and 22% are on ventilators. Testing capacity continues to increase in LA County, with testing results available for nearly 868,000 individuals and 8% of people testing positive.

A modified Health Officer Order and directives for the reopening of additional businesses is being issued today with an effective date of June 19. The Health Officer Order will allow for the following sectors to reopen once they implement the required protocols for infection control and distancing:

Cardrooms, satellite wagering facilities and racetracks with no spectators

Personal care services including: esthetician, skin care and cosmetology services; electrology; nail salons; body art professionals, tattoo parlors, microblading and permanent make-up; and piercing shops; and massage therapy

Bars, wineries, breweries and tasting rooms

The Health Officer Order contains protocols for all businesses that are permitted to reopen to ensure it is done as safely residents. Employees and visitors to these businesses will need to wear a cloth face covering when around other people and practice physical distancing of at least 6 feet at all times. Some employees may be required to wear face shields. It is important for everyone to follow the directives and to do their part every day to keep everyone as safe as possible. Businesses should take the time to put all of the protocols in place before reopening. The directives will be available online and are contained in sector-specific protocols that inform all re-openings.

To the many families who are mourning loved ones lost to COVID-19, please accept our heartfelt sympathies," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "COVID-19 has impacted everyone across the county, and we are all feeling exhausted by the safety requirements, yet we still have to find it within ourselves to do our part to protect each other from the spread of the virus. As more sectors re-open, we risk losing all the progress we have made in slowing the spread, if we don't take every precaution possible to prevent exposing others and ourselves to the virus.'

Because this virus is still easily transmitted among people in contact with each other, the best protection against COVID-19 continues to be to wash your hands frequently, avoid touching your eyes, nose, and mouth with unwashed hands, selfisolate if you are sick, practice physical distancing, and wear a clean face covering when in contact with others from outside your household. It's important if someone thinks they could be positive for COV-ID-19 and are awaiting testing results, to stay at home and act as if they are positive. This means self-isolating for 10 days and 72 hours after symptoms and fever subside, or until they receive a negative result. If a person tests positive for COVID-19, they should plan on receiving a call from a contact tracer to discuss how to protect themselves and others, to find out where they may have been, and who they were in close contact with while infectious. People who have underlying health conditions remain at much greater risk for serious illness from COVID-19, so it will continue to be very important for the County's vulnerable residents to stay at home as much as possible, to have groceries and medicine delivered, and to call their providers immediately if they have even mild symptoms.

All Things By Jeff Brown

In 1955,14 year old Emmett Till of Chicago was visiting family in Mississippi when he was kidnapped by a group of white men who accused him of flirting with a white woman. They beat him bloody, gouged out his eye, shot him in the head, mutilated his body, and dumped it in the Tallahatchie River. (The men were later acquitted) His mother chose to have an open -casket viewing, and to let Jet, an African American magazine photograph his son's brutalized remains." It forced America to see for the first time what American racism actually looked like, " said Benjamin Saulsberry, director of the Emmett Till Interpretive Center in Mississippi. That image, and the shame and disgust it evoked. launched the civil rights era. Years of sitins, protests, and confrontations with police finally toppled Jim Crow segregation, and culminated in the Civil Rights Act of 1964. And now, after Americans watched a kneeling white police officer nonchalantly crush the life out of George Floyd, we have come to another Emmett Till moment-a reckoning period. The passionate, multiracial protest that has filled the streets of more than 1000 U.S. cities and towns will not end racism. But as Mahatma Gandhi taught, shame and moral revulsion can be powerful weapons against oppression. In the past week, we have seen police chiefs taking a knee with Black Lives Matter protesters. Cities and Congress are moving towards major reform of policing . A near-insurrection broke out among current and retired generals after President Trump sought to bring in active-duty troops to "dominate" the protestors, a la Tiananmen Square. Confederate statues and flags are finally coming down. In a Monmouth University poll 76% of Americans called racism "a big problem" in the U.S.-up 26 points since 2015. No one can unsee the knee on George Floyd's neck, or unhear his cry, "I can't breath". Change is slow, and change is wrenching but change is coming .William Falk Editor-in-Chief "The Week"

When you're in a restaurant eating with a friend, it's a multi-sensory experience that feeds our need for social interaction. We're all social creatures," she says enthusiastically.

"I think that people go to musical performances for something more than just the music," she explains. "People want a sense of community. They want to be a part of something."

Fuller is also a theatre arts teacher for the LA Unified School district, though all classes have been on-line the last few months, with no direct social interaction. In the past, she has even involved her students with her public performances.

Fuller has produced four CDs, including "Night and Day," "You're Coming Back Again," and a Christmas CD called "The Spirit of Giving." Her most recent CD is called "Someone to Listen." Her music can be purchased at CDbaby.com.

Fuller began to play the guitar at age 10, when the folk music trend invaded the Catholic Church and Masses included guitars. "One of the girls at school showed me a few chords, and I had to learn quickly," she says. Fuller explains that she had a strict nun in 5th grade who pushed her into leadership positions in stage, and in organizing the music for Mass. "I had to deliver for God," she says with a laugh. "I had to learn the new songs for church, and this drove me to improve my guitar playing.

Fuller went to Alverno High School, and took classes at Pasadena City College. "I studied under Bobby Bradford at PCC and learned a lot about blues and jazz. I really learned a lot from him," she emphasizes.

She earned a bachelors degree in Creative Writing and Literature at UC Santa Cruz, and a degree in theatre arts from the American Academy of Dramatic Arts.

She has lived in Sierra Madre since 2004, and has long felt a part of this community, from her high school days at Alverno, to teaching at Saint Rita's, and to her many musical performances.

She believes that part of her mission as a musician is to support local businesses. "It's so much more than just supporting a business," she explains. "A successful business brings in people, and the people are uplifted and come together. This creates a sense of community, and it's really just like growing a garden. But in this case, the "fruit" of that garden that a healthy community produces are the people with naturally healthy immune systems."

This show on June 27 will be dedicated to longtime Sierra Madre resident Barry Schwam, who performed at Sierra Madre playhouse for years, who recently passed away from cancer. 

WHY HIGH BLOOD PRESSURE IS EVEN MORE DANGEROUS IN THE COVID-19 ERA

Dear Savvy Senior: Are people with high blood pressure at increased risk of getting coronavirus? Hypertensive Helen



Dear Helen:

If you have high blood pressure, you definitely need to take extra care to protect yourself during the coronavirus (COVID-19) pandemic. Research shows that people with hypertension are more susceptible to getting COVID-19, are more likely to develop severe symptoms if they do get sick, and are more likely to die from the infection, especially if they're older.

A weaker immune system is the key reason people with high blood pressure and other health problems are at higher risk for coronavirus. Long-term health conditions and aging weaken the immune system so it's less able to fight off the virus. Nearly two-thirds of Americans over 60 have high blood pressure.

Another concern that has been circulating, but was put to rest last month, were theories that the medications that are commonly prescribed to treat high blood pressure – ACE inhibitors and angiotensin receptor blockers (ARBs) - could make patients more vulnerable to contracting CO-VID-19, and more susceptible to severe illness if they did become infected.

But new research published in The New England Journal of Medicine last month found no risk linked to these medications.

COVID Complications

While pneumonia is the most common complication of the virus, it can also damage the cardiovascular system. That's why people with high blood pressure, heart disease, and heart failure are

High blood pressure damages arteries and reduces the flow of blood to your heart. That means your heart has to work harder to pump enough blood. Over time, this extra work can weaken your heart to the point where it can't pump as much oxygen-rich blood to your body.

Coronavirus can also damage the heart directly, which can be especially risky if your heart is already weakened by the effects of high blood pressure. The virus may cause inflammation of the heart muscle, which makes it harder for the heart to pump.

If you also have plaque buildup in your arteries, the virus may make those plaques more likely to break apart and cause a heart attack. Studies have shown that people with heart disease who get a respiratory illness like the flu or earlier types of coronavirus are at higher risk for a heart attack.

What to Do?

While everyone needs to take precautions to prevent coronavirus, people with high blood pressure and other health conditions need to be extra careful.

The best way to avoid getting sick is to stay home as much as you can. If you have to go out, wear a mask and keep at least 6 feet away from other people. And every time you come home, wash your hands with warm water and soap for at least 20 seconds. Also, clean and disinfect all frequently touched surfaces like cell phones, countertops and doorknobs.

The CDC also recommends that you have enough medicine on hand to treat high blood pressure and other health conditions. And stock up on over-the-counter medicines to treat a fever and other symptoms if you get sick.

While a coronavirus vaccine isn't available yet, you should stay up to date on your other important vaccines. The pneumococcal vaccines - Prevnar 13 and Pneumovax 23 - will prevent you from catching pneumonia on top of coronavirus. Also get a flu shot in September or early October. Its symptoms are easy to confuse with coronavirus, which could make it harder for doctors to diagnose you if you do get sick.



GOP JOINS BIG COMPANIES IN PUSH FOR MORE IMMIGRANTS

If a contest were held to name the visas most hurtful to American workers among the 25-odd federally issued ones that include employment authorization, the likely outcome would be a tie. The overwhelming majority of employment-based visas mean that an American job will be lost to a foreign national or that a qualified U.S. candidate will be denied job opportunities because craven employers have such easy access to the cheap labor that visa holders provide.

Even visas that specifically deny employment are illegally and fraudulently substi-

tuted for work permits. Infosys Limited, an Indian outsourcing company, hired B-1 visa holders to perform skilled and unskilled labor that denied chances to Americans even though that visa is designated for temporary entry only. An estimated 1 million Indian nationals – predominantly lawful, white-collar IT workers – prevent American citizens from obtaining gainful employment.

Recently, President Donald Trump has been making noise about extending his April 22 immigration Executive Order to ban several employment-based visa categories from entry, at least for the immediate future. So far, nothing has come from the president's ramblings, and rumors of further restrictions may be just more Trumpian smoke and mirrors.

Nevertheless, Capitol Hill chatter persists that the president's expanded proclamation could bar U.S. entry for H-1B, H-2B, L-1 and J-1 visa applicants. Those visa categories represent, respectively, H-1B tech workers, H-2B seasonal nonagricultural workers, L-1 international transfers and J-1 Exchange Visitor programs that include au pairs, summer work-travel participants and interns, as well as high school and university student exchanges, and medical professionals.

Trump's premise that more foreign nationals entering the devastated U.S. economy represents "a risk" is indisputable. After all, more than 40 million Americans are jobless, and their prospects are dim. The National Bureau of Economic Research estimates that more than 100,000 small businesses have closed forever. The economy is slowly reopening, but only at partial capacity. Even though the 40 million-plus total and the brutal reality that the U.S. is facing one of its most devastating economic turndowns are inarguable facts, immigration advocates and congressional globalists aren't fazed one iota.

The Fortune 500 lobby wrote a whiny letter to Trump and the departments of Labor, State and Homeland Security, signed by 324 employers, trade, industry and higher education associations, including profiteers Google, Facebook and Amazon. Collectively, the lobbyists pleaded with the president to keep their incoming cheap labor stream flowing, arguing ineffectively and insultingly that "constraints on our human capital are likely to result in unintended consequences and may cause substantial economic uncertainty if we have to recalibrate our personnel based on country of birth." In other words, if visas are put on hold, U.S.-based corporations would actually have to -perish the thought – hire Americans.

Given that Congress should be defending Americans, 21 GOP House Representatives shamefully joined forces with the Fortune 500 lobby when they sent a separate, supportive letter defending the presence of foreign nationals, specifically those who are part of the Optional Practical Training program. Never congressionally approved, OPT is one of the largest displacers of American tech workers. OPT includes thousands of graduates annually, and sidelines an equal number of American job aspirants.

Welcome to the world of immigration politics! No intelligent argument can be made that within the U.S. au pairs, landscapers, lifeguards and bookkeepers can't be found, especially in this wrecked economy. Most of those jobs would be ideal for high school or college students that have recently graduated but are unemployed. The J-1, H-2B and L visas have devastated those employment categories. Even America's medical school graduates, more than 35,000, have lost out on residency positions, without which they can't practice as physicians because international graduates have entered the country to fill those jobs.

In 2017, a political eternity ago, Trump signed an executive order, "Buy American and Hire American," intended to generate higher wages and greater opportunities for U.S. workers. Today, the president has a chance to take a big step forward toward reaching that goal. For Trump, now is put-up or shut-up time. The president must reject the immigration lobby's shallow pleas, and keep his promise to put Americans first.






