MISSION ACCOMPLISHED! SIERRA MADRE FIRE DEPARTMENT ACCEPTED INTO UNIFIED RESPONSE IN THE VERDUGO FIRE SYSTEM

On July 1, 2020 the City of Sierra Madre Fire Department was accepted as a participating member for Unified Response in the Verdugo Fire system. The Verdugo Fire system is comprised of 13 fire departments that operate under a single automatic aid agreement. When an emergency call is received at the Verdugo dispatch center, the closest available fire apparatus responds to the incident, regardless of jurisdiction.

"Congratulations to Interim Chief Bartlett and the entire Sierra Madre Fire Department for this historic achievement!" said Mayor John Capoccia. "I'm very proud of their hard work and dedication to prove to the members of the Verdugo agency that we were up to the task. Sierra Madre residents should also be very proud and secure knowing that we've achieved this long-time goal."

Sierra Madre has been a member of the Verdugo system since 1999, but has not been included in automatic aid and unified response due to its status as a volunteer agency. The Sierra Madre City Council established a goal in 2017 to transition from a volunteer fire department to a career department in order to be accepted into unified response.

"Sierra Madre is safer, as are Sierra Madre's neighbors, due to our acceptance into borderless response." said City Manager Gabriel Engeland. "I would like to thank our Interim Fire Chief Brent Bartlett, and the men and women of the Sierra Madre Fire Department, as well as our past Chief Kurt Norwood and Chief Steve Heydorff. Without their commitment and hard work, we would not have achieved the City Councils goal of being accepted into automatic aid with our peer agencies."

Retired Fire Chief Heydorff offered his sincerest congratulations to City Manager, Gabe Engeland, the Fire Department and especially, to the residents of Sierra Madre. Said retired Fire Chief Stephen Heydorff, "inclusion into Unified Response has been a goal of the Fire Department since Sierra Madre joined the Verdugo Dispatch System in 1999. Every decision made on the direction of the Department was made to complete that goal. Thank you, to all of the past and present members for their hard work, personal sacrifices and hours of training."

The Sierra Madre Fire Department has a proud and storied history extending back to 1921, and the infamous "Sierra Madre Bakery Fire". After the fire, Sierra Madre residents saw the need for a local department and the Sierra Madre Volunteer Fire Department was established. The Sierra Madre Volunteer Fire Department was the last volunteer department in operation in Los Angeles County when the transition to a career department was completed.

"I am so proud of our Fire Department, and so grateful for all the support we have received. The inclusion in to Unified Response with in the Verdugo System is going to greatly enhance the level of service afforded to our community. The members of your Sierra Madre Fire Department vow to continuously provide quality service through the utmost professionalism," said Interim Chief Bartlett

Pasadena **Transit Again** Suspends Fare Collection



In light of the recent rise in COVID-19 cases, fare payment will continue to be suspended on both Pasadena Transit and Pasadena Dial-A-Ride. When the Safer at Home order was issued in mid-March, Pasadena Transit and Dial-A-Ride instituted a number of protocols to provide the safest environment possible for customers and bus operators, including suspending fare collection. After a trial day of resuming fare payment on July 1, fare collection will continue to be temporarily suspended to avoid customers being in close proximity to drivers. Customer boarding will also continue to be from the rear doors of buses wherever possible.

In addition to the temporary suspension of fares, other actions that have been in place on Pasadena Transit and Pasadena Dial-A-Ride since mid-March, include:

Limiting the number of passengers per bus; Increased frequency of buses

on the most heavily used Disinfecting high-touch

surfaces on buses frequently throughout the day; Enhanced nightly disinfecting

of every bus surface from floor to ceiling; Blocked off select seating on

buses to encourage physical distancing; and

Allowing only rear-door boarding where possible.

Also, in accordance with the City of Pasadena health order, passengers must wear clean cloth face coverings over their noses and mouths while on board a Pasadena Transit or Dial-A-Ride vehicle. Drivers are wearing face coverings, and we ask that you also help keep your fellow transit riders and bus operators safe by wearing one too.
Pasadena Transit operates

six local bus routes within the City of Pasadena, as well as portions of the unincorporated community of Altadena, serving nearly 400 bus stops and six Metro L Line (Gold) stations. Route, fare and schedule information is available at www.pasadenatransit.net or by calling (626) 744-7311.

Now Accepting Permit Applications

The City of Pasadena Film Office reopened Tuesday and began accepting permit applications for commercial production filming and still shoots within Pasadena city limits.

Film Office guidelines have been updated to adhere to public health protocol and reduce the risk of COVID-19 transmission. All proposed film and photography permit applications must abide by the City's Public Health Reopening Protocol for Music, TV and Film Production, as well as these special conditions:

The production/applicant must comply with all federal, state and local public health requirements, including the appointment and identification of a COVID-19 compliance manager.

The number of persons allowed to gather on site must conform to physical distancing requirements outlined in the Health Officer Order.

Filming in residential areas is to occur between the hours of 7 a.m. and 7 p.m. This includes set-up and breakdown.

Filming in commercial areas is to occur between 7 a.m. and 7 p.m. This includes set-up and breakdown.

Parking is only allowed on property and directly in front of a location with a minimum street width of 35



Yep, today is the 4th of July and normally, we'd all be downtown lined up for the parade and gearing up for all the festivities in the park but this year we're going to concentrate on decorating homes and businesses and hoping to win one of the prizes the Sierra Madre 4^{th} of July Committee has planned. I know my friend, Celia, has done up her house like the rest of us wish we could, but she's a decorator so...no wonder.

If you haven't bought the really terrific July 4th t-shirt yet, you need to. It was designed by local resident, Matt Moran, who was a Sierra Madrean even before he arrived on the planet and, obviously, loves our town. Matt attended



Sierra Madre Community Nursery School, and Gooden School before moving on to Flintridge Prep and Claremont McKenna College. Seeing as how you're going to be home more the next few days that you usually are, how would you like to learn how to make Bread & Butter Pickles? First, a little story...

When I was a young bride, my sister-in-law, Gloria, and her husband, John's brother, lived in Agoura, which wasn't all that close to Sierra Madre, but she was a lot of fun, and our kids and their kids were very close cousins and we always had a great time out there. They had horses, a buffalo, goats, dogs, and assorted other wildlife and we could count on at least one kid needing band-aids sometime during the course of the day.

She taught me to make these pickles, my first canning experience, by the way. They're easy to make, just a little time consuming, but they are incredibly delicious and if you give someone a jar of them, they will be grateful forever and beg you for more.

15 cucumbers, sliced about 1/4" thick or thinner, cut them the way you like them. (No, don't peel them!)

4 onions, sliced, fairly thin (yes, agony on the eyes)

1 or 2 green peppers, chopped in strips (or a red one, or a yellow one – makes for great color)

1 clove garlic 1/3 cup salt

2 cups sugar

1 tsp. turmeric 1 tsp. celery seed

2 cups white vinegar

Put cucumbers, onions, peppers, garlic and salt into a large bowl. Cover with ice. Let stand 3 hours Drain

Combine remaining ingredients and add to the cucumber mixture. Heat just to boiling.

Seal in sterilized jars. Be sure the brine covers all the pickles in the jar. Process in boiling water bath about 10 minutes. Makes 9 pints. These look fabulous and taste better than anything you can buy in the market. 



Thank you for your patience as we continue to work together in service of our community.



HOT DOGS AND THE SPIRIT OF 4TH OF JULY

With the restaurants closed or here in Sierra Madre offering al fresco dining I know we'll be eating a ton of hot dogs, how many?

Over seven billion hot dogs will be eaten by Americans between Memorial Day and Labor Day. During the July 4th weekend alone (the biggest hot-dog holiday of the year), 155 million will be downed.

Every year, Americans eat an average of 60 hot dogs each. They are clearly one of the country's most loved, but most misunderstood, comfort foods.

Like most great events in History, there are varying accounts of how it all began and who started it. The history of the Hot Dog is no different. You will find many references throughout history to the origins of a Hot Dog-like thing called a sausage. Here are some stories of how the Hot Dog was born.

The invention of the Hot Dog, is often attributed to the 1904 Louisiana Purchase Exposition. However, similar sausages were made and consumed in Europe, particularly in Germany, as early as 1864, and the earliest example of a hot dog bun dates to New York City in the 1860s. German immigrants appear to have sold hot dogs, along with milk rolls and sauerkraut, from pushcarts in New York City's Bowery during the 1860s. The Hot Dog's association with baseball also predates the 1904 World's Fair. Chris von der Ahe, owner of the St Louis Browns, sold Hot Dogs at his ballpark in the 1880s.

Who's Served the First Hot Dog? Also in doubt is who first served the first Hot Dog. Wieners and frankfurters don't become Hot Dogs until someone puts them in a roll or a bun. There are several stories or legends as to how this first happened. Specific people were have been credited for for supposedly inventing the Hot Dog. Charles Feltman and Antonoine Feuchtwanger were among the few.

What's in a name? Another story that riles serious hot dog historians is how term "Hot Dog" came about. Some say the word was coined in 1901 at the New York Polo Grounds on a cold April day. Vendors were hawking hot dogs from portable hot water tanks shouting "They're red hot! Get your dachshund sausages while they're red hot!" A New York Journal sports cartoonist, Tad Dorgan, observed the scene and hastily drew a cartoon of barking dachshund sausages nestled warmly in rolls. Not sure how to spell "dachshund" he simply wrote "hot dog!" The cartoon is said to have been a sensation, thus coining the term "hot dog." However, historians have been unable to find this cartoon, despite Dorgan's enormous body of work and his popularity.

1893 - The 1893 Chicago World's Fair, also called the Columbian Exposition, brought thousands of visitors who consumed large quantities of sausage sold by vendors. People liked this food that was easy to eat, convenient, and inexpensive.

Historians, to this day, have not found any research to back up the claim that hot dogs were sold at Sportsman's Park.

Truly, "Necessity is the Mother of invention." = hot dog bun

The popularity of the hot dog and baseball – I know this may be very difficult for some Dodger fans but the love of the hotdog and baseball did not start with the Dodgers.

Joel Rosario had gone back East for a year. Among his 38 wins, was on Raging Bull in the "Shoemaker Mile", his first day back!



NASA's ASTER Sees Arizona's Bighorn Fire Burn Scar From Space



On the night of June 5, a lightning strike started the Bighorn Fire in the Santa Catalina Mountains north of Tucson, Arizona. Extremely dry vegetation and windy conditions caused the fire to spread quickly. By June 30, the multi-agency incident information system, InciWeb, reported that it had ballooned to more than 114,000 acres and that it was about 45% contained.

NASA's Advanced Spaceborne Thermal Emission and Reflection Radiometer (ASTER) instrument aboard the Terra satellite imaged some of the burned area on June 29. In this image, vegetation is shown in red and burned areas appear dark gray. It covers an area 20 by 30 miles (33 by 48 kilometers).

Efforts to contain the fire continue with 21 hand crews, 10 helicopters and dozens of fire engines deployed to the area. Smoke impacts to surrounding communities are being carefully monitored.

With its 14 spectral bands from the visible to the thermal infrared wavelength region and its high spatial resolution of about 50 to 300 feet (15 to 91 meters), ASTER images Earth to map and monitor the changing surface of our planet. It is one of five Earth-observing instruments launched Dec. 18, 1999, on Terra. The instrument was built by Japan's Ministry of Economy, Trade and Industry. A joint U.S./Japan science team is responsible for validation and calibration of the instrument and data products.

The broad spectral coverage and high spectral resolution of ASTER provides scientists in numerous disciplines with critical information for surface mapping and monitoring of dynamic conditions and temporal change. Example applications are monitoring glacial advances and retreats; monitoring potentially active volcanoes; identifying crop stress; determining cloud morphology and physical properties; wetlands evaluation; thermal pollution monitoring; coral reef degradation; surface temperature mapping of soils and geology; and measuring surface heat balance.

The U.S. science team is located at NASA's Jet Propulsion Laboratory in Southern California. The Terra mission is part of NASA's Science Mission Directorate, Washington.

2020 Census Operational Adjustments Due to COVID-19

The 2020 Census is underway, and more than half of the households across America have responded and more are responding every day. Online, phone, and mailed self-responses will continue throughout the data collection process. In light of the COVID-19 outbreak, the U.S. Census Bureau has adjusted 2020 Census operations in order to:

- Protect the health and safety of the American public and Census Bureau employees.
- Implement guidance from federal, state, and local authorities regarding COVID-19.
- Ensure a complete and accurate count of all communities.

The Office of Management and Budget and the Office of Personnel Management have provided federal agencies with guidelines for resuming operations on an epidemiologically sound, data-driven basis, adhering to the latest federal, state, and local guidance. The Census Bureau

continues to monitor the changing conditions at the state and local level, and in consultation with the appropriate officials, update its planned start dates for selected operations in selected states.

The information the Census Bureau receives daily from FEMA and state and local authorities guides Census Bureau decisions on timing. As a result, selected field operations will resume on a phased schedule on a geographic basis.

Under the adjusted 2020 Census operational plan, the Census Bureau is conducting a series of preparatory activities so we are fully ready to resume field activities as we continue to advance the mission of the 2020 Census to ensure a complete and accurate count. In-person activities, including enumeration, office work, and processing activities, will always incorporate the most current guidance from authorities to ensure the health and safety of the public and Census Bureau employees

LOS ANGELES COUNTY COVID-19 UPDATE 7/03/2020

COVID-19 Deaths and Hospitalizations Increase: Residents Urged to **Avoid Unnecessary Public Contact**

"We mourn with all the families that have lost loved ones to COVID-19. You are in our thoughts and prayers every day," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "Unfortunately, we continue to see negative trends in the data and we urgently need to make a change in the trajectory. We must make sure we are not unnecessarily spending time outside with others and use this opportunity as a countywide reset. We need everyone's help. Please avoid contact with other people who are not part of your household, wear your face covering when out and about and wash your hands frequently."

As we head into the 4th of July weekend, Public Health reminds everyone that all events and gatherings unless specifically allowed by the Health Officer Order remain prohibited. Please enjoy your weekend with your household only. If you do go out, Public Health urges everyone to avoid the Three C's: Crowded places, Confined spaces and Close contact with others not in your household. Everyone should always wear a face covering securely over your nose and mouth and keep six feet apart from others not in your household when out in public. Businesses must continue to follow Public Health directives.

Public Health updated the gym and fitness center protocol in the Health Officer Order issued yesterday to require patrons to wear a mask and gloves at all times at fitness centers. Fitness center patrons are warned to not extend themselves to a point where they can't breathe comfortably while wearing a face covering over both their nose and mouth at all

The Order requires the closure of:

Indoor, in-person dining at restaurants

Indoor museums, indoor children's museums, and indoor operations at zoos and aquariums

Cardrooms and satellite wagering facilities

Bars remain closed, however retail operations for breweries, brew pubs, and wineries may remain open.

The Health Officer Order also requires businesses with three or more known cases of COVID-19 within the workplace over the span of 14 days, to report the outbreak to the Los Angeles County Department of Public Health (Public Health). Employers who have one known case within the workplace must have a protocol that requires that person to self-isolate at home and anyone exposed to self-quarantine.

LA County beaches are closed from July 3 through July 6 at 5:00 a.m. to prevent crowded situations that could result in more spread of COVID-19. All public beaches, piers, public beach parking lots, beach bike paths that traverse that sanded portion of the beach, and beach access points will be temporarily closed to the public. Fireworks displays are also

Of the 55 new deaths, 40 people who died were over the age of 65 years old, 11 people who died were between the ages of 41 and 65 years old, and one person who died was between the ages of 18 and 40 years old. Forty-five people had underlying health conditions including 36 people over the age of 65 years old, eight people between the ages of 41 to 65 years old, and one person between the ages of 18 to 40 years old. One death was reported by the City of Long Beach and two deaths were reported by the City of Pasadena.

To date, Public Health has identified 107,667 positive cases of COVID-19 across all areas of LA County, and a total of 3,454 deaths. Ninety-three percent of people who died had underlying health conditions and 7% did not. Of those who died, information about race and ethnicity is available for 3,209 people (99 percent of the cases reported by Public Health); 43% of deaths occurred among Latino/Latinx residents, 27% among White residents, 16% among Asian residents, 11% among African American/Black residents, less than 1% among Native Hawaiian/Pacific Islander residents and 1% among residents identifying with other races. Upon further investigation, 44 cases and three deaths reported earlier were not LA County residents. Testing results are available for over 1,133,000 individuals, with 9% of people testing positive.







CITRUS COLLEGE BOND REFINANCING TO SAVE COMMUNITY MILLIONS IN FUTURE TAXES

Glendora, Calif. Local taxpayers are estimated to save over \$/./ million after the Citrus Community College District Board of Trustees recently approved a plan to refinance outstanding voter-approved general obligation bonds. Earlier this month, board members voted to take advantage of the nation's current low interest rate environment by refinancing portions of the district's Measure G



bonds. These bonds, which were originally issued when interest rates were higher, will now be refinanced at current market rates. As a result, the remaining repayment period of the refinanced bonds will now be reduced by five years and property tax assessments will be lower over the long term.

"When voters approved Measure G in 2004, it was a pivotal moment for Citrus College. We want to assure community members that their investment has been a wise one, and that the district has taken great care to prudently manage resources," said Dr. Geraldine M. Perri, superintendent/president of Citrus College. "While the bond refinancing does not directly impact the college's own finances, it will be beneficial to those residents who have continuously supported our mission of providing quality educational experiences

that lead to college completion and student success." This will be the third time that Citrus College has refinanced Measure G bonds, with previous refinancing taking place in 2013 and 2015. As a result, the cumulative combined estimated savings to taxpayers is nearly \$15 million.

"With interest rates currently near an all-time low, this is a great opportunity to save money for our taxpayers," explained Claudette Dain, vice president of finance and administrative services at Citrus College. "We always strive to be good stewards of district and community resources."

Nearly 16 years ago, local residents invested in the future of Citrus College students when they voted to support the \$121 million Measure G general obligation bond. Since that time, many capital improvements have been made on the Citrus College campus. Completed construction projects include the Campus Safety Building, Mathematics/Sciences Building, Center for Innovation, Technician Development Center, Student Services Building and Visual Arts Building. The remaining Measure G funds are earmarked for the Educational Development Center modernization project.

"As the college prepares to begin work on the final Measure G project, the board of trustees and the college community continue to be grateful to our partners and neighbors who supported this bond, thus allowing Citrus College to complete a number of capital improvement projects," said Dr. Patricia A. Rasmussen, president of the Citrus Community College District Board of Trustees. "I am happy that this refinancing enables us to give back to our community."

The Meaning of Life vs. Virus Protection

Tony Brown (of Tony Brown's Journal on public TV) once stated that "if it seems that I'm placing a high priority on the need to have money, it's because I consider it as valuable as oxygen." His discussion program was all about the need especially for black families to do whatever it takes to increase their cash flow in order to elevate their overall quality of life.

He was encouraging his audience to start their own businesses, and buy their own homes.

Tony Brown made me think deeply about money. I grew up in a lower middle class neighborhood in a big family. Whenever I, or any of my brothers, asked my mother if we could do something, she'd nearly always say, "Yes, just go out and earn the money so you can do it." We learned all the legal ways to hustle and earn money to buy a bicycle, or go on a trip. Our basic needs were always met by two working parents, and I've learned to live frugally life-long. But I have never been desperate due to low income, or no income, or social discrimination that would inhibit my ability to work and be a part of my society.

Tony Brown pointed out that he was not just talking "economically." When we have a job and work for income, we turn our time, our life, into a medium of exchange (i.e., "money") which we then use to create a meaningful life. The life that money can provide gives families the means to have a home around which the family can gather, the means to live a healthy life, and the means to get an education that allows one to create the job and career that gives life meaning.

In other words, the ability to earn income in our society relates to the ability to live a quality life, and all that that

Thus, more to my point, it is a false argument when people say that we should not "re-open" our economy, but we should keep most things closed for the presumed health reasons. One such proponent for the "stay closed" scenario is Bill Gates, who is openly pushing for everyone to get vaccinated. (Hey, is it true that Gates is heavilyinvested in vaccines?)

"You care more about money than people," one old-time friend challenged me.

"You're wrong," I told him emphatically. I told him that I care deeply about the total health of people: mental, spiritual, physical, and psychological health. I think it is a false idea that you must choose one over the other.

A man or woman who works at a job they love tend to have a good immune system to fight disease. They wake up looking forward to something, hopeful for the future. It's not just a job where they earn something for their labor. For most people in western societies, it is the idea that their life serves a purpose, while interacting with others and keeping busy.

Such a mental and psychological posture impacts the health of the body. Someone who is happy, who laughs, who has hope, who strives to get up in the morning, has a better immune system than someone who is gloomy, fearful, desperate, worrying, forlorn, wondering when their government check will arrive because the government won't

Yes, I know that various surveys have shown that so many Americans hate their jobs, but they would still rather work than not work, and have the ability to find another job that suits them better.

I have so, so many questions about the reasoning behind why some businesses were told to close, and others allowed to stay open. I wonder, for example, why golf courses were told to close. Don't the spaced-out conditions of the golf course seem like the least-likely place to spread a virus? And you can't sell clothes, but if you have a dry cleaner, you can stay open and clean clothes. Churches, temples and mosques are forboden, but liquor stores are considered "essential." Really?

My preference is that government entities stick to governing, and medical authorities stay out of politics, and rather than constantly talking about vaccines that may or may not work once they get developed, if they get developed, they should talk loudly about doing all the things that improve our immune system! That's right! Rather than discuss the drug of the week, what about getting into the sun, exercising, taking vitamins, sleeping well, finding ways to feel happy and uplifted, and improving our diets so that our food helps our immune systems? Isn't that the sort of thing that medical authorities should be telling us at this time?

With suicide rates up in the last two months and mental depression at a high, don't world leaders grasp that this is not about money vs. health? You see, to the fire inspector, the whole world is about fire safety, and everything else is subservient to that goal. Things such as wildlife homes, oxygen production, aroma, beauty, vibrant gardens, permaculture, et al, are less than meaningful concepts. Everything is about fire-safety.

I fear that in the zeal to protect people from the novel Covid virus, our "leaders" have become that fire inspector, with the belief that everything is suddenly subservient to the goal of virus protection and reduction, even those things that strengthen our immune systems and give us reasons to live. I fear that our "leaders" have become like the medieval doctors, who giddily declared, "The surgery was a success, but the patient died."

VIDEO CALLING SOLUTIONS FOR TECH-CHALLENGED SENIORS

Can you recommend some simple devices that can help tech-challenged seniors with video calls? My 80-year-old mother has been isolating herself for months now in fear of the coronavirus and I haven't been able to see her face-to-face in quite a while. Concerned Daughter



Dear Concerned:

Video chatting is a great way to stay connected and keep tabs on an elder parent when you can't be there, but it's even more important now during this pandemic as many isolated seniors are also suffering from chronic loneliness.

To help connect you and your mom virtually, there are various products on the market that offer simple video calling for seniors who have limited ability or experience with technology. Here are four devices to consider.

GrandPad: This is a top option for simple video calling, and much more. The GrandPad is an 8-inch tablet specifically designed for seniors, ages 75 and older. It comes with a stylus, a charging cradle and 4G LTE built-in so it works anywhere within the Consumer Cellular network - home Wi-Fi is

Ready to go right out of the box, GrandPad provides a simplified menu of big icons and large text for only essential features, providing clutter-free, one-touch access to make and receive video calls, send voice emails, view photos and videos, listen to personalized music, check the weather, play games, browse the Internet and more.

A GrandPad tablet costs \$250 plus \$40 monthly service fee and is sold through Consumer Cellular at GrandPad.net or call 888-545-1425.

Amazon's Echo Show: With its built-in camera and screen, the voice-command Echo Show also provides a simple way to have face-to-face chats with your mom, but she'll need home Wi-Fi installed.

Echo Shows, which come in three screen sizes -5-inch (\$90), 8-inch (\$130) and 10-inch (\$230) - will let your mom make and receive video calls to those who have their own device, or who have the Alexa app installed on their smartphone or tablet.

Once you set up her contacts, to make a call your mom could simply say, "Alexa, call my daughter" And when you call her, she would ask Alexa to answer the call (or ignore it). There's also a feature called "drop-in" that would let you video call your mom's device anytime without her having to

Available at Amazon.com, the Echo Show also offers thousands of other features your mom would enjoy like voice-activated access to news, weather, her favorite music and much more.

If you decide to order an Echo Show device for mom, be sure your ask Amazon to mark it as a gift so it doesn't get tied to your Amazon account. For instructions to help your mom set it up, or if she doesn't have a smartphone, go to Amazon.com/gp/help/customer/display.html, and type in "Help Loved Ones Set Up Their Echo Show Remotely" in the "find more solutions" bar.

ViewClix: This is a smart picture frame specifically designed for elderly seniors that lets family members make video calls, send photos and post virtual sticky notes with messages to their loved ones ViewClix from their smartphone, tablet or computer. Seniors, however, cannot initiate video calls from their ViewClix. Home Wi-Fi is also required.

Available in two sizes - 10-inch for \$199, and 15-inch for \$299 - you can learn more about this product at ViewClix.com.

Facebook Portal: If your mom is a Facebook user, a voice-command Facebook portal (see portal. facebook.com) is another simple way to stay connected - home Wi-Fi is needed.

Portals, which come in three sizes - the original 10-inch Portal (\$179), the 8-inch Mini (\$129) and the massive 15-and-a-half-inch Portal Plus (\$279) - are like Echo Shows, except they connect through Facebook. With a Portal, your mom can video call your smartphone or tablet (and vice versa) using Facebook Messenger or WhatsApp.

YOUR "BLENDED" FAMILY IS LIKELY HEADED TO COURT UNLESS YOU DO THIS

If you have a blended family and do not plan for what happens to your assets in the event of your incapacity or death, you are almost certainly guaranteeing

So let's start with clarity around what a blended family is and whether you have one. If you have stepchildren, or children from a prior marriage, or other people you consider "kin" who are not considered legal relatives in the eyes of the law, you've got a blended family.

Bottom line: if you have a blended family, you need an estate plan, and not just a will you created for yourself online, or a trust that isn't specifically and intentionally designed to keep your family out of court and out of conflict. Period. End of story. Unless you are okay with setting your loved ones up for

unnecessary heartache, confusion, and pain when something happens to you.

What Will the Law Do?

"Blended Families, once considered "non-traditional" families are swiftly becoming the norm. Currently 52% of married couples (or unmarried couples who live together) have a stepkin relationship of some kind, and 4 in 10 new marriages involve remarriage. So, clearly, this is no longer "non-traditional" but quite traditional, though our laws about what happens if you become incapacitated or die are still very much based on tradition.

Every state has different provisions for what happens when you become incapacitated or die, and the laws of California may not necessarily match your wishes.

For example, in California, all community property assets would go to your surviving spouse, and separate property assets would be distributed partially to a surviving spouse and partially to children, if living, in amounts depending on the number of surviving children.

This may not result in the outcome you want for your loved ones, especially if you have a blended family situation. If you have something different in mind as to how you would want things to go, there is good news. The state of California allows you to circumvent those laws, but only if you have an alternate plan in place BEFORE your incapacity or death.

Even within "traditional" families, I want to emphasize that having a full plan is the best way to provide for your loved ones. However, with "blended" families, carefully considered estate plans are often even more vital to avoid massive misunderstanding and conflict, and having your assets tied up in court instead of going to the people you want to receive them.

Disputes Between Spouse and Children from Previous Marriage

One of the most common problems that arises in a blended family is that the deceased's children from a prior marriage and the surviving spouse end up in conflict. The courts are filled with these kinds of cases. But it doesn't have to be that way.

When you're considering all of this for the people you love, it's important to have a trusted advisor who can help you look at the reality of what will happen if you become incapacitated or when you die. With the complexities of modern families, it's far better to know and plan than to leave it up to the law or a court to decide. That way, not only do the people you love get the assets that you want them to receive, but you will also be saving them from years of potential legal conflict.



The latest amendments to this law are designed to make it easier for a developer to build affordable housing by attempting to streamline the process of reviewing a density bonus application, expanding the housing options that may take advantage of a density bonus (including adding a new housing category that includes units for "transitional foster youth," disabled veterans, or homeless persons), and by lowering the standards to qualify for housing incentives and concessions. Additionally, the amended Chapter 17.34 proposes the following new provisions: (1) Section 17.34.060 regarding waivers or reductions of development standards and required findings; (2) Section 17.34.070 regarding parking ratios and required findings; (3) Section 17.34.090 regarding the density bonus calculation methodology for childcare facilities; (4) Section 17.34.100 regarding the density bonus calculation methodology for the donation of land; and (5) Section 17.34.110 regarding the density bonus calculation methodology for a

The proposed changes to Chapter 17.34, as authorized and required by state law, have no potential for resulting in physical changes to the environment because they consist of changes in the standards governing issuance of permits for density bonus projects and do not directly or indirectly approve any applications for particular projects. Any particular proposed project will be required to undergo the City's entitlement process and appropriate review under CEQA.





100th YEAR CELBRATION

Editor's Note: It's the 4th of July, a time, even in the midst of crisis, when we celebrate our nation's 'birthday', even in the midst of a Pandemic and while a recognition that the creation of a "more perfect union" is still a work in progress. So while we are busy with the 4th of July festivities, let us not forget that the founding father's not only deprived slaves of their right to participate in the most important activity that would shape the future, the also did not allow women to vote as well. In fact, it was 58 years AFTER former slaves were allowed to vote that Women were 'granted' the right to vote. Below is an excerpt of the history of the fight for voting equality for women.

Although the Declaration of Independence specifies that "all men are created equal," its publication sowed the seeds for the women's suffrage movement in the United States. The movement took root at an 1840 conference in London, when two determined women met for the first time. Even though they were delegates to the World Anti-Slavery Congress, Lucretia Mott and Elizabeth Cady Stanton could not participate in the convention because they were female. This snub inspired them to work together to guarantee rights for women.

Elizabeth Cady Stanton and Daughter, Harriot

In 1848, Mott and Stanton hosted the Seneca Falls Convention, the first women's rights convention in the United States. The convention published a Declaration of Sentiments, based on the Declaration of Independence, that called for voting rights for women and other reforms.

Some key grievances included in the Declaration of Sentiments were:

He has never permitted her to exercise her inalienable right to the elective franchise.

He has compelled her to submit to laws, in the formation of which she had no voice.

Having deprived her of this first right of a citizen, the elective franchise, thereby leaving her without representation in the halls of legislation, he has oppressed her on all sides.

Women's rights conventions were held regularly thereafter. In 1853, Frances Gage presided over the National Women's Rights Convention in Cleveland, Ohio. She commented on the prevailing opinion that women belonged at home, not at the polling place:

I was asked a few days ago . . . "are you not afraid that woman will run into excesses, that homes will be deserted, that men will lack wives in this country?" I have but one reply to make to that question. Society grants to every man in the United States, every free "white male citizen," ... the privilege of voting, and of being voted for; of being President of the United States; of sitting upon the bench; of filling the jury box, of going to Congress; ... and we don't believe woman will get very far out of her place, if society should yield her the same rights.

Susan B. Anthony

Unlike African Americans, who were enfranchised by the Constitution but denied the vote by individual states, women found no help in the Constitution. In fact, the Fourteenth Amendment (1868) defined citizens and voters as "male" - a setback for suffragists. Conflict over how to win the vote in light of Amendments Fourteen and Fifteen split the women's rights movement.

Susan B. Anthony and Elizabeth Cady Stanton formed the more radical National Woman Suffrage Association (NWSA) that tried to win suffrage at the Constitutional level. NWSA argued that the Fifteenth Amendment, which enfranchised blacks, should be abandoned in favor of a universal suffrage amendment. Anthony herself was arrested in 1872 for trying to vote for Ulysses S. Grant for president.

Lucy Stone, her husband Henry Blackwell, and Julia Ward Howe founded the more moderate American Woman's Suffrage Association (AWSA). They fought for suffrage on a state by state level. AWSA supported the Fifteenth Amendment and succeeded in winning suffrage for women in several individual states.

"Mr. President, What Will You Do For Woman Suffrage?"

In 1890, the two organizations reconciled and became the National American Woman Suffrage Association. By then, women had the right to vote in Wyoming, Utah, Idaho, Colorado and Washington. Armed with strategies from both founding groups, and joined by organizations including the National Association of Colored Women, the National Women's Party and the National Federation of Women's Clubs, NAWSA became an influential national force. As a mark of their influence, Theodore Roosevelt's Bull Moose/Progressive party adopted women's suffrage as party plank in 1912.

Alice Paul, leader of the National Women's Party, brought attention-grabbing protest tactics from British suffragists to the United States. In 1917, ten suffragists picketing the White House were arrested while picketing the White House, and charged with obstructing sidewalk traffic.

The Declaration of Independence: A TRANSCRIPTION

IN CONGRESS, July 4, 1776.

The unanimous Declaration of the thirteen united States of America,

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.--Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world.

He has refused his Assent to Laws, the most wholesome and necessary for the public good.

He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them.

He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only.

He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their public Records, for the sole purpose of fatiguing them into compliance with his measures.

He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.

He has refused for a long time, after such dissolutions, to cause others to be elected; whereby the Legislative powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the dangers of invasion from without, and convulsions within.

He has endeavoured to prevent the population of these States; for that purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands.

He has obstructed the Administration of Justice, by refusing his Assent to Laws for establishing Judiciary powers.

He has made Judges dependent on his Will alone, for the tenure of their offices, and the amount and payment of their salaries.

He has erected a multitude of New Offices, and sent hither swarms of Officers to harrass our people, and eat out their substance.

He has kept among us, in times of peace, Standing Armies without the Consent of our legislatures.

He has affected to render the Military independent of and superior to the Civil power.

He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation:

For Quartering large bodies of armed troops among us:

For protecting them, by a mock Trial, from punishment for any Murders which they should commit on the Inhabitants of these States:

For cutting off our Trade with all parts of the world:

For imposing Taxes on us without our Consent:

For depriving us in many cases, of the benefits of Trial by Jury:

For transporting us beyond Seas to be tried for pretended offences

For abolishing the free System of English Laws in a neighbouring Province, establishing therein an Arbitrary government, and enlarging its

Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies: For taking away our Charters, abolishing our most valuable Laws, and altering fundamentally the Forms of our Governments:

For suspending our own Legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever.

He has abdicated Government here, by declaring us out of his Protection and waging War against us.

He has plundered our seas, ravaged our Coasts, burnt our towns, and destroyed the lives of our people.

He is at this time transporting large Armies of foreign Mercenaries to compleat the works of death, desolation and tyranny, already begun with circumstances of Cruelty & perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.

He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the executioners of their friends and Brethren, or to fall themselves by their Hands.

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare, That these United Colonies are, and of Right ought to be Free and Independent States; that they are Absolved from all Allegiance to the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.

Family' plan. The rest of us matter also


'Secure the blessings of Liberty for ourselves and our Posterity".... i.e., life, liberty and the pursuit of happiness now and for future generations.

FYI: WHO SIGNED THE U.S. CONSTITUTION?

The 38 signers of the U.S. Constitution were delegates from the original states who gathered several times and in several places, first drafting the Declaration of Independence, and then, after the colonists defeated the British army and won independence, writing the U.S. Constitution. The signers of the two documents have some overlap — Benjamin Franklin signed both, but John Hancock wrote large only on the Declaration of Independence. The delegates are here grouped by the states they represented:

ARTICLE I

Section 1

All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

Section 2

The House of Representatives shall be composed of Qualifications requisite for Electors of the most numerous Branch of the State Legislature.

No Person shall be a Representative who shall not have attained to the Age of twenty five Years, and been seven No Senator or Representative shall, during the Time for shall be chosen.

Representatives and direct Taxes shall be apportioned among the several States which may be included within this Union, according to their respective Numbers, which shall be determined by adding to the whole Number of Section 7 free Persons, including those bound to Service for a Term All Bills for raising Revenue shall originate in the House of Years, and excluding Indians not taxed, three fifths of of Representatives; but the Senate may propose or concur No Preference shall be given by any Regulation of all other Persons. The actual Enumeration shall be made within three Years after the first Meeting of the Congress of the United States, and within every subsequent Term of Every Bill which shall have passed the House of Representative; and until such enumeration shall be made, the State of New Hampshire shall be entitled to chuse three, Massachusetts eight, Rhode Island and Providence Plantations one, Connecticut five, New-York six, New Jersey four, Pennsylvania eight, Delaware one, Maryland six, Virginia ten, North Carolina five, South Carolina five, and Georgia three.

When vacancies happen in the Representation from any State, the Executive Authority thereof shall issue Writs of Election to fill such Vacancies.

Section 3

The Senate of the United States shall be composed of two Senators from each State, chosen by the Legislature thereof, Every Order, Resolution, or Vote to which the Concurrence No State shall, without the Consent of the Congress, lay for six Years; and each Senator shall have one Vote.

Immediately after they shall be assembled in Consequence of the first Election, they shall be divided as equally as may be into three classes. The Seats of the Senators of the first Class shall be vacated at the Expiration of the second Year, of the second Class at the Expiration of the fourth Year, the Rules and Limitation prescribed in the Case of a Bill. and of the third Class at the Expiration of the sixth Year, so that one third may be chosen every second Year; and if Section 8 Vacancies happen by Resignation or otherwise, during the The Congress shall have Power To lay and collect Taxes, Peace, enter into any Agreement or Compact with another of the Legislature, which shall then fill such Vacancies.

Section 4

The Times, Places and Manner of holding Elections for any time by Law make or alter such Regulations, except as Years; to the Places of chusing Senators.

The Congress shall assemble at least once in every Year, and such Meeting shall be on the first Monday in December, unless they shall by Law appoint a different Day.

Each House shall be the Judge of the Elections, Returns and Qualifications of its own Members, and a Majority of each shall constitute a Quorum to do Business; but a smaller Number may adjourn from day to day, and may be authorized to compel the Attendance of absent Members, may provide.

Each House may determine the Rules of its Proceedings, punish its Members for disorderly Behaviour, and, with the Concurrence of two thirds, expel a Member.

ARTICLE II

Section 1

The executive Power shall be vested in a President of the United States of America. He shall hold his Office during the Term of four Years, and, together with the Vice President, chosen for the same Term, be elected, as follows

Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress: but no Senator or Representative, or Person holding an Office of Trust or Profit under the United States, shall be appointed an Elector.

The Electors shall meet in their respective States, and vote by Ballot for two Persons, of whom one at least shall not be an Inhabitant of the same State with themselves. And they shall make a List of all the Persons voted for, and of the Number of Votes for each; which List they shall securing for limited Times to Authors and Inventors the sign and certify, and transmit sealed to the Seat of the Government of the United States, directed to the President of the Senate. The President of the Senate shall, in the presence of the Senate and House of Representatives, open all the Certificates, and the Votes shall then be counted. The Person having the greatest Number of Votes shall be the President, if such Number be a Majority of the whole Number of Electors appointed; and if there be more than one who have such Majority, and have an equal Number of Votes, then the House of Representatives shall immediately chuse by Ballot one of them for President; and if no Person Senators and Representatives, shall be prescribed in each. In Case of the Removal of the President from Office, or of public Acts, Records, and judicial Proceedings of every right to a speedy and public trial, by an impartial jury of his Death, Resignation, or Inability to discharge the Powers other State. And the Congress may by general Laws and Duties of the said Office, the Same shall devolve on the Vice President, and the Congress may by law provide for the Case of Removal, Death, Resignation or Inability, both of the President and Vice President, declaring what Officer shall then act as President, and such Officer shall act The Citizens of each State shall be entitled to all Privileges accordingly, until the Disability be removed, or a President and Immunities of Citizens in the several States. shall be elected.

The President shall, at stated Times, receive for his Services, a Compensation, which shall neither be encreased nor another State, shall on Demand of the executive Authority diminished during the Period for which he shall have been elected, and he shall not receive within that Period any other Emolument from the United States, or any of them.

Before he enter on the Execution of his Office, he shall take the following Oath or Affirmation:— I do solemly swear (or affirm) that I will faithfully execute the Office of President of the United States, and will to the best of my Ability, preserve, protect and defend the Constitution of the United

Section 2

The President shall be Commander in Chief of the Army and Navy of the United States, and of the Militia of the several States, when called into the actual Service of the United States; he may require the Opinion, in writing, of the principal Officer in each of the executive Departments, upon any Subject relating to the Duties of their respective Offices, and he shall have Power to grant Reprieves and Pardons for Offences against the United States, except in Cases of Impeachment.

He shall have Power, by and with the Advice and Consent of the Senate, to make Treaties, provided two thirds of the Senators present concur; and he shall nominate, and by and with the Advice and Consent of the Senate, shall appoint Ambassadors, other public Ministers and Consuls, Judges of the supreme Court, and all other Officers of the United States, whose Appointments are not herein otherwise provided for, and which shall be established by Law: but the Congress may by Law vest the Appointment of such inferior Officers, as they think proper, in the President alone, in the Courts of Law, or in the Heads of Departments.

The President shall have Power to fill up all Vacancies that may happen during the Recess of the Senate, by granting Commissions which shall expire at the End of their next

Section 3

He shall from time to time give to the Congress Information of the State of the Union, and recommend to their Consideration such Measures as he shall judge necessary and expedient; he may, on extraordinary Occasions, convene both Houses, or either of them, and in Case of Disagreement between them, with Respect to the Time of Adjournment, he may adjourn them to such Time as he shall think proper; he shall receive Ambassadors and other public Ministers; he shall take Care that the Laws be All Debts contracted and Engagements entered into, before faithfully executed, and shall Commission all the Officers the Adoption of this Constitution, shall be as valid against of the United States.

ARTICLE III

Section 1

The judicial Power of the United States, shall be vested in one supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish. The Judges, both of the supreme and inferior Courts, shall hold their Offices during good Behaviour, and shall, at stated Times, receive for their Services, a Compensation, which shall not be diminished during their Continuance in Office.

Section 2

The Judicial Power shall extend to all Cases, in Law Article VII and Equity, arising under this Constitution, the Laws The Ratification of the Conventions of nine States, shall be made, under their Authority;---to all Cases affecting Ambassadors, other public Ministers and Consuls;---to all Cases of admiralty and maritime Jurisdiction;---to First Amendment Controversies to which the United States shall be a Party:a State and Citizens of another State;---between Citizens of different States,---between Citizens of the same State right of the people peaceably to assemble, and to petition claiming Lands under Grants of different States, and between a State, or the Citizens thereof, and foreign States, Citizens or Subjects.

In all Cases affecting Ambassadors, other public Ministers and Consuls, and those in which a State shall be a Party, the supreme Court shall have original Jurisdiction. In all the other Cases before mentioned, the Supreme Court shall have appellate Jurisdiction, both as to Law and Fact, with such Exceptions, and under such Regulations as the Congress shall make.

Section 2

A Person charged in any State with Treason, Felony, or other Crime, who shall flee from Justice, and be found in of the State from which he fled, be delivered up, to be removed to the State having Jurisdiction of the Crime.

No Person held to Service or Labour in one State, under the Laws thereof, escaping into another, shall, in Consequence of any Law or Regulation therein, be discharged from such Service or Labour, but shall be delivered up on Claim of the Party to whom such Service or Labour may be due.

Section 3

New States may be admitted by the Congress into this Union; but no new State shall be formed or erected within the Jurisdiction of any other State; nor any State be formed by the Junction of two or more States, or Parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.

The Congress shall have Power to dispose of and make all needful Rules and Regulations respecting the Territory or other Property belonging to the United States; and nothing in this Constitution shall be so construed as to Prejudice any Claims of the United States, or of any particular State.

Section 4

The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

The Congress, whenever two thirds of both Houses shall deem it necessary, shall propose Amendments to this Constitution, or, on the Application of the Legislatures of two thirds of the several States, shall call a Convention for proposing Amendments, which, in either Case, shall be valid to all Intents and Purposes, as Part of this Constitution, when ratified by the Legislatures of three fourths of the several States, or by Conventions in three fourths thereof, as the one or the other Mode of Ratification may be proposed by the Congress; Provided that no Amendment which may be made prior to the Year One thousand eight hundred and eight shall in any Manner affect the first and fourth Clauses in the Ninth Section of the first Article; and that no State, without its Consent, shall be deprived of its equal Suffrage in the Senate.

the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

Seventh Amendment

In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any Court of the United States, than according to the rules of the common law.

Eighth Amendment

Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

Ninth Amendment

The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

Tenth Amendment

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

Eleventh Amendment

The Judicial power of the United States shall not be construed to extend to any suit in law or equity, commenced or prosecuted against one of the United States by Citizens of another State, or by Citizens or Subjects of any Foreign

Twelfth Amendment

The Electors shall meet in their respective states, and vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice-President, and they shall make distinct lists of all persons voted for as President, and of all persons voted for as Vice-President, and of the number of votes for each, which lists they shall sign and certify, and transmit sealed to the seat of the government of the United States, directed to the President of the Senate;—The President of the Senate shall, in the presence of the Senate and House of Representatives, open all the certificates and the votes shall then be counted;—The person having the greatest number of votes for President, shall be the President, if such number be a majority of the whole number of Electors appointed; and if no person have such majority, then from the persons having the highest numbers not exceeding three on the list of those voted for as President, the House of Representatives shall choose immediately, by ballot, the President. But in choosing the President, the votes shall be taken by states, the representation from each state having one vote; a quorum for this purpose shall consist of a member or members from two-thirds of the states, and a majority of all the states shall be necessary to a choice. [And if the House of Representatives shall not choose a President whenever the right of choice shall as in the case of the death or other constitutional disability such number be a majority of the whole number of Electors appointed, and if no person have a majority, then from the two highest numbers on the list, the Senate shall choose the Vice-President; a quorum for the purpose shall consist of two-thirds of the whole number of Senators, and a majority of the whole number shall be necessary to a choice. But no person constitutionally ineligible to the office of President shall be eligible to that of Vice-President of the United

Thirteenth Amendment

Section 1

Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.

Section 2

Congress shall have power to enforce this article by appropriate legislation.

Fourteenth Amendment

Section 1

All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

Section 2

Representatives shall be apportioned among the several States according to their respective numbers, counting the whole number of persons in each State, excluding Indians not taxed. But when the right to vote at any election for the choice of electors for President and Vice-President of the United States, Representatives in Congress, the Executive and Judicial officers of a State, or the members of the Legislature thereof, is denied to any of the male inhabitants of such State, being twenty-one years of age, and citizens of the United States, or in any way abridged, except for participation in rebellion, or other crime, the basis of representation therein shall be reduced in the proportion which the number of such male citizens shall bear to the whole number of male citizens twenty-one years of age in such State.

Section 3

No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a

or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution Section 5 of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the following the ratification of this article. enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

Section 4

The validity of the public debt of the United States, authorized by law, including debts incurred for payment of pensions and bounties for services in suppressing insurrection or rebellion, shall not be questioned. But neither the United States nor any State shall assume or pay any debt or obligation incurred in aid of insurrection or rebellion against the United States, or any claim for the loss or emancipation of any slave; but all such debts, obligations and claims shall be held illegal and void

Section 5

The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

Fifteenth Amendment

Section 1

Section 2

The Congress shall have the power to enforce this article by appropriate legislation.

Sixteenth Amendment

The Congress shall have power to lay and collect taxes President, or acted as President, for more than two years of on incomes, from whatever source derived, without a term to which some other person was elected President apportionment among the several States, and without regard to any census or enumeration.

Seventeenth Amendment

The Senate of the United States shall be composed of two Senators from each State, elected by the people thereof, for six years; and each Senator shall have one vote. The electors in each State shall have the qualifications requisite for electors of the most numerous branch of the State legislatures.

When vacancies happen in the representation of any State in the Senate, the executive authority of such State shall issue writs of election to fill such vacancies: Provided, That the legislature of any State may empower the executive the Congress. thereof to make temporary appointments until the people fill the vacancies by election as the legislature may direct.

This amendment shall not be so construed as to affect the election or term of any Senator chosen before it becomes valid as part of the Constitution.

Eighteenth Amendment

Section 1

After one year from the ratification of this article the manufacture, sale, or transportation of intoxicating liquors within, the importation thereof into, or the exportation they shall be in addition to those appointed by the States, thereof from the United States and all territory subject to but they shall be considered, for the purposes of the election the jurisdiction thereof for beverage purposes is hereby prohibited.

Section 2

The Congress and the several States shall have concurrent power to enforce this article by appropriate legislation.

Section 3

This article shall be inoperative unless it shall have Twenty-Fourth Amendment been ratified as an amendment to the Constitution by the legislatures of the several States, as provided in the Constitution, within seven years from the date of the submission hereof to the States by the Congress.

Nineteenth Amendment

Section 1

The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex.

Section 2

Congress shall have power to enforce this article by appropriate legislation.

Twentieth Amendment

Section 1

The terms of the President and Vice President shall end at noon on the 20th day of January, and the terms of Senators and Representatives at noon on the 3d day of January, of the years in which such terms would have ended if this article had not been ratified; and the terms of their successors shall then begin.

Section 2

The Congress shall assemble at least once in every year, and such meeting shall begin at noon on the 3d day of January, unless they shall by law appoint a different day.

Section 3

If, at the time fixed for the beginning of the term of the President, the President elect shall have died, the Vice President elect shall become President. If a President shall not have been chosen before the time fixed for the Section 4 beginning of his term, or if the President elect shall have such person shall act accordingly until a President or Vice powers and duties of the office as Acting President. Section 1

The eighteenth article of amendment to the Constitution of the United States is hereby repealed.

Section 2

The transportation or importation into any State, Territory, or possession of the United States for delivery or use therein of intoxicating liquors, in violation of the laws thereof, is hereby prohibited.

Section 3

Twenty-Second Amendment

Section 1

No person shall be elected to the office of the President more than twice, and no person who has held the office of shall be elected to the office of the President more than once. But this Article shall not apply to any person holding the office of President when this Article was proposed by the Congress, and shall not prevent any person who may be Article III holding the office of President, or acting as President, during the term within which this Article becomes operative from holding the office of President or acting as President during the remainder of such term.

Section 2

Twenty-Third Amendment

Section 1

The District constituting the seat of Government of the United States shall appoint in such manner as the Congress AMENDMENTS TO THE CONSTITUTION may direct:

to the whole number of Senators and Representatives in Congress to which the District would be entitled if it were a State, but in no event more than the least populous State; of President and Vice President, to be electors appointed by a State; and they shall meet in the District and perform such duties as provided by the twelfth article of amendment.

Section 2

The Congress shall have power to enforce this article by appropriate legislation.

Section 1

The right of citizens of the United States to vote in any primary or other election for President or Vice President, for electors for President or Vice President, or for Senator or Representative in Congress, shall not be denied or abridged by the United States or any State by reason of failure to pay any poll tax or other tax.

Section 2

The Congress shall have power to enforce this article by appropriate legislation.

Twenty-Fifth Amendment

Section 1

In case of the removal of the President from office or of his death or resignation, the Vice President shall become President.

Section 2

Whenever there is a vacancy in the office of the Vice Seventeenth Amendment President, the President shall nominate a Vice President who shall take office upon confirmation by a majority vote of both Houses of Congress.

Section 3

Whenever the President transmits to the President pro tempore of the Senate and the Speaker of the House of Representatives his written declaration that he is unable to discharge the powers and duties of his office, and until he transmits to them a written declaration to the contrary, such powers and duties shall be discharged by the Vice President as Acting President.

Twenty-Sixth Amendment

Section 1

The right of citizens of the United States, who are eighteen years of age or older, to vote shall not be denied or abridged by the United States or by any State on account of age.

Section 2

The Congress shall have power to enforce this article by appropriate legislation.

Twenty-Seventh Amendment

No law, varying the compensation for the services of the Senators and Representatives, shall take effect, until an election of Representatives shall have intervened.


