# SIERRA MADRE RESIDENT **CRYSTAL CZUBERNAT TO RUN** FOR PUSD BOARD SEAT

Three other candidates have also pulled nomination papers for the seat that includes the City of Sierra Madre.

School Enrollment and Distance Learning expert Crystal Czubernat has officially filed a Candidate Intention Statement with the City of Pasadena City Clerk for election to the Pasadena Unified School District Board of Education. Facing potential challenges from Priscilla Hernandez, Tina Fredericks and Milena Albert, Czubenot says, "I am the best qualified and most experienced candidate to help guide the PUSD through the big changes in teaching practices and the use of technology the PUSD now faces."



The District 6 seat, previously held by, Educator Larry Torres, also of Sierra Madre, was created when the district changed from 'at large' representation to 'district representation. Torres announced his decision not to run for another term earlier this year. The election to fill that seat, as well as the seats for Districts 2 and 4 will be on the November 3, 2020 ballot.

Czubernat has spent nearly twenty years working in education, both as a credentialed teacher and then as a School Enrollment and Distance Learning

Expert. She was a pioneer in working to establish online learning at multiple public high schools serving students who have fallen behind in school or were looking to get ahead and graduate early, or simply desired what was then a non-traditional learning environment.

She has a Bachelor's degree in Secondary Education, two Master's Degrees (Curriculum and Instruction and Counseling) and is completing requirements for a Ph.D. in Organizational Leadership.

# CITY COMMISSIONS **REDUCED TO FIVE SEATS**

Sierra Madre City Council adopted an ordinance reducing the number of seats on commissions from seven to five in a unanimous vote during their regular meeting Tuesday, July 14, 2020.

Citing difficulties in recruitment, the City will reduce seats on the Energy, Environment, and Natural Resources Commission as well as the Planning Commission, Senior Community Commission, and Community Commission.

In addition to the lack of recruitment, commissions have also had attendance problems which led to several meeting cancelations. Over the last 18 months, for example, the Community Commission has cancelled seven meetings due to lack of quorum.

Vacant seats are not required to be filled by Sierra Madre residents, or those who work in the city. Despite that, seats are still hard to fill with usually anywhere from zero to one or two applicants tops to fill positions. Three applicants are currently required for each seat, a number that will drop to two required applicants with the passing of this ordinance.

Sierra Madre currently has more commissions, total commission seats and longer terms

compared to most neighboring cities, according to a presentation given by Administrative Analyst Jennifer Peterson. Though some cities do have seven-seat commissions.

Both Council Members and members of the community showed concern over the timing of the seat reduction ordinance during a pandemic. Some discussion focused on the Planning Commission who are currently involved in several projects, including construction plans at the Monastery. The Planning Commission currently has six seats filled for this year, and some current members have expressed the need to fill seven seats. But, when all was said and done, City Council voted unanimously on seat reduction and agreed to revisit this issue again in May 2021. At that time, they can re-evaluate and see if seats need to be added back to certain commissions. (continued on page 3)

# THE TUBERCULOSIS EPIDEMIC

When historian Michele Zack was in the process of writing her award-winning history of Sierra Madre, there were still those who whispered to her to play down the great TB epidemic that occurred around the turn of the last century and its tremendous role in shaping early Sierra Madre. What happened back then, and why would some people, even now, still feel that it should be hushed up? According to the Harvard University Collections, in the late 19th century and early 20th century, 70 to 90% of the urban populations of Europe and North America were infected with the TB bacillus, and about 80% of those individuals who developed

of the urban populations of Europe and North America were infected with the TB bacillus, and about 80% of those individuals who developed active tuberculosis died of it. PBS, in their documentary "The Forgotten Plague", state: "By the dawn of the 19th century, the deadliest killer in human history, tuberculosis, had killed one in seven of all the people who had ever lived. The disease struck America with a vengeance, ravaging communities and touching the lives of almost every family." They state that eventually one out every 170 Americans would be in a TB sanitarium.

Doctors at the beginning of the epidemic, unaware that TB was caused by a bacillus and was infectious, urged sufferers to get out of crowded cities, where bad air was thought to be the culprit, and into the healing fresh air of the countryside. Warm and dry climates were thought to be the most beneficial. The Transcontinental Railway, which had been completed in 1869, just a decade before the outbreak, made it possible for debilitated souls to take that advice and come west. Sierra Madre boosters, spotting an opportunity for growth, advertised our ideal climate. Foremost among those was our town's founder, Nathaniel Carter, who himself suffered from TB. His advertisements featured before and after photographs of himself to show how he had gone from gaunt and wasted to the full bloom of health. This stupendous epidemic, hardly remembered now, affected every aspect of life in the entire U.S. It dramatically changed Sierra Madre and the lives of our citizens.

Community members voiced their displeasure for the seat reductions during the public comment section of the meeting and via email. Concerns expressed included the need for diversity and more community involvement in city planning, as well as more communication to alert the public when seats become available.

"This is such a bad idea in the middle of a pandemic," said Deborah Sheridan, resident and member of the Sierra Madre Steering Committee. "We need an opportunity for more residents to be heard, not fewer. We need more perspectives and reducing a commission from seven to five is the wrong way to go about this," Sheridan said.

"You're basically taking away the residents' rights to make important decisions that will affect the quality of their life," said Sierra Madre resident Heather Allen. "This is the type of thing that can lead to totalitarianism at some point. If the Council truly values the residents' voices...you will protect those seats. This is just a very bad idea."

David Gordon, Board President at the Sierra Madre Playhouse expressed the need for better community reach. "This is part of a wider problem that the city has. It has a problem with communicating with its citizens. The solution is the city [should] engage much more in an attempt to reach out to citizens and to seek for volunteers for these city bodies. There are people out there who don't know these opportunities exist," Gordon stated.

"It's very important to keep seven members on the Planning Commission, as we do have some very serious considerations to be made for further development of our city," said Gary Hood, Steering Committee member.

Mayor John Capoccia expressed that the city has made a great effort to inform citizens about openings on various boards and commissions in local publications, through social media and on the city website.

Both Mayor Capoccia and Council Member John Harabedian will not seek Council seats in the next term, so the mayor deferred to Mayor Pro Tem Rachelle Arizmendi and Council Member Gene Goss before the vote, but not before adding his own insight. "I really believe that the best think to do is to reduce all the commissions to five...I don't think it's going to make a big difference having two additional people on the commission as far as the quality of the decisions to be made," Capoccia said.

Both Mayor Pro Tem Arizmendi and Council Member Goss agreed on the reduction to five seats with the promise to reevaluate in May of 2021. "Democracy is not served when there's no competition," Goss said.

In addition to the seat reductions, the City included a provision that would extend all board and commission member terms to four years. After review during the June 23, 2020 meeting, Council decided to move forward on the appointment of the following commissioners to a second term of four years: William Pevsner, Planning Commission, Anita Thompson, Senior Community Commission, Patrick Holland, Senior Community Commission, Karen Rowinsky, Community Services Commission, and London Koprowski, (Youth, Non-Voting) Community Services Commission.

Council also extended the current term length of the Library Board Trustees to four years.

# **WALKING SIERRA MADRE - The Social Side**

It's Tuesday, July 14th, friends and neighbors, and I'm checking my computer every five minutes to see if my electronically prepared taxes have arrived yet for my electronic signature so I can electronically return them to my tax preparer so they can electronically file them with the IRS. I realize we've had months of extended time to prepare, but, what with the pandemic and all, my adorable and incredibly gifted daughter, Leah, and I didn't get around to doing mine until a couple of weeks ago. All of you out there are probably way more organized and did yours back in April so you're just sitting home wishing you could go to the movies. Which is what I'd really like to do, too. Heavy sigh...

Speaking of movies, Turner Classic Movies showed, "1776" last weekend. This is a 1972 American musical drama film directed by Peter H. Hunt. The screenplay by Peter Stone was based on his book for the 1969 Broadway musical of the same name. The concept being where the burgeoning United States Founding Fathers gather in Philadelphia with the aim of establishing a set of governmental rules. Benjamin Franklin and John Adams charge Thomas Jefferson with writing a statement announcing the new country's emancipation from British Rule. I was delighted when I saw that Mountain Views News editor, Susan Henderson, had reprinted the Declaration of Independence and the Constitution for a second week. You probably were, too.

It was unbearably hot in Philadelphia when these guys got together to draft our Declaration, just like it is currently here, there and everywhere, but at least we don't have to wear all those incredibly hot clothes that were the fashion then. Benjamin Franklin's famous quote came to mind when I saw all the signatures at the bottom of the Declaration: "We must all hang together, or, most assuredly, we shall all hang separately!"

We watched "Hamilton" on Disney+ on July 3rd and, once again, I loved every minute of it. I did get to see it when it first came to Los Angeles a year or so ago but as viewed on the TV screen with closed captioning, I enjoyed it even more. Leah and I have tickets to see it again in October when/if it is able to come back.

Arlo Guthrie's birthday was July 10<sup>th</sup>. He was 73. In case you don't know what he was particularly famous for, it was the song, "Alice's Restaurant." This particular song was twenty minutes plus... "You can get anything you want at Alice's Restaurant..." Anyway, something else you might not know, is that Sierra Madre had its own radio station, KMAX-FM, back in the 60's, before anybody really knew what FM radio was. Owned by Max and Mary Ellen (last name has escaped me). Anyway, Mary Ellen had a call-in request show in the afternoons and one day she had an absolute melt-down on the air along the lines of, "Don't any of you people ever ever call me again asking for that "Alice's Restaurant" song! It's twenty minutes long and I'm just not going to play it." This was roll on the floor laughing material, broadcasted live. KMAX-FM was sold in 1975 and that was the end of that. If you want to read the story of our radio station, go online to KMAX-Henry Engineering and you'll be fascinated by what Max and Mary Ellen did.

John and I built and owned our own radio station, KROR-FM, broadcasting Modern Country Music from 1988 to 1994 and, I have to say, being in radio is certainly an exciting experience. After we sold, we always referred to that period as "The best of times and the worst of times," a direct steal from "A Tale of Two Cities" by Charles Dickens. John, like Max, was a radio addict and was heard live on Saturday mornings starting in the '50's on a variety of stations. 



The City of Monrovia COVID-19 Emergency Rental Assistance (COVID-19 ERA) and COVID-19 Emergency Utility Assistance (COVID-19 EUA) Programs will begin accepting Eligibility Intake Forms on Monday, July 20, 2020 through Thursday, July 30, 2020 through our City website. Residents who are income eligible and whose income has been affected by the COVID-19 pandemic emergency will be able to apply for assistance of a one-time payment of up to \$500 for rental assistance and for a one-time payment of up to \$150 for utility assistance. These programs are funded by the Community Development Block Grant (CDBG) funds through the federal Coronavirus Aid, Relief, and Economic, Security (CARES) Act and will provide approximately 120 rental assistance grants and approximately 135 utility assistance grants to qualified applicants.

**Program Procedures:** 

Step 1: Applicant will complete initial Eligibility Intake Packet located on the City website and submit it to City Staff by email.

Step 2: Once the eligibility intake period has reached the deadline of July 30, staff will begin screening the submitted intake forms for eligibility. If the applicant is deemed eligible, staff will put qualified applicants into a lottery system that will randomly select

Step 3: City Staff will contact the randomly selected applicants and request further required program paperwork and documentation to confirm eligibility.

Step 4: Once eligibility has been confirmed they will have 10 business days to submit all required documents. Staff will then begin submitting the supplemental one-time rental and/or utility payments on behalf of qualified and accepted households to their landlord and/or directly to the chosen utility service provider.

#### MONROVIA RESIDENTIAL/COMMERCIAL **EVICTION MORATORIUM**

In response to the COVID-19 pandemic, the Monrovia City Council adopted a Residential Eviction Moratorium and a Commercial Eviction Moratorium. These moratorium prohibits all landlords/property owners from pursuing an eviction for nonpayment of rent and "no fault" evictions. The ordinance will remain in place through the duration of the COVID-19 emergency

Can I check out materials?

Yes, our Library Takeout service is a no-contact check-out/pick-up service that allows you to request materials and pick them up at the Library entrance, Monday through Thursday, 11 a.m. to 7 p.m. and Friday and Saturday, 10 a.m. to 5 p.m. Customers using this service will be required to wear a face covering that covers nose and mouth and abide by physical distancing requirements as defined by the County of Los Angeles Public Health Department. How do I contact library staff?

On July 1 the Library implemented automatic renewals for all eligible items. Items will be automatically be renewed up to two times as long as another customer has not placed a hold on the item. # Pasadena Man Charged in Violent Kidnapping of Chinese Foreign National Remains Were Found Buried in the Mojave

Valley, one from Pasadena, were charged Wednesday in federal in the kidnapping of Ruochen "Tony" Liao, a Chinese national who was violently abducted from a mall parking lot in San Gabriel two years ago, and whose parents were extorted Liao died from his injuries.

Anthony Valladares, 28, of Pasadena, and Alexis Ivan Romero Velez, 24, most recently into custody Tuesday during the execution of search warrants by San Gabriel Valley Safe Street Task Force. Federal prosecutors this morning filed a criminal complaint in United States District Court that charges both Valladares and Romero with one count of kidnapping.

Previously in this investigation, charged in a four-count indictment alleging they kidnapped Mr. Liao and attempted to collect \$2 million in ransom from Mr. Liao's victim's life. Guangyao Yang, 26, and Peicheng Shen, 34, whose last known U.S. residences were in West Covina, were charged with conspiracy to kidnap, kidnapping, attempted extortion in violation of the Hobbs Act, and threat by foreign communication. Yang and Shen are currently in custody in China on charges filed there related to the kidnapping.

# IRS: SENIORS, RETIREES NOT REQUIRED TO TAKE DISTRIBUTIONS FROM RETIREMENT ACCOUNTS THIS YEAR UNDER NEW LAW

WASHINGTON — The Internal Revenue Service today reminds seniors and retirees that they are not required to take money out of their IRAs and workplace retirement plans this

The Coronavirus Aid, Relief, and Economic Security Act, or CARES Act, waives required minimum distributions during 2020 for IRAs and retirement plans, including beneficiaries with inherited accounts. This waiver includes RMDs for individuals who turned age 70 ½ in 2019 and took their first RMD in 2020. Roth IRAs do not require withdrawals until after the death of the owner.

What if I already took my RMD?

If an individual has already taken an RMD in 2020, including someone who turned 70 ½ during 2019, the individual will have the option of returning the distribution to their account or other qualified plan.

Since the RMD rule is suspended, RMDs taken in 2020 are considered eligible for rollover. Therefore, RMDs can be rolled over to another IRA, another qualified retirement plan, or returned to the original plan.

An IRA owner or beneficiary who has already received an RMD in 2020 can also repay the distribution to the distributing IRA no later than Aug. 31, 2020, to avoid paying taxes on that distribution.

IRS Notice 2020-51 also provides that the one rollover per 12-month period limitation and the restriction on rollovers to inherited IRAs do not apply to this repayment.

The CARES Act provisions apply to most retirement plans, including traditional IRAs, SEP IRAs, SIMPLE IRAs, 401(k) plans, 403(b) plans, 457(b) plans, profit sharing plans and other defined contribution plans. The RMD suspension does not apply to qualified defined benefit

# LOS ANGELES COUNTY COVID-19 UPDATE 7/17/2020

### As COVID-19 Cases Increase, Public HealthMonitors for MIS-C

As COVID-19 cases and hospitalizations increase, I who are affected with MIS-C are rare, but we are the Los Angeles County Department of Public Health (Public Health) continues to monitor for multisystem inflammatory syndrome in children (MIS-C) that is affecting a number of children under 21 years of age across the country who may have been exposed to COVID-19 or has COVID-19.

To date, Public Health has identified 15 cases of MIS-C in LA County with a median age of 8 years, 7 months old. Forty percent of these cases were between ages of 0 and 5 years old, 40% were between the ages of 6 and 12 years old, and 20% were between the ages of 13 and 20 years old. The majority of cases (73%) were Latino/ Latinx. No reported cases have died.

MIS-C is a condition where different body parts can become inflamed, including the heart, lungs, kidneys, brain, skin, eyes, or gastrointestinal organs.

Public Health is advising physicians to consider for MIS-C in patient children under 21 years old who present with the clinical presentation and to notify the department immediately of any cases.

Public Health confirms 62 new deaths and 2,885 new cases of COVID-19. Over the last 48 hours there have been 7,477 new cases. To date, Public Health has identified 150,319 positive cases of COVID-19 across all areas of LA County, and a total of 4,047 deaths.

Of the 62 new deaths, 45 people who died were over the age of 65 years old, 15 people who died were be-tween the ages of 41 and 65 years old and one person who died was between the ages of 18 and 40 years old. 22 people had underlying health conditions including nine people over the age of 65 years old and 13 people between the ages of 41 to 65 years old. One death was reported by the City of Long Beach.

There are 2,122 confirmed cases of COVID-19 currently hospitalized, 26% of these people are confirmed cases in the ICU and 18% are confirmed cases on ventilators. Data continues to show younger people between the ages of 18 and 40 years old are being hospitalized at a higher rate than seen at any point in this

Ninety-three percent of people who died had underlying health conditions. Of those who died, information about race and ethnicity is available for 3,760 people (99 percent of the cases reported by Public Health); 46% of deaths occurred among Latino/Latinx residents, 26% among White residents, 15% among Asian residents, 11% among African American/Black residents, less than 1% among Native Hawaiian/Pacific Islander residents and 2% among residents identifying with other races. Upon further investigation, 34 cases and three deaths reported earlier were not LA County residents.

Testing results are available for over 1,465,000 individuals with 9% of all people testing positive.

To the families that are experiencing the sorrow of losing a loved one to COVID-19, please know that our thoughts and prayers are with you every day," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "We know that more than 10,000 children and teens have been infected with COVID-19. Those

monitoring for this devasting condition. I also want to warn parents that even though our children and teens may not show the same symptoms and illness of COVID-19 when compared to older people, they can spread COVID-19 like anyone else and should wear face coverings if they are two years old and older and they should continue to practice physical distancing and avoid gathering with people outside of their household. Bars, indoor dining at restaurants, indoor museums, indoor operations at zoos and aquariums, and cardrooms and satellite wagering facilities remain closed and all events and gatherings unless specifically allowed by this Order remain prohibited.

Residents need to make sure they are doing their part as well. Residents should always wear a face covering securely over their nose and mouth and keep six feet apart from others not in their household when out in public and wash hands frequently. Everyone should avoid the Three Cs: Crowded places, Confined spaces and Close contact with others not in your household. Public Health reminds everyone that you remain safer at home.

It's important if someone thinks they could be positive for COVID-19 and are awaiting testing results, to stay at home and act as if they are positive. This means selfisolating for 10 days and 72 hours after symptoms and fever subside. If a person tests positive for COVID-19, they should plan on receiving a call from a public health specialist to discuss how to protect themselves and others, to find out where they may have been, and who they were in close contact with while infectious.

### WEEK TWO OF OUR COVID 19 COOK AT HOME SERIES COOKIE **DOUGH EASY AS 1 2 3 WITH PETER DILLS**

I used to think that the bacteria may be originating from raw eggs, so we created eggless cookie doughs. Terrible, right?! We thought the way to make edible cookie dough safe to eat was to simply leave out the eggs. You see, some raw eggs can contain salmonella. But raw eggs alone are not the only culprit. We've also discovered that E. coli can be viable in baking flour. Unbaked flour itself can contain È. coli contamination and can be just as damaging to your health as raw eggs. So, in short, it's not advisable to eat raw cookie dough or other foods that use unbaked flour or raw eggs.

First you'll want to kill the bacteria in the raw flour by heating it to at least 165°Fto pasteurize the flour. You can quickly and easily pasteurize raw flour using one of these simple methods:

- Microwave the flour for 1 minute and 30 seconds, stirring it every 15 seconds, or Bake the flour spread out on a baking sheet and toast in a preheated oven at 350°F for 5 to 7
- minutes. Regardless of the method, use an instant-read thermometer to ensure that the flour reaches

How To Pasteurize Eggs

- Bring the eggs (in their shells) to room temperature (20 to 30 minutes before pasteurizing). Place the eggs in a saucepan filled with cold water and fitted with a digital thermometer. Turn on the heat and bring the water up to 140°F.
- Keep the water temperature at 140°F for 3 minutes (and no more than 142°F), reducing the heat
- on the burner if necessary. Remove the eggs from hot water and rinse immediately and thoroughly with cold water.
  - Store the pasteurized eggs in the refrigerator until needed or use right away.





Dear PUSD Community,

The COVID-19 pandemic is continuing to have a tremendous impact on our lives. In the last several weeks, we have seen an alarming rise in COVID-19 cases.

Yesterday, [July 13, 2020] Governor Newsom announced modifications to the "Stay at Home" orders and closed indoor activities in Los Angeles and other counties in California due to current public health conditions. Also yesterday, the L.A. County Department of Public Health and the L.A. County Office of Education issued new guidelines and protocols for opening K-12 schools in the new academic year. L.A. County Public Health stated that, given current health data, we must all prepare to remain in a remote learning environment in the new school year.

From the beginning of the pandemic, every decision that our district has made has been based on science, facts, and the law, with the safety and well-being of our students and staff at the forefront. We have been working in collaboration with the Board of Education, our labor partners, families, and community partners to plan for the safe reopening of our campuses in the new school year. After surveying parents, we had hoped to safely reopen schools in a hybrid model with students attending school on campus on alternate days and an option for 100% online learning. In our online school survey which ended Sunday, we had more than 13,000 responses, a very high completion rate for a survey. We appreciate your engaging with us and sharing your thoughts.

All of us would like to see students back in school when it's safe to do so. But Los Angeles County has recorded a surge in new cases in the last week, with a 9% rate of positive cases.

We cannot and will not take chances with the health and safety of our students and staff. I plan to bring a recommendation to the Board of Education at a special meeting on July 16 that Pasadena Unified open in a 100% distance learning model on August 17.

We will continue to monitor and evaluate public health conditions and guidelines and will let you know when it is possible to return to in-person learning on campus.

We have been preparing for the possibility of a full distance learning model. Our school reopening plan is designed to allow us to move seamlessly from a hybrid model to a full distance learning environment and back again as conditions change.

Distance learning will have a strengthened emphasis on teacher-student engagement, including more live interaction with certificated employees and peers for the purpose of instruction, progress monitoring, and maintaining school connectedness. We will provide specific details in the weeks

We will continue planning for a return to in-person learning during the 2020-21 academic year as soon as public health conditions allow and adequate resources are allocated by both the state and federal governments for the safe return to schools.

This ongoing situation is challenging for every one of us. But I know that with the strength, unity, and resolve that PUSD students, staff, and families have demonstrated during these last difficult months, we will get through this time.

# **2020 Census Operational** Adjustments Due to COVID-19

The 2020 Census is underway, and more than responded and more are responding every day. Online, phone, and mailed self-responses will continue throughout the data collection process. In light of the COVID-19 outbreak, the U.S. Census Bureau has adjusted 2020 Census operations in order to:

- Protect the health and safety of the American public and Census Bureau employees
- Implement guidance from federal, state, and local authorities regarding COVID-19.
- Ensure a complete and accurate count of all communities.

The Office of Management and Budget and the Office of Personnel Management have provided federal agencies with guidelines for resuming operations on an epidemiologically sound, data-driven basis, adhering to the latest federal, state, and local guidance. The Census Bureau

continues to monitor the changing conditions at the state and local level, and in consultation with the appropriate officials, update its planned start dates for selected operations in selected states.

The information the Census Bureau receives daily from FEMA and state and local authorities guides Census Bureau decisions on timing. As a result, selected field operations will resume on a phased schedule on a geographic basis.

Under the adjusted 2020 Census operational plan, the Census Bureau is conducting a series of preparatory activities so we are fully ready to resume field activities as we continue to advance the mission of the 2020 Census to ensure a complete and accurate count. In-person activities, including enumeration, office work, and processing activities, will always incorporate the most current guidance from authorities to ensure the health and safety of the public and Census Bureau employees.

# GOV. NEWSOM JOINS EDUCATORS IN PRIORITIZING SAFE REOPENING OF CALIFORNIA **SCHOOLS IN NEW GUIDANCE**

Clarity welcomed ahead of school year start; Distance learning for 33 counties on 'watch list;' Masks for grades 3-12, adults

BURLINGAME — CTA President E. Toby Boyd released the following statement regarding Gov. Gavin Newsom's newly-released guidelines to reopening schools amidst COVID-19 widespread surge:

"Today's updated guidance from Governor Newsom through the California Department of Public Health is a good step in providing some clarity and uniformity across the state. We cannot reopen schools unless it is safe!

"The new guidance provides clarity that distance learning should be the immediate course of action in any county that is on the state watch list and allows other districts to make those decisions in accordance with local health department officials. We also appreciate the specific guidance on requiring masks for students in grades three through 12, testing of school staff, and pushing districts to create Injury and Illness Prevention Programs that are transparent to parents and the community. We do, however, have concerns and will seek further clarity on the standards for closing a school (multiple cases, multiple cohorts vs. the five percent threshold) upon an outbreak and will be reviewing the rest of the guidance thoroughly.

"There's no one more eager to get back to school with their students than teachers. We miss and want to be with our students but are ready to engage with school districts to implement a robust distance learning program that is inclusive of all and equitable in resources and technology.

"Safe school reopening, quality distance learning and equity for our communities requires funding. Many local districts don't have the necessary resources or capacity to maintain even the most basic prevention measures of six feet physical distancing and limiting contacts, much less the other important preventative actions such as personal protective equipment (PPE), or adequate ventilation and cleaning supplies. In addition, studies show that 30 percent of K-12 students still do not have access to the internet or computers.

"That's why we're calling on lawmakers to return to the Capitol and adopt additional revenues, including additional suspension of corporate tax credits and exemptions, capturing unrealized capital gains or imposing a tax on the wealthiest billionaires and millionaires to help our students, families and communities survive through this crisis. CTA asks Governor Newsom to join us in supporting Proposition 15 to ensure large corporations pay their fair share of taxes to restore \$12 billion to our schools and communities. And, we stand with the three million educators throughout the nation in calling on the federal government to pass the HEROES Act to help mitigate the impact of the pandemic."

# **EXCERPT FROM "SQUATTER IN LOS ANGELES."**

Shortly after I moved in to the house where I was a squatter for a year and a half, I asked a tree pruner to dump his load of wood chips in my yard. He did so gladly, since it saved him a trip to the local dump and it saved him money. I took a rake and spread the chips throughout the southern end of the house, what I considered my garden area. This was soil that was hardpacked and probably had cars parked on it at one time. I would water these chips and the ground soon became a productive garden. I planted yellow and blue corn, amaranth, beans, tomatoes, chard, fennel and other vegetables. I also saved soup cans and milk containers and used them to plant my potted plants which I then tried to sell for income but more often gave away.

Eventually, I was given some ducks which I kept in the inner yard that was fenced. Animals are a responsibility, and they tie you to your place. That can be a good thing, or not. But they were a gift, and I said yes I needed to purchase some bags of duck food for them, and eventually I discovered an amazing thing about ducks.

My postage stamp-sized garden grew out of my wood chip patch where I grew corn and other foods. To water, I would simply place the hose down, turn it on, and let the water soak in to the wood chip-mulched garden. Once, after I turned on the water, the ducks rushed over and began to feast on something in the chips. Apparently, the water brought out the bugs from the soil and the ducks would methodically work the wet soil with great relish, making a low quacking sound as they went which seemed to say that they were very happy. After that, I learned that I could feed them less, and let them feed themselves from the garden after I turned on the hose.

My garden never seemed highly productive but I had a few of the tall red amaranth plants, some squash, a corn patch, some greens, and wild foods. I had wanted to try the so-called Three Sisters of the native Southwest, of corn, beans, and squash. In the arid soil of the Southwest, the corn was planted first, and once it arose beans were planted at the base of the each corn. The beans' roots fix nitrogen and this acts as a fertilizer to the corn. Squash was then planted as a sprawling ground cover to retain the valuable scant moisture of the desert

I planted my corn in my wood chip patch, three seeds per hole about two feet apart. Corn came up, and then I planted bean seeds. Not many beans came up -- maybe the ducks ate them. I planted squash too. Not a desert squash but ordinary zucchini which did a good job as a ground cover and food producer. I loved the little garden. During the day, little birds would flock to the corn patch and eat bugs. I enjoyed the fact that this little garden that I created with my simple efforts was now teeming with wildlife. It felt good just to look at it It provided food for my body, food for wildlife, and food for my soul.

Not long after I started this patch – it was near Thanksgiving – David Ashley came by for a visit. David had already moved into the neighborhood from wherever else he'd been living. He came up to the top of the hill where I was an illegal squatter. My housing status didn't cause David to lower his regard for me.

I took David out into my garden, and we stood there talking about life. I pulled off a ripe ear of corn and handed it to him and picked one for myself.

"What's this?" asked David.

"To eat," I responded as I began to peel off the leaves and hairs on my average size ear of corn. It took a bite of the sweet kernels.

"I didn't know you could eat corn raw," said David in a surprised voice.

"Yep, you can," I told him as I chewed on my sweet cob. David began to peel his and take some bites.

"Wow, that's really good!" said David, chewing on more kernels. We stood there for a few moments, eating our corn, looking at the outside world through the stalks of corn that were taller than us. It was a quiet, special moment.

Eventually, David left, and over the ensuing months, I would occasionally hear David telling someone about his surreal experience eating raw corn.

Video chatting is a great way to stay connected and keep tabs on an elder parent when you can't be there, but it's even more important now during this pandemic as many isolated seniors are also suffering from chronic loneliness.

To help connect you and your mom virtually, there are various products on the market that offer simple video calling for seniors who have limited ability or experience with technology. Here are four devices to consider.

GrandPad: This is a top option for simple video calling, and much more. The GrandPad is an 8-inch tablet specifically designed for seniors, ages 75 and older. It comes with a stylus, a charging cradle and 4G LTE built-in so it works anywhere within the Consumer Cellular network - home

Ready to go right out of the box, GrandPad provides a simplified menu of big icons and large text for only essential features, providing clutter-free, one-touch access to make and receive video calls, send voice emails, view photos and videos, listen to personalized music, check the weather, play games, browse the Internet and more.

A GrandPad tablet costs \$250 plus \$40 monthly service fee and is sold through Consumer Cellular at GrandPad.net or call 888-545-1425.

Amazon's Echo Show: With its built-in camera and screen, the voice-command Echo Show also provides a simple way to have face-to-face chats with your mom, but she'll need home Wi-Fi

Echo Shows, which come in three screen sizes – 5-inch (\$90), 8-inch (\$130) and 10-inch (\$230) – will let your mom make and receive video calls to those who have their own device, or who have the Alexa app installed on their smartphone or tablet.

Once you set up her contacts, to make a call your mom could simply say, "Alexa, call my daughter" And when you call her, she would ask Alexa to answer the call (or ignore it). There's also a feature called "drop-in" that would let you video call your mom's device anytime without her having to

Available at Amazon.com, the Echo Show also offers thousands of other features your mom would enjoy like voice-activated access to news, weather, her favorite music and much more.

If you decide to order an Echo Show device for mom, be sure your ask Amazon to mark it as a gift so it doesn't get tied to your Amazon account. For instructions to help your mom set it up, or if she doesn't have a smartphone, go to Amazon.com/gp/help/customer/display.html, and type in "Help Loved Ones Set Up Their Echo Show Remotely" in the "find more solutions" bar.

ViewClix: This is a smart picture frame specifically designed for elderly seniors that lets family members make video calls, send photos and post virtual sticky notes with messages to their loved ones ViewClix from their smartphone, tablet or computer. Seniors, however, cannot initiate video calls from their ViewClix. Home Wi-Fi is also required.

Available in two sizes - 10-inch for \$199, and 15-inch for \$299 - you can learn more about this product at ViewClix.com.

Portals, which come in three sizes – the original 10-inch Portal (\$179), the 8-inch Mini (\$129) and the massive 15-and-a-half-inch Portal Plus (\$279) – are like Echo Shows, except they connect through Facebook. With a Portal, your mom can video call your smartphone or tablet (and vice versa) using Facebook Messenger or WhatsApp.

### COVID-19 HIGHLIGHTS CRITICAL **NEED FOR ADVANCE HEALTHCARE DIRECTIVES**

Americans to create the proper estate planning documents, so medical providers can better coordinate their careshould they be come hospitalized with the virus

The most critical planning tools for this purpose are medical power of attorney and a living will, advance healthcare directives that work together to help describe your wishes for medical treatment and endof-life care in the event you're unable to express your desires. In light of COVID-19, even those who have already created these documents should revisit them to ensure they are up-to-date.

While all adults over age 18 should put these documents in place as soon as possible, if you are over age 60 or have a chronic underlying health condition, the need is particularly urgent.

Medical power of attorney is an advance directive that allows you to name a person, known as your "agent," to make healthcare decisions for you if you're incapacitated and unable to make those decisions yourself. For example, if you are hospitalized with COVID-19 and need to be placed in a medically induced coma, this person would have the legal authority to advise doctors about your subsequent

If you become incapacitated without medical power of attorney, physicians may be forced to ask the court to appoint a legal guardian to be your decision maker. The person given this responsibility could be someone you'd never want having power over such life or death decisions—and that's why having medical powers of attorney is so important.

While medical powers of attorney names who can make health-care decisions in the event of your incapacity, a living will explains how your care should be handled, particularly at the end of life. For example, if you should become seriously ill and unable to manage your own treatment, a living will can guide your agent to make these medical decisions on your behalf.

These decisions could include if and when you want life support removed, whether you would want hydration and nutrition, and even what kind of food you want and who can visit you. To ensure your medical treatment is handled in exactly the way you want and prevent your family from undergoing needless stress and conflict during an already trying time, it's vital that you document such wishes in a living will.

As the COVID-19 Keep your directives updated p a n d e m i c Even if you've already created advanced directives, c o n t i n u e s | now is the perfect time to review the documents to ensure they still match your wishes and circumstances For instance, is the agent named in your medical power of attorney still the individual you'd want making these decisions? Do you have alternate agents named in case your primary choice is unable to serve? Has your health changed in ways that might affect your living will's instructions? Are your values and wishes regarding end-of-life still the same?

> What's more, whether you are creating new documents or updating your old ones, you should keep COVID-19 in mind. The highly contagious and life-threatening nature of the coronavirus is something medical providers have never dealt with before, and it has strained our nation's healthcare system to the breaking point.

You don't want anything slowing down your treatment options if you contract COVID-19. Because COVID-19 is so contagious, family members of those who've contracted the virus are often not allowed to accompany them to the hospital. This means your agent likely won't be there in person to make your treatment decisions. Ensure your agent has access to a copy of your directives and be sure to take a copy with you, along with contact info for your agent, if you must go to the hospital for treatment.

While you'll find a wide selection of generic, advancedirective documents online, you shouldn't trust these do-it-yourself forms to adequately address such critical decisions. This is especially true during the ongoing pandemic, when doctors are constantly tasked with making highly difficult and uncertain decisions for patients suffering from this deadly new virus.

When it comes to your medical treatment and end-oflife care, you have unique needs and wishes that just can't be anticipated by fill-in-the-blank documents. To ensure your directives are specifically tailored to suit your unique situation, you must work with experienced planning professionals to create—or at the very least, review—your medical power of attorney


> Then there is the question as to your definition of a mistake. I am sure my definition would be quite different from my wife's. Everybody has their own definition of these things.

During these Covid 19 times of limited professional day care my wife and I are helping take care of our granddaughter two or three times a week. This allows my daughter to work fairly undisturbed from her home and still keep her Law Practice going. My wife does all the changing and feeding and bottle warming. You know the unimportant stuff, while I try to be helpful. Mainly, I just make faces and laugh with the baby and have a wonderful time just observing. I've seen how hard it is to be a baby. Sitting up and turning over is really tough and then comes crawling and now she is working on standing. She works so hard and often fails and then fails again but always keeps trying. She is quite the chatterbox already and obviously is experimenting. I think listening to our speech is necessary to make the subtle decisions

# IF COVID ISN'T A NATIONAL TRAGEDY, WHAT IS?



'My fellow Americans, I am today ordering that Monday, August 3, shall be a national day of mourning. All of us should take time on that day to honor the memories of more than 134,000 souls taken by ĆOVID-19. Flags will be lowered to half staff." -Donald J. Trump, President

"When our leagues resume play for their shortened seasons, all players will wear black uniform patches to acknowledge the tragic coronavirus deaths." - Adam Silver, NBA Commissioner; Rob Manfred, MLB

"I am asking all New Yorkers to observe a moment of silence at noon each day until further notice, as we remember the lives lost to COVID-19. I urge people in cities and towns across the nation to join the citizens of New York in expressing our collective grief." - Bill de Blasio, Mayor

None of these statements has been made, and a reasonable question is, why?

What's happening to us? Are we already experiencing what could be called the "thoughts and prayers" phenomenon?

So often, when tragic events have leapt to the top of our collective consciousness, Americans have pledged to never forget, to take action, to work for social and political change and, of course, to offer thoughts and prayers to the victims and their families. Then, as has happened so often with gun violence, we quash our emotions and move on.

One thing is certain: the public and its news media can't rely on the Trump administration to acknowledge the gravity of the pandemic. Our president is never seen shedding a tear or leading the nation in grieving. Better to resume campaign rallies in a display of reckless disregard for the well-being of the living and the memories of the dead.

Police brutality is absolutely worthy of protests and outrage, but the overpowering national objection to it in recent weeks is in strange contrast to the failed pandemic response. Yes, many Americans complied with social distancing and other rules at least for a few months - but why hasn't the nation stood in protest over scandalous conditions at nursing homes, prisons, and meatpacking plants?

With a U.S. COVID-19 death toll greater in five months than the 14 years of American combat in the Korean and Vietnam wars combined (95,000 lives lost), many of us are in deep despair over this horrific loss, while others seem unable - or unwilling – to process such staggering numbers. America's difficulty in putting the pandemic's toll in proper perspective is causing significant emotional, social and political problems.

Where do senior citizens, particularly those who are in nursing homes, rank? I've heard some right-wing talk show hosts shamefully scoff that many of the dead are old, some already suffering other illnesses. Between the lines: These deaths are less newsworthy because they don't count as much as those of younger persons.

Even the basic math has become controversial. Some conservatives claim death counts are being inflated to make the Trump administration's handling of the crisis appear worse than it is. Others, including the head of the Centers for Disease Control, Robert Redfield, believe the toll is much higher – as much as 10 times higher than has been reported.

When some politicians and their misguided followers choose to treat death counts as mere points on a graph, much like a stock table, it leads to reckless decisions about reopening public places before safety conditions are met. It creates a national numbness. It allows politicians to frame the deaths as collateral damage in their self-proclaimed war. It twists a national crisis into a political pretzel.

No one's death, regardless of age or pre-existing medical condition, should be dismissed as a statistic. Why aren't we wearing pins or ribbons in remembrance of the dead? In addition to 7 p.m. tributes for heroic doctors and nurses, why isn't there also a national moment of silence at noon each day to honor those who have passed? Or a national day of mourning? Why aren't more flags at half staff?

News organizations have devoted enormous space and airtime to the pandemic. Most, including this one, have worked vigilantly to track down individual stories and give names and faces to the dead. But it's not enough.

Our friends and neighbors are dying in unthinkable numbers. When we stop giving that proper focus it's the first step in allowing a president and his cowardly allies on Capitol Hill to escape retribution at the ballot box in November.

We talk a lot these days about a "new normal." If by normal we mean treating so many deaths as routine, then we should be ashamed. I can think of over 134,000 reasons why.

# DR. FAUCI, WE ALWAYS KNEW IT WOULD COME TO THIS

Let's begin today with Joe Biden, who is far too often trumped by the tumultuous roar of the MAGA train wreck. Biden, who currently leads Trump by nine points nationally and by as many as five points in Texas (Texas!), had a few choice things to say about the Trump regime's treacherous efforts to

discredit Dr. Anthony Fauci.

The presumptive Democratic nominee tweeted: "Donald Trump needs to spend less time playing golf and more time listening to experts like Dr. Fauci." And the Biden campaign said: "The president's disgusting attempt to pass the buck by blaming the top infectious disease expert in the country - whose advice he repeatedly ignored and Joe Biden consistently implored him to take - is yet another horrible and revealing failure of leadership as the tragic death toll continues to needlessly grow."

Trump's cultists will surely view those complaints as "partisan," but let us recall how the senior George Bush responded, during a presidential debate in 1988, when he was asked to name some of his heroes: "I think of Dr. Fauci...He's a very fine researcher - top doctor at the National Institute of Health – working hard doing something about research on this disease of AIDS." And indeed he was, while serving the first of six presidents - of

The problem now is Fauci serves an anti-science ignoramus who can't abide anyone who outshines him in the public eye, and therefore it was inevitable that he would be marginalized and kept off TV. A national poll recently reported that 67 percent of Americans trust Fauci to deliver "accurate information" about the pandemic, while only 26 percent trust Trump. Nobody who tells the truth - not Alexander Vindman, or James Mattis, or Marie Yovanovich – can breathe free in Trump's fetid swamp.

Fauci recently told the Financial Times, "I have a reputation, as you probably figured out, of speaking the truth at all times and not sugar-coating things." No wonder Trump is trying to put him out to pasture.

It does seem foolish, as a re-election strategy, to attack the nation's top infectious expert in the midst of a roaring pandemic. But this hapless husk of a regime, plagued by a mounting death toll and horrified at the prospect of defeat, has gone off the deep end. In the words of conservative commentator Michael Gerson, who served in the second Bush White House, the baseless assault on Fauci "indicates an administration so far gone in rage, bitterness and paranoia that it can no longer be trusted to preserve

Lest we forget, Fauci started to draw heat way back in March, when he was already warning about the dangers of "community spread." Trump, at the time, was already in sugar-coat mode, dreaming of packed churches on Easter Sunday, and his fans on the rabid right were already circulating the hashtag #faucifraud.

So what we're seeing now is merely an acceleration of the MAGA rage against reality. Fauci, assessing the pandemic, is trying to warn us that "we haven't even begun to see the end of it yet," even as Trump lied last Friday that "we are winning the war." But what about the titanic spikes in Texas and Arizona, spikes triggered by the insane decision (goaded by Trump) to reopen too early? No problem at all, according to Trump: "They're going to have it under control very quickly."

But there's one cure for the virus of ignorance:

Just ignore Trump and heed Fauci. A landslide share of Americans are doing that already.

Technically, Trump can't even fire Fauci, at least not without waging a protracted bureaucratic battle that will backfire against the guy whose credibility outside the cult is already nil. Trump can't thwart Fauci's impulse to speak truth to power - or stop Americans from listening.

Trump's sole motive is selfish – to stay in office and out of jail. Fauci's sole motive is selfless – to keep Americans alive and healthy. Game over.

Of all the stupid things Trump has said and done, fingering Fauci as a fall guy is surely in the top tier.

# SUPPORT YOUR LOCAL NEWSPAPER!

Please help us save your weekly newspaper! The National Emergency has had an immediate adverse impact on the future of the Mountain Views News. (www.mtnviewsnews.com)

Since 2006, I have been publishing a weekly newspaper in the San Gabriel Valley specifically covering the cities of Sierra Madre, Arcadia, Monrovia, Duarte, Pasadena, and also South Pasadena, Altadena and San Marino. This effort has been financially challenging primarily due to the nature of publishing and because of a 40% tariff on newsprint that was imposed in 2018 and is still in affect.

We have survived primarily on the paper's ability to publish legal notices and the support of our advertisers many of whom are also impacted by the COVID19 virus. However, that has all changed. We were informed mid-March that the County of Los Angeles closed all public access to buildings that process legal notices. Such action, while absolutely necessary means that the income generated from the publication of the notices has come to an abrupt halt. Without the ability to publish legal notices, continued publication of the Mountain Views News is not possible.







# CELEBRATE FREEDOM

# The Declaration of Independence:

#### IN CONGRESS, July 4, 1776.

The unanimous Declaration of the thirteen united States of America,

When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.--Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world.

He has refused his Assent to Laws, the most wholesome and necessary for the public good.

He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them.

He has refused to pass other Laws for the accommodation of large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only.

He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their public Records, for the sole purpose of fatiguing them into compliance with his measures.

He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.

He has refused for a long time, after such dissolutions, to cause others to be elected; whereby the Legislative powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the dangers of invasion from without, and convulsions within. convulsions within.

He has endeavoured to prevent the population of these States; for that purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands.

He has obstructed the Administration of Justice, by refusing his Assent to Laws for establishing Judiciary powers.

He has made Judges dependent on his Will alone, for the tenure of their offices, and the amount and payment of their salaries.

He has erected a multitude of New Offices, and sent hither swarms of Officers to harrass our people, and eat out their substance.

He has kept among us, in times of peace, Standing Armies without the Consent of our legislatures. He has affected to render the Military independent of and superior to the Civil power. He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation: For Quartering large bodies of armed troops among us:

For protecting them, by a mock Trial, from punishment for any Murders which they should commit on the Inhabitants of these States: For cutting off our Trade with all parts of the world:
For imposing Taxes on us without our Consent:
For depriving us in many cases, of the benefits of Trial by Jury:
For transporting us beyond Seas to be tried for pretended offences
For abeliable to the free System of English Laws in a possible vision. Province potablishing therein an Arbitrary government and of

For transporting us beyond Seas to be tried for pretended offences
For abolishing the free System of English Laws in a neighbouring Province, establishing therein an Arbitrary government, and enlarging its
Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies:
For taking away our Charters, abolishing our most valuable Laws, and altering fundamentally the Forms of our Governments:
For suspending our own Legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever.
He has abdicated Government here, by declaring us out of his Protection and waging War against us.
He has plundered our seas, ravaged our Coasts, burnt our towns, and destroyed the lives of our people.
He is at this time transporting large Armies of foreign Mercenaries to compleat the works of death, desolation and tyranny, already begun with circumstances of Cruelty & perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.
He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the executioners of their friends and Brethren, or to fall themselves by their Hands.
He has excited domestic insurrections amongst us, and has endeavoured to bring on the inhabitants of our frontiers, the merciless Indian Savages,

He has excited domestic insurrections amongst us, and has endeavoured to bring on the inhabitants of our frontiers, the merciless Indian Savages, whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions.

In every stage of these Oppressions We have Petitioned for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Prince whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

Nor have We been wanting in attentions to our Brittish brethren. We have warned them from time to time of attempts by their legislature to extend an unwarrantable jurisdiction over us. We have reminded them of the circumstances of our emigration and settlement here. We have appealed to their native justice and magnanimity, and we have conjured them by the ties of our common kindred to disavow these usurpations, which, would inevitably interrupt our connections and correspondence. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Enemies in War, in Peace Friends.

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare, That these United Colonies are, and of Right ought to be Free and Independent States; that they are Absolved from all Allegiance to the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace, contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. And for the support of this Declaration, with a firm reliance on the protection of divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.



#### FYI: WHO SIGNED THE U.S. CONSTITUTION?

The 38 signers of the U.S. Constitution were delegates from the original states who gathered several times and in several places, first drafting the Declaration of Independence, and then, after the colonists defeated the British army and won independence, writing the U.S. Constitution. The signers of the two documents have some overlap — Benjamin Franklin signed both, but John Hancock wrote large only on the Declaration of Independence. #### THE PREAMBLE

Tranquility, provide for the common defence, promote Each House may determine the Rules of its Proceedings, the general Welfare, and secure the Blessings of Liberty to punish its Members for disorderly Behaviour, and, with ourselves and our Posterity, do ordain and establish this the Concurrence of two thirds, expel a Member.

Constitution for the United States of America.

#### ARTICLE I

Section 1 All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Legislature.

No Person shall be a Representative who shall not have attained to the Age of twenty five Years, and been seven Years a Citizen of the United States, and who shall not, when elected, be an Inhabitant of that State in which he

Representatives and direct Taxes shall be apportioned among the several States which may be included within this Union, according to their respective Numbers, which shall be determined by adding to the whole Number of free Persons, including those bound to Service for a Term of Years, and excluding Indians not taxed, three fifths of all other Persons. The actual Enumeration shall be made within three Years after the first Meeting of the Congress of the United States, and within every subsequent Term of ten Years, in such Manner as they shall by Law direct. The Number of Representatives shall not exceed one for every thirty Thousand, but each State shall have at Least one Representative; and until such enumeration shall be made the State of New Hampshire shall be entitled. one Representance; and until such enumeration shall be made, the State of New Hampshire shall be entitled to chuse three, Massachusetts eight, Rhode Island and Providence Plantations one, Connecticut five, New-York six, New Jersey four, Pennsylvania eight, Delaware one, Maryland six, Virginia ten, North Carolina five, South Carolina five, and Georgia three.

When vacancies happen in the Representation from any State, the Executive Authority thereof shall issue Writs of Election to fill such Vacancies.

The House of Representatives shall chuse their Speaker and other Officers; and shall have the sole Power of Impeachment.

The Senate of the United States shall be composed of two Senators from each State, chosen by the Legislature thereof, for six Years; and each Senator shall have one

Immediately after they shall be assembled in Consequence of the first Election, they shall be divided as equally as may be into three classes. The Seats of the Senators of may be into three classes. The Seats of the Senators of the first Class shall be vacated at the Expiration of the second Year, of the second Class at the Expiration of the fourth Year, and of the third Class at the Expiration of the sixth Year, so that one third may be chosen every second Year; and if Vacancies happen by Resignation or otherwise, during the Recess of the Legislature of any State, the Executive thereof may make temporary Appointments until the next Meeting of the Legislature, which shall then fill such Vacancies.

No Person shall be a Senator who shall not have attained to the Age of thirty Years, and been nine Years a Citizen of the United States, and who shall not, when elected, be an Inhabitant of that State for which he shall be chosen.

The Vice President of the United States shall be President of the Senate, but shall have no Vote, unless they be equally divided.

The Senate shall chuse their other Officers, and also a President pro tempore, in the Absence of the Vice President, or when he shall exercise the Office of President of the United States.

The Senate shall have the sole Power to try all Impeachments. When sitting for that Purpose, they shall be on Oath or Affirmation. When the President of the United States is tried, the Chief Justice shall preside: And no Person shall be convicted without the Concurrence of two thirds of the Members present.

Judgment in Cases of Impeachment shall not extend further than to removal from Office, and disqualification to hold and enjoy any Office of honor, Trust or Profit under the United States: but the Party convicted shall nevertheless be liable and subject to Indictment, Trial, Judgment and Punishment, according to Law.

The Times, Places and Manner of holding Elections for Senators and Representatives, shall be prescribed in each State by the Legislature thereof; but the Congress may at any time by Law make or alter such Regulations, except as to the Places of chusing Senators.

The Congress shall assemble at least once in every Year, and such Meeting shall be on the first Monday in December, unless they shall by Law appoint a different

Section 5
Each House shall be the Judge of the Elections, Returns and Qualifications of its own Members, and a Majority of each shall constitute a Quorum to do Business; but a smaller Number may adjourn from day to day, and may be authorized to compel the Attendance of absent

Members, in such Manner, and under such Penalties as land and naval Forces;

Each House shall keep a Journal of its Proceedings and from time to time publish the same, excepting such Parts as may in their Judgment require Secrecy; and the Yeas and Nays of the Members of either House on any question shall, at the Desire of one fifth of those Present, be entered on the Journal.

Neither House, during the Session of Congress, shall, without the Consent of the other, adjourn for more than three days, nor to any other Place than that in which the two Houses shall be sitting.

The Senators and Representatives shall receive a Compensation for their Services, to be ascertained by Compensation for their Services, to be ascertained by Law, and paid out of the Treasury of the United States. They shall in all Cases, except Treason, Felony and Breach of the Peace, be privileged from Arrest during their Attendance at the Session of their respective Houses and in going to and returning from the same; and for any Speech or Debate in either House, they shall not be questioned in any other Place.

No Senator or Representative shall, during the Time for which he was elected, be appointed to any civil Office under the Authority of the United States, which shall have been created, or the Emoluments whereof shall have been encreased during such time; and no Person holding any Office under the United States, shall be a Member of either House during his Continuance in Office.

All Bills for raising Revenue shall originate in the House of Representatives; but the Senate may propose or concur with Amendments as on other Bills.

Every Bill which shall have passed the House of Representatives and the Senate, shall, before it become a Law, be presented to the President of the United States; If he approve he shall sign it, but if not he shall return it, with his Objections to that House in which it shall have originated, who shall enter the Objections at large on their Journal, and proceed to reconsider it. If large on their Journal, and proceed to reconsider it. If after such Reconsideration two thirds of that House shall agree to pass the Bill, it shall be sent, together with the Objections, to the other House, by which it shall likewise be reconsidered, and if approved by two thirds of that House, it shall become a Law. But in all such Cases the Votes of both Houses shall be determined by yeas and Nays, and the Names of the Persons voting for and against the Bill shall be entered on the Journal of each House respectively. If any Bill shall not be returned by the President within ten Days (Sundays excepted) after it shall have been presented to him, the Same shall be a Law, in like Manner as if he had signed it, unless the Congress by their Adjournment prevent its Return, in which Case it shall not be a Law.

Every Order, Resolution, or Vote to which the Concurrence of the Senate and House of Representatives may be necessary (except on a question of Adjournment) shall be presented to the President of the United States; and before the Same shall take Effect, shall be approved by him, or being disapproved by him, shall be repassed by two thirds of the Senate and House of Representatives, according to the Rules and Limitation prescribed in the Case of a Bill.

#### Section 8

The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defence and general Welfare of the United States; but all Duties, Imposts and Excises shall be uniform throughout the United States;

To borrow Money on the credit of the United States;

To regulate Commerce with foreign Nations, and among the several States, and with the Indian Tribes;

establish an uniform Rule of Naturalization, and uniform Laws on the subject of Bankruptcies throughout the United States;

To coin Money, regulate the Value thereof, and of foreign Coin, and fix the Standard of Weights and Measures;

To provide for the Punishment of counterfeiting the Securities and current Coin of the United States:

To establish Post Offices and post Roads:

To promote the Progress of Science and useful Arts, by securing for limited Times to Authors and Inventors the exclusive Right to their respective Writings and

To constitute Tribunals inferior to the supreme Court:

To define and punish Piracies and Felonies committed on Elector. the high Seas, and Offences against the Law of Nations;

To declare War, grant Letters of Marque and Reprisal, and make Rules concerning Captures on Land and Water;

To raise and support Armies, but no Appropriation of Money to that Use shall be for a longer Term than two

To provide and maintain a Navy;

To make Rules for the Government and Regulation of the

To provide for calling forth the Militia to execute the Laws of the Union, suppress Insurrections and repel

To provide for organizing, arming, and disciplining, the Militia, and for governing such Part of them as may be employed in the Service of the United States, reserving to the States respectively, the Appointment of the Officers, and the Authority of training the Militia according to the discipline prescribed by Congress;

To exercise exclusive Legislation in all Cases whatsoever, over such District (not exceeding ten Miles square) as over such District (not exceeding ten Miles square) as may, by Cession of particular States, and the Acceptance of Congress, become the Seat of Government of the United States, and to exercise like Authority over all Places purchased by the Consent of the Legislature of the State in which the Same shall be, for the Erection of Forts, Magazines, Arsenals, dock-Yards, and other needful Buildings;—And

To make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any Department or Officer thereof.

The Migration or Importation of such Persons as any of the States now existing shall think proper to admit, shall not be prohibited by the Congress prior to the Year one thousand eight hundred and eight, but a Tax or duty may be imposed on such Importation, not exceeding ten dollars for each Person.

The Privilege of the Writ of Habeas Corpus shall not be suspended, unless when in Cases of Rebellion or Invasion the public Safety may require it.

No Capitation, or other direct, Tax shall be laid, unless in Proportion to the Census or enumeration herein before directed to be taken.

No Tax or Duty shall be laid on Articles exported from any State.

No Preference shall be given by any Regulation of Commerce or Revenue to the Ports of one State over those of another: nor shall Vessels bound to, or from, one State, be obliged to enter, clear, or pay duties in another.

No Money shall be drawn from the Treasury but in Consequence of Appropriations made by Law; and a regular Statement and Account of the Receipts and Expenditures of all public Money shall be published from time to time.

No Title of Nobility shall be granted by the United States: And no Person holding any Office of Profit or Trust under them, shall, without the Consent of the Congress accept of any present, Emolument, Office, or Title, of any kind whatever, from any King, Prince, or foreign State

Section 10

No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; make any Thing but gold and silver Coin a Tender in Payment of Debts; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility.

No State shall, without the Consent of the Congress, lay any Imposts or Duties on Imports or Exports, except what may be absolutely necessary for executing it's inspection Laws: and the net Produce of all Duties and Imposts, laid by any State on Imports or Exports, shall be for the Use of the Treasury of the United States; and all such Laws shall be subject to the Revision and Controul of the Congress.

No State shall, without the Consent of Congress, lay any Duty of Tonnage, keep Troops, or Ships of War in time of Peace, enter into any Agreement or Compact with another State, or with a foreign Power, or engage in War, unless actually invaded, or in such imminent Danger as will not admit of delay.

#### ARTICLE II

#### Section 1

The executive Power shall be vested in a President of
the United States of America. He shall hold his Office
during the Term of four Years, and, together with the
Vice President, chosen for the same Term, be elected, as

Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress: but no Senator or Representative, or Person holding an Office of Trust or Profit under the United States, shall be appointed an

The Electors shall meet in their respective States, and vote by Ballot for two Persons, of whom one at least shall vote by Ballot for two Persons, of whom one at least shall not be an Inhabitant of the same State with themselves. And they shall make a List of all the Persons voted for, and of the Number of Votes for each; which List they shall sign and certify, and transmit sealed to the Seat of the Government of the United States, directed to the President of the Senate. The President of the Senate shall, in the presence of the Senate and House of Representatives, open all the Certificates, and the Votes shall then be counted. The Person having the

greatest Number of Votes shall be the President, if such Number be a Majority of the whole Number of Electors appointed; and if there be more than one who have such Majority, and have an equal Number of Votes, then the House of Representatives shall immediately chuse by Ballot one of them for President; and if no Person have a Ballot one of them for President; and if no Person have a Majority, then from the five highest on the List the said House shall in like manner chuse the President. But in chusing the President, the Votes shall be taken by States, the Representation from each State having one Vote; A quorum for this Purpose shall consist of a Member or Members from two thirds of the States, and a Majority of all the States shall be recovery to a Choice. In surprise of all the States shall be necessary to a Choice. In every Case, after the Choice of the President, the Person having the greatest Number of Votes of the Electors shall be the Vice President. But if there should remain two or more who have equal Votes, the Senate shall chuse from them by Ballot the Vice President.

The Congress may determine the Time of chusing the Electors, and the Day on which they shall give their Votes; which Day shall be the same throughout the

No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any Person be eligible to that Office who shall not have attained to the Age of thirty five Years, and been fourteen Years a Resident within the United States

In Case of the Removal of the President from Office or of his Death, Resignation, or Inability to discharge the Powers and Duties of the said Office, the Same shall devolve on the Vice President, and the Congress may by law provide for the Case of Removal, Death, Resignation or Inability, both of the President and Vice President, declaring what Officer shall then act as President, and such Officer shall act accordingly, until the Disability be removed, or a President shall be elected.

The President shall, at stated Times, receive for his Services, a Compensation, which shall neither be encreased nor diminished during the Period for which he shall have been elected, and he shall not receive within that Period any other Emolument from the United States, or any of them.

Before he enter on the Execution of his Office, he shall take the following Oath or Affirmation:—I do solemly swear (or affirm) that I will faithfully execute the Office of President of the United States, and will to the best of my Ability, preserve, protect and defend the Constitution of the United States.

The President shall be Commander in Chief of the Army and Navy of the United States, and of the Militia of the several States, when called into the actual Service of the United States; he may require the Opinion, in writing, of the principal Officer in each of the executive Departments, upon any Subject relating to the Duties of their respective Offices, and he shall have Power to grant Reprieves and Pardons for Offences against the United States, except in Cases of Impeachment.

He shall have Power, by and with the Advice and Consent of the Senate, to make Treaties, provided two thirds of the Senators present concur; and he shall nominate, and by and with the Advice and Consent of the Senate, and by and with the Advice and Consent of the Senate, shall appoint Ambassadors, other public Ministers and Consuls, Judges of the supreme Court, and all other Officers of the United States, whose Appointments are not herein otherwise provided for, and which shall be established by Law: but the Congress may by Law vest the Appointment of such inferior Officers, as they think proper, in the President alone, in the Courts of Law, or in the Heads of Departments.

The President shall have Power to fill up all Vacancies that may happen during the Recess of the Senate, by granting Commissions which shall expire at the End of their next Session.

He shall from time to time give to the Congress Information of the State of the Union, and recommend to their Consideration such Measures as he shall judge to their Consideration such Measures as he shall judge necessary and expedient; he may, on extraordinary Occasions, convene both Houses, or either of them, and in Case of Disagreement between them, with Respect to the Time of Adjournment, he may adjourn them to such Time as he shall think proper; he shall receive Ambassadors and other public Ministers; he shall take Care that the Laws be faithfully executed, and shall Commission all the Officers of the United States.

The President, Vice President and all civil Officers of the United States, shall be removed from Office on Impeachment for, and Conviction of, Treason, Bribery, or other high Crimes and Misdemeanors.

#### ARTICLE III

Section 1
The judicial Power of the United States, shall be vested in one supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish. The Judges, both of the supreme and inferior Courts, shall hold their Offices during good Behaviour, and shall, at stated Times, receive for their Services, a Compensation, which shall not be diminished during their Continuance in Office.

Ambassadors, other public Ministers and Consuls;--to all Cases of admiralty and maritime Jurisdiction;--to Controversies to which the United States shall be a Party;---to Controversies between two or more States;---between a State and Citizens of another State;---between Citizens of different States,---between Citizens of the State claiming Lands under Grants of different States, and between a State, or the Citizens thereof, and foreign States, Citizens or Subjects.

In all Cases affecting Ambassadors, other public Ministers and Consuls, and those in which a State shall be a Party, the supreme Court shall have original Jurisdiction. In all the other Cases before mentioned, the Supreme Court shall have appellate Jurisdiction, both as to Law and Fact, with such Exceptions, and under such Regulations as the Congress shall make.

The Trial of all Crimes, except in Cases of Impeachment, shall be by Jury; and such Trial shall be held in the State where the said Crimes shall have been committed; but when not committed within any State, the Trial shall be at such Place or Places as the Congress may by Law have

Treason against the United States, shall consist only in levying War against them, or in adhering to their Enemies, giving them Aid and Comfort. No Person shall be convicted of Treason unless on the testimony of two Witnesses to the same overt Act, or on Confession in open court.

The Congress shall have Power to declare the Punishment of Treason, but no Attainder of Treason shall work Corruption of Blood, or Forfeiture except during the Life of the Person attainted.

#### ARTICLE IV

Section 1 Full Faith and Credit shall be given in each State to the public Acts, Records, and judicial Proceedings of every other State. And the Congress may by general Laws prescribe the Manner in which such Acts, Records and Proceedings shall be proved, and the Effect thereof.

#### Section 2

The Citizens of each State shall be entitled to all Privileges and Immunities of Citizens in the several

A Person charged in any State with Treason, Felony, or other Crime, who shall flee from Justice, and be found in another State, shall on Demand of the executive Authority of the State from which he fled, be delivered up, to be removed to the State having Jurisdiction of the

No Person held to Service or Labour in one State under the Laws thereof, escaping into another, shall, in Consequence of any Law or Regulation therein, be discharged from such Service or Labour, but shall be delivered up on Claim of the Party to whom such Service or Labour may be due.

New States may be admitted by the Congress into this Union; but no new State shall be formed or erected within the Jurisdiction of any other State; nor any State be formed by the Junction of two or more States, or Parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.

The Congress shall have Power to dispose of and make all needful Rules and Regulations respecting the Territory or other Property belonging to the United States; and nothing in this Constitution shall be so construed as to Prejudice any Claims of the United States, or of any particular State.

Section 4
The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when Legislature cannot be convened) against domestic

ARTICLE V
The Congress, whenever two thirds of both Houses shall deem it necessary, shall propose Amendments to this Constitution, or, on the Application of the Legislatures of two thirds of the several States, shall call a Convention for proposing Amendments, which, in either Case, shall be valid to all Intents and Purposes, as Part of this Constitution, when ratified by the Legislatures of three fourths of the several States, or by Convention in three fourths thereof, as the one or the other Mode of Ratification may be proposed by the Congress: Provided Ratification may be proposed by the Congress; Provided that no Amendment which may be made prior to the Year One thousand eight hundred and eight shall in any Manner affect the first and fourth Clauses in the Ninth Section of the first Article; and that no State, without its Consent, shall be deprived of its equal Suffrage in the

#### ARTICLE VI

All Debts contracted and Engagements entered into, before the Adoption of this Constitution, shall be as valid against the United States under this Constitution, as under the Confederation.

This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, Section 2

The Judicial Power shall extend to all Cases, in Law and Equity, arising under this Constitution, the Laws of the United States, and Treaties made, or which shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the be made, under their Authority;---to all Cases affecting

Contrary notwithstanding.

The Senators and Representatives before mentioned, and the Members of the several State Legislatures, and all executive and judicial Officers, both of the United States and of the several States, shall be bound by Oath or Affirmation, to support this Constitution; but no religious Test shall ever be required as a Qualification to any Office or public Trust under the United States.

The Ratification of the Conventions of nine States, shall be sufficient for the Establishment of this Constitution between the States so ratifying the Same.

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

#### Second Amendment

A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

No Soldier shall, in time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law.

#### Fourth Amendment

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

#### Fifth Amendment

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against hims to have computery, process witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any Court of the United States, than according to the rules of the common law.

Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

#### Ninth Amendment

The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

Tenth Amendment
The powers not delegated to the United States by the
Constitution, nor prohibited by it to the States, are
reserved to the States respectively, or to the people.

#### Eleventh Amendment

The Judicial power of the United States shall not be construed to extend to any suit in law or equity, commenced or prosecuted against one of the United States by Citizens of another State, or by Citizens or Subjects of any Foreign State.

Twelfth Amendment The Electors shall meet in their respective states, and vote by ballot for President and Vice-President, one of vote by ballot for President and Vice-President, one of whom, at least, shall not be an inhabitant of the same state with themselves; they shall name in their ballots the person voted for as President, and in distinct ballots the person voted for as Vice-President, and they shall make distinct lists of all persons voted for as President, and of all persons voted for as Vice-President, and of the number of votes for each, which lists they shall sign and certify, and transmit sealed to the seat of the government of the United States, directed to the President of the Senate;—The President of the Senate shall, in the presence of the Senate and House of Representatives, open all the of the Senate and House of Representatives, open all the certificates and the votes shall then be counted;—The person having the greatest number of votes for President, shall be the President, if such number be a majority of the whole number of Electors appointed; and if no person have such majority, then from the persons having the highest numbers not exceeding three on the list of those voted for as President, the House of Representatives whall choose immediately, by hallot the President But in voted for as President, the House of Representatives shall choose immediately, by ballot, the President. But in choosing the President, the votes shall be taken by states, the representation from each state having one vote; a quorum for this purpose shall consist of a member or members from two-thirds of the states, and a majority of all the states shall be necessary to a choice. [And if

the House of Representatives shall not choose a President whenever the right of choice shall devolve upon them, before the fourth day of March next following, then the Vice-President shall act as President, as in the case of the death or other constitutional disability of the President.—] The person having the greatest number of votes as Vice-President, shall be the Vice-President, if such number be a majority of the whole number of Electors appointed, and if no person have a majority, then from the two highest numbers on the list, the Senate shall choose the Vice-President; a quorum for the purpose shall consist of two-thirds of the whole number of Senators, and a majority of the whole number shall be necessary to a choice. But no person constitutionally ineligible to the office of President shall be eligible to that of Vice-President of the United States.

#### Thirteenth Amendment

Section 1

Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.

#### Section 2

Congress shall have power to enforce this article by appropriate legislation.

#### Fourteenth Amendment

Section 1
All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge State shall make of eithoice any law which shall ablege the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

#### Section 2

Section 2
Representatives shall be apportioned among the several States according to their respective numbers, counting the whole number of persons in each State, excluding Indians not taxed. But when the right to vote at any election for the choice of electors for President and Vice-President of the United States, Represents States. Congress, the Executive and Judicial officers of a State, or the members of the Legislature thereof, is denied to any of the male inhabitants of such State, being twentyany of the male inhabitants of such state, being twenty-one years of age, and citizens of the United States, or in any way abridged, except for participation in rebellion, or other crime, the basis of representation therein shall be reduced in the proportion which the number of such male citizens shall bear to the whole number of male citizens twenty-one years of age in such State.

No Person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any State, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any State, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or given aid or comfort to the enemies thereof. But Congress may by a vote of two-thirds of each House, remove such disability.

Section 4
The validity of the public debt of the United States, authorized by law, including debts incurred for payment of pensions and bounties for services in suppressing insurrection or rebellion, shall not be questioned. But neither the United States nor any State shall assume or pay any debt or obligation incurred in aid of insurrection or rebellion against the United States, or any claim for the loss or emancipation of any slave; but all such debts, obligations and claims shall be held illegal and void.

The Congress shall have the power to enforce, by appropriate legislation, the provisions of this article.

#### Fifteenth Amendment

The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of race, color, or previous condition of servitude—

The Congress shall have the power to enforce this article by appropriate legislation.

#### Sixteenth Amendment

The Congress shall have power to lay and collect taxes on incomes, from whatever source derived, without apportionment among the several States, and without regard to any census or enumeration.

Seventeenth Amendment The Senate of the United States shall be composed of two Senators from each State, elected by the people thereof, for six years; and each Senator shall have one vote. The electors in each State shall have the qualifications requisite for electors of the most numerous branch of the State legislatures.

When vacancies happen in the representation of any State in the Senate, the executive authority of such State shall issue writs of election to fill such vacancies: Provided, That the legislature of any State may empower the executive thereof to make temporary appointments until the people fill the vacancies by election as the legislature may direct may direct.

This amendment shall not be so construed as to affect the election or term of any Senator chosen before it becomes valid as part of the Constitution.

#### Eighteenth Amendment

Section 1

After one year from the ratification of this article the manufacture, sale, or transportation of intoxicating liquors within, the importation thereof into, or the exportation thereof from the United States and all territory subject to the jurisdiction thereof for beverage purposes is hereby prohibited.

Section 2
The Congress and the several States shall have concurrent power to enforce this article by appropriate legislation.

#### Section 3

This article shall be inoperative unless it shall have Inis article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by the legislatures of the several States, as provided in the Constitution, within seven years from the date of the submission hereof to the States by the Congress.

#### Nineteenth Amendment

The right of citizens of the United States to vote shall not be denied or abridged by the United States or by any State on account of sex.

Congress shall have power to enforce this article by appropriate legislation

#### Twentieth Amendment

Twentern Americanient Section 1
The terms of the President and Vice President shall end at noon on the 20th day of January, and the terms of Senators and Representatives at noon on the 3d day of January, of the years in which such terms would have ended if this article had not been ratified; and the terms of their suppressors shall then begin of their successors shall then begin.

#### Section 2

The Congress shall assemble at least once in every year, and such meeting shall begin at noon on the 3d day of January, unless they shall by law appoint a different day.

Section 3
If, at the time fixed for the beginning of the term of the President, the President elect shall have died, the Vice President elect shall become President. If a President shall not have been chosen before the time fixed for the Vicionia of his term or if the President elect shall have shain not have been chosen before the time inxed for the beginning of his term, or if the President elect shall have failed to qualify, then the Vice President elect shall act as President until a President shall have qualified; and the Congress may by law provide for the case wherein neither a President elect nor a Vice President elect shall have qualified, declaring who shall then act as President, or the manner in which one who is to act shall be selected, and such person shall act accordingly until a President or Vice President shall have qualified.

Section 4

The Congress may by law provide for the case of the death of any of the persons from whom the House of Representatives may choose a President whenever the right of choice shall have devolved upon them, and for the case of the death of any of the persons from whom the Senate may choose a Vice President whenever the right of choice shall have devolved upon them.

#### Section 5

Sections 1 and 2 shall take effect on the 15th day of October following the ratification of this article.

This article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by the legislatures of three-fourths of the several States within seven years from the date of its submission.

## Twenty-First Amendment

Section 1
The eighteenth article of amendment to the Constitution of the United States is hereby repealed.

The transportation or importation into any State, Territory, or possession of the United States for delivery or use therein of intoxicating liquors, in violation of the laws thereof, is hereby prohibited.

#### Section 3

Section 3
This article shall be inoperative unless it shall have been ratified as an amendment to the Constitution by conventions in the several States, as provided in the Constitution, within seven years from the date of the submission hereof to the States by the Congress.

#### Twenty-Second Amendment

Section 1
No person shall be elected to the office of the President more than twice, and no person who has held the office of President, or acted as President, for more than two years of a term to which some other person was elected President shall be elected to the office of the President more than once. But this Article shall not apply to any person holding the office of President when this Article was proposed by the Congress, and shall not prevent any person who may be holding the office of President, or acting as President, during the term within which this Article becomes operative from holding the office of President or acting as President during the remainder of such term. such term.

This Article shall be inoperative unless it shall have

been ratified as an amendment to the Constitution by the legislatures of three-fourths of the several States within seven years from the date of its submission to the States by the Congress.

#### Twenty-Third Amendment

Section 1
The District constituting the seat of Government of the United States shall appoint in such manner as the Congress may direct:

A number of electors of President and Vice President equal Anumber of electors of President and Vice President equal to the whole number of Senators and Representatives in Congress to which the District would be entitled if it were a State, but in no event more than the least populous State; they shall be in addition to those appointed by the States, but they shall be considered, for the purposes of the election of President and Vice President, to be electors appointed by a State, and they shall meet in electors appointed by a State; and they shall meet in the District and perform such duties as provided by the twelfth article of amendment.

#### Section 2

The Congress shall have power to enforce this article by appropriate legislation.

#### Twenty-Fourth Amendment

Section 1

The right of citizens of the United States to vote in any primary or other election for President or Vice President, for electors for President or Vice President, or for Senator or Representative in Congress, shall not be denied or abridged by the United States or any State by reason of failure to pay any poll tax or other tax.

Section 2
The Congress shall have power to enforce this article by appropriate legislation.

#### Twenty-Fifth Amendment

Section 1

In case of the removal of the President from office or of his death or resignation, the Vice President shall become President.

Whenever there is a vacancy in the office of the Vice President, the President shall nominate a Vice President who shall take office upon confirmation by a majority vote of both Houses of Congress.

Whenever the President transmits to the President pro tempore of the Senate and the Speaker of the House of Representatives his written declaration that he is unable to discharge the powers and duties of his office, and until he transmits to them a written declaration to the contrary, such powers and duties shall be discharged by the Vice President as Acting President.

#### Section 4

Whenever the Vice President and a majority of either the principal officers of the executive departments or of such other body as Congress may by law provide, transmit to the President pro tempore of the Senate and the Speaker of the House of Representatives their written declaration that the President is unable to discharge the powers and duties of his office, the Vice President shall immediately assume the powers and duties of the office as Acting President.

Thereafter, when the President transmits to the President pro tempore of the Senate and the Speaker of the House of Representatives his written declaration that no inability exists, he shall resume the powers and duties of his office unless the Vice President and a majority of either the unless the Vice President and a majority of either the principal officers of the executive department or of such other body as Congress may by law provide, transmit within four days to the President pro tempore of the Senate and the Speaker of the House of Representatives their written declaration that the President is unable to discharge the powers and duties of his office. Thereupon Congress shall decide the issue, assembling within forty-eight hours for that purpose if not in session. If the Congress within twenty-one days after receipt of the latter written declaration, or, if Congress is not in session, within twenty-one days after Congress is required to assemble, determines by two-thirds vote of both Houses that the President is unable to discharge the powers and assemble, determines by two-thirds vote of both riouses that the President is unable to discharge the powers and duties of his office, the Vice President shall continue to discharge the same as Acting President; otherwise, the President shall resume the powers and duties of his office.

#### Twenty-Sixth Amendment

Section 1

The right of citizens of the United States, who are eighteen years of age or older, to vote shall not be denied or abridged by the United States or by any State on account of age.

#### Section 2

The Congress shall have power to enforce this article by appropriate legislation.

#### Twenty-Seventh Amendment

No law, varying the compensation for the services of the Senators and Representatives, shall take effect, until an election of Representatives shall have intervened.
