Early reports say the epicenter was near El Monte, 2 miles south of Rosemead. At press time, no reports of serious damage or injuries.

### YMCA AWARDED BID TO MANAGE SIERRA MADRE POOL

At last week's council meeting, the city elected to award the lease for the Sierra Madre pool to the Pasadena-Sierra Madre YMCA. The organization will take over operations at the Aquatics Center, ending its lease with Waterworks Aquatics after eight years.

Waterworks swim lesson format was met with mixed reviews by residents. While some noted that they enjoyed lap swim and programs for kids, others felt pool temperatures were kept too warm and there was a lack of community programming.

In 2012, budget woes brought about by the destructive wind storm

at the end of 2011 was cited as the main reason for leasing the pool to Waterworks. The city sustained \$1.2 million in damage as a result of the windstorm. After some early growing pains mainly over pricing and hours, Waterworks overall received favorable reviews.

However, this year, when it came time to review and possibly renew the Waterworks contract, once the Request for Proposal was sent out, Waterworks response disturbed many residents. In an effort to maintain the contract, the group resorted to rather aggressive techniques to gain the support. Those efforts including 'robocalls' and mailers were not well received by many, confirmed City Manager Gabe Engeland.

The YMCA, in its bid, proposed to tailor programs and hours to fit community needs and also offer free community events throughout the year. Engeland noted there may be a pool closure to allow for transition, pool maintenance and to set rules for COVID-19 protocols. This may be as long as 30 days. The new contract will begin October 1, 2020.

The initial lease is set for two years, with the option to renew for an additional three years. Though leasing the pool to the Y will bring in \$4,000 a month or \$48,000 annually, that is \$18,720 less annually than the current lease. Despite this figure, the City expects to save money on maintenance and capital items.

YMCA programs that will be offered include: lap swim, recreation swim, water aerobics, various group, private, parent & me swim lessons, and swim team. In addition, the YMCA proposed an annual Water Safety week, a free Get Summer program for youth, Junior Lifeguarding, and community rentals.

#### RESIDENTS THANK SIERRA MADRE FIRST RESPONDERS, CITY STAFF AS BOBCAT FIRE EVACUATION ORDERS ARE LIFTED; FIRE EXPANDS EXPLOSIVELY NORTH, EAST AND WEST TOWARDS THE ANTELOPE VALLEY

In one of the most efficient emergency operations anyone can ever remember, the Sierra Madre Fire, Police, CERT, Search and Rescue and City Staff utilized traditional methods of protecting the city and new technology to keep residents informed of the fire's progress and possible threat. As reported previously, the SMFD also sent teams out to assist other agencies as they worked day and night to keep the fire from spreading.

The last dispatch to the cummunity was sent on Wednesday by the Sierra Madre PD: "The current status of the fire for Sierra Madre is that all contingency lines have held the fire in check. Fire crews have worked diligently today in the rough and steep terrain to establish perimeter lines that are intended to contain the southern portion of the fire. Once the perimeter lines are complete, crews will monitor to make sure the lines have held. After validation, these perimeter lines will become a portion of the overall containment of the Bobcat Fire. Today the evacuation orders for Sierra Madre residents east of Santa Anita Ave. and north of Elkins Ave. were lifted.

However, Sierra Madre remains under evacuation warning at this time. The order requiring streets to remain clear in the canyon areas of all vehicle, property, and debris expired at 6:00 pm. Red flag parking restrictions in the canyon areas will remain in place indefinitely.

When the Bobcat Fire first started, there was no imminent threat to Sierra Madre and informational updates on the fire were focused on the overall condition and status of the fire. As the Bobcat Fire moved toward Sierra Madre, communications became more frequent and detailed as it pertained to the Sierra Madre community. As the threat to Sierra Madre is diminished, communications will once again decrease.

The City will not communicate via Nixle Alerts unless there is an immediate threat or substantial change to the status of the Bobcat Fire in regards to Sierra Madre. The City will provide additional updates on the Bobcat Fire after daily Incident Command briefings."

In true Sierra Madre fashion, the community expressed their gratitude with donations of food and water for the brave men and women who keep the town safe



Sierra Madre was my home for 51 years, most of which my darling husband, John, and I spent at our house on Alegria. We saw many fires come and go over the years but never anything as bad as this past week has been. Many years ago, during a fire which came very close, I packed my car in readiness. So funny...people ask you what you'd take if you had to evacuate. Here's what I packed: Most of my Dad's art, all the afghans I had crocheted, the photo albums and my jewelry. No clothes.

This time, when our beloved city is so threatened, I am far from my friends and family but so very grateful for the pictures Lisa Cardella, Bob Gollihugh, Lawrence Taylor, Susan Henderson, our Police Department and many others have posted on Facebook. Most of all, huge thanks to Robert Gjerde for his concise reports on what is going on. So many Sierra Madre residents have posted excellent pictures of the firefighters, the helicopters and those with "boots on the ground." I am praying for rain!

#### A Firefighter Poem

"He stares in the face of death without a second thought,
To save that one special life, that he so bravely sought.
He has walked as close to 'hell on earth' as any man could do,
And he's so proud of the job he did for people he never knew.
He puts his life on the line every time duty calls,

Walking next to me."



### **SGV Woman Linked to Drug** Overdoses in Pasadena

Charged with Federal Narcotics Trafficking Offense

Prosecutors filed a criminal complaint Friday against a San Gabriel woman who allegedly sold narcotics to several individuals in Pasadena who suffered overdoses last week.

According to the Department of Justice, Marisol Bolanos Hernandez, 35, was charged with one count of drug distribution resulting in serious bodily injury.

Bolanos allegedly sold

narcotics to a man who, along with a friend, was found unresponsive at a Pasadena location on the evening of September 11. The two victims were transported to local hospitals, where one recovered, but another died two days later. Pasadena Police officers seized white powder residue from the location of the overdoses, but that material has yet to be tested, according to the affidavit in support of the complaint.

At the hospital, the surviving victim, identified as A.C., responded to Narcan, indicating there were opioids present, and his urine samples were positive for cocaine. A.C. was released from the hospital the following day and told Pasadena Police that he purchased cocaine from "Mari," shared some of the drugs with the deceased victim, and lost consciousness

after taking the purported cocaine, according to the affidavit. Investigators have determined that Mari is Bolanos through evidence that includes A.C. identifying her out of a six-photo lineup, the affidavit states.

The narcotics distribution charge in the complaint relates to the drugs allegedly sold to A.C.

The affidavit also alleges that Bolanos sold purported cocaine to two other overdose victims on September 11. Both of these victims required hospitalization and survived. Phone records link Bolaros to another fatal overdose on September 11, according to the affidavit.

Pasadena Police detained Bolanos on September 16. During an interview she admitting selling what she believed to be cocaine to three of the overdose victims, including A.C., on September 11, according to the affidavit.

Bolanos was taken into federal custody on Thursday by special agents with Drug Enforcement Administration. She was expected to make her initial appearance Friday in United States District Court in downtown Los Angeles.

A criminal complaint contains allegations that a defendant has committed a crime. Every defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt.

The charge of drug distribution resulting in serious bodily injury carries a mandatory minimum sentence of 20 years in federal prison and a maximum sentence of life imprisonment.

The case against Bolanos is the result of an ongoing investigation by the DEA and the Pasadena Police Department.

### Teenager Charged in Parking lot Stabbing

A 19 year old man was charged with murder Wednesday in connection to the stabbing death of an Altadena man in a Northwest Pasadena CVS parking lot.

According to reports, Enrique Real was charged in court and remained in jail on \$2 million

Police said that they found Christopher Flores severely bleeding on the ground after responding to several 911 calls, September 11, around 8:15 p.m., of a stabbing near the corner of Orange Grove Boulevard and Fair Oaks Avenue.

Flores, 30, died later at a nearby hospital.

Witnesses told police that the two men were walking through CVS parking lot when Real stabbed Flores several times for reasons unknown. A knife with blood on it was recovered at the scene, police said.

### **SMOKE ADVISORY**

Unhealthy Air Quality Declared due to Smoke from Wildfires Burning in the Region

LOS ANGELES – According to the South Coast Air Quality Management District, smoke from wildfires burning in the region has caused unhealthy air quality in the following areas:

West San Gabriel Valley East San Gabriel Valley Pomona-Walnut Valley San Gabriel Mountains

This advisory remains in effect through Saturday, September 19.

"It is difficult to tell where smoke, ash or soot from a fire will go, or how winds will affect the level of these particles in the air, so we ask everyone to remember that smoke and ash can be harmful to health, even for people who are healthy," said Muntu Davis, MD, MPH, Health Officer for Los Angeles County. "If you can see smoke, soot, or ash, or you can smell smoke, pay attention to your immediate environment and take precautions to safeguard your health. These precautions are particularly important for children, older adults, and people with heart or lung diseases."

These precautions include avoiding unnecessary outdoor exposure and limiting physical exertion (whether indoor or outdoor), such as exercise. Children and people who have air quality sensitive conditions, such as heart disease, asthma, and other chronic respiratory diseases, should follow these recommendations and stay indoors as much as possible even in areas where smoke, soot, or ash cannot be seen, or there is no smell of smoke. If your condition worsens, contact your health care provider immediately for medical advice or call 911.

Wildfire smoke is a mixture of small particles, gases, and water vapor. Small particles are the primary health concern. These small particles can cause burning eyes, runny nose, scratchy throat, headaches, and illness (i.e., bronchitis). In people with sensitive conditions, they can cause difficulty breathing, wheezing, coughing, fatigue, and chest pain.

"We are also advising day camps that are in session in smoke-impacted areas to suspend outside recreational activities, such as hiking or picnics, until conditions improve," said Dr. Davis.

People can participate in indoor activities in areas with visible smoke, soot, or ash, provided the indoor location has air conditioning that does not draw air from the outside, and it has closed windows and doors to protect the cleanliness of indoor air. If not, it is recommended that everyone follow these guidelines as if they were outside.

The following recommendations will help you protect yourself and your family from the harmful effects of unhealthy or poor air quality:

If you see or smell smoke or see a lot of particles and ash in the air, avoid unnecessary outdoor activity to limit your exposure to harmful air. This is especially important for those with heart or lung disease (including asthma), the elderly and children.

If outdoor air is bad, try to keep indoor air as clean as possible by keeping windows and doors closed. Air conditioners that re-circulate air within the home can help filter out harmful particles. Avoid using air conditioning units that only draw in air from the outside or that do not have a recirculating option. Residents should check the filters on their air conditioners and replace them regularly. Indoor air filtration devices with HEPA filters can further reduce the level of particles that circulate indoors.


If it is too hot during the day to keep the doors or windows closed and you do not have an air conditioning unit that re-circulates indoor air, consider going to an air-conditioned place, such as a cooling center, to stay cool and to protect yourself from harmful air.

Do not use fireplaces (either wood burning or gas), candles, and vacuums. Use damp cloths to clean dusty indoor surfaces. Do not smoke.

If you have symptoms of lung or heart disease that may be related to smoke exposure, including severe coughing, shortness of breath or difficulty breathing, wheezing, chest tightness or pain, palpitations, nausea or unusual fatigue or lightheadedness, contact your doctor immediately or go to an urgent care center. If life-threatening, please contact 911.

When smoke is heavy for a prolonged period of time, fine particles can build up indoors even though you may not be able to see them. Wearing a mask may prevent exposures to large particles. However, most masks do not prevent exposure to fine particles and toxic gases, which may be more dangerous to your health.

Public Health Reminds Everyone to Get Immunized against the Flu The Los Angeles County Department of Public Health (Public Health) has confirmed 38 new deaths and 1,160 new cases of confirmed COVID-19. To date, Public Health has identified 257,271 positive cases of COVID-19 across all areas of L.A. County and a total of 6,324 deaths.

There are 780 people currently hospitalized with COVID-19 and 31% of these people are in the ICU. The number of daily hospitalizations has returned to levels seen early in the pandemic.

Because it is highly likely that both flu and COVID-19 will be present in L.A. County this year, Public Health advises residents to protect themselves from the flu by getting the flu immunization.

Every year, tens of thousands of people nationwide are hospitalized or die from flu-related illness. Considering the toll COVID-19 has had on our healthcare system, now more than ever it is important to be protected from influenza by getting immunized. Not only is getting immunized important because it is safe and provides protection against the harmful effects of influenza, it can also help keep people out of the hospital which will conserve hospital resources that may be taxed with both influenza and COVID-19 circulating at the same time.

You can get the flu immunization from your regular health care provider or local pharmacy. Flu immunizations are also provided at no-cost or low-cost at various locations throughout the County. For more information on where you can get immunized for the flu, visit: www.publichealth.lacounty.gov.

"We send our deepest sympathies to everyone who has lost a loved one or friend to COVID-19," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "As many residents are spending more time indoors to avoid the poor air quality, I remind everyone to take precautions to minimize COVID-19 spread if you are indoors with others. Please remember to distance from other people, wear a face covering, and wash your hands frequently and to clean high touch surfaces often if around others who are at high risk. It is important to continue to isolate from others if you are sick and to get tested for COVID-19 if you were exposed or have symptoms."

Of the 38 new deaths reported today, 13 people that passed away were over the age of 80 years old, 10 people who died were between the ages of 65 and 79 years old, nine people who died were between the ages of 50 and 64 years old, and four people who died were between the ages of 30 and 49 years old. Thirty-two people who died had underlying health conditions including 12 people over the age of 80, seven people between the ages of 65 and 79 years old, nine people between the ages of 50 and 64 years old, and four people between the ages of 30 and 49 years old. Two deaths were reported by the City of Long Beach.

Ninety-two percent of the people who died from COVID-19 had underlying health conditions. Of those who died, information about race and ethnicity is available for 5,950 people (99 percent of the cases reported by Public Health); 51% of deaths occurred among Latino/Latinx residents, 23% among White residents, 15% among Asian residents, 10% among African American/Black residents, less than 1% among Native Hawaiian/Pacific Islander residents and 1% among residents identifying with other races. Upon further investigation, 37 cases and 17 deaths reported earlier were not L.A. County residents.

Testing results are available for more than 2,494,000 individuals with 10% of all people testing positive.

The best way to prevent getting and spreading COVID-19 is to avoid being exposed to the virus. Always put six feet of distance between yourself and people who don't live in your household. Always wear a face covering in public settings and when around people who don't live in your household. The face covering is meant to protect other people in case you are infected. You could spread COVID-19 to others even if you do not feel sick. And others can spread COVID-19 to you when they have no illness symptoms. Please remember to also wash hands frequently.



#### ARCADIA HIGH STUDENTS SEE CONTINUED SUCCESS IN NATIONAL MERIT SCHOLAR PROGRAM

ARCADIA-- Over the past 25 years, Arcadia High has had an average of 20 or more National Merit Scholarship semifinalists each school year and adds 20 more Arcadia High students this year who have earned a coveted spot in the 2021 National Merit Scholarship competition.

To be eligible for a finalist spot in this program, Arcadia High's semifinalists and Arcadia High counselors will work together to submit a detailed scholarship application, wherein they provide information about a semifinalist's academic record, participation in school and community activities, demonstrated leadership abilities, employment, and honors and awards received. In addition, semifinalists need to have outstanding academic records throughout their high school careers, be endorsed and recommended by a high school official, and write an essay.

Of the approximately 16,000 semifinalists, 15,000 finalists will be selected. Those who make it to the finalist phase will receive notification of this designation in February 2021 and will be the final pool of scholars considered for a 2021 National Merit Scholarship.

In addition to a stellar showing each year in the National Merit Scholarship program, Arcadia High School has been ranked in the top 1 percent of best public high schools in the nation by Niche.com, and its Class of 2018 saw a 100 percent graduation rate. In addition, Arcadia High has also been distinguished as a U.S. News and World Report Gold Medal School three times, an honor bestowed on less than 3 percent of the more than 19,000 schools in the country. Similarly, Newsweek named Arcadia High on its Top Public High Schools in America list. Arcadia High graduates are represented in every Ivy League school and in top universities across the country. ### CREATIVE WRITING PROGRAM FOR TEENS AT LIBRARY

Arcadia Public Library is offering free online creative writing workshops from September through November. The workshops are taught by Arcadia High School student and published writer, Audrey Sloeng, who is completing her Girl Scout Gold Award.

Each workshop focuses on a different genre—journaling, flash stories, poetry, song writing, and free writing—and lets teens express themselves and share their work in a safe and encouraging environment.

The workshops are open to students in grades 6 through 12. AN EXPERIMENT IN ALCHEMY

and let us know your results.

Continuing from last week, here are a few guidelines if you'd like to begin alchemi¬cally changing "a cup of coffee" to "wonderful elixir." This is the procedure that Timothy Hall was taught by his mentor, R. E. White of WTI in the mid-1970s.

Begin with meticulously clean utensils. Stainless steel, French porcelain, glass, or copper are preferred; softer metals (e.g., aluminum) should not be used.

First, measure the needed amount of water (spring water is better than the chlorine and fluoride-laden city tap water) and set on the stove to boil.

Next, prepare your filter. An ideal filter is a simple cloth bag sewed into a cone, using the densest cotton flannel. These are reusable indefinitely -- far superior to commercial paper filters. The bag is suspended over your cup, or a second pot; the coffee grounds are measured into the bag (a fine grind works best).

Another ideal system is a French ceramic pot with a ceramic cone that fits into the top, and a gold-plated reusable filter. You measure your grounds into the filter.

When the water has boiled, stand squarely and strongly on both legs; breathe deeply; then, slowly pour the water in a clockwise circular motion over the grounds. While pouring, visualize and fell the energy of Love flowing from your heart, down your arm, and into the beverage.

We call this "chi," and much has been written about this "chi' energy in books on Chinese healing and martial arts. You may need to "imagine" the feeling at first, but with practice you will find it easy. It sometimes feels like a mild electric shock.

If you wish to add anything to the resultant beverage, try raw honey and raw cream.

One of the main problems with extensive coffee ingestion is that it either removes or destroys the B-vitamins from the body, resulting in a slowly cumulative degeneration of the sheaths of the body's nerve fibres. This is what causes the "nervousness" with heavy coffee-drinkers. Honey, cream, and B-vitamins added to the diet, help to offset any harmful effects.

When the above process is done thoughtfully and lovingly, the process is somewhat analogous to the Japan¬ese tea ceremo¬ny. And it CAN result in a truly fine elixir. Please try this method of "elixir-making" in your own Alchemi¬cal Chamber (aka "kitchen")

So is coffee "good" or "bad"? As always, it depends on the way you interact with it.

Coffee says: "As you care for me, and as you treat my fruits, so shall I be able to provide sustenance to you, my dear humans. Ignore me, and I have nothing, or little, to offer but "cheap thrills" of your lower aspects of autonomic nervous system."

Coffee also says: "Compromise and/or adulterate me and you'll not only have something of little value, but your choice to exploit/adulterate me will change my potential beneficence into an exploitation/adulteration of your own body and brain."

As is nearly always the case with such matter of "health," ALL is choice, Choice, and CHOICE, and consequence of choice.

### TIPS TO KEEP PETS SAFE DURING WILDFIRES

Dr. Jennifer Freeman, DVM, PetSmart resident veterinarian and pet care

- 1. Ensure your pets are safely contained. Consider getting a pet carrier if you don't already have one and practicing crate training in advance to avoid extra stress in the face of an emergency. For fish or turtles, it's a good idea to have buckets or plastic bins with a lid on hand in the event you need to evacuate them. This is a safer alternative to transporting these pets in glass bowls or aquariums.
- 2. Make sure your pet has identification. Countless pets go missing after storms, wildfires and other natural disasters. Proper ID on your pet is the best assurance that you and your pet are reunited in the event you are separated. "Consider microchip identification for your pets, as this is a permanent way to identify them and is used universally by animal shelters and veterinarians," Freeman said.
- 3. Look for pet-friendly housing options for your pet should you need to evacuate your home. Ensure your pet is up to date on vaccinations, which are often needed for boarding, and that you have a supply of your pet's medication.
- Ask friends, relatives and others outside of your immediate area whether they could shelter your animals.

Prepare a list of animal shelters, boarding facilities and veterinarian offices that could shelter animals during an emergency and include 24-hour phone numbers.

If you plan to take your pet with you, seek out pet-friendly hotels that are along possible evacuation routes in advance so that you are not caught without a place to stay for the night.

- 4. Assemble a pet emergency supply kit. Pet emergency kits do not need to be big but should include the following, in an easy-to-carry waterproof container that can be taken in the event
- Portable food and water bowls, along with a one-week supply of food and fresh water Vaccination records

An extra supply of medication including heartworm and flea/tick prevention (if refrig-


eration is necessary, have easy access to a small, insulated bag or cooler)

- Pet First-Aid items such as antiseptic spray, antibacterial ointment, and bandage material. These are easy solutions that can deliver quick first-aid care in the event of a pet injury. A list of regional pet-friendly hotels

- A bed, carrier and leash and harness for each animal
- Pet waste bags
- Cat litter, litter box and scoop
- Current photos of your pets, in case they get lost
- 5. Provide comfort. Severe weather or leaving home can be frightening to pets. Provide your dog or cat with a familiar toy or blanket or try aids like calming sprays, collars, chews, supplements, anti-anxiety medications, or a ThunderShirt<sup>™</sup> to help ease anxiety.

#### SHOULD I BUY LONG-TERM CARE INSURANCE?

Dear Savvy Senior:

My wife and I have thought about purchasing a long-term care insurance policy, but we hate the idea of paying expensive monthly premiums for a policy we may never use. Is there a good rule of thumb on who should or shouldn't buy long-term care insurance? Getting Old



Dear Getting:

There are two key factors you need to consider that can help you determine if purchasing a long-term care (LTC) insurance policy is a smart decision for you and your wife. One factor is your financial situation and second is your health history. Currently, around 8 million Americans own a policy.

Who Needs LTC Insurance?

As the cost of LTC - which includes nursing home, assisted living and in-home care - continues to rise, it's important to know that most people pay for LTC either from personal savings or Medicaid when their savings is depleted, or through a LTC insurance policy. National median average costs for nursing home care today is around \$92,000 per year, while assisted living averages around \$50,000/

While national statistics show that about 70 percent of Americans 65 and older will need some kind of LTC, the fact is, many people don't need to purchase a LTC insurance policy.

The reasons stem from a range of factors, including the fact that relatively few people have enough wealth to protect to make purchasing a policy worthwhile. Seniors with limited financial resources who need LTC turn to Medicaid to pick up the tab after they run out of money.

Another important factor is that most seniors who need LTC only need it for a short period of time, for example, when they're recovering from surgery. For those people, Medicare covers in-home health care and nursing home stays of 100 days or less following a hospital stay of more than 3 consecutive

So, who should consider buying a policy? LTC insurance policies make the most sense for people who can afford the monthly premiums, and who have assets of at least \$150,000 to \$200,000 or more that they want to protect, not counting their home and vehicles.

Another factor to weigh is your personal health and family health history. The two most common reasons seniors need extended long-term care is because of dementia and/or disability. And, almost half of all people who live in nursing homes are 85 years or older. So, what's your family history for Alzheimer's, stroke or some other disabling health condition, and do you have a family history of

You also need to factor in gender too. Because women tend to live longer than men, they are at greater risk of needing extended LTC.

Choosing LTC Insurance

After evaluating your situation, if you're leaning towards buying a LTC policy, be sure to do your homework. The cost of premiums can vary greatly ranging anywhere between \$2,500 and \$8,000 per year for a couple depending on your age, the insurer, and the policy's provisions.

Also note that because of coronavirus, it may be more difficult to qualify for coverage now if you're age 70 or older, in a high-risk group or have had a positive COVID-19 test.

To find a policy, get a LTC insurance specialist who works with a variety of companies. See the American Association of Long-Term Care Insurance website (AALTCI.org) to locate one. Also shop insurers like Northwestern Mutual and New York Life, who work only with their own agents.

Another option you may want to consider are Hybrid policies that combine long-term care coverage with life-insurance benefits. These policies promise that if you don't end up needing long-term care, your beneficiaries will receive a death benefit.

#### **ONCE YOUR KIDS ARE 18, MAKE SURE** THEY SIGN THESE DOCUMENTS

While estate planning is probably one of the last things your teenage kids are thinking about, when they turn 18, it should be one of their (and your) number-one priorities. Here's why: At 18, they become legal adults in the eyes of the law, so you no longer have the authority to make decisions regarding their healthcare, nor will you have access to their financial accounts if something happens to them.

With you no longer in charge, your young adult would be extremely vulnerable in the event they become incapacitated by COVID-19 or

another malady and lose their ability to make decisions about their own medical care. Seeing that putting a plan in place could literally save their lives, it your kids are already 18 or about to hit that milestone, it's crucial that you discuss and have them sign the following documents.

Medical Power of Attorney

A medical power of attorney is an advance directive that allows your child to grant you (or someone else) the legal authority to make healthcare decisions on their behalf in the event they become incapacitated and are unable to make decisions for themselves.

For example, a medical power of attorney would allow you to make decisions about your child's medical treatment if he or she is in a car accident or is hospitalized with COVID-19.

Without a medical power of attorney in place, if your child has a serious illness or injury that requires hospitalization and you need access to their medical records to make decisions about their treatment, you'd have to petition the court to become their legal guardian. While a parent is typically the court's first choice for guardian, the guardianship process can be both slow and expensive.

And due to HIPAA laws, once your child becomes 18, no one—even parents—is legally authorized to access his or her medical records without prior written permission. But a properly drafted medical power of attorney will include a signed HIPAA authorization, so you can immediately access their medical records to make informed decisions about their healthcare.

Living Will

While a medical power of attorney allows you to make healthcare decisions on your child's behalf during their incapacity, a living will is an advance directive that provides specific guidance about how your child's medical decisions should be made, particularly at the end of life.

For example, a living will allows your child to let you know if and when they want life support removed should they ever require it. In addition to documenting how your child wants their medical care managed, a living will can also include instructions about who should be able to visit them in the hospital and even what kind of food they should be fed.

Durable Financial Power of Attorney

Should your child become incapacitated, you may also need the ability to access and manage their finances, and this requires your child to grant you durable financial power of attorney.

Durable financial power of attorney gives you the authority to manage their financial and legal matters, such as paying their tuition, applying for student loans, managing their bank accounts, and collecting government benefits. Without this document, you will have to petition the court for such authority.

Peace of Mind

As parents, it is normal to experience anxiety as your child individuates and becomes an adult, and with the pandemic still raging, these fears have undoubtedly intensified. While you can't totally prevent your child from an unforeseen illness or injury, you can at least rest assured that if your child ever does need your help, you'll have the legal authority to provide it. Have you ever wondered what books the especially literate Jews took with them to Auschwitz or Dachau? I have never before wondered and wonder why I am wondering now. I just learned that the order mandating

an evacuation in the Upper Canyon was the result of a misunderstood direction to remove all non-resident

lookie loos and was, mistakenly taken as an instruction to remove all residents thus causing all kinds of confusion and stress. Wonderful! My wife is no longer threatening to disconnect and pack up the computer and I may be able to complete this article. Before returning to the decision about the book I should share with you my worry that I have not called my mother to assure her I am okay. Do I want a book that reminds me that my blood sugar numbers are completely out of control such that even my iPhone tells me to do something to normalize the reading. I am advised to be sure to get a good night's sleep and to go out and walk or exercise as possible ways of lessening stress. Hysterical don't you think? It's so smoky outside that my wife had to put on two or three masks just to go outside and pick up the Sunday In addition to the nearby raging fires, the

Covid epidemic, and the unimaginable political mess I have had a very disturbing week. In association with the series of interview articles which now accompany my regular weekly columns I have been conducting interviews which delve into subjects that usually are not discussed with me. I have learned that the high price of medical services and prescription medications result from corrupt practices. #### LOSERS? SUCKERS? TERRORISTS? **ANARCHISTS? MEET THE REAL** FOLKS BEHIND TRUMP'S INSULTS

Ty Rewolinski doesn't look like a loser. Or a sucker.

Standing on a Harrisburg street corner outside the head-quarters of the Pennsylvania AFL-CIO, Rewolinski looks like what he once was: A U.S. Marine Corps sergeant who served his country in Iraq. He's tall and broad and self-contained. His eyes are alert. A silver cross dangles from his neck.

A few minutes before we started our conversation, I'd heard him mutter under his voice, "I'm no loser."

It seems like an entry point. So I ask him him what he thinks of the story in The Atlantic, since corroborated by several other news organizations, that the current commander-in-chief, President Donald Trump, believes soldiers are "losers" and "suckers."

"It makes me feel horrible," he said in a quiet and even voice that might as well be shouting out loud.

I keep coming back to the quiet directness of his answer. A Marine sergeant, who's likely seen terrors that none of us will ever see, feels "horrible," because of what the commander-in-chief is alleged to have said about him.

And right there, that's the human cost of living in Donald Trump's America.

Like all bullies, Trump has dehumanized the people behind his insults and jibes. And it's exacting a price on their – and our – souls.

During a press conference from the White House's South Portico last week, Trump pushed back hard against his critics, growling that "only an animal" would say such things about America's service men and women, and our fallen soldiers.

"The story is a hoax, written by a guy who's got a tremendously bad history," Trump said, of Atlantic reporter Jeffrey Goldberg, the story's author. "The magazine itself, which I don't read, I hear is totally anti-Trump ... He made up the story, it's a totally made-up story."

But is it so hard to believe? Really?

In nearly four years in office, and on the campaign trail before that, Trump has smashed through one norm after another. He mocked the appearance of former GOP presidential candidate Carly Fiorina, saying "Look at that face! Would anyone vote for that?" He referred to onetime White House aide Omarosa Manigault Newman as a "dog."

He's called Mexican migrants "rapists." He's invented a playground nickname for each of his political rivals. He's used a racial epithet to refer to Sen. Elizabeth Warren. He once mocked a disabled New York Times reporter.

Trump, who has never served, trashed former Defense Secretary James Mattis as "the world's most overrated general." Former National Security Adviser John Bolton was alternately "incompetent," a "wacko" and "a disgruntled boring fool who only wanted to go to war," according to the Los Angeles Times.

So is it really inconceivable that Trump, who has compared avoiding sexually transmitted diseases to fighting in Vietnam, and who derided the late Sen. John McCain, who endured unspeakable torture during his time as a prisoner of war, would really talk that way when he thinks the world isn't listening?

Destiny Brown doesn't look like an anarchist or looter. But if Trump saw the grandmotherly Black woman in the bright yellow Black Lives Matter t-shirt, that might well be how he'd describe her.

After all, he's done it before.


"Look at what happened in New York, look what happened in Chicago. All Democrats. All radical left Democrats," Trump said during a rally in New Hampshire last month. "You know what I say about protesters? Protesters, your ass. I don't talk about my ass. They're not protesters, those are anarchists, they're agitators, they're rioters, they're looters."


We're not violent," Brown told me emphatically. "It's so sad with race and how it is in the world now."


Brown says she's looking to Biden to heal a badly fractured country. Biden, she says, "will smother the flames."

### **CHANGE VOTING AGE TO** 16? TRY 80!



San Francisco residents will vote on a measure in November to allow teenagers as young as 16 to vote in local elections. That's according to The Hill, which also reports that in recent years, two women in Congress introduced measures to lower the voting age nationwide to 16.

One argument for doing so is that 16-year-olds are permitted to work and therefore must pay taxes – but, unable to vote for political leaders, they have no representation regarding how their tax "contributions" are spent.

Critical thinking, which college education should teach, appears to be losing ground to uncritical "groupthink." The younger and more passionate one is, the more one may be at risk of "getting facts wrong" and voting for silver-tongued politicians whose real goals are their own personal and financial gain.

An 80-year-old is much less likely to fall for such nonsense.

opportunity for misinformation to spread is incredible.

At 87, my father reads a print newspaper and does at least one crossword puzzle every day. He reads two or three books a week. His mind is sharp.

He has seen a lot of silver-tongued politicians come and go – and a lot of once-popular ideas do a lot of damage to a lot of people.

He remembers the hopefulness of the War on Poverty, for example. We've spent more than \$20 trillion on it since the 1960s, and though it has helped millions avoid poverty in terms of food and housing, it has given us too much poverty of the spirit – too many broken families and children with limited opportunities to reach their fullest potential as human beings.

At 87, your bones ache. You find yourself in long conversations about roughage in your diet and good prostate health. You're in no mood for nonsense. You aren't easily swayed by the passions of the moment. You don't feel the need to faint at political rallies – unless you forgot your nutrition drink that morning.

You've paid way too many taxes and seen billions wasted on everything from unnecessary wars to pipe-dream programs that enrich lobbyists who get their pals in Congress to fund them more than they have done any good.

You know you may not be here much longer. All you care about is what you can do to make our country's future better for your children, grandchildren and greatgrandchildren. And that is the lens you would use to evaluate candidates and ideas. We would be better off as a country if our voters did more cranky critical thinking and indulged in less feel-good emotional nonsense.

Bring on the octogenarian voters!



### PORTRAITS OF OUR NEIGHBORS By Stuart Tolchin

#### **AMANDA MACIEL ANTUNES**

As unforseen as these times are, so was my meeting with Amanda Maciel Antunes. Ten days ago she and another woman, both masked, walked past my house. Taking them to be mother and daughter, I commented that their masks were probably unnecessary if they were family living together. I learned that they were just neighbors living at the entrance to the canyon. I asked the younger woman if she was familiar with the famous writer Anais Nin who lived in that same area a few decades earlier. I maintained the superior attitude of an older man who had lived in the canyon for forty two years, but my attitude quickly evaporated never to return in the presence of this amazing young woman. She nonchalantly explained that serendipitously she lived in the very apartment where Anais Nin had lived! Amanda had become, in addition to many other things, a Nin scholar.

It would take many books to describe the life and person of Amanda Maciel Antunes. After another chance meeting I asked to interview her. A few days later she came bearing tasty homemade Brazilian cheesebread that she had awakened early to bake. Despite the heat she was wearing a long dress that covered her from neck to foot. When I remarked upon her clothing I learned that she always makes her own clothes generally from materials that come from her native Brazil. Amanda explained that she was from a partly indigenous family that lived in an isolated area in Salto de Pirapora, Brazil. In order to go to school she took long bus rides to a larger city. Although she was something of a prodigy she was unique among the other students who called her "the girl from the farm" or "the girl from the past." With a divided family blessing she fled Brazil at the age of fourteen to follow the life of an artist ending up in Boston, learning English by studying an Anais Nin diary. It has taken ten years to settle her immigration problems but now married and living in Sierra Madre she has become an LA based multidisciplinary artist working in painting, costuming, performance, writing and installation art. While living in Sierra Madre she began each morning by climbing part way up the Mount Wilson Trial where she sits on a bench creating a tapestry on which she embroiders a poem. On the way back down the trail she picks up assorted items storing them in her backpack to later to be used in her other art projects. Somewhere along the trail she has created her own sanctuary.



Still, I have told you nothing about her person. To me she seems like a kind of Angel with a bit of an accent and some very strong opinions. She is a Feminist who asserts that a great part of Western hemisphere and European history involves the continued suppression of women largely because men are frightened of feminine power.

In a Zoom presentation in which Amanda was interviewed by two older Feminist poets she spoke of her need to be an artist. She explains that every moment of her life she lives her art, living her life with integrity and continuing to enrich her soul. She is very interested in the underlying connections between our deepest selves which mere words cannot reach. The continued presence of the obscured past and the often unnoticed present is an underlying theme. She looks for a safe place to be to feed her soul and is, for now, disinterested in forming a family. Nevertheless, she is a very loving person, willing to fly across country to aid a troubled friend or to check on new friends in the canyon.

Even with all this, she looks just like any other person walking in the canyon sometimes with her backpack. In her bag is the ongoing living piece of art. As I hoped to emphasize in these articles, every person you pass along the road has a new story to tell, and the more stories you hear the richer your own world can be.







### Returning Your VBM Ballot

Voters are advised that they are responsible for how their Vote by Mail (VBM) ballots are returned and with whom they entrust their ballots. The Los Angeles County Registrar-Recorder/County Clerk recommends returning a ballot to either a mailbox, official drop box, or ballot box.

Voters who cannot return their VBM ballot can designate any person to return their ballot as long as there is no compensation involved for that individual, group or organization returning the ballot.

There are several recommended options for returning a Vote by Mail ballot during any election:



### Return by mail.

Must be postmarked by Election Day. No postage required.



### Drop-off at a Vote by Mail Ballot Drop-Off Location.

List of drop-off locations available at LAvote.net prior to each election.



Drop-off at any Vote Center leading up to and on Election Day.

List of Vote Centers available at LAvote.net prior to each election.



#### Signature Verification

Voters must sign the eligibility oath and date the VBM return envelope before submitting their ballot. Every signature is verified before the ballot is cleared for counting. If a signature is missing or if the signature does not match the one on file, the County will notify the impacted voter to allow the voter an opportunity to provide a valid signature


