MATER DOLOROSA'S LOCAL FOOD MINISTRY **CONTINUES TO HELP THOSE IMPACTED BY COVID 19**

With the global pandemic, millions have lost their source of income, their homes, or simply their ability to leave the house. These effects have made it difficult for many people to provide themselves and their families with food on a regular basis. Luckily, organizations within our community have stepped in to help out our neighbors in need. Mater Dolorosa Passionist Retreat Center is one such organization.

Back in March, Mater Dolorosa partnered with several other groups to start a Food Ministry Program. Thanks to generous donations from supporters, they have been able to serve over 20,000 meals since the beginning of the pandemic. They have been able to cook thousands of meals per week, which they then distribute to

several other organizations that hand out the food to people in need.

When coronavirus began to spread, the Hart Park House Senior Center was forced to cease all operations for safety reasons. This meant that they could no longer provide the daily meal service that many seniors in Sierra Madre relied on. Luckily, the Mater Dolorosa Food Ministry partnered with the Sierra Madre Police Department has been able to fill this gap. As a result, SMPD has been handing out these meals to members of the community, mainly seniors, who have been affected by the pandemic. They hand out over 50 meals a week, and have at least 250 people signed up with their food program.

Foothill Kitchens is another organization that the Food Ministry has been able to provide meals for. Foothill Kitchens hands out these meals to individuals who are struggling with homelessness in the area. They are able to serve 120-150 people every single day down at the Lario River Bed thanks to their collaboration with Mater Dolorosa.

Throughout this time, the necessity of this ministry has not diminished. The virus is still affecting millions of people, and the needs are seemingly endless. Mater Dolorosa and the organizations they are partnered with plan to continue this program as long as they need to.

Tobe able to keep this amazing service running and continue helping out members of our community, however, they need support! A donation of \$100 can provide 15 meals to people who need them. They recently ran an exciting "Spice Up Your Summer" donation campaign. For every \$100 donated to the Food Ministry Program, Mater Dolorosa will send a spice kit containing a bulk-sized bag of spice or herb and a couple of delicious recipes featuring the included spice. By donating to this campaign, you not only help out your neighbors, you also get some new recipes to add to your repertoire and use to impress friends and family!

A "yes" vote supports issuing \$5.5 billion general obligation bonds for the state's stem cell research institute and making changes to the institute's governance structure and programs.

A "no" vote opposes issuing \$5.5 billion general obligation bonds for the state's stem cell research institute, which ran out funds derived from Proposition 71 (2004) for new projects in 2019.

California Proposition 15, the Tax on Commercial and Industrial Properties for Education and Local Government Funding Initiative

A "yes" vote supports this constitutional amendment to require commercial and industrial properties, except those zoned as commercial agriculture, to be taxed based on their market value, rather than their purchase price.

A "no" vote opposes this constitutional amendment, thus continuing to tax commercial and industrial properties based on a property's purchase price, with annual increases equal to the rate of inflation or 2 percent, whichever is lower.

California Proposition 16, the Repeal Proposition 209 Affirmative Action Amendment

A "yes" vote supports this constitutional amendment to repeal Proposition 209 (1996), which stated that the government and public institutions cannot discriminate against or grant preferential treatment to persons on the basis of race, sex, color, ethnicity, or national origin in public employment, public education, and public contracting.

A "no" vote opposes this constitutional amendment, thereby keeping Proposition 209 (1996), which stated that the government and public institutions cannot discriminate against or grant preferential treatment to persons on the basis of race, sex, color, ethnicity, or national origin in public employment, public education, and public contracting.

California Proposition 17, the Voting Rights Restoration for Persons on Parole Amendment

A "yes" vote supports this constitutional amendment to allow people on parole for felony convictions to vote.

A "no" vote opposes this constitutional amendment, thereby continuing to prohibit people who are on parole for felony convictions from

California Proposition 18, the Primary Voting for 17-Year-Olds Amendment

A "yes" vote supports this constitutional amendment to allow 17-year-olds who will be 18 at the time of the next general election to vote in primary elections and special elections.

A "no" vote opposes this constitutional amendment, thereby continuing to prohibit 17-year-olds who will be 18 at the time of the next general election to vote in primary elections and special elections.

California Proposition 19, the Property Tax Transfers, Exemptions, and Revenue for Wildfire Agencies and Counties Amendment

A "yes" vote supports this constitutional amendment to:

* allow eligible homeowners to transfer their tax assessments anywhere within the state and allow tax assessments to be transferred to a more expensive home with an upward adjustment; tincrease the number of times that persons over 55 years old or with severe disabilities can transfer their tax assessments from one to

* require that inherited homes that are not used as principal residences, such as second homes or rentals, be reassessed at market value

when transferred; and tallocate additional revenue or net savings resulting from the ballot measure to wildfire agencies and counties.

A "no" vote opposes this constitutional amendment, therefore continuing to:

* allow eligible homeowners to transfer their tax assessments within counties and to homes of equal or lesser market value;

theep the number of times that persons over 55 years old or with severe disabilities can transfer their tax assessments at one; * allow the tax assessments on inherited homes, including those not used as principal residences, to be transferred from parent to child

or grandparent to grandchild.

A "yes" vote supports this initiative to add crimes to the list of violent felonies for which early parole is restricted; recategorize certain types of theft and fraud crimes as wobblers (chargeable as misdemeanors or felonies); and require DNA collection for certain misdemeanors.

A "no" vote opposes this initiative to add crimes to the list of violent felonies for which early parole is restricted; recategorize certain types of theft and fraud crimes as wobblers (chargeable as misdemeanors or felonies); and require DNA collection for certain misdemeanors.

California Proposition 21, the Local Rent Control Initiative

A "no" vote opposes this ballot initiative, meaning California Assembly Bill 5 (2019) could be used to decide whether app-based drivers are employees or independent contractors.

California Proposition 23, the Dialysis Clinic Requirements Initiative.

A "yes" vote supports this ballot initiative to require chronic dialysis clinics to: have an on-site physician while patients are being treated; report data on dialysis-related infections; obtain consent from the state health department before closing a clinic; and not discriminate against patients based on the source of payment for care.

A "no" vote opposes this ballot initiative to require chronic dialysis clinics to: have an on-site physician while patients are being treated; report data on dialysis-related infections; obtain consent from the state health department before closing a clinic; and not discriminate against patients based on the source of payment for care.

California Proposition 24, the Consumer Personal Information Law and Agency Initiative


A "yes" vote supports this ballot initiative to expand the state's consumer data privacy laws, including provisions to allow consumers to direct businesses to not share their personal information; remove the time period in which businesses can fix violations before being penalized; and create the Privacy Protection Agency to enforce the state's consumer data privacy laws.

A "no" vote opposes this ballot initiative to expand the state's consumer data privacy laws or create the Privacy Protection Agency to enforce the state's consumer data privacy laws.

California Proposition 25, the Replace Cash Bail with Risk Assessments Referendum

A "yes" vote is to uphold the contested legislation, Senate Bill 10 (SB 10), which would replace cash bail with risk assessments for detained suspects awaiting trials.

A "no" vote is to repeal the contested legislation, Senate Bill 10 (SB 10), thus keeping in place the use of cash bail for detained suspects awaiting trials.

The City of Sierra Madre gives notice, pursuant to State of California law, that the City Council will conduct a public hearing to onsider recommending adoption of Ordinance 1431, amending Chapters 17.08 (Definitions), Section 17.20.015 (Definitions), Chapters: 17.36 (Commercial Zone) in its entirety, 17.40 (Manufacturing Zone), and 17.60 (Variances and Discretionary Permits). The purpose of the amendment is to update the list of permitted and conditionally permitted uses in the commercial zone, update the corresponding development standards, and develop a comprehensive list of commercial zone uses pursuant to City Council Resolution 20-62. Additional amendments to the chapters referenced above are intended to achieve consistency specific to cross references in the Commercial Zone and other related zoning provisions.

"Listen! The wind is rising, and the air is wild with leaves; We have had our summer evenings, now for October eves!" Humbert Wolfe

"Welcome October! New month, new chapter, new page and new wishes. May the month give you courage, strength, confidence, patience, self-love and inner peace. May every day in October fill your day with Hope, Love, Sunshine and Energy. Let there be Joy, Fun and Laughter!"

September was a tumultuous month, filled with fires, fear, fortitude, gratitude to all the fire fighters and first responders and it ended with the loss of another dear friend, Bud Switzer. John and I and our family lived across the street from Bud and Donna and their children for all the years we lived on Alegria. Their children and our children were friends, along with the Sutcliffe kids, the Blakeslee kids, the Biely and the Witter kids. When they were all growing up together, they swam in our pool, hung out at each other's houses, got in moderate amounts of trouble together and... oh friends and neighbors, these were the days when we were able to say, "Go outside and play!" and they did. Rode their bikes, and actually talked to each other.

One of my fondest memories of Bud is about his dog, Elvis. Elvis was one of those big dogs everybody loved, kids on their way to and from St. Rita's would stop to pet and talk to Elvis. Bud put a small license plate with "Elvis" on it on the fence so everyone would know what his name was. Elvis eventually went to dog heaven, but the sign stayed on Bud and Donna's fence.

There were the pumpkins, of course, and, sadly, during the time when Bud and Kevin carved hundreds of them each year we didn't have cell phones and didn't take pictures like we do now.





accordance with COVID guidelines from the State on Outdoor Playgrounds and Other Recreational Facilities, Recreation Parks, and Community Services Department reopened outdoor playgrounds on Friday.

Consider coming different times or days to avoid wait times and potential crowded times.


No eating or drinking in playground, to ensure face masks are worn at all times. Wash or sanitize hands before and after using the playground.

Homeless Outreach in South Pas Continues During the Pandemic



Even during the pandemic, the South Pasadena Police Department's Homeless Outreach Program for Education, (HOPE) Team deploys 24/7, conducting outreach day and night while out on patrol to assist the homeless and educate them about COVID-19, the importance on social distancing as well as providing available resources, including emergency shelters in the area.

A resident recently brought to our attention a few homeless encampments that were believed to be located on the West side of the Nature Park along the Arroyo Trail. The Homeless Outreach team canvassed the area and located two medium encampments and one small encampment in the park. Two unhoused neighbors were contacted and informed they needed to relocate themselves and personal belongings to a different location. The unhoused residents were extremely cooperative and asked if our team could help them clean up and relocate their property. The team spent a short time providing our pick-up truck's services, and the unhoused neighbors cleaned up the sites and disposed of some trash.



I thought winter just started, is it springtime? Being a good guest I often ask what type of wine is the host or birthday boy's favorite, and half the time the answer is chardonnay. When you look at supermarket wine offerings these days, many major chains seem to be focusing on wines, so why then is the space allocated to chardonnay so large compared to other varieties of wine? I have deduced my own theory that not only is the price point narrow compared to other wines,

but the aging potential is longer so you might run into a chardonnay that is a few years old. Supermarket sales of chardonnay have remained steady over the past few

I have been a big fan of St. Francis Winery for some years -- I even visited the winery on a recent visit to Santa Rosa to the Charles Shultz Museum. St. Francis' 2018 Sonoma Chardonnay fit all right notes with me, having benefitted from heavy rains that May and followed by a



cool summer. I closed my eyes on my first taste and could actually taste the aromas of __citrus_, finished by soft tannins. The St. Francis website suggested a pairing of __crab, but my market was out of crab so I had rotisserie chicken which went very well with it. I do suggest decanting the wine for a few minutes before drinking and drink it just slightly chilled.



Public Health is consulting with County Counsel to determine the process and date for re-opening outdoor operations at breweries and wineries serving a meal. We anticipate this process will be completed in a week.

Beginning Monday, October 5, school waiver applications for in-person instruction for students in grades TK-2 will be available online at www.publichealth.lacounty.gov. Applications will be received and reviewed by Public Health in consultation with the State. Schools must follow all required school re-opening protocols for infection control, distancing, and cohorting. Students will be in cohorts of no more than 12 children and in each classroom. This group of students and adults will need to stay together throughout the entire day for all activities. Every school that re-opens will receive a site visit from Public Health. Public Health has a dedicated team of specialists providing technical assistance and disease management control to all schools that are re-opened or re-opening.

Comprehensive protocols for all sectors that reopen will be posted online to ensure the continued health and safety of workers and the community. Businesses are required to implement the protocols for infection control and distancing prior to reopening to ensure they are in compliance, and to avoid citations, fines and possible closure. Businesses have a duty to protect employees, customers and residents from COVID-19 as much as possible and to follow Public Health protocols and directives. It is important for everyone to follow the directives and to do their part every day to keep everyone as safe as possible.






SAFETY IS PRIMARY AS IN-PERSON CLASSES RESUME FOR ESSENTIAL WORKER TRAINING AT LOCAL COMMUNITY COLLEGES

This fall, with campuses closed, nearly all California community college students are pursuing their educational goals online. At the same time, the impact of COVID-19 has increased the need for qualified "essential workers" in fields like healthcare and automotive technology. This leaves students stymied between course requirements for at least some hands-on training for these professions and closed college campuses.

Citrus College has recently reopened labs for students in the Automotive and Diesel Technology programs to train essential workers for the Transportation and Logistics industry. The fact that these qualified professionals are considered "essential" adds an extra sense of urgency to quickly and effectively move students through their programs of study, so they can enter the workplace as soon as possible.

Doing so safely has required the development of myriad protocols and well-choreographed procedures to ensure the learning environment is safe for all participants---a deliberate and painstaking



In addition to the basic COVID-19 protections, like temperature checks, mandatory maskwearing, the use of personal protective equipment, and the distancing of work stations, the college has developed a detailed set of checklists for instructional labs that follow guidelines provided by the Los Angeles Department of Public Health. These include specific protocols for parking, arrival and departure from campus, floor diagrams for standing and walking, the cleaning of classrooms and equipment and a great many other details. The limited number of students who are enrolled in these labs have been informed of the protocols and mandates for participation. They are also reminded of the risk of potential exposure to COVID-19.

Labs and clinical training for several other essential worker programs requiring in-person hours are also available at Citrus College, or will be available soon. Each program is required to meet and abide by every item on detailed checklists.

Studies show online learning is effective, has several unique advantages, and is sufficiently rigorous to satisfy the high standards required by all accredited institutions of higher learning in the state. And during a global pandemic, it is a safe option for students, faculty and staff. Training for some professions, however, requires in-person instruction, and local community colleges are stepping up to provide a safe environment as students complete the requirements for graduation or certification in their chosen fields.



A RATTLING TALE FROM A LOCAL TRAIL

During a hike in Monrovia with one of my four-legged furry friends, a golden retriever named Gus, we were enjoying the cool breeze and warm sunshine as we ascended up the steep hill when we had a rattling encounter with a low-lying, lurking creature in the tall grass. Like



most dogs, Gus is a very curious canine. He notices everything that moves around him, whether it be a leaf falling from a tree, a bird flitting about in a bush, or a squirrel scampering across a power line.

When wind-blown objects or whimsical wildlife draw Gus's attention, it's easy for him to forget his excellent "leash-side manner", and bolt toward the object in motion. I believe his random responses are deeply rooted in his desire to catch and retrieve, in return for a moment of loving praise from his human friends. After all, isn't that what we bred them for?

Although squirrels, bugs and lizards are most often what Gus and I encounter during our walks, deer, coyote and an occasional bear also appear quite regularly in the brush-covered hillsides surrounding the area where he lives. That's pretty commonplace in these local foothills. But on this particular evening, as we ascended up the hill, Gus and I came across a creature that took us very much by surprise!

I'm not sure if it was Gus's nose, ears or eyes that first drew his attention to the would-be elusive crawling creature. Perhaps it was a combination of all three. What I do know is that whichever of his keen senses kicked in at that moment, he was immediately snapped to attention and within a split second he changed his direction toward the object of interest.

Naturally, I looked to see what it was that had captivated Gus's undivided attention, and I saw what I first assumed to be a sagebrush lizard - a harmless reptilian we locals often see slithering over the rocks and through the dirt. Some lizards get quite large, and as adults they can develop a heavy coat of colorful scales and a broad head with shiny round piercing eyes. Lizards are quite agile and they move very fast, which is why dogs and cats love to go after them. It's all about the challenge of the chase.

When Gus got close enough to the reptile to scare it away, I was surprised to see that it did not move, rather it remained still and held it's ground. It was then that I realized our new-found friend was not a lizard at all. My canine companion had just come face-to-face with a snake lying low and lurking in the

Fortunately I managed to pull Gus away before the snake had the opportunity to strike. When we were far enough away for my comfort level, we turned to get a better look at it. I was hoping to figure out what kind of snake it was. Per my estimate, the serpent measured about 25 inches long by 1-1/2 inches wide at its center. All I could think at that point was that Gus could so easily have been bitten, if I had not been paying attention and pulled him away promptly. Feeling lucky that we'd escaped what might have been a revolting development, we continued on our way and completed our hike.

When I got home that evening, I did a web search on snakes most often seen in our area and I determined that the one we saw was likely a Southern Pacific Rattler, which is one of the most common rattle snakes in the San Gabriel foothills. Although it's venomous bite can be lethal, this snake is not known to be aggressive. It just wants to be left alone to continue it's quest for survival, which explains why it refrained from striking and simply laid still in the grass. While I was on-line I also did a little research to refresh my memory on emergency procedures for rattle snake bites in the wilderness.

One of the many important things I learned is; dogs that spend time on the roads and trails of our local canyons should receive a snake bite vaccine before venturing out. There are various kinds of vaccines designed to prevent snake bite demise, so it's best to let your vet help you choose the right one for your pet. There's been some research on the outcome for vaccinated dogs versus non-vaccinated dogs bitten by snakes, and the data implies that it's definitely worth vaccinating your dog before engaging in frequent wilderness hikes.

Paramount to helping avoid the risks and detrimental results of a canine snake bite is to stay vigilant and attentive to what the dog shows sudden interest in during your hike. Basic canine training and maintaining control are very important as well, as exemplified by my reaction when Gus first saw the snake. If I had hesitated to call him back, he would probably have been inquisitive enough to aggravate the snake, in which case he would most likely have been bitten.

If a dog (vaccinated or not) is bitten by a rattle snake, immediate veterinary attention is imperative. In the case of a time-lapse between the biting and veterinary care, keep the dog well-hydrated in the meantime. If the dog is not willing to drink, use a syringe to force fluids down his throat and keep the dog as calm and relaxed as possible. Finally, and perhaps most obviously, do not panic! Stay focused and use your energy to handle the situation efficiently. The happy side of this potentially not-so-happy tale, is the fact that the rattle snake is known to be way more passive than aggressive. I often say "Love and let live", but in this case, I'll say "Love, let live and leave it alone." A rattle snake will typically hide in lieu of striking when left to itself, so give it some space and continue on your way. Here's to a healthy, hearty, happy hike!

It seems that sore throats, coughs, colds, and flus have afflicted people forever, whether resulting from the proximate causes of pollen, dust, woodsmoke, or from talking too much, or yelling, or even from "catching" something from another person. This season we also have Covid-19 to contend with.

Fortunately, there are quite a few natural remedies which help relieve the pain and discomfort these conditions, and many of these have been used for at least centuries.

First, keep in mind that the best defense is a strong immune system, so do everything you can that maintains a strong immune system.

I spoke with Dr. James Adams, a doctor of pharmacology at USC, and a student of Chumash healing for about two decades. Dr. Adams wrote the book "Healing with Medicinal Plants," which is the source for my information today.

Each of the plants described are commonly available in the wild, and typically can be purchased in the dried form in herb shops. You can contact me if you cannot find these herbs.

ELDERBERRY FLOWERS (Sambucus nigra; formerly Sambucus Mexicana)

Different species of the elderberry tree can be found world-wide, often near water. It can be a large bush or a small tree, with pinnately divided leaves. Though the fruit has long been cooked and used for juices, wine, jam, and jellies, it is the flowers that are used for colds and flus. Indigenous people of California used the flowers to cure colds and flus. The flowers are made into an infusion and drunk. The flowers are only available in the spring, so you'd need to collect and dry them to be available year-round.

EVERLASTING, CALIFORNIA (Pseudognaphalium californicum)

This one, and several related species, are somewhat widespread in the West. Leaves have a sweet odor, akin to butterscotch or oranges. It's easily grown in backyard gardens, and the flowers can be collected and dried, so that the herb can be available

I learned about its uses from Dr. James Adams, author of "Healing with Medicinal Plants of the West." Whenever I feel congested and have difficulty breathing, often after a day of being out in the willow forest, I drink an infusion of the everlasting flowers. They have a quick and immediate effect. (I often drink this along with stinging nettle tea, which also has mild decongestant effects.)

Dr. Adams recommends using these flowers at the first signs of a cold, or flu.

The flowers contain flavinols which stimulate the immune system and help get rid of flu virus.

The medicine is the flowers. For a cold or flu, put 1 teaspoon of flowers into a cup of water, and heat until it simmers. Dr. Adams suggests drinking it for 4 nights in a row for colds and flus.

YERBA SANTA (Eriodictyon spp.) This is a very common western herb, with several

species that are more or less used a like. Yerba Santa leaves are boiled in water, and the fumes are inhaled for upper respiratory issues. The infusion can also be drunk for a sore throat, cough, or

Herbalists use this herb for many afflictions, and it is particularly good for coughs, breathing, and congestion issues. The indigenous peoples of California used this herb for coughs. This is commonly consumed by drinking the boiled decoction. Another method is to boil the leaves in a covered container,

THE COVID LONG-HAULERS

It's been six months since Zach got Covid, and he hasn't yet recovered. Zach, a previously fit, healthy 33 year old attorney who's the son of two good friends was never admitted to a hospital because of an acute shortage of ICU beds. But over two months of coronavirus hell, he developed pneumonia, struggled to breath, coughed constantly, shivered under three blankets, and barely slept or ate. His chest felt like it was on fire.

'There wasn't an inch of my body(truly)that wasn't in excruciating pain" he recounted in a Facebook post last week. Despite sophisticated medical care and an endless battery of tests, his chest still aches, he's breathless after a short walk and he's too weak to work. Zach is one of a largely invisible legion of "long-haulers"-covid survivors who continue to suffer a host of mystifying maladies. Studies suggest that about three-quarters of those who get sick remain ill for months. No one knows if and when long-haulers will return to their pre-Covid selves. "for now, this is my new normal" Zach said.

Whenever I see people highly congregating without masks or social distancing, I think Zach and a younger member of The Week's staff who is a long-hauler. Many younger Americans falsely assume that because most of the people Covid kills are over 70, they are safe.. In reality, the coronavirus makes some younger people very sick for reasons no one fully understands; Covid roulette is a high-risk game. Long-haulers like Zach would tell you that this nasty virus is not "a little flu" and that you don't want it inside your body, attacking cells in your blood vessels, lungs, heart and even the brain. President Trump would have told you that, too, if you were speaking to him privately.

HOW TO CREATE AN ONLINE MEMORIAL FOR A DEPARTED **LOVED ONE**

Dear Savvy Senior:

My mother passed away last week, and because of COVID we didn't have a funeral. I would like to create some type of online memorial for her so family and friends can express their condolences and share their stories. What can you tell me about making an online memorial for my mom? Grieving Daughter



Dear Grieving:

I'm very sorry for your loss. Creating an online memorial for your mom is a great idea and one that's become increasingly popular in the age of COVID. Thousands of families have created them for their departed loved ones, especially those who didn't have a proper funeral because of the pandemic. Here's what you should know.

What is an Online Memorial?

An online memorial is a website created for a deceased person that provides a central location where their family and friends can visit to share stories, fond memories, photographs, comfort one another and grieve. The memorial can remain online for life, or a specific period of time, allowing people to visit and contribute any time in the privacy of their own space.

Online memorials started popping up on the Internet in the late 1990s but were created primarily for people who were well known. But now, these sites are for anyone who wants to pay tribute to their departed family member or friend and ensure they will be remembered.

Content typically posted on an online memorial includes a biography, pictures and stories from family and friends, timelines of key events in their life, along with favorite music and even videos.

Another common feature is an online guestbook where visitors sign their names and write tributes to the departed. Online memorials can also direct visitors to the departed person's favorite charity or cause to make a donation, as an alternative to sending funeral flowers.

Some online memorial sites today even offer virtual funeral/event capabilities as a replacement for an in-person funeral. And they'll help you get the word out by offering invitations and RSVP tracking.

Top Online Memorials

To make an online memorial there are a wide variety of websites available that make it easier than ever to create a thoughtful, personalized profile for your mom to celebrate and honor her life, and the process of creating it can be very satisfying.

You also need to know that some online memorial sites are completely free to use, while others offer a free and a paid version that provides additional features.

Some of the best sites that offer both free and paid options are MyKeeper.com (free or \$75) and iLasting.com (free or \$49/year or \$99 for a lifetime membership).

Or, if you're interested in one that's completely free to use, some top options are GatheringUs.com (they do charge for virtual events), Memories.net, InMemori.com and WeRemember.com.

Memorialize Facebook

If your mom used Facebook, you can also turn her profile into a memorialized account for free when you show proof of death. This option will let your mom's family and friends share stories, photos or memories to celebrate her life, with the word "Remembering" shown next to her name.

Once her account is memorialized, the content she shared is still visible on Facebook to the audience it was originally shared with, however, her profile will not show up in public spaces such as people she may know, ads or birthday reminders.

In addition, you can also request a Look Back video, which is a short video created by Facebook highlighting your mom's pictures and most liked status messages.

WHAT YOU SHOULD KNOW BEFORE AGREEING TO SERVE AS TRUSTEE

As he grew up I was pretty certain that he would never be able to live independently. When my new house was being built it was designed to have a back entrance that would allow my son to come and go with some privacy and independence. Remarkably, he has never had to use that entrance as he, through his own very hard work, has managed to live independently.

His life has had its ups and downs but, on the whole, he is just as happy or just as miserable, as everyone else. After the age of six he lived with me as his single parent. Soon my daughter joined us and we lived as a single parent family together with our dog.

My deficiencies as a parent are pretty obvious to anyone who knows me. I am terribly disorganized, lack almost all domestic skills, had absolutely no experience in parenting, and was a working lawyer with little extra time. Somehow the kids and I managed to eat and do our laundry and pay our bills. During the schoolyear we had limited outings like going personally to pay our utility bills and to the bank because I never liked using the ATM. For me every possible interchange with another person represented a possible expansion of a pretty isolated life. We were regular customers at Robin's Restaurant and got to know Robin so well that my name was placed on the menu. Of course what I thought was isolated then is laughable when measured against the forced isolation required by today's Covid virus rules. What I could do then was listen, answer questions, and explain.


It was my son's acceptance of rules that allowed him to develop enough confidence and skill to lead the life that he does. He is always punctual, always remembers to take his multiple medications each day and amazingly has learned to make good friends wherever he has lived. He has learned to rely on people he trusts to explain situations that he does not understand. If I had any strength, whatsoever as a parent, it was my willingness and my ability to take the time necessary to explain things to him. While he was growing up he thought I was pretty smart and could explain most things to him. This morning when he called, he was troubled from watching the Trump-Biden "debate". "AREN'T THERE ANY RULES"? AREN'T WE SUPPOSED TO BE A GOOD COUNTRY?" he simply asked.

All day I have pondered the question and have decided that the answer is not simply that the President is much like a willful undisciplined child. I am pretty proud of what we have accomplished over the last 14 years, despite huge economic challenges, such as the 40% tariff on newsprint that comes from China and has adversely impacted print media in the United States or California's AB5 which is another threat to newspa pers statewide, we survived.

And then....2020 and COVID-19 happened! To date, we are still alive and moving forward. We are proceeding cautiously and are committed to continue providing you with accurate information about your community. In March, when we reached out to you for help we expected that by May at the very least the Emergency would be over. We could not have imagined in our wildest dreams that in August the crisis would still be with us. As indicated in the beginning, the Mountain Views News has survived primarily on the paper's ability to publish legal notices and the support of our advertisers many of whom are also impacted by the COVID19 virus. 

LETTER TO THE EDITOR:

President Trump's announcement early Friday that he had contracted the coronavirus upended the presidential race in an instant, inviting significant questions about his cavalier attitude toward the pan-demic and the future of his campaign just 32 days before the election.

Mr. Trump had already been trailing Joseph R. Biden Jr. in the polls, in part because of his mishandling of a virus that has unsettled the day-to-day lives of voters for over six months. The president com-pounded his difficulties by disregarding and at times belittling the basic precautions, such as wearing a mask, that his health advisers were urging Americans to take to protect themselves. Now, though, his personal indifference toward the virus could threaten his own health, the stability of the country and his already dimming hopes for re-election.

Strategists in both parties and even senior aides to Mr. Trump said the president would face a harsh judgment from voters for throwing the country into greater uncertainty after one of the most trying years in American history.

Returning Your VBM Ballot

Voters are advised that they are responsible for how their Vote by Mail (VBM) ballots are returned and with whom they entrust their ballots. The Los Angeles County Registrar-Recorder/County Clerk recommends returning a ballot to either a mailbox, official drop box, or ballot box.

Voters who cannot return their VBM ballot can designate any person to return their ballot as long as there is no compensation involved for that individual, group or organization returning the ballot.

There are several recommended options for returning a Vote by Mail ballot during any election:



Return by mail.

Must be postmarked by Election Day. No postage required.



Drop-off at a Vote by Mail Ballot Drop-Off Location.

List of drop-off locations available at LAvote.net prior to each election.



Drop-off at any Vote Center leading up to and on Election Day.

List of Vote Centers available at LAvote.net prior to each election.



Signature Verification

Voters must sign the eligibility oath and date the VBM return envelope before submitting their ballot. Every signature is verified before the ballot is cleared for counting. If a signature is missing or if the signature does not match the one on file, the County will notify the impacted voter to allow the voter an opportunity to provide a valid signature

PORTRAIT OF OUR NEIGHBORS by Stuart Tolchin

JEANNETTE ESPINOZA

Ieannette Independent Living Instructor with brightly colored red hair which reaches half-way down her shoulders. I say "How do you do it? You look like you're always enjoying yourself." She says "I love my job!" As an Independent Living Skills Instructor" she provides services to disabled adults who receive Social Security payments (SSA). Her specific duties are to assist with transportation to medical appointments and pharmacies. She helps her clients by sorting their medications and stays in constant contact with them so they do not skip taking their pills. If her client has an operation, she will be there for them. She helps with their grocery shopping, and reminds them about personal hygiene. She tries as hard as she can to make her clients happy, and healthy, and to be sure that they are not being taken advantage of. She describes herself as often acting like a Court Jester, doing anything, "to put smile in their hearts."



One of the great advantages of her position, she says, is that her relationship with her clients is often long term. She has known some clients for a decade or more. Successes in these relationships is observable in "baby-steps" as she sees them improve "little by little" as they become less isolated or depressed and willing to utilize resources that are available. Of course, at this time during the pandemic most of these resources are not functioning and it is very tough on her clients. She admits to bonding with her clients and seriously cares about their welfare and their future. This, despite the fact, that her supervisors emphasize that no personal attachment should be formed with her "consumers". Frankly, she says this is impossible and that a big part of her job is caring. She emphasizes to me that she does not act as a "parent" but rather as resource of support. She informs her clients about resources or jobs

but has no authority to direct her clients to do anything.

Jeanette's journey to becoming an Independent Skills Instructor was unusual. Her early ambition was to be a game warden. She loves the outdoors and animals. Growing up she went camping, hunting, and fishing with her parents. Police work was also of interest, and she described the duties of a game warden like a police person in the forest. So at age thirty, as her sons were old enough to allow her to go to College, she began taking courses to prepare for this position when she was involved in a terrible auto accident.

She knew her injuries would make it impossible for her to pass the physical requirements to be a policemen or a game warden. Still she wanted to be of help and could not imagine working in an office. As a part of her recovery she became involved in tai chi and later taught classes. When she was finally able she became a volunteer at Senior Centers and Schools for ten years. Fortunately, her sister became a supervisor within the ILSI program and directed Jeanette to the classes necessary to qualify for the position. She also explained that most of her skills result from On the Job Training which has taught her never to preach to people and by all means to treat her clients with respect and to likewise expect to be treated with respect. In her thirteen years on the job she has rarely felt that her relationship with a client was not positive and on those rare occasions she has requested that the client be provided with another worker.

I learned from this interview that one of the keys to satisfaction is to recognize early what your interests are and to adapt to the inevitable obstacles that appear but to not lose sight of what you want to do. It is not the salary or the prestige of a job that is important but rather how that job coincides with your own vision of yourself.
