

# SIERRA MADRE PLAYHOUSE **MARQUEE RE-LIGHTING**

The SMP marquee has long been a fixture on the Boulevard and a landmark for the



City of Sierra Madre. While SMP has been closed during the pandemic, the marquee has been bearing weekly messages of inspiration and thanks. But as many may have noticed, the marquee has been showing its age - with broken neon, dimmed lights, and broken acrylic backing.

But recently, you may have noticed quite a bit of activity around the marquee. In the spring, SMP's Board of Directors launched a campaign to renovate the iconic sign as proof that, Covid-19 notwithstanding, the Playhouse stands strong and will continue as the cultural center of our part of the San Gabriel Valley. Built in 1910 and transformed into a movie theater in 1924, the marquee was added to the building sometime after that and has been badly in need of a facelift. A grant from the Sierra Madre City Council, along with earmarked donations from private Sierra Madre residents, has allowed SMP to hire the premier restorer of theater marquees, Yesco, to restore ours to its original brilliance.

The Playhouse will host a ceremonial relighting of the Boulevard landmark at 6 pm, Friday, October 23rd. The Playhouse looks forward to having our community join them in celebrating this long-anticipated moment by watching a live stream of the event on their social media – go to their website SierraMadrePlayhouse.org for links to the event. Local and community leaders will be on hand to participate in the dedication ceremony; social distancing protocols will be in place. The event will be recorded and posted on the SMP website following the event.

I've been collecting them for a while now and the first one is the one I opened last Monday when daughter, Crissy, and I went to P F Chang's for lunch to celebrate the return of her daughters, Jessie and Emily, to school. In the school building. Wearing masks, working on Chrome books, distanced in the



gym, but out of the house and back with many of their peers. The picture isn't the girls as they were too giddy to photograph.

What a delight to see George Maurer's picture on the front page of last week's Mountain Views News, celebrating his 98th birthday. I have to say he looks great. I'm sure all of you have a George Maurer story and I've told this one before, but in honor of his 98<sup>th</sup> birthday, I'm going to tell it again. In 1974, John and I and our family were living there on Alegria and our youngest daughter, Crissy, (yes, that same one mentioned above) was four years old. John and I had gone to one of the Museum buildings in Exposition Park to record a concert for the jazz station which is now KKGO – Go Country. John worked for Mt. Wilson Broadcasting most of his adult life and did a lot of that sort of thing. As the evening progressed, he got a page from our own Nancy Shollenberger, who at that time was the owner of the local answering service company. As paging was brand new at that time, it's a wonder she got him at all but she was determined and, if you know Nancy, that's a good description of her. Her news was not good. Crissy had been hit by a car, running across the street to the ice cream truck. She was horribly injured and as it was hot mid-July, was wearing a bathing suit so being dragged along the pavement was awful. Here's where George Maurer comes in. Sierra Madre had a station wagon which was fitted out with paramedic supplies but not at all equipped as an ambulance. George and the dear man who was with him that day took a look at our little girl, scooped her up and drove her to Methodist Hospital where they saved her life. But if George had waited for an ambulance, we're not so sure she would have made it.

In our eyes he achieved sainthood that day and his service to the community and great man he has continued to be to this day have done nothing to change our minds. Happy birthday, George, and thank you again for what you did that hot July day so long ago.

## **City Issues** Halloween Safely Guidance

City Officials remind everyone that COVID-19 continues to impact families and traditions as we move into the fall season. It is another difficult milestone to think of Halloween without the block parties, gatherings and the door to door "trick or treat" that we all look forward to every year. We recognize that these are "high risk" activities that can spread this disease. There are protocols from the state and county and local health departments which continue to limit our activities and which provide guidance for celebrating safely, including safer alternatives that still promote as festive an environment as is possible amid the pandemic.

Under existing state, county and local orders, community members may participate in the following activities as long as they adhere to the City's Safer at Home Order and related protocols:

Online parties and contests (e.g., costume or pumpkin carving);

Car parades that comply with public health guidance for car line celebrations;

Halloween movie nights at drive-in theaters (must comply with the drive-in movie theater protocol);

Halloween-themed meals at outdoor restaurants (must comply with the restaurant protocol);

Halloween-themed installations at an outdoor museum (must comply with the museum and galleries protocol); and

Dressing up homes and yards with Halloween-themed decorations.

#### Halloween activities NOT permitted include: Door to door trick or treating

and outdoor Indoor gatherings/parties non-household members; Carnivals, festivals, entertainment, rides, petting zoos, and haunted house attractions;

"Trunk-or-treating" events where children go from carto-car instead of door-todoor to receive treats; and in the setting of a gathering or

#### Halloween activities NOT recommended include:

Door-to-door or car-to-car trick-or-treating because proper social distancing is difficult to maintain and sharing food is risky.

The City reminds residents of Halloween fire safety tips, including using battery-operated candles or glow sticks in jack-o-lanterns and keeping exits and escape routes clear of decorations. It is also a good time to make sure that all smoke alarms in your home are working.

During the holiday season, it is especially important to avoid driving under the influence. Remember that Doesn't Just Mean Booze." If you take prescription drugs, particularly those with a driving or operating machinery warning on the label, you might be impaired enough to get a DUI. Marijuana can also be impairing, especially in combination with alcohol or other drugs, and can result in a DUI. The City also urges drivers to plan routes in advance and avoid texting or otherwise using a cell phone while driving.

## Pasadena Fire Strike Teams Safely Return



Over the past three months, California experienced its worst fire season in history. Pasadena Fire Department responded to several incidents as part of their commitment to statewide mutual aid.

"We thank our community and city management for allowing us the opportunity to support other counties and neighboring cities affected by these unprecedented wildland fires. We know that if fires of this magnitude occur in our foothills we would have the support of our fire department partners throughout the state. It is also important to recognize those firefighters who came in on their days off to cover those who were deployed to these incidents. This is yet another shining example of their firm commitment to the fire service and to our community," states Interim Fire Chief Bryan

Frieders. The fire department had resources out a total of 218 days over an approximate three-month period including fire engines, water tender, Rapid Extraction Module Support (REMS) teams, fire line emergency medical technicians and strike team leaders. The total personnel for all deployments combined was 79, which includes some who went on multiple deployments.



#### SUPERVISOR BARGER ASKS BOARD TO EXPAND ACCESS TO HIGH-SPEED INTERNET TO ENSURE EQUITY

Los Angeles County meets students' and workers' needsin light of disparity revealed by COVID-19

LOS ANGELES COUNTY - The Board of Supervisors unanimously approved a motion au-thored by Supervisor Kathryn Barger and co-authored by Supervisor Hilda Solis to pro-vide more equitable access to high-speed internet for students and workers in need.

COVID-19 shed a light on many inequities within Los Angeles County. The pandemic re-vealed a great disparity for internet access, which impacts children who are learning online and residents who are teleworking.

"As many have transitioned to working from home and distance learning, the need for af-fordable, reliable telecommunications services and resources is now more important than ever," said Supervisor Kathryn Barger. "We hope this effort will lead to a more just and equitable future in order to equip our residents with the access they need to learn, work, and thrive."

The American Community Survey Data for Los Angeles County revealed that only 65 per-cent of households in low-income communities had internet access and only 51 percent had a computer. In total, 238,000 households lack internet access. According to a study by the USC Annenberg School of Communications, one in four families with school-age chil-dren in Los Angeles County do not have the resources necessary for distance learning and are likely to fall behind in their education during the pandemic.

"Bridging the digital divide is an educational justice issue," said Supervisor Hilda L. Solis. "Communities of color, those from low-income families, people with disabilities, limited English-speakers, and people experiencing homelessness lack the appropriate technology to adequately telework or participate in distance-learning. No one should be left behind, and through this motion, the County hopes to ease this divide through digital innovation and inclusion."

The motion raised by Supervisors Barger and Solis aims to create a plan to:

- (1) Develop best practices for streamlining the permitting of high-speed broad-band internet;
- (2) Explore both public and private options for providing access to internet, including leveraging grants;
- (3) Develop a database and geographic information system to display existing broadband infrastructure;
- (4) Explore revisions to the County's General Plan to give unincorporated areas sufficient access to high-speed internet; and
- (5) Explore new strategies to provide free, low-cost or permit based internet to disadvantaged communities.

The motion directs the Department of Public Works and the Department of Regional Planning to report back to the Board in 90 days with their plan.

#### CALIFORNIA DEPARTMENT OF PUBLIC HEALTH **GUIDANCE FOR PRIVATE GATHERINGS**

This guidance provides an updated plan for Californians to gather outside their household and replaces the prior gatherings guidance issued on September 12, 2020 and March 16, 2020. It applies to private gatherings, and all other gatherings not covered by existing sector guidance are prohibited. Gatherings are defined as social situations that bring together people from different households at the same time in a single space or place. When people from different households mix, this increases the risk of transmission of COVID-19.

Mandatory Requirements for All Gatherings

All persons planning to host or participate in a private gathering, as defined above, must comply with the following requirements. Local health jurisdictions may be more restrictive than this guidance. Refer to your local uidance for what is al-lowed in your area Attendance

Gatherings that include more than 3 households are prohibited. This includes eve-ryone present, including hosts and guests. Remember, the smaller the number of people, the safer.

Keep the households that you interact with stable over time. By spending time with the same people, risk of transmission is reduced. Participating in multiple gather-ings with different households or groups is strongly

The host should collect names of all attendees and contact information in case con-tact tracing is need-

ed later. 2. Gather Outdoors

Gatherings that occur outdoors are significantly safer than indoor gatherings. All gatherings must be held outside. Attendees may go inside to use restrooms as long as the restrooms are frequently sanitized.

Gatherings may occur in outdoor spaces that are covered by umbrellas, canopies, awnings, roofs, and other shade structures provided that at least three sides of the space (or 75%) are open to the outdoors.

A gathering of no more than three households is permitted in a public park or other outdoor space, even if unrelated gatherings of other groups up to three households are also occurring in the same park or other outdoor space. If multiple such gath-erings are occurring mixing between group gatherings is not allowed. Addi tional-ly, multiple gatherings of three households cannot be jointly organized or coordi-nated to occur in the same public park or other outdoor space at the same time this would constitute a gathering exceeding the permitted

3. Don't Attend Gatherings If You Feel Sick or You Are

in a High-Risk Group

• Anyone with any COVID-19-like symptoms (fe ver, cough, shortness of breath, chills, night sweats, sore throat, nausea, vomiting, diarrhea, tiredness, muscle or body aches, headaches, confusion, or loss of sense of taste/smell), must stay home and not come into contact with anyone outside their household.

Anyone who develops COVID-19 within 48 hours after attending a gathering should notify the other attendees as soon as possible regarding the potential

People at higher risk of severe illness or death from COVID-19 (such as older adults and people with chronic medical conditions) are strongly urged not to attend any gatherings.

Practice Physical Distancing and Hand Hygiene at Gatherings

For any gatherings permitted under this guidance, the space must be large enough so that everyone at a gathering can maintain at least a 6-foot physical distance from others (not including their own household) at all

Seating must provide at least 6 feet of distance (in all directions—front-to-back and side-to-side) between different households.

• Everyone at a gathering should frequently wash their hands with soap and water, or use hand sanitizer if soap and water are not available. A place to wash hands or hand sanitizer must be available for participants to use.

Shared items should not be used during a gathering. As much as possible, any food or beverages at outdoor gatherings must be in single-serve disposable containers. If providing single-serve containers is not possible, food and beverages must be served by a person who washes or sanitizes their hands frequently, and wears a face covering. Self-serve items from communal containers should not be used.

Wear a Face Covering to Keep COVID-19 from Spreading

• When gathering, face coverings must be worn in accordance with the CDPH Guidance on the Use of Face Coverings (PDF), unless an exemption is appli-cable.

People at gatherings may remove their face coverings briefly to eat or drink as long as they stay at least 6 feet away from everyone outside their own household, and put their face covering back on as soon as they are done with the activity.

Face coverings can also be removed to meet urgent medical needs (for example, to use an asthma inhaler, take medication, or if feeling light-headed).

6. Keep it short

Gatherings should be two hours or less. The longer the duration, the risk of trans-mission increases. Rules for Singing, Chanting, and Shouting at Outdoor

Gatherings

• Singing, chanting, shouting, and physical exertion significantly increases the risk of COVID-19 transmission because these activities increase the release of respira-tory droplets and fine aerosols into the air. Because of this, singing, chanting, and shouting are strongly discouraged, but if they occur, the following rules and rec-ommendations apply:

o All people who are singing or chanting should wear a face covering at all times while singing or chanting, including anyone who is leading a song or chant. Because these activities pose a very high risk of COVID-19 transmis-sion, face coverings are essential to reduce the spread of respiratory drop-lets and fine aerosols;

People who are singing, shouting, chanting, or exercising are strongly en-couraged to maintain physical distancing beyond 6 feet to further reduce risk.

People who are singing or chanting are strongly encouraged to do so quietly (at or below the volume of a normal speaking voice).

Instrumental music is allowed as long as the musicians maintain at least 6-foot physical distancing Musicians must be from one of the three households Playing of wind instruments (any instrument played by the mouth, such as a trumpet or clarinet) is strongly discouraged.

COVID-19 continues to pose a severe risk to communities and requires all people in California to follow neces sary precautions and to adapt the way they live and function in light of this ongoing risk. The safest way to gather is to spend time with people in the same household or to gather virtually.

In general, the more people from different households a person interacts with at a gathering, the closer the physical interaction is, and the longer the interaction lasts, the higher the risk that a person with a COVID-19 infection symptomatic or asymptomatic, may spread it to others. Public health studies have also shown that the risk of transmission is increased in indoor spaces, particularly when there isn't appropriate ventilation.[1] Unlike indoor spaces, wind and air in outdoor spaces can help reduce spread of the virus from one person to another. Planning scenarios published by the CDC estimate that, on average, a person with COVID-19 goes on to infect between 2-4 people, with a best estimate of 2.5 when there are no preventive measures.[2] For example, if each infected person spreads the virus to two people, who in turn spread it to two others each; those four will spread the virus to eight others; those eight will spread the virus to 16; and so on. As a result, after 10 transmission cycles, one person could be responsible for 1,024 other people contracting the virus.[3] Additionally, there is broad agreement that people who are not experiencing symptoms can still spread COVID-19[4]. The fact that COV-ID-19 can be spread by people who don't have symptoms or aren't showing symptoms yet is one of the aspects of the COVID-19 that makes it difficult to control.

All gatherings pose a higher risk of transmission and spread of COVID-19 when people mix from different households and communities. The likelihood of transmission and spread increases with laughing, singing, loud talking and difficulty maintaining physical distance. Limiting attendance at gatherings is a way to re-duce the risk of spread as it lowers the number of different people who are inter-acting. Additionally, by limiting attendance there is an improved ability to perform effective contact tracing if there is a positive case discovered, which can help to slow the spread of COVID-19[5]. People who do choose to attend gatherings should discuss and agree upon the specific group rules before convening together.

#### PUBLIC HEALTH ADVISES IT HAS NEVER BEEN MORE IMPORTANT FOR RESIDENTS TO GET IMMUNIZED AGAINST THE FLU

The Los Angeles County Department of Public Health (Public Health) encourages residents to protect themselves from influenza this year by getting the flu immunization.

Because it is highly likely that both flu and COVID-19 will be present in L.A. County this year, it's vital that we do all that we can to protect ourselves to prevent a serious flu season coinciding with the COVID-19 pandemic.

Every year, tens of thousands of people nationwide are hospitalized or die from

flu-related illness. Considering the toll COVID-19 has had on our communities and our healthcare system, now more than ever it is important to be protected from influenza by getting immunized. Immunizations are safe and provide protection against the harmful effects of influenza and can also help keep people out of the hospital freeing up critical hospital resources.

Everyone 6 months and older should be immunized against flu. Anyone can get flu (even healthy people), but people at high risk of developing serious flu-related complications include: people 65 years and older, pregnant women, children younger than 5 years and people with chronic medical conditions (such as asthma, diabetes, heart disease, or HIV).

To get immunized for flu, visit your doctor, a pharmacy or a flu immunization clinic, where both walk-up and drive-thru service is available. To find a low-cost, or free, immunization, call 2-1-1 or go to PreventFluLA.com.

Hey all on vacation this week but with the elections coming up I thought we could re run this!!!

Let's talk minimum wage. The Federal Government sets it at \$7.25 but that amount can be superseded (big word) by individual states, including California. If you dig further, cities such as Santa Monica, Pasadena and San Francisco have their own. For example, San Francisco's minimum wage is \$16.07 - this isn't some Newsom mandate; this was passed by the voters in San Francisco.

Many restaurant owners I talk to have supported this wage as long as it is for non-tipped employees. This where it gets tricky - besides what they and we are going through now restaurants have a very slim margin so the question I have for you is: "Is that too much? Too little?" And, if you work in or have worked in a restaurant would you rather work



for as much as you can get (performance based) or take a living wage say, \$23 an hour but no tips? Places like Target and WalMart pay a minimum wage, and at \$16 a hour I could see that attracting a pretty good young worker, although when I was growing up working at McDonald's or Target was purely meant for side cash not supporting a family. While I'm not an economist what I've read tells me that as wages go up, menu raises also go up, so it makes sense that in a restaurant if the menu prices go up tips will also go up. However for over 70% of restaurant employees, their take home pay has not gone up. Tipping is down an average of 23% every time a restaurant enacts a price hike due to minimum wage, while only 5% said that tips have gone up, so there goes theory one. Consumers often feel that servers are making more money so why tip more. I still tip 20%. Remember TIPS ensure good service and when I'm out I want it all.

Some restaurants have added surcharges instead of adding to the menu prices this restaurant goer is opposed to that, but open to discussion.

Tipping has been around forever and there has to be a solution of rising wages and tips - maybe a tip credit? I have known workers that work at the Red O or Paradise Cove or Carrows who make \$45 an hour. That is a living wage.



#### CHAMBER STRONGLY OPPOSES PASSAGE OF **PUSD MEASURE O**

Pasadena Chamber of Commerce Board of Directors voted to strongly oppose passage of Pasadena Unified School District's facilities bond Measure O on the November 3, ballot. The unanimous vote of the Chamber Board members present reflected the strong sentiment that Measure O is the wrong initiative being put before the voters at the worst possible time.

Measure O, placed on the ballot by the PUSD Board in a divided vote, asks voters to approve a more than \$500million bond measure to improve existing campuses. The additional tax burden will be borne by local taxpayers for more than 25 years. Titled the Pasadena Unified School District Repair, Technology, Student Achievement Measure, less than 15% is dedicated to technology upgrades. None of the funds generated are allowed to be spent on instructional materials or teacher salaries, per California law.

In dissenting during the vote, Board members Kimberly Kenne and Elizabeth Pomeroy expressed concerns that there is no set project list, the measure was rushed onto the ballot, the amount is too much of a burden on taxpayers right now and that existing PUSD bonds are still outstanding.

'The Board of the Pasadena Chamber found this measure to be an affront to taxpayers, property owners and residents," said Pasadena Chamber CEO Paul Little. "This country and our greater Pasadena area are experiencing the harshest financial downturn since the Great Depression-unemployment has skyrocketed, recovery will be a long slow process and no one but the wealthy among us can afford any additional expenses right now. Pasadena Unified is in crisis, it is just not a facilities emergency, it is a student achievement crisis. Investment needs to be made in teachers, instructional materials and student support - not buildings and not at the expense of local taxpayers already reeling from our battered economy."

PUSD leadership is on record stating they have "failed" African-American students. One school board candidate has expressed concerns about the quality of education her children are receiving from PUSD, pointing out that her son graduated with a 1.45 Grade Point Average from PUSD and earned a 3.2 GPA at Pasadena City College. "That made me realize it's not about the kids, it's what the kids have to make them successful," she said at a recent candidate forum.

Pasadena Unified is suffering from significantly declining enrollment, with projections that only 14,000 students will be attending PUSD schools within five years. School district officials and board members have blamed the decline, at least in part, on a lack of affordable housing in the PUSD service area. Passage of Measure O will make residential rents even less affordable as landlords pass tax increases along to tenants. Struggling small businesses will see their rents increase to cover additional costs forced upon them by Measure O.

"Somehow there is this notion that tax increases are simply absorbed by landlords when the truth is exactly the opposite-California allows landlords to pass tax increases along to residential and commercial tenants and most leases contain provisions that permit exactly that," said Mr. Little. "Passage of Measure O will further provoke a decline in PUSD enrollment by driving housing costs up. It is simple math-higher rents mean fewer PUSD families able to afford to live in its service area. It will also hasten the closure of local small businesses who are teetering on insolvency now and cannot face increased rent and building costs."

The Pasadena Chamber of Commerce and Civic Association Board of Directors wants to encourage an effective Pasadena Unified School District that delivers an excellent education for all its students. Measure O does not address the pressing need to invest in effective classroom support for PUSD students or teachers.

The PUSD Board of Education has struggled to maintain a healthy financial outlook for the district, getting to the verge of a takeover by the LA County Office of Education due to its inability to make tough financial decisions. At the same time the school board struggled to determine which campuses to close as a result of its significantly declining enrollment. The Chamber says vote no on Measure O.

# TEEN MEMORIES OF EDDIE VAN HALEN

It was late Sunday night, and Eddie Van Halen had died 4 days earlier. My wife and I were on our way home and we were talking about my memories of Eddie. We felt inspired to go see the Van Halen landmark, the curb where Eddie carved his family name in wet cement many decades ago.

It was past 10 p.m. when we arrived at the curbside candle-lit landmark. "There it is," I said. Fans had written messages on the sidewalk and left candles and paraphernalia all around the Van Halen inscription. Large letters spelling out VANHALEN decorated the lower walls of the line of stores.

As my wife and I took a few photos, fans continued to stop and take pictures, and talk about how they wish they had met Eddie. As I was telling stories to my wife of my high school youth, some people overheard and asked if I really knew Eddie.

"Yes, I knew Eddie," I told them. "We hung out together in high school."



People were impressed that someone who actually hob-knobbed with the Great Eddie could be there on that dark night. One man, a true devoted fan, drove over from Long Beach to honor the man's shrine. A group of young people showed up, most dressed in hard rock-black – one with a guitar, and two with long hair just like Eddie -- to pay hom-age to The Man. These young men and women, were too young to know Eddie in the day, but old enough to have listened to and admired his music. During our short visit, maybe two dozen people came by and drove by to see the shrine.

I knew Eddie well enough. It began when I went to John Muir High School with David Roth, taking Spanish with Roth, and circulating in the same social circles. It was through David that I got to know Eddie Van Halen and the band. David Roth dated the sister of my best friend, and through Joe and Debbie Sierra, and John Linthurst, and the John Muir Conservation Club, I got to know David, and through David, I often went to the parties as the unpaid group photographer.

Eddie attended Pasadena High School on the other side of town, so we saw Eddie and the band on the weekends, or when the band was practicing in the sound-proofed back room of Homer Dollar's home on Maiden Lane. My close friend John Linthurst rented the Dollar place, and so John would call me when the band was out back practicing, and I bicycled the short few blocks from my parents' house to listen, and take pictures.

I liked Eddie. He was friendly, open, never conceited or preoccupied with himself as a star. I liked his smile and his enthusiasm. He very much reminded me of the humble na-ture of Jimi Hendrix. No, I never met Jimi, but I recall his quote saying that he never thought he was that good on guitar, and that he had so much more work to do. The true and deep artists are often that way, deep into the art, always looking for ways to improve and conquer the next challenge. So Eddie was like that – much more than an entertainer. He was the consummate artist.

I met Eddie, David, and the band in 1971 or '72, during the time that they were evolving from "Mammoth" to "Van Halen." We could not miss Eddie's excellence. Of course, the fans focused on David too – he was the lead singer. In our little social group of friends and schoolmates, I don't recall that anyone ever believed the group would hit the big time. Still, when we sat around talking about the things that high school people talked about, the talk would get around to Van Halen, and to Eddie.

I recall once when a friend was describing how Eddie was so good on guitar that he could exactly replicate Jimmy Page's Led Zepplin songs, Jimi Hendrix, Eric Clapton of Cream, and others. Eddie could replicate these masters so well that you could close your eyes and be-lieve you were listening to them. Eddie was good, and everyone knew it.

I often felt a kinship with Eddie because our birthdays were so close. We were born in the same year, 1955, and he was born on January 26, about 2 weeks after my birth in Pasadena. Eddie was born in Amsterdam, and in 1967, his family settled into Pasade-na. Born of musically talented parents, both Eddie and Alex were playing music from their early years. Eddie once shared that he'd never learned to read music, and that he just practiced all the time and learned to improvise.

My personal interactions with Eddie – mostly during the pre-fame days -- were brief and spotty, though he left a special mark on me.

I was their periodic photographer. When Van Halen was getting started, I was getting started with journalism at John Muir High School, and David always saw me with a cam-era – either super 8 video or 35 mm. He invited me to take their pictures, so I would drive with the band in their packed van to take photos at their gigs at the Cucamonga Connection. I also went to the Pasadena Civic, and various Pasadena backyards. One such back-yard was within walking distance of my parents' home on Los Robles Avenue.

David Roth always seemed to take the center stage and was the idol of all the teenage girls, which continued to bring in the crowds at their rented halls or backyards. Still, there would have been no Van Halen band without Eddie. And certainly, Alex the drummer kept the musical composition tightly woven with his technical mastery.

Though David seemed to do most of the talking and singing, Eddie did most of the smiling. Gregarious, positive, always friendly. I know that lots happened once they signed record deals and began touring, and I rarely saw any of them anymore. I would read about Eddie in the newspaper, or hear something on the radio, and always wondered how much was truth, and how much just part of the developing myth. I prefer to remember Eddie as the young and innocent teen who was my friend, and who never seemed puffed up with pride, and could genuinely smile at anyone in his circle, including me. I feel that Eddie played for the pure love of it, for the manifest expression of excellence, with no rival in recent memory except possibly Jimi Hendrix.

After we finished talking with the young fans at the street memorial, we went to the old Van Halen family home where a similar shrine had been set up. However, this felt differ-ent. It was quiet and dark. A couple quietly moved along as we walked up to the house. A few candles were lit on the sidewalk, barely making the shrine visible. There was a spir-itual quality here, a solemn silence, and it felt as if Eddie was back at his old home, looking at friends and fans who came, pondering now whatever is next. I was there as a friend, not a "fan," and I quietly let thoughts of Eddie fill my mind, in this place where the spirit of Eddie would be if it was anywhere.

After some moments of quiet reflection, we drove home.

Eddie, we'll miss your smile and your musical genius. May your journey be filled with peace.




#### HOW TO RECOGNIZE AND STOP ELDER ABUSE IN THE COVID ERA

Dear Savvy Senior:

Can you write a column on how to recognize elder abuse and what to do if you suspect it? Concerned

#### Dear Concerned:

Elder abuse is a big problem in the United States that



The term "elder abuse" is defined as intentional or negligent acts by a caregiver or trusted individual that causes or can cause harm to a vulnerable senior. Elder abuse also comes in many different forms: emotional, psychological, physical or sexual abuse, abandonment, neglect and self-neglect, and finan-

Those most vulnerable are seniors that are ill, frail, disabled, socially isolated or mentally impaired due to dementia or Alzheimer's disease.

It's also important to know that while elder abuse does happen in nursing homes and other long-term care facilities, the vast majority of incidents take place at home where the senior lives. And tragically, the abusers are most often their own family members (usually the victim's adult child or spouse) or

#### How to Recognize Abuse

So, how can you tell if an elderly relative or friend is being abused, and what can you do to help?

A change in general behavior is a universal warning sign that a problem exists. If you notice that your relative or friend has become very depressed, withdrawn or gets upset or agitated easily, you need to start asking questions. Here are some additional warning signs on the different types of elder abuse that can help you spot a possible problem.

Physical or sexual abuse: Suspicious bruises or other injuries that can't be explained. Sudden changes in behavior (upset, withdrawn, fearful). Broken eyeglasses. Caregiver's refusal to allow visitors to see

Neglect or self-neglect: Weight loss, poor hygiene, unattended medical needs, and unsanitary, unsafe

Emotional or psychological abuse: The senior is extremely upset, agitated, withdrawn, unresponsive, fearful or depressed, or demonstrates some other unusual behavior.

Financial exploitation: Missing money or valuables. Unexplained withdrawals from bank accounts, or transfers between accounts. Unauthorized use of credit, debit or ATM card. Unpaid bills despite available funds. Checks written as a loan or gift. Abrupt changes in a will or other documents.

For more tips on how to recognize the warning signs of abuse during the pandemic, see the National Center on Elder Abuse website at NCEA.acl.gov/Resources/COVID-19.aspx.

The best ways to help stop elder abuse is to be in touch and keep the lines of communication open. If you suspect any type of abuse or neglect in your relative's or friend's home, report it to your local protective services agency.

Adult Protective Services is the government agency responsible for investigating elder abuse cases and providing help and guidance. Call the Eldercare Locator at 800-677-1116 to get the agency contact number in your area or visit NCEA.acl.gov/Resources/State.aspx.

The agency will ask what you observed, who was involved, and who they can contact to learn more. You don't need to prove that abuse is occurring; it is up to the professional.

Or, to report suspected abuse in a nursing home or assisted living facility, call the local Long-Term Care Ombudsman – see LTCombudsman.org for contact information.

If, however, you feel the person is in immediate danger, call 911 or the local police for immediate help.

# ALL IN DUE TIME, SO SHE SAYS

For several weeks, or has it been years, I've been waiting for an important package to come through the mail. I don't know why they call it snail mail because I have seen snails crawl faster.

With all our technology today, you would think that mail could come in on a particular schedule, and I'm thinking of a fast-paced schedule.

I've been going to the mailbox every day for several weeks, and I find a lot of junk mail, but I don't find the mail that I'm looking for. They promised it would arrive between seven and ten days. Of course, they didn't mention what days they would come, nor did they say those days would be consecutive. Each day that mail hasn't come has made me more jittery.

The Gracious Mistress of the Parsonage is always encouraging me to be patient. I once re-sponded to her, "I'm not a doctor, and I don't have any patients." There are times when I should not verbalize what I'm thinking. It would keep me out of trouble. When I



reliance, difficult as it is at times for us, is an authentic, sincere illustration of human beings doing what is necessary to survive. It is real.



# WHENEVER TRUMP FLAPS HIS YAP, HE MAKES THE BEST CASE



If Donald Trump was a movie scene, he'd be the fiery train wreck in "The Fugitive," and U.S. Marshal Tommy Lee Jones would be cruising through the carnage saying, "My my my. What. A. Mess."

The dueling "town halls" Thursday night were enough to make one's head spin. On ABC, where Joe Biden resided, you had decency and sanity. On NBC, had demagoguery and sociopathology. Choose the America you want, folks, because the contrast could not be starker. For instance, here's how Biden talked about how masks curb the

spread of the deadly virus: "When a president doesn't wear a mask, or makes fun of folks, like me, when I was wearing a mask for a long time, then people say, 'well, it mustn't be that important.... It is estimated by the University of Washington that if, in fact, we wore masks, we could save, between now and the end of the year, 100,000 lives."

But here's what Trump said: "I'm OK with masks...But just the other day, they came out with a statement that 85 percent of the people that wear masks catch [coronavirus]. That's what I heard, that's what I saw."

There's less than zero evidence that 85 percent of mask-wearer get COVID-19. Anyone who spends five seconds parsing that fake statistic knows it's laughable. What Trump shared with viewers – and shared with his rally saps earlier yesterday – was a blatant lie popularized by Tucker Carlson on Fox News.

What a shame that NBC, the network that saved Trump from financial ruin by airing his celebrity game show, decided this week to indulge him again, giving him free air time to dump his stinking rhetorical detritus on America's lawn. Hold your nose, because here we go:

- He again refused to say whether he had tested positive for Covid prior to sharing a debate stage with Biden and delusionally lauded his greatness on handling the pandemic.
- He refused to condemn the QAnon conspiracy freaks (who believe there's an international cult of celebrities and Democrats who engage in child sex-trafficking). Even though federal law enforcement authorities are closely watching them, Trump claimed he knew nothing about them. Then he changed his mind and said they're "very strongly against pedophilia, and I agree with that."
- He didn't think it was wrong to falsely tell his Twitter followers that Biden had conspired with Navy SEALS to cover up the fake death of Bin Laden. "That was a retweet. I'll put it out there. People can decide for themselves. I don't take a position," Trump said.
- He confirmed he's personally \$400 million in debt, but said it was a small amount of money ("a peanut"), and he refused to name is creditors because he claims not to know who they are. When he was asked whether his creditors are foreign sources or foreign entities, he said: "Not that I know of, but I will probably, because it's so easy to solve, and if you'd like to do, I will let you know." Whatever that means.
- He recycled one of his pet lies about purported mail ballot fraud: "When I see thousands of ballots dumped in a garbage can, and they happen to have my name on it? I'm not happy about that." Thanks to Trump's non-stop blather, NBC's viewers never heard the truth. The episode Trump was referring to involved nine trashed ballots not "thousands" in one Pennsylvania county, where a temporary seasonal worker screwed up and was fired after three days on the job.
- He recycled the lie that he and his servile Republicans "are always protecting people with preexisting conditions, and I can't say that more strongly. In reality, he's working to kill Obamacare in the U.S. Supreme Court, thereby removing all statutory protections for people with preexisting conditions, and he still has no plan to replace the 10-year-old law that's now widely popular.

And so on. Shame on NBC for indulging a guy who fled like a coward when offered a second opportunity to debate Biden. If he wants to lie with impunity, let him buy ads. But the good news is with less than 2 weeks on the clock, he said virtually nothing that's likely to bedazzle the independents, seniors, and college-educated suburbanites he so desperately needs.

# THE FATE OF GIG WORKERS COULD TURN ON BALLOT QUESTION

Become an employee with full paid benefits, or remain a mostly independent gig worker? That debate's raging in California as November's general election approaches, and its outcome is likely to affect the entire country.

According to The Washington Post, "Uber, DoorDash and other gig economy companies are bombarding TV airwaves, social media and even their own apps with ads and marketing materials promoting a ballot initiative [Proposition 22] that they say would improve drivers' financial situation and working con-

ditions but that would also deny them the right to be classified as employees in California."

tections, but establish them as an independent class of workers – and undo a 2019 California law, Assembly Bill 5 (AB5), that "would guarantee drivers access to the minimum wage, employer-provided health care and bargaining rights."

Proposition 22 would give gig workers limited benefits and wage and worker pro-

I've long been self-employed, with the exception of some recent cybersecurity consulting contracts in which I was paid as a full-time employee with benefits, but that's been my choice.

Being fully self-employed is not for the faint of heart. Besides cybersecurity consulting and writing a newspaper column, I have an apartment-rental business. I recently earned a real estate license and am selling properties, too.

I manage my own invoicing and taxes. I know to the penny – once my CPA explains it to me and I drop whatever mug of coffee I'm holding – how high my income taxes are. Few employees are aware of how much they pay in taxes or what their benefits cost their employers – which would be helpful to know before voting for new government policies that will increase both.

I manage my own health-care insurance, which has gotten plenty expensive in recent years for individuals who don't qualify for subsidies, in part because of government attempts to expand health insurance to everyone.

But, again, I choose to be self-employed. I like the freedom it provides. But it also makes me keenly aware of the unintended consequences of government regulations and policies.

California's 2019 AB5 law would require Uber, for instance, to hire drivers as full-time employees with health insurance, paid sick leave and other benefits. Benefits are wonderful, but come at a price.

Uber claims that "if the company were forced to make all drivers across the country employees, for example, it could only support 260,000 full-time roles," reports The Post. "That compares to 1.2 million active drivers the company was hosting on its app before the coronavirus pandemic."

Uber also says fares would increase and drivers would be less available and timely – which means you might have to wait a while for your ride home to arrive after a night of enjoying the pub.

What it comes down to is that some politicians believe individuals shouldn't have the freedom to exchange their skills and services for money from organizations, because organizations take advantage of those individuals. Joe Biden and Kamala Harris support AB5, not the watered-down Proposition 22.

Others think that in a free society, individuals should be able to offer their professional talents to anyone willing to pay for them, and government shouldn't restrict the terms they negotiate. President Trump's campaign supports that approach and is critical of AB5 (but has not, to my knowledge, supported Proposition 22).

That's something else to think about when you vote in November's election.

The amendments replace the list of specific uses and corresponding parking requirements with requirements for residential and non-residential uses; reduces the total number of required parking spaces for non-residential uses; allows for shared parking arrangements involving separate properties in the commercial zone; updates standards for development of parking facilities, provides relief from required parking in connection with the reuse of existing structures and residential additions; introduces in the Commercial and Manufacturing zones, up to 50% of the required parking spaces for non-residential uses may be satisfied by paying a one-time fee; Satisfaction of greater than 50% of the required parking spaces by payment of such in lieu fee may be approved subject to a minor conditional use permit upon the additional finding by the reviewing authority that doing so will not unreasonably overload street parking or public parking facilities nor create a nuisance.

California Proposition 14, the Stem Cell Research Institute **Bond Initiative** 

A "yes" vote supports issuing \$5.5 billion general obligation bonds for the state's stem cell research institute and making changes to the institute's governance structure and programs.

California Proposition 15, the Tax on Commercial and Industrial Properties for Education and Local Government Funding Initiative

A "yes" vote supports this constitutional amendment to require commercial and industrial properties, except those zoned as commercial agriculture, to be taxed based on their market value, rather than their purchase price.

#### California Proposition 19, the Property Tax Transfers, Exemptions, and Revenue for Wildfire Agencies and Counties Amendment

A "yes" vote supports this constitutional amendment to:

- \* allow eligible homeowners to transfer their tax assessments anywhere within the state and allow tax assessments to be transferred to a more expensive home with an upward adjustment;
- \* increase the number of times that persons over 55 years old or with severe disabilities can transfer their tax assessments from one to three:
- require that inherited homes that are not used as principal residences, such as second homes or rentals, be reassessed at market value when transferred; and

single-family homes.

A "yes" vote supports this ballot initiative to define app-based transportation (rideshare) and delivery drivers as independent contractors and adopt labor and wage policies specific to appbased drivers and companies.

#### California Proposition 23, the Dialysis Clinic Requirements

A "yes" vote supports this ballot initiative to require chronic dialysis clinics to: have an on-site physician while patients are being treated; report data on dialysis-related infections; obtain consent from the state health department before closing a clinic; and not discriminate against patients based on the source of payment for care.

#### California Proposition 24, the Consumer Personal Information Law and Agency Initiative

A "yes" vote supports this ballot initiative to expand the state's consumer data privacy laws, including provisions to allow consumers to direct businesses to not share their personal information; remove the time period in which businesses can fix violations before being penalized; and create the Privacy Protection Agency to enforce the state's consumer data privacy laws.

I believe there is a true HERO living just a few doors away from me in the lower canyon of Sierra Madre. He looks like everyone else except that he is a very tall person, perhaps a representative of the Norse Gods to whom he may bear some relation. This is Robert Gjerde. Surprisingly people like you and me often do extraordinary things although that is not obvious from our appearance or from casual small talk.

During these horribly disputative political times there is much talk of the God Narcissus, someone hopelessly absorbed with himself. The complete opposite of narcissists, according to philosophers may be described as heroes. Heroes are people who, for whatever reason, view the world as "a theatre for heroism" a place to do good.

Before I attempt to describe Robert in detail I want you to know that he is by no means a perfect person. His home and his yard are an accumulation of bewildering objects whose purposes are known only to him. He has explained to me that he has a great zest for beginning projects but that frequently this zest and its accompanying energy dissipates before the project is completed resulting in a kind of semi-permanent chaos of ongoing projects. Living in these times is not easy for anyone nevertheless, Robert and his two teenage children manage to live mostly harmoniously amongst the various projects as they cope with the responsibilities of virtual education.

On days when our neighborhood bears have overturned trash cans I have observed Robert cleaning up the mess in front of homes in the canyon. Additionally, Robert still manages to continue doing incredible things that

benefit the community. He is the administrator of the Sierra Madre CA Facebook group, is involved with the Sierra Madre Rose Float Association, he creates websites for other people and organizations, is actively involved with Sierra Madre CERT (Community Emergency Response Team) and has pursued multiple grants to benefit this organization. He will spend weeks mastering skills such as welding which he will then use to repair equipment which can be of service to others. He has created a wireless emergency communications system that should stay operational during a disaster when nothing else works. He kept Sierra Madre residents realistically informed about the dangers and nearness associated with the Bobcat Fire. There's really a

Enough of what he does—the question for me is WHY DOES HE DO IT? I did my best to question Robert about his motivation. He explained that he is somewhat introverted and loves digging into detailed projects and researching them to death. As a child he loved taking apart watches and almost never put them back together. He really likes finding problems and then figuring out solutions. No challenge seems too big for him. While he wants to be a perfectionist, he usually falls short. This often leads to a sort of crisis-management which might explain his involvement in disaster preparedness. He seems to thrive on the idea of disasters. He went out into the business world and for a time was extraordinarily successful. Changes in the economy have made it harder but he still survives and provides for his children. Still his greatest joy comes from being of help to others and he is continually involved in being of assistance. (If you saw the huge electric Menorah in the center of town last year, that was his creation and he is not even Jewish.)

He is an incredible inspiration to many of us in Sierra Madre. I wish my parents had given me a watch to take apart instead of telling me not to touch anything and not to rip my pants. I wish it was that easy!

# Returning Your VBM Ballot

Voters are advised that they are responsible for how their Vote by Mail (VBM) ballots are returned and with whom they entrust their ballots. The Los Angeles County Registrar-Recorder/County Clerk recommends returning a ballot to either a mailbox, official drop box, or ballot box.

Voters who cannot return their VBM ballot can designate any person to return their ballot as long as there is no compensation involved for that individual, group or organization returning the ballot.

There are several recommended options for returning a Vote by Mail ballot during any election:



Return by mail.

Must be postmarked by Election Day. No postage required.



Drop-off at a Vote by Mail Ballot Drop-Off Location.

List of drop-off locations available at LAvote.net prior to each election.



Drop-off at any Vote Center leading up to and on Election Day. List of Vote Centers available at LAvote.net prior to each election.




Signature Verification

Voters must sign the eligibility oath and date the VBM return envelope before submitting their ballot. Every signature is verified before the ballot is cleared for counting. If a signature is missing or if the signature does not match the one on file, the County will notify the impacted voter to allow the voter an opportunity to provide a valid signature


