#### COUNCIL TO HOLD HEARING ON **DESIGN REVIEW STANDARDS**

The Sierra Madre City Council meeting scheduled for Tuesday, October 27, 2020 at 6:30 pm has agendized a public hearing on the revision of the city's Design Review Standards for use by the Planning Commission and the Planning Department. The guidelines define the process for the issuance of development permits in the city.

Recommended changes were submitted to the Planning Commission for review more than a year ago, however, the commission's revisions were not adopted by the council.

The changes submitted by the city were developed out of necessity because of recent changes in state law, SB330 - The Housing Crisis Act of 2019. The bill removes a significant amount of power from cities in determining what kind of housing is permitted.

For many Sierra Madre residents, any action, whether by the council or State government which appears to put the city at risk of losing its' village character, is a problem. The state has removed local jurisdiction over 'new mixed-use development projects, multi-family developments, low-income housing, and single family housing with an ADU's. The local planning commission may still determine the fate of proposed new large single family housing.

Mayor John Capoccia is keenly aware of the challenges that not only SB330 bring to the city, but also the looming mandate for 204 additional housing units under the RHNA requirements. (http://mtnviewsnews.com/v14/htm/n41/ index.htm ). Failure to comply with either the new state law or the RHNA requirements would have a negative impact on Sierra Madre. Capoccia is hoping that the council and planning commission can agree on acceptable revised Design Review Standards that will not only satisfy the state requirements but also preserve the character of Sierra Madre. His target for getting this ac-





#### **Pasadena Shooting** Leaves Two Injured

Pasadena police are still investigating a shooting Monday night in East Pasadena that left a man and woman injured near the site of a now controversial memorial for Anthony McLain (see story right).

According to police, they responded around 8 p.m. to calls of gunfire near La Pintoresca Park. Pasadena Police Lt. Pete Hettema said there were two police responses, one to nearby Pasadena Fire Station 36, where the female gunshot victim had been dropped off and to the park where officers found a car leaving at a high rate of speed. When they stopped the car the male driver had been shot in the neck.

Both victims were expected to survive, with serious although not life threatening injuries.

Witnesses said they heard 25 to 30 shots fired.

No description of the suspect or suspects were



According to a written police statement, two officers stopped the car for a vehicle code violation, not having a front license plate. During the stop, "the passenger in the vehicle [McClain] elected to run away. While running, the passenger removed a handgun from his





#### Pasadena Guidance for **Small Private Gatherings**

This week, the state updated its guidance to allow private gatherings of three or fewer households, as long as the private gathering is outdoors, everyone wears a cloth face covering and keeps at least six feet of physical distance, food is in single-serve disposable containers, and the duration of the gathering is short (two hours

City of Pasadena officials, Friday, updated its Health officer Order to align with the change in the state guidance.

Private gatherings with people from different households increases the risk of COVID-19 transmission, with the risk increasing the longer the gathering. If you do gather, do so with no more than two other households and the same households each time, creating a stable cohort.

A single household or living unit does not include institutional group living situations, such as dormitories, fraternities, sororities or residential care facilities. Nor does it include commercial group living arrangements, such as boarding houses, hotels or motels.

"You should avoid gatherings of any kind if you are experiencing symptoms of illness, have tested positive for COVID-19 or if you have been exposed or likely have been exposed to someone who tested positive," says Pasadena Public Health Officer Dr. Ying-Ying Goh. "People who are 65 or older or who have underlying medical conditions are strongly discouraged to gather with anyone they do

As a reminder, large public events and gatherings in general remain prohibited by the Health Officer Order, even when held outdoors, and all industry sector guidance still applies to those sectors.

#### COUNTY OFFICIALS WARN AGAINST PROPERTY TAX SCAM

Scammers Going to Taxpayer Homes to Collect Property Tax Payments

LOS ANGELES, CA - Los Angeles County Treasurer and Tax Collector Keith Knox and County Assessor Jeffrey Prang are alerting the public to an alleged property tax scam perpetrated under the guise of COVID-19 building closures.

It's being reported that unknown people are attempting to fraudulently collect in-person property tax payments at taxpayers' homes because of COVID-19. The individuals may even have fake identification as well as the tax bill for the specific homeowner in question. These individuals allegedly are claiming that the homeowner must pay their property taxes in-person because the COVID-19 pandemic has closed County offices to the public.

"The County of Los Angeles Treasurer and Tax Collector (TTC) does not conduct in-person visits to collect property tax payments and that any attempts to collect in-person payments are fraudulent," said Keith Knox, Los Angeles County Treasurer and Tax Collector. "Should you be contacted at your home or hear about this in your neighborhood, do not make payment to the person requesting it and notify local law enforcement immediately. Be sure to provide a detailed description of the individual."

Assessor Prang agreed, saying that residents need to be aware of this scam and not to engage with anybody seeking an in-person property tax payment.

"It's important to be cautious with anybody making unsolicited offers," Assessor Prang said. "Appraisers sometimes will visit homes to appraise the property, but our appraisers will never ask for tax payments. This current activity is a scam and it's important to report it to the authorities immediately."

Two New MIS-C Cases in Children Confirmed; Public Health Reports 23 New Deaths and 2,773 New Positive Cases of COVID-19 in Los Angeles County High COVID-19 Case Numbers Reflect Backlog Test Results

Public Health is reporting two additional cases of multisystem inflam*matory syndrome in children (MIS-C).* This brings the total cases of MIS-C in L.A. County to 43 children. All 43 children with MIS-C in L.A. County were hospitalized and nearly 50% of the children were treated in the ICU. Of the children with MIS-C, 26% were under the age of 5 years old, 37% were between the ages of 5 and 11 years old, and 37% were between the ages of 12 and 20 years old. Latino/Latinx children account for 72% of the reported cases. No children have died from MIS-C in L.A. County.

Public Health in consultation with the Board of Supervisors, is revising the Health Officer Order to allow for the re-openings of additional personal care services indoors with modifications (in addition to hair salons and nail salons), as well as outdoor operations at go-carts, mini-golf and batting cages. In addition, the percentage of high-needs students permitted at a school campus for on-site learning has been increased from 10% to 25%, allowing more students to return for in-person instruction and services. Public Health will also modify the Health Officer Order for breweries and wineries; reservations will no longer be required at these establishments, though they are strongly recommended. In addition, wine tastings for retail sales will no longer require a meal to be served. Comprehensive protocols for all sectors that reopen will be posted online to ensure infection control and distancing and the continued health and safety of workers and the community. Businesses are required to implement the protocols prior to reopening to ensure they are in compliance with the Health Officer Order, and to avoid citations, fines, and possible closure.

#### **HEALTH OFFICER ORDER UPDATE**

- ✓ Private gatherings cannot exceed more than 3 households.
- Private gatherings must be held outdoors.
- ✓ Attendees must wear face coverings when not eating or drinking, and seating allows for physical distancing between households.
- ✓ Keep it short private gatherings should be two hours or less.
- ✓ People in high-risk groups are strongly urged to not attend any private gatherings.



#### DANGERS OF SECONDHAND SMOKE FROM MARIJUANA

I'm allergic to marijuana smoke. When I first smell it nearby, I think it's the smell of a skunk that got hit by a car. Then, I quickly realize, no, not a skunk, just someone getting high. If I see them, I walk over, and ask, politely, "Can you please go somewhere else? I'm allergic to your smoke." The first kneejerk reaction is nearly always, "Hey, it's legal." And my response, "I wasn't talking legal. I said your smoke is bothering me." And then, I often am able to add, "And how old are you? 16? I don't think it's legal for you, and I don't think it's legal to smoke in

this public place," whereupon the person usually disappears in a huff.

I'm not a fan of getting high, or doing anything that impairs my ability to function and to think as clearly as possible. But that's a subject for another day.

If you wish to smoke marijuana, that's your business. However, just like non-tobacco smokers don't wish to have tobacco smoke in their breathing-air, non-marijuana smokers don't care for marijuana smoke either. Did you know that marijuana second-hand smoke has many risk factors, just like tobacco?

For example, secondhand marijuana smoke contains many of the same cancer-causing substances and toxic chemicals as secondhand tobacco smoke. Some of the known carcinogens or toxins present in marijuana smoke include: acetaldehyde, ammonia arsenic, benzene, cadmium, chromium, formaldehyde, hydrogen cyanide, isoprene, lead, mercury, nickel, and quinoline. Marijuana smoke contains tetrahydrocannabinol (THC), the active chemical in cannabis, so, yes, "contact high" is a very real thing.

And there are specific health risks of exposure to secondhand marijuana smoke. Secondhand smoke from combusted marijuana contains fine particulate matter that can be breathed deeply into the lungs, which can cause lung irritation, asthma attacks, and makes respiratory infections more likely. Exposure to fine particulate matter can exacerbate health problems especially for people with respiratory conditions like asthma, bronchitis, or COPD.

Significant amounts of mercury, cadmium, nickel, lead, hydrogen cyanide, and chromium are in marijuana smoke. Three times the amount of ammonia is found in marijuana smoke compared to tobacco smoke.

In general, secondhand smoke from marijuana has many of the same chemicals as smoke from tobacco, including those linked to lung cancer, harmful cardiovascular health effects, such as atherosclerosis (partially blocked arteries), heart attack, and stroke. Tobacco is a legal drug, and no one has ever claimed that there are no detrimental health effects from smoking it. Now, it's the same with marijuana. Don't fool yourself and believe that there are no health effects from marijuana merely because the laws have been relaxed.

Just like non-tobacco smokers have a right to be free of smoke in public and work places, we should also insist upon that same condition with marijuana, legal or not. If you don't like marijuana smoke in your public atmosphere, just speak up. Ask the person to smoke elsewhere.

For the record, I am of the opinion that the excessive use of alcohol is far worse for the body and mind than marijuana, simply based on the totality of available evidence. The fact that alcohol is legal and will probably always be legal means that for you to suffer no harm, you have to take great personal responsibility for your own health -- the health of your mind and your body.







#### HOW SENIORS CAN SAVE MONEY ON PRESCRIPTION EYEGLASSES

Dear Savvy Senior:

What tips can you recommend for finding affordable prescription eyeglasses? I used to have vision insurance through my work but lost it when I turned 65 and signed up for Medicare. Need Spectacles.



Dear Need:

Unfortunately, in 2020 it's still true that original

Medicare does not cover vision services, which includes routine eye exams and prescription eyeglasses – unless you've just had cataract surgery. While there's no one solution to this common need, here are a few tips that can help you save.

Medicare Advantage

While original Medicare doesn't cover vision services, there are Medicare Advantage plans that do. Medicare Advantage plans, which are sold through private insurance companies, cover all the same medical and hospital services that original Medicare does, but many of them also provide vision as well as dental, hearing and prescription drugs too.

To locate Advantage plans in your area that provide vision coverage, go to Medicare.gov/plan-compare or call 800-633-4227. But before enrolling in a plan, check the benefit details to ensure the plan's vision coverage includes routine eye exams, eyeglass frames and lenses.

If you are currently enrolled in original Medicare you can switch to a Medicare Advantage plan each year during the open enrollment period, which is between Oct. 15 and Dec. 7. Or, if you already have an Advantage plan that doesn't provide adequate vision coverage, you can swap to another plan between Jan. 1 and March 31.

If, however, you don't want to change your Medicare plan, you can still get coverage by purchasing a vision insurance policy – see eHealthInsurance.com. Vision policies typically start at around \$11 to \$13 per month for an individual, but before signing up make sure your savings potential is worth the cost of the monthly premiums and required copays.

Purchasing eyeglasses from discount retailers is another way to save. Costco Optical is one of the best discount stores for good eyewear and low prices. Eyeglasses cost an average of around \$184, but to shop there you have to pay a \$60 annual membership fee. Some other good retail options for low prices include Sam's Club Optical and Walmart Vision Centers.

You also need to find out if you are eligible for any discounts. Some retailers provide discounts to membership groups like AARP and AAA. AARP members, for example, can get 30 percent off a pair of glasses (frames and lenses) at LensCrafters and Glasses.com, and you save an additional \$10 on a complete pair at Target Optical. AARP also offers \$55 comprehensive eye exams (dilation included) at participating eye doctors. See AARPVisionDiscounts.com for more information.

Buying eyeglasses online can also offer huge savings. Stores like ZenniOptical.com, and EyeBuy-Direct.com sell prescription eyeglasses for as little as \$6 and \$7. These sites let you upload a photo of your face, so you can see what you'd look like in different frames.

Or, for a snappier choice of frames see WarbyParker.com, which offers single-vision glasses starting at \$95. They even offer a free program where you can request up to five pairs to try on at home for five days.

To purchase glasses online, you'll need a valid prescription from an eye doctor (typically no more than a year old), plus your pupillary distance number, which is the distance, measured in millimeters, between the centers of your pupils in each eye.

Low-Income Assistance

If your income is low, depending on where you live, there may be some local clinics that provide free or discounted eye exams and eyeglasses. Put in a call to your local Lions Club to see what's available in your area. See Directory.LionsClubs.org for contact information.

You may also be able to get free eyeglasses through New Eyes (New-Eyes.org, 973-376-4903), a nonprofit organization that provides free eyeglasses through a voucher program to people in financial need.

This endless feedback cycle, designed to exploit you for profit, contributes to our increasing polarization, poisoning our political process and resulting in violence in our streets.



#### Returning Your VBM Ballot

Voters are advised that they are responsible for how their Vote by Mail (VBM) ballots are returned and with whom they entrust their ballots. The Los Angeles County Registrar-Recorder/County Clerk recommends returning a ballot to either a mailbox, official drop box, or ballot box.

Voters who cannot return their VBM ballot can designate any person to return their ballot as long as there is no compensation involved for that individual, group or organization returning the ballot.

There are several recommended options for returning a Vote by Mail ballot during any election:



Return by mail.

Must be postmarked by Election Day. No postage required.



Drop-off at a Vote by Mail Ballot Drop-Off Location. List of drop-off locations available at LAvote.net prior to each election.



Drop-off at any Vote Center leading up to and on Election Day. List of Vote Centers available at LAvote.net prior to each election.



Signature Verification

Voters must sign the eligibility oath and date the VBM return envelope before submitting their ballot. Every signature is verified before the ballot is cleared for counting. If a signature is missing or if the signature does not match the one on file, the County will notify the impacted voter to allow the voter an opportunity to provide a valid signature

#### California Proposition 14, the Stem Cell Research Institute **Bond Initiative**

A "yes" vote supports issuing \$5.5 billion general obligation bonds for the state's stem cell research institute and making changes to the institute's governance structure and programs.

#### California Proposition 15, the Tax on Commercial and Industrial Properties for Education and Local Government Funding Initiative

A  $\ensuremath{^{^{''}}\!yes''}$  vote supports this constitutional amendment to require commercial and industrial properties, except those zoned as commercial agriculture, to be taxed based on their market value, rather than their purchase price.

#### California Proposition 16, the Repeal Proposition 209 **Affirmative Action Amendment**

A "no" vote opposes this constitutional amendment, thereby keeping Proposition 209 (1996), which stated that the government and public institutions cannot discriminate against or grant preferential treatment to persons on the basis of race, sex, color, ethnicity, or national origin in public employment, public education, and public contracting.

A "no" vote opposes this constitutional amendment, thereby continuing to prohibit people who are on parole for felony convictions from voting.

#### California Proposition 18, the Primary Voting for 17-Year-Olds Amendment



#### PORTRAIT OF OUR NEIGHBORS by Stuart Tolchin

#### MEA CULPA (Conversation with myself)



I am very sorry that there will be no portrait of a neighbor presented to ou this week. I did prepare an article and emailed it to the intended subject. have been informed not to submit the article for publication. She described my attempt as a random collection of facts that were mostly inaccurate which in no way presented a picture of who she was. In reflecting upon her response I have come to understand the true intention of my articles.

During this period of forced isolation connected to the Pandemic I, like most everyone else felt extremely isolated. I sought to relieve this condition by conducting interviews with neighbors in the canyon. This seemed like a wonderful idea. My house is perfectly set up to conduct interviews while still complying with the Covid restrictions. My plan was to invite an individual neighbor over to the house and just sort of talk to them for an hour or an hour and a half. After the conversation, during which time I would carefully take notes I would attempt to cobble together an article staying within the 650 word .limit allocated to me by the editor. So far so good! I loved doing the interviews and the whole process gave my life a kind of meaning. It allowed me to feel a kind of significance during my retirement.

It was my hope that by presenting information about local people, our neighbors who are not generally interviewed, we would all learn something more about ourselves and come to understand that we are all pretty interesting and worth knowing. Additionally the permission I received to include a picture of the subjects would provide people some satisfaction. It is not everyone who gets to see their picture in the newspaper. Altogether, I thought this was a wonderful idea and speculated that perhaps the whole series of articles could be compiled into a book which would illustrate how one particular locality dealt with the Covid crisis.

I imagined I would interview parents of schoolchildren and teachers who were prevented from going to school. I would talk to small business owners whose businesses were now threatened by the enforcement of sheltering in

place rules. I would talk to artists living in the community who would now have the opportunity to speak to the world, or at least the neighborhood, about the motivations behind their art. I imagined talking to doctors and scientists living within the neighborhood who would describe their individual methods of coping with the crisis. I would interview people of different political and religious beliefs and, while remaining as non-judgmental as possible, allow readers to realize that there is much to learn from one another and, importantly, that differences could be resolved through by civil conversation. This would be my contribution to the world.

After the interview, I would then do my best to go through this information and prepare an article of 650 words or less and present that to the subject for their approval. This time my subject did not approve and from this rejection I have realized much. I enjoy the conversations and the opportunity to get to know people a little much more than I enjoy the editorial process of carving out well written articles from the material. I realize that there are many important areas that I have been hesitant to delve into such as how does the person actually feel about the people they deal with or the effectiveness of the service they are providing? Do people long for retirement or are they happy in what they are doing and not thinking about the future? This is an area which I have avoided probably because it frightens me to talk about it. In conclusion, I once more apologize that there is no portrait of another neighbor this week, but, hopefully, you got to know this neighbor a little better.


