Sierra Madre without question is an 'All American City'. In the backdrop of the chaos which continues in Washington, this quiet village is a shining example of how a democracy works. As Councilman and Former Mayor Gene Goss said, Sierra Madre is "a model for other cities".

Councilmembers Capoccia and John Harabedian, who served on the council since 2012 and who both have served as Mayor, decided not to run for re-election in 2020. Tuesday's meeting was their last official act as part of Sierra Madre's elected leaders.



They received Proclamations from Assemblyman Chris Holden and Congresswoman Judy Chu as well as a video message from State Senator Anthony Portantino. LA County Supervisor Kathryn Barger attended the Zoom meeting to not only thank them for their service but also to swear in the new Mayor and Mayor Pro Tem. Luther Tsinoglou, President of the Sierra Madre Chamber also made presentations to all, including outgoing City Clerk Sue Spears.

Prior to their departure, the entire council narrated a powerpoint presentation that was an overview of all the City Council's accomplishments since the last election. Elected by the citizens on November 3rd to fill the vacancies for the four year terms were Kelly Kriebs and Robert Parkhurst. Also elected was Edward Garcia to fill the unexpired term of former Mayor Denise Delmar and Michael Amerio who ran unopposed and was re-elected as City Treasurer.

The newly elected officials were sworn in by the outgoing City Clerk

During the election, residents also voted to change the office of the City Clerk to an appointed position. Until a new city clerk is appointed by the City Manager, Assistant City Clerk Laura Aguilar will serve as the Interim Clerk.

Mrs. Spears last official acts were to swear in the newly elected officials, and to preside over the election by the new council leadership. She was greatly praised for her professionalism in handing her

The new council elected Rachelle Arizmendi as Mayor and Gene Goss as Mayor Pro Tem who were sworn in by Los Angeles County Supervisor Kathryn Barger.

Voter apathy was definitely not an issue in Sierra Madre. According to Asst. City Clerk Laura Aguilar the LA County Registrar of voters reported 88.2% of registered Sierra Madre voters exercised their rights. LA County only had 75.98% registered voter participation.

On December 8, 2020, the City Council of the City of Sierra Madre introduced for second reading Ordinance 1432, recommend-

ing adoption of Municipal Code Text Amendment 20-04 (MCTA 20-04).

The purpose of MCTA 20-04 is to amend Chapter 17.08 (Definitions), Section 17.20.015 (Definitions), and Chapter 17.68 (Parking). The amendments replace the list of specific uses and corresponding parking requirements with requirements for residential and non-residential uses; reduces the total number of required parking spaces for non-residential uses; allows for shared parking arrangements involving separate properties in the commercial zone; updates standards for development of parking facilities. provides relief from required parking in connection with the reuse of existing structures and residential additions.

This summary is published pursuant to Government Code Section 36933(c)(1) and a full and complete certified copy of the text of Ordinance is available at the Sierra Madre City Manager's Office located at City of Sierra Madre City Hall, 232 W. Sierra Madre Blvd., Sierra Madre, CA. Ordinance 1432 becomes effective on January 8, 2020. ENVIRONMENTAL DETERMINATION: The subject ordinance is exempt from California Environmental Quality Act (CEQA) under Section 15301, of Title 14 of the California Code of Regulations and is also exempt from review because it does not meet the definition of a project under CEQA Guidelines sections 15061, subdivision (b)(3), and section 15378, subdivision (a) and subdivision (b)(5). The proposed changes to Chapter 17.68 have no potential for resulting in physical changes to the environment because the amendments are intended to establish standards to ensure the use, activity, and operations of residential and non-residential uses provide adequate parking facilities for the intended use. Any particular proposed project will be required to undergo the City's entitlement process and appropriate review under CEQA.

APPEAL: If in the future anyone wishes to challenge the decision of the City Council in court, one may be limited to raising the issues that were raised or presented in written correspondence delivered to the City Council at, or before, the scheduled public hearing. Pasadena Man Charged with CARES Fraud, Buys Maserati

A Pasadena man was scheduled to be arraigned Friday on federal charges alleging he used stolen identities to fraudulently unemployment obtain insurance benefits, which he later used to purchase a Maserati.

During a traffic stop October 1, Pasadena Police officers arrested Robert Sloan Mateer, 30 and found inside his Maserati, 17 unemployment benefits debit cards, several other credit and debit cards, approximately \$197,711 in cash, more than 85 grams of methamphetamine and a loaded firearm with no serial number.

Evidence gathered during the investigation determined that at least 14 of the 17 debit cards were loaded with at least \$133,000 in unemployment insurance benefits, later determined have to been issued under the Coronavirus Aid, Relief, and Economic Security (CARES) Act passed by Congress in March, and had been issued in the names of third-parties, including identity theft victims.

Mateer also admitted that he withdrew the approximately \$197,711 in cash found in his Maserati from ATMs across Los Angeles. Mateer taken into federal custody on October 21 and was ordered detained pending trial.

If convicted of all charges, Mateer would face a statutory mandatory minimum sentence of 17 years and a statutory maximum sentence of life

New South Pasadena Water and Sewer Rates For 2021

The South Pasadena City Council approved establishing new water rates with additional increase from the Metropolitan Water District (MWD) and new sewer rates. The new rates were approved on November 18. The MWD's change of the wholesale water rate for 2021 is considered as pass-through charge. Here are a few important key notes of the new rates:

New rates will be effective January 1, 2021.

Residents will see the new rates for January 2021 service on their bills around March or April 2021.

Water Rates for 2021 will increase by approximately 6.2 percent for the bi-monthly fixed charge and 8.8% for the

volume charge. Most single-family residences are served by a 3/4" meters, which are the least expensive

Sewer rates for 2021 will increase by approximately 4 percent from current sewer

sized meters available.

Emergency Rental Assistance Program

The application period for the Rental Assistance Emergency Program (ERAP) has been extended to February 1, 2021, to allow tenants additional time to apply for assistance after the holidays. The ERAP will provide rental assistance to qualified South Pasadena tenants affected by the COVID-19 pandemic and who meet federal low-income requirements with a one-time grant. The Emergency Rental Assistance Program (EARP) will provide residents who have lost income due to COVID-19 and meet federal



low-income requirements with a one-time grant of \$1,000. The monthly assistance payments will be provided directly to property owners or landlords on behalf of qualifying residents and will be applicable to rent due during the eligible period from March 19, 2020, until the end of the Los Angeles County Health Officer's Safer at Home Order.

To be considered for the grant, applicants must first submit the eligibility form included in the application packet before the application deadline. The City will review these forms to determine eligibility. A lottery drawing may be conducted to select qualified applications to move to the next phase.

These applicants will be required to submit additional documentation confirming substantive income losses caused by job layoffs, furloughs or reduction in hours or pay during the COVID-19 pandemic period beginning March 19. All documentation, including rental lease agreements, will be subject to

verification. Application packets are available on the City's website www.southpasadenaca.gov/ERAP. Eligibility requirements are outlined in the application packet, along with answers to frequently asked questions. Applicants may pick up application packets at the Senior Center (1102 Oxley St) by appointment. OFFICIALS WARN DEMONSTRATIONS HIGH RISK OF TRANSMITTING COVID

For residents that plan on attending peaceful demonstrations, be aware of the elevated risks that come when people of different households gather during this pandemic, even when they are outdoors. Demonstrations can inadvertently result in transmission of COVID-19, including from people who are asymptomatic and have no idea that they are positive for the virus. If you unknowingly become infected, you may infect other people in your life, including people who are older or who have underlying health conditions that put them at far greater risk of becoming seriously ill and dying from COVID-19.

If you plan to attend a demonstration, please follow these guidelines:

Stay home if you are feeling sick. Seek medical attention as needed if you have symptoms for COVID-19, and be tested for the virus – testing is widely available across LA County.

If you are not sick and plan to attend a peaceful demonstration, wear a face covering over both your nose and mouth at all times and keep your physical distance, staying more than 3 steps away from anyone who is not from your household. Consider wearing eye protection. Encourage other attendees to do the same.

Keep your hands clean before, during, and after the demonstrations. Bring hand sanitizer or frequently wash your hands.

If you think you have been exposed to COVID-19 during a demonstration, it is very important that you quarantine for 14 days and stay away from all other people, especially those at greater risk of becoming seriously ill from COVID-19.



L.A. COUNTY EXCEEDS 500,000 COVID-19 CASES AND CONTINUES TO BREAK ALL-TIME RECORDS

Please Stay Home and Follow the Safety Guidance

The Los Angeles County Department of Public Health (Public Health) has reported more than 500,000 confirmed COVID-19 cases in Los Angeles County. We have reported 100,000 new cases since November 30, when L.A County reached 400,000 COVID-19 cases.

To date, Public Health identified 501,635 positive cases of COVID-19 across all areas of L.A. County and a total of 8,199 deaths. Upon further investigation, 97 cases reported earlier were not L.A. County residents.

There are 3,624 people with COVID-19 currently hospitalized and 23% of these people are in the ICU. The number of people hospitalized with COVID-19 continues to exceed all-time highs every day since December 1 and has increased nearly every day since November 1. The number of people hospitalized has increased twofold in just 15 days.

The impact of the Thanksgiving surge of cases on top of already rising cases is creating extraordinary stress on our healthcare system. When we see increases in cases, we see increases in hospitalizations about two weeks later.

In two weeks, there could be over 7,300 daily hospitalizations for COVID-19, and over 1,600 patients in the ICU. This is alarming given that there are only 2,100 adult ICU beds across County hospitals and many of these beds are essential for patients that need intensive care for other illness including trauma, cardiac surgeries, serious infections, and cancer treatments.

"These numbers are overwhelming. The grief that our community continues to experience cannot be comprehended, and my deepest sympathies go out to everyone who is mourning," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "We cannot undo what has already been done and collectively, we are going to pay a very high price for the actions we took in the past. What we can do and what everyone across the county needs to do right now is to stay at home as much as possible, and limit going out to what is essential: work, school, childcare, exercise and obtaining necessary goods and services. The best way to protect our essential workers, including healthcare workers, who have to serve and be with others, is to always follow the rules when you are with or around those not in your family: we need everyone to wear a face covering and keep physical distance from anyone they do not live with. Make the choice today and every day through December that you will protect yourself, you will protect your friends and loved ones, and you will protect the friends and loved ones of other people. Our actions prevent terrible suffering and save lives."

Testing results are available for more than 4,060,000 individuals with 12% of all people testing positive. Today's daily test positivity rate is 14.4%.



PORTRAIT OF OUR NEIGHBORS By Stuart Tolchin

BRANDON EASTON

I present the piece as an illustration of my basic thesis that even in these difficult restricted times interesting people pass by our front door. Now some of us have the time to get to know them a little better, perhaps contributing to a more acceptable mental inner place or even a better outer world. I spoke with, Brandon Easton, a professional screenwriter and educator now based in this area. He was born in Baltimore Maryland and still has a great attachment based on his boyhood experiences there. He has received numerous awards and honors and is known for his work in the comic book industry, writing on series like Judge Dredd, Spider-Man, Vampire Hunter D and Closer to Heaven, the acclaimed biography of the late pro-wrestler Andre the Giant.

Brandon's career also spills into the realm of television, with credits on the 2011 WB reboot of Thundercats, Netflix's hit new series Transformers: War for Cybertron, Marvel's Agent Carter, Avengers Assemble: Black Panther and much more. One of my hopes in our conversation was to gain some understanding of this modern phenomena which reaches so many and perhaps has the potential to remedy present inequalities which negatively affect everybody. In the first moments of our conversation I immediately recognized a highly educated man with broad interests and knowledge in many fields. Speaking to him reminds me of speaking with scholars who possess a great depth of knowledge

which left me with the desire to hear more. I was surprised to learn that Brandon had a very difficult, unstable childhood causing him at fifteen to leave home and reside with a friend. He still has concerns about the welfare of his mother and periodically returns to Baltimore to assist

The obvious question is- given such a difficult childhood how did he get to be who he is now? He obtained his undergraduate education from Ithaca College; a place he describes as being in the middle of nowhere in upstate New York. Why and how in the world did he end up there? "It was simple," he explained, "because Ithaca offered the best financial aid package."

As an African American student with no money and from a different geographical region, Brandon found himself at odds with the other students of color (who mainly hailed from NYC) and most of the financially privileged kids at Ithaca. Nevertheless, while there, he developed an insight which influenced the rest of his life. As he learned more of America's disreputable history it gave birth to his writing voice combined with a greater sociological understanding. Subsequently he obtained a Master of Fine Arts in Screenwriting from Boston University and second master's from CUNY Lehman College in Secondary Social Studies Education. With new insights and educational qualifications, he hoped he could make a difference by teaching in New York public schools. During his six years there, he became aware of the almost inescapable disadventages of attempting to reach already disillusioned students. He described the incredible disadvantages of attempting to reach already disillusioned students. He described the incredible disrespect for teachers now existing in the school resulting in a complete lack of discipline and a general experience of chaos.

Bravely, he came to Hollywood with the hope of becoming a screenwriter positively reaching young people and obtaining greater personal satisfaction. Despite numerous obstacles breaking into the scene, he managed to achieve his dream of becoming a professional writer. Before Covid, Brandon led multiple panels at major comic conventions discussing issues of racial discrimination in the entertainment industry. Certainly, there is much more to write about Brandon and his past and current adventures in Hollywood and I plan to do that in a future article. By the way, he and my daughter have been living together in a loving relationship for about ten years and are the parents of my sixteen month old granddaughter, the most wonderful person in the history of the Universe.

I have found a light and refreshing wine with enough bubbles to enjoy and flavor that even a splash of orange juice won't kill. Ruffino Prosecco has been produced from grapes grown in the hilly area of Valdobbiadene, which is the most historically vocated region for the production of Prosecco. Bright straw yellow with fine bubbles, the bouquet is fragrant and intensely fruity. It shows clean notes of apples, pears and citrus. I found it crisp, clean and yet delicate - a perfect wine for a toast at a celebration. Intense sensa-

tions of apples and peaches drive a pleasant aftertaste that is reminiscent of fruity and floral aromas.



Ideal as an aperitif; it is very versatile as a food companion. What to pair it with? Ruffino Prosecco matches well with fish and shellfish dishes as well as white meat dishes. I enjoyed this sparkler just this past weekend with a thin crust BBQ Chicken pizza. Others in this category would include Sofia Sparkling Wine and the previously written about Domain Chandon. I do recommend the Ruffino Prosecco for the toast and depending on the wedding or celebration menu at around \$14(Vons Pasadena) you can't go wrong. Again a touch of OJ or a sweet strawberry added and I won't call party foul. Enjoy!!



HOW ROBOTIC PETS CAN HELP ISOLATED SENIORS AVOID **LONELINESS**

Dear Savvy Senior:

I recently read an article about robotic pets being a great substitute for pet-loving seniors who can't have or take care of a pet any longer. What do you think of this? My mother, who has some dementia, is living in an assisted living facility that doesn't allow pets. And because of CO-



VID, we haven't been allowed inside the facility to visit her since March. I've been thinking about getting her a robot pet to help cheer her up but would like to know if they are worth buying, and if so, where can I go to find one. Locked Out Daughter

Dear Locked Out:

There have actually been several studies on this topic that has shown that robotic pets - which are lifelike interactive pets - can have a positive impact on many lonely, socially isolated seniors, especially those who have dementia. This is particularly important now as the pandemic has caused millions of high-risk, vulnerable seniors to isolate as a means to protect themselves from the coronavirus. Here's what you should know.

Robotic Pet Studies

In 2018, the New York State Office for the Aging was the first state in the U.S. to test the robotic pets with isolated seniors and results showed that using pets to lower social isolation was highly successful, with 70 percent of pilot participants reporting a decrease in isolation after one year. Subsequent programs done in aging agencies in Alabama, Florida and Pennsylvania have also shown positive

Other clinical studies conducted by AARP, UnitedHealthcare, and other clinicians and have also found that robotic pets can help to enhance the well-being and quality of life of lonely or isolated individuals and those living with dementia and other forms of cognitive decline, by providing a level of interaction and comfort from a lifelike companion.

Where to Look

If you're interested in getting your mom a robotic pet, a top option is Ageless Innovation's Joy for All Companion Pets – see JoyForAll.com.

They offer cats, a kitten and a pup that look, feel and sound like the real thing - minus the feeding, watering, litter box or backyard cleanup, and the vet bills. With prices ranging between \$65 and \$130, these soft, plush animals have built-in sensors, "vibrapurr" or "barkback" technology, and brushable fur, making them surprisingly realistic.

Insert four batteries, and the cats, which come in four different shades to mimic real breeds, can open and close their eyes, lift their paws, and move their head and body. If you pet them in the right spot – like on their belly or back side – they'll let out a purr.

If your mom is more of a dog person, you can also buy a stuffed golden puppy, accessorized with a red bandana, that will bark if he's feeling happy, sad, or needy. At only four pounds, the stuffed pup is easy to play with and won't weigh down even the most fragile frame.

Some other robotic pet options you should look into include Tombot's Jennie (\$399; tombot.com), a lapdog that barks on command and has realistic facial features; AIBO (\$2,900; us.aibo.com) by Sony, which is a plastic puppy that has lifelike expressions and a dynamic array of movements; and Paro the Seal (\$6,120; parorobots.com), which is marketed as a "carebot," designed specifically for people with dementia.

5 QUESTIONS TO ASK BEFORE HIRING AN ESTATE PLANNING LAWYER—PART 1

Since you'll be discussing topics like death, incapacity, and other frightening life events, hiring an estate planning lawyer may feel intimidating or even morbid. But it doesn't have to be that way.

Instead, it can be the most empowering decision you ever make for yourself and your loved ones. The key to transforming the experience of hiring a lawyer from one that you dread into one that empowers you is to educate yourself first.

This is the person who is going to be there for your family when you can't be, so you want to really understand who the lawyer is as a human, not just an attorney. Of course, you'll also want to find out the kind of services your potential lawyer offers and how they run their business.

To this end, here are five questions to ask to ensure you don't end up paying for legal services that you don't need, expect, or want. Once you know exactly what you should be looking for when choosing a planning professional, you'll be much better positioned to hire an attorney who will provide the kind of love, attention, care, and trust your family deserves.

1. How do you bill for your services?

There's no reason you should be afraid to ask a lawyer how he or she bills for the work they do on your behalf. In fact, questions about billing and payment should be thoroughly discussed before you engage any lawyer to represent you. No one wants surprises, especially when it comes to legal fees.

Find an estate planning lawyer who bills for their services on a flat-fee, no surprises, basis—and not on an hourly basis—unless it's required for limited purposes. And ideally, you want a lawyer who will guide you through a process of discovery in which they learn about your family dynamics, your assets, and they educate you about what would happen for your family and to your assets if and when something happens to you, and then support you in choosing the right plan for you that meets your budget and your desired outcomes.

2. How will you respond to my needs on an ongoing basis? One of the biggest complaints people have about working with lawyers is that they are notoriously unresponsive. Indeed, I've heard of cases in which clients went weeks without getting a call back from their lawyer. This is all too common, but totally unacceptable, especially when you're paying them big

That said, in most cases, these lawyers aren't blowing you off—they simply don't have enough support or the systems in place to be able to be responsive. Far too many lawyers believe they can take care of everything themselves. From paperwork and client meetings to scheduling and returning phone calls to connecting their clients with other advisors, there are just too many responsibilities for one person to manage all on their own.

Ask them how quickly calls are typically returned in their office, ask them if there will be someone on-hand to answer quick questions, and ask them how they will support you to keep your plan up to date on an ongoing basis and be there for your loved one's when you can't be.

A great way to test this is to call your prospective lawyer's office and ask for him or her. If you get put through right away—or even worse, your call gets sent to a full voicemail—think twice about hiring this lawyer. This means they don't have effective systems in place for managing and responding to calls or answering quick questions.

Instead, what you want is for the person who answers the phone—or another team member—to offer to help you. And if that individual cannot help you, then he or she should schedule a call for you to talk with your lawyer at a future date and time. Ideally, all calls with your lawyer should be prescheduled with a clear agenda, so you both can be ready to focus on your specific needs.





CAN DISEASE-SPREADING DOLTS BE REASONED WITH?

I suppose this is progress: On Sunday, Trump's vaccine "czar," Moncef Slaoui, endorsed President-elect Biden's plan to ask all Americans to wear masks during his first 100 days. Slaoui's said, "I think it's a good idea...We all need to take our precaution, have our masks... We will not all have the vaccine in our arms before May or June. So we need to be very cautious and vigilant.'

Alas, and oh so predictably, Slaoui's message was undercut 24 hours later by his lame-duck boss, who proceeded to violate CDC guidelines by host-ing a maskless ceremony in the Oval Office. How many more people will he kill on his way

He's our most prominent menace to public health, but he's hardly alone.

Two random examples: Last week, a viral photo showed maskless patrons of a popular D.C. bar whooping it up in tight quarters, all of them exercis-ing their God-given freedom to infect. And last month, out in Oregon, a high-profile doctor named Steven LaT-ulippe appeared at a Trump rally and told the cultists to "take off the mask off shame" (few wore masks an-yway). He also boasted that none of his clinic staffers wore masks. The cultists cheered for that one. (The state has since suspended LaTulippe's medical license, so now he's a martyr.)

You have to wonder how many more deaths and hospitalizations and ill-nesses and quarantines we must endure, on the cusp of our darkest win-ter, before the selfish idiots among us finally recognize their responsibility to their fellow citizens.

Actually, I remember pondering that question when the death toll hit 1,000. But now it's 280,000, and I'm pondering anew not just because that stat is so horrific, but because one of my pen pals – a reader – has emailed me a blast of ignorance that epitomizes the

He signed the email "Beowulf," so let's call him that. Beowulf was upset with a recent column where I criticized Scott Atlas, Trump's incompetent (and now-departed) coronavirus adviser. After a few insults, Beowulf wrote:

You are without objectivity. One example; where in this piece is the switching positions of both Fauci and the concerning masks? Why do you not say why he was originally against them? And do you know that the average mask mesh size compared to virus size is the same as that of a chain link fence and a swarm of flies?"

This is what we're up against, folks. People like Beowulf are still assailing Anthony Fauci for what he initially said about masks way back on March 8. They're still mimicking Trump's fake claim that Fauci was against masks - whereas, in truth, Fauci was trying to prevent a mask shortage for health workers.

Also, at that time, the extent of asymptomatic spread was unknown. But as health authorities learned more - about the spread of the disease and the efficacy of masks their recommendations changed. That's called science. The CDC endorsed masks for the general public on April 3, and Fauci has confirmed that in countless interviews ever

Beowulf's other argument – that the virus passes through masks with the ease of insects flying through "a chain link fence" – is a viral Facebook lie that's persistently popular among deniers. But infectious disease expert Brian Labus, a member of Nevada's coronavirus task force, had the best response:
