SIERRA MADRE MAINTAINS ITS' FINANCIAL HEALTH IN 2020

On Tuesday, January 26, 2020, the Sierra Madre City Council will review its' Comprehensive Financial Report (CAFR) for fiscal year ending June 30, 2020, a review of the audit report prepared by the independent accounting firm of Rogers, Anderson, Malady & Scott, LLp, CPA.

Sierra Madre, through the leadership of City Manager Gabe Engeland and staff, has managed to end the year with a General Fund Balance of over \$7.5 million dollars; water fund surplus of \$3.3 million and a sewer fund surplus of \$668, 000 in the midst of a National Emergency.

In addition to the positive bank balances, the staff report lists

"Major Accomplishments for the Year" which include (partial listing):

The continuation of the long-term project to replace the City's water main infrastructure: Capital Investment in EV

the City's water main infrastructure; Capital Investment in FY 19-20 was \$1.9M and \$1.8M for FY 18/19.

The installation of the Advanced Metering Infrastructure (AMI) Project was completed for the City's 3,800 water

meters. The Wi-Fi-based meters collect customer's water usage data instantaneously, allow billing to occur on a monthly basis effective July 1, 2020.

The City Council approved a proposal to fund a \$3 million prepayment to CalPERS beyond the annual required

million prepayment to CalPERS beyond the annual required contribution budgeted to occur during FY 19-20 to reduce Unfunded Accrued Liability (UAL). In addition, the prepayment will also reduce funding in future requirements as determined by CalPERS.

In October 2019, the final payment was made to the

- In October 2019, the final payment was made to the L.A. County Auditor-Controller based on the "Last and Final" Recognized Obligation Payment (ROPS) Schedule. This was in connection with the City of Sierra Madre Redevelopment Successor Agency. The City will pursue final dissolution of the Agency during FY 20-21.

The City executed a sales agreement with TowerPoint, LLC for the sale of lease interests in wireless communication sites on City property for \$1.2 million.

PALM FROND CLEAN-UP

The Sierra Madre Department of Public Works would like to make residents aware of its policy regarding the removal of fallen Palm fronds. City staff receives numerous questions and requests after windstorm events, but the policy is consistent throughout the year:

Public Works crews will work diligently after windstorm events to pick up fallen Palm Fronds from City trees. City trees include trees within the parks and parkways throughout the City.

The Department of Public Works would like our residents to know that they really appreciate so many of our residents lend a hand to gather and stack the fronds to ease the work of the crews. Thank you! We would ask that stacks of fronds be located in the parkway instead of the street as much as possible.

Palm fronds from private property are the responsibility of the resident to dispose of. These fronds should not be included in the "green" waste cans but should be included in the "black" waste cans. The reason for this is that they are not recyclable/compostable, and their fibrous content does not work with the machinery that is used to handle green waste. Fronds can also be picked up by arranging a "bulky item" pick up from Athens Services (888-336-3100).

HAPPY 100TH BIRTHDAY JOHN SHEAR!

SIERRA MADRE AND SANTA ANITA RACE TRACK CELEBRATE AND HONOR JOHN SHEAR'S

100th BIRTHDAY

What a day! On January 17, 1921 John Shear was born! To celebrate the birthday 100 years late in 2021, family, friends and well wishers gave him a 'drive by birthday party in front of his home in Sierra Madre. John stood outside waving and smiling to all who passed by. Shown above with Sierra Madre Mayor Rachelle Arizmendi (pre-Pandemic), John is a true home town hero!

In 2011, at age 90, he saved the life of a young girl by hurling his body in front of a horse. The girl was saved but John sustained serious injuries. He was, however able to return to work at Santa Anita where he had worked for more than 50 years. (http://mtnviewsnews.com/v05/htm/n12/index.htm.

At age 100 he is doing well, and being honored not only by his friends and neighbors, but also by Santa Anita Race Track who named a race in his name on his birthday!

From Santa Anita:Although his preferred venue is off the agenda for the time being, Santa Anita's beloved Paddock Captain John Shear will nonetheless celebrate his 100th birthday with family this Sunday, Jan. 17. Furloughed since the onset of the COVID-19 pandemic in March, Shear, who has been employed by the track since 1961, would dearly love to return to his beloved Santa Anita.

Santa Anita named a race in honor of Shear's 100th birthday on Sunday, and although they'll be unable to attend, Shear and his wife Diane and son Michael, will spend his 100th birthday at John and Diane's Sierra Madre home watching the races and wading through dozens of birthday greetings from jockeys, trainers and track employees via a virtual birthday card presented by Santa Anita.

"I enjoy watching on television, but nothing compares to being at Santa Anita," said Shear. "We just hope this pandemic will end soon and we can get back to normal. My wife and I are trying to stay busy with exercise classes and we spend as much time outdoors as we can. We're being careful, staying out of stores and ordering things to go, but I miss working and being around the horses so much."

A native of England who was raised from age four to 14 in an orphanage, Shear, at four feet, 11 inches, originally aspired to be a jockey and following World War II, emigrated to Vancouver, B.C. from where he came to Santa Anita as an exercise boy in 1954.

"I was exercising horses for a guy in Vancouver and he asked me if I'd like to go with him to Santa Anita that fall," said Shear when interviewed a year ago. "I said 'Sure,' and as soon as I stepped off that van in the Stable Area here, I said 'Lord, this is where I want to be.' The place was so incredibly beautiful and I've never gotten tired of "t"

And The Great Race Place will never tire of John Shear, a man who gained national attention nine years ago when at the age of 91, he heroically threw himself between an on-rushing loose horse and a 5-year-old girl who was standing with her father outside of Santa Anita's Seabiscuit Walking Ring.

On the cusp of his 100th birthday, Shear no doubt speaks for thousands of race goers when he says, "I just hope I can get back to the track soon."





Yes, dear readers, Valentine's Day is fast approaching. I will find you a great wine to make a hero out of you in the coming weeks. This week we travel back to Paso Robles for a visit to the Justin winery, one of the most popular and recognized wineries in Paso Robles. My pick is their Cabernet Sauvignon. I have enjoyed many cabernets from Paso, and this one, for the money, just might be my favorite. Why? The price is around \$25 and I could easily sip this wine all by itself. For me, red wines are best when paired with food. Justin is the exception to this rule. However, some soft cheese and seasoned crackers might be in order.

Justin Cabernet is a big, rich wine with a good amount of tannin that balances out the thick flavors in the glass. Good density and intensity with a dose of oak gives the wine a dimension that really makes Justin a winner. Along with hints of ripe black cherry, blackcurrant and berry fruit with vanilla, cinnamon and subtle dried fall leaf accents, you'll find moderate blackcurrant, cherry fruit and baking spice flavors on the first taste.

Justin winery, like many Paso Robles wineries, is a relative newcomer. The first grapes were picked in 1981 and, as I mentioned, it just might be the most popular winery in the region, for good reason. The winery offers wines from \$19 to \$100, and this cabernet is on their less expensive side so there's no reason to spend that kind of dough.

This weeks Wine term: Sommelier is a French word for wine steward, often placed held in high esteem. Sommeliers have passed tests to earn the right to be called a sommelier. Dills Score: 91

Closure: Corked

Each week I will give you my Dills Score. Starting with a base of 50 points, I have added 8 points for color, 8 points for aroma or "nose", 8 points for taste, 7 points for finish, and 10 points for my overall impression, which includes my value rating.

WALKING SIERRA MADRE - The Social Side

"I have decided to stick with love." Martin Luther King

What a week we had this last week! Martin Luther King day on Monday, a moment to pause and reflect on this great man's life. The quote goes on to say, "...for I know that love is ultimately the only answer to mankind's problems." The Inauguration last Wednesday seemed to be heading in that same direction...that love is the answer.

Here are a few of the things that made an impression on me:

Eugene Goodman, the Capitol police officer who single-handedly led the mob that broke into the Capitol two weeks ago away from the Senate Chamber, escorted the new Vice-President, Kamala Harris and her husband into the Inauguration. Officer Goodman is now acting deputy sergeant -at-arms for the senate. As the mob bore down on the closed doors leading to the Senate chamber, from which all members of Congress had not yet been evacuated, Goodman intercepted the crowd and retreated down an adjacent hallway leading them away from the chamber. Sounds pretty heroic to me!

Bill Clinton making his way over to Mike Pence to greet him and engage him in conversation when it looked like Mr. Pence was going to be ignored by all. Kindness works!

Senator Amy Klobuchar, first woman elected to represent Minnesota, looked so happy, thrilled and excited to be there and her speech promised, "never to take our democracy for granted." Here is my favorite part: "This is the day our democracy picks itself up, brushes off the dust and does what America always does, goes forward as a nation, under God, indivisible, with liberty and justice for all." Snow started to fall but didn't last long. The sun came out and, while it looked really cold, at least everybody didn't have to sit outside under a snowstorm!

The principal ladies all looked terrific. The outfits on Hillary Clinton, Michelle Obama, Laura Bush, Jill Biden and Kamala Harris were all just perfect. Lady Gaga did a nice job on the Anthem, but I had to laugh when I saw that a lot of Twitter folks were comparing her outfit to costumes worn in the "Hunger Games" movies. The huge golden dove of peace on her shoulder with an olive branch clutched in its beak had to be 6" wide and 5" tall. But if you're Lady Gaga, you can pull it off. Remember the meat dress?

Jennifer Lopez sang an interesting version of Woody Guthrie's "This Land Is Your Land," which was written as a protest song in 1940. Guthrie wanted to address income inequalities in America and the suffering of millions during the Great Depression. When I graduated from 8th grade sometime shortly after the discovery of fire, the 8th grade class of St. Paul's in Westwood sang this song.

I don't remember who used the quote from Ronald Reagan's inauguration in 1981, but I loved hearing it: "To few of us here today, this is a solemn and most momentous occasion; and yet, in the history of our nation it is a commonplace occurrence. The orderly transfer of authority as called for in the Constitution routinely takes place as it has for almost two centuries and few of us stop to think how unique we really are. In the eyes of many in the world, this every-four-year ceremony we accept as normal is nothing less than a miracle."

My picture is of the Capitol with a glorious blue sky behind it and flags draped over the front of it. I was impressed by the field of flags which covered the National Mall and featured flags from all 50 states, Washington, D.C., American Samoa, Guam, Northern Mariana Islands, Puerto Rico and the U.S. Virgin Islands. In years past, the Mall was stuffed with thousands of people there to see the new President take his oath of office. I missed seeing all the people with their children and babies bundled up to be part of this historic moment. Flags are nice but just don't have the same meaning as people. There were a few spectators, socially distanced, out in front of the ceremony, but it was kind of sad looking.

I was also struck by the presence of soldiers everywhere, making sure the peace would be kept. I knew they would be there, but it was startling all the same.

You all saw this, too, and have your own thoughts and memories to take away. I was struck by how many times the words, "A more perfect Union..." were spoken. And "without unity there is no peace."

Garth Brooks singing Amazing Grace was a great ending note. And one last observation, the real star of the day was the guy who swabbed down the podium before and after every speaker, taking a sanitizing wipe out of a blue package and wiping down the top and complete front while the next speaker waited.

All I saw and heard made me think of the Prayer of St. Francis...

"Lord, make me an instrument of Thy peace.

Where there is hatred, let me sow love;

Where there is injury, pardon; Where there is doubt, faith;

Where there is despair, hope;

Where there is darkness, light;

Where there is sadness, joy. O Divine Master, grant that I may not so much seek

To be consoled, as to console;


To be understood, as to understand; To be loved as to love.



Council to Discuss **Police Oversight** Commission

The Pasadena city council is set Monday to discuss policies for appointment members to the city's new Community Police Oversight Commission.

They will also look at rules, regulations and compensation for the commission members.

According to the agenda report, the commission consists of 11 members to be appointed by the city council. All 11 members must be a resident of the city, but council nominees need not reside in the nominating council member's district. Each council member, including the mayor, has one nominee to the commission, for a total of eight members. Three additional members representing communitybased organizations must also be nominated. The Municipal Code is silent as to how the communityorganizations based would be nominated. The Municipal Code also states a goal of having at least half of the filled positions on the commission be filled by women.

For the eight commission positions nominated by council members and the mayor, the resolution does not limit the means for nomination. As proposed, each council member and the mayor can determine how they will arrive at their nominee. Several council members discussed a public application process for nominees.

The city manager would designee publicize the opportunity community-based organizations, and to refer applicants to the Public Safety Committee.

If the council approves a policy for appointment of commission members (by resolution), a \$100 per meeting stipend would be set for commissioners.

The city attorney is also in the process of issuing a Request for Proposals for Independent Police Auditor, which will be a contractor (not employee) position within the city attorney's office the report reads.

The commission is expected to hold 12 meetings a year, at a cost of \$13,200 per year.

Huntington to Renovate Historic Tea Room

The project, developed by The Huntington with Architectural Resources Group, will upgrade the indoor dining space, modernize the kitchen, develop new restrooms and ancillary areas, and create a pavilion on its eastern side, opening onto the Shakespeare Garden for exterior dining service. SUPERVISOR BARGER JOINS IN EFFORTS TO CURB THE **USE OF PUBLIC SAFETY POWER SHUTOFFS** REPEATED SHUTOFFS LEAVE THOUSANDS STRANDED WITHOUT POWER - DEBILITATING WORK AND SCHOOL DURING THE COVID-19 PANDEMIC

LOS ANGELES COUNTY —Supervisor Kathryn Barger is supporting the effort by the California Public Utilities Commission (CPUC) to address concerns of communities throughout Los Angeles County, which continue to experience ongoing Public Safety Power Shutoffs (PSPS) initiated by Southern California Edison (Edison). The CPUC will hold a public hearing with Edison to ensure transparency regarding their compliance with CPUC rules and requirements and to receive comments from stakeholders.

"This hearing is an important first step to hold Edison accountable to its customers and communities and to fix what is clearly a broken system tied to Public Safety Power Shutoffs," said Supervisor Barger. "Although we understand that Southern California Edison must balance very real concerns about public safety and impending fire danger when they decide to implement a PSPS event, we believe there is a better way to communicate and mitigate these outages. We look forward to working with the CPUC, Edison, and all of the stakeholders involved, including our impacted community members, to make sure any future PSPS events are as painless as possible."

During dangerous weather conditions, such as high winds, extreme heat, and low humidity, utility companies such as Edison proactively turn off power in high fire risk areas to reduce the threat of wildfires. These Public Safety Power Shutoffs (PSPS) can impact nearly 50,000 households in the San Gabriel, Santa Clarita and Antelope Valleys. With the various health officer orders that have closed schools and forced more individuals to work from home, the devastating impacts of power loss are significant to these community members.

Earlier this month, the Los Angeles County Board of Supervisors unanimously approved a motion by Supervisor Barger that asked County Counsel to investigate all available legal options for the County to mitigate the impacts of future PSPS events. The motion also sought assistance from the CPUC, the Office of the Governor, and the Los Angeles legislative delegation to address proper notification and communication to impacted communities and to mandate substantial additional mitigation measures as a requirement for the continuation of the PSPS program. 





HOW MUCH DO YOU HAVE TO MAKE TO FILE INCOME **TAXES?**

Dear Savvy Senior:

What are the IRS income tax filing requirements for retirees in 2020? My income dropped way down when I was forced into retirement last March due to COVID, so I'm wondering if I need to file a tax return this year. Unexpected Retiree



Dear Unexpected,:

Whether or not you are required to file a federal income tax return this year actually depends on several factors: How much you earned last year (in 2020), the source of that income, your age and your filing status.

Here's a rundown of this tax season's IRS tax filing requirement thresholds. For most people, this is pretty straightforward. If your 2020 gross income - which includes all taxable income, not counting your Social Security benefits, unless you are married and filing separately – was below the threshold for your filing status and age, you may not have to file. But if it's over, you will.

- Single: \$12,400 (\$14,050 if you're 65 or older by Jan. 1, 2021).
- Married filing jointly: \$24,800 (\$26,100 if you or your spouse is 65 or older; or \$27,400 if you're both over 65).
- Married filing separately: \$5 at any age.
- Head of household: \$18,650 (\$20,300 if age 65 or older).
- Qualifying widow(er) with dependent child: \$24,800 (\$26,100 if age 65 or older).

To get a detailed breakdown on federal filing requirements, along with information on taxable and nontaxable income, call the IRS at 800-829-3676 and ask them to mail you a free copy of the "1040 and 1040-SR Instructions for Tax Year 2020," or you can get it online at IRS.gov.

There are, however, some other financial situations that can require you to file a tax return, even if your gross income falls below the IRS filing requirements. For example, if you earned more than \$400 from selfemployment in 2020, owe any special taxes like an alternative minimum tax, or get premium tax credits because you, your spouse or a dependent is enrolled in a Health Insurance Marketplace (aka Obamacare) plan, you'll need to file.

You'll also need to file if you're receiving Social Security benefits, and one-half of your benefits plus your other gross income and any tax-exempt interest exceeds \$25,000, or \$32,000 if you're married and filing jointly.

To figure all this out, the IRS offers an interactive tax assistant tool on their website that asks a series of questions that will help you determine if you're required to file, or if you should file because you're due a refund. It takes less than 15 minutes to complete.

You can access this tool at IRS.gov/Help/ITA – click on "Do I Need to File a Tax Return?" Or, you can get assistance over the phone by calling the IRS helpline at 800-829-1040.

Check Your State

Even if you're not required to file a federal tax return this year, don't assume that you're also excused from filing state income taxes. The rules for your state might be very different. Check with your state tax agency before concluding that you're entirely in the clear. For links to state tax agencies see Taxadmin.org/ state-tax-agencies.

Tax Prep Assistance

If you find that you do need to file a tax return this year, you can free file through the IRS at IRS.gov/FreeFile if your 2020 adjusted gross income was below \$72,000.

Or, if you need some help, contact the Tax Counseling for the Elderly (or TCE) program. Sponsored by the IRS, TCE provides free tax preparation and counseling to middle and low-income taxpayers, age 60 and older. Call 800-906-9887 or visit IRS.treasury.gov/freetaxprep to find out about services near you.

You can also get help through the AARP Foundation Tax-Aide service, a participant in the TCE program that provides free tax preparation in-person, online and by phone. To find out about service options in your area, call 888-227-7669 or visit AARP.org/findtaxhelp. You don't have to be an AARP member to use this service.

I stared at her for a few moments, not knowing what to think, and then I broke down in hilarious laughter. 'So, I'm not drinking coffee this morning.'


Together we laughed for a few moments, then she went back into the kitchen and made the coffee all over again, and this time she did not forget to put the coffee grounds in the coffee pot.

MOVIE REVIEW

"ONE NIGHT IN MIAMI"Written by Kemp Powers, Directed by Regina King.

"One Night in Miami" begins by introducing us to four influential black men in 1964: Cassius Clay, Malcolm X, Jim Brown, and Sam Cooke, each arguably at the top of their game in, respectively, boxing, civil rights, football, and music.

The movie begins with a brief introductions to these key players – we assume that most viewers already know most of them. We then get to watch the fight that jettisoned Cassius Clay to the heavy-weight title of the world, the February 25, 1964 fight with Sonny Liston. Then, after the win, Jim Brown and Sam Cooke expected to party with Cassius until the cows came home, but they first met at the motel room which Malcolm X reserved for them.

The bulk of the movie then deals with their conversation, which, of course, no one has any idea if anything like this actually took place. That's the beauty of "One Night in Miami": Kemp Powers took great literary license, set into the historical reality of the day, and tried to present us with what these four Greats might have talked about. The result is riveting, insightful, humorous, and sad, and opens a portal to the thinking of those directly involved with the civil rights struggle of the 1960s.

After the fight, Malcolm X and Cassius Clay had planned a short discussion, and Cassius is trying to decide how and when to announce that he will join the Nation of Islam. Once Cooke and Brown arrive, they want to know when others will join them for the party, but Malcolm tells them that it's just them, and no liquor. They are not happy.

Malcolm X is the spiritual leader and guide of the discussion, admonishing each of the men to do better, to rise up, to not let their lives be dictated by their white agents and bosses. Perhaps the most revealing and compelling discussion is when Malcolm X chides Sam Cooke for not rising to the occasion of civil rights in his music, and for just pandering to the emotional whims of his mostly white audiences. Cooke is incensed, pointing out how he owns his label, and owns his copyrights, and how he has worked towards equality through economic means. Cooke points out that everyone in the room has an actual job, all but Malcolm X. That only momentarily silences Malcolm X, who seems to be fairly accurately portraying the real Malcolm X as a strict and uncompromising American Muslim.

Another near fight breaks out during a later discussion where Malcolm X tells Clay, reluctantly, that he is actually thinking of leaving the Nation of Islam. Clay goes into a rage, feeling that Malcolm X was just using him to lend credence to Malcolm's own possible breakaway group.

Powers did a masterful job of combing through the historical record to paint a realistic picture of the conversation that could have happened, which weaved together the drama occurring in each of the lives.

Clay was going to "come out" as a Muslim and knew it might hurt his career.

Cooke loved Bob Dylan's song which so accurately described Cooke's feeling – "how many roads must a man walk down, before he is called a man?" – and he was visibly ruffled by Malcolm X's suggestions that he wasn't doing enough. The movie depicts Cooke's new direction by his performing of "A Change Is Going to Come" on the Johnny Carson show. (In fact, this song was recorded before Clay's heavyweight fight).

Brown was at the top of his game, and was about to decide to retire from football and go into acting, a never-certain proposition.

And Malcolm X, wanting to inspire each of these men to even greater heights in service to the goal of equal rights for the black man, was himself in turmoil. Though Malcolm X had become the eloquent spokesman for the American-born Nation of Islam, he was well aware of the lavish lifestyle of the leader, Elijah Muhammad, and his many women out of wedlock. Most objective observers regarded Malcolm X as nearly a saint by comparison to the leader of the Nation, and after Malcolm X's visit to Mecca, he saw a new side of Islam, that Islam embodied people of all races. He knew that breaking from the Nation would have dramatic consequences, and he even foresaw his eventual assassination.

Though the movie makes a few alterations in the chronology of known historical dates, the movie otherwise flows well and is believable. I was spellbound, and could not stop discussing its various aspects long after it was over.

The movie ends with certain highlights of each of the four men: Cassius Clay declaring the next day that he was a member of the Nation of Islam, and his name was now Muhammad Ali. Jim Brown retiring from football and pursuing an acting career. Sam Cooke revealing a new song which revealed a new direction towards support of the civil rights movement. And lastly, Malcolm X is shown reading the manuscript of his autobiography, as told to Alex Haley. Almost a year after Cassius Clay won the heavyweight title, on February 21, 1965, Malcolm X was giving a talk at the Audubon Ballroom, and was no longer affiliated with the Nation of Islam. Three members of the Nation of Islam gunned him down and killed him that night.

"One Night in Miami" shares a personal, private side of these four men, and does justice to their memories.

Cassius Clay played by Eli George, Malcolm X played by Kingsley Ben-Adir, Jim Brown played by Aldis Hodge, and Sam Cooke played by Leslie Odom Jr.



IT'S NOT JUST US - IT'S JUSTICE

It's just another Wednesday and gee I'm glad that I'm still around. Watching the activities of January 20, 2021 which included the farewell of the maskless Trump "China" virus deniers (never to be mentioned again) and the arrival of reality in the presentations of the Joe Biden/Kamala Harris inauguration. Farewell to the inglorious past four years. An emphatic farewell to the previously unimaginable riot directed against our Democracy presented to us live on television just two Wednesdays ago. The orderly presentation of the inaugural activities of today including the participation of



In 1972 I was living in Bakersfield and working as the Director of a Legal Services Program. Bakersfield was and is a very conservative community represented today by House Minority Leader and staunch Trump supporter (at least until today) Kevin McCarthy. To relieve some of my frustration and desirous of associating with potentially like-minded individuals I drove with a friend up to the City of Fresno where a Shirley Chisholm for President rally was being conducted. Really this was not so long ago but it was a very different time. Richard Nixon had been elected President in 1968 along with Vice-President Spiro T. Agnew, the former Republican Governor of Maryland. There seemed little chance that any Democrat could defeat Nixon although there was some talk that a fairly unpublicized break-in intended to spy on the Democratic Party might have some effect upon Nixon's certain re-election. It didn't! Nixon won 49 States.

Prior to the election various Democrats competed for their party's nomination. Included within this group was the infamous Alabama Governor George Wallace whose well-remembered campaign slogan was "Segregation now, Segregation forever! (If you recall, Wallace was the victim of an assassination attempt during this campaign which left him paralyzed for life.)

Another candidate was Shirley Chisholm who in 1969 was the first Black woman elected to the United States Congress. She called for a "bloodless Revolution". Well change has come as demonstrated by the election of Vice President Harris and the presence of Justice Sotomayor. It's taken 29 years but it has come and is still coming. Progress and coming equality was unmistakably demonstrated by the appearance of the inaugural poet Amanda Gorman. This 22 year old African American Woman from Santa Monica, no less, completely stole the show. She told the world that a skinny Black girl descendant from slaves, raised by a single mother, stood for the future. She represents the promise of this Country explaining that Democracy can never be defeated. She supported President Biden's assertion that there are "enough of us" to overcome the divisiveness now present in this country. Her call for Justice included a demand for equality and an end to systematic racism which has so damaged this country. Her use of the word "Justice" brought to mind the old Richard Pryor joke of a generation ago about what "Justice: meant in terms of African Americans relation to Police conduct. In terms of arrest "Justice" meant penalties and mistreatment for "Just Us". The events of the last years resulting in the deaths of George Floyd, Briana Taylor, Elijah McClain, Michael Brown, Eric Garner and too many others demonstrate that Pryor's characterization of what is meant by Justice is still with us. Hopefully the election of Kamala Harris, together with the presentation by Amanda Gorman demonstrate that a better understanding of what "Justice" should mean is on the way. It is this belief and hope that contributed to the naming of my granddaughter aspirationally named Justice.

Humor, says Merriam-Webster, is "the ability to be funny or to be amused by things that are funny."

We are at our best when we're amused. Few things can better reduce stress or shed light on truth than a good joke.

I can't think of a better time to revisit what some great minds have said about humor's

These words couldn't be more pertinent to the wackiness of 2021, when half the country thinks the other half should be silenced in all public forums.

Groucho's words remind me of something that "Saturday Night Live" founder Lorne Michaels said about poking fun at politicians. He noted that when the show pokes fun at Republicans, they find it funny – they don't take the ribbing as personally as do some with opposite political points of view.

Look, America needs to restore its sense of humor. We need a good belly laugh for our own health and that of our republic.

"We change physiologically when we laugh," reports WebMD. "We stretch muscles throughout our face and body, our pulse and blood pressure go up, and we breathe faster, sending more oxygen to our tissues."

What our country needs is no more complicated than this great thought from a commonsense country singer:

"To succeed in life, you need three things: a wishbone, a backbone and a funny bone." – Reba McEntire

SEARCHING FOR UNITY IN A SEA OF EXCLAMATION POINTS

An email laced with exclamation points is never a good sign. At least not if you're me.

In my world, exclamation points usually follow words such as "idiot!" or "communist!" I take issue with the latter though the former is certainly up for discussion.

Moreover, when the salutation itself is followed by an exclamation point, as it was in a recent email, I know it's trouble. "Mr. Manieri!"

Inside voice. I'm right here.

This particular writer went on to make several assumptions about my intellect, or lack of. He ended with a call to action. "Defend your character!"

For context, the writer was responding to a column I wrote in which I blamed President Trump for lighting the fuse that led to the Capitol riots. He went on to ask how I could do such a thing when it was clear that members of Antifa and Black Lives Matter were bused in and were, in fact, responsible for the insurrection – a claim without any basis in fact.

My response featured a conspicuous absence of exclamation points as I encouraged the writer to keep an eye on his blood

I resisted quoting from Proverbs 15: "Those who are hot-tempered stir up strife, but those who are slow to anger

calm contention."

If you watch much television, or any television, or if you engage in social media, it's pretty clear that we tend to punctuate our discourse with exclamation points. Perhaps Jerry Springer was actually a visionary. He understood the marketability of impoliteness and boorish behavior long before it went mainstream. (By the way, I promise never to use the name "Springer" and the word "visionary" in the same sentence again.)

Civility has fallen out of fashion. Some say it's overrated. How do I know this? I refer you to a Dec. 2019 piece in the Atlantic titled, "Civility is Overrated."

An NPR article in 2019 quotes Lynn Itagaki, an associate professor at the University of Missouri, who said, "Civility has been about making sure that the status quo, the hierarchy of the status quo at the moment, which means racial inequality, gender inequality, class inequality, stays permanent."

By this redefinition of civility, it would be permissible and even encouraged to meet any injustice, perceived or actual, with an uncivil response. That's fine if you happen to agree on the injustice. For example, if your candidate loses a presidential election and you believe the election was rigged, storming the Capitol might be an appropriately uncivil response.

Thus, if you disagree with someone

the point of a civil response? After all, you're right and he's wrong.

Many believe our national discourse fell apart the moment Donald Trump darkened the doorway of the Oval Office. Surely, the former president, with his unhelpful rhetoric, name-calling and incessant tweeting contributed to the problem. But he wasn't alone.

Our elected representatives in Washington – Republicans and Democrats – have been content to play their respective parts in the Monty Python "Argument Clinic"

"Is this the right room for an argument?"

"I told you once."

"No you haven't."

"Yes I have."

"When?"

"Just now."

"No you didn't."

"Yes I did."

The main difference, of course, between the sketch and reality is there's nothing even mildly amusing about the real thing.

For what it's worth, President Biden struck mostly the right tone in his inauguration speech.

"I pledge this to you – I will be a president for all Americans, and I promise you, I will fight as hard for those who did not support me as for those who did," Biden said. He then signed 15 executive orders undoing various Trump policies.

Unity is a fine message but no amount of rhetorical gymnastics will bring people together unless we're willing to understand and listen to those with whom we disagree. That means acknowledging that not all of the 75 million Americans who voted for Donald Trump are racists and that not everyone who voted for Joe Biden is pushing a Marxist agenda.

From the president on down, unless we're truly committed to making unity a reality, it won't happen, no matter how many exclamation points we use.


