# MAN WITH VIOLENT CRIMINAL PAST IN SIERRA MADRE CHARGED WITH SHOOTING CHP OFFICER

Sierra Madre Police Arrested Suspect 3 weeks earlier

Marvin Chang 32, of Monterey Park was arrested last Friday in Tulare County for allegedly shooting a California Highway Patrol Officer. The officer survived the shooting in which Chang was also wounded and survived. Chang is currently being held on a \$4.5

In 2007, Chang, then 18 years of age, was arrested and convicted for the brutal stabbing of an unsuspecting youth in Memorial Park in Sierra Madre. The victim according to testimony at trial, had been lured to the park by local teens and was attacked by outside gang members who came to town for the specific purpose of attacking a specific group of Sierra Madre youth who were involved in a drug dispute. The victim was not a part of the group involved in the disagreement, he was simply at the wrong place at the wrong time.

Chang was one of three 'gang' members who came to town and attacked the young Sierra Madre resident. At Chang's trial covered by this writer, 'Pasadena Police Department Detective William Brougham was brought back to the witness stand to give the court an update on the injuries of the victim. According to Brougham, the victim has sustained "permanent brain damage that causes him to pass out and faint." In addition, said the detective, "the victim's left eye had nerve damage and had to be closed." The teen had multiple stab wounds in his head, back, chest and shoulder.(Mt. Wilson Observer February 16, 2007)

Chang was convicted and sentenced to 7 years in prison.

Approximately 3 weeks ago, Sierra Madre Police responding to a trespassing call near the Stonegate development, found Chang in a locked, gated area. He was arrested without incident because in addition to trespassing, the SMPD found him with a loaded firearm, a box of ammunition, a dagger, a collapsible baton and drugs. he was transported to the Pasadena City Jail and the case was turned over to the District Attorney's office. The charges by SMPD included: Being an ex-felon 1. In possession of a gun; 2. In possession of controlled substance; 3. Carrying a concealed dirk or dagger; and 4. being in possession of possess leaded canes or batons.

Chang was released from custody in Pasadena on \$35,000 bail.



Transaction Will Benefit Future Sierra Madre **Water Treatment Projects**

City Council approved a resolution to pave the way for the transfer and sale of water from Sierra Madre's Cyclic water reserves stored in the main San Gabriel basin to the San Gabriel Valley Municipal Water District (District).

Resolution 21-10 passed unanimously during the regular City Council meeting on Tuesday, February 22 allowing for the transfer of 2,970.74 acre-feet for the sale price of \$2,376,592.

The District is currently unable to meet its groundwater replenishment requirements set by the State Water Project, which is an obligation of 14,500 acre-feet to the Main San Gabriel Basin Water Master, or a 10% allocation. The percentages vary due to the amounts of precipitation received in the mountain areas. The sale and transfer of this water will help the District fulfill its obligation.


Both the District and Sierra Madre benefit from this transfer and sale. The District would be able to sell water on the open market for approximately \$650-800 per acre-foot and tack on an additional \$200 per acre-foot to deliver purchased water. This would allow the District to save between \$150,000 and 740,000. Sierra Madre could apply its profit of \$2,376,592 toward future water treatment projects and water infrastructure deficiencies, according to a presentation given by Jose Reynoso, Director of Utility Services and Director Miles Prince of the San Gabriel Valley Municipal Water District.

Back in 2007, City Council approved the purchase of 4,000 acrefeet of water from the District for \$100 per acre-foot. The 2,970.74 acre-feet of water is what remains in that reserve. Sierra Madre will have the option of purchasing water back from the District for \$200 per acre-foot, when it becomes available.

After posting bail, Chang was a free man who went on to allegedly participate in a firefight that ended with the shooting of a California Highway Patrol Officer. The officer had been on the job less than

#### THE CARDBOARD PROBLEM: PANDEMIC CAUSES INCREASE IN RECYCLABLE WASTE EXPENSE

There have been many non-medically related side effects from the COVID-19 crisis that have caused great concern. The most problematic of course has been the impact on in-school learning along with the quarantine of outdoor activities and closure of businesses. As we struggle to cope with these problems, yet another one has come to light. Namely, what to do with all the cardboard shipping materials that are the result of online shopping?

Yes, too much trash is a real thing. The majority of households today are receiving boxes almost daily with food, supplies and other items that they would ordinarily purchase in person. Now, orders are made online and goods are delivered primarily in cardboard boxes and therein lies

Cardboard is recyclable and for most residents, the discarded boxes can fit into their blue recycle trash bins and often causes overages (the lid won't shut). Therefore, because of the Pandemic, Athens Services, which handles Sierra Madre and most of the surrounding cities, waived the additional charge for single family homes in 2020. Ed Chen, Director of Governmental Affairs for the company says that practice will only continue for single family homes in 2021. Also, to further help residents, Athens has placed a large container in Sierra Vista Park for recyclables and encourages residents to use it.

However, for apartment owners and commercial businesses the excess cardboard poses another, more costly problem. Like single family homes, in 2020, all overage fees were waived. As of January 1, 2021, Athens has returned to their previous billing practice of charging for bins that are 'overflowing'.

"Athens has done our best to absorb the costs of overflow bins the last several years, but we can no longer absorb those costs with disposal costs rising, state laws to comply with, and safety protocol that we must adhere to. Our main goal remains to be right-sizing and providing the proper level of service to meet our customers' waste and recycling needs, and eliminate unsightly overflowing dumpster bins, which causes a safety hazard for our frontline employees, in our effort to continue preserving community cleanliness.", says Chen.

Businesses and apartment owners are struggling with the increased expense without relief. The increases are occurring through no fault of their own. As evidenced by a video sent to the Mountain Views News earlier in the month, unauthorized people are dumping boxes and trash into commercial dumpsters causing the overflow. Last year, in an effort to deter the practice, Athens installed cameras that captured the 'dumpers' in action. It is a criminal offense to discard materials into dumpsters without permission. And yet, the practice continues, dumpsters are overflowing and businesses are charged extra.

Apartment owners have a different problem. Tenants are properly disposing of their delivery materials legally in the container provided, but the overflow is then charged to the building owner. As indicated in Chen's statement earlier, attempts are made to 'right size' the container size to avoid additional charges, however that too is an increased expense. Some have suggested that the overage charges are nothing more than a

price increase, something that is not allowed under the current contract between Athens and the City of Sierra Madre. Chen insists that there is no attempt to implement a price increase or

circumvent the existing contract.

In October 2020, the Governor approved Assembly Bill No. 2345 ("AB 2345"), which revises the Density Bonus Law to increase the maximum density bonus, lower the thresholds to qualify for incentives and concessions, reduce the parking standards, provide new definitions, and impose new reporting requirements. AB 2345 took effect on January 1, 2021.

#### WALKING SIERRA MADRE - The Social Side



"Perseverance is the hard work you do after you get tired of doing the hard work

The Perseverance rover landed on Mars on February 18<sup>th</sup>, just a few days ago. Manufactured by our friends at JPL and launched from Cape Canaveral on July 30<sup>th</sup>, 2020, Percy, as it is fondly referred to, is looking for past Martian environments capable of supporting life, seeking out possible microbial life, collecting rock and soil samples and testing oxygen production from the Martian atmosphere to prepare for future manned missions. Just a little aside: Our youngest daughter, Crissy, was born on July 30th, 1969 – just a few days after Neil Armstrong set the first ever foot on the moon making his famous pronouncement: "That's one small step for man, one giant leap for mankind."

You may already know this, but just in case you didn't, the name "Perseverance" was selected by Associate Administrator of NASA's Science Mission Directorate, Thomas Zurbuchen, following a nationwide K-12 student "name the rover" contest that attracted more than 28,000 proposals. This is the best part...a seventh grader, Alexander Mather, from Lake Braddock Secondary School in Burke, VA, submitted the winning entry. Here's part of what Matthew wrote:

"Curiosity. Insight. Spirit. Opportunity. If you think about it, all these names of past Mars rovers are qualities we possess as humans. We are always curious, and seek opportunity. We have the spirit and insight to explore the Moon, Mars, and beyond. But if rovers are to be the qualities of us as a race, we missed the most important thing. Perseverance. We as humans evolved as creatures who could learn to adapt to any situation, no matter how harsh. We are a species of explorers, and we will meet many setbacks on the way to Mars. However, we can persevere. We, not as a nation but as humans, will not give up. The human race will always persevere into the future." Alexander Mather has to be one extremely bright 13 or 14 year old!

Going to Mars has been a favorite topic of the film industry and, thanks to Wikipedia, I was able to see that there have been about 50 or more movies about going to Mars, being on Mars and various personages that could be encountered on Mars such as: The Wizard of Mars, Santa Claus Conquers the Martians, Princess of Mars, Mars Needs Moms, Robinson Crusoe on Mars, Flash Gordon's Trip to Mars and so many more. We probably haven't seen most (or any) of these, but I have to admit that I'm a big fan of "Flash Gordon," which features Topol, who later starred as Tevya in Fiddler on the Roof, Max von Sydow as Ming the Merciless, Timothy Dalton as Prince somebody or other and later was briefly James Bond and it was produced by Dino De Laurentiis. While we're on the subject of perseverance, The Alamo defense is certainly a study in exactly that. Today in History tells us that...

'On February 24, 1836, in San Antonio, Texas, Colonel William Travis issues a call for help on behalf of the Texan troops defending the Alamo, an old Spanish mission and fortress under siege by the Mexican army.

Though Santa Ana's 5,000 troops heavily outnumbered the several hundred Texans, Travis and his men determined not to give up. On February 24, they answered Santa Ana's call for surrender with a bold shot from the Alamo's cannon. Furious, the Mexican general ordered his forces to launch a siege. Travis immediately recognized his disadvantage and sent out several messages via couriers asking for reinforcements. Addressing one of the pleas to "The People of Texas and All Americans in the World," Travis signed off with the now-famous phrase "Victory or Death."

Only 32 men from the nearby town of Gonzales responded to Travis' call for help, and beginning at 5:30 a.m. on March 6, Mexican forces stormed the Alamo through a gap in the fort's outer wall, killing Travis, Bowie, Davy Crockett and 190 of their men. Despite the loss of the fort, the Texan troops managed to inflict huge losses on their enemy, killing at least 600 of Santa Ana's men." That's perseverance!
"Dare mighty things!" President Theodore Roosevelt... A JPL mantra. It was







#### City Class Action Lawsuit **Dismissed**

Pasadena city officials announced the dismissal of a class action lawsuit that challenged the annual transfer from the power fund to the City's General Fund. A Los Angeles County Superior Court Judge granted Pasadena's motion Wednesday to have the case dismissed.

According to Pasadena Information Officer Lisa Derderian, if the city were unsuccessful in the lawsuit, it faced the loss of approximately \$18 million annually in General Fund monies. The General Fund is the City's primary operating fund, and provides a number of essential services to Pasadena residents and businesses.

The lawsuit was originally filed in 2017, alleging the use of electric rates to fund the transfer to the General Fund violates the California Constitution. Pasadena voters had established and confirmed Charter provisions allowing the General Fund transfer a total of seven times, dating back to 1934.

In March 2020, the city was unsuccessful in obtaining a dismissal of the lawsuit, where the City had argued that Pasadena voters had approved the Charterauthorized transfer a total of seven times. As such, in July 2020, the City Council placed the Charter provisions for the transfer on the ballot for the eighth time. In November 2020, almost 84 percent of Pasadena voters resoundingly approved Measure P, confirming that voters clearly approve of having a portion of their electric rates fund the \$18 million annual transfer to the General Fund.

With Pasadena voter approval of Measure P, and a January 29 published (precedential) appellate decision approving of Sacramento's utility fund transfer, Pasadena sought reconsideration in its case. The court's vesterday decision reverses its March 2020 decision against Pasadena. Rather, the court decision yesterday recognizes that Measure P and the court decision on Sacramento's transfer both require "new and different orders motion for summary judgment." granting [Pasadena's]

"I am pleased that justice prevailed. The transfer continues to be approved by Pasadena residents, and for good reason," Pasadena Mayor Victor Gordo said. "Pasadena has proven that our residents have confidence in receiving high quality essential services, and that residents want to ensure that our General Fund and tax dollars are protected from class action lawsuits."

# **City Begins** Installing Suicide Mitigation Mock-up Panels

The purpose of the commission is to enhance, and strengthen community-police relations, and review and make recommendations regarding the ongoing operations of the Pasadena Police Department to the chief of police, city manager, and/or City Council.

The CPOC will be composed of 11 members, with each City Council member nominating one (for a total of eight), and three members nominated community-based organizations. No later than 90 days after appointment to the commission, commissioners must participate in a ride-along with the Pasadena Police Department, and receive 30 hours of training in relevant subject matter areas. 

# SUPERVISOR BARGER RESTORES FUNDING TO PARKS AND RECREATION TO INCREASE ACCESS TO FACILITIES AND PROGRAMS FOR LOCAL COMMUNITIES

LOS ANGELES COUNTY —Through a motion by Supervisor Kathryn Barger that aims to invest services and programs in Los Angeles County communities, the Board of Supervisors approved the budget restoration of the Department of Parks and Recreation.

"After a year of decreased social and physical activity for families across Los Angeles County, our renewed focus on programs, staff, and services at local parks and nature centers provides an opportunity to rejuvenate our residents," Supervisor Barger said. "Parks programs are a fundamental part of wellness for our neighborhoods and provide opportunities to play, grow, and create lasting memories."

The cost of restoring recreation programming is \$2,120,000 in fiscal year 2020-2021 and \$8,586,000 of ongoing cost. The motion, coauthored by Chair Hilda L. Solis, approved funding for hiring, training, and staffing hours previously cut back because of the pandemic, which will enable the department to provide safe opportunities and places for youth to play, including sports clinics and access to nature and open space.

Additionally, the motion allows the department to restore aquatics programming, including swimming lessons, recreational swim, pool access, lakes, and therapy and wellness. The cost of restoring swimming days at Santa Fe Dam and Castaic Lake Recreation Area is \$243,000 in fiscal year 2020-2021 and \$580,000 in ongoing costs. The budget will resume community pool operations in Arcadia, Granada Hills, Altadena, Littlerock, Quartz Hill, and Castaic.

"The pandemic has proven that parks are an important place for our vulnerable residents to seek refuge, rest, and recreation," Barger said. "In many of our neediest areas, Parks and Recreation is the sole provider of affordable and accessible youth recreation and after school programs."

The motion enables the Parks Department, CEO, and other partner departments to identify and allocate funding for the Parks After Dark program, which is particularly important given the increase in crime and mental health stresses presented over the last year. This program was hosted at 33 parks before the pandemic and cost \$6,832,000.

Low income families and communities are most impacted by the pandemic and are also those who most benefit from the Department of Parks and Recreation's services and activities. Restoring recreation programs addresses the devastating impact of COVID-19 and provides much-needed healing and community connection. Physical and mental health benefits through social connection provide a lifeline to youth who need support.

Because of the public health crisis, Parks and Recreation was required to cut eight percent of its costs last fiscal year, which was a \$12.9 million reduction in Net County Cost funding, plus an extra \$9.9 million because of revenue shortfalls. This led to a massive cut in staff, as the department significantly reduced its recurrent and temporary staff by 857 employees, recreation services staff were cut by 43 percent, lake lifeguards were reduced by nine positions, and pool lifeguard positions were completely eliminated.

"Restoring the Department of Parks and Recreation's budget also allows hundreds of hard-working, passionate staff to return to work," Barger said


#### ARCADIA AUTHOR C.V. DREESMAN PENS THIRD NOVEL



Next week on Monday, March 1, three additional sectors become eligible to receive vaccinations: education and childcare workers, food and agriculture workers, and emergency services and law enforcement workers. The County expects to receive 269,000 doses to be distributed next week, of these, 103,000 will be provided for first doses. Those who fall under the newly eligible sectors will be able to get vaccinated at many sites across the County. Workers will be required to show proof of their identity with a photo ID and proof that they reside or work in L.A. County. Partnerships have been established to facilitate the vaccination process throughout the County.

The FDA has recommended Emergency Use Authorization for the Johnson & Johnson vaccine. This vaccine requires a single dose. Johnson & Johnson vaccine trial data indicate that the vaccine is very effective in preventing moderate to severe COVID-19 disease and 100% effective in preventing hospitalizations and deaths. With the potential influx of supply, this vaccine could greatly accelerate progress in our vaccination efforts.







#### A SOCIAL SECURITY PERK FOR OLDER PARENTS

Dear Savvy Senior: I've been told that my two children, ages 14 and 16, may be eligible for Social Security when I file for my retirement benefits. Is this true? What can you tell me? Viagra Daddy



It's true. If you're age 62 or older and are still raising young children, there's a Social Security benefit strategy that can put some extra money in your family coffers.

Here's how it works. When you file for Social Security retirement benefits, your minor children can get money on your work record equaling half of what you would receive at full retirement age, now gradually rising from 66 to 67. Even if you were to take a smaller benefit by claiming earlier, your kids will still get half of your full-retirement age amount.

To qualify, your daughter – whether she's biological, adopted or a stepdaughter – must be unmarried and under age 18. Kids that are over 18 but still in high school, can collect too until they graduate or turn 19, whichever comes first. (Other rules apply to kids that are disabled.)

But that's not all.

Because one of your children is only 14, your wife (if you're married) can collect Social Security benefits on your work record too, and it doesn't matter if she's just 40 years old. The minimum age requirements to collect retirement benefits (62) or survivor benefits (60) does not apply when it comes to collecting benefits as the caregiver of a young child. The spouse's benefit, which is also worth up to half of your benefit, will stop when your daughter turns 16.

But note that there are limits to the amount of money that can be paid to a family. The Social Security "family maximum payment" is determined by a complex formula and can range from 150 to 180 percent of your full retirement benefit amount. If the total exceeds that, each person's benefit, except yours, is cut proportionately until it equals the maximum.

Here's an example of how that's figured. Let's say, for example, that your full retirement age benefit is \$2,400 per month. That would make your family maximum benefit (according to the Social Security formula at SSA.gov/oact/cola/familymax.html) roughly \$4,200 per month.

Subtract your \$2,400 benefit from the \$4,200 family maximum benefit, which leaves \$1,800. That's the monthly amount that can be split between your two children – \$900 each. If your wife wants in on it too, the individual checks are smaller, at \$600 a piece, but the family amount is the same.

You should also know that minor children can collect up to half of a disabled parent's Social Security disability benefit. And if the parent dies, they will get a survivor's benefit, which is up to 75 percent of the deceased parent's basic Social Security benefit.

Social Security benefits for your kids may not be available before full retirement age if you are still working. In 2021, you will lose \$1 in benefits for every \$2 earned over \$18,960, except in the year you reach full retirement age. In that case, the earnings limit is \$50,520, with \$1 in benefits withheld for every \$3 earned over the limit.

If you lose your benefits, your dependents also lose theirs. You can recoup those payments later, but your kids can't.

#### IMPORTANT ESTATE PLANNING LESSONS FROM LARRY KING'S DEATH—PART 1

host, Larry King, died on January 23rd, 2021 at age 87. With a career spanning more than half the most famous interviewer of his generation.

With his success in the media and the fact he continued working long after most people would have retired, Larry amassed a fortune estimated to be worth some \$50 million. In addition to Larry's fame as a broadcaster, he also became equally well known for his numerous marriages. Starting at age 19, the media mogul got married a total of eight times to seven different women (one of them, he married twice).

Larry also had five children, nine grandchildren and four great-grandchildren. With so much money, so many spouses, and so many lineal descendants, it was practically guaranteed there would be some conflict over Larry's estate following his death.

However, three factors are sure to make settling his estate especially troublesome.

First, Larry was in the middle of negotiating a divorce settlement with his seventh wife, Shawn Southwick King, when he passed away. Second, in October 2019, Larry created a new handwritten will, which stipulated that \$2 million of his estate should be equally divided among his five children upon his death, yet the document makes no mention of his seventh wife.

And finally, two of the five children—Andy and Chaia —named in Larry's new will died within weeks of one another in August 2020, yet it seems Larry failed to amend his handwritten will to reflect their deaths.

Given Larry's immense wealth and the fact that his seventh wife claims they worked with estate planning lawyers in the past it's likely that he had other estate planning vehicles, such as trusts, in place to protect and pass on some of his assets. But since trusts are private and their contents generally aren't made available to the public, we don't know the full details of Larry's estate

That said, in light of his impending divorce, the existence of the new handwritten will, and the recent death of two of Larry's children, it's almost certain that there will be a major court fight between Larry's seventh wife and his surviving children over the \$2 million in assets listed in the new will. In fact, Shawn has already announced that she plans to contest the handwritten will.

Lesson #1: Update your estate plan as soon as divorce

Although Larry attempted to do the right thing by creating the new will, he should have taken the time to work with legal counsel to properly update his plan once he knew he was getting divorced—and ideally before the divorce was filed.

It's important to keep in mind that some states (including California) have community-property laws that entitle your surviving spouse to a certain percentage

So, if you die before the divorce is final, as Larry did, you probably won't be able to entirely disinherit your surviving spouse in your will or trust. But you can amend your plan to ensure the a century, Larry became | proper individuals inherit the remaining percentage of your estate should you pass away while your divorce is still ongoing.

> Had Larry worked with his estate planning lawyer to draft his new will, rather than writing his own by hand, he could have created a much more robust will that not only would have stipulated exactly how he wanted his share of the marital assets divided among his children upon his death, but he also could have prevented a number of conflicts inherent with do-it-yourself

> Lesson #2: Work with an experienced estate planning lawyer when creating or updating your planning documents, especially if you have a blended family.

> While it's always a good idea to have a lawyer help you create your planning documents, this is exponentially true when you have a blended family like Larry's. If you are in a second (or more) marriage, with children from a prior marriage, there's an inherent risk of dispute because your children and spouse often have conflicting

> By creating your own will, even with the help of an online document service, you won't be able to consider and plan ahead to avoid all the potential legal and family conflicts that could arise. For example, had Larry enlisted the help of an experienced estate planning law-yer to create his new will, he could have built in provisions that would have made it unlikely that Shawn—or anyone else—would contest his will.

> It remains to be seen whether or not Shawn will be able to successfully contest the validity of Larry's new will. However, because the new will was created in such an informal manner, her case will be a lot stronger than it would've been had Larry worked with lawyers to formally create a new document. And even if Shawn isn't successful in contesting Larry's new will, the resulting litigation will be a lengthy, costly, and needless ordeal that will deplete Larry's estate at the expense of all of

> Finally, had Larry consulted with an attorney when seeking to amend his plan to account for his impending divorce, he would have been advised that a will is not the ideal planning vehicle for protecting and passing on his assets to his children. Instead, Larry could have used a trust for this purpose. And while there are several types of trusts available, we would have advised Larry to create a special type of trust known as a Lifetime Asset Protection Trust.

Using a Lifetime Asset Protection Trust, Larry could have not only immediately transferred his share of the marital assets to his children upon his death or incapacity, without the need for court intervention, but he could have also ensured that those assets would transfer with airtight protection from common life events like divorce, serious illness, lawsuits, and even bankruptcy. Best of all, this asset protection would last for the lifetime of his designated beneficiaries.

She just stared at me, "What do you mean?" "Are you sure you did not give them the left piece of your mind?"


She finally smiled and then said, "No, I'm saving that piece for you."

# "SPROUTS ARE GOOD FOR YOU!" An Exploration of Entirely Safe Botanical Families

I was visiting a friend's place, and a few others were there for lunch. The friend – let's just call him John -- had been learning about edible wild plants.

He explained to the half-dozen guests that their lunch would be embellished with some of the wild spring edibles growing on the open area surrounding his place. Wonderful, I thou ght. Since I had visited the place before, I already knew most of the wild edibles that grew there, plants like chickweed, London rocket, mallow, purslane, lamb's quarter, nopales, sow thistle, New Zealand spinach, and many others.

He served some highly aromatic soup. It was a miso base with some dried seaweed and thin slices of mallow added. It was delicious. There were a few other dishes that he brought out, and then he served each of us a salad. I froze, and stared into my salad.

"What's that?" I asked John, with a bit of alarm in my voice. I already knew what it was, but I wanted to hear John's response.

"Sprouts!" he responded gleefully.

"Yes," I responded blandly. "But, what is it?"

 $\hbox{``I said, those are sprouts. Sprouts in the salad. Everyone knows sprouts are good for you," he gushed.$ 

"Ah," I said slowly, picking a few of the "sprouts" out of the salad bowl, and then setting the salad bowl beyond my reach.

"Yes," I again replied. "Sprouts. But sprouts of what? Every plant produces seed, and the seeds of any plant can produce a sprout."

John looked more closely. "Well," he finally responded, trying to remain upbeat, "sprouts are good for you."

He was very enthusiastic, and I hated to be the bearer of bad news. "Those are not just any sprouts," I said, as others put down their salad bowls. Those are the sprouts of the castor bean plants. Yeah, they look awesome, but I thought when I saw them in my dish that I had done something to you and you were trying to get even by killing me."

John was silent, and picked up a castor sprout to examine. Clearly, I was the damper on what

was intended as an enthusiastic and fun lunch. Everyone began eating more slowly, and ignored the salad. At least one person present carefully picked every castor sprout out of his salad.

"Sprouts are not a generic group like grosses or secured or accura." I explained to John

"Sprouts are not a generic group, like grasses, or seaweeds, or acorns," I explained to John while everyone listened. I don't think he got my point at first. I had to pretend to enjoy the rest of my lunch, while attempting to provide a quick botany lesson that would save everyone's life.

Certain botanical families are nearly entirely edible, often with a few considerations. This includes groups like grasses, seaweeds, mustards, acorns, onions, and many others. But every plant, poisonous or edible, that produces seeds can produce sprouts. The sprout is nothing more than the young seed, sprouting forth to produce a new plant. The fact that many edible seeds produce highly nutritious sprouts does not mean that ALL seeds from ALL plants will have edible sprouts. Without sounding like I was talking down to John – who after all was trying to impress me with how much he knew about wild edible – I explained that all flowering plants have roots, and many are edible, but some roots will kill you. Just because you find a root doesn't mean you can eat it. And all plants have leaves, what we call greens. Just because you found some pretty looking greens does not guarantee that you can eat them.

I think he got the point. Enthusiasm can kill you, or can kill your lunch guests.

Never eat any wild plant unless you have positively identified it as an edible plant, or belonging to an edible plant family.

NO, YOU CANNOT EAT ANY RANDOM SPROUT YOU FIND! Just like with the mature plant, you must identify the plant as an edible species. IF you cannot identify the plant because it is a baby, then DO NOT EAT IT!

In my very first book, "Guide to Wild Foods," my mentor Dr. Leonid Enari worked me with to list many of the botanical families that are entirely safe to eat. I have since organized all my books by botanical family to provide a moment to describe the family to which the plants have been classified. 



So no big deal, right? The bankrupt casino owner who vaulted into politics by relentlessly tweeting the lie that Barack Obama was a fake American – who reigned by sliming anyone who criticized him and retweeting crackpot calls to violence - got a pass every time because his soulless enablers covered their eyes.

#### OUT IN THE COLD: THERE BUT FOR THE GRACE OF GOD

But by the grace of God I am what I am, and his grace toward me was not in vain. On the contrary, I worked harder than any of them, though it was not I, but the grace of God that is with me.

- 1 Corinthians 15:10

He couldn't have been more than a kid, early twenties maybe, though he looked older. Life outdoors tends to age a person prematurely. He was homeless, addicted, alone.

I'll call him "Daniel" and I met him at a homeless shelter where I was vol-unteering with my wife the other night. More accurately, Denise is the ac-tive volunteer, serving on boards, giving out scarves and blankets, getting to know the residents. Mostly, I tag along for support.

On this particular night, temperatures were in the teens and a steady snowfall covered the streets and sidewalks in front of the church where we waited

Denise recognized Daniel from another shelter where she volunteers. She asked him how he was doing, what he was up to, showed him where he could sleep for the night and where to get some food in the kitchen.

For the four hours we were there, from 8 p.m. to midnight, Daniel left and returned a few times. At one point, he produced a drawing pad on which he had made a few sketches. He showed them to Denise and she made a fuss, as you would when one of your kids presents you with a few doodles.

A little later, Daniel asked us what the temperature was supposed to be tomorrow. It took a minute but it dawned on me that he wasn't asking us about the weather in an effort to make small talk. He wanted to see if it was going to be warm enough to

As we spoke to him, I couldn't help but wonder. How did he get here? What led a young and seemingly healthy young man to an aimless exist-ence on the streets? Certainly, addiction is part of the answer but only part. What happened in his past? Was he ever nurtured or encouraged by anyone? Then, after the questions, came the

realization that there are so many others, like Daniel, living life day-to-day; outdoors and forgotten.

It is true that a few homeless people are homeless by choice. Though able to work or even get back on their feet in a shelter, they choose homelessness instead of structure and rule-following. Denise will tell you that some of the men with whom she worked at the shelter simply walked away on

rather than follow the house rules. Others were kicked out.

I had another thought as I spoke to Daniel. Could I have been him? With a slight alteration of circumstances, could I have wound up in the same situation due to job loss, financial ruin or illness?

Oh, we say, "Not me. Don't be ridiculous. Those people are sick. They have problems. They can't be helped and they don't know how to help themselves." Exactly.

There was a time when it was easy for me to disregard young men like Daniel. After all, in Philadelphia, there were hundreds of them. It was easy to walk by, not make eye contact, even

"Better him than me," as if I were somehow impervious to personal catas-trophe.

We're all fragile, vulnerable, mortal. Ask the people of Texas where a winter storm has turned life upside down. While politicians bicker about why it's so cold and whose fault it is, millions of residents are freezing, without power or drinking water. Warming shelters have opened throughout to state. People who were warm and secure suddenly found themselves hun-

gry, cold and in need of help. According to the National Alliance to End Homelessness, there are an es-timated 553,742 people in the U.S. experiencing homelessness on a given night. In the Kentucky county where

public school students were identified as homeless in 2019.

This is not a call to action to volunteer or donate to your local homeless shelter, though you may feel led to do that. Rather – and I'm speaking to myself as much as anyone – it's a call to compassion and empathy.

The truth is there's less daylight between Daniel and me than I was ever willing to admit.

#### A LESSON WE COULD USE TODAY

Last week, I wrote an article on the remarkable life of my good friend, George Maurer. Although I recognized that he was approaching 100 years of age, I really was stunned and saddened when I learned of his passing.

As has been said, George was a man of many passions and good be both charming and as tough as a brick wall. Early last year, I went to visit with him for lunch with our mutual good friend Bud Switzer. During lunch, we all had a hearty laugh at just how George and I became good friends. I thought I would share it now because given the current climate of vitriol and hostility towards those who are on opposite ends of the 'values' spectrum,

this might be a teachable experience.

So, back in 2006 George Maurer was Mayor of Sierra Madre. I was a columnist for The Sierra Madre Weekly and Sierra Madre resident. As was often the case, Sierra Madreans were at odds with each other over a proposed downtown development. George and I were on opposite sides of the controversy, each very passionate about their position. In April when the council reorganization took place, the outgoing council members left the chambers along with their supporters and had their celebration across the street in the social hall at the Congregational Church, upset over the election results.

I wrote an article about the incident in The Sierra Madre Weekly critical of the walkout, especially of the Mayor who had done so much for the city. From that point on, George was so upset he would cross the street or leave the room if he saw me coming. He wasn't alone in his disdain for my presence, but to me how he felt was important. Oh well, I was a big girl and if he didn't like me that so what I said, and that road ran two ways for the next year.

However, we both had a common friend in our lives, Dr. Paul Neiby. To put it mildly, he was known as 'The Lion of Sierra Madre', a big guy who was plain spoken and stubborn. A birdie once told me that

he actually liked the paper (Then the Mountain Views Observer) and I was surprised. Neiby was very committed to the city. He was very instrumental in the publishing of, "Southern California Story: Seeking The Better Life In Sierra Madre". (If you don't have a copy, go to the Historical Society's website and purchase one today: <a href="https://www.smhps.org">www.smhps.org</a>). Anyway, Neiby found himself smack in the middle of what appeared to be a very serious standoff by two of his best friends. George would not be in the same room that I was in, and I wasn't throwing myself into an environment of 'haters'. What did Neiby do....well this is where the story begins.

One day Neiby called and invited me over to talk. He had also invited George over. Neither George nor I was aware of the other's invitation. When I arrived his wife Louise let me know that he was out by the pool. So I go through the door and see two people at the table. Paul Neiby and George Maurer! Before I could open my mouth Neiby said, "Sit down. You two need to learn to get along and you are not leaving here until you do". With that he left and went inside the house.

George and I sat quietly for a few minutes without speaking. Finally one of us started talking about how stubborn Paul could be and eventually the conversation lead to us learning that both of us were from the east coast. I from Philadelphia and George from the New Jersey/Phillie area. We found that we both missed our east coast foods, TastyKakes, real Cheesesteaks and Hoagies, etc.

The more we talked, the more we learned we had in common. I had not known that George had been involved in the publication of numerous newspapers. He was a professional Linotyper. We talked about the transition of the industry via technology. We talked about everything under the sun including Sierra Madre and the clashing of our views.

When Paul finally crashed in on our conversation at least an hour later, we had torn down all the preconceived notions of one another and developed a deep regard and respect for each other. No, we didn't suddenly prescribe to each other's political views, but we embraced our differences. We respected each other and over the next 10 or so years had a wonderful relationship.

I last saw George on his 98th birthday and we still had that same admiration and respect for each other, something that would have never happened if we had never taken the time to get to know one another.

And that is the lesson we all can learn. Take the time to know each other. We are not as different as you may think. After all, we are all in this thing called life, together!

As indicated in the beginning, the Mountain Views News has survived primarily on the paper's ability to publish legal notices and the support of our advertisers many of whom are also impacted by the COVID19 virus. However, that has all changed. We were informed mid-March that the County of Los Angeles closed all public access to buildings that process legal notices. Such action, while absolutely necessary means that the income generated from the publication of the Fictitious Business Notices came to an abrupt halt and that has not changed. Without the ability to publish those legal notices, continued publication of the Mountain Views News remains in jeopardy.

With your help, however, we can continue to sustain the only paper where your community news comes first while we work on alternatives to the current legal notice processing is found or LA County Buildings allow public




