NEW COUNCIL VOTES ON POTENTIAL SITES FOR HOUSING ELEMENT

Every eight years, Sierra Madre goes through the arduous task of updating the Housing Element of the General Plan as required by California State law. The latest update is due to the state by October 15, 2021 for approval.

The Housing Element is an analysis of housing needs, taking into consideration all income levels and provides strategies for meeting those needs. It is a vital part of a City's General Plan. The current period is from 2021-2029. The Housing Element is comprised of five major components.

- A review of the current Housing Element
- Assessment of current housing needs
- Identification of resources (land, financial and administrative)
- Evaluation of constraints to housing
- Housing Plan: Goals, Policy and Programs.

Housing prices have skyrocketed to the point where professionals such as teachers, nurses, and public safety officers cannot afford to own a home in Sierra Madre. Fewer professionals in these areas impacts the economy so each region must do their "fair share" to accommodate those needs.

On several occasions in 2020, City Staff and Karen Warner, the City's housing element consult-ant, have presented City Council with an overview of the Housing Element process and Regional Housing Needs Assessment (RHNA) site requirements. They also outlined consequences of non-compliance.

City Staff identified seven potential sites that consist of a combination of Multi-Family Residential sites and sites that fall in the Measure V boundary which are subject to voter approval. Measure V was put in place to preserve Sierra Madre's small-town character.

Potentially suitable, multi-family sites being considered includes:

- Site 1. Mariposa parking lots
- Site 2. Nine properties at 200 block W. Mariposa Site 3. Five properties on W. Mariposa Post Office parcels
- Site 4. Nine properties on Suffolk Ave.
- Site 5. Seven properties on East Montecito Site 6. One property at 491 W Sierra Madre.
- Site 7. One property at 215 N Baldwin Ave.

Other potential sites include Church parking lot sites around Sierra Madre. These options would require a vote to be eligible.

Though the Housing Element provides recommendations on potential housing site, it does not require that the units be built, provide funding for the sites or authorize any construction on any sites.

The Southern California Association of Governments (SCAG) regions have been tasked with providing 1.34 million housing units across California during this period. This is the highest the RHNA has ever been. SCAG has determined Sierra Madre could produce 204 housing units broken down to the following income levels.

Very Low Income [<50% Area Median Income for LA County (AMI)]	79

Moderate Income (80-120% AMI)	35
Above Moderate (>120% AMI)	51

This is a RHNA increase of 270% for Sierra Madre, but still much less than most neighboring communities.

During the February 23, 2021 meeting, City Council were given two options to vote on for the update of the Housing Element. Option A, which was the previous Council's recommendation, would push for Sites 1-7, some falling within Measure V boundaries requiring a vote by the people. A 4-1 vote passed to accept Option B, the recommendation of the Planning Commis-sion which would designate non-Measure V site options 2,4,6 and 7 for R3-H 20 du/acre and R3-H 30 du/ acre and add an affordable housing overlay zone on parking areas on congregational land.

These sites include portions of the parking lots of St. Rita's, United Methodist Church, Old North Church and Bethany Church. Mayor Pro Tem, Gene Goss voted nay, expressing his desire to let the people vote. Goss also disapproved of the congregational site options. Once the updat-ed Housing Element goes to the state, the approval process could take up to 60 days.

Back in December 2020, the City hosted a Community Workshop webinar on the Housing Ele-ment for the public where participants could learn more about the process, site options and pro-vide feedback. The full Housing Element Report is available to view on the city website at cityofsierramadre.com.

BEE SAFE!



Kersting Court Besieged With Angry Bees Over The Weekend Photo Courtesy Cheryl Regali

The weather in Sierra Madre was wonderful last weekend and businesses had a healthy measure of customers until...the Bees Came!

According to eyewitness accounts, people began being attacked by bees that were in a Pepper Tree in Kersting Court. First reports came were mentioned on social media on Thursday but the agressiveness of the bees escalated to the point that the Sierra Madre Police were called. The city's Public Works Department immediately cordoned off the area and contacted the appropriate pest control company, however, before they arrived Sierra Madre resident and local Bee enthusiast, Brian Abernathy (pictured above), donned his protective clothing, located the hive and eliminated the problem.

"Those were the meanest bees I have ever seen", said Abernathy. "They were attacking me in the courtyard on the outside of the tape". The bees also attacked several people in Kersting Court causing the closure of severral businesses such as Lucky Baldwin's and Leonora Moss. According to the SMFD who dispatched paramedics to the scene, no one was taken to the hospital, however several people were stung multiple times.

According to Abernathy, the warm weather brought the bees out of the hives, something people will have to contend with. He noted that these particular bees were not of the 'endangered species'.

Los Angeles County on its' website reminds everyone, " Bees may be found almost everywhere in our environment busy foraging for food. They feed on nectar for energy and pollen to feed their young. There are thousands of bee species in North America and about 1500 of them are found in California." Like other forms of life, we have to learn to co exist with them.

Thomas Arnold, MD, Professor and Chairman, Department of Emergency Medicine, LSU Health Sciences Center says," It seems every family has their own secret remedy. From meat tenderizer or tobacco juice to vinegar or baking soda, there's no shortage of "cures" out there and people who swear by them.

In reality, these home remedies have no real scientific or medical basis. While most aren't necessarily dangerous, they also aren't particularly effective. Taking the right steps can minimize the typical pain, redness, swelling, and itching that most people suffer after a sting. For most people, a sting won't cause more than pain, swelling, and redness right around the sting—what's known as a local reaction. However, a small percentage of people are allergic to insect stings and suffer a much more severe and dangerous reaction. Stings in these people may cause anaphylaxis and can be fatal.

Next time you or a child receives a nasty sting, look for signs of a generalized allergic reaction.

Signs of a generalized allergic reaction (Symptoms usually develop

very quickly and may include)
A feeling of uneasiness, tingling sensations, and dizziness.

Generalized itching and hives

Swelling of the lips and tongue Wheezing and difficulty breathing Collapse and loss of consciousness

Anyone who has any of these symptoms should go to the emergency department immediately.





Do you remember when you first discovered Sierra Madre? And what made you want to move here and raise a family? Everyone has a story of how they wanted to live in this unique 'Village of The Foothills" in the middle of the surrounding metropolis.

Whatever you liked about Sierra Madre, you may not have recognized that community members have come together over the years to preserve our special way of life.

In 1978, Margaret Buckner started the 'Homeowner & Residents Association' in response to community concerns over developers failing to follow established building codes. In 1987, the community came together again when variances were being granted that circumvented building codes.

In 2001, Margie Simpson, as Coordinator for the "Residents For The Preservation of Sierra Madre" published an eight page mailer giving voice to more than 30 families who spoke out against plans to build a high school complex in the hills above Baldwin Avenue.

In 2014, the "Stop the Monastery Housing Project" was formed to respond to the Monastery's plans to sell part of their land to a residential developer.

The group called 'Preserve Sierra Madre' was formed from the 'Stop the Monastery Housing Project' coalition when the water moratorium was imposed and it became important to monitor other projects in the city as well. When the water moratorium was lifted in February, 2020, the planning for the Monastery development began again in earnest. Many hours have been spent attending meetings and following the progress of the plans with the developer -New Urban West, the Monastery and the City of Sierra Madre.

In August, 2020, the City Council approved a Memorandum of Understanding (MOU) with the Mater Dolorosa Community for the building of 'up to 42 single-family detached residential units...' The Project will require the City Council to adopt a Specific Plan, amend the General Plan and Land Use Map, and amend the Zoning Code and Zoning Map.

Dealing with the pandemic this last year has made it very difficult for the community to understand what is going on with the MOU.

'Preserve Sierra Madre' has a web page and newsletter to provide residents with useful information on the development. For further assistance, the City Manager, Gabe Engeland, has agreed to answer questions from the community that will be published on line or in the Mountain Views News.

PASADENA'S PLANNING DIRECTOR TO ADDRESS CLIMATE ACTION PLAN

Pasadena, CA- On March 18 at 7pm, the League of Women Voters Pasadena Area will host David Women Voters at the national, state and local Reyes, Pasadena's Director of Planning, for an interactive on-line discussion of "How to Put the Action in Pasadena's Climate Action Plan."

Joining Reyes will be Dean Kubani, a sustainability expert and Chair of Santa Monica's Sustainability Task Force. The speaker presentations will be followed by a moderated public question and answer discussion.

Cities throughout California have adopted Climate Action Plans (CAPs). CAPs use modeling techniques to attempt to measure local greenhouse gas (GHG) emissions and identify strategies" and "actions" to reduce these GHG emissions. Specific actions are identified to target emissions from fossil fuel energy use in commercial, residential and municipal buildings and transportation, because these account for most GHG emissions. CAPs also address waste treatment, water management and urban greening.

Martha Zavala, president of the League of Women Voters - Pasadena Area, stated: "The climate

The voters want to know more on this critical subject, and we are committed to providing objective, up to date and useful information."

Pasadena's CAP was adopted in 2018 and a progress report was issued that same year. The City is currently assessing how to measure progress in GHG monitoring and implementation of actions. In addition to puzzles, we usually bake something and take some of that over to our neighbors, too. Like this Cinnamon Coffee Cake which is easy and fast to assemble, will make your house smell fabulous and it's delicious...trust me!

Cinnamon Coffee Cake

1/4 cup butter 3/4 cup sugar

2 eggs beaten

2 cups flour

3/4 tsp. salt

1 TB. baking powder

1-1/2 tsp. cinnamon (generous)

1 cup milk (nonfat works fine, or you can use orange juice if you're out of milk).

Cream butter and sugar together, add eggs, beat till light and fluffy. Mix together flour, salt, baking powder and cinnamon. Add alternately with butter-sugar mixture and milk. Pour into greased 9" baking pan. Sprinkle with topping mixture.

Topping:

1/1-2 tsp. cinnamon (generous)

1/2 cup sugar 2 TB melted butter

Bake at 350 degrees for 45 minutes. The topping melts down into the coffee cake creating deliciously cinnamon-y valleys amongst the cake. You can double and triple this recipe if you plan on making enough for all your neighbors.

City Asks to Dismiss Lawsuit by **Tournament**

Attorneys for the City of Pasadena filed motions Tuesday in United States District Court to dismiss all claims against the city as alleged in the Pasadena Tournament of Roses' lawsuit.

'The city's motions clearly demonstrate why the Tournament of Roses should have never taken this matter to court," city officials said.

According to the city attorney's office, "the motions make clear that case is not—and has never been-about trademark rights." The and Tournament have a long-standing Master License Agreement wherein each party recognizes the trademark rights of the other. The Tournament's lawsuit is about money and the desire of the Tournament to have flexibility to move the Rose Bowl Game out of its long-time home in Pasadena. The agreement between the city and the Tournament prohibits the Tournament from selling its rights to the Rose Bowl Game to the highest bidder, and then moving the Rose Bowl Game out of Pasadena. The facts of this year's Rose Bowl Game lay bare the Tournament's sole pursuit of dollars and nothing more, they said.

The Tournament insists that this litigation "is not about moving the Rose Bowl Game out of Pasadena" in the future, yet the legal complaint demonstrates just the opposite. The Tournament wants a court of law to assure it that it can move the Rose Bowl Game. It is an attempt by the Tournament to ask the court to allow it to redraft the Master License Agreement for future hypothetical events that might never happen. The fact is, the current agreement between the parties does not allow the Rose Bowl Game to be played anywhere but in Pasadena for any reason, unless the city consents, like it did this year as a good-faith partner during extraordinary times.

The Tournament's lawsuit attempts to deny the mayor's and the city's First Amendment rights to speak to the press and the mayor's constituents on a matter of fundamental public interest when it claims the mayor's comment that "The comment that football game belongs to the City of Pasadena and the people of Pasadena" is somehow an infringement of a trademark. It is a baseless and reckless claim to make, seeking to chill the city's speech on a matter of public interest, they said.

"The city and Tournament have a parade and a game to host on New Year's Day 2022, which will hopefully symbolize a return to normal," they said.

HELP FOR ANYONE FACING **HOMELESSNESS**

Times are difficult. Some of our neighbors are very well facing the unprecedented pressures of this pandemic on everything from mental health to financial burden to housing insecurity. The City of Duarte offers resources to assist those vulnerable to homelessness.

"Homelessness has been a longstanding issue in Los Angeles County, but the COVID-19 pandemic has further strained individuals financially to the point that fundamental needs are not being met," said Brian Villalobos. "We encourage any resident who is facing homelessness or who knows a neighbor with housing struggles to reach

Here in the City of Duarte Public Safety Outreach Coordinator Tony Hadloc works to improve public health with regional partners. Hadloc conducts direct street-level outreach to the unhoused to connect them to services, distribute hygiene kits with hand sanitizer and clean socks among many other items, and even transports individuals to safe space if requested. Through a grant from the San Gabriel Valley Council of Governments, the City of Duarte also has an assigned housing navigator and case worker through Union Station Homeless Services (USHS). Hadloc will refer clients to USHS that wish to enter the Los Angeles Coordinated Entry System to receive full case management including bridge housing, permanent housing and employment opportunities. Duarte's assigned housing navigator, Lisa Montano, works Monday through Thursday and every other Friday, holding office hours at Duarte Park, Tuesday and Wednesday from 11 AM to 3:30 PM, and is on-call as needed.

The City of Duarte also partners closely with Foothill Unity Center (790 West Chestnut Ave., Monrovia, CA). Foothill Unity Center provides clothing, food, school supplies, support and crisis services, health service programs, and other special programs to the Foothill community. Starting in summer 2020, Foothill Unity was a subgrant recipient through the City of Duarte to provide hygiene services for the unhoused. This funding from the City of Duarte has allowed Foothill Unity Center to secure mobile restrooms and a handwashing station - services that became even more important during the pandemic as public restrooms were shut down. Foothill Unity Center recently acquired separate grant funding to also offer mobile showers. Visit the Foothill Unity Center website or call their office at (626) 258-3486 for support.

Additionally, Hadloc conducts intake for the City's homeless prevention and diversion program. The City has a number of resources available to community members who are either currently unhoused or at risk of becoming homeless due to any number of reasons, including but not limited to unpaid rent, overdue utility bills, family or roommate dispute, auto repair preventing access to work, lack of rental deposit, or inability to pay moving costs. Any other barrier that may lead to homelessness can be

The Rialto Revealed: A **Landmark Restoration**

The South Pasadena Public Library is set to host an illustrated virtual talk on the exterior renovation of the Rialto Theatre, featuring founder of the Friends of the Rialto, Escott O. Norton. Norton, a lifelong preservationist, was an advisor to the restoration work carried out by theater owner the Shomof Group and will share his vast knowledge of the theater's history along



with stories and photos from the effort to restore it to its former glory. The Rialto Revealed will be presented on the Crowdcast platform at: crowdcast.io/e/rialto. The event, March 10 at 7:00 p.m. is free and open to the public, but an internet connected device is required.

Constructed in 1925, the Rialto Theatre is an iconic landmark in South Pasadena and one of the few remaining single-screen theaters in Southern California that reflect the majesty of the golden age of cinema. The Rialto has not been an active theater since 2007, and was purchased by the Shomof Group in 2014. The Shomof Group is known for projects in downtown Los Angeles completed under the City's Adaptive Reuse Ordinance, which encourages the conversion of older, economically distressed, or historically significant buildings to residential or retail uses.

Escott O. Norton grew up surrounded by theater and architecture. His mom founded the OXY Summer Drama Festival, and his father designed and built all of Norton's childhood homes. Continuing the family tradition, Norton is now the 4th generation in a family of quality home developers. His consultation company, EON Design, specializes in historic buildings, with a primary focus on historic theaters. Escott founded Friends of the Rialto 35 years ago to advocate for the preservation and reactivation of his favorite theater. He was also the Executive Director of the Los Angeles Historic Theatre Foundation, a nationally renowned non-profit that has landmarked and protected dozens of historic theaters across Los Angeles County.





PUBLIC HEALTH STATEMENT REGARDING FAVORABLE COURT OF APPEAL RESTAURANT RULING

The Los Angeles County Department of Public Health (Public Health) is pleased that the Court of Appeal recognized that during a pandemic, it is vitally important for public health officials to quickly take affirmative measures to reduce transmission of COVID-19, in order to combat an ongoing surge of CO-VID-19 cases and hospitalizations. The Court acknowledged that Public Health recognized that while temporarily restricting outdoor dining at restaurants would have an economic impact, the re-striction was an appropriate exercise of public health discretion because dining with others creates a circumstance where non-household members are gathering in close proximity with each other with-out CO-VID-19 infection control precautions, such as face mask, thereby increasing the risk of trans-mission. Importantly, the Court of Appeal found that the trial court stepped outside of a court's ap-propriate role by "mandating a nebulous risk-benefit requirement" on public health decision-making. This ruling will help public health officials continue to protect the health and safety of all Cali-fornians.

THE REAL MCCOY? VERY CLOSE

I read a recent article in the NY Times that said consumers, during hard economic times, buy more generic brands at their local supermarkets, and when the economy picks up they go back to their national brands. That makes perfect sense to even this college drop out. How does that pertain to our wine aisles? More and more of the supermarkets that you and I shop at Vons and Pavilions are coming up with their own store brands. No, they don't own their own vineyards just yet - though I wouldn't put it past Costco - they have existing wineries put together their store's private label. Is this acceptable? Absolutely! Keep in mind 80% of the wine that you are purchasing has grapes sourced from other wineries, or if they don't have their own plot of soil, they use marketing companies to find wines.

What about when a winery comes out with a lower end wine? In my book that is okay, too. Look at the big French champagne houses like Moet, Taittinger, and Crystal. They all have wineries here in California producing exceptional wines at almost half the cost of their imports.

Recently I had the pleasure of a nice glass of Decoy cabernet at a friends here in Pasadena (hopefully you read my recent column about wine by the glass). I thoroughly enjoyed it with my crab cake and decided that

the purchase of a bottle was in order. No, not at the restaurant - I read my own column and took my own advice for once. Decoy hails from the same winery that produces the very popular Duckhorn wines. While about half the cost of it's older brother, I could get used to this more economic wine as it hails from the exact same area of Napa Valley. And, for the life of me I cannot tell much difference in the cabernet.

The vintage is smooth, with perfect levels of fruit and tannins, and a finish that you'd expect from a higher priced cabernet. It's a classic California cabernet with a touch of toasted oak. Closure: Corked

This weeks wine term: finish: That means exactly what it sounds like - the last thought/taste as the juice goes down your throat. Many experts say that the finish is the true test of an exceptional wine.

Each week I will give you my Dills Score. Starting with a base of 50 points, I have added 8 points for color, 7 points for aroma or "nose", 9 points for taste, 8 points for finish, and 8 points for my overall impression, which includes my value rating.



Elementary School

Los Angeles County has reached the threshold to reopen elementary schools according to the California Blueprint for a Safer Economy. PUSD is implementing health and safety requirements and is preparing to welcome elementary students back for in-person learning with a hybrid schedule with a staggered schedule beginning March 30.

Middle and High School
According to the California Blueprint for a Safer Economy, middle and high schools (grades 7-12) can open when the county has moved to the red tier and have also followed the school re-opening guidance. The threshold is 7.0% positivity rate. Currently the LA County rate is 7.2%. It is expected that Middle and High School reopening will follow soon.

ELEMENTARY SCHOOL REOPENING DATES

Pasadena Unified is triggering plans for the safe return of all PreK-5th grade elementary students who wish to participate in on-campus instruction beginning the week of March 29, subject to Board approval. Schools will operate on a hybrid simultaneous learning model, with groups of students physically in the classroom with their teacher while a group of their classmates participates via distance

Opening schedule, subject to Board of Education approval:

Monday, March 29 - all students remain on distance learning
Tuesday, March 30 - PreK-Kindergarten return to all elementary schools
Wednesday, March 31 - No School: Cesar Chavez Holiday
Thursday, April 1 - Grades 1 and 2 return, grades PreK-Kindergarten also on campus
Friday, April 2 - PreK-2nd grades on campus

April 5-8, 2021 - Spring Break Monday, April 12 - all students on distance learning Tuesday, April 13 - Students in grades 3-5 return, students in PreK-2nd grade on campus

Early Childhood Education (ECE) programs are planning to open together with the District's PreK-2 grades with in-person full and half-day programs.

TECHNOLOGY THAT CAN HELP YOU LOCATE THINGS YOU MISPLACE

Dear Savvy Senior,: Can you recommend any good devices that help seniors with tracking down misplaced items? My wife misplaces everything including her car keys, eye-glasses, cell phone, purse and more. Always Searching



Dear Always:

All you do is attach a small battery-powered Tile to the items you want to keep track of with an adhesive sticker, a key ring or you can just slip it inside the item.

Then, when a tagged item goes missing, you simply access the app on your smartphone or tablet to see how far away you are from the item or last known location on the map. If you're within 150 to 200 feet, you can make the Tile ring so you can follow the sound to easily find it.

Or, if your wife loses her phone, the Tile work in reverse, allowing her to double press the button on her Tile to make her phone ring (even if it's on silent) as long as it's nearby.

Tile also works with Google Assistant, Amazon Alexa or Siri to find misplaced items. All you have

To fit your tracking needs, Tile offers a variety of different sized trackers including the Tile Mate (\$25) that's ideal for keeping track of keys, purses or backpacks; Tile Slim (\$25), which is the size of a credit card that can be put into a wallet or attached to a laptop; Tile Sticker (\$40 for a 2-pack), the smallest finder that can attach to things like remotes, bikes and more; and Tile Pro (\$35), which is the most durable tacker that has a 400-foot range and extra loud ringer.

Glasses Tracker

Since Tile doesn't offer a glasses tracker, a great product to help your wife keep tabs on her eyeglasses is Orbit Glasses (FindOrbit.com; \$40). This is a tiny rechargeable Bluetooth device that sticks to the inside arm of the glasses so it's not noticeable.

So, when your wife's glasses aren't on her head, but are nearby, she can use the free Orbit app to make them ring so she can find them quickly. Or, if she's out of Bluetooth range, she can check the last known location that will be shown on the map.

If you or your wife don't have a smartphone or tablet, there are also radio frequency devices like the Esky Key Finders (EskyNow.com), sold through Amazon.com, that can help you find misplaced

These devices come with an item locator remote and four to six tags with prices ranging between \$20 and \$30. Attach a tag to the items you want to keep track of with a key ring or adhesive. Each tag is color-coded and corresponds to a colored button on the finder.

When an item goes missing, you simply press the colored button on the locator remote and the tag will flash and beep. The signal will go through walls and cushions and have a tracking range of around 100 feet. Make sure you keep the finder fob in a safe spot, because if you misplace it, you won't be able to find the tagged items.

IMPORTANT ESTATE PLANNING LESSONS FROM LARRY KING'S DEATH—PART 2

Legendary TV and radio host, Larry King, died at Cedars-Sinai Medical Center in Los Angeles on January 23rd, 2021 at age 87.

Last week, in part one of this series, we discussed how Larry's decision to create a handwritten will, rather than take the time to consult with legal counsel to properly update his plan for his impending divorce, is likely to result in a lengthy court battle between Larry's seventh wife, Shawn Southwick King, and his surviving children. Moreover, we also noted that Larry would have been far better off using a Lifetime Asset Protection Trust, instead of a will, to distribute his assets to his children upon his death.

A Lifetime Asset Protection Trust is a unique estate planning vehicle specifically designed to protect your children's inheritance from unfortunate life events, such as divorce, debt, illness, and accidents. At the same time, the trust gives your children the ability to access and invest their inheritance, while retaining airtight asset protection for their entire lives.

For someone with as much wealth and as many heirs as Larry, a Lifetime Asset Protection Trust, built into his Living Trust, would have been an ideal vehicle to protect and pass on his assets. To see why, let's break down how these unique trusts

To avoid the court process of probate that's inherent with a will-based plan, most lawyers will advise you to put the assets you're leaving your kids in a revocable living trust—and this is the right move. THE PRIEST THAT STIMULATED OUR THINKING

Once I began attending John Muir High School, I was no longer getting the Catholic religious instruction that I got from classes at St. Elizabeth's in grades 1 through 8, and at St. Francis high school in the ninth grade.

Our local parish church, St. Elizabeth, offered Monday night classes for Catholics who were at-tending public school, and my mother encouraged me to go, just like my older brothers had done. Did I say encouraged"? Let's just say I had no other choice. The classes were called CCD, which I believe meant Confraternity of Christian Doctrine. For me, this meant I could get out of the house on Monday nights and hopefully meet girls. I would usually go up to St. Eliza-beth's school with my brother Richard and friend George, and sometimes with others.

We'd go to the 7th grade classroom and the priest would engage us in discussions of issues of honesty, relationships, politics, etc., all with the intent to get us to think in terms of how problems and issues can be seen, and resolved, in the context of Catholic dogma and theology. In the be-ginning, I spoke very little, afraid of my own shadow. But when I began to answer simple ques-tions when no one else spoke up, and the priest seemed delighted and surprised at my answers, I continued to override my feelings of stupidness and self-consciousness and would engage the priest in discussions and lively questions that everyone else at least found entertaining. I don't recall all of the specific topics we discussed, but one time, the priest asked us what was the most important single factor in a relationship. No one said a word. I thought about it and the answer seemed obvious. Finally, I spoke up and said, "being honest," and the priest said "You hit the nail on the head." He then spoke for the rest of the night about being honest.

Often, I would share some fact, or have some query, which would objectively contradict what the priest had previously told us. The priest always seemed to smile, and lighten up, when some-one challenged his ideas. It allowed him the opportunity to share the Catholic dogma, but more importantly, it allowed the priest to intellectually engage with us students.

Some of the subjects generally dealt with biological evolution, abortion, the possibility of rein-carnation,

the possibility that the English translations of the Bible could have some errors, and other topics. The priest encouraged us to ask questions, and I began to look forward to the discussion aspects of his lessons. Though the priest always tried to bring it back to Catholic dogma and belief – which was the stated purpose of the classes – he did so in a very dynamic way. I liked the fact that we were never being dryly taught "church doctrine" but rather we were guided to see some of these issues in the light of traditional church beliefs.

Word got around to my mother that I was "debating with the priest." I don't know who would have reported that to my mother, or what they actually said. I presume it was a second or third hand report by another student who told their parent about the discussions, who told another parent, who knew my mother and told her, most likely in a very distorted way.

"How dare you talk back to the priest?" she said one day, without even asking me for an expla-nation or asking me my side.

"What? When did I do that?" I replied.

"I heard that you were telling off the priest. What makes you think you know more than the priest?" she

I attempted an explanation, but all she knew is that I didn't sit there in the classroom meekly and say "yes, father" to the priest. It was near-heresy to question anything that the priest said. She never accepted my explanation, and would bring it up for years later, pointing out my arrogance to think that I could actually "talk back" to the priest, as if that's what I was really doing, which I wasn't.

I never forgot this incident, realizing that when it came to the Church, my mother had some very strong viewpoints. In this case, she would not let facts get in the way of what she already believed.



BELIEVE IT OR NOT, MONEY ISN'T THE KEY TO HAPPINESS

Get this: A study by McGill University has found that more money does not necessarily make people in low-income countries happier.

I like more money as much as the next guy, but that does not surprise me.

People in developing countries like Bangladesh may not have high incomes and own lots of nice mate-rial things, but they do have an abundance of two key sources of happiness: More contact with family and

nature. McGill's study backs me up.

Sara Minarro, the lead author, says in Futurity.org that the people interviewed reported that what was responsible for making them happy was the greater proportion of time they spent with their families and in contact with nature (many of the people interviewed were fisherman).

As Chris Barrington-Leigh, a professor in McGill's Bieler School of the Environment, explained, "When people are comfortable, safe, and free to enjoy life within a strong community, they are happy – re-gardless of whether or not they are making any money."

A number of recent studies have come to a very similar conclusion.

A 2017 study by the University of British Columbia found that spending money to buy free time, such as paying others to cook or clean for you, does improve happiness, leave you feeling less stressed and generally more satisfied with life.

Beyond that, however, money does not necessarily make us happier.

According to Time magazine, Dan Gilbert, a Harvard University psychology professor and the author of "Stumbling on Happiness," believes that having money has some obvious benefits but also limitations.

"Once you get basic human needs met," Gilbert says, "a lot more money doesn't make a lot more happiness."

Research shows, reports Time, that "going from earning less than \$20,000 a year to making more than \$50,000 makes you twice as likely to be happy, yet the payoff for then surpassing \$90,000 is slight."

In other words, once you have enough money to pay your bills and enjoy going out to dinner now and then, additional increases in wealth do not necessarily correspond with greater happiness – or, as one of the academic studies called it, "greater life satisfaction."

I remember talking with elderly family members, no longer with us, at a family gathering a few years ago.

They told me stories about growing up in Pittsburgh during the Great Depression. They had no money at all – but had no idea they were poor.

Their neighborhood was rich with humanity – kindly old characters, people watching out for them and lots of friends to play with.

They said it took forever to walk to the store and back because so many people stopped them to say hello.

They told me they felt sorry for kids today who have so much material wealth but will

never know the deep connections they had with so many neighbors and friends when they were growing up. But we know all this.

We all know that the happiest moments in our own lives involve friends and family. These are the people who affect the deeper part of our nature, our spirits and souls, where true hap-piness resides.

These are the people who can make us laugh so hard our guts hurt – or who are there to help us when we're down and out and in need of advice or just someone to talk to.

Yet too many of us today spend most of our waking hours not nurturing our friends and families but chasing success and money and a bigger house.

Sadly, we don't experience the "life satisfaction" that people in some of the poorest countries on Earth enjoy every day – as the true happiness that is right under our noses eludes us.

bury players left the floor, most of them in tears, the winning team and the crowd stood as one, in appreciation for six young women who had given every bit of themselves for each other and for those who weren't here.

This is a good story and one that needs telling because you probably haven't heard about

Tech took the last shot in a 72-72 game, a desperate three-pointer as the buzzer blared. It

was perfect. The Tech players mobbed the shooter at midcourt. But as the defeated As-

it. Nor will you. It isn't big enough. Small-college basketball. It wasn't on TV and no one will be discussing it on sports talk radio tomorrow. But it happened.

It was the story of the year, at least so far. The conference had asked the Eagles if they even wanted to play the game.

"Not playing never entered our minds," Eagles head coach Chad Mayes said.

But Tech would be a much taller order. A better team with its full roster of players against an Eagles team which would, once again, start four true freshmen, two of whom saw very little playing time dur-ing the season. No, this wasn't Hoosiers. Rocky, maybe, but not Hoosiers. And then it became something even better.





THANKS TO VICE PRESIDENT KAMALA HARRIS, THE POWER OF WOMEN WILL NEVER BE THE SAME By Reecie Colbert, BlackWomenViews Media

OPINION: Vice President Kamala Harris shattered a 200-year-old glass ceiling in November 2020. As a Black woman, she brings both cultural and gender competency to the most powerful table in the country.

Two hundred and thirty-three years ago as the United States Constitution established the role of vice president, it also enshrined the rights of southern states to continue to enslave over half a million Black Americans; and granted latitude to local and state governments to deny free Black Americans the rights and protections of full citizenship.

Undoubtedly, the prospect of a woman vice president would have been unfathomable to a group that prohibited women from participating in the framing and ratification of the Constitution. Yet in 2021, we commemorate a new historic achievement this Women's History Month: the first woman, Black person, and person of Asian descent as vice president.

In becoming the 49th vice president of the United States, former San Francisco District Attorney, California Attorney General and United States Senator Kamala Harris shattered a two-centuries-old glass ceiling.

The significance of having a woman, especially a Black woman, occupy the country's second-highest office cannot be overstated. Harris' win is both inspiring and transformational. As a Black woman, Kamala Harris brings both cultural and gender competency to the most powerful table in the country.

Issues like Black maternal and infant mortality — which have long been on the back burner — now find a champion in the White House. As Harris often states, she may be the first but will not be the last. The diversity of Harris' staff, headed by Hartina Flournoy (the first-ever Black woman chief of staff to the vice president), makes it clear that Harris is continuing her tradition of creating a pipeline of women and Black leaders.

Vice President Kamala Harris' success finally puts to bed the notion that women are unelectable political liabilities on a presidential ticket. Within 24 hours of Harris' announcement as the Democratic vice presidential nominee, the Biden campaign received an astronomical \$26 million fundraising boost. Together, President Joe Biden and Vice President Kamala Harris won the 2020 election *by a margin of 7 million votes ultimately receiving 81.2 million votes*, *the most in U.S. history.* There is no better proof that women can win, than winning.

While the position of vice president has existed since 1789, it was not until 1939 the Office of the Vice President was established. With only three duties enumerated in the Constitution, presiding over the Senate, the counting of Electoral College votes before Congress, and impeachment trials, each administration has carved out its own portfolio for the vice president.

In recent history, the vice president has taken on substantially more power and distinction. President Biden often characterizes himself as a transitional figure, so it's no surprise that he has wholeheartedly embraced and elevated the role of Vice President Kamala Harris to stand beside him rather than to stand back.

Harris has been visible to a seemingly unprecedented extent, giving her own separate address the day she and Biden were declared president-elect and vice president-elect, and being prominent during each unveiling of the Cabinet.

With Vice President Harris avamen have now moved from a position of influence at the highest levels, to a position

With Vice President Harris, women have now moved from a position of influence at the highest levels, to a position of power. While several first ladies have been credited with wielding considerable influence in their husband's administration, with the Harris vice presidency that power comes out of the shadows to be exerted in an official capacity.

Pledging that Harris will be the last person in the room with him, President Biden has demonstrated that she is a trusted and valued decision-making partner. Biden has credited Harris with being heavily involved in all of the Cabinet selections, which are notably full of historic firsts and a gold standard for diversity.



Shattered glass portrait of Kamala Harris was unveiled on National Mall last month. The extraordinary new artwork, standing 6 feet tall and stretching 6 feet wide, was created by Swiss artist Simon Berger commemorateing VP Harris, the first woman, Black and South Asian Vice President of the United States by creating an art piece made entirely of shattered glass. Berger immediately began working on the piece after the presidential election last November.

While Harris' role as an expected frequent tiebreaker in the Senate has garnered much attention, her day-to-day work is concentrated in the executive branch. She is a member of the National Security Council, National Economic Council, and National Space Council as well as a recipient of the Presidential Daily Briefings.

Though Kamala Harris' portfolio is not yet formally defined, her addressing the hardships of small business and the alarming decrease of women in the workplace spurred by the pandemic offers clues about her potential domestic focus. Reportedly, cybersecurity and global health will be Harris' foreign policy focus.

Although just 6 of the 15 vice presidents who ascended to the presidency have done so through an election, Harris' vice presidency makes the prospect of the country electing its first woman president more likely. Twelve vice presidents secured their party's nomination, while 20 did not run for higher office.

The likelihood of Harris being the frontrunner for the Democratic Party's nomination after Biden's presidency in part





