## WHAT IS NETZERO WATER USAGE?



To many of us, this is an unfamiliar, hard to imagine concept. For the 42 unit Monastery housing project proposed by New Urban West, it is an important component. For clarification, Preserve Sierra Madre contacted the City Manager, Gabe Engeland, and asked him to explain the NetZero water process. His response follows.

With regards to NetZero, the MOU states "NetZero. To ensure the Project has a net zero water impact through the

establishment of a fund that will pay for retrofitting of water efficient features in older homes in the City (e.g., low flush toilets and low flow showers)."

The purpose of the inclusion of NetZero in the MOU was to ensure the project did not have any water impact on Sierra Madre. Since the signing of the MOU, and subsequent research, Staff has determined creating, operating and managing a retrofitting program would be less efficient than simply charging the developer the cost of water expected to be used in each of the homes if they are developed. This charge would then be used to purchase and import 100% of the expected water use for each home and recharge our local aquifer.

Below is an example of how a NetZero water charge would work. Please understand this is an example of how the charge is calculated and may not represent the final numbers proposed.

Here is how we propose to calculate the NetZero charge: The cost to import one acre foot of water in Sierra Madre is \$512. The average single family home uses approximately 0.25 acre feet per year. The life of home is 50 years.

In order to calculate, we multiply: Cost of an acre foot by use:  $$512 \times 0.25 = $128$ 

Then multiply this by the life expectancy of the home:  $$128 \times 50 = $6,400$ 

Then multiply this by the number of homes:  $$6,400 \times 42 = $268,800$ 

In this example, each home would be required to pay, up front, for all of the expected water use during the lifetime of the home.

New homes are more water efficient than older homes. The water used in the calculation, however, is from the average Sierra Madre home. This means the new homes will likely offset more water than used over their lifetime.

It is also important to note the NetZero charge is in addition to the actual water that the future property owner would use. Each home will also be charged the same rate as all other Sierra Madre residents.





## **Local Area News Brief**

Police Release new Information in Double Murder



Pasadena police are asking for the public's help, after releasing new information on the vehicle, in finding a suspect involved in a shooting last year at Villa Parke that left two people dead and another injured.

The vehicle has been described as a newer model, white Mercedes Benz, with black rims (as depicted in the above photograph).

According to police investigators, on Tuesday, December 1, 2020 at approximately 2:58 p.m., Pasadena Police Officers responded to the 300 block of Parke St. regarding a report of a shooting. Officers arrived on scene and located three victims in the northeast portion of Villa Parke. Two victims succumbed to injuries and the third victim survived. All three victims were struck by gunfire.

#### **Police Arrest** Shooting Suspects

Pasadena police announced Wednesday the arrested two suspects wanted in connection to a shooting into an occupied vehicle in East Pasadena, in March, that left a man dead and a woman iniured.

According to police Evan Roland Bynum - 26 year-old Los Angeles Resident, and Dante Dejuan Ward - 33 yearold Irvine Resident, were both arrested Friday April 2 for the alleged shootings.

Additional evidence was also found after search warrants were served at various locations.

Investigators said that on March 13, at approximately 8:56 p.m., officers arrived on scene and located two victims inside a parked vehicle. The male victim a 23-years old, Azusa resident had been struck numerous times by gunfire while the female victim a 19-years old, Duarte resident sustained only minor injuries. Pasadena Fire Department Paramedics arrived on scene and transported both victims to a local hospital. The male victim arrived at the hospital in critical condition and would later succumb to his injuries.

The female was treated for non-life-threatening injuries and was released.

Bynum and Ward ran from the location following the shooting police alleged.

Both were charged Tuesday with murder and attempted murder. Bynum is being held on \$4,090,000 bail and Ward's bail was set at \$3,140,000.

#### **Blinn House** to Become Pasadena Heritage Headquarters

In a joint statement, the ownership transfer for the Edmund Blinn House in Pasadena by the Women's City Club to Pasadena Heritage was finalized last week. The move came after members of the Women's City Club voted to dissolve the organization in May. The Women's City Club had operated as a non-profit organization out of the home for 75 years.

Blinn House is set to become the new headquarters for

Pasadena Heritage.
"It was a very difficult decision for us to dissolve the Club after so many years, and it was with much thought and careful consideration that we decided Pasadena Heritage should take over the historic house." Said Suzanne Burger, President of the Women's City Club. "We feel

confident they will take the best care of it and be able to continue able to continue The Bl maintain the restoration and Mississippi River.



The Blinn House at 160 N. Oakland Avenue is listed on the National Register of Historic Places, both individually and as a contributor to the Ford Place Historic District. The house is also a Pasadena Cultural Landmark and is listed on the California Register of Historical Resources.

The Blinn House was designed in 1905 by renowned Chicago architect George Washington Maher who also designed the Blinn's home in Chicago. Maher was recognized as one of the finest architects in Chicago, along with Burnham & Root, Frank Lloyd Wright and Louis

"We are excited and very grateful for the opportunities this historic place will provide for our organization," added Sue Mossman, Executive Director. "Home fires remain the most frequent disaster during COVID-19, yet most of us don't realize we have just two minutes to safely escape," said Joanne Nowlin, CEO for the Red Cross Los Angeles. "As families spend more time at home during the pandemic, it's critical that we help our vulnerable neighbors protect themselves from these everyday disasters."

In 2021 alone (just three months), Red Cross LA has supported more than 660 people following more than 120 home fires. The Red Cross helped with urgent needs such as emergency shelter-ing, financial assistance and recovery planning.

Most recently, the Red Cross responded to a condominium fire in Panorama City and helped more than 50 people displaced by the fire by providing food, water, safe lodging and other services as they begin the recovery process. A report published by the Los Angeles Fire Department sited that functioning smoke alarms alerted some occupants, and all were able to evacuate

#### LA COUNTY MORTGAGE RELIEF **PROGRAM**

The Los Angeles County Department of Consumer and Business Affairs (DCBA) is pleased to an-nounce the new LA County Mortgage Relief Program, a partnership with Neighborhood Housing Services of LA County (NHS) and local HUD-approved housing counseling agencies. The \$5.5 mil-lion initiative developed by the Los Angeles County Board of Supervisors will support property owners who have been adversely affected by the COVID-19 pandemic.

The Mortgage Relief Program will include a relief fund which provides grants of up to \$20,000 for qualified property owners, plus expanded foreclosure prevention counseling services. The program is structured to benefit single-family homeowners and property owners with four or fewer units liv-ing in communities highly impacted by COVID-19. This includes lowhave suffered a higher percentage of significant health impacts during the on-going COVID-19 pandemic. Properties must be owner occupied.

NHS will administer the relief fund and deploy funds to qualified applicants from a diverse set of cities and unincorporated areas throughout Los Angeles County, excluding the City of Los Angeles. DCBA and NHS-LA have determined qualification requirements for applicants. Relief funds will be paid directly to lenders and servicers.

Free foreclosure prevention counseling will be provided by nonprofit HUD-approved counseling agencies to property owners in multiple languages. To find more ways how LA County can help property owners, visit DCBA's foreclosure prevention website at dcba.lacounty.gov/foreclosure-prevention.

Phone scammers are getting smarter with their tactics. And if you're not careful, they could make big bucks off of you, the unsuspecting caller. Aside from hanging up if you hear this four-word phrase, there's something else you can do to avoid becoming a victim and to keep up with your smartphone security and

Another area code to look out for may look like it's coming from the United States, but isn't. "Criminals have been known to use caller IDs with the area code 473, which appears to be domestic, but is actually the area code for the island of Grenada," Steinberg says. Watch out for these phone call scams that could steal your money, too.

To play it extra safe, never answer or return a call from a number you don't recognize. If you actually know the person, they can always leave a voicemail. It can't hurt to be wary of possible scam phone numbers with the following international area codes.

#### L.A. COUNTY NEARS 5 MILLION VACCINE **DOSES ADMINISTERED**

The Los Angeles County Department of Public Health (Public Health) has confirmed 48 new deaths and 752 new cases of COVID-19. To date, Public Health identified 1,224,503 positive cases of COVID-19 across all areas of L.A. County and a total of 23,431 deaths.

Of the 48 new deaths reported today, 19 people that passed away were over the age of 80, 10 people who died were between the ages of 65 and 79, 12 people who died were between the ages of 50 and 64, three people who died were between the ages of 30 and 49, and one person who died was between the ages of 18 and 29. Tragically, one youth under the age of 18 also passed away. Two deaths were reported by the City of Long Beach.

More than 4,715,000 doses of COVID-19 vaccine have been administered to people across Los Angeles County. Of those vaccinated, 1,652,149 people received second doses and 136,232 people received the single dose Johnson & Johnson vaccine.

As of April 6, 70.2% of L.A. County residents 65 and older received at least one dose of the vaccine. In total, 37.1% of the County's population 18 and older have received at least one dose of vaccine.

Public Health continues to expand the number of sites offering vaccination services across the county. As of this week, vaccinations are administered at 566 locations. These sites include seven large community vaccination sites operated by the County, nine LA City vaccination sites, 24 hospital vaccination sites, 130 pharmacies, 199 federally qualified health centers and community clinics, and 197 additional sites provided vaccine directly by the federal government and the state.

This week, 397,430 total doses were allocated to Los Angeles County. This allocation included approximately 151,000 doses of the Pfizer vaccine, 128,000 doses of Moderna vaccine, and 118,000 doses of the Johnson & Johnson vaccine. With the additional doses shipped directly by the federal government to L.A. County providers, vaccination sites across the county had capacity to administer nearly 700,000 doses this week. Next week, Public Health is expecting to receive approximately 323,000 vaccine doses; a decrease of 74,000 doses from this week due to a reduced supply of Johnson & Johnson vaccine. This allocation includes approximately 165,000 doses of the Pfizer vaccine, 139,000 doses of Moderna vaccine, and 20,000 doses of the Johnson & Johnson vaccine.

Of the nearly 323,000 doses of vaccine the County expects to receive next week, 70% of doses will go to sites located in the most vulnerable communities. Fifty-seven percent of doses are needed for second dose appointments.

Additional doses will continue to be allocated directly from federal partners and the state to pharmacies, health clinics, FEMA sites, and multi-county entities. Together, Public Health hopes that slightly over 500,000 doses of vaccine will be allocated to vaccination sites across the county next week.

'We send our deepest sympathies to the families and friends grieving a loved one lost to COVID-19, "said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "I encourage those already eligible for COVID-19 vaccination to not delay getting vaccinated. Now that we have expanded eligibility for vaccination to all adults 50 and older, and will soon be expanding to residents age 16 and older, effective April 15, I want to urge all employers to please give your employees time to get vaccinated when it is their turn. We expect a rush for appointments in the coming weeks, and employees will need as much flexibility as possible to get their vaccinations.'

There are 540 people with COVID-19 currently hospitalized and 26% of these people are in the ICU. Testing results are available for more than 6,175,000 individuals with 18% of people testing positive. Today's daily test positivity rate is 1.3%.

Public Health is committed on ensuring an equitable distribution of vaccines and ensuring eligible residents and workers in hard hit communities have increased access to vaccines. #### DEPARTMENT OF PUBLIC HEALTH **GUIDANCE FOR VACCINATED INDIVIDUALS**

On March 10, the Los Angeles County Department of Public Health published a modified Health Officer Order to reflect changes for individuals who are fully vaccinated to align with the Centers for Disease Control and Prevention's (CDC) new guidelines and interim public health recommenda-tions.

The guidance provides that fully vaccinated individuals may resume certain activities, such as gathering with other fully vaccinated people indoors without wearing masks or physical distancing; visit with unvaccinated people from a single household who are at low risk for severe COVID-19 disease indoors without wearing masks or physical distancing; and refraining from quarantine and testing following a known exposure if asymptomatic. The Department of Public Health recommends that fully vaccinated people should continue to:

- Take steps to protect themselves and others by wearing a mask, staying at least 6 feet apart from others, and avoiding crowds and poorly ventilated spaces. These precautions should be taken whenever they are:
- In public
- Gathering with unvaccinated people from more than one other household
- Visiting with an unvaccinated person who is at increased risk for severe COV-ID-19 disease or who lives with a person at increased risk.
- Avoid medium- and large-sized in-person gatherings
- Watch out for symptoms of COVID-19, especially if after contact with someone who is sick. If they have symptoms of COVID-19, they should get tested and stay home and away from others.







#### THE MOST AND LEAST POPULAR AGES TO **CLAIM SOCIAL SECURITY**

Dear Savvy Senior:

How much does your claiming age affect your Social Security benefits, and what are the most popular ages people start taking their retirement benefits? Nearing Retirement



#### Dear Nearing:

You can sign up for Social Security at any time after age 62. However, your monthly payments will be larger for each month you delay claiming them up until age 70. This adds up to around 6 to 8 percent higher payments every year you delay.

To get a breakdown on exactly how much your claiming age affects your benefits, visit Social Security's Retirement Age Calculator at SSA.gov/benefits/retirement/planner/ageincrease.html. This tool provides your official full retirement age (FRA) – which is between 66 and 67 depending on your birth year - and shows how much your benefits will be reduced by taking early payments or increased by delaying them.

In the meantime, here's the rundown of when most people start receiving retirement benefits (according to 2019 SSA statistics), and how signing up at each age impacts your payout.

Age 62: This is the earliest you can sign up for Social Security and the most popular age. Around 34 percent of women and 31 percent of men signed up for Social Security at 62. But if you sign up at this age, you'll get 25 percent smaller Social Security payments if your FRA is 66, and 30 percent lower payments if your FRA is 67.

Age 63: About 7 percent of all workers start drawing their benefits at this age. Monthly payments are reduced if you sign up at age 63, but by less than if you claim at 62. A worker with a FRA of 66 will get a 20 percent pay cut by signing up at 63. And workers with a FRA of 67 will get 25 percent less.

Age 64: Around 8 percent of women and about 7 percent of men claim benefits at 64. Social Security payments are reduced by 13.3 percent for those with a FRA of 66, and 20 percent for people whose FRA is 67.

Age 65: This use to be FRA for people born before 1938, but it's still enrollment age for Medicare. Around 12 percent of workers begin their retirement benefits at 65. By starting at this age, you'll see you monthly payments reduced by 6.7 percent if your FRA is 66, and by 13.3 percent if it's 67.

Age 66: This is FRA for people born between 1943 and 1954. If you fit into this age group, you're eligible to claim unreduced Social Security benefits. Nearly 29 percent of men and 22 percent of women sign up for benefits at 66. But if your FRA is 67, you'll get a 6.7 percent pay cut if you sign up here.

Age 67: People born in 1960 or later will be able to claim unreduced Social Security payments starting at age 67. Baby boomers born before 1955 will get an 8 percent increase if they wait to claim their benefits at 67. Less than 4 percent of men and 3 percent of women start their benefits at this age.

Age 68: Only about 2 percent of workers start claiming their retirement benefits at 68. Those with a FRA of 66 will get 16 percent more if they claim Social Security payments at age 68, while those with a FRA of 67 will get 8 percent increase.

Age 69: Less than 2 percent of workers start claiming their retirement benefits at this age. Those with a FRA of 66 will get a 24 percent boost in their benefit by waiting to 69. While those with a FRA of 67 will increase their benefits by 16 percent.

Age 70 and older: Waiting to age 70 offers the biggest possible payout. Nearly 9 percent of women and 6 percent of men held out until this age. Those with a FRA of 66 can increase their benefits by 32 percent, while those with a FRA of 67 will get a 24 percent increase. After age 70, there's no additional increase for further delaying your payments.

#### YOUR LEGAL RELATIONSHIP WITH YOUR CHILD CHANGES ON THEIR **EIGHTEENTH BIRTHDAY**

I was recently asked a question by a client with a graduating senior at home. It's a great question and one which parents often don't think about. I was asked, "what estate planning documents should my son, who just turned 18 and is planning to attend college in the fall, have in place?"

Answer: At age 18, your son is now an adult in the eyes of the law. This means you no longer have the authority to make decisions regarding his medical care, nor will you have access to his finances if something happens.


Since you are no longer in charge, your son's greatest liability from a planning perspective is what would happen if he were incapacitated by illness or injury and become unable to make decisions on his own behalf. To prepare for this scenario, you should have your son sign three key documents: medical powers of attorney, a living will, and durable financial power of attorney.

Medical powers of attorney allow your son to grant you (or someone else) the legal authority to make healthcare decisions on his behalf in the event he is incapacitated and unable to make decisions for himself. Used in conjunction with medical powers of attorney, a living will provides specific guidance about how your son would want his medical decisions made in the event he is incapacitated.

Finally, if your son is incapacitated, you may also need the ability to access and manage his finances, and this is done with durable financial powers of attorney, which gives you the authority to manage his financial and legal matters, such as paying tuition and maintaining his bank accounts.

The things we take for granted as parents, during our kids' childhoods, change and can become big liabilities as they enter adulthood. Until they settle down and have a family of their own, you (and they) should seriously consider setting up these basic estate planning documents, naming you as their agent.

It's one more way families can provide peace and security for each other. Congratulations to all soon to be graduating seniors!


My only problem at this point was what not to buy. The chocolate that I love the most is the one I'm eating at the time.

"Well, I suppose it depends on the person," she responded.

My friend and I were checking out at a small grocery store. The clerk was on her

cell phone, an obviously personal call because we could hear everything she was saying. Yet, she somehow managed to check each item with mechanical efficiency. She smiled towards us, without actual-ly looking at us. She spoke the price, I handed her some bills, and she returned the correct change. The groceries were bagged and we walked away.

I was a bit nonplussed, even though this scene has become way too normal. To speak on a cell phone to someone else while handling a paying customer is the antithesis of service. My friend told me I was making a big deal out of nothing.

"Besides, I do that all the time at my office and home," she smiled. "You know, multi-tasking."

"Really?" I responded. "So that's your fancy word for doing two things at the same time and doing them both poorly?'

"But that clerk didn't do her job poorly," my friend protested. "You got the correct change, didn't you?"

"Yes, I got the correct change but that's not the point. Let's just say that if she were my employ ee, she'd get one warning and then I'd fire her."

"But that was a small store," my friend said. "How do you know that she wasn't the boss?"

"I don't know that," I said, trying to explain why I felt that we'd just had less than an ideal in-teraction. Perhaps it was because the clerk's mind was elsewhere, and that I believe you really cannot do two things simultaneously, and do them each well, which is why it is illegal to talk on a cell phone and drive. I asked my friend to explain what sort of "multi-tasking" she does at

"You know, the usual," she responded. She described a variety of tasks such as paperwork, let-ters, taking phone calls, reading e-mails. "If you don't give a task your full attention, do you think the task suffers?" I asked.

She thought about it. "Not really," she said. "As long as I do an adequate job, there's no prob-lem."

#### ON MULTI-TASKING

I dropped the subject for fear that if I pushed my point further, a friend would soon be a former friend.

I'm not a big fan of so-called "multi-tasking." I think it's a somewhat fraudulent, self-deceptive concept where you believe you can efficiently do more things than one at a time. It's a belief that by moving a lot of stuff around, that your quantity is more important than quality. This is probably one of the reasons why the quality of goods and services has declined, in general.

In a similar vein, today there are many multipurpose tools now on the market, such as a tool which promises to be a hammer, a screwdriver, a saw, a shovel, a can opener and pliers. Such tools do about 40 tasks poorly and none well. In my survival skills classes at Pasadena City Col-lege, I have often showed some of the tools that you can carry in your wallet, or in your glove box of the car, and the unique tool supposedly allows you to do everything that you formerly did with a large tool box. Of course, that's preposterous.

I do believe that Swiss Army knives pack a lot of quality into a little package, though they cannot handle big jobs. The Leatherman tool is also generally a good combination tool because it is well made.

But as a rule of thumb, the more tasks a tool claims, the more poorly it performs. And, generally, as the price lowers, so does the performance and longevity of the tool. In my world view, it is better to have just a few quality tools that a tool box full of cheap tools that mostly result in frus-tration.

My "multi-tasking" friend reminded me that the benefit of her doing so many things at once means that she gets more done at a lower cost, more quickly. I had to think about that one. It reminded me of a sign that I once saw in a motorcycle repair show.

Yes, true quality – in a service or in a product – takes more time and costs more. And because most of us want it now and want it cheap, we've created a frustrating world of low quality service and goods. Change will only come slowly, when enough of us realize that fast and cheap is just a quick thrill with no lasting satisfaction. Everything is a choice, and a result of our many choices, and we create the world that we have collectively chosen.

My son is a Jewish Caucasian man while his girlfriend is Chinese. I am a Jewish man while my wife is a Hispanic woman with a Catholic background. Our dog doesn't talk much about it but I believe he is a mixed breed of sorts. My wife and I live in the beautiful canyon of Sierra Madre in what I think is a lovely home with a few too many staircases that seem to be getting steeper each day. All in all it is a very diverse group of which I am very proud to be a part.

This diversity came about through no particular intent by any of us to create such a motley crew. I think, or would like to think, that our diversity reflects what is happening within our beloved country and is a predictor of future peace and harmony within this country and the rest of the world. Sixty or so years ago when I graduated High School the world seemed to be at war. There was this Cuban missile crisis when it felt like we were going to be bombed any minute. My male friends and I were all facing compulsory military service and the available means to deny the inevitable conscription was to go to College and receive a deferment from military service. Four years later as we graduated College things were even worse. In 1965 the literate, articulate, handsome, forever young President had been assassinated while we were in College and the new President seemed neither literate, articulate, handsome, forever young, and besides that he talked like a Southerner. To many of my contemporaries, (perhaps including me) it felt like LBJ was after us personally.

In addition to this, in 1965 the Watts riots, sometimes referred to as the Watts Rebellion or Watts uprising took place affecting the surrounding areas of Los Angeles. It all began when a 21 year old Black man was arrested for drunk driving in the Watts neighborhood, an almost completely

Are the Stones | segregated area at the edge of Los Angeles. The ensuing struggle during his arrest sparked off 6 days of rioting, resulting in 34 deaths, over 1,000 injuries, nearly 4,000 arrests, and the destruction of property valued at \$40 million dollars. As I look back on it now this event really set me on a path that describes the arc of my entire life. I was very certain that racial prejudice and continuing discrimination was going to ultimately cause the destruction of this country.


All right! Law School here I come. It


also helped that by going to Law School I would receive a further student deferment and would escape conscription for at least another three years. Really though, I like to think that Law School meant to me that I would have the opportunity somehow to assist and even participate in the necessary process of correcting the continuing injustices present in this land where all men (women didn't count then) were created equal. While in Law School I somehow landed a work study job that allowed me to participate in the creation of a program which enrolled High School Students from Watts (all African American) and Boyle Heights (all Hispanic) and brought them to UCLA every weekend during the School year and allowed them to live in a UCLA dorm for the whole summer. Best of all, at least for me, I was allowed to live free of charge with the students. It was a wonderful opportunity and I learned deeply within myself that notwithstanding whatever academic and social problems these kids had they were wonderfully interesting, entertaining, people to get to know. During the School year I had the opportunity to travel to Grenada Mississippi and become a part of the Southern Christian Leadership Conference and participate in Voter registration, economic boycotts, and mass marches and personally observed the remnants of the segregated South but was privileged to experience the inevitable truth that the coming of Democracy and Equality were on the march and couldn't be stopped.

It is now 54 years later and if I could have been able to view the 2021 video (no such thing was even imagined then) of our birthday breakfast I imagine I would have been very satisfied. Change has come, all religions and races are living together happily in beautiful surroundings and important family bonds are maintained. That's how it would have looked to me then and I most certainly would have been satisfied. So why ain't I satisfied now? The answers is obvious and it leads me to the conclusion that "Satisfaction" may well come from only a recognition of the way things were but has absolutely nothing to do with complacency as to the way things are today.

There is no utopia. We must all continue

doing the best we can to continually participate in the creation of the better world to come. For satisfaction we can look back at all we have accomplished but in the present we must recognize all the work that still needs to be done and that hat we can continue to be part of that work. That also is pretty satisfying!

#### SO NOW REPUBLICANS HATE **COKE AND BASEBALL**



Republicans and corporate America have been conjoined for so long that any breach in the bond is almost impossible to imagine. Yet we're seeing one now, thanks to the GOP's decision to give free rein to its authoritarian impulses.

The way it has long worked is easy to explain. Corporate America shovels big bucks to the Republicans, who in turn ensure via legislation that cor-porate America makes as much money as possible,

which in turn ensures that the Republicans will be further rewarded. That's why Mitch McConnell has long championed corporate donations as "free speech" and insisted that those donors have the right to give money without dis-closing their names.

But now that some corporations have belatedly decided it's in their best business interest to oppose the GOP's unprecedented vote-suppression efforts (most notably in Georgia), all of a sudden Republicans like McConnell are outraged. Apparently it's freedom when corporations say and do stuff that echoes the GOP agenda, but if they dare stray from the lockstep party line - and speak ill of the strategy to sabotage democracy - then Republican heads detonate with maximum decibels.

And so now that Georgia-based Coca Cola has denounced the state GOP's voter-suppression law as "a step backwards," and that Georgia-based Del-ta Airlines has accurately pointed out that the law "will make it harder for many underrepresented voters, particularly Black voters, to exercise their constitutional right"...well, suffice it to say that McConnell and other party hacks are suddenly not big fans of corporate

free speech. In a statement Tuesday, McConnell complained that "parts of the private sector keep dabbling in behaving like a woke parallel government," and he warned that unless these firms cease their "frantic left-wing signaling," they would pay a steep price: "Corporations will invite serious conse-quences."

You have to laugh at these people. They're all for corporate free speech – unless corporations say something they dislike. Then their impulse is to threaten some form of punishment. (A government crackdown on rebel-lious corporations? Gosh, that

McConnell and his pals don't seem to grasp the irony of the situation: Co-ca Cola, Delta, and Major League Baseball (plus, in Texas, American Air-lines and computer magnate Michael Dell) have decided that defending the right to vote would best serve their interests in the free market. They decided that silently abetting authoritarianism would be bad for business, pissing off customers as well as their employees. Yes, folks, it's all about the free market - which Republicans purport to worship.

Granted, you can make the case that Republicans have reason to be angry. After all, corporate America has long pumped money into the GOP, to the same state legislators who've been concocting vote suppression bills na-tionwide. Since 2015, corporations have reportedly steered \$50 million to those state legislators - not necessarily for the express purpose of sup-pressing the vote, but simply because they were Republicans (for whom vote suppression and racial gerrymandering has long been a top priority, well known to anyone paying attention).

Their state legislative races are financed by the Republican State Leader-ship Committee. Here's a partial list of recent corporate donors to the RSLC, just give you a flavor: 3M, Amazon, Anheuser-Busch, Autozone, Bank of America, Best Buy, Boeing, Bristol-Myers Squibb, Capital One, Charter Communications, Chevron, Citigroup, Coca-Cola, Comcast, Cono-coPhillips, Ebay, Eli Lilly, ExxonMobil, Facebook, FedEx, General Motors, GlaxoSmithKline, Google, Hewlett-Packard, Home Depot, Honeywell, iHeartMedia, JPMorgan Chase, Juul, LexisNexis, MasterCard, Microsoft, MillerCoors, Motorola, Nationwide, PayPal, PepsiCo, Pfizer, Raytheon, Reynolds American, Sheetz, Target, TIAA, T-Mobile, UnitedHealth, UPS, Vi-sa, Volkswagen, Waffle House, Walgreens, Wal-Mart, Waste Management, Wells Fargo, and Yum

So corporations have long been political players, lobbying for interests that typically align with Republican priorities; the only thing that's differ-ent now – albeit with only a handful of prominent firms - is that, from the GOP's perspective, they're suddenly playing for the wrong team.

One more irony: The GOP, in its knee-jerk opposition to President Biden's infrastructure plan, insists that it's unfair to finance the rebuilding of America by hiking taxes on corporations. So what are they going to do now - agree to hike taxes on corporations, as punishment for "woke" free speech? Three words: Pass the popcorn.

#### **VOTERS ALREADY SAYING** YES TO BIDEN'S INFRASTRUCTURE PLAN



Here's a quiz for the Republican politicians among you. Check as many as apply. Do you support:

- Repairing and rebuilding America's deteriorating network of roads and bridges, includ-ing the interstate highway system brought to life by GOP President Dwight D. Eisenhow-er?

- Ensuring that every American public student isn't drinking water out of lead pipes and doesn't attend class in buildings riddled with toxic chemicals?

- Giving every American access to reliable and affordable broadband internet service? - Making sure that America's electric grid is reliable so there's not a repeat of the de-- Building up the nation's electric vehicle infrastructure so that we can continue the

pivot away from fossil fuels, all the better to hand a cleaner environment to our children, and to their children after them? Because, guess what Republican members of Congress? When it comes to all of the

above, Americans are way ahead of you. As The Washington Post's Jennifer Rubin noted, a Politico-Morning Consult poll finds that six in 10 respondents favor President Joe Biden's sweeping, \$2 trillion infrastructure pack-age. And support for individual items within the plan is even higher, with 77 percent fa-voring modernizing highways and roads. Majorities even support items not traditionally thought of as infrastructure issues: 80 percent support refurbishing Veterans Affairs hos-pitals and improving caregiving (76 percent), Rubin wrote.

And when it comes to Biden's plan to pay for it all by increasing corporate taxes, yep, Americans are down for that, too, according to the Politico-Morning Consult poll, with "sixty-five percent of registered voters [saying] they strongly or somewhat support fund-ing Biden's infrastructure plan through 15 years of higher taxes on corporations, while 21 percent somewhat or strongly oppose it."

Republicans on Capitol Hill, meanwhile, have blasted the plan, with Senate Minority Lead-er Mitch McConnell calling it a "trojan horse," that will result in "more borrowed money and massive tax increases on all the productive parts of our economy."

Putting aside the sheer hilarity of McConnell's sudden concern about fiscal responsibility after he supported adding up to \$2 trillion to the national debt with the Trump tax cut, the Senate Republican leader nonetheless added that he thought there was enough room in the horse's saddlebags for a bridge in his home state.

Another Republican, Rep. Kevin Brady, of Texas, the ranking GOP member of the powerful House Ways & Means Committee, dismissed Biden's plan as a "sugar high." And Sen. Pat Toomey, of Pennsylvania, the ranking member of the Senate Banking Com-mittee and tax-and-spending hawk, said that while he believes "we can and should do more to rebuild our nation's physical infrastructure," Biden's plan would "[undo] large portions of the Tax Cuts and Jobs Act. That 2017 tax reform helped create the best Ameri-can economy of my lifetime."

So if the GOP is against all the things that the American public so clearly favors, it's only reasonable to ask what they support.

Some of the more immediate answers appear to be turning the reins of the party over to Trump loyalists who deny the reality of the Capitol insurrection and who propagate the myth of the stolen election. They fight make-believe culture wars over Dr. Seuss books. And they're doing all they can to push racist voter suppression bills over the goal line. "The GOP remains a cult of personality for the worst president in U.S. history. It has be-come a bastion of irrationality, conspiracy mongering, racism, nativism and anti-

scientific prejudices," the Post's Max Boot wrote in a separate column this week. The White House, knowing the public is with them, is moving on without the GOP, by tee-ing up the infrastructure bill for approval through the parliamentary maneuver known as budget reconciliation, which would not require Republican support.

On Wednesday, Biden forcefully rebutted the GOP criticisms, saying "the idea of infrastructure has always evolved to meet the aspirations of the American people and their needs. And it is evolving again today" He also left the door open to compromise, even as Republicans contort themselves to oppose spending and a vision of government they once embraced: An America that thinks and builds big.

So, I'll try to frame the choice confronting the GOP in the only language they seem to


