Two new Bills, effective January 1, 2022, will impact single-family zoning in California.

The first, Senate Bill 9, makes it possible to build more than one housing unit on land that was previously designated for only one unit.

The second, Senate Bill 10, allows for denser development near public transit corridors, such as bus and train lines.

Zoning regulates how land can be used, or what can be built where. Can a business be built on a given plot? That area is zoned for commercial use. Can a home or condo complex be built there? That is residential zoning. In a downtown area, you might have mixed-use zoning — say, ground-floor retail businesses and residential units in the high-rise above.

Single-family zoning refers to a residential area where only one housing unit can be built on a given parcel of land. Think of the Southern California suburban staple of a home with no shared walls - in other words, not a duplex, triplex or multiunit complex. If you live in a house with a driveway, garage, three bedrooms, two bathrooms, and front, back and side vards, it's almost certainly a single-family home.

## **CLEAN POWER ALLIANCE:** WHAT IS IT?

There has recently been some confusion related to additional electrical energy costs that have appeared on the monthly bills of Sierra Madre residents. Environmental Consultant Robert Parkhurst, a freshman City of Sierra Madre councilmember explains this situation as follows:

Councilmember Parkhurst explains that all utilities across the Western United States are experiencing high prices, due in part to a doubling in natural gas prices this year

Three years ago, rather than continuing to purchase electrical energy from Southern California Edison, the City of Sierra Madre joined Clean Power Alliance (CPA) with 29 other cities located throughout Los Angeles and Ventura counties as well as the unincorporated areas of both.

These municipalities have come together for the purpose of purchasing CLEANER local power from newly constructed or soon to be constructed, environmentally responsible renewable energy plants. Clean Power Alliance (www. cleanpoweralliance.org) has grown to become the single largest provider of 100% renewable energy to customers in the nation. Due to the efforts of CPA, more than 90% of the electricity Sierra Madreans use daily is renewable and by 2024 about half of that will originate from these newly developed sources exclusive to CPA.

Parkhurst also points out that Southern California Edison is a private company which must earn a profit and therefore adds additional costs to its customers. In contrast, CPA is a non-profit entity which does not need to add such costs, charging its customers only the cost of providing electricity. Additionally, due to CPA's work, many good paying renewable energy jobs have been and continue to be created throughout the Southern California region.

Presently, CPA customers have the choice of three categories of service: 1) Lean Power, which provides 40% clean power 2) Clean Power, which provides 50% clean power 3) 100% Green Power, which provides 100% renewable energy. The cost for each category varies, but according to Councilmember Parkhurst, 95% of Sierra Madre residents have chosen 100% Green Power. CPA customers can change to another level at any time.

CPA recognizes that many Southern Californians have been adversely impacted by the COVD-19 pandemic and thus may have trouble paying their electricity bill. As such, CPA's Board of Directors voted to provide \$2 million in COVID bill assistance, which helped more than 72,000 residential and small business customers.



As reported last week, the Preserve Sierra Madre Steering Committee has been studying the Draft Environmental Impact Report (EIR) for the housing project of 42 large homes (2700-4000 square feet) on the Monastery property, as well as their Specific Plan, 13 appendices, zoning changes, and the City's General Plan. We have come to the conclusion that we cannot support this Monastery project (The Meadows at Bailey Canyon) as presented for many reasons. The major ones are:

#### TREES -

The developer's Specific Plan for the project named The Meadows at Bailey Canyon calls for the removal of 100 irreplaceable mature trees, 10 of which are protected Coastal Oak. Removing over 100 trees is a significant environmental impact, not only to the Monastery property, but to the neighboring community as well. This is in defiance of the General Plan's goals and policies of continued preservation and protection of existing trees, increasing the City's community forest, and continuing to develop tree preservation and protection measures.

#### TRAFFIC -

Goal 3 of the developer's Specific Plan is "preservation of quiet neighborhoods with limited thru traffic." In reality, the project does nothing to preserve quiet surrounding neighborhoods to the east and south. It does, in fact, increase thru traffic by a minimum of 300-400+ car trips a day. To get to the project, the cars will have to travel local streets including Sunnyside, Lima, Carter and Grove. There is no mention of the impact in the EIR of traffic on these streets.

#### WATER -

The developer has assured the City of 'net zero' water usage, which they interpret to mean they will purchase water up front for the next 50 years and store it for future use. California and surrounding states are in an unprecedented drought. The Colorado River is the lowest it has ever been, and its water usage is already being rationed for Nevada, Arizona, and Mexico. Imported water is not as sustainable as ground water. General Plan Objective R12 is to optimize the use of water resources. Building 42 large homes will be counter to this.


The project site is located in a very high fire severity zone, according to the Cal Dept of Forestry and Fire Protection and our Fire Department. It is inconsistent with our General Plan that states clearly that we not expand development in these areas. Local streets can't support emergency equipment. Parts of Sierra Madre have been evacuated three times in the last 35 years, and the incidence and intensity of wildfires has been increasing.

#### EARTHQUAKES -

The project is located near the Sierra Madre Fault as well as the Raymond and Clamshell Faults. In 1991, the Sierra Madre earthquake damaged one of the Monastery buildings beyond repair and 22 homes in the proximity of Sunnyside were condemned, with damage to 403 structures, resulting in \$12.5 million in damages.

The Specific Plan disregards the five years of work that volunteer citizens spent creating a comprehensive vision and its guiding principles for Sierra Madre, called the General Plan. The developers disregarded our vision and replaced it with a poorly written Specific plan which is inconsistent with many of our goals, objectives and policies. They call the Specific Plan: "Sierra Madre quality." The project fails to develop high quality housing, fails to address traffic issues, and fails to ensure community compatibility with our distinctive small town.

Assemblymember Chris Holden presented, at last weeks City Council meeting, a check for \$4 million to the City of Pasadena and the Pasadena Public Library to help seismic retrofit and restoration of the

Central Library.
According to city officials after a long closure of Pasadena Public Library facilities due to the pandemic, many looked forward to the reopening of the Central Library and its nine branch libraries. In April, the first to open was the Central Library. It was short lived as the city discovered that the building was not safe should there be an earthquake.

On May 3, city officials were forced to close Central Library for a required seismic retrofit and restoration to meet life safety requirements. A structural assessment revealed that most of the building consists of unreinforced masonry.

The city moved to work towards identifying a plan for seismic upgrades, restoration, and reopening of the facility. The city reached out to Holden. Just one month later, it was announced that the State of California had approved in its budget \$4 million to be used for the design and drawings for the seismic upgrades of the Pasadena Central Library.

At the City Council meeting, Holden said, "Having served on this council, I understand first-hand how important this library is to the community."

In the previous year, prior to the pandemic closure, Pasadena Public Library greeted over 616,000 guests, with the Pasadena Central Library hosting 232 group events and 876 community and organization meetings.

With these initial funds now secured, the city will assemble and manage an architectural engineering design team of experts that will bring the iconic Central Library back online to ensure access to library services and programs for future generations, and to preserve the historical features of the Central Library

## Vaccine Proof To Be Required at Events, Bars and Nightclubs

A Pasadena Health Officer Order was issued Monday, requires proof of COVID-19 vaccination or a pre-entry negative test for outdoor mega events starting Oct. 7; children under 12 are exempt. The Health Officer Order also requires vaccination verification for customers and employees at indoor portions of bars, breweries, nightclubs and lounges.

The requirement is for vaccine verification or a negative test within 72 hours prior to attending an outdoor mega events with more than 10,000 attendees that are ticketed and/or have controlled points of entry to a well-defined area, such as sporting and music events. Customers receiving indoor service in bars, breweries, nightclubs and lounges, and employees must provide proof of at least one dose by Oct. 7 and full vaccination by Nov. 4. Although the new order does not apply to restaurants, vaccination proof for customers dining indoors is strongly recommended.

The order puts in place safety measures to address the continued need to reduce community transmission of COVID-19, which is still at a substantial level in Pasadena, For more information visit: cityofpasadena.net.

## **DUARTE CERT TO HOST** PREPAREDNESS POP-UP

The Duarte Community Emergency Response Team (CERT) will host a preparedness pop-up at Target (1050 Huntington Drive) from 5-9 PM on Friday, October 8 and from 1-5 PM on Saturday,

Over these two days, Duarte CERT will discuss the importance of preparing a 72-hour emergency kit in the event of a disaster. Additionally, they will walk residents through building their own kit, including providing a list of necessary items.

"This is the time for residents to ask any questions they might have about building their own kit, plus they can pick up necessities in a single shopping trip, right after vis-iting CERT," stated Duarte CERT Coordinator Tony Hadloc. "Many necessities are easily accessible at our local Target or Walmart."

CERT is a nationwide program that educates volunteers about disaster preparedness. Volunteers learn basic disaster response skills, such as fire safety, search and rescue, team organization, and disaster medical operations. During emergencies, volunteers put their skills and basic training into practice, freeing up professional first respond-ers to focus on complex, urgent needs.

"We hope the community takes advantage of having Duarte CERT members right at their fingertips," said Public Safety Director Brian Villalobos. "As one of the most active CERT programs in the region, we invite residents to come learn how to best keep their families safe in the event of an emergency."

In addition to providing emergency kit information, Duarte CERT will also have details about upcoming classes and virtual training.



## DESKS FOR KIDS PROJECT HIGHLIGHTED

This year of the pandemic has been a challenge for everyone. The West Covina Kiwanis Club certainly stepped up to the plate. Member, Andres Casteneda, saw a posting on Instagram. ## PUBLIC HEALTH CLOSELY MONITORS OUTBREAKS; VACCINATION REQUIREMENT FOR HEALTHCARE WORKERS GOES INTO EFFECT

The Los Angeles County Department of Public Health (Public Health) closely monitors community outbreaks as the Delta variant comprises 100% of all variants sequenced by the Public Health lab

The highest numbers of outbreaks among vulnerable people in healthcare and residential settings over the last few months have been in settings serving people experiencing homelessness (40). Meanwhile, outbreaks at skilled nursing facilities (21), other long-term care facilities (15), and healthcare settings (1), where vaccination rates are relatively high, have been relatively low. These differences are real-time evidence of the protective effect of vaccines among our most vulnerable residents

Public Health continues to closely follow disease transmission at schools. Weekly student cases increased in August from about 1,300 to a peak of nearly 2,800 cases the week ending August 22. The number of student close contacts increased correspondingly to a peak of nearly 11,000 by the end of August. Both student cases and contacts have since decreased substantially; last week, the County saw 829 student cases and 3,100 student close contacts. Meanwhile, staff numbers have also de-creased weekly from their high point of 403 staff cases and 493 staff close contacts in mid-August: last week, there were only 109 staff cases and 26 staff close contacts.

While overall case numbers in schools are trending downward, the number of outbreaks has increased slightly over the last few weeks, from 11 outbreaks the week ending September 18, to 12 outbreaks the week ending September 25. Youth sports account for most outbreaks, although the County is seeing some outbreaks in elementary, middle, and high schools. These numbers are impressively low given that 3,000-plus schools are now open countywide.

There are various vaccination verification requirements affecting L.A. County residents and workers. Today, September 30, is the deadline for health care and home health care workers across L.A. Coun-ty to be fully vaccinated. Earlier this week, the state issued a new order requiring workers in adult and senior care facilities and in home direct care settings to be fully vaccinated by November 30. L.A. County employees have until October 1 and L.A. City employees have until October 5.

On October 7, proof of full vaccination or a negative test result will be required to enter outdoor mega events, and proof of at least one dose of the vaccine will be required to enter or work in indoor portions of bars, lounges, nightclubs, brew-

eries, wineries, and distilleries in L.A. County. On Novem-ber 4, bars and similar establishments throughout L.A. County will be required to verify full vaccina-tion of all patrons and employees prior to entry to indoor portions of their establishments.

With cases declining in communities and schools, the County can focus on increasing vaccination rates as quickly as possible to avoid the disruption that would come with future waves of infection.

As of September 26, 92% of L.A. County residents 65 and over have received at least one dose of the vaccine, 78% of residents 16 and over and 77% of residents 12 and over. Sixty-nine percent of residents 12 and over have been fully vaccinated. Sixty-seven percent of L.A. County teens between the ages of 12 and 17 received at least one dose and 59% are fully vaccinated. Out of the nearly 10.3 million L.A. County residents, including those who are not yet eligible for the vaccine, 66% have re-ceived at least one dose, and 59% are fully vaccinated. Millions of eligible residents remain unvac-cinated.

Last Friday, September 24, the County began administering booster doses as well as the additional doses administered to immunocompromised people. Countywide, a total of nearly 105,930 third dos-es have been administered by L.A. County providers.

The County continues to send hundreds of mobile vaccination teams into neighborhoods where un-vaccinated people live and work to administer first, second, and third doses of vaccines. Ninety-five percent of mobile unit visits scheduled this week will be offering Pfizer vaccines, including boosters, and 704 fixed sites are offering Pfizer boosters. Over the coming weeks, Public Health mobile teams will be targeting communities with limited access to Pfizer doses to ensure that access to boosters is easy across the county.

Vaccinations are always free and open to eligible residents and workers regardless of immigration sta-tus. Anyone 12 and older living or working in L.A. County can get vaccinated. Boosters are available for eligible individuals at all sites offering the Pfizer vaccine. 

"Time in a Bottle" was a hit song by singer/songwriter Jim Croce. A question I am asked almost weekly basis is "does wine get better as it spends more time in a bottle?" Answer is "yes... and no".

Philipe Jeandet is a professor at University of Reims Champagne-Ardenne in France, and was lucky enough to discover a shipwreck that had quite a cargo. Gold? No, champagne. Jeandet and his crew brought all 168 bottles to the surface, and actually opened one on the spot. First tastes were fantastic. Given his knowledge of bubbles, his first guess was that they were at least 100 years old. The bottles had no boxes or labels, so after a few years of inspecting the corks and bottle engravings his group decided that the champagne was over 200 years old. It's home at the bottom of the Baltic Sea provided total darkness and a temperature of 35 degrees, aided by the compression of depth

for the discovery, perfect for storing wine.



Your home wine cellar provides somewhat different conditions than the bottom of the Baltic Sea, so getting back to the question above, does wine get better with age? Yes, wines that are expensive or rare will get better. No, most wine is produced to drink now. In fact, up to 90% of wines don't actually get any better with ageing.

Many of us will let our wines breathe, especially the reds, and that's fine. I suggest using a large wine glass with enough room to swirl your wine around, watch the legs on the glass, and drink. Many of my class "A" sommelier friends contend that if it's not ready drink, it isn't ready to buy. I agree!!

As for champagne, my storage procedure (for a single bottle or case) is to simply leave it on the floor of my closet, laying each bottle sideways. Champagne, for many, is only for special occasions, whereas for me it is a weekly toast. You should only put champagne in the refrigerator when you are ready to serve it. Once opened it will only last a few hours, so make sure you have plenty of help to drink it.

My bottom line on the subject is to let the supermarkets and wine shops take care of the storage for you. They have the right equipment, and it is a heck of job (and a lot of money) to build your own wine cellar.







#### LOCAL PRINCIPAL WINS NATIONAL EDUCATION AWARD HONORED FOR ACHIEVEMENTS AT FROSTIG SCHOOL **DURING PANDEMIC**

The National Center for Learning Disabilities (NCLD) honored Frostig School Principal Jenny Tucker Mottes with its Everyday Champion Award for her "heroic and outstanding achievements made during the COVID-19 pandemic."



Ms. Tucker Mottes has been principal of Frostig School in Pasadena for eight years. She has worked tirelessly throughout the pandemic to provide Frostig students with a strong academic program while also supporting their social and emotional needs.

The Everyday Champion Award recognizes those who have gone above and beyond helping children with learning and attention issues while distance learning during the COVID-19 pandemic," the NCLD said in announcing the award. "One in five children nationwide has a learning disability or attention issues and these champions have been crucial to their success in the classroom." Frostig School has been a leader in the field

of learning differences since Dr. Marianne Frostig established it 1951. The school, which has a second campus in West Los Angeles, provides an individualized education to 120 students in grades 1-12 who have complex

learning differences.

"As principal of a small school, Jenny was required to provide leadership on every front of this pandemic, from curriculum development to the design and

implementation of protocols for the safe reopening of our campus," said Dean Conklin, executive director of The Frostig Center. "I have worked closely with Jenny throughout the pandemic and I constantly marvel at her infinite optimism and positivity in the face of unprecedented challenges and stresses."

The NCLD, based in Washington, D.C., advocates for strong federal policies, convenes experts to discuss pressing issues facing the field, and publishes research and resources to improve practices in schools.

The organization named two Everyday Champions, an administrator and a teacher. An educator in Moorestown, NJ, won in the teacher category. Ms. Tucker Mottes and Ms. Maurer were awarded \$5,000 prizes. They will be honored at NCLD's Annual Benefit, virtually, on November 9.

## M HOW DOES THE ADMINISTRATION OF A WILL

When someone executes a will (this person is called the testator) he or she names another person or persons to inherit the testator's assets at death (this person is called the beneficiary or beneficiaries, if more than one). For the assets to legally be retitled in the beneficiary's name, however, the will must first pass through the court process known as probate.

The first step in the probate process is for the executor (the person named in the will to transfer the testator's assets after death) to file a petition for probate, along with the original will – not a copy – with the court in the county where the testator resided at the time of death. The court will then validate the will by determining if it is in fact the testator's will and that it was executed properly. Once the will is validated, the court will qualify and appoint the executor and issue "Letters Testamentary" which grants the executor legal authority over the assets of the estate - the estate is simply whatever was owned by the decedent.

Once the executor receives this authority from the court, the decedent's assets can be gathered. A taxpayer ID number for the estate should be applied for and a bank account for the estate should be opened. It is the executor's responsibility to safeguard all estate assets throughout the process. For example, property taxes must be paid, homeowner's insurance maintained, heirlooms and other personal property must be protected from theft or damage. The executor must then file an inventory and appraisal of all estate assets with the court. Creditors will then have four months to make a claim for any debts owed against the assets of the estate. Once all creditor claims have been paid or settled and the final tax return for the decedent and the estate has been filed, the executor may petition the court to close the probate. The court will issue an order for distribution and the executor can then transfer all the estate assets to the beneficiaries.

There are waiting periods and scheduling delays inherent in the process which often mean probate proceedings drag out for years. During probate, there's also the chance that someone might contest the will, make a false claim against the assets, or dispute the division of the property. All of this can add time, expense, and emotional angst to the process.

Unlike wills, however, trusts don't require your family to go through probate, which saves them time, money, and the potential for conflict. Plus, when you have a trust set up, the distribution of your assets happens in months, rather than years, and in private rather than the completely public forum of a courtroom.

While a simple will makes sense for some Californians, for those who own real estate and/ or have dependents, a trust should be seriously considered for the time, cost, energy, control, and privacy benefits it provides over the probate process.

#### LA COUNTY'S REPORT ON CANINE INFLUENZA H3N2

Just as we humans are experiencing an unprecedented uprise in bio-viral attacks, it seems so are our precious pets. Although we all have, throughout history, had to fight the "bugs" that bother us, there have been signs that would indicate the battle between the stronger strains, and our ability to fight them is becoming more and more by Chris Leclerc challenging over time. When COVID-19 crept in on us, it had not occurred to me that there may be a similar trend that might offend our canine

cohorts, but I suppose I should have seen it coming and should not be too surprised by its arrival. I'm no scientist, but in a layman's way I do understand the tiny bits and pieces in the microchemistry of living things on our planet, and I "get" the fight between the good and evil organisms.

So, while we humans went about avoiding and immunizing ourselves against the most intense killer virus that has ever plagued us, a canine-focused bug was creeping up and has recently forced our precious pets to make lifestyle adjustments of their own. I first heard about the new canine flu from a client who knew about it from a friend whose dog typically goes to daycare but was asked not to come, due to other guests showing signs of 'kennel cough' and being asked to go home. That was sometime in August and honestly, it didn't seem like a 'thing' to me. Just a predictable wave of kennel cough that should be avoided at all costs.

Next I was told by another friend in town that there was this new thing going around; more like a flu virus among canines and I was sorry to hear that, yet I was still not so concerned that I felt the need to spread the word. I guess I was thinking perhaps some folks were becoming a bit paranoid and assigning too much meaning to a few 'one-off' kennel cough cases, based on our recent horrific experience with the Corona virus.

Then, last week I learned of more sick pups being sent home from daycare, due to a highly contagious poly-symptomatic bug, and I thought this really must be a problem beyond the typical kennel cough we are all so familiar with. So I decided to look into it and share whatever information I could find with my readers. The following information is from the LA County Dept. of Veterinary Public Health website. I feel confident that the science is solid and I hope it helps my fellow pet parents decide what is best for their babes.

#### Overview of Canine influenza H3N2:

The canine influenza virus H3N2 (CIV H3N2) usually causes mild to moderate disease in dogs and on rare occasions can also infect cats. This strain of canine influenza was first found in the US in 2015 when it was detected in Chicago and spread to other parts of the country.

Infected dogs start shedding the virus 2 days before the start of clinical signs, and for at least 21 days or more afterward, even after they appear healthy. In August 2017, the Veterinary Public Health Program (VPH) learned from The College of Veterinary Medicine at the University of Wisconsin that some infected dogs may shed the virus for 30 days or more. Transmission of influenza usually occurs through contact with infected respiratory secretions (e.g. coughing, sneezing) as well as from contamination of the environment (e.g. bedding, floors, bowls, collars, leashes). To date, there is no evidence that humans can become sick with canine influenza H3N2.



When CIV H3N2 cases occur locally, VPH's goal is to stop the spread of the virus to protect the animals of our county. The most effective tool in stopping the spread is home isolation of sick dogs for 28 days from the first day of illness and a 14 day quarantine for exposed dogs (to see if they will develop symptoms). VPH strongly recommends that dogs be vaccinated against CIV H3N2 before they enter boarding kennels, dog day care, dog parks, or engage in dog group activities. This vaccine is also advisable for dogs that may occasionally encounter other dogs.

Current Outbreak of Canine Influenza H3N2 cases in

Los Angeles County, July - September 2021: Between July and September 22, 2021 a total of 279 confirmed cases and 120 suspected cases of CIV H3N2 in dogs in LA County have been reported to Veterinary Public Health. Sadly, 5 deaths in dogs have been associated with this outbreak. Of the cases reported, most were associated with attending boarding kennels or dog daycare settings. There are a number of cases that have never visited a boarding or daycare facility, but were exposed while on walks in their neighborhood, at dog parks, groomers, or at veterinary clinics. This virus has spread rapidly among dogs throughout LA County, affecting many congregate facilities. Based on interviews with these facilities, many additional cases have not yet been reported to VPH. We suspect that this outbreak likely involves more than 1000 cases of CIV H3N2 in LA County dogs. Dogs that appear to have 'kennel cough' have a high likelihood of having CIV H3N2. To date, this is the largest outbreak of CIV H3N2 ever reported in LA County. To stop the spread of this outbreak, pet owners and veterinarians are strongly encouraged to vaccinate dogs against CIV H3N2 and isolate sick pets at home for 28 days from the first day of illness. Pets exposed to confirmed or suspected cases should be kept on a home quarantine and observed for clinical signs for 14 days.

#### Recommendations:

If your pet has symptoms of influenza, keep it away from other animals and contact your veterinarian. Symptoms of influenza may include: cough, fever, sneezing, discharge from the nose, lethargy, and/ or loss of appetite. Some dogs have no symptoms. Vaccinate dogs against CIV H3N2 before they enter boarding kennels, dog day care, dog parks, or engage in dog group activities. This vaccination is also advisable for dogs that may occasionally encounter other

If your pet is sick, keep your pet at home for 28 days from the first day of illness - this will help to prevent your dog from spreading the disease to other dogs even after they are fully recovered. If your pet is asymptomatic but was exposed to other sick pets, keep your pet at home for 14 days to monitor for symptoms and then contact your vet if they become ill. To prevent spread of disease, do not let a sick pet share its food bowl, leash, toys, or other supplies with other pets.

Wash your hands after touching your pet.

"But isn't coffee bad for my health?"

Much has been said and written about the benefits vs. the detrimental effects of coffee. But what is the "bottom line"? Are there beneficial qualities? Does it harm me? Should it be abstained from? Is it OK to drink coffee in moderation?

These and similar questions are not easily answered because, in the tests and statistical data, researchers and doctors do not use -- or attempt to define -- a consistent standard for what is meant by "coffee."

Coffee has also been accused of causing, or contributing to, cancer, heart diseases, hypertension, hepatitis, and cirrhosis of the liver. Dr. John Timson of the University of Manchester in England, while admitting that coffee is mildly addictive, states that, at present, there is no hard scientific evidence that links the use of coffee to any of the above-mentioned diseases.

Unfortunately, in virtually all studies done on the health effects of coffee, researchers indiscriminately lump all "coffees" together. But no two cups of coffee are alike. And it is not likely that any standard will ever be established for coffee research. Why? Because brewed coffee contains not only caffeine, but various acids, oils, and alcohols, the qualities of which vary depending on the way the coffee beans are handled from farm to cup. It is rare that any two cups of coffee are chemically identical!

The FDA (Food and Drug Administration) has placed caffeine on their Generally-Recognized-As-Safe list. Caffeine acts as a stimulant to the central nervous system. If used in excess, it contributes to nervousness, irritability, sleeplessness, anxiety, and heart palpitations.

FACTORS AFFECTING THE QUALITY OF "COFFEE"

According to Timothy Hall, a teacher with the L.A. Unified School District who has given numerous lectures on coffee, there are at least 30 factors which affect the beverage called "a cup of coffee," all of which must be taken into account if one is to draw a useful conclusion about coffee's "good" or "bad" effects. According to Timothy Hall, one cannot answer "Is coffee good for me?" until one has explored the following questions. In some cases, definitive answers to the following may be hard to come by, if not next to impossible. Some factors, however, are completely within our control.

## THE PLANT

What is the type or variety of coffee plant? Of the two primary types of coffee -- arabica and robusta -- arabica is considered the better of the two. Where and how was it grown? How was it fertilized?

What was the method of roasting? The depth of darkness of the brown in coffee color is due to the proportion of cresylic acid (cresol) present after the beans have been roasted. The darker the roast, the greater the tar content. GRINDING

What was the grinding procedure? How hot did the beans get during the grinding process? Though not everyone will notice the difference, any grinder which grinds at a high temperature can result in the loss of aromatic oils. One solution is to grind with a hand mill. Another solution (when using an electric mill) is to only grind enough for a few cups at a time, since prolonged grinding may result in excessive heat. How much time elapsed between grinding and brewing? **TEMPERATURE** 

What was the temperature of the coffee grounds, and the temperature of the water, when you began brew? What were the temperatures when you finished brewing? Fusel oil, released into the water whenever coffee grounds are boiled, causes bitterness; however, fusel oil is NOT released into water at less than boiling temperatures.

What type of coffee maker was used (vacuum, drip, percolator)? (Space doesn't permit us to review every coffee-maker on the market however, so let the buyer beware.)

Did I brew the grounds using the percolation, infusion, or decoction method? Infusion refers to adding the grounds to the water and letting them steep. A camper might do this. Decoction refers to actually cooking the grounds -- even boiling -- to make a strong brew. Though this might be acceptable in a prison camp when one is trying to extend the available grounds as far as possible, it is the least desirable choice. Percolation -- pouring the hot water through the grounds -- is the best option.

Hall asserts that in his tests, the quality of one's thinking has proven to be the most important factor. States Hall, "If you brew your coffee with precise intent, you can alchemically transmute those common grounds into a veritable elixir.'

Here are a few guidelines if you'd like to begin alchemically changing "a cup of coffee" to "wonderful elixir." This is the procedure that Timothy Hall was taught by his mentor, R. E. White of WTI in the mid-1970s.


Begin with meticulously clean utensils. Stainless steel, French porcelain, glass, or copper are preferred; softer metals (e.g., aluminum) should not be used.

Next, prepare your filter. Perhaps the best are the reusable gold-line cone filters.


Hall suggests that you pour the water over the grounds, breathing deeply, slowly, and visualizing the energy of Love flowing from your heart, down your arm, and into the beverage. This is called "chi," and much has been written about this "chi' energy in books on Chinese healing and martial arts.

There is much more to this, and Hall treats it as a science, akin to the Japanese tea ceremony. So is coffee "good" or "bad"? As always, it depends on the way you interact with it.

As is nearly always the case with such matter of "health," ALL is choice, Choice, and CHOICE, and consequence of choice.

That Sunday, as I was setting up the sound system to record the Sunday service, I could not get it working. None of the microphones worked, and there wasn't anything I could do to change it.

I had to get it fixed by Wednesday because that's when I record our weekly radio program. So if I don't get it fixed by then, I'm in trouble.

That was Sunday. Then Monday came tiptoeing along, and somebody had hacked into my email, and I could not open up my email. I worked very hard to get it open and set a new password, but nothing worked. So finally, the email service locked me out for 24 hours because I had done it too many times. It took several days to unlock my account, so I could use my email.

I still don't believe in karma, but sometimes things come back on you because of some of your ac-tions.

I read in the Scriptures that evening, "Be not deceived; God is not mocked: for whatsoever a man soweth, that shall he also reap" (Galatians 6:7).

I need to learn how to be careful in what I sow because that is exactly what I will reap.

#### HOW DOES SOCIAL SECURITY WORK WHEN A SPOUSE OR **EX-SPOUSE DIES?**

Dear Savvy Senior:

Who qualifies for Social Security survivor benefits? My ex-husband died last year, so I would like to find out if me or my 17-year-old daughter are eligible for anything? Divorced Survivor

Dear Divorced:

If your ex-husband worked and paid Social Security taxes and you and/or your daughter meet the eligibility requirements, you may very well be eligible for survivor benefits, but you should act quickly because benefits are generally retroactive only up to six months. Here's what you should know.

Under Social Security law, when a person who has worked and paid Social Security taxes dies, certain members of that person's family may be eligible for survivor benefits including spouses, former spouses and dependents. Here's a breakdown of who qualifies.

Widow(er)'s and divorced widow(er)'s: Surviving spouses that were married at least nine months are eligible to collect a monthly survivor benefit as early as age 60 (50 if disabled). Divorced surviving spouses are also eligible at this same age, if you were married at least 10 years and did not remarry before age 60 (50 if disabled), unless the marriage ends.

How much you'll receive will depend on how much money (earnings that were subject to Social Security taxes) your spouse or ex-spouse made over their lifetime, and the age in which you apply for survivor benefits.

If you wait until your full retirement age (which is 66 for people born in 1945-1954 and will gradually increase to age 67 for people born in 1960 or later), you'll receive 100 of your deceased spouses or ex-spouses benefit amount. But if you apply between age 60 and your full retirement age, your benefit will be somewhere between 71.5 – 99 percent of their benefit.

There is, however, one exception. Surviving spouses and ex-spouses that are caring for a child (or children) of the deceased worker, and they are under age 16 or disabled, are eligible to receive 75 percent of the worker's benefit amount at any age.

Unmarried children: Surviving unmarried children under age 18, or up to age 19 if they're still attending high school, are eligible for survivor benefits too. Benefits can also be paid to

children at any age if they were disabled before



age 22 and remain disabled. Both biological and adoptive children are eligible, as well as kids born out of wedlock. Dependent stepchildren and grandchildren may also qualify. Children's benefits are 75 percent of the worker's benefit.

You should also know that in addition to survivor benefits, a surviving spouse or child may also be eligible to receive a special lump-sum death payment of \$255.

Dependent parents: Benefits can also be paid to dependent parents who are age 62 and older. For parents to qualify as dependents, the deceased worker would have had to provide at least one-half of the parent's financial support.

But be aware that Social Security has limits on how much a family can receive in monthly survivors' benefits - usually 150 to 180 percent of the worker's benefit.

Switching Strategies

Social Security also provides surviving spouses and ex-spouses some nice strategies that can help boost your benefits. For example, if you've worked you could take a reduced survivor benefit at age 60 and switch to your own retirement benefit based on your earnings history – between 62 and 70 – if it offers a higher

Or, if you're already receiving retirement benefits on your work record, you could switch to survivors benefits if it offers a higher payment. You cannot, however, receive both benefits.

You also need to know that if you collect a survivor benefit while working, and are under full retirement age, your benefits may be reduced depending on your earnings - see SSA.gov/ pubs/EN-05-10069.pdf.

## STUART TOLCHIN PUT THE LIGHTS ON

## WHY DO WHAT WE DO?



On the Bill Maher show last Friday I saw Tristan Harris being interviewed. In the interview Harris explained how today's major technology platforms have increasingly become the social fabric by which we live and think. He explained that the defining quality of any individual is that to which he or she is focused upon. He described the different levels of focus as consisting of, of course, our conscious attention.

This conscious attention is like our "to do lists". We focus on these things that result in our intentions and eventually our actions. There is another kind of attention

that exists below our consciousness. This level is the result of all the experiences to which we are subject and is responsible for our attitudes, beliefs, and ideals. We are not readily aware of these influences but rather experience ideas just popping into our heads which often lead to specific intentions, and finally to actual actions. Tristan Harris asserts that social media is solely concerned with obtaining attention from its consumers such that more can be learned about them which is designed to increase susceptibility to persuasive techniques used by the advertisers who fund the platforms. What the advertisers want is to sell something and make money. This was certainly no surprise.

What was also no surprise is that the kind of thing that most grabs people's attention is spectacle, confrontation, negativity, competition and fear. This is the content of much of social media and according to Tristan Harris the result has been to create an underlying experience of fear and negativity which exists below the surface in many of us of which we are not aware. David Foster Wallace, in a 2005 commencement speech, delivered the following anecdote:

There are these two young fish swimming along and they happen to meet an older fish swimming the other way who nods at them and says "Morning, boys. How's the water." And the two young fish swim on for a bit and then eventually one of them looks over at the other and goes "What the hell is water?"

David Foster Wallace, explained the anecdote by saying that what is important to any individual is not really freedom of thought or freedom of speech but rather freedom of choice about what to think about. He makes the similar point as does Tristan Harris that it is the totality of our underlying experiences, of which we are basically unaware, that is responsible for the very ideas that pop into our head rather than exercise of freedom by the individual.

I thought of Wallace's speech as I read this morning about 39 year old five time Olympic medalist Klete Kelter, a USC product (I'm a UCLA guy which partially explains my point) who stood out amid the chaos in the Capitol Rotunda on January 6 thanks to his 6 foot 6 height, beard and distinctive U. S. team jacket with USA written in large letters on the back. Later he admitted to throwing away the jacket in the hope that his participation would not be discovered.

In attempting to understand what Kelter had been thinking about that lead to his intention to participate in the insurrection and the subsequent action he took I, parenthetically, mentioned the fact that he was a USC product. Without any conscious decision to focus on that particularity the thought popped into my mind, frivolous and irrelevant is a living example of how our subconscious works. Certainly the college he attended was irrelevant but the non-stop rivalry between the two Southern California colleges, surrounding me for sixty years, subconsciously initiated the thought which popped into my mind. This is not freedom of thought; it is no exaggeration to say it is a kind of mental imprisonment in which we barely understand ourselves. If our society is ever able to bring about an understanding between the highly partisan composition of our electorate it is necessary that we understand the underlying thoughts, prejudices, experiences and whatever else is in the water that has resulted in actions seemingly unthinkable to others. Tristan Harris asserts that social platforms in their never ending quest to please advertisers and make more money have wittingly, or unwittingly, created a partisan society afraid of itself and unwilling to learn why. It would be wonderful if social media somehow did a turnabout and presented more compassionate, humane, material that would therefore bring about a more congenial society and a congenial world. I don't participate in social media and I won't hold my breath but the water around me, unnoticed or not, will let me know what's happening.

#### STICKING WITH MY FATHER ON JOHN HINCKLEY

News that a federal judge had approved the unconditional release of John Hinckley Jr. next June set my phone to ringing furiously earlier this week.

Journalists naturally wanted to know what I thought about the decision to let Hinckley go free after serving nearly 40 years in a mental hospital for trying to assassinate my father on March 30, 1981.

Hinckley, now 66, has been living on his own outside the mental facility for several years without incident and doctors say he is no longer violent and shows no signs of mental illness. But my sister Patty and many conservatives think approving his release was the

wrong decision. They believe Hinckley, who was found not guilty by reason of insanity, is still a

threat to society or doesn't deserve to be fully released.

I totally understand their emotional reactions, but none of them ever talked to Ronald Reagan about forgiving Hinckley like I did. This week when people asked me about Hinckley, I told them I don't have a prob-

lem with him becoming completely free because I'm going to side with Ronald

My father publicly forgave Hinckley long ago. He did it within days of being shot and before he went back to work at the White House on April 11. He even wanted to visit Hinkley, but the Secret Service wouldn't allow it.

What was good enough for my father is good enough for me. He was one of those rare people who didn't just recite "The Lord's Prayer," he

When he asked God the Father to "forgive us our trespasses as we forgive those

who trespass against us," he meant it. I'm not going to be angry for the rest of my life at a mentally disturbed guy who tried to take my father's life. My father didn't hate Hinckley, why should I? He was never a hateful or vengeful man - even after almost dying from an as-

sassin's bullet. In private, and with his family, he was the same affable guy who quipped to Nancy "Honey, I forgot to duck" and said to the emergency room doc-tors "I

hope you're all Republicans." To prove what I say, here's a loose retelling of the conversation I had with him six hours after he got off the operating table at George Washington University

When my wife Colleen and I walked into his room, my dad looked up at me

from his bed and said, "Mike, if you're ever going to get shot, don't be wearing a new suit." 'Excuse me?'

"Well, yesterday I was shot." "Yeah?

"That blue suit I was wearing was a brand new suit. It was the first time I ever wore it. The last time I saw it they had cut it off me and it was in shreds in the corner of my hospital room. So that's why I'm telling you, 'If you're ever going to be shot, don't be wearing a new suit.'

Then he said, "That young man who shot me - Hinckley." "Yes," I said, "John Hinckley."

"I understand his family is in the oil business."

"Do you think they have any money?"
"They're in the oil business and they live in Denver. Of course they've got money.

"Well, do you think they'd ever buy me a new suit?"

That was what my father was really like. Unlike so many people in and out of politics today, he was never angry - even after being shot.

Humor was his way of putting people at ease, whether it was his worried son, his doctors or the entire country. His good-natured temperament – and the virtue of forgiving the trespasses of others – are what we miss and what we could all use a lot more of today.
