Two new Bills, effective January 1, 2022, will impact single-family zoning in California.

The first, Senate Bill 9, makes it possible to build more than one housing unit on land that was previously designated for only one unit.

The second, Senate Bill 10, allows for denser development near public transit corridors, such as bus and train lines.

Zoning regulates how land can be used, or what can be built where. Can a business be built on a given plot? That area is zoned for commercial use. Can a home or condo complex be built there? That is residential zoning. In a downtown area, you might have mixed-use zoning - say, ground-floor retail businesses and residential units in the high-rise above.

Single-family zoning refers to a residential area where only one housing unit can be built on a given parcel of land. Think of the Southern California suburban staple of a home with no shared walls - in other words, not a duplex, triplex or multiunit complex. If you live in a house with a driveway, garage, three bedrooms, two bathrooms, and front, back and side vards, it's almost certainly a single-family home.



THE LASTING MEMORIAL TO **EDDIE VAN HALEN**

On Monday, October 11th, the City of Pasadena's officials unveiled a plaque memorializing Edward Lodewijk Van Halen at the Pasadena Civic auditorium, the venue where he, along with his band Van Halen, performed at least fourteen times during the 1970s.

Van Halen, who many consider was the greatest, most innovative rock guitarist of all time, grew up in Pasadena, and with his brother Alex, attended Pasadena schools after immigrating from Holland.

Eddie's passing just over a year ago on October 6th, 2020, was devastating for his family, but also sent shock waves around the world to his millions of followers.

Two such fans are Pasadena residents Randa Schmalfeld and Julie Kimber - who thought he should be properly remembered for his contributions to Pasadena as a world renowned resident, outstanding musician, inventor and song writer. Sch-malfeld and Kimber formed the Pasadena4VanHalen Facebook page, and a Go-FundMe page, which raised money from fans around the world. The funds paid for this plaque and will also go toward commissioning an Artist for a mural at Pasadena High School and other citywide projects which they hope will transpire.

As a classmate of Eddie's at Pasadena high, I felt nostalgic attending this unveiling – memories from school days flooded back. The shy but kind boy in class, the impish grin I'd see on his face while he shuffled by, head down, murmuring 'Hello, Cathy'.

English was not his first language, it was discovered later than he and Alex were bullied – possibly for their accents or maybe due to their mixed race heritage.

Back then friends and I attended parties in garages and homes in the area where his fledgling (and very loud) band was playing. They were called Mammoth with Eddie, his brother Alex the drummer and our classmate Mark Stone on bass. Later they were joined by David Lee Roth, also from Pasadena, as well as Michael Anthony, and the band exploded on the rock scene; changing its name to Van Halen.

Stories of the band's wild antics at those parties and their meteoric rise to fame abound - lots of them are recounted in Greg Renoff's book: Van Halen Rising. Some of my friends kept in touch with Eddie through his years of fame, though I did not. And a few even attended his wedding to the actress Valerie Bertinelli in April of 1981.

Little did we know that in 2015 Edward Van Halen would play his last concert – this time with his son Wolfgang on bass and David Lee Roth, who reunited with them as their original frontman – replacing Sammy Hagar's term with the band. A group of us from Eddie's class of | '73 bought tickets for this show at the Hollywood Bowl, enjoying a picnic and mini-reunion until the concert began.

We were in awe that Eddie, in his 60s then, enthralled everyone with his energy, tapping away at that Guitar, erupting with *Eruption* and all of their big hits of the 1970s and 80s. The audience couldn't get enough!

A few days after that concert, Greg Renoff, Educator and Author, drew a standing room only crowd at Vroman's bookstore for a presentation and book signing of Van Halen Rising. The band's celebrated producer, Ted Templeton, was also there along with fans and Pasadena High School Alumni. We were overjoyed when Mark Stone joined us that evening. Ironically Mark passed away from cancer, just a week before Eddie in 2020.

Back to the plaque:

The unveiling was conducted by L

Pasadena Mayor Victor Gordo and council members Tyrone Hampton, Andy Wilson, Gene Masuda and Felicia Williams, along with the press i.e. media- it was not open to the public due to coronavirus restrictions. Wolfgang, Alex and Eddie's widow: Janie Van Halen could not attend either due to scheduling conflicts.

I thought it was timely that it is during Mayor Gordo's term in office to unveil this plaque as he remarked that he too is a fan of the band and also attended Pasadena High School.

I love that Felicia Williams as well as Randa Schamlfeld are both from District Two in Pasadena, where the Van Halens used to live. As Williams said: "This event brings together history and community to celebrate a world-renowned artist."

It's not just the history of Eddie as a guitar legend, but also the challenges he faced growing up mixed race in Pasadena, which always spoke to me. And the community support and initiative to make this happen is inspiring.

Van Halen Rising: How a Southern California Backyard Party Band Saved Heavy Metal



Recently I attended a book signing at Vroman's in Pasadena, in a standing room only crowd of my contemporaries, many of them Pasadena High School classmates. Greg Renoff, along with legendary rock and roll producer Ted Templeman, told stories with whom many in the room were familiar: How a Pasadena 'garage' band rose to stardom. Eddie and Alex Van Halen were my classmates; and the flamboyant, but brilliant, comedian and frontman, David Lee Roth, attended Pasadena City College with us in the early 70's. Whether or not you are a fan of Van Halen's music, there is no doubt that Eddie became and still is considered one of the greatest rock guitar players of all time.

Though not a fan myself, I AM a fan of the author, who, with his PhD in American History, was the Associate Professor of History at Drury University, and interviewed hundreds of people from the San Gabriel Valley, including many Sierra Madre residents. He painstakingly chronicled the history of Van Halen's humble beginnings before their meteoric rise to fame and platinum record sales.

The Van Halen family sailed across the Atlantic from Holland, with \$50 and a piano in the 1960s, eventually settling in Pasadena. The rags to riches tale, the music lessons, the raucous high school parties; later playing in seedy clubs of Hollywood before being 'discovered,' all make for a fascinating read of the history of the boys in the band from our own backyard.

Letter To The Editor

THEY CALLED IT PARADISE?

A small town in the forested hills emerged at the base of the Foothills near the Sierra Nevada Range in Butte County. As the setting was idyllic, offering clean air and gorgeous scenery, the people called it Paradise, As the town thrived more people came, stayed, and called it home. The town grew, but grew so much the ingresses and egresses of the town (in case of a major fire)were basically forgotten or ignored until disaster struck. On November 8, 2018 disaster struck as 95% of the town was lost, Fueled by a sea of tinder created by 5 years of drought, and propelled by 40 mph powerful gusts of wind, the flames grew and traveled rapidly. Burning at a rate of a football field or an acre a second. In less than 24 hours, the fire had swept through the town of Paradise and other communities, leaving a charred ruin in its wake. "Over the course of 17 days, the Camp Fire, named for its origin along Camp Creek Road, killed 85 people, burned more than 150,000 acres, and leveled more than 18,000 buildings — a hospital, houses, businesses, schools — making it the most destructive and deadliest wildfire in California history.". As Wikipedia stated....."The fire forced the evacuation of Paradise, Magalia, Centerville, Concow, Pulga, Butte Creek Canyon, Berry Creek and Yankee Hill and threatened the communities .. The actual total statistics were 153,336 acres burned or 240 square miles caused by an Electrical transmission fire from a PG&E killing 85 people and destroying 18,804 buildings. Do you want Sierra Madre to become another Paradise?

On September of 2020, the Bobcat fire broke out in the hills behind Monrovia and came back down the canyon towards Sierra Madre, Alta-

dena, and Arcadia. It was finally contained by December 18.2020 after having burned 115,796 acres in the central San Gabriel Mountains. Evacuation orders for residents were announced in Sierra Madre, Monrovia, Bradbury, and Duarte, along with evacuation warnings for those in Arcadia, Pasadena, and Altadena. The fire then grew westward and threatened the Mount Wilson Observatory by September 15, and approached within 500 feet (152 m) of the observatory as firefighters worked to protect the structure. The fire came so close that the paint bubbled on the building from the heat. By September 17, the fire rapidly expanded to the north into Pleasant View Ridge Wilderness due to moderate coastal winds, leading to mandatory evacuations in Antelope Valley as the fire approached Juniper Hills. The ire was exacerbated by very dry vegetation from over 5 years of drought and rugged topography that made it more difficult to access.

The Monastery Housing Development site is considered to be in a Severe Fire Hazzard Area. The city decided that after The Bobcat Fire of 2020 that no further development should occur in Severe Fire Areas. After the evacuations of just over a year ago, why is this development even being considered? It should have been eliminated before any discussions ever began given its location. If the winds in 2020 had blown in another direction the monastery would have been destroyed in the fire as well as other parts of Sierra Madre .What more proof does anyone need than the unsettling two weeks we lived through in early September of 2020. Do we really want to put our firefighters in this kind of danger intentionally?

Do we really want to become another Paradise?

THE MOUNT WILSON **TRAIL RACE IS** TODAY!!

At last, the fabled, fantastic, best trail race anywhere is back! I'm hoping it's going to be a beautiful day with cool temperatures and nobody falls down. Here's some information you already know, but there might be somebody out there reading the Mountain Views News today who doesn't know...

"The Mount Wilson Trail Race is the second oldest trail race in California; first held in 1908 when runners raced to Mt. Wilson, rested half an hour, then raced back down and only a very few intrepid runners attempted it. The race was held sporadically from 1908 until the late 1940's - early 1950's when it was abandoned completely. Organized by a volunteer committee and sponsored by our fair city, Sierra Madre, the current race is 8.6 miles in length. The exact course has



been changed by erosion, fires and earthquakes, but is lovingly maintained by some amazing guys who wield shovels, move boulders, avoid the occasional bear, and just generally keep the trail in good shape." That was mostly from the Mt. Wilson Trail Race web page, except for that last part about the guys who keep the trail in good shape.

My best friend and trail race aficionado, John, and I spent many years on Trail Race day walking downtown to grab a cup of coffee at Beantown, visit with friends, look at all the goodies on display and available for purchase on Kersting Court, be awed and astonished by whatever young person was delivering the National Anthem, watch the runners take off, occasionally including our daughter, Leah, enjoy the little kids' races, and hang out till the first runners returned in some astonishingly fast time, usually around an hour. John is watching the race from heaven, along with Bud and Kevin Switzer, who both ran the race with astonishing speed for many years - which brings to mind that great verse from Hebrews...

"Therefore, we also, since we are surrounded by so great a cloud of witnesses, let us lay aside every weight, and the sin which so easily ensuares us, and let us run with endurance the race that is set before us." Heb. 12:1

The scarecrow competition is heating up all over town. And this guy tromping through the roses certainly fits the description of a scarecrow: "a scarecrow is an object made to resemble a human figure, set up to scare birds away from a field where crops are growing." Also, "an object of baseless fear."

We could certainly apply the term "scarecrow" meaning 'an object of baseless fear' to an awful lot of what is going on in our world currently, but I digress!





City Forms Team to Help **Senior Care Facilities**

Pasadena city officials reassured the public Friday that they have setup the Pasadena Elderly and Pasadena Elderly and Dependent Adult Liaisons (PEDAL) team to help oversee Skilled nursing facilities (SNFs) that provide long-term care services to many of Pasadena's frail, older adults with underlying chronic medical conditions.

According to a statement, despite regulation by the state and the county, substandard care is an ongoing and persistent problem in many SNFs throughout the region, including Pasadena. The COVID-19 pandemic magnified systemic deficiencies at SNFs.

Unfortunately, the City of Pasadena does not have direct oversight of SNFs or authority to enforce SNF regulations and standards.

In August 2021, the city established the Pasadena Elderly and Dependent Adult Liaisons (PEDAL) team. The mission of PEDAL is to improve the quality of life for elders and dependent adults residing in long-term care facilities through education, community outreach, code enforcement, and prosecution. PEDAL builds code enforcement, upon prior work performed by the city in this arena.

In June 2020, more than 60 residents were evacuated from Golden Cross Health Care (Golden Cross) in Pasadena after the skilled nursing facility's license was suspended by the Licensing and Certification Program of the CA Department of Public Health (CDPH) due to ongoing quality of care issues reported to the licensing agency by the City of Pasadena Fire and Public Health Departments, and the local long-term care ombudsman. Less than four months later, more than 30 residents were evacuated from Foothill Heights Care to excessively high indoor temperatures.

Subsequently, the Los Angeles County Office of Inspector General conducted an exhaustive review of the county's capacity to perform various licensing and certification, inspection, and investigative activities in long-term care facilities as it is contracted with CDPH to do, and found deficiencies that impeded state and county regulators from fulfilling their oversight responsibilities. The evacuations revealed issues with state and county mechanisms for triggering a crisis response, efficacy of LA County Health Facilities Inspection Division's (HFID) oversight and enforcement actions, and problems with coordination and communication between HFID and partner agencies.

PEDAL has already completed coordinated inspections, escalating operational deficiencies to regulatory agencies and is actively addressing enforceable violations.

PEDAL includes the City Manager's Office; Pasadena Public Health, Fire, Police, and Planning & Community
Development Departments; Code Enforcement; City Prosecutor's Office; WISE and Healthy Aging Long-Term Care Ómbudsman Program; and Huntington Hospital. For more Visit: cityofpasadena. net.

Council to Vote on Banning Gas Leaf blowers

The Pasadena city council is set Monday to take up the issue of gas-powered landscaping equipment, specifically gas leaf blowers, after years of complaints, with the possibility of banning them outright from being used anywhere in the city.

The issue stems from 359 complaints in the last six years, the majority (275, or 77 percent) concerned the use of a leaf blower outside the allowed hours. The remaining categories, exceeding the allowed length of use received 52 complaints (14 percent), noise level had 23 (six percent) and blowing debris over a property line had 9 (three percent) complaints city officials said.

According to the city staff report currently, all gas and electric leaf blowers are regulated in the Pasadena Municipal Code. This includes prohibitions on when a leaf blower can be used in a residential area or within also conduct an outreach 500 feet of one (before 8:00 a.m. effort that will include virtual and after 6:00 p.m., Monday through Friday; before 9:00 a.m. and after 5:00 p.m. on Saturday; for gardeners and landscapers. or at any time on Sunday.

NASA Turns to the Cloud for Help With Next-Generation Earth Mission

As satellites collect larger and larger amounts of data, engineers and researchers are *implementing solutions* to manage these huge increases.

The cutting-edge Earth science satellites launching in the next couple of years will give more detailed views of our planet than ever before according to NASA officials. "We'll be able to track small-scale ocean features like coastal currents that move nutrients vital to marine food webs, monitor how much fresh water flows through lakes and rivers, and spot movement in Earth's surface of less than half an inch (a centimeter)." But these satellites will also produce a deluge of data that has engineers and scientists setting up systems in the cloud capable of processing, storing, and analyzing all of that digital information.

"About five or six years ago, there was a realization that future Earth missions were going to be generating a huge volume of data and that the systems we were using would become inadequate very quickly," said Suresh Vannan, manager of the Physical Oceanography Distributed Active Archive Center based at NASA's Jet Propulsion in Southern Laboratory California.

The center is one of several under NASA's Earth Science Systems program responsible for processing, archiving, documenting, and distributing data from the Earth-observing satellites and field projects. The program has been working for several years on a solution to the information-volume challenge by moving its data and datahandling systems from local servers to the cloud – software and computing services that era for data handling," said run on the internet instead of

Two of those forthcoming missions, SWOT and NISAR, will together produce roughly 100 terabytes of data a day. One terabyte is about 1,000 gigabytes – enough digital storage for approximately 250 feature-length movies. SWOT, short for Surface Water and Ocean Topography, will produce about 20 terabytes of science data a day while the NISAR (NASÁ-Indian Space Research Organisation Synthetic Aperture Radar) mission will generate roughly 80 terabytes daily. Data from SWOT will be archived with the Physical Oceanography Distributed Active Archive Center while data from NISAR will be handled by the Alaska Satellite Facility Distributed Active Archive Center. NASA's current Earth science data archive is around 40 petabyes (1 petabyte is 1,000 terabytes), but by 2025 - a couple of years after SWOT and NISAR are launched – the archive is expected to hold more than 245 petabytes of data.

Both NISAR and SWOT will use radar-based instruments to gather information. Targeting 2023 launch, NISAR will monitor the planet's surface, collecting data on environmental characteristics including shifts in the land associated with earthquakes and volcanic eruptions, changes to Earth's ice sheets and glaciers, and fluctuations in agricultural activities, wetlands, and the size of forests.

Set for a 2022 launch, SWOT will monitor the height of the planet's surface water, both ocean and freshwater, and will help researchers compile the first survey of the world's fresh water and small-scale ocean currents. SWOT is being jointly developed by NASA and the French space agency Centre

Governor Signs Portantino's Mental Health Education Bills

Senate Bills 14 and 224, authored by State Senator Anthony J. Portantino were signed into law last week by Governor Newsom - just days before World Mental Health Day. SB 14 and 224 address the growing mental health crisis among California's youth by implementing mental health education and training in

"I am very thankful to the Governor for signing SB 14 and 224 into law and recognizing the urgency of implementing policies that give our kids the help they need," stated Senator Portantino. "California is in the midst of a youth behavioral health crisis exacerbated by the COVID-19 pandemic. Although the bills don't nearly go as far as they should, this is an important step forward. We need to keep these critical policies moving forward and end the stigma surrounding the discussion of mental health. Mental health education and training is one of the best ways to increase awareness and empower students to seek help," he added.

According to the U.S. Department of Health and Human Services, nearly 1 in 3 California high school students surveyed reported feeling sad or hopeless almost every day for two or more weeks in a row. Nearly 1 in 5 reported that they have seriously considered attempting suicide. The Center for Disease Control reports that from March 2020, when the pandemic was declared, to October 2020, emergency department visits were up 24% for children 5 to 11 years of age and 31% for those 12 to 17 years of age, when compared with the same period in 2019. In the fall of 2020, the number of kids with suicide attempts coming to the emergency room at UCSF Benioff Children's Hospital had doubled since the fall of 2019.

SB 14 ensures that student absences for behavioral health concerns will be treated the same as excused absences for physical health concerns. In addition, SB 14 requires the California Department of Education to recommend best practices and evidencebased mental health trainings to address youth behavioral health, including training for teachers, staff, and students on how to recognize, appropriately respond, and seek help for mental health concerns.

The measure was sponsored by a coalition of behavioral health professionals and mental health advocates led by the California Council of Community Behavioral Health Agencies, and supported by the California Behavioral Health Directors Association, Lady Gaga's Born This Way Disability Foundation, Rights California, NextGen California, and importantly, the voices of students including GenUP, California Association of School Councils, and California Student Board Member Association.

'The California Council of Community Behavioral Health Agencies (CBHA) and our coalition partners applaud Governor Newsom for signing SB 14 authored by Senator Anthony Portantino," said Dr. Le Ondra Clark Harvey, CBHA's Chief Executive Officer. "As the COVID-19 pandemic continues, youth behavioral health needs to be a primary focus to protect and promote the well-being of our students. California has once again shown itself to be a leader by implementing this life saving legislation. The work is far from done. Youth are dying, and educators and other school employees need the tools offered by quality behavioral



health trainings. CBHA looks forward to continuing to work with our elected leaders to equip our school communities with the tools needed to destigmatize behavioral health care and create supportive learning environments.

With no state-mandated health education course at the middle or high school level in California, a vast majority of California students do not receive instruction in mental health. SB 224 requires local educational agencies and charter schools which currently offer one or more courses in health education to middle or high school students to include mental health content in those courses. SB 224 also requires the California Department of Education to develop a plan to expand mental health instruction in California public schools on or before January 1,

The measure was supported by a coalition of mental health advocates, including the National Alliance on Mental Illness – California, California Alliance of Child & Family Services, California Association of Student Councils, California Youth Empowerment Network, National Center for Youth Law, and the Children's Partnership.

"We are so thrilled that Governor Newsom signed SB 224 into law," said Jessica Cruz, CEO of the National Alliance on Mental Illness (NAMI CA). "NAMI-CA has been working on this issue for years, and we are so grateful to have had the strong leadership of Senator Portantino to carry this policy through - and not a moment too soon. Every day, we learn more about the terrible toll this pandemic has taken on our children and youth's mental health. It is imperative that we enable them to understand the signs and symptoms of mental illness, overcome stigma, and know how to get help early so they can thrive."

"We are so proud of Governor Gavin Newsom and his Administration for recognizing the impact that SB 224 will have", said Christine Stoner-Mertz, CEO of the California Alliance of Child and Family Services. "Education can help move mental illness out of the shadows and build a path to treatment. SB 224 calls for reasonably designed instruction in middle and high schools on the overarching themes and core principles of mental health. With the signing of SB 224, California will prioritize supporting our children and youth by bringing mental health awareness into schools. This bill will go a long way to improve the well-being of our children and youth at school, at home, and within their communities."

SB 14 and SB 224 were introduced earlier this year and reflect Senator Portantino's dedication to improving mental health outcomes for youth. The Senator previously authored SB 972, which required schools to print the suicide hotline on student identification cards. Additionally, the Senator dedicated three years to pass SB 328, which pushes back school start times for middle and high schools.



SOCAL GAS CONDUCTING AERIAL METHANE MAPPING

Pipeline safety and maintenance is of top priority for SoCalGas. As such, SoCalGas will be conducting methane emission mapping over SoCalGas infrastructure in the Cities of Monrovia, Arcadia, Temple City, Rosemead, El Monte as well as over the community of South San Gabriel.

This new technology allows SoCalGas to detect methane emissions from the air at 500 ft altitude (within normal FAA flight operations regulations). SoCalGas will use a helicopter for the operation:

Weather permitting, the project will take place on Wednesday, October 20, and Thursday, October 21 Hours of operation will be from 8 a.m. to 5 p.m.

The Bell JetRanger helicopter will be going back and forth in a lawnmower pattern at 500 ft.

There is no threat to the community. On the contrary, detection of methane emissions is another method in helping keep the communities SoCalGas serve safe and is part of the SB 1371 Natural Gas emissions reduction program.

ARBOUR (AGAIN) !!! AN AMERICAN RESTAURANT

Open for well over three years I still look at Arbour as the New Kid on the Block!! The last time I visited Arbour on South Lake Street I was reminded that before the Smitty's, Del Frisco's, Crocodile Café and Paul Martin's, there was Burger Continental and The Chronicle, that was pretty much it for food faire on South Lake in Pasadena .

Before I get into the menu the scene is typical of any modern built from the ground up restaurant, beautiful bar area, open kitchen, a nouvelle feel to it . Certainly this not say that the other restaurants on Lake don't have their space looking sharp, but there is a feel to The Arbour that might make you think that you were dining in Napa. So much similar but so very different.... ready sports fans... Spoiler alert, there is no television, no Big Screen anywhere to be found at The Arbour, and I get it!!

This is a place with a real focus on the food, imagine that! Chef Ian Gresik was the youngest pastry chef in the US with a Michelin Star while at Patina, now those stars are hard to come by. I know Ian and his wife Nancy aren't going to like this, but do yourself a favor, call first and make sure he is there.

His presence makes the night so special when the owner/chef comes by and says hello. And, his charm is the signature of the restaurant! If you hold your breath and say M-I-S-S-I-P-P-I, you might get him to make his signature dessert, The California, right at your table. looking to score points with the one you love? This a deal closer! But wait Johnny there is more! We haven't even gone over the food yet.

My dad used to say pictures tell a thousand stories and I am glad this article includes the dishes that I tried. Start off with a couple of cold appetizers (appetizer: a small portion to stimulate the desire to eat). First up is the Seafood Salad, yep that is the name crab, shrimp and shellfish with parsnips and meyer lemon vinaigrette, (Side note, if you like lemonade, Meyer lemons are the best. Next was the Bison steak tartare, Fresno chili stamp served with puffed bread.

As I have mentioned just before I was born my parents lived in Germany and tartare was very common, Chef Ian of course was familiar with European eating habits, next up from the hot appetizers was the Tagliatte, crumbled pork sausage, rapini light chili flakes and San Joaquin gold cheese. From the entrees menu the Butternut Squash agnolotti, then a taste of the Sea Bass. My assessment was two thumbs up, only problem is there are dishes that I didn't get to, and so badly want to return for the Beef Chili and the Heritage Pork Chop.

Amusing to me is that the menu doesn't offer descriptions but what I had was so good that I can't wait for my

LA COUNTY AS ADDITIONAL BOOSTER DOSES ARE UN-DER FEDERAL REVIEW, PUB-LIC HEALTH UNDERSCORES IMPORTANCE OF GETTING VACCINATED

Friday, the U.S. Food and Drug Administration's (FDA) Vaccines and Related Biological Products Advi-sory Committee recommended booster doses of Johnson & Johnson for all adults given at least two months after the first dose. Yesterday, the committee recommended approval of the Moderna boost-er dose at least six months after completion of the two-dose series. The FDA will consider the com-mittee's recommendation and once the FDA authorizes the booster doses for Johnson & Johnson and Moderna, the Centers for Disease Control and Prevention (CDC) will finalize and determine eligibility.

L.A. County will use its extensive network of over 1,400 vaccination sites and 400 mobile sites to ad-minister doses to those eligible while prioritizing reaching those at most risk, including those not yet vaccinated. In addition to the 1.2 million individuals eligible for the Pfizer booster, are an estimated 948,000 individuals who completed the Moderna two-dose series prior to April 10 and 298,000 indi-viduals who received one dose of Johnson & Johnson by April 10.

Out of the nearly 10.3 million L.A. County residents, including those who are not yet eligible for the vaccine, 60% are fully vaccinated. There continues to be room for improvement to increase vaccina-tion coverage. The millions of individuals who remain unvaccinated unfortunately represent opportu-nities for viral transmission and mutation of the virus.

"To all those who have lost friends, loved ones, and family, may time help you heal and find peace," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "We can expect all COVID-19 vaccines available in the country to have a booster option in the near future. In the near future, we expect that millions more L.A. County residents will qualify for a booster. For those who are older, have underlying health conditions, or high risk of exposure at a worksite, please plan to get your booster once you are eligible. This will allow your immune system to mount a more effective response to the virus. As we prepare for colder weather and the holidays, getting a first, second or third dose of a COVID vac-cine should be very high on our to do list."

Vaccinations are widely available throughout L.A. County and are always free and open to eligible res-idents and workers regardless of immigration status. Anyone 12 and older living or working in L.A. County can get vaccinated. Appointments are not needed at many sites and all Public Health vaccina-tion sites where first, second, and third doses are available.

Vaccinated middle and high school students are eligible for free UCLA football tickets. UCLA has part-nered with Public Health to give away free tickets to a UCLA football game at the Rose Bowl to middle or high school students in L.A. County who've received at least one dose of a COVID-19 vaccine, while tickets last. Students aged 12 to 18 who've received at least one dose can sign up for the free tickets online by visiting: http://ph.lacounty.gov/DPHUCLAVaxforTix.

HOW TO FIND FINANCIAL ASSISTANCE FOR AGING **IN-PLACE IMPROVEMENTS**

Dear Savvy Senior:

Do you know of any financial assistance programs that can help seniors with home improvement projects? I would like to help my grandparents make a few modifications to their house so they can continue living there safely, but money is tight. Searching Grandson



Dear Searching:

Yes! There are a number of financial aid programs available that can help seniors with home modifications and improvement projects for aging-in-place, but what's available to your grandparents will depend on their financial situation and where they live. Here are some different options to explore.

Medicare Advantage benefits: While original Medicare does not typically pay for home improvements, if your grandparents are enrolled in a Medicare Advantage (Part C) plan, it may offer some aid for modifications based on need. Contact their Medicare Advantage provider to see if this is available. Medicaid waivers: If your grandparents are low-income and eligible for Medicaid, most states have Medicaid Home and Community Based Services waivers that provide financial assistance to help seniors avoid nursing homes and remain living at home. Each state has different waivers, eligibility requirements and benefits. Contact your Medicaid office (see Medicaid.gov) for information.

Non-Medicaid government assistance: Many state governments and several agencies within the federal government have programs that help low to moderate income seniors, who aren't eligible for Medicaid with home modifications. For example, the Department of Housing and Urban Development offers HUD Home Improvement Loans by private lenders. Contact a HUD approved counseling agency (call 800-569-4287) to learn more.

And the U.S. Department of Agriculture has a Rural Development program that provides grants and loans to rural homeowners. Your local USDA service center (see offices.sc.egov.usda.gov) can give you more for information.

Many states also have financial assistance programs known as nursing home diversion programs. These programs, which may include grants or loans or a combination, helps pay for modifications that enable the elderly and disabled to remain living at home. Modifications covered typically include accessibility improvements like wheelchair ramps, handrails and grab bars.

To find out if there are programs in your grandparent's area, contact the city or county housing authority, the local Area Aging Agency (800-677-1116) or the state housing finance agency - see

Veteran benefits: If your either of your grandparents is a veteran with a disability, the VA provides grants like the SAH, SHA and HISA grants that will pay for home modifications. See Benefits.va.gov/ benefits/factsheets/homeloans/sahfactsheet.pdf for details and eligibility requirements.

Some other VA programs to inquire about are the "Veteran-Directed Care" program and "Aid and Attendance or Housebound Benefits." Both programs provide monthly financial benefits to eligible veterans that can help pay for home modifications. To learn more, visit VA.gov/geriatrics or call

Nonprofit organizations: Depending on where your grandparent's live, they may also be able to get assistance in the form of financial aid or volunteer labor to help with modifications. One of the most noteworthy is the organization Rebuilding Together (Rebuilding Together.org, 800-473-4229), which offers three programs: Safe at Home, Heroes at Home, and National Rebuilding Day.

Another option is community building projects, which provide seniors with volunteer labor to help them make home improvements. To search for projects in your grandparent's area, do web search containing the phrase "community building project" followed by their "city and state."

Reverse mortgage: Available to seniors 62 and older who own their own home and are currently living there, a reverse mortgage will let your grandparents convert part of the equity in their home into cash - which can be used for home improvements - that doesn't have to be paid back as long as they live there. But reverse mortgages are expensive loans, so this should be a last resort. For more information on these and other financial assistance programs, go to PayingForSeniorCare.






