TEN YEARS LATER.....AFTER THE WINDSTORM

Wednesday, December 1, 2021 will mark the 10th anniversary that a devastating windstorm hit Sierra Madre and surrounding cities. The storm also wrecked havoc in Pasadena, Altadena, Arcadia and several other neighboring cities.

In Sierra Madre, hundreds of trees were uprooted, homes and cars were damaged, and tons of debris was scattered throughout the city. Trees and debris also damaged Edison equipment and scores of downed power lines throughout the town.

That evening, Sierra Madre officials opened the Emergency Operations Center to monitor the Windstorm and its impact. City staff and volunteers provided 24 staffing for the center and coordinated disaster relief operations with other local, county, state and federal agencies since the impact of the storm was so widespread.

In the edition of the Mountain Views News that was published two days later, (p1, v5.49 — Home Page Mountain Views News (mtnviewsnews.com)), it was reported that more than 30 homes had been badly damaged. Seven of those homes were Red Tagged and deemed un-inhabitable. Six were Yellow Tagged because of extensive damage. Fortunately, there were no reports of residents being injured.

The town lost power on December 1st and a week later, there were still 43 locations in Sierra Madre operating in darkness.

Without electricity, many telephones, landlines and cell, were non-functioning and television/cable/internet service was interrupted. Those who survived learned valuable lessons the hard way, about emergency preparedness. (See related story below reprinted from Mountain Views News, December 20, 2011.)

Ten years ago the wind changed Sierra Madre in many ways, forever.



SIERRA MADRE CERT CONTINUES TO URGE RESIDENTS TO PREPARE

In light of the recent wind storm, many of us now realize how very vulnerable we all are in our usually calm Sierra Madre. Trees came down causing structural damage and a full electrical outage for up to 5 days in some areas. Residents were diligent about taking their kids and elderly parents to family or friends' houses. The City of Sierra Madre, the Sierra Madre Police Department and the Sierra Madre Volunteer Fire Department did an extraordinary job ensuring all residents were safe, the streets cleared as soon as possible and provided continual updates and information to residents. Southern California Edison crews worked around the clock to restore service within an incredibly short amount of time given amount of damage.

Luckily, it wasn't "The Big One" where we could lose water, gas, electricity, telephones (including cell phones) and could be weeks without help!

With that being said, the Sierra Madre Community Emergency Response Team (CERT) would like to continue to encourage residents to prepare for a large-scale natural disaster. The level of personal preparedness will determine the quality of life for families in

the event of an emergency. Just a few simple steps can dramatically reduce the dependence on emergency services in the event of a disaster:

- -Water: one gallon per person per day for three weeks
- -Food: at least a three week supply of non-perishable food, plus a can opener
- -Extra water and food for pets
- -Prescription medications
- -Blankets, clothing and sturdy shoes for each family member -Baby items, such as extra formula and diapers
- -Special items for seniors or people with disabilities (generators with enough fuel to run heat and medical equipment for at least
- one week. 5 gallons per day for 7 days = 35 gallons of fuel) -Small hygiene kits, including toothbrush and toothpaste
- -List of allergies to any drug or food (especially antibiotics)
- -Battery powered or hand-crank radio -Flashlights and extra batteries
- -First aid kit
- -Whistle to signal for help
- -Wrench or pliers to turn off utilities
- -Pocket knife
- -Emergency cash in small denominations; quarters for public pay phones
- -Paper cups, paper plates, plastic utensils and paper towels -Copies of important documents such as birth certificates, insurance policies, pass-ports, etc.
- -Photos of family members and pets for identification purposes -List of emergency point-of-contact phone numbers (out of state preferable)
- Extra keys to your house
- -Extra toilet paper, shovel for digging a latrine

Sierra Madre is also equipped with its own radio station at 1630 am to provide con-tinual updates in the event of an emergency. Remember: Don't become a victim! Be empowered! Be prepared!'

THE LATEST FROM THE CITY

The November 13 Mountain Views News front page article was: 'Housing Element Update Adopted! City Council Vote Unanimously Despite Citizen Opposition. We at Preserve Sierra Madre find this disturbing for several reasons. In adopting the Housing Element, the General Plan (dubbed by a former Mayor as "The Constitution of the City") needed to be amended. That included two major amendments - one was to add a religious overlay zone so that potential housing

units could be built on religious properties, namely the Old North Church, and the Methodist Church (other churches refused). The second amendment was the Safety element, adding Hz.5b under Fire Safety – "Avoid construction of new development in natural open space areas in Very High Fire Severity Zones." This appears to have been done to ease the way for the building of 42 high income homes proposed by New Urban West on the Monastery property. Our town has been tasked by the state to find locations to build 204 new housing units. These potential new homes "may or may not be included" in this number when attempting to come up with new housing. We keep getting confusing statements as City Council has said that the Meadows project is under the rules of the old general plan, the Meadows EIR, and the MOU

It took the General Plan Update Steering Committee five years, which included hundreds of volunteer hours, among approximately 100 volunteers, several town hall meetings and a city-wide survey of what residents considered important to our town. The City had planned on hiring a consultant for different aspects of what needed to be updated to the original General Plan of 1996. Instead, using volunteers, the City was saved over \$25,000.

This time, in 2021, the City paid the Consultant nearly \$250,000, to come up with this year's Housing Élement and General Plan Update. Unlike the extensive work by many volunteers on the 2015 General Plan, this revision was updated by a consultant with only one public scoping meeting held in July of this year, two weeks before the Draft SEIR was circulated. Only 25 residents attended. Expecting and counting on volunteers to contribute to Sierra Madre, but then not soliciting and welcoming their input on critical city issues is disconcerting.

Ironically, the Supplemental Impact Report with its



huge implications was produced for public view at the same time as the Draft Environmental Impact Report for the Meadows housing project. We, the public who will be impacted forever by these decisions, had 49 overlapping days to study and comment on these two 4,000 page reports and 11 days additional days to comment on the DEIR.

What is so disturbing is the lack of transparency in the process. We have been told that the Environmental Impact Report will have residents' comments included, with responses. However, if these responses are similar to those for the SEIR, they will be rather meaningless. Preserve Sierra Madre submitted a 28 page analysis of the DEIR, with questions. We were told by the Planning Director that at least 70 emails were received. Will we be able to voice our concerns? Will they be heard? We, as well as other concerned residents, have stated frequently that responding to City Council discussions cannot adequately fit into a three minute time frame. The Planning Commission allows five minutes, but at the last meeting, Chair Pevsner, switched to three minutes.

By now you have received post cards and a brochure from New Urban West regarding this housing development. You will see that NUW is projecting 'Open Space Area," north of the Monastery and "Residential Area" on the south end. This looks suspiciously like an attempt to thwart the General Plan change in the definition of open space in a Very Severe High Fire Zone.

The Passionist Fathers certainly have the right to sell their property, to whomever they please. The Passionist Fathers will make a lot of money from the sale of the property. As will the developer. As this housing project goes through the required review process, we are asking for transparency by our City Hall and by our elected officials - the City Council.



City Offering Reward after Teen's Murder

The City of Pasadena Announced Tuesday they are offering a \$10,000 reward for information that leads to the arrest and conviction of the suspect(s) responsible for the shooting death of 13-year old Iran Moreno.

"As your Mayor, I want you to know that the safety of our city is my top priority", Pasadena Mayor Victor Godo said. "I am working with my City Council colleagues, our City Manager, Police Chief, Fire Chief, City staff and community leaders to address this violence as well as assist with the immediate needs of our community members who are deeply impacted. I ask all of you to keep our victims in your prayers as we work to stop this violence."

According to police, on Sunday at approximately 6:12 p.m., officers from the Pasadena Police Department responded to a residence in the 900 block of N. Raymond Avenue regarding a person who had been struck by gunfire. Officers located Moreno, a resident of Pasadena, suffering from a gunshot wound. The victim was unresponsive and officers immediately began providing emergency, lifesaving medical care. Moreno died at a nearby hospital.

Investigators said they do not think Moreno was the intended target. Reports said he was playing video games at the time gunfire come though the widow.

"The suspect(s) and motive are unknown at this time and investigators are attempting to determine the identity of the intended target."


70-year-old Victim's Name Released

Officials released the name of to death by a suspect Tuesday afternoon before being shot himself during a gun battle

with Pasadena police

Witnesses told officers there was a male suspect running from the scene armed with a firearm. In his attempt at escape, the suspect carjacked a vehicle from a female, but ultimately fled on foot once officers arrived. Officers gave chase, made contact with the suspect, and an Officer Involved Shooting (OIS) occurred. At one point during the incident, the suspect took a second female hostage at gunpoint. The hostage was ultimately rescued, unharmed.

Minissian was transported to a local hospital where he succumbed to his injuries and the suspect is deceased within the crime scene. The unnamed suspect was a male in his 20's.

Senator Portantino Makes Emotional Trip to Artsakh

The First Elected Official from the United States to Visit the Region since the End of the 44-Day War

California State Senator Anthony Portantino recently returned from an emotional trip to Artsakh Armenia, during which he toured the countryside and broke bread with heroes. It is believed that this is the first time a state or federal elected official has visited the region since the end of the 44-day war.

"I was honored to have been asked to go to Artsakh and deeply affected by my time there," stated Senator Portantino. "In particular, in the village of Taghavard, I encountered the most resilient and strong people I have ever met. Their pride and determination to live peacefully on their lands was both inspiring and emotional. At the Lady Cox Rehabilitation Center, I observed a classroom of autistic children receiving loving care and spent time with war heroes who are dealing with the significant personal consequences of the war. Government officials and residents made ardent pleas to the international community to recognize the sovereignty of Artsakh and to advocate for human rights and dignity," Portantino added.

While in Artsakh, the Senator met with President Harutyunyan, Arayik Minister Foreign Affairs David Babayan, Minister of Education, Science and Culture Lusine Gharakhanyan and leaders of the Artsakh In addition, Parliament. he visited the frontlines during a tour of Taghavard village in the Martuni region. In Taghavard, he had the opportunity to witness the consequences of the unprovoked war. He assessed destroyed homes and a prominent church that was leveled by Azeri shelling. Additionally, he was local village leaders, soldiers with destructive intent, and survivors of the war. At



the Lady Cox Rehabilitation Center, he was able to spend time and share a caring voice with veterans suffering from the aftereffects of the tragic

Senator Portantino was also able to tour a school damaged by bullets and bombs but later revitalized by the Armenia Fund. At a church, he was shown remnants of missiles and was sadly taken to a cemetery where family members proudly and emotionally mourn the loss of young men and women who bravely fought for their country.

"This was by far the most emotional visit I've taken to Artsakh. The personal stories and first-hand accounts of the war were both inspiring and sad. Walking through the rubble of a once thriving home with the grandson of the owner was quite emotional. And seeing the harsh reality of adjacent Azeri military camps and infrastructure advances were imminent and concerning. Standing below deserted city of Shushi was particularly disturbing, as I have such fond memories of my last visit there. And seeing the proximity to danger school children face every day when they go outside to play was unsettling and all too real," added Senator Portantino. "Given the recent and continued aggression in Syunik and the unprovoked actions on the Shushi-Berdzor road, we know that the international community needs to act with humanitarian passion and dedicated support for the Armenian people who are privileged to have met with facing a well-funded military

Curiosity Rover Sends a Picture Postcard from Mars



An artistic interpretation of Curiosity's view high up on a Martian mountain was created by mission team members who were stunned by the sweeping landscape.

NASA's Curiosity rover captured a remarkable image from its most recent perch on the side of Mars' Mount Sharp. The mission team was so inspired by the beauty of the landscape, they combined two versions of the black-and-white images from different times of the day and added colors to create a rare postcard from the Red Planet.

Curiosity captures 360-degree view of its surroundings black-and-white navigation cameras each time it completes a drive. To make the resulting panorama easier to send to Earth, the rover keeps it in a compressed, low-quality format. But when the rover team saw the view from Curiosity's most recent stopping point, the scene was just too pretty not to capture it in the highest quality that the navigation cameras are capable of.

Many of the rover's most stunning panoramas are from the color Mastcam instrument, which has far higher resolution than the navigation cameras. That's why the team added colors of their own to this latest image. The blue, orange, and green tints are not what the human eye would see; instead, they represent the scene as viewed at different times of day.

On Nov. 16, 2021 (the 3,299th Martian day, or sol, of the mission), engineers commanded Curiosity to composite images, capturing the scene at 8:30 a.m. and masa.gov/mission_pages/msl/index.html.

The team then combined the two scenes in an artistic re-creation that includes elements from the morning scene in blue, the afternoon scene in orange, and a combination of both in

At the center of the image is the view back down Mount Sharp, the 3-mile-(5-kilometer-tall) mountain that Curiosity has been driving up since 2014. Rounded hills can be seen in the distance at center-right; Curiosity got a closer view of these back in July, when the rover started to see intriguing changes in the landscape. A field of sand ripples known as the "Sands of Forvie" stretches a quarter- to a halfmile (400 to 800 meters)

At the far right of the panorama is the craggy Rafael Navarro Mountain," named after a Curiosity team scientist who passed away earlier this year. Poking up behind it is the upper part of Mount Sharp, far above the area Curiosity is exploring. Mount Sharp lies inside Gale Crater, a 96-mile-wide (154-kilometer-wide) basin formed by an ancient impact; Gale Crater's distant rim stands 7,500 feet tall (2.3 kilometers), and is visible on the horizon about 18 to 25 miles away (30 to 40

kilometers). The Curiosity mission is led by NASA's Jet Propulsion which Laboratory, managed by Caltech in Pasadena, California.






CITRUS COLLEGE FOSTER YOUTH PROGRAM HIGHLIGHTED



SENIOR ALERT: YOUR OLD CELLPHONE MAY NOT WORK IN 2022

Dear Savvy Senior: My 80-year-old father has an old flip phone he carries around with him for emergency purposes, but I've heard that these devices will soon be phased out. Is this true? If so, how can we know if his phone will be affected, and where can I find him a simple new one that he can operate. Searching Daughter

Dear Searching:

Yes, it's true! If your dad's mobile phone is more than a few years old, he will probably need to upgrade it the very near future. Why?

Because all of the major cell phone carriers - AT&T, Verizon and T-Mobile – are shutting down their old-3G networks in 2022 to free up airwaves for 5G and othadvanced services. So, if your dad is using an old 3G



phone, like millions of other older Americans, he'll need to get a new device if he wants to make calls, text or reach 911.

But you should also know that it's not just older cellphones that will be obsolete. Older home security systems, medical devices and personal emergency response systems that still harness 3G will also be affected. Adding to the confusion, older 4G phones that don't support modern cellular voice technologies, such as Voice Over LTE or HD Voice, are impacted, too. Those customers may need a software upgrade or a new

Here are the timelines for the 3G shutdowns: AT&T - Feb. 2022; T-Mobile - July 1, 2022; Verizon - Dec. 31, 2022; Sprint (which is owned by T-Mobile) - March 31, 2022; and Sprint LTE - June 30, 2022. Other smaller carriers like Tracfone, Cricket, Boost and Straight Talk, will also be affected, because they rely on airwaves from the big three.

Is Your Phone Affected?

Cellphone carriers say they have been alerting customers who use older phones that services are ending, sending a combination of texts, letters, phone calls and emails. If you're not sure about your dad's phone, contact his carrier or check their website for a list of affected devices.

Another way to see if your dad's phone is 3G is to look up his international mobile equipment identity number which can be found by pressing *#06# on his keypad. Once you have it, go to www.imei.info and type it in the search bar to get the phone's details. If his phone has a frequency of 900 megahertz (MHz) or 2100 MHz, it's 3G. You can also look for a "3G" icon at the top corner of his phone, but not all 3G phones have that icon.

How to Upgrade

If you find that you do need to upgrade your dad's cellphone, carriers are offering discounts and special promotions on replacement devices. If you're worried about your dad having to learn your way around a new device, you'll be happy to know that there are plenty of modern new flip phones available that work on the next-generation networks.

Or, if your dad decides that he would rather forge ahead without a phone than upgrade, then he will need to cancel the service. Most carriers will let you cancel your plan without any penalty. However, if he forgets to cancel his phone plan and doesn't upgrade to a working device, the company won't automatically stop charging him just because he isn't able to access their network.

If your dad does have to replace his old cellphone, the best way to dispose of it is to recycle it. Large retailers, such as Best Buy, offer recycling programs for old electronics. Or you can search for local recycling programs on websites like Call2Recycle.org and Earth911.com.

10 THINGS YOU SHOULD KNOW ABOUT LIVING WILLS

When it comes to estate planning, you've most likely heard people mention a couple of different types of wills. The most common is a "last will and testament," which is also known simply as a "will." But you may have also heard people talk about what's called a "living will."

Both terms describe important legal documents used in estate planning, but their purpose and the way in which they work is very different. Here we are going to discuss some of the most critical things you should know about living wills, and explain why having one is an essential part of every adult's estate plan and how

1. What Is a Living Will?

A living will, often called an "advance healthcare directive," is a legal document that tells your loved ones and doctors how you would want decisions related to your medical care handled in the event you become incapacitated and are unable to make such decisions yourself, particularly at the end of life. Specifically, a living will outlines the procedures, medications, and treatments you would want—or would not want—to prolong your life if you become unable to discuss such matters with doctors yourself.

2. Living Will vs Last Will & Testament

A last will and testament is used to ensure your assets are divided upon your death in the way you choose. Note that your will only deals with your assets, and it only operates upon your death. In contrast, a living will is about you, not your assets, and operates in the event of your incapacity, not your death.

3. What Is an Advance Directive and How Is It the Same or Different Than a Living Will? An "advanced directive" or "advance healthcare directive" are both general terms that describe legal docu-

ments that are related to your healthcare needs. Typically, an advance healthcare directive will include a living will (with instructions for how you want your medical care handled), and a medical power of attorney (naming the people you want making decisions for you, and giving them authority to talk with your medical team).

4. Living Will vs Medical Power of Attorney

A medical power of attorney is the part of an advance healthcare directive that allows you to name a person, known as your "agent," to make healthcare decisions for you if you're incapacitated and unable to make those decisions yourself. While medical power of attorney is an advance directive that names who can make healthcare decisions in the event of your incapacity, a living will explains how your medical care should be

5. Why Is a Living Will So Important?

A living will is a vital part of every adult's estate plan, as it can ensure your medical treatment is handled exactly the way you want in the event you become unable to communicate your needs and wishes yourself. Additionally, a living will can prevent your family from undergoing needless stress and conflict during an already trying time.

6. Even Young People Need a Living Will

Although you may think that a living will is something that only the elderly or older people need, the fact is, you can experience a serious accident or illness at any age, which would leave you incapacitated and unable to communicate your wishes for medical care. For this reason, all adults over age 18 should have both a living will and a medical power of attorney in place.

7. Decisions and Scenarios Addressed in A Living Will

A few of the most common types of decisions, treatments, and scenarios typically addressed in a living will include the following: tube feeding, resuscitation (CPR & DNR), Intubation & mechanical ventilation, pain management & palliative care, organ/tissue donation.

8. Should You Do It Yourself with an Online Living Will?

While you'll find a wide selection of generic living wills, medical power of attorney, and other advance directive documents online, you may not want to trust these do-it-yourself solutions to adequately address such critical decisions. When it comes to your medical treatment and end-of-life care, you have unique needs and wishes that just can't be anticipated by fill-in-the-blank documents.

9. Communication is Vital

Even if you have the most well-thought-out and professionally prepared living will around, it won't be worth the paper it's printed on if nobody knows about it. Both living wills and medical power of attorney go into effect the second you sign them, so you should immediately inform your agent, your alternate agents, your primary care physician, and any other medical specialists you're seeing.

10. Don't Wait Until It's Too Late

Your living will and medical power of attorney must be created well before you become incapacitated and unable to make your own decisions. You must be able to clearly express your wishes and consent for these planning documents to be valid, as even slight levels of dementia or confusion could get them thrown out of court. Not to mention, an unforeseen illness or injury could strike at any time, at any age, so don't wait.

A Comprehensive Plan for Incapacity

A living will and medical power of attorney are just two of the legal documents you need as part of your overall plan for incapacity. You will also likely need other estate planning tools, such as a durable financial power of attorney and a revocable living trust, to have a truly comprehensive incapacity plan.

EATING HEALTHY IS FOR THE WEAK

the true side of the table. So I guess that is a father's prerogative, and I probably have done the same thing many times. But I don't want to research that aspect of my life right now.

One that he said quite often was, "Eating healthy is for sissies.'

At the time, I had no idea what he was talk ing about, but I did know that good old mom worked very hard to make sure he had healthy food to consume. So she did her job, but he did not fare well with that. He always ate in the opposite of healthy, and that just was the way he

Later in life, he had diabetes, high blood pressure, clogged arteries and finally, several heart attacks. Then he died.

According to him, these things had nothing whatsoever to do with his eating. They were just things that happened and he had no control over them.

No matter how sick he was at any given time, he always found it in himself to enjoy a dessert with lots of sugar in it. His favorite dessert was the one he was eating at the time.

I had not remembered that for the longest period until several weeks ago, when I had my first heart attack. Who knew I even had a heart! And, what did my heart have against me that it wanted to attack me?

My main artery was 90% clogged, and the doctors called it the "widow maker." That was something relatively new to me.

I spent about half a week in the hospital having a stent put in to help the main artery. The nurses took more blood out of me than I knew I had. Count Dracula would have been jealous.

One nurse, I called Nurse Porcupine because she had more needles than a porcupine had quills. It took half a dozen attempts to find an artery that had blood in it. Both my arms are black and blue and have the appropriate needle marks in them.

My stay in the hospital was only three days, but felt like an eternity. Its experiences like that make you appreciate your own home and bed and lazy chair. I was so happy to get home.

Then I again thought about my father. He spent most of his time in the hospital during the last few years of his life. I am not quite sure how he made it through those experiences, but he did. Then I thought about his healthy diet remarks

According to him, a diet consisted of what he wanted at the time. All this cautious eating was far beyond his modus operandi.

I remember once he spent two weeks in a hospital to have his arteries cleansed and purged or whatever they call it, and when he came home, his idea was, "I'm healthy now so I can eat whatever I want to eat."

As a youngster, I often heard my father say things that later turned out not to be on It did not take long until he was back where he was before he went into the hospital.

Thinking about this, I had a dire option before

I could take things as my father did in a very hap-hazardous way and not take my dietary routine seriously.

On the other hand, I could take my health and my eating habits seriously.

My first impression is to go along with my dad. After all, dads are never wrong, right?

Not to criticize my father, who has been gone for over a decade, but he did not really take his health seriously. He assumed it was just a given that he could eat whatever he wanted with no consequences involved.

As the situation is, the biggest obstacle in my decision concerning my health and eating habits is the Gracious Mistress of the Parsonage. For some reason, she has taken my diet quite seriously as though it was hers.

The quandary I am in is that she is the one who supervises the culinary activities in the house. I have been barred from the kitchen for years because of an incident that happened a few years back, which I am not comfortable getting into right now.

Being in a health-challenging situation right now, I do not have many choices. It's either eat what the Gracious Mistress of the Parsonage has produced or starve. Starving is not the particular exercise that I enjoy.

I must admit my wife is a marvelous cook and makes very delicious meals, which I am assured, are most healthy. From my point of view, if it does not have broccoli, then it is delicious.

Her healthy array of desserts is mouthwatering.

Therefore, I can do my own thing and be in a lot of trouble or allow the Gracious Mistress of the Parsonage to do her thing and be in charge of the dietary activities in our home.

In pondering this quandary that I am in, I realized a wonderful verse in the Bible. "And also that every man should eat and drink, and enjoy the good of all his labour, it is the gift of God" (Ecclesiastes 3:13).

Instead of getting all caught up in some ritualistic eating habits, I believe from God's perspective he would want me to enjoy my life. But, of course, as I realize now, enjoying life means that I take care of my eating habits to the glory of God.



5 HOLIDAY SAFETY TIPS FOR YOUR PETS

The holiday season is here so please be mindful about how to keep your pets safe. Here are 5 holiday tips from Pasadena Humane on how to keep your pets safe during celebations.



"As the winter holidays approach, your home may be filled with festive food, decor, and more. Keep these tips in mind to make sure your pets stay safe during your holiday celebrations:

1. Avoid giving your pets "people food"

Food is a huge part of the holidays, but so much of it isn't good for our furry friends. Onions and garlic are toxic to pets, so make sure you keep ingredients out of reach when cooking Thanksgiv-ing dinner. Alcohol is also hazardous to cats and dogs, so don't leave your glass or wine or egg-nog unattended. Cooked turkey bones can be a serious danger, as they can easily splinter in an animal's digestive tract. If you want your pet to indulge with you for the holidays, only purchase treats and chews made specifically for them.

2. Pet-proof your Christmas trees

Pine needles are mildly toxic to pets and can potentially puncture the intestines, so if you catch your cat or dog trying to eat them, move the tree to a room you can close off or stick to an artifi-cial tree. If you have a live tree, the tree water can contain preservatives that can upset your pet's stomach, so cover your tree stand to prevent pets from having access to the water. If your cat is climbing your tree, make sure it's securely anchored so it won't tip over.

3. Be vigilant with decorations

Keep breakable ornaments up high on the tree where curious pets can't reach. The same is true for Christmas lights, which can pose an electrocution risk if bitten. Always unplug Christmas lights when you're not actively supervising your pet. Tinsel can be tempting for cats to play with but can cause intestinal blockages if swallowed. Opt for artificial holly and mistletoe, since the real thing can cause vomiting. And if you have a menorah, don't leave a lit flame unattended, or opt for flameless candles to be extra safe.

4. Keep an eye on gift wrapping supplies

Wrapping paper, string, and ribbon are tempting for pets to play with but can be dangerous if swallowed. Use caution when keeping wrapped presents under the tree, or better yet, keep them out of reach until it's time to open them.

5. Create a sanctuary space

New Years' Eve fireworks, Christmas poppers, and even holiday carolers can make noise that may frighten your pet. And if you're entertaining guests, your pet may feel stressed by new peo-ple in the home. Always make sure they have a safe, soothing space to go to – like a closed-off room – if they need to get away from scary sounds or strangers.

FROM LA COUNTY HEALTH:

Public Health Encourages Everyone to Celebrate Safely

28 New Deaths and 1,081 New Confirmed Cases of COVID-19 in Los Angeles County

With substantial community transmission of COVID-19 continuing in Los Angeles County, the Los An-geles County Department of Public Health (Public Health) encourages everyone to enjoy Thanksgiving safely. Unvaccinated people are at higher risk of getting and spreading COVID-19 to others, creating additional risk for holiday gatherings where not all attendees are fully vaccinated.

Public Health recommends if you're gathering with anyone at higher risk of severe illness or who is not fully vaccinated, celebrate safely outdoors as much as possible, wear masks when indoors and keep your distance while eating/drinking, or even consider getting together virtually. In addition to gathering safely, avoid crowded places and wear your mask when in crowded outdoor settings. If you are traveling for Thanksgiving, follow all local and national public health vaccination, testing, and quarantine guidelines.

If you are not fully vaccinated and planning to visit family or friends this Thanksgiving or during this winter season, here are ways to layer on protection for yourself and your family and friends:

- Get vaccinated now or as soon as possible. (For all COVID-19 vaccines, you are only consid-ered fully protected two weeks after all doses are complete.)
 - Avoid crowded or poorly ventilated areas.
- Wear a well-fitting mask over your nose and mouth when gathering with others, especially if you or they are not fully vaccinated or are at increased risk of severe ill ness if they get infected (elderly or have underlying health conditions). Keep distance while eating unless everyone is fully vaccinated.
- Take a COVID-19 viral test before joining others if you have symptoms of CO
- VID-19, have been in close contact with someone who has COVID-19, or have been in crowded indoor places in the past two weeks.
- Stay home if you are sick, have symptoms, or test positive.

Of the 28 new deaths reported today, 11 people who passed away were over the age of 80, six peo-ple who passed were between the ages of 65 and 79, eight people who passed were between the ag-es of 50 and 64, and two people who passed were between the ages of 30 and 49. One death was reported by the City of Pasadena. To date, Public Health has identified 1,522,240 positive cases of COVID-19 across all areas of L.A. County and a total of 27,074

There are 551 people with COVID-19 currently hospitalized, 29% of these people are in the ICU. Test-ing results are available for nearly 9,370,000 individuals, with 15% of people testing positive. Today's test positivity rate is 1.4%.

"Our hearts go out to everyone grieving the loss of a family member or friend to COV-ID-19," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "As we all take some much-needed time to rest and gather with loved ones, please remember the risk of COVID-19 transmission continues to be substantial, and unvaccinated people continue to be at higher risk for severe health outcomes. Taking a common sense approach to the holiday can limit risks: Please remember to gather outdoors for as much of your Thanksgiving festivities as is feasible, get tested if you are unvaccinated or have high-risk guests, and mask up when indoors if anyone attending is unvaccinated and/or high risk. And when you're out shopping or at community events, mask up and avoid large crowds. We wish you all a safe, healthy, and happy holiday."

COVID-19 vaccines are safe and effective and are recommended for everyone 5 years old and older to help protect against COVID-19. Vaccinations are always free and open to eligible residents and work-ers regardless of immigration status. Appointments are not needed at all Public Health vaccination sites and many community sites where first, second, and third doses are available.

BUBBLES FOR THE HOLIDAYS

Reader Ken Fuller loves Christmas the pride of Altadena dresses his house up like no other in his neighborhood asked my opinion on a decent Prosecco, I hope I come through for this holiday loving neighbor.



I have found a light and refreshing wine with enough bubbles to enjoy and flavor that even a splash of orange juice won't kill. Ruffino Prosecco has been produced from grapes grown in the hilly area of Valdobbiadene, which is the most historically vocated region for the production of Prosecco. Bright straw yellow with fine bubbles, the bouquet is fragrant and intensely fruity. It shows clean notes of apples, pears and citrus. I found it crisp, clean and yet delicate - a perfect wine for a toast at a celebration. Intense sensations of apples and peaches drive a pleasant aftertaste that is reminiscent of fruity and floral aromas.

Ideal as an aperitif; it is very versatile as a food companion. What to pair it with? Ruffino Prosecco matches well with fish and shellfish dishes as well as white meat dishes. I enjoyed this sparkler just this past weekend with a thin crust BBQ Chicken pizza. Others in this category would include Sofia Sparkling Wine and the previously written about Domain Carneros. I do recommend the Ruffino Prosecco for the toast and depending on the wedding or celebration menu at around \$14(Vons Pasadena) you can't go wrong. Again a touch of OJ or a sweet strawberry added and I won't call party foul. Enjoy!!

I met a man who began to discuss with me the column I wrote for this paper last week, about the historical origins of Thanksgiving, and what happened, and what didn't happen.

"I was a little puzzled after I read it," Burt told me. "I wanted to know more. I understand that the first historical Thanksgiving may have not happened the

way we are told as children," he told me, "but how did we get to where we are today? What I understood from your column was that there are historical roots, and that we today remember those roots and try to be very thankful, but the connection was unclear." Burt and I then had a very long conversation.

A newspaper column is typically not long enough to provide the "big picture" of the entire foundation of such a commemoration, as well as all the twists and turns that have occurred along the way. But here is the condensed version of what I told my new friend Burt.

First, try reading any of the many books that are available that describe the first so-called "first Thanksgiving" at the Plymouth colony that at least attempts to also show the Indigenous perspective. You will quickly see that this was not simply the European pilgrims and the native people sitting down to a great meal and giving thanks to their respective Gods, though that probably did occur. In fact, the indigenous peoples and the newcomers had thanksgiving days on a pretty regular basis.

As you take the time to explore the motives of the many key players of our so-called "first Thanksgiving," in the context of that time, you will see that though the Europeans were now increasingly flowing into the eastern seaboard, their long-term presence had not been allowed - until this point. Massasoit was the political-military leader of the Wampanoag confederation, which was the stronger native group in the area. However, after disease had wiped out many of the native people, Massasoit was worried about the neighboring long-time enemies - the Narragansett -- to the west. The gathering of the European leaders of the Plimouth Colony and Massasoit and entourage had been more-or-less brokered by Tisquantum (aka Squanto) who spoke English.

Yes, there had been much interaction between the new colonists and native people for some time, and this gathering of 3 days in 1621 was intended to seal the deal between the colonists aligning with Massasoit. The exact date is unknown, but it was sometime between September 21 and November 9.

Yes, historians say that a grand meal followed, including mostly meat. The colony remained and there was relative peace for the next 10 to 50 years, depending on which historians were correct in their reading of the meager notes. The historical record indicates that the new colonists learned how to hunt, forage, practice medicine, make canoes and moccasins, and much more, from the indigenous people. Even Tisquantum taught the colonists how to farm using fish scraps, ironically, a bit of farming detail he picked up during his few years in Europe.

Politicians and religious leaders continued to practice the giving of thanks, in their churches and in their communities, and that is a good thing. They would hearken back to what gradually became known as the "first Thanksgiving" in order to give thanks for all the bounty they found and created in this new world, always giving thanks to God! But clearly, the indigenous people would have a very different view of the consequences of this 1621 pact, which gradually and inevitably meant the loss of their lands and further decimation of their peoples from disease. Of course, there was not yet a "United States of America," and it was with a bit of nostalgia and selective memory that we refer to this semi-obscure gathering of two peoples as some sort of foundational event in the development of the United States. And it is understandable from the perspective of a national mythology that the native people were forgotten and the "gifts from

My new friend Burt was nodding his head, beginning to see that there was much under the surface of this holiday. I recommended that he read such books as "1491: New Revelations of the Americas Before Columbus" by Mann, "Native American History: Idiot's Guide" by Fleming,

As I still believe, giving thanks is a good thing – good for the soul and good for the society. Just be sure to always give thanks where it is due!

Eventually, in the centuries that followed, Thanksgiving was celebrated on various days in various places. George Washington declared it an official Thanksgiving in 1789. However, the day did not become standardized as the final Thursday each November until 1863 with a proclamation by Abraham Lincoln.


The gross commercialization of Thanksgiving is a somewhat recent manifestation of the way in which we have tried to extract money from just about anything. One way to break that cycle is to just choose to do something different.

When I used to visit my parents' home for annual Thanksgiving gatherings, I disliked the loud arguing and banter, the loud TV in the background, and the way everyone (including me) ate so much that we had stomach aches! I felt that Thanksgiving should be about something more than all that. I changed that by simply no longer attending, and then visiting my parents the following day with a quiet meal. It took my parents a few years to get used to my changes, but eventually they did.

This year, before the actual Thanksgiving day, I enjoyed a home-made meal with neighbors and friends. Before we sat down to eat, everyone stated the things they are thankful-for before the meal. Nearly everyone cited "friends and family," among other things. It was quiet, intimate, and the way that I have long felt this day should be observed. Yes, like most holidays we have a whole host of diverse symbols, and Thanksgiving is no different. And like most modern holidays, their real meanings are now nearly-hopelessly obscured by the massive commercialism. Nevertheless, despite the tide that is against us, we can always choose to do something different. Holidays are our holy days where we ought to take the time to reflect upon the deeper meanings. By so doing, we are not necessarily "saving" the holiday, but we are saving ourselves. As we work to discover the original history and meanings of each holiday, we wake up our minds and discover a neglected world hidden in plain sight.



Which way are we going? A friend presented me with a book entitled Technopoly subtitled The Surrender of Culture to Technology. I read most of the Introduction in which the author, Neil Postman, first describes the benefits of technology as a friend of humanity which makes life easier, cleaner, and longer. After this brief tribute Postman asserts there is a dark side to this friend. "Its gifts are not without a heavy cost. Stated in the most dramatic terms the accusation can be made that the uncontrolled growth of technology destroys the vital sources of our humanity. It creates a culture without a moral foundation. It undermines

certain mental processes and social relations that make human life worth living. Technology is both a friend and an enemy." Any seeming step forward may in time lead to generally unforeseen potentially catastrophic negative results.

I am writing this article on November 24, 2021 the day before Thanksgiving. My reading of Postman and the approaching holiday lead me to a desire to call friends and wish them a Happy Thanksgiving. I first called my friend Gene, a friend since elementary School. As Gene answered my call I said "Happy Thanksgiving" to which he replied "Don't you know this is a day of mourning for me." He explained that his "mourning" was the proper recognition of the first Thanksgiving when the indigenous people extended their welcome to the immigrant Europeans. Technology provides entertainment and information that makes it seem unnecessary to ever talk to other people.

I think that if you have taken the time to read this whole article it's a good sign. Remember for every positive step that Progress takes us there well maybe a step or two or three negative consequences. Altering the name of Columbus Day and renaming it as Indigenous People's Day is a reflection of my friend Gene' concern. Progress is not our most important product. How about trying instead to lead a good and meaningful life.


