

discolored and why do I pay so much? - Exactly how old are you? - Wouldn't it be better if we contracted with the Sheriff's Department? –What are your thoughts on Prop 13? -What makes you qualified? Where do my taxes go? –What was your position on Measure V? -Why did you move here?".

We have come a long way since 2014 and I'm extremely proud of the progress we have made. Last year we reported a \$2.5MM budget surplus in our City Budget. In 2021, we invested \$2MM to replace 23,000 linear feet of aging water infrastructure that resulted in a reduction of water loss leakage (30% to 13%). The police department showed an 11% decrease in crime. We now operate a fully-paid career Fire Department that secured automatic-aid status with peer agencies.

That's not all. Other accomplishments over the past year include the following:

No layoffs of staff during the pandemic

carbon emissions annually.

A funding of 85% of our total accrued pension liabilities (compared to a high-risk 69% in 2016) Approval of 30 Accessory Dwelling Units (ADUs)

A completed Kersting Court refresh project

Funding of a joint-well for a secondary water source with Arcadia in the San Gabriel Basin.

(San Gabriel Valley Municipal Water District (SGVMWD) approved \$1.8MM in financial support). Approved budget for Library Building upgrades

Free public WiFi at Memorial Park and Kersting Court Installation of a solar project that will eliminate up to 715 tons of

Our work is far from over. There will be many issues that will challenge us a united community. The proposed Bailey Meadows project at the monastery is still in process and continues to be a contentious issue with some residents. The State's mandates in the areas of affordable housing, zoning, and compost rubbish separation leave little to no room for local government control. The state of drought emergency is always looming over us. Our aging city infrastructure and the years of deferred maintenance will be an ongoing expense. Rising costs will force us to question if we should maintain our own Fire and Police departments. And why do people blatantly disregard the "No U-Turn" signs downtown?

I remain hopeful and optimistic.

Our historic Wistaria vine will survive. Maintaining a strong and healthy financial state is at the top of our priorities. We have a phenomenal City Staff- with a dedicated City Manager at the helm. Our City Council is comprised of committed individuals that have the best interest of Sierra Madre at the core of their work. We have passionate residents at the heart and drive of our community.

There is one thing I know for certain - the answer given by me on the campaign trail remains the same. The reasons I love Sierra Madre and why we moved here are 1) I know I can walk my dog at 10:30 at night and feel safe; 2) People still wave "hello" to each other on the streets- just like the neighborhood I grew up in; and 3) No doubt- the quality of life in our Village of the Foothills is unlike anything you'll find in the other 87 cities in Los Angeles County.

It truly has been an honor to serve as your Mayor and I have been humbled by your support.

On December 14, I will pass the ceremonial gavel to our next Mayor and will reflect as to who we are as a community...proud Sierra Madreans. #StrongerTogether

SIERRA MADRE CANDLELIGHT **WALK RETURNS**

Sunday, December 19th at 7:00 PM



More than forty years ago two wise visionaries, Pastor Bob VanderZaag and Pastor Richard Anderson "Dick," felt their community deserved a momentous celebration. Maybe they both saw the beauty in the small towns that had gathered their people together in those many snow filled landscapes, huddling meekly in simple rooms, where a lone fireplace lent its heat. It was not lost on these two Pastors that it was not the splendor of the place that mattered but the people gathering together that created the collective depth to inspire the Spirit of Christmas.

In the Big City, the granting of ones personal space and privacy is considered a social politeness. That is predictable and understandable. It has remained our great fortune that two Pastors understood the Social Contract but also understood the human heart with a perceptive intuition, and so they did not accept the predictable and understandable.

In an age of power grids and lavish displays of electricity, we have not stolen away the charm of candlelight. It remains eternal in its ability to inspire reverence, ever vigil in touching our heart in its simple and artistic beauty. The Sierra Madre event has commenced in the same manner for forty plus years, at the steps of Saint Rita Catholic Church. The Pandemic sidelined this event last year, however, this year the walk is back! The processional will begin at Saint Rita's Church, where participants light their candles and begin the walk to Kersting Court at 7:00 pm. Participants can come a little early and listen to brass carols starting at 6:15. For those that wait below at the bottom of the street, the sea of lights begins its slow, picturesque descent down Baldwin Avenue. As scripture passages are read and the notes of Christmas hymns swirl around the nativity scene and the Baby Jesus will be placed in the manger in the Nativity Scene in Kersting Court.

It is exactly as Linus, instructed Charlie Brown on the true meaning of Christmas. For each year two local children become Joseph and Mary and carry the statue of the baby Jesus and place the statue of Jesus in the crèche.

Be Aware of Your Surroundings!

A word from Corporal Lilian Shaw, SMPD

While you may have your eye on a hot ticket item for Christmas this holiday season, robbery suspects may have their eyes on you! A rash of follow-home robberies has caused police to be on alert and warn people about this growing crime trend.

Whether you're out shopping at a high end store, dining at a five star restaurant, or simply out for a stroll, you may find yourself as a target. Criminals have become brazen, trailing people in affluent neighborhoods and ultimately robbing them at gunpoint, taking jewelry, cash and even the victim's vehicles. On some occasions victims were followed home and

forced to open their door, where suspects then ransacked their valuables before fleeing the scene.

Although news reports show that some arrests have been made in connection to these robberies, this trend continues to plague southern California and surrounding areas, often resulting in violent and even fatal attacks. Police warn the public to be aware of their surroundings, keep your cell phone handy and always know your location in case you need to call police. If you are driving and believe you are being followed, don't go home or to your place of business, drive to your nearest police station instead.

Here are some safety tips for pedestrians:

- Avoid walking alone at night in areas that aren't well lit
- Walk against traffic so that cars cannot surprise you from behind
- Carry a wallet instead of a purse
- Don't be complacent, look for anyone walking too close to you or possibly hiding in wait Criminal see someone who is unable to care for themselves as an easy target, stay sober!
- Keep your keys in hand so that you can open your door quickly
- Wear comfortable shoes in case you have to run to get help
- Stay alert and be prepared to give police a description of the suspects if needed

If you are confronted by suspects don't put your life in added danger by fighting for your property, let them have it!

If you have any information that can help in identify any suspects from previous cases please contact your local law enforcement agency as soon as possible.

YOUR TURN TO SPEAK UP

The final Environmental Impact Report (EIR) for "The Meadows at Bailey Canyon" housing project proposed to be built on the Monastery property has not yet been released. One of the latest timelines states the plan will be presented in early 2022. But timelines have been changed regularly.

We are concerned that once that report is out, there will be scant time for citizens to read,

review and respond to the final report. The State has mandated that there be only five meetings concerning a development. The City plans for two Planning Commission and two City Council Meetings. That leaves one for a Citizens Town Hall.

There needs to be a Town Hall scheduled after the EIR has been released before the Planning Commission meetings. We believe you can make that happen. Let our city planners know how important it is. We also believe that you should start voicing your concerns now about the many problems of the development by writing to the Planning Commission and the City Council

The major issues the Steering Committee of Preserve Sierra Madre addressed in the Draft EIR

Safety: Our General Plan states that the City "avoid construction of new development on land currently unimproved in a very high fire area." The development is not only in a very high area, this area has been evacuated many times due to wildfires threatening the area, including the Bobcat Fire in 2020. The ingress and egress portion of this project from Carter Avenue presents a clear danger if evacuation should be necessary as Carter Avenue is only 20 feet wide at this point; city streets are required to be 37 feet wide.

There is no provision for pedestrian or bicycle traffic on that very thin stretch of road on the entrance to the development on Carter Avenue. Nor is there a provision to add sidewalks or bike paths on Sunnyside, Grove, or Fairview Avenues. This goes against our General and causes very dangerous situations for walkers and bikers alike.

Water: The issue of Net-Zero water is extremely significant since we all know that the extreme drought will prevent the City's ability to purchase water from any source to save for the future, nor do we know when in the future water will be available. Governor Newsom has asked us all to cut back our water usage, even though we have already done so during our five-year drought. The Colorado River is at an all-time low, as is every lake in California. Most are at 35% of their normal level. Minimal snowfall, our major source of water, is already being predicted

Trees: The plan proposes to cut down 100 mature trees. Ten of those trees are well-established protected oaks. Even though the developers have proposed to replace most of the 100 trees, it is inconceivable that sapling trees could survive given the climate concerns of today and the need for increased watering during a drought. The trees they propose to remove also provide shade, shelter, and food to the wildlife that inhabits the area. This includes bats, birds, bears, and deer.

Please email, write, or call your Councilmembers and Planning Commission members with your concerns about this project. Ask them to plan for a timely Town Hall so you can address these problems when the project comes before the Planning Commission and the City Council. Be heard and be specific with your concerns; not just that you don't like the development, or that it shouldn't happen.

They are also somewhat cracked and crazed (which, occasionally, our marriage was, too) but they are precious

in my sight. Playing Christmas music and rediscovering each cute little Christmas item is such fun. I'm especially partial to all my little lighted houses. My mother started collecting them many years ago and gave her collection to me. I have added to it over the years and now think I have about twenty of them. They look fantastic on top of the bookcases, and the tall cabinet. The most interesting part of putting these things up is, of course, not falling off the step ladder. The second most interesting part is figuring out how to get them all plugged in somewhere. The ones on top of the bookcase in my office even turn on and off with the wall switch, which is fabulous.

THE PUBLIC SAFETY AWARD for an employee/individual for protecting and maintaining safety







Fire and Police Issue **Rose Parade Safety Tips**

As the 133rd Rose Parade approaches on Saturday, Jan. 1, 2022, Pasadena's fire and police departments are issuing the following safety tips for the thousands of overnight campers who will line the route on New Year's Eve. The parade route will be a safer place if everyone follows the rules and regulations listed below.

What You Can Do:

Protect yourself and others by getting fully vaccinated against COVID-19 and flu before

Wear a mask over your nose and mouth if you're unable to maintain at least 6 feet of distance from people you don't live with.

Overnight camping is permitted only on the night of Friday, Dec.

A position on the sidewalk may be maintained along the parade route beginning at noon, Dec. 31. All persons and property, such as blankets, chairs and personal items, must remain on the curb until 11 p.m. At that time, spectators may move out to the blue "Honor Line" but not

professionallymanufactured barbecues elevated at least 1 foot off the ground are allowed on the parade route as long as they are 25 feet from buildings and other combustibles. A fire extinguisher must be readily available.

Minors under the age of 18 may be on the parade route from 10 p.m. to 5 a.m. only if they are supervised by an adult.

Asteroid Impact Monitoring System for Risk Goes Online

The new system improves the capabilities of NASA JPL's Center for Near Earth Object Studies to assess the impact risk of asteroids that can come close to our planet.

To date, nearly 28,000 near-Earth asteroids (NEAs) have been found by survey telescopes that continually scan the night sky, adding new discoveries at a rate of about 3,000 per year. But as larger and more advanced survey telescopes turbocharge the search over the next few years, a rapid uptick in discoveries is expected. In anticipation of this increase, NASA astronomers developed a nextgeneration impact monitoring algorithm called Sentry-II to better evaluate NEA impact probabilities.

Popular culture often depicts asteroids as chaotic objects that zoom haphazardly around our solar system, changing course unpredictably and threatening our planet without a moment's notice. This is not the reality. Asteroids are extremely predictable celestial bodies that obey the laws of physics and follow knowable orbital paths around the Sun.

But sometimes, those paths can come very close to Earth's future position and, because of small uncertainties in the asteroids' positions, a future Earth impact cannot be completely ruled out. So, astronomers use sophisticated impact monitoring software to automatically calculate the impact risk.

Managed by Propulsion Laboratory Southern California, the Center for Near Earth Object Studies (CNEOS) calculates every known NEA orbit to improve impact hazard assessments in support of NASA's Planetary Coordination Defense Office (PDCO). CNEOS has monitored the impact risk posed by NEAs with software called Sentry, developed by JPL

"The first version of Sentry was a very capable system that was in operation for almost 20 years," said Javier Roa Vicens, who led the development of Sentry-II while working at JPL as a navigation engineer and recently moved to SpaceX. "It was based on some very smart mathematics: In under an hour, you could reliably get the impact probability for a newly discovered asteroid over the next 100 years - an incredible feat."

But with Sentry-II, NASA has a tool that can rapidly calculate impact probabilities for all known NEAs, including some special cases not captured by the original Sentry. Sentry-II reports the objects of most risk planetarydefense' in the CNEOS Sentry Table.

By systematically calculating impact probabilities in this new way, the researchers have made the impact monitoring system more robust, enabling NASA to confidently assess all potential impacts with odds as low as a few chances in 10 million. Special Cases

As an asteroid travels through the solar system, the Sun's gravitational pull dictates the path of its orbit, and the gravity of the planets will also tug at its trajectory in predictable ways. Sentry modeled to a high precision how these gravitational forces shaped an asteroid's orbit, helping to predict where it will be far into the future. But it couldn't account for non-gravitational forces, the most significant being the thermal forces caused by the Sun's heat.

As an asteroid spins, sunlight heats the object's dayside. The heated surface will then rotate to the asteroid's shaded nightside and cool down. Infrared energy is released as it cools, generating a tiny yet continual thrust on the asteroid. This phenomenon is known as the Yarkovsky effect, which has little influence on the asteroid's motion over short periods but can significantly change its path over decades

and centuries. 'The fact that Sentry couldn't automatically handle the Yarkovsky effect was a limitation," said Davide Farnocchia, a navigation engineer at JPL who also helped develop Sentry-II. "Every time we came across a special case like asteroids Apophis, Bennu, or 1950 DA - we had to do complex and time-consuming manual analyses. With Sentry-II, we don't have to do that

Another issue with the original Sentry algorithm was that it sometimes couldn't accurately predict the impact probability of asteroids that undergo extremely close encounters with Earth. The motion of these NEAs gets significantly deflected by our planet's gravity, and the postencounter orbital uncertainties can grow dramatically. In those cases, the old Sentry's calculations could fail, requiring manual intervention. Sentry-II doesn't have that limitation.

"In terms of numbers, the special cases we'd find were a very tiny fraction of all the NEAs that we'd calculate impact probabilities said Roa Vicens. "But we are going to discover many more ese special NASA's planned NEO Surveyor mission and the Vera C. Rubin Observatory in Chile go online, so we need to be prepared."

A study describing Sentry-II was published in the Astronomical Journal on Dec.

Mexican Nationals Charged in Kidnapfor-Ransom Conspiracy

A federal grand jury today returned an indictment against six members of a Tijuana, Mexico-based hostage-taking organization that allegedly kidnapped nine victims—one of the victims is from Pasadena and murdered six of them including three United States citizens - some of them after their families paid ransom for their release.

The five-count indictment charges all six defendants with one count of conspiracy to commit hostage taking resulting in death, one count of conspiracy to commit extortion, and one count of extortion. The charged defendants, all Mexican nationals, are:

Garcia German Hernandez, 37, the indictment's lead defendant and the alleged ringleader of the hostage-forransom organization; Gilberto Omar Avila Lopez,

27, a.k.a. "Luis Enrique Ávila Moreno" and "Omar;" Aylin Estrada Reyes, 24;

Eduardo Mascorro Delgado, 22; Victoria Camila Espinoza Ballardo, 22; and

Oscar Bautista Valencia, 30 Yera, Lopez and Ballardo each face an additional count of hostage taking resulting in death and extortion. All six defendants are in custody in defendants are in custody in as "Victim H," had been Mexico facing charges filed by authorities there.

According to the indictment, from January 2020 to April 2020, Yera led the hostagetaking organization extorted money from victims by taking hostage and holding for ransom United States nationals and Mexican nationals with relatives in the United States.

The hostage-taking group generally lured their victims into meetings under false pretenses and took them hostage, the indictment states. The group allegedly held the victims at gunpoint, tied them up, and often brutally beat them. Members of the group then called victims' family members in the United States vehicles as ransom in return for the release of their loved ones, according to the indictment. If victims did not have family members who could pay ransom, they were murdered, by the defendants relative to as happened with what the indictment calls "Victim A,"

Victim B" and "Victim I." In other instances outlined 477-6565.

in the indictment in which ransoms were paid, Yera and other conspirators allegedly the organization traveled from Mexico into the United States to locations selected by Yera and others to collect the ransom payments made by the victims' family members. For example, on March 28, 2020, a coconspirator traveled to collect ransom payment on Yera's behalf at a McDonald's in San Ysidro. After the murder of this victim, the indictment alleges that Yera sent Lopez a message depicting a large amount of cash and wrote "this was good job done." On April 11, 2020, Yera and

co-conspirators orchestrated the hostage taking of a victim identified in court documents as "Victim E," a United States national who resided in Norwalk and who was at the time visiting a family member in Tijuana. Victim È was forced to call his mother, say he was in trouble and instruct her to call an individual to pay \$25,000 for his release. The victim's mother struggled to obtain the ransom money but agreed to pay the hostage takers \$1,000 and Victim E's vehicle in exchange for Victim E's release and met up with a ransom collector in Norwalk on April 13, 2020 – the same day Victim E was murdered. His body was recovered in Mexico the next

Ón April 22, 2020, a Pasadena woman called law enforcement kidnapped in Mexico with a ransom demand of \$20,000. One of the kidnappers, calling from a Mexican phone number, informed the victim's family that a woman would pick up the ransom money at a Food 4 Less parking lot in Lynwood. That same day, law enforcement in Mexico rescued the victim, who was being held hostage at a Tijuana hotel.

If convicted of all charges, the defendants would face a mandatory sentence of life imprisonment or the death penalty.

CITY OF DUARTE RECEIVES **PLATINUM LEVEL IN 2021 ENERGY CHAMPIONS AWARD**

On December 8, 2021 the City of Duarte was recognized for excellence by the San Gabriel Valley Energy Wise Partnership (SGVEWP) for achieving the Platinum level of the 2021 Energy Champions Awards.

The intent of this program is to challenge Cities to become more sustainable by becoming more energy efficient and encouraging their populace to join the effort. CHRISTMAS ROAD TRIP AKA **DAY TRIPPIN'**

There is a popular adage "if it was easy, everyone would be doing it", so my visit to Lucky's a white table cloth restaurant in Montecito seemed a simple enough task. Lucky's is clear in their mission: steaks, chops, and seafood. Located on Coast Village Road in Montecito, the space has seen its fair share of businesses since it was built in 1926. Not all were restaurants - this



writer wasn't present for the Pink Squirrel in the 50's (and is still not convinced that the owner actually had a pink squirrel, but that is for another day), Irelands in the 60's, and a few others after that. By the late 90's the building had seen better days and area residents thought the location had just plain run out of luck. As luck would have it, however, a few Montecito residents gave the building a makeover, and Lucky's was born as Montecito's clubhouse - a home away from home complete with a patio, bar and dining area. I have often thought that fine dining is a dying breed, but Lucky's has restored my

The menu lists wonderful aged prime steaks featuring a 24-ounce porterhouse steak and 18 oz bone-in rib chop - for me, the meat closest to the bone is my favorite. A closer look at the nightly specials reveals comfort food that you will appreciate as much I do, like Thursday's Market Street Meatloaf, created and introduced to Lucky's by GM and Chef Leonard Schwartz. Mr. Schwartz has been at Lucky's for eight years, with 22 years in the restaurant business prior to that, and has brilliantly brought some of his favorite dishes to Montecito. Besides the meatloaf, consider the chili with just the right amount of beans for texture (I suggest having the cheese and onions on the side).

On my last visit, I sat at the bar , and had the calamari appetizer with a burger. I don't eat burgers that often, but when I do I want something special, and Lucky's offers an eight-ounce burger made with meats from the kitchen, and the fries are all house-made (if you follow my column, you know I'm a stickler for fresh French fries!). Of course, there are many popular salads on the menu including the house favorite "Lucky's Salad", and an iceberg wedge that is almost a meal in itself. The wine list has many California offerings, including wines from Santa Barbara, Paso Robles and Napa - with more than 25 wines by the glass, there's something for every taste. LOS ANGELES COUNTY REPORTS ADDITIONAL CASE OF THE OMICRON VARIANT AS A POSSIBLE RESULT OF LOCAL TRANSMISSION

The Los Angeles County Department of Public Health (Public Health) has received confirmation of a fourth case of COVID-19 with mutations consistent with the new Omicron variant (B.1.1.529). This latest case is a possible result of local transmission.

The individual is fully vaccinated and received a booster. The individual had mild symptoms and had multiple close contacts who have since tested positive and are self-isolating. Several of the close contacts are fully vaccinated, while the vaccination status of some is still being determined.

Public Health is working to determine if these additional cases are of the Omicron variant.

'The identification of a case of Omicron attributed to community spread is a reminder that we all need to take necessary precautions to prevent transmission of COVID-19," Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "Celebrating with those we love this holiday season requires layering on the protections that are now available to us: vaccinations, boosters, masking up, and testing. This is how we slow the spread of Delta and

Public Health would also like to remind residents that getting vaccinated or boosted remains critical as holiday traveling and gatherings

Additionally, all residents across LA County should continue:

Getting tested to help reduce the spread, especially if you traveled for the holidays, have had a possible exposure or have symptoms

Adhering to masking requirements when indoors or at large outdoor mega events, regardless of vaccination status

Residents are also reminded that they are legally required to be isolated if they have a positive COVID test result and that vaccinated close contacts with symptoms and unvaccinated close contacts need to be quarantined. Los Angeles County

WITH UNVACCINATED 12-17 YEAR OLD'S NINE TIMES MORE LIKELY TO GET COVID-19 THAN VACCINATED 12-17 YEAR OLD'S, PARENTS EN-COURAGED TO VACCINATE THEIR CHILDREN AHEAD OF THE HOLIDAY SEASON

As residents prepare to gather for holidays, the Los Angeles County Department of Public Health (Public Health) encourages parents to protect their children and prevent the transmission of COVID-19 by getting everyone in their family who is eligible vaccinated or

COVID-19 is now one of the top 10 causes of death among children nationwide. The CO-VID-19 vaccine is the best way to protect your child from getting sick, being hospitalized, or developing long-term symptoms. Most importantly, vaccinating your child also helps protect family members, including siblings who are not eligible for vaccination and those who may be at high risk for getting very sick if infected.

In L.A. County, COVID-19 cases among school-aged children decreased by 30% between late September and late November. Over a two-week interval at the end of November, unvaccinated 12-17-year old's were nine times more likely to be infected than those who had been vaccinated. During this same interval, two children aged 5 to 11 and eight children aged 12 to 17 were hospitalized, all of them unvaccinated. There were 6 confirmed MIS-C cases in L.A. County in October 2021 and 4 confirmed cases in November 2021. Pediatric trends mirror adult trends: over the same interval, unvaccinated L.A. County residents over 18 were infected and hospitalized at rates 3 and 14 times higher than vaccinated adults, respectively.

Public Health continues to see very low numbers of school cases given the 1.55 million students enrolled countywide. During the week ending December 4th, 1,311 cases and 3 outbreaks were identified, and test positivity was 0.28%.

"I send my heartfelt condolences to everyone mourning the loss of a loved one to CO-VID-19," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "Although several parts of the country are seeing large waves of pediatric infections and hospitalizations, our experience in L.A. County has been different, with transmission decreasing here over the past two months and relatively low numbers of pediatric hospitalizations. What we are continuing to see is that unvaccinated children are the ones getting severely ill with COVID infections and ending up in the hospital. Meanwhile, county schools remain a very safe place – and in fact, we think it's because of the outstanding preventive work our school partners are doing that we are seeing so little severe illness in children. As we're headed into the winter holidays and children spend more time intermingling without schools' protective layers of consistent mask wearing and other control strategies, their risk of infection is going to increase. The best way to get children ready for the holidays is to get them vaccinated as soon as possible."

Ms. [Karalee] Nakatuska, mentioned in the review above, was recently named as one of Time's "Educators Who Saved a Pandemic School Year" and has also been celebrated as a California History Teacher of the Year in 2019. Nakatsuka is just one of several award-winning Arcadia Unified teachers, some of whom include GRAMMY Museum 2019 Jane Ortner Education Award recipient, Heather Moore and EdTech Magazine's Top 30 K-12 IT Influencers for 2021, Christine Pinto.

In addition to making the Niche grade, Arcadia Unified has kept its commitment to developing the "whole child" by supporting more than academics. It's placed a focus on social and emotional development, as well as helping students establish lifelong leadership skills from an early age. Since the 2018-19 school year, and though not a mandated requirement for local public school districts, Arcadia Unified has had at least one full-time school counselor at each of its schools in its dedication to student mental health and wellness. Likewise, the district also offers character education programs, such as "The Leader in Me" for students in TK-8 grade, and has adopted "restorative practices," which are techniques geared towards building strong, trusting relationships and community in classrooms and schools. In the 2020-21 school year, Arcadia High established a Wellness Center, which has a full-time counselor, a physical space for students to go to, and is solely dedicated to fostering mental health and wellness needs.







PILL SPLITTING: WHEN IT'S SAFE, AND WHEN IT ISN'T

When is it safe, or not safe, to split pills? I have a cousin who cuts almost all her pills in half in order to save money, but I'm wondering if she's going overboard. What can you tell me about this? Curi-

Dear Curious:

Pill splitting – literally cutting them in half – has long been a popular way to save on medication costs, but your cousin, if she hasn't already done so, needs to talk to her doctor or pharmacist because not all pills should be split.



The reason pill splitting is such a money saver is because of the way drugs are manufactured and priced. A pill that's twice as strong as another may not be twice the price. In fact, it's usually about the same price. So, buying a double-strength dose and cutting it in half may allow you to get two months' worth of medicine for the price of one. But is it safe? As long as your doctor agrees that splitting your pills is OK for you, you learn how to do it properly, and you split only pills that can be split, there's really no danger.

Ask Your Doctor

If you're interested in splitting your pills, talk to your doctor or pharmacist to find out if any of the medicines you use can be safely split. It's also important to find out whether splitting them will save you enough money to justify the hassle.

The pills that are easiest to split are those with a score down the middle. However, not every pill that's scored is meant to be split. Pills that are most commonly split are cholesterol lowering drugs, antidepressants and high blood pressure medicines.

Use a Pill Splitter

Having the right equipment is very important too. Don't use a knife or scissors to cut your pills in half. This can cause you to split them unevenly resulting in two pieces with very different dosages, which can be dangerous. Purchase a proper pill cutter that has a cover and a V-shaped pill grip that holds the pill securely in place. You can find them at most pharmacies for \$5 to \$10.

For convenience, you might be tempted to split the whole bottle of pills at once. But it's best to do the splitting on the day you take the first half, and then take the other half on the second day or whenever you are scheduled to take your next dose. That will help keep the drugs from deteriorating due to exposure to heat, moisture, or air. It will also help ensure that any deviation in the size of one dose is compensated in the next. It's also important to know that pills are only safely split in half, and never into smaller portions such as into thirds or quarters.

Don't Split These Drugs

Some pills should never be split. Drugs that are time-released or long-lasting and tablets that contain a combination of drugs probably shouldn't be split, because it's difficult to ensure a proper amount of active ingredient in each half. Pills with a coating to protect your stomach, and pills that crumble easily or irritate your mouth shouldn't be split either, along with chemotherapy drugs, anti-seizure medicines, birth control pills and capsules containing powders or gels.

Again, your doctor or pharmacist will know which drugs can and cannot be split. If you're taking a medicine that can be split, you'll need to get a prescription from your doctor for twice the dosage you need. Then you can start splitting and saving, safely.

THE BASICS ON NFTS: THE NEWEST **CRYPTOVERSE CRAZE**

NFTs, or "non-fungible tokens," are the latest sensation in the cryptocurrency universe. In the most basic terms, an NFT is a cryptographic token that exists on a blockchain and is used to establish proof of ownership of digital artwork, videos, GIFs, collectibles, and other digital assets. Clear as mud, right?

NFTs have been generating a major buzz in the tech and art sectors for years now, but after Christie's auction house sold a single NFT collage from the digital artist Beeple for a staggering \$69.3 million this March, NFTs have begun making mainstream headlines.

WHAT'S THE DIFFERENCE BETWEEN CRYPTOCURRENCY AND NFTS?

While NFTs and cryptocurrencies like Bitcoin and Ethereum are all part of the Cryptoverse, cryptocurrency is a "fungible" asset, meaning it can be traded or exchanged with another identical unit of the same value. For example, one Bitcoin is equal in value and can be exchanged for another Bitcoin, just like one dollar is always worth the same as another dollar.

However, NFTs are "non-fungible," meaning each NFT is totally unique and not mutually interchangeable. Given this, no two NFTs are ever the same, and they cannot be replicated. Think of it in terms of traditional artwork: anyone can buy a Mona Lisa print, but only one person can own the original artwork.

HOW DO NFTS WORK?

As with cryptocurrency, a record of who owns each NFT is stored on a blockchain ledger. The vast majority of NFTs reside on the Ethereum blockchain, though other blockchains like Bitcoin Cash and FLOW also support them. Whenever a new NFT transaction is verified, it's added to the blockchain, where it cannot be changed, replicated, or forged.

The code embedded in NFTs can include specific information about the asset and its creator. For example, an artist can sign their digital artwork by including their signature in the NFT's metadata. The unique information related to an NFT is stored in what's known as a smart contract, which is one of the most unique and powerful features underpinning NFT technology.

A smart contract is a digital contract in which the terms of the agreement are set in code. A smart contract can be programmed to execute a specific action when a set of predefined conditions are fulfilled. For example, a smart contact can be programmed to make royalty payments to an NFT's creator whenever their digital art is sold to a new owner.

WHY DO NFTS HAVE VALUE?

Traditional pieces of art like paintings are valuable precisely because they are one of a kind, yet digital art can be easily duplicated an infinite number of times. With NFTs, digital art and other assets can be tokenized, which creates a digital certificate of ownership that allows the buyer to own the original item.

The value comes from both the scarcity and collectability of the asset, as well as its potential for future sale. NFTs work like any other speculative asset, in that you buy it and hope that the asset's value increases over time, so you can sell it for a profit.

Essentially, NFTs transform, or "tokenize," digital art, videos, and other collectibles into one-of-akind, verifiable assets, which allows them to be easily bought, sold, or traded on the blockchain. NFTs are basically like any other collector's item, such as a painting or a vintage baseball trading card, but instead of buying a physical item, you're instead paying for a digital file and proof that you own the original copy.

ARE NFTS A GOOD INVESTMENT?

While many see NFTs as merely another passing fad and expect the NFT bubble to burst any day now, I don't know what to think. Personally, I won't be investing in NFTs anytime soon - my wealth building plan incorporates more conventional, less speculative endeavors. I am, however, fascinated by these new Cryptoverse technologies and will watch the coming financial asset revolution with interest



I admit that I felt a little guilt about the ease of my own life as compared to my father's and grandmother's lives. I knew they came from another country where they had not even been allowed to go to School and lived in fear for their own lives. I knew they had survived the depression and I knew that even my mother was unable to finish High School because her family could not afford the fifteen cents necessary for bus fare. I knew about the Concentration Camps killing Jews in Europe but that happened a long time ago, more than ten years at least. Now, however, was a new time and my whole family had struggled to create a good life for me

So what happened to this awareness? I do not feel fortunate or confident now. The major change, I think, is that I am not confident that things will get better. I do not believe that the politicians or the political parties, or the corporations are interested in very much other than making more money and accumulating more power. Worst of all I don't believe anybody. In the battle of Covid virus versus science and all Man's accumulated knowledge I feel like willful ignorance is winning and still people are complacent and accepting. I am extraordinarily depressed when I hear people in their twenties and thirties say they want no children because "who would want to bring a new child into this world". Worse yet, to me, are the younger generational folk who say they don't want to have children because it would be too disruptive to their careers or vacation plans? To me this is generational confusion connected to habits of abundance and a belief in entitlement.

Maybe the problems are more connected to attitudes than to beliefs. Somehow the whole country expected that life would be pretty easy for us absolutely not recognizing how hard previous generations had worked to put us where we are. I don't think life was easy and it never was. I know there is a reason I keep a picture of my father in army uniform and CCC uniform on my bedroom wall. I know a great many of us keep pictures of our deceased parents and grandparents on our walls and that those pictures remind us of how much we were cared for. We have a debt to pay and that debt can only be paid by maintaining a positive attitude toward our own lives and doing the best we can to assist our children in maintaining the attitude necessary to enjoy their own lives. Do you realize what a wonderful opportunity our life was and still is?

Often, I hear my wife repeatedly say to our granddaughter "You can do it" and then seeing my grandaughter's triumph, face her fears, slide down the scary slide and then loudly proclaim, "I strong—I brave". It is bravery that is necessary to face maturity and the realization that the world will not take care of us. We have to take care of ourselves. The way we do it is through our own attitudes as we face the challenges presented to us. Be strong, be brave and accept the gift of life and value it and pass it on.

Rather than material goods or money, why not write up a series of IOUTs (I owe you time) to give to others:


- I'll make you your favorite dinner.
