It's that special time of year again, but before searching the sky for eight flying reindeer and before we toast to a better year in 2022, the annual reorganization process takes place in Sierra Madre.

City Council met on December 14 before a small handful of people for the year's final meeting and announced the leadership changes to take us into the New Year.

City Manager

First on the docket was the approval of an employment agreement for a new City Manager. In July 2021, City Manager Gabe Engeland reigned to seek a new venture in Los Altos. Since then, Jose Reynoso has served as interim City Manager. On November 2, 2021, after reviewing potential candidates in a closed session with City Council, Mayor Rachelle Arizmendi recommended City Attorney Aleks Giragosian draft an employment agreement for Reynoso.

City Council unanimously approved the employment agreement for the new City Manager, Jose Reynoso. It is an indefinite term and one of only two positions appointed by the City Council, the other being City Attorney.

Mayor and Mayor Pro Tempore

Mayor Arizmendi, along with the other Council Members, honored Mayor Pro Tem, Gene Goss, for his continued service this past year as he heads into his final year as part of the Council. Goss previously served as Mayor in 2016 and has been on the Council since 2014. In addition, Mayor Arizmendi was also honored for her service this past year, which included facing a pandemic in California, the epicenter. There were shutdowns causing businesses to struggle as a result. The mayor's first challenges included conducting City business over Zoom and later in sometimes cold, rainy, outdoor settings. She approved for permit-free extended, outdoor dining for restaurants and awarded funds to help businesses crippled by COVID shutdowns. The mayor was honored by Senator Anthony

Portantino, Assembly Member Chris Holden, and the Sierra Madre Chamber of Commerce.

After all the commemorations were over, it was time to look toward 2022. Not two minutes after receiving great praise for her term, Mayor Arizmendi rose from her center seat, and Gene Goss took the oath and became the next Mayor of Sierra Madre. Council Member Edward Garcia, who is new to the Council this year, followed suit and took his oath to become mayor Pro Tem.

The Mayoral roles are ceremonial and change every year. These appointments directly impact the City's liaison appointment to the Los Angeles County Sanitation District as the City's primary and secondary voting delegate,

COMMUNITY YOUTH SERVICE AWARD presented to youth under 18 for outstanding service



LETTER TO THE EDITOR

For those who have never had the occasion to attend a City Council meeting or a Planning Commission meeting, I share with you what was discussed at the last PC meeting. On the agenda was a request from the family that recently purchased the Wistaria property. They wanted to add on to the small house to accommodate their family and make it safer from the heavy weight of the Wistaria Vine. Part of the request was to cut down and remove one of the 5 trunks of the Vine. To the gasp of those in attendance, it was obvious to everyone in the room that something was wrong and it was not all the homeowners fault. It was interesting that the Planning Commissioners stated: 'hold on here, we don't want to be responsible for any damage to the Vine'.

From that point, we all learned that in the last 40 years the previous owners cared for the Wistaria Vine and graciously allowed local organizations and the city to host the Wistaria Festival every year, allowing thousands of visitors to walk through their property to view the vine, all at the pleasure of the owners of the house and the vine. The new homeowner, who was aware of the celebrity of the vine, had an arborist at the meeting but the City wanted them to get a second or third opinion at the homeowner's expense.

The City has not done anything to officially protect the vine by designating it a 'protected' plant or 'historical' treasure in the municipal code, maybe that was because the Wistaria Festival was put on by the Chamber of Commerce with the help of other local organizations and the community at large.

The next day I found out that "Gabe", the City Manager at that time, had looked at the property when it was up for sale to consider purchase of the property and the vine by the city. Apparently he had Council take no action.

Taking no action meant the new owners could totally cut the vine down or, if they kept the vine, they were under no agreement to allow the public on the property to view the vine for the annual Wistaria Festival.

Learning of the failure at City Hall to protect one of the Treasures of Sierra Madre, I quickly sent an email to one of our trusted council members explaining the problem that required some quick action and communication with the new owners. The reply I got back was, "I spoke to the owner today, I hope the community understands that their actions and words make the home owner feel unsafe and unhappy about our City."

WOW!--the community got scolded for a problem created by City Hall for not taking action in the past!

The council member was referring to a Saturday in October or November when there was a truck in front of the Wistaria property being loaded with cuttings from the Wistaria vine. Uncertain what was going on, neighbors contacted the City. Word spread quickly and a few residents showed up to see what was going on. There was no arborist present and there were concerns about the health of the vine. A city employee halted the work until they could review the problem during normal business hours. Ironically, had the vine been damaged irreparably, the same folks at city hall would probably be asking why no one did anything?

Sure makes you wonder how many other times City Hall hasn't acted in the best interest of the community?



Omicron Variant found in Pasadena

The Pasadena Public Department announced Tuesday that they have received the first laboratory-confirmed report of COVID-19 with mutations consistent with the new Omicron variant in a Pasadena resident.

The Omicron variant was identified in a laboratory specimen from resident through genomic sequence testing. The person did not recently travel internationally and is believed to have acquired the infection locally in early December. The person, who was fully vaccinated and had a booster dose, has recovered from a mild illness that did not require hospitalization. contacts are self-isolating.

The Omicron variant of the SARS-CoV-2 virus was first identified in Africa and has been designated by the World Health Organization as a variant of concern. As of Dec. 8, 13 cases of the Omicron variant have been reported in the state of California.

"Now is the time for anyone who is not yet vaccinated to get fully vaccinated, and for everyone 16 years and older to get a booster dose. Getting vaccinated, including a booster, remains your best defense against COVID-19 variants," said Dr. Ying-Ying Goh, health officer and director of Pasadena Public Health Department.

COVID-19 vaccines are proven to be highly effective at preventing hospitalization and death from COVID-19, and people who are fully vaccinated and received booster doses are much less likely to be infected and transmit the virus to someone else. The longer you wait to get vaccinated, the greater the risk of contracting COVID-19.



I hope that you were able to spend valuable time during Christmas with your family and friends. Next up on the calendar, The New Year! I think time is speeding up on me.



One of my favorite subjects is joyfully known as "Bubbly." I do not wish to be a referee with zebra stripes, but I think it is important to discover some of the more intriguing historical elements of the liquid that tingles within our glass upon the stroke of midnight. There is a difference between "Champagne" and "Sparkling Wine." Champagne is a distinct region in France and by strict French Law, only grapes grown and produced in the region can be called Champagne. Many states and countries produce a sparkling wine using very similar methods as the French. In California the procedure is called, "Champione Method." In Spain they call it Cava, and South Africa uses Cap classique. An Italian sparkling wine is called Asti. In Germany, Sekt is a common sparkling wine. Other French wine regions cannot use the name Champagne, i.e. Burgundy and Alsace produce Crémant. Sparkling wines mislabeled Champagne can be and are often seized and destroyed by legal authorities.

How did this wonderful bottle of Bubbly come into our world? Most believe that the monks of France developed and began the process some four hundred years ago. It appears that these guys have a lot of free time on their hands. Like some many of our greatest discoveries, Champagne was actually a mistake. Can you believe that! Most wines were drunk very early, but some were transported long distances and through the journey, the casks would warm and set off a secondary fermentation. A strange bubbling would be noticed when these casks were opened. Dom Perignon gets the credit for one of the first successful deliberate capture of the "mousse" in a bottle. Since then many a ship has set sail and many weddings have started and ended with Champagne. Here are a few of the funnier quotes I found...

"I only drink Champagne when I'm happy, and when I'm sad. Sometimes I drink it when I'm alone. When I have company, I consider it obligatory. I trifle with it if I am not hungry and drink it when I am. Otherwise I never touch it - unless I'm thirsty." (Lily Bollinger)

I drink Champagne when I win, to celebrate . . . and I drink Champagne when I lose, to console myself." (Napoleon Bonaparte)

"In victory we deserve it, in defeat we need it." (Winston Churchill)

"Champagne makes you feel like it's Sunday and better days are just around the corner." (Marlene Dietrich)

"My only regret in life is that I did not drink more Champagne." (John Meynard Keynes)

"Champagne is the only wine that leaves a woman beautiful after drinking it." (Madame De Pompadour)

Public Health encourages everyone who is eligible for a booster to get one as soon as possible and to continue wearing a mask when in crowded public spaces

HIGH COMPLIANCE WITH MASKING REQUIREMENTS KEEPS L.A. COUNTY RESIDENTS SAFE AND HEALTHY; CDC RECOMMENDS MRNA VACCINES OVER JOHNSON AND JOHNSON

Public Health data suggests that public mask wearing is one of the most effective strategies at reducing the spread of the virus when compliance is high.

In L.A. County schools, where mask wearing is mandatory indoors, this practice (in combination with other mitigation strategies and outbreak management) has kept transmission low. This protective effect was demonstrable even in elementary schools before 5-11 year old were eligible for vaccines. With more than 1.55 million students across 3,000 L.A. County schools, Public Health is routinely seeing less than a dozen outbreaks each week. Public and business sector masking compliance is high, indicating the broad understanding that this small behavior change adds a layer of protection that enables us to engage in our customary activities without endangering ourselves or others. Public Health regularly conducts site visits to assess mask compliance across a variety of L.A. County businesses, during which we determine compliance among customers, employees and their staff, and overall safety requirements. Out of more than 1500 site visits conducted between December 4th-10th, the vast majority of businesses and industries, including restaurants, bars, food markets and hair salons, had masking compliance rates above 95%.

Public Health notes yesterday's endorsement by the Centers for Disease Control of updated recommendations made by the Advisory Committee on Immunization Practices (ACIP) for the prevention of COVID-19, expressing clinical preference for adults 18+ to receive an mRNA COVID-19 vaccine over Johnson & Johnson's COVID-19 vaccine. As of December 12th, over 530,000 residents in L.A. County have received a dose of the Johnson & Johnson COVID vaccine. We remind residents that L.A. County's supply of mRNA vaccines is abundant and that when it is time to get a booster dose, individuals previously vaccinated with the Johnson & Johnson vaccine should consider boosters with Pfizer or Moderna.

"Masking requirements reduce transmission without much disruption to people's routines and allow businesses to reduce risk for their customers, and workers," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "We would like to express our sincere appreciation to the business community of L.A. County for leading by example on masking as champions for public health. The take home message is clear: masking creates safety for employees and customers, reduces COVID transmission in our communities and helps everyone stay safe here in L.A. County."

Ferrer continued, "We appreciate the CDC's guidance on vaccine choice. While any vaccine is better than no vaccine, we urge those who have received Johnson and Johnson vaccines to obtain booster doses of Pfizer or Moderna vaccines to ensure they are well protected from both suffering severe Covid outcomes and transmitting infection to others."

Public Health has identified a total 1,556,685 positive cases of COVID-19 across all areas of L.A. County. Today's positivity rate is 1.6%.

Public Health would like to remind residents that getting vaccinated or boosted remains critical as holiday traveling and gatherings begin.

Additionally, all residents across L.A. County should continue:

Getting tested to help reduce the spread, especially if you traveled for the holidays, have had a possible exposure, or have symptoms, or are gathering with people not in your household.
Adhering to masking requirements when indoors or at large outdoor mega events,

regardless of vaccination status.

Residents are also reminded that they are legally required to be isolated if they have a positive COVID test result and that vaccinated close contacts with symptoms and unvaccinated close contacts need to be quarantined.

COVID-19 vaccines are safe and effective and are recommended for everyone 5 years old and older to help protect against COVID-19. Vaccinations are always free and open to eligible residents and workers regardless of immigration status. Appointments are not needed at all Public Health vaccination sites and many community sites where first, second, and third doses are available.

HOW OLDER DRIVERS CAN SAVE ON INSURANCE

Dear Savvy Senior:

Can you provide any tips to help seniors reduce their auto insurance premiums? I just got hit with a 15 percent increase on my car insurance and am looking for ways to save. Fixed Income Frank

Dear Frank:

Unfortunately, auto insurance rates went up significantly over the past year as the pandemic eased and more Americans got back on the roads. But there are plenty of ways to cut your premium. To find out what discounts may be available to you, contact your auto insurer and inquire about these options, and any others that may benefit you.



Low mileage discount: Most insurers offer discounts to

customers who drive limited miles each year, which is usually beneficial to retirees who drive less because they don't commute to work every day. These discounts usually kick in when your annual milage drops below 7,000 or 7,500, which is significantly less than the typical 12,000 miles most Americans drive a year.

Drivers Ed discount: Many states require insurance companies to offer defensive driving discounts - between 5 and 15 percent - to drivers who take a refresher course to brush up on their safety skills. These courses, offered by AAA (aaadriver.online/register/roadwise) and AARP (aarpdriversafety.org), cost \$20 to \$30 and can be taken online.

Monitored driving discount: Many insurance providers offer discounts based on how and when you use your car. To get this, the insurer would provide a small monitoring device that you would place in your car to track things like your acceleration, braking habits, driving speeds, phone use and when you drive. Drivers are rewarded between 10 and 50 percent for safe driving and for not driving late at night.

In addition, many insurance providers also offer discounts to drivers who do not have any violations or accidents for three or more years.

Membership discounts: Organizations that you belong to can also lower your insurance premium. Insurers offer discounts through professional associations, workers' unions, large employers or membership organizations such as AAA, the National Active and Retired Federal Employees Association, AARP, etc. You could even qualify for savings based on the college you attended or the fraternity or sorority you belonged

Bundle policies: If your auto policy is issued by a different company from the one insuring your life or home, call each insurer and ask if bundling the policies would be cheaper.

Improve your credit: You may be able to lower your car insurance premium by paying your bills on time and reducing the amount of debt you carry. Insurers look at how their customers manage credit to get an idea of risk and to price policies. Better rates are given to those with good credit scores, typically 700 or

Increase your deductible: While it's not right for everyone, paying a higher deductible could save you big on premiums. For example, raising your deductible from \$200 to \$500 could reduce the cost of your collision and comprehensive coverage by 15 to 30 percent. Going to a \$1,000 deductible could save you 40 percent

Consider your car model: If you're shopping for a new vehicle, call for an insurance quote before you decide what to buy. Some vehicles are safer and cost less to repair than others. Insurance companies collect data about each make and model and use it to determine how much to charge customers.

Comparison shop: To find out if your current premium is competitive with what other insurers charge, or to help you look for a different provider you should comparison shop. Online brokerages such as CarInsurance.com, TheZebra.com and QuoteWizard.com let you plug in basic details - such as your age and your car's make, model and year - to compare rates from insurance companies.



MY ONGOING GRUDGE WITH SANTA

I've had sort of a grudge with old Mr. Santa Claus. I was introduced to Santa Claus by my parents, who informed me that he was the one that brought all of my Christmas presents on Christmas day. And I believe my parents.

I remember on Christmas Eve we had to go to bed early to give Santa Claus time to deliver our presents under the tree. It was hard to sleep that early on Christmas Eve knowing that Santa was coming with Christmas presents. Finally, we did fall asleep only to wake up Christmas day with the tree filled with our Christmas presents.

I did not know the real identity of Santa Claus until many years later.



THINKING IS NOT ENOUGH BUT IT'S A GOOD START



graduated from Radcliffe College. In 1991 she was badly beaten by Indonesian soldiers after witnessing a mass killing of peaceful demonstrators. I was not beaten, maybe spat upon a few times, but I still identify a bit with Amy.

The content of the show and the background of Amy contribute to my maintenance of a certain attitude about myself. I am proud of being a Jewish person, a secular Jewish person, with no religious belief or religious education or much knowledge of Jewish traditions but who firmly believes in authentic Jewish principles. These principles are fairness, equality, and compassion for the oppressed. I like knowing that an elitist education at Radcliffe (now Harvard) and an orthodox grandfather are not necessarily impediments to engaging heroically with the present horrors of today's world. Democracy Now guarantees that I remain aware but it is accompanied by a strong dissatisfaction with myself.

I still want to help the world but have lost my way. As an attorney representing mainly indigent and politically persecuted people I tried to do my best. But now I am retired and am rarely out in the world. My wife takes loving care of me, prepares our meals, washes our clothes, and uses technology to shop for our food and to pay our bills. She even presses the right keys so that my weekly articles are sent to the editor of this paper. I bemoan the fact that I don't do anything and she says "so learn"; but I don't. So why not? Like Lady Gaga was "I born this way?" After all I was raised in a home with mothers and grandmothers who told me not to touch anything. I never went to the refrigerator myself and never thought of saying that that I wanted to pick out my own clothes or that I had much preference for anything. I never had any particular ambition as far as professions were concerned and I went to College because my friends did. I went to Law School because I didn't want to get drafted—that was one thing I knew. My present inaction and indecision leaves me feeling dissatisfied with myself. Probably this feeling is intensified by watching Democracy Now. Maybe that's what I like best is this continual dissatisfaction with myself. It is familiar and comfortable and does not require that I do anything else.

Well, I spend a lot of time thinking, mainly about myself, I guess. Notwithstanding my internal disapproval I still manage to quite like myself. Without comparing myself to others I think I am okay. Forgetting infants and toddlers I am one of my favorite people. I know there is a kind of unforgiveable privilege and complacency associated with this overall picture and, as typical of me, I do think about it. I wonder what else I should be doing. It is not my desire to be beaten by soldiers as Amy Goodman was. But I know that there is more that I should and want to be doing. I keep writing but writing isn't enough.

Let's think about that because that's probably all that I will do. Remember the Hippocratic Oath (not hypocratic—but sometimes you wonder) First: Do No Harm. Right now I'm just trying for honesty and believing my curiosity and continuing to talk with all kinds of people and carefully listening will help me to find the right track. Strangely today, in these impossible times, I am continually delighted by my experience of existence. Being alive is pretty great and beatings are not required. Happy Holidays

NOW RAND PAUL IS IN FAVOR OF BIG GOVERNMENT



Rand Paul has long been a laughable lightweight – at Senate hearings, Dr. Fauci beats him up on a regular basis – but now he has outperformed even himself.

Republicans like him always equate "big government" with "socialism" and routinely condemn it as a matter of principle – until catastrophe hits their own backyard, and then suddenly,

without even a scintilla of embarrassment, they dump their doltish boilerplate and plead for big government socialist money to rescue them.

Look, the tornado victims in Kentucky deserve all the help that Joe Biden can possibly provide, and he's already doing it. But we can still take a moment to laugh ourselves silly at the letter Paul sent to the president over the weekend, where be begged for federal assistance and asked Biden to "move expeditiously to approve the appropriate resources for our state."

Isn't it amazing how all the idiot talk about the evils of "socialism" gets blown away as soon as killer weather (the "new normal," thanks to climate change) comes calling?

If memory serves, Paul is the purportedly principled "libertarian" who voted in 2013 not to send billions in federal relief aid to the New Jersey victims of Hurricane Sandy, who voted in 2017 not to send billions in federal relief to the Texas victims of Hurricane Harvey, who voted in 2017 not to send federal relief money to the Puerto Rico victims of Hurricane Maria, and who voted in 2019 not to appropriate billions in new relief money to several federal agencies.

As he once explained, "This (relief spending) has to stop. We spend too much. We owe too much. We cannot keep spending money we do not have."

But now that his state has been hit hard, he wants to spend as much as possible with all expeditious speed. In the past he always insisted that if the feds wanted to hike disaster spending, they should offset those costs by cutting the budget somewhere else. But lo and behold, you can read the entire letter that Paul sent to the president, and not once is there any insistence that Kentucky should be helped only if the federal budget is cut elsewhere.

No amount of air freshener can erase the stench of his hypocrisy.

Actually, that's standard Republican behavior. Mick Mulvaney, the Trump budget director, was a congressman who voted in 2013 not to send money to New Jersey, insisting that Sandy relief should happen only if budget cuts were made elsewhere. But in 2015, when his state of South Carolina was flooded by a killer storm, he pleaded for federal money without first insisting on other budget cuts: "There will be a time for a discussion about aid and how to pay for it, but that time is not now."

The state's senior senator, Lindsey Graham, did the same thing. He'd voted No on the Sandy package, but suddenly, after his flood, he declared: "Rather than put a price tag on it, let's just get through this, and whatever it costs, it costs."

There's much more. Tom Cotton, the Arkansas senator, voted No on the Sandy package, but pleaded for expeditious federal money a few years later after Arkansas was hit by floods. Four House Republicans from Colorado voted No on the Sandy package, but a pleaded for socialist help a few months later when Colorado was hit by floods. In 2011, the two Republican senators from Oklahoma voted No on the Sandy package and in 2011 they tried to cut the Federal Emergency Management Agency budget – only to pull a miracle switcheroo in 2013 when Oklahoma was hit by tornadoes.

One of those senators, Tom Coburn, told his constituents: "As the ranking member of the committee that oversees FEMA, I can assure Oklahomans that any and all available aid will be delivered without delay."

So Rand Paul is merely one rotten egg in the basket of deplorables. Nevertheless, he was still a committed scrooge as recently as last month. When Biden's infrastructure package reached the Senate floor – with its \$47 billion outlay to combat climate change; with its \$6.8 billion for FEMA – Paul again voted No. How fortunate for his benighted citizens of Kentucky that he was powerless to stop its historic passage.

And how fortunate Kentuckians are that Paul's hypocrisy has been trumped by Biden's sense of responsibility. The president has already approved massive federal relief aid with all deliberate speed – without fuming that the state's red electorate had voted against him, without ranting that the state's two red senators were horrible people or whatever, without offering to throw paper towels, without telling Kentuckians that maybe the tornadoes would've never happened if they'd bothered to rake their forests.

That's called governing.

'TIS THE SEASON FOR STUDENT LOAN SCAM CALLS

If you have a federal student loan, you probably already know that the Coronavirus emergency relief program that has paused your payments is ending. Repayments will begin again after January 31, 2022. Scammers know it, too, and are looking for ways to take advantage: they're calling, texting, and e-mailing to try to use any confusion around restarting your student loan payments to steal your money and personal information.

If you get a call, text, e-mail, or message on social media from someone about your federal student loan, here are some things to keep in mind:

- Never pay an upfront fee. It's illegal for companies to charge you before they help you. If you pay up front to reduce or get rid of your student loan debt, you might not get any help — or your money back. Also, remember that there's nothing a company can do for you that you can't do yourself for free. And you never have to pay to get help from the Department of Education.
- Never give out your Federal Student Aid ID, your Social Security number, or other personal information to anyone who contacts you. Scammers posing as student loan servicers can use this information to log into your account, change your contact information, and even divert your payments to them. Instead of giving out your FSA ID, call or contact your servicer.
- Don't sign up for quick loan forgiveness. Scammers might say they can get rid of your loans before they know the details of your situation. Or they might promise a loan forgiveness program — that most people won't qualify for. They might even say they'll wipe out your loans by disputing them. But they can't.
- Scammers use fake seals and logos to lure people in. They promise special access to repayment plans, new federal loan consolidations, or loan forgiveness programs. It's a lie. If you have federal loans, go to the Department of Education directly at StudentAid.gov.
