CITYWIDE ORGANICS **RECYCLING TO BEGIN** IN 2022

SIERRA MADRE

On November 8, 2021, the City Council approved the second reading of Ordinance 1447 adding Section 8.14 "Organic Waste Disposal Reduction" to the Sierra Madre Municipal Code. Sierra Madre adopted Ordinance 1447 to comply with various State-Wide recycling requirements, and specifically Senate Bill 1383.

City Staff and Elected individuals will be in discussions with the City's franchise hauler, Athens Services in the next few weeks to update the City's agreement to reflect the new requirements contained within Ordinance 1447.

Mandatory recycling of organic waste is the next step toward achieving California's aggressive recycling and greenhouse gas (GHG) emission goals. California disposes approximately 30 million tons of waste in landfills each year, of which more than 30 percent could be used for compost or mulch (see the 2014 Waste Characterization Study). Organic waste such as green materials and food materials are recyclable through composting and mulching, and through anaerobic digestion, which can produce renewable energy and fuel. Greenhouse gas (GHG) emissions resulting from the decomposition of organic wastes in landfills have been identified as a significant source of emissions contributing to global climate change. Reducing the amount of organic materials sent to landfills and increasing the production of compost and mulch are part of the AB 32 (California Global Warming Solutions Act of 2006) Scoping Plan. Finally! The Sierra Madre Rose Float Association's entry to the Rose Parade is almost done! The float, 'Nature's Classroom' was designed by Jason Redfox originally for the 2021. The Parade was sidelined by COVID-19 and construction of the float was curtailed. However, dedicated SMRFA staff worked on the float this year, finishing in time for it to participate in the 2022 parade on Saturday, January 1st.

There will be a total of 43 floats in the 2022 parade. The overall theme is, "Dream. Believe.

This will be the 90th volunteer-built float entry from the SMRFA and highlights the need to conserve and protect the endangered rainforest. A textbook and student's journal invites discovery throughout the beautifully composed presentation of animal, insect, and plant life. Toco and keel-billed toucans atop kapok trees tower over endangered frogs, lizards, and butterflies. Both toucans' heads turn independently through a joystick, allowing the operator to respond to the crowd reactions. Holiday trees are 100% recyclable! Athens Services collects holiday trees each year, from the day after Christmas through the second week of January, on your normal pickup day. Trees are delivered to various landfills to be used as mulch or cover material, or to Athens' American Organics compost facility in Victorville.

Tips to ensure your tree is properly collected:

- Remove stands, ornaments, lights, and tinsel.
- Place holiday trees next to your regular trash containers.
 Trees over 6 feet in length must be cut in half.
- Trees with flocking or fire retardants ARE NOT acceptable.
- If you miss the date for recycling, please cut up your tree and place it in your yard waste container(s).

And a little word from The Word can't hurt either:

"Always be full of joy in the Lord. I say it again – rejoice! Don't worry about anything; instead pray about everything. Tell God what you need and thank him for all he has done. Then you will experience God's peace, which exceeds anything we can understand...And now, dear brothers and sisters, one final thing. Speaking of things that are excellent and worthy of praise, just about everything on the front page of last week's Mountain Views News was exactly that! The picture by Sonny Salsbury of a snow-covered street with folks tobogganing is delightful. The Candlelight Walk was so beautiful to see. Craig Haikola's story "The City of Angels" was intriguing as it started with deciding whether or not to pick up a tarnished penny in the street or speak to a lost soul who might or might not be an angel in disguise but ended in our imagination as, try as I might, I never could find the rest of the story. With your permission, Craig, I'd like to give your story my ending...

"I am sure I was supposed to say something to him – even if it was just a kind word to let him know the world cared. I did none of that, much like the old penny of the street, so tarnished..."

That's where Craig's story ended. But I would like to think that he reconsidered, went back, found that exhausted, discouraged soul, and took him into the all-night diner down the block, bought him a cup of coffee and a short stack of pancakes and told him that there was Someone Who cared deeply for him. God had not forgotten him. I am a devout picker upper of pennies on the street, no matter how tarnished and dirty they look. "Find a penny, pick it up! All that day you'll have good luck!" A kind word and a penny to pick up only take a second of your time. Maybe think of those things once in a while in the coming year.

Many people like to start their New Year's with black-eyed peas, a Southern tradition for good luck and prosperity. In years past, my family liked to kick off the New Year with Split Pea Soup. I realize you're reading this New Year's Eve, too late for New Year's Day and the parade and Rose Bowl Game, but the Superbowl is coming up! It's easy to make, you can do it ahead of time, and if you've planned ahead, you can make enough to keep hungry folks happy all day long. You can double and triple this recipe with great success, if your pot is big enough. It also freezes well.

SPLIT PEA SOUP

1 package split peas (these are found in the market aisle where rice, noodles, beans, etc. are located)

4 ham hocks (usually packaged 2 to a package in the meat section) or a ham shank, or the ham bone left over from Christmas.

3 medium-size onions – actually there's no such thing as too much onion!

6-7 good size carrots (or a package of baby carrots) 1 good size bunch of celery

Salt, Pepper

Split pea soup is an opportunity to creatively express yourself. There are few rules, just a few suggestions:

Get out your really large pot and put the ham hocks or the ham bone in the bottom. Throw the peas on top of that, followed by the onions, carrots and celery which you've washed and cut into big chunks. Cover all this with water, or a combination of water and chicken broth. Say about 8-12 cups of water. Season with salt and pepper and whatever else you like. If you're partial to thyme, put some in there. Or Mrs. Dash.

Cover your pot and put in the oven at about 300 degrees. Leave it in there for about four to six hours, or till the peas have become very tender. Take it out and let the mixture cool to where you can handle it without burning yourself. Remove the ham hocks or ham bone and set them (it) aside.

Assemble your blender and blend your lukewarm soup/veggie mixture into a smooth puree. Put this into a large container with a cover, like your crock pot. When all your soup is pureed, remove whatever meat is on your ham hocks or ham bone, tossing out all fat and other non-meaty parts and put the meat back into your soup. Refrigerate. Let it sit for a day or so to develop flavor, reheat it and stand back so the hungry relatives don't run over you as they rush to grab a bowl of the best split pea soup anywhere.

Happy New Year, dear friends and neighbors. 2022 will bring more joy, more laughter, more health and more happiness. Trust me!





GPS Dog **Collar Used** to Catch **Car Thief**



Quick thinking Pasadena police officers used a dog's GPS collar, last week, to track down a suspected thief who drove off, stealing a victim's car with their pet named Kazoo inside. Police were able to then find and stop the suspect near LAX at the 105 Freeway and Imperial Highway.

Asteroid Impact Monitoring System for Risk Goes Online

The new system *improves the* capabilities of NASA JPL's Center for Near Earth Object Studies to assess the impact risk of asteroids that can come close to our planet.

To date, nearly 28,000 near-Earth asteroids (NEAs) have been found by survey telescopes that continually scan the night sky, adding new discoveries at a rate of about 3,000 per year. But as larger and more advanced survey telescopes turbocharge the search over the next few years, a rapid uptick in discoveries is expected. In anticipation of this increase, NASA astronomers have developed a nextgeneration impact monitoring algorithm called Sentry-II to better evaluate NEA impact probabilities.

Popular culture often depicts asteroids as chaotic objects that zoom haphazardly around our solar system, changing course unpredictably and threatening our planet without a moment's notice. This is not the reality. are extremely predictable celestial bodies that obey the laws of physics and follow knowable orbital paths around the Sun.

future position and, because of small uncertainties in the asteroids' positions, a be completely ruled out. So, astronomers use sophisticated impact monitoring software to automatically calculate the

impact risk. for Near Earth Object Studies (CNEOS) calculates every known NEA orbit to improve impact hazard assessments in support of NASA's Planetary Defense Coordination Office (PDCO). CNEOS has monitored the impact risk posed by NEAs with software called Sentry, developed by JPL

'The first version of Sentry was a very capable system that was in operation for almost 20 as a navigation engineer and hour, you could reliably get the impact probability for a newly discovered asteroid over the next 100 years - an incredible

But with Sentry-II, NASA has a tool that can rapidly calculate impact probabilities for all known NEAs, including some special cases not captured by the original Sentry. Sentry-II reports the objects of most risk in the CNEOS Sentry Table.

By systematically calculating impact probabilities in this new way, the researchers have made the impact monitoring system more robust, enabling NASA to confidently assess all potential impacts with odds as low as a few chances in 10 million. Special Cases

As an asteroid travels through the solar system, the Sun's gravitational pull dictates the path of its orbit, and the gravity of the planets will also tug at its trajectory in predictable ways. Sentry modeled to a high precision how these gravitational forces shaped an asteroid's orbit, helping to predict where it will be far into the future. But it couldn't account for non-gravitational forces, the most significant being the thermal forces caused by the Sun's heat.

As an asteroid spins, sunlight heats the object's dayside. The heated surface will then rotate to the asteroid's shaded nightside and cool down. Infrared energy is released as it cools, generating a tiny vet continual thrust on the asteroid. This phenomenon is known as the Yarkovsky effect, which has little influence on the asteroid's motion over short periods but can significantly change its path over decades and centuries.

"The fact that Sentry couldn't automatically handle the Yarkovsky effect was a limitation," said Davide But sometimes, those paths Farnocchia, a navigation can come very close to Earth's engineer at JPL who also helped develop Sentry-II. "Every time we came across a special case like asteroids Apophis, Bennu, future Earth impact cannot or 1950 DA - we had to do complex and time-consuming manual analyses. With Sentry-II, we don't have to do that anymore."

Another issue with the original Managed by NASA's Jet Sentry algorium was com-Propulsion Laboratory in sometimes couldn't accurately asteroids that undergo extremely close encounters with Earth. The motion of these NEAs gets significantly deflected by our planet's gravity, and the postencounter orbital uncertainties can grow dramatically. In those cases, the old Sentry's calculations could fail, requiring manual intervention. Sentry-II doesn't have that limitation.

"In terms of numbers, the special cases we'd find were a very tiny fraction of all years," said Javier Roa Vicens, the NEAs that we'd calculate who led the development of impact probabilities for," Sentry-II while working at JPL said Roa Vicens. Mexican Nationals Charged in Kidnapfor-Ransom Conspiracy

Six suspects were responsible for Six Murders. Law enforcement killed the victims to protect the in Mexico rescued a victim conspiracy. Other members of from Pasadena, who was being held hostage at a Tijuana hotel.

A federal grand jury today returned an indictment against six members of a Tijuana, Mexico-based hostage-taking organization that allegedly kidnapped nine victims—one of the victims is from Pasadena and murdered six of them including three United States citizens – some of them after their families paid ransom for their release.

The five-count indictment charges all six defendants with one count of conspiracy to commit hostage taking resulting in death, one count of conspiracy to commit extortion, and one count of extortion. The charged defendants, all Mexican nationals, are:

Garcia German Hernandez, 37, the indictment's lead defendant and the alleged ringleader of the hostage-forransom organization;

Gilberto Omar Avila Lopez, 27, a.k.a. "Luis Enrique Avila Moreno" and "Omar;" Aylin Estrada Reyes, 24; Eduardo Joel Mascorro

Delgado, 22; Victoria Camila Espinoza Ballardo, 22; and

Oscar Bautista Valencia, 30 Yera, Lopez and Ballardo each face an additional count of hostage taking resulting in death and extortion. All six defendants are in custody in Mexico facing charges filed by authorities there.

According to the indictment, from January 2020 to April 2020, Yera led the hostagetaking organization extorted money from victims by taking hostage and holding for ransom United States nationals and Mexican nationals with relatives in the United States.

The hostage-taking group generally lured their victims into meetings under false pretenses and took hostage, the indictment states. The group allegedly held the victims at gunpoint, tied them up, and often brutally beat them. Members of the group then called victims' family members in the United States and demanded money and vehicles as ransom in return for the release of their loved ones, according to the indictment. If victims did not have family members who could pay ransom, they were murdered, as happened with what the indictment calls "Victim A," 'Victim B" and "Victim I."

in the indictment in which ransoms were paid, Yera and other conspirators allegedly the organization traveled from Mexico into the United States to locations selected by Yera and others to collect the ransom payments made by the victims' family members. For example, on March 28, 2020, a coconspirator traveled to collect ransom payment on Yera's behalf at a McDonald's in San Ysidro. After the murder of this victim, the indictment alleges that Yera sent Lopez a message depicting a large amount of cash and wrote "this was good job done."

On April 11, 2020, Yera and co-conspirators orchestrated the hostage taking of a victim identified in court documents as "Victim E," a United States national who resided in Norwalk and who was at the time visiting a family member in Tijuana. Victim E was forced to call his mother, say he was in trouble and instruct her to call an individual to pay \$25,000 for his release. The victim's mother struggled to obtain the ransom money but agreed to pay the hostage takers \$1,000 and Victim E's vehicle in exchange for Victim E's release and met up with a ransom collector in Norwalk on April 13, 2020 – the same day Victim E was murdered. His body was recovered in Mexico the next

On April 22, 2020, a Pasadena woman called law enforcement to report a family member, identified in the indictment as "Victim H," had been kidnapped in Mexico with a ransom demand of \$20,000. One of the kidnappers, calling from a Mexican phone number, informed the victim's family that a woman would pick up the ransom money at a Food 4 Less parking lot in Lynwood. That same day, law enforcement in Mexico rescued the victim, who was being held hostage at a Tijuana hotel.

If convicted of all charges, the defendants would face a mandatory sentence of life imprisonment or the death indictment contains

allegations that a defendant has committed a crime. Every defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt. The FBI is investigating this



His fascination with the application of computer technology in surgery and the benefit of sophisticated instruments for procedural accuracy has led Dr. Gilbert to adopt robotics for his partial knee replacements. Recent advances in orthorobotics allows for the successful implantation of single compartment knee replacements in appropriate cases. Dr. Gilbert has used computer navigation in over five hundred joint replacement procedures. Areas of current research capturing his attention are the use of tourniquets in knee replacement surgery and the success of partial knee replacements. Dr. Gilbert is board certified by the American Board of Orthopedic Surgeons and is a Fellow of the American Academy of Orthopaedic Surgeons. He completed undergraduate work at the University of California San Diego and received his BA in 1977. He earned his medical degree from the USC School of Medicine and went on to complete his internship and residency in orthopedic surgery at Los Angeles County+USC Medical Center

L.A. COUNTY REACHES MORE THAN 16,000 NEW CASES IN MIDST OF DUAL DELTA & OMICRON SURGES

With Delta and Omicron transmissions surging, L.A. County today reported more than 16,000 new cases in one of the highest daily case counts of the pandemic.

Over the past week, Public Health reported cases have increased 91% (from 8,633 to 16,510), test positivity rates have more than doubled from 8.7% to 17.6%, and daily hospitalizations have jumped over 30% (from 770 to 1,069).

As of December 25th, the Centers for Disease Control and Prevention revised estimates on variant prevalence, with Omicron now estimated to account for 59% of all U.S. infections and Delta for 41% of infections. In the week ending December 18th, 54% of L.A. County sequenced positive cases were Omicron variants.

Keeping family members, the community, and those most vulnerable safe from the quickly spreading Omicron and Delta variants is of paramount importance. Public Health urges residents to scale down New Year's plans by limiting gatherings to a very small number of people where everyone is fully vac-cinated and boosted if eligible. Large, crowded events are just too risky this holiday. Individuals who are sick should remain isolated from others, and everyone should wear a mask, even when indoors, if gathering with people not in your household. Vaccinations and boosters remain the best protection against severe illness and disease from COVID.

"I send my heartfelt condolences to everyone mourning the loss of a loved one to COVID-19," said Dr. Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "As cases continue to rise, it is im-portant that we all use the tools available to help us curb the spread. As we get ready to welcome the new year, this includes re-thinking party plans, limiting time indoors with non-household members, and isolating from others if feeling sick. And always wear a medical grade mask when in close contact with others outside your household. With increasing evidence that vaccinated, and where eligible, boosted individuals have significant protection against severe COVID illness, the best way to limit heartache during one of the worst COVID surges, is to get vaccinated and boosted as quickly as possible."

Thursday's positivity rate is 17.6%.

There are 1,069 people with COVID-19 currently hospitalized. Testing results are available for more than 9,988,700 individuals, with 15% of people testing positive.

Public Health would like to remind residents that getting vaccinated or boosted remains critical as holiday traveling and gatherings begin. Additionally, all residents across LA County should

- Getting tested to help reduce the spread, especially if you traveled for the holidays, have had a possible exposure, or have symptoms, or are gathering with people not in your household
- Adhering to masking requirements when indoors or at large outdoor mega events, re-

gardless of vaccination status Residents are also reminded that they are legally required to be isolated if they have a positive COVID test result and that vaccinated close contacts with symptoms and unvaccinated close

contacts need to be quarantined. COVID-19 vaccines are safe and effective and are recommended for everyone 5 years old and older to help protect against COVID-19. Vaccinations are always free and open to eligible residents and work-ers regardless of immigration status. Appointments are not needed at all Public Health vaccination sites and many community sites where first, second, and third doses are



Happy Tails Over the years of writing this column, I've often shared my feelings about the importance of treating animals more humanely. by Chris Leclerc While my motive has been pure, with hopes

of encouraging change for the better, I do realize that my writing has, at times, turned to ranting on a subject that some folks would rather not have to address.

This week I decided to focus on the good things humans have done to help protect animals and enhance their quality of life. Many positive changes have come about through compassionate legislation, volunteerism, philanthropy and individual self-sacrifice - all on the part of the human and on behalf of the animals. There is much more to be done, but we've come a long way so let's celebrate our success!

Here are a few examples of positive change that have occurred for the animals over the past several decades. It's a short list, but it shows our society is taking a more positive approach to our relationship with our fellow beings.

In 1966, The Animal Welfare Act was signed into law, making it the first in the United States that regulates the treatment of animals in research, exhibition, transport, and by dealers. Other laws, policies and guidelines before or after may include additional species coverage or specifications for animal care, but today all refer back to the Animal Welfare Act as the minimum acceptable standard.

In May of 2006, Ohlone Dog Park in Berkeley, CA became the first known of it's kind in the world. Since then, dog parks have been popping up by the hundreds in numerous cities within the US, and throughout the globe. This proves that all those millions of dog owners care enough about their pets to want the very best for them. Off-leash play in a social setting (for well-socialized dogs) is a kind way to show you love your canine.

In February, 2012 LA County agreed to allow dogs to accompany their humans for dinner on restaurant patios. Now your four-legged friend can really be a part of the family, by joining you for an evening outing rather than waiting at home anxiously for your return. With LA county being the forerunner and followed example, this law carried over to several other counties in California as well. It was amended later to prevent restaurant owners from being cited by the Health Dept., opening even more doors to four-footers.

In October of 2012, The LA City Council voted 12-2 in favor of a law that would require pet stores to sell only rescued animals. In addition to reducing euthanizations, the law seeks to put an end to puppy and kitten mills that breed animals in poor conditions and ship them to pet stores for profit.

Pet ownership in the United States, Great Britain and Australia is on the rise! According to a recent census, the number of dog owners in these three countries has grown by several millions since the early 2000's and the number of dogs per household has increased as well. We humans are obviously becoming much more willing to forego another toy or trinket, in order to love and care for someone besides ourselves! Pets are great teachers.

Countless animal rescue organizations have emerged over the past few decades. The Humane Society is a prime example of kind humans helping animals in need. Their efforts have reduced the number of euthanized pets to a proportionate fraction of what it used to be and numerous other organizations have followed their lead by placing rescued animals and advocating spay and neuter practices to all pet owners.

Which brings me to another positive praise for the human's love toward animals. Many licensed veterinarians in the US now offer affordable - if not free - spay and neuter services to those who are financially strapped. Several non-profits network with veterinarians who share their desire to stop excessive breeding, and are willing to provide such services at their own cost. Do the research to find the right vet for your pet, and discuss your financial status frankly & honestly. You may be surprised at how helpful your vet will be when you tell them your desire is to prevent unintentional pet pregnancy.

Last but certainly not least, there is a growing trend in our society to adopt and not shop. This not-so-new concept got started by avid animal rights advocates, and has been made more popular in recent years by celebrities who promote the philosophy. Now it seems just about every animal lover is on the band wagon. Now adopting is not only a win-win for the animal and its owner, it is also a cool trend that has caught on like wildfire.

It seems that, more than ever before, we humans are realizing how precious our beloved pets are. They love unconditionally, and for some people a pet may be the only source of unconditional love they have in their life. Kudos to those who recognize the value of animals and selflessly help pave the way to a better life for them. May we all try to focus more on the good things happening to make a change for the better in our society. Love and let live.

LONG LINES OF WAITING CARS

Recently while driving around town doing some errands, I began to notice a strange phe-nomenon. I was behind a line of cars in the right lane, waiting for the red light to change to green. The light changed and the cars ahead of me did not move. I didn't know why, but I didn't honk but just got out of that lane, and drove around the curious line of waiting cars.

As I drove by, I noticed that all the drivers were just sitting there, parked, waiting. I began to notice this on numerous other occasions, and soon realized that this line of waiting cars was

always by a school. The time was always around two or three p.m. I no-ticed this often enough, and always around schools. I suppose I am a slow learner, but everyone else I asked about this already knew what this was all about. Parents are lining up to give their school children a safe ride home from school. Oh! Simple! Now, each time that I see this line of waiting parents in cars, usually with the motors still running, I cannot help but think how different the world has become in the several dec-ades since I was a school child. When I was about to begin my very first adventure out of the womb and home at age five, my father

drove me several times from our home to Longfellow school, over on Washing-ton Avenue east of Lake. He instructed me in the path that I was to walk each and every day, to school and back home again. He instructed me which side of the street to walk on, and where to cross, and a few pointers for emergencies. (I believe I kept our phone num-ber written on a piece of paper in my shoe.). I had a least one in-person guided walk so that it was absolutely clear how and where I was to walk every day. Every day I walked along the path my father instructed for me to get to school, and at noon, when kindergar-ten was over, I walked directly home along the same path. I never deviated from that path because I thought I would get lost. Then, the following year, I began first grade at Saint Elizabeth school, which was a lot closer to our home.

My mother walked with me to the new school, about five blocks away. Now that I was "grown up," I walked by myself, sometimes with my brother, up Highland Avenue to school. There were no twists or turns to get home, so when school got out, I walked back down the residential area to my home.

By second grade, I was riding my own bicycle the few blocks to school every day, and rid-ing home afterwards. I noted that a handful of parents actually did come to the school and drive their children home. There was also a small bus that came to our school and drove maybe 20 of the students to their homes. Once, I was invited to the home of a fel-low classmate and I curiously rode the bus with the other students. My friend lived up the hill at a remote home at the base of the mountains, at least a mile from the school. That visit made me realize the reality of the economic differences of the members of my school and community. My friend's home was very upscale, and their furniture was splendid, and even the food we were served at dinner was quite exceptional by my usual standards.

Back home, in my "real world," my brother explained to me that our family lived in "lower middle class" standards, and that my friend's family, and neighborhood, was either "upper middle class" or "lower upper class." I remember telling my brother that I'm glad we lived so close to the school, because I could not imagine bicycling all the way up the hill to my friend's home.

"Yeah, but your friend would never bicycle to school," my brother told me in a conde-scending voice, attempting to pierce through my naievete. "Your friend's parents have money! Why would he bicycle?" It was an interesting comment, since before that time, I had never thought about myself or my family in comparative economic terms.

More recently, I asked a friend what he thought about the long line of cars that now await daily in front of nearly all grammar schools.

"The world has changed," he told me. "This is no longer the 1960s." "Yes, but why do you think that parents do this today," I asked.

"Things are not safe today," my friend quickly replied.

"Really? Is that the reason?" I wondered aloud. Hasn't the slow gentrification of our cities reduced much of the suburban crimes? I remember when I was growing up in Pasadena that there were children everywhere after school, in yards, walking, playing ball in the street, everywhere. When I lived with my father while he was dying, in our same family home, I observed a very quiet section of Pasadena that had previously been bustling with youthful activity.

"Are you sure that's the reason?" I asked my friend. He speculated that perhaps comput-ers had something to do with this phenomenon, where youngsters spent way too much time behind the computer, playing

We didn't know all the causes, but I did speculate that laziness was another factor. Plus, I can recall talking to friends my age who had children, telling me how they didn't want their children to endure all the "hardships" they had to endure. Though it was a sincere comment, and a sincere concern, I realized that it was life's childhood hardships that made me who I am, and formed my character. I had to get out in the world, and I had to bicycle and work to get anywhere. Threats were very real, and I could not fight dangers by hid-ing behind a computer screen. And the few times when we really did have to get physical with another boy taught each of us that sometimes our greatest seeming-enemies could (eventually) be a friend and ally, and that the rewards of negotiation can be quite pro-found.

Maybe it's just me and getting older, but when I see the long lines of cars in front of schools, though I realize the concerns of safety, I cannot help but think about all the expe-riences that these children are no longer

HOW TO GET YOUR AFFAIRS IN ORDER


Dear Savvy Senior:

I would like to get my personal, legal and financial information organized so my kids will know what's going on when I'm no longer around. Can you offer any tips on the best way to do this? Unorganized Emma

Organizing your important papers and getting your personal and financial affairs in order is a smart idea and wonderful gift to your loved ones. Here are some tips to get you started.

Get Organized

The first step in getting your affairs in order is to gather up all your important personal, financial and legal information so you can arrange it in a format that will benefit





want certain things handled when you die or if you be-

come incapacitated. Here's a checklist of areas you need to focus on.

PERSONAL INFORMATION

- Contacts: Make a master list of names and phone numbers of close friends, doctors, and professional advisers such as your lawyer, accountant, broker and insurance agent.
- Medical information: Include a list of medications you take, along with any allergies and illnesses. Personal documents: Include such items as your birth certificate, Social Security card, marriage license, military discharge papers, etc.
- Secured places: List all the places you keep under lock and key such as safe deposit boxes, safe combination, security alarms, etc.
- Digital assets: Make a list of all your digital assets, including everything from social media accounts to online banking accounts to home utilities that you manage online. It should include usernames and passwords. Use Rutgers Digital Assets Inventory Worksheet (njaes.rutgers.edu/money/pdfs/digital-assetsworksheet.pdf) as a guide.
- Pets: If you have a pet, give instructions for the care of the animal.
- End of life: Indicate your wishes for organ and tissue donation and write out your funeral instructions. If you've made pre-arrangements with a funeral home include a copy of agreement, their contact information and whether you've prepaid or not.

LEGAL DOCUMENTS

- Will, trust and estate plan: Include the original copy of your will and other estate planning documents you've made.
- Financial power of attorney: This document names someone you trust to handle money matters if
- Advance health care directives: This includes a living will and medical power of attorney, which spell out your wishes regarding your end-of-life medical treatment when you can no longer make decisions for yourself.

FINANCIAL RECORDS

- Financial accounts: Make a list of all your bank accounts, brokerage and mutual fund accounts, and any other financial assets you have.
- Debts and liabilities: Make a list of any loans, leases or debts you have mortgages owed, car loans, student loans, medical bills, credit card debts. Also, make a list of all credit and charge cards, including the card numbers and contact information.
- Company benefits: List any retirement plans, pensions or health benefits from your current or former employer including the contact information of the benefits administrator.
- Insurance: List the insurance policies you have (life, long-term care, home, auto, Medicare, Medigap, prescription drug, etc.) including the policy numbers, agents, and phone numbers.
- Property: List real estate, vehicles and other properties you own, rent or lease and include docu-
- ments such as deeds, titles, and loan or lease agreements. Taxes: Include the location of your tax records and your tax preparer's contact information.
- Keep all your organized information and files together in one convenient location, ideally in a fireproof filing

cabinet or safe in your home. Also be sure to review and update it every year, and don't forget to tell your kids where they can find it.

ONE OF THE GREATEST GIFTS TO YOUR FAMILY IS THE PLAN FOR **INCAPACITY**

When it comes to estate planning, most people automatically think about taking legal steps to ensure the right people inherit their stuff when they die. Although that thought is not wrong, it also leaves out a very important piece of planning for life, and perhaps the most critical part of planning overall.

Planning that's focused solely on who gets what when you die is ignoring the fact that death isn't the only thing you must prepare for. Rather, consider that at some point before your eventual death, you very well may be incapacitated by accident or illness.

You must name someone

The most important thing to remember is that you must choose someone. If you don't legally name someone to make these decisions during your incapacity, the court will choose someone for you. And this is where things can get extremely difficult for you and your loved ones.

In such a scenario, the court will typically appoint a guardian or conservator to make these decisions on your behalf. This person could be a family member you'd never want to manage your affairs, or a professional guardian who charges exorbitant fees, and could even potentially decimate your estate. Either way, the choice is out of your hands.

Furthermore, like most court proceedings, the process of naming a guardian is often quite a timeconsuming, costly, and emotionally draining task for your family. If you're lying unconscious in a hospital bed, the last thing you'd want is to waste time or impose additional hardship on your loved ones. And this is assuming your family members agree about what's in your best interest.

This potential turmoil and expense, however, can be easily avoided. An effective incapacity plan keeps you in charge of who makes decisions for you, without the need for court intervention. What's more, the plan can provide clear guidance about your wishes, so there's no mistake or conflict about how these vital decisions should be made.

Don't put it off

If you don't yet have an incapacity plan as part of your overall estate plan – or you haven't had your plan reviewed in several years, the new year is a perfect time to make that happen. Getting it done will give you peace of mind and be an incredible gift of love to your family. It's so important for you and those you care most about. Make it a priority in the new year.



PUT THE LIGHTS ON MIKE PENCE AS HAMLET



Don't you think that the subtitle to this article is very surprising? I believe it is a sentence, or at least a partial sentence or phrase that has never before been in print. Contrast that sentence with the phrase "To be, or not to be" generally described as the most popular phrase in English Literature. Most of you, my imagined readers, are still familiar with the name of our former Vice-President. The "to be or not to be" phrase is uttered by the title-character in Act 3, Scene 1 in William Shakespeare's play. This morning I awoke thinking about the usual subjects: the Pandemic, Global Warming, and the importance of a peaceful transfer of power. In addition to the frequently talked about potential madness of the former President notwithstanding his

incredible ability to skillfully use language to manipulate the actions of others. Actually there's more that worries me. statement "There is something rotten in the state of ... Denmark!

Substitute the United States, or the Western World for Denmark and I believe you will understand the connection. First thing in the morning I tried to read a little book that I had helped myself to from one of little libraries placed in front of a neighbor's home. Alas, the writing was too small and the Shakespearean language often arcane and difficult. I switched to watching television where I found multiple filmed versions of the play. Finally I settled on the Sir Laurence Olivier version in which he starred and directed and which garnered four Academy Awards including Best Picture. I thought I had watched the whole thing but when the movie finished I realized that I had fallen asleep and missed important parts of the movie such as when Hamlet actually spoke to the ghost of his father and learned about his murder.


Are you beginning to get the connection to Mike Pence?
