## **ENVIRONMENTALLY FRIENDLY SIERRA MADRE:**

## PHOTOVOLTAIC SOLAR ARRAY PROJECT BEGINS

"....the City of Sierra Madre is on the cutting edge in delivery of municipal services.", Mayor Gene Goss

On January 27, 2022, the city of Sierra Madre broke ground for the construction of its Photovoltaic Solar Array Project. Construction of the project is expected to be completed by the end of March, 2022. The ground-mount system of solar panels will be located on approximately two acres near the groundwater replenishment basins, City Yard, and water production facilities.

#### TIMELINE:

A team comprised of then-Mayor Harabedian, then-Mayor Pro-Tem Capoccia, city staff, and then volunteer resident industry experts Robert Parkhurst (now councilmember) and Matthew Schneider began meeting in early 2019 to discuss the options and processes of identifying the feasibility of the potential

On April 28, 2020, the City Council approved 'upon successful completion of CEQA analysis and a Conditional Use Permit of a power purchase agreement contract to Rec Solar Inc. for design and construction


On May 6, 2021, the Sierra Madre Planning Commission approved the Conditional Use

and its associated environmental documents.

In November, 2021, the final contract and amendments were approved by the council.

#### PROJECT DETAILS:

The finished project will yield a 554.58 kilowatt (kW) solar ground-mounted system and a 111 kW battery energy storage system (BESS). The fixedtilt photovoltaic (PV) solar array with anti-reflective technology will absorb and convert sunlight directly into electricity. The project is estimated to offset 948,332 kilowatt-hours (kWh) of energy from the Water Department's production facility. The savings account for approximately 38% of the energy use in the production and distribution of the City's water supply. In addition, the Solar Project will eliminate 693 tons of CO2 emissions and save 1,457 barrels of oil per year.

The panels will consume no fossil fuels and produce no air emissions. In addition, the PV solar array will have a relatively low profile. Standing at approximately 15 to 20 feet in height, the ground-

mount system will have little to no impact in modifying the scenic view of the San Gabriel Mountains. There is no tree removal planned; however, the trees along the western border of the project have been trimmed to allow maximum sunlight exposure.

The Power Purchase Agreement for design and construction of the project was awarded to Rec Solar Inc. at a value not to exceed \$1,373,000 (without any expense to the City). It includes the condition that the City will not be obliged to spend any capital investment, operations and maintenance are included, and at the end of the 20-year term, the agreement may be extended, the equipment may be purchased, or system will be removed.

This project furthers the City's environmental commitment. Sierra Madre is a founding member of the Clean Power Alliance, a Joint Powers Authority of 32 communities across Los Angeles and Ventura counties who are purchasing their own renewable energy. Sierra Madre is doing its part to generate clean, local, and renewable energy for its residents and the community at large. Construction activities at the Solar Facility site are scheduled from 7:00 am to 3:30 pm, Mondays through Fridays until the end of March. #### CITY COUNCIL MEETS VIRTUALLY -**PUSHES FOR FIRE DEPARTMENT GRANT** AND LANDLORD INCENTIVES

meeting on Tuesday, January 25, as Mayor Goss and Council Members appeared remotely and separately. This was due to concerns over the COVID-19 omicron variant that continues to sweep through the Los Angeles area.

During the January 11, 2022 meeting, City Council unanimously adopted Resolution 22-05 authorizing hybrid and fully remote teleconferenced meetings for 30 days. At the end of the 30 days, Council will have to reevaluate the situation and decide whether to pass another resolution for a 30-day extension.

The January 25th meeting was short, running a bit over 38 minutes. The following items were passed as part of the Consent Calendar.

CALFIRE GRANT

City Council has agreed to send letters supporting the San Gabriel Valley's applications for CAL FIRE's Fire Prevention Grant Program. Two applications are being sent out to develop a community outreach program

It was back to a virtual setting for City Council during their regular plan. The program would inform the community on wildfire prevention and include community events, marketing campaigns, and educational activities.

> THANKS TO SM FIRST RESPONDERS

> Last week's windstorm had Gusts that reached over 80 miles-per-hour across the San Gabriel Valley.

"I'd like to time to thank our wonderful staff, the police, the fire, the public works which have worked really tirelessly over that last four days to clear out all of the palm fronds and trees...because of the windstorm," said Council Member Robert Parkhurst. Parkhurst noted that eight houses lost power on Chaparral Road alone due to a downed powerline. The line however, was quickly repaired by Sunday, January 23.

"Our Fire and Police and Public Works were amazing," said Mayor Pro Tem Edward Garcia, noting that Public Works were out clearing debris and palm fronds out of the street before the street sweepers.

#### A WORD FROM THE CHIEF

The county of Los Angeles has seen an alarming increase in vehicle thefts. From 2020-2021 auto thefts increased by 59%. The most targeted vehicle makes are Honda, Kia, Hyundai, GMC and Chevrolet. These vehicles are targeted by thieves due to their security features and locking mechanisms.

Along with vehicle thefts, there has been a significant increase in catalytic con-verter thefts all over Southern California. Catalytic converters are easy to steal and contain several types of precious metals, which are scrapped for a quick illegal profit.

There are several actions one can take to reduce or prevent vehicle and catalytic converter thefts:

When choosing a parking location opt for a well lit area and avoid dark secluded spaces.

If you are able to park inside a garage then do so.

Add security surveillance cameras or motion sensor lights in the area where you regularly park.

Installing or adjusting the security alarm in your vehicle to activate from vibration will maximize your security and overall give peace of mind.


One of the most difficult issues regarding investigating catalytic converter thefts is the lack of serialized information that aid law enforcement in locating a victim when a suspect is found in possession of one.

This makes it nearly impossible to prosecute as well as give victims the ability to possibly receive restitution for damages to their vehicle.

To assist with this problem, in the coming weeks' Sierra Madre Police Department will be offering a "free of charge' opportunity for community members to have their catalytic converters etched with identifiable information. This will aid with investigations, as well as in some cases act as a deterrent to the individuals who steal them and the recycling locations that purchase random catalytic converters.

#### Speaking Up: TELL THE CITY WHAT IS **IMPORTANT!**

Protect Sierra Madre - Stop the Housing Project has filed an Intent to Circulate Petition to let the citizens of Sierra Madre decide what values are important to them. Our petition, based on our "intent" below, will be available to sign in late February.



Protect Sierra Madre - Stop the Housing Project was organized to stop the largest housing development in the history of Sierra Madre. The proposed project by New Urban West, the developer, and the Passionist Ownership of the Monastery, based in Chicago, would allow the building of 42 large, multi-million dollar homes in the meadows at the Monastery, the last open space in Sierra Madre. (They have named the project 'The Meadows at Bailey Canyon." That's a nice, ideallic name, but the Destroyed Meadows at Bailey Canyon is more appropriate, as let's be clear, there will be NO meadows left, as they will be destroyed with the building of 42 homes. They are pushing this project despite significant, real concerns about:

- Wildfire risk (the meadows are up against the foothills and in an extremely high fire zone).
- Impact on water supply, as we are in the middle of California's worst, sustained drought.
- Significantly increased traffic. A traffic study indicates traffic will more than double with this development.
- Destruction of open space and wildlife habitat.)

#### NOTICE OF INTENT TO CIRCULATE PETITION

Protect Sierra Madre - Stop the Housing Project has filed an Initiative to place an Ordinance on the Ballot in this year's election to be voted on by all registered voters of Sierra Madre. It would change the zoning of the Monastery parcel (Mater Dolorosa) and any subdivisions of it, from Institutional to Hillside Residential Zone. A petition with signatures of 10% of Sierra Madre registered voters will put the question on the ballot.

If the measure passes at this year's election, the Retreat Center can continue to operate as a preexisting non-conforming use, as long as they choose. But any change in use, or development of any part of the parcel, would be subject to the requirements of our Hillside Ordinance.

Over the years, recognizing that all Sierra Madre properties adjacent to the mountains and part of the wildland urban interface require special protection, our elected officials enacted many General Plan changes and ordinances to protect what makes Sierra Madre special - the Environment, the wildlife, tree canopies, the Hillsides, and the Monastery parcel. In discussing the Hillside Ordinance, Planning Commission members commented that the Ordinance wasn't only about slope, but about elevation, topography, views, vegetation, wildlife, fire safety and "things that would change the look

The "Monastery" parcel is one of the only properties abutting the mountains that is not protected by a zoning designation of Open Space or Hillside Residential.

In 2015, during the drought, the Sierra Madre Planning Commission and City Council added many Water Conservation measures to the pending General Plan update, including removal of a provision that might have someday allowed the reuse of the Monastery property as housing. The EIR was certified and the General Plan adopted in 2015, and in 2016 the zoning was amended to conform to the General Plan with no objection to any of these actions during the 90 day periods after enactment. The California Constitution gives voters the power to enact initiatives, to change laws in their City in light of the theory that the power of government ultimately resides in the people. We believe the citizens of Sierra Madre know best what is right for their City and will vote to forever protect that fragile open space, with an ordinance to change the zoning on the property from Institutional to Hillside

Development can happen on that land, but with the protections of all our values that our City Government has failed to enact.

SAN GABRIEL VALLEY LANDLORD INCENTIVE PROGRAM

The San Gabriel Valley Landlord Incentives Program (SGVLIP) is designed to provide muchneeded security and assistance to landlords in the San Gabriel Valley Area who, in turn, rent available units to individuals experiencing homelessness. According to the agenda report, Union Station Homeless Services manages the SGVLIP program in partnership with the San Gabriel Valley Council of Government (COG) and provides rental property owners with financial incentives for leasing units to tenants receiving Housing Choice Vouchers. City Council received and filed the information.

LINING PROJECT

City Council will award a construction contract to Advantage Redline in an amount not to exceed \$70,000 for the lining of 200 feet of 10-inch water main. Several water mains in the area are over

100 years old and go through rugged, steep, and hilly regions, making them difficult to get to and repair. Between Canyon Crest and Brookside Ln., one of the mains is considered a cross-county line. After the idea of replacing this main was found to be not feasible, staff recommended lining the existing water main and re-connecting it in its current location. The construction of the new water main on Canyon Crest is also underway.

#### ANNUAL FINANCIAL REPORT

The council received and filed the Annual Financial Report (ACFR) for the fiscal year ending June 30, 2021. The full report is available to the public on the city website cityofsierramadre.com. This past year includes a list of city accomplishments, such as a long-term project to replace the City's water main infrastructure, the Kersting Court Renovation Project, and grants for small business support in response to the COVID 19 pandemic. #### **WALKING SIERRA MADRE - The Social Side**

"Life is like the wind...sometimes a sweet breeze and sometimes a raging storm."

"Time and the wind never leave anything alone." Marty Rubin

"The answer, my friend, is blowin' in the wind." Bob Dylan

It seems that the wind is trying to blow our lovely city off the map! One wind storm after another, taking out trees, blowing huge pots off their stands and making an enormous mess all over the place. Chuck Seitz sent me pictures of one of his heavy pots of Epiphyllum tossed on the ground surrounded by broken pieces of plant where beauty used to be. This is especially annoying as the Epiphyllum in this pot and all the other pots of these plants came from cuttings from my dad a number of years ago. Folks have posted pictures of damage on Facebook and I ex-

pect everybody wishes this wind would go blow someplace else. Power outages abound and I am reminded of the huge windstorm that hit Sierra Madre in 2011 and left us all in the dark for days. Trees were uprooted all over town, huge ones, hundreds of years old, tossed about like tinker

John and I huddled in front of our gas log fire and burned candles for light, reading by flashlight and eating everything out. No power, No Coffee!! John figured out a way to rig up an old dial telephone, charge our cell phones and make my curling iron work so I wouldn't look exactly like Broomhilda. One of the joys of having married an electrical engineer is that they can make electricity happen, rewire the entire house and make my curling iron go.

We lived close to the Los Angeles County Arboretum where 400 magnificent trees were blown over and ripped right out of the ground. The Arboretum, in their wisdom, offered the rare, unique wood of many of these trees to artists who worked in wood and asked them to express through their art what was in the grain and hearts of these trees. The picture today is "Weeping Man" by artist Gonzalo Algarate, carved from Eucalyptus globules – Tasmanian Bluegum. I saw this sculpture at the "Force of Nature II" Arboretum art showing and it touched me deeply.

I came across some really interesting information about the ill effects of wind that you'll enjoy:

<u>A Brief Eerie History of How the Wind Makes Us</u> <u>Crazy</u>

Lyall Watson on the Ill Effects of Heavy Weather "Between five and ten times every year, when pressures are high over Utah and Nevada, air spills off the Mojave Desert, rushes down the valleys, through the narrow mountain passes of Santa Ana, and out on to the coast around Los Angeles. Within minutes, the sea off Long Beach is whipped into white-caps and gales of up to 100 kilometers an hour hammer the coast between Santa Monica and Oxnard. In a single swat, one such blast flattened 252 oil derricks, while anoth er rained 15 million tons of dust on downtown Burbank. Devastating fires sweep through the hills and homes. Moods change. Skin turns taut. Aches come back to old scars in the night. And, in the words of Raymond Chandler, "On nights like that, every booze party ends in a fight. Meek little wives feel the edge of the carving knife and study their husband's necks. Anything can happen."

Murder often does. In 1968, Willis Miller of California Western University, collected statistics for homicides in Los Angeles County and compared them with weather records. There were 53 days during 1964 and 1965 when the Santa Ana blew and humidity, which is normally around 43 percent, fell below 15 percent. On 34 of those 53



windy days, there were more deaths than normal. And during the longest sustained Santa Ana, which blew from October 20th to 26th in 1965, the total was 47 percent higher than in any other windless week.

The FBI recognizes a "long, hot summer" phenomenon, expecting more murder, aggravated assault and rape between June and September than at any other time. But the Santa Ana seems to supersede this annual cycle, producing shortterm local effects whenever it blows, winter or summer, turning any time at all into a season of discontent. In California's early, and to this extent more enlightened days, defendants in crimes of passion were able to plead for leniency, citing the wind as an extenuating circumstance.

The Santa Ana, like other ill winds, is perfectly capable of violence without human help. When it blows, there is the usual increase in ulcer perforation, embolism, thrombosis, hemorrhage, myocardial infarction and migraine-not to mention theatrical failures, lower industrial production and loss of milk in cows. All these disorders are the result of tension, the product of an atmosphere heavy with menace and imminent catastrophe. Of dry air so filled with static electricity that even a handshake becomes shocking. It is in such air that unnatural charges accumulate—and it seems to be these that have the most negative effect."

And for those of us in the San Gabriel Valley, we mourn our trees, turn on our gas fire logs, stock up on candles and prepare to clean up the branches and pine needles and thank the Creator that the tree didn't land on the house or our car. 'The wind blows wherever it pleases. You hear its sound, but you cannot tell where it comes from or where it is going. So it is with everyone born of the Spirit." John 3:8 NIV



#### **PWP** to Hold **Hearing** on **Water Kate** Increases

The Pasadena City Council announced that they will hold a public hearing on, March 14, to consider the adoption of proposed water rate increases, adjustments to existing rate structures, and a change in capital improvement charges.

Council members said that they encourage the public to participate videoconference/ teleconference and submit public comment.

The meeting is set for 5 p.m. via videoconference/ teleconference.

According to a statement the proposed increases will help cover rising costs for purchasing and treating water, and provide funding for critical improvements to reservoirs, treatment facilities and other water infrastructure. Pending City Council approval, the water rates will increase by an average of 7.1 percent on April 1. A second adjustment of 7.2 percent would take effect on Jan. 1,

While individual customer bill impacts will vary based on water meter size and amount of water used, projected cost estimates show most residential customers will likely see a \$3 increase in their monthly bill starting April 1, and an additional \$4 monthly increase on Jan. 1. Based on similar modeling, PWP estimates that commercial customers are likely to see a \$19 and \$20 increase,

respectively. The proposed water rate adjustments are the result of a number of factors, including our infrastructure aging which is in need of critical and proactive updates. We're also experiencing severe statewide drought conditions, and that's impacting both water supply and operational costs," says Jeffrey Kightlinger, interim general manager. "PWP is a community-owned, not-for-profit utility, and invests revenue generated in the provision of services and infrastructure improvements to serve our customers. This adjustment is necessary to cover increasing costs so that we can continue to deliver water to the high standards that our customers expect

and deserve." Pasadena City Council approved recently new Water System and Resources Plan outlines the City's longterm plans and priorities for securing its water supply and investing in infrastructure, some of which is currently over 100 years old. In addition, California's ongoing severe drought conditions may affect water supply and conservation efforts in the years to come.



#### **Caltech Names Laurie Leshin New Director of JPL**

*The distinguished* geochemist and space scientist brings more than 20 years of leadership experience in academic and government service to JPL.

Laurie Leshin (pictured), president of Worcester Polytechnic Institute (WPI), has been appointed director of the Jet Propulsion Laboratory (JPL) and vice president of Caltech. Leshin will formally assume her position on May 16, succeeding Michael Watkins, who retired in August, and Lt. Gen. Larry D. James USAF (Ret.), who currently serves as JPL interim director.

She joins JPL from WPI, one of the nation's oldest private STEM universities, where she has served as president since 2014. She is the first woman president in the university's 150-year history and will be JPL's first female director.

"Laurie Leshin stood out in an exhaustive international search because of her profound commitment to people, her strategic approach to scientific and technological opportunities, her deep appreciation of leadership in space exploration and Earth science, her mastery of complex organizations, and her ability to inspire the next generation of scientists and engineers," says Caltech president Thomas F. Rosenbaum, the Sonja and William Davidow Presidential Chair and professor of physics. "We are so pleased to be able to welcome Laurie back to campus and to JPL."

"NASA's Jet Propulsion Laboratory has a storied history of defying what was once thought impossible in the field of space exploration. In this new era of groundbreaking discoveries and constant innovation, it is clear that Dr. Laurie Leshin has a track record of scholarship and leadership needed to serve as director of JPL and cement the center's status as a global leader in the 21st century," says NASA Administrator Bill Nelson. "Under Dr. Leshin, the technology invented at JPL will continue to allow humans to explore the places in our universe that we cannot yet reach and spark the imaginations of future mathematicians, engineers, and pioneers in classrooms across America. I want thank Mike Watkins and Gen. Larry James for their contributions that the JPL team will build on for decades to come."

Leshin is an internationally recognized scientist whose career has spanned academia and senior positions at NASA, and included two White House appointments. She has been lauded for her barrier-breaking leadership in the space industry and in academia as well as for her accomplishments as a distinguished geochemist and space scientist.

"I am both thrilled and humbled to be appointed the director of JPL. In many ways, this feels like a homecoming. Some of the most impactful experiences of my career have taken place on the Caltech campus and at JPL – lessons learned and goals achieved that have shaped me as a leader and a space scientist. The opportunity to return to working closely with so many colleagues across Caltech - at the Lab and on campus - and at NASA is a dream come true," Leshin says. "We have enormous opportunities ahead to leverage JPL's global leadership in robotic space exploration to answer awe-inspiring scientific questions and improve life here on Earth. I look forward to my work with Caltech and NASÁ to ensure that JPL continues to drive innovation across the global space ecosystem. Finally, I am especially honored to be the first woman to hold the title of director of JPL. I know from personal experience that diverse teams make greater impact, and I will work every day to ensure that JPL is a place where all belong and thrive. We will dare mighty things, together."

In 2005, she became director of science and exploration at NASA's Goddard Space Flight Center, and in 2008, she was promoted to Goddard's deputy director for science and technology, where she and colleagues were responsible for the strategy, planning, and implementation of more than 50 Earth and space flight projects. In 2010, Leshin assumed the role of deputy associate administrator of the Exploration Systems Mission Directorate at NASA Headquarters, where her work involved the oversight of the future human spaceflight program, including efforts to establish commercial crew capabilities and elements of what is now the Artemis program. In that role, Leshin also worked to catalyze worldwide space exploration by engaging with international space organizations and corporations, and through developing new technologies and robotic missions to create new possibilities for humans to travel to destinations deeper in the solar system. Lesĥin left NASA in 2011 to join Rensselaer Polytechnic Institute as dean of the School of Science.

#### OPERATORS OF SAN GABRIEL VALLEY POULTRY PLANT FACE CHARGES OF WAGE THEFT, INSURANCE FRAUD

An Arcadia couple accused of insurance fraud and wage theft are facing dozens of felony charges after authorities alleged they underreported payroll to workers' compensation insurance carriers and underpaid employees at their poultry processing business.

Feng Wu Lam, 49, and her husband, Wei Wen Wu, 54, each face 43 felony counts — 34 counts of grand theft of labor, six counts of insurance fraud and two counts of conspiracy to commit wage theft, the Los Angeles County district attorney's of-fice announced Thursday.

The criminal complaint includes a special allegation of theft in excess of \$500,000, prosecutors said. Lam and Wu also face two misdemeanor counts of wage theft each. Lam owns the South El Monte-based Golden Food Inc., a poultry processing company, prosecu-

tors said. Wu is the company's manager. Authorities allege the couple underreported their payroll to their workers' compensation insurance carriers by roughly \$4.5 million between 2015 and 2019. The underreporting allowed them

Wu and Lam are also accused of underpaying their 34 employees by at least \$437,542, prosecutors

to avoid about \$1.7 million in insurance premiums, prosecutors said.

California Labor Commissioner Lilia García-Brower said many wage theft victims "go unheard and unnoticed," noting that the unfair business practice also gives cheating employers an unfair

State Insurance Commissioner Ricardo Lara also spoke out against the couple's alleged crimes and said workers' compensation fraud can lead to higher insurance premiums for employers who follow the rules, "and may ultimately hurt workers who are legitimately injured on the job." Wu and Lam are scheduled to be arraigned March 29.

The Duarte City Council is holding its third redistricting public hearing on Tuesday, February 8, 2022. All hearings will be held in the Duarte City Council Chambers (1600 Huntington Drive) starting at 7:15 PM.

Every ten years, cities with by-district election systems, like Duarte, must use new census data to review, and if needed, redraw district lines to reflect population shifts. This process, called "redistricting," ensures all districts have nearly equal populations, and therefore, representation in local elections.


Public input is an important aspect of the process, with residents being encouraged to participate in a series of public hearings during which they can share their thoughts on how Council district boundaries should be drawn.

Duarte's third public hearing on Tuesday, February 8, will focus on reviewing draft maps submitted by residents, gathering community feedback, identifying focus maps, and receiving feedback from the City Council on how they would like to revise the maps. If Duarte's City Council does not present revisions at this hearing, it may select a map and conduct a first reading of an ordinance adopting it with the second reading and map adoption taking place at the fourth public hearing on Tuesday, March 8.

Should the Duarte City Council make amendments to the preferred map, the first reading of the ordinance adopting the Council's new district map will take place at the City's fourth redistricting public hearing on Tuesday, March 8 with the final map adoption occurring at a fifth public hearing.

Residents can submit their own map by using the paper and digital mapping tools available on the City's redistricting website, DrawDuarte.org. All draft maps should be submitted to Redistricting@AccessDuarte.com by Thursday, January 27, for con-sideration at the February 8 public hearing.

#### **SUPERVISOR BARGER INTRODUCES \$10,000 REWARD TO GET ANSWERS REGARDING MONROVIA MURDER**

Seeking justice for the Monrovia community, Supervisor Kathryn Barger introduced a motion at Tuesday's Board of Supervisors meeting to offer a \$10,000 reward in exchange for information leading to the arrest of whomever is responsible for the murder of Terry Alford.

The reward comes nearly a year after the incident occurred on January 29, 2021, when 46-yearold Alford was shot multiple times in front of a residence in Monrovia while visiting his family. He was on the front porch when four male suspects snuck up behind him. Law enforcement investigators believe the shooting was gang related and intentional, but presume Alford was not the intended target.

"Terry Alford and his family deserve justice and answers," Supervisor Barger said. "While the Los Angeles County Sheriff's Department and Monrovia Police Department have been dedicated to solving this crime, we need the community's help to reach a conclusion. My thoughts are with Terry's wife, children, and siblings as they grapple with this senseless tragedy."

The City of Monrovia is closely partnering with Los Angeles County in this effort. "The Alford Family deserves justice for the tragic death of Terry," City Manager Dylan Feik said. "Four suspects remain in our community, somewhere, and we ask for the community's help in finding

#### PETITION TO RECALL LOS ANGELES DA GEORGE GASCON APPROVED BY LA **COUNTY REGISTRAR**

The recall effort to remove Los Angeles District Attorney George Gascon from office was officially approved by the Los Angeles County Registrar on Thursday.

Gascon has faced mounting criticism over his policies that are said to put criminals first and have led to high crime rates.

With the approval of the petition, organizers have to get 566,857 signatures - about 10% of registered voters in the county by July 6. If the petition gets the required number of signatures Gascon will face a recall election in the county later this year.

The proponents who signed the notice of intention to recall Gascon have been personally impacted by one or multiple of Gascon's special directives, including the directive to not charge special enhancements, parole and resentencing policies, and blanket rules for the prosecution of juveniles.

"We are sick and tired of living in the pro-criminal paradise Gascon has created," Desiree Andrade and Tania Owen, co-chairs of the Recall DA George Gascon campaign, said in a release. "Gascon turned his back on us, and now his policies are destroying Los Angeles County right before our eyes and needlessly creating more innocent victims."

They continued, "This is our chance to put an end to all of it, but it is massive undertaking that will require an all-in approach from the entire community. We need all Angelenos to join us in this effort to restore public safety and end the chaos in our streets. We all deserve to live without fear of criminals running amok, and to have a District Attorney who actually does his job.'

Some of his orders include the elimination of sentence enhancement charges, zero-bail policies and not prosecuting juveniles as adults for many crimes.

The impact of his policies hit even small towns like Sierra Madre where his office refuses to prosecute more than a third of the cases before them. As previously reported in this paper, (http://mtnviewsnews.com/v15/htm/n09/index.htm), his policies allowed for the release of a convicted violent felon who went on a few weeks later to shoot a Highway Patrol officer.

This is the second attempt to gather signatures to remove Gascon from office.

#### The Chef Knows By Peter Dills

#### WHERE IS YOUR WINE REALLY FROM?

#### THE ANSWER IS A AS FOGGY AS A GOLDEN GATE MORNING

Sometimes I think my job title should include "detective", as in "Peter Dills: Wine Detective". I guess, for that matter, most of us who carry a pen could fall into that category. Something that I assume is common knowledge might be unknown to those of you who just have a glass or two of wine now and then.



Think about this: where does your wine come from? Where does the label say it is from? There is a simple way to know by looking at the label if the wine is estate grown and, generally speaking, the label will tell you the percentage of that grape.

For example: "Estate grown" means that 100% the grapes come from the winery even if that winery owned vineyards in different regions, i.e. Paso Robles and Lodi. On the other hand, do the grapes come from a small section of Sonoma or Napa, AVA\*, or can they be pinpointed to the Alexander Valley, a region on the edge of Sonoma? If the latter case, then it has to be at least 85% wine from Alexander Valley.

Many larger wineries produce grapes for themselves and for other wineries in a very common practice called "sourcing". If a winery doesn't have a vineyard of their own can they still be called a winery? Yes and no. I have heard terms such as "virtual", and even though I'd call them more of a marketing company, don't discount their ability to produce great wines. This is how many new wineries make a name for themselves. They get the luxury of picking and choosing what grapes/juice they want to buy. If there was a bad crop or a bad year, said winery can wait until better grapes are available.

San Antonio Winery in Downtown LA produces their award-winning wines in Los Angeles, and they do have the luxury of owning their own vineyards. Winemaker Anthony Riboli explains it this way: "We own estate Chardonnay vineyards in Monterey, but we ferment the juice from those vineyards in downtown LA. It's a tradition of many decades. However, it shows that very high quality wines can be made in many places, even downtown LA. The urban winery trend is also very strong throughout the US."

#### LA COUNTY COVID-19 UPDATE

#### HOSPITALIZATIONS CONTINUE TO DECLINE, IN-DICATING LOS ANGELES COUNTY LIKELY PASSED THE PEAK OF OMICRON TRANSMISSION

Along with several other COVID-19 metrics, hospitalizations are also declining with 4,323 people currently hospitalized, representing a decline from the peak of 4,800 patients last week. The seven-day average of new admissions of people with COVID-19 also decreased by 10%, from 614 patients one week ago to 552 admissions today. Further, only a portion of COVID cases are requiring critical care. As of Thursday, 17% of COVID positive hospitalized patients are currently in the ICU, and 12% of COVID positive hospitalized patients are currently on ventilators.

Data is also showing the spread of Omicron has had a disproportionate effect among certain residents over the past two months, with the risk of hospitalization significantly lower for people who are fully vaccinated and boosted. Through January 15th, fully vaccinated and boosted individuals were 28 times less likely to be admitted to the ICU for COVID-19 than those unvaccinated, showing that vaccines continue to provide the best protection against severe illness.

Nonetheless, the county's healthcare system remains under strain due to more healthcare workers testing positive, which is contributing to the shortage of healthcare workers across the county. For the week of January 14th, there were 1,559 new healthcare worker positive cases, representing a nearly 18% increase compared to the 1,326 cases from the week prior.

"I send my heartfelt condolences to those families who have lost a loved one to COVID-19," said Dr. Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "While these declines give us cause for much welcomed hope, we should not take them as a sign to forgo the commonsense protective measures that helped to slow COVID-19 transmission in our county. Continuing these safety measures will drive down cases, which will ultimately end staffing shortages, reduce workplace and school outbreaks, and most importantly, keep residents from becoming seriously ill and dying."

Thursday, Public Health confirmed 85 additional deaths and 26,010 new cases of COV-ID-19. Of the 85 new deaths reported today, seven of the people who died were between the ages of 30 and 49, eight people were between the ages of 50 and 64, 25 were between the ages of 65-79, and 42 were over the age of 80 years old. Of the 85 newly reported deaths, 72 had underlying conditions. Information on the two deaths reported by the City of Long Beach and the one death reported by the City of Pasadena is available at www.longbeach.gov and www.CityofPasadena.net To date, the total number of deaths in L.A. County is 28,715.

Public Health has identified a total 2,586,739 positive cases of COVID-19 across all areas of L.A. County. Thursday's positivity rate is 12.7%.

There are 4,323 people with COVID-19 currently hospitalized. Testing results are available for more than 10,979,500 individuals, with 21% of people testing positive.

To keep workplaces and schools open, residents and workers are asked to:

Adhere to masking requirements when indoors or at crowded outdoor spaces, regardless of vaccination status.

Remain home when sick, isolate if positive and quarantine when in close contact.

Residents are legally required to be isolated if they have a positive COVID test result and are vaccinated. Close contacts with symptoms and unvaccinated close contacts need to be

#### PASADENA UNIFIED SCHOOL DISTRICT COVID-19 UPDATE **IMPORTANT CHANGE TO STUDENT COVID-19** PROTOCOL PICTURE

Dear Parents and Guardians:

Good news! We have now received our supply of rapid antigen COVID-19 tests which will allow PUSD to adopt a less restrictive QUARANTINE Protocol so that students may return to in-person learning as soon as possible. The new guidelines will maintain protective measures to continue reducing the risk of transmission in our schools and will take effect Monday, January 31, 2022.

Please be aware that these changes do NOT affect ISOLATION protocols for students who test positive for COVID-19. As a reminder, students who have COVID-19 must still isolate (stay in their home or other residence) for a period of at least 10 days. They may return to school if:

10 days have passed from the start of symptoms or the date of the positive test

No fever for at least 24 hours, without the use of medication

Other symptoms have improved

For students who have been exposed to COVID-19 and are identified as close contacts, the QUAR-ANTINE pro-cedures have changed. However, if the student is fully vaccinated, they are exempt from quarantine and can remain in school. Unvaccinated students who are identified as close contacts and directed to quarantine will now be allowed to return on Day 6 from the last date of exposure to the positive case if they meet the following criteria:

At least 5 days have passed from their last known contact to the infectious case

Are asymptomatic

Receive a negative result from an FDA-authorized viral COVID-19 test (rapid antigen or PCR) taken on Day 5 or later at the PUSD Primary Clinic (located at 351 S. Hudson, Pasadena, California 91109), which will be observed and verified by a PUSD Nurse

Monitor for symptoms for 10 full days from the last known contact to the infectious case,

Wear a non-cloth mask of multiple layers of non-woven material with a nose wire at all times when around oth-ers both indoors and outdoors,

Must eat outdoors when possible and with distance from others.

Exposed persons who were previously infected with COVID-19 within the past 90 days are exempt from quaran-tine and can remain in school.

The revised PUSD Quarantine Protocol is an option for schools and is outlined in further detail in the Pasadena Public Health Department (PPHD) COVID-19 Exposure Management Plan Guidance in TK-12 Schools. Our new guidelines are aligned to PPHD quarantine procedures and will shorten the time students are away from in-person learning. The health and safety of our students and staff remain our top priorities when making decisions regarding our health protocols. We will continue to monitor the spread of the Omicron variant and send updates as proce-dures change. We appreciate your patience and cooperation as we work together to navigate these rapidly changing guidelines.

#### ARCADIA HIGH COMES IN FIRST AS JPL MARKS 30 YEARS HOSTING REGIONAL SCIENCE BOWL

after an intense virtual competition that also marked a milestone for the Lab.

After months of training till midnight and hours of anxiety amid fast-paced competition, five Arcadia High School students took back their crown and are headed to the National Science Bowl in Washington, D.C.

The Arcadia team was victorious at the Jan. 22 regional competition, which marked the 30th year NASA's Jet Propulsion Laboratory in Southern California has hosted the tournament. The event brings together science- and mathminded high schoolers from across Los Angeles, Orange, Riverside, San Bernardino, and Santa Barbara counties. Arcadia last won the bowl in 2015; this year marked its eighth victory since the competition began.

The San Gabriel Valley school narrowly defeated Irvine's University High School, which came in second after winning for the past four years; another former winner, Troy High School in Fullerton, placed third. Twenty-two teams competed.

"It was pretty intense throughout," said Arcadia senior Ŝonia Zhang, who has competed in the bowl alongside her twin sister Selena since they were sophomores. "It was just a lot of hard questions. ... The pacing was really quick."

The team credits their victory in part to the "power of friendship," which regularly led to an extra hour of chatting after study sessions that ended at midnight. That closeness showed up on competition day.

"After every round, we were complimented about our teamwork," said Jeshwanth Mohan, also a senior.

Regional Science Bowl tournaments take place across the country in the lead-up to the National Science Bowl, which is coordinated by the U.S. Department of Energy and includes an all-expenses-paid trip to Washington for participating teams. The first national competition took place in 1991; JPL has been hosting the regional annual event since 1993.

"It's like the Super Bowl of science," said Arcadia High coach Cherryl Myster, who teaches advanced placement chemistry.

Since the beginning, Kim Lievense, who manages the Lab's Public Services Office in the Communications and Education Directorate, has

The team heads to the national championship | been at the helm for JPL. She coordinates some 35 volunteers, largely from JPL and Caltech, which manages JPL for NASA, to run the tournament.

> "I love this competition. I love interacting with the students, and I love interacting with the volunteers," Lievense said. "It's just fun." The questions have gotten harder over the years,

> The students are quizzed at a first-year college level in biology, chemistry, Earth and space science, energy, math, and physics in a fast-paced verbal format. Teams have just seven seconds to answer questions like this sample from the chemistry category:

> Dr. Ecniecs, who loves riddles, gave the following riddle about the periodic table: Element A is left-right adjacent to element B. Element A never shares what it holds. Element B is always taking from other elements. Both elements are a clear gas. Both elements are nonmetals. Combined, they have a mass less than that of gallium. What are the identities of elements A and B? The answer: neon and fluorine.

> Students, who competed from home, had two cameras on them: one showing their faces and another monitoring their workspace in an effort to ensure they're not cheating. Each team joined with three volunteers in a private virtual Zoom "room" for individual rounds of the event, and – unlike the in-person tournament – never went head-to-head with other teams.

Competing remotely increased the pressure, members of the Arcadia High team said.

"In this format, you're under more pressure to know the information well because you can't rely on the other team to screw up," Sonia Zhang

And you don't have the fun of interrupting, her sister Selena said.

It's not quite the same when the events are online only, Lievense agreed, but it's still a unique challenge for the students. Next year, she hopes, the competition will be held in person.

The Arcadia High team will face dozens of teams from other high schools at the national championship competition, which may also end up being virtual and is currently slated to begin in late April. Before that, there is plenty of time for more studying and late-night chatting.

#### HOW TO SURVIVE NO ELECTRICITY FOR AN EXTENDED PERIOD OF TIME,

#### AND HOW TO DEAL WITH NO ACCESS TO BANK ACCOUNTS AND MONEY

We've all grown accustomed to electricity in our lives. Some say we're addicted. However you see it, modern life as we know it would cease to exist without the steady flow of electrons. But most of us have so acclimated our lives to the availability of electricity that it's hard to imagine any life without it. We flip the switch and we have light, or a TV, or radio, or the computer, and a whole host of power tools for our shop and yard. Modern banking would not exist without electricity, nor would modern communication.

We're fortunate that so many inroads have been made to de-centralize electricity, at least for those who choose to educate themselves and build little systems so they can get off the grid, a little or a lot, and be able to have power if the whole grid goes down.

Ted Koppel (from the popular Nightline TV news show) wrote a book called "Lights Out" where he explored what it might take for a terrorist to take down what are essentially three grids in the U.S. Though he points out that this would not be easy, it could be done. Koppel also points out, perhaps to the dismay of the reader, that there is really no meaningful action plan to deal with such an eventuality.

We have no crystal ball, but let's just look at life without electricity, and explore the way in which we would live.

#### THE TRANSITION

If electricity were to "go out," suddenly without warning – especially for a prolonged period of time -- the results would be disastrous in today's society, though a prepared person would be better able to survive.

First, there would be widespread panic as the means of communication - except word of mouth - would be eliminated. The lack of communication means much more than not knowing what happened. It means that whatever method you've relied upon to communicate with your family, students, fellow workers, etc., will now be gone.

Rural areas would do somewhat better, for a variety of reasons. Bells and other sounding devices could be used for communications, as could fires on hilltops, but these systems all took time in the past to develop. A clear method of communication would not be established immediately, and I can visualize a brisk business in bicycle couriers who hand-delivered notes.

You should always discuss the day's plans with family members and discuss action plans, and where to gather, in the event of an emergency.

#### **MONEY**

Too many of us rely on the ability to go to a bank regularly and use the ATMs. Plus, have you ever watched at your local store how people buy things? Most people use credit cards all the time, which is a modern marvel of technology that can only exist in an inter-connected world powered by electricity.

People have always figured out how to buy and sell and trade, even before there was electricity. But in a transition to no electricity, people might not have access to their money, maybe temporarily, and maybe permanently, depending on the nature of the emergency.

People in rural area's have quite an advantage over people in the urban centers since they are more likely to know where all their needs are coming from. They are more likely to be producers of a raw commodity, with which they can directly trade for needs.

In urban areas, however, everyone tends to buy everything that's needed, and any food, animal, or craft production is nearly always "hobby" level. A major disaster that takes out electricity will take out the ability for most urban people to conduct ordinary transactions. During the interim, people should band together for protection, because you can expect violence, chaos, and unpredictability during such a period, until people figure out a new way of doing things.

Do not underestimate the severe impact that lack of access to money will have on your life and society. My suggestion is to constantly have it in the back of your mind, "what would I do if I could not get cash today? What can I do differently each day to be better prepared if that ever happened?" There are many options, such as always having extra cash and coin on hand, well hidden of course. And always purchasing a little more of the basics that you need so you have something extra for barter, if need be. In times of duress, such as war times, the best barter items tend to be those that feed the vices: alcohol, tobacco, chocolate, sugar, salt, all of which have a great shelf life.



#### **HOME MODIFICATION TIPS FOR 'AGING-IN-PLACE'**

Dear Savvy Senior:

My wife and I would like to make some affordable changes to our home so we can remain living there for as long as possible. Can you recommend some good re-sources that can help us determine what all we need to consider? Getting Old

Dear Getting:

Many older adults, like you and your wife, want to stay living in their own home for as long as possible. But being able to do so will depend on how easy it is to maneuver your living space as you get older. Here are some helpful resources you can turn to, to get an idea of the different types of features and improvements that will make your house safer and more convenient as you grow older.



Home Evaluation

A good first step in making your home more age-friendly is to do an assessment. Go through your house, room-by-room, looking for problem areas like potential tripping or slipping hazards, as well as areas that are hard to access and difficult to maintain. To help with this, there are several organizations that have aging-in-place checklists that point out potential problems in each area of the home, along with modification and solutions.

For example, Rebuild Together has a two-page "Safe at Home Checklist" that's created in partnership with the Administration on Aging and the American Occu-pational Therapy Association. Go to AOTA.org and search for "Rebuilding Togeth-er Safe at Home Checklist."

You also need to get a copy of AARP's "HomeFit Guide." This excellent 36-page guide has more than 100 aging-in-place tips and suggestions that can be made to an existing house or apartment or incorporated into designs for a new residence.

It explains how a smartly designed or modified home can meet the varied and changing needs of its older residents. It also features easy-to-do, low-cost and no-cost fixes that lessen the risk of trip hazards and increase the safety of high-use ar-eas like the bathroom, kitchen and stairway.

In addition, they also offer videos and a HomeFit AR app (available for iPhone and iPad) that can scan a room and suggest improvements to help turn your house into a "lifelong home," free from safety and mobility risks.

Visit AARP.org/HomeFit to order or download a free copy of this guide, or to watch their videos.

If you want some personalized help, you can get a professional in-home assess-ment with an occupational therapist.

An occupational therapist, or OT, can evaluate the challenges and shortcomings of your home for aging in place, recommend design and modification solutions, and introduce you to products and services to help you make improvements.

To find an OT in your area, check with your physician, health insurance provider or local hospital, or seek recommendations from family and friends. Many health insurance providers, including Medicare, will pay for a home assessment by an OT if prescribed by your doctor. However, they will not cover the physical upgrades to the home.

Another option is to contact a builder who's a Certified Aging in Place Specialist (CAPS). CAPS are home remodelers and design-build professionals that are knowl-edgeable about aging in place home modifications and can suggest ways to modify or remodel your home that will fit your needs and budget. CAPS are generally paid by the hour or receive a flat fee per visit or project.

To find a CAPS in your area visit the National Association of Home Builders web-site at NAHB. org/capsdirectory where you can search by state and city.

## YOU CAN'T HANDLE THE TRUTH MAYBE NOT—BUT I'D SURE LIKE THE **OPPORTUNITY TO TRY**

I hope Jack Nicholson's challenge hurled at the rest of us in "A Few Good Men" is untrue. Very much I would like to believe that the transparency promised by just about every candidate as the battle for our votes was something more than mere words. Increasingly I have come to understand that presenting truth is simply not in the best interest of those in power no matter what party they represent. What those in power want

is to stay in power. To do that fictions are created to pacify a potentially out of control population. We are all manipulated to act in the interest of those in power rather than doing what is best for us. Maybe this all necessary to maintain the organization of our culture and truthfully many of us live comfortable and often satisfying lives.

Still I am bothered by the inevitable loss of freedom and curiosity and the diminished joy of living. Let me start by talking about my 2 and ½ year old granddaughter. She is at an age where she is discovering that she has a mind of her own. She has amazing energy and always seems to have her own agenda in mind. She stamps her foot and pouts if she does not get her way. She wants what she wants and she wants it now. She plays games and teases but is full of love and mischief. A behavior that I found very interesting (actually everything she does is interesting to me) occurred on Saturday. My wife had placed some fresh flowers in a vase and cautioned her not touch them. She ignored the warning and took a flower upstairs to display it to my son and me. How nice of her to share; but while she displayed the flower to us she purposely broke off a part of the stem and yelled down to my wife, "meema" the name she has created and bestowed upon my wife, "I broke the flower". I am pretty certain that her thought processes were something like wanting to hold the flower when she noticed it and wanting it even more when she couldn't have it. She craftily snatched the flower displaying it to us and in her mind thereby turning us into her allies as she taunted her grandmother.

That's the dilemma. Human beings early become aware of their own agency and probably it is the responsibility of caretakers and parents to help the child maintain their energy and creativity so that they can get along in society and simultaneously use their abilities in the most fulfilling ways. Do we want our kids to be good little boys and girls who follow all the rules and make their parents proud; but at what expense? I know it's socially unacceptable to openly compare oneself with others but I will take a risk and do it. Pleasing one's parents is not the most fulfilling way to lead a life. I don't know exactly what I would rather have done but these past couple of years of pandemic isolation has left me some time to reflect. I think about the one time I stood up for myself which was when I stood up for myself and told my parents I would not serve in the armed forces during the Viet Nam war. I think we talked about the rightness of the war and whether it was reasonable to expect me or anyone else to put our life at risk so as not to suffer the disapproval of others, including my mother. I took his message to mean something like "You're a smart boy. If you don't want to go into the army then figure a way to stay out without damaging your whole life and "without ripping your pants" (You know causing my mother unnecessary grief.)

Already, I have heard my granddaughter say "walk in single file" which must be a repeat of what she hears at daycare. I want to tell her not to do it and to maintain her independence. I know this would be bad advice and also know that my daughter would get mad at me. I need to communicate that sometimes, most of the time, you have to walk in single file but you don't have to think in single file. Life is an experiment with a predetermined end. The challenge is to enjoy that life and to do this I think independence of thought must be maintained and it ain't easy but it is the truth. I get that, Jack!

#### **BEATING INFLATION IS LAUGHABLE**



In these inflationary times it's not easy to laugh as you watch the value of your hard-earned savings being de-stroyed.

But I chuckled out loud when I read some of the tips offered by Bloomberg News to beat inflation, which is at its highest point in more than 40 years.

Since Americans have enjoyed low inflation and stable consumer prices for a long time, Bloomberg explains, Americans are "a little rusty on basic inflationary-era tactics.'

Bloomberg turned to the long-tortured people of Argentina for guidance, as they have become experts at navi-gating hyperinflation rates as high as 50 percent in a typical year.

The tips the Argentines offer are the polar opposite of everything my Depression-era parents taught my sisters and me about managing our money — nutty tips that suddenly make sense in a nutty world.

Here's the first one: spend your paycheck immediately.

Why put money in the bank where its purchasing power will decline in value every day, when you can buy a new refrigerator, sofa or some other big-ticket item that will cost more a month from now?

In these goofy times, the sooner you buy it, the less you will pay for it.

Another tip: borrow lots of money.

If you can borrow a million today at a 3 percent annual rate and the inflation rate continues at 7 percent, you will enjoy a 4 percent gain.

That is, as today's dollars inflate, it will be easier for you to repay the loan in the future.

Even this English major can see that makes sense — sort of.

Another tip: buy cars.

That was certainly my strategy in my spendthrift 20s, when I lived paycheck to paycheck, in part because I always had to have a nice ride that I couldn't afford.

I can't believe any news outlet would encourage Americans to put their money into auto-

chips used in their manufacture — even new and old cars are soaring in value. My father has lost a fortune in cars over his lifetime, as they depreciated 30 percent or more

the day he drove them off the car lot. Finally, he got lucky. He leased a 2020 Kia. A year from now when his lease is up he will

make the payoff of \$13,500 and keep the car because it will be worth significantly more than that.

Bloomberg offers some traditionally sensible tips, such as buying inflation-linked bonds, which increase in value as inflation increases.

Bloomberg also suggests buying a home, which also makes sense, as a house is a great hedge against inflation. Though good luck finding one at a reasonable price, as housing values have soared.

Covid has caused considerable market disruptions that have contributed to rising prices and our inflation woes.

The federal government's stimulus spending, massive borrowing and especially its continuous money printing are major drivers of inflation.

I wish we had confidence that our political leaders had a sound strategy to solve this problem — a problem largely of their own making — but we don't.


I'm surely not alone in my worry that financial matters may get plenty worse before they get better.


Until then I'll demonstrate my investor acumen by squandering my hard-earned savings on a shiny new car I can't afford.

#### TERROR ALERT LEVELS IN REVIEW

Time to review the five stages of our Federal terror alert levels. At the bottom is our safest level "LOW" signified by the color green. The next level up is "GUARDED" displayed by the color blue.
