TO SUSTAIN TOWN'S CHARACTER will direct Planning Commission to

The Sierra Madre City Council met for their third regular meeting of 2022 on February 8th. At 2 hours and 25 minutes, this was the longest meeting yet, surpassing the 43-minute session on January 11, 2022. Once again, city staff appeared remotely in separate locations. Here are some of the highlights.

Planning and Community Preservation Director Vincent Gonzalez brought before the council the Planning Commissions prioritized Municipal Code Text Amendment (MCTA) as recommended by city staff. This list was derived based on state mandates and recommendations by the Planning Commission the City Attorney, and staff. Staff will draft ordinance amendments for consideration in the first quarter of the year to comply with state law.

The amendments include:

Urban Lot Splits: Ministerially approves dividing a single lot into two within a single-family residential

Small Home Lot Developments: Ministerially approves splitting a single parcel and developing single-family units up to the maximum allowable density in a multi-family residential zone.

Ministerial Design Review Permits: Ministerially approves up to two new, qualified housing units in a single-family residential zone.

Affordable Housing: To conform to the state density bonus law under Senate Bill (SB 290) and Assembly Bill (AB 634).

Second Units: To conform to the chapter to new state mandates related to Accessory Dwelling Units and Junior Dwelling Units.

Some ordinance "clean-up" items can be viewed on the city website.

The Planning Commissioner also suggested eight items for the priority list, including:

The reduction of the maximum allowed amount of floor area in all residential zones by 800 square feet \mid dent at the planning commission to offset the promotion of the development of Accessory Dwelling Units. And,

the creation of a list of approved arborists.

City Council wants to come back to the Accessory Dwelling Units topic for more discussion and would like staff to suggest multiple arborists.

Other than these items, Council unanimously approved the Municipal Code Text Amendments and During the public comment section

Discretionary Demolition Permit **Procedures**

The city wants to insure that potential historic resources are properly evaluated before being altered or demolished. The Discretionary Demolition Permit states that "no structure which was constructed 75 years or more before the date of the application for review shall be demolished without a Discretionary Demolition Permit."

One property that is a hot topic is 505 N. Hermosa Ave., known as the Wistaria Vine site. After the property owners did some pruning of the historic vine which is the backdrop of the logo in Sierra Madre, residents cried "foul," and demands followed to save the record-breaking vine somehow. The Discretionary Demolition Permit may help this property become a landmark despite being less than 75-years-old.

On that note...

Wistaria House Up for Sale... Again

In September 2021, Vicky Mak, the property owner at 505 N. Hermosa Ave. stated, "I think a lot of people thought this was a historical house, and you cannot touch anything," Mak said. "No, it is not." She noted that the trimming was done because the vine was "crushing the house" and a "fire hazard." (It should be noted that the Vine, the world's largest blooming plant did in fact destroy the home on the property in the past.)

However after the planning commission further deferred making a decision on her application to add a room to the house which would have required her to prune one of five 'trunks' of the vine, Mak, who has been unable to move in since April of last year decided to sell the property.

Her disappointment in the city's bureaucracy, the infringment on her rights as a private property owner and the hostile attitude towards her and her family by an irate resiand the event on September 11th when some residents trespassed on her property after rumors that they were tearing down the vine spread through town, she decided that she "was afraid to move her family to

So now, the property which holds the largest blooming vine is again up for grabs for a cool \$1,480,000, as listed on Zillow.

on Tuesday, resident Lynne Collmann had this to say, "At the December 2nd Planning Commission meeting, the new owner of the Wistaria house presented plans to upgrade their new home by adding a new addition. Commission members brought up some concerns about the impacts on the Wistaria vine due to the construction. To everyone's surprise, it was noted that there are currently no protections for the vine and that it can be cut down and removed by any property owner at any time. We have been fortunate that the previous owners, Bob and Nell, took good care of the vine for almost 50 years and welcomed visitors every year for the Wistaria Festival. Unfortunately, we can't be certain that will be the case for the next 50 years."

Will the amended Discretionary Demolition Permit Procedures save the vine? Time will tell.

Another Vine House Up For Sale

The Wistaria Vine extends beyond the primary home at 505 N Hermosa. In fact, during the Wistaria Festival, the house adjacent to it showcases the part of the vine that spans its yard. Visitors have viewed the vine at both locations. That secondary Vine House was also put on the market last week for more than 2 million dollars.

"The Meadows" to be Discussed in Special Joint Meeting

There will be a special joint session with City Council and The Planning Commission to discuss "The Meadows" proceedings at Bailey Canyon and the proposed 42-lot residential subdivision located at Sunnyside Ave. It will occur at Memorial Park Bandshell on Tuesday, February 15, New Net Energy Metering Changes a Blow to Residents

Net Energy Metering (NEM) allows customers who generate their energy onsite (such as solar) to receive incentives.

Currently, customers who install small solar panels to generate electricity are eligible for the state's NEM program. This includes a credit on electric bills for surplus energy fed back to their utility. The California Public Utilities Commission (CPUC) is now considering NEM 3.0. This update would affect current customers by:

Reducing credits to 4.7 to 5.8 cents per kWh from 22 to 36 cents per kWh.

Increased grid participation charge of \$48 a month for the average home.

Retroactively reduces the period that NEM 1.0 and 2.0 customers are eligible for energy credits from 20 to 15 years.

Eligible low-income and disadvantaged customers would be exempt from paying grid participation charges; however, many lowincome customers cannot take advantage of federal solar tax credits. Many residents have voiced strong opinions over these changes, and City Council seems to be on their side on this issue.

City Council unanimously recommended that the Energy Environment and National Resources Commission evaluate impacts on Sierra Madre residents and provide recommendations to City Council.

Note: City Council has extended the authorization to allow for remote and hybrid meetings for the next 30



Joy, sorrow, laughter, tears, death, birth, pleasure, misery, poverty, not quite so poverty, And always, always we had each other to hold on to."


My Valentine has been in heaven for almost five years now, but I am so very glad I wrote that piece



ShotSpotter Goes Live in **Pasadena**



Pasadena police officials announced Wednesday that the new gunshot detection system ShotSpotter is now in use making Pasadena the first city in Los Angeles County to use the controversial system.

The city council had approved, in October, a \$640,000 three year deal with ShotSpotter.

In a statement to the media, Interim Police Chief Cheryl Moody called the system a

game changer.
"By installing this system, the officers of the Pasadena Police Department will be able to quickly respond, save lives and increase the chance of taking into custody those responsible for the senseless acts of violence."

Critics of the system have said it is far from perfect and can report other sounds, such as fireworks or backfiring of cars as gunfire. Residents also questioned the system's use in minority neighborhoods and its high cost. Its use is also questionable as evidence in

Caltech Observatory to be Removed from Maunakea



Caltech officials announced Thursday that they received the final approval needed to begin decommissioning the Caltech Submillimeter Observatory (CSO) from Maunakea in Hawai'i.

According to a statement the Hawai'i Board of Land Natural Resources unanimously approved, on January 14, the Conservation District Use Permit (CDUP) for the decommissioning of the CSO from the Mauna Kea Science Reserve.

"We are grateful to move forward with the deconstruction process," said Sunil Golwala, Caltech physics professor and CSO director. Caltech aims to undertake the decommissioning this summer, with removal and restoration completed by the end of 2022." This will be the first observatory removed under the 2010 Decommissioning Plan for Maunakea Observatories.

During the observatory's lifespan, the CSO was one of the world's premier facilities for astronomical research and instrumentation development wiki/cso/outreach/outreach. at submillimeter wavelengths. The telescope was used by many scientists, including almost 200 student and postdoctoral researchers. All the astronomical instruments were removed from the facility in 2015.

The CDUP is the culmination of a careful process required under Hawai'i law to address technical aspects of the CSO's removal and the restoration of its site, including a detailed review of the potential cultural and environmental impacts. The CDUP sets the terms and conditions Caltech must follow during the decommissioning. Portantino Introduces Bill to Prioritize Pedestrian & Cyclist Safety



Senator Anthony Portantino introduced Monday Senate Bill 932, a measure to prioritize pedestrian and cyclist safety by requiring California cities to take concrete steps to reduce traffic collisions and fatalities. SB 932 is sponsored by Streets For All, ActiveSGV, Calbike, and Streets Are For Everyone. Recent data from the National Traffic Safety Highway Administration documenting a nearly 20 percent increase in traffic fatalities in the first six months of last year.

"There is no denying it, California needs safer streets. And, despite efforts during the last several decades to make our streets safer for pedestrians and cyclists, many of our streets have grown more dangerous in recent years," Portantino said. "Data driven plans to remedy this serious problem are necessary to save lives and encourage more people to walk and bike to their destinations. 'In California, the general plans of cities have often been very car centric when it comes to their street network," said Michael Schneider, Founder of Streets For All. "That all changes today with Senator Portantino critical bill that would integrate multi-modal thinking into the planning process, helping make our streets safer for all modes and fight climate change." SB 932 requires a county or

city to include a map of the high injury network in its General Plan and would further require a county or city to identify and prioritize safety improvements within 15 years that would address serious and injurious traffic collisions. The bill would increase or decrease the 15year implementation period, based on whether the measures introduced by a county or city achieve results to reduce percentages of traffic violence.

SB 932 creates an annual grant program to award funding to cities and counties that implement timely and effective short-term efforts to mitigate bicycle, pedestrian, and other human-powered transportation injuries and fatalities.

MOSQUITOES EXPECTED TO INTERCEPT WEEKEND FESTIVITIES -MORE THAN 500% INCREASE IN MOSQUITO ACTIVITY DE-TECTED THIS WEEK COMPARED TO SAME WEEK IN 2021

West Covina, Calif. (February, 10 2022) — Football isn't the only big game this weekend as mosquitoes are expected to score touchdowns in yards and patios in San Gabriel Valley — a region in Los Angeles

Mosquito trap data from the San Gabriel Valley Mosquito & Vector Control District (SGVMVCD) shows the average mosquito activity this week is 517.83% higher compared to the same week as last

The average mosquitoes per trap this week was 19.40. The same week in 2021 was 3.14. In fact, more mosquitoes were collected with less traps this week compared to the same week in 2021.

'Temperatures aren't the only highs this week as we buzz into the weekend," said SGVMVCD Vector Ecologist Kimberly Nelson. "Higher temperatures cause mosquitoes to go through their life cycles more quickly."

Tips to stay bite free

- Tip out stagnant water weekly Mosquitoes will use stagnant water to lay their eggs. Their larvae will grow in the water in about a week.
- Toss unused containers Forgotten containers left outside can collect stagnant water. Protect with mosquito repellent Pick up a bottle and look for any one of the following ingre-
- dients: Oil of lemon eucalyptus, picaridin, IR3535 or DEET.

"If you're tired of mosquito bites, the best defense is to use mosquito repellent," said Levy Sun, SGVM-VCD communications director. "Mosquitoes will exist to some degree in our city environments, but we can prevent them from biting us."

Repellents containing any one of the four active ingredients are effective against mosquitoes: Oil of lemon eucalyptus, picaridin, IR3535 or DEET.

Only female mosquitoes bite. Mosquitoes use the blood to create the eggs. However, in the process of biting, mosquitoes can leave behind itchy bumps and can make people sick.

In Los Angeles County, the most pervasive mosquito-borne disease threat is West Nile virus. Zika, yellow fever, and dengue fever pose an outbreak possibility due to the presence of invasive Aedes mosquitoes.

SUPER BOWL AND VALENTINE'S DAYS OF **FOOTBALL AND ROMANCE**

First of all, let's agree to disagree: Valentine's Day should be a full week long. A single day is not long enough to fully express one's love.

What do you say about having an evening at home with a bottle of bubbly and a candlelight table for dinner?

You may wonder why a critic would dare such treason. In all truth, it's an impossible night for restaurants, so let's find three bottles in price ranges you can live with.

In the \$10 price range, Ruffino Prosecco has been produced from grapes grown in the hilly area of Valdobbiadene, which is the most historically active region for the production of prosecco.

Bright straw yellow with fine bubbles, the bouquet

is fragrant and intensely fruity, with clean notes of apples, pears and citrus. I found it crisp, clean, and yet delicate - a perfect wine for the budget-minded lovebird.

From the \$20 range, let's go back to Paso Robles for the San Simeon Petite Sirah. I enjoyed this well-

bodied wine with a pre-Valentines dinner of lobster thermidor. This wine is not for the "beginner" (nor is cooking lobster thermidor), and brings strong notes of fruit when opened with a well-rewarded and long finish.

My \$30-range selection is the Domaine Carneros. My opinion is that this estate-bottled wine gets as close to a "real" French champagne as any California sparkler on your supermarket shelves. This cuvee is 51% chardonnay and 49% pinot noir, with an alcohol content of a modest 12.1%. I got a perfect "pop" upon opening the bottle, which I poured into a lightly chilled flute and watched the bubbles rush to the top. The flavor was a little toasty in the beginning with a clean, long finish. You have my permission to drop a strawberry in your glass for this special occasion.

LA COUNTY COVID-19 UPDATE

LA County and Cincinnati Public Health Departments Congratulate the Rams and Bengals and Encourage Safety Measures as Residents Gather to Watch the Super Bowl LOS ANGELES - The Los Angeles County Department of Public Health and the Cincinnati Health Department are joining together to encourage residents and visitors in Los Angeles County and Cincinnati to gather safely when watching the Super Bowl game between the Cincinnati Bengals and the Los Angeles Rams on Sunday, February 13.

The health departments want to caution residents that COVID-19 spreads more easily in closed spaces with poor airflow, crowded indoor areas where there are many people from different households, and crowded indoor and outdoor settings where people are unmasked and chanting or shouting together. For all of these situations, there are sensible safety measures that everyone can use to have a safe game day.

Smaller gatherings are recommended as mixing with different households increases the risk of infection. People should also gather outdoors, if possible, and if you can do it safely, move the TV outside or plan to serve food and drinks outdoors. If having an outdoor Super Bowl gathering isn't possible, it is recommended that organizers improve airflow, including using fans or portable air cleaners, or running the heat or air conditioning.

Residents should also consider getting a rapid test as close to the start of the gathering as possible, especially when gathering indoors with people who are unvaccinated and/or are at higher risk of severe illness from COVID-19. Rapid tests, including over-the-counter (OTC) self-tests, provide a result in 15-30 minutes. Residents can also find a testing site in LA County at https://covid19.lacounty.gov/testing/ or in Cincinnati at https://www.cincinnati-oh.gov/health/covid-19/covid-19-testing/

Wearing an upgraded mask (such as an N95, KN95, or KF94) while not eating or drinking also adds stronger protection, especially if the gathering is crowded with unvaccinated guests, people with unknown vaccine status, or people who are at higher risk of severe illness.

Individuals will benefit from getting boosted or vaccinated as soon as they can, as it will help protect themselves, and their friends and family at Super Bowl gatherings. Residents in LA County can visit VaccinateLACounty.com (LA County), and Cincinnati residents can go to Cincinnati-OH.gov/health/covid-19/ to find vaccine information or to schedule an appointment.

Fans who plan to go to a bar, restaurant, or to SoFi Stadium in Los Angeles County to watch the game, should follow all county rules at the venue and check specific venue's COVID-19 requirements ahead of time, which are likely to include vaccine verification and masking requirements.





I hadn't been able to sleep much the night before, so I arose very early. It was Saturday, and the sun had not begun to rise over the hills to the east. It was very quiet, and I could actually feel the collective heave and sigh of relief

The streets were still dark, and cool, and devoid of people. I turned my bicycle around and began to coast back down the hill, and after a few miles, I turned down a street where a family I knew lived. I slowly bicycled by and saw that only Jim, the young six-year-old, was out in the yard playing. I said hello, and he recognized me and said hello. He asked me if I wanted to see the dirt people. I got off my bike, and got down on my hands and knees, and he showed me the little tunnels and trails of the dirt people, and he showed me where they lived, and how they drove around on little pebbles. He pushed a pebble with a long stick, and made a sound like an automobile engine.

"See how they go?" he said, excited. "Make yours go," he commanded, and so I began to push a little pebble around with a stick. "What are you guys doing?" she asked to both of us, but really to me.



Our bodies got older and we allowed our minds to ossify. We put aside imagination for pragmatism, and we gave up the ability to believe for hard-earned cynicism.

That morning, I realized that childhood ends when you can no longer lie in the dirt and imagine.

DO I HAVE TO FILE INCOME TAX RETURNS THIS YEAR?

What is the IRS standard tax deduction for 2021? I didn't file a tax return last tax year (2020) because I lost my job and my income in March due to COVID. But I got a part-time job in 2021 and am wondering if I made enough money that requires me to file this year. Part-Time Retiree

Dear Retiree:

Whether or not you are required to file a federal income tax return this year depends not only on how much you earned last year (in 2021), but also the source of that income, as well as your age and your filing status.



Here's a rundown of this tax season's IRS tax filing re-

quirement thresholds. For most people, this is pretty straightforward. If your 2021 gross income – which includes all taxable income, not counting your Social Security benefits, unless you are married and filing separately - was below the threshold for your filing status and age, you may not have to file. But if it's over,

Single: \$12,550 (\$14,250 if you're 65 or older by Jan. 1, 2022).

Married filing jointly: \$25,100 (\$26,450 if you or your spouse is 65 or older; or \$27,800 if you're both over

Married filing separately: \$5 at any age. Head of household: \$18,800 (\$20,500 if 65 or older).

Qualifying widow(er) with dependent child: \$25,100 (\$26,450 if 65 or older).

To get a detailed breakdown on federal filing requirements, along with information on taxable and nontaxable income, call the IRS at 800-829-3676 and ask them to mail you a free copy of the "1040 and 1040-SR Instructions for Tax Year 2021," or you can get it online at IRS.gov.

Check Here Too

You also need to be aware that there are other financial situations that can require you to file a tax return, even if your gross income falls below the IRS filing requirements. For example, if you earned more than \$400 from self-employment in 2021, owe any special taxes like an alternative minimum tax, or get premium tax credits because you, your spouse or a dependent is enrolled in a Health Insurance Marketplace plan, you'll need to file.

You'll also need to file if you're receiving Social Security benefits, and one-half of your benefits plus your other gross income and any tax-exempt interest exceeds \$25,000, or \$32,000 if you're married and filing jointly.

To figure all this out, the IRS offers an online tax tool that asks a series of questions that will help you determine if you're required to file, or if you should file because you're due a refund. It takes approximately 12 minutes to complete.

You can access this tool at IRS.gov/Help/ITA - click on "Do I Need to File a Tax Return?" Or you can get assistance over the phone by calling the IRS helpline at 800-829-1040.

Check Your State

Even if you're not required to file a federal tax return this year, don't assume that you're also excused from filing state income taxes. The rules for your state might be very different. Check with your state tax agency before concluding that you're entirely in the clear. For links to state tax agencies see Taxadmin.org/ state-tax-agencies.

Tax Prep Assistance

If you find that you do need to file a tax return this year, you can free file through the IRS at IRS.gov/FreeFile if your 2021 adjusted gross income was below \$73,000.

Or, if you need some help, contact the Tax Counseling for the Elderly (or TCE) program. Sponsored by the IRS, TCE provides free tax preparation and counseling to middle and low-income taxpayers, age 60 and older. Call 800-906-9887 or visit IRS.treasury.gov/freetaxprep to locate services near you.

You can also get tax preparation assistance through the AARP Foundation Tax-Aide service. Call 888-227-7669 or visit AARP.org/findtaxhelp for more information.

PURCHASING LIFE INSURANCE: WHAT YOU NEED TO KNOW

Life insurance is a key component of your family's estate plan, offering a safety net to those who depend on you for their financial security. And although purchasing life insurance may seem straightforward, it can be quite complex, especially given all the different types of coverage available. When it comes to life

insurance, you will want coverage in place if any of the following scenarios apply:

You are likely to have dependents-minor children, a non-working spouse, or senior parents—who rely on you for their financial needs, and you will likely not have enough saved up to continue to provide for those needs after your death. You have a business that will need a cash infusion if you die to keep it running, until it can be

sold or for your loved ones to buy out a business partner.

You have a potential estate tax bill that you want to cover with life insurance, so your family doesn't have to sell assets to pay the taxes.

Betting On Your Life

A life insurance policy pays benefits to your family or business (whomever you choose as the beneficiary) in the event of your death. And the earlier in life you purchase your policy, the less expensive your monthly or annual premiums will be. By the same token, the healthier you are when you get life insurance, the less you'll pay in premiums, because your policy is basically a bet between you and the insurance company about when you'll die.

The insurance carrier is betting they'll be able to earn enough from the premiums you pay before you die, so they'll have received more than enough money to pay out the death benefit to your designated beneficiaries when you pass away. As such, many carriers require a medical exam before your policy is issued.

Life insurance comes in two main forms, which you can think of as permanent and temporary. With permanent coverage, such as whole life and universal life, as long as you pay the premiums, your insurance cannot be canceled, and your policy will pay out when you die (unless you live longer than the guaranteed period).

With temporary coverage, known as term life insurance, you pay premiums over a certain number of years—usually 10, 20, or 30—and if you have not died during that period, the insurance ends, your premiums are gone, and no benefits are paid out when you die.

Term Life Insurance

Because your coverage expires after a certain number of years, term life insurance is much cheaper than permanent. Term policies are typically used by people who expect that they'll only need the insurance for a certain period or for a certain purpose.

For example, you might purchase term insurance to cover your home mortgage in the event you die before it's paid off. Or you might have minor children, who rely on your income for their basic needs, and you need a term policy to ensure they have enough money to live on until they become financially independent should you die before they reach adulthood.

Permanent Life Insurance

Permanent life insurance comes in several different forms, such as whole life, universal life, and variable universal life. And it's mostly used for estate tax planning, very high-end income tax planning, and key-person insurance, which pays out benefits if you fill a vital role in a company that would need cash upon your death to continue operating. As mentioned earlier, the various forms of permanent life insurance pay a death benefit whenever you die, no matter how long you live (unless the policy contract has a termination provision at a specific age).

Permanent life insurance policies typically have two components: the amount that goes toward paying for the life insurance, and the amount that builds up as an investment, called the "cash value" component. The cash value amount of your premium is invested tax-free, and depending on the policy, you may be able to use the cash value component in several ways: you can borrow against it throughout your lifetime (in which case you pay interest to the insurance company), you can take out cash withdrawals (in which case your death benefit would be reduced accordingly), or you can use it to pay future premiums.

PUT THE LIGHTS ON



Yes, the world sits idly by as this ongoing Uyghur What is a genocide anyway? The dictionary defines it as "the deliberate killing of a large number of people from a particular nation or ethnic group with the aim of destroying that nation or group". To me this definition avoids the basic question of "race". As the now suspended Whoopi Goldberg attempted to explain it was not a question of "race"-- just one group of White People killing another group of White People. BIG DEAL, TRUMP BROKE ANOTHER LAW

A federal statute on the books – Title 18, Section 2071 of the U.S. Code - spells out the provisions of the Presidential Records Act of 1978. All materials generated by a president, in the furtherance of his (or her) official duties, automatically belong to the American people. Which means that all such materials - documents, memos, gifts, letters, whatever - must be transferred to the National Archives upon that presi-

The law also warns that anyone found guilty of "willfully and unlawfully" concealing, removing, mutilating, obliterating, or destroying, or attempting to do any such action, can be fined and imprisoned for up to three years.

dent's departure from office.

As David Ferriero, the official Archivist of the United States, stated this week, "The Presidential Records Act is critical to our democracy, in which the government is held accountable by the people. Whether through the creation of adequate and proper documentation, sound records management practices, the preservation of records, or the timely transfer of them to the National Archives at the end of an administration, there should be no question as to need for both diligence and vigilance. Records matter."

Why, pray tell, did Ferriero feel compelled to issue such a statement? Only because the Visigoth of Mar a Lago had been caught, yet again, pillaging the spirit of democracy. Because, as we've now learned, it took the National Archives a full year (from January 2021 to January 2022) to retrieve 15 boxes of our stuff - including potential security-sensitive material - that Trump stole from the White House while being shoved out the door by a record-high 81 million voters.

Granted, other presidents have done bad things. Bill and Hillary took some gifts and furnishings that belonged to the White House that they were compelled to return. But the sheer scale of Trump's pilferage has reportedly dwarfed all previous episodes.

Of course, considering everything else Trump has done and continues to do, stealing 15 boxes in breach of federal law is roughly the equivalent of jaywalking. This grifter hid his tax returns and his medical records, so why should we care that he spent a full year hiding government documents?

That's how far he has lowered the bar - he gets away with everything (so far) because nobody expects him to do any better. But just imagine how the right-wing infauxtainment complex would've reacted if Barack Obama had stolen 15 boxes and secreted them in his manse on Martha's Vineyard. 

WHERE ARE THE SIDEWALKS?

The looming specter of the proposed Meadows Housing Development of 42 homes on land the Mater Delorosa purchased in the early 1920's has found me re-thinking several long-held concerns regarding city management and maintenance. The lack of sidewalks above Grandview and on the north side of West Grandview is becoming one of my main concerns. Since I moved I to Sierra Madre in 2008, I was struck by how it felt that the city had forgotten to put in sidewalks in the upper northwest quadrant of town. Sidewalks have always made pedestrians feel safer while walking on streets whether it was with their dogs, taking an early morning walk, walking from neighbor to neighbor, or simply walking their children to and from school. In many cases the residents have made their own sidewalks in the dirt, because the city has not had an active program to put sidewalks in for its residents. However, I took a hard look at North Lima a few months ago and realized the residents have adjusted to this situation by using the street as their sidewalk. Because the elevation of North Lima is quite pronounced above Grandview, safety becomes another concern as the mere weight of the cars allows them to speed up until the first stop sign at Grandview. After doing further research the city actually had a master plan for installing sidewalks and maintaining sidewalks once. This is part of what I found.

"One Goal of the Sidewalk Master Plan" is listed below: "The Sierra Madre Sidewalk Master Plan is intended to be a broad planning document that can be referenced when sidewalk considerations confront the Public Works Department. Resources and funding will most likely prevent the city from accomplishing all recommendations of this plan immediately. The primary goal of this plan is continuous improvements towards a safe, accessible, useful, aesthetically pleasing and sus-

Also recognized in the continuation of the Master Sidewalk Plan was:

tainable system of walkways throughout the city.

Sidewalks are the pedestrian arteries of the city and the safety of those pedestrians using the sidewalks is a significant concern to the community. As is the case with any other segment of city-owned infrastructure, the city is generally considered to be

responsible for the safety of persons using the sidewalks. Further exploration of this 42 page Master Sidewalk Plan

A sidewalk inspection program paired with a plan for maintenance and installation provides economic benefits to the city by preventing claims and minimizing the expense of litigation. Aside from the prevention of accidents, inspection programs and maintenance/installation plans may allow cities to take advantage of certain governmental immunities that are not otherwise available to those entities without such programs.

Clearly the city recognizes the need and the safety issues sidewalks address, but the question is the why has there been no aggressive sidewalk program to have them installed throughout this area? My home and my next-door neighbor's home were built in 1922. Both homes are 100 years old and neither have sidewalks. Why has the city neglected this area for so long? In fact, with the exception of one home whose owner installed their own sidewalk as part of a total landscape remodel for installing drought tolerant plants a few years ago, both sides of North Lima up to Carter have very few sidewalks. If the city's plan was to have residents put in their own sidewalks when the property was involved with a major renovation, or when the homes were bought and sold that program has not occurred in Sierra Madre. It is rather a haphazard arrangement when someone wants a sidewalk installed they contact the city and pay for it themselves. However if had someone from the city told me when I moved into Sierra Madre I needed to put in a sidewalk in front of my home it would have been installed years ago. Instead I also use the street as a sidewalk because no sidewalks have ever been installed above Grandview. The sad comment is that if there has been a program in place no one has ever heard about it and I have lived here for 15 years and subscribe to the local paper. Why is that?

The thought of additional traffic or approximately 800 cars a day generated from 42 homes that MIGHT BE BUILT IF THIS HOUSING PROJECT ON THE MONASTERY LAND GOES FORWARD further concerns me. The current infrastructure of the streets that will be impacted by this development are woefully not ready to accept extra traffic. Can you imagine the law suit generated from one child walking in the street to school being hit by a car speeding down Lima, because the child had to walk in the street to get to school! Think about it. This is a real "wake-up call" for the city. Whether the Housing Development is accepted or not, for safety reasons sidewalks should be installed throughout the city. Better be safe and start installing sidewalks in an aggressive fashion so something like this does not have a chance
