

#### **MONASTERY MINUTE:**

#### CAN THE SIERRA MADRE HANDLE THE ADDITIONAL TRAFFIC FROM THE MEADOWS PROJECT?

If there is one thing Los Angeles is known for it is traffic. Sierra Madre is so idyllic because it seems to escape the hustle and bustle of the "big city."

There is concern that the Meadows homes and three acre park will cause an unreasonable increase in traffic. The Environmental Impact Report (Appendix K), using the State required traffic standards based on Vehicle Miles Traveled, determined the impact will be "less than significant".

This metric doesn't tell us what the tangible impact will be. For that we can look at the Fehr and Peer traffic study which shows existing trips to or from homes and the Monastery at 340 per day. After the Meadows project is complete that will increase that to 710 trips per day. The most impacted intersection of Sunnyside Ave. and Fairview Ave. will have just under 600 trips per day.

That might sound like a lot, but if we look at the worst case scenario and assume all that traffic is squeezed into a 12 hour period, that is 50 cars per hour or less than one car per minute. If we compare that to the peaceful Upper Canyon, with 85 homes (served by a single 20' wide street), there are about 1000 trips per day. That is 83 cars per hour or 66% more traffic than Sunnyside Ave. and Fairview Ave. will experience.

The Meadows project will not create an unreasonable amount of traffic by adding less than one car every two minutes.

#### LETTERS TO THE EDITOR

Dear Editor:

In his letter to the editor that appeared in the March 26, 2022 edition of the Mountain Views News, John Doyle of "Neighbors for Fairness in Sierra Madres" asks: "What if it were your property?"

He also invokes the 1st Amendment and damage to the property rights of Mater Dolorosa.

If it is the private property of "Mater Dolorosa" isn't the disposition of the land their decision?

Oh, they are a religion. The 1st Amendment says that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof;"

And congress, via the tax laws, have decreed that churches (and non-profit organizations) do not have to pay property and other taxes.

If I wanted to have a religion of the Great Green Grasshopper and have church property on which I don't pay taxes then I have to comply with laws established by Congress that decide whether I qualify as a religion. That pretty much sounds like "Congress making a law respecting the establishment of

The real questions are:

1) Do the owners of a property have the right to dispose of it as they wish? Of course they do. 2) Do

religious organizations, and other non-profit organizations, deserve exemptions from paying taxes? No, they don't. There should not be any exemptions on the responsibilities of an entity under the laws of the United States.

Take a look at the 14th Amendment to the Constitution:

"All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."

Tax law considers corporations as a "person". Churches and non-profits are therefore corporate persons. They too should pay taxes and have the same rights to life, liberty and property that are guaranteed to all citizens of the United States and the equal protection of the laws. They should also have the same responsibilities which include paying

#### JUST THE FACTS: THE MEADOWS **DEVELOPMENT AND RELIGIOUS FREEDOM**

I'm not fond of bickering, but I am fond of getting facts right and John Doyle's rebuttal of my letter to the editor had so many misstatements I feel I need to step up again.

First he claims I was trying to hide the "real" purpose of the proposed initiative which asks the voters to require the Mater Dolorosa "monastery" development be consistent with current Hillside zoning.

He claims the initiative secretly "seeks to outlaw any institutional expansion of the property ever and to restrict residential development to untenably large parcels, essentially rendering the Mater Dolorosa property incapable of development".

That's simply wrong. The initiative asks that the citizens of Sierra Madre vote to require the developers to follow the current Hillside provisions in the city's General Plan for buildings in similar parts of the city, if the project is approved. It does not prevent them from developing. It does prevent them from developing under a new Specific Plan they drafted, full of special provisions just for those 42 homes and apart from and not approved for the rest

More importantly, John claims the initiative and other efforts to resist the development of 42 homes on the property violates the religious freedom of the current owners, the Passionist Fathers organization of Chicago. Specifically, he cites the Religious Land Use and Institutionalized Persons Act (RLUIPA) and claims the initiative violates it.

The RLUIPA states: "No government shall impose or implement a land use regulation in a manner that imposes a substantial burden on the religious exercise of a person, including a religious assembly or institution, unless the government demonstrates that imposition of the burden on that person, assembly, or institution—" and goes on to detail how that is implemented.

It is a good law that helps protect against religious

discrimination and government intrusion in to Religious activities.

But building 42 homes is not a religious activity. It is a money making activity to generate up to \$200M for the Passionist Fathers and the developer New Urban West. And it will forever impact and change our community if it goes on unchecked.

Property rights are not religious rights if the use is not religious. And the wider community has a say when builders do something that impacts their neighbors. Would it be violating the Passionists' religious freedom if the city prevented them from building a slaughterhouse or a nuclear powerplant or a skyscraper on that property?

When I joined the SM General Plan Steering Committee (GPSC), the property was already zoned as "institutional". Institutional zoning means the owners are free to develop anything they want that is institutional in nature; such as a church, religious school, or whatever religious activity they want. It does not allow them to build housing.

The GPSC spent years polling and meeting with our fellow citizens to develop a plan that reflects their desires for Sierra Madre. When the city approved the General Plan, we did not do anything in particular aimed at Mater Dolorosa; we established guidelines that the community as a whole desired for all of Sierra Madre. The zoning of that area has a long history, starting with its original zoning as low density residential. This was updated, along with the rest of the city, in a long process starting in the 80's where zoning for hillside portions of the city and for institutions such as churches and schools were designated consistent with the long standing desire of Sierra Madre residents that this town maintain its small town character and ties to the natural mountain landscape.

As honored fellow citizens, the owners of the Mater Dolorosa should honor the General Plan when they develop their property and do so according to the Hillside provisions. That is what the initiative is asking the citizens of Sierra Madre to vote for. Ed Miller, SIerra Madre

#### WHAT'S IN THE MATER DOLOROSA HILLSIDE RESIDENTIAL ZONING INITIATIVE?

For a couple of weeks, we've been talking to people about the current "Mater Dolorosa Hillside Zoning Initiative" being circulated throughout Sierra Madre. It seems as if many of those who have signed the petition either have a misunderstanding about what will be asked of the voters or what effect it will have on an institution's ability to use their private property.

Others who have signed the petition have the misconception that the proposed project will change the character or quaintness of the entire Čity. In our 58 years of living in Sierra Madre, first in the Canyon, and then on East Grandview, we have seen many changes, including several housing projects - all except for the Jameson property, are above Grandview. We can honestly say that in those years the character or quaintness of Sierra Madre has not gone away. In fact, it has been enhanced as our new neighbors have brought

The claim of some is that the wildlife that in-

terface with our City will be displaced. This is simply not true. The wildlife will have space around and behind the Retreat Center, in Bailey Canyon Park, and all of the foothills behind Sierra Madre. In fact, where we live the deer have chosen to graze and rest under our Jacaranda tree even though there is a "Meadow" just three doors up from our

Mater Dolorosa has been a major part of Sierra Madre's fabric for 100 years. The Initiative is directly aimed at violating the very purpose of the Mater Dolorosa's existence. The Initiative states, "The intent of this Initiative is to permit the continued operation of the Mater Dolorosa Passionists Retreat Center without expansion, significant physi-

their talents and individual personalities to cal alteration, or change in use, as a non-our City. most restrictive covenant that can be placed on their property without it being a complete taking. The Initiative covers the entire property owned by Mater Dolorosa, not just the area of the proposed project. It negates the current Institutional zoning. In other words, hypothetically, should the Passionists want to convert their Retreat Center into a Retirement Home that would not be allowed under the proposed change to the Hillside Residen-

Further, under Section 5, the Initiative states "It is the intent of the voters that the City of Sierra Madre retains its authority. . . . However no such authority shall be exercised in a manner that undermines or is inconsistent with the provisions of this Initiative, unless an amendment of this Initiative is approved by the voters" thus restricting Mater Dolo-

rosa from making any changes to their property unless they create an Initiative of their own to be placed on the ballot. Not even City officials can change the zoning by application or request to the Planning Department should this Initiative pass. How is this fair? Any other property owner in the City can apply for a permit to build, a change in zoning, or other use of their property. Why discriminate against this particular property

By supporting this Initiative, you are, in effect, approving the violation of a 100-year religious institution's right to further expand their ministry. Please do not sign this petition or if you have already done so, you may request to have your signature removed by contacting the city clerk.



Pasadena Mayor Victor Gordo, (pictured) released a letter to residents Friday that disputes California Attorney General Rob Bonta's claims that Pasadena is in violation of Senate Bill 9, a housing law passed by the Legislature in

"It is important that I communicate and provide the supporting documentation, directly to our residents who are entitled to know that the City of Pasadena is not in violation of SB 9 as wrongfully asserted by the Attorney General" Gordo said.

In a formal response to Bonta, Gordo simply states that local historic districts are exempt from the provisions of SB 9. According to Pasadena's legal counsel, the city's "landmark districts" are clearly "historic" districts, as they are evaluated using the same criteria as used for an application for the National Historic Register, boundaries are determined using the same criteria as used for an application for the National Historic Register, and every landmark district must show a relationship to a historical context Gordo's letter reads.

Gordo states that Pasadena is acutely aware that there is a serious housing shortage in the State of California.

"Assuming your office was unaware, please take note that, in the last housing element cycle, Pasadena permitted and entitled over 4,950 new residential units, many times more than its total Regional Housing Needs Allocation of 1,332 units," Gordo states. "The city currently has 1,021 affordable units in the development pipeline, all but 150 intended for lower income households, and an additional 2,200 units are under review."

Using fiery language, Gordo said city officials took issue with Bonta's politics with his

'We were sent the letter alleging violations of state law without any prior substantive conversation with your office, and despite the city's history as a supporter of new housing," Gordo said. "To add insult to injury, the letter was released concurrent with a press statement, and shortly thereafter self-serving tweets by elected officials, misrepresenting Pasadena's efforts on SB 9, and housing policies in general."

Gordo ended his letter saying that city officials were in the process of setting up a meeting with Bonta's office, elected state and local officials, and legal counsel.

Gordo also wrote, near the end of the his letter, "Be aware that Pasadena must defend its reputation of successfully balancing the need for new housing while protecting its historic resources."



### The Chef Knows By Peter Dills

#### GAS OR WINE?

Recently, I was the recipient of a question from reader Cruz Trevino of Sierra Madre. It appears that Cannon Drive(Beverly Hills) and their wine list may have migrated to a location near us. Cruz was at the Langham Hotel and enjoyed a glass of Taittinger Champagne (\$27), and he asked



this writer to investigate how establishments come up with prices of wines by the glass. I dream of a day when a poor restaurant critic may soothe his many worries with an exceptional glass of wine and not be required to carry a bag of gold dust as payment. Like the majority of us, Cruz strikes me as a regular consumer of wine; a person who is not cheap but searches for value when he is dining out. I must admit I, too, like the gentle view from the Tap Room over looking the 50 acres of greenery.

I reached out to my many sources in the industry and this is what I found out. Ian Blackburn, founder of Learnaboutwine.com, said, "That (\$27) is fairly common (really?) for a good glass of wine and the math works out to (\$135) for the full bottle at that price per glass." While many chain restaurants use a Libby wine glass which costs a couple of bucks, upscale restaurants use a higher quality glass, so you can guess that the cost of the glass might be just a bit lower than what they paid for the entire bottle. My next call was to Randy, who owns the Domenico's restaurant on Washington in Pasadena. He tells me that his wine purveyors suggest to "tripling the cost of the bottle". This means if you see a bottle for \$30 at your favorite restaurant, by this rule of thumb, they paid \$10 for it."

Ok, so how about corkage fees? Most restaurants charge \$4-\$15 for this service because, yes, they still have to open your bottle and clean the glasses. I find it that is unacceptable to bring in a bottle of wine that is already listed on the restaurant's menu. If it is an owner-occupied restaurant, often it is a good gesture to let the owner sample the wine that you have brought in. Who picks the wine? Erudite wine broker Eddie Ramirez offers this insightful advice, "Always have the wine list when ordering, and I do not recommend asking the servers for a wine recommendation unless you do not have any issues with the price." My suggestion to Cruz and my readers is it to never blindly let the server choose the wine for you and be careful on the "House Wine" I stayed at a resort in South Laguna just a few years ago and my bill was \$110!!

I hope this helps. I learned something as well.

# SECOND BOOSTER DOSES AVAILABLE TO ELIGIBLE RESIDENTS AT PUBLIC HEALTH OPERATED VACCINATION SITES

## Public Health Reports 541 New Positive Cases and 7 New Deaths Due to COVID-19 in Los Angeles County

Last week, the U.S. Food and Drug Administration authorized a second booster dose of either the Pfizer-BioNTech or the Moderna COVID-19 vaccines for individuals 50 years of age and older at least 4 months after they received their first booster dose. Public Health sites will be prepared to administer second booster doses to those eligible starting immediately.

Sites administering second booster doses for those 50 years of age and older starting tomorrow include Obregon Park (East Los Angeles), Ted Watkins Park (South Los Angeles), Balboa Sports Complex (Encino), Commerce Senior Citizens Center (Commerce), Market Street Center (Santa Clarita), Palmdale Oasis Recreation Center (Palmdale), and the Norwalk Arts and Sports Complex (Norwalk). Visit VaccinateLACounty.com for more information.

Eligible residents can also check with other vaccination sites about the availability of the second booster dose.

The Los Angeles County Department of Public Health (Public Health) today released the latest data on COVID-19. The number of cases and deaths are likely to reflect reporting delays over the holiday weekend.

- 541 New COVID-19 cases (2,831,655 cases to date)
- 7 New deaths due to COVID-19 (31,626 deaths to date)
- 321 people currently hospitalized with COVID-19
- More than 11,675,000 individuals tested; 22% of people tested positive to date

# THE HIGHLY INFECTIOUS BA.2 SUBVARIANT INCREASING IN LA COUNTY, ACCOUNTING FOR 32% OF ALL SPECIMENS SEQUENCED

Increases in LA County reflect patterns seen around the world, with the World Health Organization announcing last week that worldwide, BA.2 accounted for 86% of sequenced cases from the prior 4 weeks. And on Tuesday, the Centers for Disease Control and Prevention estimated that BA.2 is now the dominant variant in the U.S., accounting for approximately 55% of sequenced cases for the week ending March 26.

While there are not yet increases in cases or hospitalizations in LA County, given the increased risk for spread of BA.2, it's important to take steps to maximize protection against spread, including increasing vaccination and booster rates for residents, as these gaps in vaccination coverage create significant risk.


As of March 27, 83% of LA County residents ages five and older had received at least one dose of the COVID vaccine and 75% were fully vaccinated. Additionally, 57% of eligible residents ages 12 and older received the additional protection of a booster. This leaves about 2.6 million booster-dose eligible residents not benefiting from the extra protection of a booster dose and 1.7 million eligible residents needing to get their first vaccination. If residents cannot be vaccinated due to medical reasons or because their body can't mount an appropriate immune response to vaccines, they may still be able to be protected with COVID therapeutics. Residents should ask their provider if they're eligible to receive Evusheld, a new therapeutic for people 12 years and older that can prevent COVID-19. There are also several therapeutics available that can reduce severe illness for people who have been infected with COVID-19. If residents test positive, they should check immediately with their provider whether they are eligible to receive one of these treatments. Residents who don't have a doctor can call the COVID-19 information line at 833-540-0473, 8:00 am - 8:30 pm daily for more information. Note that the monoclonal antibody medicine Sotrovimab is no longer authorized for use in California due to studies showing less efficacy against BA.2.

Residents can also stock up on the over-the-counter COVID test kits that they can administer themselves at home. Up to two sets of four at home tests can be ordered at no charge from the federal government at www.covidtests.gov. Residents who have health insurance can receive eight free at home tests each month for each insured member in their household. Individuals can also get tested at one of the many free testing sites located throughout the County. Visit www.ph.lacounty.gov/covidtests for information and links to testing sites. Individuals should get tested if they feel sick, have an exposure, or are gathering with others at elevated risk.

Individuals should also continue to wear a mask indoors in public places, especially if they, or others they will be in contact with, are not fully vaccinated, elderly, immunocompromised, or have serious underlying health conditions. Masking is one of the easiest and most effective strategies for protecting ourselves and others from COVID-19.

"We continue to extend our deepest sympathies to everyone mourning the loss of a loved one from COVID," said Dr. Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "We're about two months out from the peak of our winter surge and have seen significant declines in our cases, hospitalizations, and deaths. However, with case numbers no longer decreasing and increases in the circulation of the more infectious BA.2 subvariant in LA County, now is the time for us to use the tools at hand to decrease both personal and community risk: vaccination, testing, masking and therapeutics. In a similar way that we take steps to be prepared for fires and earthquakes, we now also need to take preparedness actions that allow us to be safe during a pandemic. And just like we don't wait until there is a fire or an earthquake to make a plan, we don't need to wait until we are experiencing another surge, to increase our protection. Get vaccinated and boosted, have a supply of test kits, talk to your provider about eligibility for new therapeutics, and wear a well-fitting, high filtration mask in places where the risk for transmission is elevated."

#### **CHARMING CHATA**

At the ripe ole age of 59, I have come to appreciate true friendship more than Happy Tails ever before and I feel blessed to have as many loyal friends as I do. One thing that came to mind for me recently as I by Chris Leclerc reflected on this fact, is that most of my closest friends are a lot different from



me. Some are much older, and some are considerably younger. Many do not look anything like me; they are not the same color, shape or size and they come from a myriad of backgrounds. Indeed, several of my dearest friends don't even speak my language, yet they know me intimately and love me unconditionally.

You might be wondering how I could have found such genuine friendships in people with whom I have so little in common. The answer is simple: First of all, I am naturally drawn to diversity in other humans, and secondly, the majority of my friends just so happen to be animals! Fortunately the humans and animals I surround myself with are kind and openminded enough to accept me just the way I am, and I accept them likewise, so friendship is inevitable.

Among my closest canine companions is one that inspired me enough to write this story about her. I think her example could help do away with one of today's most damaging urban myths about her canine breed. The friend I am referring to is an 11 year old girl named Chata. Chata has a beautiful, shiny golden coat and matching smiling eyes. She is symmetrically perfect from one side of her body to the other. She's as fit as a fiddle and healthy as a horse, with not an ounce of spare fat and plenty of tight muscle to fill out her stature in all the proper places. Her bone structure is striking with alluring curvature including a dramatically "to-die-for" slim waist (don't I wish!).

Her senses are extremely keen, and her heart is bigger and warmer than that of many humans I know. Chata lives quite the life of leisure with her family of 4 humans including 2 small children, and a 6-year-old Chocolate Lab named Charlie. She is remarkably aware of how lucky she is to have been adopted into an incredible family that loves and cares for her. When Chata looks directly into your eyes, she melts your heart. She is a true charm. What kind of dog is Chata? She is what is commonly known as a Pit Bull, but her official breed title is American Pit Bull Terrier.

Known for their intelligence and loyalty, American Pit Bull Terriers make excellent companions despite the bad reputation they have gained due to the cruel treatment and unfair press they've received. They are often confused with the American Staffordshire Terrier, and apparently in the eyes of the United Kennel Club (UKC) they are considered to be the same breed, although there are those who disagree. Some AKC (American Kennel Club)registered American Staffordshire Terriers are dual-registered as American Pit Bull Terriers with the UKC.

The AKC, on the other hand does not allow a UKC-registered American Pit Bull Terrier to be registered as an American Staffordshire Terrier. To be dual-registered, the dog must first be an AKC-registered American Staffordshire Terrier and then it can be registered with the UKC as an APBT -- but not vice versa. Having said all of that, I am an individual who would rather steer clear of canine breed titles and labeling altogether. To me, it is much more important that each dog be recognized as an individual, each with his/her own unique personality and qualities, the same way we strive to view our fellow human beings.

My beautiful American Pit Bull Terrier friend, Chata defies all negative rumors about the behavioral traits that are "typical" for her breed. She puts you at ease the moment you are in her presence, both with her body language and her eye contact. She respects others more than most humans do, in my opinion and she is a great "nanny" to her baby brother, Charlie. She plays gently with the two youngsters she lives with. She displays humility by lowering her head slightly when you first greet her, then she begins her child-like writhing back and forth with her tail swiftly whipping from one side of her groin to the other. She lets out a tiny whimper now and then when she is excited, as if to say "I am so happy to see you".

Contrary to what some people think about her breed, Chata is by far one of the most sensitive and loyal canine companions that I have ever known. As humans beings, we have learned to be very careful not to jump to conclusions about one another, regardless of color, race or culture. In fact there are certain laws that prohibit us from such profiling. Well, I say it's high time that we learned to apply the same moral principals to the way we view and treat man's best friend!

Many rumors have been spread indicating that Pit Bulls are vicious dogs that are likely to attack, but in reality, most are quite the opposite. Although it is clear that they are capable of potential harm, it's all about how they are raised. Again, let's remember that each dog is an individual. It is well put in the old adage "You can't judge a book by it's cover". Yes, some Pit Bulls are unfriendly, but that is typically because they have been either neglected or abused by the human.

The Pit Bull was originally bred to fight, (who's warped idea was that?) but thankfully, breeding dogs to fight has been outlawed in this country. I say treat every dog equally with kindness and respect, regardless of it's appearance. Don't be ignorant by breed-bashing based on rumors and assumptions. If we assume things about a dog because of it's breed, are we not breaking our own moral code as human beings, to refrain from judging one another based on appearances? Keep an open mind, think for yourself and above all, love and let live.

Will strides back to his seat, and Chris Rock doesn't miss a beat, pointing out that he list at the list and Chris Rock doesn't miss a beat, pointing out that he just got whipped by Will, and Chris asks, "Really?"

Many people thought it was all some sort of publicity stunt, but what happened next cured them of that illusion. Will loudly heckles back, twice, to Chris that Chris should absolutely keep his wife out of any comedy routines, including the unacceptable "F" word in Will's comments.

And then, for better or worse, Chris just kept rolling and the show went on. A few minutes later, Will Smith wins an award for a film I'd never heard of, and he's up on stage crying, and talking about fatherhood, protecting the family, and also apologizing for what everyone had just witnessed.

What does it all mean? For one, it means that everyone – and I mean "everyone" – was overly preoccupied in the days that followed by talking about the slap, and what it meant, and who

was right, and who was wrong, and what now. Suddenly everyone forgot that death and killing were taking place in Ukraine.

When I realized what had occurred, I found it to be a sad moment. First, it should be said that I never enjoy a comedian "roasting" anyone in the audience, in the harsh manner that people such as Don Rickles used to do. It always makes me cringe. And yet, if you're going to be a politician, or have a high public profile, you need to have thick skin. And at first I sided with Will Smith, especially when I learned that Chris Rock had gone after Will's wife before. So there was some history and background that I didn't at first appreciate. Still, in retrospect, was the G.I. Jane comment really demeaning, or sarcastic, or degrading? Not really. If I were Chris, nevertheless, I would find ways to be funny without unnecessarily hurting innocent bystanders.

As for Will Smith, he did the wrong thing, on several levels. Granted, I might have done the same in similar circumstances, though I probably would have run onto the stage and tackled the comedian while the crowd tried to tear us apart. Just saying. Still, I have had the highest respect for Will Smith – and for Chris Rock. I can see that Will could do so much good in the world, and that means he must bite the dust sometimes, and be an example. He could have just bid his time, and when he won the award and had the world listening to him, he could have set Chris Rock straight with a medical lesson. As it is now, are comedians fair game for attack if we dislike their "comedy?" I hope not.

To his credit, after the dust of emotions had settled, Will issued the following statement:

"Violence in all of its forms is poisonous and destructive. My behavior at last night's Academy Awards was unacceptable and inexcusable. Jokes at my expense are part of the job, but a joke about Jada's medical condition was too much for me to bear and I reacted emotionally," Smith wrote. "I would like to publicly apologize to you, Chris. I was out of line and I was wrong. I am embarrassed and my actions were not indicative of the man I want to be. There is no place for violence in a world of love and kindness."

That was a good gesture, though I doubt it will be the final word.

Chris Rock issued the following: "As a comedian it can be difficult to understand which lines are to be crossed and which ones aren't. Last night I crossed a line that I shouldn't have and paid the enormous price of my reputation as a renown comedian. Comedy is never about poking fun at or making lite of people with major ordeals happening in their lives. Comedy is about using real life circumstances to create laughter and bring light to an otherwise dark world. With that said, I sincerely apologize to my friends Jada Pinkett-Smith, Will Smith, and the rest of the Smith family for the disrespect and disregard I displayed which was unfortunately broadcast for the world to see. I hope that, with time, forgiveness can come of this situation and we can all be better, more considerate people in the end."

Sometimes it takes a tragedy for good things to come about. I hope and pray that this is so in this case.

#### HOW TO CHOOSE A MEDICARE ADVANTAGE PLAN

Dear Savvy Senior:

I will be 65 and eligible for Medicare in a few months and am interested in getting a Medicare Advantage plan to cover my health care and medications. What tips can you provide to help me pick a plan? *Ready to Retire* 

Dear Ready:

Medicare Advantage plans have become very popular among retirees over the past 15 years, as nearly half of all new Medicare enrollees are signing up for Advantage plans, which accounts for about 42 percent of the entire Medicare market. Here are some tips and tools to help you pick a plan that fits your needs.



First, let's start with a quick review. Medicare Advantage plans (also known as Medicare Part C) are government approved health plans sold by private insurance companies that you can choose in place of original Medicare. The vast majority of Advantage plans are managed-care policies such as HMOs or PPOs that require you to get your care within a network of doctors.

If you join an Advantage plan, the plan will provide all of your Part A (hospital insurance) and Part B (medical insurance) coverage like original Medicare does. But many plans also offer extra benefits like dental, hearing and vision coverage along with gym/fitness memberships, and most plans include prescription

Medicare Advantage plans are also cheaper than if you got original Medicare, plus a separate Part D drug plan and a Medigap policy. Many Advantage plans have \$0 or low monthly premiums and don't always have a deductible, but they also typically have a high out-of-pocket maximum. În 2021, Advantage plan participants on average were responsible for a maximum of around \$5,100 for in-network care, and about \$9,200 when out-of-network care is included.

How to Choose

To help you pick a plan, a good first step is to call the office managers of the doctors you use and find out which Advantage plans they accept, and which ones they recommend. Then go to the Medicare Plan Finder tool at Medicare.gov/plan-compare to compare Advantage plans in your area. This tool provides a five-star rating system that evaluates each plan based on past customer satisfaction and quality of care the plan delivers. When comparing, here are some key points to consider:

Total costs: Look at the plan's entire pricing package, not just the premiums and deductibles. Compare the maximum out-of-pocket costs plus the copays and coinsurance charged for doctor office visits, hospital stays, visits to specialists, prescription drugs and other medical services. This is important because if you choose an Advantage plan, you're not allowed to purchase a Medigap policy, which means you'll be responsible for paying these expenses out of your own pocket.

Drug coverage: Check the plan's formulary – the list of prescription drugs covered – to be sure all the medications you take are covered without excessive co-pays or requirements that you try less expensive drugs

Dental, vision and hearing: Many Advantage plans come with dental, vision and hearing benefits, but are usually limited. Get the details on what exactly is covered.

Coverage away from home: Most Advantage plans limit you to using in-network doctors only within a service area or geographic region, so find out what's covered if you need medical care when you're away from

Out-of-network coverage: Check to see what's covered if you want to see a specialist in a hospital that is not in a plan's network. You can get a list of doctors and hospitals that take part in a plan on the plan's website.

## FAMILY MATTERS

#### PROBATE: WHAT IT IS & HOW TO AVOID IT

Unless you've created an estate plan that works to keep your family out of court, when you die (or become incapacitated) many of your assets must go through probate before those assets can be distributed to your heirs. Like most court proceedings, probate can be time-consuming, costly, and open to the public, and because of this, avoiding probate—and keeping your family out of court—is often a central goal of estate planning.

To spare your loved one's the time, cost, and stress inherent to probate, you can spend a little time and effort planning now.

How To Avoid Probate

Before we discuss the more advanced ways you can use estate planning to allow your loved ones to avoid probate, it's important to point out that not all of your assets will have to go through the probate process—and that's true even if you don't have any estate plan at all.

Assets That Do Not Require Probate: Certain assets, such as those with beneficiary designations like 401(k)s, IRAs, and the proceeds from life insurance policies, will pass directly to the individuals or organizations you designated as your beneficiary, without the need for any additional planning (unless your named beneficiary is a minor child, then you will need additional planning).

Outside of assets with beneficiary designations, other assets that do not go through probate include assets with a right of survivorship, such as property held in joint tenancy, tenancy by the entirety, and community property with the right of survivorship. These assets automatically pass to the surviving co-owner(s) when you die, without the need for probate.

However, it's critical to note here that if you name your "estate" as the beneficiary of any of these assets, those assets will go through probate before being distributed. The same goes if you overlook a beneficiary designation, or if you die at the same time as a joint property owner each of those assets will also go through probate, even though they have beneficiary designations.

In addition, we generally recommend that you do not rely on beneficiary designations to handle the distribution of your assets. These designations give you little to no control over how

your assets are distributed, and they can result in negative outcomes you did not intend, especially if you have a blended family with children from a prior marriage or if you have no children at all.

Although there are several different types of assets that automatically bypass probate, the majority of your assets will require slightly more advanced levels of planning to ensure your loved ones can immediately access them, without the need for any court proceedings in the event something happens to you. The primary estate planning tool for this purpose are trusts.

Avoiding Probate With A Revocable Living

Trusts are a popular estate planning tool for avoiding probate. Although there are a variety of different types of trust, the most commonly used trust for probate avoidance is a revocable living trust, also called a "living trust."

A trust is basically a legal agreement between the "grantor" (the person who puts assets into the trust) and the "trustee" (the person who agrees to manage those assets) to hold title to assets for the benefit of the "beneficiary." With a revocable living trust, this agreement is typically made between you as the grantor and you as the trustee for the benefit of you as the beneficiary. You act as your own trustee during your lifetime, and then you name someone as a "successor trustee" to take over management of the trust when you die or in the event of your incapacity.

It might seem odd to make an agreement with yourself to hold title to assets for yourself in order to benefit yourself. Yet by doing so, you remove those assets from the court's jurisdiction in the event of your incapacity or when you die. Instead, those assets transfer to your successor trustee, without any court intervention

At that point, your successor trustee is responsible for managing the trust assets and eventually distributing them to your beneficiaries, according to the terms you spell out in the trust agreement. This is how a trust avoids probate, saving your family significant time, money, loss of privacy, forfeiture of control, and emotional stress.







#### WE DON'T TALK ABOUT...



Of course we do: That is all anybody seems to be talking about. Today is Wednesday and perhaps by Saturday or Sunday when you have a chance

to read this article the furor will have died down. It's been a week since Will Smith, the 6 foot 2 inch Black Male celebrity, struck or slapped 5 foot 10 inch Chris Rock, also a Black beloved celebrity, right in his face. This occurred during the presentation of the OSCARS program and as Chris said it was "unforgettable television". Frankly, I wish I could forget.

Why do I mention that both Will Smith and Chris Rock are Black male celebrities well known to huge audiences across America? Like all other attendees at the ceremony, Smith and Rock wore fancy tuxedos and the whole presentation was an attempt to market the worthiness of the Black People and the entertainment industry. This particular OSCAR presentation was for the first time produced by a Black producer, Will Packer, who employed an all Black production team all with promise that the show

So why do I emphasize the racial component. Remember, I'm an old guy with memories of times when Black people were thought incapable of playing quarterback or of being smart enough to be coaches or of being admitted to prestigious colleges or of being considered able enough to produce a show like the OSCARS. Those times are not far behind us and this 2022 Oscar presentation was intended to increase viewership and to demonstrate the abilities to the world of people for whom those opportunities were formerly foreclosed.

As I began watching the show there appeared the Williams Sisters, Black female athletes born anything but rich in Compton and new world-famous, wealthy and admired. There they were presented in beautiful dresses with their boobies falling out. Maybe the dresses were fashionable and beautiful, I really didn't notice. What I did notice was their almost completely exposed breasts and I was repelled. In these "Me Too" times displaying women in this matter to the ogling eyes of audiences plainly gives the wrong message. Certainly if women wish to dress this way certainly they have that right I guess but to me it gives the wrong message. Frankly, I am glad that prospective Justice Ketanji Brown Jackson did not present herself in that manner at her confirmation hearing and I believe there is something off-kilter | real high!

about Russian President Vladimir Putin baring his chest to display his toxic-masculinity which somehow makes him qualified to preside over a nation or even he whole world. (I hope Vice-President and potential future President Kamila Harris agrees with me.)

Back to the Oscars. Do you think Will Smith would have acted the same way if the person telling the joke which arguably insulted Will's wife was a more powerful Black Man, or a White Man, or a Black Woman, or a White Woman? As far as I am concerned Smith's explanation that the innocuous joke caused him to lose complete emotional control is complete nonsense. There must be other factors involved and I really don't have enough information to speculate. The fact that Smith was simply allowed to resume his seat and minutes later was allowed to receive his Oscar to a standing ovation absolutely disgusted me. To my mind the producers of the show should have required that he be immediately escorted out of the theatre as he retook his seat.

There is an important racial element to all this as has been expressed by my old UCLA classmate Kareem Abdul-Jabbar. Kareem, an extraordinarily famous successful Black Athlete, wrote a column saying that Will Smith's behavior "perpetuated stereotypes against Black People advocating violence, diminishing women, and insulting the entertainment industry." In his column Abdul-Jabbar noted that Śmith's action will allow pundits to push a narrative that "Black People are more prone to violence and less able to control their emotions."

I would like to think that those stereotypes no longer exist in the minds of people, or at least younger people, but for older people like Kareem and me it is still necessary for Black people, and particularly Black celebrities, to understand that their actions contribute to the way an entire Race is judged. Listening to the Brown Jackson confirmation hearing I was especially moved by her explanation of the importance of racial modeling to young people. What are we teaching our children when obviously wrong behavior is ignored and everyone stands to applaud the wrongdoer.

Sure, Chris Rock's current tour in Boston is sold out and he's making lots of money that he doesn't need and that's not the point either. Meanwhile global warming continues, the war in the Ukraine is unresolved, there's possibly a new threatening virus variant but the public discourse seems to center around whether Will should be required to return his Oscar. #### **HOW MUCH MORE EVIDENCE** DOES MERRICK GARLAND NEED TO INDICT TRUMP?

If or when Merrick Garland bestirs himself to action, he'd do well to ponder the new federal court ruling that drops the hammer on coup conspira-

On Monday, the case for indicting Donald Trump was succinctly framed and arguably wrapped in a bow. And this was without even knowing what Trump may have said to fellow conspirators during seven key hours on Insurrection Day, the 7 hours and 37 minutes that are mysteriously missing from the White House phone logs. Seriously, folks. What is it gonna take?

First, some quick housekeeping: Eastman, you may recall, is the Better-Call-Saul lawyer who's been outed for concocting a "legal" memo that was designed to help Trump overturn his election loss. Sort of a fascist instructional sheet for dummies.

Monday's court ruling, authored by U.S. District Judge David Carter (a former decorated Marine), commanded Eastman to cough up 101 emails - mostly exchanges with Trump - and to share them with the House's Jan. 6 Committee. That was the narrow issue at hand. But, fortunately, Carter took it upon himself to connect the dots that situate Trump at the center of the blessedly failed coup. Carter's warning was an implicit plea for Merrick Garland to wake up: "If Dr. Eastman and President Trump's plan had worked, it would have permanently ended the

peaceful transition of power, undermining American democracy and the Constitution. If the country does not commit to investigating and pursuing accountability for those responsible, the Court fears January 6 will repeat itself." It would seem that our accountability sleuths at the Justice Department still need to be enlight-

ened about the evidence that shines with the strength of 100 suns. Whatcha got for us, Judge Carter? "Dr. Eastman and President Trump launched a campaign to overturn a democratic election,

an action unprecedented in American history...Their campaign was not confined to the ivory tower - it was a coup in search of a legal theory. The plan spurred violent attacks on the seat of our nation's government, led to the deaths of several law enforcement officers, and deepened public distrust in our political process."

As Judge Carter reminds us, Eastman insisted in his Jan. 3, 2021 memo that Mike Pence, during his ceremonial task of counting the Electoral College votes, could simply throw out seven Biden states, thus reducing the tally to 232-222; and that Pence could then announce that since no candidate had reached the magic 270, the election would decided by the House, where each state would get one vote - and since the GOP at that time controlled 26 of the 50 state delegations, presto! Trump would win the election.

The problem, of course, was that Pence had no power to toss Electoral College votes, because there's no such provision in the Constitution. But that mattered not a whit to Trump, who spent days trying to muscle Pence into executing the plan that Eastman had touted as "BOLD." The judge zeroed in on one particular provision of the federal criminal code - 18 U.S.C. § 1512(c)(2) – which, as he explained, "criminalizes obstruction or attempted obstruction of an official proceeding. It requires three elements: (1) the person obstructed, influenced or impeded, or attempted to obstruct, influence or impede (2) an official proceeding of the United States, and (3) did so corruptly." He thus concluded:

Because President Trump likely knew that the plan to disrupt the electoral count was wrongful, his mindset exceeds the threshold for acting 'corruptly'... After filing and losing more than 60 suits (in court), this plan was a last-ditch attempt to secure the Presidency by any means." The potential hitch in all this evidence is that to prove Trump's criminality to a jury beyond a reasonable doubt, prosecutors need to successfully argue that Trump knew in his mind that his coup conspiracy was wrong. Hence the potential problem: This mope doesn't have a moral compass. He tends to believe that whatever he wants or says at any given moment is right and true.


For instance, one possible explanation for the seven-hour gap in the White House phone logs is that Trump communicated with fellow conspirators by using burner phones. In a statement, he denied doing that because, he insisted, "I have no idea what a burner phone is, to the best of my knowledge I have never even heard the term." I'm sure he believes that lie in his mind. The problem is, he used the term "burner phones" at

least three times in his recent lawsuit against niece Mary Trump. And former national security adviser John Bolton told CBS News, "Wait a minute, Trump knows burner phones." The Jan. 6 Committee members have been calling on the Justice Department "to do its job," but alas it's possible that Garland is hesitating to indict Trump precisely because it's so hard to prove that someone so amoral has any consciousness of wrongdoing. Heck, just this week Trump asked his 2016 campaign ally, war criminal Vladimir Putin, to release some dirt on Hunter Biden.






