Home Prices & Sales Slow As Mortgage Rates Increase

Southern California home prices leveled off last month as buyers reacted to higher mortgage rates and rising inflation, causing sales to plunge 16% from year-ago levels. Last month's sales tally was one of the lowest for May in records dating back to 1988. "The market's changed," said Katherine Orth of Sierra Madre, a brokerassociate with DPP Real Estate. "It's not like a bubble bursting. It's more like a punch in the stomach.... the market today is entirely different from what I saw in the market in May," she said.

"We were talking this morning in our office meeting how the market has changed drastically. The demand is still there, but buyers are afraid that rates are going to continue to go up."

DID MATER DOLOROSA HINT AT LEGAL TROUBLE FOR CITY?

After 3 Sierra Madre residents filed a successful petition for the purpose of changing the zoning of the Monastery (Mater Dolorosa), supporters of "The Meadows" project came out in full force at Tuesday's city council meeting to express their disapproval. The Initiative Measure will appear on the General Election Ballot on November 8, 2022.

If the measure passes, the zoning at the Monastery parcel and any subdivisions would change from Institutional to Hillside Residential, spoiling Mater Dolorosa's future building ambitions for a possible housing development, shrine, expanded retreat area, and gardens or paths.

Barbara Vellturo, Alexander Arrieta, and Gary Bacio submitted their intent to circulate their "Stop the Housing Project" petition in January. The completed petition was delivered to the County Clerk's office in May. Of the 1,492 signatures on the petition, 1,300 were sufficient, and they only needed 856 signatures to qualify for the

During a public hearing on June 14th, City Council had the option of adopting the initiative, submitting the initiative for inclusion on the November 8, 2022; General Municipal Election; calling for a Special Election and submit the initiative there; or directing the City Attorney to prepare a report under Elections Code § 9212.

Misinformation and Legal Jeopardy

The standing-room-only days at City Council Chambers for this hot topic have dwindled to just a handful of diehard residents committed to keeping the smalltown charm alive in Sierra Madre. Those who were there to speak out against "The Meadows" project were outnumbered by mostly out-of-towners who contributed in some way to the religious functions at Mater Dolorosa.

Most of the speakers in favor of the project expressed that Sierra Madre residents were "misinformed" by unreliable information about the Monastery's intentions and false statistics on added traffic, water usage, and environmental impacts. In addition, much talk of costly legal action against the city if this initiative vote passes.

the information that's been passed by the concerns raised by the Planning Com-News, in which a resident claimed that allowing this project to proceed would double the traffic in the local area. "What they weren't able to explain is how producing this amount of housing in the area, which would be less than one percent of what is now available in the city of Sierra Madre, would increase it by 100 percent," Briones inquired. Briones also expressed that he felt there was much misinformation but did not cite any examples.

CEO spoke out against the Initiative. "Mathis initiative is successful. Damage has miscommunication of our development plans and the status of our ministry," Cunningham said. "This is not a future that we a future that anyone else would want," he stated.

"You need to listen to your constituents," said Alexander Arrieta, one of the residents who proposed the petition. "There has been a very compelling message that has come across. CITIZENS FOR TRUTH

If you are reading the Mountain Views News regularly, chances are you are following the huge controversy generated by a project of 42 very large homes, destroying over 100 trees in the process at the

Here are the facts from the four-hour Planning Commission meeting on June 2nd - questions and concerns from the Commissioners who struggled to understand how they could approve such a project, as well as comments from concerned residents.

Planning Commission:

- 1. The Specific Plan is the primary zoning code for the project, and once the project is reviewed by City Council, takes precedence over any of the City's zoning codes.
- 2. At the May 5 meeting, the Commission asked for a comparison of the zoning per developer New Urban West's calculation, compared to our City's. Using the City's calculation, the houses became even larger resulting in larger houses on smaller lots. Here's the result: Big houses crammed together in cookie cutter fashion, 4850 square foot houses can be built on every lot. That is double anything in Sierra Madre.
- 3. New Urban West through its representative Jonathan Frankel repeatedly refused to clarify which of the housing designs will go on which lots, or if there would be a limit to two story houses.
- "The square footage of the homes is 'breathtaking".
- 5. "This will look like the downtown area where everything is crammed together."
- "This is unsettling from the Memorandum of Understanding on. I've never felt this way. Lies are going back and forth. I love the project but I have all kinds of trepidations."

Residents:

- "There was an anonymous donation of \$100,000 for a new fire truck.
- Net zero water is New Urban West's made-up definition that keeps changing. It is not a community benefit.
- The Thomas Fire in Santa Barbara destroyed 10 new homes. They had the same materials as these houses would have.

- 1.
- We won't reconfigure the square footage to conform to Sierra Madre's definition. Six times he repeated: We need to advance the project. We want this to move along for our investors
- This is not an R-1 (residential) project. 3.
- This is unfair to us (under the guise of Neighbors for Fairness, paid for by New Urban West)

Citizens for Truth - Mr. Frankel, and "Neighbors"- we have a very conscientious Planning Commission. What they are asking for is for this project to follow the same rules as Sierra Madre, even with larger homes.



A CRITICAL TIME FOR **ACTION AGAINST THE** PROPOSED MEADOWS AT BAILEY CANYON HOUSING **PROJECT**

Protect Sierra Madre has been actively engaged in trying to retain and help preserve

all that is special about Sierra Madre.

New Urban West (NUW) and the Passionist Ownership (based in Chicago and owners of the Monastery) are proposing to build the largest housing development in Sierra Madre history, the Meadows at Bailey Canyon.

Recently, it was shared that Protect Sierra Madre was successful in attaining 1,300 signatures to get an important initiative on the ballot in November to allow Sierra Madre residents to have a voice on a zoning change that would limit this huge housing development that does not fit at all with the values of our community. Far exceeding the 856 signatures that were required by the city, the team of volunteers secured the signatures in a fairly brief period of time. Proponents of the housing project state that opposition to the project is from a 'small number of residents in the

immediate vicinity'. However, the number of signatures gathered shows otherwise, as signatures came from residents on nearly every street in our city and reflects a very significant and broad level of Sierra Madre residents that have huge concerns with this project and are opposed to it. It's not difficult to understand why.

At the June 2 Planning Commission (PC) meeting, the PC were asking very fundamental but critical questions about how big the homes of the proposed project could ultimately be. Doing the math, the PC discovered that if the Specific Plan that the developer New Urban West has submitted were to be approved in its current state, it would allow for the building of 42 homes each up to 4,850 square feet, on lot sizes as small as 8,000 square feet. Imagine that: 42 McMansion size homes packed in against each other. One of the PC members stated that the General Plan and ordinances was specifically put in place to guard against McMansion housing developments.

At this week's City Council (CC) meeting, where next steps on the initiative were to be discussed, several housing project supporters spoke. The only issue was that most of their speakers don't live in Sierra Madre. Imagine showing up at an important City Council meeting in Pasadena or Altadena and providing your support for a huge proposed housing project that a significant number of actual, local residents oppose. Local residents would rightfully ask, "Why are you speaking?" Most housing project supporters, especially those that speak at CC or PC meetings don't even live here, and will not have to live with all the disastrous impacts of this project.

The project supporters continue to allege that the initiative is creating religious persecution of the monastery, which is completely ludicrous and false. It's a false narrative being used to distract from the fact that this is a really bad project on multiple levels. It's also asserted that they are being singled out and treated differently than other landowners in Sierra Madre.

However, New Urban West wants to be singled out for favorable treatment. They do not want to be subject to the same General Plan policies all of us Sierra Madre residents need to abide by. Instead, NUW wants and is demanding huge exceptions to our General Plan and they want changes to the ordinances that all other builders of single family homes have to follow. They have submitted a Specific Plan that would allow them to completely disregard and bypass critical building parameters and ordinances carefully developed over many years that every other land-owner in Sierra Madre needs to abide by. The Passionist Chicago organization, the single largest landowner in Sierra Madre as owners of Mater Dolorosa, together with New Urban West is pro-posing the single largest housing development in our small city's history. And they believe they should not have to play by the rules of our ordinances and General Plan policies.

Our city and residents deserve so much better. We look forward to the City Council certifying the initiative. Join us in Protecting Sierra Madre.

MATER DOLOROSA CONTINUES TO PROMOTE **MISINFORMATION**

Many residents eagerly awaited the June 14th City Council meeting to hear council members discuss the citizen's petition to put an initiative on the November ballot. The City Clerk, Laura Aguilar, reported that residents were successful in obtaining 1492 signatures and 1300 of them qualified, easily over the

856 required for certification by the county. Congratulations to the residents of Sierra Madre for their efforts to make this happen!

As reported in the Mountain Views News edition of June 11th, the meeting required the council to consider four options:

- Adopt the initiative ordinance; 1.
- Submit the initiative at the November 8th general election; 3.
- Call for a Special Election to be held before Nov 8th; or Direct the city attorney to prepare a report pursuant to Elections

Interestingly, there was no discussion of these options by the council; no questions asked, no pros/cons, no debate. It was all strangely orchestrated - as if they had decided beforehand - and, as expected, City Council unanimously voted to have counsel prepare a report. The report will consider the environmental impacts of both the current proposal and the proposal in the Initiative; the benefits of each, the political/legal aspects of each alternative; the size of the homes; possible legal cost; alternatives; maximum development and SB9 lot splits and ADU's. This monumental undertaking must be completed in 30 days and will add to the already existing 6,000+ pages of reports already completed.

During Open Comments, a number of Mater Dolorosa Board of Directors and staff (majority not Sierra Madre residents) were compelled to attend and speak repetitively on the same points. 'How they are saddened and hurting' by residents opposed to their housing project. How the project is just a 'tiny amount of homes'. How the council needs to 'educate' the citizens about the project. How opposing this housing project will 'prevent the Passionists from spreading their vision around the world.

As one of the Passionist speakers stated, 'we all know the priests are seeking income to continue their mission and they will be looking for ways to monetize their property. They have been doing this successfully for many years. Their CEO stated that they are fully booked for retreats and conferences until May of 2023. The Retreat Center has almost 90 single and double rooms plus conference rooms, a library, breakout rooms, a Chapel and a kitchen capable of feeding over 100 guests 3 meals a day. They provide accommodations at a quoted cost of \$160 per night, per person plus cost of meals. The latest Dun and Bradstreet report shows that the Mater Dolorosa Passionist Retreat Center reported \$2.43 million in annual sales from conferences and retreats. No one wants to deny Mater Dolorosa the right to make money to fund their ministry. They already receive special treatment by not paying taxes and now they want even more special treatment.

It seems that Mater Dolorosa is never happy. As New Urban West pointed out in their marketing material, this property was zoned residential for years and Mater Dolorosa chose not to pursue housing. Under its present institutional zoning, Mater Dolorosa can expand the Retreat Center or build an additional religious institution to expand their ministry. But they have chosen not to do that - they have chosen instead to build an oversized 42 unit tract housing development with no religious purpose.

Our zoning laws are not subject to the whims and fancies of individual community members that can't seem to make up their mind. They are the collective wisdom of years of hard work to create a shared vision. Requesting a change is not automatic because you have lived here for many years and believe yourself to be a good neighbour. It requires careful scrutiny and review by the City Council and Planning Commission as well as the residents living in the community and those impacted by the change.

Mater Dolorosa misjudged the people of Sierra Madre and their willingness to blindly support a project that is so wrong for our community on so many levels. It is sad that the Passionists wish to celebrate their illustrious and proud 100 year history and legacy in Sierra Madre by imposing an 'out of touch,' over-sized, unsuitable, cookie cutter housing project on the community and then acting offended and persecuted when citizens ask for a better project.

HELP PROTECT THE FIRST AMENDMENT RIGHTS OF THE PASSIONISTS

As a long-time supporter of the Passionist Community in Sierra Madre, I've attended many retreats at Mater Dolorosa Passionist Retreat Center over the last 25 years. I was a member of their first Board of Directors in 2003 and was involved as a lay person in the restructuring of the Holy Cross Province of the Passionist Congregation which includes Retreat Centers in the Midwest, the South, and the Western United States. As an attorney I've advised our local Passionists on past legal issues and helped them evaluate different uses for their property in Sierra Madre.

I am also a member of the Sierra Madre Neighbors for Fairness Steering Committee and represent the interests of the Passionists. As a grassroots organization, the Steering Committee is made up entirely of Sierra Madre residents and neighbors (my husband and I are the only two that live just across the border in Arcadia, although we spend nearly every weekend in Sierra Madre patronizing the local shops and restaurants).

At Thursday's City Council meeting I commented that we are not "financed" by New Urban West. To clarify, we have partnered with the developer to help protect the rights of the Passionists and we do receive financial help from them in service to this one goal. Nonetheless, we also receive financial support from other interested parties. We certainly do not work for New Urban West and they do not tell us what to do.

Our goal is to support the Monastery in its ability to exercise its freedom of religion. We do this by helping the voters of Sierra Madre understand the consequences of the proposed Initiative, including how it will violate the rights of the Passionists and put the City at serious risk of being sued for religious discrimination, among other things.

RLUIPA, the Religious Land Use and Institutionalized Persons Act of 2000, provides religious institutions with protection from overly restrictive down-zoning. The Act states that "No government shall impose or implement a land use regulation in a manner that imposes a substantial burden on the religious exercise of a ... religious institution, unless the government can demonstrate that imposition ... is in fur-therance of a compelling governmental interest; and is the least restrictive means of

furthering that compelling governmental interest."

The proposed Initiative states that its purpose is to change the Retreat Center to a "nonconforming" use by prohibiting all future "expansion, significant physical alteration, or change in use" and that the compelling government interest is to "ensure that any future development is protective of the City's hillside environment"

Applying the standards of RLUIPA, the compelling government interest of protecting the "hillside envi-ronment" has not been justified. Expansion not in the hillside areas, or alterations within the Monas-tery buildings, do not risk the hillside environment. Not even the EIR for the proposed Meadows at Bailey Canyon development found any significant environmental impacts to the hillside environment, and that is when adding just 42 homes to the property - less than one percent of the residences in Si-erra Madre. There is no compelling government interest that justifies prohibiting all expansion, alteration, or change in use for a religious organization that has been operating its ministry here for close to 100 years.

Even if there were a compelling government interest, the "least restrictive" prong cannot possibly be defended. There are many less restrictive options available to protect the hillside environment. Turn-ing a religious Institution into a nonconforming use, while prohibiting all future expansion, alteration, or change in use, is extremely burdensome on the Passionists and a gross overreach of the City's zon-ing authority.

Moreover, there is a strong argument that the proposed Initiative raises the specter of religious dis-crimination based on the targeting of the Passionists, in particular, by "spot-zoning" in contravention of state regulations. If the Initiative passes and the City gets sued, they - and, more particularly, its resi-dents - could face hundreds of thousands of dollars in legal fees and other penalties.

Please support the Passionists as Sierra Madre Neighbors for Fairness fights to protect their religious freedoms under the First Amendment.

ON THE PROPOSED INITIATIVE TO DOWNZONE THE ENTIRE MATER DOLOROSA PROPERTY

The following statement was addressed to the City Council at its June 14 meeting by Dr. Michael Cunningham, OFS, Mater Dolorosa Passionist Retreat Center Director and CEO.

As expressed in a letter from our attorney and verbally to the Sierra Madre City Council last week, Mater Dolorosa would be greatly harmed if this initiative is successful. Unfortunately, I also can say that damage has already been done through considerable miscommunication of information about us, our development plans, and the status of our ministry.

Mater Dolorosa has served Sierra Madre, the San Gabriel Valley, greater Los Angeles, and Southern California with spiritual and healing ministries since 1924. Since then, the ministry has been evolving, expanding, and responding to the signs of the times.

Imagine if this restriction arrived earlier in our history. Imagine that the soldiers returning from the Second World War were not welcomed at our Retreat Center because we had been unable to build it due to such an initiative. Imagine if all the thousands of people in recovery programs had not been able to come to this sacred place. Imagine if the 15,000 visitors who grace our gardens and retreat center during a typical year were suddenly not welcome.

Now, imagine a time in the future when we, and all those who want to visit Mater Dolorosa, for whatever reason, are not able to because we cannot add additional rooms, build improved facilities for our Food Ministry, or provide more meeting space for recovery groups and those with trouble in their lives. This is the future which this initiative beckons for us.

Living in Sierra Madre is an expensive proposition. Imagine a time when we cannot provide staff accommodation for

our employees because the initiative does not allow it. Even though we own the land and the ministry, we cannot offer it if we cannot plan and expand.

This is not the future we have imagined for ourselves and not a future that anyone else would want. Imagine if building restrictions were made on land you owned, fully paid for, where you are operating city services that individuals can enjoy regardless of their financial means, and suddenly all growth stopped

Even short-term improvements in our plans are affected. For example, we have been working on a solar plan for two years and are nearing the end of the planning and funding phase. Will we be able to get permission for solar to provide a cleaner environment? I don't know.

Despite all this, Mater Dolorosa's ministry is alive and well today. We are fully booked for retreats, conferences, and recovery ministry activities until May 2023. Will we be able to meet expanded demand in the future, as we have in the past? If this initiative passes, then the answer will be "No."

The unfairness of the initiative has been communicated by others and by our letter to the City Council. I ask the council members to consider the implications of this initiative carefully before a ministry that has provided services to this community and the surrounding area becomes what the proponents want: To be frozen in time, and unable to respond to the needs of those around us.

Hopefully, anyone considering voting for this initiative will consider prayerfully what this will do to our ministry. The initiative has little to do with the proposed property development and its progress through the approval process. Instead, it is about removing Mater Dolorosa's rights to operate and grow a vital and flourishing ministry that thousands of Californians rely on.

SORRY, BUT IF YOU SUPPORT THE INITIATIVE YOU ARE NO FRIEND OF THE PASSIONISTS.

You may hear the proponents of the initiative saying that "opposing the project is not religious discrimination." Well, don't you think that depends on how you are opposing the project? There are no two ways about it. Supporting the Initiative, which will take away the fundamental Institutional rights of the Passionists, means you are supporting religious discrimination. The initiative singles out the Retreat Center and will prohibit all future expansion or alteration of the existing buildings. If you support this egregious violation then you are no friend of the Passionists, no matter how honorable you think your intentions are.

You can both oppose the housing project and support the Passionists, but you can't do both while also taking away the Passionists' fundamental rights as a religious institution. Sierra Madre Neighbors for Fairness is opposing the discriminatory initiative. We are also neutral on the Meadows housing project. We are often called a "mouthpiece for the developer," but if that were the case then we would be fighting for the project itself.

The SMNFF Steering Committee solely decides what our strategy is. We have a similar goal with the developer of protecting the rights of the Passionists because they, too, do not want to see the Passionists harmed. We have partnered with the developer in defending the Pas-sionists from illegal discrimination and we welcome their support.

Under the federal Religious Land Use and Institutionalized Persons Act any overly restrictive down-zoning of a religious institution is illegal unless it is the least restrictive means of accomplishing the goal (in this case) of protecting the hillsides. Prohibiting all physical expansion, alteration, or change in use under the guise of protecting the hillside environment is a blatant violation of RLU-IPA and puts the city in serious financial jeopardy.

The initiative clearly states that the Retreat Center will be forced to become a "nonconforming use" "without expansion, significant physical alteration, or change in use." The Initiative states that the Monastery buildings will fall under "the provisions of the Sierra Madre Municipal Code relating to non-conforming use." Municipal code section 17.56.040 states that "Each and every nonconforming use or structure may be continued and maintained, provided that there is no addition, alteration, or en-largement to any use or structure..." If the Passionists do any alteration or expansion or have a change in use then under 17.56.060 A. the city will be forced to "terminate" their nonconforming use and start the "abatement" process.

We encourage those who oppose the religious discrimination of the Passionists to show your support by putting a "Support the Monastery" sign in your yard. This especially applies to those who have a yard sign saying they want to preserve or protect Sierra Madre. These are not two mutually exclusive ideas. Birthdays seem to be happening just about every day lately and they are all significant. In our family, many are celebrations of the lives of folks who have graduated from here to heaven.

Flag Day, June 14th, for instance, was my father-in-law's birthday. He would have been 129.

My memories of him and my mother-in-law are so good that I want to share a little bit of them. He was a life-long member of the Gideons and must have given out thousands of little New Tes-taments in his lifetime. During WWII he was down at Union Station as young soldiers left Los Angeles to go to war; handing out New Testaments, shaking their hands, encouraging them, praying for them. They lived, Jay and Leila Davis, all their lives together in the home that Leila's father bought on Van Ness Avenue in Los Angeles when she and her family first moved here from Idaho when she was 14. John and I were married fifty years and his birthdays became more and more interesting as time went on because he made it very clear he didn't want any more stuff. As far as the children were concerned, what he wanted was for them to arrange something for them to do together. He went to air shows with Leah, helped son, John, remodel a house, went on an outing to an aircraft carri-er with Patti and grandson, Blake. We flew to Texas to celebrate birthdays with Crissy and Chris, had innumerable dinners, lunches, breakfasts to celebrate and all my memories of his birthdays involve lots of laughter, flocks of family, good times and good food.

We took a hot air balloon ride to celebrate his 40th birthday, had a belly dancer and the party of the century at our house on Alegria for his 50th. Yep, friends and neighbors, epic good times. In-terestingly, when I opened Sarah Young's devotional book, "Jesus Calling," today, the reading was really about him and his character, ending with his life verse, Micah 6:8: "He has shown you, O man, what is good. And what does the Lord require of you? To act justly and to have mercy and to walk humbly with your God." That was pretty much how John lived. Happy birthday my one and only love!

My son-in-law, Christopher's, birthday was June 8th. The picture today is of the amazing piece of art his daughter, Emily, who is 11, created for him to celebrate his birthday and Father's Day. I just love this... "you are the rarest of them all!" We took him to the movies to see "Top Gun" and to dinner at Red Lobster. A great time was had by all and we absolutely loved "Top Gun Maver-ick." Tom Cruise looks amazing. He's 60! And still doing all his own stunt work. Val Kilmer hasn't aged nearly as well and I understand he has throat cancer. Everybody I know says this is the best movie ever, and I have to agree with them. If you haven't gone, take your Dad!

The flying is incredible and all the time I was thinking how much John would have enjoyed see-ing it. He was a pilot and we spent so many hours together flying various Cessna 172s. I looked at his log book and his last entry showed his hours at 560.1 in 2004. We made so many trips to Goleta to eat Jambalaya at the Cajun Kitchen. To Oakland to visit family there, and so many oth-er places. He got his instrument rating when we couldn't get out of Oakland due to the dense fog there. Good times! Made me think of the WWII-era sonnet, written by a 19-year-old American airman who had volunteered for the Royal Canadian Air Force. The poet, John Gillespie Magee Jr., was killed in action near Great Britain on Dec. 11, 1941. You'll remember President Reagan quoted a portion of this sonnet after the space shuttle disaster in 1991...

High, Flight
Oh, I have slipped the surly bonds of earth,
And danced the skies on laughter-silvered wings;
Sunward I've climbed and joined the tumbling mirth
Of sun-split clouds--and done a hundred things
You have not dreamed of--wheeled and soared and swung





Pasadena to Ban Ghost **Gun Kits**



The Pasadena city council is set Monday to discus an ordinance that would make it a crime in the city to possess firearms known as ghost guns and ghost gun kits.

According to city staff the new ordinance, if passed, would close a loophole in federal and state law that ghost gun kits themselves are not regulated. Once pieces of the kit are drilled and machined, it becomes a receiver and should be regulated," the city council report reads. "However, the person who assembled the kit will likely fail to register the fully functional firearm."

ghost gun is a homemade gun made from easy-to-get,

unregulated ghost gun kits.

If passed the council could also enhance the penalty for possessing ghost gun violations to one year in the county or city jail and a \$1,000 fine. Currently, the punishment is six months in county jail with a \$500 fine.

The rise of ghost guns is the fastest-growing gun safety problem facing the country, according to city staff. More than 14 percent of the firearms seized by the Pasadena Police Department have been unserialized, untraceable ghost guns in the last year. The number is trending closer to 16 percent for the current year. "Disturbingly, little is known about who sells ghost guns, who buys them, and how much they are used in crime," they said.

The report alos states that law enforcement officers are recovering increasing numbers of homemade, unserialized guns from people who are legally prohibited from having guns. "It is easier and cheaper than ever for anyone to make guns. With do-it-yourself kit ordered online and some commonly available tools, a novice can make their pistol, like a Glock 19, or an assaultstyle rifle, like an AR-15 or AK-47, in just a few hours. The number of ghost gun sellers offering gun-making kits with all parts needed at discount prices is exploding."

Call the Pasadena Police

Department at (626) 744-4241 to request a police officer to respond to, or surrender, a weapon. Gun registration is not necessary to voluntarily surrender a firearm.

HOW TO CHOOSE A MEDICARE SUPPLEMENTAL (MEDIGAP) POLICY

Dear Savvy Senior:

I'm planning to enroll in original Medicare in a few months and have been told I probably need to get a Medicare supplemental policy too. Can you offer any tips on selecting one? Almost 65

Dear Almost:

If you're enrolling in original Medicare, getting a supplemental policy (also known as Medigap insurance) too is a smart idea because it will help pay for things that aren't covered by Medicare like copayments, coinsurance and the Part A deductible. Here are some tips to help you choose an appropriate plan.

Medigap Plans

In all but three states (Massachusetts, Minnesota, and Wisconsin), Medigap plans, which are sold by private health insurers, are available to new enrollees in eight different standardized plans. These plans are labeled with the letters A, B, D, G, K, L, M and N, with two more, C and F, that are only available to those eligible for Medicare before 2020.

Plan G is the most popular policy among new enrollees because it covers the most comprehensive range of benefits. Monthly premiums for Plan G typically range between \$100 and \$300, depending on your age and the state you reside in. If that's more than you're willing to pay, there are also high-deductible plans that have lower

premiums but impose higher out-of-pocket costs.

For more information on the different types of plans and coverage details, including Medigap options in Massachusetts, Minnesota, and Wisconsin, go to Medicare. gov/publications and type in "choosing a medigap policy" in the Keyword box, and download their 2022 guide. Or call 1-800-MEDICARE and ask them to mail you a

How to Choose

To pick a Medigap policy that works best for you, consider your health, family medical history and your budget. The differences among plans can be small and rather confusing.

To help you choose, visit Medicare.gov/medigap-sup-plemental-insurance-plans and type in your ZIP code. This will give you a list of the plans available in your area, their price ranges and the names, and contact information of companies that sell them. But to get specific pricing information, you'll need to contact the carriers directly or call your State Health Insurance Assistance Program. See ShipHelp.org or call 877-839-2675 for con-



tact information.

Since all Medigap policies with the same letter must cover the exact same benefits (it's required by law), you should shop for the cheapest policy.

You'll get the best price if you sign up within six months after enrolling in Medicare Part B. During this openenrollment period, an insurer cannot refuse to sell you a

policy or charge you more because of your health.
You also need to be aware of the pricing methods, which will affect your costs. Medigap policies are usually sold as either: "community-rated" where everyone in an area is charged the same premium regardless of age; "issueage-rated" that is based on your age when you buy the policy, but will only increase due to inflation, not age; and "attained-age-rated," that starts premiums low but increases as you age. Community-rate and issue-agerated policies are the best options because they will save you money in the long run.

You can buy the plan directly from an insurance company, or you can work with a reputable insurance broker.

Drug Coverage

You also need to know that Medigap policies do not cover prescription drugs, so if you don't have drug coverage, you'll need to buy a separate Medicare Part D drug plan too. See Medicare.gov/plan-compare to compare plans. Also note that Medigap plans do not cover vision, dental care, hearing aids or long-term care.

Alternative Option

Instead of getting original Medicare, plus a Medigap policy and a separate Part D drug plan, you could sign up for a Medicare Advantage plan (see medicare.gov/ plan-compare) that provides all-in-one coverage. These plans, which are sold by insurance companies, are generally available through ĤMOs and PPOs that require you to get your care within a network of doctors.

FAMILY MATTERS

IF YOU'VE BEEN ASKED TO SERVE AS A TRUSTEE, HERE'S WHAT YOU SHOULD KNOW

If a family member or friend has asked you to serve as trustee for their trust either during their life, or upon their death, it's a big honor—this means they consider you among the most honest, reliable, and respon-

sible people they know.

That said, serving as a trustee is not only a great honor, but also a major responsibility, and the role is definitely not for everyone. Serving as a trustee entails a broad array of duties, and you are both ethically and legally required to properly execute those duties, or you could face liability for not doing so.

In the end, your responsibility as a trustee will vary greatly depending on the size of the estate, the type of assets covered by the trust, how many beneficiaries there are, and the trust's terms. Considering this, you should carefully review the specifics of the trust you would be managing before making your decision to serve.

Remember, you don't have to take the job. That said, depending on who nominated you, declining to serve may not be an easy or practical option. On the other hand, you might enjoy the opportunity to serve, so long as you understand what's expected of you.

Here I'll give you a brief overview of what serving as a trustee typically entails. For help in making your decision, it may be beneficial in having an estate planning lawyer review the trust first, so he or she can detail exactly what that specific trust would require of you. And as we'll discuss more below, if you do accept, a qualified lawyer can also help you carry out your responsibilities, so you won't have to handle things all by yourself.

A Trustee's Primary Duties

Although every trust is different, serving as trustee comes with a few core requirements. These duties primarily involve accounting for, managing, and distributing the trust's assets to its named beneficiaries, as a fiduciary.

As a fiduciary, you have the power to act on behalf of the trust's creator and beneficiaries, always putting their interests above your own. In fact, you have a legal obligation to act in a trustworthy and honest manner, while providing the highest standard of care in executing your duties.

This means you are legally required to properly manage the trust and its assets in the best interest of all the named beneficiaries. And if you fail to abide by your duties as a fiduciary, you could face legal liability.

But regardless of the trust or the assets it holds, some of your key responsibilities as trustee include:

Identifying and protecting the trust assets

Determining what the trust requires in terms of management and distribution of the assets Hiring and overseeing an accounting firm to file income and estate taxes for the trust Communicating regularly with beneficiaries

Bringing in the right investment management team to manage the trust assets

WHAT THE WORLD NEEDS TODAY ARE **FATHERS!**

There is much talk today about what's wrong with our society. That list is pretty long, but the most important cause of problems in our culture today is the lack of fathers. So many children grow up without a father in the home. How

I was fortunate enough to know my father. My father passed away a little over 12 years ago. I re-member many things he taught me or at least tried to teach me. One of the most significant things was when I became a teenager, he said, "Son, just because you get a girl

pregnant doesn't mean you're a father.' I didn't quite understand what he was talking about at the time. Years later, I understood what he was talking about.

My father taught me a lot, and most of the things had to do with money. He was very close to his money. Often, he would tell me, "Son, don't pay somebody to do something you can do yourself."

I understand that, but I also understand that, at times, it backfired on him. There were times when he was trying to fix something and made such a mess that he had to hire somebody to fix it, which cost him about three times as much as if we would've hired the person in the first place. He never talked too much about that, but I noticed it several times and probably more times than I noticed.

About a year before he died, he gave me his ring. He told me this ring was worth thousands of dol-lars and wanted me to have it. I was rather happy, but I'm the kind of person that does not like to wear money out in public.

After my father passed away, I took the ring and had it appraised. If this ring is worth thousands of dollars, I was not going to wear it; I would rather have the money and put it in the bank.

After appraising the ring, the person said that at most, it was worth \$100. That was far short of my father's evaluation. Why he believed it was worth thousands of dollars is beyond me. Maybe he was just trying to impress me. I still wear that ring and think of

My parents would come down to Florida as snowbirds every year and stayed not far from where I lived. For the last week of my father's life, I was with him, and most of the time, he was in a coma state. He was in bed and unresponsive.

Then, much to everybody's surprise, he woke up one day as though nothing was wrong with him. He had energy, got up and dressed, and friends came to visit him.

One of the things my father did was talk to me, "Son, I don't want to stay here in Florida. I want to get ready and go back to Pennsylvania. Can you drive me back tomorrow?" We had a long discussion about this, and I cheerfully said, "Oh, dad, of course, I'd be

happy to drive you home tomorrow." One of his friends overheard our conversation. Towards the end of the day, he took me

out to the garage and had a rather straightforward conversation with me. 'Do you know how serious your father is? Do you know that he could never last that

trip home?" He then proceeded to tell me that as a son, I needed to be more considerate of my father's health. I should never jeopardize his health, and I should never agree take him home.

That was too danger-ous, according to my father's friend. When he was done ranting about all this and quieted down, I explained what was going

"I know how sick my father is," I said as seriously as possible. "I know that my father will not last more than a couple of days, and I do not want my last conversation with my father to be a vicious argument. Whatever he wants now, I am willing to go along with." My father's friend looked at me and said, "I'm so sorry. I never thought of it like that." Pausing for a few moments, he said, "You are absolutely right to make your father happy in the last moments of his life. You are a good son."

We conversed for a few more moments, and then he went in to say goodbye to my father and went home.

The rest of that night, my father and I talked about how we would travel back home to Pennsylva-nia tomorrow. Whatever he said, I enthusiastically agreed, and we had a wonderful conversation.

The next day my father went back into that coma, and the following day he passed away. I was so glad I had that conversation with my father before he passed away. A good son is a result of a good father. Although my father was not perfect, I learned a lot of life lessons from him and I'm only now beginning to appreciate all that he taught me.

Thinking about this I was reminded of a very special verse of Scripture. "The father of the right-eous will greatly rejoice, And he who sires [gives birth] a wise son will be glad in him" (Proverbs 23:24).

My goal in life is to be a reflection of my father to my children and grandchildren and all the peo-ple around me.

THE BURMESE HARP – a movie review

I recently sat spell-bound for nearly two hours, watching the emotionallyriveting film, The Burmese Harp, produced in 1956 in black and white.

The movie follows a company of Japanese soldiers, stationed in Burma, following the surrender of Japan. The captain of this company, Inouye, had been drafted out of music school, and regularly led the soldiers in song. This group of singing soldiers is depicted as different, healthier, and happier because they sing so frequently. One soldier, Mizushima Yasuhiko, often plays his harp to accompany the singing.

When news of the surrender is received, the soldiers are exuberant, and begin prepara-tions to depart within a few weeks or so.

Mizushima is also the company scout, because he could be mistaken for Bur-mese. Another group of soldiers is hiding out in a cave, refusing to surrender, and so Mi-zushima is sent to convince them to surrender. They angrily tell Mizushima that they will never surrender, that they would rather die than surrender. [Historical fact: The last two Japanese soldier holdouts from WWII were captured in 1978!].

Mizushima fails in his task, and the cave is bombed by the British, apparently killing everyone. Mizushima's company assume that Mizushima is dead, and they make plans to move along to an eventual camp where they will be taken back to Japan.

The story then tracks Mizushima, who although wounded, was not killed. He was healed and brought back to health by a Buddhist monk. Though Mizushima could have returned to his company, he was overcome with grief for all the dead soldiers still in Burma. He set about burning and burying the dead, the anguish and terror of war having changed him permanently. At some point, he becomes a monk.

When I watched the unfolding plot of this story, told through two different perspectives, I wondered why so few people have heard of this masterpiece. It was actually the 27th film by 41-year-old Japanese film-maker Ichikawa, and apparently his most famous. It is a hauntingly compelling movie that draws you along in its story and vistas, very much as you'd expect in a classic Kurasawa movie.

Filmed in 1956, there were still Japanese at that time who believed that Japan should not have surrendered, and that it had been wrong for their government to surrender. And though the movie has been described as an "anti-war" movie, that description seems to miss the point.

War seems inevitable in human life. Yet, when everyone is drawn up into various con-flicts, there are endless choices that can be made, for better or worse. Inouye led his sol-diers in song, that lifted their spirits. And Mizushima, after his near-death experience, de-cided he would no longer be a soldier, but remained in Burma as a monk, burying the dead, and perhaps contemplating returning to Japan one day.

The movie was based on a novel by Takeyama, written in 1946, and the movie largely sticks to the book. One early critic of the Burmese Harp movie suggested that the movie whitewashed the atrocities of Japan in Burma in WWII. This is probably an unwarranted criticism, since the movie accurately depicts the appalling cost of human life in war, and more importantly, that there is always an alternative to the militaristic spirit. The fact that Mizushima could change from a Japanese soldier to a monk under such dire conditions is where the movie gives us all hope.

The Burmese Harp is strongly recommended, and I give it my highest rating.





JOE Guzzardi REMEMBERING A PERFECT GAME ON FATHER'S DAY



On Father's Day, 1964, Philadelphia Phillies' right-hander Jim Bunning pitched a perfect game against the New York Mets in Shea Stadium.

Bunning's two-hour, 10-minute masterpiece – 90 pitches, 10 strike outs – during a double-header's first game had special significance. At the time, Bunning and his wife, Mary Theis, had seven children. Eventually, the Bunnings, married 60 years, would have nine children, 35 grandchildren and seven great-grandchildren.

Few in baseball history have lived as rewarding a life as Bunning, who represented Kentucky as a U.S. representative from 1987 to 1999, and then as a two-term U.S. senator from 1999 until 2011. Bunning's baseball achievements put him in the Hall of Fame. Along the way, Bunning racked up 224 wins, 2,855 strike outs and was chosen to participate in nine All-Star Games. The fire-balling righty led the league in strike outs three times, and when he retired Bunning ranked second among all-time strikeout leaders behind Walter Johnson of the Washington Senators.

In 1955, Bunning debuted with the Detroit Tigers, and in 1958, he threw a 3-0 no-hitter against the Boston Red Sox. Bunning was then traded to the Phillies, his second stop in a career that also included brief stints with the Pittsburgh Pirates and the Los Angeles Dodgers.

Long after Bunning hung up his glove, he recalled in detail how he set down 27 consecutive Mets, the first National League perfect game since 1880. After attending Mass at St. Patrick's Cathedral, and eating a hearty sausage and egg breakfast, Bunning headed out to Shea Stadium, where the temperature and humidity would hit 90 by game time. Although Bunning said that he felt no better or no worse than usual as he warmed up, Phillies' manager Gene Mauch disagreed. Mauch told Sport Magazine's Larry Merchant, "We knew when he [Bunning] was warming up that this was something special. The way he was throwing so live and as high as he was. Not high with his pitches. High himself."

For nine innings, Bunning was so relaxed that he rejected the long-standing baseball tradition which forbade pitchers to talk to teammates about no hitters in progress – considered a jinx. "Dive for the ball," Bun-ning laughingly told his infielders. "Don't let anything fall in."

With one out in the bottom of the ninth, Bunning called catcher Gus Tri-andos to the mound and asked him to tell him a joke. Triandos shook his head in dismay and went back behind the plate. Bunning then struck out the last two Mets and pounded his glove as his teammates rushed to share his joy in his 6-0 win.

Bunning's was the fifth perfect game in major-league history and the first in the regular season since the Chicago White Sox Charlie Robertson blanked the Detroit Tigers, 2-0. Later, Bunning said about his flawless performance: "Everything has to come together, good control, outstanding plays from your teammates, a whole lot of good fortune on your side and a lot of bad luck for the other guys. A million things could go wrong, but on this one particular day of your life none of them do."

But when Bunning looked back at his 1964 season, disappointment super-seded his perfect game's thrills. By September 20, the Phillies led by 6½-games with 12 to play. But then the wheels fell off. The Phils lost ten in a row; Bunning, overworked by Mauch, was charged with three losses. The St. Louis Cardinals eked out the pennant by a game over the Phils and the Cincinnati Reds.

Before he died at age 85, Bunning said, "I am most proud of the fact I went through nearly 11 years without missing a start. They wrote my name down, and I went to the post." In today's era, Bunning's consistency would be a marvel.

During the time my son and I shopped my daughter hurriedly prepared some legal papers which had to be filed in the morning. I wished I could be of more help.

Yesterday, I called to just see how she was doing and she had some good news. She had been working on this one case pro bono (that means without receiving any money) for about four years putting in about one hundred fifty hours. Earlier on Tuesday she received the news that the Biden administration had loosened a terrorism-related related exemption that would arguably allow her client to return to the United States and rejoin his family and resume his life. It's true the facts are complicated and I really don't understand very much but in connection with the Presidential action my daughter was interviewed by the Los Angeles Times and that interview would be described in today's LA Times. Hooray; I could hardly wait for the morning to go to Happy's Liquor Store to buy a paper.


At eight o'clock there were only a few papers on the stand. I was going to buy a number of papers and place the page with her interview on the wall. First I thought it best to find out the price of an individual daily paper. To my surprise the cost was over four dollars, the same price as the Sunday paper. I couldn't believe it and asked the man behind the counter for an explanation. He explained to me that hardly anybody ever reads the paper anymore as everyone got their news from Social Media or television. As I looked through the thin paper and found the interview with my daughter on page four my elation diminished. The article containing the news about my daughter was exciting and quoted her as saying "I'm going to cry", she said, "this is morally right and politically right". Still, as I looked at the paper, I felt like I had lost an old friend. The paper was so small and did not even contain a separate Sports Section.

I was an early reader as my immigrant grandmother and I learned to read English together before I went to Elementary School. Later in life I would read the paper aloud to my father who had lost his vision and we would talk about it. Today more than sixty years later, my two year old, almost three year old grand-daughter can now play a game in which I pick out a scrabble piece and she looks at it, thinks for a while and names the letter. I ask her to name a word that starts with that letter and she generally produces a correct word. She likes to orally pronounce the letters on license plates and my wife told me that a couple of people attempted to give her a five dollar bill in appreciation of her ability. My wife didn't want to accept the money but the people said to "keep the bill for her college fund".

College is a long way off but for now I am displaying the bill on my dresser next to an article written by my father eighty years ago during the depression. There is a connection between the willingness and the ability to read, write and reflect. It is perhaps a necessary part of a responsible and caring life. It's hard to explain but I hope you and my granddaughter after I am gone will understand that I was doing my best to point her in what I think to be the right direction.

Maybe all I am saying is that it is better to pick up a book rather than a gun, or a video game and one person, or a whole society, will be rewarded for that decision.



SHANNON TAVERA OF ST. RITA SCHOOL NAMED CYO COACH OF THE YEAR




