
SIERRA MADRE LOSES **ANOTHER LONGTIME VOLUNTEER**

GERALD BRYAN CARLTON March 22, 1932 - June 8, 2022

Jerry Carlton died at home in Sierra Madre on June 8, 2022, after enjoying one last Dodgers win with his family.

Jerry was born Upland, California, to Gladys Irene Gray and Gary Brennan Carlton. The family moved Arcadia when Jerry was 6 years old.

After finishing his tour of duty with the US Navy, he moved to Sierra Madre with his wife Nan Carlton.



Jerry attended First Avenue Elementary School and Monrovia Arcadia Duarte High School (commonly referred to MAD high school by alumni). Jerry served in the US Navy from 1950 to 1954, receiving an honorable discharge. Jerry attended Cal Poly Pomona for two years. He worked in manufacturing for his entire career with long stints at Carlson Rules and Lockheed.

Jerry married Nan Hatheway on February 12, 1953, and they resided in Sierra Madre for the rest of their lives. They had three kids by 1957: Steve, Sheri, and Suzi. In 1960 they all moved to the Adams Street house where Jerry lived for the next 62 years. In the early 1960s Nan's young siblings Bert, Jesse, and Maggie moved in, and Jerry and Nan raised them through high school. Bert, Jesse, and Maggie remained close to and important to Steve, Sheri and Suzi; they were essentially three more siblings.

Jerry and Nan volunteered for many community groups, and often volunteered together. They taught Sunday school and ran the church youth group when their kids were young. Jerry's volunteer career started with youth issues and continued into other areas. He was active in the Little League, Girls Softball, and the Sierra Madre Athletic Association. Jerry with Nan were founders and first managers of Girls Softball. Jerry and Nan started the league with other parents because in those days the girls were not allowed to play in Little League, and Sheri and Suzi needed an outlet for their baseball skills. Baseball was a lifelong passion for Jerry, and he loved the LA Dodgers.

Jerry worked with the Sierra Madre Rose Float Association. His kids pasted many a flower on the floats. Jerry was a longtime volunteer for the Friends of the Sierra Madre Library. The family were big readers, and Jerry saw the importance of supporting his local

Jerry and Nan were also interested in the environment around them; both were early members of the Sierra Madre Environmental Action Council, which started the Recycling Center. In addition, Jerry and Nan were actively involved with the Mt. Wilson Trail Race for many years.

Jerry and Nan's community commitment was recognized by the City of Sierra Madre and the Los Angeles County Board of Supervisors in 2012 when they were honored as Older Americans of the Year.

He is survived by his son Steve Carlton (wife Laurie) of Nevada City, California; his daughter Suzi Stretton of Sierra Madre; grandkids Amanda Burnett Sosa (husband Manny), Mike Stretton, Liz Carlton, and Wyn Carlton; great-grandson Hunter Sosa; sister-in-law Maggie Clements; family members Bob Burnett and Michael Stretton; and close friends and



DISTURBING FACTS FROM THE LAST PLANNING COMMISSION MEETING

On the surface, the June 16 Planning Commission meeting may not have had the impact to our residents as the massive Mater Dolorosa project. However, there were several disturbing issues to emerge.

Once again there was no City Council liaison at the meeting, neither liaison Kriebs, nor her backup if she once again was unable to attend in person. City Council was given a petition signed by a significant number of residents in a short period of time. The City attorney will prepare a report regarding the petition within a 30 day period, in other words to be brought before the Council at the July 12 meeting. This is the most significant occurrence to affect our city since any of the Council Members was sworn in to serve and protect our City.

Acting Planning Commission Chair Tom Denison commented at their meeting on June 16 that the City Council liaison was not there to give them a report. Our Planning Commission has been working diligently, asking significant questions of New Urban West's representative Jonathan Frankel, studying the vaguely worded Specific Plan, and doing the due diligence necessary for a project of this size. Council member Kriebs in her report to the Council as liaison said she had watched the meeting remotely, but she didn't know when the next time the Meadows project would go before the Commission. How is that possible if she was watching the entire meeting?

The Agenda item at the Commission's June 16 meeting was the appeal of a staff decision to allow a 1425 sq ft house to add on, including an ADU, to reach a total of 3762 sq ft on a 9900 sq ft lot, increasing the height 32 feet, over the 25 foot limit, and adding a rooftop deck that would look directly into the neighbor's backyard. Neighbor Colin Barr, who filed the appeal, and did a thorough research job, said the median square footage of the homes in the neighborhood is 1847, and the average is 2066, so nearly double the average. Not only does this affect the neighbors within a 300 ft radius, but don't the requested variances have a familiar ring to them, a la The Meadows oversized houses, on postage stamp lots?

The three Planning Commissioners (two were absent) did their usual thorough job of asking relevant questions, analyzing what was before them and their options. As just described, not only does this impact the immediate neighbors, but also seems ironically like a 1/42nd version of The Meadows. Yet there was no Council liaison present to report to the next City Council meeting. Very disappointing!

Interestingly, this appeal presented a dilemma for the Planning Director, City lawyer, and Planning Commission, created by the most recent City Council:

The three Commissioners agreed that as is, the massing is too big, and they'd like to see adjustments, how to do that though? Not only did the previous Council reduce the size of the Commission from 7 to 5, but they also took away the design review standards and gave Staff that authority.

The dilemma: If the applicant agrees to some changes, where does the application go – Planning Commission or Planning Department. Or....should the Commission wait until the absent Commissioners can be present to ask questions? After some consultation between the City lawyer and the Planning Director, they told the Commission, who informed the applicant that he could ask for a vote of the three present Commissioners, and if turned down, could appeal to City Council, or withdraw his application, and resubmit it to Staff. Applicant said he would withdraw the application.

MAJOR ISSUES BEFORE CITY COUNCIL

The last City Council meeting was disturbing on several levels. The petition to put the Mater Dolorosa property into the Hillside Management Zone, instead of Institutional, as it is currently zoned was presented. 1492 residents, representing every corner of Sierra Madre, signed the petition; 1300 signatures were certified. The four options of what to do within the re-

quired time frame were agendized: 1. Adopt the initiative ordinance; 2. Submit the initiative at the November 8 general election; 3. Call for a special election to be held before November 8; 4. Direct the City Attorney to prepare a report, to be reviewed within 30 days.

As stated in last week's column – there were 17 speakers during Public Comment. Of the 14 pro-New Urban West development, nearly all were Mater Dolorosa Board Members and employees. Of those 14, 9 threatened legal action.

Ironically, the Chair of our City's Energy, Environmental and Natural Resources Commission (EENOR), a former supervisor for Glendale Water and Power, gave a report, before the discussion of the petition, mainly on our record drought. He quoted experts who are saying they haven't seen anything like this in 40 years, and we need to have meaningful changes, or we will go the way of the dodo bird. Isn't that what the residents have been saying all along? How can building 42 large homes in such a drought be a responsible thing to do?

There was no discussion by the Council about the first three options before they voted for Option #4, as was suggested by many of Mater Dolorosa's Board Members/employees. Did the Council members discuss this behind closed doors, including the threatened lawsuit, as many good Sierra Madre citizens have speculated?

More irony in the comments by the development crowd regardless of environmental costs:

- 1. "This is spot zoning" (a favorite of theirs). "Mater Dolorosa should be treated the same way others are especially their neighbors." This is exactly what the petition is attempting every large property north of Grand View is in the Hillside Management Zone.
- 2. "The City has not had the actual facts." We agree with this one, just not the way Dr Doyle intended. We keep asking City Council to allow experts not paid for by New Urban West developers to speak about the environmental damage.
- 3. "The petition will prohibit meaningful development." The petition is requesting meaningful development by ensuring the large houses comply with the Hillside zoning for lot coverage, not "stack and pack" as one resident had said earlier.
- 4. From Father Bruno "We've always welcomed people on our property." Is that why the gate at the entrance is now often locked? Residents have not been permitted to walk the grounds for over a decade.
- 5. "How will people in other cities feel about a petition signed by signature gatherers who went to the supermarket?" No one gathered signatures in front of a supermarket not even Taylor's, and as we spoke to several people who live in nearby communities, most said they wished they could vote in Sierra Madre, to vote for the petition.
- 6. "The properties abutting the Monastery are zoned R-1, not to do that would be spot zoning." Developer Representative Frankel said several times that the Meadows project is not R-1.

Just as disturbing, if not more so, was the lack of discussion on a \$31 Million budget. City Clerk Laura Aguilar had said that this discussion may take two sessions. It did take half an hour, and the Council members asked relevant questions. Council members did not ask any hard-hitting questions regarding the budget. There were no concerns about inflation or increasing expenses. There was a time when the budget and strategic planning were discussed in a Town Hall type forum, with community input. Instead, Mayor Goss said, "You've given us a lot of data to crunch. Thankfully we've done so before the meeting." We'd like to know if the numbers crunching was done individually or behind closed doors? There was no public comment.

City Manager Jose Reynoso has informed us that there will be a water report on the City website by June 24. The next Planning Commission meeting regarding The Meadows project will be July 7, 7 pm. City Council will be receiving a report on the ramifications of the petition by the City Attorney on July 12, 5:30 pm. Please plan to attend both.

FIGHTING THE SPECIFIC PLAN ON THE MONASTERY DEVELOPMENT.

I was one of the volunteers who sought the signatures, and it was quite an experience. I am a resident and I am not anti-Catholic or anti-Development but I am Anti-New Urban West. About 80 % of the residents could not wait to sign the petition, and they were from all over Sierra Madre, not just the streets that will be drastically

affected. 20% did not want to sign the petition and when asked why they responded in this fashion. Many were Catholic and felt the Catholic Church could do no wrong and would support the Catholic Church, Since the project was to take place on the current monastery property, they would support the project no matter how many problems came with the proposed housing development. Another portion off that 20% said they would

not sign any petition for any reason, Still others felt uncomfortable in signing until they felt like they understood the petition and its language. We patiently tried to help them by taking the time to explain the project, the problems, and the benefits with this housing project. We also told residents they still had until November to find out more information, and where to find the information so they could make up their own mind in November. Their signature only meant it would be placed on the ballot. Lots of misinformation is going on out there, and the Passionists and New Urban West. are responsible for most of it. However, patient discussion educating people one at a time was successful. More education still has to be done to those residents we were unable to reach.

I think the big break for the residents came on June 2 , 2022 at the Sierra Madre Regular Planning Commission Meeting. The meeting can be seen by googling City of Sierra Madre Planning Commission Regular Meeting June 2, 2022 .(it is 3 hour and 44 minutes meeting ,but the last 44 minutes shows the anger the Planning Commissioners felt about this developer and the development. They were being pressured by the developer to send the proposal to the city council and the developer asked them 3 times to send the proposal with their concerns to the council. The Commissioners refused to give into the developers requests.

Earlier in the evening the commission asked the developer to put the size of the proposed homes on their housing pads so they could be compared homes to be built to the those under the general plan. In other words remove the project from the "Specific Plan" and the New Urban West definition of home square footage and the comparison would be based on Sierra Madre standards from the general plan . When the residents and the commissioners found out that all of the 42 lots could have the largest proposed home of 4875 sq feet on lots smaller than those on the #1Carter project the gasp was heard throughout the room. That makes this the densest project ever proposed in Sierra Madre. The Commissioners also realized that if changes were not made now, once the Specific Plan had been accepted there could be no further changes to it. It was and is a legal document. The project will not match the surrounding homes because this will be a cookie cutter development, and will just be huge homes on small lots with new drought tolerant landscaping, but no well-established trees. Those 101 well established trees, including 11 Coastal Oaks will have been bulldozed in order to clear the land to then be developed. The Coastal Oak Trees are protected everywhere in the State of California and in Sierra Madre, except on the Monastery land. Because this project was a 'Specific Plan," the removal of all those trees is allowed because a "Specific Plan" overrides all the city ordinances and statutes if passed by the city council. However, "Mc Mansionization" in Sierra Madre has been successfully fought for years. We shall see what happens at the next Planning Commission Meeting in July.

That is what is now being proposed in Sierra Madre, and the developer presented this to the Planning Commission himself. Watch the video. It is quite revealing.

I want to thank Kevin McGuire for his reporting, keeping us informed what's happening with the "Meadows" project. He explains this current proposal involves "spoiling Mater Dolorosa's future building ambitions for a possible housing development, shrine, expanded retreat area, and gardens or paths." It should be understood, though, that if it were just a matter of that "shrine, expanded retreat area, and gardens or paths", there'd be no petition, no conflict, no threats of costly litigation – just support from our community. It's only the damn "housing development" that's the problem.

Elsewhere in the paper, opposition to the prospect of 42 McMansions on 20 acres of our irreplaceable hillside is described as "religious discrimination". Whether the development was proposed by Tibetan Buddhists or KB Homes, arguments in opposition would remain the same. If their strategy in garnering support from our community is to characterize opponents as religious bigots, they might want to rethink that strategy.

Attorney Angela Hawekotte cites the 2000 Religious Land Use and Institutionalized Persons Act, which prohibits re-zoning with the intent to restrict the "religious exercise" of an institution. I think Sierra Madreans love having the Passionists as our neighbors, applaud the work they do, and understand this work entails significant costs. We also understand this project would make them a ton of money in pursuing this laudable work.

The question then is who is to bear the costs. I'm sure the Passionists could provide documentation as to their budget and how this project would help support ongoing activities. But the costs imposed on the rest of us wouldn't necessarily be dollar figures on an Excel spreadsheet – these costs would be significant, ongoing and irreversible – forever affecting what it is we love so much about Sierra Madre. So – I'd give my full support to that "shrine, expanded retreat area, and gardens or paths". But for that obscene housing development proposal, if the best they can do is threaten lawsuits and accuse opponents of religious bigotry, it just shows their tank is out of gas as far as rational argument to justify it – as I see it.

Again and again, I read stories and opinions in the "Mountain Views News" about the Meadows Project at Baily Canyon in Sierra Madre.

I think that there is a either a deliberate attempt to muddy the waters or that those who comment don't fully understand the issue.

At issue is: Should the Passionist monastery be exempted from what applies to others who would want to engage in a similar project or should the Passionist monastery be subjected to terms and conditions that would normally NOT be applied to a similar entity?

WHAT THE LONGEST-LASTING NEIGHBOR OF THE MONASTERY HAS TO SAY

I hit the trifecta of impacts from the proposed Meadows at Bailey Canyon project. My home, which I grew up in and was built in 1948, abuts the Monastery property and will be one of the most affected homes if the Meadows project is approved. I will have to put up with the construction noise and dust. I will be looking at homes where now all I see is the "meadow". Being on a corner, I will also get the increased traffic. If you only listened to the most vocal voices out there then I should be the most upset person in Sierra

But I'm okay with all of this. I've seen many changes on the Monastery property. I grew up with the annual Fiesta where we would have 15,000 people coming up and down our street and 5,000 cars would be parked outside my living room window in the parking lot (aka "the meadow").

I've seen the expansion of the Retreat Center, the old unreinforced Monastery building razed after the earthquake, restrooms built on the Fiesta grounds, and a new garden and patio where the Monastery used to stand. I expect the Mater Dolorosa will continue to grow and adjust as their needs change, and I respect their right to do so.

In 2007, the Passionists created a Master Plan which included selling off a portion of their property for housing. This option had been on the table for 40 years but they didn't feel it was the right time until now. The city knew that the area was ideal for housing so, at the Passionists' request, they left that option open in the 1996 General Plan. That wasn't changed until after the Passionists proposed a housing development.

The Passionists have been good neighbors to me and to Sierra Madre, serving their community for almost 100 years. The property, which is zoned Institutional, would allow them to build a large assisted living facility matching five Kensington's, except three stories tall and with over 500 residents. The Passionists don't want to see large Institutional buildings and neither

You have probably heard talk about the size of the proposed homes. Many of these same people who started the initiative to rezone the property to the Hillside Residential zone wanted an institutional project which could have massive buildings compared to what is currently proposed. We know the size of homes is not their concern because they have no problem with the large three-story retreat center or a new huge assisted living project. But hey, try to build two-story homes and suddenly it is a travesty worthy of stripping the development rights from the Mater Dolorosa.

Let's try to keep this in perspective. The reality is that the proponents of the initiative care about one thing and that is stopping the only project out there. If this project is denied then you can be sure they will be fighting whatever is next, just like happened at One Carter which cost the city hundreds of thousands of dollars in legal fees only to end up with homes still being built up the mountainside.

Those opposing any project don't care about the collateral damage, or if Sierra Madre loses a new park or the net-zero water offsets or the properties placed in conservancy. And worst of all, they have no concern if they discriminate against the Passionists in the process.

Did you know that if the initiative passes and rezones to Hillside Residential, the Passionists could just sell the entire property and build around thirty 6,500 sq. ft. homes plus another thirty 1,200 sq. ft. homes and no one can stop them? Support reasonable development and support your elected officials. Allow them to do their job and to weigh the pros and cons of any legally submitted project to determine what is best for the city. Don't let a group of neighbors violate the rights of the Passionists.

MISINFORMATION AND CRITICAL THINKING

"Misinformation" is a running theme in the "Meadows" debate. Last week's article by Preserve Sierra Madre (PSM) was titled "Mater Dolorosa Continues to Promote Misinformation." But they forgot one thing, to say what this supposed misinformation was. Sierra Madre Neighbors for Fairness has pointed this false accusation problem out before.

If one wants to be seen as credible then one needs to back up their claims. It takes work to read something carefully and critically. SMNFF regularly quotes claims we are questioning and we provide references for claims we make, yet we are still regularly (and vaguely) accused of spreading misinformation. We have made repeated requests to show us specifically what misinformation we are spreading and where we said it so we can address it.

Here is an example of a misrepresentation we saw last week. In PSM's article they accused the City Council of not having any discussion of the options available to them regarding the ballot initiative. The city clerk read what options were available to the City Council. Only one option included gathering more information to find out what the impacts of the initiative would be. Since the City Council had concerns about the initiative the only rational option available was to ask the city attorney to prepare a study addressing these issues. But PSM frames this as the City Council not asking questions and called it all "strangely orchestrated - as if they had decided beforehand" - but they also said it was "as expected they asked Council to prepare a report." If this was as expected, then what was strange about it? Nothing. This is just a way to malign the Council for doing what was expected, but what PSM didn't want.

Another point of misrepresentation was how during public comments most of the people speaking were directly tied to the Mater Dolorosa and not Sierra Madre residents. Let's put that statement in context. The number of speakers who live in Sierra Madre and spoke in support of the Passionists out-numbered two to one those who spoke in opposition to the project. PSM also failed to address the main point of those speaking in support of the Passionists, which was the issue of taking away their development rights at the retreat center. Instead they framed it that the Passionists were hurt that people were opposing the housing project. This sort of misrepresentation is not surprising coming from those who show no regard for the religious rights of a 100 year old institution in the city.

Sierra Madre Neighbors for Fairness does not hold a position on the Meadows project, but we do accept that the Passionists have protected rights, including the right to sell off part of their property, to propose a project for it, and to have fair hearings by the Planning Commission and City Council. 

And finally, Mr. Hoffman found a gentleman in Los Angeles who was willing to finance the \$10,000 which was the original cost of the main club building before any of the added annexes.





Gun Student and Campus Safety Bills Pass Committee

A gun safety and reform measure authored by State Senator Anthony Portantino (pictured) that prioritizes student and campus safety by promoting safe at-home storage of firearms and robust investigations of imminent violent school threats was one of two gun safety Senate Bills that passed the Assembly Appropriations Committee Wednesday.

Portantino's SB 906 would require the State Department of Education, in consultation with the Department of Justice, to develop model content for public or charter schools on a threat or perceived threat of a mass shooting incident.

According to Portantino upon becoming aware of a credible violent threat, schools must immediately report that threat to the law enforcement authorities, and school leaders, in consultation with law enforcement, must search a student's on campus property for the presence of firearms Schools are required to include information related to the safe storage of firearms in the annual notification provided to the parents or guardians.

SB 1327, jointly authored by Portantino and Senate Majority Leader Emeritus Bob Hertzberg (D-Van Nuys), is a major gun reform bill, allows private citizens to sue manufactures, distributers, transporters, importers or sellers of assault weapons, .50 BMG rifles, ghost guns, or ghost gun kits in California. It allows citizens to sue for \$10,000 on each weapon involved, as well as attorney

"The continued need to adopt sensible solutions to our nation's tragic history of gun violence is dire and necessary, Portantino said. "We must continue to take swift and meaningful steps to stop the gun violence epidemic in our country and to improve public safety for all Californians. That includes SB 1327 - which I am proud to jointly author



with Senator Hertzberg to empower individuals to bring civil lawsuits against those who manufacture, distribute or transport ghost guns into California. Let's be clear the NRA will continue to oppose us and we need to be diligent with our efforts to make this law and keep our communities

Governor Gavin Newsom is the official sponsor of the SB 1327 legislation.

According to Portantino Since 1970, the United States has had over 1,316 school shootings with 164 occurring in California. As experienced in Michigan and Uvalde, these shootings are fatal. Senator Portantino is following up on his safe storage of firearms legislation with a comprehensive school safety plan, which includes a strong and prudent mandate to follow through on threats.

We must be proactive and adopt common sense measures to prevent future violence at our schools," Portantino said. "SB 906 can help prepare educators and parents to identify red flags and heed warning signs. There can sometimes be hesitancy in acting on these warning signs and a comprehensive safety plan for campuses is necessary to help save lives."

Mars Orbiter to Show One Last Rainbow-Colored Maps

The map, to be released *in batches over six* months, covers the vast *majority of the planet,* revealing dozens of minerals found on its surface.

Scientists are about to get a new look at Mars, thanks to a multicolored 5.6-gigapixel map. Covering 86 percent of the Red Planet's surface, the map reveals the distribution of dozens of key minerals. By looking at mineral distribution, scientists can better understand Mars' watery past and can prioritize which regions need to be studied in more depth.

The first portions of this map were released by NASA's Planetary Data System. Over the next six months, more will be released, completing one of the most detailed surveys of the Martian surface ever made. (Read more about these map segments.)

NASA's Mars Reconnaissance Orbiter, or MRO, has been mapping minerals on the Red Planet for 16 years, with its Compact Reconnaissance Imaging Spectrometer for Mars, or CRISM.

Using detectors that see visible and infrared wavelengths, the CRISM team has previously produced high-resolution mineral maps that provide a record of the formation of the Martian crust and where and how it was altered by water. These maps have been crucial to helping scientists understand how lakes, streams, and groundwater shaped the planet billions of years ago. NASA has also used CRISM's maps to select landing sites for other spacecraft, as with Jezero Crater, where NASA's Perseverance rover is exploring an ancient river delta.

The first piece of this new map includes 51,000 images, each of

which represents a "strip" 336 miles (540 kilometers) long by 6 miles (10 kilometers) wide that was captured as MRO passed overhead. The resolution is lower than CRISM maps made from targeted observations because the data was acquired with the instrument looking straight down, a different imaging strategy designed to cover much more of the planet.

To acquire its data, ĈRISM used two spectrometers, one of which was designed with three cryocoolers to keep temperatures low so that it could more clearly detect the longest wavelengths of reflected solar infrared light. Used in succession, the last of these cryocoolers completed its lifecycle in 2017, limiting the instrument's capabilities to view visible wavelengths. So this will be CRISM's last map covering the instrument's full wavelength range. The instrument is now in a standby mode and may record data a few more times in the coming months before being decommissioned.

One last map will be released within the year, covering visible wavelengths and focusing only on iron-bearing minerals; this will have twice the spatial resolution of the latest map.

The CRISM investigation has been one of the crown jewels of NASA's MRO mission," said Richard Zurek, the mission's project scientist at NASA's Jet Propulsion Laboratory in Southern California. "Analyses based on these final maps will provide new insights into the history of Mars for many years to come."

MRO is led by JPL, which is a division of Caltech in Pasadena. CRISM is led by Johns Hopkins University's Applied Physics Laboratory.

HOW TO HIRE AN IN-HOME HELPER FOR AN AGING PARENT

Dear Savvy Senior,

I would like to hire an in-home helper for my 82-year-old mother to assist with household chores like housekeeping, grocery shopping and driving her to the doctor, etc. But mom doesn't require any personal/physical caregiving, nor does she require any home medical care. Any tips to help us fina someone? Searching Sarah

Getting your mother some help at home to handle some of her day-to-day chores is a smart idea that can make a big difference keeping her independent longer. Here's are some tips to help you find someone reliable.

For seniors who could use some help at home - but don't need a caregiving aide for personal care - there are homemakers/home helpers you can hire that can help make

Most in-home helpers can assist with any number things like shopping, running errands, transportation light housekeeping, laundry, meal preparation, arranging services (home maintenance, lawn care, etc.) and other household chores, along with providing companionship and support. And, if your mom gets to the point she needs personal/physical care like bathing or dressing, many home helpers can assist with this too.

Most home helpers are part time workers who work a fe hours a day or a few days per week.

You also need to know that while Medicare does cover home health care services if a doctor orders it, they do not cover in-home homemaker/helper services.

There are two ways in which you can go about hiring someone for your mom; either through a home care agency or you can hire someone directly on your own.

Home Care Agency

Hiring a home helper through a non-medical home care, or non-medical companion care agency is the easiest, but most expensive option of the two. Costs typically run anywher from \$15 to \$25 an hour depending on where you live.

Some of the drawbacks, however, are that you may not have much input into the selection of the aide, and the helpers may change or alternate, which can cause a disruption.

To find a home care agency in your area, use search engines like Google or Yahoo and type in "non-medical home care" followed by the city and state your mom lives in. Or you can use Medicare's home health services search tool at Medicare.gov/care-compare - click on "home health services." Most home health agencies offer some form of non-medical home care services too. You can also check your local yellow pages under "home health

Hiring Directly

Hiring a personal assistant/home helper on your own is the other option, and it's less expensive. Costs typically range between \$12 and \$20 per hour. Hiring directly also gives you more control over who you hire so you can choose someone who you feel is right for your mom.

But be aware that if you do hire someone on your own, you become the employer so there's no agency support to fall back on if a problem occurs or if the assistant doesn't show up. You're also responsible for paying payroll taxes and any worker-related injuries that may happen. If you choose this option, make sure you check the person's references thoroughly and do a criminal background

To find someone, ask for referrals through friends or you can search online at sites like Care.com or CareLinx.com.

Yet, for other young adults, staying single and childless is a matter of choice. And if trends hold, the number of single, childless households is likely to increase in the coming years.

While most adults don't take estate planning as seriously as they should, if you are single with no children, you might think there's really no need for you to worry about creating an estate plan. But this is a huge mistake. In fact, it can be even MORE important to have an estate plan if you are single and childless.

If you are single without kids, you face several potential estate planning complications that aren't an issue for those who are married with children. And this is true whether you're wealthy or have very limited assets. Indeed, without proper estate planning, you're not only jeopardizing what wealth and assets you do have, but you're putting your life at risk, too. And that's not even mentioning the potential conflict, mess, and expense your surviving family and fr deal with if something unexpected happens to you.

If you're single and childless, consider these three inconvenient truths before you decide to forego estate

1. Someone Will Have to Handle Your Stuff

Whether you're rich, poor, or somewhere in between, in the event of your death, everything you own will need to be located, managed, and passed on to someone, which can be a massive undertaking in itself—one that few families are properly prepared for.

In fact, following a loved one's death, American families spend an average of 500 hours and \$12,700 over an average of 13 months (20 month if probate is required) to finalize their deceased loved one's affairs and settle their estate, according to the first annual Cost Of Dying report released this March by tech startup Empathy in partnership with Goldman Sachs.

On top of the logistical complications involved with finalizing your affairs, without a clear and comprehensive estate plan, including at least a will - and often a trust your assets may have to go through the court process of probate, where a judge and state law control who gets everything you own. And in the event no family steps forward, your assets can become property of the state.

Why give the state everything you worked to build? And even if you have little financial wealth, you undoubtedly own a few sentimental items, maybe even including pets, that you'd like to pass to a close friend or favorite charity.

It's rare for someone to die without any family members stepping forward. It's far more likely, however, that some relative you haven't spoken with in years will come out of the woodwork to stake a claim. Without a will or trust state intestacy laws establish which family member has the priority inheritance. If you're unmarried with no children, this hierarchy typically puts parents first, then siblings, then more distant relatives like nieces, nephews, uncles, aunts, and cousins.

Depending on your family, this could have a potentially troubling-and even deadly-outcome. For instance what if your closest living relative is your estranged brother with serious addiction issues? Or what if your assets are passed on to a niece with poor money-management skills, who is likely to squander her inheritance?

And if your estate does contain significant wealth and assets, this could lead to a costly and contentious court battle, with many of your relatives hiring expensive lawyers to fight over your estate. In the end, this could tear your family apart, while making their lawyers rich—all because you didn't think you needed an estate plan.

I'm sure that's not what you want. But unfortunately, I see it happen all the time.

2. Someone Will Have Power Over Your Healthcare

Estate planning isn't just about passing on your assets when you die. In fact, some of the most critical aspects of estate planning have nothing to do with your money at all, but are aimed at protecting you while you're still very much alive.

Proactive planning allows you to name the person you want to make healthcare decisions for you in the event you are incapacitated and unable to make such decisions yourself. This is done using an estate planning tool

known as a medical power of attorney.

For example, without a medical power of attorney in place, if you're incapacitated due to a serious accident or illness and unable to give doctors permission to perform a potentially risky medical treatments, it would be left up to a judge to decide who gets to make that decision on your behalf.

If you have a romantic partner but haven't granted him or her medical power of attorney, the court will likely have a family member, not your partner, make those decisions. And that person may make decisions contrary to what you or your partner would want.

And if you don't want your estranged brother to inherit your assets, you probably don't want him to have the power to make life-and-death decisions about your medical care, either. But that's exactly what could happen if you don't put a plan in place.

Furthermore, your family members who have priority to make decisions for you could keep your dearest friends away from your bedside in the event of your hospitalization. Or tamily members who don't share your values about the type of food you eat, or the types of medical care you receive, could be the one's making decisions about how you'll be cared for.

To address these issues, you need to implement an estate planning tool that provides specific guidelines detailing exactly how you want your medical care to be managed during your incapacity, including critical end-of-life decisions. This is done using an estate planning vehicle known as a living will.

Bottom line: If you are single with no kids, you need to create an estate plan to name healthcare decisions-makers for yourself and provide instructions on how you want those decisions made should you ever become incapacitated and unable to make those decisions yourself.

3. Someone Will Get Power Over Your Finances

As with healthcare decisions, if you become incapacitated and haven't legally named someone to handle your finances while you're unable to do so, the court will pick someone for you. The way to avoid this is by granting someone you trust durable power of attorney.

A durable power of attorney is an estate planning vehicle that gives the person you choose the immediate authority to manage your financial, legal, and business affairs if you're incapacitated. This agent will have a broad range of powers to handle things like paying your bills and taxes, running your business, collecting your Social Security benefits, selling your home, as well as managing your banking and investment accounts.

Without a signed durable power of attorney, your family and friends will have to go to court to get access to your finances, which not only takes time and money, but it could lead to the mismanagement—and even the loss—of your assets should the court grant this authority to the

What's more, the person you name doesn't have to be a lawyer or financial professional; it can be anybody you choose, including both family and friends. The most important aspect of your choice is selecting someone who's imminently trustworthy since they will have nearly complete control over your finances while you remain incapacitated.

Don't Leave So Much At Risk

Given these potential risks and costs for yourself and those you care about, it would be foolhardy to ignore or put off these basic estate planning strategies just because you if you are single and without kids. Identifying the right estate planning tools is easy to do, and it begins with a consultation with a qualified estate planning attorney who will consider everything you own and everyone you love, and guide you to make informed, educated, and empowered choices for yourself and your loved ones.

In the end, it will likely take just a few hours of your time to make certain that your assets, healthcare, and finances will be managed in the most effective and affordable manner possible in the event of your death or incapacity. Don't leave your life and assets at risk or leave a mess for the people you love; get your estate planning handled

LIVING OFF THE LAND - Is It Possible In the City?

Billy Nickel, 53, is a professional electrician who has also spent hundreds of hours in the last 15 years studying ethnobotany, and related survival skills.

In the early spring of 2010, he was between jobs and living in the Hollywood area. He was also trying to lose weight at the time and improve his lifestyle, and he embarked on a seven-day experiment. "Could I live off the land using just the wild foods I find?" he asked himself.

So, each day, he walked approximately one mile to Griffith Park to his north. Griffith Park is located not far from downtown Los Angeles, and is considered the largest urban park in the United States.

He decided to do a seven day experiment, as a test of his self-reliance, and secondly, as a way to lose weight. "I had been doing a lot of hiking then," he explained, "and so I walked from my house to Griffith Park about a mile away. I did that walk every day during the seven day experiment."

He started his experiment on a Monday, and walked to the park with a large bag, and a large salad bowl.

He carried the large bag for collecting the greens, and a large salad bowl, which measured about 14 inches across and 8 inches deep. "I used the bag to collect the greens, and then I washed them in the park at the water spigot. I tore them up into little pieces, and used a cutting board and chopped up all the greens. Then I sat there in the park, and ate a big salad every day," says Nickel.

What exactly did he eat? "I found lambs quarters, which was the main plant I ate." Lambs quarter (Chenopodium album), is a relative of spinach and quinoa. "I ate a lot of London rocket (Sisymbrium irio), and the flower heads of various mustards. I didn't care for the black mustard leaves because they were a bit furry. I ate some pineappleweed flower heads too," he explained. Pineapple weed is a close relative of chamomille which grows wild.

During his seven-day experiment, he found some sow thistle greens (Sonchus sp.), some mallow (Malva neglecta), some curly dock greens (Rumex crispus), and what he calls "a hidden patch of nasturtium" whose leaves he picked and included in his salads. "I also know of a little stream in the park where there is a field of miner's lettuce and chickweed, which I included in my salads."

Nickel nearly always processed the greens each day and ate it in the park. He seasoned the salad with olive oil and vinaigrette dressing that he carried along, but otherwise it was a 100% foraged salad.

So each day, all that Nickel ate was this huge raw salad, with dressing and olive oil.

He always felt full and he didn't eat anything else in the early part of the day or later in the day. "I never really felt like eating beyond that," explains Nickel, "but it actually took me at least half an hour to eat the salad! I had to chew everything really well!"

Towards the end of the seven days, Nickel still enjoyed each salad and found it very satisfying, but "I could tell my body was craving protein. I started getting the urge to get a burger. But I never felt weak or a loss of energy from the all raw, all wild diet of salads. I just started to have the overwhelming desire to have a burger. I had only planned to do this for a week, and maybe that's all I could handle because I was fixated on getting meat towards the end." Nickel shared that he had not yet realized the value of seeds and grains in a diet of foraged food, which would have helped to provide a more balanced diet with more calories.

"The thing I noted most," explains Nickel, "was that it was quite an ordeal to eat! Each day's walk to the park, foraging, cleaning, processing and eating, and then walking home took at least 6 hours. Once it took nearly 8 hours. I was between jobs then so I had the time, but I hadn't realized that the entire food quest was such a time-consuming ordeal."

Nickel foraged in a hilly area of the park, and people on the trails often saw him collecting his large bag of daily greens. "When people asked me what I was doing, I shared with them what I was doing," says Nickel with a smile. "I knew I was getting lots of vitamins and minerals, though not that many calories."

Incidentally, Nickel performed this one-week experiment during a larger four month period where he was working to lose weight – he lost 70 pounds during the four-month period. He adds as a footnote that his gas had no smell during the time when he was exclusively eating wild foods.



The Chef Knows By Peter Dills

SUMMER TABLE MANNERS


Must admit with all the past Father's Day notes and trivial trivia, I almost missed National Martini Day, and what type of foodie would I be, but fear not friends, I did partake in a Martini and lobster. I have to take my Andy Rooney Card out again and give you my fellow diners the rules of Etiquette 101. I love my daughter, and some of my friends kids. But here goes.

I am asked frequently asked about etiquette and table manners, so I compiled this simple list based on the most common questions.

Your napkin goes in your lap, folded in half, as soon as you sit

Many people wait until the food arrives, but the proper form is to be prepared.

If you leave the table, place the napkin to the left of your plate, loosely draped.



In formal dining, a charger will be under the place setting. It remains there during the starter course and is removed at the main course.

Your eating utensils go in the order of use, starting from the outside (furthest from the plate) and working their way in. Forks go on the left; knives and spoons on the right, as you face the plate. Dessert utensils are placed at the top of the plate, sideways.

The bread and butter plate goes to the left, above the forks.

The water glass goes above the knives (behind the wine goblet, if there is one).

Food should be passed counter-clockwise.

It is considered impolite to start eating before everyone is seated and served, including your

Only the meal settings and food belong on the table. Do not place your elbows, eyeglasses, notebook, pen or other objects on the table.

Cut no more than two bites of any item at a time. When it comes to bread, tear off one bite

Do not season your food until you have tasted it.

at a time and butter it, rather than buttering a whole roll.

It is permissible to use a piece of bread to wipe up excess gravy, as long as you use your fork and not your fingers.

If you need to leave the table, place your utensils on the edge of your plate so that the tips point to the plate's center, in a V-shape. To signal when you are finished, lay your utensils



FAIRY TALES

The final straw hit me a few days ago. I spent a great deal of last week glued to the television watching the January 6th hearings and then later in the day diverting myself by watching sports. The hearings were a terribly disquieting review of things I already knew and tried not to think about. Sports were unable to divert me as I watched baseball games sneaking in extra commercials right while the game was taking place. Commercials between innings were no longer enough; now they were inserting commercials between pitches. Additionally I read somewhere in a magazine that opioid deaths are probably due "to strategic supply strategies by the pharmaceutical industry to influence doctors to prescribe un-

necessary huge amounts of these potentially deadly medications with no concern about addiction. I read that hospitals concerned about post-surgical patients who complained of pain feared that these complaints would lead to lost rating points which would lead to lost revenues. Doctors were urged to prescribe opiates after surgery so that the complaints would disappear and hospital ratings would be maintained.

As I read this I was reminded of what told by a neighbor who was a researcher formerly attached to our local City of Hope. He described his frustration when realizing that this respected facility was not interested in the prevention of disease but rather was interested and invested in the ongoing treatment of disease which was so much more profitable than prevention. He advised me to go out and have fun while I still can. Anyway, why would anyone want to bring another child into this world?" My Jewish heritage screamed.

Something else struck me which may seem disconnected to you. My almost three year old granddaughter does not seem to differentiate between "children" and "people". As we sat around the table on Father's Day she explained that she had five "children" grandparents, father, mother and uncle and we all had to love and take care of each other. She happily counted each of us but wasn't sure if she should count our dog but felt we all should also take care of the dog. I know she's a toddler but she is also a remarkable example of what is a human being and I believe she is right! Life is not about just having fun; it is about caring and loving and learning from one another.

All of these weekend experiences combined to become that "straw" which lead me to the strange conclusion that it would be best for me to forego watching television in order to gain perhaps a better perspective on what is going on around me. The Hans Christian Andersen Fairy Tale titled the Emperor's New Clothes came to mind".

Rather than watching television I read the fairy tale and then reread it. To me it has a very modern relevance. The tale describes an emperor who was indifferent to the true tasks of being an emperor but was just more concerned about showing off. He had one major concern which was that he might be surrounded by people who were disloyal, and stupid, and unfit for their job. It so happened that one day a pair of swindlers turned up claiming to be weavers who boasted that they could provide the emperor with clothes that had the virtue of being invisible to anyone who was stupid or not fit to hold his job. You probably remember the ending of the story in which everyone including the emperor himself pretended to see the clothing because they did not want to appear stupid or unfit for their job. So everyone pretended to see the emperor's clothing until one child exclaimed "But he hasn't anything on.

The actual end of the fairy tale is very disheartening. I had forgotten that the Emperor, even after having the uncomfortable feeling that the child was right, realized that he had no choice and decided "I must go through with it now". He walked proudly on followed by his loyal followers who carried on the pretense. This disturbing ending is reflective of my actual experience as a well educated American person. I grew up being a proud American the child of an immigrant family that was very proud to offer me opportunities that they never had. Inevitably I read Howard Zinn, went to Berkeley, and represented poor people for over fifty years. I have learned about a whole different not very honorable America. I now know about the restrictive covenants that insured racial residential discrimination and inequality in education, job opportunity, and even health services. So what's to be done? Do we just go on acting like the Emperor acting out a fairy tale in which we no longer believe? All I can do right now is to avoid the lies which television continually provides and maybe learn a little from my granddaughter as we both try to be good and responsible human beings. I recommend reading as an educational tool—even fairy tales.

TRUMPISM IS FASCISM, AMERICAN-STYLE



If you want to know what the slide into fascism looks like, go back and review Tuesday's session of the U.S. House committee investigating the Jan. 6, 2021 insurrection at the U.S. Capitol. It was a tragic parade of public ser-

vants relaying the vile acts of harassment they were subjected to as they did the hard work of making sure the wheels of American democracy turned smoothly during the 2020 election.



There was Georgia election worker Wandrea "Shaye" Moss, who, along with her mother, Ruby Freeman, were harassed by Trump supporters after the former president publicly falsely accused them of engaging in voter fraud.

In one instance, Trump supporters even broke into Moss' grandmother's home, looking to make a "citizen's arrest," Capital-Star Washington Reporter Jacob Fischler wrote Tuesday. Freeman said the FBI told her that she had to leave her home for her own safety and stayed away for two months to escape the danger, she told the committee in taped testimony. "It was horrible," she said.

And you don't have to agree with - or even like - Pennsylvania House Speaker Bryan Cutler to be repulsed by the same harassment he and his family were subjected to by Trump loyalists and their enablers.

Cutler, of Lancaster County, the top Republican in the state House, revealed that he was bombarded by near-daily calls from Trump lawyers Rudy Giuliani and Jenna Ellis, as they sought his support in illegally toppling the results of the 2020 presidential election.

The calls from Giuliani and Ellis, now an adviser to Pennsylvania Republican gubernatorial nominee Doug Mastriano, persisted even after Cutler, who described the outreach as "inappropriate," asked them to stop.

'I understand that you don't want to talk to me now," Giuliani said in another message. "I just want to bring some facts to your attention and talk to you as a fellow Republican." Cutler also discussed the impact that Trump supporter Steve Bannon's calls for protests outside Cutler's home and district office had on him and his family. In one instance, Cutler's

15-year-old son was home alone as protesters massed outside, according to the Washington Post. In newly released footage, Cutler said he was forced to "disconnect [his] home phone for about three days," after his personal information was shared online. Cutler said his phone

ish reported Tuesday. Now you can argue that Cutler, an elected official, is fair game for protesters. And you can justifiably say he deserves criticism for joining with 63 other legislative Republicans who sent a letter urging Congress to object to Pennsylvania's electoral votes, which went to now-President Joe Biden.

But there's no universe where a 15-year-old boy deserves to be terrorized by a crowd after his father's was doxxed by people who already are subscribing to the lie of the stolen election. But that's what fascists do: They bully and intimidate. And they work methodically, as the House committee's sessions have shown, to undermine the legal underpinnings of the elected government so they can seize power.

And when they don't get their way, they set their goons loose, as was the case on Jan 6. And they don't lift a finger to stop them, even when it becomes clear that the lives of the vice president of the United States and other senior officials clearly are at risk.

In it, the gun-wielding candidate exhorts his supporters to go "RINO hunting" with him — a reference to so-called "Republicans in Name Only" who are judged not to be to eing the line

After the chants of "Hang Mike Pence," it's not far-fetched to imagine deranged MAGA supporters taking Greitens both literally and seriously, engaging in their own Night of the Long Knives, as Hitler's thugs did in 1934 when they took out the paramilitary SA and other opponents of the Nazi regime.


There already are eerie echoes of the 1933 Reichstag Fire in the sacking of the Capitol. In both cases, fascist thugs were looking for a pretext to seize and consolidate their hold on power. Trumpism is fascism, American-style.
