# LOCAL BUSINESS SHUT DOWN AFTER UNDERCOVER VICE **OPERATION**

Sierra Madre, CA. – On August 3, 2022, at about 12:30 pm, Detectives with the Sierra Madre Police Department conducted an investigation of a business at 18 W. Sierra Madre Blvd., in response to several complaints of suspected illegal conduct.

The business, operating in Sierra Madre as Sisters Spa, describes its services, "Specialties: Sisters Spa offers an array of uniquely rewarding and deeply personalized experiences in an amazing spa and wellness setting, which infuses life with a greater sense of vitality. You'll always go home enlightened, empowered and ready to live your life more playfully and healthfully. Here you will experience unparalleled service, unrivaled presence and attention to detail. We purposely decorated our spa to bring you the highest level of service and relaxing atmosphere.'

After receiving complaints from the public regarding suspicious activities, SMPD opened an investigation and, along with the Pasadena PD Vice-Unit and San Gabriel PD Detectives' Bureau managed an operation involving undercover officers. During the operation, officers identified several violations of the City's Municipal Code and State Law.

A "Stop Work" Order was placed at the entrance of the business, prohibiting the Sisters Spa from re-opening until the police investigation and any legal matters are concluded. SMPD is expected to file charges with the LA County District Attorney's

In addition, staff recommended that an Environmental Impact Report and approval of a Mitigating Monitoring and Reporting Program at the Bailey Canyon Project be certified.

This public hearing was continued several times from April 7, May 5, June 2, and July 7 this year. The project is broken down into two phases of proceedings. Part I is the public hearings, and Part 2 is the consideration of a Tentative Tract Map and the Design Review Permit. The Part 2 items are limited to a five-hearing rule.

At the July 7 meeting, several revisions were requested by the Planning Commission to the Specific Plan, including floor area calculations, development agreement, design guidelines, and park design.

# Revisions

There was a healthy crowd at this meeting, though not as full as other meetings on this subject. The public hearing started with a presentation by Jonathan Frankel of New Urban West, Inc. and a few project architects to address the requested revisions. Those highlights included:

- An increase in drainage and water storage capacity to exceed the required retention volume
- Add clarification to minor

Developers also highlighted that the average floor area of the 68 homes surrounding Mater Dolorosa is 2,293 square feet, and the average Meadows floor area will be 2,854 square feet.

The Planning Commission asked for additional revisions, including clarifications on the height of roofs and retaining walls, keeping bathrooms in the park, and more information about renovations for Carter Ave. The discussion is tabled until 08/18/22.






# **WHAT ARE THEY HIDING?**

It is remarkable, that in all of the thousands of pages, hundreds of charts and drawings, and dozens of meetings, we still don't know

what the Meadows Project really looks like. The only glimpse we have had is a multi-coloured rendering of the entrance at Sunnyside looking up at an angle towards the mountains. We see the tops of three homes peeking out from overgrown shrubs, tall grasses and mature trees. And the first thought that comes to mind is: Wow, what a fire hazard!



No aerial shots looking down on the project. At this stage of the review, and since July 2021, we have only seen a plot plan showing 4 rows of rectangles situated on 5 streets.

The latest plot plan below shows what looks like pieces of a puzzle. This is supposed to show us what the Project looks like.



Strangely puzzling in these times of incredible technology and computer programs, that we are not seeing this project 'up close and personal'. Why are we not taking a leisurely stroll on our computers down the street through this planned development and looking to our left and right-seeing the various home designs as they are planned, seeing how close they are to each other, how tall they are, how big the front and back setbacks are, what size the yards are, what 'lot coverage' really looks like, what the proposed mix of predominately two story homes looks like, what the retaining walls look like, what the landscaping looks like, how the views are affected and much more.

We all know the saying 'A picture is worth a thousand words' and recognize how much information is conveyed visually. It begs the question why we are not 'seeing' this Project.

We know that the meadow will be heavily graded in order to fit a housing project that belongs on a flat piece of land and put it on a hillside. There are no renderings of what this will look like.

We now know the Project has gone from mostly single story homes that 'reflect the character of the surrounding neighbourhood' to a majority of two story homes with only twelve single story homes. There are no pictures of what this will look like.

We know that this Project was designed 'to retain the small town, eclectic character that is cherished by the community' and 'promote compatibility with the immediately adjacent neighbours. It is creating this vision by installing 'buffers' or barriers on all four sides to physically isolate it from the community it desires to be a part of - and that is being touted as a Project benefit. All it needs is a gate at the entrance to complete the picture.

We now know that the Project will require additional water usage from construction and the addition of over 400 small trees that will require regular water during the first years of their growth. There has been no update on projected water usage.

As the vagueness and lack of detail in the developer's 'Specific Plan' is questioned during public meetings and comments, it continues to raise questions about what we are not being told and what they are hiding that remains to be uncovered.

# WE CAN FOLLOW THE MONEY, TOO

There are so many problems with | and vocal backers of this measure is the "Protect Sierra Madre - STOP the Housing Project" initiative that it is hard to believe someone actually designed it thinking it would benefit the City. We now know that the initiative allows 68 mansions to be built at the Monastery with little city oversight and exposes all taxpayers to significant legal liabilities. That is probably why our City Council and Mayor unanimously voted to oppose this ill-conceived measure.

Why are these self-proclaimed "Protectors" and "Preservers" of Sierra Madre arguing so adamantly for the city to give up a free public park, lose 40 acres of hillside placed in conservancy, and do away with almost \$1 million in net-zero water offsets, all to change the zoning so it will allow a bunch of mansions to be built? They don't appear to be incompetent because all three proponents appear to have extensive legal training.

There is a deeper story here. It would be naïve to think that the three people who sponsored this initiative simply didn't know what they were doing.

Most disturbingly, we recently learned that one of the most public also a senior vice president for a Beverly Hills homebuilder who refers to themselves as "the world's leading developer and operator of luxury private residential communities." They specialize in building 5,000 12,000 square foot mansions, exactly the size structures that can be built if their initiative passes.

Of course, the initiative proponents didn't tell their supporters that their measure was literally sponsored by a senior executive with a luxury homebuilder when they asked folks to sign. This initiative would "stop the housing project" they told voters. This is a bait and switch of epic proportions.

As we have been told many times by those supporting the initiative, "follow the money." The initiative doesn't protect the hillside environment but it does greatly increase the value of the 45 acres that the Passionist's Retreat Center sits on because it makes it possible to develop the entire property with mansions. The initiative incentivizes the Passionists to leave the city and sell out to a large luxury residential developer, just like a proponent happens to work

for, where 68 identical homes can be built and the city will not be able to stop them if the initiative passes.

It is safe to assume that these initiative boosters know exactly what they are doing. If they did their duediligence then they also knew it was likely that the city council would come out against the initia-tive and possibly not defend it in a lawsuit. Why are these three legal experts willing to personally take on the risk of paying hundreds of thousands of dollars to defend the inevitable lawsuit if the city decides not to? Or possibly costing them millions of dollars in damages if the city loses a First Amendment RLUIPA case? Do the proponents have so much gambled here that they will defend the initiative themselves to protect their investment?

Are they incompetent or is this just a very carefully thought out plan? You decide. Like they keep tell-ing us... follow the money.

## THEY WHO FORGET HISTORY ARE DOOMED TO REPEAT IT

was full of unintended irony. A front page article compared the fight for Measure V in 2007 to the fight to put the Mater Dolorosa property into the Hillside Management Zoné. Doing this would ensure that the developer, New Urban West follow the same building codes as the rest of us, rather than making up their own codes in their Specific Plan, or as one resident called it "their Special Plan."

All kinds of dire consequences were promised if Measure V passed. Instead of approximately 175 condos in two different buildings in our downtown area, Measure V would "make just about everything worse for Sierra Madre." "Taxpayers will foot the bill for Measure V votes for tens or hundreds of thousands of dollars.' "The flaws in Measure V are so se vere that the proponents don't even do what it purports to do." Measure V was a simple solution to a problem made worse by the misstatements and misinformation of its opponents. Its purpose was to keep overexpansion of 175 or so condos out of wntown by limiting any building to 13 units per acre, two stories and limited to 30 feet high. That seems very clear, and it certainly worked.

for Sierra Madre." One supporter of the monastery spoke before the Planning Commission a few months ago, stating "putting the initiative on the ballot will cost the City about \$50,000." Of course, we know that that is wildly exaggerated, the cost is closer to \$1000-\$2000. I'm frankly perplexed at the front-page op-ed by Scott Hood in the July 30 issue of the MVN. In it, Mr. Hood tries to compare the 2006 Measure V Initiative with the 2022 Stop Initiative. In 2006 a group of local investors believed modernizing our downtown would vitalize the town. Others disagreed and believed the downtown area was fine the way it was and created the Measure V Initiative to limit the size and height of buildings. Measure V passed and Sierra Madre remains its charming self.

Fast forward to 2013, when the Passionists determined they could no longer be self-supporting. They decided to sell the lower 17 acres of their property to fund their religious works and provide for their aging priests. They believed a wellthought-out housing project would have the least impact on the Retreat Center, the neighborhood, and the City itself.

Mountain Views News published that news, with Mater Dolorosa stating, "no plans yet of the number of houses." Neighbors quickly formed a group in

Yard signs with the slogans, Stop the Monastery Development" and "Preserve Mater Dolorosa and our quality of life" appeared.

A Water Moratorium halted plans but when it was lifted, New Urban West (NUW) was introduced as the developer of a proposed project. No plans were presented at that time. The neighbors maintained NUW would destroy everything known to the citizens of Sierra Madre. Fire, floods, wildlife harm, and increased traffic would be the norm. There could even be a traffic signal installed.

These arguments were shown to be false by an Environmental Impact Report. As a counter to that, the neighbors conceived an initiative to convert the current zoning from Institutional to Hillside Residential. Instead of affecting only 17 acres, however, the initiative would rezone 45 acres, including the Retreat Cen-

Meanwhile, City Council's current analysis of the initiative has determined that the initiative will create a development contrary to the intent of the initiative, and may result in a lawsuit due to the overly restrictive downzoning of a religious institution.

The Stop/Preserve groups scream bias, saying our City Council is unworthy of making an informed decision. Those of us who have followed this process know that from 2013 to date, the Stop Group would have protested ANY development proposed. This initiative is their last-ditch effort to squelch the rights of a land owner. I trust our Council. They are addressing the Initiative, not the NUW project. There is no comparison between Measure V limits on buildings and the new initiative which violates the rights of the Passionists as land owners and allows for 68 mansions. Pat Alcorn

# SIERRA MADRE'S 2020 BUSINESS OF THE YEAR - TAYLOR'S OLD FASHIONED MARKET TO EXPAND

The Planning Commission approved a modification of a Conditional Use Permit (CUP) on Thursday night to allow the sale of wine, beer, and distilled spirits at Taylor's Ol' Fashioned Market.

According to the applicant, Kevin Taylor, the underutilized floor area of the Market located at 14 E. Sierra Madre Blvd., would be used to expand services so patrons could have a sandwich, a glass of wine, or another adult beverage on-site.

Mr. Taylor is also looking to hold special events in the adjacent property parking lot. He plans an expansion of the property to include a patio area where patrons can sit, eat and drink alfresco style. There would be some renovations to the inside of Taylor's, which has been in business since 1966, but no more than a 500-square foot area, and minor alterations to the outside façade. The actual property won't be expanded, and renovations won't affect parking conditions.

Before receiving a modified CUP, the applicant had to prove several criteria, such as the site for the proposed use is adequate in size, shape, topography, and location; and that the area has sufficient access to streets that are adequate in width and pavement type to carry the quantity of traffic generated by the proposed use. In addition, the proposed use wouldn't be detrimental to public health, safety, and general welfare. The Planning Commission was satisfied that Taylor's met these criteria and others.

Some of the special events at Taylor's could include wine tasting. Taylor's Market has a 12,623 square-foot lot, which has been primarily used as a grocery store and would need to be classified as an eatery to sell alcohol for in-store consumption and at the outdoor seating.

It's unclear when Taylor's will be done with its renovations or obtain its license to sell alcohol, which could be a lengthy process. Still, the Planning Commission unanimously approved Resolution No. 22-19 and CUP 22-02.

# Pasadena **Confirms** First Cases of Monkeypox

The Pasadena Public Health Department (PPHD) announced Tuesday that they have received reports of the first cases of monkeypox infection in four Pasadena residents. All cases being reported have been PPHD confirmed by meet the Centers Disease Control Prevention (CDC) definition for either a probable or confirmed Monkeypox case. generally spreads through prolonged skin-to-skin contact. Contact includes prolonged intimate interactions, and sharing of infected bedding or clothing. If you have sex or intimate physical contact with many people, risk of contracting monkeypox is

The individuals are adults and are recovering with monitoring and support from PPHD.

"We have been coordinating with our healthcare partners who are managing cases of monkeypox infections," said PPHD Director and Health Officer Dr. Ying-Ying Goh. "We will are recommending individual and community mitigation measures to reduce the risk of spread of the monkeypox virus, and we will continue to provide vaccination to eligible populations as quickly as we receive federallysupplied vaccine."

Monkeypox is a viral infection that can spread through contact with body fluids, monkeypox sores, or shared items (such as clothing and bedding) that have been contaminated with fluids from sores of a person with monkeypox. Although monkeypox is not generally considered a sexually transmitted infection, it can be transmitted during sex through skin-to-skin and other intimate contact, regardless of gender or sexual orientation.

Most people with monkeypox have a mild illness that improves without treatment over 2 to 4 weeks. Treatment is supportive and focused on easing the symptoms of the illness. Monkeypox is contagious and spreads easily to others until scabs have fallen off and a new layer of skin has formed. Monkeypox is NOT spread through casual brief conversations or walking by someone (like in a grocery store).

Public Health will directly communicate to eligible individuals to provide details on how and where to access the JYNNEOS vaccine. PPHD is providing monkeypox vaccines by invitation only.

# City to Look at Rent Control Measure

Conclusions and finding for the report include:

The Amendment's rent regulations would limit the year-to-year increases in rents to 75 percent of the regional CPI increase and the eviction regulations would prohibit evictions except in specified circumstances.

# San Marino House Fire

# SENATOR PORTANTINO RECEIVES AWARD FOR MENTAL HEALTH POLICIES

Senator Anthony Portantino received the 2022 Bebe Moore Campbell National Minority Mental Health Award on, July 24, from the Urban Los Angeles National Alliance on Mental Illness (NAMI). The award was presented to Portantino during a celebration of National Minority Mental Health Awareness with issues of mental health and

Month. Portantino was honored for championing policies that remove the stigma associated

health instruction in schools.

"As a father who has the privilege to advocate for comprehensive mental health policies, I am humbled to receive this honor," Portantino said. "I am also honored to work alongside many advocacy organizations, like NAMI, dedicated to improving mental health outcomes for those in need. Together we will continue push forward policies that are critical to ensuring the long-term wellbeing of persons living with mental illness."

Portantino has a strong record of advocating for mental health policies and has been dedicated to improving mental health outcomes during his time in public office. The Senator previously authored SB 972, which required schools to print the suicide hotline on student identification cards. He dedicated three years to pass SB 328, a policy which pushes back start times for middle and high schools. Scientific data and research show that later school start times lead to improved mental health for kids, with reductions in instances of anxiety, depression, and suicidal

Children's Hero Award from the California Academy of Child and Adolescent Psychiatry and has been recognized by Family Services Agency in Burbank. Last year, the California Council of Community Behavioral Health Agencies (CBHA) honored Portantino as a Behavioral Health Champion. Earlier this year, Board of Directors for NAMI Urban Los Angeles



Portantino was honored with the Youth Mental Health Champion Leadership Award by California Mental Health Advocacy for Children and Youth.

Portantino has authored multiple bills aimed at improving mental health outcomes. SB 224 requires local educational agencies, which currently offer one or more courses in health education to middle or high school students, to include

for authoring SB 224, which expands mental mental health content in those courses. It also requires that the California Department of Education develop a plan to expand mental health instruction in California public schools on or before January 1, 2024.

> SB 14 requires the California Department of Education to recommend best practices and identify training programs to address youth behavioral health, including but not limited to, staff and pupil training. Additionally, the bill ensures that youth absences from school for mental health issues will be treated as an excused absence in the same way any other health issues are treated. Both SB 224 and SB 14 have been signed into law.

> This year, Portantino introduced SB 1302 to establish or improve wellness and mental health support centers on campuses and SB 387 to require evidence based mental health training for 75 percent of classified and certificated employees on school campuses.

We were impressed by Senator Anthony Portantino's record of prolific legislation, namely For his past work, Portantino received the his initiation of SB 224 in January, 2021 and signed into law in October, 2021. This legislation is crucial in having matters of mental health be a part of the curriculum of instruction for students in California. **CALTRANS ANNOUNCES FIVE-DAY CLOSURE OF EASTBOUND I-210 AT** SAN GABRIEL RIVER BRIDGE

IRWINDALE - The California Department of Transportation (Caltrans) announces a five-day closure of westbound Interstate 210 (I-210) at the San Gabriel River Bridge in Irwindale for a bridge upgrade project partially funded by Senate Bill 1 (SB 1). Crews will divert traffic from eastbound I-210 to westbound I-210, which will be converted to three-lanes in both directions between Interstate 605 (I-605) and Irwindale Ave. during the closure.

The following closures will be taking place Wednesday, August 17, at 10:00 p.m. through Tuesday, August 23, at 5 a.m.:

- Eastbound I-210 from I-605 to Irwindale Ave.
- Westbound I-210 Irwindale Ave. on-ramps
- I-605 to eastbound I-210 connector Eastbound I-210 Mt. Olive Dr. on-ramps

Trucks over seven tons are prohibited on Huntington Dr. in the city of Duarte and will be subject to traffic enforcement. Message signs on the highway will be alerting trucks to use designated alternate routes.

Caltrans advises motorists to expect major delays, use I-10 or SR-60 as alternate routes, use public transportation on the Metro L Line (Gold) or Metrolink during the closures and if possible, work from home.

The closure schedule is subject to change due to weather, availability of equipment and materials, and construction-related issues. Motorists are encouraged to plan ahead and check the Caltrans QuickMap for up-to-the-minute traffic conditions. # **COMMUNITY: WILDLIFE ALERT:** MOUNTAIN LION SIGHTING

A mountain lion has been spotted in the 2700 Block of Starpine Drive in Duarte. As temperatures rise, more wild animals will come into residential are-as. The Department of Public Safety suggests the following guidelines to as-sist in coexisting

- Do not leave small children and or small pets (even if pets are caged) unattended outdoors.
- Should you have to maintain your pet outdoors and have room to do so, consider the placement of an enclosed dog or cat run adequate in size to allow your pet to exercise. The run should contain a 6-sided shelter and potable water and have some shade to protect your pet from direct sunlight.
- Do not encourage, entice, approach, or feed mammalian wildlife such as coyotes or bears. It is a violation of the law.
- Please remove your pet's food dish or bowl when your pet has finished eating, and do not leave any unattended food outdoors.
- Pick up all fallen fruit & berries from your yard. If possible, do not leave ripened fruit on branches. For assistance in removing ripened fruit, con-tact Duarte's Local Harvest at (626) 359-5671, ext. 316, to schedule a harvest time and date.
- Enclose or remove woodpiles.
- Do not compost human food items.
- Enclose vegetable gardens with sturdy welded wire mesh or green-house. Clear dense vegetation to reduce wildlife hiding places.
- Clean all grills or barbecues after use.
- Secure or store trash containers in enclosed structures or securely strap down the lids. Do not place refuse containers out until the day of ser-vice. Spray ammonia occasionally in the trash to cut down on food odors.
- Report abandoned or severely neglected unkempt properties to the Public Safety Department at (626) 357-7938 and overgrown brush to the Fire Department as wildlife may often take up living at such locations.
- Carry a walking stick or large colorful umbrella when out on walks so that you can use it to fend off an animal. An open umbrella, for example, presents you as much larger than the animal and may frighten it away.
- Please report suspicious activity to your Public Safety Department at (626) 357-7938 in regards to people who feed wild animals.

We recommend you take the following steps in protecting your property and to discourage would-be criminals from committing auto burglaries or theft from un-

Do not leave valuable items visible in your car. Car Burglary and theft from unlocked vehicles is a crime of opportunity, be sure to keep your car clean from any

Don't think your dark tinted windows will hide your valuables. Thieves often use flashlights to see through tint.

Close all windows and lock all doors before leaving your vehicle.

Park in well-lit, heavily populated areas.

Make a copy of your registration and insurance, and keep them in your wallet or purse. Then remove all forms of identification from your vehi-cle. Anyone with permission to drive your vehicle should also have a copy of the registration and insurance with them to furnish to the law en-forcement if necessary.

Do not leave garage door openers in parked vehicles. If you are parking your vehicle for several days check on it periodically.

- Inspect your vehicle regularly, thieves often times will remove license plates or replace them with stolen plates from stolen vehicles or take vehicle registration tabs.
- Secure truck tail gates- tail gates are stolen due to the ease of removal. Catalytic converter theft is on the rise, get your converter engraved with

In addition, they will also triage callers to determine when dispatching a mobile crisis team is appropriate and, in rare cases, connection to law enforcement when safety is of concern.





# **PASADENA UNIFIED SCHOOL DISTRICT** COVID-19 UPDATE

Since the early days of COVID, PUSD has had to pivot and adapt to rapidly changing circumstances. At last week's meeting, the Pasadena Unified Board of Education approved revisions to COVID safety protocols.

The following revisions are now in place at all PUSD schools.

Outdoor in-person meetings/activities with parents/guardians, community members, staff, and students are now allowed with masking strongly recommended.

Indoor in-person meetings/group activities with parents/guardians, community members, staff, students are allowed with masking required for all.

- Masks are strongly recommended for students and staff indoors in classrooms and other shared spaces.
- Parent group meetings such as (PTA, SSC, ELAC, AAPC) are allowed in person and may be held outdoors or remotely if the respective parent leadership agree.
- IEP meetings with parents/guardians may be held in-person or remotely, whichever supports greater parent/guardian participation.
- Back to School nights will proceed as planned with masks required for all.

Visitors and volunteers are allowed on campus if they self-attest to being fully vaccinated or to having a negative COVID test within the past 48 hours. They must also conduct a symptom screening prior to entering campus and masking is required. All visitors and volunteers must abide by Board policies, regulations, and school rules. Board Policy - Visitors BP 1250.

Back-to-School Nights will be allowed in-person with mandatory masking.

The following protocols remain in place:

Masks are strongly recommended for students and employees in classrooms and indoors.

Masks are required in larger group activities such as assemblies.

Masks are required:

- on PUSD buses (with accommodations for students)
- at testing and vaccination clinics
- during field trips when required by the venue
- for 10 days after exposure to COVID-19 and after a positive test result

Ventilation Air purifiers are in place in classrooms and indoor common areas. Filters were changed over the summer, and all lead custodians were trained on how to change both carbon and HEPA fil-ters.

Personal Protective Equipment Masks and hand sanitizers are in stock and available to students and staff.



# Happy Tails

### STING OF THE BOTHERED BEE

As a young child, I was terrified of every insect I came into contact with, particularly those that I knew could bite or sting me. I'll never forget the first time I was stung by a bee. Or, more specifically, the first time I was stung by a swarm of angry bees. I was about four years old, and had not yet learned about how nature works. I didn't understand the important role those creeping,

crawling, flying creatures played in the big scheme of things.

The angry bee attack was my own fault. I had been teasing them as they came and went to and from the hive they had built just outside the window of my parents' bedroom. Being the baby of seven, and with not a lot to do around the house whilst my siblings attending school, I had spent most of that morning obnoxiously tapping on the window, aggravating those bees to a point of frenzy. I guess I thought it was fun to tease them from a safe place were they could not retaliate.

Well, I must say it came as quite a surprise to me when I stepped out the front door later that day and was suddenly under siege of those buzzing, bothered bees. The moment I closed the door behind me, they launched their attack and found their way inside the back of my t-shirt. They then proceeded to plant their needle-like stingers deeply into the delicate skin of my neck and shoulders. I immediately panicked and began yelling for someone to come and rescue me.

Suddenly my mother was there yanking my t-shirt off and dragging me inside where she prepared a home remedy, which I believe was made of baking soda and milk. She spread that cool paste heavily over the bee stings as they were starting to rise up all over my neck and back. I don't know which was more swollen by the end of that fiasco; my face, from crying so hard, or the numerous stings I'd sustained. For that first hour, my temperature rose to about 102, and I was feeling quite queasy. But thanks to my mother's TLC, eventually the raised, rosy-red marks shrank down and my fever subsided.

Years later, when I reflected on this painstaking experience, I remember being amazed that my mother knew enough to use a homemade baking soda remedy to draw out the venom those bees had injected into me. As it turns out, I benefited from all kinds of awesome alternative health care tricks my mother had up her sleeve, and I now know how very fortunate I was to have had her for a mom.

To this day, I am unsure why I felt the need to pester those poor bees. I guess I was just a dumb kid finding satisfaction in annoying them from within the safety of my home. What I didn't realize, was that bees have no desire to terrorize humans, they are simply going about the business they are designed to do. To work hard transporting pollen, to breed freely and to make delicious honey. When I learned about the important part bees play in nature, I was finally able to let go of my childish fear.

In general, bees only attack in response to aggravation. It is not in their nature to do so at random. Because so many aspects of life on earth depend on the bees' persistent activities, it is important that the human understand this and allow them to go about their business. By becoming fearful and causing a raucous, we humans can often get in the way of nature's harmonious symbiosis.

There've been numerous scientific studies on the bee's olfactory capabilities. Though results have varied from species to species, the aggregate results strongly suggest that they have an excellent sense of smell, and are capable of sensing pheromones, a chemical factor that is secreted or excreted by mammals in response to social stimulation - ie: fear. Though some results are scrutinized, and it is an on-going, fluid research project, I'm inclined to believe it is true, due to my own personal experience. In my opinion, those bees smelled my fear and made it clear, they were not happy with me!

With this in mind, I think the best thing to do, if you happen to come across a swarm of bees, is remain calm. That way they will be much more likely to ignore you and continue their work, than to become aggravated and attack. Conversely, if you become fearful and make loud noises or sudden movements, they may respond with aggression and give chase. For bees, it's all about completing the task at hand, protecting their hives, and surviving.

When I finally figured this out for myself as a young adult, I learned to relax and enjoy watching bees do their work and fly about with no anxiety or fear. It is a fabulous feeling to sit and listen to them buzz as they do what they were created to do. Somehow, understanding what makes bees "tick", and learning to trust them not to attack, has helped me see a bigger picture in life. Getting to know what bees are about has taught me to stay out of the way of every form of wild life and just let them "do their thing".

There are so many lessons to be learned from all creatures, great and small. They teach us how to be better human beings if we let them. Perhaps the proverbial "birds and the bees" story that people used to tell their children during adolescence has been underrated. It's not just a metaphoric means of explaining sex and reproduction, more importantly it is a true story about how best to navigate life on earth. Relax and enjoy your surroundings, fear-free. Indeed, you'll be less likely to get stung by a bothered bee!

# **DEALING WITH DEATH of A PET**

When a loved one dies, the close survivors often express regret that they didn't spend more time with the departed, or tell them that they loved them. Time flies, of course, and life always presents us with so many things to do.

It's easy to put off what's important in life.

I also deeply love and value my pets, and have always considered them very much a part of the family. As a child, I remember when our family dog Pariah was old and sick. I could no longer walk him, but I would go into the back yard to pet him and feed him. Then one day when I came home from school, my father told me that he "took care of" Pariah. "What? Where is he?" I exclaimed. My father calmly told me that the local pet hospital "euthanized" Pariah. "What does that mean?" my teenage-self replied. "Does that mean he'll be home soon?" "No," my mother chimed in with a somber tone. "The doctor put him to sleep. He was dying." My mother tried to hide her tears. I was shocked, and ran to my room.

I was stunned! How could they do that.

Later, after my father was asleep, my mother – who grew up on a farm – explained that she used to see animals die all the time. "We just tried to make them comfortable," she told me. "Animals know they are dying. They usually want to be around their people to feel safe, and not in a cold hospital where they don't know anyone."

That was her way of telling me that she didn't agree with my father's decision. I was sad for a long time, and vowed that I would never again do that to any pet of mine - and I've kept that vow life-long, despite the inconveniences that come with assisting a person or pet in death. I've watched pets – cats, dogs, one pig – get old, stiff, and slow, and then they find a spot to go and die. I've learned to accept this as part of The Way.

I was saddened by what an Eagle Rock friend recently told me. His father, who lives alone, has had a cat for over 10 years. The cat became sick and old and was on its deathbed. The father – in his 80s – now seemed indifferent to this animal that once was a close friend. He wanted the cat to be taken to a vet and "put to sleep." Fortunately, the cat died in peace on its bed in its home. But I was saddened that a person could be such a fair-weather friend because the dear pet was now dying.

All of life is precious, and we need not push the death process. It comes quick enough. Nor should we fear death.

I'm reminded of the time – precisely 10 years ago – when I was taking care of my wife of 22 years on her deathbed, 24/7. She died with me by her side, at home. I think the reason that so many people fear death, and want dying people out of sight-out of mind, is because they cannot get into the shoes of the dying person. The dying person usually wants to be around the people who they were close to in life and not in a sterile hospital. (Yes, I know all situations are different, and sometimes the family simply cannot deal with the demands and pressures of the dying person).

The fact that we have grown so far from this very basic tenet shows how far we have strayed from out most fundamental roots.

What tips can you recommend for choosing a good active adult housing community? My husband and I, who recently retired, are planning to relocate to an area closer to our grandkids and are interested in buying a house in an age-restricted 55-plus housing community. Active Retirees

### Dear Active:

If you're contemplating moving into an age-restricted community, finding one that's right for you takes some legwork. While active adult communities generally offer the opportunity for a lower-maintenance lifestyle around similar aged people, they vary enormously. Here's what you should know.

Today's active adult communities come in all shapes sizes and price ranges, ranging from small city-based apartment complexes, to single-family homes, to sprawling resort-style locations situated on a gated golf course. Most are owned by their occupants, but a growing number are rentals. Typically, at least one occupant of each property must be at least 55.

It's also important to understand that 55-plus active adult communities are not the same as retirement or independent living communities, which are primarily designed for older seniors in their 70s and 80s. Active adult communities do not typically include meals or have a central dining area, but many of them do offer a range of recreational amenities and activities.

To help you locate and research active adult communities in the areas you're interested in, the best resource is 55places.com. This is a comprehensive website that provides ratings, reviews and information on activities and amenities for thousands of communities across the country.

Once you find a few you like, here are some ques tions to ask yourself that can help you choose:

What's our budget? To help you choose the right ac tive adult community you'll first need to determine what you can afford. Consider the home's purchase price, whether you'll need a mortgage, how much the property taxes and insurance are, and how much the homeowners' association or community fees are

These fees, which typically run a few hundred dollars per month, go toward lawn care and possibly snow removal, as well as community areas like a clubhouse or pool. However, some communities may require additional memberships or fees for golf, tennis, classes, or other activities.



You also need to consider the area's cost of living for other things like food, utilities, transportation, health care and taxes. Numbeo.com and BestPlaces. net offer tools to compare the cost from your current location to where you would like to move. And Kiplinger's has a tax guide for retirees at Kiplinger. com/links/retireetaxmap that lets you find and compare taxes state-by-state.

How active is the community? Some communities provide fitness facilities, swimming pools, tennis courts and more, along with dozens of organized activities, classes and social events. Other communities are much simpler and more laid back with very limited amenities and structured activities. You'll want to choose a community that has the types of people, facilities, activities and vibe that appeals to

Will we like the surrounding area? Will the area around your prospective community serve your needs now and in the future? Ideally, this means having easy access to good doctors and hospitals, and a local airport if you plan to travel much. You'll also want to research how far you'll be from essential services like grocery stores, banks and pharmacies, as well as dining, shopping, and recreational attractions.

### Schedule a Visit

Once you've narrowed your choices, call to make an appointment and visit them. Be sure to allow plenty of time at each community and, if possible, go back to your favorites more than once. Also be sure to ask questions while you are visiting, particularly about the community rules.

Some developments will let you stay overnight in a model home for a few nights to get a feel of what it would be like to live there. While you are there, try the amenities and activities, and speak with as many residents as you can.

focused on the financial cost of dying as illustrated by the recently

released Goldman Sachs "Cost of Dying Report". But of course, the death of a loved one comes at a much higher cost than just financial. There's the personal side of loss, too, which has many different facets.

# THE COST IN LOST TIME

On average, the report found that families spent 420 hours over 13 months completing all the tasks needed to settle a loved one's estate after death. However, the time commitment shot up to 20 months for estates that required the court process of probate. Additionally, most respondents underestimated how long these tasks would take: 54% said it took longer than they expected, while 31% said it took much longer.

To give you some idea of what consumed families' time most during these months, the report breaks down the responsibilities that respondents reported taking the longest as follows:

Most Time-Consuming Tasks The funeral: 55% Financial matters: 47% The will and probate: 45% Paying bills, debts, and taxes: 41% Dealing with the house or other property: 25% Finding service providers: 23%

Reducing The Time Burden for Your Family

With proper estate planning, you dramatically reduce the time your surviving loved ones will have to spend on many of these tasks. For example, by preplanning and prepaying your own funeral, you can greatly reduce what most families reported as the most time-consuming task.

For other tasks, such as dealing with probate and paying off estates with debt, you can use estate planning to eliminate the need for your family to deal with these issues. One other unnecessary task we see families spending a lot of time on is simply locating all of a loved one's assets when they die.

"Bereavement is emotionally and physically taxing, writes BJ Miller, MD, in the report's section on dying's mental cost. "It's hard on your body, it's hard on your mind, it's hard on your life. By not talking about it openly, we have made it much harder than it needs to be."

One positive part of this situation is that when those enduring loss are properly educated and informed about what to expect and how to best deal with these responsibilities, things do get easier for them.

'The good news is that when we give them the guidance they need, when we fill that knowledge gap, the bereaved tend to feel a lot better," says Miller.

May 7, 1959 was the date my love affair with the Los Angeles Dodgers and Vin Scully began. This was the date that I attended my first official Major League Baseball game. Another well remembered moment occurred between the fifth and sixth inning when the Public Address announcer (I wish it was Vin Scully but I don't think it was) informed the crowd that all lights were to be put out and the gigantic crowd was instructed to light matches. The sight was electrifying. The Coliseum suddenly burst into a mass of blinking stars. In my mind's eye which, unlike my actual eyes, does not need glasses, I can still see the matches burning in the darkness.

Why do I choose this particular time to tell this story? Of course it is all brought to mind by the recent passing of Vince Scully who called the Dodger games for 67 years beginning even while the Dodgers were still in Brooklyn. For my dad and me and for so many others Vince Scully was more than the voice of the Dodgers. He was the Dodgers. Already I have received 6 emails describing the importance of Vin Scully to my friends. They, like me and my Dad listened to him on transistor radios as he told humorous stories still managing to keep track of the game. He was an old friend whose voice, listened to on warm summer nights in our non-air conditioned apartments made life tolerable, even fun. Go Dodgers!

After my Dad lost his vision we listened to Vin every night of the season and believe it or not we were pretty happy. Sure we had to get up at 5:00 a,m to begin my dad's route, but it was fine as my Dad couldn't see my questionable early morning driving. It was actually a pretty wonderful time for me as my Dad and I would discuss the previous night's Dodger game and remind each other about the humorous stories that Vin had constructed during the game. Of course I also had the opportunity to hear my Dad's stories about growing up in the Ukraine and surviving life-threatening times. I want you to understand that there was sometimes humor in these stories like my dad's adventures with his constantly wandering cow. These stories were always mixed in with our discussions of Dodger games and how Vin Scully's wonderful voice and tone allowed us to feel like we were right there at the game and pretty pleased with our self as we coped with a very difficult situation It sort of reminds me of today.

Sure we live in a capitalistic society which is all about money and I recognize that the Dodgers have been awfully good at the money game. Inadvertently or not, the Dodgers are responsible for wonderful consequences which have broken racist, ethnic, and gender barriers. Perhaps Jessica Mendoza, the female Latina super-star now calling the Dodger games from Vin Scully's old seat, or right next to it, is a harbinger indicating the potential bring down the sexist gender barrier presently preventing females from playing in the major leagues.
