#### SIERRA MADRE NEWS BRIEFS

#### **BALLOT MEASURE NAMED MEASURE HR**

The ballot measure that will appear on the November ballot opposing the "Meadows at Bailey Canyon" project was officially named late Friday. Based on information received at press time, voters will be casting their votes to either approve or reject Measure HR (Hillside Residential).

In a related matter, the Sierra Madre City Council will meet on Tuesday, August 23, 2022 to formally develop their ballot statement opposing the measure.

#### U.S. MARSHALS PERFORM A SEX OFFENDER COMPLIANCE CHECK ON E. MIRAMONTE

On Friday morning, several members of the Los Angeles U.S. Marshal Service conducted a compliance check at a home on E. Miramonte where a registered sex offender resides. Deputy Olvera of the USMS in Los Angeles confirmed the activity Friday afternoon.

Because of the proximity of the home to a school, school authorities were alerted the day before that the activity would take place and that the officers would be armed.

A check of Megan's Law website (www.meganslaw.ca.gov) for offenders in the area does reveal that AWest resides on that street. According to the site, Awest was convicted of "Lewd or lascivious acts with a child under 14 years of age" in 2006 and released from prison in 2014. Upon his release he was required to register with SMPD and listed on Megan's Law list.

#### PROGRESS AT THE POST OFFICE



As you may have noticed, the landscaping of the Sierra Madre Post Office has taken some giant steps forward and we are ready to announce more.

FormLA, the landscape architecture firm that specializes in drought tolerant native landscaping has been busy with the design and they are ready to reveal it. On Tuesday, August 30 at 6pm there will be a Zoom presentation and everyone is invited. The landscape architecture team of Cassy Aoyagi, Eric Crow and Isara Ongwiseth will do a presentation of the final design and are looking for the public's feedback. If you want to be part of the big reveal, go to: www.formlainc.com to register.

In preparation for the final design, you may have noticed some additions at the Post Office. One of our intrepid volunteers designed, built and installed a new bench for the front that also covers the new irrigation valves and matches the mid-century design and colors of the building.

We also installed the foundation for the non-flammable walkway that is part of the landscape design. Other ongoing preparation work includes the digging of the new swale, the addition of new topsoil and the digging for the new irrigation system. The plants can't go in until all the hardscape has been finished.

The project has also received a generous donation from Rainbird that will cover all the irrigation needs. Fun Fact: The founder of Rainbird lived in Sierra Madre! We are planning a public demonstration on how to install a Rainbird drip irrigation system for native plants so please keep an eye out for the announcement.

Our future public demonstrations will cover how to create a swale to capture rain water and how to plant native plants. We expect those presentations to take place in October and

#### PHASE I OF "THE MEADOWS" PROJECT APPROVED BY THE PLANNING COMMISSION

#### It's off to City Council 3. Fourteen units will comply for a final vote

Well, the dog days of summer are winding down, the kids are back in school, and The Planning Commission has given a passing grade to The Meadows at Bailey Canyon Project, with some minor adjustments agreed upon by the developers.

During what would be continued public hearing number six on Thursday, August 18, the Commission was presented with these familiar options:

A. Certify the Environmental Impact Report (EIR) and adopt the Mitigation Monitoring and Reporting Program;

B. Approve the Specific Plan; and C. Approve amendments to the General Plan and Land Use Map and Zoning Code and Zoning Map to change the project site from Institutional to Single-Family Residential Specific Plan Overlay; and

D. Approve the Lot Line Adjustment, and

Approve the Development Agreement.

At the August 4th meeting, The Planning Commission hit the developers with requested revisions to the Specific Plan, Development Agreement, design guidelines, and park design. Some of the revision requests to the Specific Plan included clarifications on maximum height, identifying the amount of 2-story houses proposed, allowance for appeal, mandatory recommendation, and notice requirement for the Final Park Design.

Revisions requested for the Development Agreement include an amendment to read those offsite improvements commence before the issuance of the first building permit, and construction should be complete before the 11th building permit. This is regarding Carter Ave.

Jonathan Frankel of New Urban West, Inc., presented red-lined revisions to the Commission at the meeting before a packed room Thursday night. Frankel did offer the following adjustments.

The improvements to Carter Ave. would comply with requirements and be completed "well" before the new public park is completed.

2. They have adopted a way to

calculate the floor area except for small entryways and foyers connected to a staircase that do not exceed 180-square feet.

with the angle plane height requirements in the Municipal Code.
4. Confirmed that the maximum

retention wall height will be six feet, except for privacy walls between existing Mater Dolorosa Retreat Center Gardens and The Meadows, for which developers request eight-foot walls. The walls will be fully screened with landscape.

5. The final park approval will be subject to a public design process with Community Services review and approval, and a public notice will be mailed to those homeowners in adjacent properties. Appeals to City Council and Community Services Commission are permitted.

Clarified that minor modifications may be approved by the City Manager upon the written recommendation from the Director of Planning and Community Preserva-tion. Notice of applications for minor modifications will be provided to the Planning Commission and City Council. Developers also agreed to lower allowable deviations in height from 20% to 10%, making the maximum height 27.5 feet.

The maximum floor area may not be exceeded unless a variance is granted in accordance with existing code requirements. Future homeowners will be subject to the regulations included in the Specific Plan.

The public had a chance to comment on this subject once again. Comments included some of the same concerns over fires, water usage, and drought situations to impact the surrounding communities and lack of outreach. A few members of Mater Dolorosa pushed for final approval and commented negatively about how long this process has taken.

But, the final result after meeting 6 is the approval of Resolution 22-10 certifying the Environmental Impact Report, Resolution 22-11, approving the General Plan, Land Use Plan Amendment, approval of the Zoning Map, Lot Line Adjustment, approval of the Specific Plan (with some minor revisions) and acceptance of the Development Agreement (also with some final edits). The developers have already agreed upon the requested revisions.

Next stop City Council. Stay tuned for announcements when City Council will vote on The Meadows Project. Phase Two of the Project, which includes the Tentative Tract Map and Design Review Permit, is subject to a Five-Hearing Rule. New Urban West has 24 months to complete the application for these two entitlements.





#### **MORE MISINFORMATION**

Much misinformation continues to swirl around the Meadows Project. It is easier to leap to a conclusion without doing diligent research into the City's Municipal Codes and ordinances. It is so

much easier to form an opinion and then promote it as fact. All this talk about religious discrimination is troubling. Sierra Madre is a community of churches with worshipers of every denomination regularly attending the church of their choice.

It seems strange that knowing this, our elected officials would support any provision of our local laws that would discriminate, restrict or discourage any of us from expressing our religious beliefs. Yet, supporters of the Meadows Project argue that rezoning the Mater Dolorosa property to Residential Hillside (R-H) does just that.

Let's dig a little deeper and do some research into our municipal codes. SMMC Section 17.52.070 C (1) of the Hillside Management Zone (Chapter 17.52)

"Uses in the R-H Zone requiring a Hillside Development Permit. The following uses of land shall be allowed subject to the granting of a hillside development permit in compliance with this chapter: 1) Any primary or accessory use permitted in the R-1 one family residential zone (as set forth in Section 17.60.030"). This section states: "The following uses....shall be permitted in the zones as hereinafter set forth in the following." A. "Conditional uses-All zones except the Open Space and Resource Conservation Zone include Churches, temples and other places of worship."

To clarify, the Initiative places the Monastery property in an R-H Zone. A clear reading of this section is that "churches, temples and other places of worship are permitted in an R-H zone. "Other places of worship" is a purposefully all-encompassing term that broadly includes a "retreat center" and "religious depictions". To interpret this otherwise is suspect.

Under the Initiative, the Passionists would be allowed to construct religious -based structures on their property upon submission of a hillside development permit, which the City would have no basis to deny. The conclusion that any section of the Sierra Madre Municipal Code would prohibit the right of a religious organization to exercise it's religious freedoms in contradiction of the Religious Land Use and Institutionalized Persons Act, which has as one of its purposes to ensure religious uses in nearly all zoning districts, makes no sense. Those seeking to further divide us by arguing religious persecution are way off base and factually incorrect. Those who wrongly say the Initiative will not allow for the expansion of the Retreat Center kitchen are grasping at straws. In reality, the Initiative does not affect the ability of the Passionists to expand any existing facility, i.e. the Retreat Center, or construct a new one under their operation as a place of worship and arguing otherwise is misleading.

With so much information swirling around this complex, ever-changing project, readers are urged to go beyond the glib statements of those seeking to destroy the small town ambiance of our community, research the facts for yourself and discover the truth.

#### TOO MUCH RHETORIC

There was so much rhetoric about the Meadows project in last week's paper that it is hard to know where to start. This week we will quickly respond to the key points.

Preserve Sierra Madre

Complaint: The developer would add a new gate to Bailey Canyon: The Passionists already own their own gate to Bailey Canyon. The city can control two gates. Since when is making a park more accessible to the public during open hours a bad thing?

Stop Housing Project

Complaint: SMNFF articles are unsigned: Our Steering Committee publishes all content and we are listed at: sierramadreneighborsforfairness.org/committee. we can't find is a single name listed on the Stop Housing Project website, not even in the posted text of their initiative where it conveniently cuts off at the proponents' signature pages.

Complaint: Entirely unsubstantiated suppositions were made that could be considered libelous: Vague accusations are standard from the proponents of the initiative. We invite them to provide any facts we got wrong.

Complaint: That SMNFF said an initiative proponent worked for a developer of luxury homes: According to the Linked-In information at the time it showed that a proponent was a senior vice president for a large developer. It now shows they worked there while signatures were collected and through June 2022. It is relevant to us that this was not disclosed. It certainly was a Fair question to ask when the initiative allows sixty-eight 6,500 square

Compliant: That we implied that a Resort Developer must have its eyes on the 17 acres of monastery property: Actually, it was the 35 buildable acres that the initiative rezones. We don't know what the proponent's intent was, that is why this information needs to be disclosed. All three proponents were knowledgeable about both legal matters and real estate... yet somehow failed to tell anyone that sixty-eight 6,500 square foot homes could | SierraMadreNeighborsforFairness.org

be built after their initiative passes. Why do they support mansions in Sierra Madre and oppose a public park? Either they know what they are doing or they don't know what they are doing. We will let the readers decide.

Complaint: That we suggested that the developer of luxury homes must be funding the initiative: We never said that, but it is a Fair question.

Claim: 229 donations on STOP's GoFundMe page came from ordinary citizens: Of the currently 233 donations, only 91 unique donors are listed, less than 1% of the city's population. 75 donations are listed as Anonymous totaling over half the donations (\$22,083). There are two anonymous \$5000 donations; that seems like a lot for an "ordinary citizen" to give. Who donated these large sums?

Claim: Donations paid for STOP's attorney whose initiative will allow the CITIZENS to decide what is right for Sierra Madre: Before they donated did you tell them that sixty-eight 6,500 square foot mansions could be built after your initiative passes and that the city can't stop them? What else are you hiding?

Complaint: New Urban West has spent many times more than raised by STOP's Go Fund Me: SMNFF has disclosed from the beginning that we are working with the developer to protect the rights of the Passionists, and now to prevent sixty-eight mansions from possibly being built in the city. See? This is what disclosure looks like. We have nothing to hide.

Complaint: It is a ridiculous allegation that "68 large houses [could be built] under the initiative": The City Attorney's 9212 report states under A COMPARISON OF THE INITIATIVE AND THE MEADOWS PROJECT a. 6. "35 Acres State Permitted Maximum Density: 68 units, Maximum Gross Floor Area: 6.500 sq. ft./ unit." Why is STOP pushing so hard to stop a public park and 40 acres placed in conservancy while allowing mansions in Sierra Madre? The citizens deserve answers.

Dear Editor:

Oh my, libel and mud-slinging all in one paragraph. This accusation is in a recent MVN column. Rare coming from the columnist who has for months accused our City Council, the City Attorney, and City workers for being on the take, of the developer for underhanded tactics, and some of the public for being "bought" for coming out against the initiative. There was even an insinuation in front of a City Council meeting that the new fire truck purchased by the City was a bribe to the City to make sure the project was approved. One phone call to the City would have cleared that accusation up in a hurry. And, oh, by the way, the initiative still allows all 34 acres of the Mater Dolorosa property to be changed to hillside residential, not just 17 acres and 8 homes claimed by the framers of the initiative on every occasion imaginable. Here are some facts:

- The Initiative takes away the rights of one property owner who has legally filed to the City for a change in property use.
- The Initiative uses the strictest wording to change and you'll decide for yourself to vote NO on this what it called "only 17 acres" by some, but in actuality all of the 34 acres of buildable property. Pat Alcorn This has created a Religious Rights Violation

including some of the use and rights of the Mater Dolorosa community.

- It won't stop houses to be built, and actually creates mansions. It creates the possibility of 6500 square foot houses – far larger than planned by the Passionists.
- It won't preserve the meadow, the wildlife, water
- It creates legal issues for the City in terms of Religious Rights Violations.
- It ties the hands of the City to be able to consider any change in zoning should the initiative be

An in-depth analysis of these six issues will be coming in the next few weeks leading up to the election. In he meantime, do some homework yourself. Read the nitiative to see the actual wording of this legal document destructive ballot measure.

Dear Editor:

Robert Gjerde opened his letter in last week's paper with a startling observation - that we're "now six months into the discussion on the initiative to rezone the monastery property to the Hillside Residential zone." But in all this time, I still haven't heard a cogent argument as to why the developer is investing so much time, effort and money to avoid having to proceed under our Hillside Management restrictions.

Given arguments presented, you'd think a major concern of the developer and their investors is protection of religious exercise by the Passionists. They may very well be devout churchgoers. But to suggest motivation is anything other than maximizing return on investment, or that concern over the Passionists' free exercise of religion plays any part in this - one would have to assume developer New Urban West cares.

And then the other argument - they object to restrictions that would be imposed under our Hillside Management zoning because they wouldn't be restrictive enough. ("allows for 6,500 sq ft homes"!) I've yet to encounter a developer who objected to proposed rezoning because it would allow for greater development than what they had in mind. Pat Alcorn asks, "What are they hiding?" I'd like to know what it is in our Hillside Management restrictions that New Urban West finds such a deal-killer.

Another question raised (though not by anybody other than the developer and their proponents) has been why so many of us have endorsed this petition requiring compliance with our Hillside Management restrictions. According to Neighbors for Fairness, it's because signa-

ture gatherers told us lies. They won't explain how what we've been told necessarily contradicts the facts - but confidently assert we've been lied to, nonetheless.

Our Mayor Gene Goss takes it in another direction as he was quoted in New Urban West's full-page ad in this paper a few weeks ago, "I think a lot of them would be opposed to this if they looked at it closely." Suggesting to your constituency, especially one with a notably high income and educational demographic, that they might lack the sophistication necessary to read and understand the fine print themselves is not a particularly good look for any elected official. It might be better to simply tell us what we'd find if we did indeed look more "closely".

And then there are Councilmembers suggesting we should simply roll over because the developer threatens a lawsuit. Great - just the message we want to send - that if anybody wants to do anything anywhere in our town, all they have to do is threaten litigation and Sierra Madre's leaders will cave.

So – in these past six months I've heard the arguments: New Urban West and their investors are on a quest to safeguard religious freedom. They refuse to comply with our Hillside Management restrictions because it would allow them to build bigger houses than what they'd planned. Those who signed the Petition did so because they were lied to and/or were just too dumb to understand what they were signing.

I've been involved with a number of political campaigns, but if I were engaged as a consultant on this one, I'd have to say, "C'mon, guys - if you really want to shut this down, you'd better come up with something that makes sense!" Howard Hays, Sierra Madre





#### Custodian Handcuffed Held at **Gunpoint**



Pasadena police released video this week after the local community became outraged over a longtime Pasadena Unified School District janitor being mistaken as a burglar Sunday morning at San Rafael Elementary School.

The Body Cam video shows the unnamed custodian shortly before 9 a.m. being handcuffed, on his knees, at gunpoint although he identifies who he is.

The custodian was held for over six minutes as officers confirmed who he was with the school principal, Rudy Ramirez.

The original 911 call was also made public. The caller said that someone had climbed the school's fence with a

backpack and a bag.
Interim City Manager
Cynthia Kurtz said in a statement that officers acted professional and consistent city and Police Department policies.

She said that the guns used by the officers were nonlethal with foam bullets.

#### **Pasadena Police Make Arrest** in Stabbing

Pasadena police arrested a 26-year-old Man from Los Angeles Saturday night for the alleged stabbing murder of a man in North Central Pasadena earlier that night.

According to detectives, at about 10:53 p.m. officers responded to the 600 block of North Lake Avenue regarding an "Assault with a Deadly Weapon" call. On arrival, officers located an unresponsive male in the street suffering from multiple stab wounds. The victim was pronounced deceased at the

Within a few minutes of the original call, a male suspect was detained by officers a short distance away from the crime scene. The suspect, identified as 26-year-old Sadarius Lawson of Los Angeles, was booked at the Pasadena Police Department for murder.

Detectives from the Pasadena Police Department's Robbery / Homicide Unit responded to the crime scene to commence immediate follow-up investigation. The



## Letter by Pasadena Mayor: San Rafael Elementary School

To the residents of our community and the parents of the children who attend San Rafael Elementary School:

As Mayor of Pasadena, and as an alumnus of PUSD schools, I represent a very diverse population and feel it's imperative to address the actions of San Rafael Elementary School Principal

On Sunday, August 14, a resident called the Pasadena Police Department, believing a possible crime was in progress at the neighborhood elementary school. Our Police Department responded as they will with every call for help received, and located an individual on the campus who was later identified as the school custodian. In the context of what has happened recently in schools across the country, it is appropriate for our officers to respond to all concerns involving our schools and

While I was not there, I reviewed all videos and reports of the incident. Our Police Department did detain the custodian, subsequently verified his identity, and he was released within six and half minutes. We believe our officers acted professionally, respectfully, and with caution while responding to a call by a

As leaders of our City, school district, and schools, it is our collective responsibility to act professionally and work together to resolve issues. Our comments are a reflection of ourselves, and as leaders we need to set an example for the students and young persons in our community. We represent the people of our community, and there is no place for divisive statements or jumping to conclusions before facts are made clear.

Principal Ramirez made very derogatory racial remarks that were caught on camera and recorded in a report by the school district's security officer. He made remarks that were not factual and were inflammatory. As a leader, mentor and supervisor, he is held to a higher standard, and should be held accountable for the impact his behavior has caused. A school principal is a leader and educator of educators who ultimately shape the minds and views of our children. Whether during work hours or responding after hours, his demeanor, professionalism and judgement should not

Race-based denigrating statements are never appropriate. Biased statements directed or intended to denigrate people based on skin color were wrong in times long past, wrong on Sunday, and will always be wrong. There is no place in our society for these types of statements, and certainly not in Pasadena. These denigrating biased statements made by Principal Ramirez are offensive, and on behalf of my constituents, I have a difficult time accepting his

The City of Pasadena will continue to work diligently to build trust and communication between our police, the school district and our community. We will continue our commitment to supporting our school district so they may provide students with the best educational opportunities possible, as education is the key to stomping out ignorance, hate, and systemic racism wherever it exists. The answer to past racism is not more racism. We should always denounce hate and racism whenever and wherever we encounter it.

## **Huntington Acquires the Archive of LA Architects** John and Donald Parkinson

The Huntington Library, Art Museum, and Botanical Gardens has acquired the archive of notable early 20thcentury Los Angeles architects John and Donald Parkinson. The little-known cache contains more than 20,000 items, including drawings, blueprints, office records, photographs, and ephemera. Adding dramatically to The Huntington's growing strength in Southern California architectural history, acquisition was made possible by the donation of Wm. Scott Field, a restoration architect who took great care in stewarding the archive for

The Parkinson archive unlocks the process behind the creation of some of the most iconic buildings in Los Angeles," said Erin Chase, assistant curator of architecture and photography at The Huntington. "Spanning 100 years, and chronicling the firm's work in such detail, the collection will be the cornerstone of our Southern California architecture and planning materials documenting the growth of our region in the early 20th

The firm's landmark buildings in LA include Bullocks Wilshire; Braly Block, the city's first skyscraper; the Homer Laughlin Building (now Grand Central Market); Los Angeles City Hall; the Memorial Coliseum; and Union Station, in addition to the campus master plan for USC. These buildings were either designed by John Parkinson and his partner Edwin Bergstrom (Parkinson and Bergstrom, 1905–1915) or by John and his son, Donald Parkinson (Parkinson and Parkinson, E. and Arabella Huntington's from 1894 to 1994, during Huntington supports research successors developed more than 400 structures. The wealth of materials from the early 1900s to the 1930s demonstrate the rapid growth of Los Angeles

at that time. Walking in downtown Los Angeles, one can see a Parkinson building in almost every direction," said Stephen Gee, author of Iconic Vision: John Parkinson, Architect of Los Angeles. "The Parkinson collection is a treasure trove of rare materials that tells the



story of an architect considered by many historians to be one of the founders of modern Los Angeles. This archive is an incredible tool for researchers and scholars who want to understand how Los Angeles grew from an outpost to a major metropolis on the West Coast."

The Parkinson archive includes nearly 20,000 original ink-on-linen detailed drawings and blueprints created by the firm, as well as books from the firm's architecture library, business records, project photographs and slides, and ephemera. It enhances Huntington's existing The Los Angeles architecture collections, which include the papers of architect Wallace Neff; the Foss Construction Company; and the Morgan, Walls, and Clements firm.

"Forming the core of this collection are thousands of original drawings created by the firm," said Sandra L. Brooke, The Huntington's Avery Director of the Library. "These are one-of-a-kind, richly detailed renderings that, for many buildings, cover the entire scope of the project from elevations and floor plans to technical specifications and design details. They are in extraordinary condition, a testament to the donor who took great care in managing the archive for decades. We couldn't be more delighted with this landmark acquisition."

## SCHIFF, L.A. CONGRESSIONAL DELEGATION: MORE MONKEYPOX VIRUS VACCINES NEEDED

As County Caseload Explodes, Vaccine Supply Through FDA's Alternative Dosing Regimen Still Falls Short of Projected Demand

Los Angeles, Calif. – Today, Congressman Adam Schiff (D-Burbank) and 10 members of the Los Angeles County area Congressional Delegation sent a letter to U.S. Health and Human Services Secretary Xavier Becerra highlighting the urgent need to increase the supply of the monkeypox virus vaccine. This comes as the L.A. County Department of Public Health reported more than 100 new cases over the weekend and that its vaccine supply is expected to run out in the next two weeks, forcing them to pause pre-registration for appointments.

"We are encouraged by the Biden administration's recent actions declaring monkeypox a public health emergency and issuing an emergency use authorization to help expand JYNNEOS vaccine supply. While these are critical steps in the public health response to MPV, we strongly urge the Department of Health and Human Services, in coordination with the White House, to take further steps to procure and distribute additional JYNNEOS vaccine doses to ensure areas that have been hardest hit, including Los Angeles, have adequate vaccine supply," the members wrote in the letter.

Congressman Schiff first wrote to Secretary Becerra on July 20 urging the federal government to bolster its monkeypox virus (MPV) response, including by increasing the manufacturing and distribution of vaccines, supporting more health care provider and community outreach, and developing a long-term strategy to ensure access to testing, vaccination, treatment, and provider education for years to come.

On August 9, after public health experts and elected officials like Congressman Schiff raised the alarm about the United States' limited supply of MPV vaccine doses, the FDA announced it had granted Emergency Use Authorization for the JYNNEOS vaccine to be administered intradermally, increasing the number of doses available through the existing supply. However, clinical data available about the alternative dosing regimen is limited to a single 2015 study, and will require urgent and comprehensive outreach to health care providers on how to use the more specialized administration method.

Furthermore, while the existing vaccine supply and alternative dosing regimen could fully vaccinate 1 million people, the CDC estimates about 1.7 million people are currently at the highest risk for MPV infection – and as cases continue to climb and the virus spreads beyond the communities already impacted, the highest-risk population will inevitably grow. In Los Angeles County, more than 100 new cases were reported just last weekend, and the Department of Public Health has nearly exhausted its current vaccine dosages. Therefore, the members are encouraging the federal government to look beyond the emergency use authorization and take additional steps to increase its overall vaccine supply.

"As of August 12, 2022, Los Angeles County – the most populous county in the United States with over 10 million residents – has received only 43,290 doses of the JYNNEOS vaccine. Supply is not meeting demand, and as the virus continues to spread demand will inevitably increase. While we are encouraged by the potential to expand the number of available doses through implementation of intradermal administration, this approach alone will not suffice," the members added.

#### LA COUNTY HEALTH UPDATE

As COVID-19 Numbers Continue to Improve, Residents Can Take Steps to Protect the Most Vulnerable

4,274 New Positive Cases and 13 New Deaths Due to COVID-19 in Los Angeles County

As Los Angeles County's COVID-19 cases, hospitalizations and deaths continue to decline, residents can help protect those who are the most vulnerable to the virus. Residents can help reduce the high rate of transmission by being fully vaccinated, getting tested when exposed and before gatherings, masking indoors, and staying home while sick or recovering from COVID-19.

The Omicron variant continues to account for 100% of sequenced specimens and the BA.5 subvariant of Omicron remains the most predominant subvariant. In the week ending July 30, 88% of all sequenced specimens in LA County were BA.5. The Centers for Disease Control and Prevention (CDC) estimates that, across the country, as of the week ending August 13, the BA.5 subvariant accounted for 89% of specimens.

The relative proportions of other key sublineages Public Health is tracking changed only slightly, including BA.2.12.1 which has declined to 4%, and BA 4.6 which remains at just over 1.5%. To date, only three specimens of BA.2.75 have been detected, indicating no increased circulation of this sublineage here. This is welcome news since it indicates that the new strains currently circulating remain at a low level and do not appear poised to outcompete BA.5 in the very near future.

The 7-day average case count today is 3,577 cases, a 2% drop from 3,660 cases a week prior. The 7-day average test positivity rate over the past week also declined slightly to 10.1%, from 10.7% one week ago.

Over the last seven days, the average number of COVID-positive patients per day in LA County hospitals was 1,009, a decline of 10% from one week ago when the 7-day average number of COVID-positive patients per day was 1,118. The CDC reported LA County's hospital admission rate at 8.9 weekly hospital admissions per 100,000 people, a decrease from the rate of 9.9 reported a week ago.

Deaths, which typically lag hospitalizations by several weeks, dropped slightly to an average of 13 deaths reported each day this past week, compared to an average of 14 daily reported deaths one week ago.

Getting vaccinated continues to provide protection from severe illness and hospitalization, especially for the most vulnerable residents living in communities with high rates of poverty. For the 30-day period ending August 4, unvaccinated residents living in the highest poverty areas were 11 times more likely to be hospitalized than their vaccinated counterparts. And while 77% of LA County residents age 5 and older are fully vaccinated, only 35% of children 5-11 years old are fully vaccinated, and less than 7% of children under 5 have received at least one dose.

There are thousands of vaccination locations across the county. Residents can visit the Public Health website at VaccinateLACounty.com or VacunateLosAngeles.com (Spanish) to find locations, and schedules for clinics offering COVID-19 vaccines.

"I send my deepest sympathies and wishes of peace and comfort to the many families who have lost a loved one from COVID-19," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "While lower case and hospitalizations are welcomed, the continued high rate of transmission places many individuals at elevated risk of getting infected, and, for some, there can be serious consequences to a COVID infection. People facing higher risk from COVID include many of our family and friends, along with community residents we encounter every day. Older people, people with underlying health conditions, those who are immunocompromised and those who are unvaccinated are all at elevated risk of experiencing a bad outcome if they get infected. There are also many who face higher risk because their job brings them close to a large number of people. These are often the people we rely on every day to provide food and medicines, to take care of us when we are sick, to drive our buses and trains, to teach and care for our children, and to provide us with essential goods and services. Others face higher risk because they live in very dense communities and overcrowded housing, where viral spread is easier. Living through times of high viral transmission, is like getting through a bad storm. While it is very helpful if each of us is able to have good rain gear, when the storm is of long duration, we often need additional help from others. Having everyone masking when indoors, testing when exposed or sick, staying home when ill, and being up-to-date on their vaccines, provides additional protections that can make a difference for those must vulnerable."

Friday, Public Health reported 13 additional deaths and 4,274 new positive cases today. Of the 13 new deaths reported today, one person was between the ages of 30 to 49, three people were between the ages of 50-64, two people were between the ages of 65-79, and seven people were aged 80 years or older. Of the 13 newly reported deaths, 11 had underlying health conditions. To date, the total number of deaths in L.A. County is 33,003.

Public Health has reported a total of 3,375,907 positive cases of COVID-19 across all areas of L.A. County. Today's positivity rate is 10.1%.

There are 940 people with COVID-19 currently hospitalized. Testing results are available for more than 12,422,000 individuals, with 24% of people testing positive.

#### ALTHOUGH MONKEYPOX VACCINE SUPPLY REMAINS LOW, PUBLIC HEALTH TO BEGIN ADMINISTERING SECOND DOSES

On August 9, 2022, the U.S. Food and Drug Administration (FDA) issued an Emergency Use Authorization (EUA) to allow the JYNNEOS vaccine to be given between layers of the skin (intradermally) for people 18 years of age and older at high risk for monkeypox infection. The recent EUA also allows the vaccine to be given beneath the skin (subcutaneously) for people younger than 18 years of age at high risk for monkeypox infection.

This change makes it possible for the number of monkeypox vaccine doses in the country to increase five-fold, as one vial of vaccine can now potentially yield five doses instead of just one dose. Based on the earlier federal allocation plan, LA County expected to receive 14,000 vials this week, which would have yielded an estimated 70,000 monkeypox vaccine doses for eligible LA County residents.

However, the federal government clarified earlier this week that LA County will receive 5,600 vials (totaling 28,000 doses), not 14,000 vials. Public Health has received assurances from the federal leadership that additional doses will be available in the coming weeks.

With the arrival of 28,000 doses later today, LA County will open up eligibility to about 8,000 individuals eligible for their second doses. Residents who received their first dose more than 28 days ago can receive their second dose the following ways:

- Residents who received their first dose through their healthcare provider over 28 days ago should contact their provider to schedule an appointment.
- Residents who registered through the Public Health registration system and were vaccinated at a Public Health location will receive a second text message when their second dose is due with instructions on where to receive their second dose.

There will be an additional 19,000 doses distributed to community providers and public vaccine sites providing first doses to those eligible; 1,000 doses are reserved for close contacts, outbreak response, and special populations.

Eligible residents needing their first dose can now register by visiting ph.lacounty.

gov/monkeypoxsignup.

All first and second doses will be administered intradermally, unless contraindicated. The FDA has advised that those under 18 years of age and adults who have a history of developing keloid scars should get the vaccine beneath the skin (subcutaneously), not between the layers of the skin (intradermally).



#### 3 CRITICAL CONSIDERATIONS FOR HOW TO SAVE FOR YOUR CHILD'S (OR GRANDCHILD'S) COLLEGE EDUCATION

If you have started to save for your child or grandchild's college education, there are many different financial vehicles available to help.

Here's what we think you should consider as you decide which one to use:

First, consider whether you want your offspring to have broader options than just the traditional college

Since the start of the pandemic, college enrollments have declined by over one million students over the past two years, and with college tuition getting more and more expensive, many students are considering alternatives to the traditional higher education path.

Gap years, travel, trade programs, and online training are replacing the traditional college education path for many, and if you want that to be an option for your children or grandchildren, you should be aware that the traditional college savings plans may not be the best fit for your family.

Second, consider the financial aid consequences of how you are saving for college.

If you think your child or grandchild may need or want to qualify for financial aid, beyond student loans, the way you save for their education may significantly impact their ability to qualify. If your offspring will need financial assistance to pay for their education, it's vital that the way in which you choose to save will not negatively impact their qualification for such assistance.

Third, consider the income tax consequences of how you are saving for college.

When you set aside money, unless you are saving for retirement in a qualified retirement plan, the income earned on that money is subject to income taxes. However, with various types of college savings plans, you can defer or avoid income taxes altogether.

529 Plans

Since 1996, 529 plans, which are named for Section 529 of the Internal Revenue Code, have been one of the most popular options for covering college costs. Congress expanded these plans to cover K-12 education in 2017, and it also changed the program to pay up to \$10,000 in student loan debt in 2019.

One reason 529 plans are so popular is due to their tax-saving advantages. The money you contribute to a 529 account grows on a tax-deferred basis, and withdrawals are tax-free, provided they are used for qualified education expenses, such as tuition, room and board, and other education-related fees.

But before you automatically save for your offspring's future education using a 529 plan, keep in mind that to avoid paying taxes, plus a 10% penalty, the money must be used for eligible expenses only. Eligible expenses include tuition and fees, room and board, books, as well as computers and other items if they are required for classwork.

If your child decides not to go to college, you will pay income taxes, plus the 10% penalty to withdraw the funds and use them for something else. Another downside to saving for your child's education in a 529 plan is that your investment options may be significantly limited to only a small selection of mutual funds.

**Education Trusts** 

While 529 plans are quite popular, there is another way to save for your child or grandchild's education using an irrevocable trust. While there isn't any income tax deferral on income earned by the assets held by these trusts, it is possible to structure a trust, so your beneficiaries could qualify for financial aid that they may otherwise be ineligible for with a 529 plan. And in certain circumstances, qualifying for financial aid would be even more valuable than savings on the income taxes owed on income earned by the trust.

In addition to the issue of qualifying for financial aid, another benefit of such trusts is that you can not only save for a single child's or grandchild's education, you can also structure your trust to provide a pool of funds for the education of all family members. Moreover, when creating the trust, "education" can be broadly defined to include any type of learning institution or organization, such as trade schools, educational workshops, community colleges, and private academies, to name just a few options.

Furthermore, you can provide that the trust can pay for alternative education, such as travel, retreats, business building programs, and other nontraditional educational experiences, which may prove even more valuable than college. Bottom line: when you set aside money to educate your family with an education trust, you get to decide exactly how your beneficiaries can use the funds by what is most in alignment with your family values.

Poke is actually a toxic plants that has a long history in the South and Eastern states as a good spring food, when properly prepared. It can be found in the West, but not commonly. I first encountered pokeweed while living on my grandfather's farm in Ohio during the summers. As it matures, poke is a large and fairly distinctive plant so once you've seen it a few times, you really can't confuse it with anything else.


A big misconception about eating poke resulted from the popular 1969 song by Tony Joe White called "Polk Salad Annie." The song was about a girl who picked poke weed, and knew how to prepare it. But if you're from the South, you know that White should have spelled it "Poke Sallet," since "salad" suggests you eat poke raw you can't! - and "sallet" refers to cooked greens, which is the proper way you must prepare poke.

In the spring, the first poke shoots are collected, boiled, and the water discarded. The greens are then boiled again, and then discarded again. Then, after that, you can season and eat the greens. At that point, you can season them with any of the traditional dressings, like bacon fat or butter, or add the greens to soup or casseroles.

Here is how herbalist Susun Weed describes the processing of poke greens: "To make your own sallet: Collect very young poke greens as early as possible in the sea son (late April to mid-May in the Catskills, as early as February in Georgia). Pour boiling water over the greens and boil them one minute. Discard water. Add more boiling water and again boil the greens for one minute. Discard the water. Do this at least twice more before attempting to eat the greens. If you fail to leach out the poisonous compounds -- or are foolish enough to at tempt to eat poke leaves raw -- your mouth and throat will feel like they are on fire, you may vomit, and you will no doubt have copious diarrhea." That's doesn't sound like something enjoyable.

There seems to be scant data in the literature about the use of poke berries for food I have often read that the berries are poi sonous and could kill you and that you should never eat them. According to Don ald R. Kirk, author of "Wild Edible Plants of Western North America," "The berries are reported by some to be edible, and by others to be poisonous. Those that use them make them into pies and jellies."

On our farm, we cooked the berries and made pie. My uncles grew up eating poke pie that their father (my grandfather) made and always enjoyed it. As a new poke eater in my late teens, I simply boiled the mashed fruits, strained out the seeds, sweetened it, and added it to a pie crust. It did have a



ate it and no one got sick. To be fair, some people really love the flavor of cooked poke berries and some will never try it again after the first taste. It's not what I'd call an acquired taste – but it is a unique flavor.

Since everyone's body chemistry is different, I would suggest that you proceed with caution if you decide to try this.

Susun Weed points out that the small seeds in the berries are poisonous. "Lucky for us," she writes in sagewoman.com, "they are too hard for our teeth to break open. I have had pokeberry jam (no worse than blackberry jam, that is, seedy) and pokeberry jelly (ah, no seeds) and pokeberry pie (seedy). Since children are attracted to poke plants and since the berries leave telltale stains on children's mouths and since many parents are frightened if their child eats anything wild, and since medical personnel know little about poke except that it is poisonous, lots of kids have their stomach pumped (for no good reason, since they can't break open the seeds either) after investigating the taste of poke berries

These days, when I read about people getting sick from products made from poke berries, I tend to be a bit more cautious. I would suggest mashing the fruits, straining out all seeds and then boiling it thoroughly. Yes, there are those who always bring up the fact that hard-boiling can destroy some vitamins. Yes, but it's either that or vomiting! I prefer the former! Or just avoid these berries altogether and stick to strawberries and grapes.

The poke berries can also be crushed and made into a paint for artworks, and possibly fabrics. I experimented a little with the ink, and found it to be a refreshing color when brushed onto white art paper.

#### CAUTION:

Yes, you might read in some herbal that the root is good for certain maladies. I suggest that you just leave the root in the ground! The root has sometimes been suggested as a remedy for various inflammations, mastitis, rheumatism, etc., by trained herbalists.

I have often been asked if poke can be confused with any poisonous plants. Well, in fact, poke is a poisonous plant, and so if you eat the young shoots, be sure to cook them twice as described here so you won't

#### WHAT IS AN ANNUAL NOTICE OF CHANGE?

Dear Savvy Senior:

Last year I received a "notice of change" letter from my Medicare provider. Should I expect another one this year, and what should I do with it? Medicare Rookie



Dear Rookie:

The letter you're asking about is actually re-

ferred to as the Annual Notice of Change (or ANOC), which is a letter you receive from your Medicare Advantage or Medicare Part D prescription drug plan in late September. (People with only a Medigap plan don't receive these because Medigap plans do not have benefit changes from year to year). So yes, you should expect to receive another letter next month.

The ANOC gives a summary of any changes in your plan's costs and coverage that will take effect Jan. 1 of the next year. The ANOC is typically mailed with the plan's "evidence of coverage," which is a more comprehensive list of the plan's costs and benefits for the upcoming year.

You should review these notices to see if your plan will continue to meet your health care needs in 2023. If you are dissatisfied with any upcoming changes, you can make changes to your coverage during fall open enrollment, which runs from Oct. 15 to Dec. 7.

Here are three types of changes to look for:

Costs: If you have a Medicare Advantage plan, find out what you can expect to pay for services in 2023. Costs such as deductibles and copayments can change each year. For example, your plan may not have had a deductible in 2022, but it could have one in 2023. A deductible is the amount of money you owe out-of-pocket before your plan begins to cover your care. Another example is that your plan may increase the copayments you owe for visits to your primary care provider or specialists.

Coverage: If you have an Advantage plan with prescription drug coverage check to see if your doctors, hospitals, and other health care providers and pharmacies will still be in network for 2023. You have the lowest out-of-pocket costs if you go to providers and pharmacies that are in your plan's network. If you see an out-of-network provider, your plan may not cover any of the cost of your care, leaving you to pay the cost out-of-pocket. You should also contact your providers directly to confirm that they will still be accepting your plan in the coming year.

Drugs: If you have prescription drug coverage, look through the plan's formulary, which is the list of drugs the plan covers. Formulary changes can happen from year to year, so make sure the medications you're taking will be covered next year, and that they're not moved to a higher tier which will affect your copay. If you see any changes that will increase your costs, you may want to select a different drug plan that covers all of your medications. If the formulary is incomplete, or you do not see your drug(s) on the list, contact the plan directly to learn more.

If you have not received an ANOC by the end of September, you should contact your Medicare Advantage Plan or Part D plan to request it. This notice can be very helpful in determining whether you should make any changes to your coverage during the fall open enrollment. Reading your ANOC can also prevent any surprises about your coverage in the new year.

Shopping, comparing and enrolling in a new Medicare Advantage or Part D plan during the open enrollment period can easily be done online at Medicare's Plan Finder Tool at Medicare.gov/ find-a-plan.

Or, if you don't have a computer or Internet access, you can also call Medicare at 800-633-4227 and they can help you out over the phone. Your State Health Insurance Assistance Program (SHIP), which provides free Medicare counseling, is also a great resource to help you make any changes. To find a local SHIP counselor, visit ShipHelp.org or call 877-839-2675.

#### TOM PURCELL END OF LIFE CHANGES IN MODERN TIMES



A long time ago I watched a We've moved death from our homes and commudocumentary about poet Emily Dickenson's life and writings.

One thing that I never forgot about that film is that she lived at a time when death was regrettably common — and therefore the subject of many of her poems.

"How are you doing?" is a polite way of introducing ourselves to each other now.

But as I learned in that documentary, this greeting during Dickinson's times meant, "Are you healthy and well and going to be with us tomorrow?'

Until modern times, dying commonly affected all age groups.

Women died during child birth. Children died from a variety of maladies.

The rich as well as the poor suffered tragedy and loss almost equally.

Haider Warraich, the doctor who wrote "Modern Death: How Medicine Has Changed End of Life," explained in an interview that in the 1800s in Boston or London people died mostly of three things: injuries, infections, or some type of nutritional

"Really," he said, "death was a very binary event and it was very sudden.

"For example, before the advent of medical technology, if someone had a heart attack or if someone had some type of abnormal heart rhythm such as ventricular tachycardia, they would almost certainly die, in many cases instantaneously, sometimes even in their sleep."

Warraich said that dying today is no longer an "instantaneous flash event," but a "phase of our life."

New technologies enable people to live longer even if they have chronic diseases, so they are in and out of hospitals — as my dad was the past five months. Today we've become disconnected from death, Warraich said.

nities to hospitals and nursing homes - where four of five Americans now die.

When my father's father died at only 34 in 1937, he died in his own bed of streptococcus, now easily cured with penicillin, and was laid out in the parlor

We'd hoped my father would meet his end peacefully in his own home.

After repeated visits to the hospital and skilled nursing facilities, we brought him home and hired

We celebrated his 89th birthday at his home a few weeks ago in epic fashion. A glorious event, it was attended by the large extended family he and my mother produced.

When his time finally came, he was back in the hospital, but he was surrounded by his family and his wife of nearly 66 years. As advances in technology change the way we live

and die we are becoming fearful of death — yet it's something every one of us is going to experience. I'm honored to say that my sisters and mother and

I fully embraced my dad's life and supported him with everything we had in his last painful months. Knowing he's at peace now quells the hurt of watch-

ing him suffer so much for so long. I believe he is in Heaven now, reunited with his

parents, and I believe I will see him again. I will wait patiently for that grand reunion.

"How are you doing?" is the question of the moment. I wish you the very best if you are in your end stage

of life now or caring for someone you love who is as you navigate the challenges of dying in mod-






