COUNCIL APPROVES MEADOWS AT BAILEY CANYON PROJECT

On Tuesday, Sierra Madre Mayor Gene Goss presided over the continued Public Hearing regarding the controversial Meadows at Bailey Canyon Project. He began by asking the council and public to "agree to disagree" in a civil manner and adhere to addressing the stand alone agendized issue of either ratifying or rejecting the project.

Goss promised not to exercise his ability to 'cut the mike' for speakers who exceeded the 3 minute time limit as was the case at the previous hearing. However, while asking speakers to respect the time limit he also asked them to restrict their comments to the matters on the agenda. He pointed out that Measure HR was not on the agenda and that public comment should only bring up the matter if it related directly to the items on the agenda.

The council was then tasked with deliberating and approving or rejecting the following Planning Commission recommendations for the project:

- 1. Certifying the Environmental Impact Report
- 2. Adopting the CEQA Findings of Fact;
- 3. Adopting the Mitigation Monitoring and Reporting Program;
- 4. Approving the amendments to the General Plan and Land Use Map to change the project site | The Council also amended from Institutional to Residential Single Family; and
- 5. Approving the Lot Line Adjustment

The Planning Commission also recommended that the City Council approve the following actions:

- 1. Approve amendments to the Zoning Code and Zoning Map to change the project site from Institutional to Residential Single
- 2. Approve the Specific Plan for The Meadows at Bailey Canyon Project; and

3. Approve the Development Agreement

The Council was presented with presentations by staff, followed by questions from the Council.

During Public Comment there were a number of speakers and on the city's transparency portal there are approximately 519 comments that the council members all acknowledged receiving and reading.

Deliberation Highlights:

Council ascertained 3 key concessions from the developer that addressed some of the public's stated concerns:

- 1. Tree sizes in the new **development:** Developer committed to increasing 25% of the 24" boxed trees to 36" to be placed in strategic locations
- 2. Increased demands on public safety for the 42 new homes: The developer committed to a supplemental payment of \$250,000 to help stating, "....pleased to sup-port whatever public safety needs the city council deems appropriate".
- 3. Water: An amendment was made committing the project be subject to future amendments to the Water Efficient Landscape Ordinance (WELO), to be effective at time of construction document submittal.

the Development Agreement Section 14 – Remedies, deleting the term "event of" from the event of default from the entirety of the Development Agreement.

With the unanimous approval of all the items on the agenda, the council will have a second reading of Ordinance 1461 at the regular City Council Meeting on Tuesday, September 27, 2022 at 5:30 PM in the City Council Chambers.




"The Meadows is the right plan that supports the Monastery's vision to serve this area for another 100 years.




LETS MAKE A FEW THINGS CLEAR ABOUT THE MEADOWS DEVELOPMENT.

- The purpose of "The Meadows" development is to make around \$100 Million Dollars to be split by the Passionist Fathers in Chicago and their hired developer New Urban West (NUW) of Santa Monica. The money goes to people that don't live in Sierra Madre. The impact of this project remains with us citizens forever. That is what this is all about.
- 2. The "Neighbors for Fairness" group is funded by the Developers from Santa Monica (NUW), and the Passionists of Chicago. Additionally, NUW has spent hundreds of thousands of dollars to marketers and PR firms to spin their project in a positive light in glossy brochures and full page ads. Preserve Sierra Madre and the proponents of Initiative HR are fully funded by volunteer residents that live in Sierra Madre and will be negatively impacted by the Project.
- The Meadows project violates significant parts of the Sierra Madre General Plan, the "constitution" of Sierra Madre which was carefully crafted over 5 years by the citizens of Sierra Madre to preserve the look and feel of our town. Contrary to this, the 42 homes NUW would build will be massed in a way previously unseen in Sierra Madre. It will be a massively dense cookie cutter housing project unlike any other area in town, with their own special rules superseding the General Plan.
- The primary purpose of Measure HR is to require that the development be zoned per the Hillside Residential zoning code, which applies to every other similar area in Sierra Madre, and is part of the General Plan. The Hillside code requires minimum 2 acre lots. Thus, in the 17 acre area planned for development, Measure HR would allow 7 to 8 homes, not
- The "Neighbors for Fairness" and the City Attorney have claimed that the Initiative would allow the developer to build 68 large homes on the property. This mistake by the City Attorney was proven in court and later admitted by the City Attorney to be PATENTLY FALSE, yet NUW and some on the City Council continue to use this as a scare tactic. On the 17 acres they plan to develop, that would result in 7-8 lots. The 68 home number could only happen with the destruction of the Retreat Center, building on the unbuildable northern slope, and assuming each lot would have 2 homes built on it. The Passionist Fathers have only proposed developing the lower 17 acres of their property. On these 17 acres it is 42 homes vs. 7-8. 68 just doesn't add up.
- Since the Retreat Center building would be included in the Hillside zone, and it already is sized differently than the Hillside zoning allows, it must be designated a "nonconforming use", which simply states a fact. The initiative also says that building can't be enlarged, but if the Passionists desired, it can be renovated consistent with the Hillside rules if the city approves their plan. There is no such plan at this time. It does not mean they can't build anything else. It means if they want to build another building, they must comply with the Hillside zoning. If they want to build a chapel next to the Retreat Center, they just have to follow the law like the rest of us. There is no discrimination against them.
- The "Neighbors for Fairness" was established on the belief that Hillside Residential zoning prohibits such improvements, and also claim it violates the Passionists religious freedom. This is simply not true. Initiative proponents have no intent to limit their ability to practice their faith. They simply have to follow the rules for building like the rest of us. The developers and their mouthpiece "neighbors for fairness" are using this claim as well as the "68 houses" to scare you; their real fear is not being able to make millions of dollars for themselves.
- Impacts on our water quality and usage will be permanent. NUW claims the project will have "zero impact water" but they have failed to provide a viable plan. They have no workable plan, but have fallen back on a mishmash of ideas and repairing existing pipes, a short term solution. There is no viable plan in NUW's proposal that results in "zero impact water". Not mentioned or addressed are the millions of gallons of water required during construction as well as the thousands of gallons a day the new homes will require for perpetuity. Meanwhile we all must limit our lawn watering and pay water usage fees for extra tens of units a month. All this in the midst of the worst drought in 1,200 years!
- On top of this and other things, the Meadows project will permanently impose 4-500 additional car trips a day on neighboring streets including GrandView (not including all the trucks during construction) and will increase pressure on parking downtown and throughout the city. Wear and tear, street improvements, fire, emergency and police services, will all be permanent costs to the city.

Preserve Sierra Madre is not about blocking progress or the property rights of our neighbors, we are about keeping development consistent with the look and feel of this city we all love. To do so, we all must follow the same rules.

IT'S TIME TO MOVE ON

Sierra Madre Neighbors for Fairness has stood for supporting the rights of property owners, including the Passionists. We believe the Passionists have a right to due process and that they have been working through that process in good faith along with their partner, New Urban West (NUWI). As Mayor Goss expressed at last Tuesday's meeting when they approved the Meadows project, while not perfect, it is reasonable... from the EIR, to the Specific Plan, to the detailed Development agreement. The Planning Commission and City Council have made many requests of NUWI and they have replied positively to any reasonable requests.

The most recent was a request by the City Council that NUWI help the city financially with building out the public safety facilities, either for the new police station or for remodeling the fire department building. NUWI offered an additional \$250,000 for that cause. This is what a partner does that cares about the city even though they have no obligation to help in this way. But we wouldn't be surprised to see Protect Sierra Madre and Preserve Sierra Madre (PP) frame this as the city taking a bribe. The difference is that a bribe only benefits one or a few key people, whereas a concession is to the benefit of the whole city.


That is the "reasonable" side of the project. The unreasonable side is those opposing the project who constantly make demands and are never satisfied with concessions. The Carter Ave exit is a perfect example. The opponents said a single exit is unsafe (even though allowed under county fire codes). When NUWI offers a second exit on Carter they complain about the traffic and how dangerous it will be for pedestrians. So NUWI offers to widen Carter to put in a sidewalk and then they complain that a few trees will have to be removed (even though they will be mitigated with more

trees). NUWI then offers to put in a sidewalk on the other side of the trees and they get accused of trying to steal park space for their development (even though the city or county will still own the property). PP cannot be satisfied. Now they are going to try to overturn the City Council vote that approved the project.

This is what it means to be unreasonable and it is why PP is losing credibility. No one wants to listen to or work with unreasonable people. What started as a lie to "Protect the meadow" and "Preserve open space" has turned into a farce where PP is now arguing that the best plan for Sierra Madre will be one that allows 68 homes to be built on the monastery property, with no public park, no net-zero water offsets, and no 35 acres of conserved open space. They want to allow 6,500 square foot Arcadia-style mansions on huge lots, exactly what Sierra Madreans (and originally the leaders of PP) had been fighting against for decades. Can you guess what will happen if the property is rezoned to allow this? These same people will be fighting against whatever is proposed, even under their own initiative. How do we know this? Because just about every argument they make against this project applies equally to any other development.

It is time for reasonable people to move on and not let this minority group manipulate everyone else through misinformation and constantly shifting the goal post. We support our Planning Commission and City Council who have done the hard work of evaluating this project to the benefit of Sierra Madre. Join us in the fight to protect the rights of the Passionists. Say NO to Measure HR and say NO to the referendum. www.sierramadreneighborsforfairness.org

Here's why:

- Stops over-development of tract housing
- Stops doubling of traffic in the neighborhood
- Stops the possibility of a development of a 270,000 square foot institution on the upper 18 acres of the property
- Protects more than 100 mature trees
- Allows Mater Dolorosa to continue their mission and expand beyond their current size (with city approval)

If you've seen or heard the disinformation that's been spread around about Measure HR by the "Meadows at Bailey Canyon" developer, you might think that the initiative goes against everything good and fair and decent in our community. Nothing could be further from the truth. Let's dispense with falsehoods and establish the facts about what is allowed and what is not allowed under Measure HR.

First, the developer falsely claims that, under Measure HR, 68 mansions can be built at the Mater Dolorosa parcel. While it is true that Hillside zoning may lead to several very large houses on the Mater Dolorosa property, each would be built on a two-acre lot, which severely limits the number that can

be built there. In fact, on the lower 17 | ing is that the Mater Dolorosa Retreat acres, including roads, 7 houses could be built. If Mater Dolorosa sold the entire 35 Acres, including roads, only 15 to 16 houses of a maximum size of 6,500 square feet could be built under Hillside zoning. Under the current Institutional zoning, a developer can build a 270,000 square-foot institution such as a school or residential housing unit in addition to 42 houses. If the city were to grant them a new specific plan in addition to the one that has already been approved for the bottom tract, a developer could build an additional 80 houses. There have been all kinds of extreme hypotheticals bandied about to spread confusion, including crazed lot-splitting and ADUs run amok but, realistically, we're talking about the prospect of 122 tract houses versus 15 or 16 houses under Hillside zoning. Second, ads and flyers paid for by the developer suggest that, under Hillside zoning, the Passionists will be prevented from continuing their mission.

This is patently false. The Passionists are protected by the Religious Land Use and Institutionalized Persons Act (RLIUPA). Therefore, even if Protect/ Preserve Sierra Madre members were the nihilists we've been made out to be, there will be no restrictions on the Passionists' mission. Just like everybody else in town, they will need a building permit if they want to make additions or build new buildings—that's all. The only difference under Hillside zonCenter will be designated as a nonconforming use, which means they will need a different type of permit. There is no reason on Earth that the city of Sierra Madre would not grant them that permit.

Third, the developer falsely claims that Hillside zoning circumvents Sierra Madre's existing checks and balances. Talk about the kettle calling the pot black! When it comes to maintaining checks and balances, the Meadows project is off the charts (and not in a good way). If we citizens allow them to get away with it, their houses will be up to 80% larger on a given lot size than the city's General Plan and Municipal Code allow. The bottom line is, other property owners (you and me, for example) can't build behemoths on our property, but New Urban West of Santa Monica can and will if we don't stop

Due to the City Council's failure to assert leadership and protect Sierra Madre's long-term interests and quality of life, we believe that Measure HR is the best option. Otherwise, a slew of cookie-cutter houses will be built on that property—big houses ten feet apart and fifteen feet from the street, all crammed together in a High-Severity Fire Zone.

Sierra Madre can do better than this! Vote YES on Measure HR.

LETTER TO THE EDITOR

There are so many misconceptions and misinformation about Measure HR that it is hard to know where to start. Measure HR will prevent the Mater Dolorosa Passionists from using their property to meet their needs. Currently, the property is zoned Institutional. The Passionists applied for and were considered for a zoning change as all private property owners are allowed to do.

In 2013, Mountain Views News published a report that a housing project may be considered. In that report, a Passionist said no definite plans were made. The nearby neighbors organized and began to protest. Then called "Stop the Monastery Development", (later changed to Preserve Sierra Madre) the neighbors protested, set out signs, and began campaigning against a project not yet established.

Fast forward to 2019. Mater Dolorosa came to the City with a proposed plan. The City Council determined a housing project would be most favorable, rather than an institutional project. They appointed then City Manager Gabe Englund as the liaison between the City and the applicants. Preserve Sierra Madre was kept informed of the plans.

After meeting with New Urban West in 2021, half of the Preserve group split and renewed the Stop the Monastery Development, now called Protect Sierra Madre – Stop Development, then changed to Protect Sierra Madre - Stop Housing Project. In other words, the group wants NO DEVELOPMENT. When it became clear that there was going to be a project, the Initiative was formed to stop the Passionists from using property they own as they have the right to do.

- A bond measure was considered to purchase the property. That didn't materialize because of the risk to the city should it not pass.
- Other conservation groups were approached. None were able.
- The Passionists can't keep the property as is because they need the funds to further their missions, their community works, and their retreat work.
- The Passionists chose New Urban West because the project would be compatible with the property, the serenity of the Retreat Center, and the surrounding neighborhood.
- The Passionists donated an additional 3 acres of land to be a dedicated city park.
- The Passionists donated another 40 acres to be placed in a conservancy.
- Wildlife will remain, water situation considered, fire risk taken into account and the homes will be safer than the surrounding homes.
 - Carter is currently wide enough for ingress and egress. Improvements will enhance the area for pedestrians, handi

capped, and bike riders. A yes vote on HR will take away the rights of a property owner. A NO vote will restore rights of a landowner to petition

the City for a zone change. A NO vote will enable a religious organization to continue their religious activities. Vote NO






A HALLOWEEN HORROR STORY

Halloween is almost upon us and those pumpkins that decorate porches and walls, with their happy faces, grotesque faces, scary faces are not always what they seem.

Come with me to the Pumpkin Patch. An acre dotted with corn stalks and scarecrows and pumpkins, more pumpkins than you were expecting. Enormous pumpkins, flat ones, round ones, tall skinny ones; some misshapen, some with strange lumps and bumps, some with scars and some so little they are passed over again and again. "Not that one, Daddy! It's too small. I want a really big one! I want that one...or that one...not that one, that one's ugly!" For a pumpkin, whose entire life has been dedicated to growing into a carve-worthy orange globe, this is hurtful, degrading, and can bring a pumpkin to thoughts of revenge.

The packet of Atlantic Giant Pumpkin Seeds from Burpee arrived at the Pumpkin Patch in a somewhat damaged condition. There were heavy, dark tire tracks over the face of it and





Everywhere except there in the corner of the Pumpkin Patch where the broken, cracked seeds had been planted. There the vines were thicker, stronger and stretched out in every direction, seething with dark green life. Quite frankly, that corner area made the owner just a little uneasy. There seemed something unpleasantly unusual about those vines. The word, "sinister" came to mind. Ridiculous! He thought. They're pumpkins. That's all, just plain old pumpkins. But were they?

July came and went, and the pumpkins out in the middle of the field grew fat, bursting with orange life. August arrived and the pumpkins grew to such gigantic sizes that the owner visualized pictures of himself in the newspaper standing next to a pumpkin – his pumpkin - that weighed more than the heaviest pumpkin in North America "Tiger King" grown by Travis Gienger and weighing in at 2,350 pounds.

October at last! The owner put ads in the newspaper and banners at the entrance to the Pumpkin Patch. The Pumpkin Patch would open on Saturday, October 3rd! Come one! Come All!







Pasadena Chamber **Backs Library** Tax Measure

The Pasadena Chamber of Commerce Board of Directors at its most recent meeting voted to endorse passage of Measure L the extension of the Library Tax in Pasadena on the November 8th ballot. The Measure would cost single family homeowners and owners of condominiums \$41 per year on their property tax bill. It would generate \$2,800,000 to support library services. The tax can only be used for library services and upkeep and requires the City of Pasadena maintain its current annual budget for the Library and that service levels be maintained.

The Library Tax extends the existing levy for 15 years. It is not a new tax and will not increase costs for homeowners or commercial

property owners. "Pasadena's Public Library system is a tremendous asset to our community and important to our local economy and the quality of life in Pasadena," said Pasadena Chamber CEO Paul Little. "The Board of Directors of the Pasadena Chamber recognized the importance of maintaining library services to our community in recommending voters support measure L?

Since the earliest days of Pasadena, the Chamber has played a major role in the development of this internationally renowned city. Founded in 1888 as the Board of Trade, the Chamber's primary purpose has been the enhancement of the economy, business climate and the quality of life in Pasadena.

In 2020 Janna Ireland published Regarding Paul R. Williams: A Photographer's View. Paul R. Williams, known as "Hollywood's Architect," was the first Black architect admitted to the American Institute of Architecture.

Throughout his wildly successful career, Williams designed over 2,000 buildings, including the homes of entertainment legends Lucille Ball, Frank Sinatra, and Barbara Stanwyck. In Regarding Paul R. Williams, Ireland explores the work and legacy for Paul R. Williams through a series of intimate black-and-white photographs, exploring both the skill of Williams' architecture and the social conditions under which he worked as a Black architect decades before the Civil Rights Movement.

Janna Ireland was born in Philadelphia, but has chosen Los Angeles as her home. She holds an M.F.A. from the U.C.L.A. Department of Art and a B.F.A. from the Department of Photography and Imaging at N.Y.U. Her work has been shown in solo and group exhibitions across the United States and internationally and is held in the collections of institutions, including the Los Angeles County Museum of Art, the California African American Museum, and the Santa Barbara Museum of Art. Ireland is currently an assistant professor in the Department of Art and Art History at Occidental College.

The Chef Knows By Peter Dills

It seems that everyday I get the question, Peter, who has the best Mexican Food? That is not an easy question to answer, as you may as well ask me which hand I like better. I absolutely love Mexican food; in fact, I would drive to another state for an exceptional Mexican meal. But there is no need for that, thankfully, living in Southern California we have the best Mexican cuisine in the entire country.

I do not wish to decorate any single place with a gold medal in this article, but I think that I can give us a couple restaurants that are in the race. My daughter Lauren and I go to Rosarito on Colorado when we want great Mexican food that we can take and run. Their carne asada tacos are divine and I cannot resist their chicken burritos on my visits. I just wish there was a restaurants

that had the succulent flavorings of Rosarito at a full service Mexican Restaurant. That leads me to a question, what is true Mexican fare and how did we come to have all these Mexican restaurants that line our landscape? I did a little research and here are some of the seeds that were planted along the way that grew into that great Mexican restaurant expansion.

'Food historians tell us TexMex cuisine originated hundreds of years ago when Spanish/Mexican recipes combined with Anglo fare. TexMex, as we Americans know it today, is a twentieth century phenomenon. Dictionaries and food history sources confirm the first print evidence of the term "Tex Mex" occurred in the 1940s. Linguists remind us words are often used for several years before they appear in print. TexMex restaurants first surfaced outside the southwest region in cities with large Mexican populations. The gourmet Tex Mex "fad" began in the 1970s. Diana Kennedy, noted Mexican culinary expert, is credited for elevating this common food to trendy fare. These foods appealed to the younger generation. And now I suspect since we view Mexican food as inexpensive it has gain popularity through our limited budgets. Items such as burritos, tacos and enchiladas are more of a street food item in Mexico. But here in the states we have embraced it as Mexican



Located on the same block as the Pasadena Playhouse. It is the perfect place for those of us that require some me time. After a long week, I can look at Charlie the bartender and next thing you know he has his head down and is pouring a margarita that will bring a smile to anyone's face. On select nights they may have a strolling band of three musicians playing warm Latin tunes and filling the restaurant with melodious ambiance. Between the margaritas, music and fantastic food, you may drift away and think you are vacationing. CRIME PREVENTION TIPS FROM THE CITY OF DUARTE **VEHICLE SECURITY**

You can prevent vehicle theft!

Most cars are taken by amateurs who can be stopped fairly easily. You can increase your protection against this type of crime by taking the following sensible precautions:

Lock Up

An unlocked car is an open invitation to a car thief. Lock up when you leave your car, and take the keys

Lock the trunk or tailgate. Close all windows — professional thieves have tools that unlock cars through the smallest openings.

Be sure vent or wind-wing windows are shut tight.

When you park the car, remove cellular phones, and other valuable possessions. Do not leave backpacks/ gym bags or packages lying on the seat or in plain view. Lock all valuables in your trunk or take them

Lock your car even if you are making a quick stop at the gas station, convenience store or mini-mall.

Park Carefully

Don't leave your vehicle unattended in parking lots for an extended period. A car is five times more likely to be stolen or broken into from an unattended lot than from a busy street or attended lot. Never attach a tag with your name and address to your key ring. If the keys are lost or stolen, the tag will lead the thief directly to your car and your home.

At night, park in well-lit areas.

Turn wheels sharply toward the curb when parking, this makes it extra difficult for thieves to tow your

Operation I.D.

With an electric engraver, etch your driver's license number (preceded by the letters "CA") on catalytic converters, tailgates and other valuable items.

Record your vehicle identification number and store it in a safe place.

Keep the vehicle registration in your wallet or purse, not in your car.

Use Anti-Theft Devices

- Consider the purchase and installation of security devices, such as: Ignition switch or "kill switch" Fuel switch

Alarm device to activate a siren, horn or lights – or all three – to frighten the thief away. Locking Device that attaches to the steering wheel or brake pedal.





"But isn't coffee bad for my health?"

Much has been said and written about the benefits vs. the detrimental effects of coffee. But what is the "bottom line"? Are there beneficial qualities? Does it harm me? Should it be abstained from? Is it OK to drink coffee in moderation?

These and similar questions are not easily answered because, in the tests and statistical data, researchers and doctors do not use -- or attempt to define -- consistent standard for what is meant by "coffee."

Coffee has also been accused of causing, or contributing to, cancer, heart diseases, hypertension, hepatitis, and cirrhosis of the liver. Dr. John Timson of the University of Manchester in England, while admitting that coffee is mildly addictive, states that, at present there is no hard scientific evidence that links the use of coffee to any of the above-mentioned diseases. Unfortunately, in virtually all studies done on the

health effects of coffee, researchers indiscriminately lump all "coffees" together. But no two cups of coffee are alike. And it is not likely that any standard will ever be established for coffee research. Why? Because brewed coffee contains not only caffeine, but various acids, oils, and alcohols, the qualities of which vary depending on the way the coffee beans are handled from farm to cup. It is rare that any two cups of coffee are chemically identical!

According to Dr. Neil Solomon, "Caffeine is a strong stimulant with drug-like properties and is considered to have an unfavorable effect on nutrient absorption."

The FDA (Food and Drug Administration) has placed caffeine on their Generally-Recognized-As-Safe list. Caffeine acts as a stimulant to the central nervous system. If used in excess, it contributes to nervousness, irritability, sleeplessness, anxiety, and heart palpitations.

FACTORS AFFECTING THE QUALITY OF "COFFEE"

According to Timothy Hall, a teacher with the L.A Unified School District who has given numerous lectures on coffee, there are at least 30 factors which affect the beverage called "a cup of coffee," all of which must be taken into account if one is to draw a useful conclusion about coffee's "good" or "bad" effects.

According to Timothy Hall, one cannot answer "Is

coffee good for me?" until one has explored the following questions. In some cases, definitive answers to the following may be hard to come by, if not next to impossible. Some factors, however, are completely within our control.

THE PLANT

What is the type or variety of coffee plant? Of the two primary types of coffee -- arabica and robusta arabica is considered the better of the two. Where and how was it grown? How was it fertilized?

The elevation, quality of soil, and the amount of water received during growing all affect the quality of the fruit. This is why coffee connoisseurs have individual preferences regarding the country of origin.

What was the quality of care in picking, cleaning, and storing the beans?

ROASTING

What was the method of roasting?

The depth of darkness of the brown in coffee color is due to the proportion of cresylic acid (cresol) present after the beans have been roasted. The darker the roast, the greater the tar content.

GRINDING

What was the grinding procedure? How hot did the beans get during the grinding process? Though not everyone will notice the difference, any grinder which grinds at a high temperature can result in the loss of aromatic oils. One solution is to grind with a hand mill. Another solution (when using an electric mill) is to only grind enough for a few cups at a time, since prolonged grinding may result in excessive heat. How much time elapsed between grinding and brew-ing? Remember: if you smell it, you're losing it. If you don't plan to use your grinds immediately, then put them in a covered container and place in the refrigerator. How was the coffee handled and stored between the

grinding and brewing?

WATER

How much coffee grounds are used in relation to water? Obviously, a cup of coffee made with one scoop of grounds is vastly different than one made with 6 scoops of grounds. A person with stomach disorders with have difficulty with the stronger brew. What is the quality of the water? (After all, the primary constituent of "a cup of coffee" is water.)

TEMPERATURE

What was the temperature of the coffee grounds, and the temperature of the water, when you began brew? What were the temperatures when you finished brewing?

Fusel oil, released into the water whenever coffee grounds are boiled, causes bitterness; however, fusel oil is NOT released into water at less than boiling temperatures.

CLEANLINESS

What was the level of cleanliness of the coffee maker? Old coffee stains are a combination of "dirt" and oxidized insoluble fats. When fat oxidizes, it becomes rancid. Rancid fat "flavors" all coffee that is brewed in coffee pots that have not been scrubbed spotless.

PREPARATION

What type of coffee maker was used (vacuum, drip, percolator)? (Space doesn't permit us to review every coffee-maker on the market however, so let the buyer beware.)

Did I brew the grounds using the percolation, infusion, or decoction method? Infusion refers to adding the grounds to the water and letting them steep. A camper might do this. Decoction refers to actually cooking the grounds -- even boiling -- to make a strong brew. Though this might be acceptable in a

Nyerges is the author of a dozen | prison camp when one is trying to extend the available grounds as far as possible, it is the least desirable choice. Percolation -- pouring the hot water through the grounds -- is the best option.

What type of materials did I use in the making of the beverage? Stainless steel, glass, aluminum, porcelain, and plastic all affect the quality (and the flavor) of the finished product.

ADDITIVES

What have I added to the finished product? Sugar? Salt? Egg? Vanilla? Cinnamon? Chocolate? Honey? Sweet-'n-Low? Saccharin? Cream? Milk? Powdered milk? Half and half? Cloves? Cardamon? Coffeemate? Brandy?

INSTANT COFFEE

Was the coffee instant?

Instants are made two ways: spray dry or freeze dry. Both are begun as a very concentrated brew made spray dry method, the concentrated brew is sprayed into a chamber where hot, dry air is pumped. The air removed the moisture, leaving bubble-shaped particles behind; the particles are then ground into powder. In the freeze-dry method, the concentrated brew is first frozen, and is then introduced into a vacuum chamber which removed the moisture, leaving a solid mass; the mass is then reduced to granules.

Instants vary due to the varying strengths of the initial concentrated brew, and differences in drying methods (temperature, etc.). Though the quality of instants may vary, most coffee-lovers will only drink instant when the circumstances dictate simplicity, or if nothing else is available. A detailed comparison of the quality of instant coffees was done by Consumer Reports magazine, a copy of which may be obtained by writing to the magazine.

DECAFFEINATED

Is the coffee decaffeinated?

The chemical formerly used to remove the caffeine was trichloroethylene (found to cause liver cancer in laboratory mice). Currently, methylene chloride is used, a chemical under study by the National Cancer Institute. A non-chemical method of decaffeination that has been gaining is popularity is the steam method.

SERVING

What type of cup is the coffee served in? How long after brewing is the coffee served? What do I use as a stirring device?

How many cups do I drink at one sitting?

Of the factors under our control, the quality of our thinking (as we brew the coffee) has a direct effect on the finished product. Also, the way in which we drink the beverage has an effect (i.e., slow thought¬ful sips vs. hurried gulps).

Hall asserts that in his tests, the quality of one's thinking has proven to be the most important factor. States Hall, "If you brew your coffee with precise intent, you can alchemically transmute those com-mon grounds into a veritable elixir."

AN EXPERIMENT IN ALCHEMY

Here are a few guidelines if you'd like to begin alchemically changing "a cuppa coffee" to "wonderful elixir." This is the procedure that Timothy Hall was taught by his mentor, R. E. White of WTI in the mid-1970s.

Begin with meticulously clean utensils. Stainless steel, French porcelain, glass, or copper are preferred; softer metals (e.g., aluminum) should not be used. First, measure the needed amount of water (spring

water is better than the chlorine and fluoride-laden city tap water) and set on the stove to boil. Next, prepare your filter. An ideal filter is a simple cloth bag sewed into a cone, using the densest cotton flannel. These are reusable indefinitely -- far superior to commercial paper filters. The bag is suspended

over your cup, or a second pot; the coffee grounds are measured into the bag (a fine grind works best). Another ideal system is a French ceramic pot with a ceramic cone that fits into the top, and a gold-plated reusable filter. You measure your grounds into the

When the water has boiled, stand squarely and strongly on both legs; breathe deeply; then, slowly pour the water in a clockwise circular motion over the grounds. While pouring, visualize and fell the energy of Love flowing from your heart, down your arm, and into the beverage. We call this "chi," and much has been written about this "chi' energy in books on Chinese healing and martial arts. You may need to "imagine" the feeling at first, but with practice you will find it easy. It sometimes feels like a mild electric shock. If you wish to add anything to the resultant beverage, try raw honey and raw cream.

One of the main problems with extensive coffee ingestion is that it either removes or destroys the B-vitamins from the body, resulting in a slowly cumulative degeneration of the sheaths of the body's nerve fibres. This is what causes the "nervousness" with heavy coffee-drinkers. Honey, cream, and B-vitamins added to the diet, help to offset any harmful effects

When the above process is done thoughtfully and lovingly, the process is somewhat analogous to the Japanese tea ceremony. And it CAN result in a truly fine

Please try this method of "elixir-making" in your own Alchemical Chamber (aka "kitchen") and let us know your results.

So is coffee "good" or "bad"? As always, it depends on the way you interact with it.

Coffee says: "As you care for me, and as you treat my fruits, so shall I be able to provide sustenance to you, my dear humans. Ignore me, and I have nothing, or little, to offer but "cheap thrills" of your lower aspects of autonomic nervous system.

Coffee also says: "Compromise and/or adulterate me and you'll not only have something of little value, but your choice to exploit/adulterate me will change my potential beneficence into an exploitation/adulteration of your own body and brain.

As is nearly always the case with such matter of "health," ALL is choice, Choice, and CHOICE, and consequence of choice.

FREE ONLINE HEARING TESTS YOU CAN TAKE HOME

Dear Savvy Senior:

Can you recommend any good online hearing tests? My husband has hearing loss, but I can't get him to go in and get his hearing checked, so I thought a simple online test could help him recognize he has a problem. What can you tell me? Loud Talking Linda



Dear Linda:

There's actually a growing number of very good online and app-based hearing tests available that will let your husband check his hearing on his own. These tests are a quick and convenient option for the millions of Americans that have mild to moderate hearing loss but often ignore it, or don't want to go through the hassle or expense of visiting an audiologist for a hearing exam.

Who Should Test?

Hearing loss for most people develops gradually over many years of wear and tear, which is the reason many people don't realize they actually have a hearing problem.

Anyone who has difficulty hearing or understanding what people say, especially in noisier environments or over the phone. Or, if you need a higher volume of music or TV than other people, should take a few minutes to test their hearing.

Self-Hearing Tests

Online and app-based hearing tests can serve as a great screening tool. They are not meant to be a diagnosis, but rather to give you an idea of how bad your hearing loss is and what can be done about it

For most do-it-yourself hearing tests, you'll be advised to wear ear headphones or earbuds and sit in a quiet spot.

You also need to know that there are two different type of tests available. One type is known as pure-tone testing, where tones are played in decreasing volumes to determine your specific level of hearing loss. And the other type is known as speech-in-noise or digits-in-noise (DIN) where you'll be asked to identify words, numbers, or phrases amid background noise.

Where to Test

If your husband uses a smartphone or tablet, two of my favorite app-based hearing tests are the hearWHO app created by the World Health Organization, and the Mimi Hearing Test app. Both apps are free to use and are available through the App Store and Google Play.

HearWHO allows users to check their hearing status and monitor it over time using a DIN test, while Mimi uses pure-tone and masked threshold tests to give you a detailed picture of your hearing abilities.

There are also a wide variety of online hearing tests your husband can take on a computer. Some top online tests – all offered by hearing aid manufacturers – for speech-in-noise or DIN tests can be accessed at ReSound (resound.com/en-us/online-hearing-test) and Mircle Ear (miracle-ear. com/online-hearing-test).

And some good online hearing tests for pure-tone testing are available by Signia (signia.net/en/service/hearing-test); Ergo (eargo.com/hearing-health/hearing-check); and MD Hearing Aid (md-hearingaid.com/hearing-test).

All of these hearing tests are completely free to use and take less than five minutes to complete.

What to do with Results

If the tests indicate your husband has hearing loss, it's best to think of that as a starting point. He should take results to his doctor or an audiologist for further evaluation.

Many insurance providers and Medicare Advantage plans cover routine hearing exams, however original Medicare does not.

If his hearing loss is mild to moderate, he should look into the new over-the-counter (OTC) hearing aids, which are available this fall online and at retailers like Best Buy, Walgreens and CVS.

OTC hearing aids don't require a prescription or medical examination for purchase and they're much more affordable than traditional hearing aids you buy through an audiologist or a licensed hearing instrument specialist.



I normally distrust the computer but this time at my wife's insistence we followed the GPS instructions and managed to get lost.

Eventually, after a pretty heated fight, we managed to find the place.

I was surprised, despite the President's proclamation of victory, that upon arrival my wife and I had to undergo unexpected, (at least for me) procedures before being allowed past the receptionist's desk. First we had to present proof of vaccination; next we had to have our temperature taken, after that we had to have nose swabs to demonstrate that we were not infected. The procedures were already more confusing than what was necessary to be allowed into the Rose Bowl to see the Bruins play. Worse yet the games are not presented on my TV. (I present this information to demonstrate the perils of attempting to survive in today's Climate Crisis infected post- Pandemic world.)

Despite the President's proclamation, the necessary procedures at the nursing facility had remained in place. (Perhaps no one had watched TV that morning.) Finally after being cleared to proceed to the patient's room we were instructed to put on hospital gowns. Given all this, I had some trepidation as we entered Elena's room. We entered and there Elena sat in her wheelchair next to a window with a very pleasant view. Even though she, as well as us, wore a mask I could tell just by her eyes that she was happy. Because of my hearing problems and my inoperative hearing aids together with being masked I had to rely on my wife to repeat what Elena said. Nevertheless, it was clear to me that Elena's sense of humor and her extraordinary memory had returned. She knew that my wife, son, and I planned to attend a wedding next month and she reminded us where my son's formal clothes could be found in his closet. Elena and my son had gone on a cruise about ten years ago where formal clothes were required at dinner and now, so many years later, she remembered where the clothes were hung.

Frankly I was overjoyed by her spirits and attitude. While we were there my son called on the phone and even though I could barely understand the words over the speaker phone I experienced how loving he and Elena were toward one another. I should explain that both my son and Elena are in, or soon to be in, their fifties. My son's eye problems and his developmental disabilities make it impossible for him to drive to the facility himself and he relies on Elena's sister for assistance. Both Elena and my son are under the supervision of the Regional Center and have had very difficult lives. Still they have maintained their relationship, although living apart, for over fifteen years.

As I heard their voices over the speaker phone, I could feel something of their sus-Tears fell from my eyes to my mask and I felt a strong hooray for them and the doctors and the view from the window. I started this article expressing a very cynical view of Joe Biden's, announcement that the Pandemic is over. I know that still almost 500 Americans continue to die daily from this supposedly defeated Pandemic that has caused more deaths in the United States than anywhere else.

Maybe all the world's leaders have cynically lied to us and continue lie to themselves. (Perhaps that's Mr. Putin's problem). Still there is joy to be found in this difficult world and I am so gratified to have found some today.


Last week, maybe it was the barrage of commercials or the BOGO special that was running but I ordered my first Little Cesars pizza since moving to the US in 2017.
