#### CHAMBER VOTES NO ON HR

Sierra Madre Chamber Votes NO ON MEASURE HR

At its quarterly Board Meeting the Sierra Madre Chamber voted overwhelmingly not to endorse the controversial Measure HR. Measure HR was also opposed unanimously by the entire city

Says President Luther Tsinoglou, "The Chamber's mission is to support those things that we believe are in the best interest of the businesses and residents of Sierra Madre. The majority of our board, after reviewing and discussing both the pros and cons of Measure HR, have reached the conclusion that a NO vote will best serve everyone in town."

The Chamber, along with the Sierra Madre Woman's Club held an election forum earlier in the month where City Council canlidates and speakers for and against Measure HR presented their arguments to the public. The Chamber does not endorse candidates.

The overall position was that Measure HR would cause more harm than good to the town and local businesses.

This is not the first time that the group has taken a position on controversial local ballot measures. The group supported the UUT which brought much needed dollars to police and fire; they, opposed Measure V which put restrictions on downtown development. They have also been advocates for the business community on the Ban on Smoking, K Rails in Kersting Court, and

It is their hope that Sierra Madre will retain its small town charm and continue to support the businesses in town.

#### **EXPOSING THE CALIFORNIA DEPARTMENT OF FISH AND** WILDLIFE'S COLOSSAL FAILURE

As we all have come to know, Sierra Madre's residential areas, elementary schools, and the downtown area have become California's hotspot for bear activity and the most dangerous city in California for bear attacks, suffering more bear attacks on humans in the last few years than any other city in California. Daily bear encounters in Sierra Madre are, according to the California Department of Fish and Wildlife (CDFW), now considered "routine."

Consider for a moment, according to a search of California Department of Fish and Game records, during the 20 year period between 1975 and 1995, the entire State of California reported 7 bear attacks. That's 7 attacks in a 20 year period over an area of 164,000 square miles. Now contrast that with the last 6 years in Sierra Madre's 3 square miles that has suffered 4 bear attacks and bear encounters greater than the CDFW's ability or willingness to control them. Additionally, according to reports by both CBS Sacramento and CNN, in 2021, California experienced two home break-ins. Sierra Madre Canyon often sees more than that in a single day so either both CNN and CBS are not doing their homework or someone is not giving accurate data to the public.







Despite ongoing efforts and tens of thousands of dollars aggressively being spent by the out-of-town developer, New Urban West, to confuse and misinform us, there are many Sierra Madre residents who want to

know the truth so they can vote in the best interests of the community they love.

Rather than let the facts speak for themselves and let the light shine on the Meadows tract housing development - so we can actually see what it looks like - Sierra Madre is being bombarded with multiple, costly mailers designed to confuse voters and muck up a sincere effort for residents to learn the truth and vote accordingly.

When you don't have the facts on your side and hide behind shiny mailings, it looks like you are too ashamed to show the community what your project looks like and instead try to divert their attention by flooding their homes with slick graphics, falsehoods and improbable outcomes. New Urban West thinks it best to hide behind a veiled smokescreen of marketing designed to trick and fool you into believing that tract housing is best for us. Let's take a breather from all this nonsense and restate the facts about what is allowed

Measure HR is simple. It changes the present zoning for the 35-acre Monastery parcel from Institutional to Hillside Residential. It means that institutional development, i.e., schools, retirement centers, hospitals, etc., is no longer permitted; residential homes on two acres each is permitted. Now, to dispel some of the gross misrepresentations pushed by the developer:

and what is not allowed under Measure HR.

FACT ONE: Under Measure HR, nobody can build 68 mansions on the Monastery parcel. Measure HR allows for one home up to 6500 square feet on a two acre lot. This means that in place of the 42 tract homes to be built under the Specific Plan, just 7 homes could be built on these 17 acres. If the entire 35 Acres was sold, only 15 to 16 houses of a maximum size of 6,500 square feet could be built under Hillside zoning. Under the current Institutional zoning, a developer can build a 270,000 square-foot institution such as a school or residential housing unit in addition to "The Meadows" project of 42 houses. If the city were to grant them a new specific plan in addition to the one that has already been approved for the bottom tract, a developer could build an additional 82 houses. There have been all kinds of extreme hypotheticals bandied about to spread confusion, including crazed lot-splitting and ADUs run amok; but, realistically, we're talking about the prospect

of the developer's 124 tract houses under their Specific Plan versus 15 or 16 houses on the 35acre parcel under Hillside Residential zoning.

FACT TWO: Ads and flyers paid for by the developer state that, under Hillside zoning, the Passionists will be prevented from continuing their mission. This is totally false. The Passionists are protected by the Religious Land Use and Institutionalized Persons Act (RLIUPA) as well as Section 17.60.030 (A) of our municipal code that clearly states

"Churches, temples and other places of worship" are uses that are permitted in the Hillside Management Zone. As a result, there is no restriction on the Passionists' mission. Just like everybody else in town, they will need a building permit if they want to make additions or build new buildings—that's all. The only difference under Hillside zoning is that the Mater Dolorosa Retreat Center will be designated as a non-conforming use, which means they will need a different type of permit. There is no reason on God's green Earth that the city of Sierra Madre would not grant them that permit.

FACT THREE: The developer falsely claims that Hillside zoning circumvents Sierra Madre's existing checks and balances. Nothing could be further from the truth.....from a developer whose Specific Plan disregards our carefully written General Plan and zoning ordinances. If we citizens allow them to get away with it, their houses will be up to 80% larger on a given lot size than the city's General Plan and building codes allow. The bottom line is, other property owners—the people who actually live here—like you and me, can't build oversized houses on little lots even if we want to, but New Urban West of Santa Monica can and will if we don't stop them, setting a dangerous precedent for fu-

Don't be fooled by the endless stream of confusing, misguided, inaccurate, false information coming your way. The real citizen groups opposed to this project don't have the \$143,000 that the developer has funneled so far into pushing this project. The real citizen groups have only the facts on their side and would like to issue the following simple challenge to the developer:

If you stop telling lies about the project, we'll stop telling the truth about the project. Vote YES On Measure HR

#### **SEEMS LIKE GROUNDHOG DAY**

One must wonder what is in it for the City Council to not only approve the Meadows project but also each member display a No on Measure HR sign on their property. Several Planning Commissioners are also displaying the No sign. We would think this would at the very least be poor judgment on their part. We know that the Meadows project is not yet a fait accompli. The zoning change was approved in two hastily scheduled meetings of the Council, within a one-week period, in order to accomplish this. The Environmental Impact Report was also approved, without any probing questions. But, there are several loose ends that the Planning Commission and the City Council will have to rule on - New Urban West Developer promised to reveal which houses will go on which plot of land once the Meadows is approved. There are no pictures, and the actual pictures of their huge crammed together developments in other cities have been taken down from their website.

One of the other loose ends is that pesky (to NUW) matter of the widening of the narrow, sidewalk-less Carter Avenue. There is still no plan to get County approval to widen the street, or to cut down the projected 17 trees in Bailey Canyon to do so. What is truly frightening is that both the Planning Commission and City Council have made their intentions absolutely clear before even discussing these issues that will affect all of us.

Meanwhile, the developer New Urban West has now spent over \$150,000 just in the last three months to try to confuse the resi-

dents. They are saying that to stop the mansionization of the Monastery property you must vote No on Measure HR, when just the opposite is true. Measure HR will allow only 7 large homes on two acres of land. Even with a lot split – now one acre, and 14 large homes, it still is vastly different from 42 homes on 17 acres, set 10 feet apart, smaller setbacks than our zoning codes allow. We've mentioned in several articles - this is Measure V all over again. The building industry spent over \$180,000 telling us of the dire consequences if we allow our downtown to prohibit three story condo units.

The difference, though, is that there is a Memorandum of Understanding between the developer and the City Manager Gabe Engeland, approved by City Council, in the height of the pandemic -

"Indemnification. The Applicant shall defend, indemnify and hold harmless the City and its agents, officers and employees from and against all claims, costs, penalties, causes of action, demands, losses and liability of any nature, whatsoever, caused by or arising out of or related to any alleged negligent act omission of the City, its officers or employees or any other agent acting pursuant to the City's control arising from, related to, or regarding this MOU or the Project."

In other words, if we residents want to sue, the developer will use even more of its deep pockets to defend any lawsuits. They, on the other hand, have threatened over and over to sue – just like those who lost the Measure V fight, and the One Carter developer.

#### MEASURE HR Q&A

Is Measure HR the Meadows project?

Measure HR is an initiative by three neighbors to rezone the entire Monastery property to the Hillside Residential zone, making the existing Retreat Center and Stations of the Cross non-conforming uses. HR states that its intent is to allow continued operation "without expansion, significant physical alteration, or change in use." The Hillside Residential zone allows up to 68 units on the entire property, and some number of mansions up to 6,500 sq. ft.

The Meadows project, which was recommended by the planning commission and unanimously approved by the City Council, is a plan to build 42 homes averaging 3500 sq. ft. on the southern half of the property. It includes a \$5 million 3-acre park, 40 hillside acres in conservancy, almost \$1 million to offset water use, and \$250,000 for public safety infrastructure.

What does it mean to vote Yes or No on Measure HR?

A yes vote on HR will rezone the entire property to the Hillside Residential zone, which would stop the Meadows project but allow larger homes to be built with none of the concessions like the 3-acrk, etc. It would turn the existing structures into non-conforming uses likely leading to a lawsuit against the city. A no vote on HR would allow the Meadows project to be built as approved by the city council.

What do the Passionists want?

The Passionists, who have owned the property for 100 years, are intent on selling some of the property for development. Their preferred solution is the Meadows project. The Passionists have stated that if Measure HR turns their Retreat Center and the Stations of the Cross into a non-conforming uses they will pursue legal options to restore their rights under the federal Religious Land Use and Institutionalized Persons Act. If the property is rezoned Hillside Residential, the Passionists' headquarters in Chicago could also decide to sell the entire property to a developer of mansions and leave Sierra Madre.

What was the lawsuit against the city about?

In the argument against Measure HR the city council used the phrase "a developer" from the city attorney's report. Since it would take more than "one" developer to build the 68 units the judge removed that phrase. The petitioner requested that the number of units be reduced from 68 to 34, but the judge refused since 68 units could be built if HR passes.

Who is funding each side?

Sierra Madre Neighbors for Fairness has partnered with the developer to protect the rights of the Passionists. We have not been promoting the Meadows project other than as an approved project being the best way to protect the rights of the Passionists. The Yes on HR side is funded by a GoFundMe campaign and there is also a dark pool PAC called Citizens for Better Government out of Norwalk that is actively promoting yes on HR. No one has claimed responsibility for this group so it is unknown if it is a developer hoping to build mansions under the Hillside Residential zone or someone with unknown intentions.

What type of homes can be built?

Under Measure HR there is minimal design oversight as long as it fits within the objective zoning standards and within the 6,500 sq. ft. limit. The Meadows project homes will be a mix of single and two stories averaging 3,500 sq. ft. with four different styles: craftsman, farmhouse, Spanish, and modern. #### HR LEADS TO BAD OUTCOMES

I am an author and retired litigator and have been a homeowner and HOA Board member in Sierra Madre since 2009. I am also a member of Sierra Madre CERT. I am voting NO on HR and want to share a couple of reasons why I oppose the initiative.

The initiative seeks to outlaw any institutional expansion of the Monastery property ever, and to restrict residential development to large parcels. Some HR backers believe that the restrictions would make development impossible and that the Passionists would simply comply with the restrictions on their use of the property. Under HR they believe that the status quo would become permanent. That is one view, however misguided.

Other proponents of HR, such as the former developer who lives near the property and the drafters of the initiative, know that is not true. They know that under HR as many as 68 units, many of which are 6500 square foot mansions, could eventually be built on the property. This fact has been litigated and confirmed by a Judge of the Los Angeles County Superior Court.

What would happen if HR passes? Maybe the Passionists would simply comply, as painful and humiliating as that would be for them.

Or maybe they would sell the entire property and let the chips fall where they may. We could get up

to 68 houses, many of them huge mansions, all with minimal city oversight. I'm curious whether there are some interests associated with HR such as developers, financiers and others who might find that outcome an attractive opportunity. Or maybe a government entity like the State of

California would get involved and require high-

Or, if HR passes, the Passionists, as pointed out by the City Attorney, could choose to sue the city for violation of their 1st Amendment right to practice their religion as codified under the federal Religious Land Use and Institutionalized Persons Act. The Passionists would claim they are being singled out to prevent expansion of their ministries and discriminated against. They have been mocked and belittled by more than a few of the initiative supporters. The record of Measure HR is filled with evidence of invective and of the hatred and enmity many of the initiative proponents harbor toward the Passionists. This evidence already supports a finding of malice and has the potential to result in a runaway verdict.

As a former litigator for 41 years, which included civil rights and land use litigation, I suggest this path exposes the city's taxpayers to unnecessary risk and terrible outcomes. Please reject the HR scheme.

A "yes" vote supports this ballot initiative to (i) legalize sports betting at American Indian gaming casinos and licensed racetracks in California; (ii) tax profits derived from sports betting at racetracks at 10%; and (iii) legalize roulette and dice games, such as craps, at tribal casinos

**A "no" vote opposes** this ballot initiative, thus continuing to prohibit sports betting in California and roulette and dice games at tribal casinos.

What would Proposition 26 change?

Proposition 26 would legalize sports betting at American Indian gaming casinos and licensed racetracks in California.[1]

The ballot measure would define sports betting as wagering on the results of professional, college, or amateur sport and athletic events, with the exception of high school sports and events featuring a California college team. Individuals would need to be 21 years of age to engage in legal sports betting.[1]

The ballot measure would enact a tax of 10 percent on profits derived from sports betting at racetracks. The state government would be required to distribute the revenue as follows: (a) 15 percent to the California Department of Health for researching, developing, and implementing programs for problem gambling prevention and mental health and providing grants to local governments to address problem gambling and mental health; (b) 15 percent to the Bureau of Gambling Control for enforcing and implementing sports wagering and other forms of gaming within the state; and (c) 70 percent to the General Fund.[1]

The ballot measure would also legalize roulette and dice games, such as craps, at tribal casinos; however, tribal-state compacts would need to be amended before these games can be offered.[1] Who is behind the campaigns surrounding Proposition 26?

# PROP 27 LEGALIZES MOBILE SPORTS BETTING AND DEDICATES REVENUE TO CA. SOLUTIONS TO HOMELESSNESS AND MENTAL HEALTH SUPPORT ACCOUNT AND THE TRIBAL ECONOMIC DEVELOPMENT ACCOUNT

**A "yes" vote** supports legalizing online and mobile sports betting for persons 21 years of age or older, establishing regulations for the mobile sports betting industry, imposing a 10% tax on sports betting revenues and licensing fees, and allocating tax revenue to an account for homelessness programs and an account for tribes not operating sports betting.

**A "no" vote opposes this ballot initiative,** thus continuing to prohibit sports betting in California. What would Proposition 27 do?

Proposition 27 proposes a constitutional amendment and statute to authorize a gaming tribe, an online sports betting platform with an operating agreement with a gaming tribe, or a qualified gaming company with a market access agreement with a gaming tribe may operate online sports betting for individuals 21 years of age or older in the state but outside of Indian lands. The amendment would prohibit online sports betting on youth sports. The proposed law would create the Division of Online Sports Betting Control within the Department of Justice. The initiative would give the division authority to regulate the online sports betting industry and investigate illegal sports betting activities. The amendment would take effect on January 1, 2023.[1]

The proposed law would establish the California Online Sports Betting Trust Fund. The revenue from licensing fees, renewals, and the sports wagering tax would be deposited into the fund. After deducting regulatory costs, 85% of the fund's revenues would be allocated to California Solutions to Homelessness and Mental Health Support Account for permanent and interim housing and 15% of revenues to the Tribal Economic Development Account, which would be established by the initiative to provide funds to Indian tribes for expanding tribal government, public health, education, infrastructure, and economic development.[1] Currently, mobile and in-person sports betting is illegal in California.

#### PROP 28 REQUIRES FUNDING FOR K-12 ART AND MUSIC EDUCATION

A "yes" vote supports this ballot initiative to:

- require an annual source of funding for K-12 public schools for arts and music education equal to, at minimum, 1% of the total state and local revenues that local education agencies receive under Proposition 98;
- distribute a portion of the additional funding based on a local education agency's share of economically disadvantaged students; and
- require schools with 500 or more students to use 80% of the funding for employing teachers and 20% to training and materials.

**A "no" vote opposes requiring an annual source of funding** for K-12 public schools for arts and music education equal to, at minimum, 1% of the total state and local revenues that local education agencies receive under Proposition 98.

Proposition 28 would require a minimum source of annual funding for K-12 public schools, including charter schools, to fund arts education programs. The annual minimum amount established by the law would be equal to, at minimum, 1% of the total state and local revenues that local education agencies received under Proposition 98 (1988) during the prior fiscal year. The minimum under the proposed law would be in addition to the funding required by Proposition 98. According to the Legislative Analyst's Office, the ballot initiative would likely result in increased spending of \$800 million to \$1 billion each fiscal year.[2]

How does Proposition 98 relate to school funding? See also: California Proposition 98, Mandatory Education Spending Initiative (1988)

In 1988, Californians approved Proposition 98 by a margin of 50.7% to 49.3%. Proposition 98 amended the state constitution to require a minimum percentage of the state budget to be spent on K-14 education (kindergarten through two-year community college), which is referred to as the minimum guarantee. Proposition 98 established two formulas or tests to determine the minimum guarantee, which is the highest funding level produced by Test 1 or Test 2. Test 1 links the minimum guarantee to about 40% of the state General Fund, which is equal to California's 1986-87 funding level of public education. Test 2 calculates the minimum guarantee by adjusting the prior year's minimum guarantee by student attendance and changes in the cost of living.[3]

## PROP 29 HEALTHCARE ENACTS STAFFING, REPORTIIG REQUIREMENTS AND OWNERHIP DISCLOSURE FOR DIALYSIS CLINICS

A "yes" vote supports this ballot initiative to require dialysis clinics to have at least one physician, nurse practitioner, or physician assistant while patients are being treated; report data on dialysis-related infections; and not discriminate against patients based on the source of payment for care.

A "no" vote opposes this ballot initiative to require dialysis clinics to have at least one physician, nurse practitioner, or physician assistant while patients are being treated; report data on dialysis-related infections; and not discriminate against patients based on the source of payment for care.

Proposition 29 would enact staffing requirements, reporting requirements, ownership disclosure, and closing requirements for chronic dialysis clinics, including:[1]

- requiring clinics to have at least one physician, nurse practitioner, or physician assistant with at least six months of experience with end-stage renal disease care onsite during patient treatments;
- requiring clinics to report dialysis-related infections to the California Department of Public Health (CDPH);
- requiring clinics to provide patients with a list of physicians with an ownership interest of 5% or more in the clinic;

- requiring clinics to provide the CDPH with a list of persons with ownership interest of 5% or more in the clinic; and
- requiring clinics to obtain the CDPH's written consent before closing or substantially reducing services to patients.

The ballot initiative would also prohibit clinics from refusing to care for a patient based on the patient's form of payment, whether the patient is an individual payer, the patient's health insurer, Medi-Cal, Medicaid, or Medicare.[1]

In 2020, 63.4% of voters rejected Proposition 23, which was also sponsored by SEIU-UHW. Proposition 23 would have required chronic dialysis clinics to: have an on-site physician while patients are being treated; report data on dialysis-related infections; obtain consent from the state health department before closing a clinic; and not discriminate against patients based on the source of payment for care.[2]

In 2018, SEIU-UHW also sponsored Proposition 8, which was defeated with 59.9% of voters rejecting it. Proposition 8 would have required dialysis clinics to issue refunds to patients or patients' payers for revenue above 115% of the costs of direct patient care and healthcare improvements.[3]

# PROP 30 TAXES AND TRANSPORTATION INCREASES TAX ON PERSONAL INCOME ABOVE \$2MILLION BY 1.75% AND REVENUE TO ZERO EMMISSION VEHICLE PROJECTS AND WILDLIFE PREVENTION

A "yes" vote supports increasing the tax on personal income above \$2 million by 1.75% and dedicating the revenue to zero-emission vehicle subsidies; zero-emission vehicle infrastructure, such as electric vehicle charging stations; and wildfire suppression and prevention programs.

A "no" vote opposes increasing the tax on personal income above \$2 million by 1.75% and dedicating the revenue to zero-emission vehicle subsidies; zero-emission vehicle infrastructure, such as electric vehicle charging stations; and wildfire suppression and prevention programs.

Proposition 30 would increase the income tax by an additional 1.75% on income above \$2 million for individuals. Currently, income above \$2 million for individuals is taxed at a rate of 13.3% in California. The additional tax would take effect on January 1, 2023. The initiative provides that the tax would end on the earliest of the following dates:[1]

January 1, 2043, or

• January 1 after three consecutive calendar years after January 1, 2030, of statewide emissions reduced by 80% of 1990 levels.

Revenue from the increased income tax would be appropriated into the Clean Cars and Clean Air Trust Fund (CCCATF). It would then be allocated to the following three subfunds: Zero-Emission Vehicle Infrastructure Investment Plan Sub-Fund (35% of revenue), Zero-Emission Vehicle and Clean Mobility Sub-Fund (45% of revenue), and Wildfire Green House Gas Emissions Reduction Sub-Fund (20% of revenue). The sub-funds would fund zero-emission vehicles, charging stations, and infrastructure, as well as hiring and training firefighters.[1]

#### PROPOSITION 31 TOBACCO BAN ON FLAVORED TOBACCO SALES

**A "yes" vote is to uphold the contested legislation,** Senate Bill 793 (SB 793), which would ban the sale of flavored tobacco products.

**A "no" vote is to repeal the contested legislation**, Senate Bill 793 (SB 793), thus keeping the sale of flavored tobacco legal in the state.

Opponents of Proposition 31 seek to overturn Senate Bill 793 (SB 793), which was signed into law on August 28, 2020. SB 793 was designed to ban the sale of flavored tobacco products and tobacco product flavor enhancers, with exceptions for hookah tobacco, loose leaf tobacco, and premium cigars. Retailers would be fined \$250 for each sale violating the law.[1]

The California State Legislature passed SB 793 in August 2020. The legislation received support from most legislative Democrats (84 of 89) and a quarter of legislative Republicans (8 of 30). One legislator voted against the bill, and the remaining legislators were absent or abstained. State Sen. Jerry Hill (D-13), the legislative sponsor of SB 793, said, "Using candy, fruit and other alluring flavors, the tobacco industry weaponized its tactics to beguile a new generation into nicotine addiction while keeping longtime users hooked. SB 793 breaks Big Tobacco's death grip."[2] The California Fuels & Convenience Alliance, which opposed SB 793, described the flavored tobacco ban as "misguided policy that will do more harm than good" and "hurt small businesses, eliminate necessary tax revenue, and perpetuate dangerous and avoidable police interactions in our communities."[3]

## LOS ANGELES COUNTY MEASURE C IS ON THE BALLOT AS A REFERRAL IN LOS ANGELES COUNTY ON NOVEMBER 8, 2022.

A "yes" vote supports enacting taxes on marijuana businesses in the unincorporated areas of Los Angeles County, including \$10 per square foot for cultivation; a 6% tax on gross retail receipts; a 2% tax on testing facilities' gross receipts; a 3% tax on gross distribution receipts; and a 4% tax on the gross reciepts of manufacturing and other marijuana business facilities.

**A "no" vote opposes enacting taxes** on marijuana businesses in the unincorporated areas of Los Angeles County.

## LOS ANGELES COUNTY MEASURE A IS ON THE BALLOT AS A REFERRAL IN LOS ANGELES COUNTY ON NOVEMBER 8, 2022.

A "yes" vote supports allowing the Los Angeles County Board of Supervisors, by a four-fifths vote, to remove the sheriff from office for cause, which is defined to include: violation of laws related to the sheriff's duties; repeated neglect of the sheriff's duties; misuse of public funds or properties; willful falsification of documents; or obstruction of an investigation into the department's conduct.

A "no" vote opposes allowing the Los Angeles County Board of Supervisors, by a four-fifths vote, to remove the sheriff from office for cause.

#### Overview

Measure A would allow the Los Angeles County Board of Supervisors to vote to remove the elected sheriff from office for cause. The vote requirement to remove the sheriff would be four-fifths. As of 2022, the County Board of Supervisors included five members, meaning an affirmative vote of four members would be needed. Measure A would define cause to include:[1]

- include:[1]violation of laws related to the sheriff's duties;
- repeated neglect of the sheriff's duties;
- misuse of public funds or properties;willful falsification of documents; or
- obstruction of an investigation into the department's conduct

## LOS ANGELES COUNTY MEASURE PCC IS ON THE BALLOT AS A REFERRAL IN LOS ANGELES COUNTY ON NOVEMBER 8, 2022.

**A "yes" vote supports authorizing the Pasaden**a Area Community College to issue \$565 million dollars in bonds with bond revenue going to fund school facilities and requiring an estimated property tax levy of \$20 per \$100,000 of assessed value.

A "no" vote opposes authorizing the Pasadena Area Community College to issue \$565 million dollars in bonds with bond revenue going to fund school facilities and requiring an estimated property tax levy of \$20 per \$100,000 of assessed value.

• A 55% vote is required for the approval of Measure PCC.

Maybe just stay safe inside...and turn off that porch light.



## Woman **Attacks** Home with

The attack happened with sleeping baby inside.

a Pickaxe



A Pasadena woman is now facing felony vandalism charges after smashing multiple windows out of a Pasadena home Monday, with a pickaxe, including a window just feet from where a baby had been The whole sleeping. incident was caught on the family's home surveillance system.

As of press time, the home in the in the 1700 block of Asbury Drive had the front windows boarded up. Video shows a neighbor identified as 65-year-old Beverly Baker, returning several times with the pickaxe over her shoulder. At one point she states, "I'll be back. Get out,"

Police arrested Baker, after a 30 minute standoff, at her home just two blocks away in the 1600 block of Casa Grande St. At the time police found her, Baker had the pickaxe in her hand.

The homeowners said they think they were targeted in the attack because they are Armenian.

It was unclear if Baker knew there had been a baby next to the window during the attack.

The homeowner Arman Tchoukadarian said his daughter had been taken out of a bassinet just seconds before the attack that left shards of glass in the carrier. He said his mother-in-law had been babysitting at the time.

Baker may have been suffering from a mental crisis health police said. Before the attack, neighbors said Baker had been acting odd, including screaming and what appeared to be fighting with someone in her front yard, although no one was there.

Tchoukadarian said his home has an estimated \$20,000 in damages. The family planned to stay with relatives.

He said Barker needed to bet help, but that it was no excuse to attack someone's family and attack someone's newborn baby, ruining their dream home, life and sanity.

Baker's ex-husband lives across the street from the home neighbors said.

Baker failed to appear in court Wednesday but was expected to appear Friday now under warrant.

### **EDWARD STONE RETIRES AFTER 50 YEARS AS NASA VOYAGER PROJECT SCIENTIST**



JPL announced Tuesday that Edward Stone has retired as the project scientist for NASA's Voyager mission a halfcentury after taking on the role. Stone accepted scientific leadership of the historic mission in 1972, five years before the launch of its two spacecraft, Voyager 1 and Voyager 2. Under his guidance, the Voyagers explored the four giant planets and became the first human-made objects to reach interstellar space, the region between the stars containing material generated by the death of nearby stars.

Until now, Stone was the only person to have served as project scientist for Voyager, maintaining his position even while serving as director of NASA's Jet Propulsion Laboratory in Southern California from 1991 to 2001. JPL manages the Voyager mission for NASA. Stone retired from JPL in 2001 but continued to serve as the mission's project

"It has been an honor and a joy to serve as the Voyager project scientist for 50 years," Stone said. "The spacecraft have succeeded beyond expectation, and I have cherished the opportunity to work with so many talented and dedicated people on this mission. It has been a remarkable journey, and I'm thankful to everyone around the world who has followed Voyager and joined us on this adventure."

Linda Spilker will succeed Stone as Voyager's project scientist as the twin probes continue to explore interstellar space. Spilker was a member of the Voyager science team during the mission's flybys of Jupiter, Saturn, Uranus, and Neptune. She later became project scientist for NASA's nowretired Cassini mission to Saturn, and rejoined Voyager as deputy project scientist in 2021.

Jamie Rankin, a research scientist at Princeton University and a member of the Voyager science steering group, has

been appointed deputy project scientist for the mission. Rankin received her Ph.D. in 2018 from Caltech, where Stone served as her advisor. Her research combines data from Voyager and other missions in NASA's heliophysics

The twin Voyager spacecraft launched in 1977, on a mission to explore Jupiter and Saturn, ultimately revealing neverbefore-seen features of those planets and their moons. Voyager 1 continued its journey out of the solar system, while Voyager 2 continued on to Uranus and Neptune – and

remains the only spacecraft to have visited the ice giants.
Following this "grand tour" of the outer planets, the
Voyager Interstellar Mission began. The goal was to exit the heliosphere – a protective bubble created by the Sun's magnetic field and outward flow of solar wind (charged particles from the Sun). Voyager 1 crossed the boundary of the heliosphere and entered interstellar space in 2012, followed by Voyager 2 (traveling slower and in a different direction) in 2018. Today, as part of NASA's longestrunning mission, both spacecraft continue to illuminate the interplay between our Sun, and the particles and magnetic fields in interstellar space.

'Ed likes to say that Voyager is a mission of discovery, and it certainly is," said Suzanne Dodd, Voyager project manager. "From the flybys of the outer plants in the 1970s and '80s, to the heliopause crossing and current travels through interstellar space, Voyager never ceases to surprise and amaze us. All those milestones and successes are due to Ed's exceptional scientific leadership and his keen ability to share his excitement about these discoveries to the world." Among the many honors bestowed on him, Stone has been a member of the National Academy of Sciences since 1984. He was awarded the National Medal of Science from President George H.W. Bush in 1991. When Stone was interviewed on the late-night TV show "The Colbert Report" in 2013, NASA arranged for host Stephen Colbert to present him with the NASA Distinguished Public Service Medal, the agency's highest honor for a nongovernment individual. In 2019, he received the Shaw Prize in Astronomy from the Shaw Foundation in Hong Kong for his work on the Voyager mission.

A division of Caltech in Pasadena, JPL built and operates the Voyager spacecraft. The Voyager missions are a part of the NASA Heliophysics System Observatory, sponsored by the Heliophysics Division of the Science Mission Directorate in Washington.





#### Jim Osterling Says: VOTE YES ON MEASURE PCC FOR AFFORDABLE HIGHER EDUCATION AND JOB

For 100 years, Pasadena City College (PCC) has provided high-quality, affordable college education and career training for residents of all ages, including thousands of graduates from our

With the rising cost of four-year college, many students are turning to community college for higher education at a fraction of the cost of Cal State, University of California (UC) and private

Each year thousands of local high school graduates from Sierra Madre and throughout the West San Gabriel Valley rely on PCC for affordable access to higher education and job training. PCC delivers the highest transfer rate to Cal State and UC among all community colleges in California. The College's satellite campuses bring these benefits to residents throughout our region.

Continuing to provide affordable access to higher education and job training requires up-todate classrooms, labs and technology to meet the growing demand. This November there is an important measure on the ballot to support PCC which is aptly named Measure PCC.

Measure PCC is a community college facilities improvement bond measure on the November 8, 2022 ballot that will provide locally controlled funding for Pasadena City College to upgrade aging classrooms, labs and job training facilities to maintain affordable, high-quality education for local students.

Most of PCC's facilities were built over 50 years ago and need repairs and upgrades. There is a clear need to upgrade classrooms, instructional technology and career training facilities to better prepare students for in-demand jobs in science, healthcare, nursing, engineering and skilled trades. A portion of the funds will be used to replace a red tagged building (The Sarafian Science building) and upgrade 4 yellow tagged buildings that have outdated structural and building systems.

Voting Yes on Measure PCC ensures local students, including lower and middle-income students who can't afford expensive university tuition, can access affordable higher education and job training in our area.





#### DAY OF THE DEAD: A Mayan Approach to Closure

In 2010 I went to Mexicoʻs Yucatan peninsula to learn about the Maya culture and spirituality under the tutelage of Miguel Angel Vergara Calleros.

Among other things, I was told that Vergara does "readings" with people based upon Mayan beliefs. I didn't know precisely what a "reading" was, but I was urged me to take advantage of this opportunity. I had to give Vergara's assistant my birthday the day before

in order for Vergara to prepare.

I was also asked to determine my personal goal, and to come up with pertinent questions. I decided that my goal was to find peace with my wife who had died two years earlier. I still talked to her daily, and I still missed her very much. Another goal was to live my destiny. Thus, my question was: "what are my steps to living more fully my life goal?" I felt that I could, and should, be able to determine these things on my own, but I still wanted the feedback from Vergara.

After lunch, I met with Vergara in his Campeche, his office, a table by the window in the hotel Tucan

He prepared a document based on my birthdate. He pointed to the symbols on his black and white image as he explained each. Plus, he had a small stack of cards and upon each was drawn a Mayan symbol. He went into great detail about my character and personality, details which I share in my book, "On the Road

Then, after his reading, I ask, "How do I find peace with Dolores? How do I fulfill my life's destiny?" His answer was to point to the Mayan symbols, one by one, and to create the answer by their entirety. He first points to a symbol, Ok, which he says represents "prints," which refers to when I walk, footprints. Next, he point to a symbol, Kan, which represents wisdom and knowledge. Next, Ix, which refers to coming and doing ceremonies with Mother Earth.

Then, Eb, which means that is the way.

And finally, Akbal, which means to reconnect with your pure essence and be in peace inside you. He smiles, and tells me that my answer is there. It is very obvious, really. It is the answer to everything. To be who I am, or who I am to be, and to fulfill my dharma or destiny, I walk with wisdom, or seeking wisdom, and join in the ceremonies that connect me with my self. I will know that this is the way, and this will help

me to reconnect with my own higher Self, and be at peace. Yes.

Vergara smiled, and nodded. "Yes," he said, "go up higher, like the eagle, to see the spiritual geometry of the problem. See the way in, and the way out. Then, let your jaguar essence go down and find the way out with calmness and without emotional attachment."

Next he tells me how to perform a special ceremony to find peace with Dolores. Vergara tells me to dig a hole, around 3 feet wide, maybe 2 feet deep, in a special place. I do this by myself, but if I choose to do so later, OK I can do it again and invite others to join.

I needed to obtain the following items as offerings: Honey, Seeds, Oils, Bread, Chocolate, Incense.


I was to put all of these items around the hole, and then talk to Dolores. I ask for healing. I say words to the effect of: "Heart of Earth, I am doing this ceremony in your name. Please heal my heart and mind from my painful memories." I was told to say whatever else I feel is appropriate. When done, I would put all the items in the hole and bury them.

Then I was to be at peace, let Dolores be with me, and honor her. "But you need to remember that you are incarnated," said Vergara. "Go and teach and share and honor, and devote these things to Dolores." ... He told me that I could consult with him in the weeks that followed if I had questions.

We hugged when it was done, and when I returned home, I was determined to do these ceremonies. I did grow roses and keep roses in water in my room some of the time.

But it wasn't until the following November - November of 2011 - that I finally dug the hole and did the

I did the ceremony as Vergara prescribed. There were no psychic appearances and no special clouds or winds that spoke to me. However, within the next three days, I felt a feeling of calm and peace settle upon me, as if the ceremony had in deed done its job to free each of us to continue on our needed path. I thanked Dolores for the life we had, and I thanked Vergara for his guidance.



#### TOP FINANCIAL SCAMS TARGETING SENIORS TODAY

Dear Savvy Senior:

What are the most common scams today that target elderly seniors? My 75-year-old mother has been swindled several times over the past year, so I'm being extra cautious. Paranoid Patty



Dear Patty:

Great question! While many scams today are uni-

versal, there are certain types of fraud that specifically target older adults or affects them disproportionately. And unfortunately, these senior targeted scams are on the rise.

According to the Federal Bureau of Investigation (FBI), in 2021 there were 92,371 older victims of fraud resulting in \$1.7 billion in losses. This was a 74 percent increase in losses compared to

Here are five of the most common senior scams that were reported last year, that both you and your mom should be aware of.

Government imposter scams: These are fraudulent telephone calls from people claiming to be from the Internal Revenue Service, Social Security Administration or Medicare. These scammers may falsely tell you that you have unpaid taxes and threaten arrest or deportation if you don't pay up immediately. Or they may say your Social Security or Medicare benefits are in danger of being cut off if you don't provide personal identifying information. They may even "spoof" your caller ID to make it look like the government is actually calling.

Sweepstakes and lottery scams: These scams may contact you by phone, mail or email. They tell you that you've won or have the potential to win a jackpot. But you need to pay a fee, or cover taxes and processing fees to receive your prize, perhaps by prepaid debit card, wire transfer, money order or cash. Scammers may even impersonate well-known sweepstakes organizations, like Publishers Clearing House, to fool you.

Robocalls and phone scam: Robocalls take advantage of sophisticated, automated phone technology to carry out a variety of scams on trusting older adults who answer the phone. Some robocalls may claim that a warranty is expiring on their car or electronic device, and payment is needed to renew it. These scammers may also "spoof" the number to make the call look authentic.

One common robocall is the "Can you hear me?" call. When the older person says "yes," the scammer records their voice and hangs up. The criminal then has a voice signature to authorize unwanted charges on items like stolen credit cards.

Computer tech support scams: Theses scams prey on senior's lack of knowledge about computers and cybersecurity. A pop-up message or blank screen usually appears on a computer or phone, telling you that your device is compromised and needs fixing. When you call the support number for help, the scammer may either request remote access to your computer and/or that you pay a fee to have it repaired.

Grandparent scam: The grandparent scam has been around for several years now. A scammer will call and say something along the lines of: "Hi Grandma, do you know who this is?" When the unsuspecting grandparent guesses the name of the grandchild the scammer most sounds like, the scammer has established a fake identity.

The fake grandchild will then ask for money to solve some unexpected financial problem (legal trouble, overdue rent, car repairs, etc.), to be paid via gift cards or money transfers, which don't always require identification to collect.

Some other popular scams targeting older adults right now are romance scams through social media and online dating sites, COVID-19 scams, investment scams, Medicare and health insurance scams, and Internet and email fraud.

#### **DON'T BE SCARED - EMBRACE THE** FEAR AND ACT

First, don't try to tell me that there is nothing to be afraid of. Open your eyes and look around. The Pandemic won't go away and keeps mutating into other scary variants. Every morning, as soon as we make the mistake of turning on the morning news or, worse yet, Democracy Now, we learn of shootings and bombings and the number of deaths since yesterday. Corruption is reported everywhere and it feels like there is no one left to trust, even Dr. Fauci. Each day my phone messages demand contributions to causes

and candidates as the frightening midterm elections approach like horsebacked Cossacks coming to pull us from our homes with the intent of torturing us.

This last image of approaching Cossacks comes from, "My Life By Golda Meir", the book I was reading as I fell asleep. As an eight year old child, newly arrived from Kiev, Golda and her family attended their first American parade and were horrified by the sight of uniformed men on horseback. I immediately they thought of the Cossack's and the pogroms that caused them to leave the Ukraine. The Golda Meir book reminded me of some other frightening, inevitable occurrence—CHANGE. Soon af-The Golda Meir book ter their arrival the father who barely knows his eight year old daughter warns her on page 41,"It doesn't pay to be too clever. Men don't like smart girls." In these intervening years I believe things have changed, sort of. It is impossible not to recognize that change has occurred but my double negative is a reminder of how difficult the changes have been and how so many of us do not want to recognize these inevitable changes and are frightened by them.

I realize that many of my own attitudes, recognized or not, are based upon a fear of Change. The big question in Sierra Madre today concerns referendums allowing the beloved monastery to be sold to developers and fears of future development. I want the whole thing to go away. I want no change period and I know this will not be the case. I want things to stay the same with the world needing to adapt to me rather than me adapting to the world. This attitude is much like that of Holden Caulfied, the hero of J. D. Salinger's novel the Catcher in the Rye. Reviews of the novel describe Holden as permanently immature and unwilling and unable to adapt to changes. Nonetheless, I completely identify and sympathize with him notwithstanding that by the end of the book it is clear that he has been institutionalized.

A couple of years ago I went to a local bookstore to see about another writing by Salinger. I asked the worker to look into books by J.D. Salinger. The clerk said if you don't know the author's first name "I can't help you." I do need help as was made even more obvious when in connection with my desire to have a book of my articles to be published in the hope that my granddaughter might be interested in it at some future time when she can actually read more that the letter "J" (remember she is only three years old). Anyway, I had some vague recollection of the poem "Ozymandias" by Percy Bysshe Shelley which dealt with the human wish to be remembered. I went tó a locál líbrary (not Śierra Madre) and approached THE RESEARCH LIBRARIAN asking her to direct me to the section where I could find poetry by Shelley and she actually said, "Shelley who?" Her lack of information greatly disappointed me and was reflected in my expression. The RESEARCH LIBRARIAN condescendingly explained that literature that was current in my era was probably not remembered today. I asked if she was familiar with Frankenstein which of course was written by Shelley's wife. That the librarian knew about that.

Speaking of Frankenstein that brings me to the plethora of frightening Halloween displays all over town. Frankly I have never understood the great desire to be frightened or to frighten. Recently, after her swimming lesson, a large costumed monster-like creature appeared at the poolside to entertain the 3-5 year old kids. My granddaughter was at first very frightened and clung to my wife for support and safety. Almost immediately she announced that she raised her arms to indicate she was now "big and strong" and attempted to follow the creature up the stairs.

This is my final point about fear and fear of change. They are both constancies within our lives that do not go away. "The more things change the more they remain the same." But as FDR (I hope you know who he was) reminded the nation eighty years ago, "The only thing we have to fear is fear itself." Fear must be recognized but it cannot be allowed to paralyze us into denial and inaction and Holden-like despair. Sorry, you MAGA fans the America that never was cannot be retrieved. Fearing the future and longing for the past, imagined or not, is never a solution. I believe that it is necessary to stay informed, recognize the truth, face our fears, and take appropriate individual action. Don't despair! There are at least two-sides to everything. Start by voting (for the candidates of my choice-that's what Holden would want.) I have not completely changed.

"Just Do It. Vote for Rich." "Pardon Me. Can You Spare a Vote? Vote for Rich."


"Thank Rich It's Friday.<sup>3</sup>

## HERITAGE MONTH: THE ALL-BROTHERS BASEBALL TEAM



In 1997, the Cooperstown Hall of Fame honored the Acerra family, an all-Italian, 12-brother semi-pro team that played .700 winning baseball from 1938 to 1952.

Between 1860 and 1940, 29 baseball teams were made up entirely of brothers; the Acerras played longer than any other.

Honored isn't the same as inducted, so the brothers didn't join the powerful Italian-American contingent that has Hall of Fame plaques, which includes Joe DiMaggio, Tony Lazzeri, Yogi Berra and Phil Rizzuto.

Among the Italian-American baseball standouts born too soon to benefit from today's watered-down Hall of Fame standards were Sal "the Barber" Maglie, a New York Giants, Brooklyn Dodgers and Yankees pitcher, and Rocco Domenico Colavito, a nine-time All-Star with 374 career home

The Acerras' wonderful story is one of strong family ties and exceptional baseball skills. Louis "Pop" Acerra coached his sons, part of his family of 17 children. The team consisted of Alfred and Edward as catcher, James and Robert on the mound, Charles at first base, Louis Jr. at second base, Fred at shortstop, Richard at third base and sharing outfield duties, Paul, Joseph, William and Anthony.

Back then, girls didn't play baseball, so Pop's five daughters rooted from the sidelines along with the family dog "Pitch." Neighbors couldn't remember a time when the brothers weren't out in their yard playing catch or hitting fungos to each other.

The age difference between oldest brother, Anthony, to the youngest, Louis Jr. was 25 years. While being scouted by major league teams, their playing ages were as young as 17 and as old as 40. For 22 consecutive years, the Long Branch High School baseball team fielded an Acerra brother.

Officially formed in 1938, the team played throughout the East Coast for 14 years. In 1948, the sibling squad challenged the New York Yankees to an exhibition game, an offer the Bronx Bombers rejected.

During World War II, the team temporarily disbanded. Defending America's freedom was more important than baseball. At different times, six brothers enlisted; when they all returned, the team resumed playing. The brothers turned down college scholarships and offers to play professional baseball.

Alfred, the catcher, continued to play after losing sight in one eye. Attempting to bunt, the ball bounced off Alfred's bat, and struck him directly in the eye. Within months, Alfred was back behind the plate. Brother Freddie said: "He was a pretty good catcher for a guy with one eye."

In 1946, the Acerras joined the Long Branch City (New Jersey) Twilight Baseball League, and during the next six years, won the championship four times. When the Acerras played, the stands were always packed with fans.

Along their road to success, the Acerras became the talk of the town. In 1947, Life and Look magazines and Ripley's Believe it or Not ran features on the brothers. The Acerras also appeared on the popular "Once in a Lifetime" nightly radio program.

By 1952, the brothers had married and were raising children. The team's playing days were over. But 45 years after their last game, the seven still-living brothers accepted the Hall of Fame's invitation to participate in its annual ceremony. James M. Accera, pitcher Jimmy's son, donated his Dad's uniform and glove which now are in the same museum with the artifacts of the lives of Babe Ruth, Ty Cobb and Willie Mays.


Acerra said, "This just touches the surface of a family that stayed a family, behind all the baseball and athletic achievements. A family that never allowed sibling rivalry and infighting or success to tear them apart. Their team was a reflection of something greater, something that 14 years, many



#### FINDINGS OF AN EMERGENCY FOR THE ORIENTAL FRUIT FLY

On September 25, 2022, the California Department of Food and Agriculture (CDFA) confirmed that two oriental fruit flies (OFFs), **Bactrocera dorsalis** (Hendel) group, were trapped in the City of Beverly Hills in Los Angeles County. These detections indicate that a breeding population exists in the area. Unless emergency action is taken, then there is high potential for sudden future detections in Los Angeles County. The OFF is a devastating pest of a wide variety of important fruit, vegetables, and native plants.

In order to determine the extent of the infestation, and to define an appropriate response area, an additional survey took place, centered on the detection site. Based on the survey data, and findings and recommendations from the CDFA **Bactrocera** Science Advisory Panel (BacSAP), the Primary State Entomologist, the CDFA's "Action Plan for Methyl Eugenol Attracted Fruit Flies including Oriental Fruit Fly **Bactrocera dorsalis** (Hendel)," and County Agricultural Commissioner representatives who are knowledgeable on OFF, I have determined that OFF poses a statewide imminent danger to the environment and economy.

The results of the additional survey also indicated that the local infestation is amenable to CDFA's OFF response strategies, which include chemical treatments and removal of host fruit. These options were selected based upon minimal impacts to the natural environment, biological effectiveness, minimal public intrusiveness, and cost.

The OFF is an exotic insect originating in Asia, and has been accidentally introduced into a number of Pacific Islands, including Hawaii. It is a member of a closely related group of species, known as the OFF group, which are difficult to distinguish based on individual specimens. Several of the group species are major fruit and vegetable pests, and collectively members of the OFF group are known to attack over 230 types of fruits and vegetables. Important California crops at risk include pome and stone fruits, citrus, dates, avocados, and many vegetables, particularly tomatoes and peppers. Damage occurs when the female lays eggs in the fruit. These eggs hatch into larvae, which tunnel through the flesh of the fruit, making it unfit for consumption.

A life cycle is an estimate of insect phenology based on a heat degree day temperature driven model. Warmer temperatures lead to faster lifecycles, while colder temperatures slow lifecycle development. Daily minimum and maximum temperatures are collected from nearby regional data stations and used to calculate estimated temperature value curves. These temperature curves are used to project the length of fly lifecycles against established models specific to the Oriental Fruit Fly. Because the third (F3) life cycle of the OFF detected on September 25, 2022 is not projected to be complete until April 27, 2023, it is likely that there are additional flies in the environment that will lead to sudden future detections.

This pest presents a significant and imminent threat to the natural environment, agriculture and economy of California. Exotic fruit flies are internal feeders of fruit, and their presence therefore makes the fruit unfit for consumption. There is a loss of marketability and ability to ship food to other states and nations. The combined 2020 gross production value of host commercial commodities potentially affected by OFF was over \$19.33 billion. The permanent establishment and spread of this pest would result in increased production and postharvest costs to safeguard commercial fruit from infestation, increased pesticide applications on both production agriculture and residential properties to mitigate damage, and lost economic activity and jobs from trade restrictions imposed by the United States Department of Agriculture (USDA) and foreign trade partners.

This decision to proceed with treatment is based upon a realistic evaluation that it will be possible to eliminate OFF from this area and prevent its spread using currently available technology in a manner that is based on an action plan developed in consultation with the Pest Prevention Committee of the California Agricultural Commissioners and Sealers Association, the USDA, and scientists on the BacSAP. Due to the size of the infested area and the number of flies detected, historical data indicates that eradication is possible. The first California OFF detections occurred in Orange and Santa Barbara counties in 1960, and since that time, multiple re-introductions have been delimited and successfully eradicated.

The CDFA has evaluated possible treatment methods in accordance with integrated pest management (IPM) principles. As part of these principles, I have considered the following treatments for control of OFF: 1) physical controls; 2) cultural controls; 3) biological controls; and 4) chemical controls. Upon careful evaluation of each these options, I have determined that it will be possible to address the imminent threat posed by OFF using currently available technology in a manner that is recommended by the BacSAP.

Based upon input from the BacSAP, the Primary State Entomologist, USDA experts on OFF, and County Agricultural Commissioner representatives who are knowledgeable on OFF, I find there are no cultural or biological control methods that are both effective against OFF and allow CDFA to meet its statutory obligations and therefore it is necessary to conduct physical and chemical control methods to abate this threat. As a result, I am ordering that male attractant treatments, consisting of methyl eugenol, a pesticide (spinosad), and a time-release matrix be applied to utility poles and street trees to eliminate this infestation. Additionally, in the event of evidence of a breeding population on a property, foliar bait spray treatments will be applied to host trees using ground-based equipment and host fruit removal will occur.

#### Sensitive Areas

CDFA has consulted with the California Department of Fish and Wildlife's California Natural Diversity Database for threatened or endangered species, the United States Fish and Wildlife Service, the National Marine Fisheries Service, and the California Department of Fish and Wildlife when rare and endangered species are located within the treatment area. Mitigation measures for rare and endangered species will be implemented. The CDFA shall not apply pesticides to bodies of water or undeveloped areas of native vegetation.

#### Work Plan

The proposed treatment area encompasses those portions of Los Angeles County which fall within a 1.5-mile radius around each property on which an OFF has been detected and any subsequent detection sites within the program boundaries. The Proclamation of Emergency Program is valid until April 27, 2023, which is the amount of time necessary to carry out the treatment plan across three life cycles of OFF as required by the treatment protocol for OFF. A map of the project boundaries is attached. The work plan consists of the following elements:

- 1. Delimitation. Traps will be placed in a 4.5-mile radius from each detection site to delimit the infestation and to monitor post-treatment OFF populations. The cardboard Jackson sticky trap is baited with the attractant methyl eugenol mixed with the pesticide naled (Dibrom® 8 Emulsive), and the McPhail trap is an invaginated glass flask baited with Torula yeast and borax in water. The Jackson trap is strongly attractive to sexually maturing males, while the McPhail trap is attractive to both sexes of the fly. Jackson traps and McPhail traps will each be placed at a density of 25 per square mile within a 0.5-mile radius of each detection site, and Jackson traps will be placed at a density of five per square mile in the remaining delimitation area going out to 4.5 miles from each detection site. Additional traps may be added to further delimit the infestation and to monitor the efficacy of treatments. These traps will be serviced on a regular schedule for a period equal to three OFF generations beyond the date of the last OFF detected. In addition, host fruit may be sampled for the presence of eggs and larvae in a 200-meter radius around each detection property.
- 2. Treatment. Any OFF detections within the original and/or expanded eradication area(s) will be treated according to the following protocol.
- The male attractant technique (MAT) will be used to eliminate all sexually-mature male OFFs. MAT applies small bait stations using STATIC<sup>™</sup> Spinosad ME, which is a pre-mixed solution containing the attractant methyl eugenol and an organically registered pesticide spinosad, mixed into a waxy time-release matrix (SPLAT®). The methyl eugenol lures male flies to the bait stations, where the flies ingest the insecticide as they feed. The flies are killed when they feed at the stations. In each square mile within the eradication boundary, a targeted density of 600 evenly spaced five- to ten-milliliter bait stations are applied to utility poles, street trees, and other unpainted surfaces using pressurized tree marking guns mounted on specially modified trucks. The bait stations are placed six to eight feet above the ground. The size of the eradication area is defined as that area within 1.5 miles of each detection site, squared off to create a nine-square mile block, and adjusted to use existing features as boundaries, such as roads. Applications are repeated every two weeks for one life cycle if no quarantine is triggered (typically two to three months), and for two life cycles if a quarantine is triggered (typically four to six months). Life cycle durations are dependent on temperature.
- If evidence that a breeding population exists on a property (i.e., immature stages, mated female, or multiple adults are detected), foliar bait treatments will be used within 200 meters of each detection site in order to mitigate the spread of OFF by eliminating those adult life stages not directly affected by MAT (i.e., females and sexually-immature males). The foliage of host trees and shrubs within 200 meters of each detection site will be treated with an organic formulation of spinosad bait spray (GF-120 NF Naturalyte® Fruit Fly Bait) using hand spray or hydraulic spray equipment. Treatments are repeated every seven to 14 days for one life cycle of the fly (typically two to three months, dependent on temperature).
- If evidence that a breeding population exists on a property (i.e., immature stages, mated female, or multiple adults are detected), all host fruit from each detection site and all properties within a minimum of 100 meters of each detection site will be removed and disposed of in a landfill in accordance with regulatory protocols. Fruit removal will occur at the beginning of the project, but may be repeated if additional flies are detected.

#### Public Information

For MAT applications in public areas, notification is given to the general public via mass media outlets such as newspapers or press releases.

Residents whose property will be treated via foliar bait sprays or host fruit removal will be notified in writing at least 48 hours in advance of any treatment, in accordance with the Food and Agricultural Code (FAC) sections 5771-5779 and 5421-5436. Following the treatment, completion notices are left with the residents detailing precautions to take and post-harvest intervals applicable to any fruit on the property.

Press releases, if issued, are prepared by the CDFA information officer and the county agricultural commissioner, in close coordination with the project leader responsible for treatment. Either the county agricultural commissioner or the public information officer serves as the primary contact to the media.

Information concerning the OFF project shall be conveyed directly to local and State political representatives and authorities via letters, emails, and/or faxes.


Due to the detection of OFF, there exists a significant, clear, and imminent threat to California's natural environment, agriculture, public and private property, and its economy.

Unless emergency action is taken during the life cycles of recently detected OFFs, there is high potential for sudden future detections in Los Angeles County.

The work plan involving physical and chemical control of this pest is necessary to prevent loss and damage to California's natural environment, fruit and vegetable industry, native wild-life, private and public property, and food supplies.

Therefore, I am invoking Public Resources Code Section 21080(b) (4) to carry out immediate emergency action to prevent this loss and damage.

My decision to adopt findings and take action is based on Sections 24.5, 401, 401.5, 403, 407, 408, 5401-5405, and 5761-5764 of the Food and Agricultural Code, and title 3 of the California Code of Regulations (CCR) Section 5388.
